Like the Pheonix, a New Church Will Rise

Back on September 11, 2001, a small Greek Orthodox Church which had been a reprieve for folks working in the financial district of Manhattan was crushed when the World Trade Center's south tower collapsed after being struck by hijackers who rammed both towers with commercial airliners. On Saturday, October 18, church officials blessed the ground where the new St. Nicholas Church will rise.

The original church was a faith community for about 70 families and was the only religious structure destroyed on that terrible day over 13 years ago. Among those in attendance were U.S. Senator Chuck Schumer, D-NY; former Gov. George Pataki and former New York City Mayor, David Dinkins.

Moments after that tower fell, a nice little church nearby turned into a hole with a depth of seven to ten feet.

As Schumer noted, "Like a phoenix rising from the ashes, this church will show the resilience and fortitude of St. Nicholas and of all New Yorkers."

Stirpe Nostra

LUNA AND AURORA



Luna, the Roman goddess of the moon was considered to be a beautiful woman. She wore a golden crown that gave off a subdued light, had long wings, and was generally shown riding in a chariot drawn by two white horses or cows. When cows were used, their horns were drawn to symbolize the crescent of the moon. She was also regarded as a huntress and an archer, and was recognized on days of the new moon and the full moon. Being a mythological figure, there are at least three versions of her amorous regard for a handsome young man named Endymion. The first version tells of her union with him and the birth of fifty daughters. These offspring are said to have symbolized the fifty lunar months between the Olympic Games.

Another story identifies Endymion as a shepherd or hunter on Mount Latmus in Caria, a district in Asia Minor. The gods bestowed upon him eternal youth and eternal life, but it was in the form of unbroken slumber. Luna came down from the heavens every night to visit and embrace him as he slept in his grotto.

The third story tells us that Luna placed Endymion into his deep sleep so that she might caress him without his knowledge. There is a statue of Endymion in the British Museum. We are told that this legend is what inspired Keats to write one of the most beautiful poems in English literature, but it was attacked by critics who referred to it

as "the Cockney school of poetry."

Aurora, of course, is the Roman goddess of the morning. One of the world's greatest masterpieces in painting is a fresco on the ceiling of the great hall in the Casino Rospigliosi in Rome, which was painted by the artist Guido Reni. The panel is said to be one of the most beautiful works of this master. It shows Sol, the Sun god, seated in a chariot drawn by four fiery steeds, while seven females dance gracefully around him. Above the horses a winged cupid holding a flaming torch represents Lucifer, the morning star. The assembled figures are led by Aurora, who is shown rising into the air while scattering flowers before the chariot of Sol.

For those persons who are unfamiliar with the term "fresco", I might add that it is an art medium which uses watercolors that are applied to fresh plaster. The colors dry into the plaster, oxidize, and form a lasting picture. The difficulty in fresco work lies in the fact that the plaster must be dry enough to absorb the additional watercolor without sagging, and also that only a limited amount of plaster can be applied and painted at one sitting. Dried plaster will not accept the water paint and retouching is taboo. Leonardo Da Vinci's Last Supper, and Michelangelo's Sistine Chapel Ceiling and Wall are among the world's most famous frescoes.

Martha Coakley Has No Problem with Non-Citizens Voting

Recently Martha Coakley said she believes that allowing non-citizens to vote in local town and city elections should be an option for municipalities to choose for themselves, showing, once again, how out of touch she is with the citizens of Massachusetts.

She has been roundly denounced. Some have even suggested that our Attorney General needs a refresher course in constitutional law because, they say, such a proposal is contrary to the U.S. Constitution. Here I must part with my fellow conservatives, for, no matter had bad the idea of aliens voting in our elections may be, it is, nevertheless, perfectly constitutional.

The U.S. Constitution, as it went into force in 1787, says absolutely nothing about qualifications for voters, leaving it entirely in the hands of the states. At the time no state prohibited non-citizens from voting. There were other restrictions. In Massachusetts, the electoral franchise was restricted to male inhabitants (not limited to citizens), 21 years of age and older, and owning a certain amount of property. Most states had similar requirements. Southern states further restricted the franchise to Whites only.

Some states limited voting to citizens starting after the War of 1812, which generated an enhanced sense of patriotism. More banned it in the 1840s and 1850s. Two notable things were happening around then — (1) the 1848 revolutions in Europe caused many Americans to regard foreigners with suspicion and (2) the beginning of the flood of Irish Catholic immigrants who threatened the political supremacy of English, Scots, and Scot-Irish Protestants. But the big wave of states banning voting by non-citizens was in the early twentieth century. Then a new wave of immigrants from Italy, the rest of Southern Europe, and Eastern Europe, again awaked nativist fears about "inferior races" namely Catholics and Jews. It was not until the election of 1928 that all states had limited voting to citizens only.

The Constitution has seven times been amended to regulate voting.

- (1) The 14th Amendment, ratified February 3, 1870, said that states could not deny the vote to African-Americans. In Massachusetts, American-Americans had the vote since the 1780s.
- (2) The 17th Amendment, ratified April 8, 1913, provided for the direct election of U.S. Senators. The amendment stipulated that, "The electors in each State shall have the qualifications requisite for electors of the most numerous branch of the State legislatures," again, recognizing that qualification of voters is a *state*, not *national*, right.
- (3) The 19th Amendment, ratified August 18, 1920, said that states could not deny the vote to women. In Massachusetts women had been able to vote since 1879, but *only for school committee*, not for any other offices.
- (4) The 22nd Amendment, ratified, February 27, 1951, limited the President to two terms.
- (5) The 23rd Amendment, ratified March 29, 1961, gave the District of Columbia votes for President and Vice President. It did not specify whether D.C. voters had to be citizens.
- (6) The 24^{th} Amendment, ratified January 23, 1964, said that states could no longer assess a "poll tax" for voting.
- (7) The 26th Amendment, ratified July 1, 1971, said that states could not limit voting based on age in the case of citizens who are 18 years of age or older. Interestingly, there is nothing in the Constitution hindering states from choosing a lower age. In Maine, 17-year-olds can vote in a primary election, as long as they will be 18 by the time of the general election. Maine is not the only state to allow voting by 17-year-olds.

Clearly, nothing in the Constitution prohibits voting by non-citizens. In New York City non-citizens voted in elections for school board until 2002 (when the board was made an appointed rather than elected body). The reasoning behind this is that many non-citizens have children in the public schools and are taxed to support the schools. A few, very few, other municipalities allow non-citizens to vote in at least some local elections.

Currently it is illegal for aliens to vote for President, Vice President, U.S. Senator, and U.S. Representative. That restriction is found not in the Constitution, but in a law [18 U.S.C. §611]. It was passed as a part of the Illegal Immigration Reform and Immigrant Responsibility Act of 1996. Given that the Constitution gives to the states, not Congress, the power to regulate qualifications for voting (except that the states cannot disenfranchise specific classes of voters under the provisions of the 14th, 19th, 24th and 26th amendments) I question whether the federal prohibition on aliens voting in national elections is itself constitutional. Derek T. Muller, Associate Professor of Law, Pepperdine School of Law, also questions the constitutionality of 18 U.S.C. 8611

L'Anno Bello: A Year in Italian Folklore

Halloween's Haunted History

Outside my bedroom window, the trees are nearly bare. A few yellow leaves wave tentatively against spindly dark branches, while the forest ground is blanketed with hues of orange and red. As I make my way to work every morning, toothy jack-o-lanterns grin eerily at me from the win-

dows and doorways of neighborhood homes. A wicked wind howls during the pitchblack night, calling me into the cozy quarters of the indoors. Yes, it is time for Halloween, the spookiest holiday of the year and the night when witches and ghosts exit from our subconscious and enter everyday life. It is a day of mystery, when nothing is what it appears. Halloween happens to be one of my favorite holidays, for it brims with the possibility of the unexpected and reminds me that much of the world unknown remains (of course, the prevalence of chocolate helps, too). But from where did this macabre and bizarre holiday originate? The history of Halloween is just as complex and as multifaceted as the plot of a gripping suspense film. From its origins in a pre-Christian harvest festival to its association with the Catholic feasts of All Saints' and All Souls' Day, the Halloween story crisscrosses the world with fascinating and unique traditions.

The ancient Celts celebrated a holiday called Samhain ("sow-en," where "sow" rhymes with "cow") on November 1st, with festivities beginning the evening before. Samhain was considered the first day of winter and may have even functioned as the Celtic New Year. Samhain represented a scary time for the Celts because the harvest had just finished and the dark winter days were quickly approaching. In this agriculture-based society, a good harvest was a matter of life or death, so the Celts prayed for a successful crop. Indeed, since nature was dying and barren during this time of the year, Samhain had a strong association with that the veil between the living and the dead was especially thin on this transi-



tional night, and both good and evil spirits wandered through the Earth. To ward off these spirits, the Celts built bonfires and donned frightening costumes, a custom which has survived in the modern Halloween. Another way to scare evil spirits away was to build jack-olanterns, or hollowed turnips carved with eerie faces and bearing a candle inside. When the Irish immigrated to America in the nineteenth century, the pumpkin eventually replaced the turnip for this craft. Samhain was also a night ripe for divination, when girls tossed apple peals over their shoulders to ascertain the initials of their future spouse and people closely watched the bonfires for portents about the harvest. Meanwhile, the popular Halloween game of bobbing for apples comes from our ancestors in Italy, who played it during Pomona, the ancient Roman festival honoring the goddess of the orchards.

This pre-Christian holiday of harvest's close and death later combined with All Saints' Day and All Souls' Day, two Catholic feasts also honoring the dead. When Christianity began to spread across Europe in the early Middle Ages, All Saints' Day was attached to November 1st to bring a religious perspective to Samhain. All Saints' Day also went by the name of All Hallows, and as the preceding evening, All Hallows' Eve morphed into the word Halloween. While All Saints' Day commemorated deceased saints, as the name suggests, All Souls' Day, a holiday celebrating all the faithful departed, was placed on November 2nd. The tradition of trick-or-treating actually stems from All death. The Celts believed Souls' Day; in the Middle Ages, beggars and children would go souling, or moving from home to home receiving spiced cookies known as soul cakes in return for prayers on behalf of the household's dead. Modern Italians do celebrate Halloween with pumpkin and witch decorations and haunted attractions, but All Souls' Day remains the most important festival of the dead in that country. Known as il

Giorno dei Morti (day of the dead), people in Italy visit and clean graves on November 2nd and attend special masses for the deceased. In the countryside, old-time villagers tell spine-tingling stories of lost travelers stumbling upon a church service the night of All Souls and noticing that the pews are filled with the spirits of longgone townsfolk. Elsewhere, depending on the region. Italian children may leave offerings out for wandering souls during the eve of All Souls and find treats the next morning, or people may munch on ossa dei morti, or nutty spice cookies whose creepy moniker means "bones of the dead." I remember learning about similar traditions for Día de los Muertos, the Latin American Day of the Dead, in Spanish class and making cinnamon-topped called pan de los muertos. Truly, spookiness is a worldwide affair!

I keep all of these old traditions in my mind when I celebrate Halloween. I love honoring this holiday in a folksy manner, paying special attention to the themes of harvest's end and the accompanying sense of the unknown. Α grinning wooden jack-o-lantern decorates my door. I bake a pumpkin bread with a cream cheese ripple every year, letting the spices warm my kitchen. In between handing out candy to the trick-ortreaters, I snuggle on the couch with a cup of tea, watching ghost programs with my husband. These traditions make Halloween a very meaningful holiday for me. A lot of people may find the holiday's emphasis on death quite morbid, but it actually stems from the custom of earth-based holidays With the withered leaves, dark nights and brisk winds of late October, it is no wonder that the ancient Celts and the early Catholics turned to questions of mortality and restless spirits this time of the year. However, as a sort of New Year, Halloween also reminds us that life is indeed a cycle, and the sun and nature will soon grow again. We must acknowledge the darkness, and all of its mysteries, to truly appreciate the light.



"Bad Jews" is billed as a comedy, and it is very, very funny. It is also a heartbreaking and deeply emotional work. The play takes place in the NYC apartment of Jonah (Alex Marz) who is being visited by his cousin Daphna (Alison McCartan), and a little later by his brother Liam (Victor Shopov) and his fiancé Melody (Gillian Mariner Gordon). They are all brought together in this cramped space because of the death of their grandfather Poppy for whom they will begin sitting Shiva the next day. Liam and Daphna, between whom there is already much tension, engage in a battle over who should have possession of Poppy's Chai which is the Hebrew symbol for life and is now a necklace. Poppy carried the Chai with him during his time in a concentration camp during the Holocaust, hiding it under his tongue. Daphna and Liam, each of whom believes they are more deserving of this precious heirloom go at it hammer and tong. Jonah wants to just stay out of it, and poor Melody, who is meeting her future cousin in-law for the first time, is


caught completely off guard by the anger she witnesses, and by the nasty comments that are directed at her by Daphna. The words are cruel and cutting, but the scenes are also uproariously funny. Funny, that is, until it begins to sink in just how cutting and cruel the comments are. Daphna and Liam get into it about who is the better Jew and the meaning of Jewish culture. The cast is excellent, and

while Liam and Daphna are center stage for the greater part of the play, Melody and Jonah have roles that deeply impact how the audience will feel at the end of the perfor-

Whether you are Jewish or not, watching playwright family in it.

Joshua Harmon's finely constructed work will resonate with anyone who has dealt with the dynamics of a family at odds with each other. The History of Animation: The Birth of Bugs



"A Wild Hare"

In 1937 Porky Pig went on a duck hunt and flushed out one of Warner's biggest cartoons stars, Daffy Duck. In 1938 that cartoon was essentially remade with one altercation, it was retitled Porky's Hare Hunt and the duck became a nutty white rabbit with an almost supernatural ability to drive the hunter crazy. The cartoon was met with little fanfare, mostly because it was so similar to Daffy's debut the previous year. As director Ben Hardaway said, "That rabbit was just Daffy Duck in a rabbit suit."

Even Tex Avery, who would come to be known as the father of Bugs, initially saw little promise in the rabbit. "We didn't feel that we had anything until we got it on the screen and it got a few laughs," he said. "After we ran it and previewed it and so forth, Warner liked it, the exhibitors liked it, and so of course [the producer] ran down and said, 'Boy, give me as many of these as you can!' Which we did."

Despite these less than stellar predications, the screwy rabbit appeared in two more cartoons where his magical abilities were accounted for as he was revealed to be part of a stage act in Prest-O Change-O and then Hare-um Scare-um.

The rabbit's popularity was growing and the design needed to evolve into a distinct character. Charlie


ticular gift for cartoon rabbits (he designed Max Hare for Toby Tortoise Returns) was approached by story man Tedd Pierce to refine the rabbit that would become Warner's biggest star. Drawing from his experiences with the rabbit cartoons he created while at Disney, Thorson designed the star for 1940's A Wild Hare...and so Bugs Bunny was born.

There would be modifications but the long-eared icon was solidified in A Wild Hare. He was gray and white and never without his white gloves. His love of carrots



was instant and "What's up, Doc?" was forever his greeting phrase. Where it came from nobody knows for sure, though theories have circulated including that it came from the sight of Clark Gable eating a carrot in It Happened One Night.

Be that as it may, A Wild Hare not only introduced the Bugs we know today but set the standard for future cartoons. Bugs lives in his rabbit hole, usually in the forest, where he is hunted out by a physically more powerful but intellectually challenged enemy, namely Thorson, director of Hare-um Elmer Fudd. Elmer's appear-Scare-um and a former ance also went through a first stuck his long ears out Disney animator with a par- number of physical changes



going from the egghead of his early days to a rolli-polli maroon in the early 40s. But in A Wild Hare everything is classic Bugs vs. Elmer, right down to Elmer's oversized hunting cap. A Wild Hare is really the prototype for what is commonly thought of as a Bugs Bunny cartoon, from the dimwitted hunter, to Bugs' extraordinary tricks and stunts, to the classic "play dying" gag. In one cartoon it not only polished Bugs Bunny's look, pitted him against his archenemy, immortalized his

Brooklynesque voice by the legendary Mel Blanc, and provided an outlet for his classic gags.


A Wild Hare proved so popular that Bugs became an instant star (inexplicably, though, he reverted back to his old look for the following year's Elmer's Pet Rabbit). The formula was repeated with variations in Hiawatha's Rabbit Hunt, The Heckling Hare (the cartoon that got Tex Avery fired from Warner Bros. after a dispute with studio boss Leon Schlesinger over the cartoon ending), All This and Rabbit Stew, Wabbit Twouble, and The Wacky Wabbit.

The appeal of Bugs Bunny is primal and timeless, dating as far back as the Aesop and Uncle Remus, the trickster rabbit armed with nothing more than his wit can outsmart his burliest foes. But to ensure his enduring popularity, the Warner animators knew he had to have a human vulnerability and Bugs' overconfidence did occasionally get the best of him in the few cartoons in which he was not the victor, including his three races against Cecil Turtle (Tortoise Beats Hare, Tortoise Wins By a Hare, and Rabbit Transit). But even then Bugs exhibits what most humans can only wish, the gift of grace and wit under pressure. No wonder he remains one of the most popular cartoon characters more than 70 years since he of the rabbit hole.

Saint Marcellus the Centurion

In the year 298 the birthday of the Emperor Maximian Herculius was celebrated with extraordinary solemnity and feasting. Marcellus, a Christian centurion or captain in one of the legions that was stationed in Spain, refused to take part in the sacrifices offered to the pagan gods and declared himself a Christian. He also threw down his arms and the vine-branch, which was the symbol of his rank (Roman officers were forbidden to strike a soldier with any instrument except a vine-branch), which the centurions usually carried

in their hands.

Anastasius Fortunatus, the prefect of the legion, having learned of the deed of Marcellus, committed him to be cast into prison. At the conclusion of the feast, he ordered Marcellus to be brought before Fortunatus then asked him what was the reason for his conduct. Marcellus declared it was his religion.

Fortunatus told him that he was obliged to lay his case before the Emperor Maximian and Constantius Caesar. Marcellus was sent under guard to Aurelian Agricolaus, vicar to the pre-

fect of the praetorium, who was then at Tangier, in Africa. When Marcellus admitted to the truth of the accusation, the vicar passed sentence of death upon him for desertion and impiety, and ordered that he be beheaded. Cassian, the notary of the court, refused to write the sentence, which he declared to be unjust. In consequence of this, he too was condemned to death. Saint Marcellus was beheaded on October 30 and Saint Cassian suffered martyrdom on December 3rd. Saint Marcellus feast is celebrated on October 30.

Getting your pooch or cat safely into a car or onto a plane requires some thoughtful planning.

Traveling with pets is becoming more and more popular. Today's dogs, and even some cats, are vacationing thanks to friendlier airlines, safety innovations, petfriendly hotels, resorts, campsites and restaurants with outdoor dining privileges.

Here are a few tips to keep pets safe while traveling:

BY PLANE: In most cases, it's safe for your pet to travel by plane if your vet gives the OK. Animals accustomed to traveling in a car, going out on walks and who are socialized tend to travel very well depending on their personalities. Traveling internationally or even crossing state lines in a plane requires a health certificate from your vet. Additional ways to prepare:

Make sure vaccines (especially rabies) are up to date. Consider an ID collar and a tag, perhaps even a microchip.

The trend nowadays is against sedation unless significant risks for pet injury exist. Sedation can cause the pet to feel unstable and cause more fear. Cats tend to fly pretty well because they are usually allowed in the cabin in a cat carrier under the seat. Preparations for international travel with pets can be complex and there may be extensive planning. Double check with the airlines and your destination's consulate to make sure you have the most up to date information about the papers you are required to bring. Many documents for international travel require the signature of a certified USDA veterinarian, which adds an additional step. Pet travel companies, like travelpets.com remove a lot of the guesswork. It's very tedious to have to do the work yourself. In many cases, you would have to start six months ahead of time.

BY CAR: A few pointers for traveling safely with dogs in Food Drive a success. motor vehicles:

Have your dog always wear a specially designed dog seat belt or dog car harness in front and back seats.

Make sure there adequate ventilation.

Never let your dog put its head outside the window, as this can lead to ear and eye injuries.

For cats, provide a good carrier, a place to sleep, and a safe place for the litter box. Make sure they cannot escape if the doors or windows accidentally open.

BY BOAT: Some innovative products make boating and sailing with your dog reasonably safe. There are dog life vests, so if they do fall overboard you can pull them up. Dogs can also use puppy pads and artificial turf products for elimination. Your pet can get acclimated fairly easily, but do that well ahead of time.

BASIC TIPS: Make sure your pet is well groomed (not itchy and dirty.)

Take along some comforts of home — bed, blanket, toys, and a litter box.

Rather than buying new types of food, carry your pet's familiar food from home when practical.

Carriers should be big enough for standing and turning around, with room for food and water.

Place absorbent towels on the carrier floor in case of accidents.

Have a pet first aid kit for emergencies.





Parla Come Mangi!

(Speak as You Eat!)

Benvenuti! Bread, along with olive oil and meat, is a staple food in Tuscany. The great 13th century poet Dante Alighieri, exiled in Ravenna after being banished from Florence by the "Black Guelph" faction in 1302, remarked upon "the saltiness of other people's bread". Back in the Middle Ages the Tuscans were in fact baking their rustic bread "pane sciocco" without the addition of any expensive salt making the point that there is no need to add salt to bread since its ultimate purpose is to accompany salty specialties such as sausages, cheese or meat dishes. To this day, pane toscano remains saltless although Tuscan bread specialties include many varieties of flour blends, ingredients and shapes. Along with bruschetta, crostino toscano remains one of the favorite Tuscan appetizers, easy to prepare and sure to be enjoyed by all.

Crostino Toscano (toasted bread with chicken livers) Ingredients (serves 6)

1 small onion (finely chopped)

3 Tbsp olive oil

1/2 lb chicken livers (cut into pieces)

1 glass of dry Marsala or Vin Santo wine

Salt and pepper 3 ½ Tbsp anchovy fillets

3 ½ Tbsp capers (in jar)

3 ½ Tbsp butter

Tuscan bread (white bread)

Preparation: gently sauté in a skillet the onion with the olive oil. Add the chicken livers to the onion and cook for a few minutes. Pour the Marsala or Vin Santo and simmer until the liquid has almost evaporated. Season the chicken livers with salt and pepper and cook on low heat for 5 more minutes. Leave to cool slightly, then place in a food processor with the anchovy fillets, the capers and the butter blend to a very fine purée. Toast the slices of bread in the oven and spread thickly with the chicken liver paste. Buon appetito!

Crostino Toscano Ingredienti (serve 6)

1 cipolla piccola (tritata finemente) 3 cucchiai di olio extravergine di oliva 250 g di fegatini di pollo (tagliati a pezzi)

1 bicchiere di Marsala o di Vin Santo Sale e pepe 50 g di filetti di acciughe 50 g di capperi sott'aceto 50 g di burro

Pane Toscano affettato

Preparazione: fai soffriggere la cipolla e l'olio in una padella. Aggiungi i fegatini di pollo e cuoci per alcuni minuti. Versa il Marsala o il Vin Santo e fai cuocere fino a quasi completa evaporazione del liquido . Aggiusta di sale e pepe e lascia cuocere a fiamma bassa per altri 5 minuti. Lascia intiepidire e poi versa il tutto in un mixer, aggiungi I filetti di acciuga, i capperi ed il burro e riduci in purea. Tosta le fette di pane in forno e cospargile con un generoso strato di purea di fegatini. Buon appetito!

Nanna & Babbononno

A Nostalgic Remembrance



I was in junior high school attending the Joseph H. Barnes School on Marion Street in East Boston. I believe that it is a senior residence today, but back then, it was one of three middle schools in East Boston. I had become friendly with a few boys who were not from my immediate neighborhood and they convinced me to join the Boy Scouts.

When I was a Cub Scout at the Sacred Heart Parish, I wondered if there were Scout troops nearby as I loved anything military and scouting was the closest I would get until I was an adult.

Two new classmates, John Di Nicolantonio and Peter Bartolo belonged to the Boy Scout troop at St. John's Parish on Saratoga Street near the fire station just outside of Day Square. I appeared one Thursday night and joined, I believe Troop 12, Panther Patrol. I was introduced to Fred Marino, the head of scouting and his associates Peter Interbartolo and Tony Abbatessa. With their directions imbedded in my mind, I convinced my mother that I wanted to be a Boy Scout and needed a uniform to correspond to my new choice in life. Dad agreed that I should have a fitting uniform, and with Nanna and Babbononno en tow, we headed to the boy's department at Jordan Marsh and the counter that catered to Boy Scout needs.

Well, Dad and Babbononno observed as I tried on the correct uniform and picked out the patches that corresponded to the troop and patrol I now belonged to. When the salesperson mentioned alterations, Babbononno insisted that the changes could only be handled by his friend, Billy the Tailor. Billy D'Allesandro had a tailor shop across the street from the front entrance of East Boston High School. He had magic fingers. When he used a needle to make alterations, he could take a rag and make it look like it came from the Armani collection. The following week, I showed up at the Boy Scout meeting in my altered uniform and took my place next to my new comrades in the Panther Patrol.

I loved Boy Scout life and threw myself into it becoming a participant in all of the events that they sponsored.

As a matter of fact, the only time in my life I wanted to attend a summer camp was when I was a Boy Scout. Dad was on the road during the summer months playing county fairs throughout the northeast with either his own band or as part of the rhythm section of other bands. To me, this was more fun than camp and Mom and I always accompanied him on these summer excursions.

The fall of my first year as a scout, the scoutmaster decided on a Halloween party to be held on October 31. Each patrol member then decided on whether we should show up in uniform or dress for Halloween. Halloween won out. I had to decide on a costume and made a decision based on something that had happened a couple of years earlier, on January 17, 1950 ... the Brinks robbery. At about 7:30, the night of the 17th, a group of men dressed in Brinks uniforms and face masks, robbed the Brinks depository in Boston's North End. It soon became international news as it was classified as one of the most brazen robberies in American history.

My decision was to design a Halloween costume that resembled one of the Brinks robbers but with a bit of comedy thrown in. I asked Babbononno for a pair of his old pants that weren't worn anymore. When he gave them to me, he added in an old sport jacket that had seen better days. I found a black dress shirt and a white necktie. With a farmer's back pocket handkerchief falling out of the breast pocket of the old sport jacket I was on my way. Dad came up with an old scally cap that Grandpa Christoforo had used when he worked on construction and it almost fit. The following day, I headed for a junk store that was located on Meridian Street between Eutaw and Trenton Streets. It was next to Lenny's Spa, a coffee shop that was a local hang out. When I say that they sold junk, I'm giving the merchandise they sold, a compliment. Anyway, I found a rubber mask that made me look like a tough guy. I also found a rubber cigar that I could add into the mouth area of the mask. A rubber knife and a large black plastic pistol were shown to me by the store owner and I added them into the image I was trying to put together.

I think I bargained with the proprietor of the store and purchased everything for about \$1.50. It was all I had and I think he still made a profit. Once home, I found a child's brief case that Uncle Nick had given me when I started kindergarten. On the front of it, I pasted a piece of white cloth, but not until I painted a word on the front in all caps, BRINKS

Well, the night of the Halloween party came and I dressed for the occasion. Babbononno supervised my comic appearance: his old pants were held up by a wide Garrison belt, and I added in the black shirt, white necktie, old oversized sport jacket with farmer's handkerchief hanging out of the breast pocket, and the scally cap placed on my head above the rubber mask with the cigar butt hanging out of the frowning mouth. The rubber knife and the pistol were tucked into the Garrison belt in plain view and the last touch was the brief case with BRINKS printed on the front.

I accepted a ride to the party from Dad who was on his way to work, playing for an adult Halloween costume party at the Copley Plaza Hotel. When I arrived at the lower level of St. John's church, I became an instant hit. All the other scouts were in costume but none came close to mine. I felt kind of proud of myself and my imagination. The evening continued and a record machine played the songs of the day. I found it difficult to eat any of the food with my mask on and couldn't get the open end of a Coke bottle through the frowning mouth, so when I ate, off came the mask and everyone then knew who the little gangster

After we all had eaten, someone announced that we were going to have a judging of the costumes for prizes. We scouts then marched around the perimeter of the assembly room in the basement of the church and when the music finally stopped, they announced the winners, "The prize for best costume goes to John Christoforo!" I jumped for joy. And to this day, I don't remember who won second or third prize, or what I won for a prize. Unfortunately, no one took a picture and the parts of the costume are long gone.

That episode of my young life happened over 60 years ago, and each October 31, when a child appears at my front door and announces, "Trick or treat," I think about that Boy Scout party from the early 1950s and the wonderful time I had. Happy Halloween, and

the Orchestra's 2014-15 seasons. Tilson is currently the longest-tenured music director at any major American orchestra, and has surpassed Pierre Monteux as the longest-tenured San Francisco Symphony Music Director. Tilson assumed his post as the SFS's 11th Music Director in September 1995, consolidating a strong relationship with the Orchestra that began two decades earlier with his SFS debut at age 29, leading the Orchestra in Mahler's Symphony No. 9.

A Los Angeles native, Tilson Thomas began his studies at USC, where he studied piano with John Crown and conducting and composition with Ingolf Dahl. At 19, he was named Music Director of the Young Musicians Foundation Debut Orchestra and worked with Stravinsky, Boulez, Stockhausen, and Copland on premieres of their works at Los Angeles's famed Monday Evening Concerts.

At age 24, after winning the Koussevitzky Prize at Tanglewood, Tilson Thomas was appointed Assistant Conductor of the Boston Symphony Orchestra (BSO) and made his New York debut when he replaced Music Director William Steinberg mid-concert at Lincoln Center.

Violinist Gil Shaham was named Musical America's "Instrumentalist of the Year" in 2012, and is regularly sought after for concerto appearances with leading orchestras and conductors. He routinely gives recitals and ensemble appearances on the great concert stages and at the most prestigious festivals. Shaham was born in Champaign-Urbana, Illinois in 1971, and later moved with his parents to Israel, where he began violin studies with Samuel Bernstein of the Rubin Academy of Music at the age of seven. PATRIOTS PILE UP 51 POINTS TO BURY BEARS

They were once the "monsters of the midway," but last Sunday at Gillette Stadium, the Chicago Bears looked more like stuffed animals that the Patriots enjoyed playing with all afternoon. By the time they were through

"toying" with the Bears, Tom Brady and company had outscored Chicago by 28 in a thorough annihilation, 51-23.

In a 31-point second quarter, the New England Patriots sealed their sixth win of the 2014 regular season and sent a strong message to the rest of the league.

Four weeks can be an eternity, the current Patriots case in point. It was just four weeks ago that the team could do nothing right in a Monday night meltdown in Kansas City. They looked washed up, a team that had given up. Since the loss the Patriots have rattled off four

straight wins, it appears once again setting the bar higher than their AFC East competition can reach.

On paper, the Bears are no slouches, Particularly on offense where they feature playmakers in the form of running back Matt Forte to go along with talented wideouts Brandon Marshall, Alshon Jefferies and tight end Martellus Bennett.

Quarterback Jay Cutler is a classic gunslinger, who can throw the ball a mile on target, but can also make dumb decisions. One such ill-advised choice resulted in an easy seven points for the Patriots. Instead of moving onto the next play and taking a sack after being wrapped up by Patriot defenders, Cutler attempted to toss the ball out to a Bears teammate. Instead the ball came loose and Rob Ninkovich gratefully scooped it up and proceeded 15 more yards into the end zone.

"It was a good team play there," said Ninkovich, "It wouldn't have happened if it wasn't for a collective group of men that were all over him. I was able to just scoop it up, didn't feel anyone around me, stand up, and run it in. Isn't that what you're supposed to do?" Exactly what a defender is supposed

to do following a move a quarterback should never attempt.

The Patriots defense did manage to sack Cutler successfully three times while also adding an interception by cornerback

Darrelle Revis.

Newly acquired linebacker Akeem Ayers, picked up in a trade with the Tennessee Titans last Tuesday, made a quick contribution, accounting for one sack as well as consistent pressure. "It felt amazing. I haven't had one of those in a long time,"

said Ayers. "I prepared as best I could. It was fun to let loose."

Where the Patriots defense was successful, the Bears defense unequivocally failed. For the bulk of the game, Bears defenders looked stunned, and in awe of Tom Brady and the Patriots offense. "We flat out

got it handed to us." said Chicago defensive end Jared Allen.

Brady completed 30 of 35 pass attempts for 354 yards and five touchdowns, three of which were to tight end Rob Gronkowski, who destroyed single defenders and required a team of tacklers to bring down.

"Everything was working," said Brady after the game. "We have a lot of confidence in what we're doing and we have to keep doing it."

MICKEY MANTLE WAS THE BOOMER'S BABE RUTH AND JOE DIMAGGIO ROLLED INTO ONE


Growing up a baseball fan in the late '50s and '60s, I loved the Red Sox and went to countless games every season, sat in the bleachers for cheap money and rooted for the old town team despite their pathetic play. However, when it came to my greatest experiences at Fenway Park, it was to see the Yankees and Mickey Mantle in centerfield. On several occasions, he would hit a ball out of the park either to left, right or center since he was a great switch hitter. Once or twice, I saw him hit two homers in a game, one from each side of the plate.

I viewed him as the ultimate ballplayer, better than the rest, as Tina Turner often called herself in that old tune of hers.

America loved the Mick (1933-1995). He epitomized what the game meant during the '50s and '60s. Babe Ruth may have been the Sultan of Swat but Mantle was its Prodigious Prince.

Mantle played two Minor League seasons before making the Opening Day lineup in 1951. He was sent down again in midseason to Triple A Kansas City. He got into the swing groove and returned for good to New York in late August and was there over 18 seasons doing it all through lots of pain along the way.

In his 18-year career (1951-68) he hit 536 homeruns and won three AL



MVP Awards, 1956, 1957 and 1962. In 1961, he hit 54 homers in the race to break Babe Ruth's single season high 60 homers. Injured late that season, Roger Maris finished with 61 homers besting Ruth's HR record.

Over his long career he was Mr. Baseball and Mr. October. He did all that he despite overcoming many injuries and ailments. He always said. "Passion helps you find a way to do something." One of the highest paying ballplayers of his generation, he once said, "When I'm hitting, I'd play for nothing. When I'm not, any kind of money I receive makes me feel as if I'm stealing.'

He was elected to the Hall of Fame in 1974 and to Major Leagues All Century Team in 1999. Mantle and the Yankees won 12 American League pennants. In a dozen World Series, he hit 18 homers, knocked in 40 RBIs, scored 42 runs, 43 walks 26 extra-base hits, and had 123 total bases, all records.

Mantle was born in Oklahoma and grew up in Commerce. On his high school graduation day, the Yankees signed him up for \$140 a month and an \$1,150 signing bonus, which in those days was big money.

The Mick was candid later in life as he battled with alcohol. He once said that if he knew he would live so long, he would have taken better care of himself. His father and grandfather both died in the early 40s, he thought he would too. He ended up escaping that part of his family tree.

He ended up losing his life to the damage he probably did to his liver at age 63. I remember where I was when I heard the news. I was on vacation up in Bristol, N.H. eating at a diner a few miles north of Newfound Lake. I felt so bad hearing the sad news, I felt a part of my past had come to an end, the Mick really wasn't Superman or indestructible.

Boston legend Ted Williams once said, "Mantle was the greatest hitter he ever saw.

Mantle's career ended following the 1968 season. Mantle called it a career after realizing his injuries and inability to play at top form. He finished 1968 a shadow of himself only hitting .238. His final game was September 28, 1968 against the Boston Red Sox at Fenway Park. The best of all hitters had his final at-bat in a season called "The Year of the Pitcher."

He will forever be remembered by true baseball fans as one of the greatest hitters of all time and he did it amazingly through much pain and agony. I got to see him play and I will always cherish that gift.


