### The Fall of Traditional Media

When we would think of traditional media outlets or networks the most common would most likely come to mind, including ABC, NBC, CBS, CNN, *The New York Times* and the *Washington Post*. But the focus has changed dramatically over the past few years, with the most listened to broadcasts typically podcasts.

Joe Rogan, out of Austin Texas, averaging 11 million viewers per episode, is the most listened to broadcast in the nation. In comparison CNN can't seem to attract more than 400,000 viewers to its primetime line up, which is less than 4% of what Rogan pulls in. Elon Musk's X is said to be the number 1 source for news in the world.

The Washington Post has reportedly lost more than \$70 million dollars and 50% of its audience in 2023 and looked to be on track to lose more than \$75 million in 2024. A number of well-known, high-profile reporters have departed for other publications. One of the top reasons for the change

in viewership and decrease in readership is the loss of respect the traditional media has encountered due to the lack of integrity, ethics and honesty.

Just look at how many media outlets covered for the Biden/ Harris administration and their inept governing ability by outright lying or censoring factual information, including President Biden's cognitive decline, all while defaming President-elect Donald Trump and his supporters. Thankfully these efforts failed, exposing the biased media for the manipulative hypocrites they truly are.

According to Gallup, only 27% of independent voters trust the media, and only 12% of Republicans say the same. With the number of viewers and readers on the downslide, it is unsustainable for traditional large-scale newsrooms, and national newspapers to continue moving forward without drastic changes. The days of big paydays for network and

# President Biden Signs Bill Increasing Social Security Benefits for Millions of Workers

Employees, including teachers, policemen, firefighters and other public sector workers were stripped of a portion of their social security benefits, President Biden signed the Social Security Fairness Act, paving the way for nearly three million workers to boost their monthly social security benefits. The bipartisan legislation repeals two provisions, the Windfall Elimination Provision (WEP), and Government Pension Offset (GPO), that reduced social security benefits for certain public workers who also receive pension income. These provisions had been in place for over four decades and were implemented under President Ronald Reagan. While advocates of the bill say this rights a decades old disparity, others believe it will place an added strain on Social Security Trust funds, which are facing an insolvency crisis.

The WEP reduced social security benefits for individuals who receive pension or disability benefits from employment where social security payroll taxes were not withheld. As of December 2023, that provision affected approximately two million Social Security beneficiaries. The GPO reduced Social Security benefits for spouses, widows and widowers who also receive income from their own government pensions. In December 2023, the GPO affected almost 750,000 beneficiaries.

"By signing this bill, we're extending Social Security benefits for millions of teachers, nurses and other public employees and their spouses and survivors," Biden said after signing the bill. This could mean an estimated average of \$360 per month increase. The extra income is a big deal for many households. More than two and a half million Americans will receive a lumpsum payment of thousands of dollars to make up for a shortfall in benefits they should have received in 2024. The Social Security Fairness Act will affect Social Security benefits payable after December 2023.

Advocacy groups who pushed for the changes praised President Biden for signing the bill. "Our organization has spent decades lobbying for the repeal of the WEP and GPO. We endorsed the Social Security Fairness Act and are gratified to finally see this legislation

enacted and signed by the president," Max Richtman, president and CEO of the National Committee to Preserve Social Security and Medicaid said in a statement. "This victory is more than forty years in the making, while we celebrated today, we also reflect on those who were impacted by these provisions but are no longer here to witness this change. Their service and contributions are not lost on us, and we honor their legacy by continuing to advocate for fairness in retirement benefits for all public servants," he added.

The bill was passed by the Senate with a bipartisan vote, including Senators Sherrod Brown, D-Ohio, and Susan Collins, R-Maine, who co-led the legislation in that chamber. The House also passed the legislation in a bipartisan manner led by Representatives Garrett Graves, R-LA, and Abigail Spanberger, D-VA.

#### Lawmakers Split Over J-6 Pardons

I am putting this column together on January 6<sup>th</sup>, which is also the 4th anniversary of the January 6th so-called insurrection at the U.S. Capitol. ## Stirpe Nostra

#### **VITRUVIUS**

Marcus Vitruvius Pollio, writer, engineer, and architect is my last scholar in the Augustan Period of Latin Literati. He served as an architectural advisor to Emperor Augustus. This emperor's reign of forty-one years was called the Augustan Age, and was for Rome what the Age of Pericles was for Athens. Supposedly, it was Vitruvius whose able assistance made it possible for Augustus to boast that he found Rome a city of brick and left it a city of marble.

Vitruvius was in the twilight of his career when he composed his famous work entitled De Architectura Libri X (The Ten Books of The eighth be Architecture) in which he detailed four of the five.

Architecture) in which he detailed four of the five "orders of architecture" and laid down rules for their proportions. He also set rules for column spacing, how they should be located and grouped.

His first book describes in general, the science of architecture, and suggests the proper education for an architect. Book I also treats city planning and fortifications. Book II is completely taken up with recommendations as to the use of building materials. The third and fourth books are devoted to temples and how the orders of architecture are employed. For those who are unfamiliar with the term "orders of architecture," may I define that an order of architecture is a column with capital, setting on its base, and the entablature (horizontal construction) above.

The Greeks developed three orders of architecture and these are called: Doric, Ionic, and

Corinthian. The Romans accepted (or copied) these three Greek orders, and then added two more of their own design. These two additional Roman orders are called the Tuscan and the Composite. The key to the correct use of the orders is based upon mathematical proportion, and any attempt to vary from the established rules would be to create optical distortion and consequently a disproportionate structure.

The fifth book of Vitruvius relates to buildings for public use, the sixth deals with houses of the "domus," while the seventh discusses interior decorations.

The eighth book deals with the subject of water for community use, how it is found, the various kinds, and the methods used to convey it to required destinations. Sundials and other means for measuring time are discussed in this ninth book, while machinery used in building construction, and military engines occupy the tenth book. These ten books by Vitruvius are considered to be a summary of the works of numerous Greek architects and Roman writers on architecture.

Little else is known about Vitruvius except that his probable birthplace was in Formiae and he died during the reign of Augustus. Formiae was a very ancient town in Latium, on the Via Appia.

About fifteen hundred years later, the work of Vitruviuis became a basic guide for the great architects of the Renaissance.

## Celebrity Opinions Non-Starters

It seems many Americans prefer not to hear celebrity opinions or political endorsements as most seem to be suffering from post-election "information overload" according to a recently released poll. AP-NORC Center for Public Affairs Research published a poll titled, "Most adults feel the need to limit political news consumption due to fatigue and information overload."

Sixty-one percent of Republicans strongly/somewhat disapproved of celebrities speaking out about political issues, while 27% neither approved nor disapproved and 11% strongly/somewhat approved. For Democrats 20% strongly/somewhat disapproved, while 40% neither approved nor disapproved and 39% strongly/somewhat approved.

Much of America is still processing the 2024 contentious election results, with many burned out on political news altogether. Sixty-five percent of adults have felt the need to limit their media consumption about the government and politics due to information overload, fatigue, or similar reasons and half feel the same for overseas conflict. Around four in ten adults feel the same way about news on the economy and climate change, according to the poll's summary findings. Democrats are more likely than Republicans to limit their "media consumption" of stories about government and politics at 72% vs. 59% respectively.

"People are not eager for politics to mix with their entertainment or commerce experiences. Forty-three percent of adults approve of small businesses speaking out on political issues and 20% disapprove. One quarter approve of celebrities, professional athletes, or large companies speaking out, while four in ten disapprove," according to the summary. The study also noted that "Democrats are more likely than Republicans to approve of celebrities, professional athletes, and large companies speaking out about politics. Small businesses speaking out on political issues is viewed similarly by Democrats and Republicans."

One major point of interest from the 2024 election showed podcasts that focus on political and cultural commentary, such as the "Joe Rogan Experience," seemed to influence voters more than endorsements from celebrity entertainers. When Taylor Swift endorsed the Harris-Waltz campaign in 2024, it was believed to be a devastating blow to the Trump campaign, however President-elect Donald Trump's decisive victory over Vice-President Kamala Harris proves that Swift and other celebrity endorsements may not have the impact Democrats were hoping for.

According to AP VoteCast, 44% of women between ages 18 and 44 voted for Trump, while 48% of women 45 and older supported him.

## President Biden's Mental Decline Began on Day 1 of Presidency

The lack of access to the nation's oldest president began during his 2020 election bid and continued throughout his fouryear term. Presidential staff formed a tight circle around Biden, as soon as he took the oath of office on January 20, 2021, immediately limiting his in- person interactions with the public and press corps. It seems White House staff and personal aides to the president covered up his mental decline from Day 1, limiting his public events and rearranging his schedule after less than lucid performances, according to a newly released Wall Street Journal report. In response to his gaffe prone interviews, Biden hosted the fewest large press conferences in modern history often unable to finish a coherent thought or sentence, but just how much the White House covered his haziness had been hidden, until

this newly released report was made public.

By spring 2021, meetings were being rescheduled to accommodate for his "good and bad days" and adjustments made to daily plans when the president appeared tired or continued to stumble at world stage events. Meetings were often scheduled for later in the day, a fact not disclosed until after Biden's disastrous debate performance against Donald Trump in June of 2020, with his staff finally admitting Biden had difficulty functioning outside a six-hour window that typically closed about 4:00 p.m.

Officials were instructed to make their briefing to the president short and to the point, with meetings with top cabinet officials growing more infrequent as time went on. It's been reported that the White House even went as far as

hiring a voice coach, Hollywood honcho and campaign co-chair Jeffery Katzenberg, to try and improve Biden's faint, raspy voice. Staffers were also known to remove negative reports from Biden's stack of daily news, potentially misleading him about the public's actual opinion of his job performance, reaching a seventy-year low in 2024.

While many presidential aides and staff denounced these rumors as pure nonsense, the signs were clearly evident from the onset of Biden's presidency, He habitually relied on note cards, had large directions printed out for him, mixed up the names of foreign leaders and dignitaries or other facts when he went off script or ignored his teleprompter.

The circle around Biden during the 2024 re-election campaign was even tighter with staffers fielding questions more than the president and First Lady Jill Biden often holding the president's hand in public as she apparently attempted to prevent him from answering questions from the press. The Wall Street Journal report clearly indicates there was a large scale cover up carried out by the president's family, closest aides, staff and the complicit national news media who were willing to go to any extreme necessary to re-elect Biden over Donald Trump. Had it not been for Biden's cataclysmic debate performance, the course of U.S. history might have looked very different.



#### From the Greatest Generation to Gen Beta

First came the greatest generation born in 1901 to 1927, next was the silent generation from 1928 to 1945, then came baby boomers from 1946 to 1964, generation x was 1965 to 1980, millennials were born from 1981 through 1996, Gen Z ran from 1997 to 2012, followed by Gen Alpha spanning from 2013 to 2024 and now babies born in 2025 will be the first of a new peer group known as Generation Beta, lasing until 2039.

This newest generation "will inherit a world grappling with major societal changes, climate change, global population shifts, and rapid urbanization at the forefront, sustainability will not just be a preference but an expectation," wrote Mark McCrindle, who coined the term "Generation Alpha". He also noted that by 2035, Gen Beta will make up 16% of the world's population and live in a world powered by artificial intelligence (AI). "Generation Beta will live in an era where AI and automation are fully embedded in everyday life, from education and workplaces to healthcare and entertainment," he explained.

McCrindle also predicted that parents of Gen Betas, who are mainly Gen Zers, may take a different approach to social media use than previous generations. "While many millennial parents used social media to document their children's lives, Generation Z know more about both the positives and challenges that come with social media use at a young age. Gen Z parents are more likely to strongly agree that limiting their child's screen time is a high priority for them."

Generational researcher Jason Dorsey pointed out that Gen Betas will be born in a post-pandemic world, which they will learn about in history class. "It'll be something that maybe older siblings went through, certainly something they learn about in history, but not something that is necessarily a contemporary event," he stated. When Gen Betas are old enough to vote, Gen X, or those born from 1965 to 1980 will be the demographic in power. "We will likely have Gen Z as elected officials when Gen Beta is old enough to vote, and climate change will continue to be a big deal for them," Dorsey added.

#### Massachusetts Native and WWII Pearl Harbor Veteran

### HARRY CHANDLER

Passes at 103 years old

Harry Chandler, Holyoke, Massachusetts native and longtime resident of South Hadley passed away on December 30, 2024 at 103 years old. Chandler was a Navy medic and hospital corpsman  $3^{\rm rd}$  Class when waves of Japanese firefighter planes dropped bombs and fired machine guns on battle-

ships in Pearl Harbor, Honolulu, Hawaii, on December 7, 1941. He is the third Pearl harbor survivor to die in the past few weeks.

He told the associated Press in 2023 that he saw planes approach as he was raising the flag that morning at a mobile hospital overlooking the base. "I thought they were planes coming in from the states until I saw bombs dropping," Chandler said. The harbor was covered in oil



from exploding ships, so he boarded a boat to help pluck wounded sailors from the water and washed the sailors off after lifting them out. "It got so busy that you weren't scared. It was after that you got scared."

The attack killed more than 2,300 U.S. servicemen. Nearly 1,200 were sailors and Marines on board the USS Arizona,

which sank nine minutes after it was bombed. Chandler recalled his memories while attending a 2023 ceremony commemorating the 82nd anniversary of the bombing, "I look out there, and I can still see what's going on. I can still see it happening. We should have known that was going to happen. The intelligence should have been better," Chandler told the Associated Press.

## I Was Frank Bellotti's Friend for 54 Years

Over the years I was amazed at how persistent he was. He had more than his share of losing but he kept coming back and he ended his career on an up note having served three terms and 12 years as the state attorney general. I called him my friend and also became friends with his family, too.

Several years ago when I retired as a police officer, I was given an award at a Massachusetts Italian American Police Officers Association at which Frank Bellotti would be a speaker. I attended this function with my daughter and introduced her to Mr. Bellotti and the first thing he told my daughter, who was 27 at the time was, "I knew your father since he was only 22." My daughter was impressed with Frank Bellotti's words to her.

The last time I spoke with Frank Bellotti was at his 100th birthday party on May 4, 2023. I remember that date well since I turned 75 years old that very same day. He and I smiled and wished each other Happy Birthdays.

I was so appreciative that year when his son Michael called and told me to be there. Frank Bellotti was an old school Democrat, never an ideologue and saw himself as a voice for the people. It was never about him but about the role in life he accepted. God gave him a long life in which to use those talents God gifted him. We are all here for a purpose and apparently God decided that Frank had finished his race down here and has now crossed the finish line

Let us never forget him and all the good he accomplished in his long life among us.

However, as much as January remains firmly enveloped by the trappings of winter, it does frosty temperatures often come intrigue us with soft whispers of spring. In Italy, no January holiday better introduces the coming spring than the Feast of St. Anthony the Abbot, or

which occurs on the 17th of the month. Because the eponymous fourth-century hermit is the patron saint of domestic animals, many Italians celebrate his feast day by honoring their pets or, if living in an agrarian community, their livestock. In many areas, farmers bring their livestock to the local church for a blessing. I remember watching one such ritual with my father on the Italian channel, my curiosity sparked by the lines of sheep, horses and cows winding their way through the cobbled streets of a medieval town towards the church, where a priest waited to bestow a benediction. This quaint festival reminds me of the nature which starts to blossom under the cold, snowy ground. The first tiny flower seeds are slowly budding beneath the ground, ready to wink hello to the world as the crocuses and snowdrops of February. Sheep begin the process of birthing lambs around this time as well. I know that sooner than I can expect, robins will be hopping among bare tree branches and small green sprouts will peek out of the dirt. In other parts of Italy, people light huge bonfires on the eve of St. Anthony's feast day. These bonfires light up the night sky with their bright orange blaze and warm the bodies and souls of all nearby, mimicking the sun's longer duration as winter cedes the way for spring. I sense the magic of la Festa di Sant'Antonio Abate even here, whenever I look up at the pale January twilight and ponder the cycle of the year shifting beneath my feet.

January can be the most exciting of months, bursting with the liminal energy of two seasons. It provides us with the perfect chance to reflect on the beauty and repose of winter, calling us into the tranquility of our homes. Sipping a mug of herbal tea while watching the snow drift, incorporating citrus fruits into desserts, and gathering with family and friends for joyous celebrations that can warm even the chilliest night are wonderful ways to enjoy the winter season. However, January also teaches us to remain forever hopeful for the promise of spring. This anticipation is evident in the Cupids and hearts that decorate store shelves, in the leisurely lengthening of days, and in the folkloristic festivals that honor animals and the natural world. January helps us become attuned to the changing course of the year, and if we always look for the wonders each season offers, we will be instilled with enough hope and optimism to weather the remainder of winter.

#### Here We Go Again!

The news of yet another mass shooting at a Wisconsin Christian School which left two dead, many wounded and the shooter taking out herself, serves as yet another reminder of how unsafe our society has become going back to at least the aftermath of the Columbine High School mass shooting.

Back in 1999, at the police academy I witnessed first-hand the rules of engagement changing dramatically. Instead of law enforcement trained to remain outside a school waiting for a SWAT team to arrive, officers would immediately move in to search and engage the suspect or suspects.

Here we are 25 years later and these attacks on school children continue. One wonders once again why no red flags were spotted of this latest teen shooter. It seems difficult to fathom how school officials did not observe any warning signs of approaching danger. However, even if red flags went up, what does anyone do in response to seeing those warnings? Scarier too, now school shooters are no longer just young males as the last two school shootings

Once again the immediate reaction from anti-gun activists and liberal Democrats is to blame the weapon rather than the shooter. Didn't her family, the school teachers or anyone who knew her notice something was obviously very wrong? How did a 15-year-old get her hands on a gun which is absolutely illegal? Who granted her access to a deadly weapon?.

Was she in treatment? Was she on psych medicine? Did she have a therapist? All important questions in need of answers. It is always easier to see things clearly when using hindsight, not so much in real time.

School shooters cannot become the norm. Many blame the lack of enough anti-gun legislation but I question what affects young people to grow so dark that they would contemplate killing others. I think we need to look at social media as a possible culprit. Too many young people spend too much time on their screens and get overdosed by this addiction to the web where reality quickly gets distorted pushing people down a rabbit hole into darkness. We may never know why the latest shooter did what she did. Her motives may never be fully understood.

However, as a society we must deal with the rise in mental health issues affecting our young people. This violence we see all too often cannot continue to happen without understanding it and effectively dealing with it.

We need to keep our schools as safe as possible but we shouldn't be turning them into prisons. We live in a dangerous world and resource officers need to be mandated into every school in America; private, public, religious, etc. We will never be able to prevent all schools from active shooters but we need to make such occurrences as rare as possible.

As a retired police officer, I say we owe it to our young people of today to keep them safe from harm inside their classrooms. We need to be far more vigilant with their young lives. No more excuses.

## Dilemma Brewing Over Rental Broker Fee

The Boston City Council was set to reintroduce a home rule petition, at their weekly council meeting, Wednesday, January 8, 2025 that would shift the broker's rental fee to the party, lessor or tenant who hired the broker. This move comes simultaneously with Massachusetts Governor Maura Healey's call for abolishing broker fees that renters are often forced to pay when signing a lease agreement. The Massachusetts State Legislature is also considering a similar change during the current legislative session

Healey has publicly stated she supports doing away with broker's fees as an avenue to improve housing affordability in Massachusetts. "I think they should be abolished. I think they should go away. I totally support that, and I support taking action to make that happen, because when it comes to affordability, we're an expensive state", Healey said. However, the Governor stopped short of endorsing the fee to be paid for or absorbed by the landlord instead of the tenant. "The landlord can make their own arrangements," Healey said.

The Governor's comments are part of a movement in Boston and Massachusetts to review a system that places the burden of broker's fees squarely on the tenant. Renters are traditionally required to pay the fee, typically equal to a month's rent, to a real estate broker hired by the landlord. That is in addition to the tenant being required to pay first month rent, last month rent and a security deposit.

Last year, as part of the Senate's housing bill, a policy requiring broker's fees be paid by landlords rather than tenants was considered, but the House of Representatives did not move on the measure. Senate President Karen Spilka noted in her recent Inaugural remarks that the Senate would "try again to shift the burden of broker's fees from renters."

Boston's attempt to shift the burden requires the Massachusetts State Legislature to sign off and approve the measure to bar tenant-paid broker's fees. "Boston remains one of the last major rental markets where prospective tenants are commonly required to pay broker's fees," the petition states.

The Greater Boston Real Estate Board CEO Greg Vasil expressed support of the potential change, offering "Whoever brings a broker to a real estate transaction should be responsible for paying the broker's fee." However, others are fearful this legislation could have the potential to negatively impact realtors, especially if landlords are required to pay the fee. Property owners may decide not to work with a broker or instead pass the costs on to tenants through higher rents.

### St. William of Bourges

William was born into the illustrious family of the ancient counts of Nevers. He was educated by Peter the hermit, archdeacon of Soissons, his uncle by his mother's side. He learned from his infancy to despise the folly and emptiness of the riches and grandeur of the world, to abhor its pleasures, and to tremble at its dangers. His only delight was in exercises of piety and in his studies.

He became a Cistercian monk and took the habit in the abbey of Pontigny. He was in time chosen prior of that house, and then abbot, The cheerfulness of his countenance testified the uninterrupted joy and peace that overflowed his soul.

On the death of Henry de Sully, archbishop of Bourges, the clergy of that church requested his brother Eudo, bishop of Paris, to come and assist them in the election of a pastor. They wanted to choose some abbot of the Cistercian Order, then renowned for holy men, they put on the altar the names of three.

Eudo, accordingly, laid them on the altar; and having made his prayer, drew first the name of the abbot William, on whom,



at the same time, the majority of the clergy had voted on, the 23rd of November, 1200. This news overwhelmed William with grief. He never would have accepted had he not received a double command from both the Pope, and from his Abbot General, He left his solitude, and was received at Bourges as one sent by heaven. He redoubled all his austerities, saying, it was now incumbent on him to do penance for others, as well as for himself. He always wore a hair-shirt under his religious habit, and never added, nor diminished, anything in his clothes either winter or summer.

He never ate meat, though he had it at his table for strangers. His attention to feed his flock was no less remarkable, especially in assisting the poor both spiritually and corporally.

Certain great men abusing his leniency usurped the rights of his church; but the saint strenuously defended them even against the king himself, notwithstanding his threats to confiscate his lands. By his ardent spirituality he converted many of the Albigenses, contemporary heretics, and was preparing himself for a mission among them, at the time he was seized with his last illness. He preached a farewell sermon to his people, which increased his fever to such a degree, that he could not undertake his

Then, according to a sign made by him, he was laid on ashes in the hair-cloth, which he always privately wore. He passed away a little past midnight, on the morning of January 10, 1209. His body was interred in his cathedral. He was canonized by Pope Honorius III in 1217. The Feast day of Saint William de Bourges is January 10th.

#### George Herman Ruth Junior



George Herman Ruth Junior was born February 6, 1895 in Baltimore, Maryland, parents, George, Senior, and Kate. George Jr., was one of eight children, although only he and his sister Mamie survived. His parents worked long hours, leaving little time to watch over him and his sister. The lack of parental guidance allowed George to be a bit unruly, often skipping school and causing trouble.

When George turned seven, his parents realized he needed a stricter environment. They sent him to St. Mary's Industrial School for Boys, run by a brotherhood of laymen from an order of the Xaverian Brothers.

St. Mary's provided a regimented environment which shaped George Jr.'s future. Not only did George learn vocational skills, but he also developed a passion for baseball.

Brother Matthias at Saint Mary's took an interest and became a role model and father figure.

He helped George Jr. refine his baseball skills, working tirelessly with him on hitting, fielding, and pitching. George Jr. became so good that the Brothers invited Jack Dunn, owner of the Baltimore Orioles, to watch George Jr. play. Dunn offered a contract to George Jr. in February 1914 after watching him for less than an hour.

Since George Jr. was only nineteen, Dunn had to be George's legal guardian to complete the contract. Seeing George Jr. for the first time, the Orioles players referred to him as "Jack's newest babe" igniting the most famous nickname in sports history was born. Thereafter, George Herman Ruth Jr. was known as the Babe.

The Babe performed well for Dunn and the Orioles, leading to his sale to the Boston Red Sox. While Babe is most known for his power as a slugger, he started as a pitcher-a very good one. In 1914, Babe appeared in five games for the Red Sox, pitching in four. He made his major league debut on July 11, 1914; however, due to a loaded roster, Babe was optioned to the Red Sox minor league team, the Providence Grays, where he led them to the International League pennant. Babe became a fixture in the Red Sox rotation in 1915, accumulating an 18-8 record with an ERA of 2.44. He followed his successful first season with a 23-12 campaign in 1916, leading the league with a 1.75 ERA. In 1917, he went 24-13 with a 2.01 ERA and a staggering 35 complete games in 38 starts. By then, Babe had displayed enormous power in his limited plate appearances, so it was decided his hitting was too good to be left out of the lineup on a daily basis.

In 1918, the transition turned Babe into an everyday player. Ruth tied for the major-league lead in home-runs with 11, and followed that up by setting a single-season home run record of 29 in 1919.

On December 26, 1919, Babe was sold to the New York Yankees. The Yankees would never be the same again; joining the Yankees, Babe became a full-time outfielder. He dominated baseball, achieving never-seen-before stats. He changed baseball from a grind-itout style to one of power and high-scoring games. He re-wrote the record books from a hitting standpoint, combining a high batting average with unbelievable power.

In 1920, he beat the home-run record he set in 1919 by belting a staggering 54 home-runs, a season in which no other player hit more than 19 and only one team hit more than Babe did individually. But Babe wasn't done, as his 1921 season may have been the greatest in MLB history. That season, he blasted a new record of 59 home-runs, drove in 171 RBI, scored 177 runs, batted .376 and had an unheard of .846 slugging percentage. Babe was officially a superstar and enjoyed a popularity never seen before in professional baseball. The Yankees became the most recognizable and dominant team in baseball, setting attendance records along the way. When the Yankees moved to a new stadium in 1923, it was dubbed "The House that Ruth Built."

Babe's mythical stature grew in 1927 as a member of "Murderers Row," when he set a new home run record of 60 which would stand for 34 years.

With the Yankees, Babe ignited the greatest dynasty in all of sports. Prior to his arrival, the Yankees had never won a title of any kind.

Babe helped the Yankees capture seven pennants and four World Series titles. The 1927 team is still considered by many the greatest in baseball history. Babe held an astonishing 56 major league records at the time, including the most revered record in baseball: 714 homeruns.

In 1936 the baseball Hall of Fame was inaugurated and Babe was one of its first five inductees..

During the fall of 1946, it was discovered that Babe had a malignant tumor on his neck. His health deteriorated quickly.

On June 13, 1948, Ruth's jersey number "3" was retired by the Yankees during his last appearance at Yankee Stadium.

Babe passed away on August 16, 1948. His body lay in state in Yankee Stadium, with his funeral two days later at St. Patrick Cathedral in New York. Over 100,000 people lined up and paid their respects to the Babe.

George Herman Ruth Jr. also known as Babe Ruth, is considered by many, the greatest baseball player in the history of the sport.

A Nostalgic Remembrance



For the first 20 years of my career as a Boston teacher, I taught drafting and design at Hyde Park High School. When the faculty had social functions, my band played for them. It was fun (and profitable) playing for my fellow workers who let their hair down periodically. Many of them were single and traveled during the school vacations: Christmas, February recess, April vacation and the two months of July and August. I couldn't travel during the Christmas vacation as I played Christmas parties and New Years Eve events back then. But, I was ready, willing and able to travel during the other points in time and teamed up with the teachers who traveled. Their destinations were often

off-beat and I loved traveling to places that were not tourist destinations, per se. As an example, the travel group headed for the Canary Islands one winter, Caracas, Venezuela the following year, northern ski resorts at other times, Hawaii, Acapulco, Mexico, remote islands in the Caribbean like Trinidad, Tobago, Barbados, the Dominican Republic, Haiti, and North African locations such as Morocco, Tunisia, Algeria, Spanish Sahara, Malta, and in the Pacific, the Philippines, American Samoa, Fiji, French Polynesia, etc. ... I enjoyed traveling so much, when an old high school chum asked me to team up with him and open a travel agency, I said yes. For both of us it would be a part-time venture as he was an electrical engineer with one of the companies on 128 and I a teacher with the Boston Public Schools.

We chose Allston as a good location. Garber's Travel Agency was in Brookline and catered to the crowds that vacationed several times during the year at the latest hot spots, and Crimson Travel was in Cambridge and catered to the college trade. Allston was half way between these two businesses, so in the mid-1960s, my partner and I opened Paradise Travel Service in Allston. We teamed up with a wholesale travel company, Summit Tours of New England, a business that programmed travel concepts for the retail travel agencies that were affiliated. As a result, we put travel packages together that were unique and not what Garber's or Crimson were interested in: tours to Egypt to see the pyramids, trips to Latin American countries, a two-week package to Hawaii, trips to North Africa, stopovers at exotic Pacific Islands like Samoa, Tahiti, Fiji, and the Philippines.

Periodically, my partner or I would accompany one of the groups that traveled to the above-mentioned locations and conduct the tours that were part of the package. That first summer we were in business, Summit Tours put a two-week package to Hawaii together for us that we could sell for \$499.00 and still make a good profit. So many people opted for the chance to go to Hawaii, we needed two tour

guides to handle things. Both my partner and I decided to hire someone to run the office and we both flew with the crowd as their tour guides. My folks were proud of my new venture, but Babbononno was worried that I would fall off the edge of mother Earth at some point in my travels.

When that first trip to Hawaii left Boston we stopped in Chicago and then headed to Seattle, Washington to refuel before making the 2,470-mile trip westward in the Pacific.

Our stopover in Seattle was necessary as a plane with tourists to Honolulu was coming in from San Antonio, Texas to join our flight to Hawaii. While we were waiting for the plane from Texas, my partner and I brought our tourists to the Space Needle in Seattle, a construction put up a few years earlier for the 1962 World's Fair. We headed for the restaurant atop the Space Needle and had dinner while the top of the building spun around in a 360-degree When the plane from Texas

finally arrived, we were all back on our plane and looked over the Texans as they came aboard our flight. They didn't look like cowboys and cow girls, something we both expected. One young lady, in particular, caught our fancy and both my partner and I strained our necks to see where she was sitting. After we took off, we had to deal with a couple of finicky passengers from our group and lost sight of the young lady I mentioned. Once we landed, we realized that we had been in the air for around 12 hours but a luau was waiting for us as part of the package. Once we checked into our hotel, both my partner and I assured the crowd that we wouldn't be doing anything until we got up at the crack of noon. Later that day, after a meeting with our travelers, we all headed for the beach and a surfing lesson. And, there she was, the young lady from Texas. Both my partner and I began tripping over each other to get to the young lady and attract her attention. We both succeeded but were too eager. As a result, we did the only thing two young responsible young Italian gentlemen from Boston could do ... we flipped a coin. I lost the toss and humbly backed off while my partner tried to woo the girl we both admired. He was successful.

We had packaged many side trips for our tourists and the young lady from Texas joined in accompanying my business partner as we ventured forth each and every day. We saw the Kodak Hula Show, a rising star playing piano and singing at a hotel on Waikiki Beach (Don Ho), the remains of the U.S.S. Arizona from the memorial built above it, Diamond Head, an extinct volcano, Punch Bowl National Cemetery where servicemen and women killed in the Pearl Harbor attack are buried and the shopping bazaars of Waikiki Beach.

There were no Italian restaurants in Honolulu at that point

in time, but I developed a taste for Hawaiian pork and fish with poi, Philippine cuisine, and several Japanese dishes. Most of our crowd was venturesome and tried these ethnic foods too, but there were a few who stuck to McDonald's burgers and fries each day.

When the trip finally ended, my partner and the young lady from Texas were unofficially engaged, and began to plan a wedding to take place back here in Boston. We headed to San Antonio a month later for a Texas engagement party, and a month after that, the girl moved to Boston to be near my business partner. They were married that following spring at Lombardo's in East Boston. After the wedding, the Texan attempted to change her husband's social status and elevate him in society, a venture that caused them to eventually separate and divorce. I was spreading myself too thin between teaching, playing music, working on a master's degree and the travel business. Something had to go, so I sold my share of Paradise Travel to my partner. Summit Tours, the company that put the travel packages together for us left Boston for Los Angeles and I would get involved in a couple of businesses with one of the partners due to a chance meeting one night at the Hollywood Bowl, but that's a story for another day.

Split pea soup might not hail from Italy's culinary catalog, but Italian American cooks have a knack for reinventing recipes while adding a distinct twist. In cucina povera tradition, many transform humble ingredients into dishes brimming with flavor and heartiness. Chicken, beef, and leftover ham bones become the foundation for savory broths, while a handful of ditalini or orzo adds a classic Italian flair — making this hearty soup a distant cousin of favorites like Pasta e Fagioli.

My Nonna, a true maestro of cucina povera, would often transform chicken, beef, and ham bones into a variety of flavorful soups. With soup season upon us, there's no better way to warm your soul than with a comforting bowl of Italian Split Pea Soup. Hearty, cozy, and deeply satisfying, it's the perfect antidote to a cold winter day!

#### ITALIAN SPLIT PEA SOUP Zuppa di Piselli Spezzati all'Italiana



- ½ cup olive oil (more if needed to cover the bottom of the pan)6 cloves garlic, finely chopped
- or pressed

  1 extra-large sweet onion,
  finally channed
- finely chopped 5 stalks celery, chopped
- 5 carrots, chopped 1 large hambone
- 1 ½ pounds dry split peas, rinsed and drained
- 12 cups chicken or beef stock
- 12 cups water 4 bay leaves
- 1 sprig of thyme
- 1-pound chopped ham
- 2 large russet potatoes, peeled and cut into chunks (optional) ½ pound ditalini or orzo Salt and pepper, to taste Homemade or store-bought croutons (optional)

In a large Dutch oven, heat the olive oil over medium heat. Add the garlic, onion, carrots, and celery. Sauté for about 10 minutes until softened and fragrant.

Add the split peas and the hambone to the pot. Stir in the bay leaves, thyme, chicken or beef stock, and water. Bring the mixture to a boil.

Once boiling, reduce the heat to low. Simmer the soup for about 2 hours, stirring occasionally.

Stir in the chopped ham and optional potatoes. Continue simmering for another 1 ½ hours, or until the soup is flavorful, the peas have broken down, and the mixture has thickened.

Remove the hambone, bay leaves, and thyme sprig. Stir in the ditalini or orzo and cook for an additional 10-15 minutes.

Turn off the heat, cover the pot, and let the soup rest for a few minutes. This allows the pasta to cook fully and the soup to thicken further. If the soup becomes too thick, thin it with additional stock. Taste the soup and adjust the seasoning with salt and pepper

as needed. Ladle into bowls and serve with croutons, if desired.

#### The Bleak Fascintion of Six Flags New Orleans



Urban exploration, as the term is used by the seekers of crumbling architecture, has a distinct appeal from the more popular and not specifically named spectacle of ancient ruins. The latter offers clues to a long-vanished world, a life so abstracted from our own that any narrative assembled from the remnant pieces is fueled by speculation. Urban exploration hits closer to our shared cultural home. It offers pieces of a familiar world and a life we know. For some an abandoned urban landscape evokes specific memories but, even for those visiting the shattered remains of a once thriving location, there are enough commonalities to imagine the place at its peak with relative accuracy. Whether or not we knew the now decaying place in person we bond over the shared history, a bond formed by remnants of a shared culture, history or routine.



aftermath over political incompetence in the face of disaster that still lingers.

The final component here is New Orleans itself, a city that in the face of every tragedy that comes its way still maintains its joviality. The Big Easy acknowledges its dark secrets and its hardships with a sometimescynical good spirit. Its festivities




There is a haunting bittersweetness, then, to most such spots not entirely different from visiting a cemetery or a memorial. Most abandoned areas tell of misfortune whether it is a favorite watering hole that went out of business or the site of a natural disaster that caused an evacuation. Indeed, the conflicting emotions conjured by ghost towns are not bound by scope or location, from the misty desolation of Centralia in central Pennsylvania to the stoic empty German mining villages of Namibia.

And yet, the resilient but nonetheless somber remains of Six Flags New Orlean have a bleak fascination of their own. In part this is because after Hurricane Katrina destroyed the park, nature has been remarkably kind to these ironically joyous pieces. It matters too that Six Flags is still very much a cultural fixture, but the real horror comes not only from the recent memories of Hurricane Katrina but at the resentment that emerged in the

and often grotesque masks and ghost tours are a large part of its tourist draw.

Perhaps not surprisingly, the story of Six Flags New Orleans after Hurricane Katrina is a testament to the bureaucratic blunders that plagued the city in the years surrounding the

disaster. In its first incarnation, opening in the spring of 2000, the park was called Jazzland. When Six Flags bought the land in 2002 (opening as Six Flags New Orleans the following year), the national chain themed it to the Bayou Country. Rides included Lafitte's Pirate Ship, Ozarka Splash, The Big Easy, Jocco's Mardi Gras Madness, Voodoo Volcano, The Jester, Gator Bait and Mardi Gras Menagerie and was divided into areas such as Main Street Square and Cajun Country.

Despite spending \$20 million to refurbish the park, Six Flags soon began losing interest in its investment. By early 2005, Six Flags began closing its lower performing parks nationwide. By that summer Six Flags New Orleans was among the least profitable parks in the company's portfolio and, though plans for a water park were in talks, it was likely that the New Orleans location was due for the axe.

The last day of operation for the park was August 21st due to the start of school with a planned weekend reopening on the 26th. With news of Katrina hitting New Orleans directly the plans were cancelled.

By the time Katrina passed the park was submerged in six feet of water, its drainage system proving no match for the storm. Six Flags reported that because it took nearly a month for the water to dry out, about eighty percent of the rides and attractions were ruined by the longterm submersion and in 2006 declared the park a total loss. Only a few rides were salvaged. Of these only Bayou Blaster was unique to the New Orleans park and found a new life in Six Flags Great Escape and Hurricane Harbor (the irony is not lost) in Queensbury, New York as Sasquatch. The other salvaged rides were generic to Six Flags Warner Bros I.P.'s, Batman: The Ride was moved to San Antonio's Six Flags Fiesta Texas where it reopened as Goliath in 2008 and Road Runner Express lives on in its original name in Six Flags Magic Mountain in Valencia,

What happened next is typical of the finger-pointing and corporate blustering that always seems to follow catastrophe. Then-mayor Ray Nagin expected

cable news hosts are coming to an end. Just look at MSNB's Rachael Maddow and her \$5 million dollar pay cut as a result of a decrease in ratings and viewers, or news veteran Chris Wallce departing CNN to start his own podcast, after he was told his annual \$7 million dollar salary would be slashed. Ratings are down, viewership and readership are down, the demand for advertising on these sites are down. Falling revenue and fewer viewers and subscribers means job losses and smaller pay days.

ABC just settled their own defamation suit with President-elect Trump, stemming from news anchor George Stephanopoulos repeated on air claim that the former president has been convicted of rape, It was a lie he repeated 10 times in one interview with Congresswoman Nancy Mace (R-SC), even after he was told by his producer and higher ups not to use that term as he would be referring to a verdict that was never found. 


Happy Birthday to Pudge Fisk




