

# COLUMBUS DAY

(Observed Monday, October 14, 2024)



*America* — *Land of Dreamers* 

The year was 1492, a young man from Genoa, Italy, Cristoforo Colombo, was convinced a route to the Far East could be found by sailing West and he wanted a chance to prove it. Many thought he was a dreamer. Luckily he was able to persuade others and turned his dream into a reality.

In the years that followed, America became a melting pot for people who, like Columbus, had a dream and were willing to take a chance on what they believed in. The English, the French, the Jews, the Irish, the Italians, and countless others, all came seeking the freedom to make their own decisions and to have the opportunity to make their dreams a reality. They wanted the best of both worlds and got it. These people were proud to call themselves Americans and equally proud to hold on to the traditions of their homeland. Where else but in America would this be possible?

Five hundred and thirty years later, we salute the man who took a chance — Christopher Columbus. A man who was a model for future explorers to emulate. We are the product of all the Christopher Columbuses that came before us.

#### **Noble Journey Sculpture Dedication**

There is not a more fitting site for a sculpture honoring our immigrant ancestor's voyage to their new homeland than the front entrance of a North End landmark, a church built by Italian immigrants in 1873. This "Noble Journey", located in the heart of the Boston's North End. in the Peace Garden of St. Leonard Church, on Hanover Street, was dedicated on Sunday, September 29, 2024. Following a mass offered by Father Michael Della Penna, Pastor of St. Leonard Church. the sculpture was dedicated in front of an overflow crowd of current and past residents, parishioners, well-wishers and donors to this beautiful tribute. The work of art was created by world-renowned artist and sculptress Nancy Schoen, who designed the "Make Way for Ducklings" in the Boston Public Garden.

Born out of a discussion between the late Dr. Michael Annunziata, Victor Passacantilli, both co-founders of Friends of the North End (FONE), Nancy Schoen Father Michael Della Penna, Dr. Anthony Cortese, a former North Ender with longstanding family connection to St. Leonard Church, and Tom Damigella, President of the North End Historical Society. The Noble Journey's name derives from a previous project that Tom's daughter completed in high school about the life and immigration of her Italian grandparents from Gaetan and Sicily to America.

The project is comprised of a bronze pathway imprinted

with sets of footprints leading into the entrance of St. Leonard Church and will symbolize the literal "walk" of the footsteps our immigrant ancestors took when crossing the Atlantic Ocean, between the 1850s and 1920s, including the immigrants who built St. Leonard Church in 1873. The sculpture's pathway is flanked on both sides by black metal railings, topped with brass lanterns, while two

white life preservers emblazoned with "USS North End" in black lettering is affixed to each railing.

"We represent the confluence of our cultural beliefs and our religious ethics through the footsteps of our ancestors leading directly to the church they built. We hope it gives continuity for generations to

## **FEMA Out of Cash, Illegal Immigration Drains Funds**

#### Hurricane Helene Victims Fending for Themselves

Homeland Security Secretary Alejandro Mayorkas announced that the Federal Emergency Management Agency (FEMA), the agency responsible for assisting States and U.S. cities during natural disasters and other and other emergency situations, has spent more than one billion dollars on services for illegal immigrants over the past year, now has insufficient funds to last through the remainder of the U.S. hurricane season, even with another major storm set to hit the entire state of Florida in the next couple of days. "We are meeting the immediate needs with the monies we have. We are expecting another hurricane to hit. FEMA does not have the funds to make it through the current season," Mayorkas stated.

Hurricane Helene decimated the west coast of Florida and a number of states in the southeast, flooding towns, destroying properties and killing hundreds. From Florida's Gulf Coast to the Blue Ridge Mountains, to the major devastation in Ashville, North Carolina, whose town has been left without power, running water and basic necessities.

Congress recently provided \$20 billion for FEMA's disaster relief fund as part of a short-term government spending bill to fund the government through mid-December. The Federal Government is sending additional aid to North Carolina for its recovery effort. "This will pay for the urgent work

#### Major Labor Unions Fail to Endorse Kamala Harris

*Is Silence Golden for Trump?*

Vice-President Kamala Harris, Democratic Presidential Nominee, has lost the endorsement of another major labor union. The International Association of Fire Fighter's (IAFF) announced it would not be making a presidential endorsement in the 2024 Presidential Election.

The union, representing over 300,000 firefighters and emergency responders, was the first union in 2020 to endorse President Joe Biden's presidential bid and has a long history of supporting Democratic Presidential Candidates. The IAFF's determination not to endorse a presidential candidate in the 2024 race follows the recent decision of the International Brotherhood of Teamster's President Sean O'Brien's decision, to defy the preference of its Pro-Trump membership and opt not to endorse a presidential candidate.

"Today the IAFF Executive Board, by a margin of 1.2% voted not to endorse a candidate in the 2024 presidential election," said IAFF General President Ed Kelly in a prepared statement. Kelly is a native Bostonian, who hails from Dorchester and boasts a long legacy of fire fighters in his family. "Over the past year, IAFF took unprecedented steps to hear our members' views on the candidates and policy issues that matter most to them. The IAFF Executive Board determined that we are better able to advocate for our members and make progress on the issues that matter to them if we, as a union, are standing shoulder-to-shoulder. The decision, which we took very

seriously, is the best way to preserve and strengthen our unity," Kelly added.

United States Congressman, Carlos Giminez (R-FLA), the only career firefighter paramedic in congress and retired IAFF member said the union's decision not to endorse was a "big deal" and good news for former President Trump. "It's a big shift in that union, not giving an endorsement." The IAFF has backed the Democratic nominee for president in every election between 1984 and 2012. In 2016, when Trump was facing Democrat Hillary Clinton, the union again did not make an endorsement. This is the second major union that has failed to endorse the Democratic nominee, that's a big deal," said Congressman Gimenez.

#### CICERO, Part III




19th Century illustration, Murder of Cicero

It was at the demand of Mark Antony that Cicero's name was added to the list of the proscribed. Cicero attempted to escape from Italy, but was twice driven back by contrary winds, so he returned to his country estate at Formiae to

await his fate. It has been reported that he said, "I will die in the country which I have so often saved." He resigned himself to meet his death, but his faithful slaves forced him into a litter for one more escape attempt. They were

overtaken by soldiers before they left the grounds of the estate and the slaves prepared to defend their master. Cicero refused to allow any blood to be shed on his account and directed the slaves to set the litter down and then withdraw. His order was obeyed and he then stretched out his neck to await the sword of the commanding soldier.

He died in his sixty-third year, 43 B.C. After the murder was accomplished the soldiers cut off both of his hands, as these were the instruments which permitted him to write his bitter verbal attacks against Mark

And now we learn of another of those numerous bitter ironies of fate. Cicero had successfully defended a man named Popilius in court a few years earlier. It must also be noted that advocates defended their clients gratuitously in those days and this of course created closer than normal friendship ties between both parties. Guess who was the commanding solider that volunteered for the job and who slew Cicero? Right, his name is Popilius. A friend in need is a friend indeed.

The head and hands of Cicero were brought to Rome and exposed on the Rostra of the Forum. Crowds of people viewed the remains and shed tears for the brutal and unjust manner in which this most eloquent man met his death. He is known to have composed at least 107 orations, of which 77 have been preserved, either partially or entirely. He also wrote 864 epistles (long letters). There also were poems, historical works and manuscripts.

Marcus Tullius Cicero, statesman, man of letters, the greatest of all Roman orators, the greatest master of composition that the world has ever known and the most amiable and upright man in all of Roman history. Who can do justice to the memory of this intellectual giant in a few hundred words? I'm sure that I can't.

#### **Columbus Day** Restored in New Hampshire

New Hampshire is first in the nation for more than Presidential primaries. This past July, through the efforts of Friends of Italian Americans, the New Hampshire legislature passed and the Governor signed House Bill 1014, which requires that municipalities and schools call the second Monday in October as Columbus Day, making New Hampshire the first state to restore the Columbus Day holiday throughout the state.

House Bill 1014 requires all school districts, towns and cities use the official names of State mandated holidays, as found in RSA 288.1, in all "communications, publications, documents, or calendars." This means December 25 is called Christmas, the third Monday in January is called Martin Luther King, Jr. Civil Rights Day, November 11 is called Veterans Day, the second Monday in October is called Columbus Day, etc.

Columbus Day was created by President Benjamin Harrison in 1892 as an apology to the 1891 lynching of eleven Italian immigrants in New Orleans, and prevented a potential war with Italy. Known as the Crescent City hangings, this is considered the largest recorded lynching in American history as it is estimated that 10,000 New Orleans citizens came out to murder the Italians the day after they were acquitted by a jury of a murder they did not commit.

Since its inception, Columbus Day has been the only holiday dedicated to the immigrant community in the United States. It honors all immigrants who tirelessly worked to build the United States, even though they may have been persecuted due to their immigrant status. In fact, on that first Columbus Day on October 12, 1892, more than one million people gathered in New York City to cheer on the 40,000-strong parade of American citizens, immigrants and Native Americans.

October has long been identified as Italian American Heritage Month, and bringing the second Monday in October back as Columbus Day is not an attack on Indigenous People of the United States. It isn't in the best interests of any municipality to pit one minority community against another. The Friends of Italian Americans encourages municipalities and school districts to celebrate Indigenous Peoples' Day on another day such as August 9th, which is already recognized as such by the United Nations. Having a separate Indigenous Peoples' Day in addition to a separate Columbus Day would honor both minorities with the respect they correctly deserve.


#### **Justin Paul Capodilupo**

Dina G. Malgeri died peacefully in her beloved North End of Boston on September 22, 2024.

Born in Chicago, Illinois on August 19, 1929, she was the daughter of Francesco Malgeri and Dina D'Alto Malgeri, sister to Francis Malgeri, all deceased. She is survived by a number of cousins in Turin, Italy and Medford, MA. along with many dear & devoted friends.

Dina was a humanitarian and an independent woman with many interests ranging from history to travel, current affairs, all of the arts and all things library. With the exception of a two-year stint in her late teens in Manhattan, NY and three

for the US Dept. of the Army Special Services in S. to successful completion in 1996. North End since 1935. She enjoyed traveling to many US states and foreign countries, but her love of the city was immense and well known to all her friends.

First educated locally at St. Anthony's School, North End and St. Mary's High School in Cambridge, MA., Dina received her BA in Humanities at Harvard Extension School and her MLS at Simmons College. Among notable positions she held during her years of work, Dina started her professional career as a clerk to the Commissioner of the MA Office of Probation for 14 years. A position which, traveling by public transportation, brought her to improve or establish libraries at hospitals, reform schools and the prison system throughout MA. dusty basement closets in the original library building, opened in 1885 and designed by renowned architect H.H. Richardson. Among her great successes as Library Director was the restoration of this, the historic Converse Memorial Building, that serves as a multi-faceted cultural center and houses the art galleries, exhibits and serves as a research center for local history and genealogy. And prior to that, the skillfully designed library addition; originally conceived as new home to the library's growing vibrant daily use. Working with the City's administration and the Library Board of Trustees, she gathered resources and

years she spent as a civilian administrative librarian craftspeople to see the building addition through

Bavaria, Germany, Dina remained a resident of the But it wasn't all work. Dina liked to break down stereotypes and loved to tell the story of the theft and recovery of Winslow Homer's "The Whittling Boy" from the library's art collection in 1975, which she was beneficial in helping to recover. The tale involved detectives, a ransom, a rendezvous in Boston's Government Center and the positive outcome of retrieval. She got a twinkle in her eye as her listener gasped at the quiet little woman relating the tale-surely the stuff movies are made of, not a day in the life of a librarian.

After losing her immediate family early on, Dina left this life especially thankful to her cousin Sapia D'Alto and all her cousins in Italy and Medford, MA for folding her into the family.

#### L'Anno Bello: A Year in Italian Folklore

A Voyage through Italy's Spooky Side

Halloween season is officially upon us! An old-fashioned holiday sign hangs upon my door, boasting Victorian images of smiling pumpkins, black cats sporting pointy witch hats, and bats in mid-flight. Jacko-lanterns and ghastly ghosts grin mischievously from store shelves, with thin lights flickering inside them like little captured sunbeams. The cornstalks and scarecrows that adorn my neighbors' front steps speak of the concluding harvest season, while the colorful leaves that flutter to the ground against the backdrop of a slate-gray sky remind us that the year itself now winds down to its close. Halloween is the time to revel in all these examples of a world turned upside-down, of the pleasure of the unknown and the thrill of everything that is mysterious and spine-tingling. Though modern Halloween celebrations are largely an American phenomenon, the United States does not have a monopoly on spooky imagery or mythical creatures. Across the ocean in Italy, people also ready themselves for Halloween, and may draw upon their own unique mythology and folklore. So, in the spirit of Halloween, let's dive into the eerier side of Italy, the side that you may not find in guide books but certainly plays an important part in the Italian character!

Italy has long had a fascination with the occult, stretching back to the days of Ancient Rome. The

modern Italian prejudice against the number seventeen, similar to the American superstition of unlucky thirteen, stems from the burial customs of the Romans. The Roman numeral for seventeen, XVII, can be rearranged to spell VIXI, or the Latin word meaning "he lived" — a phrase frequently carved into ancient tombstones, and therefore linking the number with death. Ancient Rome's penchant for the macabre did not end with numbers, however. Romans shivered with fear over the lemures, or terrifying ghosts. These ethereal beings haunted certain houses or roads because, as many ghost stories stated, they could find no rest due to an improper burial or some sort of injustice committed against them during their lifetime. The Romans even devoted the month of May to a holiday called Lemuria which sought to appease these spirits, and this creepy feast may form the origin of an olden superstition that advised against marrying in May. Ancient Romans also resorted to supernatural omens in order to predict the future. Priests known as augurs interpreted the flight of birds to divine looming events and outcomes. Haruspices had to report the future with a much yuckier method: they scoured the entrails of sacrificed animals for omens! While modern Italians are certainly less superstitious than their ancient counterparts, many remnants of Rome's mysterious folklore persist to this

day, such as the ubiquitous charms against the evil eye and the popular red horn-shaped amulets said to bring good luck.

Though Ancient Rome's love for the mysterious is wellstudied, contemporary Italy nevertheless brims with a plethora of scary monsters and eerie folktales. Werewolf stories abound in Italy, where the hairy shape-shifting beast bears the name licantropo. The fear of the licantropo hearkens back to the time when the wolf stood as the most dreaded predator in the forests of Europe, especially during the nights of the full moon, when certain men could morph into this formidable animal. My father frequently spoke of hearing the plaintive howls of wolves in his secluded Italian village, and such a chilling memory is a testament to the strength of the werewolf myth. Similarly, the witch, or strega, constitutes a complex symbol in Italian society, sometimes functioning as an example of evil and other times signifying benign and astute female power. The gift-bringer of the Italian Christmas season, La Befana, is even depicted as a kindly fairy-witch figure. Unique mythological creatures also roam localized areas of Italy. The Badalisc is a large, hairy beast that inhabits the Alpine woods of Lombardy in northern Italy. It can only be captured on the Epiphany, and this event forms a part of the region's folksy holiday celebrations to this day. Visitors to Naples may hear tales of the Monaciello, or "little monk," a gnome-like creature who resides in the city's old abbeys, monasteries, and canals, playing harmless tricks on people and offering help to wayward travelers. Meanwhile, the famous Lake Como boasts its own version of the Loch Ness Monster, a living dinosaur known as the Lariosauro! With all of these fascinating legends and beings, Italy is a prime destination for Halloween thrills and hair-raising adventures.

Halloween provides us with the wonderful opportunity to have fun with the mysterious. From witches to ghosts to vampires, all of the hidden, spookier aspects of society come out to play during this chilly autumnal night. This Halloween season, I will also be thinking about the mythical creatures and unnerving legends that form a part of my Italian heritage, old and new. After all, folktales and myths do a lot more than just give us a thrill. They connect with the universal fears, concerns, and desires of people across generations, emotions made manifest in guiding superstitions and metaphorical monsters. Let's celebrate the unknown on Halloween and reflect on how it impacts our lives as humans and our collective unconsciousness. Halloween teaches us that there is far more to the world than immediately meets our eye, and the legends and beings of yore are prime examples of this lesson!

Michele would show up to your door with a box of cannoli's from Modern Pastry, or tiramisu from Café Vittoria just because she was thinking of you.

Michele was strong willed and we can say (ahem) stubborn at times and she was never lost

> for words whether the words were appropriate or not. She was unapologetic because as Michele would say, "she was always right"!

Michele struggled the last three years of her life after she survived a massive stroke that left her semi paralyzed. This malady tethered her to her room in the North End Rehab and was a torment to her incredibly social

lifestyle that she so cherished. In true Michele style she would keep her ear to the ground and somehow know of all the gossip of the town well before most media outlets would know. She kept in constant contact with the world beyond the four walls of her rehab by calling everyone she knew, sometimes as often as 50 times a day.

And now she fly's untethered. Our bohemian is free to journey without any boundaries. She is free to capture all of life's beautiful moments, amazing sunrises and sunsets. She can dance with the wind beneath her feet



Dr. Annunziata approached Father Michael Della Penna with his idea to create a memorial for Italian immigrants honoring their journey at a difficult time, coming in the aftermath of an incident in June 2020,

when the statue of Christopher Columbus at Columbus Park on the waterfront was beheaded by a senseless act of vandalism. "I was hoping to find a place for the proposed project that would be secure to perpetrate the legacy of the Italian heritage that we celebrate and be a means to bring people together. For me, this is not only a cultural and historical work of art that tells the story of the millions of people who immigrated to the United States but also a beautiful means of affirming their faith, the most valuable asset declared at the border. It was their faith that they carried to the country, and which carried them," said Father Della Penna of the project.

#### WHICH FOREVER YOUNG VERSION IS BETTER?





#### • Unions not Endorsing Harris (Continued from Page 1)

Another of America's largest and strongest labor unions has defied its membership's preference to endorse former President Trump, the Republican 2024 nominee for President. It's the first time in thirty years the union has failed to endorse a presidential candidate.

The International Brotherhood of Teamsters President Sean O'Brien described "the union's 2024 endorsement process as the most inclusive Democratic and transparent presidential endorsement process in the history of our 121-yearold organization," just before he announced the Teamsters would not endorse Donald Trump or Kamala Harris, while at the same time acknowledging it's 1.3 million members overwhelmingly support former President Trump. O'Brien was invited to speak at the Republican National Convention in July and accepted the invitation. He was not invited to speak at the Democratic National Convention in August.

An election poll showed Trump

led Harris 59.6% to 34%, compared to a phone poll showing Trump with 58% and Harris 31%. Those numbers are a dramatic reversal from when Biden, before his withdrawal, led Trump 44.3% to Trump's 36.3%.

The union endorsed Democrat Hillary Clinton in 2016 and Joe Biden in 2020. Trump called the non-endorsement "a great honor, it's a big thing." With less than five weeks until election day, November 5th, it will be interesting to see how these non-endorsements play out.

you need to clear landslides, to provide shelter, and to offer food and medicine," President Biden said.

More than 150 households have registered for FEMA and that number is expected to spike as the reality of the devastation becomes more apparent. Biden, Harris and FEMA, an extension of their administration, have been accused of not prioritizing the crisis, with many in North Carolina still without clean water, food or cell phone service.

FEMA has overstretched its budget under the Bide/Harris administration to accommodate the needs of illegal immigrants. The Shelter and Services Program (SSP), administered by FEMA in partnership with the U.S. Customs and Border Protection (CBP), provides financial support to non-federal entities to provide humanitarian services to "non-citizen immigrants." Between FY 2023 and FY 2024, at least one billion dollars has been spent on the program, according to FEMA's website. In 2024, over \$20 million went to the New York City of Management and Budget.

New York City's Department of Homeless Services gave \$4,000 grants to 150 migrant families to transition from city shelters to permanent housing. Eligible families may also receive up to \$1,000 in gift cards for moving expenses and household necessities, according to a September report. When speaking in Atlanta, Georgia last week, Harris said, FEMA is Providing \$750 in cash "for folks who need immediate needs due to the storm."

Desperate residents of the ravaged North Carolina town have given up waiting for rescue efforts from the Biden/ Harris Administration and FEMA for food, water and medicine, and have begun to rely on home grown efforts instead. Donations have been collected by volunteers and loaded into small privately owned airplanes for delivery to the hardest hit regions of the state.

#### Sir Christopher Wren

Sir Christopher Wren — British architect Christopher Wren was born on October 30, 1632 in Wiltshire, southwestern England. the only surviving son of Christopher Wren the Elder and Mary Cox.

Educated in Latin,, Philosophy and Physics at the University of Oxford, Wren was a founder of the Royal Society and served as its president from 1680



to 1682. His scientific work was highly regarded by Isaac Newton and Blaise Pascal.

In 1661, Wren was elected Savilian Professor of Astronomy at Oxford, and in 1669 he was appointed Surveyor of Works to Charles II. From 1661 until 1668 Wren's life was based in Oxford.

The main sources for Wren's scientific achievements are the records of the Royal Society. His scientific works ranged from astronomy, optics, the problem of finding longitude at sea, cosmology, mechanics, microscopy, surveying, medicine and meteorology.

It is unclear why Wren turned to architecture, but at the time it was considered a branch of applied mathematics and a gentleman's pursuit.

Wren's career as an architect was well established by 1669, and it may have been his appointment as Surveyor of the King's Works early that year that persuaded him that he could finally afford to marry. In 1669, the 37-year-old Wren married his childhood neighbor, the 33-year-old Faith Coghill,

In 1677, 17 months after the untimely death of his first wife, Wren remarried, this time to Jane Fitzwilliam.

Wren's later life was not without criticisms and attacks on his competence and his taste. In 1712, Anthony Ashley Cooper, third Earl of Shaftesbury, circulated a document proposing a new British-style of architecture, Ashley Cooper censured Wren's cathedral, his taste and his long-standing control of the royal works. Although Wren was appointed to the 52 New Churches Commission in 1711. He was left only with nominal charge of a board of works when surveying started in 1715. On April 26,1718, on the pretext of failing powers, he was dismissed in favor of William Benson.

In 1713, he bought the manor of Wroxall, Warwickshire, from the Burgoyne family.

On one of his trips to London, at the age of ninety, he caught a cold and on February 25, 1723, a servant who tried to awaken Wren from his nap found that he had died in his sleep. His body was placed in the southeast corner of the crypt of his masterpiece, St. Paul's Cathedral. There is a memorial to him in the crypt at St. Paul's.

Considered one of the greatest minds of his time, Wren designed St. Paul's Cathedral and 52 churches for the City of London. His secular buildings included the "new" wing of Hampton Court near London and Greenwich Hospital, now the Royal Naval College.



A Nostalgic Remembrance



It was October and the cottage in Winthrop, Maine had been closed up since Labor Day. The leaves were starting to turn in Boston and Mom and Dad knew that the foliage in central Maine would be beautiful. As a result, it would be time to take a ride north to see what the colors of the leaves would be. Dad would have a substitute bass player take his place for the weekend jobs he had booked and packed up what we would need for the weekend. Nanna and Babbononno would be joining us for the trip to Maine and, they, too, packed what they needed.

Seeing we were going up on a Friday afternoon and returning on that Sunday, we wouldn't need much except warm clothes and bed linens. There would have been a pile of firewood already cut and stacked and covered with a tarp for a cold fall weekend. Depending on the temperature, we were ready with a clean pot belly stove in the living room and a couple of electric heaters for the bedrooms.

Both Mom and Dad put overnight bags together for the trip and Mom told Nanna not to pack too much, but it fell on deaf ears where Babbononno was concerned. I had a boy scout duffle bag that I used for sports equipment and put in a pair of hiking boots, warm clothes and a bomber jacket, but when we picked up my grandparents, they each had suitcases filled with clothes and bags of things to cook with, enough food to feed a group of hungry truck drivers, a gallon of Zi'Antonio's best red wine and a bottle of Brioschi, just in case. When we picked them up, Dad told them that we were probably going to eat out for our main meals, but that too fell on deaf ears. Nanna had packed a can of espresso for Babbononno's morning coffee, a bottle of milk and a pound of sugar to add in, a couple of dozen eggs, three loaves of Italian bread, two jars

It was past the dinner hour but we were all hungry and the hostess accompanied us to a table away from the teenagers sipping their Cokes and listening to the juke box at 5 cents per song or 6 for a quarter.

When the menus arrived, the waitress told us what they were out of, which seemed like everything except ham steak with pineapple chunks as a hot meal. She said that they could make any sandwich we wanted. Well, it was Friday night, and if you remember the old days, Catholics couldn't eat meat on Fridays. Babbononno started complaining, "What kind of Catholics are they; we can't eat meat. Dad told him that there were very few Catholics in that part of Maine, adding the fact that most of the people were Protestant. Nanna asked if they could eat meat on Fridays. Dad responded with, "As I understand it, yes, they can. The only people who can't are Roman Catholics and the members

of Orthodox religions. When the waitress took our order, we all seemed to order tuna salad sandwiches. Babbononno asked for Scali bread. The waitress replied, "What's that, sir?" Discovering he was out of East Boston, Babbononno asked, "Wadda kinda bread you gudda?" The waitress said, "White, rye, and whole wheat." The resolve was the five of us eating tuna salad sandwiches on white bread with sweet pickles and potato chips on the side. Actually, the sandwiches weren't bad, but Babbononno swore in Italian after each bite.

What finally quieted him down were the desserts, homemade pies a la mode. Babbononno had a sweet tooth and worked his way through two orders of homemade apple pie with ice cream. On the way back to the cottage, he raved about the American food, especially the apple pie. Once we were back in the cottage which had been warming up for us, Babbononno had to wash down the apple pie with a glass of wine. That was his nightcap and all was well.

The next morning, we all went for a walk around Lake Maranacook looking at the colors of the leaves, bright jonguil yellow, Chinese red, burnt orange and everything in between. It was breathtaking. On the way back, Old Vic Gordon, one of the locals was waiting for us. He was sitting on the front steps of his son Arthur's house whittling away at a piece of wood. As we approached, he yelled in a very pronounced down-Maine accent, "Heard you folks was here foah the weekend, and was wondrin' if Mike brung some of that home-made Eye-talian wine with him." Between Vic's accent and Babbononno's fractured English, I don't know how communicated, but they did.

Just then Old Vic's son, Arthur Gordon, and his wife, Arlene, appeared in the doorway. Arthur, who stuttered through his Maine accent, told us that they had heard we were there for the weekend and that lunch was ready. Nanna, Babbononno, Mom, Dad and I were ushered into the Gordon home and treated to lunch... tuna fish salad sandwiches on white bread, with sweet pickles and chips on the side. What could we do but eat and rave about the lunch. Arlene mentioned that, seeing it was Saturday, there was a bean supper at the Baptist church in Winthrop Center and they were inviting us. Dad looked at the rest of us and accepted. What else could he do?

The following day was Sunday. We walked the mile and a half to the center to the small Catholic church for Mass. Nanna couldn't wait to get back to the cottage and begin to make dinner. Actually, she had risen about 6:00 a.m. and started her gravy. By the time everything was ready, the Gordons showed up as our guests. Old Vic and Babbononno put a dent in the gallon of wine and we had a "down Maine" Sunday dinner ... ITALIAN-STYLE.

In the United States, pumpkin-flavored treats like lattes, pies, and muffins have become iconic representations of the fall season, often spiced with warming flavors such as cinnamon, nutmeg, and cloves. A wonderful dish to embrace the seasonal spirit is Budino di Pane alla Zucca, or Pumpkin Bread Pudding. It's delightful whether served warm or chilled, and pairs perfectly with a dollop of whipped cream or a scoop of vanilla ice cream.

#### **PUMPKIN BREAD PUDDING**

Budino di Pane alla Zucca





1 loaf Challah bread, cut into cubes

4 whole eggs

3 egg yolks

1 ½ cups heavy cream 3/4 cup pumpkin puree

1 ½ cups milk

1 cup sugar

½ teaspoon salt

1 tablespoon pure vanilla

2 teaspoons pumpkin pie spice

3 tablespoons cold butter, cut into small cubes

Preheat the oven to 350°F. Generously grease a 9x13" baking pan with butter and set aside.

Line a baking sheet with parchment paper. Spread the cubed bread on the sheet and bake for 10-15 minutes to dry it out. Remove from the oven and allow to cool. Place the bread cubes in the greased baking dish and set aside.

In a large mixing bowl, whisk together the eggs, milk, heavy cream, pumpkin puree, sugar, salt, vanilla extract, and pumpkin pie spice.

Pour the mixture over the bread cubes, letting it sit for about 15 minutes until the bread absorbs the custard.

Dot the top with butter cubes.

Bake for 40-50 minutes, until the center is set but not dry. Refrigerate leftovers.



#### Saint Mellitus

by Bennett Molinari and Richard Molinari

Mellitus, a Roman and the son of a noble family, may have been the abbot of St. Andrew's monastery in Rome. He was the leader of the second band of missionaries whom Pope Gregory 1 sent to assist Augustine, the Archbishop of Canterbury. The Pope also sent a letter instructing Mellitus to tell Augustine and his fellow missionaries to destroy the Saxons' idols but to convert their pagan places of worship into churches (rather than destroy them) and to preserve local pagan festivals by turning them into Christian observances. These measures helped to make Christianity more acceptable and, consequently, greatly furthered the cause of the church in England.

Consecrated as bishop in 604AD Mellitus was directed to preach in the kingdom of the East Saxons. He baptized their king, Saberht, but failed to convert Saberht's sons. After Saberht's death, Mellitus was eventually banished by his sons, supposedly when he refused to give them Communion because they were unbelievers.

still remember that one All-Star game when he nearly killed a catcher at home plate as he raced from third to touch the plate and score a run. He tackled the catcher like a runaway train. It was hard to watch the replay and he never really apologized for his action either. After that day, he was no longer a great player to me. Whitey Ford once called Rose "Charlie Hustle' the way he always played the game to win at seemingly any cost.

At first, I liked the way he played old school but his personality, not that much. He was on his way to immortality as a baseball great before the sky fell down on him after getting accused of gambling while manager of the Cincinnati Reds. He broke according to MLB the most important rule which was No. 21: No gambling allowed. He was banished from baseball forever and would be barred forever from Hall of Fame induction at Cooperstown. He never really ever owned up to his gambling accusations.

Things started out great for him. His rookie season was sensational. He ended up being 1963 Rookie of the Year. His first hit came off Bob Friend of the Pirates on April 13, 1963 and he would go on to hit over 4,000 hits in his 24-year career. During his time as a player, he was a 17-time All-Star, he won

the National League MVP Award in 1973 and World Series MVP in 1975 against the Red Sox. He still holds the longest hitting streak (44) in the National League. During his career, he had 200 or more hits for 10 seasons and 180 hits for four more seasons and he had a career .303 batting average.

He once said, "Every summer, three things happen, the grass is going to get green, the weather is going to get hot and Pete Rose is going to get 200 hits and bat .300." He meant it and he did it too. Rose reached the 4,000-hit mark off Jerry Koosman from the Phillies at that time. It came exactly 21 years to the day after his first hit.

In 1986, President Ronald Reagan was talking with Rose and told him, "Your reputation and legacy are secure." However, by 1989, Rose's legacy and reputation were no longer that secure as MLB eventually would ban him from baseball and bar him from ever getting into the Hall of Fame in Cooperstown.

Major League Baseball charged him with violating Rule 21 and gambling while manager of the Cincinnati Reds. Rose said he never bet against the Reds but gambling alone got him banished from the game.

As he grew older, there were attempts by some to get his lifetime ban lifted but it never happened. Partly because of his own mouth at times. He eventually became one of those old baseball players who showed up at sports memorabilia events where he would sign autographs for a price and people would line up to pay for it too. I wouldn't give him two cents for his autograph.

#### **An October Surprise**

Zivic Wins Welterweight Title from Armstrong

In 1940, World Welterweight Champion Henry Armstrong was staying very busy. Through September he had eight fights. Five of those fights were title defenses. He still wasn't done as he would put the title on the line one more time before the year was finished.

While Armstrong was staying quite active, another welter-weight who was hoping for a shot at the title was staying even busier. Fritzie Zivic had thirteen fights through August of 1940. He lost two of the thirteen, but was putting together a winning streak of five fights culminating in a win over Sammy Angott. This was enough to secure him a shot at Henry Armstrong's title.

The fight, which took place on October 4, 1940 at Madison Square Garden, would have champion and challenger entering the ring with a combined total of twenty-one fights over the previous nine months. Their career records at this point saw Armstrong with 109 wins, 12 losses, and 8 draws. Fritzie was sporting a record of 100 wins, 24, losses, and 5 draws. That's a combined total of 258 fights. Both fighters made their debuts in 1931, so all of these fights took place in just nine years. That would be unthinkable today.

Armstrong had pretty much wrapped up his place in history as one of the all-time greats. He was favored to defeat Zivic. However, Fritzie was not a fighter to take lightly. He was a rough customer in the ring and feared no man. He took on fighters others avoided such as Charley Burley and Eddie Booker. Later in his career he would defeat Jake LaMotta.

Henry was the only man to hold three undisputed titles simultaneously. He was featherweight, lightweight, and welterweight champion. He came within a whisker of adding the middleweight championship when his fight with Ceferino Garcia was called a draw.

Armstrong defended the welterweight title 19 times. To call Henry an active champion is a gross understatement.

Zivic was also prolific when it came to stepping into the ring. Sometimes I think fighters like him fight so often because they really don't like training. Plus, he got paid to fight, not for training.

When the bell rang for the first round on that October night in Madison Square Garden, it became apparent Henry had lost some of his edge. It certainly wasn't due to ring rust, but fighters do wear out. This is not to say he was washed up, and he put up a great fight against Zivic. Over ten rounds the fight was close, but Armstrong was taking a beating. As the bell rang for the fifteenth round. Armstrong, who was noticeably tired came out to face the challenger. Zivic sealed his victory when he dropped Henry at the bell ending the fight.

Henry Armstrong was battered and bloody as the score cards were announced. The decision was unanimous in favor of Fritzie. It is always sad when a great champion falls, but inevitably they do.

There is no film footage of the fight available. Here is a ringside account from the press:

"Henry Armstrong lost his welterweight title after 15 of the most vicious rounds ever fought but he lost like a true champion should. There was no doubt as to the victor. The crowd sensed as early as the 10th round that a new champion was in the making but that crowd stayed to cheer the game little fellow who gave it all he had and still lost. For the first seven rounds they stood head-to-head with Henry banging away from outside and Fritzie stabbing, cutting and slashing at Henry's eyes. Henry was on his way out as early as the 8th round when Zivic, fighting a cool, heady battle, cut both of the fading champion's eyes and never let up banging away at them. In ten different rounds Fritzie knocked the rubber mouthpiece from Henry's mouth. Zivic did just what he said he'd do--cut the old scar tissue over Henry's eyes, blind him and then finish. Then came the final round and Zivic stood off and banged Henry at will. Just before the bell, Zivic landed a corking right and Henry went down on his ear just as the bell rang." - International News Service (Thanks to Boxrec)

There two would meet again in January of 1941 with Fritzie retaining the title via a TKO in the 12th round. It was another brutal fight and Henry fought his heart out, but the referee was forced to stopped the fight when Henry's eyes were swelling shut and he was taking a terrible beating.

After defeating Armstrong in their title rematch, Zivic fought seven non-title bouts before putting the crown on the line against Freddie Cochrane in July of 1941. Cochrane beat him by decision. Again, as hard as it may seem to believe today, but Zivic fought 13 more times in 1941 after defending the title against Armstrong. He took on an up-and-coming Sugar Ray Robinson in October of that year. A side note; Robinson made his pro debut on the undercard of the first Armstrong/ Zivic fight.

It is often forgotten that Zivic and Armstrong would meet one last time. In 1942, now both former champs, fought a ten rounder in San Francisco. This time Armstrong won a one-sided decision.

Henry Armstrong would continue fighting until 1945, while Zivic carried on until 1949. Their career records were outstanding. Armstrong's stood at 149 wins, 21 losses, and 10 draws, while Fritzie ends with 157 wins, 65 losses, and 9 draws. Two amazing careers. Two amazing fighters. Numbers like these will never be seen again. Neither will such fighters.

#### HOOPS and HOCKEY in the HUB

When the Celtics open the 2024-2025 season by hosting the archrival New York Knicks at the Garden on October 22, there may well be a very interested spectator on hand.

That person would be very familiar with the Boston area since he played his high school ball in the region, later came back to play and coach against Boston College but is best remembered for his stellar career in the NBA — with the New York Knicks, no less.

Yes, while the Celtics will be all smiles as they are presented with their championship rings and Banner 18 is hoisted to the rafters on that night when all things will glitter, there may be moments of wistfulness for Patrick Ewing, who did just about everything in basketball with one exception — win an NBA title.

You see, Ewing, who is now 62, is back with the New York Knicks once again, having been signed by the franchise as a "basketball ambassador assisting both basketball and business operations," the organization stated in a press release

The move reunites Ewing with the NBA franchise that has always been closest to him. "As I said the day my number 33 was lifted to the rafters at Madison Square Garden, I will always be a Knick and I will always be a New Yorker."

But while that statement may refer to his present feelings, there was a past for Patrick Ewing and a major portion of that past included the Boston area.

Ewing was born in Kingston, Jamaica but moved to Cambridge with his parents as a young child. He attended Cambridge Rindge and Latin High School where he learned the game of basketball under head coach Mike Jarvis.

And he learned it well, leading the team to three consecutive Massachusetts Interscholastic Athletic Association Division One state championships from 1979 to 1981.

During his time on the court in Cambridge he averaged 14 points a game during his sophomore season, 18 tallies a contest as a junior and 23 as a senior. He also led Cambridge to a phenomenal 76-1 record during that time span.

He was named to *Parade Magazine*'s High School All-America team twice and was named the 1981 McDonald's High School Player of the Year, edging out another player you might have heard about — Michael Jordan.

If a high school player had put together a career like that in the current era, the sports media portion of the internet would be virtually exploding with accolades. But this was a different era. IBM would not introduce what we would call its first desktop home computer until the summer of 1981. There wasn't an internet, thus no social media, It was an era of landline phones when print edition newspapers and magazines reigned in the sports media environment. A time so different

from today for those of us who came of age in the B.C. era — before computers and before cell phones.

It was during this era of communications that Patrick Ewing made his mark. But still the traditional big-name coaches found their way to his door. He almost signed up to play for Dean Smith at the University of North Carolina — a move that would have made him and Jordan teammates. The move meant he also bypassed Rick Pitino, who was the coach at Boston University during that time

Instead, he went to Georgetown University in Washington, D.C. where he played for coach John Thompson — a leader who is it is fair to say had both his backers and his detractors. While there, Ewing would return to Boston to play against Boston College since both were members of the Big East Conference at that time.

Ewing led Georgetown to three appearances in the NCAA Division One "March Madness" tournament, winning the title in 1984 when the Hoyas beat Houston 85-75 at the Kingdome in Seattle.

After his playing days were concluded Ewing went on to serve as an assistant coach for the Washington Wizards, Houston Rockets, Orlando Magic, and Charlotte Hornets.

He eventually was named the head coach at Georgetown, his alma mater. He was there for six seasons before being let go.

But when one door closes, another often opens. "The New York Knicks and Patrick Ewing are synonymous with one another and we are humbled and excited to bring Patrick Ewing back home," stated Knicks president Leon Rose in a press release. "He is a monumental figure in New York basketball lore and brings a wealth of knowledge from his time both on and off the court that is unmatched."

The majority of the writers in the New York metropolitan area are picking the Knicks to make it to the Eastern Conference Finals this coming spring — something they almost accomplished last season before being eliminated by Indiana.

But no one is picking them to win the Eastern Conference Finals. Everyone in the NBA has the Celtics returning to the NBA Finals and most have them winning a second consecutive NBA title.

In that sense, although the October 22 opener will be only the first game of the 82-game regular season schedule, it may serve as a very early preview of next year's playoffs.

Of course, that is a long way away and much could happen before we get there. Over the course of the long season injuries — both repetitive and singular — sometimes take their toll. But providing that is on the floor on October 22 is still available during the spring playoffs, it could be quite a bit of a window into the future spring playoffs.

Only time will tell.
