#### Let's Go Brandon!

The creator of *America's Most Wanted* is urging voters in the Syracuse area to back the re-election of first-term Republican Brandon Williams in a TV ad buy. "Tonight, America's most dangerous criminals are back out on our streets, thanks to Democrats (Gov.) Kathy Hochul and John Mannion," says John Walsh in a 30-second TV campaign ad. "Democrats support cashless bail, releasing violent criminals in our communities, putting families at risk ... Brandon Williams will keep America's most wanted behind bars where they belong," said John Walsh.

#### Latest Lithium Fire Death

A 69-year-old man was killed when a fire sparked by a lithium-ion battery trapped him inside his Brooklyn apartment Wednesday of last week. The victim died and two others were injured in the early morning fire that broke out inside the second-floor apartment, where the battery, which powered a scooter, burst into flames.

#### The True Threat to Democracy is ...

"The real long-term threat to democracy in the United States is the increasing willingness of Democratic Party leaders to use the power and leverage of the federal government to silence speech they don't like," explains the Washington Examiner editorial board. The Supreme Court's "shouting fire in a crowded theater" exception to the First Amendment came "in an infamous case that wrongly gave the federal government dictatorial authority to shut down debate" about "the draft during World War I," and the high court ruled in 1969 "that free speech could not be so easily limited." Rather, "the proper test for limiting speech was much narrower"; was it "likely to incite or produce ... imminent lawless action?" And: "Under this test" Democrats "current"

Columbus Day Celebration on Pier 1, East Boston

The Italian American Alliance celebrated Columbus Day on Monday, October 14th and they couldn't have chosen a more fitting location to honor the explorer's history. # Should Photo Identification Be Required When Voting In-Person?

Federal identification laws require voters to present some form of photo ID in order to register to vote. Whether each state should require voters to show identification before voting has become a subject of debate. Supporters of requiring voter identification laws argue that it is needed to prevent voter fraud, it does not decrease voter turnout, and it is popular with voters. Opponents of requiring identification laws argue they are burdensome for many voters and target minorities and argue that in person voting fraud is rare.

As of April 2024, 35 states required voters to present identification in order to vote at the polls on election day. Of these states, 24 required voters to present identification containing a photo, and 11 accepted

other forms of identification. The remaining 16 states did not require voters to present identification in order to vote in person at the polls on election day.

Valid forms of identification differ by state. In certain states that require voters to provide identification, there may be exceptions that allow some voters to cast a ballot without providing an ID. Commonly accepted forms of ID include driver's licenses, state-issued identification cards, and military identification cards.

There are multiple arguments for and against voter identification laws. Those in support believe "Voter ID laws can stop multiple types of fraud, such as impersonating another registered voter, and stopping out-of-state residents or someone registered in multiple

jurisdictions". There are voters across various demographics who support voter ID laws in numerous polls by almost 80%, including almost 60% of democrats, according to the Heritage Foundation.

The opponents to voter identification laws cite "Overly burdensome photo ID laws deprive many voters of their right to vote, reduce participation and stand in direct opposition to our country's trend of including more Americans in the democratic process. Many Americans do not have one of the forms of government-issued photo identification that state laws list as acceptable for voting. These voters are disproportionately low-income, racial and ethnic minorities, the elderly,





Domitian, Nerva, Trajan, and Hadrian.

The first six Caesars, from Julius to Nero constitute what is commonly known as the Julio-Claudian line. Readers must be reminded that Julius Caesar was a dictator but not an emperor; therefore, of the "Twelve Caesars" only eleven were emperors. It also might be of interest to note that in later years, the names Czar and Kaiser (absolute rulers) were derived from the Latin name Caesar.

The Julio-Claudian line was followed by "The Flavian Emperors" who were Vespasian, Titus, and Domitian. These are the emperors who were responsible for the construction of the "Flavian Amphitheater" which we now call the "Coliseum." The next three Caesars: Nerva, Trajan, and Hadrian are part of a line of emperors which were called the "Antonines" or "The Good Emperors."

# **5 Massachusetts State Ballot Questions**

On election day in Massachusetts, Tuesday, November 5, 2024, five binding statewide ballot questions will appear on the state election ballot offering each voter the option to vote **YES** or **NO**. The choices you make will shape the path that our state and local government will follow. Please take the opportunity to participate in this process, because your vote does matter!

**Question1: State Auditor's Authority to Audit the Legislature**— This proposed law would specify that the State Auditor has the authority to audit the Legislature. A **YES** vote would specify that the State Auditor has the authority to audit the Legislature, a **NO** vote would make no change in the law relative to the State Auditor's authority.

Question 2: Elimination of MCAS as High School Graduation Requirement — This proposed law would eliminate the requirement that a student pass the Massachusetts Comprehensive Assessment System (MCAS) test (or other statewide or district-wide assessments) in mathematics, science, technology, and English in order to receive a high school diploma. Instead, in order for a student to receive a high school diploma, the proposed law would require the student to complete coursework certified by the student's district as demonstrating mastery of the competencies contained in the state academic standards in mathematics, science and technology, and English, as well as any additional areas determined by the Board of Elementary and Secondary Education.

A **YES** vote would eliminate the requirement that students pass the Massachusetts Comprehensive Assessment System (MCAS) in order to graduate high school but still require students to complete coursework that meets state standards. A **NO** vote would make no change in the law relative to the requirement that a student pass the MCAS in order to graduate high school.

**Question 3: Unionization for Transportation Network Drivers**— An Act Giving Transportation Network Drivers, such as Uber and Lyft, the option to Form a Union and enter into Collective Bargaining. A **YES** vote would provide transportation network drivers the option to form unions to collectively bargain with transportation network companies regarding wages, benefits, and terms and conditions of work. A **NO** vote would make no change in the law relative to the ability of transportation network drivers to form unions.

Question 4: Limited Legalization and Regulation of Certain Natural Psychedelic Substances — The proposed law would allow persons aged 21 and older to grow, possess, and use certain natural psychedelic substances in certain circumstances. The psychedelic substances allowed would be two substances found in mushrooms (psilocybin and psilocyn), and three substances found in plants (dimethyltryptamine, mescaline and ibogaine). These substances could be purchased at an approved location for use under the supervision of a licensed facilitator. This proposed law would otherwise prohibit any retail sale of natural psychedelic substances. This proposed law would also provide for the regulation and taxation of these psychedelic substances.

A **YES** vote would allow persons over age 21 to use certain natural psychedelic substances under licensed supervision and to grow possess limited quantities of those substances in their home and would create a commission to regulate those substances. A **NO** vote would make no change in the law regarding natural psychedelic substances.

**Question 5: Minimum Wage for Tipped Workers** — This proposed law would gradually increase the minimum hourly wage an employer must pay a tipped worker, over the course of five years. The proposed law would require employers to continue to pay tipped workers the difference between the state minimum wage and the total amount a tipped worker receives in hourly wages plus tips through the end of 2028. The proposed law would also permit employers to calculate this difference over the entire weekly or biweekly payroll period. The requirement to pay this difference would cease when the required hourly wage for tipped workers would become 100% of the state minimum wage on January 1, 2029.

Under the proposed law, if an employer pays its workers an hourly wage that is at least the state minimum wage, the employer would be permitted to administer a "tip pool" that combines all the tips given by customers to tipped workers and distribute them among all the workers, including non-tipped workers.

A **YES** vote would increase the minimum hourly wage an employer must pay a tipped worker to the full state minimum wage implemented over five years, at which point employers could pool all tips and distribute them to all non-management workers. A **NO** vote would make no change in the law governing tip pooling or the minimum wage for tipped workers.

# **College Students Express Concern Ahead** of 2024 Election

### "We're Going in the Wrong Direction"

American college students are worried about the state of the country as the presidential election draws near, including how Americans talk to one another, inflation and future prospects. Students at the University of Tennessee and New York University (NYU) spoke about how they feel regarding the direction of America and what they are most concerned about when it comes to their future

"Right now, it's kind of heading in a negative direction because I feel like every one's lost hope," said Marina, an NYU student. "It's quite scary knowing how much information is censored these days," stated Kevin, a University of Tennessee student. Lily, also a student at University of Tennessee, said "it is currently a very divisive time for the country" and added that "former President Trump and Vice-President Harris are complete polar opposites. I think it's really hard to have that conversation with people and kind of have a peaceful conversation about disagreements. I hope we're going in the right direction. I do enjoy this country. I love the freedoms that we have, and hope they stay protected," she added.

Voters on college campuses in Washington, D.C., Milwaukee, Detroit and Houston cited the economy, immigration and foreign policy as their top issues. One student expressed optimism about his own future but is pessimistic in terms of the country as a whole. Alex, a student at George Washington University, who describes himself as far left, believes "inflation, rent prices and the housing crisis is something that I think the Biden administration didn't really tackle enough, along with securing a ceasefire in Gaza."

This group could very well represent a large voting bloc, so it may be in the best interest of each candidate to take the feelings and beliefs of this next generation quite seriously.

### What Once Was Promised



### L'Anno Bello: A Year in Italian Folklore

This is Halloween! A Very Haunted Holiday

After those chilly and windblown autumnal rains that frequently mark the end of the October, the forest outside my bedroom always looks particularly eerie. A few bright yellow leaves cling gingerly to slick black branches, shivering against the cool air. The thick gray clouds blanketing the sky offset the carpet of red and orange leaves strewn on the ground. On my way to work in the morning, jack-olanterns grin from doorsteps

and cloth ghosts wave playfully from porches. At night, the ominous dark sky and whispering winds propel me indoors to my cozy home, surrounded by soft light and the scent of baked goods. Yes, the time has come for Halloween, the spookiest night of the year, when witches and ghosts and vampires depart our collective subconscious and enter the realm of the everyday world. During Halloween, nothing is what it appears to be, and the day pulsates with a mysterious, spine-tingling energy. Halloween remains one of my favorite holidays, not just because of the oh-so-welcome prevalence of chocolate, but also because it brims with a sense of wonder and possibility over all that is unknown and unexplainable. At times macabre, and often bizarre, Halloween has an equally colorful origin story. The feast as we know it today took an intriguing and complex journey across continents and ancient traditions in order to morph into the modern Halloween. With roots in a pre-Christian harvest festival and its strong association with the Catholic feasts of All Saints and All Souls, Halloween boasts a history full of fascinating twists and memorable customs.

The story of Halloween begins with the ancient Celts, who celebrated a holiday known as Samhain (pronounced sow-en, where "sow" rhymes with "cow") on November 1st, with festivities commencing on the preceding evening. Samhain was considered the first day of winter, and some scholars theorize it may have functioned as the Celtic New Year. Samhain represented a time of uncertainty and fear for the Celts: the harvest had just finished, and the cold days of winter were quickly approaching. A good harvest meant the difference between life and death for their agriculture-based society, so the Celts prayed for a successful crop. As nature itself appeared bare and barren on the blustery days of early



November, Samhain retained a potent connection with death. Indeed, the Celts believed that the veil between the world of the living and that of the dead proved especially fragile on this transitional night, and that both good and bad spirits wandered the Earth during Samhain. Celts built bonfires and donned frightening costumes to deflect these spirits, and costumes continue to form an indelible part of modern Halloween. The Celts also hoped to ward off evil spirits by carving jack-o-lanterns, or hollowed turnips etched with eerie faces and illuminated by a candle inside. When Irish immigrants arrived in North America in the nineteenth century, they carried over this custom, substituting the pumpkin for turnips. Due to the fluidity between the worlds of the living and the dead, Samhain also served as an especially appropriate time for divination. Girls would toss apple peels over their shoulders in order to determine the initial of their future spouse, and people interpreted bonfires for omens concerning the harvest. Meanwhile, unsettling stories of ghosts returning to visit the living could also be found among our ancestors in ancient Rome, who held feasts to appease the lemures, or restless spirits.

Samhain, the pre-Christian holiday commemorating the end of the harvest and the specter of death, received another slew of customs when it merged with All Saints' Day and All Souls' Day, two Catholic feasts which likewise honor the dead. As Christianity spread across Europe in the early Middle Ages, the Church eventually attached All Saints' Day to the date of November 1st in order to bring a religious context to Samhain. All Saints' Day was also known as All Hallows, and the name of the previous evening, All Hallows' Eve, transformed into the name Halloween. While All Saints' Day revered the memory of deceased saints, a new holiday situated on November 2nd, All

Souls' Day, sought to honor all the faithful departed. The popular practice of trick-ortreating harkens back to All Souls' Day. During the medieval tradition of souling, beggars and children would traipse door to door and receive spiced cookies known as soul cakes in exchange for prayers on behalf of the household's dead. Modern Italians do celebrate Halloween with all the usual trappings of witch decorations, glowing pumpkins

and haunted attractions, but All Souls' Day remains the most significant festival of the dead in that country. On il Giorno dei Morti, or day of the dead, Italians visit and clean graves and attend special Masses for the deceased. In villages across the countryside, grandparents whisper bone-chilling tales of lost travelers who stumble into a church service on the night of All Souls and notice that the pews are lined with the wraiths of long-gone townsfolk. In some regions, children may leave offerings of food for wandering souls on All Souls' eve and find treats the next morning. In other areas, people munch on ossa dei morti, or nutty spice cookies whose creepy name translates to "bones of the dead"! I vividly remember learning about el Día de los Muertos, or the Latin American Day of the Dead, in my Spanish class and making a cinnamon-topped anise bread known as pan de los muertos. It seems that spooky holidays know no geographical bounds!

On Halloween, I love to honor old traditions. I keep the ancient motifs of harvest's end and the pervading sense of the unknown in my mind as I celebrate Halloween in a folksy, homey manner. A wooden wreath sporting jack-olanterns and black cats adorns my door. I bake a pumpkin bread swirled with a ribbon of cream cheese every year, letting the autumnal scent of the spices pervade my kitchen. After handing out candy to trick-ortreaters, I snuggle with a cup of tea on my living room couch, watching special Halloween programs with my husband. These traditions combine to make Halloween one of my favorite and most meaningful holidays. Some people may be put off by the emphasis on death, but this actually stems from the customs of olden, earth-based festivals. As withered branches howl against the dark late October nights, it is no wonder that the ancient Celts turned to matters of mortality and legends of restless ghosts at this time of the year. However, Halloween also functions as a sort of new year, emphasizing the fact that the year is a cycle, with the sun and nature soon returning. By acknowledging the mysteries of the world and their place in the dark half of the year, we can truly learn to appreciate the light.

Her mom's love is ever present and I can attest to that after all those meals I ate with them at their family dining table. Lina loved cooking and making everyone happy. She and her husband Vincenzo (Vinny for short) were married and in love for almost 62 years. He will miss her dearly as will her children, Maria, Pat and Lisa. Christian, her grandson, will miss her as will her entire extended family.

The Capogreco family always understood the concept of faith, family, friends and community. Eating together every Sunday evening and sharing life with each other. On a number of those dinners, I was invited to share dinner with them. I saw first-hand what family love is really all about. It reminded me of long-ago days growing up when my mom, dad, little brother Dominic and I regularly ate dinner together, talked, laughed, and

passed the Italian bread around the table. I can still remember my family celebrating all our birthdays together at the dining table, eating ice cream and cake and sometimes my dad would even bake a cake or apple pie.

The Capogreco's grew up in a Calabrese home, I grew up in a Sicilian-Irish home. My dad was always the cook at my house because he loved to cook and my Irish mom thought that was just great with her.

I still remember the first time I broke bread with the Capogreco Family one Sunday for dinner. When the meal ended, I immediately went over to the sink to start washing the dishes. Everyone stopped and looked at me. Several wondered why I was at the sink but growing up washing dishes was my mother's job but she always told me and Dominic, she was passing on washing duties to the both of us.

I couldn't cook like my dad but my brother did. I could do well at the sink and that made my mom smile. She trained me well and just smiled at me.

Having the Capogreco family enter my life has become a very important part of this period of my adult life. We all grow up differently with different families and with different traditions but we all know what faith, family, friends and community means. I feel badly for those who missed these four things that the priest spoke of in his homily up on the pulpit at Lina's Mass. When travelling on this journey for a while, we eventually come to understand the true meaning of this brief journey we are all on. We need one another to truly understand ourselves. Lina's journey down here has ended but she lives on with God now. Meanwhile, we keep on our journey remembering what came before, what was and what is to come.

On her mother's side, she was descended from the Quincy's, a family of great prestige in the colony; her father and other ancestors were Congregational ministers, leaders in a society that held its clergy in high esteem.

Abigail lacked formal education, like other women of the time, but she was curious and highly intelligent, and she read avidly. Reading created a bond between her and John Adams, a young lawyer who recently graduated from Harvard, and they were married in 1764. It was a marriage of the mind of the heart.

The young couple lived on John's small farm in Braintree and moved to Boston as his practice grew. Over the next 10 years, they had three sons and two daughters, Abigail looked after family and home when he went traveling as a circuit judge.

Long separations kept Abigail from her husband while he served the country as delicate to the Continental Congress, envoy abroad, elected officer under the Constitution. Her witty letters vividly detail her life in times of Revolution. They tell the story of the woman who stayed at home to struggle with wartime shortages and inflation; to run the farm with a minimum of help; to home-school four children when formal education was interrupted. Most of all, they tell of her loneliness without her "dearest friend."

In 1784, Abigail joined John at his diplomatic post in Paris, and observed with interest the manners of the French. After 1785, she filled the difficult role of wife of the first United States Minister to Great Britain. In 1788, they returned to Massachusetts and the new

house they had just acquired in Braintree, later called Quincy, home for the rest of their lives.

A wife of the first vice president, Abigail became a good friend to Mrs. Washington and a valued help in official entertaining, drawing on experience of courts and society abroad. After 1791, however, poor health forced her to spend as much time as possible in Quincy.

When John Adams was elected president, she continued a formal pattern of entertaining, even in Washington and the primitive conditions she found at the new capital in November 1800. The city was wilderness, the president's house far from completion.

The Adams' retired to Quincy in 1801, and for 17 years enjoyed the companionship the public life has long denied them. Abigail passed away in 1818, and is buried beside her husband in United First Parish Church. She leaves her country a most remarkable record as patriot and First Lady, wife of one president and mother of

#### Saint Francis Di Girolamo

Known as the Apostle of Naples, Francis was born in Taranto in the province of Naples of exceptionally virtuous parents, in 1642, he was the eldest of eleven children.

Showing early signs of intense piety and intellectual ability, he was received into a community of secular priests who initiated his education. He received the tonsure at sixteen and was ordained with special permission before the age of twenty-four.

Francis taught at a Jesuit college for several years, and at twenty-eight was received into Society of Jesus, despite his father's strong opposition.

His novitiate complete, Francis was sent to Leece to assist a renowned preacher, Father Agnello Bruno.

For the next three years the two priests travelled the length and breadth of the province of Otranto. At the close of their travels, Francis completed his theological studies and was professed.

The next field of his apostolic labors was to preach at the Church of Gesu Nuovo in



Naples, and from the very beginning, attracted huge crowds. His preaching produced such excellent results that he was appointed to train other missionaries.

Preaching was his dominant talent. Wherever he went, people were spellbound by his eloquence and crowded his confessional. He preached in one church after another, at times impromptu in the street, he

visited hospitals, prisons, and galleys. Once he brought to the Faith twenty Turkish prisoners in a Spanish galley.

The holy Jesuit's preaching was enhanced by his reputation as a wonder-worker, though he continuously disclaimed any extraordinary powers, and rather attributed the numerous cures which accompanied his ministry to the intercession of St. Cyrus to whom he had a special devotion.

After suffering from a painful illness, St. Francis of Girolamo died at age seventy-four. He was canonized in 1839. The Feast Day of Saint Francis Di Girolamo is May 11th.

### Massachusetts and Boston to Embark on Two-Year Celebration of Sesquicentennial (250th Anniversary of America's Independence)

The Governor also offered \$1.5 million from her administration in funding for 37 different celebratory projects across Massachusetts.

Funds for Anniversary related events across the state will cover historical re-enactments including the Shot Heard Around the World, the Battle of Bunker Hill and Paul Revere's Ride. Massachusetts Economic Development Secretary, Yvonne Hao, said "the celebrations will be an opportunity for us to lead and also create a ton of economic development for our state. You're welcome to America. Come visit us. Come spend money with us. Come help all of our creative economy."

The Governor believes the anniversary of the founding of the U.S., the war and ultimate victory over Britain to secure our independence will showcase technological advancements in Massachusetts, the fact it boasts the first public school, public library, public transit system, public beach and public park. "We're a state that led in the past and now invents in the future, the state that cures diseases, develops vaccines and heals the world. We're standing up for and protecting the very rights, liberties and freedoms that folks came together for 250 years ago to fight for and establish right here in Massachusetts," Governor Healey exclaimed.



The event will feature the history of East Boston's oldest cemetery, the people buried there, and maybe even a ghost story. The Tombstone Tour is free to the public, and refreshments will be provided.

The Bennington Street Cemetery was established in 1838 and is listed on the National Register of Historic Places. The entrance to the cemetery is located on Bennington Street between Swift Street and Harmony Street.

The East Boston Museum and Historical Society is a local volunteer organization dedicated to preserving and promoting the rich and diverse history of East Boston and its people. October 2024 marks the release of the final in the series of half-speed mastered studio albums from Pete Townshend. The Iron Man: The Musical By Pete Townshend and Psychoderelict (Music Only), which is making its vinyl debut. These limitededition black vinyl versions have been mastered by longtime Who engineer Jon Astley and cut for vinyl by Miles Showell at Abbey Road Studios with a half-speed mastering technique which produces a superior vinyl cut, and are packaged with obi strips and certificates of authenticity. Initially released in 1989, The Iron Man: The Musical by Pete Townshend, is an adaptation of Ted Hughes' famous short story, The Iron *Man.* The album was produced and mainly composed and performed by Townshend, but also features performances from Roger Daltrey, legendary bluesman John Lee Hooker, and the astonishing Nina Simone. The three then-surviving original members of The Who (Daltrey, John Entwistle, and

Townshend) perform two songs, "Dig," and a cover of The Crazy World of Arthur Brown's "Fire." A stage version was mounted at The Young Vic Theatre in 1993, where 20 years earlier, The Who had debuted songs for Life House/Who's Next, which led to a movie version in 1999, for which Pete received an executive producer credit. Psychoderelict, released in 1993, is Pete's last solo album to date. Structured like a radio play with dialogue, it follows Ray High, a reclusive '60s rock star who resurfaced in Townshend's novella, The Boy Who Heard Music, and in the mini rock opera Wire & Glass, the centerpiece of The Who's Endless Wire album. The Half-Speed Master is presented without the dialogue of the original album and is making its vinyl debut. Psychoderelict track list contains: Side 1) English Boy/Meher Baba M3/Let's Get Pretentious/Meher Baba M4/ Early Morning Dreams. Side 2) I Want That Thing/Outlive The Dinosaur/Now And Then. A Nostalgic Remembrance



Today is October the 25th, the date my folks celebrated their anniversary. Giovanni DeCristoforo and Angelina Contini were married at the Sacred Heart Church in East Boston on October the 25th, in 1936, eighty-eight years ago. They became Mr. and Mrs. John and Anne Christoforo. They were married for fifty-five years, when Dad passed away in 1991. Mom made it into her late 90s, passing in 2007.

It was October of 1961, and I decided to throw a surprise 25th anniversary party for them. I called Uncle Nick, who headed up the musicians' union back then, to see what we could set up. He called Stanley Blinstrub, the owner of Blinstrub's, Boston's famous supper club. We met with Mr. Blinstrub who reserved a table for me that was down front perpendicular to the center of the stage. I told my folks that I was receiving an award from Boston State College and the presentation was to be made on the night of the 25th. In spite of it being their anniversary. They were OK with everything and I called members of the family and close friends that I knew would like to celebrate my folk's 25th.

Mr. Blinstrub knew Dad, as my father had played with the house orchestra on many occasions, and all of his entertainment was New York or Las Vegas level and went through Uncle Nick when they played Boston. It just happened that the entertainer on the night of the surprise party was Sammy Davis Jr. On the afternoon of the surprise party, Uncle Nick met with Davis and outlined what he would like him to do that night to acknowledge my folks and help them celebrate. The show was scheduled for around 9:00 or 9:30 and I had the guests all show up at around 8:00 pm. When I brought my folks in around 8:30, everyone at the table stood and applauded, then toasted my folks in both English and Italian.

The list of guests included Babbononno (Nanna had passed away three years earlier), my mother's brothers, their wives, Dad's widowed sister, Mary, my mother's closest cousins and their spouses, Dr. Rose Giannini and her sister, a few East Boston neighbors and my fiancé, a Winthrop girl named Florence. My folks were totally surprised and sat at the head of the table. Within minutes, the wait staff took everyone's dinner and drink orders and one and all made merry until it was showtime. The first act

was a local tap dancer named Luck Lewis, who was followed by a local comedian named Teddy English. I would back them years later when they played Piety Corner Gardens in Waltham, and I led the house band there.

As soon as they were done,

Sammy Davis was announced and did about 30 minutes of his newest hit songs. After that, he started talking to the audience and introduced my folks and made a big deal of their 25th anniversary. He sang a few songs to them and Uncle Nick winked and nodded in my direction. I knew at that point that he had met with Davis and set everything up. Someone yelled up to Davis that I was the source of the surprise party and that I was 3rd generation musician in my family. At that point, Sammy Davis invited me to come to the stage and sit in on bass. He climbed behind the drums, and along with his pianist, George (I think), we three played a few jazz selections for the audience. (Besides being a great singer, tap dancer and actor, Sammy Davis was an accomplished drummer.) When it was time for me to exit the stage, Sammy whispered, "I want to talk to you before you leave." I nodded and headed back to my table. All told, he was on for almost two hours, and then came to our table to congratulate my folks. Before he headed out, he pulled a chair out from a nearby table, sat next to me and gave me a slip of paper with his private number on it, saying, "If you make it to the coast, give me a call. This is my private number so don't call before 4:00 in the after-noon. If you can hit the west coast, we can do something together, I dig the way you play bass." He then asked me for my phone number and when I wrote it, I gave him my stage name, Johnny Christy Jr. along with it. A year or so later, I was out in Hollywood and called him. I filled in on several occasions in Los Angeles and Las Vegas, and would tie up with him in Puerto Rico 2 years later, when he entertained his mother's people at a San Juan hotel. (Sammy was Puerto Rican on his mother's side.)

After he left my folks anniversary table, I asked Uncle Nick to get me the bill for the party as none of the wait staff had brought one. He went into the kitchen, came out and motioned for me to follow him. In the middle of the kitchen was a couch where Mr. Blinstrub often sat to observe the operations of his club. He was on the couch when I entered, and as I approached,

I thanked him for all he did and asked for the bill. His reply was, "Tip the waiters that served you \$10.00 each. When I asked about the bill again, he smiled and said, "Did you hear what I said?" Uncle Nick whispered in Italian, "Tutto e sulla casa." (Everything is on the house.) I was thankful, grateful and honored.

On February 7, 1968, a five-alarm fire would wipe out Blinstrub's Village. Cardinal Cushing and a few of Stanley Blinstrub's close business associated tried to put fund raisers together to rebuild the supper club. It was not insured, and in spite of everyone's attempt, the club never reopened.

I would continue to have anniversary parties for my folks for the next 30 years. Dad was never into large parties, but Mom was, so I compromised. For numbers 30, 35, 40, 45, 50 and 55, I had large parties, but for the years in between, I would take my folks out for dinner and include only the closest of friends or relatives.

On one occasion, Mom and Dad wanted to celebrate their anniversary at a Japanese restaurant called Osaka that was located in the Fresh Pond section of Cambridge. I knew the owners who were Japanese, but from Argentina, and set everything up. My folks had never eaten Japanese food prior to, so I explained as much as I could. When the main courses were served, the owners came to the table to meet my folks and wish them a happy anniversary. Their English was so-so, and I don't speak Japanese, so we spoke in Spanish. When all was said and done, I heard someone at the next table saying, as he pointed toward me, "Wow, that young man speaks beautiful Japanese."

On other occasions, I brought my folks to steak houses for anniversary dinners. A friend once asked me why I didn't bring them to Italian restaurants. MY answer was, "We are Italian. There is no way a restaurant's red sauce (gravy) is going to be as good as my mother's, so why look for trouble?" I know that those of you out there who are Italian or grew up in Italian homes, know what I mean, right???

In South Tyrol, apple strudel is more than just a sweet indulgence; it's a cherished symbol of heritage paying tribute to the region's abundant apple orchards, The classic recipe features wafer-thin pastry wrapped around a fragrant filling of sliced apples, sugar, cinnamon, and raisins, with the occasional addition of almonds or walnuts. Baked to a perfect golden brown, every bite offers a balance of sweetness and warmth that captures the essence of South Tyrol. For many families, the real magic happens in their own kitchens, where the art of making it from scratch is passed down like a treasured heirloom.

As a young girl, I was fortunate to be able to join my Nonna to gather apples from the trees in her yard, which we then used to create an assortment of delicious desserts. From crostata's to sbriciolatas, each one was more delicious than the last. Sometimes we would prepare strudels inspired by those from Bolzano; other times, Nonna would use her cherished sweet crust or even puff pastry to create her own. This recipe, passed down through generations, brings together flaky pastry, spiced apples, and sweet icing — a tribute to family, heritage, and those comforting moments in the kitchen with Nonna!

#### NONNA'S APPLE STRUDEL Strudel Di Mele Della Nonna



#### Crust

3 cups all-purpose flour

1 teaspoon salt

2 tablespoons sugar

1 ½ cups chilled butter flavored shortening, cut into small pieces

½ to ¾ cups cold water

In a large bowl, sift together the flour, salt, and sugar. Add the chilled shortening, and using your hands, mix until the texture resembles sand. Slowly add the cold water and continue mixingexpect the dough to be sticky. Flour your hands, wrap the dough in plastic wrap, and refrigerate for 30 to 45 minutes.

#### **Filling**

6 to 8 apples, peeled and cut into chunks

1 organic lemon

½ cup all-purpose flour 2 teaspoons cinnamon

1 teaspoon nutmeg

½ cup and 2 tablespoon brown sugar

In a medium bowl, toss the apple chunks with the lemon juice. Add the flour, brown sugar, cinnamon, and nutmeg, and mix until the apples are evenly coated. Set aside.

#### Icing

2 cups confectioners' sugar

1 tablespoon softened butter

6 to 8 tablespoons whole milk

Combine the confectioners' sugar, butter, and milk in a bowl, mixing until smooth. Transfer the icing into a Ziplock bag for easy drizzling.

#### Assembly & Baking

Preheat the oven to 400°F. Line a 13x9-inch baking sheet with parchment paper.

Once the dough is ready, roll it out on the parchment paper into a 13x19-inch rectangle. Spoon the apple filling down the center of the dough. Using a knife, make 14 to 16 slits along both sides of the dough. Braid the dough strips over the filling, overlapping them slightly to seal.

Carefully transfer the parchment with the strudel onto the baking sheet. Prepare an egg wash by whisking one egg with a tablespoon of water, then brush it generously over the strudel. Sprinkle with sanding or granulated sugar.

Bake for 40 to 45 minutes, or until the strudel is golden brown. Remove from the oven and allow it to cool completely. Once cooled, cut a small corner off the Ziplock icing bag and drizzle the icing generously over the strudel.

and people with disabilities. Such voters more frequently cannot afford or cannot obtain the underlying documents that are a prerequisite to obtaining government-issued photo ID cards." stated the American Civil Liberties Union (ACLU).

On the Massachusetts Secretary of State's website, a voter may be asked to show identification if you are voting for the first time in Massachusetts in a federal election, you are an inactive voter, you are casting a provisional or challenged ballot, or if the poll worker has a practical and legal reason to ask for identification. Acceptable forms include (must show your name and address at which you are registered to vote): MA driver's license or MA-issued ID card, recent utility bill, rent receipt, signed lease, copy of a voter registration affidavit, a letter from a school dormitory or housing office or any other printed identification which contains the voter's name and address.

NOTE, the acceptable forms of ID in Massachusetts are Not required to be a Photo ID. So why is a photo ID required in so many other settings, including, at a bank to conduct a transaction, at airports prior to travel, at hospitals upon check in for a doctor's visit, in schools, at work sites, when purchasing a firearm, in a bar to order an alcoholic beverage, in a liquor store to purchase alcohol, in a store to purchase tobacco or a lottery ticket. Yet voting, our most precious and fundamental democratic right Does Not Require a Photo ID be presented in order to vote in person.

Of course, with the postcovid mail in ballot option, which may be requested in Massachusetts online, by mail or via e mail or fax, the need for a photo ID has become basically obsolete. In addition, the State of Massachusetts is required by state law to send a pre-addressed, postage prepaid Vote by Mail application to every registered voter before each statewide election, again eliminating the need to provide photo ID when voting.

While change and adaption are necessary to progress in our society, it is my opinion that certain liberties are just too vital and delicate to alter. Voting Must be one of them. It is just too important to play around with. In person voting (except in specific circumstances) by U.S. born or naturalized Citizens, requiring a photo ID are imperative to the continuity of our precious Democracy!

# When Doug Jones Fought the Other Clay

Doug Jones is best remembered for his fight with Cassius Clay. The fight took place in 1963. It was young Clay's 18th fight and the closest he would come to being defeated in his early career.

At the time of the fight Doug Jones had an impressive record. While not undefeated, he had scored 21 wins in 25 contests. His losses were to Eddie Machen, Harold Johnson (in a bid to win the World Light Heavyweight Title), and Zora Folley. He would avenge the loss to Folley when he kayoed him in 7 rounds. This was just before Jones took on Clay. Jones also scored a kayo over a young Bob Foster. In another fight he went to Europe where he fought a draw in a bout with Erich Shopper.

In total, Jones had 25 fights to Clay's 18. Cassius had fought some decent opposition at this time as well, going up against Billy Daniels, Alejandro Lavorante, Charlie Powell, Archie Moore, Alex Miteff, and Sonny Banks. On paper it appeared Jones had fought the better opponents and should have had the edge in experience on Clay.


There was a difference though. While Clay was fighting solid competition, he was being brought along thoughtfully. Yes, he was in with some tough guys, but they weren't of the world class status as Jones's opponents were. In fact, if Jones had been guided in the same manner as Clay his career might have ended up very differently.

In 1960 Doug Jones fought another fighter named Clay, Von Clay. This Clay was also an up-and-coming prospect. Jones had 13 fights at this point with 13 wins. Von Clay had a record of 11 wins, 1 loss, and 2 draws. The fight took place at St. Nicks Arena in New York with Jones winning a ten-round decision. The two were matched again three months later. This time it was a closer fight with Jones winning a split decision after ten rounds.

Here's where it gets interesting for both fighters. Clay was still a good prospect but obviously not ready for the big time. However, after just two subsequent wins, his managers threw him in to a title fight against the great Harold Johnson. Clay had only 18 fights at this point in his career, Johnson had been to the post 71 times. Clay was dropped once in the first round and three times in the second resulting in a knockout win for the champion.

After this loss Clay was back in the ring just two months later. After being dropped in the first round, he kayoed Kirk Barrow in the 6th round. A month later the two fought again with Clay stopping Barrow in the 5th round.

Now, just a month after beating Barrow, and just three months after being kayoed by Johnson, Clay was matched once again with Doug Jones. This fight was scheduled for

August 26, 1961 at Madison Square Garden. It would be Clay's 6th fight in that year.

Meanwhile, since the second go round with Clay, Jones had stayed busy and undefeated. He scored a kayo over former middleweight champ Bobo Olson, stopped Pete Rademacher, and kayoed Floyd McCoy.

The third fight between Clay and Jones is available to watch on YouTube. It is an interesting fight in that you get to see two very good young prospects go at it. At the opening bell Jones came out and took control and appeared on his way to a onesided victory. Von Clay rallied in the 3rd and 4th rounds and evened the fight up. Jones regained control in the 5th round and began landing heavy shots on Clay culminating in his knocking Von out in the 10th and final round. At this point Clay was an exhausted and beaten fighter.

It was not only the blows Clay took from Jones but also the toll that had been exacted on him in his fights leading up to this bout. He was a young fighter who was brought along much too fast and was already getting burnt out at this point in his career. In the final 17 fights of his career, he lost 10. A sad ending for a promising fighter.

Ironically, Jones's career began to follow the same path as Clay's after their third bout. In his very next fight, he was put in with Eddie Machen. Interestingly, Jones was originally slated to fight Harold Johnson, but Johnson pulled out due to an injury. Machen won a one-sided decision in the fight.

Jones would then fight Johnson in his very next bout. This was for the title, with Jones losing a one sided 15 round decision. You'd think Jones would be given a rest after all of these tough fights, but no. Just three months later, on August 8, 1962, he was facing top heavyweight contender Zora Folley. Once again, Jones lost though this fight was a closer with Zora winning a ten-round decision.

Just a month later, Jones is in Europe fighting Eich Schooner to a draw, then he is back in New York a month after that where he stops a young Bob Foster. His blistering schedule does not let up. Just two months later he steps in against Zora Folley once again. In a big upset he knocks out Folley in the 7th round.

This leads to his fight with Cassius Clay on March 13, 1963. Jones had the speed to match Clay and gave him fits throughout most of the fight. Clay pulled out the close decision by coming on very strong in the last two rounds.

At this point in his career, Doug Jones had only had 26 fights but was battle scarred. He had been in with formidable opposition and taken quite a few punches. In the third fight with Von Clay, you can see the great ability Jones had. He was an aggressive boxer puncher with great head movement and terrific combinations. As good as he looked at that stage of his career, he was still developing and quite a ways away from being put in with the likes of Harold Johnson and Eddie Machen. If he had been guided more carefully, he very well may have beaten Cassius Clay in 1963. Alternatively, he also could have remained fighting as a light heavyweight and seen success in that division.

Unfortunately, Jones ended up becoming an opponent. He had name recognition because of the Clay fight, but he was pretty much through as a serious prospect. He had three wins after the bout with Cassius. In his fourth fight he lost a decision to Billy Daniels whom he had previously beaten. In his next fight he was kayoed by George Chuvalo.

The descent continued with his only wins after that coming against second raters. With losses to Ernie Terrell, Thad Spencer, Joe Frazier, and Boone Kirkman, Jones finally hung up the gloves in 1967.

Both Jones and Von Clay were talented and promising prospects. Their careers may very well have turned out quite differently if they had been managed better. Instead, they were thrown in for the quick money and never were able to fully develop. Unfortunately, their story was not an uncommon one in boxing.

### HOOPS and HOCKEY in the HUB

There they were — looking upward — both those gathered on the floor of the Garden and those in the stands as well. They were there witnessing the final official commemoration of the Celtics triumphant journey that concluded with their winning the 2023-2024 NBA Championship.

Four months earlier, back in May, there had been another celebration in the Garden, one that took place in the immediate aftermath of the Celtics defeating Dallas to claim the cherished championship trophy.

But it was different. In June confetti descended from the rafters to the Garden floor, transforming the parquet into a whitened space. All eyes had been on that moment as the white shreds turned a portion of the floor into a surface fit for victory.

But now, all eyes were transfixed on an upward journey as Banner 18, nobly, solemnly and majestically, rose to take its place with its other 17 brethren for all time. Back in June, the confetti was gradually swept away but this was an eternal placement, one for the ages.

On hand were numerous Celtics luminaries including one of the eldest of the elite. Bob Cousy's lengthy lifetime of association with the Celtics has embraced all 18 banners. He won six of them — one third of the total — as an active player.

Cousy, a member of the 1947 Holy Cross NCAA Division One National Championship team, came to the Celtics in 1950. He was there for the first banner in 1957 and then for five more in 1957, 1959, 1960, 1961, 1962 and 1963.

Although the ceremony had been heavily publicized in the weeks leading up to it, the actual duration was rather short. It started at 7:00 p.m. and concluded at 7:18, thus lasting only 18 minutes — a bit of a letdown after all the buildup. We think people were expecting a somewhat more lengthy affair, given its deep meaning for the Celtics. Speeches, such as they were, were very brief. Celtics Captain Jayson Tatum, who was the last to receive his ring, seemed to be distracted by the glare of the Garden lights shining down on the spot where he stood and appeared to cut his remarks short.

We would have enjoyed hearing a few words from Paul Pierce, Kevin Garnett, and Ray Allen, three members of the 2008 championship team who were on hand.

But from a different perspective the ceremony was a novel experience. The last time the Celtics won it all was in 2008, some 16 years ago. Applying a standard that to fully understand an event one must be 10 years or older at the time, that would mean that those with a full comprehensive memory of the 2008 event would be at least 26 today, meaning that for a significant number this was an initial experience.

The raising of the banner, which was the capstone of the ceremony, occurred last. It was not raised from center court as one might have expected but from a location down near the end of the visiting team's bench.

On hand for the festivities and the game, of course, were the night's opponents, the New York Knicks. They remained in their locker room and did not witness the ceremony from the Garden floor, choosing to only engage in final warmups before tipoff. The last time the Knicks won an NBA championship was 1973 — over a half century ago. They lost in the NBA Finals twice after that - in 1994 to the Houston Rockets and in 1999 to the San Antonio Spurs. Thus, two extremes were present on the floor at the same time — the franchise with the most recent title, separated by just yards from a franchise that has not won one in over 50 years.

Many New York media members feel the Knicks can finish second in the Eastern Conference standings and then go on to meet the Celtics in the Eastern Conference Finals. Most everyone who follows the NBA picks the C's to win it all for the second year in a row. But some pick the Oklahoma City Thunder. We shall see.

As Mike Vaccaro wrote in the New York Post: "The Knicks want what the Celtics have and in order to take it away they will have to learn how to beat them over the next seven or eight months. The Celtics are the gold standard right now. They are the defending champs.' The C's return 13 players, including the entire starting rotation from last season's title team. One prominent member not seeing action on opening night was Kristaps Porzingis, who was present to receive his ring but did not take the floor. He is recovering from ankle surgery he underwent in June and is expected back sometime in December for the majority of the regular season and the playoffs.

Out on the floor, it seemed as if the Celtics from last year had just hit the pause button for a few months. Tatum hit a three-point shot soon after the tip, giving the C's a 3-0 lead that only increased as the game progressed. It reached 35 at one point in the second half and concluded with the Celtics winning 132-109. Tatum's three-pointer was the first of 29 that the C's made on the night, a total that tied an NBA record.

It appeared that the 2024-2025 season was starting for Knicks on a negative note. Last year, the Knicks were 1-4 against the C's with three of those setbacks featuring double-digit margins of defeat. It seemed that the Knicks, at least on this opening night, had not begun to learn how to beat the Celtics, a move that Vaccaro said was critical.

Finally, at some point after the game had concluded and the fans had left, the lights went out in the Garden. The festivities were over but Banner 18's reign in the rafters had just commenced, standing as a sentinel for all time as a reminder of the accomplishments of 2023-2024 Boston Celtics.
