51st Annual North End Boston Christmas Fund Luncheon

The 51st Annual North End Christmas Fund Luncheon was held at St. Joseph Society Hall at St. Leonard Church in the North End on Thursday, December 14th to a sold-out crowd.

The annual fundraiser in the North End provides Christmas gifts to elders and families from the community who would otherwise be unable to enjoy the holiday season due to financial difficulty, poor health, family situations, or lost employment.

An Appreciation Award was presented to St. Joseph Society accepted by Jim Martorano and President Eddie Summers.

The Annual Fred Carangelo Humanitarian Award given every year in memory of Fred Carangelo was presented to Marie Salvati for all her years of community service.

"Today, we honor a woman who has lived her entire life in the North End and who helps this community. Marie gives of herself and continues to help whenever asked", said Chairman Ted Tomasone.

This annual award was started in 1994 after the passing of a man who started this luncheon in the 1980s. A man who gave of himself entirely to this community while fighting muscular

AG Andrea Campbell Takes on Easy Knock

East Knock, a fast-growing company that specializes in purchasing homes from cash-strapped homeowners and renting them back to them, often at much higher prices, has agreed to change its business practices in a settlement, according to the office of Attorney General Andrea Campbell. The settlement resolves allegations that Easy Knock engaged in an unfair and deceptive "equity-skimming scheme" that involved purchasing the homes at "bargain-basement prices". After buying these homes, Easy Knock then rented the property back to the former owners, at times for unfair rents in violation of the state consumer protection law known as Chapter 93. The AG's office will also make a payment of \$200.000 to the state.

Ski Resort Uphill Battle

A California ski resort's owners have plans to erect a 20-foot statue of the Blessed Virgin and the idea isn't going over so well with the local-yocals. The Mt. Shasta Ski Park in McCloud will build the platform for the effigy atop Douglas Butte this season and construct the statue by summer, the resort announced. According to a Facebook posting, the idea of this statue was "very important" to the owner and her late husband.

However, folks in the area say the statue would offend those who aren't Christian, and a petition with nearly 1,700 signatures aims to stop the construction of this statue. Advisory: Holiday Travel

No Construction Activities During Holiday Weekends; HOV Lane from Boston to Quincy Will Open Early,

No Scheduled Closure of Sumner Tunnel

The Massachusetts Department of Transportation (MassDOT) is encouraging members of the public to plan for upcoming holiday travel by recognizing that traffic volumes and the number of travelers on public transportation are anticipated to be higher than normal. Motorists and public transportation customers should check websites for real-time travel information on major statewide roads, MBTA schedule information and the weather forecast before leaving home.

The MassDOT Highway Division is taking several steps to ensure safe and efficient travel on roadways and will be shutting down scheduled construction activities from 5:00 a.m. on Friday, December 22, until 5:00 a.m. on Tuesday, December 26, and from 5:00 a.m. on Friday, December 29, until 5:00 a.m. on Tuesday, January 2.

In addition, the High Occupancy Vehicle (HOV) lane on I-93 between Boston and Quincy will extend its afternoon hours by opening at 2:00 p.m. on Thursday, December 21, and at 1:00 p.m. on Friday, December 22, as well as at 2:00 p.m. on Thursday, December 28, and at 1:00 p.m. on Friday, December 29. The HOV lane will be closed on Monday, December 25, with deployment resuming on Tuesday, December 26, and on Monday, January 1, with deployment resuming on Tuesday, January 2.

MassDOT will not be closing the Sumner Tunnel the weekend of December 22 or the weekend of December 29 due to anticipated high traffic volume on roadways nearby. Scheduled construction work will not occur on the weekends of Friday, December 22, through Monday,

The Massachusetts Department of December 25, and Friday, December 29, through ransportation (MassDOT) is encouraging mem-Monday, January 1, 2024.

MassDOT strongly urges all drivers to minimize distractions by turning off or putting away cell phones, traveling the posted speed limit, driving sober and devoting full attention to what is ahead on the road. MassDOT encourages travelers to make an extra effort to be courteous on the roads and report to law enforcement any reckless driving.

Due to increased travel in and out of Logan Airport, the Sumner Tunnel swing lane will not be deployed on Monday, December 25, and Monday, January 1, with normal deployment resuming at 5:00 a.m. the following days.

For travelers getting to and from Logan Airport in Boston, please note:

1). Please see the MBTA's helpful online user guide on using T services to and from Logan Airport: www.mbta.com/Logan

2). MBTA Silver Line provides service between South Station and Logan's terminals. Outbound service from Logan Airport to the South Boston Seaport District and South Station is free.

3). Silver Line 1 (SL1) service to Logan is every 8 to 17 minutes, depending on the time of day (and stops at all terminals): https://cdn.mbta.com/sites/default/files/media/route_pdfs/batch_6665/741-742-743-S4-P3.pdf

FUCUS




Fucus is the name that was given to the cosmetic which the Greek and Roman ladies used to paint their cheeks and eyebrows. The use of cosmetics became very general among the Greek ladies and probably came into fashion because of their sedentary life style, which removed much of the natural color from their complexions. We are told that the practice of using cosmetics is one of great antiquity and probably started with the ancient Ionians, where it prevailed from the earliest times. They didn't paint their faces when at home, but reserved it for times when they traveled, or wished to appear more captivating.

The cosmetic that was used to provide a fair complexion

was made from white lead, while the rouge was made from vegetable reds. Red lead and mineral alkali were also used. The eyebrows and eyelids were stained black, with a kind of burnt solution that is still being used by some ladies from other countries. A soot preparation was also used but this could never hold up against tears or perspiration and at times generated some very humorous

Among the Roman ladies, the art of painting the complexion was carried to a greater extent than with the Greeks. The Romans even used a blue color to paint the veins on their temples and their favorite rouge was made from a variety of moss. All of the above is mere child's play compared to the following preparations or remedies which are taken from authentic sources, so help me Hannah (or

situations.

Ass's milk was used to remove wrinkles from the face and make the skin white and soft. Poppaea, the wife of Nero, always kept enough she-asses around for her bath supply. White lead and butter was used for skin eruptions and ulcers on the face were treated with the afterbirth of a calf (yuck). Another good remedy to give whiteness to the skin and smooth away wrinkles was to boil the hoof of a white bull-calf for 40 days, then apply to the face with a linen cloth. Bull's dung was used to bring a rosy color to the cheeks, as did an extract made from crocodile's intestines. Red spots and discolorations of the skin were removed by using calf's dung kneaded by hand with oil and

Any kind of skin fungus was cured by the application of the gooey substance made from the genitals of calves, dissolved in vinegar and native sulphur. The whole mess was stirred with a fig branch before application ... and folks, that's my tip for the day.

Massport is expecting an increase in passengers at Boston Logan International Airport during the upcoming weeks and suggests passengers allow extra time to get to Logan and through security. Extra staff will be on hand to help passengers and families who may not have traveled recently. Massport continues to

recommend passengers arrive two hours early for domestic flights and three hours early for international. There is also ongoing construction at the airport and Massport is advising passengers to please drive carefully and follow any detour

L'Anno Bello: A Year in Italian Folklore

A Cozy Christmas, a Nice Natale

The magical season known as midwinter is upon us! The shortest day of the year, also known as the winter solstice, descended upon the world this past Thursday, the 21st of December. On the days surrounding the solstice, I can sense the darkness enveloping me like a thick velvet cloak, veiling the world in a perpetual state of dusk. However, I do not mind the darkness, as I view it as a necessary and intriguing spoke on the wheel of the year. These are the nights when stars appear sharp and bright against the inky black sky, their light sending diamond-like spangles flitting across the frost below. The darkness also imbues the winter solstice with a profound significance: now that the date has passed, we know that the sun will remain for longer periods in the sky, bringing its much-awaited warmth and its sweet, luminous blaze. For this reason, Christmas — with its focus on candles and crackling yule logs and electric light displays — occurs during the darkest time of the year. Whether enjoying age-old recipes or exchanging gifts with loved ones, I most appreciate Christmas when the glow of family and tradition encircle

Many of my family's muchloved holiday customs revolve around food. Food forms an ancient and essential part of the Italian Christmas Eve feast known as la Vigilia di Natale, which my family celebrates every year. La Vigilia di Natale, or "Christmas vigil," is traditionally a meatless meal in Italy, a vestige from the era in which Christmas Eve was considered a fast day in preparation for Jesus's birth on the following day. Therefore, many Italian families trim their tables with seafood dishes for la Viailia. I am always excited to plan fish recipes with my mother

for la Vigilia; in the past, we served sole bursting with a buttery shrimp stuffing and a delectable smoked salmon quiche. This year, my mother will prepare a creamy seafood lasagna laden with shrimp and scallops. However, my favorite component of Christmas cooking involves the plethora of desserts that fill my family's kitchens. A great number of traditional Italian desserts have become inextricably linked with Christmas and remain an indispensable part of my holiday celebrations. My father would always bring home a cylindrical cardboard box of panettone home right before Christmas. Panettone, whose name means "great bread," is a sweet bread studded with dried fruit and candied peel. I am not a huge fan of the taste of panettone, but I appreciate its time-honored symbolism in the Italian Christmas festivities. I hold the nostalgic struffoli, a dessert my grandmother has been making since I was little, in high esteem. Struffoli are deep-fried spheres of dough soaked in honey, then arranged into the shape of a tree or wreath and sprinkled with colorful nonpareils. Struffoli are a fun, whimsical way to celebrate the childlike wonder of the holiday season. I also make a lemon tart every year to cap off our la Vigilia meal and honor the citrus fruits seasonal during the winter. Collectively, these desserts stand in the exquisite tapestry of love and family that characterize my Christmas memories.

Indeed, I believe that family forms the crux of Christmas joy. The true meaning of Christmas derives from the sensation of comfort and peace that envelops a person when surrounded by loved ones. I cannot imagine Christmas without my family. Our Christmas traditions. from the la Vigilia meal to opening presents at midnight, strengthen our familial bonds. When my family plays a silly board game on Christmas Eve, our merriment and laughter create a barrier of delight against the darkness and chill air outside, filling the room with the warmth of our love. Opening gifts — which my family does at midnight, according to old Italian lore, while huddled under the multicolored glow of the Christmas tree lights provides me with vet another way to relish time with my loved ones. I adore the looks of happiness and delight that fill my family members' and friends' faces when they open a present selected or crafted with thoughtfulness

and care. That moment of love and understanding is the real significance of gift-giving, not materialistic gain. No matter what traditions typify your Christmas, it remains important to approach them with joy, selflessness, and a true appreciation for the people in your life. Midwinter celebrations like Christmas developed as a response to the frigid and dark days of the winter solstice. At a time when nature seems barren and gelid, lively festivities serve to honor the abundance of past harvests and reinforce the convivial strength of community and family, offering hope that life will cycle on as surely as the sun will once again shine in the sky. An old Italian aphorism states that no one should be left alone on Christmas, which is why we should strive to do good deeds on behalf of those who are lonely or separated from their families during the holidays, including the sick, the poor and those in the military. After all, a family includes more than iust blood relations, and the Christmas spirit of generosity and goodwill is too joyous to be contained in small numbers.

This Christmas, I will continue to honor the traditions that have become an intrinsic part of my family. Whether these traditions consist of enjoying struffoli or opening gifts at midnight, they link me to the world of my ancestors and their enduring values and spirituality. However, I also plan on paying attention to the true significance of all these beloved customs. For I have found that lurking behind Christmas traditions, no matter their culture of origin, is the universal need for love. Love for family, love for the wisdom of our forebears, the love which inspires us to improve our local and global communities, the love of Jesus and the Holy Family, the love for the sun which grows ever bigger in the sky — all these myriad facets of love imbue Christmas with its indelible complexity. So on Christmas, as you partake in your own special traditions, take heed of the love which surrounds you, and which you can provide to others. You will find that this love can warm even the frostiest night, and that it will carry you through the wonders of the New Year and beyond.

North Market Building Study Report



The Boston Landmarks Commission has posted a study report on the proposed designation of the North Market Building as a Landmark under Chapter 772 of the Acts of 1975, as amended.

Designed by Alexander Parris in consultation with Asher Benjamin, North Market is the northernmost range of stores in a complex of three detached granite blocks, with Faneuil Hall Market (currently known as Quincy Market) at the center and South Market to the south. One of the most impressive and large-scaled market complexes built in the United States during the first half of the 19th century, the blocks are also significant as early examples of the Greek Revival style and monumental granite construction in Boston, encompassing Boston's first substantial civic improvement project following its incorporation as a city in 1822.

North Market has been in continuous commercial use since its completion in 1825. The multibuilding block was originally used for wholesale

and retail activity, warehouse storage, and small offices. North Market retains integrity of location, setting, design, materials, workmanship, feeling, and association.

Recognition of North Market's historic and architectural significance, and its importance to the three-block complex as a whole, accelerated during the urban renewal era of the 1960s and early 1970. During that period, local, regional, and national organizations mobilized to ensure preservation of the complex. The subsequent restoration and adaptive reuse project was completed in the 1970s to national acclaim.

This study report contains Standards and Criteria which have been prepared to guide future physical changes to the property in order to protect its integrity and character.

Saint John Almond

John Almond was born around 1577 in Allerton, Liverpool, and spent his childhood there until the age of eight when he was taken to Ireland. He went to the English College in Rome, at the age of twenty, where he was ordained as a priest, returning to England as a missionary in 1602. He concluded his term there by giving the "Grand Act" - a public defense or theses which covered the whole course of philosophy and theology — and was warmly congratulated by Cardinals Caesar Baronius and Francesco Maria Tarugi, who presided.

He continued to minister to the faithful and labored in his mission for 10 years, during that time he would eagerly speak out against the anti-Catholic powers of the state.

Father Almond returned to the dangers of England in 1602 as a secular priest and administered to the faithful there. He was arrested in 1608, and



then again in 1612. In November 1612, seven priests escaped from prison. It was alleged that, while in prison,

Almond had said that "whosoever had killed a king, and were afterward penitent ... and did confess the same to a priest, might have absolution". This allegation served as reason to execute him.

Before his death, he prayed, distributed alms to the poor, and gave his final oration, concluding with these words: "To use this life well is the pathway through death to everlasting life". During his final speech on the scaffold he condemned regicide, discussed the nature of grace and true repentance, and said that he conceded as much authority to King James as to any Christian prince.

John Almond was hanged, drawn, and quartered on December 5, 1612 at Tyburn, London, England. The Feast Day of Saint John Almond is December 5th. He is also one of the Forty Martyrs of England whose Feast Day is October 25th.


A COLUMN OF PAST AND CURRENT EVENTS

Cicero (Marcus Tullius) was born to a wealthy family on January 3, 106 BC. After serving in the military, he studied Roman law and went on to be elected to each of Rome's principal offices, becoming the youngest citizen to attain the highest rank of consul without coming from a political family. He was a writer, statesman, and was considered ancient Rome's greatest orator.

Cicero's influence on the Latin language was immense. He wrote more than threequarters of the existing Latin literature that is known to have published in his lifetime, and it has been said that subsequent prose was either a reaction against or a return to his style, not only in Latin but in European languages up to the 19th century. Cicero introduced into Latin the arguments of the chief schools of Hellenistic philosophy. He was also an adept scholar of philosophy as well as a skilled translator.

Though he was an accomplished orator and successful lawyer, Cicero believed his political career was his most important achievement.



It was during his consulship that the Catiline conspiracy attempted to overthrow the government through an attack on the city by outside forces, and Cicero suppressed the revolt by summarily and controversially executing five conspirators without trial.

During the chaotic middle period of the first century BC, marked by civil wars and the dictatorship of Julius Caesar, Cicero championed a return to the traditional republican government. Following Caesar's death, Cicero became an enemy of Mark Antony in the ensuing

power struggle, attacking him in a series of speeches. He was denounced as an enemy of the state by the Second Triumvirate and consequently executed on their behalf in 43 BC, having been intercepted during an attempted flight from Italy. His severed hands and head were then, as a final revenge of Mark Antony, displayed on the Rostra, the speakers' platform at the Forum, in Rome.

Cicero remained loyal to the Roman Republic during his career. He viewed the informal alliance known as the First Triumvirate to be in direct opposition to the principles of the republic and authority of the Senate. He wrote many works relating to philosophy, such as On the Republic, On Invention, and On the Orator. He established himself as a prolific Roman author. He also made many speeches and wrote letters that have been preserved, allowing the modern world to gain knowledge of the politics and culture of Cicero's

APPLE SEED: SPECIAL EDITION (Blu-ray) VCI Indie

Prince McCoy, now a worn down man in his 40s, living far from both the small idyllic east coast town of Apple Seed where he grew up and all the dreams he once had, finds himself suddenly without a home, a girlfriend and as of 4:32 PM, without a living father. Holding his childhood bank responsible for the foreclosure on their properties and his father's demise, Prince in a final desperate go-out-on-hissword move makes the choice to drive across the country to make his small town bank pay. With a 1967 Mustang, a loaded gun and not much else, Prince has to rely on the help of an eccentric 80 something year old hitchhiker named Carl Robbins he meets on the edge of town. With a bucket list mission of his own drafted out on a napkin, they cross paths with a struggling singer, a lonely waitress, a teenage runaway and even the love of Prince's life he once let get away, the road continues to unfold before them, as do their own fears and struggles within. After a latenight brawl with some Midwest bar locals, Carl reveals to his younger companion, Prince, that he is actually only days removed from a 40-year prison sentence he served for robbing a bank himself. As the pair move closer and closer to Prince's final destination, having to rely on their feet and even freight trains to get them there, Carl's past begins to look more and more like Prince's future. Facing the teller he robbed, a partner in crime he left near dying on the street many years ago and finally another man that he left as a young child to a rather lonely world, Carl's own destiny begins to close in on him as well. The men may not be as far apart as they once thought, have one final crossroad to face together in Apple Seed before their journeys are finished....

KILL BUTTERFLY KILL (Blu-ray) Cauldron Films

Years after being assaulted, a young woman seeks bloody revenge on the five men responsible. She is aided by a retired hitman sympathetic to her plight and a group of likeminded girlfriends. One by one, each of the creeps are caught in a trap and done away with, but her final quarry has a few tricks up his sleeve, leading to a violent climactic confrontation. Kill Butterfly Kill (aka Underground Wife) is a prime example of the so-called 'Black Movie', an exploitation sub-genre popular during the early 1980s in Taiwan. Though cheaply made, these were stylish and potent action films with often socially conscious aims and two feet planted firmly in the gutter.

After a mysterious mold starts spreading across the surface of an abandoned mattress, a sentient creature begins to take shape from within. Feasting on its unsuspecting victims' vertebrae while they rest, the

creature grows stronger, finding nourishment not only in the bones and sinew it assimilates, but also in the hopes, fears, and emotions of all those it encounters. Mayor Michelle Wu Announces Transformative Redevelopment of Boston Public Library's West End Branch to Include Housing

The City of Boston has Tentatively Designated the Development Team to Rebuild the West End Branch of the Boston Public Library and Create 119 New Units of Income-Restricted Housing

Mayor Michelle Wu, the Mayor's Office of Housing, and the Boston Public Library (BPL) announced that the City of Boston's Public Facilities Commission has tentatively designated the development team of Preservation of Affordable Housing (POAH) and Caste Capital to redevelop the West End branch of the Boston Public Library on Cambridge Street. The renovation will include a new two-story branch library and 119 incomerestricted units of housing above the library through the Housing with Public Assets initiative, an innovative new program designed to maximize the use of municipal properties for the public good.

"The Mayor's Office of Housing is very appreciative of both the Beacon Hill and West End communities. They were supportive of combining housing with a new branch library and have played an active role in shaping the RFP and associated design criteria," said Chief Sheila Dillon. "The response to the RFP was significant, with many talented development teams submitting high-quality proposals. We look forward to working with POAH, Caste Capital, and the community to shape this development proposal."

The chosen development team was designated by the Public Facilities Commission for their experience in sustainable and community-centric development projects. The proposed project involves transforming the parcel into a mixed-use development with 119 transitoriented, income-restricted apartments above the library space, along with open space and amenities for library visitors, building residents, and the public. The goal of the project is not only to expand the library's size and offerings, but also to address the growing demand to create more income-restricted housing. The development team will prioritize community input, including the needs and preferences of residents, to create an inclusive environment for all. The new building will be all-electric and designed to minimize the carbon footprint of both the housing and library, in alignment with the City of Boston's climate goals and commitment to sustainability.

"POAH has been invested in the West End since 2012 when we acquired The Blackstone Apartments, a key senior affordable housing resource in a rapidly developing neighborhood," said Aaron Gornstein, President and CEO of Preservation of Affordable Housing (POAH). "We are excited to further expand access to affordable housing in a neighborhood of opportunity that once housed generations of diverse, lower-income Bostonians. The new development at 151 Cambridge Street will be a community resource, underpinned by a re-envisioned library and a sustainable, intergenerational affordable housing community."

The 119 units of affordable housing will include a mix of bedroom sizes, from studios to three-bedroom units. The high proportion of family-sized units in this proposal was a key factor in its selection and a key community objective for the development. Of the 119 residences, 40 apartments will be affordable to households earning up to 30 percent of Area Median Income (AMI), and 79 apartments will be designated for households earning up to 80 percent of AMI.

"The West End Library project will not only revitalize the West End and Beacon Hill neighborhoods but also leave a lasting impact on the entire Greater Boston community, said Patrick Kimble, Founder and Managing Partner for Caste Capital. "Through our partnership with the Mayor's Office of Housing and the Boston Public Library to develop a new library branch and much-needed affordable housing supply, we aim to combat the pressing affordable housing crisis that impacts countless Boston residents from diverse backgrounds. This endeavor represents our unwavering commitment to creating a public asset that uplifts and empowers individuals from all walks of life. Together, we will shape a brighter future for Boston, where everyone has access to quality housing and vital educational resources."

Twenty of the most deeply affordable apartments will be created using a dedicated subsidy, in partnership with the Boston Housing Authority, which allows new public housing to be built. The new development will also include a courtyard, multiple residential amenity spaces, and a shared plaza with the neighboring Otis House museum, library, and archives.

The new development will result in a new, two-floor branch library – approximately 70 percent larger than the size of the current branch – to serve the West End community. The design of the new space will be informed by a comprehensive programming study, which was carried out by the BPL in conjunction with the City's Public Facilities Department, the Mayor's Office of Housing, and Ann Beha Architects. The

study identified potential new additions to the branch's offerings, including a new community room, a space reserved for teens, an updated outdoor space, and a learning lab, along with updated technology and audio-visual capabilities.

"As library leaders, we are charged to use all of our resources to serve the public. I can think of no higher level of public service than to colocate a public library and its critical offerings together with affordable housing," said David Leonard, President of the Boston Public Library. "In continued partnership with the Mayor's Office of Housing, we are also looking forward to additional projects that co-locate library services with housing, including in Upham's Corner and Chinatown. The Housing with Public Assets initiative uses current City-owned land to its highest and best use, and we are extremely proud to be a

The Boston Public Library and Mayor's Office of Housing, along with the Public Facilities Department and other City departments, co-hosted nine public meetings to set clear expectations for what a mixeduse building at this location could be. The participation of multiple community groups, including the West End Civic Association, Beacon Hill Civic Association, Historic New England, and others was essential to laying out a compelling vision. All told, eight different applicants responded to the Request for Proposals, demonstrating the rare and exciting opportunity to deliver multiple public benefits to the neighborhood. All the respondents presented their designs to the community over the summer, with extensive public input factoring into the evaluation and selection.

"The BHCA is very excited to see this important project move to its next phase," said Meghan Awe, Chair of the Beacon Hill Civic Association. "Converting the West End Library to a mixed-use building with affordable housing was hatched by three former leaders of BHCA. The BHCA has long been a strong supporter of this project and appreciates the spirit of transparency and thoughtful collaboration that the City has displayed through Senior Development Officer, Joe Backer of the Mayor's Office of Housing. The BHCA looks forward to continuing to work with the City and seeing the project through to completion.'

"The West End Civic Association appreciates the work that went into selecting a developer for the West End Library, including the extensive community input included during this phase of the process," said Sebastian A. Belfanti, President of the West End Civic Association. "We are pleased that the City selected a project the Association's Board and planning committee approved of, and are excited to see how the project develops from this point. We look forward to continuing clear and open public

dialogue as this innovative project moves forward."

The City's Housing With Public Assets program seeks to build low- and moderate- income housing above municipal assets. The program explores ways to build housing above City properties such as libraries, police stations, fire stations, and parking lots, as a way to maximize the utility of those locations while maintaining and improving the core functions of those properties. The program is one of many initiatives spearheaded by the Mayor's Office of Housing and the Housing Innovation Lab in recent years to address the housing crisis, including the Acquisition Opportunity Program, the Additional Dwelling Unit Program, and the Future Decker initiative.

"We applaud Mayor Wu's innovative strategy to maximize city resources and return desperately needed affordable housing to the West End, while forming an important cultural and civic anchor in the neighborhood," said Vin Cipolla, President and CEO of Historic New England. "We are so grateful to the City for its

collaborative approach, which will have such a positive impact on the neighborhood through culture, community, and meaningful partnerships."

The tentative designation to redevelop the West End branch of the Boston Public Library aligns Mayor Wu's commitment to the principles of smart growth and transit-oriented development in Boston. In the fiscal year 2023, the Mayor allocated substantial resources to address housing challenges in the city. A substantial portion of the \$200 million committed from ARPA funds has been designated for diverse housing initiatives, including affordable homeownership development, strategic acquisitions to combat displacement, energy retrofits for multifamily homes, permanent supportive housing with specialized services, and upgrades to Boston Housing Authority properties.

A Nostalgic Remembrance



Last week, I was telling you the story about the Trinity Neighborhood House and how it influenced my young life. In my dialogue of happenings on the night of their Christmas party for the kids, I mentioned that Ms. Orr, the head mistress of the settlement house, would read the Gospel According to Saint Luke, Chapter 2. I would hear this once again at the Children's Christmas Mass at the Sacred Heart Church on December the 25th, and I thought you might like to read it:

"And it came to pass in those days, that there went out a decree from Caesar Augustus that all the world should be taxed, and all went to be taxed everyone into his own city.

And Joseph also went up from Galilee, out of the city of Nazareth, into Judaea, unto the city of David, which is called Bethlehem; (because he was of the house and lineage of David) to be taxed with Mary his espoused wife, being great with child.

And so it was, that, while they were there, the days were accomplished that she should be delivered, and she brought forth her first-born son, and wrapped him in swaddling clothes, and laid him in a manger, because there was no room for them in the inn.

And there were, in the same country, shepherds abiding in the field, keeping watch over their flock by night. And lo, the angel of the Lord came upon them, and the glory of the Lord shone round about them, and they were afraid.

And the angel said unto them, "Fear not, for, behold, I bring you good tidings of great joy, which shall be to all people. For unto you is born this day in the city of David, a savior, which is Christ the Lord. And this shall be a sign unto you. Ye shall find the babe wrapped in swaddling clothes, lying in a manger."

And suddenly, there was with the angel a multitude of the heavenly host praising God and saying, "Glory to God in the highest, and on Earth, peace and good will toward men." (There are many versions of this Gospel reading and this is an abbreviated one, but the one I remember the best.)

Well, Christmas Eve finally arrived and the family headed for Nanna and Babbononno's apartment. As I mentioned last week, my musician-father and musician-uncles did not play on Christmas Eve. They had replacements cover for them. The family gathering would consist of Nanna, Babbononno, Mom, Dad, Uncle Paul, his wife,

Aunt Eleanor, their children, Paula and Ellie, Uncle Nick and his first wife, Aunt Ada, Uncle Gino, his wife, Aunt Ninna, their infant twins, Richard and Donna, and yours truly.

Like most Italian households, we would celebrate by consuming several fish courses, which traditionally were seven. Dad would make lobster fra diavolo but everything else was prepared by Nanna and Mom. I especially liked the stuffed calamari that Nanna made.

Dad, or one of my uncles, would have driven Babbononno to his brother-in-law's house. Zi'Antonio was Nanna's oldest brother and Babbononno's best friend. He was a wine maker and Babbononno would obtain a gallon or three of his best vintages. For Christmas Eve, seeing the food was mainly fish, white wine was in order. A couple of gallons of his red would also go home with us for Christmas Dinner. After dessert, Nanna and Babbononno would open the presents given them by the rest of the family and then coffee and dessert would be served. We kids were biting at the bit to get home, get to bed and await the arrival of Santa Claus, hoping that he remembered the gifts we asked for when we visited him at Jordan Marsh a week or two earlier.

On Christmas morning, I was up at the crack of dawn. Searching under the Christmas tree, I would find the gifts from my uncles and aunts, but sort of ignored them. I was more interested in what Santa had left me. From a very young age, I was into electric trains, and each Christmas added to my set of Lionel trains. I also loved BB guns, and early on, received a pump action rifle. (Unlike the movie A Christmas Story, no one ever warned me about shooting my eye out.) Another of my young interests was making models of American World War II fighters and bombers. Back then, they were made of wood, not plastic and were fun to put together. I would have asked Santa for models of a P-51 Mustang, a P-38 Lightning, a P-47 Thunderbolt, assorted carrier-based Navy fighters, or maybe a B-17, a B-25, or a B-29

I would have left a glass of wine and a couple of cookies for Santa with a note of thanks. Seeing that the cookies were gone and the wine glass was empty, I knew Santa had liked what I had left him.

Around noon, we would begin to get things ready to head to Nanna and Babbononno's for Christmas dinner and a reuniting of the family. The dining room table was set up the same, as it had been set the night before for the seven fishes. Before dinner, the kitchen table was set up with dishes of cut up cheese, cold cuts, olives, marinated mushrooms, hot peppers slices of bread and a gallon of Zi'Antonio's best red wine.

An hour or so later, Babbononno would yell out, "La cena e pronto." (Dinner is ready.) The first course was Nanna's escarole soup with pastina and tiny meatballs. Then came the ravioli, followed by meatballs, sausages, gravy meats, stuffed mushrooms, stuffed artichokes, an assortment of vegetables sautéed in garlic and olive oil, and toward the end, salad. Loaves of sliced bread sat in dishes, just in case, and at the end nuts, fruits and candy, especially torrone would be placed on the table with after dinner wines.

About an hour or two later, dessert consisting of Christmas cookies, cannoli, sfogliatelle, and zepole would be served along with both Italian and American coffee. Bottles of after-dinner drinks would find their way back to the table along with an assortment of hand-made Cuban cigars. The men would wind up in the living room with the cigars and unbuttoned trousers, while the women did all of the cleanup. Chances were that single or widowed friends of Nanna and Babbononno would have dropped in at dessert time and after the women had cleaned up, doggie bags of leftovers were put together for all to take home. Italian goodbyes took about a half hour, and by the time we got home, it was too late to play with any of the things given me by Salta Claus ... but tomorrow was another day.



ITALIAN JUJUBE NOUGAT CANDY

Caramelle al Torrone Italiano JuJube



2 tablespoons butter

2 (250 gram) bags mini marshmallows

2~(225~gram)~bags~white~chocolate~chips

2 cups gumdrops (I use DOTS)

Line a 13 x 9 pan with parchment paper and set aside.

In a medium saucepan (nonstick or sprayed with non-stick baking spray) over low heat, melt the butter, marshmallows, and chocolate chips, stirring until smooth. Fold in the gumdrops. Spread mixture in the prepared parchment lined pan. Cover and chill overnight in the refrigerator. Cut into squares and add to your Christmas cookie trays. I place mine in small treat bags with twist ties.

Note:

Spray a heavy metal spoon with non-stick baking spray and the pot as well, to make cleanup easier.

Make a parchment sling to put in the pan first and then another sheet of parchment over it to make it easier to lift out.

You can also store this is in the freezer. I store mine in the refrigerator and let it sit out before serving.

Include Gardening in Your New Year's Resolution

Microgreens are fast-growing, easy-to-grow, nutrient-dense greens that can be grown indoors and do not require much space or special equipment.

The New Year is filled with resolutions that usually involve dieting and exercise. Gardening is a great way to help accomplish those two resolutions, while also improving your mood, reducing blood pressure, managing anger, maintaining flexibility, and more.

Start the new year with a plan to incorporate healthy vegetables into your containers, gardens, and meals. Growing vegetables encourages you to eat more fresh produce and maximizes the benefits. You'll be able to harvest the vegetables at their peak of ripeness for the best flavor and maximum nutritional value. Plus, you control what, if any, chemicals are used in your gardens and containers.

Involve family and friends during the planning process and continue supporting each other in this healthful endeavor throughout the year. Research has found that making gardening a more social experience can intensify the physical and mental health benefits. Even sharing your surplus produce with others can reap greater health benefits.

Begin by growing a few microgreens this winter. These fast-growing nutritious greens are easy to grow and do not require much space or special equipment. Just repurpose some fast-food containers, fill them with a seed starting mix or quality potting mix, and plant the microgreen seeds. Many garden centers, catalogs, and organic

food coops sell microgreen seeds and sprouting seeds.

Grow a few pots of herbs in a sunny window or under artificial lights. Herbs are a healthy way to add flavor to winter meals. Start them with seeds or purchase transplants to shorten the time to harvest.

Plant these in a container with drainage holes filled with a quality potting mix. Follow the directions on the seed packet or plant tag for planting and care information. Once they are at least four to six inches tall, you can begin harvesting. Just make sure there will be enough leaves left on the plant to support new growth.

Look for new ways to prepare and incorporate vegetables into your diet. You'll find lots of recipes online and in cookbooks available from your library.

Start a list of vegetables you want to include and those that are suitable to grow in your location. Your *state's extension service* has information on what vegetables will thrive in your area and tips on when and how to plant and care for them.

Take stock of your current seed inventory. Make a list of any seeds and transplants you'll need to buy to boost the nutrition of your garden harvest. Greens like spinach, collards, Swiss chard and kale, carrots, beets, broccoli, Brussels sprouts, and red cabbage are among the most nutritionally dense vegetables.

Consider growing those plants that are most productive and cost-effective for the available space. Look for vegetables like tomatoes and sweet peppers that produce an abundance of fruit from just one plant. Adjust your harvest techniques to keep plants like broccoli and greens producing beyond the first harvest.

Once your list matches your gardening space, it is time to draw up a garden plan. If you are new to gardening, consider starting small and expanding over time. You will need sufficient time for planting and throughout the growing and harvest season to maintain, harvest, and utilize all the vegetables you grow.

Starting your nutritional gardening practices inside this winter will help generate momentum and keep you focused on your nutrition goals throughout the growing season.

Nettie's House of Spaghetti in Tinton Falls, NJ also announced earlier this year that it would no longer serve children without adult supervision.

In Royersford, PA, Chick-a -Fil banned anyone under 16 from dining at the restaurant without an adult after a series of "unacceptable behaviors," including being very loud, swearing and general rudeness and tossing food all over the place.

game. However, McHale got permission to fly to New York late on Christmas morning. He arrived on time to play against the Knicks.

Those comments and actions were straight out of Red's play-book concerning Christmas and family.

Indeed, although Auerbach is rightly celebrated for the many successful seasons that the Celtics enjoyed during his tenure, there was another dimension of the famous mentor.

Red, who was Jewish, was very inclusive and innovative for his time. Red and team owner Walter Brown drafted the first black player in league history in 1950 (Chuck Cooper). Red also had a Roman Catholic priest serve the team in a variety of capacities over the years.

School bells and basketball whistles have always figured prominently in John Creed's life. First there were the school bells that beckoned him. Born and raised on the South Shore, he graduated from high school in 1957 and from Fairfield University in Connecticut in 1961.

He went on to the seminary and was ordained a priest,

assigned to parishes in Revere, Saugus and Kingston. He later left the priesthood and was

left the priesthood and was married in 1984. Red was the best man at his wedding.

He first became a part of the Celtics organization in 1956, starting as a ball boy. That was the commencement of a 44-year relationship with the

starting as a ball boy. That was the commencement of a 44-year relationship with the storied franchise that extended all the way to the start of the 21st century. For some 20 years he was the home-game statistician for legendary Celtics radio play-by-play announcer Johnny Most, supplying the well-known broadcaster with many of the figures he would give out over the air.

The Celtics have won 17 NBA Championships. John Creed was on hand for 16 of them. And he has two tangible mementoes from those days — a pair of championship rings that were distributed to members of the team and franchise staff after the C's won NBA titles in 1984 and 1986.

So it is another Christmas on the hardwood. As you gather with family friends at home — with an emphasis on that word — may you have a very happy holiday. Red would want you to.





HOOPS and HOCKEY in the HUB by Richard Preiss

THE CELTICS AT CHRISTMAS - The Celtics will take on the Lakers in the latest renewal of their historic rivalry on Christmas Day this year, the latest in a string of holiday games for the C's that stretches all the way back to 1948.

When the Celtics meet the Lakers in Los Angeles on December 25. It will be the 37th Christmas Day game for the Boston franchise, which owns a 16-20 record for contests played on the holiday. The matchup is part of a multi-game extravaganza that the NBA has nurtured over the years. Starting at noon and extending far into the night, five consecutive games are televised nationally.

Last year, the Celtics defeated Milwaukee 139-118 on Christmas Day at the Garden behind Jayson Tatum's 41 points. Jrue Holiday, then with the Bucks but now a member of the Celtics, had 23 points and seven assists for Milwaukee. The 139 points were the most scored by a Celtics team on Christmas in the history of the franchise. The point total was also the highest achieved by an NBA team in the 21st century on Christmas and the second highest all-time on the holiday. It was only exceeded by Syracuse back in 1960 when the Nationals thrashed the New York Knicks 160-100.

Although some might think of Christmas games as a recent development, they actually go back to the early days of the NBA. In the early years of the league, the C's played on Christmas every year from 1948 through 1959.

In fact, the Celtics failed to win their first six Christmas Day games. It was not until 1954 that they proved to be victorious on the holiday. It was on December 25, 1954 that the Celtics recorded their first Christmas victory, downing Milwaukee 108-99. Bob Cousy led the way with 35 points. Teammates Bill Sharman and Ed Macauley each had 23 tallies.

So the C's were a fixture on the Christmas schedule but rarely at home. All those games in the early years were played on the road. The reason was that coach Red Auerbach refused to host a game on the holy day. He wanted the team staff to enjoy the day with their families, rather than have to report to work at the Garden. That is a good point to remember. Most of the people who work at an arena never get on television — secretaries, support staff, ushers, security personnel, custodians as well as those who work at concession stands. But for a Christmas Day game, they have to report for work just like all the high salaried players, coaches and broadcasters.

So, although the Celtics have played a number of times at the Garden on Christmas, that was not the case during the Auerbach era. In fact, of the first 29 Christmas Day games that the Celtics participated in, only one was at the Garden. That came in 1964 when Boston played the Detroit Pistons at the Garden on Christmas with the C's winning behind the 34 points put up by Sam Jones.

Even into the 1990s the Celtics never truly warmed to the idea of playing on Christmas. Chris Ford played for the C's and later served as head coach. He is probably best known for hitting the first three-point shot in NBA history back in October of 1979. But it is his statement concerning Christmas when he was head coach that has a ring to it. He once opined during a press conference that he did not like Christmas games, stating that "Christmas is the number one family day of the year."

When Kevin McHale played for the Celtics he asked for and received special permission one year to observe Christmas Eve at home with his wife and young children. League regulations state that the visiting team must be in the home team's city the night before a scheduled
