# Massachusetts State Legislature Rejects Audit Attempt

A power struggle has been brewing with the Speaker of the House Ronald Mariano and Senate President Karen Spilka on one side and State Auditor Diana DiZoglio on the other, over Question 2, the ballot initiative overwhelmingly approved by Massachusetts voters authorizing a full and transparent audit of the legislature's books. Mariano and Spilka have been successful in pushing off DiZoglio's audit claiming the November 5th ballot win is not official until all votes are certified.

Legal counsel for the state legislature said a renewed push by the auditor to scrutinize each chamber is premature given the law has not yet taken effect. DiZoglio's office requested records and documents necessary for the audit, however State House attorneys suggested the audit lacks legal authority since Governor Healey and the Governor's Council have not yet certified the election results. "An initiative position for a change in law is effective 30 days after the state election in which the petition was approved. Furthermore, this 30-day period does not commence until this election has been duly certified," Senate Counsel James DiTullio and House Counsel James Kennedy wrote.

DiZoglio, a former Methuen State Representative has butted heads with State House leaders on her quest to open the legislative books. "Is anyone surprised that they want to procrastinate into the final hours before working to address this issue? Prolonging the inevitable does not serve the taxpayers and we have alerted the Attorney General that we intend to litigate this matter should they continue to balk at our meeting request beyond the certification date," DiZoglio wrote in a statement to the *Herald*.

DiZoglio has made a number of requests for legal action to Attorney General Andrea Campbell, requesting the two chambers comply with the voter mandated audit. Campbell claims she has no role to play until the law takes effect and a legal dispute emerges between both sides. Legal representatives for the House and Senate referenced the fact each chamber already undergoes a professional financial audit by outside firms with results posted on-line.

## **VARRO**

Marcus Terentius Varro, usually referred to as Varro, was born in the Sabine town of Reate, in 116 BC. He was educated in Rome, and later by at least one Greek philosopher from the Academy. He fought against Julius Caesar in Spain during the Civil War but was forced to surrender. He later obtained the forgiveness of Caesar, who employed him to superintend the collection and arrangement of a great library which was intended for public

Varro is said to be the most learned of Roman scholars, and the most voluminous of Roman authors. He wrote about 74 different works, numbering 620 on the subjects of oratory, history, jurisprudence, philosophy, geography, husbandry, and the seven liberal arts, which include: grammar, logic, rhetoric, geometry, arithmetic,

astronomy, music, and then added medicine and architecture. Of these 620 books, about 130 were written during the last 12 years of his life.

His writings included 24 books on Roman grammar, 41 books on political and religious institutions, a 15-book collection containing 700 short sketches on famous Greeks and Romans, and 9 books on the "liberal arts." Also included were 76 books on philosophy, and an undetermined number on geography, law, and poetry.

The 41 book series on political and religious institutions was considered to be Varro's greatest work, and it is chiefly upon this group that his reputation was based. Unfortunately, only a few fragments are available today.

There is no question that Marcus Terentius Varro's vast and varied knowledge in every facet of literature earned him the title of "most learned of Roman scholar."

# **Diversity, Equity and Inclusion (DEI) Mandates Finally Ran its Course**

Diversity, Equity and Inclusion, or more commonly known as DEI, is on a downward spiral and is finally being exposed for one of the most toxic obsessions in American society. A recent report in New York Times magazine found that the University of Michigan's decade-long, \$250 million dollar experiment in DEI has been a total failure. The Times notes, "students and faculty members reported a less positive campus climate than at the program's start and less of a sense of belonging. Students were less likely to interact with people of a different race or religion or with different politics."

A number of companies have been pulling back from the abyss, including Walmart with their announcement that it will stop using the term "diversity, equity, and inclusion" and end DEIrelated initiatives. Look for this trend to continue across American cities and towns given the newly elected Trump administration is a sworn enemy of DEI. This experiment has been tried, has failed miserably, and is a matter of time before it is permanently cancelled once and for all.

# Are Bike Lanes Really Worth the Investment?

The City of Boston has heavily invested in bike lanes throughout the city, with plans to expand the bike share network, implement new corridors and redesign major streets to install new bike lanes in specific neighborhoods. Boston Mayor Michelle Wu is a huge proponent of cycling as a mode of transportation, even biking daily to city hall while she was an at-large city councilor. Her administration has spent millions installing new bike lanes throughout Boston and is planning to spend much more in the future. Many residents are questioning if the benefit outweighs the cost, especially given the current budget shortfall arising from the decreased commercial property values and vacant office space.

Residents from various neighborhood groups, including the North End and Back Bay have complained that newly added

bike lanes have created a traffic disaster and safety concerns instead of improving accessibility. Meg Mainzer-Cohen, President of the Back Bay Association submitted an e mail to The Boston Transportation Department explaining that "traffic congestion is driving customers away from restaurants and preventing the community from functioning at times. There's a lack of predictability with traffic signaling that is causing safety concerns for pedestrians." Even facing community pushback, the city has refused to change their plans or consider community feedback and is expected to expand its bike network over the next few years with approximately \$17 million dollars set aside for a citywide "Better Bike Project" in the capital budget.



# L'Anno Bello: A Year in Italian Folklore

Down Through the Chimney with Good Saint Nick!

The Christmas season, that most wonderful time of the year, is fully upon us! I feel its merriment whenever I take a sip of spicy eggnog, its velvety texture warming me inside with the taste of the holidays. The week before Advent, my husband and I decorated our home for Christmas, setting up our small tree and placing an evergreen wreath on our door. The twinkling lights of these adornments shine through even the darkest midwinter night, while the greenery reminds me that the cycle of life rolls on despite the blustery cold of the season. Christmas carols, ubiquitous on the radio now, compose the soundtrack of my days now, filling them with the sounds of jingle bells. However, the most inescapable symbol of secular Christmas celebrations remains the jolly man in the North Pole himself — Santa Claus! Santa Claus appears everywhere nowadays, from thrones in shopping malls to television ads, from cookie faces to household decorations. Sometimes, Santa Claus manifests as the elegant Father Christmas — a seriousfaced man clad in long, intricate robes, holding a staff. More often, however, he is a rotund, merry-faced man with a bushy white beard and a red suit, a bag bursting with gifts slung around his shoulder. Though Santa Claus has become a prominent figure in Christmas commercialism, at his purest form he is a comforting symbol of the mirth, goodwill and kindness which characterize this season. This complex character even has his own holiday on December 6<sup>th</sup>, a day abounding with Christmas history!

The idea of Santa Claus may seem rather strange, even bizarre. Here is a man who predecessor, even boasts his lives in the North Pole, wears red, owns a toyshop run by elves, and hops aboard a sleigh to deliver presents to children

on Christmas Eve. Why is this figure so attached to the holiday season? Like most Christmas symbols, Santa Claus derives from both Christian and pagan roots. Some of his characteristics hearken back to the Norse god Odin, who led a wild hunt across the midwinter night sky on an eight-legged stallion. Children would leave carrots out overnight for Odin's horse, similar to the tradition of offering cookies and milk to Santa Claus. Elves also form a major part of Scandinavian folklore, where tales abound of magical creatures who are especially active during the Twelve Days of Christmas. Nevertheless, Santa Claus's most immediate ancestor is St. Nicholas of Myra, a fourth-century bishop hailing from Asia Minor, now modern-day Turkey. St. Nicholas became famous for his generosity, eventually serving as the patron saint of children. His association with gift-giving stems from a famous legend in which he secretly made gifts of gold to three sisters too poor to afford a dowry. The very name "Santa Claus" is a corruption of "St. Nicholas," hailing from Dutch settlers who brought the figure of Sinterklaas to America. In other countries, such as England, Santa Claus's name is "Father Christmas." This corresponds to his Italian moniker as well, as the jolly man is known as Babbo Natale — literally, "Father Christmas." Though the premiere gift-bringer in Italy remains La Befana, the kindly witch who circles the world on Epiphany Eve, Babbo Natale yields enormous presence there as well, and Italian children write letters to the merry, redsuited man.

St. Nicholas, Santa Claus's own feast day on the 6th of December. My grandmother hailed from the southern Italian city of Bari, which holds the

relics of the saint, and as such la Festa di San Nicola, or St. Nicholas's Day, endures as one of her most cherished holidays. She spoke very fondly of citywide celebrations on this day, replete with parades and processions, most centered around the Basilica di San Nicola. In other areas of Europe, St. Nicholas's Day functions as a quaint and charming precursor to Christmas, a day devoted to the happiness of children. Children in Germany, Hungary and the Czech Republic leave their shoes or boots on the windowsills during the eve of St. Nicholas's feast, only to find them filled with candy and trinkets in the morning. Polish children find small bags of candy tucked under their pillows, while their counterparts in France bake gingerbread and brioche to mark the holiday. My family honors St. Nicholas's Day with customs that awaken my inner child. My husband's parents bless and distribute candy canes on this day, sharing the joy of this nostalgic treat. I bake an eggnog cake for this feast. Silky and warm, studded with golden raisins and topped with a brown sugar streusel, this cake tastes like the Christmas festivities. As its scent fills the air, I become thankful for the pleasures of home and hearth that form the crux of holidays like St. Nicholas's Day.

Though the modern age seems bent on commercializing Santa Claus, we should pay attention to the true significance of this enigmatic and jovial figure. A combination of Christian and pagan roots, Santa Claus celebrates the values of compassion and kindness. The feast day of his predecessor St. Nicholas honors children and is imbued with the optimism and generosity that characterizes the Christmas season. While it may seem far too easy to impatiently wait for Christmas's arrival, St. Nicholas's Day serves as a welcome reminder that the whole Advent period brims with unique and special holidays that reveal the various facets of Christmas. During the holidays this year, let us make a pact to face life with the same sense of magic and wonder that typifies Santa Claus, or Father Christmas, or Babbo Natale. When we look at Christmas with joyous, childlike eyes, we can finally enjoy the true magnanimous spirit of the holidays, making our souls as bright as Santa Claus's smile!

# Italian American Long-Distance Runners Excel

The college cross country running season just concluded in late November, in Madison, Wisconsin. Some 250 of the very best distance runners in U.S. colleges came together to compete for the ultimate prize of All-American status, given to the top forty finishers in all the land. Two couriers of Italian American background

achieved such lofty status: Marco Langon, of Villanova by way of Raritan, NJ, and Matt Strangio of the University of Portland, by way of Folsom, CA. Langon finished in 15th place overall while Strangio was only a few places behind him at #22. Two other Italian Americans raced well but did not earn All American honors: Leo Young, #63 and twin brother Lex at #92, both running for Stanford.

The Championship meet culminated an arduous season in which there seemed to be fewer Italo-American standouts than usual. However, in the penultimate round, the Regionals held in various geographic regions, the above runners performed extremely well gaining honors. Strangio was 2nd in the West Regional out of 210 runners. Langon was 2nd in the Mid-Atlantic region, out of 192 runners. Langon was joined in the regional honors group by Brian Di Cola, of Penn State U. who finished sharply to achieve 4th place while Strangio was joined by Lex Young who finished 10th in the West region.

## Granny Goes on Stab Spree

An angry inebriated grandma has been arrested in Tennessee for allegedly stabbing her daughter and grandson with a kitchen knife during a Thanksgiving Day altercation. The grandmother had been drinking before she screamed and grabbed a knife, charging at her daughter for pushing her grandson. Grandma sliced the victim's left hand and then stabbed her own grandson, too.

### U.S. Sends More Weapons to Ukraine

The United States will be sending Ukraine another \$725 million in military hardware as Kyiv calls for more arms to fight the Russian offensive capabilities. Two U.S. officials talking about the aid package would not confirm if the new weapons shipment included rockets for the long-range system. It appears the Biden Administration is working to spend every dime of militaryassistance allotted by Congress, which passed earlier this year before the incoming Trump Administration arrives.

In a rebuke, the state's Commission on Judicial Conduct hit Joseph now assigned to Boston Municipal Court for violating the "Code of Judicial Conduct" by "failing to comply with the law." The commission will now decide what, if any, punishment she could face, up to losing

The incident that brought all this legal trouble up for the judge was her reported actions that allowed an illegal immigrant who came before her bench on April 2, 2018. She allowed the "deportable alien" to exit the Newton District Courthouse out a back door while two ICE agents were at the courthouse aimed with a detainer allowing the defendant to escape the clutches of the federal officers. Eventually, ICE did catch up with the escapee.

# Keep Holiday Greens Looking Their Best

Wreaths, door swags, garlands, and containers filled with evergreens have long been part of winter celebrations and displays. Keep them fresh and looking their best throughout the holidays with minimal effort.

Fresh greenery with pliable branches and firmly attached needles will last the longest. Check for good color and an aroma you prefer. Consider buying extra greenery and storing it in the garage or another cool location. Use these to replace any indoor greenery that is starting to brown.

Recut the bottom of the stems with a sharp bypass pruner. Totally submerge the greenery in a tub of room-temperature water overnight to help rehydrate the needles. Gently crush the cut end to allow it to better absorb moisture.

Remove the cuttings from the water and once dry, seal in the moisture by spraying the greens with an anti-transpirant, often called anti-desiccant. These products seal in moisture, reducing drying due to warm, dry air indoors and drying winds and sunlight outside.

Follow label directions for application tips and dilution rates based on what you are treating. Avoid using these on juniper berries, cedar, and blue spruce. The waxy coating that makes these look blue can be damaged by these products. Apply anti-desiccant products outdoors during the day, as light is needed to activate some of these chemicals. Allow the treated greens to dry for three to four hours before moving them inside.

Display indoor greenery in cool locations out of direct sunlight. This reduces moisture loss and extends the life of your garland, wreaths, and arrangements.


Keep greenery away from heat sources that speed drying, decorative lights that generate heat, and flames from candles. Check the greens every few days and replace dry, brittle, and brown cuttings with fresh greens.

Outdoor greenery lasts much longer when temperatures are cooler than indoors. Further, extend their longevity by placing them in more sheltered locations, out of direct sunlight and wind where they suffer less drying. Avoid hanging wreaths and swags in front of windows in direct sunlight where the reflected light can burn the foliage. Use an anti-transpirant on outdoor greenery to help reduce moisture loss and extend your enjoyment.

Keep outdoor planters of greens looking their best throughout the winter. Keep the soil moist until it freezes when displaying spruce tips, cut holiday trees, and evergreen stems in outdoor containers. If and when the ground freezes, you can stop watering.

A bit of effort goes a long way in extending the beauty of holiday greenery.

# Saint Felix of Valois

Felix was born at Valois, France in 1127. He was a member of the royal branch of Valois.

At an early age he renounced his possessions and retired to a dense forest in the Diocese of Meaux, where he gave himself to prayer and contemplation.

He was joined in his retreat by John of Matha, who proposed to him the project of founding an order for the redemption of captives. Felix and John set out for Rome and arrived there in the beginning of the pontificate of Innocent III. They had letters of recommendation from the Bishop of Paris, and the new Pope received them with kindness and lodged them. The project of founding the order was considered in several conclaves of cardinals and prelates, and the Pope after fervent prayer decided that these holv men were inspired by God, and raised up for the good of the Church. He confirmed their order, which he named the Order of the Holy Trinity for the Redemption of Captives. The Pope commissioned the Bishop of Paris and the Abbot of St. Victor to draw up for the institute a rule, which was confirmed by the Pope, December 17, 1198.

Felix returned to France to establish the order. He was received with great enthusiasm, and King Philip Augustus authorized the Institute. Twenty acres of the woods were donated where he erected the famous monastery of Cerfroi, the mother-house of the institute. Within forty years the order possessed six hundred monasteries in almost every part of the



world. Felix and John of Matha were forced to part, the latter went to Rome to found a house of the order, the church of which, Santa Maria in Navicella, still stands on the Caeclian Hill. Felix remained in France to look after the interests of the congregation. He founded a house in Paris attached to the church of St. Maturinus.

Felix passed away amongst his fellow Trinitarians at their motherhouse in Cerfroid on November 4, 1212. He was canonized on May 1, 1262 by Pope Urban IV. The Feast day of Saint Felix of Valois is November 20th.

### **William Caxton**

William Caxton was born at Kent, England in 1422. He went to London at the age of 16 to become an apprentice to a merchant, later moving to Bruges, the center of the wool trade, where he became a successful and important member of the merchant community. From 1462 to 1470 he served as governor of the English Nation of Merchant Adventurers, which allowed him to represent his fellow merchants, as well as act as a diplomat for the king.

Caxton affiliated himself with the household of Margaret, the duchess of Burgundy, sister of the English king Edward IV. She became one of his most important patrons.

In the early 1470s Caxton spent time in Cologne learning the art of printing. He returned to Bruges in 1472 where he and Colard Mansion, a Flemish calligrapher, set up a press. Caxton's own translation of *The Recuyell of the Histories of Troye* was the first book printed in the English language published in 1473.

In 1476, Caxton returned to London and established a press at Westminster, the first printing press in England. Amongst the books he printed were Chaucer's Canterbury Tales, Gower's Confession Amantis



and Malory's *Le Morte d'Arthur*. He printed more than 100 books in his lifetime, books which were known for their craftsmanship and careful editing. He was also the translator of many of the books he published, using his knowledge of French, Latin, and Dutch. He passed away in 1492.



A Nostalgic Remembrance



Well, December is here and it's time to prepare for Christmas. Christmas season was a lot different in the Christoforo and Contini households back in the day. My father and two of my mother's brothers, Uncle Nick and Uncle Paul Contini were professional musicians, and Christmas time was their busy season. When I was in my late teens, I joined the family business and made it three generations in a row. You see, Babbononno, my grandfather Mike Contini, started the tradition, but by the time I became a professional he had long retired from playing.

The way it started out for me was with an assumption. When I was a child, everyone assumed that I would become a musician like Babbononno, my uncles and Dad. This assumption began to take root when I was just a kid. Babbononno would sit me down in front of a music stand and teach me something called Solfeggio, the Italian method of rhythmic articulation in reading and understanding what written music was all about. When he felt I was ready, Dad tried interesting me in accordion. His presumption was that keyboard players always worked and even made more money than the other sidemen. I hated accordion. The next instrument was piano. I took a couple of lessons and hated that, too. Both Uncles Nick and Paul then stepped in and tried to teach me their instruments, soprano, alto, and tenor saxes, along with clarinet and flute. I hated them, too. Babbononno had played drums and guitar and gave me lessons on both. Again, I didn't bite.

These ill-fated attempts went on for years, and Dad reconciled himself to the fact that his son was going to play baseball until the first snowfall and then read Captain Marvel comic books and make model airplanes out of wood until the snow melted and it was baseball time again. When I started the 7th grade at the Joseph H. Barnes Junior High School, I decided to join the drum and bugle corps and take lessons on how to play the bugle. The teacher turned out to be a man named Ralph Fucillo, a trumpet player that Dad and my uncles had worked with over the years and knew well. Dad was happy and brought me to a music store, Harris and Fandel. I believe they had a branch store on Meridian Street near Central Square in East Boston. He bought me a Rexcraft bugle, the best that was available at the time. With a musician's discount, the price was a whopping \$17.00. (I still have the bugle)

Mr. Fucillo taught me how to play the instrument and I learned the required marches that we would play when marching with the school band. Next, I went to Sabo's, a men's store also located on Meridian Street near Central Square. There, I bought the required military uniform and shoulder patches that indicated I marched for the Barnes. The uniforms were the same as the U.S. Army wore back then, tan shirts,

pants, matching overseas caps, neckties and web belts. Nanna sowed on the patches and with my creased shirt, pants, and the rest of my uniform, I was ready to play my bugle.

The band marched in the Columbus Day Parade (East Boston or the North End), Feast Day parades, the School Boy Parade, and several others that we were asked to march in. At times, we even joined with the East Boston High School Drum and Bugle Corps to celebrate Veteran's Day, President's Day, Memorial Day and even the Fourth of July. If the Catholic churches in East Boston had parades and needed music, we played for them, too. I loved every minute of it. When I started high school, I joined the English High School Drum and Bugle Corps, but lasted only one year. At age 13, I lied about my age and began working at the Seville Theater. This job, combined with homework and baseball prevented me from continuing with music. Dad didn't want me to give it up and asked Mr. Fucillo to teach me how to play the trumpet. He borrowed a silver trumpet from a Mr. Joseph Trongone, the head of the music department for the Boston Public Schools, and I took the weekly lessons, but could never find the time to practice. The trumpet sat in my bedroom and began to collect dust from lack of use and Dad's hopes of his only son becoming a musician began to fade.

When I was in my last year of high school, I asked Dad to teach me how to play the bass violin, his main instrument. He started giving me lessons, but I got to the point where I lost interest. Reconciled to the fact that I preferred working at the Seville and hanging on a street corner in my spare time, the lessons ended. The interest returned when I started college, and the lessons resumed. One warm spring day during my second year of college, I was sitting on the front steps of our house at 74 Eutaw Street, and a friend, Johnny Magnasco, happened to walk by on the other side of the street with his bass violin over his shoulder. I asked his where he was going and he stopped to talk for a few minutes. He told me that he was selling his bass as he had joined the army. He added that he had been playing with another neighbor, guitarist, Bob Avola who had a small band that was popular around East Boston. He then suggested that I contact Bob and take his place seeing that I played bass and they would need a new bass player.

I took his advice and began rehearsing with the band which included Bob on guitar, Ronny Hughes on alto sax, Jimmy Pastore on trumpet and Bill Welch on drums. I knew them all as we lived within blocks of each other, and this time I didn't quit. My first job with them was in 1958, and I played successfully, either bass or bass guitar for the next 65 years. Over the years, I tried

everything from symphony to soul. Babbononno loved it when I played classical music as that and opera were his first loves. From that beginning, I worked my way up and worked with some of the greats in Boston, New York, and Los Angeles, playing both dance music for private functions and jazz at many of the long gone clubs that dotted all three of those cities and several others around the country. At the tail end of my career, I was working as part a piano and bass duo with the late Marty Goldman. We specialized in private cocktail parties playing the great American songbook that featured the music of Gershwin, Cole Porter, Duke Ellington, and many other talented American composers of good music.

When Marty passed away unexpectedly, I tried a couple of other pianists but it wasn't the same. I decided that maybe 65 years was enough and I went into semi retirement as a musician. By this point in time, Babbononno, Dad, Uncle Paul and Uncle Nick were all gone and I became a senior citizen. As some of you know, I combined this profession with teaching school and when I retired from the Boston Public Schools in 2003, I became a professor at three local colleges, maintaining those positions which I recently retired from. Considering my age, I now spend the winter months in Florida. I was successful enough to have put a trio together in the Delray Beach area, consisting of piano, guitar and bass guitar. We rehearse on a weekly basis but can't compete with the younger musicians, so it remains as just a rehearsal group. Considering last week's story and memories contained within this week's column, all I can do is

I don't think I have ever seen an Italian Christmas cookie tray that doesn't include the iconic glazed knots, ropes, and wreaths sprinkled with nonpareils. Whether Anginetti, Sweet Taralli, or Egg Biscuits, these cookies are all made with simple ingredients like eggs, sugar, and flour. The magic lies in the subtle differences of shape, texture (influenced by fats and dairy), and most importantly, the family tradition behind each unique recipe. My family made a variety of these and the recipe that follows is firm in texture, easy to create and can be made in the flavor (lemon, anise, almond or vanilla) of your preference!

# ITALIAN EGG BISCUITS

Biscotti all'uovo Italiani



## Dough

½ cup granulated sugar ¼ cup shortening or unsalted butter, softened

3 large eggs

1 ½ teaspoons lemon, vanilla, or anise extract

2 cups all-purpose flour
1 ½ teaspoons haking powder

 $1 \frac{1}{2}$  teaspoons baking powder 1/8 teaspoon salt

## Glaze

1 to 2 cups confectioners' sugar

2 to 4 tablespoons whole milk 1 teaspoon lemon, vanilla, almond or anise extract

Nonpareils or sprinkles to decorate

## Instructions

Line a baking sheet with parchment paper and preheat the oven to  $350^{\circ}$ F ( $175^{\circ}$ C).

In a large mixing bowl, cream together the granulated sugar and shortening (or butter) until fluffy.

Add the eggs and the chosen extract (lemon, vanilla, or anise), and continue beating.

Sift the flour, baking powder, and salt into the bowl, then mix until well combined.

Cover the dough and let it rest for 20 minutes. If the dough

Cover the dough and let it rest for 20 minutes. If the dough remains sticky after resting, add flour a teaspoon at a time until it becomes manageable.

Use a tablespoon-sized scoop to measure out portions of dough (about 21 to 22 pieces).

Shape each piece into ropes, braids, wreaths or other desired

shapes.

Place the shaped dough on the prepared baking sheet, leaving

space between each piece.

Bake for 10 to 15 minutes, or until the cookies are firm and the bottoms are golden.

Allow the cookies to cool completely before glazing.

## Prepare the Glaze


In a medium bowl, combine confectioners' sugar with milk and extract. Whisk until smooth, adding more milk or sugar as needed to achieve a slightly thick but spreadable consistency.

Dip the cooled cookies into the glaze or brush it on. Immediately sprinkle with nonpareils or sprinkles before the glaze sets.

# A Journey to Bucharest and Transylvania

The city of Bucharest certainly has much to offer; several walking tours will give the visitor the opportunity not only see the city with a guide and other visitors but also learn about historical aspects of Romania that puts the country's current milieu into perspective. But there's also another feature that brings tourists from far and wide — a facet of the Romanian historical narrative that is based in reality but is also fused with the imagination and the literary aptitude of Irish writer Bram Stoker.

One may be familiar with Stoker the writer who lived from 1847 until 1912, but it is certain that most everyone has heard of the character Dracula on which his gothic novel is based. Although Bram fashioned his epistolary story about Count Dracula through letters, periodicals, and other correspondences, the legend itself is purely fictional. Bram created the imaginary chronical — a tale nonetheless that is considered one of the most popular Gothic horror novels in English Literature.

I had the opportunity to visit Bran Castle, which is roughly 115 miles northwest from Bucharest in the county of Brasov, and positioned amid the Carpathian Mountains; and situated in the region of Transylvania — yes folks, *that* Transylvania! Although once a part of the Hungarian Crown, this historical area is now under the jurisdiction of Romania. Due to the popularity of Bram's novel, this area, especially with the medieval Bran Castle (ironically no correlation with Stoker's most celebrated work) has become the destination of many a visitor.

Readers and certainly tourists could very well make the connection of the castle to that of *Dracula*'s protagonist (actually one of several in the book) solicitor Jonathan Harker, who journeys to Transylvania

on business and visits the castle in all its unnerving and peculiar appearance. What he discovers is as eerie and alarming as one could imagine. Harker learns that Count Dracula is a vampire. He also has the unfortunate misfortune of having forced to fend off some contemptable and nefarious vampires and flee for his safety. And in discerning what capabilities Harker unearths comprising the traits of Dracula, one thing is certain, and that is the Count possesses a supernatural nature — along with some very unusual preferences!

The day of my journey to Bran Castle (named after a village called Bran, which is located within the jurisdiction of Transylvania) could have been described as forbidding. This is because of the relatively clear weather during the trip to Brasov; however, as we got closer to Bran Castle, the atmospheric conditions changed. The sky darkened and then after touring the castle and venturing back outside the medieval citadel the rains came. One might say that this put those visiting that day in a suitably daunting mood.

The castle, or fortress is what one might expect given the expectations of what a castle constructed in the fourteenth century (and completed in 1388 AD) would look like. The building is located on a precipice, and containing about 55 rooms along with towers, dense walls, objects from the medieval period, and like many similar structures built during



this era, is surrounded by a courtyard. Truly a vestige from the feudal world!

But why the connection to Vlad the Impaler? What was the relationship of Vlad III, one of history's most infamous rulers to that of Bram Stoker's *Dracula?* 

Stoker did not base his 1897 Dracula novel on Vlad the Impaler; however, imagination and legend assuredly contributed to how people made a connection with both; a link that today remains in popular culture.

And it was most likely that the severe reputation of Vlad III (born c.1431) who ruled Wallachia, a Principality comprising the southern geographic region of Romania where Bucharest is situated was responsible for this correlation. Vlad III was known as a fierce warrior fighting the Ottomans and Saxons; and his moniker was the result due to his severe treatment of his enemies — many of whom meet their fate through impalement on stakes.

Vlad III despite being known for his massacres, is nevertheless regarded as a hero in Romania's history.

Indubitably, it was the aggressive warfare of Vlad III which contributes to the plausible connection with the Dracula legend. It is also without a question that the name Dracul has added a quixotic dimension to the overall story. A little background on this prominent title held by one of history's most extreme potentates is in order.

Vlad III was also known as Vlad Tapes, or the "Voivode of Wallachia" (Bucharest's setting;) but he also belonged to the House of Drăculești and this was due to his father Vlad II being a member of the Order of the Dragon (a chivalric movement comprised of nobility devoted in part to the military objectives of the crusades.) And since Vlad II was Vlad III's son, he was sometimes referred to as Son of the Dragon, or Vlad Dracul — hence the designation.

As Voivode of Wallachia, Vlad's official capacity is also comparable to a warlord or military leader — the term being common in the Eastern European expanse. Interestingly, Vlad III did not rule over Transylvania, although he was born there, as was his father. However, because of his family association with this enticing region, and given Vlad

III's reputation, it is easy to conjure up images of a shadowy stronghold which shelters a mysterious figure — a figure with a shocking inclination — a figure that subsists on the blood of others — namely Dracula, who resides in Bran Castle.

Alas, not to spoil a good story, a trip to the library or book store might be in order to learn some more about this fascinating character.

The castle itself has become, overtime, more of a residence than a castle — at least in the medieval sense. Actually, in the early part of the twentieth century, Bran Castle, was transformed into summer lodging for royalty (from 1881 until 1947, when King Michael relinquished his power, Romania was considered a Kingdom.) Queen consort of Romania, Maria (b.1875 and married to King Ferdinand I) was responsible for its makeover. When Maria died in 1938, her daughter Princess Illeana utilized the property for a hospital during the Second World War. However, during the following years, the castle was taken by the communist government. But, during the early years of the 21 century, the property was returned to the royal family and is overseen by the children of Princess Ileana: her son Archduke Dominic and his sisters: Archduchess Maria Magdalena and Archduchess Elisabeth.

The Queen Consort refurbished the myriad of rooms in a comfortable and modern style; dining area, bedrooms and living quarters among other rooms (including a secret passageway connecting the first and third levels only discovered about 100 years ago!)

Maria had chosen the furnishings herself.

As one walks throughout the building one has the opportunity to not only observe the royal fixtures and informative labels identifying what the various objects are but to encounter how it must have felt living in such accommodations — and realizing that the edifice itself has seen countless occurrences during its well over half a millennia timeframe.

#### Dub Jones, Cleveland Browns and His Six Touchdown Game

Recently, Dub Jones, an All-Pro flanker and running back for the Cleveland Browns championship teams of the late '40s and '50s, and one of four NFL players to score six touchdowns in a single game, has passed away at 99 years old.

On November 25, 1951, Jones scored four touchdowns running from scrimmage and two on passes from future Hall of Fame quarterback Otto Graham in the Browns' 42-21 rout of the Chicago Bears. He played on the Browns' NFL championships in 1950, 1954, and 1955. At six-foot-four and 200 pounds, he was a tall target. He retired after the 1955 season, having run 2,210 yards, amassed 2,874 yards in pass receptions and escorted 41 touchdowns in 10 pro seasons. Jones returned to the Browns as an offensive coach and oversaw the development of future Hall of Famers Jim Brown, Leroy Kelly and Paul Warfield.




# Joe Louis and His Opponents Sparring in Preparation to Face One Another

The City of Boston and the State of Massachusetts declared Sunday, December 1st "Boston Bruins Centennial Day."

Chapman is believed to be one of MLB's hardest throwing pitchers, is a seven-time All-Star, was American League Reliever of the Year in 2019, and has won two World Series (Chicago Cubs in 2016, Texas Rangers in 2023). Hopefully the Red Sox will now focus on putting a Red Sox Cap on the head of Juan Soto!!!
