Reflecting on the Fifth Anniversary of COVID-19 (Lessons, Loss and Change)

March 2025 marks five years since the world, our country and our personal lives were upended by the COVID-19 pandemic. What began as an outbreak a continent away, quickly became a global crisis, leading to widespread lockdowns, economic turmoil, and an immense loss of life. The virus changed the way we live, work and interact. As we remember this anniversary, we should reflect on the lessons learned, the resilience shown and the newly paved path forward.

There is no denying the COVID-19 pandemic was unlike anything in modern history. At its peak, millions were infected, hospitals were overwhelmed, and economies suffered. Lockdowns and social distancing measures defined our daily lives, forcing businesses, schools and communities to adapt to an almost all

Mayor Wu Announces \$10 Million Affordable Housing Investment

Mayor Michele Wu recently announced that the city has invested \$10 million in federal funds toward converting 347 market-rate units to affordable apartments and has acquired The Fairlawn Estates, a collection of 12 apartment buildings in Mattapan. That investment along with private investments would bring 347 affordable units on to the market.

The mayor said she was proud of the way the city acted in restoring Fairlawn as affordable housing and added how over the past number of years due to rent hikes, many who resided there were forced out of Fairlawn, out of Mattapan and out of the City of Boston.

Market Plunges as Trump Takes Economy on a Wild Ride

Earlier this week, the Dow Jones, NASDAQ and the S&P 500 all tumbled sharply a day after President Trump declined to rule out the possibility of a potential recession as he slapped tariffs on America's three leading trading partners.

Latest news from Ontario, Premier Doug Ford of Canada's largest province has just instituted retaliatory measures (25 percent surcharge on U.S. imports). The three largest states most impacted by the 25 percent surcharge will be New York, Michigan and Minnesota. Ford stated, "We will not back down ... we need to end the tariffs and ... the chaos once and for all."

CBS Push on 60 Minutes

CBS Network has urged the FCC to reject a complaint over a 60 Minutes interview with then Vice President Kamala Harris, saying the agency has no lawful role in policing broadcast news editorial decisions. A complaint alleges the interview violates the FCC rules on "news distortion."

Governor Healey May Hold Back Money Over MBTA Zoning Law

(Do as I Say, Not as I Do)

Massachusetts Governor Maura Healey "cannot commit" to not withholding grants from communities fighting the controversial MBTA Communities Act, requiring 177 municipalities across Greater Boston to have at least one zoning district where multifamily housing is permitted as of right. Approximately 120 cities and towns are now compliant. A number of municipalities have filed lawsuits against the Healey administration in opposition.

In a recent state budget hearing, attention was brought to the fact that Marshfield has lost access to a \$261,000 grant to dredge the North River, which also impacts Scituate, Norwell, Hanover, Pembroke and Rockland. When the Governor was asked if her administration would stop withholding previous committed state funding, the Governor refused to back down, stating "No, I cannot commit that. I think the lawsuit is without legal merit. It will be

left for the courts to decide." Healey has rescinded a \$73,000 grant for student mental needs in Middleboro and is refusing to sign a \$2.8 million MassWorks contract for commercial development infrastructure, according to town officials.

The Governor said her administration has "provided technical assistance to communities to help them work through some of this. We've said it's


SUETONIUS, MARCELLINUS, and CLAUDIAN

This is the last issue in the entire series honoring the Latin literati. Last week we briefly examined the work of Florus, Gaius, and Apuleius, the first three greats in the Age known as the Late Empire. Today we honor the three remaining scholars.

It is probable that **SUETONIUS** was born in Rome about 69 A.D. into an equestrian family. There is very little information about his early life except that he started his career as a lawyer, and shortly thereafter became a private secretary to Emperor Hadrian (magister epistolarum). Suetonius was a scholarly man with comparable tastes and habits. He wrote in Greek as well as in Latin. His biographical works include The Lives of the Caesars; also brief accounts of illustrious men in literature, writings on famous courtesans and on many kings. He also wrote, on Roman antiquity, their manners, customs, feasts, clothing, and public office. Additionally, his work included the reckoning of time, nature, bodily defects, and grammar. Considering all of his writings, the lives of the Caesars (Vitae Duodecim Caesarum) has come down to us in more complete form than any other of his works. Although it overflows with scandalous anecdotes, this is the publication which gave him universal recognition. It is certainly the most celebrated today, and also the most authentic reference source for anyone who wants to write an X-rated movie.

AMMIANUS MARCEL-LINUS was born in Syria of Greek parents, was educated in Rome, served in the Roman Legions, and retired about 390 A.D.

He wrote a history of the Roman Empire in 31 books which covered the period of time from Emperor Nerva in 96 A.D., to Valens in 378 A.D. Marcellinus followed the writing style of Tacitus, and although he was a heathen, he was fair in his assessment of the Christians. Latin was not

his native tongue, therefore his expression was crude and clumsy, however, he is considered to be the last Roman historian of any worthwhile importance.

CLAUDIUS CLAUDIANUS, known to us as Claudian, was born in Alexandra, moved to Rome in 395 A.D., and soon became famous. He was familiar with Greek and Latin literature, was poetically gifted, and was a master of language and meter. Most of his poems were written in praise of the Emperor Honorius, and of the notorious General Stilicho. In spite of their flattery, the poems have an important historical value. His work is of high quality and reflects important historical matter. The best work of Claudian is said to be Raptus Proserpinae (Rape of Proserpine). He also wrote epistles, epic, and miscellaneous poetry, and is considered to be the last important poet of this later Empire.

Boston's Trust Act

to Undergo an Audit by the Boston City Council

The Boston City Council held a hearing this past Monday, regarding the implementation and effectiveness of the *Trust Act*, a 2024 law that is under Federal scrutiny due to the city's sanctuary status. The Committee on Public Safety and Criminal Justice is planning to audit the implementation, enforcement, administrative compliance, and impact of the law that limits the city's cooperation with federal immigration enforcement.

"While across the country policies such as Boston's Trust Act come under attack, our office is choosing to seize this moment as an opportunity to demonstrate how the *Trust Act* has made Boston a safer more unified city. Not only that, but we want to identify the ways in which we can STRENGTHEN this act to ensure that we create a reality where immigrants can occupy ALL spaces and places without fear or hesitation,"

wrote the sponsor of the hearing, Councilor Julia Mejia.

This past December, councilors unanimously reaffirmed the *Trust Act* which prohibits Boston Police and other city departments from cooperating with ICE on civil immigration detainers. The law was enacted in 2014 and amended in 2019 to allow for cooperation in criminal matters like human trafficking, child exploitation, drugs, weapons trafficking and cybercrimes. Mayor Wu feels the *Trust Act* has made Boston a safer city, while others believe it is a violation of federal law.

Wu testified last week in Washington D.C. before a Congressional Committee on Oversight and Government Reform regarding sanctuary policies and the impacts on public safety. The mayor was peppered with questions with a few Republican lawmakers suggesting she should face federal charges by the Department of

Justice and possibly criminal prosecution.

The council's audit hearing will look at data collection, reporting mechanisms, and departmental compliance. According to the hearing order, Councilors will also check on whether "city personnel and funding are being used appropriately within the scope of municipal authority and not diverted to civil immigration enforcement. It has now been ten years since the passage of the Boston Trust Act, presenting an opportunity to review compliance and legislative intent in light of the realities of 2025, particularly as undocumented residents face heightened concerns and uncertainty.'

Boston's sanctuary city status also has the federal Small Business Association (SBA) moving out of its Causeway Street office and relocating to an area that complies with federal immigration law.

Bike Lanes in Doubt

Whether it's due to community pushback or her challenger's vocal opposition, City of Boston Mayor Michelle Wu is pausing installation of bike lanes amidst a 30-day review of all street changes made by her administration, including infrastructure changes from the last three years, with a focus on re-evaluating bus and bike lanes that may have negatively impacted city roads.

The point of the review is to hear from the community and assess how each bus/bike lane is functioning and identify changes that need to be made. "The goal is to make adjustments to projects

that improve functioning of roadways for all users without compromising core safety goals. We will prioritize quick changes."

Wu's decision to review bike lanes just happens to coincide with her mayoral opponent, Josh Kraft, statement that if elected he would pause all new bike lane construction. "As city wide bike infrastructure has been built out piece by piece across the last decade, our administration has had the responsibility to finish several critical links in the network to make them fully usable and safe. Many of these projects have been implemented

successfully, others have not," stated Wu in a recent memo.

The review will consider alternate proposals that the city could turn to, should a street or roadway change be found ineffective, or whether future work to fix inefficiencies can be completed with existing resources or require paid contractors. The cost for changes to replace prior city reconfiguration along with original city work and payment will be part of the review.

As of November 2024, the city built 15 miles of new protected bike lanes at approximately \$150,000 per mile or \$2,25 million dollars.

Trump's Tariffs Aiding U.S. Toy Factories

Toy makers with U.S. manufacturing facilities are overwhelmed with orders in response to President Trump's recently imposed tariffs on China and Mexico imports. MGA entertainment parent company of Bratz, LOL Surprise Dolls and Little Tykes brand manufactures toys at their Hudson, Ohio factory and will need to hire more employees to fulfill the orders of toy companies hoping to avoid the newly imposed tariffs, 20% on goods made in China and 25% on Mexico and Canadian products, resulting in a large demand toward a small group of toy manufacturers in the U.S. including 3-D printing farms that have the ability to make products domestically and for companies that traditionally manufacture oversees.

Paul Young, owner of PYE Games, operates 560 3D printers that can produce small toys in mass production, hung a "Made in the USA" banner at the New York City toy fair last week, declaring

No tariffs for U.S. made products. Simplay 3, a company that make outdoor equipment, such as sandboxes, slides and playhouses at their factory in Streetsboro, Ohio is also hiring more workers to add to its 24/7 shift operation as a result of their deal to make educational toys for a company that had previously been manufacturing oversees. "I think we'll have more business as the tariff issue ramps up," said Brian McDonald, vice-president of sales and marketing.

While the costs to produce these items will increase because U.S. labor is more expensive, starting pay in Ohio is \$17 and in China the pay is \$3 to \$4 dollars per hour. However, the cost should be offset by excluding the higher cost of shipping from China. It's not entirely a wash, the retail price may increase slightly, but it can save 4-5 weeks of transportation time and no upfront deposit on shipping.

English as the Official U.S. Language

President Donald Trump signed an Executive Order (EO) making English our official language, repealing a previous EO signed by President Clinton, which required the government, along with groups receiving federal funds, to provide language assistance to non-English speakers. A large amount of bilingualism already exists in the U.S. due to the high levels of immigration from Spanish speaking countries possibly rendering this EO more ceremonial rather than truly effective.

Still the EO is an important symbolic statement. "A nationally designated language is at the core of a unified and cohesive society, and the U.S. is strengthened by a citizenry that can freely exchange ideas in one shared language," the EO reads. The communications director for the Pro-Immigration group *United We Dream*

stated "Trump is trying to send the message that if you're not white, rich and speak English, you don't belong here. Let me be clear, immigrants are here to stay. No matter how hard Trump tries, he can't erase us."

It is believed that approximately half of the immigrants in the U.S. may be proficient English speakers. Anyone living in the U.S., not speaking or learning English is limiting themselves from educational, social and economic opportunities. Perhaps English language ability should be a criteria for a merit-based immigration system.

Presently about 1.5 billion people speak English, with approximately 400 million of those speaking it as their first language. The English language is omni-present and it's long overdue for the U.S. government to give it the respects it deserves.

L'Anno Bello: A Year in Italian Folklore

Saints of the Changing Seasons

Hello, spring! I can feel the shifting of Mother Earth all around me, humming with the thrill of rebirth. The signs of spring manifest everywhere. They are present in the sound of gurgling water as melting snow rushes down the storm drain. They are evident in the delicate white crocuses I recently saw lining the front path of someone's home. They appear in the candy-colored Easter eggs and grinning cloth bunnies that fill the seasonal departments of big-box stores. Though the weather may still oscillate between balmy temperatures and wintry cold spells - perhaps even nor'easters! - spring fever nevertheless grips my mind with all the energy of a hopping red-breasted robin. After the chilly and dark days of winter, the song of spring profoundly reverberates in our soul. The reawakening of nature and the growth of vegetation mimics the renewed energy and cheer blossoming in all living creatures. The calendar has tapped into this sense of rejuvenation and grants us two folkloric feasts that welcome spring and its accompanying beauty and promise. March 17th bursts with green to herald St. Patrick's Day. Two days later arrives St. Joseph's Day, a holiday honoring Italian heritage and commemorating one of the country's most beloved saints. Jointly, these two feasts celebrate the joy of spring and usher us into a season of hope and renewal.

Every year, I eagerly anticipate St. Patrick's Day. This holiday shines like a heacon of spring, an undeniable seasonal turning point. The very decorations of St. Patrick's Day overflow with spring imagery, from the lush green shamrocks to the rainbows which melt into pots of gold. St. Patrick's Day holds a special significance in Boston, due to our city's love of festivities and its large Irish-American population. I celebrate most holidays with symbolic food, and St. Patrick's Day proves no exception. I bake a creamy Irish soda bread studded with plump raisins and zesty caraway seeds. The bread is accompanied by a fresh spring greens salad laden with earthy beets, tangy goat cheese, and sweet caramelized pecans. Meanwhile, my fatherin-law goes the traditional route and makes an Irish boiled dinner replete with potatoes, carrots, turnips and parsnips. Sometimes he will whip up a batch of Guinness stout brownies to end the meal. These seasonal foods encourage me to live in the present, patiently waiting for and then reveling in the unhurried edible treasures of the Earth. However, there is much more to St. Patrick's Day than food. This feast day honors St. Patrick, or San Patrizio in Italian, a Roman-British man first brought to Ireland as an enslaved person. The most well-known legend concerning St. Patrick states that the patron saint of Ireland used a shamrock to teach people about the Holy Trinity, thus establishing this little spring plant as an enduring symbol of the holiday. St. Patrick's Day reminds me of brisk spring days when the forest appears lush and green after a rain shower, and a gossamer rainbow arches across the sky. This is a decidedly spring holiday, and as such forever lives in people's hearts for its sense of joy and hope.

Two days later, on March 19th, arrives another feast of spring that holds enormous significance for my family. It is

di San Giuseppe in Italian. My father lovingly remembered breezy St. Joseph's Day celebrations in his mountainous hometown of Sulmona in the Abruzzo region of Italy, where the tender tree buds and the baying of lambs whispered the coming of spring. St. Joseph's Day serves as Father's Day in Italy, reflecting on the role of San Giuseppe as the husband of the Virgin Mary and the stepfather of Jesus. In Sicily and other regions of Italy, including many Italian-American communities, people build altars to St. Joseph loaded with bread, candles, pastries and fava beans. Fava beans form an integral part of St. Joseph's Day festivities because, during the Middle Ages, this spring crop saved the inhabitants of Sicily from a famine after they prayed to St. Joseph for help. Another delightful Italian tradition involves doing charitable actions and donating food on St. Joseph's Day, a philosophy which should be carried throughout the year. My father spent the days before this holiday scouring the woods with his friends, searching for firewood to help construct il faló di San Giuseppe, a giant bonfire held on the eve of the feast. These bonfires, with their abundant warmth and light that illuminates the inky night sky, symbolize the sun on its journey from winter to spring. Sometimes, people will throw an effigy into the bonfire to represent making a fresh start for spring. Of course, St. Joseph's Day has also become synonymous with zeppole, or fried, puffy donuts. My father loved his zeppole sweet and stuffed with cream, like the ones he would buy from bakeries in the North End around St. Joseph's Day. Meanwhile, my grandmother preferred savory zeppole made with potato. Either way, they are delicious. All of these sweet treats remind me of a holiday that instills in me a pride in my heritage and gets me excited for As two quaint and folkloristic

holidays approach us, we can revel in our anticipation for spring. After all, spring is not just a season; it is a resplendent manifestation of renewal, hope and optimism for the future. The greenery of St. Patrick's Day and the warm bonfires of St. Joseph's Day symbolize the essence of the spring season, calling to mind rites of purification and regrowth. Whether we admire the first crocuses and daffodils, take in the birdsong of the early morning, or enjoy Irish soda bread or zeppole, there are a myriad number of ways to greet the rebirth of nature. The most important thing is that we fill our season with love and optimism, always looking ahead. "The MBTA Go mobile app for Android users is one more step in our quest to give customers what they need to get where they are going. Tools like MBTA Go help the public make decisions about their trips, giving them more control over their travel decisions."

"We're pleased to now offer a companion MBTA Go app

for Android users," said MBTA General Manager and CEO Phillip Eng. "Riders deserve quality and accurate real-time information to plan their journeys, and this app is just one more component of our wider effort to continuously improve communications. MBTA Go is a great, free mobile tool for riders to plan their travels, and we hope the public continues to let us know of new features they'd like to see that can make the app even better. Public feedback continues to be critical as we develop rider-centered tools that improve the customer experience like MBTA Go."

MBTA Go assists riders as they navigate their trips with features that include:

- Get real-time updates, including estimated train/ bus arrival times, live tracking as vehicles approach a stop, and estimated time to rider's destination
- View a user-friendly MBTA map that allows riders to click to see available services and transfers at each stop and

- Find out if there is a closure on your route with clear alerts and map indicators
- Access in eight languages: English, Spanish, Simplified Chinese, Traditional Chinese, Portuguese, Haitian Creole, Vietnamese, and French

MBTA Go has been downloaded by more than 57,000 users. The MBTA's Technology Innovation Department expects to share app version updates approximately every four-tosix weeks with new features. MassGOP Monthly Update ...

Back in February, the Democratic supermajority and the Healey-Driscoll Administration chose to further the migrant crisis. By voting to pass this supplemental budget without meaningful reform, Governor Healey and the Democratic supermajority have doubled down on wasteful spending, ignored public safety concerns, and disrespected hardworking taxpayers — all to appease the most extreme factions of their

New North End Community Center Construction Update ...

It was standing room only at last week's North End Community Center Construction meeting with all age groups represented. The center is set to be built adjacent to the Mirabella Pool on Commercial Street, abutting the Coast Guard Base, with the main entrance on Commercial Street. The current Nazzaro Center footprint on North Bennet Street is 28,000 square feet while the new community center will be a fourstory building, ADA compliant with an elevator, approximately 50,000 to 54,000 square feet of space, and comes with an estimated price tag of \$65 million dollars. City of Boston officials provided the group a thorough overview of the proposed plan and construction timeline and impacts.

The current schematic design stands at 50% and is slated to offer a variety of programming for youth, teens, elderly, an after-school program, studio fitness, cardio, yoga, a weight room, arts and crafts, flexible space and a full-size gymnasium. The team is still tweaking the overall project and adjustments may still be made and considered.

A major area of concern was the proposed pool renovation. New mechanical equipment and pipes will be installed along with brand new changing rooms. The city draft design calls for a zero-entry pool area in combination with a family & lap pool component, although all plans are still preliminary. However, the new design offers a smaller multi- purpose pool compared to what presently exists. The community was very vocal in their concern and disappointment in this proposal. While they are thrilled that the pool will receive improvements, they definitely do not want the size of the pool to decrease, and they made it known.


State Representative Aaron Michlewitz noted that this was the first time he had heard the pool details, as it hasn't been part of past discussions. He suggested finalizing the community center details first, then regrouping and addressing

the pool renovation. The city representatives reiterated nothing is set in stone. Construction on the project is tentatively slated to begin in fall of 2025, with an estimated completion date of Spring, 2028. The pool would be out of commission and unavailable to the community for two summers, 2026 and 2027.

Any renovations and reprogramming of the current Nazzaro Community Center will be addressed as an entirely different project, possibly in the fall of 2025. The city will continue to communicate with the community concerning the new community center and pool and will hold a follow up meeting in late spring or early summer to address resident's concerns.



If you need help kneeling, consider a garden kneeler with handles. The handles provide needed support when kneeling and standing up. The ones that can be flipped over and used as a garden bench provide double the benefit. The seating position reduces bending and helps minimize the need to kneel.

Elevating your garden can also help. It is a great way to save space and eliminate the need to bend when planting, weeding, and harvesting. Elevated gardens and raised beds also offer a place to garden where planting space is limited or nonexistent. You'll enjoy planting and harvesting with minimal weeding needed. Just be sure to monitor soil moisture and water as needed. Use selfwatering containers, add irrigation or employ water-extending products to help lengthen the time between watering.

Further expand planting options by dressing up walls, fences, and more with vertical gardens. Monitor soil moisture in wall-mounted gardens regularly as many have limited soil that dries out quickly.

Clean and sharpen your tools, including pruning equipment, digging and weeding tools. This allows you to make cuts more easily and dig into the soil and weed with less effort.

Consider investing in ergonomic tools designed for comfort to help prolong your time in the garden. Select lightweight tools with non-slip comfortable grip handles aligned to keep your wrist extension straight, which helps reduce muscle

Use pruners with ratcheting, compound, or Dual Link action for more cutting power with less effort. You'll be able to spend more time pruning with less muscle strain and fatigue. Consider investing in shovels with an anti-skid plate above the blade, providing more foot support for more digging power. Or retrofit an existing shovel with a commercially available anti-skid foot plate.

Don't overlook the importance of protecting your hands as well when gardening. Quality gardening gloves provide support and protection when digging, planting, pruning, and more.

Start with some preseason training. Every gardener knows gardening is a workout and often involves different motions and muscles than other exercises. Always warm up your muscles and do a bit of stretching before getting out in the garden.

Enlist the help of wheeled carts and wagons to move plants, mulch, soil, and other heavy loads. Don't be afraid to break heavy loads into smaller batches or ask for help. You'll spare your muscles and probably save time in the long run.

Wear a pair of safety glasses to protect your eyes and don't forget the sunscreen. Take frequent breaks and drink plenty of water.

Preseason planning and preparation can help reduce muscle strain as the garden season begins. You'll boost your enjoyment and be able to garden longer.

Frederick Law Olmsted



Frederick Law Olmsted was an American landscape architect, journalist, social critic, and public administrator. He is considered to be the father of landscape architecture in the United States.

Frederick Law Olmsted was born in Hartford, Connecticut, on April 26, 1822. His father, John Olmsted, was a successful businessman who took a lively interest in nature, people, and places. Frederick Law and his younger brother, John Hull Olmsted, also showed this interest. His mother, Charlotte Law Olmsted, passed away before his fourth birthday in 1826.

His father remarried in 1827 to Mary Ann

Bull, who shared her husband's love of nature. Their children were Charlotte, Mary, Owen, Bertha, Ada, and Albert Olmsted. The Olmsted ancestors arrived in the early 1600s from Essex, England.

When Frederick was almost ready to enter Yale College a Sumac poisoning weakened his eyes, so he abandoned college plans. After working as an apprentice seaman, merchant, and journalist, he settled on a 125-acre farm in January 1848 on the south shore of Staten Island, and he renamed it from Akerly Homestead to Tosomock Farm.

On June 13, 1859, Olmsted married Mary Cleveland (Perkins) Olmsted, the widow of his brother John, who died in 1857. Daniel Fawcett Tiemann, the mayor of New York, officiated the wedding. Olmsted adopted Mary's three children and also had two children

Olmsted was famous for co-designing many well-known urban parks with his partner Calvert Vaux. Olmsted and Vaux's first project was Central Park in New York City, which led to many other urban park designs.

In 1883, Olmsted established the preeminent landscape architectural firm in the United States. They designed campuses and other projects throughout the United States and Canada. Together, these works totaled 355. He helped design some of the most famous parks in America including Central Park in New York, the Emerald Necklace series of connecting parks in Boston, and Yosemite

His landscape architecture and planning consultancy firm of the late 19th-century was carried on and expanded by his sons, Frederick Jr., and John C., under the name Olmsted Brothers.

In recognition of his services during the Civil War, Olmsted was elected a Third Class member of the Massachusetts Commandery of the Military Order of the Loyal Legion of the

United States on May 2, 1888.

In 1895, senility forced Olmsted to retire. By 1898, he moved to Belmont, Massachusetts, and took up residence as a patient at the McLean Hospital, for whose grounds he had submitted a design which was never executed. He remained there until he died in 1903.

A Nostalgic Remembrance



Ash Wednesday took place on March 5th. In the Christian religions, it is the beginning of Lent, the forty days before Easter. In the Catholic traditions, a celebration is held during the week that precedes Ash Wednesday. The French, Spanish, Portuguese and Italian cultures go overboard making merry before the solemn days that follow. The French call the festivities, Mardi Gras, the Spanish and Portuguese, Carnival, and the Italians Carnivale. The celebrations are party time for the folks who participate, and in the past, I have been one of those folks experiencing the festivities in cities like New Orleans, Rio de Janeiro, Caracas, Venezuela, San Juan, Puerto Rico, and as a musician, Boston. MA

The famous New York restaurant, Mamma Leone's opened in Boston back in December 1972, on the first floor of a parking garage located above the Mass Pike, just off Copley Square. After the Leone family sold the original restaurant located in New York's theater district, the corporation that bought it decided to expand and Boston was one of the locations. Just before lent in the early spring of 1973, the management decided to offer Carnivale entertainment at the Boston restaurant and called Uncle Nick, who at that point in time, was the vice president of the musicians' union in Boston. They wanted four small bands to stroll among the tables of diners during the week that preceded Lent. My uncle put the whole thing together due to a business meeting with the executives of the Boston operation. He then called for a meeting at his office with the 20 musicians who would be part of the 4 bands and everything was laid out in detail.

Uncle Nick, himself would lead the first band of 5 who would be dressed like chefs: checkered pants, white shirts, white aprons, and tall white chef's hats. The other three bands would be dressed with black pants, white shirts, red white and green sashes around our waists and caps with Italian flags on the front. I was to lead a novelty band. It included an accordionist, a musician playing washboard, Dad playing washtub bass and yours truly playing kazoo and a toy friscaletto, a plastic flute with a push pull handle that gave the instrument its tones. Another band would be led by a guitar player and a fourth by a violinist. Each of the bands would feature Italian music ranging from excerpts from opera (only Italian, of course) to Neapolitan street songs. We were to stroll in consecutive order at given intervals and serenade the diners while they ate. We began about a week before Ash Wednesday and things worked out rather well. There were a couple of changes made to instrumentation and personnel, but nothing

As part of the contract, we were to be fed, seeing that most of the playing surrounded the late afternoon-early

evening hours. Uncle Nick made arrangements with the management that a lower-level room be set up as a dressing room with tables in place for a buffet-style dinner. When we were on our breaks, we could choose what we wanted for dinner and help ourselves. Each afternoon, the buffet table was set up for us with everything from antipasti, pasta courses, meat and fish courses, vegetables, salads and an assortment of Italian pastries. An urn of coffee and an assortment of sodas accompanied the food. Uncle Nick was happy with this type of treatment partly because this wasn't often the case and partly because we were being paid a very handsome sum, way over union scale.

There was one problem, though. The food was awful. Although it was Italian in appearance the taste left a lot to be desired. After the second day of employment, we all complained to Uncle Nick. He hadn't tried anything except the coffee. On the third night, after listening to everyone in the bands complain, he sampled the dinner offerings. My band was on a break at the same time that he sampled the food and I could tell by the look on his face that he was in agreement with us ... bad tasting food.

That evening, after the restaurant closed to the public, Uncle Nick had a meeting with the management. They wanted more entertainment and he agreed to provide it. He also mentioned the food which they assured him was the same as they were serving to the public. When I drove my uncle home, he told me about his meeting and their reaction to his comments about the food. He didn't want to push the issue in fear that he would insult them. After listening to my uncle detail their responses, I came up with a possible solution. He liked my idea and decided to present it to the head chef. The next day, when we arrived at the restaurant, he told the head chef that the food was too heavy for the musicians and they couldn't perform as well as they should. He asked if they could eliminate the pasta, meat and fish dishes and substitute cold cuts and sliced bread instead. He explained it that way, adding that the bands could make sandwiches and partake of the already served salads which might be better on their stomachs when they performed. Phrased that way, the kitchen staff was more than happy to accommodate us especially after Uncle Nick slipped the head chef a twenty-dollar bill.

That night, some friends arrived at the restaurant to partake of the food and Carnivale entertainment. Most of them complained to me before they left. They loved the entertainment and hated the food. He thanked them assuring them that it would continue for the forth coming last week of the Carnival season. They then asked him why he had requested a change of menu for the musicians. As diplomatically as he could, he tried to tell them about the complaints surrounding their food. The head man gave my uncle every excuse he could about how large the portions were and how well the waiters served each course. He decided not to push the issue as the man didn't seem like the type who could handle constructive criticism very well. On the way home that night, we talked about the complaints my friends had and he added in that several of his friends who had eaten at the restaurant had the same complaints. The verdict was in ... the food was not good.

Well, we finished performing on the Tuesday night before Ash Wednesday and the job came to an end. After that week, they had Uncle Nick book a small group to stroll during the weekend dinner hours, but that was short lived. Mamma Leone's went out of business. I guess the New York corporate executives couldn't run a good Italian restaurant in Boston. Thank God for the many places in the North End like La Summa, Lucia's and Filippo's, etc. ...

The rich tradition of Zeppole di San Giuseppe traces back to the ancient Kingdom of Naples, with its origins often attributed to religious communities such as the nuns of San Gregorio Armeno, Croce di Lucca, and dello Splendore. The first recorded recipe appeared in 1837, written by Neapolitan culinary expert Ippolito Cavalcanti. Puglia and Campania have long embraced this beloved pastry, each adding distinct regional touches to their preparation. Beyond these regions, zeppole are a fixed element of the celebrations of San Giuseppe and Father's Day in Calabria, Sicily and across much of Southern Italy.

Growing up, in my family, St. Joseph's Day was never complete without *zeppole* and as I grew older, it remained the same. Every March 19th my mother would arrive at my door, pastry box in hand, making sure we each had one of these golden, custard-filled delights to enjoy in honor of *San Giuseppe. Buona festa di San Giuseppe!*

ZEPPOLE di SAN GIUSEPPE al FORNO Baked St. Joseph's Zeppole



Crema Pasticcera (Pastry Cream)

4 egg yolks (80g or about 4 large yolks) 250g granulated sugar (1 ¼ cups) 500ml whole milk (2 cups) 100g all-purpose flour (¾ cup) Peel of 1 organic lemon 1 tsp pure vanilla extract ¼ tsp salt

In a large bowl, beat egg yolks and sugar until pale and creamy. Add milk and sift in flour, mixing until smooth. Add lemon peel and transfer to a medium saucepan over medium heat. Stir constantly until the mixture thickens. Remove from heat. Discard the lemon peel, then stir in vanilla extract and salt. Transfer to a bowl, cover with plastic wrap (press against the surface to prevent a skin from forming), and cool. Refrigerate if making ahead.

Zeppole Shells

250ml water (1 cup) 200g unsalted butter (14 tbsp) 5g salt (1 tsp) 250g all-purpose flour (2 cups) 6 large or 7 medium eggs

Preheat the oven to 400°F (200°C). Line a baking sheet with parchment paper.

In a large saucepan, heat water, butter, and salt until boiling. Add flour all at once, stirring vigorously until the dough forms a ball and pulls away from the sides. Remove from heat and let cool slightly. Add eggs one at a time, mixing well after each addition until smooth. Transfer the dough into a piping bag fitted with a star tip. Pipe 3-inch circles (two layers high) onto the prepared baking sheet. Bake for 20–25 minutes or until golden brown. Let cool completely on the baking sheet.

Assembling the Zeppole

Prepared Crema Pasticcera Confectioners' sugar, for dusting

Jar of Amarena cherries (2–3 per zeppole)

Fill a piping bag with Crema Pasticcera (use a star tip). Slice each zeppole in half horizontally and pipe cream inside. Pipe another swirl of cream on top of the zeppole. Dust with confectioners' sugar and top with 2–3 Amarena cherries. Serve immediately or refrigerate until ready to serve.



Yankees starter Gerrit Cole will be undergoing diagnostic testing on his right elbow according to a report this past Sunday. The report further states that the ace has been recommended to have the surgery. The 2023 AL Cy Young Award winner had imaging on his elbow last week after getting tagged for six runs and five hits during that spring training game. Cole told reporters that he felt good during that game but he got more and more sore after the game ended. The six-time All-Star missed the start of last season because of nerve irritation and edema in his right elbow. Then went 8-5 with a 3.14 ERA in 17 starts. He went 1-0 with a 2.17 ERA in five postseason games. Cole signed a \$324 million, 9-year contract before the 2020 season and opted out of the four years and \$144 million remaining this winter. After the Yankees refused to add an extra season and \$36 million to the pact, Cole agreed to stay a Yankee on

the finest skills when it came to not getting hit. He was the master of the parry and feinting. In a record encompassing 76 fights over 34 years Jack was stopped just six times. It should be remembered that of those six stoppages, five were either at the beginning or end of his career, his first stoppage coming in just his fourth fight.

On February 25, 1901, in only his eleventh fight he was

HOOPS and HOCKEY in the HUB

DID BRAD MARCHAND REALLY WANT TO BE A **BRUIN?** — If you really examine the official transcript of the March 7th press conference that Bruins GM Don Sweeney had with reporters, it shed a bit of light on what transpired in the days leading up to the transaction that saw the Bruins captain dealt to the Florida Panthers.

Many feel that the Bruins simply traded away their captain. But that simply is not true. Marchand had an offer but chose to decline it.

How else to interpret Sweeney's comments when he was asked what it finally came down to.

External forces apparently played a large role in what Sweeney called a "time gap." That could refer to the then impending trade deadline of March 7th and the thus external pressure to complete a deal by that time with duration of contract and amount of salary determined. Whatever those were, in the end, the ball (or in this case, the puck) was in the possession of Marchand and his representatives.

The Bruins offer apparently did not measure up following extensive negotiations and thus they chose not to accept it.

The Bruins desired a settled situation by the deadline and when it did not happen they took the step of dealing Marchand away, since he would be a free agent as of June 30th and thus eligible to sign with any team.

Could Brad Marchand still have been a Bruin as you read this? Of course. All he had to do was to sign the offer provided to him by the B's and he would have continued to play in Boston and be the captain of the team.

He chose not to do that. Thus, it was his decision to not sign up again that set in motion what eventually played out. If Brad Marchand had really, really wanted to remain with the Bruins all he had to do is sign his renewal contract.

He didn't. And when he returned to Boston on March 11th as a member of the Panthers, he talked about the possibility of moving his family to Florida. One wonders if all of this is worth leaving friends, neighbors and teammates — plus having children leave schools they are familiar with and all the friends they have grown up with.

Marchand apparently is earning an average of \$7 million per season as his current eight-year deal comes to a close.

But, you see, there are social costs associated with such moves and they are not always for the best.

The Red Sox experienced this within the last few years when two top candidates for front office positions declined to be interviewed because they did not want to uproot their families.

All that glitters may not really be gold but may be tarnished in some ways by the social costs involved.

And yet, if Brad really wants to be a Bruin, there is still a way

he could be back on Causeway Street in the fall. His current contract expires on June 30th. Thus, come July 1st he will be free to negotiate with any of the 32 teams in the National Hockey League — including the Bruins.

Yes, that means if either Brad or the Bruins can manage to budge on their respective stances concerning the proposed contract, the B's captain could be headed north come summer.

Until June 30th, though, Florida now has the exclusive rights to negotiate with Marchand. If the two parties can reach a deal, Brad will become a Panther for a much longer period of time.

In addition, the price of the transaction on Florida's end appeared to be a bit low. It is a conditional draft pick which could turn into a first-round selection in a future year if Florida advances through the first two rounds of the 2025 playoffs or if Marchand plays in at least 50 percent of Florida's 2025 playoff games.

Florida GM Bill Zito was delighted to have Marchand aboard for the upcoming playoffs. "We think he has some more gas left in the tank," proclaimed Zito to NHL.com. "He is a dynamic player. He is multifaceted whether it is his skills, his speed, his hockey sense or his will to win. We are looking forward to adding him to the mix. I think he will fit

Sweeney did accommodate one of Marchand's requests to be traded to a top team. And thus the Bruins star wound up going to the Panthers, the defending Stanley Cup champions who seem poised to have a lengthy run in the 2025 playoffs.

They are also a current nemesis of the B's, having eliminated them in the first round of the 2023 playoffs after Boston had compiled an NHL record of 65 regular season victories.


Then in 2024, Florida banished the B's in the second round en route to their march to the Stanley Cup Championship.

And right now, the Panthers are positioned to earn a top berth in the Cup seedings, currently battling the Toronto Maple Leafs for the lead in the Eastern Conference.

In 2019 eighth-seeded


