### **Mayor Wu Under Federal Microscope**

Boston Mayor Michelle Wu was barely back to work after appearing in front of a congressional committee regarding "Boston's Trust Act and Sanctuary City Status" when she once again found herself under a federal microscope over the city's alleged antisemitism. President Donald Trump's Federal Task Force to Combat Antisemitism will be dropping by city hall to discuss Boston's alleged failure to protect Jewish students from unlawful discrimination.

Wu has been labeled one of the most progressive and liberal mayors in America and is quickly finding herself, and Boston, home to the fourth largest Jewish community in the U.S., to be one of the Trump administrations top targets, not an envious place to be given she is in the middle of a re-election campaign. "Too many elected officials chose not to stand up to a rising tide of antisemitism in our cities and campuses following the horrific events of October 7, 2023. Actions have consequences, inaction does too," U.S. Attorney General Pam Bondi said in a statement announcing the visit to Boston by the Federal antisemitism panel.

The task force plans to meet with city leaders, effected students, local law enforcement and community members in Boston, New York, Los Angeles and Chicago as it gathers information about alleged incidents and considers whether federal intervention is warranted. In Mayor Wu's defense, she did order Boston Police to arrest one hundred pro-Palestinian demonstrators last year who were encamped at Emerson College in Boylston Place Alley and was criticized by various liberal groups for doing so. "Boston has one of the most vibrant Jewish communities in America, a source of pride and strength for our city and our region, and we stand firmly against antisemitism," Wu's spokesperson stated.

The meetings with Wu and other city mayors were announced by the Department of Justice following the Department of Education's warning to various colleges and universities across the country, including Boston University, Emerson College, Harvard University, Tufts University, U Mass Amherst and Wellesley College, surrounding possible enforcement actions if they do not protect Jewish students on their campuses.

#### Most New Yorkers Support Civil Commitments for Mentally Ill Homeless

More than nine out of 10 NY voters (91 percent) think civil commitments for the mentally ill homeless are more compassionate than letting them live on the streets according to recent polling

#### Maserati EV Gassed Out of Market?

Stellantuis-owned Maserati cancelled plans for an electric version of its MC20 sports car because of expected poor demand. The MC20 Folgore had been due to debut later this year.

Launched in 2020, the 630-horsepower MC20 is made in Maserati's hometown of Modena, northern Italy, and has a starting price around \$262,000.

#### Does Pet Bonding Lower Depression and Stress?

According to a study by the American Psychiatric Association, nearly 69 percent of pet owners believe their animals help reduce stress and anxiety while 69 percent also view their pets as giving unconditional love, and 66 percent say their pets are a calming presence in their everyday lives. However, a newer study done at Trinity College suggests your pet could also negatively impact your mental health. In this study of more than 1,000 pet owners found that pet owners who feel insecure or anxious were reportedly more likely to experience depression.

# U.S. Department of Education on Chopping Block

Secretary of Education Linda McMahon announced massive layoffs within the department was the first step in accomplishing President Trump's goal of eliminating the agency, while declaring the cuts will not affect educational programs. "This is the President's mandate, his directive to me to clearly shut down the Department of Education (DOE). What we did today was to take the first step of eliminating what I think is bureaucratic bloat," said McMahon.

Currently, it's estimated that public school revenue exceeds \$18,000 per student per year, up from \$14,700 in 2013. Expenditures per pupil exceed \$15,000 a year. Overall, federal spending per pupil has doubled since the Education Department was established in 1979. Yet high school students' scores on math and reading have not moved. The National Assessment of Educational Progress (NAEP) Long-Term Trend Assessment, the largest national assessment of educational outcomes, shows almost no change in high school students' outcomes since the 1970s.

Whatever the Department of Education has been spending their money on doesn't seem to be working or in the best interest of its students. An increase in federal spending has supported a staff surge with school districts hiring large amounts of administrative positions and non-teaching administrative staff. As of 2010, teachers compromised only 50% of total school staff, down from 70.2% in past decades.

Having previously served in the first Trump administration as the head of the Small Business Administration (SBA), McMahon said the department is mindful of keeping good people at the DOE in place so as to not interrupt funding for educational programs. "We wanted to make sure that we kept all of the right people, the good people, to make sure that the outward-facing program, the grants, the appropriations that come from Congress, all of that are being met and none of that's going to fall through the cracks."

McMahon was dismissive of American Federation of Teachers President Randi Weingarten's statement that President Trump is planning on "getting rid of education and taking opportunities away from kids," instead declaring "President Trump is taking the bureaucracy out of education so that more money flows to the states. Better education is closest to the kids. We have to identify where the bloat is, because so many of the programs are really excellent. We need to make sure that the money goes to the states, and that's what the president has said all along, if we get rid of the bureaucracy, the states will get more."


# Schumer's U.S. Government Shutdown Averted

Hours before a partial shutdown of federal government agencies were set to take effect, the Senate passed a stop gag government funding bill last Friday evening. A handful of Senate Democrats, led by minority leader Chuck Schumer, (D-NY) joined Republicans in a 62-38 vote, to advance the House passed GOP plan to keep the government open through September, with ten Democrats voting in support. Every Republican, except Senator Paul Rand of Kentucky, voted in favor of the measure, along with Democratic Senators Dick Durbin of Illinois, Kirsten Gillibrand and Chuck Schumer of New York, John Fetterman of Pennsylvania, Maggie Hassan and Jeanne Shaheen of New Hampshire, Gary Peters of Michigan, Brian Schatz of Hawaii, Catherine Cortez Maso of Nevada and independent Senator Angus King of Maine

banding together to move the bill forward, before it was finally passed by the full senate 54-46.

The procedural vote only came to be when a young group of Democratic congressional members, in both chambers, pushed back against Schumer's opposition to the Republican agenda last week, only to change his mind the next day. Senate

#### **MYTHOLOGY**

Mythology may be defined as a collection of legends or fictitious stories of a race or nation. It's also the name given to the scientific study of such myths; the myth itself, of course, being a story relating to gods or heroes. Many myths are not entirely products of imagination; some of them are slightly related to fact. The fact could have been some natural phenomena from the past or even recurring events.

The Greeks seem to have been the most creative in the development of their myths. Their gods originally represented the powers of nature, while at the same time, each was limited to specific natural phenomena, such as fire, light, moon, war, love, rain, thunder, etc. Each of these were regarded as acts of specific gods, therefore a whole cycle of myths was developed. They believed that their gods were superhuman, but required the human necessities of life (food, drink, sleep, sex, etc.). It was also believed that they had the power over nature and humans, and that all good or evil came from them, consequently, their favor could be obtained by behavior which was pleasing to them, and lost by behavior which was displeasing. Although they had normal moral weaknesses, they also possessed immortality. Ancient writers connected all of the Greek gods by creating a complete family line which was presided over by Zeus.

To the ancient Romans, the gods remained as impersonal natural forces, and these gods did little to earn the affection of



the people or to challenge their

imagination. The gods were favored but not loved; worshiped as a duty to the state in the same spirit as they paid their taxes. In addition to the gods of the sea, earth, sky, and lower world, they also had gods of thievery, lust, typhoid fever, etc. They even erected a great number of temples to various personifications or representations such as Concord, Honor, Valor, Fidelity, Modesty, Hope, and Intelligence. During later years, their association with the Greeks made possible a systematic study of Greek mythology and its genealogy. It was then that close likenesses were identified; such as Zeus with Jupiter; Hera with Juno; Ares with Mars; Athena with Minerva, etc. During the coming weeks it will be my pleasure to present thumbnail sketches of many mythical gods and goddesses, according to one of the most simplified genealogies that my research can produce.




MassDOT to Host Second Public Informational Meeting on **Tobin Bridge Long-Term Strategic Planning Study**

The session will be recorded and, along with the presentation materials, will be posted on the study's website.



During the meeting, the study team will present a review of existing conditions and discuss future conditions, which informs the development of alternatives.

# **Richmond Street Bridge Construction Update**

A public meeting was held last week at the Nazzaro Community Center to discuss the Richmond Street Bridge Preservation project in the North End neighborhood of Boston. The meeting was sponsored by the MassDOT. Moderating the meeting were Dan Fielding from the MassDOT Office of Legislative Affairs, the North End's own John Romano also from the MassDOT Office of Legislative Affairs along with Nick Foley of J.F. White Construction, superintendent of the project. The meeting was very informative and well run.

No disrespect intended but for those unsure of where the Richmond Street Bridge may be located, it is the piece of roadway and sidewalk on Richmond Street between Fulton Street and North Street. It abuts the dog park and sits over the Callahan Tunnel entrance, Route 1A Northbound. The purpose of the meeting was to provide the public with an opportunity to become fully acquainted with the proposed project and construction schedule, impacts on parking and pedestrian access. Questions from residents and abutters in attendance were encouraged and the answers provided were quite helpful.

Construction is slated to begin in late April and run through mid-July. The first six weeks, Stage 1, will run from mid- May to late June will see full vehicular detour of Richmond Street, all parking will be restricted on Richmond Street from North Street to Fulton Street. Pedestrian access will be maintained on one sidewalk, along with exit access from the North End Rehabilitation and Healthcare Center as well as maintaining access to RUFF Dog Park.

Stage 2 will last approximately four weeks, from Late June through mid-July. Richmond Street will remain open to vehicular traffic, pedestrian access will be maintained on one sidewalk and parking will be restricted on Richmond Street from North to Fulton Street.

Underside work will take place for twelve weeks, five days per week all overnights 9:00 p.m. -5:00 a.m., with single lane closure on Route 1A, Sunday - Thursday. Topside Stage 1 work will last approximately six weeks, five days per week 7:00 a.m. - 7:00 p.m. Richmond Street will be closed to through traffic, vehicles will be detoured with approximately thirty parking spaces lost.

Topside Stage 2 will run four weeks, five days per week, 7:00 a.m. - 7:00 p.m., resulting in the loss of approximately thirteen parking spaces. Pest, dust, and noise control plans will be implemented by the contractor, J.F. White. Active dust monitoring will occur.

Access to the Rehabilitation and Healthcare Center, RUFF Dog Park and pedestrian across the bridge will be maintained throughout all stages of the project. Please reach out to Daniel. Fielding@dot.state.ma.us with any questions.

#### **Price of Parking** in Boston Reaches All-time High

It's no secret that the price of parking in Boston has steadily increased over the years, but nothing can compare to the cost of a garage parking space on Beacon Hill. For a mere \$750,000 a coveted spot in the Brimmer Street neighborhood can be yours.

The valet parking space, at the Brimmer Street Garage, has been listed with Cabot & Company real estate agency for a three quarter of a milliondollar price tag. Previous spaces have sold for over \$550,000 in the same garage.

"Parking in Beacon Hill is one of the most coveted commodities in the Boston real estate market, and Brimmer Street Garage represents the gold standard. Opportunities to purchase a deeded space in this garage are incredibly rare,

making this listing an extraordinary investment for both convenience and long-term value. Having this parking spot is very valuable. There really aren't other options for people on Beacon Hill who are spending millions on homes with no parking," said Rene Rodriguez, listing agent at Cabot & Company.

In 1979 the garage was converted into condominium making the 151 parking spaces within the garage deeded pieces of property that can be bought and sold. When the garage was initially converted spaces were being sold for \$7,500 and now neighbors are paying upwards of \$500,000 for spaces.

Many of the spaces never make it to the open market and are instead sold privately. In this case, a pair of brothers inherited the parking space and have opted to list it on the open market. The process is similar to purchasing any other piece of real estate with the sale officially recorded at the Suffolk County Registry of Deeds.

The valet space comes with a number of premium services, including refueling, car washing and other concierge requests. The garage also extends guest parking flexibility. Owners may allow anyone to utilize their unoccupied space at no charge, and additional guest parking is available, subject to a fee and based upon availability.

Oversized vehicles, including trucks of any size and light pick up vehicles are prohibited from being parked in the garage due to size and weight capacity limits of the elevators and parking constraints on the first floor.

The first order of business at the recent NEWRA meeting resulted in a slightly different report than usual. Without a doubt the North End/ Waterfront is one of, if not the safest neighborhoods in the City of Boston, However there were a couple of unusual items reported by BPD Community Service Officer Frank Ciampa, including a break in of a nail salon on Commercial Street, a stolen vehicle in the area of Commercial & Richmond Street, a report of a female who felt threatened in the area of Salem and Prince Street, and a report of a large group of youth, on pedal bikes, disrupting traffic around the Lewis Wharf/Commercial Street vicinity. Although they are not typical incidents that commonly occur in the neighborhood, it's always wise to remain vigilant about your surroundings, not leave cash or valuables in the open, be extra careful about locking up vehicles and always

Also, in attendance was Corean Reynolds, Director of Nightlife Economy for the City of Boston. The focus of this agency is to strengthen the quality of life and focus on first responders and other parts of the overnight work force that keep the city running while the rest of us sleep. # Boston City Council Designates City as Sanctuary for LGBTQ Community

In light of the recent executive orders signed by President Trump declaring the federal government would only recognize two sexes, male and female, banning transgender people from the military and barring trans women and girls from participating in women's sports at both K-12 schools and colleges, the city council passed a resolution 12-1, recognizing Bostonas a sanctuary city for the LGBTQ community. Although the measure is not legally binding, it serves as a declaration offering protection for transgender and gender diverse individuals. "We're living in unprecedented times, with incredible escalation in anti-trans rhetoric and violence," said Liz Breadon, the resolution co-sponsor and first openly gay woman to sit on the council.

"Boston will not cooperate with federal or state policies that harm transgender and gender-diverse people, and remains committed to ensuring their access to healthcare, housing, education, and employment without fear and discrimination. Taxpayer-funded agencies shall not comply with federal efforts to strip resources that safeguard their rights," the resolution states.

Councilor Julia Mejia, the resolution co-sponsor noted that Boston is already under fire from Congress and the federal government over the Trust Act, which bars city police and other departments from cooperating with federal authorities on civil immigration detainers. "I understand and respect that in many cases, elected officials pass symbolic resolutions and leave it at that, but I believe this resolution is just a first step," said Mejia. Councilor Henry Santana made it clear that he only voted in favor of the measure because of the future plans to craft an ordinance "and to actually come up with legal language and protections for the most marginalized communities, which includes our trans residents."

Councilor Ed Flynn was the sole vote in opposition to the resolution, citing a request for the definition of what a sanctuary city declaration for transgender people would mean for Boston. "I would like to learn more about what this resolution does as it relates to sanctuary cities, the Trust Act, what impact it has on city services, what role the city departments will play. I don't want to be disrespectful to anybody, but it's something I would like to have before I vote.'

The **Snow-White** movie premiere has quickly become a nightmare as Disney attempts to deal with backlash over the gutting of this classic feature.

There will be none of the typical fan-fare and red-carpet interview for the film's premier screening in Hollywood, most likely to avoid questions that Disney executives are too embarrassed to face. The star of the movie, Rachel Zegler of the recent West Side Story remake has been very vocal of her distaste of Donald Trump and his supporters, as well as the plot of the original 1937 Snow White Disney classic. "There's big focus on her love story with a guy who literally stalks her, so we didn't do it this

It's that type of attitude that has enraged the family of the original animator. "The original was the way it should be. It must have Walt Disney asking 'What have you done'," said David Hale Hand, son of the original animator and supervising director, David Hand.

One question many people are asking is "where are the seven dwarfs?" Early public relations advertisements depicting seven average people of varying sizes and genders in place of the traditional seven dwarfs including strong pushback from actor Jason Acuna, known as "Wee Man" in the *Jackass* franchise, slamming the studio saying, "You're replacing jobs that people could have as little people. It's for dwarfs. Why are you hiring Snow White and the seven average people"?

Actor Peter Dinklage, who has achondroplasia, a form of dwarfism, was annoyed that the movie seemed hypocritical in i'ts woke efforts. "They are very proud to cast a Latina actress as Snow White, but you're still telling the Story of **Snow White** and the Seven Dwarfs. Take a step back and look at what you're doing," Dinkler stated.

As cultural thinking has evolved in recent months, Disney seems to be rethinking some of their earlier DEI choices, but sadly it will not come in time to save this iconic classic.

In particular, I think of the gardens that are now beginning to take form, the first tender crops sprouting from the damp, dark soil. My father, like many Italians, loved to garden and took great pride in reaping the gifts that the Earth provided. He did not bequeath me a green thumb, but he did instill in me an appreciation for all that grows and all that originates from the natural world. In the springtime, early garden plants often take the form of delicate herbs. I love cooking with herbs, as their pungent aroma wafts through my kitchen and their sharp taste provides a kick to the recipe. However, I discovered that herbs all come with their own unique folklore and superstitions. In honor of the spring and the rebirth of vegetation, let us dive into the traditional lore of some of our favorite herbs.

Basil: Basil, or basilico, is one of the best-known herbs of Italian cooking. It forms the crux of pesto, that delectable sauce hailing from the region of Genoa, typically made with crushed pesto, pine nuts and olive oil. In Italy, basil further symbolizes love, and in olden days a girl looking for a romantic partner announced her intentions by placing a pot of basil on her windowsill! However, this fragrant herb also holds a sinister side. People in the Middle Ages thought it gave birth to scorpions. Some scholars speculate that the word "basil" shares the same root as "basilisk," a spooky legendary creature that had the body of a snake and the head of a rooster and could kill its prey with just a glance!

Lavender: I always thought of lavender as a pretty flower that bloomed in spring and summer, but it is actually used as a culinary herb as well! Honey made from bees that sip on lavender nectar is prized in the Mediterranean world. Lavender also forms the basis of many herbal teas. People use dried lavender buds to flavor breads, scones and chocolate, while candied lavender flowers make sweet cake decorations. In Italy, lavender is called lavandula. It was so prized in ancient Rome that it cost as much as a farmer's monthly wages! Its name derives from the Latin word lavare, or wash, because lavender was used to perfume laundry and baths.

Parsley: Parsley is known as prezzemolo in Italian. It was once scattered atop caskets to ensure that funeral mourners would always remember the dead. The herb known as rosmarino in Italian also formed part of medieval brides' wedding bouquets, and as such became a token of love. Folklore also attributes rosemary with the power to repel the evil eye and frighten away malicious spirits.

Sage: I am in love with the classic Italian combination of savory pumpkin and sage, or salvia. You might say that whoever thought of this delectable flavor profile was wise indeed, and you would be right! The herb sage is associated with wisdom, which is why we call intelligent people sages. Supposedly, bringing a pot of flowering sage indoors invites bad luck, so people would make sure to pick sage before it bloomed. A girl who picks sage on St. Mark's Day (April 25<sup>th</sup>) or Midsummer (June 24<sup>th</sup>) will dream of her future spouse, while eating sage in May promoted longevity.

Thyme: Thyme, or timo in Italian, is a popular herb with which to season soups, stews and pastas. It also tastes wonderful mixed with lemon. This little herb carried a load of significance in the ancient world. The ancient Greeks burned thyme in their temples, believing that its aroma would imbue people with courage. In ancient Rome, it was used to purify rooms. By the Middle Ages, thyme had become synonymous with preventing nightmares and, when given as a gift,

For those too young, Rev. Martin Luther King Jr. was assassinated on

April 4, 1968. I was 19 years old at the time. He was in Georgia helping to lend his voice to a city sanitation strike by workers. He was killed standing on a hotel balcony on that day. Violence erupts following that event across the nation. The following night James Brown was scheduled to do a concert date at Boston Garden the following evening. Brown was thinking of cancelling that show but both Boston City Councilor Tom Atkins and newly sworn-in Mayor Keven H. White were concerned about the show getting cancelled and eventually persuaded Brown to keep the show on in hopes of lowering tensions across Boston itself. The show went on as scheduled Some 16,000 showed up to hear it live and WGBH Channel 2 broadcast the concert live on TV too While other cities saw massive violence, Boston stayed calm and much of the credit was given to this James Brown concert and the leadership of folks like Atkins and White.

This concert dating back to 1968 played a pivotal role in calming tensions and unrest during a very turbulent moment in Boston history. As Tony Wilson says, "We want to continue to honor not just the music played inside Boston Garden but the input James Brown had on Boston and the nation."

As I stated above I was still only 19 and one month shy of my 20th birthday. I still very much remember that 1968 concert packed full with screaming young people cheering on the music of The Godfather of Soul and I remembered watching the concert live on WGBH Channel 2 in Boston. Our city stayed calm and forced us all to stand together during a time of great uncertainty. We still live in uncertainty today and we can't go back to the past, but over at Prince Hall in Grove Hall on April 5th we can come together listening to Tony Wilson bringing the electricity back into both Grove Hall and our very spirits too.

# **Everett City Council Votes** "No Confidence" in **Mayor Carlos DeMaria**

Everett's mayor, Carlos DeMaria, holding a tight rein on the top office for the past 17 years, has been accused of improperly pocketing \$180,000 in bonuses and attempting to hide it. The Everett City Council unanimously voted "No Confidence" last Monday evening through a resolution stating DeMaria has violated state ethics laws.

The Office of Inspector General received a hotline tip regarding DeMaria's bonuses back in 2022. According to the independent state organization, Mayor DeMaria should only have been paid \$40,000 in longevity payments between 2016 and 2021 but it's alleged that he has received closer to \$220,000.

The Everett City Council is demanding DeMaria repay \$180,000 in alleged overpaid bonuses he may have received over a five-year period. Inspector General Jefrey Shapiro is pointing responsibility at Everett's chief financial officer for allegedly burying the payments in the budget to keep city councilors from noticing.

Mayor DeMaria was not present at the council meeting vote, but issued a statement through his attorney that he will not return the money until he receives "due process" and an opportunity to challenge the findings. "On March 4th, the City Council referred multiple resolutions to my administration. I am in receipt of those resolutions and will be working with members of Everett's city government to present recommendations that address the resolution in a manner that prioritizes the best interest of the city of Everett," said DeMaria in a statement.

The council believes the mayor should step down because public trust has been broken. A vote to use \$150,000 to proceed with an independent audit of city spending dating back to 2016 was also passed by the council. Despite the vote of "No Confidence," DeMaria promised to continue working for the people of Everett. "Even If I have to do it on my own, I will continue fighting alongside you to make our city a better place to live, work, and raise a family," DeMaria said in a statement.

# 35 Years Later: The Unsolved Mystery of the Isabella Stewart Gardner Museum Heist

On March 18, 1990, in the early hours after the St. Patrick's Day celebrations ended two men dressed as Boston police officers talked their way into the Isabella Stewart Gardner Museum, leaving approximately eighty-one minutes later with thirteen irreplaceable works of art, including pieces by Rembrandt, Vermeer, Degas and Manet. Thirty-five years later, the theft remains the world's largest unsolved art heist, valued at an estimated five hundred million dollars.

At approximately 1:24 a.m., two men approached the museum's side entrance and informed the security guard on duty that they were responding to a disturbance. Upon gaining entrance, the thieves



overpowered the guards and bound them with duct tape. The thieves then moved stealthily through the museum cutting priceless painting and works of art from their frames, before

disappearing into the night. The frames of the missing painting still hang empty in the museum as a haunting reminder of the loss.

Despite a ten-million-dollar reward, the case remains unsolved. Over the years, numerous tips have been reported, leads have been followed, and multiple persons of interest have been identified, but none have ever been formally charged. The museum the FBI and private investigators continue to chase leads, but the whereabouts of the stolen art remains unknown. As the 35th anniversary of the heist approached and passed, authorities remain hopeful that the renewed attention and public interest will reignite efforts to recover the missing art. The Isabella Stewart Gardner Museum is keeping the faith that these painting may still be intact somewhere and that one day these masterpieces will return to their rightful place.



# Grow an Abundant Harvest of Peppers this Season

Grow a few peppers in containers alone or mix them with herbs and flowers. A 2-to-3-gallon pot is perfect for a pepper plant and its smaller companions. Check the soil moisture daily and water thoroughly when the top inch of soil is dry. Make sure pepper plants growing in the ground receive about an inch of water each week. Supplement rainfall as needed, applying water to the soil surface using a watering wand, soaker hose or drip irrigation. Spread a layer of shredded leaves, evergreen needles or other organic material over the soil surface to conserve moisture, keep roots cool as temperatures soar, and help suppress weeds. Once the fruit forms, you may need to add fertilizer. Let the plants' growth and fertilizer directions be your guide. Peppers grow and produce best when day temperatures are 70 to 80 degrees and night temperatures are 60 to 70 degrees. Hot peppers seem to tolerate the

heat better than sweet varieties. Cold, heat, and drought are the most common causes of blossom drop, misshapen

You can jump start the season with the help of cloches, wall-owaters, and floating row covers. These protect your plants from frost and cooler temperatures, which are often common at the start of the season. Use them to keep plants warm and help shorten the time to harvest.

Plant peppers 18 to 20 inches apart depending on the variety. Check the tag for mature size and recommended spacing. Make the most of your available space by planting in wide rows. Stagger rows within the bed, allowing just enough room for plants to reach their full size. Design pathways to allow for easy access to all the plants within the wide row.

#### **Florence Nightingale**

Florence Nightingale was the second of two daughters born to William Edward and Frances Nightingale. (William Edward's original surname was Shore; he changed his name to Nightingale after inheriting his greatuncle's estate in 1815). After returning from Italy to England in 1821, the Nightingales had a comfortable lifestyle, dividing their time between two homes, Lea Hurst in Derbyshire, located in central England, and Embley Park in Hampshire, located in south-central England.



Florence Nightingale, the founder of modern nursing, was born in Florence, Italy, on May 12,1820, she was named of the city of her birth. Florence learned mathematics, language, philosophy and religion (all subjects that later influenced her work) from her father.

Florence from childhood loved God and the Bible. According to her, on the seventh of February 1837, while she was walking in a garden, she heard the voice of God, which was call her to a specific mission.

Florence in 1844 decided to work at the hospital but her parents were opposed to this idea. In July 1850, she went to Germany and France and worked as a volunteer in hospitals. Then in 1853, she returned to London and worked as a manager in the hospital that was called institute of the Sick Women.

In 1854, Britain, France and Turkey started a war with Russia known as the Crimean war. In September in one of the struggles in Alma, Russia was defeated but England had a lot of casualties. There was a lack of medical facilities and high mortality in British military camps. Sydney Herbert, the minister of war, was a friend of Florence; so, she took the advantage and in 1854 with 38 nurses went to a military camp of British soldiers, located on the outskirts of Constantinople. Florence noticed that health status in these camps was devastating. Injured soldiers were left on the floor and the few doctors desperately were trying to manage patients with basic facilities, in dirty environment. Florence used her mathematical knowledge, and recorded the mortality rate in the hospital. Statistics showed that in every thousand injured soldiers, six hundred were dying because of communicable and infectious diseases.

The Florence interventions were simple. She tried to provide a clean environment. She provided medical equipment, clean water and fruits. With this work the mortality rate decreased from 60% to 42% and then to 2.2%.

Florence was like a mother for soldiers. She visited patients' camps every night. Her great work attracted the attentions in England. She also used her fame and succeeded to attract the support of Queen Victoria, Prince Albert and Prime Minister Lord Palmerston. Florence asked them to have permission to do an official investigation of the military hospitals. The request was granted and the Royal Institute of research on the health of the military established. She was a great humanitarian and scientific figure. Nightingale was also a well-known statistician.

Florence in 1860 established Nightingale Nursing School as the first nursing school in the world. With the establishment of this school, she changed nursing to a respectful profession.

Florence Nightingale in the last years of her life was suffering from a disease, which she acquired during her service in Crimea. She wrote many books and reports, mostly in the field of nursing. One of these books, *Notes on Nursing* was published in 1860 that is the first book in nursing education. She insisted on the importance of building trusting relationships with patients. Nightingale believed that nurses' presence with a patient is a key stone for making a professional communication. Empathy with patients and making a common experience in moving toward health has been validated by Florence Nightingale. Florence services were the first efforts to relieve suffering during war. She passed away on August 13, 1910 at the age of ninety.

# Saint Winibald

Winibald's father was a West Saxon nobleman, Richard the Pilgrim and his mother was Wuna of Wessex. His brother was Willibald. With his father and brother he made a pilgrimage to Rome around the year 721. His father passed away in Rome, they fell ill, possibly with malaria, although it could have been the Black Plague. Once recovered, Willibald continued to the Holy Land, while Winibald, who from his childhood did not have a strong constitution, remained at Rome, to recover and study. In 730, Winibald returned to England and engaged a third brother and several amongst his kindred and acquaintance to accompany him in his journey back to Rome to begin a monastic life there.

Around 737, Boniface visited Rome. By this time Willibald had returned from his travels,



and had become a monk at Monte Cassino. Boniface recruited both nephews for the German mission. After Winibald was ordained, he was sent to Eichstätt. His uncle Boniface received a promise that, Winibald after his ordination, would go to Germany. Winibald arrived in Thuringia on November 30, 740. He was placed in charge of seven churches, including one at Erfurt.

Winibald established a monastery in Schwanfeld, but in 742 transferred it to Heidenheim, where the brothers founded a double monastery for the training of priests and as a center of learning. Winibald became the first abbot.

Winibald took part in the Concilium Germanicum in 742, and directed Frankish King Pepin's donation to Fulda in 753. In 762, he joined the League of Attigny, a confraternity of prayer established by Chrodegang, Archbishop of Metz. All this the saint accomplished in spite of continual illness, which prevented him from ending his life at Monte Cassino as he had hoped. Winibald passed away at Heidenheim on December 18, 761. The Feast day of Saint Winibald is December 18th.

# Three Glasses of Green Tea Daily Goes Along Way for Your Health

According to the National Institute of Health (NIH) an estimated 6.7 million people in the U.S. live with Alzheimer's dementia, with the possibility of this number increasing to almost 14 million over the upcoming decades. While socialization and mental stimulation are lifestyle choices that could lower your risk of dementia, other recent research suggests drinking green tea, especially three or more glasses each day, may dramatically lower your risk. A Japanese study found that older adults who regularly consume green tea have fewer cerebral white matter lesions, a prime cause of cognitive decline and dementia. Researchers asked 9,000 adults to fill out a questionnaire about their coffee and tea intake and then used brain scans to analyze their date. While there was no solid evidence that coffee intake

could prevent cognitive decline, their results did lead them to conclude that drinking green tea, especially three or more glasses a day, may help prevent dementia.

#### SALSA DE LA BAHIA VOL. 3: RENEGADE QUEENS - (2-CD) Patois Records

With the first two volumes of Salsa de la Bahia, arranger and trombone maestro Wayne Wallace and filmmaker Rita Hargrave provided a detailed history of the San Francisco Bay Area's vibrant and oftoverlooked Latin jazz scene. The albums make a powerful case that the region has nurtured a treasure trove of artists drawing on a singular blend of influences from across the Caribbean and Latin America. The double album Salsa de la Bahia Vol. 3: Renegade Queens shines a bright and necessary spotlight on the women who muscled their way into this scene with a combination of talent, commitment, imagination and moxie, changing the face of Latin jazz and related idioms.

*Renegade Oueens* captures the accelerating impact of female players on the Bay Area scene with a series of thrilling performances. Both discs open with new music showcasing a brilliant cross-section of women players. Arranged by Wallace, "We Were Born to Drum" is a surging big band mambo featuring vocals by Christelle Durandy. Featured throughout the anthology are, saxophonist/ flutist Mary Fettig, percussionist Michaelle Goerlitz, and the mother and daughter tandem of vocalist Sandy and vocalist/ trombonist Natalie Cressman. The second disc opens with "La Mensajera," a new Wallace salsa number that showcases the instrumental prowess of veteran improvisers. Some of the highlights include, vivacious Afro-Colombian vocalist Xiomara Torres, featured on "Me Quedo Contigo" ("I Will Stay With You"). The richly orchestrated salsa dura arrangement by vibraphonist Dan Neville effectively supports an artist who has drawn international attention to the unique folkloric

culture of Colombia's Pacific coast.

"La Lagrima" (The Tear) is a traditional song from Venezuela's Caribbean island of Margarita delivered by the singular, Caracas-born vocalist Maria Marquez, as her throaty cello tone caresses the ballad, Princesa De La Naturaleza (Nature's Princess). The lapidary arrangement features rhythms and percussion instruments by Venezuelan percussion master Gustavo Ovalles and the cuatro of Jackeline Rago, who's played a key role introducing Venezuelan rhythms to the Bay Area scene. The projects earliest piece is "Cosmo" by The Blazing Redheads. Composed and arranged by the dynamic percussionist and trap drummer Michealle Goerlitz, the sambatinged "Cosmo" came out on 1991s Crazed Women and features a particularly charged flute solo by Donna Viscuso. Some three decades later, the femmeton of La Doña (aka Cecilia Cassandra Peña-Góvea) has earned national attention, including Barack Obama listing her song "Penas con Pan" on his playlist. In something of a programmatic coup, Renegade *Queens* features the title track of her much-anticipated 2023 release, Can't Eat Clout. In many ways, La Doña speaks to the challenges faced by all the renegade queens.

A Nostalgic Remembrance



Easter is on Sunday, April the C 20<sup>th</sup> this year, a month away A and I have a couple more stories that correspond to that time of u year. The first story includes T Sal Meli, the friend from East f Boston that I traveled the world I with when we were young and single. The other subject is b Babbononno, who was in his 90s when the forthcoming b

events took place. It was the spring of  $1970\ (55$ years ago) and Easter was at the end of March that year, I believe on the 29<sup>th</sup>. Mom was putting together a list of who would be celebrating with us, and asked me about Sal Meli. Sal's parents had recently retired from their jobs, given up their East Boston apartment and moved back to Sal's father's hometown of Canicati, a suburb of Agrigento, Sicily. Mom asked if Sal might want to spend Easter with us, and when I asked him he said that he would.

This was also a point in time when Babbononno was about 95 or 96 and was a new resident at the Columbus Nursing Home, then located on Saratoga Street in East Boston. He reached a point in his mid-90s when he needed more help or attention than any one person could provide, and so, the decision was made to move him to a nursing home.

After Nanna died, he lived with us until my folks headed for Belmont. My grandfather was never happy there: nowhere to by DeNobili cigars, nowhere to buy a copy of *Il Progresso*, nowhere to buy a copy of the Post-Gazette, and no storefront social clubs where he could discuss politics and all things Italian, in Italian. He was lost. Dad and my uncles found him an apartment back in East Boston near Maverick Square, and within a few days, there was the missing smile on Babbononno's ancient face. He struck up a friendship with an Irish widow who lived next door and as she put it, "I'll look after Michael." I don't know how they communicated. The woman (I think her name was Maureen) spoke English with a thick Irish brogue, and Babbononno spoke fractured English. Somehow, they understood each other Babbononno was happy until Maureen passed away and he headed downhill from there, to the point he needed someone to care for him, and he headed to the Columbus Nursing Home. Mom made out the guest list for Easter. It included Aunt Mary, my father's sister who had been widowed in the early 60s, her son, my late cousin Jim Dello Russo, Babbononno, my

Godfather, Uncle Nick, his wife, Aunt Dorothy, and Sal Meli.

Once the preparations were underway, Easter week arrived. There wasn't much music for freelance musicians during Lent unless you had a steady job playing at a nightclub, a ballroom, a restaurant or a hotel lounge. This meant that Dad helped Mom get things ready for Easter Sunday. When March 29th finally arrived, my job was to pick up Babbononno and Sal Meli. There was no reason for Sal to drive to Belmont from East Boston, as I had to go to Eastie to pick up Babbononno, anyway.

I decided to pick up Sal first, knowing that if I needed help with Babbononno, my grandfather knew him and could communicate in Italian with him if it was necessary. Sal was a bit morose due to his folks moving back to Italy and his latest lady friend, a Brazilian bomb shell. breaking off their relationship. Actually, his girlfriend was pushing for a wedding ring and Sal wanted to stay single, so off she went. Anyway, I picked him up first and we headed to the nursing home, about five minutes from where he lived. Babbononno was ready and waiting impatiently. When I asked him what was wrong. he complained that he had been ready for hours. When I reminded him that I was to pick him up at 1:00 p.m., he looked at his watch, swore under his breath in Italian and handed me his coat. I helped him put it on, after which he donned his fedora, fixed the brim, looked down at the spit-shine on his shoes and was ready to head out. He was dressed with a suit and tie and looked the part of a Boston businessman ready to head to work.

Once outside, Babbononno looked around and asked, "Wayza da Cadillac?" I told him that I had traded the Caddy for an Imperial. He then asked, "Dis new carra is gooda won like da Cadillac?" I told him that it was even better than a Cadillac. He then asked, "Dis Imperiale, itza gudda da top you pusha down?" I answered yes, that it was a convertible, and he came back with, "Den, pusha da top down, pleeza."

Once the top was down

Once I was ready to drive off, he looked at his watch, then told me to drive slowly to Orient Heights Square and take a right onto Bennington Street and head south toward Day Square. His next command was, "Anna you driva slow." We were soon near Moore Street where St. Mary Star of the Sea Church is located, and he asked me to take a right and stop in front of the church. He had timed our arrival with the end of the Italian Mass. As the old Italian ladies exited the church, Babbononno waved at them, tipped his hat and yelled out, "Buona Pasqua, Buona Pasqua," (Happy Easter) to one and all.

Once we left the area, I had to put the top back up. It was March and still very cold, but I could tell from the actions of my grandfather that he still had that spark in him that made him who he was all his life.

He spent the day sitting at the dinner table at my folks Belmont house, enjoying the dinner my mother had prepared for Easter, and I knew that spark was still there as the holiday dinner was winding down. When it was time for an after-dinner drink, Babbononno asked, "Jenny, you gudda suma Frengia cognac?" I answered that I had a bottle of French cognac hidden away somewhere. He then asked, "You giva me liddle bit?" I said I would and he added, "Widda Frengia Cognac, I needa cigarro Cubano." I obliged him once more, gave him one of my Cuban cigars, cut the tip off and handed it to my smiling grandfather. He dipped the chewing end into the glass of cognac, put it in his mouth and waited for me to light the other end. After I did, he puffed the cigar, sipped the cognac, sat back and sighed as if he was in heaven. This is the memory I have of Babbononno's last year or two on Earth. He made it into his 98th year and then closed his eyes one day and that was it. He's gone, Sal's gone and the Imperial is long gone, but the memories ... they live on and on ...

During Pasqua (Easter), one of the most beloved traditional sweets you'll find in Italy — particularly in Sicily and throughout the southern regions of Puglia, Calabria, and Campania — are taralli dolci, or sweet taralli. Unlike the savory taralli you might be familiar with, these are delicate, tender confections, somewhere between a cookie and a biscuit. They are lightly flavored with lemon, vanilla, or anise, glazed with a glossy sugar icing, and shaped into rings or figure-eights — symbols of infinity and renewal, perfectly suited to the Easter celebration.

In Sicily, these treats are known as Taralli Dolce Siciliani. Traditionally prepared for the Feast of All Saints, they are now a year-round staple in Sicilian bakeries and pastry shops. Countless variations of this recipe exist, with the oldest versions calling for anise seeds and ammoniaca per dolci (ammonia for cakes), a classic leavening agent with a strong odor that disappears in the baking process. My Nonna sometimes included anise seeds, but she always avoided using ammonia due to its smell, relying instead on the familiar Italian baking powder sachets.

This recipe for Soft Lemon-Glazed Sicilian Taralli or Taralli Siciliani Morbidi Glassati al Limone is one of my personal favorites and has become a cherished part of our family's Easter dessert table. I hope you and your family will enjoy them as much as we always have!

#### SOFT LEMON-GLAZED SICILIAN TARALLI Taralli Siciliani Morbidi Glassati al Limone



#### **Dough Ingredients:**

500 g all-purpose flour (about 4 cups) 120 g lard or vegetable shortening (a generous ½ cup) 1½ teaspoons baking powder (or 1 sachet Italian baking powder) 120 g sugar (½ cup plus 1 tablespoon) 100 ml milk (a little less than ½ cup) 2 eggs 1 teaspoon vanilla extract Zest of 1 lemon 1 teaspoon anise seeds (optional) Pinch of salt

#### **Dough Instructions:**

On a clean work surface or in a large bowl, place the flour and add lard. Use your fingers to rub together until the mixture resembles coarse crumbs or sand. Add baking powder and mix. Make a well in the center; add eggs, vanilla, lemon zest, and salt. Begin mixing with your hands, gradually adding the milk until a smooth, soft dough forms. Knead until smooth, wrap in plastic wrap, and refrigerate for 30 minutes.

Preheat the oven to  $350^{\circ}$ F ( $180^{\circ}$ C). Divide dough into pieces of 50–60 g (about golf-ball size), roll into ropes, fold in half, twist, and join ends to form a circle. Place on a parchment-lined baking sheet, spacing them apart. Bake for 20–25 minutes or until lightly golden.

250 g confectioners' sugar (about 2 cups) 25 ml water (about 1 ½ tablespoons) Juice of 1 to 2 lemons (adjust to taste and consistency)

If the glaze is too thick, slowly add more lemon juice a little at a time until you reach a pourable consistency. Dip the cooled Tarallo cookies into the glaze, coating them evenly. Place on a wire rack to dry, allowing the glaze to set.

#### **Oneloa Beach: Tropical Dreams**



#### Molokini

During my brief stay in west Maui, I spotted at least three mongooses. Those aren't good statistics for an invasive species in an island ecosystem. Like the cane toad was imported from the Americas to control insects in Australia, so the mongoose was brought over from India to the cane fields of Hawaii to exterminate rats. Both species failed in their intended mission and instead created a biological nightmare in their host countries; the mongooses devastating indigenous bird species far more than it made a dent in rat populations.

The impact was made more significant that all the sightings were during my drive to Oneloa Beach, an inviting paradox of a place, curiously calming as it is thrilling, secluded as it is popular, small as it is expansive. A place that can only exist in a closed environment like Mākena State Park. This is the ecosystem at stake.

In less than a week, I visited the beach three times, that is how much it encapsulated for

me everything I went to Hawaii for. It tells even more about the unique experience it offers. In many ways, Oneloa Beach is what you make of it. If your idea of a tropical getaway is simply to bask in the sun and take in the soothing sound of the waves, you could easily spend hours on the sand taking in the surrounding beauty. You can also swim.

About a week before leaving for Hawaii this past January I spoke to colleagues experienced in travel to the Hawaiian islands and the much of the talk was a promise that I would love it. The one word of caution was the strength of the current. I found it a warning not to be taken lightly. Once crossing the entrance to Mākena State Park and making your way through the shaded sandy paths to the beach, a sign warns swimmers and surfers that Oneloa has the reputation as the most dangerous beach for spinal injuries due to a combination of the speed of the waves throughout Hawaii (35mph compared to 15mph in Floria and 20 mph in



California) and the unpredictable short break waves.

I had to swim. I could not be in Hawaii and ignore the allure of its crystal blue water. The quintessential experience of Hawaii, after all, is for the waves. As with most places that bare a reputation for danger three things proved essential. Take warnings seriously, use common sense and, the one most often overlooked, know your own limits.

Once in the water I realized how quickly the water runs deep. With the rapidity it pulled the sand from under me in the current, the Pacific itself made recognition easy for me, marking clearly how deep into the waters I was willing to swim and how high the waves I could take. As in all places in which we are guests of nature, visiting on nature's terms and taking nature's instructions makes for the most rewarding experience.

Ultimately, I decided to experience both the exhilaration offered by the waves and the tranquility of the beach. In Oneloa one can take in the natural harmony of the tropics at once. Even the more courageous swimmers (and I saw a few breath-stroking their way from one end of the beach to the other with admirable determination) work with the environment. In the distance one can see the crater of Molokini laying in the waters like a majestic green monarch. In the right season at least, Oneloa is one place I can almost guarantee spotting humpback whales; on each visit I spotted them in the distance if only by the massive tail.

Oneloa Beach was for me the heart of west Maui and everything I thought Hawaii would be. It is a place where nature invites you on her own account and shows you everything it can be, everything it can offer you, and everything it can teach you. A microcosm of a world worth saving.



#### Oldest Living Ballplayer Dead at 100

Art Schallock, a left-handed pitcher who in 1951 replaced Mickey Mantle on the Yankees' roster and had been the oldest



living major leaguer, has passed away. He was 100 and had celebrated his 100th birthday last spring. He was living at an assisted living facility. According to his family, "He passed away peacefully in his loving care facility at the age of 100. He would have been 101 in April."

When the Yankees optioned Mantle then 19 years old, to Triple A in 1951, Schallock was brought up to the majors at 27 years old. He made his debut on the mound on July 16, 1951 against the Tigers in Detroit and pitched 2.2 innings, then earned his first win one month later against the Senators. He also won three World Series rings from 1951-53.

In five big league seasons mostly with New York before finishing with the Orioles in 1955. Career wise he went 6-7 with a 4.02 ERA. His age didn't set a record, Negro League pitcher Si Simmons of the 1926b New York Lincoln Giants lived to 111. Another ex-Yankees pitcher Red Hoff reached 107.

### When Boxing Was Up Close and Personal **REVIEW Cleveland Arena Ohio's Professional Boxing Mecca 1937-1973 By Jerry Fitch** Arcadia Publishing

It's hard to believe today in this age of pay-per-view boxing, but there was a time when people would actually go on a regular basis to a local venue to watch live in-person boxing matches. Most cities, and even smaller municipalities had places where fights were held frequently. The 1930s and 1940s were really the heyday for well attended local fight cards.

In the 1950s, with the advent of television and with most homes having a TV set, the smaller fight clubs were being hurt. Not only were fights being broadcast up to four times a night weekly, but there were plenty of other popular televisions programs that had people hooked. This alternative also cut into other entertainment business such as movie theaters and nightclubs, but I would argue boxing was hit the hardest.

One by one the smaller clubs started to disappear. Not only was the lack of paying customers causing a problem, but the people promoting the televised fights were moving fighters along quickly in order to keep their fight schedules filled. This resulted in many boxers being put in over their heads early in their careers, resulting in their never being able to develop to their full potential.

The lack of local venues also meant less opportunities for those just starting out to find work. Because of this, many boxing gyms disappeared as well. The Cleveland Arena with a seating capacity of 14,000 for boxing was one of those places. It was in operation for 36 years, and the rise and decline of boxing is mirrored in its history.

Mr. Fitch has compiled a complete listing of every card that took place in this storied location. In this beautiful book he has supplemented his listings and brief commentaries on these cards with an incredible collection of photographs of the fights and fighters who fought there. The photos are from the author's personal collection as well as from the archive of the Cleveland Plain Dealer. Many of these photos will be new to long time fight fans, and are to be treasured.


The list of great and near great fighters who fought at the Arena is endless. There are also some interesting things to note. In particular, Jake LaMotta fought there four times but had only one win, that being in his final fight at the venue.

In the 1930s when the Arena was first in operation, had you been attending shows you would have gotten to see Henry Armstrong make three title defenses.




Mr. Fitch chronicles this history with precision along with the affection he has for the sport that he has followed since he was very young. Over his lifetime he has met just about every noted boxer as well as becoming close friends with many, most notably Jimmy Bivins.

The book takes us on a thrilling ride, with the excitement of those early years leading to the sadness of seeing the local boxing scene start to fade in the 1960s, with only 11 shows being promoted in that decade. That was quite a drop from the 37 shows held in the 1950s. This decline was not confined to Cleveland. It was happening all over the country. Fight fans attending Cleveland Arena fight cards still got their money's worth in those final years as they saw cards headlined by the likes of George Chuvalo, Zora Folley, Joey Giardello, and Doyle Baird.

1973 saw the last of the promotions at the Cleveland Arena. Local boxing was on its last legs by then, and there was no stopping the inevitable. The remaining cards headlined some future contenders and champions such as George Foreman, Ken Norton, along with former champs Floyd Patterson, Emile Griffith, and Ernie Terrell. Boston boxing fans may also remember that one of our own, Mike Pusateri traveled to Cleveland to beat local favorite Doyle Baird. Baird came back to defeat Iron Mike in two rematches. All three were very



It has been a long time and maybe that is because it has been the only time.

The singular moment when a college team from Massachusetts won the NCAA Division One men's basketball national championship.

One has to go back quite a long way — and only the most senior among us can recall with any clarity that exciting time. A time without television, little radio coverage but a fair amount in the print edition newspapers of the era,

Yes, it was the early spring of 1947 when Holy Cross captured the title by defeating the City College of New York (CCNY) in the national championship game that was played in the original Madison Square Garden in New York City.

The Crusaders came home to a parade through the streets of Worcester. It was so inspiring they almost did it again in 1948, advancing to the Final Four before losing to Kentucky in the semifinals.

When Holy Cross won the title in the early years of the tournament the event was less than a decade old-having started in 1939. The Crusaders had to defeat three opponents to capture the crown.

The Final Four teams comprised half of the tournament field. That's right. There were only eight teams in the very slimmed down version in those early years. That meant that when the tourney started it opened with the quarterfinals with the four survivors advancing to what we would call the Final Four in modern times.

There were only two regionals — an East Regional and a West Regional. The East Regional was played in Madison Square Garden while the West Regional was played in Kansas City, Missouri. Holy Cross, CCNY, Navy and Wisconsin comprised the East while Oklahoma, Texas, Oregon State and Wyoming made up the West. The winners of the four opening round games (two from the East, another two from the West) advanced to the Final Four.

Because of the limited field, the tournament was much shorter in duration, lasting only seven days. When Holy Cross defeated CCNY it was only March 25th, just about the time the first round of the tournament concludes in contemporary times.

The tournament years for Holy Cross also marked the time that future basketball Hall of Famer Bob Cousy was with the Crusaders, having arrived from New York City in the fall of 1946.

Cousy, of course, would go on to a stellar career with the Celtics while one of his teammates — Joe Mullaney — would later coach the Los Angeles Lakers.

Both the 1947 and 1948 teams were coached by Alvin Fred "Doggie" Julian, an iconic figure in New England sports who led not only Holy Cross but later went on to coach both Dartmouth and the Boston Celtics.

Holy Cross finished that 1946-1947 regular season with an excellent 24-3 record. The Crusaders defeated Navy 55-47 in the opening round, swamped CCNY 60-45 ain the semifinals and then won the championship by defeating Oklahoma 58-47.

The next season (1947-1948) was nearly a repeat of the first, with HC knocking off Michigan 63-45 in the quarterfinals before losing to Kentucky 60-52 in the semifinals. The Crusaders were victorious in what was then called the third-place game, winning 60-54 over Kansas State while Kentucky defeated Baylor for the championship.

HC next made the tournament in the spring of 1950 after going on a 26-game winning streak during that 1949-1950 regular season. It was Bob Cousy's senior year and while he was named as a consensus first team All American, the Crusaders lost to North Carolina State in the opening round of the tournament, bringing Cousy's collegiate career to a conclusion. CCNY-the team that HC had defeated in 1947-won the event.

That would be the last time a team from Massachusetts would make the Final Four until 1996 when UMass, coached by John Calipari, lost to Kentucky 81-74 on the opening night. The result of all the games UMass played in the tournament that spring were later vacated because of what the NCAA determined was UMass star Marcus Camby's acceptance of improper gifts from two sports agents. Thus, the UMass official record for the 1995-1996 season was reduced to 31.

would eventually take its toll on the televised fights. The weekly TV fight cards started to be cut.

Today, boxing is run more as an entertainment industry, or perhaps more in line with something like professional wrestling. It is driven by social media and marketing experts. Fans will pay to watch hyped up fights on payper-view, but most don't follow closely the careers of the participants, especially from their early careers. They are sold on the hype. The sizzle, not the steak.

Reading boxing historian Jerry Fitch's book *Cleveland Arena: Ohio's Professional Boxing Mecca 1937-1973*, brings us back to that time when fight fans could buy a reasonably priced ticket to see highly talented fighters compete. Undercards would often showcase local up and comers while the semi-final and main events would consist of solid pros in competitive contests.

#### Great Fighter Lloyd Marshall who fought at The Cleveland Arena

The Cleveland Arena really hit its stride in the first half of the 1940s. From 1940 to 1944, all-time great Jimmy Bivins headlined 23 cards. Others to step into the ring during this period were Tami Mauriello, Lloyd Marshall, Ezzard Charles, Abe Simon, Billy Soose, and Joey Maxim to name just a few. It is staggering to think that if you lived in the Cleveland area at that time you could have purchased a reasonably priced ticket to see this remarkable talent in person.

exciting fights.

Jerry Fitch's history of the Cleveland Arena is a must have for any boxing library. The historical information is invaluable, and the photos are something to be treasured. This is not a volume to remain on the shelf, but one to be left out where it can be perused over and over. While dipping into it you can close your eves at times and hear the roar of the crowd and smell the cigar smoke that was ever present in those days gone by. It was quite different from sitting on your sofa watching fights on a big screen TV.

While Jerry has worked tirelessly to bring those days back to us, I think I would add a final line to this volume; "You had to be there!"
