Boston Considers New Delivery Tax on Food

Consumers to Pay the Price

No one can deny the frustration we feel when food delivery drivers weave in and out of traffic on their vespers or double park their cars, while running in to grab their pick-up orders, creating back-ups on neighborhood streets. However, the newly proposed delivery tax, proposed as an amendment to an ordinance submitted by Mayor Wu, as an attempt to punish offensive food delivery companies like Uber Eats, Grubhub and DoorDash, may ultimately add more of a financial burden on customers and restaurants.

The Boston City Council is considering a potential amendment, offered by Councilor Sharon Durkin, to a "road safety and accountability for delivery providers ordinance" proposed by the Wu administration that would add a 15-cent delivery fee per order for food delivery companies that operate in Boston. Councilor Gabriela Coletta-Zapata, chair of the sub-committee that held the hearings on the proposed ordinance said the new tax is "currently on the table as a possible addition" and requires Council approval. "It would theoretically be a 15-cent per order fee that would help cover costs of the enforcement of the ordinance."

The proposed fee has come under fire from the

Massachusetts Restaurant Association (MRA). Stephen Clark, President and CEO of the MRA expressed concern to all of the councilors regarding the fee. "This will make delivery more expensive in the city and discourage consumers from ordering and doing business with restaurants in Boston and lead to rising delivery costs. The proposed ordinance is intended to alleviate traffic congestion, but enforcing existing regulations will have a far greater impact and will only hurt small local businesses and consumers who rely on third-party deliveries."

Mayor Wu's spokesperson said "the mayor did not include any fee or tax on restaurant orders in the original ordinance filed. This order holds large, national delivery companies accountable and will ensure drivers have insurance coverage while making our streets safer for everyone."

Councilor Coletta-Zapata said the council would have to take action on the mayor's original ordinance and any amendments, including the new fee, by the first week of April to comply with the 60-day order. If the council chooses to take no action, it will go into effect with the language proposed by the mayor. A vote must be taken at the next weekly council meeting, April 2nd.

Wu said Boston is home to the nation's best hospitals, colleges and universities, labs, research facilities, institutions that she said drive the city's economy, provide jobs and make the Hub America's engine of innovation. "Today they are all under attack. Boston is a target in this fight for our future because we are the cradle of democracy, pioneers of the public good, the stewards and the keepers of the American Dream. We were built on the values this federal administration seeks to tear down."

In addition to being one of four big city mayors called to

testify before a congressional oversight committee earlier this month as part of its inquiry into Boston's sanctuary status that limits local police and other city agencies from cooperating with federal immigration authorities and their impact on public safety, Wu was again one of four big city mayors to be notified by the Department of Justice this month of an impending visit by its federal task force to probe the city's response to incidents of antisemitism at Boston schools and colleges.

As part of her comments, Wu reiterated that Boston is the safest major city in America, offering Commissioner Michael Cox praise for his hard work, despite ongoing issues with crime in Downtown Crossing, Boston Common area. She also highlighted other goals and accomplishments including the city's public-private plan to rehab Franklin Park's White Stadium for a new prowomen's soccer team, efforts to improve housing affordability, a co-purchasing pilot program to help residents purchase multifamily homes with 0% deferred interest from the city, plans to tackle high energy bills through

Trump Orders Plan to Dismantle the ED Department

Massport Increases Rideshare Driver Fees

It may be less than originally planned, but it still raises the fee by 70% beginning July 1st. A plan to raise fees for rideshare drivers picking up or dropping off passengers at Logan airport was unanimously approved by the Massport Board of Directors during a recent meeting, after the board reached a "tentative agreement" with Uber and Lyft. The rideshare drivers, unions and individual drivers are all in opposition to the fee increase.

"These developments were shaped without the input of drivers, the people who will be hit hardest by the fee. Uber and Lyft drivers move thousands of passengers in and out of Logan every day. For these drivers, airport fares, are a critical source of income. the proposed fee could be a crushing financial blow to drivers who are already struggling to get by" said App Drivers Union spokesperson Mike Vartabedian.

Effective July 1, a one-time per trip fee for an app-based driver taking passengers to or



from the airport in Boston will jump from the current rate of \$3.25 to \$5.50. The agreement over a one-time increase to the ridership fee comes with a promise by Massport to "expand curbside access for rideshare drivers" while the companies agree to pursue carpooling options for passengers to reduce the number of cars heading to the airport. High occupancy trips to the airport would face a reduced-rate fee of \$1.50.

"Lyft appreciates the productive conversations we've been able to have with Massport since their initial announcement.

While we still have concerns about increasing fees on riders, this is a step in the right direction. It allows us to improve the rider experience at Logan as we continue to look for ways to equitably fund the airport's future success," Lyft's public policy manager, Brendan Joyce, offered in a statement. Josh Gold, Uber's senior dir-ector of public police and communications stated "Uber is pleased to have negotiated this compromise with Massport that will get passengers to and from Logan Airport more efficiently, while at the same time reducing congestion in the area. We will continue to work with Massport to get travelers as close to the curb as possible and will always advocate for the best service for riders and the best platform for drivers."

The fees are earmarked to help fund airport infrastructure improvements and to encourage people to use public transit

Judge to Deliver White Stadium Decision

All parties involved, defense, plaintiffs, City of Boston, neighbors, have all had their say regarding the present and future status of White Stadium with due diligence put forth by both sides. The decision now rests solely in the Judge's hands and is expected in the next week or so.

Closing arguments ended last Thursday with attorneys for both sides, the City of Boston paired with Boston Unity Soccer Partners (BUSP) along with the **Emerald Necklace Conservancy** and many Franklin Park neighbors, focusing on article 97 of the state constitution and the plaintiffs claim that the project will privatize protected parkland.

Suffolk Superior Court Judge Matthew Nestor noted the significant community engagement and public dynamic he witnessed throughout the threeday trial has been unusual. "I've seen there's been people on both sides of this issue, that's not the usual. I am not sure how to describe it. You don't hate each other, which is great because no matter what happens in this case, the neighborhood is going to go forward in one fashion or another and you are all going to be neighbors."

Nestor dismissed a large portion of the plaintiff's case prior to the start of the trial but left intact a major claim which is that the proposed plan violates Article 97 of the state constitution, which was approved by Massachusetts voters in 1972 and requires twothirds approval from the state Legislature for uses other than for land and easements taken or acquired for conservation purposes. The city and BUSP deny the privatization claim and have argued that the city and Boston Public Schools would maintain ownership of Franklin Park's White Stadium through a lease agreement, with the National Women's Soccer League team as tenants and a shared use of the facility with Boston Public School student-athletes.

Gary Ronan, attorney for the city argued the proposal does not constitute a new use for the portion of relevant park land, in that the public-private plan is for an existing stadium to be rebuilt. "There is no case in the Commonwealth where the court has found something like a giant sports stadium is protected by Article 97. All that's happening now is a reconstruction of White Stadium. The existing facility was already approved by the General Court," Ronan stated in his closing argument.

Alan Lipkind, attorney for the plaintiffs believes otherwise. "This is putting a \$200 million sports and entertainment complex in what's supposed to be a schoolboy stadium. You have to go through land that is protected by Article 97 to get there," Lipkind argued.

Judge Nestor said he will take the case and testimony under advisement and make a decision soon.

Mayor Wu's office issued a statement at the conclusion of the trial reiterating the city's confidence in their legal position on this matter." We believe state law and decades of evidence make clear that White Stadium is a school facility which Boston Public Schools has full authority to rebuild with the financial assistance of a private partner, to better serve students and the public. We are confident in our position and our plan to deliver a new home for BPS student athletics that Boston deserves."

Bulfinch Triangle District Zoning Amendment

The Bulfinch Triangle District, considered to be located in Boston's West End, was recently subject to a zoning change allowing residential development. The Boston Zoning Commission voted earlier this month to amend the zoning code for this area. The Boston 10-2 in favor of the amendment, sponsored by Councilor Sharon Durkan.

The purpose of the change was to dismiss zoning barriers and spur new housing development, piggybacking on the city's call for increasing residential units in this area and throughout the city. The approved amendment changes "Residential Use" from a "Conditional Use' City Council previously voted to an "Allowed Use," encouraging housing development and conversion of underutilized buildings into housing. There

are a number of active office-toresidential conversion projects under review that encourage developers to convert underutilized offices into residences.

Last August the RMR Group LLC submitted a letter of intent with the Wu administration's newly implemented Boston Planning Department (BPD) to build a new ground up 40-story mixed-use building to include hundreds of hotel rooms and residences, along with retail space and restaurants. The hotel and residential project, located in the Bulfinch Triangle neighborhood and will encompass the area around North Washington Street, Causeway Street and Medford Street. The project, currently under review, has drawn the ire and concern of the North End Waterfront Residents Association (NEWRA) members who are remaining vigilant on the proposed project.

President Trump Calls for Lower Interest Rates

Not one to sit on the sidelines as events unfold, President Trump has jumped into the mix regarding the Federal Reserve's announcement they will hold interest rates steady amidst uncertainty over his plans for tariffs on imported goods. Trump called on the Fed to do the right thing" and lower borrowing costs to keep the economy moving as many economists express concern that the tariffs will increase inflation.

"The Fed would be MUCH better off CUTTING RATES as U.S. Tariffs start to transition (ease!) their way into the economy," Trump wrote on social media. The Fed voted last week to keep rates steady for a second straight month after lowering them at the previous three-monthly meetings. Fed Chairman Jerome Powell said the impact and extent of Trump's tariff plan remains

The Fed's latest pause marks the second time in a row that the central bank held borrowing costs steady.

Mary Di Bazzo-Trumbull 1954 - 2025

Post-Gazette columnist Mary DiZazzo-Trumbull died March 18, 2025, after a long illness. She had written the "All That Zazz" beauty column, exclusively published in the Post-Gazette, since August 22, 2003.

Mary was born on Christmas Day 1954, in Lawrence, Massachusetts, first-born child of Alec DiZazzo (1920-2010) and Josephine (Catalano) DiZazzo (1923-2001). Both parents were natives of Lawrence Massachusetts. Mary's grandparents were immigrants.

The DiZazzo family was from Rocca d'Evandro, Caserta, Italy. The Catalano and related Cosentino families were from Aci Catena, Catania, Sicily, and Aci Sant'Antonio, Catania. On September 29, 2003, Mary was wed to Post-Gazette columnist David Trumbull, in Rome, Italy.

In addition to love of family and the Boston arts and theatre scene, Mary was proud of her trade as a cosmetologist. She followed her mother and grandmother in this trade and earned her credentials at the M. Fazio Institute of Beauty Culture, Class of '74. She worked in various beauty salons until she operated her own business, Mary for Nails, from March 1996, until, due to declining health, she had to shutter the business in March 2018.

In retirement she continued to support the trade she had taken such pride in. Even in her recuperative bed she renewed her Commonwealth of Massachusetts license as a Cosmetologist. She gave back to her trade and encouraged its future by agreeing, in April 2015, to serve on the Greater Lawrence Technical School



Cosmetology Advisory Board. Some readers may remember Mary's Saturday morning beauty culture talks at the North End Branch of the Boston Public Library.

Mary's hobbies were too many to list, but what stands out was her dollhouse and the miniature furnishing. The dollhouse had its own address to which a weekly newspaper was delivered. In 2014, the Beacon Hill Times newspaper published a front-page story about Mary's dollhouse. The reporter,

upon receiving a photo of the dollhouse said, "I see your living room, but where is the dollhouse?" Mary responded, "That is the living room of the dollhouse." That same year the Newseum, a museum in Washington DC published an online story about Mary's diminutive domicile.

Trump to Cover Astronaut Pay

After being stranded in space for 286 days, astronauts Suni Williams and Butch Wilmore finally splashed down safely in the Gulf of America, off the coast of Tallahassee, Florida, thanks to the Elon Musk's company SpaceX launching a rescue mission at the urging of President Trump. In September, SpaceX launched a Crew Dragon Capsule to rescue the astronauts, but NASA chose to delay their return, claiming the pair would have to wait for another SpaceX rescue vehicle loaded with replacement

During a press conference hailing their return, Peter Doocy, Fox News, pointed out the astronauts had been trapped at the International Space Station since June 2024 and noted that NASA has only agreed to cover just \$5.00 per day for incidentals for the crew, tallying approximately \$1,430 in back pay for each astronaut. "If I have to, I'll pay it out of my own pocket," responded Trump, promising to personally cover the overtime pay for Williams and Wimore. "Nobody ever mentioned this to me. Is that all? That's not a lot, given what they had to go through," added Trump.

A NASA spokesperson said in a statement that the agency's astronauts are "on official travel orders as federal employees," effectively categorizing their stay as a business trip. So much for service to your country.

Tesla Vehicles and Dealerships Targets of Vandalism

U.S. Attorney General Pam Bondi issued a stark warning to "tread carefully" over calls for Tesla provider Elon Musk to be taken down by Congresswoman Jasmine Crockett, D-Texas. "She is an elected public official, so she needs to tread very carefully because nothing will happen to Elon Musk, and we are going to fight to protect all Tesla owners throughout this country." Bondi vowed. She also doubled down on her previous pledge that widespread violence against Tesla owners and dealerships, which have seen electric vehicles engulfed in flames and defaced with hostile imagery, will come to a stop.

Crockett's remarks were made during a national call with the Tesla Takedown movement, a self-described "peaceful platform protest" calling for Tesla owners to sell their vehicles and for all to dump their stock in the Electric Vehicle (EV) provider. "On March 29, it's my birthday. All I want to see happen on my birthday is for Elon to be taken down. I have learned, as I serve on the DOGE oversight committee, that

there is only one language that the people that are in charge understand right now, and that language is money," Crockett stated to the group in reference to an upcoming "Global Day of Action" intended for the Tesla company.

Crockett attempted to clarify her remarks by claiming her calls to action are "nonviolent, and that the group is peaceful, loving people and this is not about violence." Republicans believe differently and have accused Crockett of inciting violence against the EV provider with her hateful speech. The Justice Department has cracked down on the violence, with three people accused of damaging Tesla's and EV charging stations facing up to twenty years in prison for alleged domestic terrorism.

"People need to know that the three people in custody right now will receive severe and swift consequences. We are not backing off these charges. We are looking at everything, especially if this is a concerted effort. This is domestic terrorism," Bondi exclaimed.

Announcing April's Arrival

As April arrives, a whole month of spring and sunshine stands before us, dazzling for our enjoyment. April smells like fresh flowers and the pungent scent of trees after a delicate rainfall, like balmy breezes and juicy strawberries. Soft rains drizzle down outside my window, making the grass seem lush and greener than a mint sprig, the pavement shiny and smooth like obsidian. I am reminded of the old rhyme

I cheerfully intoned as a young girl: "April showers bring May flowers!" Indeed, April is the time of the year when spring finally feels in full bloom, when flowers, rain and abundant sunshine meld together to form an energetic, playful month. The purported origin of April's name also reflects its qualities of rejuvenation and rebirth. April may derive from the Latin word aperire, which means "to open." As the Latin origin of the name suggests, April is a significant month in Italy. Italians even start the month in a jovial fashion, surreptitiously pinning paper fishes to each other's backs during pesce d'aprile, or April Fools' Day. The following is a sampling of quirky and culturally rich practices that characterize April in Italy:

April Proverbs: Italian folklore abounds with multiple proverbs related to months and times of the year. These hearken back to the days when Italian society was primarily based on agriculture. Farmers needed to pay special heed to the weather in order to determine important and vital times like when to plant and what crop yields to expect. As such, most of the Italian proverbs related to April (which I gathered from the wonderful website italy revisited.org) concern themselves with the weather of the month. One proverb declares: "L'aprile piovoso, fa il maggio grazioso." Translating to "a rainy April makes a grateful May," this is the Italian version of the April showers bring May flowers dictum. Another proverb says "Marzo tinge, aprile



dipinge" — meaning that what March dirties, April cleans up; just as April rains and vegetation takes over the muddy or snowy changeable weather of March. However, another proverb admonishes "Aprile, non ti scoprire." It warns against discarding your coat during April, as there are still cool days left!

Easter (April 20th): Oh, Easter! I love everything about this feast, from its rebirth symbolism to the large family gatherings laden with delectable, seasonal food. Easter is one of the most important holidays in Italy, where it is known as Pasqua. There, people attend Mass in churches decorated with olive branches and flowers, then head home for a banquet featuring Italian Easter delicacies like colomba pasquale (a sweet bread shaped like a dove, sometimes with colorful Easter eggs tucked inside) or pastiera (a pie made with wheat berries, sweetened rice, or ricotta cheese, depending on the region). As a little girl, I knew Easter was approaching when my father brought home a large uovo di cioccolato, or chocolate egg, from a specialty shop in the North End. Waiting to break open the egg and discover the treasures hidden inside served as a wonderful metaphor to the surprise and promise of Easter.

Rome's Birthday (April 21st) and St. Mark's Day (April 25th): Italy is filled with many cityspecific holidays, and two of the most intriguing fall during April. Rome's Birthday honors the founding of the city, all the way back in 753 B.C. Romans celebrate with festivals, parades, concerts, and fireworks displays throughout la cittá eterna (the eternal city). Four days later, the charming maritime city of Venice displays similar gaiety for St. Mark's Day, or la Festa di San Marco, the feast day of Venice's patron saint. Carnivals, markets and parties center around the enormous St. Mark's Square, the

beating heart of the city. Celebrate both holidays by enjoying food from each region. How about a plate of spaghetti alla carbonara (spaghetti with egg sauce) on Rome's Birthday and some risi e bisi, or risotto with peas, on St. Mark's Day?

Liberation Day (April 25th): This patriotic holiday honors the liberation of Italy from Nazi and fascist occupation during World War II. On April 25th of 1945, the cities of

Turin and Milan were the first to be freed from the occupation, and their liberation prompted a chain of events which culminated in Italy's freedom. Italy celebrates Liberation Day, or Festa della Liberazione, with processions, speeches and countrywide events. My ancestors, including my grandparents, still lived in Italy during the Second World War and had to deal with all the horrors that accompany an armed conflict, from bombings to mob violence to food shortages. As such, I always feel compelled to remind people of this springtime feast, a holiday commemorating the ordinary Italians who fought so hard to free their beautiful land from the terror of fascism.

May Day Eve (April 30th): I love this holiday! Since ancient times, European folklore has attributed the first day of May with magical properties. People believed that elves, fairies and witches were especially active on this day. In Italy, May Day is known as Calendimaggio, and celebrations begin the night before, on the last evening of April. Cities hold festivals and events with a spooky twist, replete with witch decorations and magical themes. Honor this day by taking a walk during dusk and contemplating the wonder and mystery still left in the world.

Sagre: In conclusion, I would like to point out that towns and cities all over Italy hold sagre, or food festivals, throughout the year. They focus on seasonal, local ingredients and the various way to highlight them in delicious dishes. Most Italian sagre focus on the country's premiere spring vegetable, the artichoke, or carciofo. I absolutely love artichokes and look forward to them every spring. Enjoy artichokes the way Italians do - stuffed in pastas like ravioli or tortellini, fried, or simply marinated in olive oil. Yum!

Collectively, these April celebrations typify the folklore and love of the seasons so often found in Italian culture. When spring finally arrives, everyone is in the mood for a party, and Italians are no different! No matter which April holidays you choose to honor, make sure you do so with love in your heart and optimism for the upcoming spring. That way, all of your days are sure to be filled with joy!

Boston City Councilor Open to Hiring Laid Off Federal Workers

Weber filed a hearing order suggesting the City of Boston consider ways to hire recently laid off federal workers "who have recently fallen victim to draconian mass layoffs" by the Trump administration as a mechanism to fill the thousands of vacant jobs throughout city government.

According to Weber's order, other municipalities and states across the country, including Hawaii, Pennsylvania, Virginia, New York, Montgomery County in Maryland and Fairfax Virginia have attempted to recruit fired federal workers. "As of April 2024, the City of Boston should examine whether it should recruit and train federal employees who have recently fallen victim to draconian, mass layoffs without cause," wrote Weber.

Weber's order mentioned that more than 100,000 federal employees have been laid off by the Trump administration over the last few months.

Weber's suggestion calling for additional city hiring, may not come at the most prosperous

City Councilor Benjamin time for the city. Over the past year, Mayor Wu and the city council have been dealing with falling tax revenues as commercial values and tax revenue has decreased shifting more of the budgetary tax burden onto homeowners who have been hit with double digit tax hikes.

> Post-pandemic work patterns have resulted in falling commercial values as the city's \$4.6 billion dollar budget grew by 8% this fiscal year and the city's payroll grew by more than 2.28% last year, from \$2.14 billion to \$2.19 billion. Last year Mayor Wu's administration created 54 new positions, as part of the 301 new positions that were created since Wu became mayor in November 2021.

> "These mass layoffs are being one without any thought to the impacts that may have on the public or to the workers themselves. I think it makes sense to see if we can bring in experienced government workers to provide some of the basic services that our residents are going to be deprived of if we don't take action," said Weber.

New Data Shows Gen Z

Most Conservative Generation in Decades

David Shor, head of data science at Blue Research, a Democratic polling firm, recently released charts and data showing Gen Z, those born between 1997 and 2012, ages 28 down to 13 years old, are the most conservative generation in decades. The pollster explained "is that among 18-year-olds, women of color are the only, of the four race and demographic groups, that Harris won, while Trump narrowly won nonwhite men."

The researcher pointed to one surprise result that defies a core Democratic belief, that young people don't like Donald Trump. "This is the thing I am most shocked by in the last four years, that young people have gone from being the most progressive generation since the Baby boomers, and maybe even in some ways more so, to becoming the most conservative generation that we've experienced in fifty to sixty years," said Shor.

He then went on to discuss what he called "the scariest chart in this entire presentation," showing the massive and unusual polarization between young men and women. "What's crazy is that if you look at people under the age of thirty, the gender gap has exploded. Eighteen-year-old men were 23 percentage points more likely to support Donald Trump than 18-year-old women, which is just completely unprecedented in American politics," Shor added. Various factors that may influence this trend in recent years are the #MeToo movement and the sense the Democratic Party is becoming more of a prowomen party and somewhat anti-young men, which may have had a huge effect on young men's political opinions."

The thought was that if Trump couldn't hit record numbers among seniors and millennials and Gen Z's were coming into their voting power, that would be the end of the Republican Party. However, this past election may prove to be the beginning of a new Republican Party.



Dorothea Dix

Dorothea Dix was an early 19th century activist who drastically changed the medical field during her lifetime. She championed causes for both the mentally ill and indigenous populations. By doing this work, she openly challenged 19th century notions of reform and illness. Additionally, Dix helped recruit nurses for the Union army during the Civil War. As a result, she transformed the field of nursing.



about her childhood. She moved to Boston to stay with her grandmother. Dix attended school in Boston and tutored children.

She became ill several times and was forced to stop teaching. During one of her bouts of illness her physician suggested she spend time in Europe. While visiting overseas, Dix met with groups of reformers interested in changing the way the mentally ill were cared for. Once Dix returned to the United States, she set out to tour mental hospitals across the country. Dix pushed states to care for the unfortunate. She eventually established asylums in New Jersey, North Carolina, and Illinois. She worked to pass federal legislation that would create a national asylum, though the bill did not pass. Dix also toured overseas, reporting on the conditions of hospitals in various countries.

When the Civil War started, Dix completely dedicated herself to the Union cause. She was designated as the Superintendent of Army Nurses for the Union Army. Although many believed she set impossibly high standards for recruited nurses, the army of nurses was extremely successful and crucial in advancing the role of nurses in the war and in the medical field. Dix was also known for treating both Confederate and Union soldiers, a practice which gained her respect from many.

During a period when male doctors openly expressed disdain for female nurses, Dix continued to push for formal training and more opportunities for women nurses. Over the course of the war she appointed more than 3,000, or about 15%, of Union Army nurses. She stepped down from the position in 1865.

After the war, Dix raised funds for the building of a national monument to honor deceased soldiers, which stands at Fort Monroe, Virginia today. She continued fighting for social reform throughout her life. Her work in support of better care for the mentally ill culminated in the restructuring of many hospitals both in the United States and abroad. After suffering from illness, Dix returned to New Jersey where she spent the remainder of her life. She died on July 17, 1887 and is buried in Cambridge, Massachusetts.



Saint Ceallach

In the face of stern opposition, most from within his own family, Ceallach administered Armagh, whose diocesan boundaries were laid down at this time. As a metropolitan province, Armagh was given twelve suffragan dioceses. Dublin at this stage had a strong

Norse population and was more linked with Canterbury. In 1121, after Bishop Samuel Ó h-Ainglí died, Ceallach went to Dublin as the new bishop.



returned to Armagh in 1122, saw that Malachy had sterling qualities suitable in a bishop. He sent him first to Lismore where he could have contact with Benedictine influences from England and the continent. Ceallach continued to administer Armagh. Columbia University Agrees to Trump Administration Demands

Columbia University saw the light and the lure of money and gave into the demands of the Trump administration, agreeing to policy changes, including a mask ban and allowing campus police to make arrests, after the federal government pulled \$400 million in funding over how the Ivy League school handled antisemitism. The campus, which had become the poster child for violent anti-Israel protests, will review curriculum for its Middle East, South Asian and African studies departments and Center for Palestine Studies and install a new provost to oversee it.


Administration will now allow campus police to arrest students or remove them from campus when found appropriate. The university's interim president, Katrina Armstrong, suggested the changes are a progression toward making the campus a safer place for all students, but neglected to mention it's Jewish student body. "We teach the brightest, most creative students in the world and we care deeply for each and every one of them. We stand resilient and brilliant."

The Trump administration pulled approximately \$400 million in grants and contracts from the Ivy league institution earlier this month for its failure to pushback on antisemitism throughout the campus and threatened to hold back even more. The newly announced steps to be taken by the university include banning unnecessary masks for students and requiring protestors and demonstrators to identify themselves when asked or face disciplinary action, as well as suspending, expelling or temporarily revoking the

degrees of the students who stormed Hamilton Hall in April 2024. "Meaningful discipline means expulsion or multi-year suspension," the Trump administration demanded. The Ivy university also announced they are reviewing their admission policies to ensure all standards are unbiased, noting a recent drop in both Jewish and African American enrollment.

The university considered legal options in fighting the Trump administration but decided it would be an uphill battle. "Since October 7, 2023, Jewish students have faced relentless violence, intimidation,

and anti-Semitic harassment on the campus, only to be ignored by those who were supposed to protect them. Universities must comply with all federal antidiscrimination laws if they are going to receive federal funding. For too long, Columbia has abandoned its obligation to Jewish students studying on its campus. Today we demonstrate to Columbia and other universities that we will not tolerate their appalling inaction any longer," stated Linda McMahon, Secretary of Education when she announced the federal funds would be frozen.





CHARLIE MINGUS – IN ARGENTINA: THE BUENOS AIRES CONCERTS (2CD) Resonance Records

Charles Mingus' thrilling, littleheard 1977 quintet finally gets its due on the revelatory *In Argentina: The Buenos Aires Concerts*. The collection, which succeeds Resonance's first Mingus release *The Lost Album from Ronnie Scott*'s (2022), will be issued as a two-CD set on April 18th.



Like its predecessor, it is being released with the full cooperation and authorization of the Jazz Workshop, Inc. and the Charles Mingus Estate. Recorded in concert at the Teatro Coliseo and the Teatro Sociedad Hebraica Argentina on June 2-3, 1977, In Argentina affords a revealing look at the great composer-bassist's little-documented working band of the era. He is joined by trumpeter Jack Walrath, a veteran of the storied "Changes band" of the mid-'70s that included tenor saxophonist George Adams and pianist Don Pullen; their gifted successors, tenorist Ricky Ford and pianist Robert Neloms; and the leader's long-tenured drummer Dannie Richmond. The shows took place only six months before Mingus was diagnosed with amyotrophic lateral sclerosis (ALS, or Lou Gehrig's disease), which claimed him on January 5, 1979. Exhorted vocally by Mingus, the spirited combo bracingly essayed material ranging from classic compositions like "Goodbye Pork Pie Hat" and "Fables of Faubus" to such expansive latterday compositions as "Duke Ellington's Sound of Love," "Three or Four Shades of Blue," and the aptly Latin-infused "Cumbia and Jazz Fusion." Mingus also stepped to the piano for a pair of short solo performances. Additional tracks include: "Noddin' Yo Head Blues," "Koka/Cherokee," "For Harry Carney," "Sue's Changes," and "Koka/Cherokee/Band Intros."

FREDDIE HUBBARD – LIVE FROM THE BLUE MOROCCO -(2CD) Resonance Records

Trumpet master Freddie Hubbard is heard at the apex of his early brilliance in the newly unearthed collection *On Fire: Live from the Blue Morocco*, released by Resonance Records. Remastered from the original tapes by Matthew Lutthans, the previously unreleased set was captured by recording engineer Bernard



Drayton in 1967 at the Blue Morocco, a jazz spot located in the New York borough of the Bronx and operated by Sylvia Robinson, later a co-founder of Sugar Hill Records. The collection was produced with the full endorsement of the trumpeter's son and estate representative Duane Hubbard. Hubbard's work with Art Blakey & the Jazz Messengers, his appearances on historic recordings by John Coltrane and Ornette Coleman, and his own brilliant recordings as a leader for Blue Note and Impulse! Records led contemporary observers to hail him as the masterful successor to the late Clifford Brown. He is heard on the new release playing a storming set of his own compositions and a pair of smartly arranged standards. Hubbard is backed by his working group of the day, a skilled unit, which included saxophonist Bennie Maupin, pianist Kenny Barron, bassist Herbie Lewis, and drummer Freddie Waits. Contained are seven, tasty tracks: "Crisis," "Up Jumped Spring," "Echoes of Blue," True Colors/Breaking Point," "Bye Bye Blackbird," "Summertime," and "Breaking Point." The package — will be issued as a two-CD set on April 18th — is co-produced by Bernard Drayton, his celebrated son and drummer Charley Drayton, and Zev Feldman, the award-winning "Jazz Detective" and co-president of Resonance Records. It includes an introductory essay by jazz scholar John Koenig; new interviews by Feldman with Maupin and Barron; and interviews and appreciations by trumpeters Charles Tolliver, Eddie Henderson, Steven Bernstein, and Jeremy Pelt; and more.

KENNY DORHAM - BLUE BOSSA IN THE BRONX: LIVE FROM THE BLUE MOROCCO (CD) Resonance Records

Resonance Records will release Blue Bossa in the Bronx: Live from the Blue Morocco, a never-beforeheard live performance from master hard bop trumpeter Kenny Dorham, as a two-LP set. The storming allstar club date will be issued as a deluxe CD on April 18th. Included



are notes by two-time Grammy winner Bob Blumenthal and more. Bernard Drayton recorded the collection in 1967 at the titular New York venue, a local bar at Boston Road and 168th Street that was operated by Sylvia Robinson. Blue Bossa in the Bronx features a hard-hitting band comprising alto saxophonist Sonny Red, pianist Cedar Walton, bassist Paul Chambers, and drummer Denis Charles. It leads off with Dorham's best-known composition, "Blue Bossa." The remaining six creative cuts on this outstanding collection shines via: "Confirmation," "Memories of You," "My One And Only Love," "Bag's Groove," "Blue Friday," and the finale "The Theme." The repertoire also includes an untitled blues by Dorham, numbers originated by Charlie Parker, Milt Jackson, and Miles Davis, and the standards "Memories of You" and "My One and Only Love."

A Nostalgic Remembrance



A while ago, I was talking about my problems when I started working at the Seville Theater. I had told the management that I was sixteen years old and they believed me because I looked older than my age. When I started, I was on the bottom of the food chain. I inherited the shifts that no one else wanted. After working for two weeks, Mr. Wall, the assistant manager, asked if I would be interested in doing some maintenance work. As an usher, I would earn the minimum wage, fifty-five cents per hour. Doing maintenance, I would earn \$1.00 an hour, and I agreed. When I told Babbononno, he didn't know what kind of maintenance work I would be doing and gave me a pair of work gloves to use to avoid splinters in my hands. I didn't want to burst his bubble by telling him that I wouldn't be handling any lumber, but that was his point of reference and he was proud of his grandson, so I took the gift and kept my mouth shut.

At the end of the first week of ushering and doing maintenance, I received two pay envelopes, one with my usher's pay and the other for the other work which consisted of helping to repair theater seats, painting the floor of the balcony and running a few errands. When I looked inside the corresponding pay envelope, there were just two dollars waiting for me. I questioned Mr. Wall the assistant manager and he told me that he didn't think my work was that good and the two dollars was all that it was worth. I wasn't happy and told Dad and Babbononno. Dad was ready to intervene, but I told him that I wanted to handle it. I knew that the head of maintenance had the ear of the assistant manager and I mentioned to him what I found in my pay envelope. He just shrugged. I also told his that my father was going to have the family attorney look into the matter and walked away. The next day I was working a shift in my usher's uniform and was called into the office by Mr. Wall. He stared at me for a few seconds without saying anything and then handed me an envelope. I opened it and the rest of the money that was owed to me was there. He then said, "I guess you're not one of those people just off the boat." At that point, I knew exactly where he was coming from. I thanked him for the remainder of what was owed me and began to walk out of the office, and as I did, he smiled saying, "Hey kid, you're not so dumb."

When I arrived home, I told Dad and Babbononno just what happened and they just smiled. Dad said something I didn't get at first, "Justice is sometimes its own reward.'

What I also didn't know was that Dad and Mr. Ray, the manager, knew each other from years back. Mr. Ray was well known in society circles and Dad played with bands that catered to the society crowd, hence the relationship. Word had gotten back to Mr. Ray about the pay situation and I think he exercised his authority regarding the scenario.

Well, I labored under the gun of Mr. Wall from then on. He didn't make it easy for me, but Mr. Ray did. He was what Dad called, "Very Yankee." He sometimes was abrupt, and always formal or semi formal in his approach to me. Years later when I was a young adult, Mr. Ray would tell me to call him, Jim, when we went out to dinner or when he joined me and my musician friends after work at Ken's in Copley Square late at night. However, I could never bring myself to call him anything but, Mr. Ray. Behind his back, some of the long-time ushers referred to him as Papa, but face to face, it was always, Mr. Ray.

I survived the summer of 1952. That fall, I began my tenure as a student at Boston English High School. Mr. Wall approached me again regarding my working papers, a situation which seemed to slip my mind every time it was brought up. It got to a point where Mr. Wall became exasperated and threatened to fire me if I didn't obtain them. I thought my career as an usher was over because I was only 14 years old by late October, still two years younger than the minimum age to obtain work documents. Then, one day, I headed for work and all traces of Mr. Wall were gone. I asked Mr. Ray where he was and was told that he was transferred to another theater. I didn't say I was glad, but I was happy about the situation. Then I thought about it, "Sometimes, the enemy you know is better than the enemy you don't know." So, I asked Mr. Ray who was going to take his place and I was told that the company was doing away with the position of assistant manager, and he, Mr. Ray, would be running things by himself.

As time went on, I worked my way up the ladder. I would give Mr. Ray excuses when- ever he mentioned working papers and thought I was conning the man. When I turned sixteen

and actually obtained them, I discovered that Mr. Ray knew how old I was all along. He just let things slide.

Ushers and candy girls came and went over time. When I was sixteen, Mr. Ray called me and one of the candy girls into the office one evening. He told us in his abrupt way that he had caught both ushers and candy girls stealing goods and money from the candy concession, and had fired them. Theresa, the candy girl and I just stared at each other. Mr. Ray then added, "I discovered that you two were not involved," and pointing to each of us added, "You are now head candy girl, and you are now head usher. Go out and hire new crews to work for you, go-go, I'm busy." With that, I became the head usher, a position I would maintain through high school, college and beyond.

I hired a new crew of ushers including a fellow English High student named Henry Giggi. I have lost touch with him over the years, but we were pals back then, and when I made out the schedule, I made sure we worked the same shifts. Some of the young men I hired didn't last long. Mr. Ray either liked you or took an immediate dislike to you. I never asked him his rationale for those reactions, but for those he didn't like, he would find an excuse to get rid of them and make me do the dirty work of letting them go.

A few years ago, I received a phone call from a woman who identified herself as a replacement ticket seller. I remembered her and we had a conversation that almost had me in tears. She told me that she and Mr. Ray had become romantically involved. He was an older bachelor whom I looked up to. I saw the refinement in his manner and copied his method of dress, suit, shirt, tie ... fashionable, never flashy, but always dignified. The woman added that I was the son Mr. Ray never had. He presented me with gifts when I graduated from high school and college, but I thought this was something he did with all his employees. She added that he was as proud of me as was my father when I began my college career and just as proud when I graduated. I did reach a point in my early 20s when something had to go, and I quit working at the Seville, ten years after I had started. The time spent in an ushers uniform was some of the most memorable in my young life and I will never forget those experiences. GOD BLESS AMERICA

In every Italian home, Easter is a time to honor tradition and savor the richness of nature's offerings. Freshly gathered eggs, fragrant citrus, homemade ricotta, and candied citron and orange peels all find their way into festive recipes that embody heritage, resilience, and the joy of the season!

HOMEMADE RICOTTA and CANDIED ORANGE PEELS



Ricotta:

1-gallon whole milk (not ultra-pasteurized)

1-quart heavy cream

1 tablespoon salt 1 tablespoon sugar

½ cup white vinegar or freshly squeezed lemon juice

Cheesecloth Fine mesh strainer

Slotted spoon

In a large saucepan, combine the whole milk, heavy cream, salt, and sugar. Whisk to blend. Cook the mixture over low to medium heat, stirring occasionally, until it begins to boil. Once it reaches a boil, reduce the heat and continue to stir for about 2 minutes. Remove the saucepan from the heat and add the vinegar or lemon juice. Stir slowly for a minute or two until the ricotta starts to separate. Let the mixture stand for 10 to 15 minutes, allowing the curds to form and the whey to separate.

Line a fine mesh strainer with a double layer of cheesecloth and place it over a bowl.

Use a slotted spoon to carefully transfer the ricotta mixture into the strainer, allowing it to drain. Since the ricotta is homemade and preservative-free, it should be used within 2 to 3 days.

Candied Orange Peels

4 to 6 organic oranges

Granulated sugar (equal weight to orange peels) Water

Cut the oranges into quarters and carefully peel away the skin. Use the back of a spoon to scrape off the white pith from the skin. Slice the orange skin into strips, then cut them into small squares or your preferred shape.

Place the orange peel strips into a medium saucepan. Fill the pan with water to cover the peels and bring to a boil. Let it cook for 10 to 15 minutes.

Drain the peels and rinse them with cold water. Refill the saucepan with fresh water and repeat the boiling process two more times.

Once the peels are drained after the third rinse, weigh them to determine their weight. Measure an equal amount of water and sugar based on the weight of the peels. In the same saucepan, combine the measured water and sugar over medium-low heat. Stir until the sugar is completely dissolved.

Add the drained peels to the syrup and cook, stirring occasionally, until the syrup begins to thicken. This should take about 20 minutes.

When the syrup has thickened, carefully remove the peels from the syrup and place them on a baker's drying rack or a baking sheet lined with parchment paper.

Let the peels dry at room temperature for several hours or

Once dry, you can either store them in the remaining sugar syrup or keep them as-is in a glass jar in the refrigerator for up to a few weeks.

World Champion Boston Celtics Sold for Record Breaking Amount

The eighteen-time World Championship Boston Celtics will be under new ownership at the end of the current season. The new ownership group, headed by Georgetown, Massachusetts native and life-long Celtics fan, William Chisolm, reached an agreement last week to purchase the team for a record price of \$6.1 billion dollars, making it the highest price ever paid for an American professional sports franchise.

"Growing up on the North Shore, and attending college in New England, I have been a die-hard Celtics fan my entire life. I understand how important the Celtics are to the City of Boston. I also understand that there is a responsibility as a leader of the organization to the people of Boston, and I am up for this challenge," Chisolm said in a statement regarding the sale.

Chisolm is the co-founder, managing partner and chief investment officer of Symphony Technology Group, a California-based private equity firm. He previously co-founded the Valent Group, worked at Bain & Company and PaineWebber, Inc. The group also features Celtics minority owner Robertt Hale, Related Companies president Bruce A. Beal, Jr. and global investment firm Sixth Street.

If this purchase is confirmed, pending a review by the NBA Board of Governors, in late June or early July, Chisolm will take over a franchise that has won 18 NBA championships, the most recent last summer, and is in contention for a 19th this season. It also comes with the most expensive roster in NBA history in the 2025-2026 season, hitting almost

\$500 million dollars in salary and

luxury tax penalties.

Chisolm's bid beat out long time Celtics coowner and managing partner Steve Pagliuca, who was part of the group that bought the Celtics for \$360 million in 2002. "I made a fully guaranteed and financed offer at a record price befitting the best sports fans in the world, and with all the capital coming from individuals who are fully committed to winning on and off the court. We had no debt or private equity money that would potentially hamstring our ability to compete in the future. We felt it was the best offer for the Celtics. It was a bid of true fans, deeply connected to Boston's community, and was saddened to see it rejected," said Pagliuca.

Grow, Harvest, and Enjoy All Parts of Cilantro

Growing cilantro is easy, but this cool-weather herb quickly flowers and goes to seed as temperatures rise. This can be frustrating as some vegetables typically combined with cilantro, like tomatoes and peppers, ripen during the warmer summer months. Try making multiple plantings, using all parts of the plant, or growing more heattolerant options to extend your

Sow seeds every three to four weeks throughout the summer for continual harvests if your summers are relatively cool. Gardeners in hotter regions will have the best results growing cilantro in spring, fall, and even winter when temperatures are cooler. Grow cilantro in full sun or light shade as temperatures climb and in moist, well-drained soil for best results.

Mulching the soil with leaves or evergreen needles helps keep the roots cool and moist, helping delay flowering. Avoid overwatering, which can lead to root rot.

Cilantro grows quickly, and its leaves can be harvested when the plants are four to six inches tall. Harvest as needed and as much as a third of the plant at one time to allow it to keep producing. Or cut the whole plant back to an inch above the ground and wait for it to regrow. Cilantro should be harvested often to encourage new growth and before the plants flower for the best flavor.

Store freshly cut leaves like a bouquet in a glass of fresh water. Place in the refrigerator to use for the upcoming week. Hang leaves upside down to dry or freeze. Just wash the leaves, pat dry, and place them in a freezer bag or air-tight container in the freezer. Or chop up the rinsed cilantro into smaller pieces, place in ice cube trays, and top with a splash of water before placing in the freezer.

Don't be surprised as temperatures rise, the plant will flower and set seed. Look at this as an opportunity to utilize the other parts of this plant. Enjoy the beauty and flavor of the

lacy white flowers that attract beneficial insects to the garden.

Seeds will appear after the flowers fade. Wait for the plants and seeds to turn brown if you plan to harvest and use the seeds, known as coriander. Cut off the seed heads, place them in a paper bag, and allow the seeds to drop to the bottom. The seeds are ground and used in breads, cakes, pickling spices, and Asian food. Store in sealed containers until ready to use.

You can also let the plant selfseed. Allow the seeds to drop to the ground in the garden and grow new cilantro plants to harvest and enjoy. Cilantro seeds sprout readily when soil temperatures are 55 to 68° F and the plants can withstand a light frost.

Don't forget to harvest the roots. These have a strong peppery, citrus spicy flavor, so are often used for seasoning Thai and Vietnamese food. They taste best when harvested in the fall.

Extend the season by growing more heat-tolerant varieties that are slower to develop flowers and seeds like Slo-Bolt, Longstanding, Cruiser, and Santo. Papalo, also known as summer cilantro, has a similar but stronger flavor than cilantro with a hint of citrus and mint and thrives in hot weather. You will only need one or two plants since this annual grows up to five feet tall and several feet wide. Harvest young leaves for the best flavor and use only 1/2or 1/3 the amount of cilantro called for in recipes.

Extend your cilantro harvest and enjoyment by utilizing every part of the plant. Adjust your cilantro growing techniques and plant selection to help beat the heat.





PLAYING ON BUT NOT PLAYING IN — Put down National Hockey League Commissioner Gary Bettman as not being a big booster when it comes to considering whether or not to institute a play-in event to determine the teams that claim the wild card slots for the Stanley Cup Playoffs.

The NBA instituted play-in games to determine the teams for wild card slots back in 2020 with teams that finish seventh through tenth in each conference playing games to determine who gets the two remaining berths in both the East and West respectively.

Bettman does not want to see that format introduced into the NHL, saying that a number of teams as of mid-March were already engaged in what amounted to a free for all playin competition for the final playoff spots.

"I'm pretty dug in on this," said Bettman at the recent NHL general managers meetings in Florida. "I like exactly what we have and if you look at the races we are having for the regular season, the playoffs have started already. We are in our play-in tournament."

He noted that 'the best team to win the Cup has to go through the best teams. And having great matchups in the first rounds, that is a great thing." That was in reference to the fact that each division winner gets to play a wild card team while the teams that finish second and third face each other, meaning one highly ranked team in each conference will be eliminated in the first round.

That may increase interest for the NHL which usually has lower TV ratings than the NBA. If some of the better teams play each other early, it is obvious that some will not advance. However, interest may be higher, thus boosting ratings for the tournament as a whole.

SWITCHING SEASONS FOR ALL THE WRONG REASONS

— As the NHL entered the last week of March there was still a believer — a lone entity that still held out the possibility that the Bruins — in some twisted mathematical way — could still qualify for the upcoming 2025 Stanley Cup Tournament.

It should be stated that the aforementioned entity was not human — but rather a computer residing in isolation somewhere in the headquarters of the NHL in New York City.

Any individual with a human brain knew by then that the postseason possibilities on the part of the B's were essentially dead. Just to prove that fact the Bruins entered the last full week of March dragging with them a six-game losing streak.

So what have we left in the final weeks of the regular season before the Bruins pack up for an elongated summer off the ice?

We have essentially imported the start of the September preseason into those closing weeks. It is now that players will be evaluated with the coaching staff and the front office paying close attention as they determine who they feel will be retained to help the team next year. There also could also be a prolonged evaluation of players on the Providence roster before on ice activity shuts down in Boston.

All of this points to a summer of major activity in the Hub as undoubtedly significant decisions will be made concerning who will be offered contracts, who will be released, who will be acquired in trades as well as what players in free agency around the league will be considered. The list is extensive and the summer will be lengthy.

It is hard to believe that this is a franchise that just two years ago set the all-time NHL records for victories amassed and points accumulated during the regular season.

But ironically, both that excellent year and this particularly disappointing one do share a commonality. Neither team wound up playing in May. This year, the B's will play their last game on April 15th when they face the New Jersey Devils at the Garden.

Back in 2023, the B's were eliminated by the Florida Panthers in the first round of the Stanley Cup when the Panthers scored the winning goal in overtime in the series-deciding seventh game. The date of that fateful elimination was April 30.

O FOR CRYING OUT LOUD, UCONN COULDN'T CONQUER

— There he was, with tears welling up around his countenance as he sobbed his way through a post-game national television interview with a CBS reporter.

Yes, that was Dan Hurley, the head coach of the UConn men's basketball team, the two-time defending national champions, who had just been defeated by Florida, a top seeded quintet that came from behind to take out the eighth seeded Huskies in the closing minutes of the second round March Madness game.

It is certainly hard to feel sorry for a coach who possesses a multi-year contract worth some \$30 million and has already won back-to-back national championships.

Trying for a "three-peat," his team wound up getting beat, thereby not accomplishing the feat.

And he did not take it lightly. Coming off the court into a tunnel, he could be heard swearing and blaming the officials for the setback, rather than the shortcomings of his own team on that particular day.

The score was close at 77-75, meaning the Gators moved on while the Huskies headed home to Storrs. But there were multiple opportunities along the way for a different outcome.

If, at any point during the game, UConn had made an additional three-pointer that would have provided a one-point final margin of victory. Making a two-pointer along the way would have resulted in a tie at the end of regulation, sending the game into overtime.

It isn't just the final moments of a game that decide the outcome. It is the entire game that should be taken into account.
