# Stirpe Nostra

ANTONINUS PIUS



Temple of Antoninus and Faustina

Titus Aurelius Fulvus Boionius Antoninus was born on an estate at Lanuvium in 86 A.D. He spent his childhood in Etruria, which now comprises Tuscany and a part of Umbria. After the death of his father, he was brought up under the care of his maternal grandfather, a man of integrity and culture. As a youth, he was handsome, aristocratic in bearing, generous, considerate of others, a brilliant scholar and a gifted speaker. Prior to becoming emperor, he held the positions of *quaestor* (treasury official), *praetor* (magistrate), and *consul* (one of the two highest magistrates). He also served as one of the four consuls for Italy and later as proconsul for Asia. In all of these official labors, he showed himself to be a man of compassion, dignity, and integrity.

He was adopted as son and successor to Hadrian in 138 A.D. A few months later when Hadrian died, Antoninus was enthusiastically welcomed to the throne by the Roman

people and he certainly didn't disappoint them. He entered his new office as emperor of the Roman world with simple tastes, a kindly disposition, extensive experience, a well-trained intelligence, and the sincerest desire for the welfare of his subjects.

Instead of the purge and plunder that was characteristic of so many of the *imperators*, Antoninus returned all of Hadrian's appointees to office. He used his private funds to provide relief for distressed provinces and cities, and also enforced rigid economy everywhere. He turned enemies into friends through his clemency and extended the friendly hand of protection to Christians throughout the empire. His successful effort in getting a reluctant Senate to grant divine honors to Hadrian gained him the title of *Pius* (dutiful in affection).

He is credited with the construction of mausoleums, theaters, temples; encouraging the arts and sciences; bestowing

honors and providing salaries for teachers of philosophy and rhetoric; building the wall of Antoninus in Britain; and, in general, conducting a relatively peaceful reign. We are told that he was one of the best emperors that ever ascended the throne of the Roman Empire, dedicating all of his energies and thoughts toward the happiness of his people.

Antoninus was not fortunate in his domestic relations. He was married to Faustina, who was noted for her lack of womanly virtue. He fathered two sons and two daughters. Both boys and one of the girls died before he ascended the throne. The surviving daughter, Annia Faustina, eventually became the wife of Marcus Aurelius. Following the death of his wife, Pius honored her memory by founding a charity for orphan girls. He also had her deified and erected a temple to her memory in the *Forum Romanum*, parts of which are still standing today. The exterior columns are one-piece, 50 feet high, and were made from the costly *cipollino* marble. It was one of the most remarkable buildings in the Forum. After his death, twenty years later, the Senate added his name on the inscription and dedicated the temple to his worship as well. Since that time, it has been called "The Temple of Antoninus and Faustina." During the twelfth century, the temple's interior was converted into the church of San Lorenzo in Miranda, and a facade was added in 1602.

One more of those ironies of fate tells us that when Antoninus was close to death, a tribune of the night-watch came by and asked for the password. The emperor uttered "Aequanimitas" and then expired. *Aequanimitas* in Latin means calmness, patience, kindness, or impartiality.

St. Gregory of Narek

Little is known of Gregory's life. He was born in 950 in a village on the southern shore of Lake Van in what is now Turkey. In the year 950, Gregory and his elder brother Hovhannes were sent to the monastery of Narek in Turkey.

At the monastery, Gregory was given a religious education by Ananias of Narek who was his maternal great-uncle, a celebrated scholar and the monastery's founder. Being raised in an intellectual and religious fervor, Gregory was ordained a priest in 977 and taught others theology at the monastery school until his death.

As an Armenian monk, Gregory lived humbly and taught at the monastic school. He wrote his prayers in the *encyclopedia of prayer for all nations* in hopes the book would one day guide people of all stations around the world to prayer.

He was a leader of the well-developed school of Armenian mysticism at the Monastery and was asked to answer the question, "What can one offer to God, our creator, who already has everything and knows everything better than we could ever express it?"

In his *Book of Prayer*, also called the *Book of Lamentations* or the *Song of Songs*, Gregory

wrote that the answer to the question is "the sighs of the heart." The book contains 91 prayers and was completed one year before he died. He passed away in the year 1005.

Several miracles and traditions have been traced back to Gregory and he is known as "the watchful angel in human form."

Gregory of Narek was venerated as a saint by the Armenian Catholic Church and is also recognized as a saint of the Roman Catholic church. On April 12, 2015, Pope Francis officially proclaimed Gregory of Narek as a Doctor of the Church.

The Feast day of Saint Gregory of Narek is February 27.

## Springing into Nature

Around this time of year, I feel a sense of energy bubbling up inside me. All of the cabin fever and restless excitement over a new spring evaporates into the warm air, a surge of joy and release as refreshing as an afternoon rain shower. As the temperatures hit ever-higher degrees, I can practically smell the summer in the air, the promise of barbecues and ocean waves and ice-cold glasses of lemonade. When class is dismissed at the school where I teach and students run out into the luminous day, their unbridled happiness is contagious as they scamper across the bright green, sun-soaked grass. Indeed, the month of May as a whole calls for outdoor excursions. Traditionally the beginning of summer, May heralds warmer temperatures and an explosion of tender leaves on trees. It is definitely not a month to stay cooped up indoors, but rather one to venture outside and revel in all the delights nature has to offer. From Italian traditions to nature-based holidays, the call of the wild proves most exciting in May.

In Italy, one of the most beloved traditions is called *la passeggiata*, or evening stroll. After dinner, Italian families and friends meander through city streets or rural lanes, enjoying the outdoor experience and each other’s company. In urban areas, *la passeggiata* may involve stopping for some delicious, creamy gelato, casual window shopping, or sitting and chatting along the rim of one of Italy’s many beautiful fountains. People in the countryside may rest in the shade of trees, pick fruit, or pack a small picnic of sweets and wine. In

an age where too many people are tempted to watch television right after dinner, I love the idea of a tradition that encourages people to step outside and partake in the universal and time-honored pleasures of fresh air, loved ones, and the nourishment of food and drink. I fondly remember my evening *passeggiate* from when I visited Italy several years ago: the walks through bustling city centers, where the late-day sun turned ancient ruins to the color of gold, and the hikes along dirt roads in my dad’s home region of Abruzzo, watching the dusky sky darken the mountains. My husband loves to go outside and walk, so often I will try to recreate *la passeggiata* here at home. As I walk around my neighborhood in this balmy month of May, I pay special attention to the life all around me: jubilant children kicking a soccer ball, robins hopping among blades of grass, the sun peeking through branches laden with delicate pink flowers.

May brims with a number of special holidays that encourage such outdoor excursions. The month begins with May Day, an ancient holiday celebrating the start of summer. It is also a holiday honoring flowers and trees, which are their most beautiful now. Mother’s Day, which occurred on the 14<sup>th</sup> of the month this year, not only allows us to express gratitude for the wonderful things mothers do for us but also prompts us to enjoy their company. On Mother’s Day, my family and I often go out for ice cream, an activity all the more special because of its simplicity and its unencumbered focus on loved ones, food, and the warm sun. Soon, it will

be Memorial Day, and countless families will fire up the grill and eat summer produce outdoors. Others will flock to the beach or the mountains — any outdoor place will do, as Memorial Day weekend is considered the unofficial start of summer! Earlier, however, this May will have hosted another summer holiday, Ascension Day, known as *la Festa dell’Ascensione* in Italian. Falling forty days after Easter, this holiday commemorates Jesus’s ascent into Heaven. Italians celebrate it with outdoor excursions and picnics, as typical for the holidays of May. Another feast known as *la Pasqua Rossa*, or Pentecost, falls fifty days after Easter and honors the descent of the Holy Spirit upon Jesus’s disciples. Italian churches often scatter rose petals during the services to symbolize the Holy Spirit, incorporating a lovely outdoor symbol of summer.

This month, be sure to spend an abundant amount of time enjoying nature. The warm days, the sunlight that lasts into the late hours of the evening, the succulent fruits of summer — these are all the pleasures Mother Earth has to offer this time of the year. It is also important to remember that what makes these delights so special is the fact that they are fleeting, since the year is a cycle always in motion, so relish May while you can! Whether you choose to take a *passeggiata* in the golden hours of dusk, or whether you opt for a picnic on Memorial Day weekend, or whether you simply agree to meet a friend for ice cream or a quick bike ride, strive to appreciate all that nature has to offer. May will come to a close before we know it, but her beautiful experiences are available right now, ready for our fulfillment.

## Travelling Down Old South End Streets Filled with Memories of Old

This past Saturday afternoon, I traveled over to the streets of my youth as I headed to the brand new Roxbury Branch Public Library. This place is amazing, a sight to behold. First glance, it seemed as cavernous as the old Dudley Station back in the day.

My life really started over on the other side of this city of neighborhoods. Today, I am here in East Boston and when I am not here, I’m over in Charlestown where I developed all community activism and being politically active, if you can pass the Charlestown Politics 101 reality course, you can do politics anywhere.

Getting back to this week’s subject matter. Alison Barnett is one of the best South End writers who ever lived on East Springfield Street. I can’t really remember where Alison and I met up, I think it was through mutual friends of ours. Alison has called East Springfield Street her “home” since 1964. Prior to her arrival on “my”

street where I spent much of my younger life living on East Springfield Street often from my 1950 to 1964 period of life. If you stop and think about it, between 1950 to the present, a writer has lived on this street running between Harrison Avenue to Washington Street. Not bad for one little street, huh?

Both of us are still active writers who know Boston quite well. She still writes newspaper opinion pieces but is also an author of five books on the South End.. Her latest entitled *South End Incident - A True Story*, and like all her books, there is a Barnett-style to her writings. Easy to read, full of facts, and the necessary humor to go along with all her stories.

Her book discussion was held up at the recently opened Roxbury Branch Library. The South End Library might have been more appropriate but that library was forced to shut down a while back and is currently waiting for a new neighborhood library to return there.

Her book’s title was taken from a 1968 rock song by the Beacon Street Union, a 60s Boston rock band that made fun of the neighborhood as perceived back then. In those old days to many outsiders the South End was thought to be a very scary neighborhood to travel as opposed to today with much of the neighborhood becoming gentrified. No longer seedy, but now a well sought after sort -of -expensive neighborhood.

As someone who lived in this neighborhood, which was also connected to my lower Roxbury neighborhood across Massachusetts Avenue. Another urban neighborhood seeing a resurgence like its South End partnering neighborhood. I could tell you stories about Lower Roxbury or as we called it “St. Philip’s Parish.”

Last Saturday’s book discussion was well-attended crowd of current and former residents of the neighborhood. I caught up with some old friends and made several new friends, too.

A COLUMN OF PAST AND CURRENT EVENTS

Irving Berlin

— Berlin was born Israel Beilin] on May 11, 1888, in Tyumen, Siberia, Russian Empire. He was one of eight children of Moses and Lena Lipkin Beilin. His father was an itinerant Cantor.

From Tyumen, the family returned to Tolochin, and from there, they travelled to Antwerp and left the old continent aboard the SS *Rhynland* from the Red Star Line. On September 14, 1893, the family arrived at Ellis Island in New York City. After their arrival, the name "Beilin" was changed to "Baline."

The Berlins were one of hundreds of thousands of Jewish families who immigrated to the United States in the late 1800s and early 1900s, escaping discrimination, poverty, and brutal pogroms "Massacre of a particular ethnic group." Other such families included those of George and Ira Gershwin, Al Jolson, Sophie Tucker, Louis B. Mayer, and the Warner brothers.

When his father died, Berlin, just turned 13, took to the streets in various odd jobs, working as a busker "entertainer" singing for pennies, then as a singing waiter in a Chinatown Cafe. In 1907, he began writing song lyrics, and his first published song, "Marie from Sunny Italy," appeared in 1907. A printer's error on this song named him Irving Berlin, a surname he subsequently kept.

Berlin was to become an American composer who played a leading role in the evolution of the popular song from the early ragtime and jazz eras through the golden age of musicals. His easy mastery of a wide range of song styles, for both stage and motion pictures, made him perhaps the greatest and most enduring of American songwriters.

An intuitive business man, Irving Berlin was a co-founder of ASCAP (American Society of Composers, Authors and Publishers), founder of his own music publishing company, and with producer Sam Harris, builder of his own Broadway theatre, The Music Box. An unabashed patriot, his love for — and generosity to — his country is legendary, exemplified by his establishing The God Bless America Fund, which distributes income to the Boy Scouts and Girl Scouts.

Berlin passed away on September 22, 1989, at the age of 101, in his sleep in his townhouse in New York City. A widower since his wife of 62 years, the former Ellin Mackay, had died the previous year at the age of 85. Berlin was survived by three daughters and their families at the time of his death.

In this magical place, Kuhn sang into the same microphone as Frank Sinatra had once done and was backed by drummer Jeff Hamilton and bassist John Clayton, who were then working with Diana Krall. A busy sideman, who worked alongside the likes of Les McCann, Stan Getz and label mate Shelly Manne, Vinnegar was known for his “walking” bass lines (a signature move that gave him the nickname “The Walker”). While Vinnegar’s catalog as a leader is limited, his solo material stands as a testament to his talents. His 1958 debut offers plenty of plays on the bassist’s nickname, with the original “Walk On,” plus a handful of standards, including Julie Styne’s “I’ll Walk Alone” and Fred Ahlert’s “Walkin’ My Baby Back Home.” Additional cuts include: “Would You Like To Take A Walk,” “On The Sunny Side Of The Street,” “Walkin’,” and “Walkin’ By The River.” A pattern has the word ‘walk’ appearing in six of the seven tracks. Vinnegar is backed by Carl Perkins (piano), Victor Feldman (vibraphone), Teddy Edwards (tenor saxophone), Gerald Wilson (trumpet) and Tony Bazley (drums).

**ROBERTA GAMBARINI – EASY TO LOVE (2LPVinyl) IN+OUT Records**

This masterpiece is Roberta Gambarini’s debut album – for the first time on vinyl in a Limited Audiophile Signature Edition. # Nanna & Babbononno

A Nostalgic Remembrance



People have asked how and why I headed for college after I graduated from English High School. During my young life, Babbononno lectured me about following in his footsteps, making furniture by day and playing music at night. All of his sons, Uncles Paul, Nick, and Gino became musicians early on, but none of them was interested in working with wood. I was the only male grandchild until I was twelve, and Uncle Gino’s wife, Aunt Ninna, gave birth to twins (a boy and a girl) in 1950.

Beginning when I could hold a tool, Babbononno taught me how to make things out of wood. He also taught me the rudiments of music. I was more interested in making money and began washing and waxing cars throughout the Eagle Hill section of East Boston when I was about 10. One of the things that inspired me to work was that I never received an allowance from Dad. After the Sunday children’s Mass at the Sacred Heart, I would stop by Nanna and Babbononno’s, have something to eat and leave only after Babbononno gave me his version of an allowance, seventeen cents. At age 13, I lied about my age and became an usher at the Seville Theater. (You had to be 16 and I looked older than 13) Within a year, I sold my car cleaning business to one of the boys who worked for me and concentrated on two things, hanging out on a corner and working at the Seville.

Dad, beginning in my junior year at English, began lecturing me about the advantages of a college education, but his words fell upon deaf ears. I was trying to be a tough guy (which I wasn’t) who had a job. By the time I was 16, most of my street corner friends had quit school and were working at minimum wage jobs or were trying to get into one of the trades that required hard physical work. Toward the end of my junior year, several of my high school chums were taking standardized tests or entrance exams that might get them into college. I just plodded along, hanging out and ushering at the Seville.

My senior year arrived and I just barely squeaked by. If I was interested in a subject I did well, As and Bs. If I wasn’t interested, Cs were good enough. I wasn’t dumb, just immature. Seniors who had part-time jobs could leave school in the middle of May and not return until graduation, providing the employer signed a release document stating that said person could be working full time. The manager of the Seville Theater signed the papers I showed him, and I was done by May 15.

That night, I received a call from a close friend. His father was in the trades and made an inroad for us. My friend said that his father had jobs for us working in the construction trade. I was going to drive a tractor and my friend a bulldozer, and we were going to make \$15.00 an hour, great money back in the mid-50s.

We reported to the job site the next morning at dawn. My friend was handed a pick and I was handed a shovel ... so much for the tractor and the bulldozer. We worked all day as laborers, alongside many others without skills. I headed home at the end of the workday with my palms and fingers covered with blood blisters. I was in pain... my hands hurt and the muscles in my shoulders and back that had never or infrequently been used, were crying for help.

When I arrived home, Babbononno filled a basin with warm water and Epsom salts and told me to soak my hands. When Dad arrived home wearing a suit, dress shirt and tie, I showed him my hands and said, “Dad, you’re right, I want to go to college. He next opened Mom’s sewing kit, pulled out a needle, sterilized it, and pricked all of my blood blisters. Babbononno then loosely bandaged my hands telling me to remove the bandages once my wounds stopped oozing.

The next morning, Dad called a friend of his, the dean of Boston State College, now U. Mass Boston, and laid out the details of what was going on. When Dad hung up, he told me to report to the dean at 9:00 am on the next morning. And so, I showed up with a suit and tie, and two hands bandaged. The dean sat me down at a student chair in his office, handed me a three-hour entrance exam and told me to let his secretary know when I had finished. Two hours later, I let the secretary know that I had completed the exam and she put out an all-call for the dean. When he showed up, he didn’t say a word to me, just sat at his desk and read my answers. A half-hour later, he looked up and said, “Young

man, congratulations, you are now a college freshman at Boston State.”

In the middle of September, I walked through the portals of Boston State, and was asked which program I had signed up for. When I said, Industrial Arts Engineering, I was told to report to a room, be signed in, and fill out my schedule for the first semester of the 56-57 school year. There were 42 of us who were incoming freshmen. Four years later, there were only 21 of us walking across the stage to receive our diplomas. There was a 50% drop out by the end of the second year. The 21 of that graduated were destined to all head into teaching shop subjects in various school systems.

Right after I started college, I slowly began leaving my street corner pals. As time went on, we couldn’t identify with each other any longer. I stayed at the Seville Theater through 1962, but by then, I was teaching by day and playing music at night and some- thing had to go. So, the Seville became part of my youthful past.

I started teaching school in September of 1960 and didn’t retire until June of 2003. By 1964, I had a master’s degree, and by 1969, a second one. In 1981 I received a doctorate, and later, did post-doctoral research ... not bad for a kid from a street corner in East Boston.

I also had a great career in music, playing everything from symphony to soul. I even tried my hand at acting and did well with that too. Babbononno didn’t know anything about acting, but he was happy that I was a shop teacher by day and a musician by night. I kind of fulfilled his dreams for his first-born grandson.

A couple of times over the years, I stopped by my old street corner. There were a few of the same people still there. We reminisced, with them telling me that I got all the breaks, that everything went my way, that I had all the luck. I’ve often thought about what they said, and have come to the conclusion that they were wrong on all three accounts. What do you think?

If you like a hearty breakfast, the United States is the place for your morning meal. In this country, breakfasts can sometimes include more on a plate than dinner will. The menus vary among restaurants and diners, but most often they will include combination plates of fried, scrambled or omelet style eggs, served along with sausage, bacon, ham or steak with toast, muffins or bagels and even sides of pancakes, waffles or French toast. In Italy, Italians do not spend their mornings whisking eggs or frying bacon. In fact, they tend to like their breakfast light and sweet. *La calazione* in Italy is typically coffee, sweets, and carbs based. When eating out, a brioche or cornetto with a cappuccino or espresso is common. At home, most Italians eat cookies or biscotti. In fact, one of Italy’s biggest cookie brands claimed on its website “Italians eat more cookies than Americans, mainly because so many eat them for breakfast”!

As a young girl, I remember my Papa Francesco dunking his Sicilian Milk Biscuits in warm milk every morning for breakfast. Though these biscuits made a delicious breakfast treat, I preferred the “S” shaped cookies my Nonna made much better. Her recipe for “Sicilian “S” Cookies” I am sharing today are delicious if “dunked” or eaten plain. My Nonna’s “Sicilian “S” Cookies” are wonderful for breakfast, as a snack, or to serve to guests along with a warm or cold caffè latte!

NONNA’S SICILIAN “S” COOKIES  
*I Biscotti Siciliani Della Nonna*




- 1 cups sugar  
4 eggs  
¾ cup olive, vegetable, or seed oil  
1 organic lemon zested or  
1 tablespoon pure vanilla extract (flavor depends on your preference)  
4 cups all-purpose flour
- 1 packet Lievito Paneangeli (or 2 teaspoons baking powder)  
¼ teaspoon salt  
1 egg beaten with 2 tablespoons milk (egg wash)  
¼ cup raw sugar or white sugar (for sprinkling) \*the sugar can be omitted if you prefer them plain, just use the egg wash alone.

Preheat the oven to 375°. Line a baking sheet with parchment paper and set aside.

In a large mixing bowl, beat sugar and eggs together, add oil and lemon zest or vanilla, and mix together. Gradually sift in flour, Paneangeli, and salt; blend well. Let the dough rest for 20 minutes.

Using a small cookie scoop, take even amounts of dough and roll each into a log, shape logs into “S” shapes and place slightly apart on the prepared baking sheet. Beat together egg and milk, slightly flatten cookies, brush cookies with egg wash and sprinkle generously with sugar (the sugar can be omitted if you prefer them plain, use the egg wash alone). Bake for about 15-20 minutes or until medium golden brown.

Georges Méliès:

The Man Who Brought Cinema to the World

In 1898, two years after making his film debut, *Une partie de cartes*, Georges Méliès had already built himself up to the title of Father of Cinema. A decade later, his career was essentially dead. A lot happened in the interval, not the least of which was the evolution of film from a chronicler of enchantments before a camera to a narrative art and yet that development could not have come about without the vision of Méliès. With *A Trip to the Moon* in 1902, Méliès redefined visual story telling.

The plot of this and much of his later work was simple. In the case of *A Trip to the Moon*, a zany gang of astronomers take a rocket to the moon where they encounter moon people, tussles ensue, and they return to Earth with a captive specimen. But it was through Méliès that the full potential of the new medium was realized. In America Edison and his crew and even in France, Méliès's homeland, the Lumière brothers pioneered the technical aspects of, while Méliès nurtured it into an art.

From 1896 to 1913, Méliès made around 500 films through his Star Film Company, just over 200 of which survive today. Many, especially the earlier ones, were simply vehicles for bringing his magic acts of the stage to the screen, with gags reliant on special effects and illusions, though his eleven-part plea on behalf of Alfred Dreyfus in 1899 indicated where he was heading. But by 1902, he had evolved into a storyteller. *A Trip to the Moon* was the first of a series of elaborate fantasies such as *The Impossible Voyage* (1904), *An Adventurous Automobile Trip* (1905), *The Merry Frolics of Satan* (1906), and *Under the Seas* (1907).

His innovations were so captivating that he also inspired many unabashed impersonators in many places such as Spain and the United States.

In America, also, unauthorized prints of his films began to circulate, which led him to first open a branch of the Star Film Company in the States to better control distribution abroad.

In 1908, he included Star Film Company in Thomas Edison's trans-Atlantic Motion Pictures Patent Company which, besides Edison's studio and Star Film also included Biograph, Vitaphone, Kalem, and others. The following year Méliès became chairman of *Congrès International des éditeurs de films* of Paris with the focus on de-monopolizing film distribution. His efforts there were not wholly successful, and he returned to filmmaking dissatisfied before the year was done.

By now, however, the politics of cinema were different. Méliès succumbed to the increasingly business-like nature of the film industry and in 1910 signed into a contract with film studio Pathé Frères which gave its chair, Charles Pathé, the right not only to distribute but also to edit his films. Méliès's fantasies were becoming much more elaborate and, in many ways, his *The Conquest of the Pole* from 1912 is his best work. But the films struggled to recoup their production costs and Méliès ended his contract with Pathé Frères that year. He made a few more films but the death of his wife Eugénie in May of 1913 effectively ended his career.

But it was neither tragedy nor business that faded Méliès. Rather, by the time he returned to filmmaking in late 1909, cinema had moved on without him. New players were on the scene, most notably D.W. Griffith at

Biograph who took cinema to its next evolutionary step and in less than a decade was said, without hyperbole, to have invented Hollywood. If Méliès is the father of cinema Griffith created the movies as popular art with a language of their own.

Technically, artistically and even economically cinema was far removed from the playfully fantasies of Méliès by the end of the 1900s. It was now a business needing artists who spoke its new language.

Thus, the end of Méliès's career was abrupt. Griffith himself would decrease in relevancy even before the arrival of the talkies, but Méliès had faded into relative obscurity by his death in 1938. His rediscovery, however, was inevitable and among cinephiles and film scholars his role in the development of cinema cannot be overstated. No less an authority on film than Martin Scorsese would pay tribute to his genius with 2011's *Hugo*. Charlie Chaplin called him "the alchemist of light" and even the progress of D.W. Griffith would not have been possible without Méliès's pioneering. As Griffith himself said, "I owe him everything."

train and organs were harvested by doctors before authorities even notified family members that she had died, according to a lawsuit being filed by family members.

With the IQ of the boxing public at an all-time low, it is no wonder a great, and I mean GREAT, champion such as Joe Louis is not appreciated nearly as much as he used to be. Joe was a fighter with the moves and speed of a middleweight and the punch of a heavyweight. No opponent escaped when hurt by Joe as he was one of the best at finishing a fight once he had his foe staggered.

In rematches, Joe was also superb. Only three challengers for his title lasted the fifteen round distance. In rematches, two out of the three, Auturo Godoy and Jersey Joe Walcott were kayoed. The third, Tommy Farr, never fought Joe a second time, but there is little doubt he could have repeated the feat of lasting until the final bell. Joe

would certainly have stopped him as well.

In another rematch of fight that took place before he became champion, Joe avenged his only loss by utterly destroying Max Schmeling in the first round.

Some have criticized Joe's opposition, but the fact is he fought the best and avoided no one. He kayoed five former heavyweight champions, one future champ, as well as two light heavyweight champions. He defended the title for a record 25 times before retiring. He was at his peak when WWII interrupted his career but he came back and continued on as champion.

There is an old saying that it was easy in the 1930s and 1940s to remember things; FDR was always President and Joe Louis was always Heavyweight Champion.

In 1947, Ted Carroll wrote an article for *Ring Magazine* previewing Joe's upcoming fight with Jersey Joe Walcott. In it, he compares Louis with champions that preceded him. He believed one mark of a great champion was the willingness to take on all comers and to fight often. In this category, Joe was second to none. Carroll wrote:

"With all respect for their abilities, the records of heavyweight champions of the past, during their respective reigns, look puny alongside the Brown Bomber's.



Joe cuts down Giant Primo Carnera

"Louis has put his heavyweight title on the line no less than 23 times since winning it from **James J. Braddock** 10 years ago! He has defended his championship more times than Jess Willard, Jack Dempsey, Gene Tunney, Max Schmeling, Jack Sharkey, Primo Carnera, Max Baer, and James J. Braddock put together in a space of 22 years!"

And when you take into consideration that Louis kayoed five out the eight it really is astounding. Carroll wasn't aiming to disparage the former champs, he was just putting things into perspective.

May 13 was the anniversary of the birth of Joseph Louis Barrow. There is much, much more to be written about the Brown Bomber, but I'll leave you to ponder the above that was written by Ted Carroll 77 years ago. Unfortunately, Louis had to make a comeback due to financial reasons. Even the with his skills diminished he was able to beat a number of top contenders. What he should be remembered for is the dominance he held over the heavyweight division during his championship years which ran from 1937 to 1948. Joe's achievements will never be duplicated.

As the Celtics continue in the Eastern Conference Finals against Miami, it is certainly a path that is both familiar and exciting for Celtics fans. For the Heat are familiar foes of the Green and White when it comes to meeting in postseason play with the two teams having faced one another on numerous occasions in recent years.

The current matchup marks the third time in the last four years that the two teams have met in the Eastern Conference Finals. They also battled in the Eastern Conference Finals back in the spring of 2012 as well as the 2011 Eastern Conference semifinals and the opening round of the 2010 playoffs.

In those 2010 playoffs, few remember the series with the Heat since the C's advanced all the way to the NBA Finals. They came within about six and a half minutes of winning the title before bowing to the Lakers in Game Seven. In that 2010 opening round series against Miami, the Celtics completed dominated, jumping out to a 3-0 lead in games before Miami prevented a sweep by winning game four. The C's then eliminated Miami with a 96-86 victory at the Garden.

The next year it was Miami's turn to eliminate the Celtics in a five-game series. After the Celtics swept the Knicks in the opening round, they were beaten by Miami in a low scoring series with the Heat being the only team to exceed 100 points (once) in any game.

The next postseason (2012) featured the two teams meeting in the Conference Finals — a familiar juncture that would continue down to the present day. But in 2012, there was a new dimension. LeBron James had joined the Heat. Even so, the C's held a 3-2 lead in the series before the Heat stormed back to win the last two games and take the series.

A few mediocre years followed for Boston. The Celtics would not make the 2013 postseason and would not advance beyond the first round in 2014, 2015 and 2016. But the Celtics did improve after that, advancing to the 2017 and 2018 Eastern Conference Finals where they were stopped twice by Cleveland. In 2019, hey were eliminated by Milwaukee in the second round.

The C's would meet the Heat in the 2020 Conference Finals. This was part of the "bubble series" played in Florida during the height of the Covid-19 restrictions. Miami jumped out to a 2-0 lead in games, eventually pushed it to 3-1 and wound up winning 4-2. In the middle of these "Florida playoffs" head coach Brad Stevens signed a contract extension.

However, the following spring the C's were eliminated in the first round by Brooklyn. Shortly thereafter Celtics GM Danny Ainge "retired" and moved to Utah where he was hired by the Jazz some six months later. Stevens took his place as GM.

Ime Udoka was selected as the new head coach and promptly led the C's to a memorable season, reaching the NBA Finals. One the way there, the C's downed the Heat in a

seven- game series.

Despite the loss to Golden State in the Finals, there was certainly a positive mood in the Celtics organization. That changed a few days before the start of training camp when Udoka was suspended. Assistant Joe Mazzulla took over and the C's didn't miss a beat.

They have defeated the Hawks and the 76ers on the way to meeting the Heat in the Conference Finals once again. If they get by Miami, they will play the winner of the Denver- LA Lakers series. Everyone wants a Boston-LA capstone event. Boston says it has some unfinished business but then again, so do three other teams.

So there is a lot of recent history between these two teams and although the matchup does not quite bring with it the supercharged atmosphere of a Boston-LA series, it has an interesting history all its own. Last year the series went the full seven games. Expect a battle this time around as well.

In addition, we should point out that former Celtics player Antoine Walker actually picked up his NBA championship ring while playing for Miami back in 2006. He scored 14 points and pulled down 11 rebounds in a series ending game six Finals win over Dallas.

NO REAL LATE NIGHTS — The NBA announced that all of the games in the Easter Conference Finals and the NBA Championship Finals would start no later than 8:30 p.m. on weeknights and 8:00 p.m. on Sundays, thus increasing the possibility that audiences will be awake for any dramatic finishes.

However, those fans attending Celtics playoff games at the Garden should be aware that the last trains out of North Station usually depart by 11:00 p.m. leaving only a scant window between the end of a regulation time game that starts at 8:30 and train departures.

Back in March at the Hockey East Tournament, many fans had to leave the second game early in order to make the last trains.

SUMMER PLANS FOR BRUINS — It is still spring and what happened is still fresh in everyone's mind. But the Bruins recently put out a release reminding everyone that the B's will still be active over the next few months.

Up first is the NHL Draft scheduled for late June followed by the start of free agency on July 1. Expect the Bruins to be fairly active. The roster this fall should look somewhat different than the one on the night the Bruins were eliminated (April 30).

The annual Bruins Development Camp will be held at Warrior Arena in Brighton July 3-7. Most players participating will never play for the Bruins, but a number will eventually wind up with other NHL teams or European clubs.

The last day of summer will signal a return to regular activity as the B's open training camp on September 20.
