Celebrates 50th Anniversary of Priesthood in Aquino (Frosinone) Italy

On June 30th, Padre Antonio Nardoianni celebrated an auspicious occasion of his 50th Anniversary of priesthood in Aquino (Frosinone) Italy in the medieval church of Santa Maria della Libera with the participation of hundreds (400/500) of people and over 40 concelebrants between priests, friars and nuns.

He was extremely honored by the presence of the Metropolitan Archbishop Prosper Kontiebo from Burkina Faso, and an unknown number of friends from the States and Toronto Canada. Among them Frs. David Costello, the director of the Missionary Society of St James the Apostle with its headquarters in the North End, Boston MA and Michael Simone, the first of the many Jesuits from Boston College who helped him during his 15 years tenure as pastor of St. Leonard's, North End, Boston MA.

Another surprising cause for rejoicing was the participation of 12 friars from the province of Naples, 11 of whom weren't even born 49 years ago when he left Italy to go to Boston. Antonio Riccio preached a beautiful homily as usual, and the friars from Rome provided an impeccable service during the liturgy. All the participants were incredibly excited to see such a large



concentration of priests and religious people in a rural area where most of the pastors serve between two and five churches/ chapels every single week end.

His brothers organized a fabulous, though informal, reception in a resort area, near his home town, to which all those who attended the Mass were invited. The weather was very cooperative, couldn't be better.

New Transit Zoning Regulations Upsetting Status Quo

Last year, lawmakers in Arlington County in Northern Virginia tossed out local laws meant to create single family homes only with a landmark zoning change that mirror what is taking place across the country, including right here in Beacon Hill. Lawmakers there created a new housing law that tells communities inside the MBTA District (or just near a commuter rail station) that it must construct multiple family housing and increase housing density.

It is also happening locally in the towns of Winthrop and Milton, pitting folks against each other. Those supporting the new housing legislation want to open up a tight housing market and undo so-called racist zoning and those longtime residents who warn this new legislation would overwhelm neighborhood infrastructure are now at odds.

RFK Jr. Won't Take Sides Over 9/11

Independent presidential candidate Robert F. Kennedy Jr. recently announced he "won't be taking sides on the conspiracies surrounding the September 11, 2001 terror attacks if he got into the Oval Office" and "instead would push for transparency" around the day. "My take on 9/11, It's hard to tell what is a conspiracy theory and what isn't. But conspiracy

THE TOWER OF BABEL



(Genesis 11: 1-9) "And the whole earth was of one language and of one speech. And it came to pass, as they journeyed from the east, that they found a plain in the land of Shinar; and they dwelt there. And they said to one another, Go to, let us make brick and burn them thoroughly. And they had brick for stone and slime had they for mortar. And they said, go to, let us build us a city and a tower whose top may reach into heaven and let us make us a name, lest we be scattered abroad upon the face of the whole earth. And the Lord came down to see the city and the tower, which the children of men built.

And the Lord said, Behold, the people is one, and they have all one language; and this they begin to do; and now nothing will be restrained from them, which they have imagined to

do. Go to, let us go down, and there confound their language, that they may not understand one another's speech. So the Lord scattered them abroad from thence upon the face of the earth; and they left off to build the city. Therefore is the name of it called Babel: because the Lord did there confound the language of all the earth; and from thence did the Lord scatter them abroad upon the face of all the earth."

Archaeologists differ in their opinions as to the exact location and physical make-up of the Tower of Babel. Many texts refer to this as a tower built in a series of stages or levels, one above the other, each successive level being smaller than the one below.

Experts also seem to differ on the height of the tower which is given from three hundred feet to six hundred feet. One account

claims this is to have been the tallest manmade structure that the world knew up to the time of the Eiffel Tower (1889 A.D.). Some claim that it was six stages high and others claim seven. Another interesting theory is that the seven stages were built on an earthen platform, each stage or light was of a different color, and each was consecrated to a different planet. Many claim this to have been the chief tower in Babylon, others place it eight miles away in a suburb of the city, and still others claim it was built one hundred forty miles away in the ancient City of Ur.

A few facts seem to be accepted among all of the experts: (1) The tower was constructed of sun-dried bricks; (2) it was an extremely high tower; (3) it was built by the ancestors of Noah, either to escape from a possible second deluge, or to converse with the gods, or both. In any event, the Lord came down to see the city and the tower, and regarding this building as an impious assertion of human pride, He confounded their language so that they could not understand each other. Consequently, they gave up the building scheme and were scattered abroad. The Lord scattered them over the face of the earth, and thus we have one explanation for the different languages of the world, or so sayeth the Good Book ... and you'd better believe it!

Medicare Savings Program, **Property Tax Work Off & City Savings for Older Adults**

I'm excited to let you know about two important programs that help our older residents save more money:

The first is the Medicare Savings Program (MSP) — which now offers more savings to more residents. Thanks to changes that went into effect earlier this year, assets are no longer counted against your eligibility for this program, eliminating a major barrier for access. And, on top of that, the amount of money you could save on Medicare-related costs like premiums, copays, and prescriptions have increased as well — from \$2,500 a year to \$3,000.

The second program I want to tell you about is Age Strong's Property Tax Work off Program (PTWOP). The PTWOP invites Boston homeowners age 60 and older to volunteer with the city in order to work money off of their property taxes. PTWOP volunteers have the freedom to determine their own schedules and provide support to various city departments from the Boston Public Library and our senior centers, to the Disabilities Commission or the Office of Veterans Services. This year — thanks to advocacy from Age Strong and our partners in community — older adults can now earn \$2,000 off their property taxes — up from \$1,500. Examples of past PTWOP projects include helping children with school work at the Leahy Holloran Community Center, directing traffic at the annual Boston Americans with Disabilities Act event, and assisting with the distribution of free air-conditioning units to Boston families.

Making it in Massachusetts

Has Become Making Our Way Out of Massachusetts

The latest IRS annual data recipients, all claim Democratic is proving why so many people are exiting "Taxachusetts". The Bay State has the 16th largest population in the U.S. but comes in at number 5 in lost income in 2022, losing approximately \$3.9 billion, according to Federal numbers. The only other cities with higher rates of working-class migration were California, New York, Illinois and New Jersey, which are all larger states.

According to the IRS, the top 5 states shedding income produced by non-welfare

Governors, while the top four states gaining income are governed by Republicans, including Florida, Texas, South Carolina, Tennessee and North Carolina may be on the brink as well. Three of the four states that gained the largest wealth in 2022, do not require residents to nav state income tax

The Pioneer Institute just released the IRS statistics showing the largest voting block to hightail it out of Massachusetts were the 26- to 35-year-olds. Close to 10,000 of this demographic relocated from Massachusetts in 2022, five times more of that age group than fled Massachusetts in 2012. The biggest financial loss to Massachusetts resulted from taxpayers age 55-65, totaling 4,500 who moved on in 2022, 15 times as many as left in 2012, taking close to 1.5 billion with them with most of the losses coming from people making more than \$200,000 per year, according to the Pioneer Institute

Coincidentally, the appalling numbers from 2022, was the year the "millionaires' tax" went into effect. Maybe that is the reason the states with no state income tax picked up our hard-working citizens.

You can bet these numbers will continue to rise each year and it's tough to fathom what these exit numbers may look like in 5-6 years, as we enter a new decade. Such a sad state of affairs in Massachusetts.

PRESIDENTIAL Election Fatigue

It wouldn't be a stretch to say most voters are probably suffering from a case of election fatigue, especially regarding the upcoming presidential race. Realistically there is no escaping it. No matter which television network we may watch or app we prefer on our phone, it is in our face. And face it we must, for there is a choice to be made, and we must choose wisely.

If we are to be fair and balanced, we should acknowledge that neither candidate is perfect, each has their flaws, and our options are limited. So which road do to we take, which path do we choose?

Over the past few months, we have witnessed the divide between President Biden and former President Trump grow wider, especially over the last couple weeks, as voters have begun to process Biden's abysmal performance at the recent CNN presidential debate.

According to a USA Today/ Suffolk University survey this past week, Biden is now 3 full points behind the former president, 38% to 41% as they head towards a November rematch. While each candidate's supporters are remaining committed, Trump seems to be evolving as the candidate of choice for 25% of those who are considering another option as they witness Biden's confusion and verbal gaffes according to

David Paleologos, Director of the Suffolk Political Research Center. "It is still a margin of error race right now, but the Biden campaign must be concerned about the defection of second choice voters, of third-party candidates. The Biden strategy all along was that as third parry candidacies evaporated, those voters would rotate to Biden. This research suggests the tables have turned and the Stein/West/RFK voters he may have been counting on in November have left him after the recent debate, Paleologos said after the poll's release.

A new CNN poll portrays even more unpleasant news for the Biden campaign showing him trailing Trump by 6 points, which is outside the 3.5% margin of error. According to the pollsters, most voters are saying the Democratic Party will have a better shot of keeping the White House for 4 more years, if they cast aside the incumbent president as their candidate.

As the Republican powers to be attempt to control their own candidate's comments, and with the angst and alarm taking hold of the Democratic Elites, we as voters must step up and make calm, composed, informed and conscientious decision when we step into the ballot box this November. After all it is our patriotic duty, and one we should all take very seriously.






Fr. Dan was born in Haverhill on February 19, 1930, son of the late Daniel J. Mahoney and Mary G. (Tannian) Mahoney. He is

He grew up in Haverhill where he was educated at St. James Grammer School and graduated from St. James High School.

Fr. Dan was ordained to the Priesthood on February 2, 1956, by Richard Cardinal Cushing. His first assignment after ordination was at St. Mary of the Assumption Parish in Revere. L'Anno Bello: A Year in Italian Folklore

Cats, Confetti and Caws: Creepy Italian Credences

A few years ago, I wore a brand-new dress to a close friend's wedding. As soon as I saw it, I was immediately struck by its beautiful pastel-flowered pattern, and I imagined how it would look like a garden in motion against a hot July sky. In addition, the dress, and the event to which it was worn, reminded me of another fact. Summer is here, and for many people that means wedding season. There are many wonderful aspects that I love about weddings: the reunion of family and friends, delicious and intricately decorated cakes, pulsating dance floors, peals of laughter resounding through the room. However, in the midst of this joyous festivity. I am often reminded that Italian weddings carry a sinister side, enveloped in the world of superstition. Because marriage involves such a monumental life change, Italian society ascribes a number of superstitions to weddings, born of natural anxieties and the universal desire to prescribe good luck to the new couple. My family members still hand out confetti, or sugared almonds, as favors at showers and weddings. Supposedly, when wrapped in groups of five, they bestow fertility, health, longevity, happiness and wealth to the newlyweds. However, wedding confetti are merely a portion of the rich tapestry of Italian superstitions.

I love learning about superstitions because they are reminders of the values held dear by ancient societies. The superstitions that survived to this day tap deep into the fears and desires of the human subconscious: worries over our mortality, longing for a good harvest, a need for control in an unpredictable world. People scoured everyday occurrences for both good and bad omens, and often the signs were contradictory: a black cat, for example, could be the harbinger of fortune or disaster. Gathered below are some Italian superstitions repeated in my family, most from my grandmother. If you

think that summer proves an odd time to talk about something as creepy as superstitions, keep in mind that Italian culture begs to differ. Ancient Romans celebrated many festivals honoring the dead during the spring and summer. Odd. perhaps, but in the harsh world of antiquity death was an everpresent companion — along with primal emotions of joy and hope — no matter what the season. So, in honor of both wedding season and the journey of everyday life that continues into the summer, get ready to dive into the spooky side of Italian folklore:

The number 17 is bad luck: This was an oft-repeated nugget from my grandmother. In the United States, Friday the 13th serves as the quintessential bad-luck day. In Italy, it is the 17th of the month. The roots of this superstition extend to ancient Rome. Author Mirella Sichirollo Patzer theorizes that this belief originated from the fact that the Roman numeral for 17, XVII, can be rearranged to spell VIXI, a Latin word meaning "he lived" that is found carved in many ancient tombstones.

Malocchio: This translates to "evil eye" and is an extremely popular superstition not only in Italy, but in the entire Mediterranean world. Supposedly, looking at a person with jealousy or anger is enough to trigger a mountain of bad luck upon them. As such, Italians devised a plethora of charms to ward away malocchio. One of them is the cornicello, a horn-shaped amulet found everywhere ranging from necklaces to home decorations, usually colored bright red (when I was little, I thought these were supposed to represent chili peppers). The *cornicello* is modeled after the cornucopia, a symbol of abundance and fertility in ancient Greek and Roman mythology.

Cats: I am a huge cat lover, and ever since I was little, various cats have always been members of my family — including

adorable black cats! Though I obviously don't attribute any sort of misfortune to black cats, these kinds of cats were traditionally considered unlucky in many areas of Italy. This superstition may go back to the Middle Ages, when a popular belief stated that witches could disguise themselves as black cats. Conversely, some areas of Italy view a black cat crossing one's path as a fortunate happenstance. Hearing a cat sneeze is another lucky omen for Italians. Furthermore, I remember my nonna explaining that if a cat's paw went over its ear while it was grooming itself, that meant rain was on the way!

Birds: My grandmother acquired a very ominous voice when she talked about birds, as they are generally heralds of bad luck in Italy. A bird flying into the house is a death omen, perhaps because ancients viewed birds as being closer to the world of the dead due to their ability to fly. My grandmother mostly feared owls, which Italians also consider a death omen as a result of their intense stare and eerie cry. Conversely, however, owls also represent wisdom and knowledge.

Salt: Many readers will probably be familiar with the idea that spilling salt is bad luck, since this is a superstition that has reached all corners of the globe. It is also quite popular in Italy, and my grandmother swore by it. This superstition originates from the fact that salt was a very precious commodity in ancient times, and thus spilling it could really result in financial bad luck. Also related to the "precious commodity" line of superstitions are the Italian beliefs that it is bad luck to spill olive oil or throw away bread.

From animals and salt to numbers and amulets, Italian life is peppered with fascinating superstitions. Though most people do not take them as seriously as they did in the past, when uncertainty ruled the most basic interactions of daily existence, these superstitions are still followed out of appreciation of tradition or a sense of fun. Rites of passages and major life events, such as weddings, attract the bulk of these superstitions. As I enjoyed my friend's summer wedding, I also thought about the myriad superstitions that mark the Italian counterparts of these celebrations: the aforementioned confetti, the chiming of bells which originated as a way to ward off evil spirits, the belief that rain on a wedding day is paradoxically good luck, and the granting of the bomboniera. or wedding favor. No matter what occurrence life throws your way, you can be sure that Italian society has some sort of interesting lore attached to it! So, as you enjoy the warm summer weather, make sure to watch your saltshakers and guard your eyes, whether or not you are attending a wedding or petting a cat!

Saint David Lewis



Lewis was the youngest of nine children of Anglican Reverend Morgan Lewis, the headmaster of a grammar school, and Margaret Pritchard, a Catholic He was born in Monmouthshire, England in 1616.

At 16 years of age, while visiting Paris, he converted to Catholicism from Anglicanism and subsequently went to study at the English College, Rome, where he assumed the alias "Charles Baker," a common practice among Catholic priests to avoid spies and informers in the employ of the Ohiop Crown. He was ordained a Catholic priest on July 20, 1642. Three years later, he joined the Society of Jesus.

He returned to England for a year. Then he was appointed spiritual director to the seminarians at the English College in Rome. After his mission in Rome had been completed, he came back to Monmouthshire and worked for 30 years in the apostolate paying much attention to the poor people and people in need. Due to this, he was known as "Father of the Poor."

He was arrested on November 17, 1678 at St Michael's Church, Llantarnam, then in Monmouthshire, and condemned in March 1679 as a Catholic priest and for saying Catholic Masses. He was



accused of attempting to kill Charles II and trying to restore the Catholic faith in Wales. He was betrayed by an apostate couple who had been promised an award of 50 pounds for the Jesuit's capture, and another sum of 200 pounds was promised by a Welsh magistrate to those who could help in his exposure. Like John Wall and John Kemble, he was then sent to London to be examined by Titus Oates (the originator of the Popish Plot) and other informers.

He was brought to trial at Monmouth on March 16, 1679, on a charge of high treason — for having become a Catholic priest and then remaining in England.

He pleaded not guilty to the charge of being an accessory to the Popish Plot. However, five or six witnesses claimed they had seen him say Mass and perform other priestly duties. For this, Lewis was found guilty and sentenced to death. Lewis was brought to Newgate Prison in London with John Kemble and questioned about the "plot". Oates and his fellow informers were unable to prove anything against him. Lord Shaftesbury advised him that if he gave evidence about the "plot" or renounced his Catholic faith, his life would be spared and he would be greatly rewarded. Lewis said in his dying speech, "discover the plot I could not, as I knew of none; and conform I would not, for it was against my conscience". He was brought back to Monmouthshire for his execution by John Arnold of Monmouthshire, prayed at the Gunter Mansion and was hanged on August 27, 1679 and then posthumously disemboweled. It was a tribute to the esteem in which he was held that the crowd, mainly Protestants, insisted that he be allowed to hang until he was dead and receive a proper burial.

Father Lewis was Canonized on October 25, 1970 by Pope Paul VI. The Feast Day of Saint David Lewis is August 27th.

The majority of Boston Planning & Development Agency (BPDA) staff have transitioned into jobs with the City of Boston and are now employees of the new Department.

The establishment of the Planning Department is a major part of Mayor Wu's vision to transform planning and development in Boston, and complements other initiatives including a home rule petition to end urban renewal and establish a new mission focused on resilience, affordability, and equity; the establishment of the Planning Advisory Council; citywide zoning reform, including the "Squares + Streets" initiative to increase the availability of housing near transit, the modernization of the development review process and a design framework for guiding future development.

"Our goal to make Boston a green and growing city depends on planning together for our brightest future," said Mayor Michelle Wu. "With our new Planning Department, we will be able to unlock a future for our city that truly centers Bostonians' needs and brings communities together

in making Boston home for generations to come."

"I'm glad we could see the mayor's vision through and create a Planning Department for the City of Boston," said Chief of Planning Arthur Jemison. "This was a tremendous effort led by dedicated and determined staff who focused on every detail to support our employees through this transition. I am excited to launch this new Department, which will shape the future of our great City, and ensure it is planned equitably, for years to come."

The Planning Department is charged with developing comprehensive short- and longterm plans for Boston's built environment, establishing a consistent and predictable zoning code for the city, advancing exceptional and inclusive design standards, providing predictability to guide development that is responsive to community needs, and planning for the effective use of public real estate. It is through these actions that the Department will address Boston's' greatest challenges of resilience, affordability, and equity. The Planning Department will work to build trust with communities through transparent processes that embrace predictable and responsible growth.

The new Planning Department includes the divisions of planning & zoning, development review, urban design, and real estate, as well as support staff. Moving forward, the Planning Department budget will be reviewed through the City's budget process, like all other







Frank Lloyd Wright



Frank Lloyd Wright was born in Richland Center, Wisconsin, on June 8, 1867, the son of William Carey Wright, a preacher and a musician, and Anna Lloyd Jones, a teacher. His early childhood was nomadic as his father traveled from one ministry position to another in Rhode Island, Iowa, and Massachusetts, before settling in Madison, Wisconsin in 1878.

Wright's parents divorced in 1885, making already challenging financial circumstances even more challenging. To help support the family, 18-year-old Frank worked for the dean of the University of Wisconsin's department of engineering while also studying at the university. But he knew he wanted to be an architect. In 1887, he left Madison for Chicago, where he found work at the prestigious partnership of Adler and Sullivan, working directly under the noted architect Louis Sullivan for six years

In 1889, at age 22, Wright married Catherine Lee Tobin. Eager to build his own home, he negotiated a five-year contract with Sullivan in exchange for the loan of the necessary money. He purchased a wooded corner lot in the Chicago suburb of Oak Park. It also reflected Wright's ingenuity as he experimented with geometric shapes and volumes in the studio and playroom he later added for his ever-growing family of six children. Remembered by the children as a lively household, filled with beautiful things.

Wright opened his own office and began his quest to design homes that he believed would truly belong on the American prairie.

Wright was determined to create an indigenous American architecture, over the next sixteen years he set the standards for what became known as the Prairie Style. These houses reflected the long, low horizontal prairie on which they sat with low-pitched roofs, deep overhangs, no attics or basements, and generally long rows of casement windows that further emphasized the horizontal theme

In August 1914, Wright's life with his wife Catherine was tragically ended as she, her two children and four others were killed in a fire, intentionally started by an angry domestic employee. Emotionally and spiritually devastated by the tragedy, he found solace only in his work,

In 1928, Wright married Olga Lazovich. She proved to be the

partner and stabilizing influence he needed in order to refocus on "the cause of architecture" he had begun decades earlier. With few architectural commissions coming his way, Wright turned to writing and lecturing. Two important publications came out in 1932: An Autobiography and The Disappearing City. The first received widespread critical acclaim and would continue to inspire generations of young architects. The second introduced Wright's scheme for Broadacre City, a utopian vision for decentralization that moved the city into the country, it would influence community development in unforeseen ways in the decades to come. At about this same time, Wright and Olga founded an architectural school at his winter home they called Taliesin, the "Taliesin Fellowship," an apprenticeship program to provide a total learning environment, integrating not only architecture and construction, but also farming, gardening, and cooking, and the study of nature, music, art, and dance.

In 1935, Wright moved to Arizona where he worked on the Broadacre City model, which would debut in Rockefeller Center in 1935. Wright was by this time still considered a great architect, but one whose time had come and gone. In 1936, Wright proved this sentiment wrong as he staged a remarkable comeback with several important commissions including the S.C. Johnson and Son Company Administration Building in Racine, Wisconsin; Fallingwater, the country house for Edgar Kaufmann in rural Pennsylvania.

In June 1943, Wright received a letter that initiated the most important, and most challenging, commission of his late career. Baroness Hilla von Rebay wrote asking him to design a building to house the Solomon R. Guggenheim collection of non-objective paintings. Wright responded enthusiastically, never anticipating the tremendous amount of time and energy this project would consume before its completion sixteen years later.

Wright was still actively involved with all aspects of work including frequent trips to New York to oversee construction of the Guggenheim Museum when, in April of 1959, he was suddenly stricken by an illness which forced his hospitalization. He passed away on April 9, two months shy of his ninety-second birthday

Laccetti Foundation Addresses New Programs

Highlighting Italian Contributions to the World

A select group of teachers and Program Directors were invited guests of the Silvio Laccetti Foundation to a special meeting at the New Jersey Sports and Exposition Authority (NJSEA) Meadowlands Environment Center in Lyndhurst to discuss new, unique and innovative projects to spread awareness of Italy's contributions to our world. NJSEA hosted the session, providing technical assistance.

Special guests were Daniele Castellani, the Education Officer of the New York Italian Consulate and Dr. Angela Cristini, Director of the Meadowlands Environment Center, an NJSEA facility operated by Ramapo College.

The first item considered related to improving visibility of Italy's historical and modern contributions to science and technology — especially modern ones which find little mention in curriculums, for example those of Volta, Meucci, Marconi and Fermi. The consensus was to use linkages through STEM classes and to promote extra-curricular assignments/activities in Science and Italian language courses.

Two such examples were cited. Mr. Castellani discussed the valuable role played by students from Spilimbergo, Italy who attended the word's only school that trains students in the arts of mosaics and terrazzo. These students created the tile and mosaic work to restore NYC subway stations damaged by the 9/11 terrorist attacks. On a lesser scale, the amazing work of Union City School students working in terrazzo and mosaics, in conjunction with a project to honor Italians who brought these trades to the U.S., was presented by Visual and Performing Arts Supervisor Robert Astudello and Arts teacher Fabiana Rodriguez.

Related to environmental concerns, Dr. Laccetti

explained his Foundation's WorldCast seminars for high school students globally.

For WorldCast, students from various countries produce videos of significant environmental issues in their local areas. Examples include presentations about the Brazilian Rain Forests, the weakening of the Gulf Stream (Ireland), peril of the coral reefs (Australia), land preservation in the Meadowlands, saving our Jersey shores (Pt. Pleasant Boro) and Overtourism and Ocean Liners in Venice (Venice). To see these programs, visit: laccettifoundation.org. This year a new sponsor will be needed.

An exciting highlight of the meeting was the presentation of a totally new course for use in multiple educational settings. "Italia di Lusso" was designed for the Silvio Laccetti Foundation by Mauro Raguseo, Italian teacher at Lyndhurst High. The course is essentially an exploration of Italy as a global brand. It examines various fields in which Italian achievement is unrivaled, from automotives, to fashion, design, and cuisine. "Italia di Lusso" can be taught in Italian IV courses, or as a course open to any and all students tailored to grade levels. Mr. Castellani offered the possibility of assistance from the Italian government.

Castellani further suggested that a National Design Competition could be held with the assistance of various Consular offices in the U.S. Eventually, there could be National Teachers Conferences as well. Hopefully, Consulates in New York, Boston, Chicago, and California might serve as starting points.

So many ideas were projected and discussed that we could fill much of this publication with them. Suffice to say that from this starting point, through cooperation and networking of all parties, big developments are coming in the future.

Lucia breathes new life into one

important corner of jazz history, with The Brubeck Octet Project. The album documents De Lucia and his octet's rediscovery and reconditioning of the arrangements played by the Dave Brubeck Octet, the innovative 1946-1950 unit with which the iconic West Coast pianist began his career. De Lucia's octet predates The Brubeck Octet Project. He formed the band in 2016 for another project at City College of New York where he taught, but it quickly became a weekly reading band, leaving De Lucia constantly in search for the new (old) repertoire. It was this quest that led him to the archives at Brubeck's alma mater — Mills College, where he found many of the Brubeck Octet's original handwritten charts in the papers of the band's tenor saxophonist and arranger, Dave Van Kriedt. Listeners get to reap those rewards. From De Lucia's own muscular alto workout on "I Hear a Rhapsody," to pianist Glenn Zaleski, tenor saxophonist Scott Robinson, and trumpeter Brandon Lee's gleeful runs on "IPCA," to Robinson and trombonist Becca Patterson's thoughtful, enigmatic submissions on "What Is This Thing Called Love," the players offer irresistible interpretations and expressions on the historical arrangements. The music both remains a product of its time - an experimental thrill ride of the early bebop era - and crackles with renewed vigor and spontaneity at the hands of De Lucia and his cohorts. De Lucia writes, "This is the first time in 74 years that this music has been played and recorded again, and I think the results turned out great." After a single listen to the dozen tracks on this album, that is a statement that will be uttered again and again. De Lucia is a Brooklyn-based saxophonist, clarinetist and composer with local ties to this area. Originally from Quincy, Massachusetts, he moved to New York City in 2005.

A Nostalgic Remembrance



When I was a kid, Nanna and Babbononno would put a family barbecue together about a week after the 4th of July weekend. On the 4th weekend, Dad and my uncles would be playing functions or marching in local parades, musicians one-and-all. A week later on the weekend, Dad would book a barbecue pit at Mystic Lake Reservation on Saturday or Sunday afternoon.

My grandparents would invite their relatives, who like them, came from the old country. This would mean Zi'Antonio, Nanna's oldest brother and Babbononno's best friend.

Also invited were Nanna's sisters and their husbands, her youngest brother and his wife, and oh, yes, Zi'Antonio's wife Mariauccia. Dad and Mom would invite some of the children of those old timers, and by the time we had a list put together, there might be 20 or so people, if you added in "us kids."

During the week prior to the event, all of the necessities were bought and the preparations would begin. Now an American barbecue usually consists of hotdogs, burgers, cold beer and more cold beer. An Italian barbecue is a bit different. The ladies would make ravioli, meatballs, sausages, and a meat sauce with chunks of pork, beef, lamb and the afore-mentioned meatballs and sausages mixed in. The fixin's for a salad would be readied along with the oil and vinegar dressing. Dad and my uncles Nick, Paul and Gino would pick up barbecue briquettes, and steaks, hot sausages, and hot dogs to cook on the grill, for those who wanted just barbecue. An Italian barbecue needed hot peppers, and an assortment of them were added in.

Dad had a Coleman gas stove which meant Mom could make coffee in an American pot and Italian espresso in another pot designed just for ground Italian bens. The American coffee consisted of a pound of ground up A&P Eight O'clock coffee and the Italian, a pound of Stella D'Oro. Several types of pastries and cookies were picked up in either East Boston or the North End for dessert. (We always wound up with more cannoli than we could eat.)

Babbononno and Zi'Antonio would bring a couple of gallons of homemade wine, and Dad, my uncles and a couple of cousins my folks age would add in the beer and hard stuff for those who didn't drink wine. For us kids, there was Saraford orange soda, 7 Up, and Royal Crown Cola. Checking off a list of things, Dad, Mom, Nanna and Babbononno would determine what else should accompany us to a family picnic. As a result, Babbononno would bring a set of bocce balls, a deck of Italian playing cards, and a deck of American playing cards. Dad and I would bring baseball equipment and my female cousins would add in badminton rackets and shuttlecocks.

When all seemed ready, a final list would tell everyone if anything was missing, and Dad would call one and all and remind them to wear their bathing suits as there was a beach at the Mystic Lake Reservation. Of course, none of the old timers even owned a bathing suit. A few of my folk's generation would bring theirs, but all of us kids would wear ours to the reservation and leave our shorts and shirts in our folk's cars.

On a morning of that 2nd weekend in July, we were usually the first at the lake, with Dad locating the barbecue pit reserved for us. Mom and Nanna would set up a nearby picnic table or two, to handle all of the family members who were coming. A blanket would be spread on the ground for us kids and anyone taking a baby along.

While the women would bring out the prepared foods and heat them up, the old timers would play bocce or cards. We kids would head for the beach with one of my uncles or my mother's cousins to watch over us, and Dad and my uncles would play catch with a baseball or a football. Dad would soon tire of this and begin to cook the meats slated for barbecuing. Within the hour, someone would yell, "Vieni a mangare, vieni a prenderlo." (Come and eat, come and get it) At that point, all sports activities would stop and everyone would sit at the tables. The ladies would serve salad, the pasta, the meatballs and sausages

and gravy meats family style. Babbononno and Zi'Antonio acted as the bartenders and the wine and beer would begin to flow. Someone would be sent to the beach to round up us kids and the adult watching out for us. We were usually threatened because we wouldn't get out of the water, but we eventually obeyed, knowing that we could be punished if we didn't obey.

The meal would last for an hour or so before Dad and Mom made the pots of coffee. When they did, the tables would be covered with dishes of pastries and cookies, after dinner liquors, and dishes of fruit. We kids were then warned by an adult in either English, Italian or both, "You can't go into the water for an hour. You just ate and if you go back in the lake, you will get a cramp and drown." As a result, we played games on the grass that surrounded the barbecue site, and prayed for the hour to slip by so we could go back into the lake.

After everyone ate, the women usually cleaned up (What else), and the men headed for the blankets. After another drink, almost all were asleep. In the meantime, as we kids played on dry land, I would ask Mom what time it was every few minutes. When the hour was up, we all would cheer and head back to the lake with a now full and tired adult running after us. There we would stay until our skin was wrinkled. We were Italian and there was no need to worry about the July sun doing any damage to our skin. We would just tan and not burn like other American kids did.

As the sun started to head toward the west, the entire gang would begin to pack up leftovers and all of the things they had brought with them. Someone always invited the entire group back to their home, but at this point in time, most everyone just wanted to get home, change their clothes and relax. Once all of Mom and Dad's belongings were situated in the trunk, they, Nanna and Babbononno, would say goodbye to everyone and this would take a half hour or more. Italian goodbyes can be never ending, but once they were over and the sun was setting. Nanna. Babbononno and I piled in the back seat of Dad's car, and with Mom as the copilot, we would head back to East Boston.

Within five minutes of leaving Mystic Lake, I and Babbononno would be asleep and stay that way all the way home.

We were at a couple of barbecues over the 4th, but they weren't the same ... hotdogs, burgers, potato salad, macaroni salad, tonic and beer. It wasn't the same as the old days, at Mystic Lake. Both my grandparent's and parent's generations are gone and I'm now one of the old timers, plus most of the folks surrounding me were American. None of them would ever know the fun we had back when three generations of my Italian- family decided to celebrate an American holiday, Italian style.

GOD BLESS AMERICA



In Italy during the 1960s, a humble dessert known as Pizza di Gallette, or Cake Pizza, affectionately called "the poor man's cake" or "Mary's dessert," was a beloved staple at Nonna's house, often served as the sweet finale to Sunday dinner. Originating from Southern Italy — some say Salerno, others claim Campania — this dessert is crafted using dry biscuits, such as Saiwa Gold, soaked in vermouth and layered with rich, velvety custard. The result is a dessert that is both easy to prepare and deeply nostalgic. In the United States, a similar concept took shape with Icebox Cakes, which were made using chocolate wafers and whipped cream, followed by variations with graham crackers and pudding.

Though the traditional recipe for Pizza di Gallette calls for soaking the biscuits in vermouth, many Italians today prefer a modern twist, using caffe latte or coffee with milk instead. These biscuits, once soaked, are layered with creamy custard and finished with a dusting of bitter cocoa, transforming the dessert into an easyto-make Tiramisu. Whether you stick to the classic Cake Pizza or try this variation, this no-bake dessert is sure to be a hit at all your summertime gatherings!

CAKE PIZZA Pizza di Gallette



1 package Saiwa Gold Classic Biscuits (or Italian tea or milk biscuits)

Crema Pasticcera or Custard

4 cups whole milk

8 large eggs

1 cup sugar 10 tablespoons all-purpose

flour

1 organic lemon peel

1 teaspoon pure vanilla extract

Vermouth Bath

1 ½ cups water 3/4 cup vermouth

½ cup sugar

Custard

- 1. In a medium saucepan, combine the milk and lemon peel. Heat until just before boiling, then remove from heat and allow to cool.
- 2. Once cooled, add the remaining ingredients to the saucepan and whisk together.
- 3. Return the saucepan to medium heat and cook, stirring constantly, until the mixture thickens into a custard.
- 4. Remove from heat, discard the lemon peel, and transfer the custard to a heatproof bowl.
- 5. Cover with plastic wrap and refrigerate until chilled and fully thickened.

Vermouth Bath

- 1. In a small saucepan, combine the water, vermouth, and sugar.
- 2. Heat over low heat, stirring until the sugar dissolves, then remove from heat and let cool.

- 1. Dip each biscuit individually into the vermouth bath to moisten.
- 2. In a 13 x 9-inch baking dish, create a layer of moistened biscuits followed by a layer of custard.
 - 3. Repeat the layers until all ingredients are used.
- 4. Cover and refrigerate for at least 4 hours, or overnight, before serving..



Managing Weeds in the Garden

No matter the weather, weeds seem to thrive and reproduce, and if left unchecked, they can overwhelm the garden and gardener. These unwanted plants find their way into your garden as seeds, roots, rhizomes, or whole plants. Seeds can be carried in by the wind, birds, and other animals, or on the soles of shoes. Roots, rhizomes, and even plants hitch a ride in the soil or with plants that we move into the garden.

Start early managing weeds in your garden. Smaller weeds are easier to pull and removing them before they flower and form seeds can prevent hundreds of weeds in next year's landscape.

This is not always possible. Weather and busy schedules often limit gardening time, allowing these vigorous plants to overtake the garden.

It is never too late and worth investing time in managing weeds in the garden. Weeds are adaptable and vigorous, outcompeting your desirable plants for water and nutrients. Many serve as host plants for insect pests and diseases that may also attack your garden plants.

Carefully dig or pull weeds, removing the top and roots. Established weeds may have a deep tap root or extensive root system that may be difficult to remove. Depending on the weed, any part left behind has the potential to start a new plant.

Find the tool that best works for you. A Dutch or action hoe works well on small weeds where there is space between plants. Glide the cutting edge just below the soil surface to cut the roots. Many gardeners find a weed knife to be a useful tool. It allows you to dig right next to the weed and pop it out of the ground with minimal impact on surrounding plants.

If bending is an issue, you may opt for one of the standup weeders. There are several types available. Most have tines you insert into the soil surrounding the weed. A hand or foot-operated action causes the tines to tighten around the weed roots before you lever it out of the ground.

Perennial weeds are a bit more challenging. Many have extensive roots that are nearly impossible to remove entirely. Repeatedly digging up the plants can eventually manage these weeds, but it can take years. Cutting the plants back to the ground as soon as they appear can help "starve" them, prevent reseeding, and help contain and even eliminate some perennial weeds.

If the weeds begin to take over the garden, tackle those flowering or setting seeds first. Do not compost these or perennial weeds. Most compost piles don't get hot enough to kill the seeds or perennial weeds. Contact your local municipality to find out your options for disposing of these as well as perennial and invasive weeds.

Once the weeds are out of the garden, spread a layer of organic mulch over the soil surface. The finer the mulch, the thinner the layer needed. Pull the mulch away from tree trunks, shrub stems, and the crowns of your other plants.

Mulching helps suppress weeds by reducing seed sprouting and making it easier to pull the seedlings that get through the mulch. Increase your success by placing a couple of sheets of newspaper or a piece of cardboard beneath the mulch. Mulching won't stop existing perennial weeds like quackgrass and bindweed. Keep managing these until all the roots have been removed.

Shredded leaves, evergreen needles, and other organic mulch also conserve moisture, moderate soil temperatures, and add organic matter to the soil as it breaks down. Mulch also helps protect the soil from compaction and erosion during heavy rains. As many places experience more intense rainfall and higher-than-normal summer heat, mulching the soil becomes even more beneficial.

Consider the benefits when you head out to tackle the weeds in your garden. You will improve the health and beauty of your garden while burning between 200 and 400 calories every hour you weed.

Dempsey Vs. Gibbons

In One Photo



I have written about Jack Dempsey a number of times. Looking at his fights against Jess Willard and Tommy Gibbons I commented on his defensive skills. My take on the Willard fight surprised a few people as they stayed focused on the tremendous beating Dempsey handed out to Willard. What I tuned in on was the way Jack set the champion up to be hit with those fierce blows. He didn't just run at Jess while throwing punches. He bobbed and weaved while feinting. He stepped in and back out again while circling and searching for an opening. Jack wasn't looking to go toe to toe with a man who outweighed him by over 60 pounds. He was actually fighting defensively and strategically while setting up his assault. If it had just been a slugfest Dempsey would have been hit more than he was.

The Gibbons fight was a different story as the challenger was intent on lasting the fifteen rounds without getting kayoed, so Jack had to rely more on his boxing skills than his power. This is not to say Dempsey's power did not play a part in his victory. It was that power that had Gibbons in such a defensive posture.

I'm not implying Gibbons just ran or spent fifteen rounds covering up. He boxed beautifully. However, Dempsey proved to be the superior boxer. While not the most watched of Jack's fights, it is the one that gives fans a great look at Dempsey's skills as a keen tactician.

Jack Dempsey will always be put into the slugger category, but he was not one to take two punches to land one. He may have been a knockout artist, but he was very savvy in there.

Recently, I came across a photo of the Dempsey vs Gibbons fight that illustrates the skills of both men. It is amazing what can be gleaned from a photo, a split-second moment from a fight.

In the photo, Gibbons is throwing a hard left jab at the champion. His head is down and his chin is protected by his left arm and shoulder while his right hand is in position to defend against Jack's left hook counter. This is a punch Tommy is anticipating. Both of Tommy's knees are bent a bit, the left more than the right which allows him to deliver the jab with force. It is an excellent execution of a left jab.

Now to Dempsey. As good as the Gibbons left jab is, Jack is parrying it. Note that Dempsey has not reached out to stop the punch. Instead, he is catching it just as it reaches him. This allows him to be in position to throw the counter hook. If he had reached out to stop the punch, he would have been vulnerable to be hit by a left hook. He has his left hand poised to let it go. Jack's left foot is a bit off the mat because he was stepping in when the jab was thrown by Tommy. I say this because of the positioning of Jack's right foot and leg which appear to be propelling him forward. If there were photos from the next second or two, I believe you would see Jack firing that hook as his foot settles onto the canvas. It is likely Tommy tried to slip inside of it and probably attempted to clinch.

Back when boxers were well schooled, they would focus

very much on how their opponents would respond when they threw a punch. As boxer was at his most vulnerable when throwing a punch, this was very important. It is also why all good fighters were counterpunchers. It's why feinting, a long-lost skill, was employed so often.

Jack Johnson was probably the most noted heavyweight champ when it came to using feints, but Jack Dempsey was no slouch in that department. Yes, he may have been a slugger, but he used feints to create the openings for his great combinations.

Boxing has been called physical chess, and that's what it was. In chess you have to think a few moves ahead. You have to anticipate how your opponent will respond to the moves you make and then you have to plan accordingly. The same was true of boxing. It was a game of anticipation.

One other thing I noticed in the photo is how intently the fans are watching the fight. Of course, in a Dempsey fight a knockout could occur at any moment so that is one possibility for their focus. I also believe they understood what was happening in the ring and appreciating the skills being displayed.

I maintain that not only were the fighters better schooled in boxing's Golden Age, but the fans were too. The majority of them understood the intricacies of the game.

One last thing. Check out the shadows cast by Jack and Tommy. It is almost surreal. Art cast by two men practicing the art of boxing. Cool.

HOOPS and HOCKEY in the HUB

Well, the long-awaited rumor came true and now NBA megastar LeBron James has been successful in securing his son Bronny as a teammate on the Los Angeles Lakers.

The younger James' initial deal is a four-year pact worth a total of \$7.9 million.

There are different yearly values but the amount for the 2024-2025 fiscal year is \$1.2 million. That may seem small by NBA standards but how many 19-year-olds do you know that are earning \$100,000 monthly checks? How about none.

His dad, of course, inked a somewhat larger deal, resigning with the Lakers for \$104 million for the next two years. That will average out to about \$2 million per week or about \$142,400 per day year-round.

The deal, of course, brings together what everybody wants. Television gets the father-son pair playing together. The NBA receives some additional attention with perhaps more interest (particularly) in the fall when football claims the top spot in fan interest.

Early on in 2022, the elder James issued a statement saying "My last year will be played with my son. Wherever Bronny is, that is where I will be. It's not about the money at that point."

However, Bronny has stated on occasion that he wants to be his own man with his own identity.

"I'm trying to get my name out for myself," he told those assembled for an introductory press conference in Los Angeles. "I never really had a thought of me going to play with my dad. That is always there to take part of but it wasn't a main focus of mine."

But it has been — and will continue to be — the main focus of everybody else. It will be virtually impossible for Bronny to be separated from his father. So, let's face it. If he harbored desires to go his own way at this early stage of his adult life, those hopes just evaporated with the dual signings.

We are hesitant to be hard with Bronny since he suffered a major heart attack from congenital defects last year at age 18. But he recovered and we wish him well in this new phase of his life.

NOT IN TUNE WITH REALITY — As the NBA signing season opened at the start of the month, Isaiah Hartenstein, who had played with the Knicks for the past couple of years, signed a three-year contract with Oklahoma City worth \$87 million.

What caught our eye was not the amount but an attempted explanation that appeared in the *New York Post* by writer Stephan Bondy.

"The money is not just about the salary but also about the cost of living and taxes for a fresh first-time father who spent much of his NBA career on relatively low paying and non-guaranteed contracts," wrote Bondy. "According to Spotrac, Hartenstein's career earnings since 2018 are \$22.65 million. He will easily surpass that in year one of the new deal."

Hartenstein is 26 years old. Even before signing the \$87 million deal, he had already earned \$22 million by age 26. Think about that for a moment. How many people will even approach that figure in their entire working lives — even if they are employed for more than 50 years. We would say virtually no one.

And if you have or had children, think of the cost of living and taxes you perhaps had to deal with as a parent — at a far more average monthly wage than Isaiah Hartenstein. Having already earned over \$22 million, Hartenstein is one of those very few fortunate persons living a family life free of concerns about the financial costs of daily living. We salute the working people of America. The ones who get up each and every workday and put in a full day's work to earn a full day's pay. We admire all of you. And we just can't feel sympathy for someone who has already earned over \$22 million by age 26.

THE NHL DRAFT — There was a lot of Boston flavor at the NHL Draft held recently in Las Vegas. The big moment when No.1 was announced had Boston ties written all over it. Yes, the San Jose Sharks did pick first with the Sharks General Manager Mike Grier on hand for the big announcement. A native of Holliston, he played his high school hockey at St. Sebastian School. He followed that up by playing three-years at Boston University.

After BU, he played over 1,060 games in the NHL spread across 14 seasons. He became the GM of the Sharks in 2022.

Also on hand was Joe Thornton, who had a lengthy and memorable career with the Sharks after spending his early years with the Bruins. And thus, it was that BU star player Macklin Celebrini was selected first in the draft by the Sharks.

Celebrini was the star on the ice for the Terriers last season scoring 32 goals to go with 32 assists for 64 points in 38 games — an output that was a significant factor in leading the Terriers to the Frozen Four and that earned him the Hobey Baker Award as the best player in college hockey. Celebrini decided to forego his sophomore season with the Terriers. He signed an entry level contract with the Sharks in early July.

Another player taken in the same draft by the New York Islanders is Cole Eiserman of Newburyport. He is headed for BU after playing last season in the U.S. National Team Development Program. While there he scored 58 goals in 57 games this past season while also contributing 31 assists. An off-ice relationship always helps — BU coach Jay Pandolfo played for current Islanders GM Lou Lamoriello when Lamoriello was affiliated with New Jersey a number of years

A LONG ROAD TRIP — The Celtics won Banner 18 at home but they will be playing far from home when they play two preseason games in the United Arab Emirates this fall.
