## Trump Chooses VP Running Mate



**Ohio Senator JD Vance** 

Former President Donald Trump has chosen U.S. Senator JD Vance, a 39-year-old freshman senator from Ohio, as his Vice Presidential running mate, putting to rest months of speculation about who his number two choice would be. "After lengthy deliberation and thought, considering the tremendous talents of many others, I have decided that the best person suited to assume the position of Vice-President of the United States is Senator JD Vance of the great state of Ohio," Trump announced on Truth Social Monday afternoon. "JD honorably served our country in the U.S. Marine Corps, graduated from Ohio State University in two years, Summa Cum Laude, and is a Yale Law School graduate," Trump added.

It is believed Trump chose Vance based on loyalty and to complement his strong personality, but not overshadow him, his ability to raise money and is ready to serve. JD's book, "Hillbilly Elegy" became a major best seller and movie, reflecting on his time growing up in Ohio, championing the hard-working men and women in our country and his focus will be on the American worker and farmers in Pennsylvania, Michigan, Wisconsin, Minnesota, Ohio and beyond.

Trump's decision came on the first day of the Republican National Convention (RNC) in Milwaukee, Wisconsin this past week, and two days after a gunman attempted to assassinate the former President, at a rally he was headlining. The shooter, 20-year-old Thomas Crooks, just missed Trump's head, instead grazing his right ear, as the former President moved at the last second. One person was killed and two others were critically wounded.

Trump's pick may face off against Vice-President Kamala Harris in a Vice-Presidential debate if the two campaigns agree on a network to host the forum. Biden's team is pushing for CBS News, while Trump's campaign has held onto their Fox News Vice-Presidential Debate acceptance.

Vance was first elected to the U.S. Senate in the 2022 midterm election cycle and would be the second youngest Vice-President to assume office if Trump is re-elected.

## **Donald Trump Literally Dodges a Bullet**

## Stop & Shop Shutting Store Locations

Stop & Shop will be closing seven stores in the New York City area and 32 overall. The chain owned by Ahold Delhaize, a Dutch conglomerate, had said it was planning to close "underperforming" stores, with industry experts estimating as many as 50 could be closed.

The Quincy, MA-based company said other closings will come in New Jersey, Massachusetts, Connecticut, and Rhode Island, totaling 8 percent of all stores.

# Stirpe Nostra

#### CAPSULE GEOLOGY

For the novice, a very small and elementary dose of geology, blended with some technology, might help to provide a better understanding for parts of ancient theology.

The solid surface of the earth as we see it is either rock or soil. Rock is the term used to denote the large geologic formations. Rock is broken into stone of various shapes and sizes. Rock is divided very generally into three classes according to the method by which it is formed. These classes are: (1) Igneous rock, which is formed by solidification of molten rock; in other words by volcanic action. Granite curbstones are a good example of igneous rock. It is the strongest and most durable of all rock; (2) sedimentary rock, which is formed from disintegrated products of other rocks. Flagstone is an example of sedimentary rock; (3) metamorphic rock, which is rock whose physical or chemical character is altered by pressure, temperature, and time. Marble is a good example of metamorphic rock.

Marble plays such an important role in religious architecture that it might be well to note that the most desirable qualities in sculptural marble are pure white crystals, straight uniform grain, freedom from natural stains, voids, and microscopic cracks. A good grade of marble is available in the U.S.A. Marble from Carrara, Italy is

better and pentelic marble from Mt. Pentelicus in Greece ranks with the world's best.

Soil is formed from the disintegration of rock. Soil that remains where it was formed is called residual soil and it builds up at the phenomenal rate of about one quarter inch in one thousand years. Soil that has been transported by water and deposited at another site is

called alluvial soil. The deltas of all rivers contain troublesome deposits of alluvial soil. An important soil type which is formed by wind-blown material is called loess.

Soils are also classified as (1) coarse grained like gravel and sand and (2) fine grained like silt and clay. The grain size of sand is about 1/1000 inch but in clay it is less than 1/12,500 inch. Much of the plains of Mesopotamia are made up of silt and clay carried down by the Tigris and Euphrates from the mountains the north. During ancient times these two rivers emptied into the Persian Gulf independently. Alluvial deposits have now forced the two rivers to join as one before reaching the Gulf and they have built up more than one hundred miles of silty soil in a huge delta. Ancient cities that used to be close to the shoreline are now far inland.

It follows then, to understand your Bible lands, you must understand the influence of geology upon that area. There was little or no building stone, just silt and clay, more silt and more clay. Where there is a lack of other building materials and an abundance of clay, we can look for and find brick. In this area there was small brick, large brick, sun-dried brick, kiln-baked brick and glazed brick in many colors.

Accepted Onboard Buses, Green Line Trolleys, Mattapan Line Trolleys, and at Subway Fare Gates Starting August 1st The MBTA is Rolling Out New Ways to Pay

The MBTA announced that contactless payments will be accepted onboard buses, Green Line trolleys, Mattapan Line trolleys, and at all gated subway stations beginning Thursday, August 1, 2024. This new initiative is part of the MBTA's goal of offering easier, more convenient, and modernized ways for riders to pay fares. More information is available at mbta.com/TapToRide.

"Transitioning to this contactless system is a part of the next generation of transportation that our riders deserve. This will allow them to save time and make it easier for riders and travelers to pay and board as they use the system," said Transportation Secretary and CEO Monica Tibbits-Nutt.

"I've seen directly at other transit properties and heard firsthand from many riders about the importance of contactless payment and how it would greatly enhance the experience of using mass transit. Last year this project needed a course correction and I'm proud of the progress made to deliver this important amenity for our riders, bringing our payment system for our bus and subway system into the 21st century. This lays the groundwork for the fare payment system of the future, incorporating our fare structure including the recently approved Income-Eligible Reduced Fares," said MBTA General Manager and CEO Phillip Eng. "The MBTA team's steadfast dedication to bring this initiative to fruition along with our partner Cubic, worked collaboratively, solving challenges to demonstrate our commitment to the public. I thank our riders for their patience as we continue to build a system that they can rely on and be proud of."

"Cubic Transportation Systems has been a proud partner of the MBTA for several years and we thank the MBTA for their collaboration throughout this project," said President of Cubic Transportation Systems Peter Torrellas. "The upcoming launch of Automated Fare Collection 2.0 system-wide will transform public transportation across Greater Boston and significantly enhance the rider experience. Millions of MBTA riders will soon be able to benefit from increased convenience with this modern, efficient, and user-friendly contactless payment system."

Contactless payment options provide better flexibility and allow riders to pay by tapping a contactless credit/debit card, phone with a mobile wallet, or watch on fare readers on buses, on Green Line vehicles, on Mattapan Line vehicles, and at all gated subway stations. A one-step option for pay-as-you-go travel, riders can save time by using their contactless credit/debit card, phone, or watch instead of purchasing and reloading a CharlieCard. Riders can look for the contactless symbol, tap their card or device on the reader at the fare gate or the reader at the vehicle door, wait for the green checkmark, then ride.

Riders with weekly or monthly passes or those who would like to continue to use their CharlieCards will not be impacted by the change. The current ways to pay will remain the same.

While onboard buses, Green Line trolleys, and Mattapan Line trolleys, riders should be mindful of the location of the tappable fare readers near the vehicles' doors. To avoid the possibility of accidental taps and charges of their contactless credit or debit cards, riders are encouraged to hold their purses, bags, and backpacks away from the contactless readers.

Riders in reduced fare programs (such as Senior, Student, and TAP) will have the option to link their benefits to their contactless card, phone, or watch. Riders who do not want to link their benefits to a contactless card, phone, or watch will be able to continue using their current payment method. Contactless payment options will operate in accordance with the MBTA's privacy policy, which is available at mbta.com/policies/privacy-policy. The MBTA is committed to a strong culture of privacy based on protecting our customers' personal information as well as being as transparent as possible in how we use customer data and how customers may access, update, or delete their personal information.

Riders will be able to manage their contactless cards, phone, and/ or the watch they use for travel through an online Charlie account at Charlie.mbta.com or by calling the Customer Support Center at 617-222-3200. A Charlie account allows riders to check their balance, manage their charges, view their trip history, and access other self-service tools for quick and easy account management. Registration is optional.

## AT&T Data Breach, Again!

#### Between Usage Outages & Hackers AT&T is Failing its Customers

hackers had accessed records of call and texts of "nearly all" its cellular customers for the six-month period between May 1, 2022 and October 31, 2022. Coupled with the recent service outage, AT&T is failing its customer base.

In a statement AT&T said, "The compromised data doesn't include the content of the calls, texts or personal information such as social security numbers, date of births or other personally identifiable information." The company said, "hackers downloaded the data from our workspace on a third-party cloud platform." The company learned of the illegal download

AT&T disclosed last week that in April and is working with law enforcement, noting "at least one person has been apprehended." While the files do not include call or text content, AT&T acknowledged the data identifies telephone numbers that an AT&T number interacted with during the periods.

"At this time, we do not believe that the data is publicly available," AT&T said in a statement, with the key phrase being "at this time." This data breach is separate from the one disclosed earlier this year by AT&T, the company commented. In that case hackers have stolen personal information for millions of current and former AT&T customers, with fraudsters sharing

the data on the dark web. Some security experts warned that any information could help hackers gain access to more data, opening the door to fraud.

"These types of identity-based attacks that exfiltrate customer records can allow attackers to piece together the personal data of individuals, including names, phone numbers, addresses, financial and social security details, placing millions of people at risk for identity theft or fraud, said Don Schiappa, Chief Product and Service Officer at Arctic Wolf, a cyber security company.

Companies are required to disclose security breaches to customers within 30 days of becoming aware of an incident, according to U.S. Security regulations. But when AT&T reached out to the FBI about the breach, the agency authorized a delay due to concerns over security risks, per the FBI. The agency noted that after learning of the breach, it worked with AT&T as well as the Department of Justice to investigate the incident. The Justice Department said it determined a delay in publicly disclosing the incident was warranted because it could "pose a substantial risk to national security and public safety." The U.S. Federal Communications Commission said it is also investigating the breach.

## Coletta Zapata Holds Hearing on Proposal to Provide Relief for Small Businesses through Commercial Property Tax Exemption

Boston City Councilor Gabriela Coletta Zapata chaired a hearing on July 9th to discuss an ordinance to adopt the small commercial tax exemption as a local option in the City of Boston. The Councilor's proposal would allow the City of Boston to opt into the existing state law and provide financial relief for small businesses valued under a million dollars or with ten employees or less. Those in attendance included Councilors At-Large Ruthzee Louijeune, Henry Santana, Julia Mejia, Councilors Ben Weber, John Fitzgerald, Brian Worrell, Ed Flynn, Sharon Durkan, Tania Fernandes Anderson, and Enrique Pepén.

"This ordinance comes after numerous conversations my colleagues, the administration, and I had earlier this Spring regarding tax classification in the City of Boston and finding additional pathways to support small businesses. This is one way to get a little bit more money in the pocket of mom-and-pop stores by giving them certain exemptions and protecting them from the cost burden shifting to them.," said Councilor Gabriela Coletta Zapata. "I'm grateful for the robust conversation we had and the various perspectives shared. I look forward to continuing the conversation to ensure we work collaboratively to assist small businesses and mom and pop stores like restaurants, corner stores, laundromats, and barber shops from potential impacts the new tax levy may have."

During the hearing, Councilors discussed the proposal specifically potential measures for quantifying success of the exemption, collaboration within various city departments to ensure adequate and effective communication and outreach for small businesses, and protections for small business tenants. Councilors requested additional information on the average increase on commercial and industrial property if the exemption was baked into the annual tax rate, projected impacts, and a roll out plan if the exemption is enacted.

In addition to the ordinance, Councilors discussed the possibility of amending Massachusetts General Law Chapter 59 Section 5I for a specific Boston statute that would allow for businesses valued over a million dollars to opt in. Coletta Zapata noted that she is interested in understanding the implications of increasing the stipulations between two to three million dollars to cast a wider net for properties.

Additionally, Councilors heard testimony from small business owners and representatives including Jessica Muradian, Director of Government Affairs for the Massachusetts Restaurant Association, and Carlos Castillo of Castillo Wine & Spirits and Board Member, Massachusetts Package Stores Association. Public testimony was offered by Brad Brown, owner of the Blue Frog Bakery in Jamaica Plain.

Coletta Zapata's proposal comes after the Boston City Council voted for a Home Rule Petition regarding property tax classification in the City of Boston sponsored by Mayor Michelle Wu. Mayor Wu sponsored the Home Rule Petition as a temporary tool to protect residents from property tax increases to mitigate potential revenue shortfalls from declining commercial valuations. The Home Rule Petition is now awaiting approval from the State Legislature before it can take effect.

## North End Waterfront Neighborhood Council (NEWNC) HOLDS JULY MEETING

Hosts Feast Society Representatives/Votes on Licensing Applications

The monthly North End Waterfront Neighborhood Council (NEWNC) Meeting was held on Monday, July 8th, 7:00 p.m., at the Nazzaro Center, 30 North Bennet Street. The meeting was called to order by the President, Kevin Fleming, and updates were given by each of the committee chairpersons. The voting membership consists of Kevin Fleming, President; Adam Balsam, Vice-President; Alex Chilton, Secretary; Rory Harrington, Sergeant of Arms; Marie Simboli, Joel Faller, Kristen Hoffman, and Gail Salvati Orenberg.

Jack Imbergamo, a North End resident and Liaison to District 1 City Councilor Gabriela Coleta, offered community updates. A clean up is scheduled at the Prado (The Paul Revere Mall) on Hanover Street, Saturday, July 20th at 10:00 a.m., for anyone interested in participating. Boston Transportation Department (BTD) will begin parking enforcement in the North End on Sunday, July 14th from 7:00 a.m. – 3:00 p.m. Councilor Coletta is aware the community requests a new trash barrel in the Polcari Playground, outside the Nazzaro Center and is working to make it happen. The cost of each barrel is approximately \$400 and many communities have also made similar requests. Regarding Cutillo Park, Jack did not have a formal update, but did note the businesses directly adjacent to Morton Street & Cutillo Park will be allowed to keep their trash outside but will be required to sign a business agreement with the city to keep the area clean and replace their existing barrels to help combat the rodent issue. The long-awaited opening of the Mirabella Pool is now a reality. The pool is open Tuesday through Sunday, from 8:15 a.m. - 7:00 p.m., closed Mondays, and does require patrons to register with the City of Boston

and make advance reservations

on weekends. The number of

available slots has doubled for the 2024 summer, up from 150 to 300 so hopefully everyone will have an opportunity to enjoy this Urban Oasis.

Public Safety Chair Kristen Hoffman reminded the group to use 311 and 911, when necessary, especially as a tool to identify and document repeat problem issues. The focus on safety this summer will be at the upcoming festivals. The chair of the streets committee, Adam Balsam, offered a reminder about the Sumner Tunnel closure from July 5th to August 5th. The entire MBTA Blue Line, in both directions will be free during the closure as will the East Boston Ferry Service.

There were two licensing matters before the council. The first was Forcella, 33 North Square, represented by Attorney Dennis Quilty, applying for a new all alcohol beverage license. There would be no change to hours of operation, capacity size or menu. The vote was 6-0, unanimous support. The second licensing issue discussed was the Wild Duck at 89 Salem Street, applying for a Common Victualler (CV) license with take out. The concept is based on an international market/high quality New York-style, full-service deli, similar to what is currently in other areas of the city, including the Seaport and Back Bay. There will be no seating, it is all off premise consumption. The hours of operation would be 7 days per week, from 7:00 a.m. - 11:00 p.m. The council again voted 6-0 in full support of this applicant.

The main discussion centered around the upcoming festivals with reports offered by representatives of the various feast organizations including, Sal Gesamondo, (St. Agrippina) August 1st through 4th at Hanover & Battery Streets, Stephen Passacantilli, (Madonna Della Cava) August 9th through 11th at Hanover & Battery Streets, Dom and Louis Strazzullo

(Madonna Del Soccorso -Fisherman's Feast) August 15th through 18th at North Street and Lewis Streets, Jason Aluia, (Santa Lucia, August 22nd and St. Anthony, August 23rd through 25th) at Endicott and Thatcher Streets, North Margin

The updates provided by the festival representatives were lengthy and quite detailed. Each society has hired private security companies, as security will be the main focus at each of the festivals this year. Society members will also be stationed, with security, at each of the entry points, which will also be limited in number. No open containers or backpacks will be allowed. There have been multiple meetings between the societies, Boston Police, City of Boston and Transit. Closing times will vary by festival and are as follows; St. Agrippina and Madonna Della Cava's plan is to close at 11:00 p.m., Fisherman's will use a slow close with entertainment stopping at 9:00 p.m., stands closing at 10:00 p.m., beer garden and full feast closure at 11:00 p.m. St. Anthony will close fully

Every festival will have Boston Police Details inside and patrol officers throughout the feasts and the Gassy (DeFilippo) on Prince Street will have security stationed there all night. In addition to police patrolling the exterior perimeter of the feasts they will also be vigilant throughout the neighborhood, especially in the areas of the Steriti skating rink and Starbucks, both located on Commercial Street, as these two locations are known problem areas for outside youth to meet and gather. Each of the societies stressed their commitment to ensuring safety and respect to the North End community, its businesses and its residents!

### L'Anno Bello: A Year in Italian Folklore

Blasts from Birthdays Past

My birthday is quickly approaching on Saturday, July 20th, and it has gotten me thinking about these unique celebrations in general. Birthdays fall under the category of rites of passage, or milestones, and, as a result, cultures around the world celebrate birthdays with special customs and traditions. While we think of birthdays as great opportunities for parties and food, in ancient times people viewed birthdays as dangerous occasions because of their liminality, being poised between one year and the next. As such, birthday parties included—and continue to include—loud noise and noise makers to scare off the evil spirit believed to be lurking around during this period. Many vestiges of these ancient fetes remain. From birthday cakes to picking up the check, here are special birthday traditions from around the world.

Our first stop, of course, is Italy, one of the original homes of the birthday cake. Though scholars are still unsure about the roots of the birthday cake, many theorize that these sweet treats originated in the Mediterranean world. Ancient Greeks baked round cakes to honor Artemis, the goddess of the moon and the hunt, and then illuminated the cakes with candles in order to better resemble the moon. The ancient Romans, on the other hand, made sweet honey cakes to serve at birthdays and weddings — where they were traditionally broken over the bride's head for good luck! However, the custom of placing candles on a birthday cake comes from

Germany, where a large candle was often situated in the center of the cake to symbolize life. Modern Italian birthday traditions resemble those of America. People gather for a birthday cake, food, a party and gifts. There are some differences, however. Beware of people pulling on your earlobes if you celebrate your birthday in Italy — they will pull the corresponding number of years you are turning. Also, if a group of friends go out to dinner, it is the friend celebrating the birthday who is expected to pay for the meal. Finally, since saints are an important part of Italian society, children are often named for the saint whose day coincides with their birthday. Or they may celebrate on a smaller scale during the day belonging to the saint who shares their name. My father, for example, was born on August 16th, which is Saint Roch's day, and so my grandmother appropriately named him Rocco!

Foods are an important part of birthday celebrations around the world. Australian children can expect to be served the charmingly named Fairy Bread, or buttered bread covered with multicolored sprinkles, during their parties. Children in Brazil receive marzipan candies shaped like fruit. Candies feature in Mexican birthdays as well, where they are concealed in a piñata which is later broken open by blindfolded guests. The Dutch, on the other hand, like to feast on pancakes sprinkled with powdered sugar. Many birthday foods also reflect the theme of good luck for the

ebrating their birthday in China will eat long noodles, which symbolize a long life. Russians have birthday pies instead of birthday cakes, and a message bestowing good fortune upon the birthday person is inscribed on the crust. Finally, Canadian children can expect a more immediate form of luck at birthday parties. Whoever finds a coin hidden in his or her slice of birthday cake will have the first turn in all of the feast's games! In addition to food, sometimes the specific age a person is turning forms the focal point of birthday celebrations. Usually, these special birthdays honor the entrance into adulthood. The United States has "sweet sixteen" celebrations, while Latin American countries hold elaborate quinceañeras when a girl turns fifteen. These parties rival weddings and the girl shares a special dance with her father. In the Jewish tradition, bar or bat mitzvah rituals near a teenager's thirteenth birthday welcome the boy or girl as adult members of the community.

Birthdays are a special time to honor both human joy and resilience. They indicate that we have once again made it through a year filled with myriad human emotions, from happiness to disillusionment, challenges and triumphs. They remind us that we have the strength to endure. Like holidays, birthdays are an indication that the year cycles on, and that is a good reason to celebrate. Whether we celebrate with cakes or dinners, when we honor a birthday, we honor the passage of time, but also all that is timeless — love and family and good food. That is the true meaning of the candles winking and blinking cheerfully on a birthday cake, a symbol that, like us, has come a long way.


## Saint John of Egypt

John of Egypt was born in Lycopolis, Egypt in the year 305AD. His parents were poor and he trained as a carpenter. At the age of 25, he became a monk under the guidance of an elderly hermit.

He spent a decade with the hermit, taking direction from him and learning from him. John Cassian recounts a tale that the hermit directed John to water a dry stick every day for a year. After this test of obedience his superior threw the stick away. When the hermit died, John spent the next five years traveling and visiting monasteries.

John was noted for performing seemingly absurd acts such as rolling rocks from place to place and cultivating dead trees. Finally, he withdrew to the top of a cliff near Lycopolis, Egypt, where he could avoid all human contact. There he carved three small cells out of rock; one for sleeping, one for work and the last for praying.



Then he walled them up with himself inside, leaving only a small window. He communicated through the window to people who brought him food and water twice a week. Crowds would gather on those two days to hear him preach.

John never ate until sunset and lived on a diet of dried fruit and vegetables for fifty years. He refused bread and never ate anything cooked. He lived this way well into his nineties.

He was believed to possess the spiritual gift of prophecy often predicting the future and knowing the details of persons he had never met.

To avoid temptation, but he avoided all people for the last fifty years of his life. Saint Augustine wrote that John was tempted by devils and performed miraculous cures. He cured a woman, according to Augustine, of blindness and then appeared to her in a vision to avoid seeing her in person.

John prayed incessantly, and he spent the last three days of his life without food or drink or any interactions but prayer. He was discovered in his cell, with his body in a position of prayer.

The feast day of Saint John of Egypt is March 27th.

## Mayor Wu Announces New Staff to Improve Access to City Services and Transparency

#### Staff Changes Made to Registry, Public Records, and Parking Clerk

Mayor Wu today announced new leadership to manage key constituent-facing departments, to improve efficiency in the delivery of city services and to better manage public records requests received by the city. Paul Chong will serve in a newly created role as the Commissioner of City Records. In this new capacity, Chong will be responsible for overseeing the Registry for Birth, Death, and Marriages; the Public Records Department; and the Office of the Parking Clerk. Grace Jung will support Chong as the Chief of Staff for City Records, and Mia Capone will be joining the Office of the Parking Clerk in a newly created role as the Director of Parking and Curbside Management. This is a key step to creating exceptional basic city services for Boston residents.

"For Boston to be a home for everyone, we want every interaction with City government to be welcoming and efficient whether residents are applying for a parking permit, getting married, or requesting public records," said Mayor Michelle Wu. "Paul has demonstrated his dedication and determination to serve every constituent and improve our processes. I'm grateful that Paul, alongside Mia and Grace, will deliver the best experience possible for our residents."

Prior to being appointed the Commissioner of City Records. Chong led the Registry Division, which issues more than 100,000 copies of vital records to residents each year. Since Chong became registrar in January of 2023, the city has made significant improvements to records access. The average wait times for birth certificates and marriage licenses are down by nearly 50 percent, and the visits needed to City Hall for these services have been reduced. Under Mayor Wu and Chong's leadership, last year Boston became the first city in the

Commonwealth to remove gender identification from marriage licenses. Chong will continue to serve as the City Registrar in his new role. Chong, a resident of West Roxbury where he lives with his wife and two children, is a graduate of Northeastern University and the Harvard Kennedy School of Government.

"I'm honored to support the mayor's vision and work along-side an extremely talented team," said Commissioner of City Records Paul Chong. "I believe deeply in transparency and good government and am committed to continuous improvement of the City's operations."

Jung, the new Chief of Staff for City Records, will focus on building staff capacity and implementing service improvements. Jung brings eight and a half years of experience in various roles in the Boston Public Schools, including Director of Training and School Support in the Office of Equity. Across roles, Jung worked to prevent and address bias-based conduct and sexual misconduct. including coaching of school administrators and conducting training on district policies. Jung is a graduate of Northeastern University and currently attends Northeastern University School of Law.

"I am excited to support the Registry, Office of the Parking Clerk, and Public Records team," said Chief of Staff for City Records Grace Jung. "I look forward to working with these essential city services to improve processes and procedures and develop policies that improve the lives of our constituents."

"Grace brings tremendous leadership and deep experience working in the public sector, and we are thrilled to have her as part of the team," said Alex Lawrence, Chief of People Operations. "She will help us implement system changes and build capacity for the City to operate more effectively."

As the Director of Parking and Curbside Management, Mia Capone will lead a department that responds to several public-facing city street's needs. These include parking tickets, determining parking disputes, collecting parking fines, and the issuing of moving permits and resident parking permits.

"Parking availability and how curbsides are utilized have an enormous impact on how residents, businesses, and visitors experience a city," said Director of Parking and Curbside Management Mia Capone. "I look forward to engaging closely with stakeholders and staff to modernize parking and permitting processes and policies so we can better meet Boston's parking needs of today and plan for an accessible and sustainable future."

"The Office of the Parking Clerk is a critical part of the Streets Cabinet and the Boston Transportation Department," said Nick Gove, Commissioner of the Boston Transportation Department. "Mia will ensure that Boston continues to build a world class curbside experience and provide innovative leadership in improving our services."

Capone joins the City of Boston from the Government Performance Lab at the Harvard Kennedy School, where she led work to transform the City of Syracuse's procurement systems to be more data-driven, efficient, and fair, resulting in increased opportunities for local and diverse businesses and improved delivery of contracted services to constituents. Capone has nationwide and international experience working with municipal governments and leading complex project teams to improve government operations and the delivery of services to diverse communities, with a focus on equitable impact and sustainability. Capone is a graduate of Harvard University.

#### **Last Great Buffalo Hunt**



July 4, 1882 — The "Last Great Buffalo Hunt" began on Indian reservation lands near Hettinger, North Dakota as 2,000 Teton Sioux Indians in full hunting regalia killed about 5,000 buffalo. By this time, most of the estimated 60-75 million buffalo in America had been killed by white hunters who usually took the hides and left the meat to rot. By 1883, the last of the free-ranging buffalo were gone. In 1882 and 1883, the American buffalo made their last stand here in the valley of Hiddenwood and within a 30-mile range of this area. Hiddenwood Cliff, directly opposite Hiddenwood Creek, was an ancient landmark for buffalo hunting tribes who often camped in these buttes and badlands.

The last 50,000 free ranging buffalo had migrated into this area, which was then part of the Great Sioux Reservation from territories farther west. Within 15 months they were gone. Although most of the estimated 60 to 75 million buffalo were likely killed by white hide hunters, these last buffalo were hunted by Native Americans in traditional ways on reservation lands.

The last great buffalo hunt began about June 20, 1882, when 2,000 Teton Lakota men, women, and children traveled 100 miles from Ft. Yates to this valley on foot and horseback, and saw the hills black with thousands of grazing buffalo. On the first day 2,000 buffalo were killed, pursued by mounted hunters with rifles. The hunters painted their faces, bodies, and horses in traditional ways for a successful hunt. Very few hunted with bow-and-arrow. After the first day, the buffalo remained where they had fallen and the hunters returned to camp long after dark, too tired to even celebrate or tell stories. On the second day the entire tribe worked quickly to butcher and care for the meat. Humps and other tender parts were removed for immediate feasting, and women sliced the remaining meat into thin sheets to dry and make into pemmican and jerky. On the third day, the hunters killed an additional 3,000 buffalo. In three days, the tribal hunters killed 5,000 buffalo on this "last great hunt."







A Nostalgic Remembrance



Something I am experiencing as of late, new acquaintances wanting to know my opinion on politics and religion. In either case, a conversation centered on either topic puts me in a no win/no win situation. If I were to defend any side, regardless of what it is, I put myself at a disadvantage, so I make light of things with unorthodox answers that usually cause these potentially adversarial opponents to change the subject.

As an example, when anyone who is probing asks me about President Trump and I know where they are coming from, I answer, "Oh, I'm not a Trump supporter. He's way too liberal for me." This usually shuts them up. When I've been asked about religion, I tell them I'm a Six Day Buddhist. Many know what a Buddhist is and some know what a Seven Day Adventist is but not my Six Day Buddhist religion. They will then ask me about the religion and my come back shuts them up, "We pray to Our Lady of the Heartbreak of Psoriasis, and we believe that when you die, vour soul goes to a used car garage in Chelsea or Brooklyn, depending on whether you live, Boston or New York." Again, this shuts them up and I go on my merry way.

The ones I am afraid of are the revisionists, the people who are trying to change history by erasing what they feel was wrong with it. As a perfect example of the attempt to change history is the destruction of the Christopher Columbus statue in the North End. Most of those activists who robbed us of our Italian admiral did this not knowing who Columbus really was and what he did and didn't do. They are reacting to a revisionist pandemic that is as bad for our future as the Corona Virus was for our health a few years ago.

The practices differed dramatically, but the essence of each was the same, a belief in God, a set of laws to live by and a concept of good and evil which affects us on Earth and beyond. When I looked at the Asian religions, Hindu and Buddhist, Shinto, etc., they were very different, but some of the same tenants I found in our western beliefs were the same, a belief in god(s), a set of laws to live by and a concept of good and evil which affects us on Earth and beyond.

One of my more reflective students once asked why we humans don't look for what makes us similar rather than what makes us different from one another. I wish I had had an answer for him. When I was young and Sal Meli and I traveled around the world, I would look for similarities between us and the people of the country we were in, and once they were established, we made friends. This includes people in Europe, Africa, Asia and Latin America (I've never visited Australia).

Even then, the image of the "Ugly American" was out there. It was shown to us in Puerto Rico in the mid-sixties. I was playing with a band in San Juan, P.R., and Sal had come to the island for a few weeks. After work one night, we decided to head into the hotel's casino and try our luck. We hit it big on a crap table, and the next morning headed to a local bank where I had an account, and deposit our winnings.

We headed for Old San Juan where the bank was located and were stopped by two tourists, a man and a woman who were trying to ask us something in Spanish using a Berlitz phrase book. We didn't understand and I was about to switch to English when the man said to his female companion, "Just like these Spics, they don't even know their own lingo." Sal continued speaking Spanish as the man flipped through his book looking for translations. Finally, he understood and thanked us by taking a quarter and placing it in the palm of my right hand while saying to his companion, "So they won't starve to death." I looked at the quarter, showed it to Sal and in Spanish said, "Oh, look a quarter." I then dropped it in the man's shirt

pocket and said in perfect Boston English, "Sir, you may need this more than we do." At that point, Sal removed a wad of hundreds from a carrying case and began to count the bills. The couple was fit to be tied and walked away as both Sal and I laughed. I later got mad saying to Sal, "What if we were local farmers coming to the big city for the first time and were exposed to this type of tourist? I then understood where the term "Ugly American" came from.

If Babbononno and Dad were still alive, I would ask them where we go from here. Do we let the revisionists change our history to coincide with their distorted concepts of the past, or do we learn from the realities of the past and hope not to make the same mistakes again??? I wonder how they would respond to the way things are evolving in today's America.

My suggestion for our future is to forget our differences and team up to put together a more perfect union. Our Constitution isn't perfect, but we can amend what doesn't work. It is not perfect, but it is better than any other political document that now exists on this planet. It allows for democracy. It allows us to be all we can be without restrictions put in front of us. Why is it that most countries have to put up borders to keep their people in and we have to put up borders to keep their people out (illegals). There is no country as diverse as the United States. I remember a conversation with Nanna about when she first arrived in New York. Before she left Ellis Island, she entered the gift shop and bought a model of the Statue of Liberty and kept it in plain sight for the rest of her life. It represented America to her, and freedom for all. I wonder if it still does?



In Italy, debates over the origins of certain dishes are common, but not with Caponata. This delectable "eggplant relish" is firmly rooted in Sicily, often hailed as Sicily's version of ratatouille. While they may be similar, Caponata is considered far tastier. Initially served in Sicily as a fish accompaniment, today it is enjoyed with octopus, poultry, and even as a delicious topping on Bruschetta.

Every family has their own unique way of making Caponata, with some families even having multiple recipes. My Nonna typically made hers without a set recipe, adjusting the ingredients based on the preferences of those she was serving. If someone didn't like raisins or pine nuts, she would simply leave them out. The recipe I'm sharing is easy to make and consistently turns out perfect. It's especially delicious as a topping on bruschetta. *Enjoy!* 

## CAPONATA Sicilian Eggplant Relish



eggplant (the fatter, the more seeds)
½ to ¾ cups olive oil
1½ cups chopped celery
2¼ cups chopped onions
6 ounce can tomato paste
¼ cup red wine vinegar
2 tablespoons sugar

2 tablespoons capers, rinsed and drained 12 green olives, sliced salt and freshly coarse ground black pepper to taste Optional: 3 tablespoons raisins and a handful of pine nuts (I make it with raisins)

#### 1. Prepare the Eggplant:

- Wash, dry, and cut the eggplant into 1-inch cubes.
- In a sauté pan, add about ½ cup of olive oil and the eggplant.
   Cook over medium heat until softened. Remove the eggplant.
- Cook over medium heat until softened. Remove the eggplant and set it aside.

#### 2. Cook the Vegetables:

- In the same pan, add the onions and celery.
- Sauté over medium heat, adding more oil if needed, until the onions are translucent, and the celery softens.

#### 3. Combine Ingredients:

- Add the eggplant back into the pan along with the tomato paste and ¾ can of water.
- Reduce the heat to medium-low and cook for about 15 minutes.

#### 4. Simmer the Mixture:

- Reduce the heat to low and add the vinegar, sugar, capers, olives, and (if preferred) raisins and pine nuts.
- Mix well and cook covered for about 20 minutes.

Cool well and enjoy. Refrigerate leftovers.

\*\*Note: In Sicily, many even add a teaspoon or two of pure cocoa powder to this mixture!

## Massachusetts Removes Major Hurdle for Everett Stadium Soccer Plan

The Massachusetts Senate unanimously approved an amendment in an Economic Development Bill that includes land for a new soccer stadium in Everett, specifically for the Major League Soccer (MLS) franchise, the New England Revolution (Revs). A similar bill was approved in June by the House of Representatives, with the full proposed bill heading to Governor Healey's desk for her signature.

The bill, sponsored by Middlesex/Suffolk State Senator Sal DiDomenico, removed the land as a "Designated Port Area", and would re-classify a 43-acre parcel of land owned by Wynn Resorts and Casino along the Mystic River "for the purpose of converting the parcel into a professional soccer stadium and a waterfront

The Massachusetts Senate nanimously approved an mendment in an Economic evelopment Bill that includes and for a new soccer stadium park." There are still many issues to overcome, including environmental and transportation reviews from the state as well as local zoning approvals.

The quest to find a permanent home for the Revs, owned by Robert Kraft and the Kraft Group, has been ongoing since 2006. The Revs began playing in 1996 with their first eight seasons at Foxboro Stadium, before moving to the newer Gillette Stadium. Gillette holds close to 65,000 fans for Patriot games, but the Revs play in front of a reduced 20,000 fan capacity. Finding a permanent site in the Metro Boston Area has been a goal of the Revs since 2010. The team will have five years to develop the venue before the land reverts back to its "Designated Port Area" Status.

## **Eleven parking Spaces Lost in Day Square, East Boston**

What may seem an inconsequential or minor change to the City of Boston Transportation Department is in reality a major impact to an already congested Day Square Business District.


In order to accommodate an activation and engagement area, with programming offered by Veronica Robles, tent structures were placed in the middle of Day Square, resulting in the loss of 11 parking spaces, including 1 handicapped space.

This is just the first step by the City of Boston Transportation Department, the newly created Boston Planning Department and the MBTA to re-design the "Day Square Plaza Station" as these agencies have labeled it.

At an emergency meeting, attended by a large group of Day Square Business owners and one City of Boston Transportation Department representative, just before the 4<sup>th</sup> of July long holiday weekend, the business owners requested a delay in the installation of these tent structure, but as par for the course, the city moved ahead, without any communication or notification to the businesses or patrons.

What many business owners are asking is who will be responsible for the maintenance and security of these structures? What days and hours will the programming be offered? There are many gaps in information that need to be filled in. As one business representative commented, "once again it seems like the city put the cart before the horse, and rushed to remove parking spaces even before programming details were finalized and put into place."

The business owners have made a number of requests for a follow up meeting, and are growing impatient with the stall tactics of the departments and agencies. Hopefully, our state and local elected officials will step up and offer some much-needed assistance to this group.



### Prune Raspberries for an Abundant Harvest

A bit of summer pruning goes a long way to keeping your raspberries healthy and productive. So, get out the mosquito netting, long sleeves, and pruners and get busy.

The summer harvest is produced on 2-year-old canes called floricanes. Remove those that bore fruit to ground level once your harvest is complete. These canes will not produce more fruit and their presence can increase the risk of insect and disease problems. This is also a good time to remove damaged, insectinfested, or discolored canes.

Summer is also a good time to thin the remaining canes on summer-only bearing raspberries. Remove weak or damaged canes, leaving three or four of the sturdiest canes per foot of row or six or eight stems per hill when growing in the hill system. Thinning increases airflow and light penetration, resulting in

healthier plants and a better harvest next season. Wait until next spring to reduce the height of the remaining canes. At that time, you can determine winter dieback, and damage, and *prune* accordingly.

Everbearing raspberries are often called fall raspberries and form fruit on first-year canes called primocanes. You can manage these types of raspberries for a single fall harvest only. Wait until the plants are dormant then cut the whole planting back to ground level. There will be a larger and earlier harvest when pruning everbearing raspberries this way. Although this pruning technique eliminates the summer crop, it is much easier, less time-consuming, and eliminates animal and winter damage in just one cut.

The other option is to prune everbearing raspberries for a fall and summer harvest. The new growth produces the fall crop. These canes are left to produce berries the following summer. Prune these two-year-old canes after the summer harvest as you would on a summer-only bearing raspberry.

Maximize your summer and fall harvest by planting a summer and a fall-bearing raspberry patch. You'll enjoy summer raspberries from one planting plus a larger, earlier harvest from the fall-bearing raspberries when pruning all those canes to ground level each year during the dormant season.

Don't let a lack of space keep you from growing delicious raspberries high in fiber and vitamin C. Plant, train, and use raspberries as a hedge in your landscape. Or grow the new compact and thornless Raspberry Shortcakeâ in a container or any sunny small space in your garden. You may not be freezing a large harvest from a single pot of raspberries, but you will enjoy fresh-from-thegarden raspberries even in your small space.

A Boston City Council subcommittee held a recent hearing on congestion pricing a few weeks after NYC dropped that whole idea. Apparently, it didn't prevent city councilors in Boston from exploring the idea. A few councilors seemed to like the idea of a fee for drivers entering the downtown core.

However, District 3 Councilor John Fitzgerald cited a need for hesitancy and said he found it a hard sell, the downtown area was "taking a beating lately" with declining office building values and the potential for higher commercial taxes.

As Fitzgerald stated, "I do worry about this diverting people, when we need people to come into the city, that this

#### Let's Talk About the Preponderance of Pitching Injuries this Season

Is it just me or are there lots of pitching injuries happening this year to major league pitchers? I think there are but what is causing the uptick in numbers. I have two ideas about what is going on. I see all the new rules spending up the game having a negative impact on pitchers trying to navigate. Throws to first and pitch clocks are throwing the timing for pitchers off. The new rules could be messing up arms and affecting shoulder injuries. Just a thought. The other reason could be pitching speeds. Everyone on the mound is trying to up the speed of their pitches into the batter's box. More and more pitchers are trying to reach 100 mph more often than ever. They think fastballs need to go faster and faster.

I am old school. I remember seeing the greatest pitchers when I was growing up in the late 50s and into the 70s. They loved fastballs too, Look at Dick Radatz on the Sox. He only had his fastball. He was a one trick pony. He was great for three seasons and then his shoulder and arm turned into jelly and he was out of baseball in short order. Another guy was Sandy Koufax, he loved his fastball too but a catcher on the team Norm Sherry gave him food for thought and Koufax added a few more pitches to his game. Too bad Sherry didn't get to him sooner. He was forced to retire at the top of his game at age 33. He was an instant Hall of Famer but he only had 154 lifetime wins. Had he pitched longer, he could have gotten to maybe 300 wins or close to that number.

There are lots of pitchers past and present who loved their fastballs but for many it was a two-edged sword bringing early retirement to some or lots of lasting pain. Was it worth it or not?

## Happy Birthday EZZAARD CHARLES

July 7, 2021 marked the 103rd anniversary of the birth of Heavyweight Champion Ezzard Charles. For many years Charles was considered the most underrated heavyweight champion. Over time that has changed and Charles is now recognized as one of the all-time greats.

His record of 95 wins with 25 losses and 1 draw contains a who's who of great fighters. He twice beat the great Charley Burley, not an easy feat but one he did decisively. He was also the only man to go the distance with Rocky Marciano in a title fight, giving the Brockton Block Buster a very difficult time of it.

Fifty-two of Charles's 95 victories came via kayo. He was the epitome of the boxer/puncher. A superb counter puncher with lethal power. He was as gentle out of the ring as he was vicious inside the ropes.

Charles won recognition as heavyweight champion when he won a fifteen-round decision over Jersey Joe Walcott in 1949. The title had been left vacant with the retirement of Joe Louis.

Charles would go on to win a decision over Louis who came out of retirement. He would also win a rematch with Walcott. In the third meeting between

Walcott and Charles, Jersey Joe scored a spectacular knockout to win the title. The two fought one more time in 1952 with Walcott winning a close decision.

Following the loss to Walcott, Charles lost a decision to Rex Layne. His career appeared to be on the slide, but he then ran off nine straight wins before dropping a decision to Nino Valdes in 1953. In his next fight he lost a decision to Harold Johnson. Again, it looked like the end of the road for the former champ.

Kayo wins over Coley Wallace and Bob Satterfield were enough to earn him a shot at Champion Rocky Marciano in 1954. In the

suffered a severe cut on his nose. Rocky pulled the fight out with a knockout in the eighth-round.

Charles's dreams of regaining the title came to an end that night. He continued to fight on but was by now a shell of his former self. He lost 13 of his

first fight Charles lost a hardfought decision. In the second

fight, on September 17, 1954,

he nearly stopped Rocky who

former self. He lost 13 of his last 24 bouts. Those thirteen defeats make up the majority of his career losses.

It was not until the very end of his career that Ezzard entered the ring weighing 200 or more pounds. He began fighting as

in the 185-pound range for his prime years as a heavyweight. Ezzard started out as a middleweight, and while he may have moved up to the heavyweight division and gained the title, he never stopped fighting as if he still weighed 160

a middleweight and weighed

pounds.
Ezzard Charles died on May 28, 1975 at the age of 53 after a long battle with ALS.

I always thought Charles looked more like a jazz pianist than a boxer. He was indeed a musician in the ring with boxing gloves being his instrument.



There was an absolutely a stop-you-in your-tracks column recently in USA Today that should be read by anyone concerned about the welfare of sports in this country. Written by Bob Nightendale, it presented in some detail the effect that gambling is having

Incidents such as:

Players being verbally threatened by fans seated down low at games for not coming through on the certain prop

on our nation's great game.

In some instances, players being followed back to their resi-dences by irate gamblers. The article noted that this could even extend to members of the front office, with one unnamed GM admitting that he had requested police protection for his residence.

Threatening not only players but the family members of players with physical violence.

Most agree that the problem originates with bettors who bet a bit over their own financial heads but instead of calling it a day, bet again and lose again, meaning they are now in an even deeper financial hole.

Plus, as one player noted, it is so easy to gamble now, noting that anyone can do it with a phone. No longer is it necessary to visit a special venue dedicated for that activity such as a racetrack or even a casino. You can do it from your phone.

Plus results—with plenty of stats—are available in real time—as fans sit in the stands with their phones throughout the game. They no longer have to wait to see if they won or lost their bet.

Yes, right now, in the summer of 2024, this is the seamy side of Major League Baseball which once experienced the Black Sox scandal of 1919. But while that involved certain players on the team trying to get back at the team's owner, this is much more pervasive, having the potential capacity to affect every team, every player, every umpire and every front office in some way.

By and large no one seems to question the integrity of the players — who are already paid millions to play the game. Rather it is the behavior of the gamblers themselves and their threatening behavior that is being thrust into the spotlight.

Not only this summer (but for apparently a number of past summers, according to numerous players) this has been a reality within the MLB community.

But summers don't last forever, Hints of fall ever so gently touch the horizon despite the recent heat wave.

Especially with Division One college sports, what will happen when players fall short of their normal stats in certain basketball and football games? Most Division One players don't make that much from Name and Image and Likeness programs. We think they may

well be more vulnerable to the temptation to interact with gamblers than the highly paid pro athletes. And we also think that college basketball is particularly vulnerable in this regard.

Also, since most colleges have quite a bit of congregate housing (dormitories), the problem may already literally be inside. Non-athletic students who like to gamble may be living on the same floor as members of varsity athletic teams. And those non-athletes may have their contacts with, how shall we say this, certain members of the outside world.

Sadly, the various pro sports leagues, college conferences and even the NCAA have brought this sorry scene not only to our doorsteps but right inside our homes. Gambling on sports has been "normalized" in a way that would have seemed impossible a few short years ago. Frankly, we do not know where all this is headed but the direction sure seems far from positive.

For the colleges, the academic year (and hence the start of athletic activity) begins in a few short weeks.

It is a time to look on the bright side with the start of the colorful games, pomp and ceremony plus glory for the successful about a month away. But something else may be riding in the wind, a festering poison that could have the capacity to change things in the worst way. It will be up to the leaders of college athletic programs to be on their highest alert throughout the coming year.
