

ORDER OF ARCHITECTURE



Doric Order

The Greeks took the civilizations of Egypt and Mesopotamia, added to them and improved them. During this process they developed what came to be known as the "Order of Architecture." An Order of Architecture may be defined as a column setting on its base, plus the horizontal structure (entablature) above it. The Greeks developed three Orders. They are named Doric, Ionic, and Corinthian. The development of these Orders was based upon strict mathematical proportion, and any attempt to vary from the established rules would cause an optically distorted or disproportionate structure.

Ionic Order

dish-shaped section under a square block. This eases the transition from the vertical lines to the horizontal at this critical point.

The special feature of the Ionic Order is its volute or scroll capital. It was influenced by the Egyptian lotus, Mycenaean jewelry, and ram's horns.

The special feature of the Corinthian Order is the acanthus leaf, from plants that grow in the Mediterranean region. Its employment in the design of this column capital is credited to Callimachus, a worker in Corinthian bronze. He received his inspiration after observing a funeral basket over the grave of a Corinthian maiden.

When the Romans conquered the Greeks, they accepted and used the Doric, Ionic, and Corinthian Orders, but added two more of their own design. These

Corinthian Order

two are called the Tuscan (similar to the Doric but without the vertical flutes), and the Composite (a combination of Ionic and Corinthian).

The Doric is the sturdiest of the Orders. Its finest examples are on the Parthenon (Athens) and at Paestum (modern Pesto, south of Salerno). The second story around the Coliseum in Rome has an excellent example of the Ionic order. The Corinthian Order can be seen on the Pantheon and on the Arch of Constantine (Rome). The first story around the Coliseum displays the Tuscan Order, and the Arch of Titus (Rome) shows the Composite Order.

L'Anno Bello: A Year in Italian Folklore

History, Heritage and a Happy Fourth!

No other holiday smells, tastes or feels like summer more than the Fourth of July. It is the scent of fired-up grills emanating from every American backyard, the light swirl of smoke rising up in the hazy heat. It is the taste of sweet buttered corn crunching between your teeth. The Fourth of July encompasses the sounds of families laughing as they share food and memories outside, and of fireworks exploding across a silky night sky. To this day, I still feel a mysterious shiver when I hear the faint sound of fireworks bursting from some far-off festival during a starlit evening. These distant fireworks instill in me the feeling of the unknown, the sensation that little feasts are sweeping the country before the big celebration of Independence Day. Because of these exciting and myriad feelings, the Fourth of July remains one of my favorite holidays, the quintessential celebration of summer. It is a commemoration of family and food, patriotism and heritage, history and diversity, all converging in a brilliant summer day.

Had Massachusetts representative John Adams been correct, we would have been honoring our country's Independence Day on the second of July. That was the day in 1776 when, during the height of the Revolutionary War, the convention of delegates from the Thirteen Colonies, known as the Second Continental Congress, approved a resolution that declared independence from Great Britain. Adams predicted that this day would forevermore be marked with parades, bonfires and games. In reality, Adams's speculation on the nature of Independence Day celebrations proved accurate, only the date shifted to the fourth, when the Congress finally approved this declaration after much revision. Therefore, the Fourth of July commemorates a tremendous event—a bold statement of independence, a desire to free oneself from oppression that would inspire revolutions the world over. As a patriotic holiday, the Fourth of July is also a perfect time to honor America's diversity, and during this holiday, I often reflect on what it means to be Italian-American. Italians have been involved in America's quest for liberty and equality since the country's early days. The Tuscan physician Filippo Mazzei inspired the Declaration

of Independence's statement that everyone has fundamental equality. Giuseppe Garibaldi, the hero of Italian independence, was recruited to fight in the Civil War and though he did not because of his commitment to Italy's freedom, his name inspired a Union Army regiment comprised of soldiers from both Europe and America. An Italian immigrant, Constantino Brumidi, painted the U.S. Capitol dome. I believe that America's diversity and blend of cultures is precisely what makes our country so great, and on the Fourth of July I celebrate my pride as both an American and an Italian-American.

Along with its history, the Fourth of July is also a revelry in the primordial pleasures of summer, of outdoor festivities and food and fire and the splash of water. In this way, it resembles European Midsummer celebrations, which mark the height of the season around the summer solstice. My family has several Fourth of July traditions which I hold especially dear, all of which epitomize the unbridled joy of summer. On the night of July 3rd, my husband and I watch a fireworks display put on by our old hometown. As we sit in the stands of the high school football field, we are surrounded by images of vintage Americana: children playing tag across the field, glow sticks waving like little bursts of starlight brought down to Earth, snatches of classic rock tunes, and streaks of color illuminating the night sky as the crowd hushes with awe. On the Fourth, my family gathers for a festive meal which would not be complete without my two Independence Day mainstays: a Southwestern corn pudding and, for dessert, Zebra Pudding, a delectable dessert consisting of chocolate wafers layered with

whipped cream, decorated with chocolate sprinkles, and refrigerated until properly cool and the wafers turn soft. My mother usually makes a panzanella salad and, as an appetizer, a dip of salsa and cream cheese served with tortilla chips. As we gather for food and fun, we laugh and share nostalgic and funny stories as the hot summer day descends into a balmy, firefly-filled evening. I will always be thankful for this day of community, love, pride and food!

The Fourth of July grants us an opportunity to pause and reflect on what is most important in life. As we celebrate the freedoms that make America wonderful, we should pause and honor the sacrifices of the men and women throughout history and the modern day who made these freedoms possible. We should take this holiday as a chance to feel proud to be an American but also proud of our ethnic heritage, which contributes to our unique identities. Finally, we should see the Fourth of July as a prime feast of summer, and all of the joys that the season entails. With that, I must take the time to wish everyone ... A Happy and Safe Fourth of July!

Juneteenth Day More Than Just A Day in U.S. History

I was present at the Statehouse on June 16th to commemorate the 156th anniversary of Juneteenth Day. Massachusetts sanctioned slavery as a British colony and when it became one of the 13th colonies that created the United States of America. However, in 1781, Massachusetts abolished slavery and in 1865 ratified the 13th amendment of the U.S. Constitution which abolished slavery in this Nation. This is a history all Massachusetts should be proud of.

I was shocked to see seven Republican Congressmen who voted against creating a Juneteenth National holiday. The bill passed overwhelmingly but even seven GOP No votes is seven votes too many.

One congressman, U.S. Rep. Andy Biggs, R-AZ, stated he didn't like the name of the holiday. It should have been called Juneteenth National Emancipation Day not Juneteenth National Independence Day. He insisted he supports celebrating Juneteenth Day and "thinks

that is a critical part of our nation's history but the Democrats have weaponized this bill."

Other Republicans seemed in agreement with his perspective. U.S. Rep. Paul Gosar, R-AZ said Juneteenth "is more debunked critical race theory in action and does not bring us together." Another, U.S. Rep. Chip Roy, R-TX spoke of the need to use this new holiday to "bring us together (but is) creating a separate Independence Day based on the color of one's skin."

For the longest time I considered myself a center-right Democrat but lately the Democrats have moved far too left and almost off the cliff. I re-registered as unenrolled because I also had little faith in Republicans.

I grew up in the bordering neighborhood of Lower Roxbury where it met the South End with all kinds of people in the '50s and '60s. There is no good reason to believe that Juneteenth would divide Americans. I see this holiday as one that can bind us together as one people. Juneteenth Day doesn't upend the Fourth of July Holiday it can only strengthen all of us as being Americans.

U.S. history has many blemishes over its lifetime. On July 19, 1865, Black Americans in Texas got the word about their emancipation but to them it would be just a word for at least another 100 years. Many African Americans have dubbed the day Freedom Day but it was freedom on paper. For nearly another century slavery may have been abolished but it was replaced by state sanctioned segregation and I was 16 years old when the Civil Rights Act of 1964 was finally passed and then signed into law.

I remember the Civil Rights era and it was an ugly period for America and much has improved for the better but the struggle for equality is a never ending struggle by all of us.

We need to stop this divisiveness and remember the lessons of Dr. King of being human beings first and stand together against injustice where it can still rear its ugly head.

If this is the true understanding of the significance of Juneteenth Day then making it a holiday seems like a national mandate for all of us.



We all gathered at Grandma's flat at 5 o'clock in the evening. Grandma was agitated and was anxious to get to church before the bells began to chime, signaling the Saint was on the way to the church. Charlie, Bobby and Pietro were in their surplices and cassocks, they had put on at the church. They wore them to Grandma's, knowing she would get tremendous pleasure, seeing them dressed for the procession. Grandma noticed the hem on Pietro's cassock had torn lose. Immediately, she took out her needle and thread and basted a new hem without Pietro having to remove it. Charlie somehow managed to get his surplice soiled, somewhere between the church and Grandma's. Once again, she swung into action. She had Charlie take off the surplice, washed the spot gently on her wash board in the kitchen sink, and blotted it dry with kitchen towels; the surplice was good as new, and the emergency was over. Once all repairs were completed and she felt we were properly representing the family, Grandma gave the signal for the family to leave for church. It was now 5:20 and the Saint was expected in ten minutes. Even Auntie Stella seemed excited. She helped Grandma straighten her hat, anchoring it with the large hat pin with the artificial pearl at one end, fastening it to Grandma's pug. Quickly, we made it down the stairs and onto the street with Charlie, Bobby and Pietro running ahead of everyone to be at Father Francesco's side, who was waiting at the entrance to the church. The rest of the family joined the crowd already gathered at the front of the church, awaiting the arrival of the Saint.

Meanwhile, back at the Saint Andrew Shrine, the procession



was getting ready to depart. The Saint had been removed from his pedestal, carefully placed on the litter, to be carried through the streets of the North End by members of the Society. The procession would make its way to the waterfront, where fishermen and their boats had congregated between Commercial Wharf and Long Wharf, gingerly working their boats forward, to get as close to the shoreline as possible.

"One, two, three, lift!" Sonny, the lead litter bearer, called out to his team. The eight burly men hoisted the litter now bearing the Saint onto their shoulders. The statue lurched first to the left, then to the right, steadied by the men moving in a counter direction. When he felt the statue was ready to travel, Sonny gave the word to Sam, the director of the band. Sam waved his hand and the band began to play. A second wave, and the band moved out. The ten men, who made up the band, moved in unison, rocking to the left, then to the right, as they made their way to North Square, the litter bearers following just behind. The crowd instinctively separated, allowing the band and the litter bearers to pass through their midst. The litter was set on a low platform erected in front of the church, just for the purpose. The bells of the church were ringing

from a bell tower, that in the nineteenth century, once called Methodist worshipers to this former Seamen's Bethel, where it is said, Herman Melville visited while writing Moby Dick. The ringing of the bells added pageantry and a momentous feeling to the occasion. The band and the Saint were greeted by Father Francesco, who was dressed in a spectacular gold embroidered chasuble that shimmered in the late afternoon sun. Beside him stood Pietro, holding a brass urn of holy water and a sprinkler, meant to be used by Father Francesco to bless the fleet of boats and their crews. Just to the right of Pietro, on a brass stand, was the thurible sending up puffs of incense scented smoke. Just behind Pietro, dressed as altar boys, stood Bobby and Charlie on either side of him, carrying processional candles. Mom, Grandma, Auntie Angie and Auntie Stella worked their way to the front of the crowd, standing just behind the Saint, as the crowd continued to gather in North Square.

My dad had American Ice Cream and Sandwich Shoppe on Sumner Street for about 18 years. He started it with his 4 brothers and parents, and many of my memories in Eastie involve either working there or hanging out during the summer or after school. I really miss all the flavors we used to have, including butter crunch, black raspberry, and strawberry cheesecake, which I have not eaten since my dad sold the business in 2006.

I remember big lines on hot summer nights, when we would stay open past closing at 9:00 p.m. just because the people couldn't get enough of that French vanilla, or Richie's lemon and watermelon slush. It was also fun being the last stop for the little league parade, where we would hand out ice cream bars to all the kids. 4th of July was also a great time, when people would come by before or after watching the Tall Ships come in.

Not only did we have a ton of flavors of ice cream, but a full slew of sandwiches and specials, and I loved having a meatball sub or a steak-bomb hot off the grill. People loved to come in for the frappes and banana boats, but the marinated steak tips were just as much of a draw.

We also served breakfast, and the specials were all named after famous American Presidents, with the Washington, the Jefferson, the Adams, and

also the massive constitution breakfast, which included 3 eggs, bacon ham and sausage, home fries, French toast and coffee. My dad is the son of a Korean war veteran, so maybe he thought he could teach a little American history while serving delicious food.

My dad's parents held court, with my grandma engaging customers with her sage advice at her customary spot at the end of the counter, and my grandpa would stay all day, keeping a close eye on all the comings and goings. When they passed away, things changed a bit, so it was time to move onto other ventures.

Thankfully my dad got back into the food business, after working for East Boston main streets helping businesses renovate their storefronts throughout East Boston, he got the entrepreneurial itch once again. He bought Gloria Foods on Cottage Street in 2012, and renamed it to Carmella's in honor of my mom. So now instead of scooping cones, he's slinging subs and slicing the salami and grating the cheese all day.

I will never forget the times we had putting smiles on peoples faces with the delectable dishes and delicious deserts throughout the '90s and early 2000s, and now I love seeing my dad still doing what he loves, keeping his heritage alive and making an amazing Italian sub.

Saint Bertha of Artois

Born in mid seventh century Gaul (France), Saint Bertha was the daughter of Count Rigobert, the Mayor of the Palace under King Clovis II. Her mother Ursana was the daughter of the King of Kent (in England). Bertha married Sigfried, who was related to the king, at age twenty and had five daughters, two of whom, Gertrude and Deotila, are Saints.



When her husband Siegfried died in 672, after nearly twenty years of marriage and five daughters, Bertha was determined to become a Religious.

In the year 682 or 685 Bertha had founded a convent at Blangy, Artois (now Blangy-sur-Ternoise). Legend has it that two buildings which Bertha constructed had fallen down, but an angel in a vision guided her to another spot, and there after many difficulties a nunnery was built, at Blangy in Artois, which she entered with her two eldest daughters, Deotila and Gertrude.

Bertha was persecuted by Roger or Rotgar, who endeavored to malign her to king Thierry III. to revenge his being

refused Gertrude in marriage. But Thierry, convinced of the innocence of Bertha gave her a kind reception, and took her under his protection. On her return to Blangy, Bertha completed her convents, and caused three churches to be built, one in ho of St. Omer, another she called after St. Vaast, and the third in honor of St. Martin of Tours.

Later, her daughter Deotila succeeded her as Abbess, when Bertha retired to live the life of a recluse, solely devoted to prayer. St Bertha died at an advanced age of natural causes on July 4, 725. Her feast day is celebrated on July 4th.

Nanna & Babbononno

A Nostalgic Remembrance



Right after the 2nd World War began, life changed for the Christoforo/Contini family.

My dad and uncles had been on the road with the big bands (except Uncle Gino) and that came to an end with the beginnings of the war. Uncle Paul went to work days as a journeyman printer, Dad accepted a job teaching machine shop at his old alma mater, East Boston High School, Uncle Nick got hooked up with a band that played for the dinner crowd at one of Boston's hotels, and Uncle Gino went to work at the Chelsea Navy Yard. All just waited for the draft to catch up with them, because we were at war on two fronts, and early on, it was called World War II.

By the summer of 1942, Uncle Nick was called, and to avoid the draft, enlisted in the Navy. Uncle Paul was rejected due to his age and never went into the military. Once Uncle Gino was called, he enlisted in the Army Air Corps. Dad had a high lottery number, and wasn't called right away, but by the end of 42, or early 43, he was approached by the OSS (the Office of Strategic Services) ... the forerunner to today's CIA, and asked to become a part-time operator for their Boston division. It seems that they were housing Italian war prisoners at some of the old forts on Boston Harbor Islands and at the closed immigration station on Marginal Street in East Boston. They needed someone to interrogate the captured soldiers, and somehow, Dad's name came up. With Babbononno as his recording secretary, he accepted the job on a part-time basis. (He actually needed Babbononno. Dad couldn't read nor write Italian and barely spoke the dialect he learned from his father.) So, Dad's schedule included teaching at EBHS, working for the OSS, and, oh I forgot, playing six nights a week with a quintet, the Jimmy McHale Orchestra, at the Fife and Drum Room, a downstairs café at the Hotel Vendome on Commonwealth Ave. He would eventually work in coaching football.

Gasoline became rationed early on and all car owners were issued rectangular stickers that were placed on the bottom corner of the passenger's side of the windshields. Most people were issued stickers with a capital "A" in the center. They were only able to buy, I believe, five gallons of gas per week. Dad and my uncles were issued stickers with a capital "B," which allowed the purchase of ten gallons per week. Ration books were also issued, and a

person buying gas had to hand over ration stamps that corresponded to the purchase. This meant that there was no joy riding or side trips. Most cars were used for business, and that was it. Oh, and new tires were impossible to get, which didn't help the situation.

It was the summer of 42, and Babbononno wanted to have a dinner for his family before they all went off to fight the war, with, God forbid, some never returning home. Back then, there was no home air conditioning. There were window fans or just screens located on the outside of open windows. As a result, it was often too hot to cook and eat in an East Boston kitchen. The alternative was a kitchen in the cellar where it was a bit cooler than on the upper floors.

In the cellar was the old ice box that was replaced by an electric refrigerator in the kitchen. There was the old kitchen set that was replaced by a new one just before the war. Along with this was a black soap-stone sink. Surrounding these creature comforts were shelves where Nanna stored the vegetables she had prepared the winter before. Not too far away, were the barrels filled with the red and white wines vinted by Babbononno and almost ready to drink. This was the downstairs summer kitchen.

Outside in the back yard was another table and six to eight chairs that had been in the cellar at one time and in the upstairs kitchen even before that when they were new. If the day selected for the dinner was a good one weather wise, this is where they would all eat, al fresco.

A Sunday was selected and both Nanna and my mother prayed to St. Anthony for good weather. He answered their prayers and the dinner was served outside. Nanna had made the pasta a day or two earlier and had the strands slung over the nails on the kitchen curtain stretcher that stood in the back yard. (I had never eaten store bought pasta until I was about fifteen. Up until then, it was all home-made.)

The dinner started out with antipasto that contained cold cuts cheeses and vegetables that grew in the back yard, nurtured by both Nanna and Babbononno. This was followed by what today is called Italian Wedding Soup. Next came the tagliatelle with Bolognese sauce. (Thick home-made spaghetti with meat sauce) This was followed by an assortment of meats cooked in Nanna's gravy. (Sauce to non-Italians)

This was accompanied by sautéed vegetables, and lastly, garden salad. The old timers served the salad after the main courses, not before them. They claimed it was better for the digestion. There would be bottles of Babbononno's red and white home-made wine on the table and a couple of carafes with red with cut up peaches. That was intended to be the dessert. Pastry and coffee might come later, but not right after the dinner. What did follow the dinner was a large bowl of fresh fruit, dishes of nuts and maybe little boxes of torrone, in case someone wanted something sweet, early on.

When the dinner came to an end, Babbononno would light up a cheroot, and my father and uncles hand-made Cuban cigars. From this point on, the men would relax in the shade and the ladies would do the dishes in the black soap stone sink in the cellar. My cousin, Paula, and I would be allowed to leave the table and both babysit her sister, my infant cousin Ellie, while we romped in the back yard.

This was one of the last dinners we would all share together during that summer of 1942. Soon, Uncle Nick would head off to the navy and Uncle Gino to the Air Corps.

We would not all be able to sit down again until after the war ended, about three and a half years in the future.

The war took its toll on the family. Uncle Nick and his first wife, Ada Giorgione, separated, and later divorced. Uncle Gino, while in New York on leave, would meet a Flamenco dancer, and later, marry her (Aunt Ninna). Nanna would suffer a massive heart attack and never fully recover, causing Babbononno to have to sell the big house at 70 Eutaw Street in East Boston, and move in with us. He also retired from his day job to take care of my grandmother. And that's the way it was in 1942.

For our Fourth of July celebrations, along with many delicious main and side dishes, my Nonna always made an array of incredible desserts. On this occasion, she tended to take advantage of the beautiful summer fruits that were in season, so strawberries, blueberries and peaches were the main ingredients in many. Today, I am sharing a delicious Ciambella al Limone e Mirtilli or Blueberry Lemon Donut Cake, made from fresh blueberries and yogurt, and infused with lemon and hints of vanilla. The Ciambella al Limone e Mirtilli is delicious when served for breakfast or scrumptious as a dessert for a wonderful Italian Fourth of July celebration!

BLUEBERRY LEMON DONUT

Ciambella al Limone e Mirtilli

| 3 eggs, separated | 1/4 cup and 1 tablespoon full fat Greek yogurt |
| 1 cup sugar | 1/3 cup whole milk |
| 1 1/2 cups and 2 tablespoons all-purpose flour | 1/2 cup seed oil (I use Sunflower) |
| 1/2 cup and 2 tablespoons potato starch | 2 1/2 teaspoons pure vanilla extract |
| 1 bustina paneangeli di lievito per dolce (can substitute) | 1 1/2 organic lemons, zested and juiced |
| 2 1/4 teaspoons baking powder | 1 1/2 to 2 cups fresh blueberries, washed & dried (reserve a few for decoration) |
| 1/4 teaspoon salt | |

Lemon Glaze

- 1 1/2 to 2 cups confectioners' sugar
- Lemon juice from whole lemon

Preheat the oven to 350°. Grease and flour a 24 cm ciambella or donut (tube) pan, set aside.

In a small bowl, add the milk, yogurt, and a few drops of the lemon juice. Mix and then let sit at room temperature for about 10 minutes. Be sure to keep the leftover lemon juice, it is needed for the glaze.

In a medium bowl, sift together the flour, potato starch, lievito per dolce or baking powder, salt, and set aside.

In a medium mixing bowl, beat the egg whites until stiff peaks form, set aside.

In a large mixing bowl, add the egg yolks and sugar, beat until pale yellow. Add the yogurt and milk mixture, oil, lemon zest and vanilla, mix well. Gradually add in the flour mixture, blending with each addition. Gently fold in the egg whites and then the blueberries. Spread evenly into the prepared ciambella pan. Bake for about 35 to 45 minutes, or until cake is light golden on top and skewer inserted comes out clean. Cool completely.

Lemon Glaze

Sift the icing sugar into a bowl; add the reserved lemon juice a little at a time, until you get a soft and fluid consistency. Drizzle over cooled cake and decorate with remaining blueberries, if desired.

Playing Lazarus with Sherlock Holmes

The *Final Problem* was, it has become clearer with each passing decade since its publication in 1893, one of the first exposures of what fandom can do. It also was a testament to the attachment readers had formed not only for Sir Arthur Conan Doyle's Sherlock Holmes but to the universe he created around him, his friendship with Watson, his connections in London and Scotland Yard, and an accumulating narrative.

Unlike more recent examples, Doyle didn't have a precedence to test his readers (it could be argued he set the precedence with this story). He simply didn't care enough what they thought. His mind was made up to kill his famous sleuth to, as he wrote to his mother, pursue other callings even at the expense of his bread and butter.

Fandom, however, was then a relatively unknown phenomenon and the shocking death of the detective he had been writing about for six years set off a literary fury the likes of which had not been seen outside of scandalous writing.

However obtuse Doyle's thinking was, his conviction is to be admired. He willingly sacrificed both income and reputation for what he conceived as a more rewarding path. Perhaps he was unaware of the devotion of his fans. Be that as it may, when *The Final Problem* ended with Holmes and his arch enemy Professor Moriarty meeting their demise atop Reichenbach Falls his legions made their displeasure known. Hostile letters poured in and *The Strand*, the literary journal that had been publishing the Sherlock Holmes stories from the start, barely escaped bankruptcy from all the cancellations.

Over a century before social media the power of fandom to influence creators was discovered. This was unheard of and, perhaps because there wasn't a protocol and perhaps because he did want to spread his literary wings, Doyle resisted caving into the demands. Fortunately, he ultimately consented but, still, such a spine is sorely lacking in contemporary artists.

Nearly a decade would pass before Doyle wrote another Sherlock Holmes story and that was the apotheosis of the canon *The Hound of the Baskervilles*. Tellingly, however, Holmes set it before the events of *The Final Problem* indicating a reluctance to resurrect his most famous creation. Likely due to the success (no doubt aided by a public excited to revisit their old favorite) of that novel, however, Doyle took the plunge in 1903 and officially resurrected the character in *The Adventure of the Empty House*, in which it is revealed the Holmes survived the fall tough Moriarty had indeed plummeted to his death. Doyle went on to write many more Sherlock Holmes stories for almost thirty years after that and the fans were delighted.

Holmes and Watson have a permanent place in the literary canon, but the influence of Doyle's gamble in *The Final*

Problem have been too little discussed. The killing off of an iconic character has become both a ratings play but also, thanks largely to Holmes, a test of the fandom's sentiments.

An obvious parallel for our generation was the death of Superman in 1992, which made shock waves in the world of comics. The fundamental difference was that DC planned from the start to bring the man of steel back (in fact the idea started off as a joke). Doyle wrote *The Final Problem* with the intention of killing off Sherlock Holmes for good and only revived him a decade later due to a combination of circumstances, the strongest of which was the push from readers. If there is a true contemporary parallel it is the death of Bobby in *Dallas*, also intended to be permanent as Patrick Duffy's contract for the show was up. With ratings tanking, however, the character was brought back in the only way possible, the entire season featuring his death was retconned to be a dream.

Doyle had more options. As a grieving Watson narrates, the bodies of neither Holmes nor Watson were ever recovered from the ravine and no one was present (not even Watson who was lured away by Moriarty in a ruse) to witness the fall (conspiracy aficionados may argue that such openness to the demise of the character is evidence that Doyle never intended for him to stay dead in the first place). Doyle was able, therefore, to easily explain Sherlock's survival in *The Adventure of the Empty House*.

The Final Problem, however, is best read as it was intended to be read, as the closing chapter of a series and, read as such, while it is not in itself one of the best in the canon and is a departure from the typical formula, it does create a deeper understanding of the character, his motivation for being a sleuth and, most significantly, the relationship between Holmes and Watson.

What made Sherlock Holmes such a fascinating character was the enigma behind his commitment to bringing the London underworld to justice. He disdained sentimentality, emotive reasoning and superfluous diversion. He was repulsed by criminals but his diligent pursuit of them seemed more a matter of self-stimulation (he would descend into decadence without it) than moral conviction. He had little regard for much of the Scotland Yard force and less so romantic attachments. And yet, as *The Final Problem* reveals, beneath that unflinching vanity and unbreakable composure was a man devoted to righting wrongs.

In Professor Moriarty he finally meets his match and comes to the realization that if he is to rid London of its most influential criminal mastermind he may have to make the ultimate sacrifice. That he doesn't allow this to stop him is revealing of his motivation. We can be thankful that Doyle resurrected

the character but, had *The Final Problem* indeed been the end of Sherlock Holmes, it would have been the perfect, full circle conclusion; one in which everything readers wondered about the ideology of their enigmatic hero was brought to light.

Watson, it is clear to see here, always knew this about his old friend and former roommate. He tolerated Holmes's peculiar habits, unorthodox lifestyle and misanthropic tendencies because there was enough in humanity in Holmes to form a true bond. His grief throughout the narration of the story is genuine and makes the story hard to read, even with the hindsight of the eventual reunion between the two.

But why Moriarty? His name never appeared before in the canon and would only be mentioned again outside of this narrative's context in *The Valley of Fear*, set before this story (taking the chill away since we know his threat would be extinguished, as it turned out, without the loss of Holmes). But the innumerable spin-offs have made him the official arch-enemy of Sherlock Holmes for one reason only. He is Sherlock Holmes devoted to evil. He is the one other character in the canon equal to Holmes in every way but one, morality. He is as brilliant, as resourceful and as insightful as Sherlock Holmes and, had the detective of Baker Street used his talents for evil, the two would have been virtually indistinguishable.

Professor Moriarty was the only villain in which Holmes could have met his match and (for the purposes of *The Final Problem* as it was intended to be read) his demise. The admiration and respect both detective and criminal have for each other is understandable. In each other they see their own counterpart. Two opposing sides of a shared brilliance. A showdown could only mean the destruction of both and it almost did but Sherlock Holmes had a secret weapon that not even Sir Arthur Conan Doyle knew he had; a growing fan base.

HOOPS and HOCKEY in the HUB

CAN THE CANADIENS CLAIM A CONQUEST?—In a former era of this impressive winter sport, the Montreal Forum was known as “The Cathedral of Hockey.” Not only was the team that had won numerous championships in the historic building treated with respect, but so was the surface upon which those conquests had been crafted.

Once the ice was put down at the end of September for the team's preseason games in the National Hockey league, the only events in the old Forum that could take place were ice events. Nothing could be put over the ice to create flooring for a concert or a basketball game, for example. The ice was the ice—and it could not be disturbed until the Canadiens had played their last game of the season—whether that be in the regular campaign or the playoffs.

Such was the reverence held for the sanctity of the surface upon which the Canadiens skated year after year, decade after decade.

Perhaps it is somewhat fitting then that the building that was so identified with the Montreal Canadiens was literally the venue where all those championship campaigns came together.

That's right. Within two weeks after the Canadiens won their 24th Stanley Cup Championship in 1993 by coming from behind to win four consecutive games after the Los Angeles Kings won the opener, the future would take its first formative steps. About a fortnight after the Canadiens carried the Cup down Saint Catherine Street, ground was broken for the team's new home—the Bell Centre.

But while the conquest would live in history, gradually it came to denote the commencement of an era of despair. For that, fifth game, played on June 9, 1993, would come to mark the last time the Canadiens would play in the Stanley Cup Final until their present meeting with the Tampa Bay Lightning.

The Forum would live on a venerable hall of hockey for a while longer—until the Bell Centre officially opened on March 16, 1996—but never again would the Canadiens make it all the way to the final best-of-seven until this moment in time, one that started in late June and will end in July.

The closest they ever got over the years was in 2010 when they lost in the Eastern Conference Finals to Philadelphia, a team that was fresh off its victory in the well-known meltdown series with the Bruins. That was the series where the Bruins lost after leading 3-0 in games before the Flyers pulled even at 3-3 to force a game seven. Then the Bruins took a 3-0 lead in that deciding game only to lose that one was well.

And while the Cups stopped coming, something else ended as well. The Bell Center was built as a multi-purpose arena, meaning it now hosts—and will continue to welcome—a wide array of events in addition to hockey.

Thus, while the venue is best known as the home of the town's famous hockey team, the franchise must now share the premises with a wide variety of entertainment events plus mixed marital arts, wrestling and occasional NBA preseason games. The Celtics have played there,

meeting the Minnesota Timberwolves in a preseason game back on October 20, 2013. Celine Dion has performed in the building at least 50 times over the years.

So a Cup would do more than simply be a victory for a sports franchise in this city north of the border. It would restore that special aura that seemed to have left to some degree following the Forum's finale.

It would also come as the capstone to a season that saw a significant change in leadership.

Back on February 24, former Bruins head coach Claude Julien was dismissed as the head coach of the Canadiens, in somewhat of a replay of his hiring.

Recall that Julien who led the B's to the 2011 Stanley Cup and a berth in 2013 Stanley Cup Final, was himself let go on February 7, 2017—at the very moment that the New England Patriots were engaging with fans during their Super Bowl victory parade.

About a week later Julien was back behind an NHL bench, the Canadiens having fired Michel Therrien. It was an interesting move since Montreal was still first place in the Eastern Division with 70 points. The team had opened the season with a 13-1-1 record but had cooled off to an 18-18-7 mark just before the change was made.

Fast forward to a few months ago when Julien was let go in favor of assistant coach Dominique Ducharme.

Much like during the 2016-2017 season, Montreal had started out very well at 8-2-2 but had since moved to a more pedestrian 9-5-4 mark through 18 games of the shortened 56-game schedule.

Perhaps more important, the Canadiens had slipped to fourth place in the newly aligned division comprised of all teams based in Canada, a crucial demarcation since only the top four in the division would advance to the Stanley Cup Playoffs. Montreal finished the regular season at 24-21-11 and then went on to defeat Toronto, Winnipeg and Vegas in the playoffs.

Assistant Luke Richardson took over the head coaching duties for a portion of the series with Vegas after Ducharme tested positive with Covid-19. Ducharme should return for most of the Stanley Cup Final.

“Claude is a very good coach. It doesn't mean that Claude didn't have a good message,” said Montreal GM Marc Bergevin at the time that Ducharme was elevated to the top job. “Sometimes the players need a new voice. Sometimes the message needs to come from a different voice.”

Ducharme, who was in his second season as an assistant with the Habs, pronounced himself ready for the task when the call came. “I am prepared,” he said. “When you are prepared, you sit down at school, you get the exam, you don't know what the questions are going to be but you are ready to answer them. I'm confident. I'm confident in the group. I'm confident in the guys I'm working with. I'm ready to go.”

It is the end of the term. The final exam is at hand. We will know by early July if coach Ducharme and his players can ace the most challenging test they have ever taken.
