# Stirpe Nostra

A weekly column highlighting some of the more interesting aspects of our ancestry . . . our lineage . . . our roots.



#### **FAENUS**

Most of our concerns today seem to be centered around "faenus," which is the Latin term for interest, debt, profit, gain or financial advantage. In early Greece the rate of interest on invested capital was not restricted by law but was left entirely to arrangements between the parties concerned. The average rate was considered to be quite high, far higher than the rental fee for houses or for land. This was due to the scarcity of ready cash and the difficulty in accumulating any large amount of capital. During the time of Demosthenes (about 300 B.C.) twelve percent was regarded as a rather low rate of interest and higher rates, up to eighteen percent, were quite common. In bottomry (insurance on shipping cargo) the ordinary rate of interest at Athens was twenty percent. In the event of failure in the payment of interest due, it was permissible to charge compound interest. Interest was computed and charged by one of two different methods. It was quite usual to agree on the amount of a monthly payment or by an annual payment based upon a fraction of the principal. Interest was usually paid on the last day of each month but yearly payments

were also possible. In early Rome, as at Athens, the rate of interest was originally unrestricted and it was not until after much work was done that a standard rate of eight and one third percent was established. The law limited the interest rate for Roman citizens, but usury (gouging) was quite the common practice were foreigners were concerned.

The exchange of commerce between foreign countries prompted changes in interest payments. Money was no longer lent by the year but by the month and monthly interest was paid on the first day of each month. Notice of intention to recall a loan was given on the ides (13th or 15th of the month) and reimbursement took place on the first day of the following month. The regular rate of interest under this system was one percent monthly, or twelve percent per year.

The accumulation of large fortunes in Rome at the end of the Republic lessened the rate of interest that was charged. The chief field for usury was then directed toward the provinces, where the inhabitants were compelled to raise loans at any price because of exorbitant taxes. Justinian, the great Byzantine emperor, was the one who eventually fixed a permanent interest rate in ordinary investments at six percent, in commercial enterprises at eight percent and in bottomry (previously unlimited) at twelve percent.

It is certainly a great mystery to me why our ancestors were so concerned about money and interest. All they had to do was to look to their government leadership like we do. If you need more money ... just print it ... how simple can you get?

# City of Boston Mayor and Police Commissioner at Odds with Boston City Council Over Police Staffing Levels

The atmosphere between Mayor Michelle Wu, Boston Police Department Leadership and City Councilors Ed Flynn and Erin Murphy turned acrimonious last week when the two councilors filed a request for a public hearing regarding the need to increase Boston Police Department staffing levels. The Mayor, Flynn and Murphy are often at odds in their political philosophy.

The hearing order was praised by Larry Calderone, President of the Boston Police Patrolmen's Association, the city's largest police union, "We're in fullblown crisis and a recipe for disaster, in terms of public safety on city streets. This crisis didn't just happen overnight. This has been on-going for the last several years and it's been going unanswered."

The mayor, however, felt differently. She and the police department brass referenced the city's low crime rate and their ability to increase staffing levels given the national recruitment obstacles of police officers since the Black Lives Matter (BLM) and George Floyd riots.

A Boston Police Department spokesperson placed uniform staffing levels at 2,188, a figure the city union claims is false, countering the actual number of uniformed officers who

answer 911 calls is actually lower. According to Councilor Ed Flynn's office, the Boston Municipal Code requires the number of police officers on the force shall at no time be less than 2,500. Flynn and Murphy contend a "consistent influx of recruits" are needed to replace officers retiring and resigning. While this issue has been fully embraced by the union, it spurred the mayor to admonish councilor's Flynn and Murphy, offering a very stern pushback, "We appreciate this support for our officers and the hard work they do every day, and our administration continues to bring staffing levels up through expanding recruit classes. But with due respect to these councilors, we need their support for fully staffing city jobs all the time, not just when its politically convenient."

Both councilors fired back, "I think at a critical time where we are in the city, we should be working together to find solutions, not attacking councilors who are trying to help find solutions to keep the city moving forward," Murphy said. There is no doubt that each of these elected officials respects and supports public safety in their city as well as each officer who serves Boston every day, fighting to ensure the residents, business owners and visitors are safe and protected.

# Are Bike Lanes and Lax Enforcement Creating Headaches for Ambulances, Commuters, and Even Duck Boats?

Word on the street is the newly implemented bike and bus lanes throughout Boston neighborhoods are impeding ambulances, stalling commuters and even creating havoc for Duck Boat Tours. The traffic snarls are thought to be from the reconfiguration of Boston streets to accommodate the new bike and bus lanes, combined with a perceived lack of enforcement, creating major traffic frustration for businesses, tourists, residents and even Boston Duck Boat Drivers.

District 2 City Councilor Ed Flynn is reporting that he is receiving notification from his constituents claiming it is taking longer for ambulances to get to specific hospitals in Boston, and he believes bike lanes have a negative impact on their response time. A number of main arteries in Boston have been reduced to two lanes by Mayor Wu's administration, some implemented despite community opposition, and creating major headaches.

It's no secret that Wu is a staunch supporter of bike lanes but are they having a negative effect on tourism? Duck Boat tours that used to take 80 minutes are taking closer to two hours this summer, as all size vehicles attempt to navigate the heavily congested city

streets and roadways. "The city has been tough to get around. Traffic is really challenging. We're not against bike or bus lanes, but when you don't have enforcement, the best laid plans don't work," said Cindy Brown, CEO of Boston Duck Tours. This easily recognized company operates 28 vessels and transports thousands of tourists daily on both land and sea. Brown acknowledged that she has reached out to the mayor's office to request better enforcement of parking and traffic regulations to keep the roadways clear. Customers are often late for their reserved time slots due to traffic, parking issues or become frustrated with sitting idly on the duck boats for an extended period of time.

Illegal scooters darting around, service delivery drivers such as uber eats, door dash and others failure to follow traffic and parking regulations on streets that once had three lanes and now have two, are creating chaos and gridlock for most other drivers.

Many believe the mayor's office needs to do more to ease the commute for residents and tourists attempting to navigate the city, while many feel people using bike lanes are given preferential treatment.

# Vice-Presidential Candidate Tim Walz is Labeled an Enemy of Italians

Binetti added, "He has contempt for true religion, for Catholics, and, especially, for Italian Americans."

It is heartbreaking to see that the hate I experienced as a child still seems to rear its ugly head. Occasionally, even now, due in part to my last name, people do not realize that I am of Italian heritage and that's when their ignorance shows. Each time this happens it rips off the scab of hurt from Italian jokes, slanderous, insulting comments, Italian bigotry, discrimination and hate. People who harbor such vitriol should not be on the ballot. Tim Waltz, I hear your hate loud and clear. # L'Anno Bello: A Year in Italian Folklore

A Season of Transition

The photos begin to inundate social media around this time of year: coffeeshops advertising their wares with well-lit shots of cardboard cups stacked high with a frothy cloud of whipped cream and sprinkled with the reddish glitter of cinnamon, surrounded by the seasonal trappings of orange gourds. After all, the end of August means a plethora of announcements concerning the release dates of pumpkin spice lattes, the ne plus ultra of spicy fall drinks for java lovers. Pumpkin season is still fairly far-off, but these ads serve as yet another reminder that autumn, my favorite season, is quickly approaching. Indeed, I have lately been paying attention to the signs of the changing season all around me, from the prevalence of apples in the supermarket to the ever-soslight hues of red and orange appearing on some leaves. When the days get too humid and sticky — which I am fine with at the beginning of summer but find unbearable when crafting lesson plans or setting up my classroom for the next school year - I think of the harvest decorations I continually see in stores, and shiver with excitement over the crisp days of fall. Observing the signs of the changing seasons not only helps me live in the moment by concentrating on the natural phenomena currently unfolding around me, but it links me in a powerful way to the actions and lives of my ancestors.

Tracking the seasons has been a passion of mine long before I started this column. While clearing out a drawer in my old room, my mother found an old notebook of mine in which I had been charting the natural signs of the changing seasons. For the shift from summer to autumn, I wrote about witnessing my uncle and index of hay baking under the sun serve as one of the surest signs that autumn will soon descend upon the lovely Italian countryside. Italian farmers also examine their grapes during this month, ensuring they are getting the right amount of sunshine, water and shade to make them perfect for the vendemmia, or

grandmother planting the bulbs of a daisy, called a margherita in Italian, which would bloom in late September. I mentioned a gnarled tree whose leaves always turned a kaleidoscope of vellow and red a month early and floated to the ground well before the calendar turned to autumn. Baking an apple dessert, cool mornings, the color of the early twilight — all of these observations made it into that little notebook. Doing so helped me become a better observer of nature and of the excitement of life around me, and I hope to resume this sort of project again soon. Noticing and recording the shifting tide of the seasons actually has a scientific name. It is known as phenology, and naturalists often encourage people to sketch or write down their observations and then submit them in order to help scientists track climate data. Therefore, this hobby is both romantic and functional!

This pastime is apparently quite timeless as well. Our ancestors have been discerning the seasonal changes since time immemorial — not because they were eager for pumpkin spice lattes or photographing falling leaves, but rather because they operated in a primarily agricultural society where determining the right time to plant or harvest crops was invaluable to the survival of the community. In Italy, August functions as the month of the grain and hay harvest, and tightly rolled bundles of hay baking under the sun serve as one of the surest signs that autumn will soon descend upon the lovely Italian countryside. Italian farmers also examine their grapes during this month, ensuring they are getting the water and shade to make them perfect for the vendemmia, or

grapes stand as an important cultural symbol in Italy, for the grapes gathered in September will be processed into wine in November, ready to serve as the steadfast staple of Italian hospitality during the holidays and beyond. Finally, Italian farmers of yore frequently used saints' days as milestones for seasonal changes, a trait which is reflected in the proverbs still ubiquitous in Italian society to this day. August 24th is St. Bartholomew's Day, and the Italians repeat a proverb which declares: "A San Bartolomeo montagna mia bella ti abbandono." Translated, this dictum says that one should abandon the beautiful mountains after the Feast of St. Bartholomew, perhaps a reference to the cooler weather and the end of the vacation period. When we notice even the simplest transitions from one season to another, therefore, we are actually repeating the actions our forebears performed in order to carve out a living from the

As the bright days of summer give way to the cool nights of fall, I encourage everyone to keep track of the unfolding seasonal changes. These transitions do not have to be major, as even the tiniest details like a sip of apple cider or a yellow school bus can signal the start of an exciting new season. Let us become seasonal detectives, paying close attention to the evidence of nature's eternal cycle. By doing this, we become closely attuned to Mother Earth which has nourished us and our ancestors for so long, and we learn to live in the moment by understanding the natural beauty of the here and now. If we welcome every season with optimism and a healthy dose of respect, then the bounty of the Earth will love us in kind, no matter which latte we drink!



Hennigan stated. In addition to fluency in English, Spanish and Italian, he is also able to read French, Greek, and Hebrew.

# Saint Adela of Normandy

by Bennett Molinari and Richard Molinari

It is generally believed that Adela was born between 1066 and 1070 after her father's accession to the English throne. She was the youngest daughter of William the Conqueror and Matilda of Flanders. Adela was a high-spirited and educated woman with a knowledge of Latin. As Adela's parents both travelled around Normandy, she likely spent much time at and was educated at a monastery, probably the Abbey of Sainte-Trinité, Caen. She had three older brothers and one younger, and thus she would not inherit her father's honors; however, her bloodline would be a valuable asset in marriage.

Adela married Stephen Henry, son and heir to the count of Blois, between 1080 and 1083, around her fifteenth birthday. They were married at Chartres Cathedral. This marriage created a strong familial alliance, linking the two most powerful families in Northern France. Stephen was nearly twenty years her senior. During the fifteen years of their marriage, they had six or eight children who survived infancy.

Stephen inherited Blois, Chartres, and Beaux upon his father's death in 1089, as well as lands and right in parts of Berry and Burgundy. The Thibaudian dynasty had other possessions east of Paris, and by the end of Adela's life these



were coalescing into the county of Champagne. While Theobald IV takes most of the credit for the emergence of that principality, Adela helped lay its foundations. Adela and her husband had a relationship based on trust and mutual respect, if not affection, and they made decisions together. She swore, for instance, to bind herself and her husband to protect Bishop Ivo of Chartres then in a dispute with the king of France.

In 1095, Stephen joined the First Crusade which Adela underwrote with her personal wealth. The letters Stephen sent to Adela indicate a great level of affection and trust. Adela was in charge of the family's

finances and perfectly suited to serve as regent during his three-year absence. Returning without fulfilling his vow, an action considered by Adela a cowardly retreat having been raised in the tradition of her father William the Conqueror, Adela urged Stephen to redeem his honor and return to the Holy Land which he reluctantly did and was killed in an illadvised charge at Ramla in

Adela was particularly close to her younger brother Henry who later become King Henry I of England, even supporting him against their oldest brother, Robert. As regent she earned a reputation for diplomacy, skilled negotiator and promoting economic growth supporting a range of religious communities, leper hospitals and worked to reform monasteries. Many of her pious bequests had important economic, political and spiritual benefits. An avid patroness of the arts, Adela corresponded with such dignitaries as Hildebert, bishop of Le Mans and Abbot Baudri of Bourgeuil, both of whom wrote poems dedicated to her. She ruled Blois for five years until she formally conferred authority to son Stephen vet continued to maintain power and influence until her death in 1137. The Feast day of Saint Adela of Normandy is February 24th.

# Mayor Wu Disappointed in Lack of State House Support

City of Boston Mayor Michelle Wu noted her disappointment that a number of Home Rule Petitions she submitted to the Massachusetts State Legislature have not been approved, even after the marathon session ahead of last month's deadline to pass pending bills. Some of the mayor's key priorities remain unresolved, including the petition to temporarily allow the city to raise commercial tax rates in order to offset the expected revenue loss to the city coffers, along with the hope of increasing the number of all alcoholic liquor licenses allotted to the city.

The Massachusetts State law limits the number of liquor licenses', therefore approval is needed from the legislature to make more available. In the fall of last year, the Boston City Council and Mayor Wu requested Beacon Hill Legislatures approve 250 new liquor licenses be earmarked for specific neighborhoods. "Certain neighborhoods are actively denied the ability to have more sit-down restaurants. It means you need to have extraordinary resources just to get in the game," Wu said.

The mayor expressed

frustration and disappointment that the legislature did not push through her proposal to transfer some of the tax burden to businesses and away from residents. I am still very disappointed we are in this place," she said. The house and senate will meet throughout the rest of the year for informal session, however its usually basic, non-controversial bills that are passed. State Senator Will Brownsberger, one of the top liquor license negotiators, believes the senate and house will be able to complete a final bill, at some point.

Here in East Boston, pump prices are always a good 40 cents or more per gallon. Even over in Quincy, the price is around \$2.35 and over in Roslindale/ West Roxbury, \$2.19 to \$2.25 per gallon.

A Nostalgic Remembrance



Several of you asked for an update on how my physical progress is going. Well, I use a walker in the house and a cane, or as my wife calls it, "A walking stick," when I'm outside our home. The muscles in my legs are healing nicely and I am going to physical therapy a couple of mornings per week. I will have to live with the battle scars, a six-to-eight-inch scar running vertically across each knee cap. I've been told that a weight loss would help speed my recovery and, so far, I've lost 24 pounds.

A few months ago, I decided to head to Florida as our house there is all on one level. In Boston, I had to install a chairlift to get myself out of the house, first from the kitchen, down to the cellar and then out to the street from the garage. It's actually been cooler here in the tropics that back home in Massachusetts ... global warming, or so they tell me. When we've had those oppressive days in July, Loretta had the air conditioners on day and night. It was so stuffy I didn't argue with her. (I usually like the windows open.)

Thinking back to my early years in East Boston, the only relief we had was from a large window fan that Dad placed in one of the kitchen windows. It could get so hot in our penthouse (3rd floor of an East Boston three-decker) that the water pipes would sweat and we would wind up with striped walls in that kitchen. As far as the heat was concerned, you lived with it. None of the cars Dad owned ever had air conditioning. Back in the day, it was an expensive option and the only dealers that offered it were those that sold luxury cars, Cadillac, Lincoln, Packard, and maybe, Buick and Chrysler. I' not sure about the last two.

From 1949 on, Dad's cars were all Chevys and none had air. If you wanted to cool off, you opened the windows and angled the little fly windows all the way to allow air to blow on you as the car moved forward. If you got stuck in traffic, there was always a chance of the car overheating. Thank God, you don't see this phenomenon today unless the car has a problem with the cooling system.

What did we do to cool off back then? After dinner, we headed outside, we kids played games and the adults sat on the front steps until well after dark. A vacation for some was to sit on a neighbor's front steps instead their own. We kids liked it when it was a hot night because the adults would stay out later than usual which meant we were out-side playing long after dark. So, hot nights had their advantages.

There were ways to cool off when I was a kid, family outings to Revere Beach, Nahant Beach, Wollaston Beach, Nantasket Beach, Salem Willows, and Hampton Beach. Later, when Constitution Beach in Orient Heights officially opened, we had a cooling off place closer to home. When it was just me or a few of my preteen friends, we would head for the "penny pool." That was, and I think still is, the pool on Storrow Drive across from the Mass General Hospital. Back in the day, it cost a penny for kids to swim there, and I loved it. I would sneak in a pair of underwater goggles, put them on when the life guards weren't looking, and dive to the bottom looking for change. More often than not, I would find a couple of dollars in pennies, nickels, dimes and quarters.

When Dad would have a day off, he would take Nanna, Babbononno, Mom and me to Revere Beach. He like the cement steps which used to exist way down along the beach, near Point of Pines. Nanna and Mom would have to cover up and sit under umbrellas as they both had light sensitive skin and burned easily. Babbononno kept his shirt on fearing that he would get tanned and look like a field hand, in his mind this was a negative. Dad and I would work on our tans with no problems, an experience I still enjoy.

Within the past couple of years, Loretta made comments on some brown spots on my shoulders and back. She made an appointment with a dermatologist to get them checked out fearing that they might be cancerous. The doctor gave me a clean bill of health, and when Loretta asked about all the brown spots, the doctor's only reply was, "He's old.'

On Sundays, Dad was often booked to play at the band stand on Revere Beach or the indoor band stand at Nantasket. He would pack up Nanna, Babbononno, Mom and me for each event and we would make a day of it. When at Revere Beach, a stop at Bianchi's Pizza was mandatory and my family would sit with their slices while listening to Dad play tuba to all of the famous Sousa marches. Depending who the leaders were, I might be allowed to sit next to Dad in the brass section of the band. This I loved, and after the concert, I would fight the waves of Revere or Nantasket providing the tide was coming in. Mom would time it so that an hour had passed

between the pizza and the swim. She always thought that you had to wait an hour after eating before going swimming or you might develop stomach cramps and drown.

Years later, when Bernie King became the leader of those Sunday concerts at Revere Beach, I was hired to play bass guitar. (Dad was still on tuba) By then the music included a couple of Sousa marches and lots of pop tunes of the day, and considering the ethnic groups on the beach, a lot of Italian and Jewish tunes.

After Nanna passed away in December of '58, Babbononno stopped coming to the beach concerts. I was in college by then and booked in as many of those concerts as I could It helped pay my tuition at Boston State. Between what I made at the Seville Theater and the summer concerts, and later, the resorts I played at on weekends when I was with the Ken Reeves orchestra, I never had to ask Dad for financial help. I paid my own way through college, a feat that is impossible with today's tuition costs.

I wonder if they still have band concerts at Revere Beach on Sundays during the summer months. I guess I'll have to call the Musicians' Union to find out. If they do, the crowds are different and I would imagine the music would be different,

This type of entertainment was programmed from the July 4th weekend through the Labor Day weekend, and then it was over. To me, the summer was just those two months and then it was back to the old grind,

Anyway, I hope you are all having a great summer, and God willing, I'll be back next week.

It amazes me that these cookies are usually one of the first to disappear from my cookie trays, and if you try them, I am sure you'll love them just as much!

# SIMPLE SICILIAN PISTACHIO COOKIES

Biscotti Semplici Siciliani al Pistacchio



½ cup unsalted butter, softened to room temperature ½ cup granulated sugar ½ cup oil 1/4 cup water 1 large (5-ounce) package instant

pistachio pudding mix

1 teaspoon pure vanilla extract ½ teaspoon salt 1 teaspoon baking powder 2 cups all-purpose flour 10 ounces white chocolate

Preheat your oven to 350°F (175°C). Line a baking sheet with parchment paper and set it aside.

In a large mixing bowl, combine the butter, sugar, oil, water, egg, pistachio pudding mix, vanilla extract, salt, baking powder, and flour. Mix until everything is well incorporated. Using a small cookie scoop, portion out the dough and place the

scoops on the prepared baking sheet, spacing them slightly apart. Bake the cookies in the preheated oven for 13 to 15 minutes. Once baked, allow the cookies to cool completely. While the cookies are cooling, melt the white chocolate. Place

it in a heatproof bowl and melt it in the microwave in 30-second intervals, stirring between each, or melt it over a double boiler

Transfer the melted white chocolate to a disposable pastry bag and drizzle it over the cooled cookies. Let the chocolate set, then store the cookies in an airtight





## **Rocky Marciano**

Boxing champ Rocky Marciano was born in Brockton, Massachusetts (as Rocco Francis Marchegiano) on September 1, 1923. His parents, Pierino Marchegiano and Pasqualina Picciuto, were both immigrants from Italy. His father was from Ripa Teatina, Abruzzo, while his mother was from San Bartolomeo in Galdo, Campania. Marciano had two brothers, Louis (aka Sonny) and Peter, and three sisters, Alice, Concetta and Elizabeth.





During his time in the Army, he won the armed forces boxing tournament. On March 17th, Marciano stepped into the ring as a professional competitor at the Valley Arena Gardens of Holyoke, Massachusetts. On that night, he knocked out the local competitor Lee Epperson in three rounds. Strangely after that, Marciano returned to his amateur career and fought in the Golden Gloves All-East Championship Tournament in March 1948, where he controversially lost to Coley Wallace. He continued to fight as an amateur throughout the spring and competed in the AAU Olympic tryouts in the Boston Garden. There, he knocked out George McInnis, but hurt his hands during the bout and was forced to withdraw from the tournament. That was his last amateur bout.

Rocky became a professional boxer on July 12th, 1948, where he won a fight against Harry Bilizarian. He also changed his last name to "Marciano" due to the ring announcer's problems with pronouncing his original surname. He then continued winning fights, almost all of them by knockout.

On October 27, 1951, the 28-year-old Marciano took on the 37-year-old Joe Louis. Coming into the bout, Marciano upset Louis in what was the latter's last career bout. After four more subsequent wins, he finally got a chance to fight for the world heavyweight title.

Marciano fought against Jersey Joe Walcott for the world champion title, Walcott dropped Marciano with a well-timed left hook in the second round. With time running out and Walcott leading on all score cards Marciano landed a powerful right hook which left Walcott on the floor holding the ropes. Rocky became the world champion. The first defense was against Walcott himself, who this time was knocked out in the first round. He then defended the title 3 more times winning once again. His last title defense was against Archie Moore in 1955. He knocked him out in round nine and successfully defended his title once again. Marciano then retired in 1956. Marciano died in a plane crash in 1969.

# **WAYNE BETHEA**

# Heavyweight Who Came Close, Career Ended in Tragedy with Death of Opponent

Boxing fans will remember the name Wayne Bethea. Unfortunately, they will recall him for a single fight: his firstround loss to Sonny Liston. It is the only fight of Bethea's career that is available on film. The fight took place in 1958 as Sonny was beginning his quest for a world title shot against Floyd Patterson. Liston would spend the next two years cleaning out the heavyweight division.

Bethea's time in the ring is not paid much attention to. His won/loss record was not outstanding. He finished his career with 28 wins, 18 losses, and 4 draws. He fought a number of top names, and it could be easy to put him in the "opponent" classification. However, Wayne really wasn't an opponent. He fought to win during his career. He had some impressive wins, and he came very close to having some huge victories under his belt. It should also be noted that though he didn't make it through one round with Liston, Sonny was the only man to stop Bethea.

Six of Wayne's losses were via split or majority decision. He lost twice by split nod to Zora Folley. The fights took place in 1956 and 1957. In the second match Bethea dropped Zora for a nine count.

In 1958 he faced Nino Valdes. This was another split decision loss. Bethea fought a good fight against the Cuban power puncher and would have gotten the decision except for a knockdown scored by Valdes in the 7th round. This happened when Nino grazed Wayne's chin with a left hook. Bethea was off balance and went down from the blow but wasn't hurt.

Bethea did have a number of solid wins on his record. He decisioned a fading Ezzard Charles in 1956. Also, in the same year he beat Jimmy Slade and stopped Joe Bygraves. Add in decision wins over Young Jack Johnson, Paul Andrews, Bert Whitehurst, and a young Ernie Terrell, and it appeared Wayne was ready to move up the ladder.

If he had managed to pull out the wins over Folley and Valdes he would have become a solid top ten contender. In 1957 he lost a decision to the great Harold Johnson. No shame in that.

After 1958 Bethea's career took a downward turn. The tough loss to Valdes followed by the kayo at the fists of Liston pretty much ended his chances of becoming a title contender. He dropped a unanimous decision to Alex Miteff in 1959. Wayne was also outboxed by Eddie Machen in 1960. This was less

than two weeks after his victory over Ernie Terrell. In 1961 Cleveland Williams beat him decisively over ten rounds.

It was at this point in his career that he may have entered something considered opponent status. He went to Europe and took on a number of the leading fighters in Great Britain and the Continent. He lost twice by decision to Karl Mildenberger in Germany. I can't find any reports on those fights, so there is no telling if Karl was got the benefit of being the home town boy.

In England, Wayne lost a decision to Henry Cooper. He was repeatedly warned by the referee for butting and throwing low blows, but I wouldn't be surprised if that was more a tactic by the ref to throw him off his game than actual infractions of the rules.

Bethea scored a win over old rival Joe Bygraves before moving on to Italy where he kayoed undefeated Franco Piccoli in four rounds. Wayne seemed to have hit a stride in Italy as he fought draws with Giulio Rinaldi and Santo Amonti. He certainly was playing the role of opponent at this point. His last fight overseas was the second lost to Mildenberger. This was in 1963.

On his return home Wayne Bethea would have one last fight. This bout took place on October 14, 1963 in Baltimore. It would not only end in tragedy, but was a scandal.

Bethea's opponent that night was 26-year-old Ernie Knox. Knox had not fought in nearly a year and had only 21 fights at the time with just ten wins. He had weighed around 178 pounds for most of his career, but there was some question about what he weighed the night of his fight with Bethea.

Wayne at 205 pounds was not in good shape for the fight. He was breathing heavily early on, but managed to bull his lighter opponent to the ropes on a number of occasions. In the 9th round Knox was dropped for a count of four. He was dropped again a short time later and counted out.

Knox was unable to get up after given the ten count. He was carried out on a stretcher and transported to the hospital. Two days later he died. The cause of death was a blood clot on the brain caused by the trauma from the punches he received.

An autopsy performed showed that Knox weighed only 153 pounds, a far cry from the 178 pounds recorded at the weigh in. Some of the difference could be accounted for by the perspiration excreted during the fight in the hot arena, but experts said that would not have accounted for such a huge difference. It was reported Knox weighed in with all of his clothes on.

Did the promoters fudge the weigh-in figures? There was an investigation and a grand jury was convened. However, no charges were filed. Knox's family received his cut of the purse which amounted to \$243.00, not enough to cover the funeral expenses. Bethea's end was \$500.00.

Until this fight Knox had only fought one opponent that weighed over 190 pounds and never faced anyone over 200 pounds. There is also the question about his weight. A year earlier he had weighed in at 183 pounds for previous fight. His body weight was recorded as 153 pounds at the autopsy. During his year out of the ring had he suffered an illness causing the weight loss? We'll never know.

Wayne Bethea never fought again after the Knox tragedy. He seemed to pretty much disappear and I can't find anything about him during his years after boxing. I imagine he was affected by what happened.

Wayne Bethea fought nearly ten years and never made any decent money. A guy who was stepping in against top fighters from around the world was getting \$500.00 for his last fight.

Erne Knox, a hardworking man from a large family, was not going anywhere in boxing. It is quite possible he was through with boxing when his manager called telling him the fight with Bethea would be his "big chance" at making it. He never made it home.

The boxing tragedy stories far, far outweigh the positive ones. This one occurred in 1963. The same story has been repeated hundreds, if not thousands of times since. A death, an investigation, rumbles to ban boxing, then all is forgotten until the next time and the next time, and the next time ...

# HOOPS and HOCKEY in the HUB

It will be as it should be — all about tradition. The tradition of the Boston Celtics and their record 18 Banners won.

And the tradition of their archrival — on the East Coast at least — the New York Knicks.

The tradition linking these two teams goes back as far as the NBA itself. They are the only two original NBA franchises still playing in their original franchise cities. That is quite a history going back to the 1940s.

Some original franchises are still with us but not playing any longer in their original cities. For example, the Fort Wayne Pistons became the Detroit Pistons, The same can be said of the Syracuse Nationals who moved from upstate New York and became Philadelphia 76ers. The Rochester Royals also began as an original NBA franchise in upstate New York, moved to Cincinnati in 1957, then became the Kansas City Kings in 1972 before a final move to the West Coast where they became the Sacramento Kings in 1985.

During the time the team played in Cincinnati and Kansas City, former Celtics star Bob Cousy was the coach, by the way.

But with all this movement two franchises remained where they began. It has always been Boston for the Celtics and New York for the Knicks.

That is why it will feel so good on October 22nd — the opening night for both teams in the NBA — to have the Knicks on hand for the historic proceedings. All that history in that one building on that night that will flow with memories — of those achieved much earlier and those that were created just a few short months ago.

It will be something that a new generation of Celtics fans will be witnessing for the first time. Remember that the last time a similar ceremony was held at the Garden was in the fall of 2008 — some 16 years ago — when Banner 17 went to the rafters after the C's defeated the Los Angeles Lakers for the title some four months earlier.

And there will also be something to take home from the ceremony for the players, coaches and team executives. For in addition to raising Banner 18 to the Rafters on that night, those so entitled will receive their championship rings as a part of the festivities.

The game will mark the second consecutive opening night that the C's have hosted the team from Gotham. The Celtics prevailed over the Knicks by a 108-104 score at the TD Garden in the opener of the 2023-2024 season. Boston went on to win four out of the five games between the two teams over the course of the regular season.

The Celtics are the early favorites to win the 2025 NBA Championship based chiefly on the fact that they will return their entire starting rotation for the upcoming campaign. It is not that often that an entire starting rotation returns in today's NBA, especially when

one considers the era of free agency plus possible trades — but that is true for the Celtics come this fall. The starting five that was on hand for the playoffs last spring will be the same starting five (barring injuries during the preseason) that is available to take the floor on opening night.

It will also be a farewell night of sorts. The current ownership group has indicated that it wants to sell the team so this will be a celebration of not only having seen its primary objective achieved but the opportunity to leave under the best possible circumstances.

When you leave as a champion you will always be a clear champion — not one who possibly came up a bit short in the future. We can all think of athletes and coaches who stayed too long after winning a title, only to have things go south later — bringing on the hard questions from beat reporters and the far less than complimentary comments from fickle fans who not so long ago had cheered the athletes or coaches every move.

Fans who wish to see a rematch between the Celtics and the Dallas Mavericks — the C's opponents in the NBA Finals last spring — will have to wait a bit. Dallas won't visit the Garden until February 6th — a little later in the season. There is an earlier game between the two — when the C's go to Dallas for a January 25th matchup.

In other news involving the Celtics, the NBA has released the regular season games in the fall that will be designated as opening round NBA Cup games for the C's. In reality, the games have a dual designation since they are also NBA regular season games.

The Celtics will play two home Cup games in the opening group stage at the TD Garden — on November 12th against the Atlanta Hawks and on November 19th against the Cleveland Cavaliers. Fans may remember those home Cup games from last year since they featured a unique design of the court floor created just for the games in Boston.

They will also play two group stage games on the road — against the Washington Wizards on November 22nd and against the Chicago Bulls on November 29th.

The winners of the various group stages will advance to the knockout round. Last year, the Celtics lost in the knockout round when they were defeated by Indiana. The Pacers eventually lost to the Los Angeles Lakers in the inaugural championship game in Las Vegas.

The tournament itself was deemed a success became it generated additional interest in the NBA at a time of year where it faces heightened competition for the attention of sports fans as the NFL, college football and college basketball are also taking place.

It looks like an event that is here to stay and become more popular as time goes by.
