Walmart Recalls Apple Juice with Arsenic Issue

Walmart has recalled nearly 10,000 cases of apple juice sold in stores across the nation that were found to contain potentially harmful levels of inorganic arsenic. The FDA gave the recall order a more urgent classification after making its original announcement on August 15th. The new classification said the affected product may temporarily cause adverse health consequences but is unlikely to cause serious or irreversible medical issues. The recall applies to 9,535 cases of Great Value apple juice sold in 25 states, Puerto Rico and the District of Columbia.

Few Can Afford to Buy Homes Says Data

A recent survey finds income of \$217,000 is needed to afford a single-family home in Boston according to the Joint Center for Housing Studies at Harvard University which means very few people can afford to buy anything. The average Boston-area household according

Democratic National Convention Recap

The conventions are over. The Presidential nominees and their running mates are now official, albeit the Democrats followed an unconventional path in choosing theirs and used their unique opportunity to unify their core party base and persuade undecided voters in swing states to introduce the unexpected ticket to a broader audience watching at home.

The viewers heard from President Biden in what was widely believed to be a farewell address, former President Obama, Former First Lady Michelle Obama, Former President Clinton, former First Lady, Secretary of State and past presidential nominee Hillary Clinton, who noted that she clearly sees Kamala Harris on the other side of the shattered glass ceiling and her hope is it will be broken open once and for all.

Tim Walz, current Governor of Minnesota, called the nomination as the 204 Democratic Vice-President "the honor of my life." A former teacher and football coach attempted to appeal to the small-town voters' common side, telling the crowd, "It is the 4th quarter of the election and the Democrats are down a field goal, but they're on offense and driving down the field. To get across the line, the crowd's job and of those watching is to get in the trenches and do the blocking and tackling in the election." He went on to make the Democrats case making housing more affordable, cutting the prices of prescription drugs, reducing medical debt, providing meals for kids in schools and standing for abortion rights.

Oprah Winfrey, a surprise guest, informed the crowd she is a registered independent and called on "all you independent and undecided to vote for Harris. Decency and respect are on the ballot in 2024. Common sense tells us that Kamala Harris and Tim Walz can give us decency and respect. Let us choose common sense over nonsense,"

she urged. Democrats also took the time to showcase rising stars and names to watch for moving forward. It's not just about the current election cycle but rather a chance for potential future candidates to shine, stand out and make a name for themselves before a national audience, including Pennsylvania Governor Josh Shapiro, Maryland Governor Wes Moore and our own Governor of Massachusetts, Maura Healey.

Both Obamas took this opportunity to scorch Trump and the Republicans. They unloaded their deepest beliefs in each of their respective speeches. She said Trump tried to stoke fear about her and her husband because he was threatened by two highly educated and successful people, who happened to be black.

Stirpe Nostra

LIVIUS ANDRONICUS

Last week, we divided all of Roman literati (scholars) into four general groups and then listed most of the celebrated literarians in each of those groups. The first category, as you may recall, was the Early Age or the Age of Greek Influence. The greats assigned to this era are: 1. Livius Andronicus, 2. The Scipionic Circle, and 3. Cato the Elder.

Livius Andronicus, the first of my candidates in this Early Age, is considered to have been the founder of Roman epic poetry. We all know that epic poetry deals with important historical events and historical heroes. He was born of Greek parents in the ancient Greek colonies of Southern Italy which were called "Magna Graecia." He was brought to Rome as a slave after the conquest of Tarentum in the third century B.C. while still a young man. It is thought that he took the name Livius from his master after being given his freedom.

As a free man, he became an for centuries.

For those who are not too familiar with the work of Homer, ered to be the earliest man of fame in Greece and the personification of epic poetry. His most popular works are, of course, The Iliad and The Odyssey.

The Iliad tells of the war waged by a number of Greek City States to rescue the beautiful Helen, who was captured and held in the walled City of Troy; The Odyssey tells of the wanderings of Ulysses after the destruction of Troy. It also tells of the return of the Lady Helen to her husband in Greece.

About 240 B.C., Andronicus was successful in establishing dramatic poetry in the theaters of Rome and even appeared as an actor in his own creations.

Scanty remains of his works are all that have come down to us, but, in retrospect, Livius Andronicus should be remembered as the founder of Roman dramatic and epic poetry and for his translation of Homer's The Odyssey into Latin verse.

What is the Reason for Labor Day?

Who Should We Thank for It?

Most people don't give much thought as to where our holidays or days off derive from, but with the end of Summer fast approaching, it made me wonder about the upcoming Labor Day long weekend. With just a little research, I discovered the first Labor Day celebration, in 1882, was actually a result of workers striking. What we now think of as Labor Day, a U.S. National Holiday, held on the first Monday each September, is unique in it is without rituals, other than it is most often a day to gather with family and friends, and it denotes the last weekend of summer before the start of the upcoming school

The holiday came about in the late 1800's as a way to unify union workers and reduce work time. The first Labor Day occurred in New York City, 1882, through the efforts of the city's Central Labor Union. In the 1800s, unions only accounted for a small number of workers and were relatively

weak. The goal was to bring smaller unions together, to join forces and become stronger and more powerful. The organizers of the first Labor Day hoped to create an event that brought different types of workers together to meet and discuss common interests. But how could all of these workers gather at the same time and place if they were all at their individual jobs? Thus, the ide to temporarily declare a one-day strike in the city was born. All participating striking workers were encouraged to march in a parade and then gather to eat and drink at a giant picnic afterward.

In the 1830s, workers were putting in long hours, close to 70-hour work weeks on average. More than half a century later, in 1890, the number of hours had decreased, although not by a large margin. Union organizers began focusing on shorter, eight-hour workdays, with more days off, and reducing the work week to just six days. It may have taken time and effort, but those union organizers were victorious. Recent data shows the average manufacturing worker puts in slightly over forty hours per week and most work five days each week.

As the economy expanded and grew into the early 1900's, it became important to encourage consumers to spend their wages on traveling, entertainment, and dining out. Politicians and business owners actually supported giving workers time off to do so. Labor Day became a National Holiday in June 1894, when President Grover Cleveland signed it into law. Most people assume its recognized as a national day off, however congress' proclamation only covers federal employees and leaves it up to each state to declare their own legal holidays. It also does not require private employers or even municipal workers to be given the day off. Essential government services, health care, public safety, transportation and media outlets, amongst others, report for work each Labor Day.

So, for those not fortunate to enjoy the upcoming Labor Day holiday due to work requirements or commitments, we thank you, and we urge all Americans to be grateful for the contributions, efforts and resilience of the working Americans who have kept and continue to keep our country thriving!

his wife, but also displayed what a modern blended family may look like. Unlike former President Clinton, who also supported his wife's presidential bid and is a party favorite, Emhoff is fairly unknown. The campaign shines a spotlight on an inter-racial marriage and the sometime complex issue of step-parenting.

On the final evening of the Democratic National Convention, Harris ceremonially accepted her party's nomination. L'Anno Bello: A Year in Italian Folklore

Oh, Sweet September!

Lately, I have been paying special attention to the trees in my backyard. If I look at the leaves closely enough, I can detect the slightly perceptible hues of fall - crisp reds and golden yellows tickling the borders of still-green fronds. Small breezes lift a few orange leaves and blow them gently to the ground as they swirl around like tops. These sights, both the delicate colors and the falling of the leaves, are reminders that autumn is here, the season of cooler weather and harvest and the rhythms of nature. The month of September starts this wonderful season, bringing with it the smell of juicy apples and the purring motors of big yellow school buses. The beginning of September is always a very busy time for me, as it coincides with the commencement of the school year and all of the preparations that that entails. Nevertheless, when I stop to pause and really think about September, I feel a rise of excitement bubbling inside me. This is a month full of rustic holidays and old-country proverbs that highlight September's prominence as a seasonal turn-

The first September holiday to occur in America is Labor Day, falling on September 2nd this year. A festival honoring the contributions of working people, Labor Day also signifies the unofficial end of summer, as many schools return to their sessions after this long weekend. As such, Labor Day is often celebrated with a picnic or barbecue, and this year I will add to the food tradition by baking a sparkling apple cider pound cake or an applecream cheese crisp to honor the seasonal flavors of this month. Over in Italy, September heralds a flurry of feasts and activities that will last until the holiday season in the winter. It begins in a regal fashion, with Venice's Regatta Storica occurring on the first Sunday of the month. In this renowned boat race, a parade of elegant gondolas introduces an intense competition where skilled rowers in various different categories vie for first place. This event has a royal pedigree, as it is modeled after the welcome procession given to the queen of Cyprus, Caterina Cornaro, when she returned to Venice in 1489. Later in the month, the people in Naples celebrate the feast day of Saint Gennaro on September 19th, when spectators wait to see the mysterious

liquefaction of the saint's blood, and then hold an eight-day party as stalls selling trinkets and candy line the streets. This holiday has become so popular that many Italian-American communities hold their own Festa di San Gennaro. Autumn intensifies around the fall equinox, arriving on the 22nd of the month, after which the balance between daylight and night tips towards the edge of darkness. Finally, the Feast of St. Michael the Archangel, or San Michele l'Arcangelo, closes out the month on September 29th. Also known as Michaelmas, this ancient feast features the autumnal themes of balance the scales of St. Michael echo the equal hours of day and night during the equinox — and harvest, as ingredients like carrots and ginger are traditional on this day.

For our Italian ancestors of yore, September meant collecting the harvest, enjoying the bounty of the Earth, and preparing food for the winter. In this deeply agricultural society, proverbs reminded farmers to pay attention to the weather and their crops in order to ensure a successful harvest. Rain in September proved a mixed blessing. One proverb bluntly states that "La pioggia di settembre è veleno per l'uva," meaning that September rain is like poison for grapes. However, another proverb happily declares "A settembre pioggia e luna, è dei funghi la fortuna," advising farmers that rain and moonlight made favorable conditions for collecting mushrooms, such as the delectable Italian truffles. Other dictums reflect the changing weather of the month, as summer turns to autumn. A delightful little ditty proclaims: "Aria settembrina fresco la sera e fresco la mattina." According to this proverb, September air is cool during both the evenings and the mornings. This axiom reminds me of the autumnal mist I often see rising above fields like lace on crisp mornings, or dark evenings huddled under a blanket and drinking a cup of apple cider. Italian truisms even mention the autumn equinox. "Di Settembre la notte col dì contende" roughly translates that night competes with day during September, a reminder of the long winter evenings to come.

From holidays to proverbs, September is a month brimming with great significance as a seasonal milestone. Whether you enjoy the changing foliage or admire the taste of a fresh apple, be sure to pause and be grateful for all that the autumn has to offer. For it is autumn that teaches us humility before the gifts of the Earth and an appreciation for the cycle of the year. Therefore, no matter how you desire to honor September, let us toast to a month full of bountiful blessings and new beginnings!

Saint Phoebe

The name Phoebe means "pure," "radiant," or "bright."

Some scholars believe Saint Phoebe was responsible for delivering Paul's epistle to the Roman Christian church.

Phoebe was a notable firstcentury Christian woman mentioned in the Epistle to the Romans by the Apostle Paul. She held a prominent position within the church of Cenchreae and was entrusted by Paul to deliver his letter to the Romans.

In Paul's commendation, Phoebe is described as both a "servant" or "deacon" and a helper or patron of many making her the only woman in the New Testament to be specifically referred to with these distinctions. Because she is from the Church in Cenchreae (a port in Greece a few miles from Corinth), it becomes very plausible that she was Greek. Her ability and willingness to travel all the way from Cenchreae to Rome shows that she had an outstanding belief in Christ. Such a long and



arduous journey had to have been made by someone who was open to adventure and deeply committed to the mission.

Paul introduces Phoebe as his emissary to the church in Rome, providing her with credentials due to their lack of acquaintance. The use of the term "deacon" or "deaconess" should not be confused with the modern usage of the word, "deacon," as the ancient understanding was different from the modern.

Paul's letter to the Romans was composed in Corinth between the years 56 and 58 AD, with the intention of garnering support for an upcoming missionary journey to Spain. Despite not having visited Rome, Paul would have been familiar with the community through contacts like Priscilla and Aquila, who had previously resided

In his letter, Paul commends Phoebe as a deacon of the church in Cenchreae, urging the Roman Christians to receive her warmly and assist her as needed, highlighting her beneficence towards many, including himself.

Unfortunately, little else is known of St. Phoebe primarily due to the lack of further mention and the many years that have passed from her time to the present age.

The Feast Day of Saint Phoebe is September 3rd.

Is Election Day Becoming Extinct?

Is it a Matter of Time Before it No Longer Exists?

There are approximately eight weeks until the Presidential Election, but less than one week until election season begins. By the time November 5th rolls around, most voters will have already cast their ballots. Early voting begins as soon as September 6th for eligible voters with seven battleground states sending out ballots to voters in the same month. However, if voters repeat what they did the last two election cycles, most of them will have already cast their ballots prior to election day.

States have always allowed specific categories of Americans to vote early, including members of the military or people with illnesses that may preclude them from voting in person. Many states expanded eligibility in 2020, during the COVID-19 pandemic, when it seemed riskier to vote in person. Now some states see almost every voter cast ballots by mail.

In the 2020 Presidential Election, 71% of voters cast their ballots before Election Day, with 30% voting early in person and 41% voting by mail. Early voting remained strong during the 2020 mid-term elections with 57% of voters casting ballots before election day. Election Officials insist that early voting is safe and secure. Recounts, investigations and lawsuits filed after the 2020 election did not result in any

sold evidence of voter fraud.

There are a number of ways for voters to cast their ballots prior to election day. The first is "early in-person voting" where a voter casts a regular ballot in-person at a voting center before election day. The second is voting by mail, where the process and eligibility varies by state. Some of those states vote almost fully by mail, including California, Colorado, Nevada and Utah. Registered voters receive ballots and send them back and most states allow any registered voter to use this option. This is currently referred to as mail voting or in the past absentee voting. Depending on a state's rules, voters are able to return their ballot by mail, at a drop box, or at an office facility that accepts mail ballots.

The first voters to receive absentee ballots will be North Carolina, which begins mailing ballots to eligible voters on September 6th. Other states open up early voting as well, including Pennsylvania, Georgia, Wisconsin, Michigan and Nevada. In Massachusetts, in person early voting begins on October 19th.

There are so many unanswered questions regarding voting early by mail and this new process. It makes me wonder if Election Day has actually become extinct. Is it just a matter of time before in person voting on election day will no longer exist. How will voter integrity remain intact and how do we ensure the correct person is actually the person casting the ballot when using the early mail in ballot system. With the current speed of change in this country, it seems highly unlikely that voting will ever go back to its original and traditional form, but let's just hope we never lose the right to cast a ballot in an open and democratic election.

A COLUMN OF PAST AND CURRENT EVENTS

September 25, 1690 — The first American newspaper was published. A single edition of *Publick Occurrences Both Forreign and Domestick* appeared in Boston, Massachusetts. However, British authorities considered the newspaper offensive and ordered its immediate suppression.

Publick Occurrences Both Forreign and Domestick was the first multi-page newspaper published in the British colonies in America. Before then, single-page newspapers, called broadsides, were published in the English colonies and printed in Cambridge in 1689. The first edition of



The newspaper consisted of four pages $7\frac{1}{2}$ " by $11\frac{1}{2}$ ", with two columns, with the last page left blank, allowing one to conveniently write a letter about its news that could be sent to another family member or friend.

Without Parliamentary support or any prospective advertising, Harris quickly published what would prove to be the first and last issue of his newspaper. The only known copy in existence is housed in the London Public Record office, where it was discovered in 1845 by the Reverend Joseph B. Felt.

The first and only issue, published Thursday, September 25, 1690, had an account of a battle waged by General Fitz-John Winthrop during the French and Indian Wars covering the brutal treatment of French prisoners of war. No second edition was ever printed because the account angered the colonial government, which ordered the immediate suspension of the paper, only four days later on September 29, 1690, and which referred to the paper as a "pamphlet." All remaining issues of the newspaper were destroyed.

The three-page newspaper did not contain any criticism on the new licensing law for printing newspapers, or make any issues about colonial government. Instead, it appealed to and informed its readers about the various current issues, i.e., the smallpox outbreak, the successful harvest produced by the "Christianized" Indians, a murder, the execution of Native American prisoners of war. These issues were considered sensitive and questionable by colonial authorities, which led them to close down Harris' newspaper.

After the prompt suppression of *Publick Occurrences* and the subsequent passage of the newspaper and printing licensing law, future prospective publishers were discouraged from establishing new newspapers until 1704, when John Campbell established *The Boston News-Letter*. Campbell diligently made efforts to begin publication of his newspaper under authority, and with the proper license. Remembering the fate of the first newsletter, Campbell was careful not to print anything that could be construed as libelous or that otherwise would offend the Governor and the council; he generally limited himself to the reprinting of material taken from the *London Flying Post* and *The London Gazette*.

A Nostalgic Remembrance



Labor Day will be upon us this coming Monday, but other than it being the practical end of summer, it has another significance for me. I met someone during the Labor Day weekend 51 years ago and we've been the best of friends ever since.

Babbononno always used to say, "You can't pick your relatives; you're stuck with them.

But you can pick your friends, so do it wisely." Over the years, I discovered his visions were right on target. My story begins around July 4, 1973. I had been in Hollywood doing some extra work at Paramount Studios and with the summer coming in, most of the production companies housed on the Paramount lot were shutting down for July and August. As a result, I decided to head home. My folks greeted me with open arms, and after settling in, I headed to East Boston to visit Babbononno. He was now in a nursing home and ready to turn 98. When I arrived at the Columbus Nursing Home on Saratoga Street, Uncle Nick was there visiting his father. The three of us chatted, and when it was time to leave, Uncle Nick said, "Oh, by the way, there's a Motown group passing through Boston minus a bass player ... you interested"? I said yes and let it go at that.

A day or so later, I received a call from one of the leaders of the Uniques, a Motown group that was heading north for the summer. Eddie Jackson called at the suggestion of Uncle Nick. He said that the band was heading to Maine and needed a bass player. Knowing from what Uncle Nick had said, I told Eddie that I wasn't African-American. His comment was, "What color's your talent?" I replied, "What do you mean, it's colorless." He then asked, "What color's your bass guitar?" I replied, "Black." Eddie's comment was, "Close enough." So, I joined the Uniques for the summer. I did let the guys know that I would be leaving around Labor Day as I had decided to return to teaching in the Boston Schools and playing music locally. They had no problem with my decision, and so. I headed to the Portsmouth Circle, met the band at the then Howard Johnson's Motor Lodge and followed the caravan northward to Caribou, Maine.

When we arrived at the location, we brought our equipment into a supper club that was part of a motel complex. The room was large, decorated like a Vegas nightclub and the people already in attendance having dinner were well dressed, multi-racial and many of them were in air force uniforms. It did not compute. As far as I knew, that part of Maine had only white people or Indians, (Native Americans) and most were involved in Maine's potato industry. What I discovered later that evening was that there was a SAC base in Caribou, the Loring Air Force Base, the east coast's most strategic missile site. The patrons I saw were employees and servicemen and women from the base. There was nothing else in the way of entertainment for them except the performers at the hotel.

Things went well. I fitted in and learned their tunes and routines rather quickly. The man I mentioned, Eddie Jackson, became my roommate and we hit it off. The money was good, but as August pushed forward, I told everyone that I would be leaving around

Labor Day. Around the beginning of the last week of August, Jerry Cobb, the other leader of the band told me that a New York-based bass player was available and I could leave after the last show on that Friday evening. I was delighted. I had been invited to join a bunch of guys who were going to spend the holiday weekend on the Cape. I called one of the guys and told him I would be able to make it and asked for the directions. I left Maine, stopped at my folks' house in Belmont, packed some Cape Cod clothing and headed for Hyannis. I arrived in the middle of the night exhausted. Paul Blair, the friend who had invited me, showed me my bedroom and told me that there were some other folks coming later in the night. It seems that they all worked at a Boston nightclub and were leaving after work. When they arrived, I was awakened and looked out the window. What I saw made me curious. A '60s gray Jaguar XKE two-seater pulled up with about six people wedged into it. The driver got out and looked like a little kid with a mustache. My comment to myself was, "Oh, what the Hell," and I went back to sleep.

Late the next morning, someone yelled out brunch is ready. Everyone staying at the cottage headed for the kitchen, and I was introduced to all of them. The one who looked like a little kid with a mustache was named Dean Saluti. We sort of hit it off. He was a doctoral candidate at Boston University, working his way through the program as a bartender at Lucifer's, one of three nightclubs located in a complex called The Kenmore Club situated in the middle of Kenmore Square.

As the weekend progressed, Dean and I had many conversations about our back-grounds, growing up in Italian families, both having multiple college degrees, and our likes and dislikes in women, music and food. It seemed that we were always on the same page. When the weekend came to an end, we swapped phone numbers and I headed back to Boston and returned to teaching drafting and engineering subjects at Hyde Park High School by day and playing music at night. Within the week, I called Dean and told him I was playing at a nearby hotel that Saturday evening and would be interested in getting a bite to eat afterward. We headed for Chinatown and a late-night dinner. During our conversation, Dean talked me into applying for entrance to a doctoral program at Boston University, where he was

studying. I already had two masters' degrees and was busy teaching in Boston, playing music nights and periodically heading for Hollywood when they had something for me in the way of acting.

The conversation we had over dinner that night kept cropping up in my mind over the next few weeks and I decided to take one of the exams that would allow me entrance to a BU doctoral program. When I was sent a letter of congratulations by BU, I quickly picked my subject area, signed up for courses and contacted Dean to let him know I was now a BU graduate student. From that point on, we became closer friends, even double dating when there was time. Over the course of that fall and winter I came to know many of his friends and introduced my friends to his crowd. Uncle Nick and I often worked together on weekend nights and he enjoyed hanging out with the younger guys whenever we headed for a late-night restaurant after work.

That friendship hit the 51 year mark this past weekend. Dean Saluti was a groomsman in my wedding party and I fulfilled the same obligation at his wedding to Margie Cahn. For many years after we received our degrees, we worked together in an educational consulting firm he put together. Today, in our senior years, we have the Sons of Italy and our antique cars to augment our lifestyles. But most of all we have the friendship that began 51 years ago, something that is rare and unique in today's world.

TRIPLE CHOCOLATE BISCOTTI

Biscotti al Triplo Cioccolato



8 1/2 tablespoons butter, room temperature

1 cup granulated sugar

2 eggs

1 1/2 teaspoons pure vanilla extract

2 cups all-purpose flour

1 teaspoon baking powder 2 1/2 tablespoons

unsweetened cocoa powder 1 1/2 to 2 cups milk chocolate

1 cup white chocolate chips

Preheat your oven to 350°F (175°C). Line a baking sheet with parchment paper and set it aside.

In a large mixing bowl, cream together the room temperature butter and granulated sugar until the mixture is light and fluffy. Add in the eggs, one at a time, followed by the vanilla extract. Mix until everything is well combined.

In a separate bowl, sift together the all-purpose flour, baking powder, and unsweetened cocoa powder.

Gradually add the dry ingredients to the wet mixture, blending until a dough forms. Once the dough is well-mixed, fold in the milk chocolate chips and white chocolate chips.

Divide the dough in half. On the prepared baking sheet, shape each portion into a log, spacing them apart. Flatten the tops of the logs slightly.

First Bake: Bake in the preheated oven for 25 to 30 minutes, or until the logs are firm to the touch. The exact time may vary depending on your oven.

Cool and Slice: Remove the logs from the oven and reduce the oven temperature to 325°F (160°C). Allow the logs to cool slightly. Using a serrated knife, carefully slice the logs into 1 1/2-inch pieces. **Second Bake:** Place the biscotti slices cut side down on the baking sheet. Bake for another 18 minutes, turning the biscotti over halfway through the baking time to ensure even crisping. Cool and enjoy!

Planting a Garden in the Shade

It is possible to brighten up those shady spots in your landscape? It is all about proper plant selection, planting, and care.

Start by evaluating the sun and shade patterns in your gardens. Monitor the amount of sunlight different areas receive throughout the day and at various times of the year. You may be surprised the space gets more sunlight than you thought.

Make a list of plants you have successfully grown and those that failed in the shady location you are landscaping. Use this information to help you select other plants with similar light requirements.

As always, select plants that thrive in your climate and tolerate the amount of sunlight, moisture, and soil in the proposed garden location. Look for plants that provide attractive foliage all season long and flowers at various times.

When planting under or near trees be careful not to kill the tree when creating your shade garden. Plant a foot or more away from the tree trunk and don't cut or remove surface roots that create entryways for insects and diseases. Dig as small as possible planting holes to avoid disturbing the roots and for easy planting. Avoid adding soil over the tree roots and against the trunk as this can lead to tree decline and even death. Skip deep cultivation that damages the roots, the majority of which grow within the top 18 inches of soil with 50% of them in the top six inches.

Add seasonal color and vertical interest with shade-tolerant annuals like impatiens, begonias, and coleus. Avoid damaging the tree roots by planting these in containers and setting the pots on the soil surface amongst perennial shade-tolerant groundcovers or on mulched beds under the trees.

Once you've planted your garden, adjust the care to compensate for the limited light conditions. Plants growing under large trees or overhangs must be watered more often, especially during the first year or two until the plants become established. The dense canopy of many trees and impervious overhangs prevent rainfall from reaching the ground below. Plus, the extensive root systems of trees and shrubs absorb much of the rainfall that does make it through, so check soil moisture several times a week and water thoroughly as needed.

Spread a layer of organic mulch over the soil surface and away from the tree trunk and crowns of the plants. Organic mulches help conserve moisture, suppress weeds, and improve the soil as they decompose.

Tree and shrub roots also compete with plantings for nutrients. Use a low-nitrogen, slow-release fertilizer that promotes balanced above- and below-ground growth. Apply it at planting and early each spring as needed.

Avoid high nitrogen, quick-release fertilizer that promotes lush succulent growth that is more susceptible to insects and diseases. Plus, limited light is a potential plant stressor that can further increase the risk of problems.

Sometimes there is just too much shade to grow even shadeloving plants. Consider mulching the area to suppress weeds, support the tree's health and protect the soil. Then relax and enjoy the shade on hot sunny days.





They Couldn't Break an Egg But They Knew How to Win Fights




Tommy Loughran

The big punchers always excite the crowd. Even when they are losing fans know they can pull out a victory with one sudden and dramatic punch. There is no other sport where a win can be grabbed from the jaws of defeat so quickly. Seeing a big puncher in action at his devastating best often makes us overlook his flaws. George Foreman looked utterly indestructible until he was outsmarted by Muhammad Ali and taken to school by the light punching Jimmy Young. Tommy Loughran who only scored 18 knockouts in his entire career was able to box circles around Max Baer, who had 18 pounds on him.

While the ones with dynamite in their fists may be in fights that keep fans excited for years, think Foreman vs. Lyle, the accomplishments of the lighter punching fighters should not be overlooked.

Loughran who had a career record of 90 wins with 25 losses and 10 draws won the world light heavyweight title. Tommy failed to go the distance only three times. Once was early in his career because of a broken rib. The other two occasions were when fighting heavyweights. Steve Hamas stopped him in 1932. The two would fight three more times with Loughran winning two by decision and Hamas scoring a points win.

Sharkey kayoed Loughran in 1929, but Tommy would come back to beat the Boston Gob in 1933, decking Jack in the tenth round on his way to a very close decision win.



Billy Conn

Light heavyweight champion Billy Conn's record doesn't put him into the big puncher category, but there is something that stands out upon closer examination.

Conn had just 15 kayos in his 63 wins. But, when you look at his time campaigning as a heavyweight, five of his seven wins came via knockout. That means nearly half of his career storage wins were against men much bigger than he was. What accounted for this. I believe it was because when Billy was in with larger men, he was able to slow down a bit and focus on getting more leverage on his punches. The bigger men did not move as quickly as the middleweights and light heavyweights that Conn had been fighting for so many years.

It should also be noted that Conn had a total of nine fights as a heavyweight and lost only twice. Both of those losses were to the greatest heavyweight champion of all time, Joe Louis. He also came close to beating Joe in their memorable first battle. There was only one other time Billy was stopped. That was in his fourth professional fight when he didn't answer the bell for the third round. Years later he explained he was unable to continue because he had eaten a huge meal before the fight and was having problems with his stomach.



Sid Terris

Lightweight contender Sid Terris is considered among the top when it comes to all-time great lightweights. He was certainly a brilliant boxer. He possessed uncanny speed which he used to dazzle his opponents. His record includes wins over Ruby Goldstein, Babe Herman, Billy Petrolle, Ace Hudkins, Johnny Dundee, and Rocky Kansas.

While compiling 88 wins against just 13 losses, Terris had only 12 knockouts. Should he be discounted because of so few kayo victories? Of course not. Roberto Duran would have had his hands full with this genius of ringcraft.



Maxie Rosenbloom

I'll finish up with one more. Light heavyweight champion Maxie Rosenbloom. Slapsie Maxie had a total of 207 wins during his career. How many were by knockout? Just 19. Yet he is also considered one of the best.

While not putting many oppo-

nents down for the count, Maxie scored wins over a who's who of boxing luminaries. To name a few we have John Henry Lewis, Tiger Jack Fox, Jimmy Slattery, Leo Lomski, Ace Hudkins, Jimmy Braddock, Jimmy Adamick, Lou Nova, Al Ettore, and King Levinsky.

While no footage exists of Rosenbloom's fights, it is said Cus D'Amato got the idea of the peek-aboo style from watching him. He had a style that was quite difficult to deal with.

Out of 274 fights, Maxie was only stopped twice. Rarely being stopped is something these low knockout ratio fighters have in common. Part of it is probably attributable to their having solid chins, and also to the fact they were such smart boxers.

Adjectives usually coupled with their names include; fast, crafty, shrewd, calculating, and ghost like.

I have looked at only four of these great boxers here, there were any more. They are proof that being a power puncher isn't the only way to make it to the top. In fact, these men beat any hard punching foes. I also find them more interesting to watch. They knew their craft and were something to see in action.

HOOPS and HOCKEY in the HUB

There was an interesting small tidbit of information in a recent piece in Sports Illustrated that focused on the NBA Champion Boston Celtics.

It was briefly noted by the magazine, which was a weekly for decades following its founding in 1954, but has now cut its print edition back to 10 times per year, that Celtics star Bob Cousy was the highest paid player in the NBA during his final season in the league.

The magazine's first year coincides with Cousy helping to found the NBA Players Association — an organization that continues to this day. He served as the organization's first president.

In another piece, written in 2023 by Celtics Insider scribe Chris Forsberg, Cousy indicated "my last year (1962-1963 season) they told me I was the highest paid player in the league. I made \$35,000. One of the things I am most proud of is starting the Players Association. Because that has lent itself years later, in terms of the interaction between the Players Association and the owners, to guys signing \$300 million contracts for playing a child's game."

That's right. During the 1962-1963 campaign, his final season in the NBA, Cousy was the highest paid player in the entire league. His salary will seem seriously underwhelming for those who follow pro basketball in contemporary times. But it was a significant improvement from the amount paid to him during his rookie season some \$9,000 for the 1950-1951 season.

That \$35,000 is not even a full single day's pay today compared to the numerous contemporary players who have signed multi-milliondollar contracts with their franchises. A number of them make over \$100,000 per day on a year-round basis when you divide their annual compensation by 365 — the number of days in the year.

Cousy would go on to become the head men's basketball coach at Boston College for six years, where his annual salary was significantly less than his final annual NBA salary. He supplemented his rather low annual college coaching salary through endorsements for basketball equipment.

In six years at The Heights, he put together a record of 117-38 that included making the NCAA March Madness tournament as well as going to the NIT championship game in 1969.

He left to become the head coach of the Cincinnati Royals franchise in the NBA.

Whatever fans may think of the Jacobs family — and opinion has always been somewhat divided within Bruins Nation — know this. Max and Jeremy Jacobs were the ones who enabled Cousy to live a lifestyle worthy of his fame.

They owned the Royals and wanted Cousy as the coach. According to a 2013 article in the Worcester Telegram, "they agreed to Cousy's request of \$125,000 a year (in salary), an apartment and a car. So Cousy coached the Royals for four and a half years before the Jacobs family sold the team and he was let go. But not before he made enough money and invested it wisely to assure him a comfortable life."

The Houdini of the Hardwood would not disappear. He would go on to a career in sports broadcasting, working local telecasts of the C's on game nights as a knowledgeable commentator for 34 years.

Bob Cousy hopes to return to the Garden for the game against the New York Knicks on October 22nd — the night that Banner 18 will be raised to the rafters and the Celtics will receive their championship rings.

As such he will be the only living member of the first Celtics championship team in attendance. That occurred in 1957. It also means that Cousy is one of the few associated with the team in any capacity that has witnessed the franchise win all 18 titles.

WILL THE CELTICS AND KNICKS MEET IN THE POSTSEASON? — While all fans are looking forward to the October 22nd opening game at the Garden between the two historic franchises, a number of the fans in Gotham have their eyes already set on a possible matchup in the 2025 Eastern Conference Finals next May.

That's because, according to a piece by Stefan Bondy in the New York Post, a number of prognosticators have already picked the Knicks to finish second in the Eastern Conference standings.

If everything worked out the way they do the math down there, both the first place Celtics and the second place Knicks would advance through the first two rounds of the Eastern Conference playoffs and then face each other in the Conference Finals.

That would prove to be an extended postseason run for the New Yorkers since the Knicks have not made it to the third round since 2000 — with only the Charlotte Hornets and Washington Wizards having even longer absences from the ECF.

Jalen Brunson, the new captain of the Knicks, has already acknowledged that advancement is something that the team has to focus on. "What can we do to get past the second round? That

Actually, the possibility of the Knicks advancing to the Conference Finals to face the Celtics came close to happening last spring. In their second-round matchup against the Indiana Pacers, the Knicks jumped out to a 2-0 lead in the series before Indiana fought back to tie the series at 2-2.

Even so, the Knicks won game five, thus providing the New Yorkers with two opportunities to close out the series and go on to meet the Celtics. But it didn't happen as the Pacers came back to win both game six and game seven.

That seventh game, by the way, was played at Madison Square Garden. "If you win a game seven at Madison Square Garden you have made history," said triumphant Indiana coach Rick Carlisle as he walked off the court following the convincing 130-109 victory.

And thus, an historic matchup in the ECF between the Knicks and the Celtics was denied for at least one more year. What will next spring bring?
