Massachusetts State and Local Primary Election Results are In

Massachusetts Primary races have now been decided, not that there were many to keep an eye on. The highest profile competition was amongst the three Republican challengers, John Deaton, Robert Antonellis, and Ian Cain, all vying to take on Incumbent Massachusetts Senator Elizabeth Warren. On Tuesday, September 3rd, Former Marine Corps Veteran and attorney John Deaton easily bested his two Republican rivals to secure the nomination. Deaton will now face Democratic Senator Elizabeth Warren on the November 5th ballot. Warren is a two term Democrat from Cambridge, and faced no challengers in the recent primary, automatically advancing to the upcoming general election.

The candidates will face off in two debates, both scheduled in October, one in Boston, one in Springfield, although Deaton has challenged Warren to five debates to discuss abortion rights, the Supreme Court, funding for Medicare, Social Security and many other issues facing Massachusetts residents. Warren has attempted to portray Deaton as the "Crypto"

Candidate", stating "A small handful of crypto billionaires and corporate special interests poured more than \$2 million into a super PAC to handpick their preferred Republican candidate, and now Massachusetts voters have a clear choice that could determine control of the U.S. Senate." Deaton has said cryptocurrency would not become a central issue in his campaign or this race but intends to focus on issues facing Massachusetts voters, including addressing immigration at the federal level to combat costs to Massachusetts taxpayers have incurred over the past year to house and feed the influx of migrants in state-run emergency shelters, along with the economy, income inequality, securing the border and ending the migrant crisis, foreign wars and women's reproductive rights

Warren will prove a formidable challenger for Deaton, as she is a progressive Democratic favorite and is currently seeking her third elective term. Deaton will need to rely on Massachusetts large segment of unenrolled




THE SCIPIONIC CIRCLE

We continue with our brief biography of the literary Latins and the "Early Age" or "Age of Greek Influence." Last week, we discussed Andronicus Livius, the founder of Roman dramatic and epic poetry. This week the concentration is on the famous Scipionic Circle. First, of course, there was Scipio himself. When researching this great Roman it soon becomes evident that he is number 15 in a line of about 32 Scipios. Our famous Scipio of the moment is properly called P. Cornelius Scipio Aemilianus Minor or Scipio the Younger. He became a student of literature rather than a literarian. He was a great army general and served with distinction in Spain, destroyed Carthage, then reduced Africa to the form of a Roman province, in addition to a distinguished career as a Roman Consul. This Scipio was also a brilliant orator and patron of the arts who gathered around him a group of statesmen, philosophers, poets, historians, and playwrights. The group soon became known as the Scipionic Circle and included men like Polybius, Panaetius, Terence, and Lucillius.

Polybius was one of the most important Greek historians. He was born at Megalopolis and received early instruction in military and political affairs. He was one of a thousand noble Greeks taken hostage and detained in Rome for 17 years. Because of his education and culture, he was welcomed into the most distinguished Roman houses where he soon became a friend and counselor to Scipio.

Later when Greece was converted into a Roman province, Polybius was placed in charge of

organizing the new government in the Greek cities and it was here that he gained the highest recognition for himself. His later years were spent in travel and writing. He wrote at least 40 books which recorded the rise of Roman supremacy, its efforts toward worldwide domination, its consolidation, and its defenses against overthrow. His record of occurrences is clear, sound, truthful, and is ranked with the greatest of historical writings.

Panaetius of Rhodes was one of the greatest stoic philosophers of his time. Stoic philosophy, as we know, is that which teaches of a divine power and its control over all happenings and destiny. It also teaches to calmly accept these happenings. Panaetius was educated at Athens and became the head of their stoic school and died at the age of 69 or 70 years of age. Only unimportant fragments of his writings remain, however, it is said that some of his early work furnished inspiration for many of the orations of the great Cicero.

Terence, whose full name is Publius Ternetius Afer, came to Rome as a slave from Libya. His owner, Ternetius Lucanus, was impressed by his natural literary gifts, had him educated, and later gave him his freedom.

After writing six successful comedies, Terence visited Greece in order to study Greek life and institutions, so that he could represent them accurately on the Roman stage. He died in a shipwreck at sea on his return trip from Greece and we are told that 108 translations of Greek comedies perished with him. In his comedies, Terence took his adopted Latin language and made it more artistic by carefully shaping it to the graceful rhythm and diction of the Greek dramatists. His work has been studied and praised by succeeding masters who agree that dramatic literature in general is indebted to Terence, who has left a marked influence on the style of later

Our last Circle member is Gaius Lucilius who was the creator of Roman satire. He was born of a good family, served under Scipio in the Spanish campaign and became his friend. He developed the satirical form in which it is later found in Horace and Juvenal. He wrote 30 books of satires, but only about 300 lines are preserved in fragmentary form, thus leaving just a slight clue to his method and style. It appears that he was boldly original and almost an eccentric genius. He had a most unusual vocabulary that overflowed with strange words and disgusting expressions and never did learn how to say "arriverderci."

He proudly boasted to the DNC crowd "Donald Trump thinks we should trust him on the economy, because he claims to be very rich. But take it from an actual billionaire, Trump is rich in only one thing — stupidity."


Maybe these elites should take a long hard look at their surroundings before they stand in front of every day, hardworking Americans with their comedy routine.

Gift Christopher Columbus Statue to St. Leonard Parish

In 2020, the Christopher Columbus statue, on proud display at Christopher Columbus Park, on the North End Waterfront for over 40 years, was senselessly attacked and severely damaged. After a number of discussions regarding the disposition of the statue, it became clear that it may never be returned to its home, Christopher Columbus Park. Since Ausonia Council 1513 Knights of Columbus was a co-sponsor of erecting the statue in 1979, the members stepped forward to guarantee the statue would forever remain in the North End community.

The Ausonia Council petitioned the City of Boston to display the statue at the elderly apartment project, located at 41 North Margin Street. In order to bring the statue back to its original condition, a noted restoration expert was commissioned to make the necessary repairs. Two years later the restoration was complete, allowing the Ausonia Council to install it at their project on May 16, 2023.

With the goal and intent of finding a site more visible and accessible

to the community, council members worked closely with Father Michael Della Penna, Chaplain of the Ausonia Council and Pastor of St. Leonard Church on Hanover Street. Based upon Columbus' personal association with the Franciscans, he often donned the traditional Franciscan habit when in the presence of clergy, his role as a secular Franciscan, his deep faith in Jesus and Mary, and known for spreading Christianity across the Americas, the council decided to gift the statue to St. Leonard's Parish, where it serenely rests in the Peace Garden.

L'Anno Bello: A Year in Italian Folklore

The Voices of the Vineyards

September in Italy is a glorious time of the year. The sun still bakes the landscape into glorious hues of amber and ochre. Local festivals called sagre celebrate the ongoing harvest, with town squares becoming veritable banquets of local specialties ranging from apples to truffles to figs. Of course, the country begins gearing up for the autumn as well, as the dusky nights become cooler and people adjust to rigorous rhythms of the new season. However, one September event particularly captures the whole essence of Italy in the fall. It is called la vendemmia, or the grape harvest, and it sweeps the country through the autumnal months. La vendemmia is a sacred ritual in Italy, where the grape comprises a prized crop and its final product, wine, forms the crux of the national character. Throughout this harvest, Italian towns buzz with the energy of people collecting their grapes in giant wicker baskets or on the back of tractors, ready to be eaten as a fresh seasonal treat or distilled into the country's famous wines. Communal pleasures blend with hard work in order to create a beautiful dance of quaint customs, careful food preparation, and long-term planning for the cold months ahead. Observing Italian vendemmia customs reveals much about the power of harvest as a way of respecting the Earth and the lure of traditions, even in modern Italy.

Indeed, the sight of vineyards perched on rolling hills, with dappled sunlight shining through the gemlike green leaves and violet grapes, has become an indelible symbol of Italy, often being the first image that enters people's minds when they think of the Italian countryside. Italian immigrants to the United States brought over their love for the all-important grape when they crossed the ocean, making it a staple of Italian-American culture. Grapes were

my father's favorite fruit, and a bowl of translucent and sweet pale green grapes, or velvety purple fruit, frequently sat on our kitchen table. Several relatives of mine grow grapes at home, the gnarled vines and wild leaves creeping over backyard trellises like a labyrinth. Back in Italy, the same vineyards that adorn postcards and posters are humming with activity for the September vendemmia. Skilled farmers know the precise temperature and weather that make for the best picking conditions and will produce the optimal grapes and wine. Nowadays, many people adapt technological methods to la vendemmia, using the latest gadgets to test the acidity of the grapes. However, tradition still reigns supreme in many parts of Italy, where the whole village assembles to pick grapes, from the grandmothers in kerchiefs to the hip young people on break from college. One can sense the Bacchanalian revels of old in these communal gatherings.

La vendemmia is so vital in Italy precisely because much of these harvested grapes will be used in one of Italy's most iconic products, wine. Wine, or vino, holds a significant spot in Italian culture and society, finding a place on every dinner table and forming the basic tenet of Italian hospitality. Wine is also imbued with a religious connotation, serving a prominent place in the Eucharistic ritual of bread and wine. It is not unusual for the basements in some of my family members' homes to be stocked with bottles of wine, glowing an eerie shade of white and purple in the dim light, aged to perfection and ready to be brought out to greet the arrival of a guest. Indeed, wine is such a touchstone of Italian society that numerous superstitions protect its reputation and warn of dire consequences to anyone who mistreats wine. A superstition that hearkens back to Roman times states

that a person who spills wine must dab a little behind each ear to ward off any bad luck that comes from the waste of the precious drink. However, Italians do consider it good luck to spill wine on new clothes or a tablecloth. Perhaps this is a way for the wine to transfer its inherent positivity to the new garments. Miscellaneous wine superstitions further include never toasting with water, but rather always with wine; avoiding serving wine "backhanded," or with the back of the hand facing guests; and women refraining from drinking the last drops of wine in a bottle at the risk of remaining unmarried (this superstition, of course, is from olden days when society dictated that women *must* get married). I do not drink wine myself, but I appreciate the wisdom and customs of my ancestors behind its making.

I believe that one of the most important lessons to be gleaned from la vendemmia is patience. Farmers must wait a long time for the grapes to be just right for picking; gathering the crop any sooner or later impacts that taste of the fruit and the eventual wine. Later, winemakers similarly ready themselves for the grapes to be distilled and the must to turn to wine. The traditional day in Italy for tasting new wine is actually St. Martin's Day, or la Festa di San Martino, which falls on November 11th - two months after the bulk of the grape harvest has taken place. Afterwards, though, the wine becomes a crucial part of the Italian holiday season and beyond. As we enter the fall, with its new rhythms and its return to school and work, we can all learn lessons from la vendemmia. We can set many goals for professional and personal improvement, but we should realize that they will take patience, dedication, and hard work in order to manifest. Once they do, however, they will be as beautiful and well-earned as the finest Italian wine, which once started from the lowest, barest vine. Just as Italians gather grapes this September, let us gather our own hopes, dreams and challenges and work to make them come into fruition this autumn and all year long.

Saint Verena of Zurzach

The oldest tradition of the life of Saint Verena is found in the so-called *Vita* prior by Hatto, the abbot of Reichenau (and later bishop of Mainz), written in 888.

According to Hatto's account, Verena was born to a noble Christian family living in Thebes, Egypt. She was educated by a bishop named Chaeremon. A bishop Chaeremon of Nilopolis is mentioned by the historian Eusebius as martyred in 250, which would place Verena's birth before that date.

After the death of Chaeremon, Verena travelled to Lower Egypt with a group of Christians, where the Theban Legion (a group of Egyptian Christians) was being recruited. With the Theban Legion, she then travelled to Milan. While still in Milan, she heard of the martyrdom of the Theban Legion (an uncertain historical event traditionally dated to 286, during the reign of Maximian) and travelled



to Agaunum (modern Saint Maurice, Switzerland) In later sources, she is said to have buried the martyred legionnaires.

Verena then moved on to Rhaetia [modern Switzerland] and settled in a region called Solothurn in a hermitage, and spent her days in fasting and prayer, and working miracles. Hatto presents her as a prototype of the consecrated virgin, saying that she attracted a following of young virgins. She was at one point imprisoned by a local governor, and Saint Maurice appeared to her in jail to console and strengthen her. After she was released, she continued her good works. At the end of her natural days, she retired into a narrow cave.

The year of her death was calculated as 344 by Johannes Laurentius Huber (1812–1879), provost at Verenamünster in Zurzach (Zurich).

The feast day of Saint Verena is September 14th.

Tecumseh

Tecumseh, whose name in Shawnee means "shooting star" or "blazing comet," was born in 1768 in the western Ohio Valley to the Shawnee chief Puckeshinwa and his wife Methoataske. According to legend, he was given his name because at his birth a meteor or comet was seen in the sky.

Tecumseh was born in what is now Ohio at a time when the far-flung Shawnees were reuniting in their Ohio Country



homeland. During his childhood, the Shawnees lost territory to the expanding American colonies in a series of border conflicts. Tecumseh's father was killed in battle against American colonists in 1774. Tecumseh was thereafter mentored by his older brother Cheeseekau, a noted war chief who died fighting Americans in 1792.

As a young war leader, Tecumseh joined Shawnee Chief Blue Jacket's armed struggle against further American encroachment, which ended in defeat at the Battle of Fallen Timbers in 1794.

In 1805, Tecumseh's younger brother Tenskwatawa, who came to be known as the Shawnee Prophet, founded a religious movement that called upon Native Americans to reject European influences and return to a more traditional lifestyle. In 1808, Tecumseh and Tenskwatawa established Prophetstown, a village in present-day Indiana, that grew into a large, multi-tribal community.

Tecumseh traveled constantly, spreading the Prophet's message and eclipsing his brother in prominence. Tecumseh proclaimed that Native Americans owned their lands in common and urged tribes not to cede more territory unless all agreed. His message alarmed American leaders as well as Native leaders who sought accommodation with the United States. In 1811, when Tecumseh was in the South recruiting allies, Americans under William Henry Harrison defeated Tenskwatawa at the Battle of Tippecanoe and destroyed Prophetstown.

When the War of 1812 broke out, he joined the British as a brigadier general. He recruited warriors, and helped capture Detroit in August 1812. The following year he led an unsuccessful campaign against the United States in Ohio and Indiana. When U.S. naval forces took control of Lake Erie in 1813, Tecumseh reluctantly retreated with the British into Upper Canada, where American forces engaged them at the Battle of the Thames on October 5, 1813, in which Tecumseh was killed. His death caused his confederacy to collapse. The lands he had fought to defend were eventually ceded to the U.S. government. His legacy as one of the most celebrated Native Americans in history grew in the years after his death.

A Tribute to Tradition, Family, and Italian Culture

Held annually in honor of St. Alfio, St. Filadelfo, and St. Cirino, three brothers who were martyred for their faith almost 1,800 years ago, the Feast of the Three Saints is a Sicilian tradition brought to Lawrence, Massachusetts, 101 years ago by the St. Alfio Society founders who had immigrated from Trecastagni, Sicily.

More than 100,000 people from across the country converged in Lawrence on Labor Day Weekend to attend the 101st Feast of the Three Saints. Both a religious festival and a celebration of Italian culture, the Feast this year offered live entertainment, great food, family fun, a carnival, raffles, and the famous Torchlight Parade.

On Sunday, the final day of the Feast, a Solemn Mass was followed by a 5-hour Procession of the Saints along the traditional route through what once was the old Italian neighborhood. The procession culminated with "The Moment of Glory" in front of the St. Alfio Society building on Common Street. After a special benediction of the crowd with the relic of the Saints, balloons and doves were released into the sky along with fireworks and showers of confetti while the crowd cheered "Viva St. Alfio." Tony Palmisano, president of the St. Alfio Society commented, "The St. Alfio Society would like to thank everyone who came out to help us continue our tradition of honoring the Saints and helped to make this year's feast another tremendous success."



The Carney Hospital and the Role of Hospitals in the Community

When my grandfather arrived from Venezuela in 1985 and joined us settling in Dorchester, finding a Spanish-speaking doctor was among the many challenges. This was a greater challenge in the 80s (even in Boston) than it is today, but the Carney Hospital was there, and my grandfather had a dependable doctor a few blocks away. Since then, for nearly forty years, the Carney has served my family. Even for those who saw a physician elsewhere, the Carney was there if a rush to the emergency room was ever needed.

As a child my appointments were at the Neponset Health Center where I came to know not only my doctor but the nurses and staff well. When I got sick with mononucleosis at the age of seven the clinic became my second home. I refer here not only to the frequency of my visits but the comfort and reassurance my family was given here by the medical staff that had known me since infancy.

After college, when I had to decide on a regular primary care physician, the Carney seemed an obvious choice. I had been going there for years visiting or accompanying relatives and my family had history there. Apart from this the Carney Hospital existed in my psyche as a staple of Dorchester. A deterrent for me and my childhood friends from engaging in dangerous stunts was a threat to having to go to the Carney Hospital as a consequence.

And wouldn't you know, my doctor was the same doctor who had seen my grandfather some twenty years earlier. He remembered my grandfather, inquired about him and was sorry to hear he had passed away back in 2000. After the doctor's retirement I chose to keep the Carney as my hospital and the place (despite obvious changes both physical and administrative) always felt like home. But, far away in Texas, where the Carney's parent company, Steward Health Care, is headquartered, clouds were forming

By now we know what happened. The first domino push was all too familiar. A tale of

corruption, greed and embezzlement, ending as usual with the most vulnerable paying the heaviest price. There's no need to rehash the details here. Instead, I want to focus on a lesson here that I hope in the whole saga does not go unnoticed.

When we think of community pillars hospitals rarely stand out. This is understandable, hospitals are uniquely places people don't want to have to visit. But do they ever want one nearby. A dependable place where citizens of all means can feel secure, welcome and taken care of at an hour of need or an hour of grief is something no community worthy of the term can do without. Robbing communities, especially one in which many of the residents are of limited means, of a nearby place where they can turn to for life-saving measures is an act of unparalleled immorality.

Despite a brave fight from the community and local politicians the Carney Hospital was one of two Massachusetts Steward-owned hospitals that could not find buyers and closed its doors on August 31. Patients already facing illness and the costs incurred were devastated and the tears from staff were as heartfelt as any I

We ignore hospitals when reviewing cherished memories because the time spent in them is often time we wish to forget. But a hospital that has served a community for decades and seen the generations of a family go by plays a bigger part of our emotional development than they are credited for. For us who grew up in Dorchester, the Carney Hospital served a need but it was also a part of our collective memories. We may not have thought of it as a fun place to be, but we took comfort in knowing it was there like an old family friend.

To the staff of the Carney Hospital who offered exceptional care to myself and my family and who never wavered in their commitment to the community they served I can only offer my sincerest gratitude. They deserved far better.

A Nostalgic Remembrance



I've been asked by a few people who follow my story line how I wound up in Hollywood. Well, it's a bit complicated and amounts to being in the right place at the right time, so here goes: Once upon a time, (September of 1956) I started my freshman year at Boston State College (now part of U. Mass Boston). The people I met were quite different than my pals from the street corners of East Boston, and to understand them better, I got involved with a lot of the school and social activities that were at hand. At the time, I fashioned myself as a comedian and did a little standup at college socials. I hadn't, as of yet, turned professional as a musician and this was my baptism into show business, even though it was on an amateur level. I wasn't bad, but there was another freshman who was much better, Bob Blasser. He was good, looked like a comedian and I therefore convinced myself that I should stick to music, and I did.

A few years later, I was called by a band leader whom I had never worked for but knew of through the business. He asked me if I was free on a couple of particular dates. I checked my book, saw that they were in the middle of the week and told the man I was free. He gave me all of the information and said I would be the bass player in the pit band for the Bob Blasser Show.

Evidently, his bass player had quit, and he, Frank Martelli. got my name from his trumpet player, Frank Biondo, whom I had known from my Boston State days. When I arrived at the theater where the show was to take place, I had a big hello from Biondo who introduced me to Martelli. Once I met the rest of the musicians, I realized we had all heard of each other through the business, but I had never worked with any of them. Martelli, gave me the music for the acts and a verbal walk through of the things Blasser would be doing, and twenty minutes later, the show began.

When Bob Blasser walked on stage, I saw that it was the same comedian I had known at Boston State. Before he began the show, he introduced someone I knew of rather well, Boston's Arch Bishop, Cardinal Cushing. The Cardinal made a small speech to the crowd and after it, I knew the reason for the show. It seems that when someone from one of the cardinal's parishes was killed in Vietnam, he would put a scholarship together in that serviceman's name, and kick off the whole thing with a fundraising show. The Cardinal knew of Blasser, due to the fact that before his years at Boston State, Bob was a seminarian, hoping to become a priest. Bob left the seminary, headed for college and then show business, but stayed friendly with the Cardinal. The show went off without a hitch. Bob did several minutes of standup and then imitated several radio and TV greats, Jack Benny, George Burns, Red Skelton and a few others popular back then. When he was done, several acts of entertainment followed, hence the earlier hand out of the music which now sat on a stand in front of me. George Mann, an Irish tenor,

led off the next part of the show, followed by a tap dancer, a doowop group, Bob Blasser again, and then a jazz selection from the orchestra. After intermission, Blasser came down the main isle of the theater with a basset hound on a 20-foot leash. He was formally dressed like Reggie Van Gleason, one of Jackie Gleason's characters. As the audience roared, we played Melancholy Serenade, the tune that usually introduced this Gleason character. Once he was on the stage, the dog decided to relieve himself, a biological function which had the audience roaring in laughter. In Jackie Gleason's voice, Blasser made a couple of comments regarding the dog's public indiscretion, and the show continued. When it ended, we serenaded the people as they exited the theater. After all the folks were gone, Bob Blasser came over to me and both of us reminisced about our days at Boston State.

The next thing I knew, I was part of the band permanently. Bob had told the leader that we were old friends and he wanted me to stay on and do all of his shows. Well, for the next couple of years, just about all of his shows were during the week

and I could play them. Again, most all were for Cardinal Cushing. After the end of the second year, Frank, the band leader, and Bob had a disagreement which I won't go into, but Frank quit. Bob asked me to take over as music director for his shows. I said yes, and the next thing I knew, we had a Sunday evening variety show on one of the Providence TV stations. As I got more involved, Bob asked me to be his partner in the production department. From this point on, whenever he met with the Cardinal, I was part of the meeting process as a partner.

When Bob told the Cardinal, that we would like to try our hand at operating in New York, he made several contacts for us. One was with Allan Funt the producer of Candid Camera. We actually wrote skits for him and appeared in a few of them ourselves. One of the other contacts that the Cardinal made was with Otto Preminger, the Hollywood producer/actor who had a New York office. To begin with, Preminger set us up with Alka Seltzer. We wrote and appeared in a commercial that was rather funny. It aired in other parts of the country, but not the northeast. My mother, who was dying to see it, never

One of the people close to the Cardinal was Jimmy Durante. He was a guest at a few of the Bob Blasser shows. As a result, Bob, I and a few of the musicians in the band did a little traveling with Jimmy. His act in those days consisted of himself, Eddie Jackson, a member of his vaudeville act from years earlier (Clayton, Jackson, and Durante), and the retired heavy weight champ of the world, Rocky Marciano.

When we were back in New York, contacts were made for us in Hollywood. Bob and I went out together and called the people who were waiting to hear from us. As a result, we began to go in separate directions. He began to appear on the Jack Benny Show, the Red Skelton Show, the Jonathan Winters Show and the Art Linkletter Show. He got me to appear on Skelton and Winter's shows, but I was told that my face was too pretty for comedy or too sinister ... I could take my pick. It seemed that Hollywood wasn't for me, so it was back to Boston and New York, playing music on weekends and teaching school in Boston Monday through Friday.

Some of the contacts I made in New York paid off and I began to get more bookings in music there on weekends than here. Dad was thrilled that I was making it in New York. Babbononno was happy that I made the musician-line in the family three generations in a row. But, unbeknown to most, the Hollywood bug had bitten me when I was out there, and I wanted to try my hand, not at comedy, but more serious acting, but that's a story for another day.



Pollo alla Valdostana is a classic dish hailing from Italy's Valle d'Aosta region, a place well-known for its exceptional Fontina cheese. These rolled bundles were placed side by side in a baking dish, basted generously with a mixture of butter, olive oil, and a splash of white wine. To finish, we drizzled the butter and olive oil mixture over the top and baked the dish uncovered until it achieved a perfect, golden color.

The result is a scrumptious, mouthwatering version of Pollo alla Valdostana, where the crispy exterior gives way to a tender, cheesy center that captures the heart and soul of the Val d'Aosta region!

VALLE d'AOSTA CHICKEN Pollo alla Valdostana



6 to 8 chicken cutlets, thinly sliced 6 to 8 slices prosciutto

6 to 8 slices of fontina cheese 1 ½ cups sour cream 2 cups seasoned Italian

breadcrumbs

1 ½ sticks butter, melted ¾ cups olive oil ¼ cup white wine salt and pepper, to taste Long oven-proof toothpicks

Preheat the oven: Set your oven to 350°F (175°C).

Prepare the chicken: Place the sour cream in a large zip-top bag, add the chicken cutlets, and coat each one well. Seal the bag and refrigerate for 30 minutes to marinate and tenderize.

Prepare the breadcrumbs: In a flat dish, place the seasoned Italian breadcrumbs.

Mix the butter and olive oil: In a small bowl, mix the melted butter and olive oil together. Transfer the mixture to a cruet for easy drizzling.

Prepare the baking dish: Take a 13 x 9-inch baking dish and drizzle some of the oil/butter mixture over the bottom. Coat evenly, then pour the white wine over this mixture.

Coat the chicken: Remove each chicken cutlet from the Ziploc bag, ensuring both sides are coated with a thin layer of sour cream. Dip the cutlet into the breadcrumbs, coating it evenly.

Assemble the rolls: Lay each breaded cutlet flat on your work surface. Place a slice of prosciutto and then a slice of Fontina cheese on top. Roll the cutlet up and secure it with a long, oven-proof toothpick. Place the rolled chicken in the prepared baking dish. Repeat this process with each cutlet, placing them side by side in the dish.

Drizzle and bake: Once all the chicken rolls are assembled, drizzle the remaining oil/butter mixture over the top of each one. Bake the chicken uncovered for about 35 to 45 minutes, or until golden brown. Use a meat thermometer to check the internal temperature at the thickest part of the chicken; it should read 165°F (74°C) to ensure it is fully cooked.

Rest and serve: Remove the dish from the oven and let the chicken cool for about 7 to 8 minutes before serving.





Disney's America:

The Park that Almost Was
PART II



By the summer of 1994 Disney announced that the slavery aspect was scrapped and the park would refocus its mission. To further appease critics who objected to the sacrilege of a Disney Park opening so near a Civil War battlefield Disney pledged to donate to various preservation societies and assured critics that its proximity would only attract more visitors to Manasses.

"Disney's America not only will not replace historic sites but rather will add to their luster by enthusing our guests about events that occurred there and the people who took part in them. We are confident our project will actually encourage more people to visit historic areas. And we believe our presentation of the American heritage can make a significant national contribution to the important cause of historic preservation," Eisner said. "We plan to use all of the tools available to us - filmmaking, animation, environments, music, interactive media, live interpretation — to bring the American experience to life. We are working with historians and other experts to make Disney's America an engaging and genuine encounter with America's past. Together, we have identified some common themes that run through the American experience — our persistent resistance to injustice, our quest for tolerance and inclusion, our history of rising to challenges, our faith in the promise of the future and our belief that ordinary people can accomplish extraordinary

We believe that every person, particularly the children, who can touch history and sense the emotions of a time or event, will be impelled to learn more. This is the vision and purpose of Disney's America."

Disney's new vision for the park (illustrated through concept art and brochures) involved dividing the park in nine sections, each offering a brief lesson of various times in American history. The sections mapped out included Crossroads USA would focus on the half-century leading up to the Civil War, Native America would have featured recreations of native villages of tribes from the area, President's Square would have housed replicas of the Hall of Presidents, Civil War Fort, Enterprise (focusing on the industrial growth and urbanization), We the People

told of the early immigrant experiences, Family Farm, State Fair and Victory Field (centering on the entry into WWII).

Despite this opposition to the site continued from the locals. In September of 1994 Disney announced it would be seeking a new location for the park.

Peter S. Rummell, President of Disney Design and Development Co., said, "We remain convinced that a park that celebrates America and an exploration of our heritage is a great idea, and we will continue to work to make it a reality. However, we recognize that there are those who have been concerned about the possible impact of our park on historic sites in this unique area, and we have always tried to be sensitive to the issue. While we do not agree with all their concerns, we are seeking a new location so that we can move the process forward.

Despite our confidence that we would eventually win the necessary approvals, it has become clear that we could not say when the park would be able to open — or even when we could break ground.

The controversy over building in Prince William County has diverted attention and resources from the creative development of the park. Implicit in our vision for the park is the hope that it will be a source of pride and unity for all Americans. We certainly cannot let a particular site undermine that goal by becoming a source of divisiveness."

Somewhat hidden in

Rummell's words is the truth of the matter. Ultimately, it was not public opposition that was the death knell for Disney's America but the simple logistics. By the mid-1990s, Disney was preoccupied with the expansion of Disneyland which would become Disney California Adventure and proper attention to could not be allotted to a park that was already a public relations headache. Further, Euro Disney had returned less than half the projected profits and perhaps Disney saw a warning in this. The announcement of that park had sparked outcries from French cultural critics strikingly similar to those surrounding Disney's America and now Disney was seeing the financial consequences. Could a similar fate await Disney's America when opened at the projected date of 1998? It should be added that Euro Disney (now renamed Disneyland Paris)



has undergone a significant face-lift, better attuned itself to French customs and, while not Disney's most profitable park venture, has salvaged itself quite well. But Disney could not have foreseen this in the fall of 1994. The location once again delivered the final blow but in a way Disney did not foresee. A park this far north in the unpredictable climate of Virginia would not be able to operate year-round as it could in Florida or southern California. Simply put, even without the controversy surrounding it the park would not be profitable.

By the spring of 1995 was selling off the land it had acquired for the park. Disney's America was officially dead. However, rumors of a revival came about within the following year when Knott's Berry Farm (Disney's original neighbor back home in California) went up for sale. Disney jumped at the chance and made an offer, seeing it as a great location to give Disney's America a second chance. Here weather was not a concern and the area was already built up so opposition from locals was unlikely. In addition, the area was not home to any hallowed ground sites that would spark accusations of insensitivity. Disney planned to use the park's replica of Independence Hall as the center point of the park. Once again, however, Disney's plans were dashed. The Knotts family chose to sell it instead to the Ohio based Cedar Fair in 1997. Their fear was that Disney would alter the farm their parents built beyond recognition.

That really was the end of Michael Eisner's dream project. If it has been kept alive at all it was not by Knott's Berry Farm but by its competitor for attention, Disney California Adventure where some of the ride concepts live on in new forms. Family Farm became Bountiful Valley Farm, the Lewis and Clark Expedition Raft Ride is now Grizzly River Run and California Screamin' is the reincarnation of the State Fair Rollercoaster.

Meanwhile, Prince William County, the original site proposed for Disney's America, saw a population boom in the thirty years since its battle with the Mouse resulting in multiple housing developments and increased traffic. As for Knott's Berry Farm, the new owners actually changed more of the park than Disney had proposed to had their bid been accepted but at least the old park (America's first theme park, as it proudly toots) retained its original name. In a sense, the story of Disney's America is the classical story of American enthusiasm, vision, go-getterism and triumph balanced with loss. Fights for heritage and family legacy are two of the very few forces that can successfully fight off corporations. But in this land even crushed dreams live on in their fragments.







HOOPS and HOCKEY in the HUB

The cool nights on the first few evenings after Labor Day seemed timed just about right as students headed back to high school and college for fall sports with the NHL and the NBA not far behind in their initial preparations.

Early on comes the Hockey East Media Day at the Garden (September 9th) when representatives of every men's team and women's team that comprises the Hockey East Association will be on hand to meet with members of the Fourth Estate in the official commencement of the upcoming season.

By the end of the month virtually every Hockey East team will have seen action. Some of the women's team will take the ice for games as early as September 21st.

The men will use the balance of September for practice with season opening contests slated for the first few days of October.

And remember, these are games — meaning pre-season practice is already underway in many locations. That is why college hockey has the longest time of activity of any college sport when one considers preseason practice, regular season games, conference playoffs and the NCAA playoffs.

Two of the women's teams across the country that are practicing right now will play for the national championship in late March. For the men it is even a bit longer — a national champion at the Frozen Four will not be determined until mid-April.

That is not to say that college athletes in other sports are not active because, of course, they are. But in different way. They will be spending much of their time in a varsity exercise facility specifically set aside for their use on their campus.

The school will also have such facilities for use by all students but most Division One schools also have a separate one for their varsity athletes.

There varsity athletes are normally expected to go through exercise routines every day — though in season these may take place in the practice area.

The varsity athletic facility (often named for a generous donor) is a huge element in the recruiting process because this is where athletes will spend numerous hours outside of class ever day throughout the academic year and perhaps even during the summer months.

It is a place where trainers can monitor an athlete's progress concerning an exercise routine — especially if one is recovering from an injury.

And every varsity athlete on every varsity team is given a list of exercises they should engage in every day. Some may be for every member of a specific team while others may be unique to an individual athlete — designed to gain

strength or range of motion, for example.

Team doctors are also available since they are responsible for the medical care and treatment of the athletes — and are based normally at the hospital in the community where the university is located. This means there is a continuum of care by the same medical team throughout an athlete's rehabilitation and recovery.

What has been described above is light years beyond what some in former times called "the weight room." Yes, the weights are still there but as one can ascertain, much more has been added. In some facilities there is also a nutritionist and a dietitian on staff to make sure the athletes are making the proper food choices. In some facilities, there also may be a dining room where these are provided as an integral part of a daily meal.

Long gone are the days when recruits — especially in the pros--were on their own. When Joe Thornton was drafted by the Bruins at age 18, his mother positively insisted that he would not live on his own. She requested that the Bruins find a family setting for him where he would live and come home to a residence every night — a setting that included dinner with a host family and most especially, a home-cooked meal.

Today, at the Bruins modern practice facility in Brighton, the players can have meals prepared for them — on an eat-it-there or take-it-home basis. The meals are based on suggestions put forth by a nutritionist.

And at practices, even "opponents" can be provided. Did you know, for instance, that every WNBA team in action this season has an all-male practice squad that provides the opposition during some workouts? We did not until we read an article about the topics in the New York Post.

More and more, athletes, particularly those in college, are taking a long look during the recruiting process at the total picture of an athletic program. This includes not only where the games will be played (stadium, rink, arena, field) but also where the athletes will spend a significant portion of their time — the varsity athletic facility.

The recent arrival of the much-debated Name, Image and Likeness parameters — where at least some athletes are offered a financial payment — may come to overshadow (at least for some athletes) some aspects of an athletic program already in place.

But for many more, factors such as the varsity athletic facility, conditions of practice areas, plus residence and dining options will continue to be deal makers or deal breakers.

It is a whole new world in college sports — one that will continue to play out during this academic year and beyond.
