


# Stirpe Nostra

#### THE EARLY CHRISTIAN CHURCH




It is understandable that with the great numbers of persons flocking to the Christian faith, and not being content with secondhand buildings, a crash program of church building was begun. Thirty-one Christian Churches were built in Rome alone. The layout or plan of these churches was influenced by that of the pagan basilica, and these thirty-one were known as basilican-style churches, or simply basilican churches. Most of these original structures have been either remodeled or were destroyed

for various reasons. Probably the most famous is "S. Paolo Fuori Le Mura" (St. Paul's Outside of the Walls) in Rome. It was partly destroyed and rebuilt twice, still in use today, and said to be the largest and most impressive of that era.

The characteristics of Early Christian Churches are: 1. Basilican in plan; 2. A center nave with side aisles; 3. The apse with a decorated semi dome, raised floor and altar; 4. The chancel rail with triumphal arch above; 5. Richly carved and gilded timber ceilings; 6. A high ceiling over the nave (clearstory) and a low ceiling over the aisles and 7. A colonnaded atrium in front of the church.

In the center of the atrium they dug a well or erected a fountain where the faithful were required to wash before entering the church. This was the origin of the holy water stoup which stands in the narthex of every Roman Catholic Church today.

The colonnaded atrium served as a place for meditative walks by the monks or other clergy, and the narthex became a convenient meeting place for the laity. Monks generally occupied the choir Water Stoup



section, but as their numbers increased, they were relocated to the ends of bemas. Each of the ambos is the appropriate reading stand for the gospel or epistle. All other areas need no explanation.

This design served the church needs adequately except that the dry timber roofs were often struck by lightning, and the lack of proper fire fighting equipment permitted serious damage to occur to the roof structure, or at times, even the destruction of the entire roof. The next logical step then, was to construct the roofs of stone by building a series of vaults and arches. Inadequate knowledge about arch thrusts caused some sidewalls to spread and roofs to fall. This problem was solved during the Romanesque period which came

## **BRANDEN BOOKS REPRINTS WILLIAM FAULKNER'S FIRST BOOK**

Branden Books will celebrate its 100th anniversary by hosting a reception at Harvard University and relaunching William Faulkner's original 1924 edition of "The Marble Faun."

Five hundred copies of "The Marble Faun" were first printed by Edmund Brown, founding publisher of the 1909, The Four Seas Company — now Branden Books. Today, fewer than 100 extant copies remain worldwide, two of which are at Harvard University. About 300 copies were destroyed by fire, and over 100 lost.

Finally, after 85 years, the first work of this Nobel Prize author has been re-published in the Centennial Special edition by Branden Books. The first eight chapters of this edition include the history and bibliography of Branden Books. The

#### HIGH TECH EARNINGS

Microsoft results beat ex- growth potential says Morn- lier cost cutting improved pectations, but profit and sales declined. Microsoft reported its most important product in years and reported earnings of .40¢ for the quarter, down 17% from the year earlier to \$12.92 billion. Analysts polled had expected \$12.37 billion. Investors were encouraged by key executives that the economy appeared to be recovering and business customers were bullish ready to buy new computers next year. Microsoft jumped 10.4% and strong demand for Windows, PC's and Xbox 360 game consoles, as well as the company's business spending has stabilized and the last quarter may well have been the bottom of the economy compared to last year. It had four quarters in a row of declining earnings and three declining year over year sales. As both look to increase earnings and sales, both to resume growing again in the current quarter, as sales of Windows 7 are expanding ahead of an official launch and that revenue will be recognized this quarter. Earnings/share will be .52¢/ quarter up 8%. Investors are stroked about the new product releases, and their

ing-star analyst Tom Tran. Besides Windows 2008B, which has virtualization technologies, and later this year comes the cloud computing platform Windows 2010 and exchange server 2010. A strong product cycle always bides well for Microsoft's stock price. Microsoft business unit, which sells office software was its biggest contributor to earnings last quarter with \$4.4 billion in sales down 11%. Only Bing Internet lost money last quarter with sales and earnings of \$490 million in sales and \$480 million in earnings.

climbing up 27% to a new high. It beat analysts' estimates by 36% on strong growth. It's fourth quarter was awesome. Tech firms are now on track to post a 5.6% profit decline in quarter three versus the 14% drop estimated on October 1st. "Everyone recognizes that the Recession is over" says Alec Young, Equity Strategist with S&P and looks like we will avoid the bad and ugly times. Goldman Sachs, JP Morgan, Wells Fargo and Bank of America have all beaten sales and profit forecasts, although loan losses are higher especially for personal loans. Several big companies have exceeded quarter three estimates with Catepillar obliterating views on the upside. They are benefitting from the weak dollar and a stronger recovery overseas. The median earnings surprise was 7.9% and now





## Satchel Paige

Anyone who played baseball professionally in the last 60 years knows who Satchel Paige was. Satchel was a black baseball pitcher. In the years that Satchel started pitching, blacks were not permitted to play in the major league. His pitching ability in the Negro league was legendary. Satchel was born on July 7, 1905. In 1926, Satchel started playing professionally for the Albany Giants when he was 21 years of age. He was paid \$200 per month and was given a Ford Model A car. Another team named Birmingham Black Barons offered him \$276 per month. He accepted the offer. During a game on June 27, 1927 he caused a riot by beaning three star players in a row. He ended that year by winning 8 games and losing 3. He struck out 17 batters in a one game in 1929. He later played in the Cuban league receiving \$100 per game. He stayed in Cuba for only 11 games. He didn't understand the language and when the Mayor asked him if he intentionally lost a game he smiled and nodded his head. He almost got beaten for that. He left Cuba promptly and returned to the U.S. In the Negro league it was permitted to rent ball players to his quotes as follows:

various teams. He was rented out from time to time. Later he pitched for the Chicago American Giants, later he played for the Philadelphia Giants. On July 16, 1932 Satchel pitched a no hitter and on July 4, 1934 he pitched another no hitter. He moved around later playing in Mexico for a while. He later signed to pitch for the New York Black Yankees. He became such a celebrity 50,000 people showed up to watch him pitch at Comiskey Park on July 23, 1941. On July 7, 1948 Bill Veek the owner of the Cleveland Indians needed a good pitcher and signed Paige to play in the major league with a contract at \$40,000 per year. At that time Paige was 43 years old. Paige was famous for his hesitation pitch. In 1948, Will Harridge the American League President ruled that the hesitation pitch was not legal. Satchel Paige then said "I guess Mr. Harridge did not want me to show UP those boys who where young enough to be my sons.' Satchel went on to be a great pitcher in the major league. In 1971, Satchel Paige was inducted into the Hall of Fame in Cooperstown, NY.

If Satchel Paige was allowed to play in the major leagues when he was 21 years of age, who knows what records he would have set.



It was a great feeling to be in the same room with people like Supreme Court Justice Samuel Alito, Former Director of the FBI Louis Freeh and Former Chairman of the Joint Chiefs of Staff, Peter Pace.

### Only a Few People Know about the Real Columbus

As part of October Italian-American month, I recently held two conferences on Christopher Columbus' life and legacy. I asked the audience how many times Columbus came to America and no one knew the right answer. We all know that he was born in Genova, Italy. Hhe immigrated to Portugal, then to Spain, and in the summer of 1492 he set sail for China, India, and Japan. King Ferdinand and Queen Isabella lent to him the Nina, the Pinta, and the bigger of the ships — the Santa Maria. Columbus was the first real European to set foot onto the new world (the Bahamas) on Friday, October 12, 1492. He mistakenly thought he was in southern India, so he called the natives "Indians."

In a letter to an important nobleman in the Spanish kingdom he stated, "The Indians are friendly, have only one wife, and are good people." On his return to Spain in December 1492, the ship the king of Spain

rented for Columbus sank off Hispanola (Santo Domingo) and Columbus agonized on how to explain to the king all the way back to Spain on how he lost the king's prized ship. The Spanish king sat him on his right side and gave Columbus many titles (Governor of the new lands, Admiral of the Atlantic, and more).

Columbus returned for the second time in 1493 with 17 ships and established the first town in the Americas (Isabela) in Hispanola (Santo Domingo) but the Spanish colonists and natives rebelled against him so he left and founded another city, Santo Domingo. There he founded the first Catholic church, schools, library, city hall, and more. But he was a sea captain so he left his brother Bartolomeo in charge and went to explore Cuba, Hispanola, and Puerto Rico and returned to Spain with some natives, gold, fruits, vegetables, American animals.

The king was not happy

with him but sent him back to America for his third trip (1496) when he discovered Martinique, Venezuela, and Colombia. When he went back to Santo Domingo for provisions, the newly appointed governor (Bobadilla) put Columbus and his brother in chains, threw him into the bottom of a ship, and sent him back to Spain.

The King of Spain sent him back to America for the fourth time on four ships in 1502.

He discovered Honduras, Central America, and Panama. But again he failed to neither find a passage to India, China, and Japan nor any of the riches these countries had (gold, silver, silk). The four ships sank in the Atlantic and in the Caribbean and he was marooned for one year in Jamaica. In 1504 he returned to Spain, the king refused to receive him, and he died in Villadolid, Spain in 1506 at age 55. At the end he was a sick and sad man who had discovered a New World. His son, Diego eventually became the governor of Santo Domingo and tried to regain some of his father's titles and fame ...

As I mentioned to the over 100 Italians, Hispanics, Brazilians, and Americans at the two conferences, "I hope you now have a better understanding of the first European who truly set foot on the American soil." Thank

#### AN 'ENERGETIC' PRESIDENTIAL VISIT

A couple of weeks ago I mentioned to Danny Ryan that the President would be in town on Friday, October 23. Danny works for Congressman Mike Capuano. Friday morning around 10am Danny called me. David Foster a/k/a The Hitman, is a talented producer and songwriter whose list of "friends" includes Celine Dion, Madonna, Barbra Streisand, Andrea Bocelli, Whitney Houston, and Michael Buble, just to name a few he has worked with in his 30+ year career. Just to be clear, David defines "friend," as a person he has worked with professionally — not exactly as the word is defined by Webster.

Foster filled the dual role of introducing each performer, as well as providing accompaniment on the piano. Foster's tour, Hitman: David Foster and Friends, produced great success with his Boston show, as he arrived at the Agganis Arena with an impressive list of "friends." Idol standout Michael Johns admirably performed Foster compositions, "She's a Beauty" and "Man in Motion" from St. Elmo's Fire. Foster partnered with NAMEDROP.COM to present the 'Hitman Talent Search, in a quest to find his next vocal superstar. One artist will be chosen from each of the 10 cities on the Tour, and compete in the finals to be held in Vancouver, Canada. Boston's two entrants competing were Mia Lindstrom and Gordon Michaels, with Michael's earning the Boston slot with a strong vocal performance. Cetera was a major highlight with his set of "Hard to Say I'm Sorry," "You're the Inspiration," "The Glory of Love" and the smooth sound of the number one hit for Chicago "If You Leave Me Now." Foster also teamed Cetera up with Michael Johns for a dynamite duet on "Hard Habit to Break." Idol winner Studdard provided soul power with his take on the sensuous affirmation "I Swear," and earned a standing ovation with his R&B version of "Home," already a hit for both Buble and country artist Blake Shelton. Taking a shower of germs! When you turn on your shower, you're probably getting a faceful of bacteria, some of them harmful. Researchers examined shower heads from nine cities and analyzed the slime that grows inside, to see which germs live there. Most were harmless, but tests showed that nearly a third of shower heads harbored high levels of Mycobactrium avium, a pathogen known to cause respiratory disease. "If you are healthy and your immune system is functioning properly, you should not worry about the germs in your shower head," lead researcher Leah Feazel tells CNN.com. The bugs prefer plastic shower heads over metal ones, so change yours frequently, Feazel says, or remove it and give it a good scrub. And if you're susceptible to pulmonary infections, "take a bath instead of a shower." Frankly, we shower every morning! Yes, we have a metal shower head! Ah, my morning showers. Egg heads! Many individuals have stopped eating eggs fearing artery clogging cholesterol, but a new study reveals that eggs especially fried ones — are good for your heart! The exciting new research found that eggs contain ACE inhibitor peptides that lower blood pressure just as well as drugs which also contain the substance. "Our results showed that the digestion of cooked eggs could generate a number of potent ACE inhibitory peptides which may have implications for cardiovascular disease prevention, including hypertension," writes the study team in the Journal of Agricul-

ture And Food Chemistry Findings from this study provided further evidence that



eggs are an excellent source of health-promoting food. Amazingly, fried eggs worked better than boiled eggs when it comes to reducing blood pressure, the study at Canada's University of Alberta found. But Health Science Institute member Dr. Allan Spreen says the studies that linked eggs to cholesterol used powdered eggs which react differently than shelled whole eggs.

### Recipes from the Homeland

#### QUICK VEAL OR CHICKEN SPECIAL

- 1 pound cubed Veal stew meat or chicken breast
- 1 large ripe tomato
- 1 medium chopped onion
- 2 cloves chopped garlic 2 small sprigs Bay Leaf (optional)
- 1 fresh Mint leaf (optional)
- 1 or 2 \*julienne potatoes
- 1 Chicken bouillon cube
  - 3 tablespoon olive oil

(optional)

green peas

1 can sliced mushrooms or mushrooms of choice

1 or 2 \*julienne carrots

3/4 cup frozen or canned

2 tablespoons red wine

Heat oil in skillet and add cut up veal or chicken breast. Stir and simmer to brown lightly. Remove only meat from skillet and set aside. Add cut up onion and garlic to oil in skillet and simmer until onion is opaque. Add cut up tomato. Stir and simmer over medium heat. Cover and continue to simmer for two or three minutes before adding one cup of water and a chicken bouillon to skillet. Stir, cover and continue to simmer mixture slowly for another two minutes. Then add veal or chicken breast to tomato mixture and bring to a slow boil. Add bay leaf and mint (optional) to skillet and stir. Continue to simmer at low heat for ten minutes.


Meanwhile, remove skin from carrots and potatoes and \*cut into thin long strips (julienne). Set aside in water in separate bowls.

When meat has cooked about ten minutes in skillet, add carrots first. Cover and cook for about five minutes. Then add potato and mushroom slices. Stir and cover. Continue to simmer until potatoes and carrots are tender to your liking. Add wine, cover and bring to a slow boil and then remove from burner.

Serves two.

NOTE: It was meals like this that I remember Mama surprising us with at various times. I often wondered — Now where did she find this recipe? She loved creating meals that might be different. It was a great lesson for me that encouraged me to create meals with meats and vegetables that my family

# Nanna & Babbononno

by John Christoforo

A Nostalgic Remembrance



There are many things that have gotten lost since the older generation of Italians in America have died out. Non-Italian Americans have considered many of these aspects of Italian life a bit quaint, old fashion or totally European. Among them are two in particular that I was exposed to as a child when my grandfathers were alive. One was wine making and the other, hunting for mushrooms.

My grandfather, Nunzio DeCristoforo, came from humble beginnings in San Socio de Baronia in Avellino. When he arrived in the late 1800s, he brought with him all the things he had learned as a child. Among them was wine-making. From what I understand, most of the Italian peasantry made their own wine and the De Cristoforo family was no exception. Dad had helped his father make wine from the time he was a child growing up in East Boston, and for a time, Peacedale, Rhode Island.

I became involved in the annual wine making event when I was about ten years old. One October morning, there was a knock on the kitchen door at about 6:00 a.m. When Dad opened the door, there was Grandpa De Christoforo standing there holding a sprig with three red grapes dangling downward. Without saying a word, Dad knew that it was time to make the wine and he told me to get dressed.

I jumped into the back seat of Dad's 37 Plymouth. Dad and Grandpa climbed into the front seat and my grandfather told of the shipment of grapes that he had just purchased. He explained to Dad that he wanted to make both red and white wine for the coming year and Dad listened without saying a word. When we arrived at Grandpa's house on Chelsea Street, we headed right to the cellar. I immediately inhaled the aroma of wine. The sweet smell of the previous year's vintage dominated the atmosphere. It came the wine made the previous explained that we were go-

ing to help Grandpa and they both would give me instructions as to what my part in the process would be.

grandfather showed us the wooden boxes that contained the grapes slated for crushing and Dad opened them and then showed me how to put them into the press, a cylindrical wooden tub that had a frame above it with a worm gear that suspended a lid. When the grapes filled the lower part of the cylinder, Grandpa lowered the lid into the vat crushing the grapes as it descended. This process continued until all of the red grapes were crushed. There was a smaller press that we used for the white grapes and we repeated the steps to extract the liquid from those grapes.

When all of the grapes had been crushed, I watched Grandpa and Dad siphon-off the liquid and pour it into barrels that were in horizontal positions sitting on X shaped frames. Each barrel had a hole on the top where a well-placed funnel with cheese cloth inside allowed the liquid to be poured in without any debris, twigs or seeds to enter the barrels below.

Grandpa stirred up the crushed grapes in the vats and they were pressed again to extract any liquid not obtained the first time. Any remaining liquid was then poured into the barrels and each was capped with a large wooden peg. Dad told me that Grandpa might have to add sugar to the vats at some point in time but didn't go into detail.

As I looked around the cellar, I saw several empty gallon jugs and a dozen or so whiskey bottles. When the wines were ready to be poured from the barrels, these were Grandpa's containers. When we were finished, Grandpa took two bottles of wine from an earlier pressing, one red the other white, and said, "Andiamo a mangiare." (Let's

of bread from a round loaf, dipped it into the gravy, sprinkled some grated cheese on it and gave it to me. I liked the taste and told him so. He smiled, saying, "Va bene." With that, he set the table and strained a pot of homemade gnocchi that had been sitting on the stove. He then poured the pasta into a serving dish and placed it on the table. Next he scooped out gravy meats from the large cooking pot on the stove, placed them on another serving tray which came to rest next to the dish of gnocchi on the table. A serving bowl was filled with the gravy and that too was placed on the table. With the addition of a shaker of grated cheese, we were ready for lunch, but before we could eat, Grandpa poured out three glasses of red wine and we toasted each other, "Salute a la famiglia.'

Now I know my grandfather wasn't Mexican, but if you had ever tasted his gravy, you might think he was. It was hot. It was delicious, but very hot. We ate lunch with Dad and Grandpa savoring each sip of wine that was made the year before.

I silently wished for a bottle of Royal Crown Cola. I was only a kid and had not acquired a taste for wine at the early age of 10.

Before we left, Grandpa went back to the cellar and returned with 2 gallons of red wine, saying this one's for you and the other for your father-in-law. He knew that Babbononno would enjoy the contents. When we left, Grandpa pulled me aside and slipped me a five dollar bill. He said, "Mi nipote, tu fai buona lavora." (My grandson, you do good work.) I thanked him saying to myself, "I'm rich!"

When we returned back to the big house on Eutaw Street, Dad presented the gallons of wine to Babbononno saying, "Besigliere, mi padre fa dono un regalo per ti." (Besigliere [his nickname] my father sent you a gift.) With that, Babbononno quickly sampled the wine and passed judgment saving, "Ooh, dissa gooda." Of course he had to prove what he said was true and poured himself another glass of wine. All was well with Nunzio DeCristoforo Michele Contini, Grandpa and Babbononno. GOD BLESS AMERICA



SECONDARY EDUCATION IN ITALY: 2008-2009. The

Italian school system, from the primary to the secondary, and beyond, has changed. We have been following its progress or lack of it, since the new programs were implemented. A few months have elapsed and we can say that the changes have not been fully digested! Why the changes, you may ask? Well, a new installed Government in Italy always comes up with something ... new, sometimes drastically so, although nothing is broken, as we say in this country. So, why do things have to change? Well contrary to our American way of life, in Italy we enjoy changing things that do not need to. In any case here are a few of the changes.

First of all there are two new Licei (secondary-college level education). One is the "Institute of Humanistic Sciences", which replaces, in name only, the old "Istituto Magistrale" (Teachers College, primary education specialization), the other new one is the "Liceo/Istituto Musicale", for music and dance education. The technical institutes will be basically two: "Economics Institute (school of economics), and the "Technology Institute" (istituto tecnologico). Each of these institutes will follow a specific field of concentration. In any one of the institutes the courses of studies are geared to a specialization. Thus a student that graduates from an institute, with a specific field of concentration, can success-

fully apply for a job for which he/she is proficient. A class period will be '60 minutes' instead of the old '50'. Furthermore, those who take technological courses can begin work at a company, but only at the 5th year of schooling. The English language is expanded. Not everyone attending any secondary school must study the English language. In the post-secondary levels (as in the 'Licei') the English language will be taught throughout the entire 5 years. Even in the old 'Liceo Classico' (classical college) English will be added to the curriculum which includes the final 3 years. In the technical institutes, in the final year, a non-linguistic course will be taught entirely in 'English'! Furthermore, the Technical Institutes will have the five ending years split into 2+2+1 years, so that the first biennials will provide a basic preparation, the second biennial will provide a specialization, and the last (#5) year will provide a chosen field of specialization. Small children will enter school at age  $2\frac{1}{2}$ . The study of English language in the Middle School (Scuola Media) will increase from the present '3 hours' to 5 hrs. a week. The teacher's salary will be boosted. The best of them can receive additional bonuses, up to 7,000 euro a year (@ \$10,000). In the middle schools, two hours a week will be devoted to the teaching of Italian to foreigners (Italian as a Foreign Lan-

guage). In the new specialized institutes two foreign languages will be mandatory. Also, more math and more science will be taught, even at the 'Liceo Classico'. The teaching of English will begin at the Grade level: 1 hr. at the first grade, 2 hrs. at the second grade, 3 hrs. at the third to the fifth grades. The teachers' weekly load will stop at 22 hrs. (a week), for 'five days' a week. However, all students will attend classes 'six' days a week, as the norm!. Of course, the teachers will enjoy a dayoff during the week! In closing, let me remind everyone that the school days yearly total in Italy will continue to be at least 224/225, not our 'heavy!' 180 days! Also, contrary to what you may have read recently, all graduates from the 'Istituto Magistrale' (teacher's college) complete their studies after four years (at the istituto), thus at the age of 18. Whoever thinks that they have an 'High School' equivalent diploma only, they are totally WRONG! To understand, study the school system in the old 'Colonial America' and discover that the likes of John Adams became lawyers after graduating from Harvard College at the 'ripe'

#### WHY DID IT TAKE ALMOST 40 YEARS TO REMEMBER THESE GUYS?

On Tuesday, October 20, President Obama awarded an Army squadron the military's highest unit honor for a daring rescue of fellow soldiers back during the Vietnam War. The president said he wanted to help right "one of the saddest episodes in US history. Said Obama, "These vets were often shunned and ... even demonized when they came home. That was a disgrace. And on days such as this, we resolve to never let it happen again."

In a Rose Garden ceremony, the president gave Troop A, 1<sup>st</sup> Squadron of the 11th Armored Combat Regiment the Presidential Unit Citation, the equivalent of the Distinguished Service Cross for every member in the unit.

The incident itself that led to the October 20 honors is an amazing story of duty, courage and honor in itself. On March 26, 1970, Alpha Troop heard that another unit of about 100 soldiers had stumbled onto a massive underground enemy bunker of North Vietnamese forces (RNV). They were greatly outnumbered and outgunned by 400 hundred enemy soldiers. The nearly 200 members of Alpha Troop set out to smash a pathway through the jungle, risking everything, to rescue the trapped soldiers.

I can't believe it took almost 40 years to uncover this courageous act of heroism. Obama called it "A proud chapter in the story of the American soldier."

a lovely place to live. We had a large Italian section around the old Green Shoe Factory, but also had Irish and Black families. There were three public housing projects to house people who couldn't afford the private sector housing available. It too like the South End up the street was working-class families

As I drove around Lower Roxbury, I found about four or five buildings still standing. The neighborhood died from the benign neglect of the powers that be. Buildings turned broken and then razed as one lot popped up after another. It was like a small cancer starting and then getting metastasized and spreading throughout the entire neighborhood. The neglect no longer benign but more malign-like. Nobody seemed aware downtown at City Hall.

Meanwhile, on the other side of Massachusetts Avenue, the buildings remained, but poor and working families were forced out.

A tale of two neighborhoods gobbled up by economic interests that seem to superhuman needs. Whether the buildings of old remained or were razed, it didn't matter if you couldn't afford to stay there.

Neighborhoods can die like the neighborhoods of my youth because they had no strong voice in government defending their right to exist. But sometimes neighborhoods can die when the cancer spreads unseen until it's too late. Many neighborhoods have become mine fields of violence. Random violence and death become all too commonplace. It becomes routine to hear about another shooting because it happens all the time. We come to accept as normal certain levels of violence as if that is okay to do.

The cancer that kills neighborhoods isn't just gentrification, it is ourselves. Years ago, people accepted the idea they had little say and no role in the future of their communities. They saw themselves as a TV audience watching something out of their control. It was almost like going for a ride waiting to see where you get to. Fast-forward to today and think about the violence all around us that seems to be crashing down on us. How did all this happen yesterday and still today?

Neighborhoods were never buildings, but the people occupying them. When we act like an audience just watching everything, we enable the cancer out there to grow stronger. When we do nothing, we enable the destruction of our neighborhoods and its values. When we sit back, bemoan and demand that others fix everything, we create bigger problems.

We should learn from yes-

a TV rerun. Long ago I understood that most politicians talk a lot, but do very little to help. All of us need to be working together to make all our neighborhoods safe. We can't demand more of them; we have to demand more of ourselves. The foundation of a safe society is the family. Parents, clergy members, community leaders must come together and find their empowerment. We need the police to be there, but the police can't cleanup a neighborhood filled with crime and violence, that is a job for the entire community. We are all to blame for the fix many neighborhoods are in. We can't worry about yesterday's mistakes, but we are responsible for finding the answers for tomorrow.

I can drive around empty lots filled with yesterday's memories which causes no harm but very little good or I can deal with today which could lead to a better tomorrow. Full-time citizenship means more than voting, it means always lobbying for your best interests and the interests of your community. Government has always been our business. We can run it or it can run us. If we all pick up ourselves and work for tomorrow, we can actually do it. Someday, the meaningless violence destroying many families will end, but only when we want that to happen. Life is always in our own hands. It is time terday and not repeat it like to put up, not shut up.

BU, you may recall, was down two goals to Miami of Ohio with just one minute remaining in regulation before scoring twice in those final 60 seconds to tie the game and then win it in overtime.

The Bruins were trailing Ottawa, 3-1, in the Canadian capital city on October 24 with 90 seconds remaining in regulation. But goals by Mark Recchi and David Krejci drew the B's even as regulation time wound down and a shootout goal by Patrice Bergeron followed to provide the 4-3 victory.

BU BLANKED — Speaking of the Terriers, when they lost their home opener to Notre Dame by a 2-0 score at Agganis Arena, it marked the first time in 100 games that a BU hockey team was held scoreless by an opponent. BU's streak of 99 games without being blanked was the longest active streak in the nation. The last time the Terriers were kept off the scoreboard came on February 2, 2007 when they skated to a scoreless tie against UMass-Lowell at Agganis. The loss to Notre Dame was the first shutout loss BU experienced in 113 games.

RED HOT HOCKEY — While many in the region are focused on the January 8 outdoor game between BU and BC at Fenway, the Terriers will have another showdown against another classic foe before that date. It will come on the Saturday of Thanksgiving Weekend (November 28) when the Terriers will travel to New York to take on traditional rival Cornell at Madison Square Garden.

PHIL KESSEL IS GONE — But his brother Blake is still in the region, playing for the University of New Hampshire Wildcats. And he has started the season in All-Star style, becoming the nation's top scoring defenseman in Division I in games played through the last weekend of October.

Since returning from a shoulder injury, Kessel has had 10 points in four games, including three assists in a single contest. Last year, the Wisconsin native had just 13 points in 37 games.

SHUNNING THE SHOOT AROUND — It's been a gameday tradition in the NBA for decades but now comes word that the Celtics will not engage in a shoot around on the day of a scheduled contest.

Most teams have a full practice on days when games are not scheduled and a somewhat shorter shoot around workout in the late morning on the date of a night game. But that day-ofgame workout won't take place for the C's this season.

What makes it somewhat ironic is that a Celtic player started the tradition in the first place. Decades ago Bill Sharman was looking for a place to do morning drills on the days of evening home games. Living in Metrowest, he found a gym in Framingham and started tuning up there. Gradually, the notion of a game-day workout spread, first his teammates and then to other teams around the league. The shootout became an NBA staple. It still will be so for the majority of NBA teams this season. But not for the Celtics.


