# Coakley Brown to Meet on January 19<sup>th</sup> Election for **United States Senate**

On Tuesday, December 8th, Massachusetts voters in low numbers turned out to pick candidates for the January 19, 2010 US Senate Special Election. Democrats chose Attorney General Martha Coakley and Republicans picked State Senator Scott Brown.

Turnout was under 50% and in the Democratic race Coakley received 47% of the vote, with US Representative Michael Capuano in second place with 28%. Alan Khazei had  $13^{th}$  percent and Steve Pagliuca last with 12%.

On the Republican side, it was Brown in a landslide primary win over businessman Jack E. Robinson. Brown took 89% of the vote to Brown's 11%.

# Mayor's Column

On the evening of my re-election last month, I stressed that we haven't made history by winning a fifth term, but we will with what we achieve in it. I want to accomplish as much in the next four years as we have achieved in the previous sixteen. This type of transformative change, however, will only occur by working together.

We have great momentum, and we're gearing up for the next term, when we will take on big challenges - not just when it's easy, but when it's hard, too. We will begin a new era of innovation in the Boston Public Schools; jumpstart stalled development projects in Allston, the South Boston Waterfront, and Downtown Crossing; make the Harbor Islands and the Greenway as central to our city's identity as the Boston Common and the Public Garden; and strengthen city government by implementing new technology, rebalancing public safety services, and pursuing consolidation where it makes sense. Partnership is possibly most crucial in advancing our ambitious education reform agenda. Superintendent Johnson recently proposed 14 of our under-performing schools for turnaround, but we also want to elevate our strongest performing schools. Just as Fidelity Investments stepped up to provide enriching experiences for students at the Edwards School in Charlestown, we will seek to

create new partnerships so that all of our schools have the same opportunity for success. Education reform can't happen without those who teach our students, and renegotiating the current teachers contract to prioritize students over old rules governing teacher placement will be key. Finally, we will push our in-district charter legislation at the State House as part of a bill currently before the Legislature so that Massachusetts has the opportunity to compete for its share of \$5 billion in federal Race to the Top funding.

In the same spirit of collaboration, the city will work with the business community to jumpstart stalled development projects in Allston, the South Boston Waterfront, and Downtown Crossing. In Downtown Crossing, we have a chance to create the city's first Business Improvement District to capitalize on \$1.2 billion in private investments that have already been made and will allow the area to reach its full potential. We must also take the crucial step of re-imagining uses for the former site of Filene's Basement in order to animate the site again and strengthen the surrounding neighborhood. We must also not be afraid to look at things differently on the South Boston Waterfront in order to attract innovative

### **MORE STAINED GLASS**

The most beautiful stained glass windows ever to be produced are said to be in the Cathedral at Chartres. The edifice stands on a low hill, 55 miles south of Paris, and it dominates all of the other buildings in the vicinity. The church spires can be seen 20 miles away. Fire destroyed two previous churches which stood on the same site. While the church was being built for the third time, preachers solicited gifts from all over France. People gave money, food, or labor. Other churches were larger, higher, and more richly decorated, but Chartres is known for being a people church, and also a pilgrim church. We must be mindful of the fact that during this time in history, it was the clerks and scribes who were literate, but almost all others could not read or write, and had to be told about their religion in picture form. > Even the saints had their distinctions: St. Peter always held the keys to the gates of Heaven; St. Paul held a scroll; while St. Matthew held a purse. St. Catherine was always shown with her wheel of martyrdom and St. Mark was shown with his lion to name just a few.

During medieval times, people asked "What should one do upon entering a church?" and the answer usually was: 1. Take Holy Water; 2. Pray to the Almighty; and 3. Read the stained glass windows. The windows in the medieval cathedral became a spiritual encyclopedia to show the people what they were to believe.

### ... Reserved to the States Respectively, or to the People

December 15<sup>th</sup> is **Bill of Rights Day** in the Commonwealth of Massachusetts, set aside to memorialize the entering into force, following adoption by three-fourths of the states on December 15, 1791, of the first ten amendments to the U.S. Constitution, commonly called the Bill of Rights. Incidentally, Massachusetts was not one of the ratifying states and only passed the amendments in a symbolic gesture in 1939 at the 150<sup>th</sup> anniversary of the Bill of Rights.

At the time it was proposed the concept of a Bill of Rights - not to mention the specifics of what would be in it - was controversial.

Some argued against the Constitution itself as defective due to lack of an enumeration of the rights of the People. Even as English colonists subject to the Crown they had enjoyed, or at least claimed, the traditional rights of Englishmen, including those set forth in the 1689 English Bill of Rights and earlier documents going back to Magna Carta of 1215. Surely as the free citizens of a republic they ought to enjoy such an enumeration of rights.

Others argued that the Constitution was intended to provide only for the arrangement of the national or central government of the States within the Union and that an enumeration of citizens' rights was unnecessary as it was the People making the Constitution and, therefore the People retained all rights and powers not specifically granted the national government. Alexander Hamilton made this argument in Federalist No. 84.

The compromise, which was finally enacted, satisfied both by setting forth eight sets of specific rights of the people that the national government (and later, by incorporation under the 14<sup>th</sup> Amendment, the States) is bound to respect. Those amendments are followed by the Ninth clarifying that every American citizen has all the traditional rights of a free person whether or not specifically listed in amendments one through eight. Then the Tenth Amendments makes clear (although somehow not so clear to some of the Democrats and liberals in Washington today) that the national government has only those powers specifically granted by the People through the Constitution, with all other powers reserved to the States or to the People.

### TOBIN, YOON, MENINO AND THE OFFICE OF MAYOR

Mayor Thomas Menino was recently elected to a fifth term. The first mayor ever elected five times by voters.

Previously, Mayor Kevin White was elected four, serving as mayor from 1968 until 1984. Had he wished to seek a fifth term at then age 54, he probably would have won again. Mayor James Michael Curley also was a 4-time mayor, first elected at age 40 in 1914 and last elected at age 71 in 1945. In between he was a mayor for one term in his 20s and one term in his 30s. He was an activist mayor, great orator and persistent candidate. He also lost three times for mayor, the last time in 1955 at age 81 when he still managed to garner over a 100 thousand votes in the preliminary election.

Interestingly, after getting elected in 1914, the City Charter was changed to prevent mayors from running for re-election.

In 1949, the City Charter once again let mayors run for re-election and the first mayor to do so was Mayor John B. Hynes in 1955. I say all this before bringing up two new reforms out there right now. City Councilor John Tobin has an ordinance that has been bottled up reportedly by Councilor Maureen Feeney, Chair of the Government Operations Committee. Tobin would like to see an ordinance that changes mayoral succession. If Tobin's legislation were successful, a mayor leaving in mid-term would be replaced by the City Clerk barred for running for the office in the next election. Currently, the City Council President gets to become Acting mayor as was the case for Menino in 1993 when Mayor Flynn left for the Vatican.

Outgoing City Councilor Sam Yoon also has an ordinance creating term limits for future mayors. A mayor would get only one extra term under this proposal. Long-term mayors could no longer happen. I think both these proposals shouldn't have been bottled up in committee. The people of Boston deserve to have these proposals taken out of committee and let them go to a full up or down vote before the City Council.

If both these proposals die at the end of this City Council session, it is time for City Councilor John Tobin and others to re-double their efforts in long needed reforms that make our city government much more transparent and open to the people of Boston.

Perhaps, a return to pre-1949 City Charter rules makes good sense. As British Prime Minister Winston Churchill once said, "The farther backward you can look, the farther forward you can see."



### UNEMPLOYMENT GETTING BETTER

Unemployment dropped 0.2% from 10.2% to 10% and the dollar rose, and the month of November rose 6% for the  $6^{\mbox{\tiny th}}$  month in a row. The economy has turned around much faster than expected. The gauge of future home sales rose for a ninth straight month suggesting slow but steady economic growth. Gold and copper reported new highs with gold @ 1,199.10/oz., and oil rising \$1.09 to \$78.37/ bll., as auto sales edged up driven by a 46% surge by Korea's Hyundai, while Ford and Chrysler sales dropped 25% and GM's sales fell 2% and Toyota sales rose 3%. Factory orders kept growing in November, but at a slower pace, suggesting slow but steady growth. The \$8,000 tax credit on new homes has been extended and expanded and helped the sales index by 3.7% for a 4<sup>th</sup> month of increases, signaling growth. Pending sales of homes rose 19.9% in September in the Northeast, 11.6 in the Midwest and 5.4% in the South, but Western sales fell 11.2%. ISM's figure disappointed analysts but details were generally positive. In all 12 of 18 industries reported growth. The job gauge fell to 50.8 from October's 53.1, signaling higher factory employment, but October's factory jobs fell by 61,000 their 23<sup>rd</sup> straight decline, Labor said. The market is looking ahead to inflation and higher rates. On Friday, the Dow and the S&P 500 climbed 1.2% each as the industrial reached a new closing high for the year. Volume rose on the NASDAQ. According to the Labor Department data out Friday employers cut payrolls by the smallest amount since the Recession and that job gains may be just around the corner. Non-farm payrolls weren't nearly as bad as previously thought or it seems that employees can't extract more from a shrinking work force. Payrolls fell just 11,000, better than a Pharmaceuticals loss of 125,000 forecasted. Temporary jobs rose for a pennies before getting an fourth straight month, jump- FDA approval in May sent ing by 52,400 in November, shares soaring. The stock

the most in five years. President Obama said he will unveil a package this week that will jump start hiring.

GM and Toyota introduced all electric vehicles at its Los Angeles show. The GM Volt car has a battery that will last 40 miles at full-charge. It expects to make 10,000 Volts in 2011. GM has lithium ion batteries from South Korea's LLG Chem for assembly engine that serves as a generator to keep the battery from running down. It takes 3-4 hours to charge with a 110 volt charge and 1-2 with a 220 volt charger. Nissans all electric Leaf slated to go on sale in 2010, is designed to drive up to 100 miles, but unlike the Volt, it has no gas engine, at all. It will lease the batteries for eight years so consumers won't have to buy batteries. Toyota has a plug-in Prius. It drives up to 12 miles on a charge, but then a gas engine kicks in. GM will sell the Volt for \$40,000, but U.S. buyers will get a \$7,500 rebate for a green car tax break, putting the price closer to \$32,500. That's 10,000 more than Toyota's Prius. A lot of customer feedback will be needed to see how and when customers charge vehicles. They all expect the market for electric vehicles to be smaller, so time will tell if those vehicles make it or not.

Biogen Idec moved higher Friday on an offer to buy Facet Biotech for \$17.50/ share. This represents a premium of 25% to Facets closing price, and nearly doubles Facet's stock price on September  $2^{nd}$ , when Biogen made its original offer. It can be a hazardous business trying to predict the winners in the highrisk high-stakes world of biopharma. One missed target in a clinical trial or one delay of the FDA can send a company's shares into the tank. But on the flip side, can be a stock such as Vanda

peaked at \$15.49 in August and now trades at \$12/ share. Vanda's psychotic agent Fanapt had lost the attention of the market and investors stopped looking, thinking the stock had no chance, when it happened. Back in 2008, the FDA had asked for more safety data on a hand to hand trial against another drug. The stock cratered, falling below \$1/share but the company refiled their application and addressed its concerns and Fanapt got full approval. The stock appreciated 900%. Vanda has a partnership with Novartis. The street also missed Human Genome Sciences and partner Glaxo-Smith Klines positive phase for their lupus drug Benlystra. Hope for a lupus drug faded when trials of Rituxan from a partnership between Roches Genertech and Biogen Idec failed in 2008. Human Genome was below \$1 in May, after positive data in July. Human Genomes shares were up 700% to \$28/share. It's partnered 50/50 with Glaxo. Another stock Targecept which does research on neuronal nicotine receptors in the brain, the same receptors which nicotine has its effects. Targacept's shares were up 650% on positive Phase II results for its depression drug TC-5214. The drug is for patients who need another drug to augment the first. They had some setbacks but the latest were twice as good as any drug ever seen for depression augmentation. The street became cautious as other drugs like PMZ never worked, but there are many new drugs hitting the marketplace with good results. Merke has a long history in vaccines and worth watching for several new drugs, but it's too soon to know if the vaccines will work or how well it will sell.

### Crosstown at Crossroads?

Recent financial news on Crosstown has not appeared positive. The Boston Herald recently stated, "Crosstown Center, one of the Menino's administration's pet projects to enhance a gritty section of Roxbury, keeps getting bad reviews on its finances." I remember when the project plans were unveiled ten years ago and as a former resident of lower Roxbury back in the 50s and 60s, I wanted this project to succeed and I hoped it would lead to redevelopment of all the other empty parcels along the Melnea Cass Boulevard stretch from Tremont Street to Mass. Ave.

I had hoped that the Crosstown Center would be the anchor for all kinds of retail, restaurants and residential units that would live up to the memory of community leaders such as Melnea Cass herself.

To date, not much has happened as can be seen by the endless empty parcels. Boston Water and Sewer has replaced the Stride Rite/ Green Shoe factory but that site doesn't have any connection to the nearby community. Originally, the hope by Mayor Menino appeared to be a medical link between the Longwood Medical Area and Boston Medical Center but this didn't happen. It might have just been the timing and the timing hasn't gotten any better recently.

My hope is to resurrect some semblance of the old Lower Roxbury that I grew up in which was working-class and close-knit. By the way, the neighborhood was never "gritty" to quote the Herald story. I hope the Hampton Inn and restaurants in Crosstown Center succeed and grow. I also hope that private developers will come in and add to the story of my old neighborhood. Melnea Cass Boulevard has so much potential. It is a shame to see things remain vacant for so long.

Especially as someone from the area, I remember those plans for the Southwest Expressway that would have cut right through Lower Roxbury. My neighborhood got WestEndized by a project that never came to be. Melnea Cass Boulevard can be the catalyst for even more development near that boulevard too.

Crosstown Center is too important an idea to fail. Melnea Cass Boulevard should be a road offering hope for better days rather than one paved in lost dreams.

Then they went out and began restoring other church buildings in the vicinity of Assisi that were in need of repair. Only gradually did Francis realize that "rebuild my church" meant to reform the institution, to rebuild it by witnessing to the truth of the faith and calling people to renewed faithfulness to Christ and commitment to His mission.

As Francis and his friends set about the practical task of restoring the old church of San Damiano, St. Leonard Church in Boston's North End under the direction of its Franciscan Pastor Fr. Antonio Nardoianni over the last several months has been in the midst of a series of renovations

Most recently completed was an extensive cleaning and re-pointing of the brick work to the facade of the building. Re-discovered were beautiful differences in the color of bricks used in the exterior of the Church which had been obscured by the buildup of decades of grime and smoke present in the city of a wider restoration project atmosphere. In addition, the that must be continued in

fully restored.

Extensive work is planned to repair and restore the magnificent stained glass windows of the church. The work has begun with the removal of the rose window in order to repair the casement and reverse years of deterioration to the window itself. The window will be reinstalled early in 2010.

Security cameras have recently been installed at considerable expense in both Saint Leonard and Sacred Heart Churches enabling both churches once again to be reopened throughout the day.

Finally, the famed St. Leonard Peace Garden is undergoing a complete renovation and reconstruction. Thanks to a generous gift of Albert Natale, former resident of the North End and an active patron of Saint Leonard's, a cement ramp is being constructed that will provide handicapped accessibility to the church as well as the offices and gift shop of the parish.

The old brick planters as well as the cement pathway have been removed to be replaced by a wide brick walkway; new sod has been added to the garden enhancing the beauty of this green, essential and irreplaceable oasis of the North End.





# LA MALE NOTTE (The Bad Night) PART IV

As an Italian American. I witnessed early on that the heartbeat of the Italian community is found in century old traditions like La Befana, the Vendemmia, and the festivals of the saints. Its life's blood can be found in the hundreds of provincial dialects that still vibrantly live today in Italian-American households. Yet during World War II, coupled with these evacuation and internment policies, the government campaigned to all Americans to "stop speaking

the enemy's language. Speak American." The policy was an affront to the concept of the "melting pot". Somehow the speaking of one's native tongue was equated with disloyalty. The message was to be patriotic, one must not utter a language spoken by Hitler, Mussolini or Tojo. Unlike the American Navajo Indians who assisted in the war effort by the use of their language, generations of Italian-Americans were discouraged to communicate in their original tongue and pursue their traditions for many years after the war was over.

The epilogue to the policy of wartime internment and evacuation concerns the most important driver of our society - politics. It was political pressure against the personal ambitions of one individual that brought about an end to persecution policy during a historical period of hysteria. As early as the spring of 1942, President Roosevelt lobbied by civilian and government personnel realized the fallacy of a policy designed to segregate the masses during a time of war. Considerable personnel and infrastructure would be needed to register, track, capture and transport thousands of internees and evacuees. Camps and prisons would need to be built and maintained. An entire bureaucracy would need to be created to oversee all of the functions related to an effort that would only undermine the total war effort.

Additionally, the presidential elections were on the political horizon. Roosevelt was a sickly yet popular wartime incumbent



who needed to build momentum heading into a contest against a popular Mafia prosecutor, Republican and fellow New Yorker named Thomas Dewey. Roosevelt needed success on the European and Pacific battlefields but he also needed the Italian vote particularly in the congested Northeast. He wanted the country unified as he entered the final phases of the campaign. At the close of elections on November 8, 1944, Roosevelt would win New York and

defeat Dewey by collecting 432 electoral votes overall and with a 7% margin in the national popular vote. The Italian-American community had forgiven him and had demonstrated their repudiation of Fascism once again.

It would be another 56 years before the country would acknowledge the violation of civil rights of the Italian community for what happened in World War II. In the autumn of 2000, the country's leaders admitted to these survivors and witnesses that the government bore responsibility for the treatment of resident aliens of Italian descent and Italian Americans by passing the Torricelli Bill S1909 and a House version, HR2442. President Clinton signed the legislation into Public Law 106-451 on November 7, 2000.

Professor Lawrence DiStasi concluded in his comprehensive study "Una Storia Segreta", "it is time America realized what is fundamental to its creed: to condemn one of us on the basis of our origins, national or otherwise, is to condemn us all."

The Italian-American community should once again take time to remember the sacrifices and contributions it has made in this regard and remind everyone that government policies based upon racial or religious origin should be condemned whenever and wherever possible.



While on the subject of flowers, this coming Saturday is "National Poinsettia Day." Lucky me! I've had the pleasure of visiting the Paul Ecke Ranch in Encinitas, California with members of the Garden Writers Association, a very "social" group indeed.

One thing I now know for sure — if you buy or are given a poinsettia for the holidays, it most likely originated at the Ecke Ranch as a cutting.

According to Paul Ecke III, our gracious host during our visit, more than 80% of all flowering poinsettias in the world at the time got their start at the Ecke Ranch. Their production facilities spanned over 40 acres of greenhouses.

Mr. Ecke told us that each year they shipped several million vegetative cuttings to growers in more than 50 countries, and they provided thousands of potted flowering plants for Christmas to wholesalers and retail florist outlets.

The plant we know today as the poinsettia has a long and interesting history. The fact is, that the lovely plant many of us place in our homes during the holidays was once used as a fever medicine.

Native to Central America, the poinsettia may have remained merely a regional plant had it not been for the efforts of Joel Roberts Poinsett (1779-1851). The son of a French physician, Mr. Poinsett was appointed as the first United States Ambassador to Mexico (1825-1829) by President Madison.

While visiting the Taxco area in 1828, he became enchanted by the brilliant red blooms he saw there. He immediately sent some of the plants back to South Carolina, where he began propagating them and sending them to friends and botanical gardens.

Although the widespread belief that poinsettias are

poisonous is false, the Paul Ecke Ranch emphasizes that they are not intended for human or animal consumption. Certain individuals may even experience an allergic reaction to them.

In 1992 the poinsettia was included on the list of houseplants most helpful in removing pollutants from indoor air. So, not only is it a safe and beautiful addition to your holiday décor, it can even help keep your indoor air clean.

By an Act of Congress, December 12 has been declared as "National Poinsettia Day." The date marks the death in 1851 of Joel Roberts Poinsett.

## Recipes from the Homeland

1 pound ground beef (or ground turkey) 1/2 cup Italian-style bread crumbs 2 slightly beaten eggs 1 tablespoon grated Romano cheese 1/8 teaspoon of garlic powder or one small chopped garlic clove 1 teaspoon parsley flakes — optional

Place ground beef or turkey, prepared breadcrumbs, and slightly beaten eggs in a bowl. Mix ingredients thoroughly. Shape meatballs by taking a full tablespoon of mixture and rolling it in the palm of your hands into a ball shape. Place each meatball on a lightly greased baking tray. Bake in a preheated 350°F oven for about fifteen to twenty minutes.\*

Remove from baking tray to separate meatballs from excess oil. Makes about twelve to fifteen meatballs, depending on the size preferred.

\*To microwave: Place meatballs on a microwave-proof platter and cook for five minutes, then turn and continue cooking for five to eight more minutes.

NOTE: The aroma of frying meatballs filled the air in most North End apartments every Sunday morning. My brother and I waited for Mama to start frying her meatballs so that we could enjoy one before the noontime meal.

My recipe evolved from watching my mother prepare her bread crumbs for the meatballs. Most families had a special technique to acquire their desired taste. When I prepare my meatballs, I add one tablespoon of grated Romano cheese and oneeighth teaspoon of garlic powder (or one small chopped garlic clove) to the flavored bread crumbs. These additions give me the taste and aroma of the meatballs I remember enjoying in my childhood.



I wrote the story for Thanksgiving week a bit earlier than usual because we weren't here. Here's what happened ... Young John, couldn't get the time off to come home for November 26. He lives in Switzerland and our American Thanksgiving is not a holiday there. He will be home for a lengthy stay around Christmas time, and as a result, we decided to bring Thanksgiving to him.

After our plans were made, John announced that Michael, our younger son, was going to join us also. This way the family would be all together. But, that was part of the surprise. If you remember, I mentioned that John had accidentally found family in Zurich, Switzerland and we were going to all get together once Loretta
