Experts Warn of New Landslides in Italy

Experts say Italy faces new landslides in inhabited areas after the forced evacuation of thousands from two southern towns earlier this

"Italy will always have landslides," geologist Leonello Serva told AFP. "What is not acceptable for a wealthy country is to have landslide blocking a highway, hitting a bridge or a hospital."

The density of populations in at-risk areas and a lack of awareness about geological risks both contribute to the recurring catastrophes, experts agree.

Torrential rains in southern Italy caused landslides that led thousands of people to flee the towns of Maierato in Calabria and San Fratello in Sicily.

Sicily Governor Raffaele Lombardo said that Sicily was especially at risk "because of the extraordinary rainfalls, the geological fragility of the land, and because for 40, 50, 100 years people have built houses on land that is subject to landslides."

ISPRA, a public research institute that monitors areas at geological risk, classifies, about five percent of Italy's territory at the highest risk for landslides.

It has recorded 470,000 landslide events in Italy over the last 50 years.

Serva, who heads ISPRA's land protection section, says that in Italy, landslides "can be expected anywhere there is a slope," since the soil on Italy's innumerable hills and mountains is "young in geological terms."

But the southern regions of Campania, Calabria and Sicily are the most likely to experience landslides, he said.

In October, dozens of people died in a muslide near the city of Messina in Sicily.

A worse disaster occurred in 1998, when the town of Sarno, outside Naples, was engulfed by two million metric cubes (70 million cubic feet) of mud, killing 160 people and destroying nearly 200 homes.

Serva also noted that safe

As a community it is our responsibility to maximize all the resources we have available to increase public safety, utilizing comprehensive support services along with new technology to fight crime. The tragic shooting last week of a convenience store clerk in Dorchester was an unconscionable act of violence and a reminder that we must not allow this type of behavior to be accepted in our city. I commend the Boston Police Department (BPD) and community for working together to apprehend the on how to properly maintain cash regisindividuals responsible, but more can and will be done to prevent these senseless acts of violence from occurring.

The BPD this week launched its Real Time Crime Center, a newly created division within the Bureau of Intelligence and Analysis that can monitor ongoing police incidents and provide "real time" data to officers in the field. This innovative new technology allows the BPD to monitor multiple events at the same time, combining resources and databases to assist field units in responding immediately to incidents across the city.

We have also created the Store Safety Initiative, offering free in-store assessments and making resources immediately available to convenience store owners all over Boston. Officers and city hall personnel have received specialized training on commercial robbery prevention methods and they began this week walking through Roxbury and Dorchester as part of a proactive outreach campaign to provide security assessments for convenience store owners.

The outreach teams will help owners obtain what they need to make their stores safer and provide training for store owners, managers and employees ters and what to do when a robbery occurs. After a thorough in-store assessment is completed, they will help store owners achieve better security by offering critical improvements such as increased visibility and installing alarm systems and security cameras.

The Initiative will be focused mainly on convenience stores, having the greatest need and limited resources, but we are committed to maintaining the safety of all our city's businesses and employees and encourage anyone who would like to take part in the Store Safety Initiative to call the Mayor's 24-hour hotline at (617) 635-4500 for a security assessment. Together we can all help to prevent such appalling acts of brutality from occurring in our neighborhoods.



Stirpe Nostra

The history of ancient

Rome is easily divided into three separate and distinct periods. These were known as: 1. **Regal Rome**, the period

of seven kings starting with Romulus in 750 B.C. and ending with Lucius Tarquinius Superbus in 510 B.C.

2. **The Republic**, starting with the death of the abovementioned Lucius and ending in 27 B.C. shortly after the death of Julius Caesar.

3. **The Empire**, starting with Augustus in 27 B.C. and ending with the pitiful Romulus Augustulus in 475 A D

Romulus was the founder of Rome and its first king. In earlier years people scoffed at the idea that a real Romulus did exist, but this indeed was the true name that belonged to an early builder of Rome. There may or may not have been a shewolf, but as to the existence of Romulus, or "The Man of Rome" as some have called him, later discoveries

present a great mass of evidence and most details are supported by monumental remains.

The Wall of Romulus, small parts of which are still visible at different points around the Palatine Hill, enclosed a space which was called "Roma Quadrata" by the ancient historians, because of its quadrangular shape. This enclosed space, this Roma Quadrata, an area of about twenty-four acres, is said to be where the Rome of history begins.

Contemporary with Romulus and his Palatine Hill was Tatius the Sabine, whose tribe occupied the Capital

In this location and to this period of time also belongs the story of the carrying off of the Sabine girls who had been invited with their parents, in an interval of peace, to attend some rustic games in the long valley between the Palatine and the Aven-tine Hills, (the site of the Circus Maximus). A second peace treaty be-

tween Romulus and Tatius was short-lived, and ended with the violent death of Tatius the Sabine, followed shortly thereafter by the death of Romulus the Roman. As startling or as strange as it may seem, Romulus was the first and last Roman King of Rome. There were seven kings during this first historical period called Regal Rome. Romulus was the first. The next three were the Sabines, Numa Pompilius, Tullus Hostillus, and Ancus Marcius. The last three were Etruscans named Lucius Tarquinius Priscus, Servius Tullius, and Lucius Taraquinius Superbus.

If you were introduced to the last six at a cocktail party, how many names could you remember? As an afterthought, I might add that if you were introduced to any one of the seven at a cocktail party, I'd like to know what the heck you had to drink.

50 Years Ago This Month

Fifty years ago this month The Conscience of a Conservative was published under the name of Arizona Senator Barry Goldwater (1909-1998). The thin, 127-page,

volume was, DONT TREAD ON ME First in fact, ghostwritten by L.

Brent Bozell, Jr., (1927-1997), Goldwater's speechwriter, and sets forth in ten chapters some of the most important themes in modern (post World War II) American conservatism. The book was a best-seller and propelled Goldwater to the Republican Party nomination for the presidency in 1964. The book helped to popularize the conservative movement and its publication was one of the key events preparing the way for Ronald Reagan to be nominated and win the presidency in 1980.

In chapter one the author states: "The root difference between the Conservative and Liberals of today is that Conservatives take account of the whole man, while the Liberals tend to look only at the material side of man's nature." He sets forth three conservative principles.

- First, each man has a Americans. unique individual soul.
- Second, man cannot be economically free if a political slave, and vice-versa.
- Finally, politics ought to be conceived "as the art of achieving the maximum amount of freedom for indi-

viduals consistent with the maintenance of the social order."

> In a chapter on "The Perils of Power" he sets forth the conservative doctrine of constutionalism.

limitation of the federal government's authority to specific, delegated powers. Second, the reservation to the States and people of all other power. Third, division of power among three branches of government. Finally, the wisdom of the founders in making it difficult to amend the Constitution.

I've mentioned how the Ronald Reagan's election and two successful terms as President were the fruit of the sort of conservatism articulated in Goldwater's book. The 1994 Republican revolution which saw huge conservative gains in both houses of congress, likewise, stood on the shoulders of Goldwater and other post-War conservatives. The "Don't Tread on Me" rallying cry of today's Tea Party movement is just the latest manifestation of the essential conservatism of

THE HEALTH DEBATE

While the healthcare summit seemed like an opportunity to reach a compromise, the President and lawmakers could not hide bitter partisan divisions. The attempt at reconciliation where only 51 votes were needed instead of 60 needed to end the debate. A CNN poll released opposed reconciliation 52-39%. In a gallop poll recently released the public was opposed to reconciliation, also, 48% say start from scratch, 23% supported a plan similar to the one working its way through Congress and 25% say just stop working on it.

Home prices rose again, but embattled banks are slashing lending further. Consumer confidence plunged in February to a 10 month low and the number of problem banks jumped 27% to a 17 year high. The 10 year US treasury fell 1% to 3.60%. The home price index rose .3% in December, the 7th straight seasonally adjusted gain, and prices fell month to month unadjusted. Housing could stagnate and return south, after the government ends support this spring. According to Reuters "we've been through the major boom, a major bust and since April 2009, the most dramatic turnaround that goes all the way back to 1987."

Apple rises on acquisition hints. Steve Jobs told shareholders he won't use its \$4.9 billion in cash reserves for stock dividends or buybacks because "you don't know the opportunities going to be around the corner." CWBE reported rumors of a 4/1 split and a possible buy!

The Fed chairman said low rates of interest are still needed to insure that the economic recovery will last and help ease the string of high unemployment. Also Ben Bernanke, Chairman, told the Senate Banking Committee that the privatized mortgage giants need to be cleaned up, now under conservatorship, would be interesting. The panel is near a bipartisan deal on financial regulatory reform.

Jim Morgan, CEO of Applied Materials turned around the company from \$17 million in sales to a \$5.5 billion company. Share prices were up 104%, and he sold 5 out of 6 businesses he was in. He kept the equipment businesses and looked at what worked and the firm was leaner and more ready to borrow. He supplied the PC industry as it needed lots of gear to make these chips. pany into the world's largest capital equipment maker, very profitable.

After bottoming out with only 43 new issues in 2008, the IPO market, is now attracting over 100 IPOs to the market this year. In the 1st six months there are 14 Chinese IPOs listed. Experts argue that the new much maligned Sarbanes Oxley corporate governance legislation is encouraging new US listings. Chicago accounting firm BDO Seidman's optimism on foreign listings represents a gaining share of IPOs on US exchanges this year. The Sarbanes Oxley Act has had an impact with new rules tightening accounting disclosure, government disclosure and governance raises the cost of doing business but attracts new filings. Investors around the world are demanding companies meet more and more demands in corporate governance through transparency. Eric Yu, CEO of 7 Days, a Chinese-based hotel chain that went public in November, listed on the NYSE has been helped by the new requirements. A US listing is a branding advantage with Chinese consumers.

When We Lived in a Dream World

the Bible somewhere that goes, "Young men dream dreams, old men see visions." Personally, I think we forgot how to dream and keep the visionary view of mankind. There's also a relatively new song about reaching goals. The lyrics point out the quest isn't in what's on top but the climb to arrive at it.

Back in 1960 when Jack Kennedy ran for president, he sought to be the first 20th century American leader. His slogan was "A new generation of leadership." That was my father's generation. I was a baby boomer born in the few years following the end of WWII. I can remember sitting in Sister Mary Honor's 7th grade classroom at St. Rita's Grammar School in Lower Roxbury watching the first flight of the Project Mercury Program at NASA. When Mercury 7 blasted off into the outer atmosphere carrying America's first astronaut into space, Alan Sheppard, the whole classroom broke out in cheers. We were dreamers back then. Anything was possible if we put our collective minds to work on it. Space was that new frontier to be conquered. Like that song still playing on the radio today, it wasn't just about getting to the Moon it was about the struggle and the climb into space that really meant everything.

Recently, I thought about my youthful days of the early sixties when I was young and the country felt young. I belonged to that generation that was between yesterday and tomorrow. We thought nothing was impossible. We weren't cynical about life or the future. Landing on the moon was quite possible to

There's a quotation from us and we saw the fulfillment of that dream on August 20, 1969 when Neil Armstrong put his foot down on the surface of the moon and stated, "One small step for man, one large step for mankind." For us, it was on to deeper space. The planets and beyond. We desired to reach beyond our grasp, we were part of the universe and it was there to explore.

> At the Museum of Science, I was caught by its display on space exploration. The museum even has one of those old NASA capsules that those Mercury astronauts were crammed inside in close quarters. I remembered all those liftoffs. I remember John Glenn orbiting the Earth in 1962, another classroom event for my generation. I also remembered in the years to follow, all those space tragedies when things went bad.

> While at the museum, I started talking to a young 30-something father with his little boy and started revealing my feelings to him and could tell, space exploration seemed to be of little value to him. The dream seems to have died. There is no longer a frontier out there to reach for many. People think the idea is needless and dangerous and not worth traveling toward. My generation failed, it seems, to pass on that dream. Few want to make those kinds of sacrifices today.

> Today we have fallen back to Earth and don't have the time to dare beyond our reach. Few can understand how I felt back then. Adventure seems for others but not us. Now we are chained by our fears rather than freed by our imagination and courage. We were better off than we are today.

Ralph Towner & Paolo Fresu AT THE REGATTABAR

Ralph Towner: Baritone and 12-string Guitars - Paolo Fresu: Trumpet and Flugelhorn

Chiaroscuro introduces a new duo and a rare instrumental combination - trumpet and acoustic guitar. The repertoire: a program of old and new Ralph Towner compositions and duo improvisations, plus an old Miles Davis favorite, its presence a key to the musical priorities at work here.

The album was recorded in October 2008 in Udine, but the story of the Towner/Fresu alliance really begins further South, at a festival in Sardinia 15 years ago. Towner was commissioned to write music for a local ensemble. Fresu was its trumpeter. "I didn't know him at all then," Ralph recalls, "but from the very first phrase that he played, I thought "This guy really understands melodies! And I thought there and then that we should do some more work together.'

The composition played that night, "Punta Giara," resurfaces here in rearranged form, along with pieces shaped especially for this album, including the title track, a study in strong contrasts. The atmospheric "Sacred Place," heard in two versions, and "Doubled Up" bring Towner's new baritone guitar to the fore. Tuned a fifth below his classical concert guitar it allows him new flexibility in the low range, and the freedom to be, effectively, his own bassist on the clever "Doubled Up," the most overtly jazz-like of the new tunes. "Doubled Up" has many meanings, of course, including doubled up with laughter. Here the theme is sequenced, so to speak, the events happen twice, each theme 'doubled' by the two

Two pieces from Ralph's ECM backcatalogue are revisited: "Wistful Thinking (originally heard as a solo piece on Open Letter, in 1992), and "Zephyr" (first



scored for the band Oregon on 1987's Ecotopia).

Of the subtle account of "Blue In Green," Towner says. "I'd always wanted to do that song with a trumpet." Paolo Fresu's clear, vibrato-less sound acknowledges its debt to Miles. Fresu has always been forthright about his formative influences (his bold remaking of Porgy and Bess in 2001 being a case in point). For Towner, as for so many musicians, Kind of Blue was a pivotal recording: "The whole ensemble was amazing, but especially Miles and the great Bill Evans working together — my favorite musicians of all time, in the improvising sphere."

"Chiaroscuro" concludes with "Two Miniatures" and "Postlude," improvisations that put the spotlight on the 12-string guitar, extending an approach that had worked well on Ralph's solo albums Anthem and Time Line. "I like to do these free things — well 'free' is really a misnomer. The same compositional process is at work, but you only get one shot at it." The show will be held on March 23, 2010. MODELING DEVOTION

Terracotta Sculpture of the Italian Renaissance **NOW THROUGH MAY 23, 2010**

In Italy during the Renaissance (around 1400 to 1600), an innovative form of sculpture was developed using fine clay that was modeled before terracotta in Italian (meaning baked earth), this type of overlooked in favor of sculpture carved in marble or cast

in bronze. Clay can be handled easily with material added, removed, or textured as required. This freedom allowed artists to capture fine details and emotional expression.

Moreover, terracotta sculpture of the Renaissance was almost always painted or glazed in naturalistic colors. Figures were often life-sized, three-dimensional, and fully colored, giving terracotta sculpture a remarkable immediacy. For large works, separate figures were often fired separately and then assembled.

In both religious scenes meant to inspire the faithful, as well as in portraits that recorded individual likeness, being fired in a kiln. Called the naturalism of colored terracotta works conveyed emotions with great power. sculpture has often been Isabella Gardner acquired several terracotta sculptures, including large multifigured compositions.



HARRY'S BAR The Boston - Venice Connection

What is the connection between Boston, Massachusetts and Venice, Italy? If you have been to Venice I am sure you have reveled in its wonderful sights, the Grand Canal, with its ever present Gondolas, Ponte Vecchio, Basilica di San Marco, Piazza San Marco, the Doges Palace and the Bridge of Sighs. If you take a short walk not to far from Piazza San Marco past the columns with the winged lions, the symbol of Venice, and traveling along the Grand Canal towards Santa Maria della Salute, you will find Harry's Bar. Here in this well kept and quite sophisticated place is the connection between Boston and Venice.

Harry Pickering was a quiet, wealthy young man from Boston, Massachusetts who was beginning to show some signs of alcoholism and weeks into months still

so his family sent him to live with an elderly aunt, who herself enjoyed imbibing on bourbon and 7UP. On a visit to Venice while staying at the hotel Europa they frequented the bar and became acquainted with the barman who's name was Giuseppe Cipriani. In 1927 Cipriani was working at the Bellevue Hotel in San Remo. Here a patron of the bar convinced Cipriani to loan him his savings to bet on a sure thing. The man disappeared with the money and Cipriani returned to Venice, a little smarter but poorer. Cipriani, who could speak English, got along very well with Harry and his aunt, so much so that he would pour their "usual" when they came into the bar and for this he received very good tips. Unfortunately, Harry and his aunt had a falling out when his aunt took up with some gigolo and she left the hotel leaving Harry to fend for himself.

Harry began drinking more and Giuseppe asked him if money was running low and Harry said it was. After hearing this, Giuseppe Cipriani offered to lend him 10,000 lira (about \$5,000 US). Harry asked why he would give him this money and Giuseppe replied, "Because you need it." Harry took the money and departed from the hotel and Italy.

Days turned into weeks,

Cipriani did not hear from Harry. Two years after he loaned Harry the money on a cold February day in 1931, Harry Pickering came up to the bar at the hotel Europa in Venice and handed Giuseppe an envelope. Opening it Giuseppe found 40,000 Lire. Harry said, "Let's open a bar together." "Okay" said Giuseppe, "we'll call it Harry's Bar."

Harry's Bar is known for many things, one of them is the well-known Bellini — a cocktail consisting of peach puree and Champagne or Proseco. Cipriani named it after the Venetian artist Giovanni Bellini. This drink was a favorite of the author Ernest Hemingway who frequented Harry's Bar while staying in Venice. He liked the bar so much that he included it in his novel "Across the River and into the Trees." Another drink that Hemingway favored and was the first to order it was, the "Montgomery Martini" named after British Field Marshal Bernard Montgom-





Boston neighborhoods figure prominently in a new photography exhibition now open at the Boston Public Library in Copley Square. Man in the Street: Jules Aarons Photographs Boston, 1947-1976 features the black and white photography of Jules Aarons (1921-2008) from the years he spent capturing images of Boston.

The North End, West End, and South Boston neighborhoods from the 1950s and 1960s are on display in photographs of young girls sharing a story, teenagers hanging on a street corner, and women talking to their neighbors. Some are gripping images of Boston's past like the long-gone penny

ferry from East Boston, or sites that remain familiar today like a game of pick-up basketball in the South

"This exhibition demonstrates the connection Jules Aaron had with Boston neighborhoods and the people who lived in them," said Aaron Schmidt, curator of the exhibition. "Jules Aarons was a true street photographer in the tradition of Henri Cartier-Bresson and Helen Levitt. He found visual inspiration in the juxtaposition of people against their urban background."

Photography started as a hobby for Jules Aarons, a very successful engineer and physicist who helped develop, among other things, GPS technology. When he began photographing seriously in 1947, he chose the streets and neighborhoods of Boston as his subject. He was drawn to the way people in the neighborhoods lived their public lives and the energy with which they talked, played, and worked. He brought to his photographs a technical mastery, artful eye and, most importantly, a deep understanding of the neighborhoods of Boston and the people who lived

In 1997, the Boston Public Library began collecting the work of Jules Aarons. The BPL now holds the largest public collection of his work. The Print Department at the library has made it its mission to collect the work of artists with ties to the Boston area. Jules Aarons is one of many important artists whose work is represented in the growing collection.

The exhibit is on display in the BPL's Wiggin Gallery at the Central Library in Copley Square Monday, Wednesday, Friday, Saturday, 9-5; Tuesday, Thursday, 9-7; and Sunday, 1-5 through June 4.




CARRIE NEWCOMER -BEFORE AND AFTER (CD) Rounder

KEN PEPLOWSKI — NOIR BLUE (CD) Capri

Jazz reedman Ken Peplowski teams up with drummer Joe La Barbera, the well-respected bassist Jay Leonhart, and acclaimed pianist Shelly Berg, to create a stellar group. Together they offer up a delicious mix of standards, with the music of Duke Ellington/Billy Strayhorn, and three original compositions. Salty comment! A little less salt could add years to your life, a new study suggests. Scientists in San Francisco claims if Americans reduced their daily salt intake by 3 grams, or just half a teaspoon, the number of heart attacks would drop annually by as many as 99,000 — a 13 percent decline. Most Americans eat much more than the recommended amount of salt, but 80 percent of our intake comes from processed and restaurant-prepared foods like canned soup, jarred sauce and fast food, not the family saltshaker.

Daniel Marguardo of Donna's Restaurant in Orient Heights, East Boston, claims when friends tell you how to cure a sore throat, take it with a grain of salt: The advice won't do you any good, but the salt may.

Scornato! Actor Rip Torn was arrested after he allegedly got stinking drunk and broke into a Connecticut bank while carrying a loaded handgun. Police said the 78-year-old Torn — who had twice the legal blood-alcohol limit — apparently broke a window and entered the bank, thinking it was his home. "Torn asked why we took him out of his house," a police report said. Torn, who has a history of alcohol problems, checked into a Manhattan rehab clinic, his lawyer said.

Tom Analetto of Medford, says, "Man is the only machine that needs to be lubricated with alcohol.'

Bella Culo of Chestnut Hill, claims, an alcoholic is a person who drinks like a fish, but not the same thing.

Carlo Scostumato thinks many an alcoholic would get on the wagon if they could only find one with a bar.

Vodka is Russia's curse, said Moscow's Nezavisimaya Gazeta. Literally for centuries, "the fight against alcoholism has been part of Russian government policy." Yet our national drinking problem only gets worse. In the early 1990s, right after communism fell, the average Russian consumed 5.4 liters of pure alcohol a year, and even our President, Boris Yeltsin, was a drunk. "Things got so out of hand" that the main criterion for a new president was that he be sober, and we ended up with the teetotaling Vladimir Putin. But as capitalism spread, so did cheap vodka, and now average annual consumption is up to 18 liters per person. This month, Putin announced he wanted to cut that rate in half in 10 years by raising prices. It won't work. Russians who can't afford decent vodka will simply turn to cheap moonshine, readily available on the black market. Simply put, alcohol is our "national anti-depressant," and many Russians just couldn't face the day without it. Our only hope is to reach the youth before they become addicted. If we make "great investments in recreational activities that encourage a healthy lifestyle," perhaps the next generation won't be lost to booze.

Huh? President Obama and Republican Senator-elect Scott Brown of Massachusetts are distantly related, genealogical research reveals. Obama's mother and Brown's mother both descended from Richard Singletary of Haverhill, Massachusetts, who died in 1687. Obama and Brown are 10th cousins.

A tip on how to conquer sweat, smells and skin cells. Fumigate your feet. If your feet smell like a piece of aged Limburger, rid them of odor causing bacteria. In a new Japanese study of 1,058 elderly adults, investigators found that those who drank four or more cups daily were 44 percent less likely to exhibit symptoms of depression. Tea's apparent protective effect did not fade even after researchers at Tohoku University factored in social and economic status, diet, medical history and use of antidepressant medications.

Ah tea! Frankly, as a GI stationed in England we tried and tried to enjoy a "spot of tea." We just could not stand the taste of it and wondered how the English could drink it. Perhaps the reason the English are such great tea drinkers is on account of their coffee. To an Englishman the only thing lukewarm in America is tea.

Unbelievable! There is now a pill to ease hurt feelings caused by social rejection. The widely used painkiller acetaminophen can decrease hurt feelings. "Social pain, such as chronic loneliness, damages health as much as smoking and obesity," says psychologist C. Nathan DeWall of the University of Kentucky. "We hope our findings can pave the way for interventions designed to reduce the pain of social rejection."

More medical news! Breast-feeding is heart healthy! University of Pittsburgh researchers evaluated nearly 300 women between the ages of 45 and 58 who had at least one child and found that those who had not nursed were much more likely to develop heart-related problems. "During pregnancy, a woman's body stores fat that it expects to release during lactation," explains Dr. Eleanor Schwartz. "If women don't breastfeed, then the body has to deal with excessive fat. If you can breast-feed for three months after each pregnancy, your blood vessels are likely to be in better shape down the road."

Hollywood stuff! The adorable, sultry Sigourney Weaver was a leggy 25-year-old hottie in Ghostbusters — now almost four decades later, she says she feels sexier than ever. "I like my body now," says the 60-yearold actress, who stars in the blockbuster new sci-fi flick Avatar. "I have my curves. They come from age, but I don't care. I'm just glad they're there." A brainy, 5-foot-11 beauty who attended Stanford and Yale universities, Sigourney has flaunted her leggy charms in flicks like Ghostbusters and Working Girl. In real life, Sigourney and her theaterdirector husband Jim Simpson, 53, are an old married couple. They wed 25 years ago and have a 19-year-old daughter Charlotte, who wants to be a costume designer.

VEGETABLE MEDLEY

2 medium potatoes

1/2 pounds fresh, frozen or canned string or cut beans 1 large garlic clove

- 1 medium zucchini sliced (1/2-inch pieces) not peeled
- 1 medium yellow squash sliced (1/2-inch pieces) not peeled 2 large ripe tomatoes or a four-ounce portion crushed tomatoes
- 1/3 cup olive oil 1 chopped medium onion
- 1 tablespoon capers
- 3/4 tablespoon basil

In a saucepan, sauté onion and capers in oil until opaque. Add chopped ripened tomatoes or four ounces of crushed tomato. If you prefer a heavier sauce, use a four-ounce can tomato sauce instead. Add fresh or dried basil. Stir, cover and simmer slowly. Meanwhile, peel and cube potatoes. Wash and set aside. If using fresh string beans, cut ends off, wash and set aside. Add potatoes and beans to saucepan. Stir, cover, and simmer slowly for ten minutes. Add sliced zucchini and yellow squash (optional). Salt to taste. Add water if more liquid is desired and bring to a boil. Cover and simmer slowly until all vegetables are tender. Serve with garlic bread.

Serves two.

NOTE: For those who enjoy rice or pasta, prepare your preferred rice or macaroni according to directions on the package. Serve a portion topped with the vegetable medley. Sprinkle with your grated cheese of choice.



Last week, I was in the middle of a story about one of my first vacations as a young man traveling without my parents. Sal Meli, whom I had grown up with in East Boston; Tom Aylward, a new friend who taught at the same school and I had headed for St. Thomas and Puerto Rico. We had spent a few days in St. Thomas' capital city, Charlotte Amalie, and were ready to head to San Juan, Puerto Rico. Saints Perpetua and Felicity

On March 7th the Church celebrates the Feast of Saints Perpetua and Felicity, whose names we often hear in the recitation of the Litany of the Saints. The details of their martyrdom suffered at Carthage along with their companions Revocatus, Saturus, and Saturninus have reached us through a contemporary description and remains one of the most descriptive accounts of Christian martyrdom in ancient times.

In the year 203, Vibia Perpetua made the decision to become a Christian, although she knew it could mean her death as a result of a decree by the Roman Emperor Septimus' Severus (193-211) that all imperial subjects were forbidden under severe penalties to become Christians. Her brother followed her leadership and became a catechumen as well.

Perpetua's father, who was a pagan, was frantic with worry and tried to talk her out of her decision. It is easy to understand his concern, at 22 years old; this welleducated, high-spirited woman had every reason to want to live — including a baby son who was still nursing. We know she was married, but since her husband is never mentioned, many historians assume she was a widow. Perpetua's answer to her father was simple and clear. Pointing to a water jug, she asked her father, "See that pot lying there? Can you call it by any other name than what it is?" Her father answered, "Of course not." Perpetua responded, "Neither can I call myself by any other name than what I am - a Christian."

Perpetua was arrested with four other catechumens including two slaves Felicity and Revocatus, and Saturninus and Secundulus. After their arrest, and before they were led away to prison, the five catechumens were baptized; a sixth man named Saturus, who deliberately declared himself a Christian before the judge, was also imprisoned.

A few days later Perpetua's father, hearing a rumor that the trial of the imprisoned Christians would soon take place, again visited their dungeon and pleaded with her not to put this disgrace on her name; but Perpetua remained steady in her Faith. The prison was so crowded with people that the heat was suffocating. There was no light anywhere; Perpetua "had never known such darkness." The soldiers who arrested and guarded them pushed and



shoved them without any concern. Perpetua had no trouble admitting she was very afraid, but in the midst of all this horror her most excruciating pain came from being separated from her baby.

The next day the trial of the six confessors took place, before the Procurator Hilarianus. All six resolutely confessed their Christian Faith. The Christians were then condemned to be torn to pieces by wild beasts. Felicitas, who at the time of her imprisonment was pregnant (in the eighth month), was apprehensive that she would not be permitted to suffer martyrdom at the same time as the others, since the law forbade the execution of pregnant women. Two days before the games she gave birth to a daughter, who was adopted by a Christian woman.

On March 7, the five confessors were led into the amphitheatre, the sixth confessor, Secundulus, died in prison. At the demand of the pagan mob they were first scourged; then a boar, a bear, and a leopard, were set at the men, and a wild cow at the women. Wounded by the wild animals, they gave each other the kiss of peace and were then put to the sword. Their bodies were interred at Carthage; the names of Felicitas and Perpetua are entered in the calendar of martyrs venerated publicly in the fourth century at Rome. A magnificent basilica was later erected over their tomb, the Basilica Majorum; that their tomb was indeed in this basilica has lately been proved by Pere Delattre, who discovered there an ancient inscription bearing the names of the martyrs.

The feast of these saints is still celebrated on March 7th. The Latin description of their martyrdom, written by an eyewitness soon after the death of the martyrs, was discovered and published by Poussines, contain the narrative and the visions of Perpetua and Saturus. In 1890 Rendel Harris discovered a similar narrative written in Greek

DID YOU KNOW THAT ...

The Italian embargo against North Korea is in full swing. Two yachts reflecting Italian luxury, were targeted, just before taking off toward North Korea's dictator Kim Jong Li. The operation began in July 2009. More exactly when the National Police and the Treasury Police (Guardia di Finanza) showed up at the Azimut Benetti shipyards, at Viareggio, in the Tuscany Region, where two luxury yachts were built, the '95' model (almost 100 feet) and the '105' model (almost 105 feet), and confiscated them. The two boats were about to be delivered to a purchaser, who at least on paper, appeared to be legitimate: an Austrian company which had acquired the purchasing rights to subsequently sell to a Chinese company. Precisely, behind the latter company there was what the Italian builder thought was a contractual fraud which threatened the ship builder open to a charge of violating the embargo terms against North Korea. It sounds like a spy story. The two boats would have ended up, as we gather from a summary review of the facts whose details remain top secret in North Korea. In any case, the complex, secret deal brings to mind the '007s plots right in the hands of the North Korean dictator, whose behavior has constantly been on the international periscope because of nuclear testing, in total violation of several UN resolutions. Meanwhile the two luxury boats have been returned to the ship builder (Azimut) which can sell them to other customers, provided they can afford the balance of \$17.8 million. Italy, which has diplomatic relations with North Korea, feels proud to have uncovered an international fraud.. At the same time, the North Korean Government has not lodged any protest at all. I wonder why!

Fort Hood Suspect Diversity Dilemma?

The Boston Globe recently sought permission to review the US Army's more complete findings on Major Nidal Malik Hasan and discovered that Army supervisors were warned about Hasan's increased radicalization tears before he opened fire on soldiers at Ft. Hood last November. It would also appear no action was taken because the Army apparently valued the diversity of having a Muslim psychiatrist within its ranks. Red Sox Get Hall

The Boston Red Sox have a history of having great super subs. Back when I was a kid, first there was Dalton Jones, then later John Kennedy. Guys who get timely hits, great defensively and able to play multiple positions in the field. The Sox picked up Bill Hall. He's a great utility player and the Sox are only paying him \$1.3 million of his \$8.4 million contract this season. Boston is hoping he returns to his 2006 form before injuries set in when he hit 35 homers as the Brewers' starting shortstop. Hall signed a 4-year, \$24 million deal with the Brewers following '06. The Brewers dealt him to the Mariners at last season's trade deadline and Boston got him from the Mariners in an offseason deal. He can start at short, third and center field. If Hall does well in spring training, most likely Jed Lowrie will start at short for the PawSox.

What About Beckett?

Josh Beckett turns 30 in May and is working on the final year of his contract. How much money is he worth is a big question. He's a good ace, but not a great one. He's won two World Series almost singlehandedly. However, the Sox paid over \$100

million for Dice-Kay and just gave former Angeles' ace John Lackey a 5-year, \$82.5 million pact. Then, there's the team's next ace Jon Lester. Beckett knows money is going to be a BIG ISSUE. Should we sign him up before

this season starts or wait until the end of the season seeing what he produced?

Beckett's good, but not great as I said. His first season here, he was 16-11 with a 5.01 ERA giving up 36 home runs to boot. Then, he was 20-7, 12-10 and 17-6. Last year he did win 17 games, which were his most wins since 2007 when he was a 20 game winner but in his last 9 starts, he had a 6.02 ERA and looked horrible out there on the mound.

If we sign him up before season's start and he breaks down again late in the season, we're stuck with him and his salary. I say wait. Some may disagree with me and that's fine, but Beckett in four years here is 65-34 with a 4.05 ERA. Once was one of the best, now one of the better.
