Boston Property Taxes Rise in 2019 with Surging Real Estate Values

Rising real estate values are once again driving significantly higher City of Boston property taxes for fiscal 2019. Area homeowners are reportedly seeing a mid-to-high single digit percentage

increase in their assessment from the city's mailing of its recent property tax bills due on February 1st.

The median home value in the North End is \$717,800, according to Zillow, translating to an annual property tax bill of \$7,565. Downtown Boston values are higher with a median value of \$1,069,600. That means paying a property tax levy of \$11,273, under the new residential rate.

The city's residential tax rate increased marginally this year, from \$10.48 to \$10.54 per thousand dollars value. However, citywide property assessments increased high-single digits on a percentage basis, following a similar increase last year. The commercial rate actually decreased slightly. Because residential values are rising faster, homeowners will bear more of this year's tax increase.

In a spot of relief, the owner-

increased this year to \$2,719 from \$2,538. Owners can also file for the residential exemption credit if they own and occupy a property as of the previous January 1st.

Roughly, 70% of the City's budget is funded by real estate taxes. With its higher values, the downtown Boston neighborhoods pay the majority of property taxes in the city.


There are two factors that directly change an owner's property tax: (1) a change in the assessed value and (2) a change in the tax rate. Boston's property tax system reflects a "see-saw" between commercial and residential taxes. When commercial property tax values are down (or rise slower) due to the economy, a higher burden shifts to residential properties.

The higher City tax levy is generally split with about half of the increase coming from the 2.5% increase allowed under Proposition 2 1/2 and the rest coming from new development added to the tax base.

Property owners can file for a tax abatement if they believe their assessment is incorrect. The deadline to file for a tax occupied residential exemption abatement is February 1st.



THE VIGILS OF OLD ROME PART I



The earliest civilization of Western Asia developed in the area between the Tigris and Euphrates Rivers called Mesopotamia. The name was derived from "Mesos" (middle) and "Potamos" (river). This is the area where history locates the Garden of Eden, Noah's Ark, the Tower of Babel and the great walled city of Babylon with its "Hanging Gardens" — one of the wonders of the ancient world. As early as 2200 B.C. the Mesopotamians had developed a code of laws wherein the family idea prevailed, women were free and respected, cities had rights and charters, and they had a

political system, postal service, landlords' responsibilities, and city dues.

The history of municipal policing, as far as we are concerned, goes back to Tiberius, the second Emperor of Rome. He was more properly known as Tiberius Claudius Nero Caesar. In 23 A.D., he was prevailed upon to establish permanent barracks for about ten thousand local or city troops. This was to be the only organized military force permitted in the City of Rome. Prior to this time, they had been housed in various parts of the suburbs. Barracks for these new city troops were erected on a forty-acre site in

a sparsely occupied section of that city. The compound was surrounded by solid brick walls ten to fourteen feet high.

The thinking at this time was that bringing these newly named Praetorian troops together in this manner would make them a more useful tool in the hands of the Emperor. The result proved to be just the opposite. The Praetorian Guard became a dominant force, and one that all future rulers were obliged to deal with. It is also reported that they were able to make or break emperors at will. This situation continued for about three hundred years until Emperor Constantine (the good guy) disbanded the organization and destroyed their

Like any strong law-keeping force, we hear much of the so-called bad and nothing of the good. This dominant force also kept lawlessness to a minimum, but how do you record crimes that never happen? An offshoot of the group was a corps of men who were able to keep the peace, prevent and fight fires, while at the same time maintain a watchful eye over the entire city, including all of its daytime and nighttime problems.





Houseplants 101

Lift your spirits and improve your indoor environment by taking part in the indoor gardening movement. An apartment or home filled with tropical, succulent and flowering plants can provide beauty, extend your garden season, improve air quality and create a peaceful environment to de-stress.

Though some may find indoor gardening a bit intimidating, don't let past failures or the thought of tending living greenery stop you from enjoying the many benefits. Knowing some basics in care and making needed adjustments to the growing environment can turn past failures into success.

Water, humidity and light are key to growing healthy plants. When you match these to a plant's needs and the growing media, you're sure to experience success.

Use a container with drainage holes to avoid overwatering that can lead to root rot and plant death. It should be no more than an inch or two larger in diameter than the plant's root ball. Growing in a larger pot results in the soil staying too wet, increasing the chance of root rot.

Select a quality potting mix that holds moisture but drains well. Cacti and succulents prefer a fast-draining mix while tropicals and African violets prefer a mix that stays moist, not soggy, yet drains well.

Set your plant in a location that's free from drafts of hot and cold air, but in the preferred light conditions. An east- or west-facing window usually provides adequate light for most plants. Keep cacti, succulents and other plants requiring

high light within two feet of an east- or west-facing window. Pothos, philodendron, Chinese evergreens and those that tolerate low light can be placed near a north-facing window or up to six feet back or off to the side of an east- or west-facing window. Shears, awnings and trees can impact the light reaching your plants. Adjust their location as needed.

Always water thoroughly and pour off the excess water that collects in the saucer. Allow the top few inches of soil to dry before watering drought tolerant plants like cactus. Water tropical and flowering plants that prefer moist conditions when the top few inches of soil are barely moist, like a sponge that has been wrung out.

Reduce maintenance and improve plant health with gravel trays. Fill a tray or saucer with pebbles. Allow excess water to

collect in the tray. The pebbles keep the pot elevated above the water to avoid root rot. As the water evaporates it increases the humidity around the plant.

When pest problems occur, consider an organic approach safe for people, pets and plants. Manage fungus gnats, those tiny fruit fly like insects found flitting around the house, with a naturally occurring bacteria, Bacillus thuringiensis israelensis, found in Summit Mosquito Bits (SummitResponsibleSolutions.com). Just sprinkle on the soil surface and repeat as needed until these pests disappear.

Mites, aphids, scale and mealybugs can be controlled with an organic horticulture oil like Summit Year-Round Spray Oil. This product coats the pests and kills all stages from egg to adult. Repeat as needed to control any that were missed. Once the pests are managed, check the growing conditions and make needed adjustments to the growing environment.

The more plants you grow, the easier it becomes and soon enough you may find yourself immersed in a tropical or desert paradise inside the comfort of your own home.



The Great Molasses Flood of 1919

Reaches Century Mark

World War I was in full swing, prohibition enforced, and demand for industrial alcohol and munitions were high.

Commercial Street in Boston's North End was at its usual weekday hustle and bustle, when at approximately 12:40 p.m., on Wednesday, January 15, 1919, at Purity Distilling Company facility (a subsidiary of United States Industrial

Alcohol, purchased in 1917), 529 Commercial Street (between Copp's Hill and Langone Park) was producing mass productions of alcohol and munitions. With frigid temperatures days before and a quick warm-up to above 40°F, the molasses holding tank, reportedly built hastily four years earlier, buckled under the pressure of being recently filled to capacity and the thawing of the elements split apart releasing 2.3 million gallons of molasses at 35 miles per hour into the streets destroying.

It is rumored that at least one employee of USIA warned of the imminent danger.



the solid steel supports of the elevated train platform snapped into pieces.

Molasses fermented can produce rum and ethanol, the active ingredient in other alcoholic beverages and a key component in the manufacturing of munitions.

The Boston Globe would later write that the force of the molasses wave caused buildings to "cringe up as though they were made of pasteboard."

Engine 31 firehouse was knocked clean off its foundation, causing its second story to collapse into its first where one firefighter lost his life. The nearby Clougherty house was swept away and dashed against the elevated train platform.

First responders arrived within minutes, along with 100+ sailors from the nearby Navy ship USS Nantucket. Wading through the hardening molasses rescuers pulled survivors out of the sludge.

When the molasses finally receded the destruction was evident that lives had been claimed and major damage to the local infrastructure had



Saint Edmund Arrowsmith

Bryan Arrowsmith was born at Haydock, Lancashire, England, in 1585. He was the eldest child of Robert Arrowsmith, a yeoman farmer and Margery Gerard. He was baptized Brian, but always used his confirmation name of Edmund. The family was constantly harassed for its adherence to Catholicism.

In 1605, at the age of twenty, Edmund left England and went to the English College Douai in France, to study for the priesthood. He was soon forced to return to England due to ill health, but recovered and returned to Douai in 1607. He was ordained in 1612 and sent on to the English mis-

sion the following year. He ministered to the Catholics of Lancashire without incident until about 1622, when he was arrested and questioned by the Protestant bishop of Chester. He was released when King James ordered all arrested priests be freed and he joined the Jesuits in 1624.

He was once again arrested in 1628 when betrayed by a young man he had censored for an incestuous marriage. He betrayed him to a Justice of the Peace who instantly issued a warrant by which he was apprehended on the highway. He was jailed for refusing the oaths of Supremacy and Allegiance and upon the strong suspicion that he was a priest and Jesuit.

Arrowsmith was convicted of being a Catholic priest, sentenced to death, and hanged, drawn, and quartered at Lancaster on August 28, 1628. He was canonized as one of the Forty Martyrs of England and Wales by Pope Paul VI in 1970. The feast day of Saint Edmund Arrowsmith is August 28th.

From 1628 to the present time, there has been a continuous history of miracles worked through his intercession and relics.



Silence is Golden with

SMALL MOUTH SOUNDS

at SpeakEasy Stage

As Bess Wohl's unique play Small Mouth Minds now playing at the SpeakEasy Stage it begins, when six people arrive at a resort in the country for a "silence retreat." The set is a yoga studio with a small platform toward the rear with six chairs. As each participant arrives they take a yoga mat and find some space on the floor. With the exception of two friends who arrived together, they have never met before. There is some dialog at first, but then the "Teacher" who remains unseen throughout the play speaks to them via a speaker. They are given a list of rules that include no talking for the time they are there. This makes for an original, funny, and touching play. Her telling of the Frog Parable is a riot.

With few exceptions, the actors perform without speaking a word. They do not do mime, but rather resort to doing what we all would do; they improvise ways of communicating without speaking. At times this is like being in a country where you don't speak the language and are asking for directions. Beyond that, they also convey emotions with body language and facial expressions, some are extremely funny, others very

Watching as they struggle to at first overcome the awkwardness of sharing space with strangers, something that goes with gatherings such as this, while not being allowed to communicate is a bit uncomfortable. It is something we have all had to deal with at one time or another, though usually not with the restriction on speaking. Of course, awkwardness does make for funny moments. Angry, puzzled, and inquiring looks are exchanged. The personalities of the characters are quickly revealed, while the emotional suffering that brought each one there is not brought out until much later.

Ironically, the one character with the most lines, the Teacher (Marianna Bassham) remains unseen. The tone of her voice moves from New Age guru to prison warden to frustration and emotional pain throughout the play. The one who is there to teach how to deal with inner turmoil has much of her own.

The name of only one of the six was revealed in the course of the play, but they are all named in the program. There is Ned (Nael Nacer) who never takes his hat off there is a reason for this that is part of his story, Joan (Kerry A. Dowling) and Judy (Celeste Oliva) who have come together and are dealing with stress to their friendship/relationship. Jan (Barlow Anderson) who at first doesn't appear to be suffering, Rodney (Sam Simahk) a YouTube yoga celebrity who is going through relationship issues, and Alicia (Gigi Watson) who is young and vulnerable while dealing with a breakup. It is quite remarkable to witness how each is able to convey so much about their character while not speaking. There is a particularly touching moment when Jan reveals to Judy the reason for his suffering. He does this with one simple gesture and yet it is incredibly moving.

The entire cast is excellent, while Nael Nacer is just wonderful with his many facial expressions. I would describe him as a clown in the best definition of the term in that he gives such a broad array of emotions while not speaking. His performance is top notch, and as good as he is while not speaking, he is also the one character outside of the Teacher, who does have a scene where he speaks to some extent. It is a revealing talk about what brought him to the retreat.

There is much that is funny in Small Mouth Sounds as well as much that gives reason to reflect. The idea of taking an extended period of time away from distractions such as our electronic devices as well as not being allowed to communicate verbally is really quite a daunting thought in our 24/7 social media world. While there is much to laugh at in the play, I sense that to a certain degree the audience laughter comes from their own feelings of discomfort with the silence.

While Small Mouth Sounds is somewhat of a parody of New Age style retreats, it is also a reminder that maybe we should spend more time in quiet thought and accept that we can be comfortable with ourselves while facing our inner pain.

Director M. Bevin O'Gara must have felt it a challenge to direct a work that relies almost entirely on body language, but she pulls it all together. Whether you are comfortable sitting in the lotus position on a yoga mat or think this sort of stuff is only for granola eating Cambridge types, you will enjoy this play. By the conclusion you will not be able to help yourself from doing some self reflection. You'll also be smiling and glad that you had seen this moving and thoughtful play.

Nanna & Babbononno

A Nostalgic Remembrance



It was a cold snowy January in 1956. Dad had gotten a call from a friend in Augusta, Maine. It seems that there was a major snow storm that hit Maine's capital and our cottage was in the nearby town of Winthrop. Winthrop, Maine had, at one point, a Ford plant and a couple of factories, but by the mid '50s, they were ready to close. As a result, the only real economy in the town happened during the summer when the seasonal residence were back. The town was situated on the south side of Lake Maranacook. The road we lived on, Memorial Drive, had mostly summer cottages on the lake side of the road and local residents on the other side. When Emil Andy called, it was to say that he swung by the lake to check on three places, ours, Mike Barca's place and Emil's brother-in-law's place. Mike was Dad's best friend from his days working for the Boston schools. He and Mike were two of the four pioneers in the Department of Audio/ Visual Education. As two men with Italian last names, they gravitated toward each other at a point in time when they were in the minority. Mike had married a woman from Maine and they built a cottage on Lake Maranacook back in the '40s. Due to the friendship that developed between Mike and Dad, the families came to know each other and we were invited to their summer cottage several times, a main reason for us buying a summer cottage a few doors away, right on the lake. Next to Mike's place was Emil's brother-in-law's place. Lionel Lemeux was a writer for the Lewiston Sun, a local daily newspaper in that part of Maine. Emil and Lionel, or Lal, as everyone called him, headed to the lake to check out the cottages after a major January snow storm.

Emil told Dad that when they got to our place, they couldn't find it. It was covered with snow drifts, and the snow from the roof in back of the cottage slanted right out toward the middle of the frozen lake. As a result, Dad decided that we should head to Maine to see if there was any damage to the place. The same storm had hit Boston, but northern New England had gotten a real "Nor'Eastah," and they were snow bound. Emil also said that the roads were clear and easy to travel on but we had to be cautious. He advised Dad to pull the antenna of the car all the way up and attach a red banner to the top. If we stopped at a Maine intersection, the snow might be so high that the only way a driver in a vehicle coming from the right or left might know we were there behind a snow mound was to look for the red flag. We packed our warmest clothes and Dad, Mom, Nanna, Babbononno and I climbed into Dad's '54 Chevy and headed north.

Of course, part of Babbononno's things included a gallon of Zi'Antonio's best homemade red wine. He had become friendly with one of the locals, a man called "Old Vic" by the town's people. Vic Gordon was around Babbononno's age and the two had hit it off a couple of summers earlier. Vic had a thick Maine accent and Babbononno spoke fractured English. The wine would allow them to understand each other without a problem.

We headed north picking up the Maine Turnpike just outside of Portsmouth, New Hampshire and continued toward Augusta. A mile or so out before the Lewiston-Auburn sign was the sign for Winthrop and we headed on the local roads arriving at Mike Barca's cottage within a half hour of when we planned to be there. When we arrived, the house was filled with several families, Mike, his wife, Nara, her parents Ed and Ma Mascal, Emil Andy, his wife, Irene, their three children, Lionel Lemeux, his sons, and the Gordon family from across the street. They were all waiting for us. After coffee, tea and a couple of drinks, we headed to our place, called Frosty's Point. When Dad bought the place the original owner gave Dad a discount on the price if he would keep the same name it had had for a couple of generations. Seeing most of the summer homes had names, Dad kept the tradition going which was part of the acceptance of the Christoforo family as part of the local summer scenery.

We bundled up again and walked to our place which was about 100 yards from Mike's cottage. Dad, Mike, Emil and I began shoveling a path from the road, and then the snow away from the front door. It took a long time as the snow was several feet high. The door was frozen shut and Emil and Mom began cleaning snow away from a kitchen window that was just to the left of the door. The window wasn't locked and Mom climbed inside followed by her favorite son (me). With us pushing from the inside and Dad pulling from the outside, we finally opened the door.

Mike had brought a wagon filled with dry firewood with him and he and Dad stuffed the potbelly stove with whatever would fit and then lit the fire. Emil had brought a ladder from Mike's place, set it up, climbed on the roof, cleared snow from around the chimney and we closed up and headed back to Mike's place, planning to return within an hour or so when the cottage had warmed up.

We walked back to Mike's place where Nara, her mother, and Nanna had prepared dinner for everyone. Babbononno and Old Vic had put a good dent in the gallon of wine and were singing two different songs, Vic's in English and Babbononno's in Italian. When we returned to our place a couple of hours later, the heat from the stove had melted a lot of the snow from the sides and roof of the cottage, enough so that we could see the windows and the back porch. When we entered, the place was quite warm. Mom and Nanna made up the beds and we slept there over

One of the Gordon kids, Old Vic's granddaughter, knocked on the front door early the next morning and told us that Mike and Nara expected all of us for breakfast within the hour. We could smell the bacon cooking fifty yards from their front door. As we walked in, Nara yelled that we were having fried eggs with bacon and ham. She had also make buckwheat pancakes from scratch and drowned them in local maple syrup. If you add in the homemade bread, fresh from the dairy butter and a few other Maine delicacies, you had a lumberjack's breakfast. Nanna had two pots of coffee waiting, one American and one Italian. It was a feast.

We decided to wait for a while and then head back to Boston. Dad, Emil, Mom and I headed back to our cottage which now was completely visible due to the heat from the stove melting the snow. Mom packed up the bed linens and the rest of the clothes and things we had brought from Boston. We headed back to Mike and Nara's place for a thank you and to say goodbye, which took about a half hour. It was quite an experience for all of us and we talked about the folks all the way home, referring to them as if they were family. Maybe, in a sense, they were, 60 something years ago.

Recipes from the Homeland

Cabbage & Pork Chops

4 pork chops

1 medium onion chopped

3 ripe plum tomatoes or 8 oz.

canned crushed tomatoes 2 dry bay leaf sprigs

2 small garlic cloves chopped (optional)

1 small head of cabbage

3 carrots

3 potatoes

1 cup of water

1/3 cup olive, canola or vegetable oil

Salt and pepper

In a twelve-inch saucepan, heat oil and carefully add pork chops. Brown chops lightly on both sides. Remove them from saucepan and set aside on a platter. Add chopped onion to the saucepan and simmer until onion is about to brown. Add bay leaves, garlic and cut-up or crushed tomatoes. Stir and cover. Simmer over low heat for about fifteen minutes.

Meanwhile, clean and wash carrots. Cut carrots into four-inch lengths and set aside. Peel potatoes and wash. Cut into wedges of one-inch thickness and set aside. Remove soiled or spoiled outer leaves of cabbage. Wash and cut into four or five portions. Set aside.

After tomato mixture has simmered for fifteen minutes, add one cup of water and stir. Add the chops and carrots. Cover and bring mixture to a slow boil. After ten minutes, add the cabbage. Ten minutes later add the potatoes. Additional water may be added if needed. Salt and pepper to taste. Cover and cook over medium/low heat until vegetables are tender.





It's all about you — Don't accept any advice from an advisor that does not put you first. There are advisors that push products that offer them a high commission but eat up your return. To avoid this situation all together, hire a fiduciary. A fiduciary has a legal obligation to put your financial well-being ahead of his interest.

Advisors help you create realistic financial goals — A good advisor will give you the correct answer, not the answer you want to hear. Remembering Jerry Quarry

Great Heavyweight Passed Away

20 Years Ago

January 5th marked twenty years since the untimely death of Jerry Quarry. Quarry competed in what many consider to have been the most competitive era in heavyweight boxing history, the mid '60s through the '70s.

Quarry was born in 1945, in Bakersfield, CA, to a boxing family and had his first fight at the age of five. He won his first title, the Junior Golden Gloves at the age of ten. He would compile an amateur record of 170 wins and 13 losses before turning pro at the age of 19 in 1965. He went without a loss in his first 20 fights before dropping a decision to the veteran Eddie Machen.

After the loss to Machen, Quarry went ten more bouts without a loss including a draw and a win over former champ Floyd Patterson, as well as wins over Alex Mitiff, Thad Spencer, and Billy Daniels. His next loss would be by decision to Jimmy Ellis in a fight for the vacant WBA Heavyweight Championship in 1968.

Quarry would get another shot at a piece of the Heavyweight title in 1969, when he challenged Joe Frazier. Frazier defeated Quarry stopping the game challenger for the first time in his career.

Once more Quarry came back compiling wins over Brian London, George Johnson, and the murderous punching Mac Foster. He was stopped by George Chuvalo in a fight where he was decked by a seemingly light punch and misjudged the referee's count. The win over Foster came after the Chuvalo fight and Quarry was then chosen to be the man to face Muhammad Ali in 1970, when Ali made his comeback after being in exile.

Once again, Quarry couldn't win the big fight losing because of a cut eye after the 3rd round. Quarry would earn a second shot at Ali 2 years later being stopped once again, this time in the 7th round.

He would also get a second chance at Joe Frazier in 1974, but lost again, this time in the 5th round.

Unfortunately, Quarry is best remembered by most for these losses, but he compiled some outstanding wins in between. His first round knockout of Earnie Shavers was perhaps his best performance along with the boxing lesson he gave to the undefeated Ron Lyle. Add in his win over Mac Foster who was

also undefeated with a record of 24 straight knockouts, and you will see how Quarry could handle the big punchers. It would

have been interesting to have seen him against George Foreman. It has been said that Foreman avoided him. That would make sense.

After the second loss


to Frazier things headed downhill for Quarry. He took a terrible beating in a losing effort against Ken Norton. He struggled to beat

Lorenzo Zanon in 1977. Quarry retired after the Zanon fight only to comeback six years later to compete as a cruiserweight winning over Lupe Guerra in just 36 seconds of the first round. He had

one more fight, a close win over James Williams, before retiring again.

At this point he was showing signs of brain damage from all his years in the ring. In 1992, he fought one last time losing a decision to Ron Cranmer. Quarry was 47 years old and should never have been allowed to fight.

HOOPS and HOCKEY in the HUB

A RETURN FROM WISCONSIN Just back from our annual 2,400 mile round trip drive to spend the holidays with relatives in the Badger state. It was the best drive ever with no snow on the way out or on the way back. We noticed that gasoline prices were quite a bit lower than here. Regular sold for \$1.81 a gallon near Rockford, Illinois. As we drove along in Indiana on the way back, we saw a sign displaying a price of \$1.78 a gallon. On the New York Thruway, the price was \$2.64.

TRAIPSING THROUGH THE TUNNEL — We decided to take the new tunnel that connects North Station with the Orange and Green subway lines shortly after we returned. We were a bit surprised to notice what appeared to be numerous cracks in the flooring. Several spanned the entire width of the corridor. One even had a gouge about the size of a half dollar. These imperfections were smoothed over. There was no chance of tripping.

Indeed, the flooring itself was shiny but offered no traction. While this, in itself, would not be a problem on a dry surface, we wondered about bad weather days when wet foot traffic might make the surface slippery especially since the walk from North Station to the subway entrance features a slight downward pitch. It's not steep but just enough to be cautious about. Other than, on a stairway at the start, there aren't any handrails for the length of the tunnel proper. So be careful.

RESOLUTE IN THE NEW YEAR — That just might describe the Boston Celtics and Boston Bruins, who through the first eight days of 2019 had won all their games in the New Year.

The Celtics had bagged three victories and those, coupled with another three victories since December 23, gave the Celtics an enviable 6-2 mark over the course of an extended holiday season that included a five-game home winning streak on the parquet. Those five home triumphs marked the longest home winning streak of the season for the Green and enabled them to increase their home record to an enviable 14-5 as the NBA neared the midpoint of the campaign.

Indeed, the Celtics remained hot as January reached its middle stages. In those three games, the C's actually outscored their opponents in 11 of the 12 quarters played. Their defense also has been worthy of respect. In the January 8 contest against Brooklyn at the Garden, the C's held the Nets to 95 points, marking the second straight time in 2019 that they held an opponent under 100.

The Celtics also featured balanced scoring in that contest with eight players placing in double figures. One might think that is a common occurrence in the NBA but it isn't. It marked the first time in over just over three years (December 9, 2015) that the Celtics were able to distribute the scoring among that number of players.

"We didn't play anybody above 27 minutes so a lot of people played a bit more," explained head coach Brad Stevens. "We're trying to get better at executing and playing together. We

continue to prioritize playing together. We're getting better as a group. If we do that we should get better."

The recent stretch of success pushed the Celtics over the .600 mark and into fifth place in the Eastern Conference standings. Of course, there is the potential for quite a bit of movement between now and the end of the season in April. So, we'll see how things work out.

Meanwhile, out on the ice, the Bruins were also extending their winning ways, putting together their longest winning streak of the season — five games—since December 29. It was their longest such streak since a fivegame victory span during late February and early March of last season.

"We just remind the players how we want them to play," noted head coach Bruce Cassidy in his postgame press conference. "It's a little bit easier sell in January than maybe in October or November. As the year goes on guys are understanding how valuable the points are and how we want them to play. We've talked about how we're in the second half (of the season) now. We're also getting somewhat more healthy."

Brad Marchand feels the key has been finding different ways to win. "Every game that we have won--the last five games - hasn't necessarily been our best but we're finding ways to win. Ultimately, at the end of the day in an 82-game season you need that. You can't expect to be perfect every night. But if we can continue to find ways to win then it's going to help us reach our end goal — the playoffs."

In the last game before press time, a 4-0 win over Minnesota at the Garden, goalie Tuukka Rask notched his 250th career win. It was his first shutout of the season and the 42nd of his NHL career.

"It's 250 wins with more to go, I guess," stated Rask after the game. "I've been lucky enough to be part of good teams and that's pretty much what it comes down to, I think. I've been fortunate to play here."

The veteran netminder also spoke of the attitude the team needs to bring to each game as the race for the playoffs begins in earnest. "We kind of want to get off to good starts and play with the lead because that's something you need to be able to do, come springtime. We don't want to be chasing games every night. We didn't let that happen against Minnesota."

Patrice Bergeron echoed the importance of getting off to a good start in every game. "We talked about that in practice. It's definitely needed. When you do that, you kind of set yourself up for a good rest of the game and you're usually in a good position. If you get a good start you have the momentum your way and good things happen."

At press time, the Bruins stood in third place in the Atlantic Division and tied for fourth in the Eastern Conference standings. Similar to the Celtics, quite a bit of movement is possible between now and the end of the regular season. But both teams are in good positions right now.
