Remembering the Great Molasses Flood

To the uninitiated, mentioning a Great Molasses Flood might conjure up cartoonish images of molasses flowing through the streets. But to those in Boston and more specifically the North End, the molasses flood was no joke. Ninetyfour years ago, on January 15, 1919, a disaster befell the city the likes that hadn't



been seen before.

It started at the Purity Distilling Company's facility which, through the distillation of the molasses into alcohol, produced ethyl alcohol. A tank on Commercial Street, holding about 2,300,000 gallons of molasses, collapsed on that moderately-temperatured January day, sending molasses gushing through the streets

with such force that the girders and railway lines at Boston's elevated railway on Atlantic Avenue were damaged. 26,000,000 pounds of molasses barreled through the streets at about 35 miles per hour. Witnesses recall hearing what sounded like machine-gun fire (which turned out to be the rivets

GENERAL CONSULATE OF ITALY - BOSTON

2013 GENERAL ELECTIONS

Pursuant to Presidential decree n. 226 of December 22, 2012, elections will be held on February 24 and February 25, 2013 to elect representatives to the Chamber of Deputies and to the Senate of the Republic. In Italy, voting at the polling stations will take place on Sunday, February 24th (from 8:00 a.m. to 10:00 p.m.) and on Monday, February 25th (from 7:00 a.m. to 3:00 p.m.).

Outside of Italy, Italian citizens residing abroad who are registered voters in the Overseas District may vote **by correspondence**. They can do so by casting their vote for the candidates listed on the ballot for the "Circoscrizione Estero" (Overseas District).

All voters residing abroad will receive a packet by mail before **February 6**th from the Consulate General of Italy in Boston containing: an instruction sheet on the voting procedures, the electoral certificate, a ballot (two for voters over the age of 25, therefore eligible to vote also for the Senate), one blank white envelope for the ballots, a stamped envelope bearing the address of the Consulate General of Italy in Boston, and the list of candidates for the Electoral zone of residence.

The stamped envelope containing the ballots, completed as indicated by the instruction sheet, must be sent by mail as soon as possible in order to reach the Consulate General of Italy in Boston by - and no later than - 4:00 pm on February 21st.

The vote is personal and secret. Voting more than once or voting on another's behalf is prohibited. Violators of the law will be punished to the fullest extent of the law.

Voters who have not received a complete packet by February 10th should contact the Consulate General of Italy in Boston to verify their electoral status and, if necessary, request a duplicate.

L'elettore, utilizzando la busta già affrancata e seguendo attentamente le istruzioni contenute nel foglio informativo, dovrà spedire SENZA RITARDO le schede elettorali votate, in modo che arrivino al Consolato Generale d'Italia a Boston entro - e non oltre - le ore16.00 del 21 febbraio.

THE HANGING GARDENS

The Seven Wonders of the World is the name given to two separate groups of buildings or works of art. Texts list the Wonders of the Ancient World and also the Wonders of the Modern World. The Hanging Gardens of Babylon are listed in the first group. They occupied about one hundred sixty thousand square feet of space in the huge complex that was the palace of King Nebuchadnezzar. The gardens were actually a series of terraces which were constructed one above the other. Each terrace was supported on huge brick arches bringing the total height of the structure to

city walls. The ascent tion including vines which between terraces was by ten foot wide stairs.

The terraces or garden areas were constructed on a base of huge flat stones four feet wide and sixteen feet long. Over this base was set a layer of reeds mixed with great quantities of bitumen. Next came two layers of bricks closely cemented together. All of this was then covered with thick sheets of lead (lead is mentioned in the Old Testament and is one of the first metals known to man). The lead was then covered with a layer of earth which was thick enough for large trees to take root. All of the terraces were covered about three hundred feet with trees, shrubs, flowers and equal to the height of the and plants of every descrip-

hung over the edges. Water for irrigation was raised from the Euphrates River below by an innovative type of screw pump. Several magnificent apartments were located in the spaces between the arches at the various terrace levels.

The wife of Nebuchadnezzar was a beautiful woman who came from the Country of Media and her name was Amyitis. The king built all of this as a gift, and to help alleviate the longing she had for her native land. He certainly was a generous and thoughtful husband. What have you men done for your wives lately?

Lincoln and King: Freedom and Equality

With 12 Oscar nominations, Steven Spielberg's Lincoln has been nominated for more Academy of Motion Picture Arts and Sciences awards than any other motion picture of 2012. The picture is a dramatization of the rounding up of votes, in the United States House of Representatives, to pass the 13th Amendment to the Constitution. The amendment passed by the necessary two-thirds vote of both the House and the Senate and was on its way to ratification by the necessary three-quarters of the States when Lincoln was assassinated on Good Friday, 1865.

Getting the amendment through the House (it had passed easily in the Senate) was a major effort, told in an engaging manner in the movie. Permanently ending slavery in the U.S. by means of Constitutional Amendment was, for Lincoln, an imperative. His Emancipation Proclamation, issued 150 years ago this month, did not free all slaves, being restricted to those in rebellious areas not under the effective control of the United States. Furthermore, as a proclamation based on Lincoln's wartime powers as Commander in Chief, it was uncertain how, or even if, it would have force once peace was concluded.

Limited as it was, the Emancipation Proclamation was the first step in what became an irreversible path toward, first freedom, and later equality, for Americans of African ancestry. In August of 1863 Giuseppe Garibaldi wrote from Italy to President Lincoln, declaring: "Posterity will call you the great emancipator, a more enviable title than any crown could be, and greater than any merely mundane treasure."

The Thirteenth Amendment made African-Americans free. The subsequent Fourteenth (application of the civil rights of U.S. citizens to the States) and Fifteenth (right of African-Americans to vote) promised to settled the question of equality. In reality, they marked merely the beginning of the quest for equality of all Americans. It would not be until the civil rights movement of the middle twentieth century that the rights guaranteed by the 14th and 15th Amendments would be effective in every State.

Monday we honor the memory of Martin Luther King, Jr., whose advocacy for nonviolence was essential to the success of the civil rights movement. Like Lincoln, King was assassinated (April 4, 1968) and, like Lincoln, King continues after death to inspire others to carry on the quest for freedom and equality.

shooting out of the collaps- keeping curious onlookers ing tank) while the ground quaked as if a train were passing by. Buildings in the area had their foundations swept out from under them and many city streets were flooded in up to three feet of molasses. Among the wreckage it would eventually be discovered that twenty-one people died during the flooding, varying in ages from 10 to 76 years old. The disaster didn't discriminate. Young children, older men, housewives and laborers alike lost their lives that day.

The tragedy could have been even worse if not for the USS Nantucket being docked at the nearby Navy Yard. Moments after the flooding began, cadets from the training ship arrived by foot in the North End and began pulling people out of the molasses to safety while


at bay during the rescue. Eventually, other members of the Navy, Army, Red Cross and the Boston Police Department arrived to take on the search and rescue mission. They spent four days looking for the bodies of victims with the hope they would find more survivors as well. Thanks to the large number of people involved in clean-up efforts, it ended up taking about two weeks to remove all the molasses. For months after the flood, you could still see the brown of molasses seeping through the Boston Harbor.

In looking for reasons for the disaster, it was found that the collapsed tank was constructed poorly. That issue, coupled with the fact that the temperature that day rose from two degrees all the way to forty-one degrees,

is what is believed to be the reason for the collapse and flood. The United States Alcohol Industrial Company, which owned the Purity Distilling Company, was found responsible for the tragedy and, after three years of hearings, eventually was forced to pay approximately \$600,000 in costs to victims of the flood.

The Great Molasses Flood might be an obscure footnote in the history of Boston to some, but it is still very much in the memories of the residents of the North End. In 2003, local author historian Stephen Puleo's book Dark Tide: The Great Molasses Flood of 1919, in which he gives the first full account of the flood, was published to national critical acclaim, even becoming a finalist for the prestigious Julia Ward Howe Award for literary merit. To further ensure the tragedy is never forgotten, at the site of the flood, located where now stands the Langone and Puopolo Parks, the Bostonian Society placed a memorial plaque which reads:

"On January 15, 1919, a molasses tank at 529 Commercial Street exploded under pressure, killing 21 people. A 40-foot wave of molasses buckled the elevated railroad tracks, crushed buildings and inundated the neighborhood. Structural defects in the tank combined with unseasonably warm temperatures contributed to the disaster."

Banning All Guns is Un-American

On Thursday, January 10th, Lucia (Verrocchi) Frattaroli passed away, surrounded by the many members of her loving and supportive family. But she will be forever remembered by her family as a loving, kind, devoted and strong matriarch.

Born in Sulmona, Italy, Lucia was the third of seven children born to Donato and Maria Carrolina Verrocchi. In 1949, she married Arturo Frattaroli and in postwar Italy she raised four sons and a daughter. Growing up she endured fascism,

a World War and the German occupation of Sulmona and these hardships only proved to make her a stronger person, especially when first her husband left for America, followed by two of her sons. It was more than a year after her husband left for the U.S. that she joined him, bringing her voungest son and daughter but leaving behind her oldest child who had already begun a family of his own. Once the family opened Lucia's Ristorante, she

Happy Trails to Boomtown's Rex Trailer



I liked watching episodes of Roy Rogers, Gene Autry, Hopalong Cassidy and the Lone Ranger, but Rex was live TV. He was from Boston. I loved his horse Goldrush who looked like Roy Roger's horse "Trigger." Rex had a goofy partner named Pablo whose horse was a mule whose name I never knew.

Every Saturday morning, my brother and I would get up, get breakfast and sit-down in front of the TV set for a few hours of Boomtown. I never went on the show but always wanted to. I met him a couple of times. Once he came to my grammar school on the back of a hook and ladder for Fire Prevention Week one October. I still remember the sight of seeing Ladder 3 coming down Thorndike Street to St. Rita's School in Roxbury with Rex near the tiller in the truck's rear-end. The last time I saw Rex Trailer was this past October at the East Boston Columbus Day Parade. He still had that big cowboy smile of his. He enjoyed the day surely as everyone especially older folk like me remembering our younger days when he was Bos-ton's King of the Cowboys.

Rex Trailer rode into town back in 1956 when his TV show went off the air in Phila-



delphia. He could have chosen Cleveland over us but he always loved Boston. He stayed here until he passed away on January 9th with loved ones surrounding him. I am so glad I got to say my good-byes to him this past October at the parade. He made me feel so good over the years. I hope my kind words at the parade made him feel good

L'Anno Bello: A Year in Italian Folklore

Moonstruck

Perhaps because I was born under the zodiac sign of Cancer, protected by the la luna, I have always had a special connection with the moon. At a young age, I feared the moon, viewing her as mysterious and distant, not at all bright and warm like the sun. However, as I grew older, I developed a true appreciation for the moon, a love which extended on many levels. As a woman, I feel a kinship with the folkloristic tendency, present in many cultures, to associate the moon with a female deity. In ancient Rome, the moon was associated with several goddesses: the huntress Diana, the mother Juno, and Luna, the moon personified. I always swell with pride over the fact that the moon, which possesses a force so powerful as to influence ocean tides, relates to feminine strength and clout. As an observer of the nature, I admire the way moonlit nights form a counterpoint to days when the sun shines brilliantly, bidding the world to sleep with their stillness and gentle light. Finally, I just think that moon is beautiful. Whether she appears as a full, silver orb suspended in a velvety dark sky, or a thin crescent obscured by swirling black clouds, she is always a commanding yet subtle presence in the night.

My father used to sing a cheerful Italian melody

which intoned: "La luna, la luna, ti portará fortuna" meaning "the moon will bring you luck." I always saw the moon as a lucky entity, shivering with excitement when the first faint disk of the moon appeared on a perfectly blue and gold evening sky. Indeed, the moon figures heavily in the world of superstition. The most famous tidbit of lunar folklore involves the power of the full moon to stir passions and events, both good and bad, in the world. During my first year student teaching, I had a conversation with a coworker following a tough week in which he told me that the students were acting wilder than normal due to the presence of a "supermoon" or an unusually large full moon. Other moon superstitions abound, including many that concern themselves with the waxing or waning periods of the lunar cycle. Cutting your hair during a waning moon will insure that it stays short for awhile, just as the moon will take a longer time to grow again. Getting married during a waxing moon assures good fortune because as the moon enlarges in the sky, so will the love and the happiness of the couple. It is all too easy to dismiss superstitions, but rather than believing in their admonishments, it is more important to ponder why these sayings exist. In the case of

the moon, the superstitions speak to her mysterious ability to diminish and grow in the sky, to her juxtaposition of life-saving light and deep darkness.

The full moon in January always appears larger to me, more mystical. Perhaps this is because January's full moon is the first full moon of the year, a beacon of hope and promise for the next months to follow. This may also be because I always viewed the nights of January as elegant and sophisticated, poised between the precipice of winter and spring, cold and still. After all, January crackles with the magic of a changing season and the sight of the serene January moon perfectly encapsulates these mysterious nights. The feast day of Saint Agnes, or Sant'Agnese in Italian, falls on January 21^{st} and calls upon the magic of the month. In Rome, il Giorno di Sant'Agnese, or St. Agnes' Day, is devoted to the blessing of sheep, probably due to the fact that the name Agnese sounds like agnello, the Italian word for lamb. 

Saint Wulstan, Bishop

Saint Wulstan, who was one of the most outstanding figures in the religious history of England, was born in the village of Itchington, Warwickshire about the year 1009; he was the son of Athelstan and Wulfgeva. During his youth, he studied at the monasteries of Evesham and Peterborough. Wulstan became a Benedictine monk spending 25 years in a monastery at Worcester where he became Prior; he was highly regarded for his humility and asceticism. As a monk he was very popular and regarded as exemplary as a man of holiness by his brothers. His austere life style included little sleep and spending great lengths of time worshiping at the foot of the altar.

In 1062, he reluctantly became Bishop of Worcester only a few years before the Norman invasion. As Bishop, he was known for inspirational preaching, great humility and asceticism. He was an effective administrator and one of the first bishops in England to make pastoral visits to the parishes of his diocese. Together with Lanfranc, Archbishop of Canterbury, Wulstan was influential in ending the slave trade that existed between England and Ireland.

It was he who initiated the building of the present Worcester cathedral which began in the year 1084. Wulstan assisted William I against his Barons who were in revolt and William II against the Welsh and refused to resign as Bishop during the reign of William the Conqueror.

Saint Wulstan died on January 19, 1095 after serving as Bishop for 34 years. His tomb at Worcester Cathedral became a place of pilgrimage for centuries until it was destroyed by order of Henry VIII. His feast day is celebrated on January 19th.

Winter Pet Care

how long your pet should be out this winter, ask your veterinarian.

Cats will curl up against almost anything to stay warm including car engines. Cats caught in moving engine parts can be seriously hurt or killed. Before you turn your engine on, check beneath the car or make a lot of noise by honking the horn or rapping on the hood. If you live near a pond or lake, be very cautions about letting your rambunctious dog off the leash. Animals can easily fall through the ice and it is very difficult for them to escape on their own. If you must let your dogs loose near open water, stay with them at all times.

If you light a fire or plug in a space heater to keep your home toasty warm, remember that the heat will be as attractive to your pets as to you. As your dog or cat snuggles up to the warmth, keep an eye out to make sure that no tails or paws come in contact with flames, heating coils or hot surfaces. Pets can either burn themselves or knock a heat source over and put the entire household in danger.

It's a good idea to have your furnace checked for carbon monoxide leakage before you turn it on, both for your pet's health and your own. Carbon monoxide is odorless and invisible but it can cause problems ranging from headaches and fatigue to trouble breathing. Pets generally spend more time in the home than owners, particularly in the winter, so they are more vulnerable to monoxide poisoning than the rest of the family.

Pets that go outside can pick up rock salt, ice and chemical ice melts in their foot pads. To keep your pet's pads from getting chapped and raw, wipe her or his feet with a washcloth when she sense: long-haired breeds or he comes inside. This will also keep her or him from licking the salt off her or his feet which could cause an inflammation of her or his digestive tract.

> If left alone outside, dogs and cats can be very resourceful in their search for warm shelter. They can dig into snow banks or hide under porches or in dumpsters, window wells or cellars and they can occasionally get trapped. Watch them closely when they are loose outdoors and provide them with quality, easily accessible shelter.

Keep an eye on your pet's water. Sometimes owners don't realize that a water bowl has frozen and their pet can't get anything to drink. Animals that don't have access to clean, unfrozen water are more likely to have any questions about drink out of puddles or gut-

ters, which can be polluted with oil, antifreeze, household cleaners and other chemicals.

Be particularly gentle with elderly and arthritic pets during the winter. The cold can leave their joints extremely stiff and tender and they may become more awkward than usual. Stay directly below these pets when they are climbing stairs or jumping onto furniture; consider modifying their environment to make it easier for them to get around. Make sure they have a thick, soft bed in a warm room for the chilly nights. Also watch stiff and arthritic pets if you walk them outside. A bad slip on the ice could be very painful and cause a significant injury.

Go ahead and put that sweater on Rosie if she'll put up with it. It will help a little, but you can't depend on it entirely to keep her warm. Pets lose most of their body heat from the pads to their feet, their ears and their respiratory tract. The best way to guard your animals against the cold is keeping a close eye on them to make sure they're comfortable. When you're outside with your pets during the winter, you can watch them for signs of discomfort with the cold. If they whine, shiver, seem anxious, slow down or stop moving or start to look for warm places to burrow, they're saying they want to get back someplace warm. You can also keep an eye out for two serious conditions caused by cold weather. The first and less common of the two is frostbite. Frostbite happens when an animal's (or a person's) body gets cold and pulls at the blood from the extremities to the center of the body to stay warm. The animal's ears, paws or tail can get cold enough that ice crystals can form in the tissue and damage it. The trick thing about frostbite is that it's not immediately obvious. The tissue doesn't show signs of the damage to it for several days. If you suspect your pet may have frostbite, bring her or him into a warm environment right away. You can soak the extremities in warm water for about 20 minutes to melt the ice crystals and restore circulation. It's important that you don't rub the frostbitten tissue; however the ice crystals can do a lot of damage to the tissue. Once your pet is warm, wrap her or him up in some blankets and take her to the veterinarian. Your veterinarian can assess the damage and treat your pet for pain or



In 2008, when the Massachusetts Legislature amended the state's wage laws M.G.L., c. 149 § 148 et seq., it adopted what is perhaps the strictest set of wage laws in the nation. Under the Massachusetts Weekly Wage Law, an aggrieved employee or former employee will recover mandatory triple damages, attorney's fees and costs if he can prove any damages — even as little as \$0.50. In fact, \$0.50 is what led to a amount of his damages (the \$434,655 verdict for an aggrieved former employee earlier this year. With statutory interest of 12% per year, the total recovery is likely to balloon to more than \$500,000.

It began as a minor dispute when David Fernandes, a maintenance mechanic employed by the Attleboro Housing Authority, complained to the Attorney General's Office that he was being undercompensated. At the time he filed his complaint, Fernandes had worked for the Authority for more than eight years but, allegedly, was being paid as much as an entry-level mechanic.

The Massachusetts Weekly Wage Law requires, as a prerequisite to taking any further legal action, that an aggrieved employee file what is commonly called a 'Wage Complaint' with the Attorney General's Office. Routinely, the Attorney General's Office responds to complaints with a 'Private Right of Action Letter,' granting an aggrieved employee the right to file a civil action in court to pursue his claims.

THE FIRST E-MAIL IS NOW PART OF THE SMITHSONIAN **INSTITUTION.** The first electronic message was sent by an Indian (from India), Shiva Ayyadurai in 1978. The Smithsonian Institution has recently acquired the entire documentation of the birth of the e-mail, including the copyrights of the 50,000 expressions/phrases of the computer code, which contain the historical progress of the invention of the computer mailing. Now the entire material is stored at the National Museum of American History. Soon the material can be available online. The inventor, for the record, was only 15 and attending Livingston High School, when he devised the system and later became a scientist at MIT in Cambridge, MA.

THE MONTI GOVERNMENT VIS-À-VIS THE WIDESPREAD **CORRUPTION.** The new government has introduced a new tool aiming at breaking up the "omerta" of the Mafiosi who anxiously want to collaborate with the authorities. Lately there have been increasing examples of individuals involved in "questionable" corruptive activities and have decided to cooperate with the authorities. Why have so many "deep throats," suddenly decided to come out of the cold? perature that is below normal is a condition that occurs when an animal is not able to keep her body temperature from falling below normal. It happens when animals spend too much time in cold temperature or when animals with poor health or circulation are healthy. That's all for now. exposed to cold. In mild cases, animals will shiver and show signs of depression, lethargy and weakness. As the condition progresses, an animal's muscles will stiffen, her heart and breathing rates will slow down and she will stop responding to stimuli. If you notice these symptoms you need to get your pet warm and take her or him to your veterinarian. You can wrap her or him in blankets, possibly with a hot water bottle or an electric blanket, as always wrapped in fabric to prevent against burning the skin. In severe cases your veterinarian can monitor her heart rate and blood pressure and give warm fluids through an IV.



Mumford & Sons consists of Marcus Mumford (vocals, guitar, drums, mandolin), Ben Lovett (vocals, keyboards, accordion, drums), "Country" Winston Marshall (vocals, banjo, guitar, resonator guitar) and Ted Dwane (vocals, string bass, drums, guitar). Mumford & Sons formed in December 2007, emerging out of what some in the media labeled the "West London folk scene" with other artists such as Laura Marling, Johnny Flynn and Noah and the Whale. A reminder! The breakthrough year for women in politics was 1992, thanks to Anita Hill — or rather, the male senators who grilled her. Hill was the lawyer who in 1991 accused Clarence Thomas of sexually harassing her while he was her supervisor. At the Senate hearings to confirm Thomas as a Supreme Court justice, a phalanx of male senators expressed sneering disbelief that sexual harassment existed at all, dismissing Hill's testimony that Thomas repeatedly propositioned her and made lewd remarks as the delusional rantings of a spurned woman. Women were infuriated — and motivated. One year later, more women tried for national office than ever before: 39 women ran for open seats and 22 won. In 2012, 26 women ran in open-seat elections and 14 won. "I really felt that we were paving the way for a huge number of women," said 1992 Senate candidate Jean Lloyd-Jones of Iowa. "But the promise of 1992 was never realized."

Why don't more women run? In brief, women tend not to run until after they have had children, by which time they face opponents with more experience. Women now hold a record 20 percent of Senate seats and more than 18 percent of the House. Why not more?

Women have served in Congress since suffrage activist Jeanette Rankin of Montana won a seat in 1916 — four years before women won the right to vote. The feminist movement of the 1960s brought in a new wave of congresswomen, including Shirley Chisholm, the first African-American elected and Bella Abzug, one of the first to advocate gay rights.

The worst allergy! A 21-year-old dressmaker from York, England, is allergic to people. When she and her husband kiss, the area around her lips gets scratchy and

Bravo! When Joe Lueken retired he could easily have sold his thriving grocery business to a large corporation and reaped the benefits of his 46-year career. But the 70-year-old from Bemidji, Minn., instead decided to transfer ownership of his two supermarkets to his 400 employees. Workers will receive shares at no cost based on how long they've worked for Lueken and the value of the shares will rise if the firm keeps growing. Lueken opted for the scheme after his sons chose not to take over the company. "You can't always take," he said. "You also have to give back.'

Drink up! No! Not booze! Coffee! A cup of coffee may be good for what ails you — including excess fat, cancer, Parkinson's disease, Alzheimer's disease, Type 2 diabetes, stroke or heart disease. Every cup of coffee, whether decaf or caffeinated helps you live a little bit longer, says a study conducted by the U.S. National Institutes of Health in conjunction with AARP. Despite reviewing data from 400,000 people, the researchers aren't sure what makes coffee such a potent elixir because it's such a complex biochemical brew. "This is probably the best evidence we have of coffee's health benefits," says Dr. Frank Hu, a Harvard University professor who reviewed the study results. The study is backed up by other research. For example, drinking coffee after meals can promote a healthy weight. The brew's low in calories and influences digestion. Other studies indicate that regularly drinking coffee can stave off cancers of the skin, colon, liver and prostate. Time for a coffee break. Yes, we drink decaf coffee.

More showbiz stuff from the stately musicologist Albert Natale. Singer Tony Bennett is said to have actually been "discovered" in 1950 by Pearl Bailey and Bob Hope working under the name Joe Bari. Before his obvious success as a country singer, guitarist, songwriter and actor, Merle Travis was a tobacco farmer and coal miner. One of the first songwriter/publisher's on New York's "Tin Pan Alley" was Charles K. Harris. He first received a royalty payment of 85 cents for a hit in 1892, and then formed his own company and soon raking in \$25,000 a week for "After the Ball" and other songs. One more time! When World War II ended, singers became the hit makers. Singers like Frank Sinatra, Dinah Shore, Perry Como and Dick Haymes were selling the records, much more so than recordings by the big bands. Born Alfred Cucozza in Philadelphia in 1921, Mario Lanza took his mother's name as his stage name and became the first vocalist to sell 2.5 million albums and the first singer to receive a gold disc for his recording of "Be My Love." After a legendary recording career (he made 390 records), he went to Hollywood and made 8 movies. Born the same year that Enrico Caruso died, like Caruso, Lanza died prematurely. An embolism struck him down in Rome at age 38 in 1959.

STUFFED GREEN BELL PEPPERS

- 3 Bell Peppers cut length-wise (six halves)
- 3 cups cooked rice of choice* 1 pound ground beef
- 3 eggs
- 1 tablespoon grated Romano

cheese (optional)

Prepare rice of choice according to direction on the rice package. Set aside.

Cut each pepper in half lengthwise. Remove stem and seeds and wash thoroughly. Set aside and allow

In a bowl, mix cooked rice and ground beef. Add two beaten eggs, salt and pepper to taste.

Optional: If preferred, ground beef can be lightly browned in skillet to remove excess fat prior to adding beef to the cooked rice.

Add grated cheese to bowl and mix thoroughly. With tablespoon, fill opening of each half pepper with the rice and beef mixture until all halves have been stuffed. (*Approximately ½ cup cooked rice plus 1½ tablespoon of ground beef is used to stuff each half pepper.)

Beat one egg in a separate bowl. Use pastry brush to spread beaten egg over top of each stuffed pepper.

Heat oil in a skillet. Lower heat before carefully placing three half peppers (stuffing side down) into the skillet. Fry peppers until stuffing browns slowly. With spatula, turn each pepper half over gently. Check frequently to avoid burning. Continue frying remaining peppers in this

Line bottom baking tray or casserole dish with some prepared tomato sauce. Place fried peppers, (stuffing face up) in tray. With tablespoon, spread some tomato sauce over each stuffed pepper. (Optional: Sprinkle grated cheese over each pepper.) Cover and bake in a preheated 350°F oven for about forty minutes. Remove cover and bake until tops brown lightly and peppers are fork tender. (Approx. ten to twenty additional minutes.)

NOTE: My sister-in-law Rose Sinopoli taught me this recipe many years ago. The stuffed bell peppers became a popular food to have available for family gatherings. 

A Nostalgic Remembrance



Once I started teaching in Boston, I decided to travel during school vacations. This meant that, way ahead of time, I would visit a travel agent, book in the desired location, let the band leader I was working with know that I would need a replacement for that vacation week and then just anticipate the arrival of the vacation. I never traveled during the Christmas vacation for several reasons. Number one, I loved being with the family at holiday time. Second, there was too much music to pass up during the Christmas season and third, New Year's Eve, when I could make a week's pay for one night. So, the first possible vacation would be during the February school recess.

The first time I decided to head out on my own was February of that first year teaching in Boston. I and the young lady I was engaged to parted company. It seems that on the nights I was out playing (music) she was out playing, also ... not a good beginning.

I asked Uncle Nick if he could recommend a travel agency and a contact person that he and Aunt Dorothy used when they traveled. He gave me the number of the agent they used at Colpitts Travel Service in Boston. I called the agent they used and we met a day or two later. He showed me dozens of flyers of Miami Beach hotels and pointed one out in particular where he said I would feel comfortable, as that's where "my kind" stayed. When the departure date arrived, it was the Friday before school vacation. I had an evening flight from Boston to Miami that was uneventful. They didn't have the car I was supposed to get and offered me a convertible for the same price. I took advantage of the offer, and got directions to my friend Larry's place. When I arrived, there was a note on the front door stating that he was playing a party at one of the hotels on Miami Beach and for me to go in as the front door was unlocked. Once inside, another note on the kitchen table indicated which bedroom was mine and I was all set. I never heard him come in when he returned from the party he was playing. That Friday had been a long day and I guess I was tired.

The next morning we talked at breakfast. Larry said, "I have some good news for you and some bad." The good news turned out to be an offer to work with him that following summer for a month. He was booked to play at Wentworth Hall in Jackson, New Hampshire, and needed a bass and drums to accompany him. I said OK to the offer once he told me what it would pay. The bad news was that I couldn't stay with him that week. His sister, unexpect-

small hotel on a side street running off Collins Avenue, the main street in Miami Beach. When the man arrived, I shook his hand, introduced myself using my stage name and told him that a Mr. Jack Kramer from Boston told me to look him up and that he might have a spare room that I could have for about a week. Schilling: OK with No Hall Entries this Year

This year no one was elected to the Hall of Fame ballot and Schilling says he's fine with it. "If there was ever a ballot and a year to make a statement about what we didn't do as players, which is we didn't actively push to get the game clean, this is it. Schilling received 38.8 percent of the vote in his first shot on the ballot. He finished ahead of both Roger Clemens and Barry Bonds on this year's ballot.
