# Governor Baker Passes Consumer Protection Bill

Statement from Michael Festa, State Director of AARP Massachusetts **REGARDING H.B. 4806**:

#### An Act Relative to Consumer Protection from Security Breaches

"AARP is the nation's largest nonprofit, non-partisan organization dedicated to empowering Americans 50 and older to choose how they live as they age. On behalf of the more than 800,000 members in the Commonwealth, we thank Governor Baker for signing into law House Bill No. 4806 - An Act Relative to Consumer Protection from Security Breaches.

This law, which gives consumers control of their credit reports by allowing them to freeze and unfreeze their credit without paying fees to credit reporting agencies, is an important step in ensuring that Massachusetts consumers are protected from identity theft.

We appreciate the Massachusetts General Court taking additional steps to strengthen last year's action by the federal government related to security breaches. The bill was sponsored by Senator Barbara L'Italien (Andover) and Representative Jennifer Benson (Lunenburg). We thank the sponsors and six members of the conference committee; Representatives Tacky Chan (Quincy), Daniel Hunt (Dorchester), Randy Hunt (Sandwich) and Senators Barbara L'Italien (Andover), John Kennan (Quincy), Ryan Fattman (Webster) for their efforts to help the Commonwealth's consumers.

With more access to credit due to their longer careers and higher incomes, older adults are the most common targets of identity theft nationwide. Individuals age 50-59 filed more than 7,200 complaints of identity theft in Massachusetts alone in 2017, according to the Federal Trade Commission.

With credit reporting firm Equifax revealing that hackers stole financial and consumer data on more than 143 million customers in the U.S., including at least three million residents of the Commonwealth, it's quite possible that the personal information — including birth date, Social Security number, driver's license number and address of many of us has fallen into the hands of criminals.

A security freeze allows an individual to voluntarily restrict access to their credit report so that new lines of credit cannot be opened. Enacting such a freeze can make it more difficult for criminals to steal an identity and open up new credit accounts or loans in someone else's name. A credit report security freeze does not affect a person's credit score, and can be removed at any time.

This new law helps to ensure consumers in Massachusetts don't have to pay to control access to their credit reports.

We thank Governor Baker for signing this important bill into law."

## THE VIGILS OF OLD ROME PART II



Here are some appropriate definitions: Police — the department of government concerned with the preservation of public order, including the prevention and detection of crime; Fire Department — a municipal department whose work is fighting fires and preventing their occurrence; VIGIL — a purposeful or watchful staying awake during the usual hours of sleep. Now let's take all three, put them in our giant blender and out come the Vigils of ancient Rome, a combination of police and fire department organized under military discipline. There were as many as 7,000 of them under the command of a Prefect. They were quartered in seven main barracks or "stationes" headed by a captain or "tribunus" and each of these

They were responsible for law and order in the city and for the protection of its citizens. This meant that they were also responsible for preventing and extinguishing fires; a combination police and fire department all rolled up into one neat little package. They had regular duty details at all places of public assembly and were equipped with axes, ropes and buckets. They were trained in the use of a hand-operated fire engine called a "sipho" and before long received the nickname of "siphonarii."

There was a very high incidence of fire, especially in the tenement houses of "insulae" This was largely due to the lack of adequate heating systems and the use of movable stoves or braziers, candles, poorly designed lamps, and torches. As soon as news of a fire was received, he would dash to the scene and commiserate with the owner, who was deep in despair and misery because of the sudden loss of his building. The crafty Crassus would then offer to purchase the smoldering real estate on the spot at a ridiculously low price. If his offer was accepted, and it usually was, trained teams of builders were soon on the spot erecting a new incomeproducing structure. Crassus was then handsomely rewarded for his sympathetic and capital effort. This is the same Crassus who was a member of the "First Triumvirate" and it is said that his fame spread faster than his flame. He was captured while leading an army against the Parthians and because he had such a great love for wealth, they put him to death by pouring molten gold down his throat. This was known as getting your teeth filled the hard way.

"I have a dream that one day this nation will rise up and live out the true meaning of its creed: 'We hold these truths to be self-evident, that all men are created equal."

Monday, January 21, 2019, marks America's 34<sup>th</sup> celebration of Martin Luther King, Jr., Day. Honoring King with the sacred status of a federal holiday — of which there are only ten, none other named for a 20<sup>th</sup>-century figure — is a testament to the unifying power of his legacy. King's most important work applied America's Founding ideals to the cause of civil rights. The last best hope for true racial progress, King realized, was solidarity: For people to see and treat one another as equals, they had to feel the tugs of a bond far stronger than either race or politics.

For King, that bond was America.

### Excerpts from President Donald J. Trump's 2018 Martin Luther King, Jr. Proclamation

"The Reverend Dr. Martin Luther King, Jr., dedicated his life to a vision: that all Americans would live free from injustice and enjoy equal opportunity as children of God. His strong, peaceful, and lifelong crusade against segregation and discrimination brought our Nation closer to the founding ideals set forth in the Constitution and the Declaration of Independence. Today, as we come together to honor Dr. King, we know that America is stronger, more just, and more free because of his life and work.

"We acknowledge our Nation's continuing debt to Dr. King's legacy. Dr. King advocated for the world we still demand — where the sacred rights of all Americans are protected, rural and urban communities are prosperous from coast to coast, and our limits and our opportunities are defined not by the color of our skin, but by the content of our character. We remember the immense promise of liberty that lies at the foundation of our great Republic, the responsibility it demands from all of us who claim its benefits, and the many sacrifices of those who have come before us.

"Too often, however, we have neglected these ideals, and injustice has seeped into our politics and our society. Dr. King's peaceful crusade for justice and equality opened our Nation's eyes to the humbling truth that we were very far from fulfilling our obligation to the promises set forth by our forbearers.

We must work together to carry forward the American Dream, to ensure it is within reach not only for our children, but for future generations. As your President, I am committed to building and preserving a Nation where every American has opportunities to achieve a bright future."

Importantly, in paying tribute to Dr. King, we are reminded that the duty lies with each of us to fulfill the vision of his life's work. Let us use our time, talents, and resources to give back to our communities and help those less fortunate than us. ### Wright Museum of World War II to Host **Smithsonian Traveling Exhibition in May**

Recently, the Smithsonian Institution Traveling Exhibition Service (SITES) announced the launch of a national tour of the exhibition, Righting a Wrong: Japanese Americans and World War II. Opening at the Arizona Capitol Museum in Phoenix, Arizona, January 26, 2019, the exhibition will travel to the Wright Museum of World War II in Wolfeboro, New Hampshire, May 1<sup>st</sup> through July 7<sup>th</sup>.

According to museum Executive Director Mike Culver, the exhibition examines "the complicated history and impact of Executive Order 9066, which led to the incarceration of Japanese Americans following the attack on Pearl Harbor.

"It embraces themes that are as relevant today as they were 75 years ago," he said. Righting a Wrong looks at immigration, prejudice, civil rights, heroism, and what it means to be an American."

The exhibition explores this complex history through historical images, personal stories and objects from those incarcerated at the camps. A duffle bag in the exhibition, for instance, used by the Imada family when they were relocated to the Gila River camp in Arizona reflects the restrictions to bring only what they could carry. Another example is Takeo Shirasawa's 1943 high school diploma from the Poston camp in Arizona, which exemplifies the experience of thousands of other teens



who had to complete their high school education in camps.

The exhibition's stop at the Wright Museum, said Culver, and was made possible by support from The Montrone Family.

"We are very grateful for their generous sponsorship, giving the Wright this opportunity to become involved in an exhibition with national distinction and importance," he said. "This is an exhibition of great relevancy that should be seen by every American."

Righting a Wrong: Japanese Americans and World War II was developed by the National Museum of American History and adapted for travel by the Smithsonian Institution Traveling Exhibition Service. The national tour received Federal

support from the Asian Pacific American Initiatives Pool, administered by the Smithsonian Asian Pacific American Center, the Terasaki Family Foundation, and C. L. Ehn & Ginger

Celebrating its 25th anniversary in 2019, the Wright Museum in Wolfeboro will re-open on May 1<sup>st</sup>, at which time visitors may also visit *Righting a Wrong:* Japanese Americans and World War II.

The region's leading resource for educators and learners of all ages on World War II, the Wright Museum features more than 14,000 items in its collection that are representative of both the home front and battle field.


The Magical, Mysterious January Moon

Several Roman deities, the majority of them women, presided over the moon. Diana, the forest-dwelling huntress, was associated with the crescent moon, perhaps because it resembled the shape of her bow. The darker side of the moon belonged to the goddess Trivia, most commonly known by her Greek name Hecate, who ruled over witchcraft, crossroads, and all the spooky aspects of night. Finally, the goddess Luna served as the very personification of the moon, and her name lent itself to the Italian name for "moon."



Contemporary Italians still include mentions of the moon in their folklore, especially in the realm of superstition. The most famous Italian moon-related superstition, also repeated frequently in the United States, declares that the full moon exerts an influence over human behavior, encouraging romance but also lunacy. In fact, the word "lunacy" shares the same root as "luna." Italians also whisper stories of the lupo mannaro, or werewolf, who changes into a frightening beast under the full moon. Sundry moon superstitions include cutting one's hair during a waxing moon, to ensure that it will grow back lusciously as the moon gets bigger, and that pointing at the moon is considered rude and unlucky. These pieces of lore speak to moon's immense cultural significance.

One January holiday in particular boasts the same sense of magic and mystery I associate with the moon. January 21st is St. Agnes's Day, or la Festa di Sant'Agnese in Italian, honoring a Roman virgin and martyr killed in the early fourth century. By sheer chance, this year the full moon and St. Agnes's Day coincide! In Italy, this feast is linked to lambs, possibly because of the similarity between the name Agnese and the Italian word for lamb, agnello. Every year, the Pope blesses two lambs brought to Rome on January 21st specifically for the feast of St. Agnes. Significantly, sheep begin birthing lambs and commence the process of lactation around the middle of January. Therefore, la Festa di Sant'Agnese is one of those January holidays that looks ahead to the promise of spring, that honors rebirth and the new life blossoming under the winter snow. However, in addition to livestock, old St. Agnes's Day celebrations sparkled with enchantment and secrets. In the England of yore, the eve of St. Agnes's Day was set apart for romantic divination. Since St. Agnes is the patron of young women, girls would seize this opportunity to perform a plethora of charms in order to dream about their future spouse. These

charms involved mysterious activities such ranging from silently walking backwards to bed, baking a cake at night without uttering a word, or repeating a magical rhyme while throwing grain into the soil. The romantic, supernatural nature of St. Agnes's Day perfectly accentuates the frigid, moonlit

nights of January, when the moon illuminates the shadowy skies and hints at the spring to come.

Though she is often eclipsed by the warm and fiery sun, the moon provides us with a unique blend of mystical beauty and starry-eyed magic. She is a prominent figure in folklore and mythology, having long amazed people with her changing faces and powerful nocturnal presence. Wielding the mighty ability to affect tides but gentle enough to form lacy patterns of moonlight through the bare winter tree branches, the moon continues to enjoy her place in superstition, as people still repeat tales of her influence on human behavior. I encourage everyone to take time out of their busy lives to glance at moon in all her splendor — whether she stands as a full white orb, or a glimmering sliver in the sky, or shyly peeks behind slate-colored clouds. One of my favorite moon moments was years ago, when I was driving back home with my mother after visiting my grandmother. As we passed a lake whose waters gleamed like polished glass in the nighttime, we immediately noticed an enormous full moon suspended in the sky, sending her spangles of light flitting across the tranquil waters. This moment reminded me that there is still so much beauty, magic and mystery in our world, which will only continue to be revealed as the winter melts into the renewed life of spring.

### **Pet News** from the Gazette

Five Winter Essentials for Short Haired Dogs



Keeping your dog warm in winter, not all dogs are blessed with thick, double layered winter coats or fur around the pads of their feet. For those poor souls that must live in freezing (or just cold) climates, they are left with only one solution well, two solutions: never go out during the winter and pee on the floor, or wear dog clothing. We're betting that you, as the home and pet caretaker, will choose the latter. At the minimum, these are the items you should have for your lightly haired, thin skinned dogs.

Sweaters: whether you make them yourself or buy them, sweaters are essential for keeping a lightly furred dog comfortable. Make sure the material is durable and that it ends about the elimination area. Otherwise you will have very stinky sweaters.

Boots: did you know that the pads on a dog's feet can get frostbitten? While some breeds from cold climates evolved to grow heavy fur on their feet that helps to cover the pads, many dogs do not have that. If you live in an area where snow and ice are a part of the winter landscape, do your dog a favor and get her or him some dog booties. He or she will be forever grateful for them.

Winter coat: sweaters are fine for indoors and for when it is above freezing outside, for most dogs, but once it starts snowing that's when things get really uncomfortable. A nice, thick, insulated winter jacket can make the difference between your dog hiding behind the sofa when it's time for a walks or eagerly allowing you to wrap his coat around him so that he can enjoy the weather without too much shivering. Make sure the coat is also rain resistant. Remember, snow is just powdery rain and can get a dog wet, too.

**Snowsuit**: and then there are other dogs that are so lightly furred, so thin skinned, and so lacking in insulating body fat that only a full body suit will do to get them outside. Don't forget the dog boots if there is snow on the ground.

Heated Blanket or Pad: for bed if you don't want your dog jumping into bed with you or demand to be held to stay warm (and maybe you do like those things, but within reason), an electric or self-warming bed pad is your best preemptive move. And this goes for cats as well, since they love small warm spots, but probably not so much the sweaters and booties. We're betting that unlike dogs, who appreciate the things that keep them warmer and comfy, the cats will lose those items fast.

### The Immigrant American



The Boston Santoros

Eugenio Santoro came to the United States from Messina in 1899 and became a barber in Boston.

In strict Roman Catholic tradition, he raised 14 children with his Messina born wife. Concetta Scarletta, whom he had met in Boston's historic South End. Three other children were born but passed away from small pox and cholera.

According to the U.S. Census Bureau, roughly 50 percent of Italian immigrants between 1901 and 1920 repatriated back to Italy. Many of these "new immigrants" had no intention to culturally integrate or "assimilate" into American society. Such was not the case for the Santoros. They firmly planted stakes into the American way of life and accepted the challenges of language, customs and new found patriotism.

Cultural transition initially began when Eugenio stepped off the steamer at Ellis Island in New York harbor. He "kissed the ground" as many others had before him. For the Santoros, they adapted well and were determined to "Americanize."

The Santoros adhered strongly to their own ethnic constitution of family, religion, and respect for others. These beliefs did not pose a conflict to their pledge of loyalty and allegiance to their adopted country.


As children arrived, the determination to fully assimilate became stronger. First came Francesco in 1903, followed by Letteria, Maria, and Vincenzo in the space of three years. More followed such as Salvatore, Orazio, Giacomo, Joseph and Ninfa. The Depression had not quite struck when five more boys came: Thomas, Leo, John, Paul and Rosario.

In 2009, the Italian American historian and University of Massachusetts professor Vincent Cannato said two significant factors cemented the assimilation for those Italian immigrants like the Santoros who sought to make America their country.

The first was the 1924 immigration quota act passed by Congress that effectively choked off the Italian visa flow from

42,000 to 4,000 annually. Gradually Italian immigrant enclaves began to shrink as no newcomers arrived to replace the ones that had already departed for the suburbs. During this time, the Santoros migrated from Boston to the city of Medford.

The second was World War II. Many Italians, not yet fully assimilated, saw their status change from "resident aliens" to "enemy aliens" even while some of their relatives served overseas.

The Santoros were not affected by this unfortunate policy. They demonstrated their patriotism as seven brothers entered various branches of the military and served overseas in

both the Pacific and European theatres.

Paul became one of "Merrill's Marauders" in Burma while Orazio joined the Coast Guard in the North Atlantic. Leo also joined the Coast Guard to protect troop ships destined for England. Joseph sailed to Guadalcanal with the Marines and found himself in the trenches alongside his brotherin-law John. Tommy joined the Army and survived malaria 28 times in the Pacific. Rosario, the youngest, joined the Navy and assembled landing crafts for the Marines in New Guinea.

The Sole Survivor policy had not been officially enacted until 1948. All seven Santoro brothers survived the war. For Papa and Mama Santoro, this personal sacrifice solidified

their assimilation as Americans. As decades passed, the sons and daughters of Eugenio and Concetta passed on, leaving Rosario as the sole survivor. He is 95 years old today. He made sure his three sons Frank. Charlie and Paul continued with his own brand of respect and gratitude for the country that blessed him. America gave him the economic opportunity he needed to raise a traditional Italian American family. As he related recently to me, "My proudest moment as a father recipes have been stowed away in old shoeboxes and for them, the Sunday afternoon family gatherings are a thing of the past." Then he added, "But not for us."

Several of the Santoros moved out to California and elsewhere. "For some of us, the Italian family stereotype appears to have faded away," according to Paul, Rosario's son. "Our West Coast cousins hardly speak Italian anymore. The family

ing room table."

The process of assimilation that challenges many immigrants in this country should not be viewed in a vacuum. It does not happen overnight. Over many years, American born sons and daughters of Italian immigrants observe the difficulty their parents have trying to adjust to their adopted country. Assimilation is easier when children understand how to transition into middle class America without dispensing with ethnic customs.

In 1907, President Theodore Roosevelt stated "in the first place we should insist that if the immigrant who comes here in good faith and becomes an American and assimilates himself to us, he shall be treated on an exact equality as everyone else, for it is an outrage to discriminate against any such man because, of creed or birthplace or origin. But this is predicated upon the person becoming every facet an American and nothing but an American. There can be no divided allegiance here."

For Eugenio and Concetta, the "Americanization" was complete, the ethnic traditions survived and for their 14 children, the odyssey of the American dream was realized.

## Nanna & Babbononno

by John Christoforo

A Nostalgic Remembrance



Some readers have asked me if I remember the names of some of the neighbors who lived on Eutaw Street going back to when I was a kid. Actually, Babbononno moved the family to Eutaw Street in 1920. He, Nanna, and the kids were living on Orleans Street, and one night when they were out visiting, their apartment was robbed. Not feeling safe there any longer, my grandfather moved his family to 70 Eutaw Street after purchasing the property and my mother and her brothers would grow up there.

They were one of the first Italian families in the neighborhood. There were a few Irish neighbors, but the neighborhood, called Eagle Hill, was composed mostly of the descendants of the Yankees who worked at the Donald McKay Shipyard in the 1800s. My mother and her brothers felt comfortable growing up middleclass, and Babbononno made sure Nanna and the kids had the best of everything.

When Uncle Paul, my oldest uncle was married, Babbononno made the top floor into a modern apartment for his first-born son and his wife, Eleanor. When Uncle Nick married Ada Georgone, Mom's best friend, they moved to Allston, and when Mom married Dad, they too headed for Allston. Uncle Gino remained home as the single son until he joined the Army Air Corps not long after WWII started. After I was born, Mom had some health issues and Dad moved the three of us back to 70 Eutaw Street so that Nanna could take care of her only daughter. Dad worked day and night and we were better off living with Nanna and Babbononno.

In 1945, Nanna had a heart attack and was hospitalized for quite some time. When she returned home, the house was too much for her to handle, and so, after 25 years of ownership, Babbononno sold the house and opted for an apartment that was smaller and easier to handle. Knowing that Babbononno wanted to sell the house, Mom and Dad were offered the third floor apartment at 74 Eutaw Street. It was owned by Angelo and Giuseppina Branco. Mom had grown up with their daughter, Grace, and Dad with her husband, Ralph Manfredonia. We would remain there until

There were many neighbors, many of the older ones knew my grandparents, Mom, and her brothers rather well. The single-family home at 68 Eutaw Street was owned by Marie Alexander,

a Boston schoolteacher whose family went back to the colonial days of Boston. Her friend, Marjorie Warren lived with her. Marjorie was a descendent of Dr. Robert Warren, one of the pioneers of the American Revolution, who unfortunately would lose his life on Breeds Hill during the battle of Bunker Hill. Attached to 74 Eutaw was 72 Eutaw, owned by a Mrs. Lovatare. She was from the mountains of mid-1800 Sicily, and no one could understand her Italian. Even Mom, who spoke several dialects, couldn't understand the lady when she spoke. Her daughter, Mary, and her husband occupied the first floor until the end of the war. Her husband, Andy Iantosca, an Army colonel, moved the family to the western part of the state after the war and the Eatons moved in. Eventually the top floor was occupied by a family named Mello. At 74, we occupied the top floor, with the landlord and his wife living on the second. The first floor was occupied by a couple whose names I don't remember. What I do remember was that the man, his name might have been Mario, was a hunter, and

The next house to the right was a two-family owned by Mando Sinabaldi. He and his family lived on the first floor with the second floor rented out to the Balabona family. Next to them to the right, was a house bought by Sal Romano. Before the Romano's moved in, the second floor apartment was occupied by the Thomas family with eight or nine kids running around constantly. The first floor was taken by the Muise family from Canada. Stanley Muise had been a strong man with a Canadian circus before immigrating to America. He and his wife had only one child and he would be challenged all of his life. Directly across the street was the Luis family, second generation Portuguese. To their left was a single-family home owned by the Crotty family, one of the first Irish families on Eagle Hill.

I could go on and on with this. During and after the war, several families moved into the neighborhood and Mom and the ladies would get together once a week for coffee and ...

Their husbands would often gather to play cards. The only one absent was my father, he worked both day and night. When the warm weather arrived, Dad would help to orga-

What I do remember vividly were the games their children and I played. During this time of the year, we had genuine organized competitive snowball fights right after a snowstorm. Two mounds of snow about three to three and a half feet high would be built on both sides of Eutaw Street and sides would be picked. Nickels and dimes would be bet by many of the neighborhood kids who didn't participate in the sport but didn't want to be left out of the fun. I had a good fastball, but Sal Romano's son, Bobby, had a curve and a breaking ball that allowed him to throw snowballs over the top and down behind the snow walls we had built. When we chose sides, he was always the first one picked.

During the warm weather, the children of all those neighbors played half ball. For you non-Bostonians, half ball is like New York stickball in a way. We would buy a pink rubber ball or a pimple ball, cut it in half, and hurl it toward a batter on the opposite side of the street. The batter held a broomstick, which was the bat that swung at the half ball. If you hit the half sphere, and it reached the sidewalk on the opposite side of the street, it was a single. If you hit the first floor of the house, it was a double. If you hit the second floor, it was a triple, and if you hit a wall or window on the top floor, it was a homerun. Along with this type of athletic competition, the warm weather allowed us to play tag, relievio, hide and seek, puss in the corner, and for the girls, jump rope and hopscotch.

Some of us kids had a bunch of toy soldiers and we directed mock battles defending our block of Eutaw Street from our enemies. When we became a bit older, it was baseball, baseball, and more baseball, but baseball is a story for another day.

### Saint Callistus

by Bennett Molinari and Richard Molinari

Saint Callistus was a martyred Pope of the early Church, reining as Pope from 217-222. His year of birth is not known, what is reported is he was the slave and highly placed domestic servant of Carpophorus, a

Christian. Callistus eventually was given responsibility for his master's banking business. When the bank failed, Callistus received the blame, and attempted to flee from his master. Being discovered, he was demoted to serve as a manual laborer in Rome. Thus, Callistus came as a slave to the city where he would later serve as Pope.

Callistus was sent to work in the mines of Sardinia possibly for causing a public disturbance, however, Callistus may also simply have been sentenced due to a persecution of Christians, as he was among the many believers eventually freed on the recommendation of Pope St. Victor I.

During the subsequent reign of Pope Zephyrinus, Callistus became a deacon and the caretaker of a major Roman Christian cemetery on the Appian Way. The cemetery, which is to this day called the Catacombs of St. Callixtus, became the burial ground of many popes and was the first land property owned by the Church.

In addition to advising the Pope on theological controversies of the day, he was a natural candidate to follow Zephyrinus, when the latter passed away.

Callistus was elected pope by a majority vote of the clergy and laity of Rome, and thereafter was bitterly attacked by the losing candidate, Hippolytus, who allowed himself be set up as the first antipope in the history of the Church. The schism lasted about 18 years. Hippolytus was an erudite Roman theolo-

gian, who accused Pope Callistus of being too lenient, sympathizing with heretics, and resented the new Pope's clarification that even the most serious sins could be absolved after sincere confession.

Callistus could not persuade Hippolytus' followers of his rightful authority as Pope during his own lifetime. The Catholic Church, however, has always acknowledged the orthodoxy and holiness of Pope St. Callistus I, particularly since the time of his martyrdom traditionally ascribed to an anti-Christian mob in 222. Callistus was martyred during a local disturbance in Trastevere, Rome, and is the first pope — except for Peter—to be commemorated as a martyr in the earliest martyrology of the Church.

The Feast of Saint Callistus is October 14<sup>th</sup>.



Religion to me was a mystery as a child and, in many ways, still is. But, as a little boy, the church itself was a building of at least as much wonder. I could tell how old it was and how big. This sense of wonder only increased upon starting kindergarten when I discovered the old building that served as my classroom behind the church. I knew my classroom there, the basement where the boys bathroom was, the stage and the hall where we had our holiday pageants, and I knew there were several floors above where the higher grades were, though I saw very little of these. I knew what the offices looked like and ... not much else. I couldn't help but think there was a lot more to the building that was out of view. I wanted to see the cellar, some of the hidden corridors of the old buildings and, most of all, the little house where the nuns lived. Overtime I got to see a separate little building belonging to the school where we held our holiday pageant and was used for bingo at night.

As for the church my clearest memory is my communion, a day shared with many of my classmates. Less than a year later, my family left the neighborhood and my visits to St. Mark's Parish were a rare instance. In fact, I remember going back only early in 1999 for my grandfather's memorial

There is something about a church, no matter how religious or non-religious you are, that establishes itself into memory for decades. Perhaps because, at an early age, the church asks us question and there is nothing more invigorating to a child than a spark of curiosity. For me that church is St. Mark's, the church that united my parent's, baptized both my sister and I, where I made my communion, and where, just maybe, my inquisitive nature was born.

#### **George Foreman Turns 70**

#### 50 Years Ago He Proudly Waved the American Flag at the Olympics

On January 10<sup>th</sup> former two time heavyweight champion George Foreman celebrated his 70th birthday. George has led a remarkable life. Born in 1949 to extreme poverty in Marshall, Texas, he all but gave up on himself at an early age. Foreman described those years as a time when he was "hungry most of the time." He was also ashamed of being poor. As a teenager he turned to a life of petty crime and bullying. He was big and strong and used those attributes to take what he wanted. Foreman was destined for prison or worse.

His life changed when he was 16 and entered the Job Corps where he learned skills, but more importantly, he learned to value himself as a human being.

While in the Job Corps. Foreman traveled to California where met Doc Broaddus who was a Job Corps counselor as well as a boxing coach. With the encouragement of Broaddus, Foreman began boxing as an amateur in 1966. After a rocky start Foreman went on to win numerous amateur titles, compiling an amateur record of 22 wins and 4 losses. In only his 22 fight he was representing the United States in the 1968 Olympics in Mexico City.


Foreman defeated three opponents to make it into the finals against Ionas Chepulis who was representing the Soviet Union. Chepulis was ten years older than George and had much more experience than the American. Chepulis was also a very hard puncher, having won all his Olympic bouts by knockout. Winning the Gold Medal was not expected to be an easy task for Foreman.

Foreman surprised the skeptics when he came out in the first round relying on his powerful left jab to keep Chepulis at a distance while bloodying his face. By midway through the 2<sup>nd</sup> round the Russian was taking a savage beating and the referee stepped in to halt the slaughter. Foreman had won Olympic Gold.

As he was announced the winner he went over to his corner and pulled a small American flag out from the pocket of his robe. He walked around the ring bowing and waving the flag. This

was the first Olympics to receive a large television audience, and at home millions of Americans watched as this kid born into poverty 19 years earlier was proudly representing his country. It was one of those beautiful and spontaneous moments that remains etched into the minds of those who witnessed it when it happened. It was also controversial.

If you think the country is in turmoil today, in 1968 it was coming apart. Popular opinion was turning against the War in Viet Nam. The fight for Civil Rights was being fought and there were divisions within that movement. Dr. Luther King Jr. was assassinated in April and Bobby Kennedy was shot to



death in June. There were riots in major cities over the war and civil rights. The mounting loss of life of American soldiers in Viet Nam was being reported on the news every night, while on college campuses young men were burning their draft cards. The nation was in the midst of having a nervous breakdown.

Days earlier at the Olympics where George Foreman waved the American flag after winning his Gold Medal, two other black athletes, Tommie Smith and John Carlos stood on the podium where they were receiving medals for their victories in track. As the national anthem was being played both men put their heads down and raised a black gloved fist in protest over the treatment of black Americans. It was also quite controversial.

Carlos and Smith were immediately stripped of their medals and sent home by International Olympic Committee President Avery Brundage. It was ironic that this was the same Avery Brundage who, as president of

the IOC in 1936, stayed quiet when German athletes were raising their arms in the Nazi salute.

Foreman caught heat as some people felt his waving the flag was done to undermine the actions of Smith and Carlos. That is not why he did it. The two actions were not related and George never intended it to be taken as a response to what had happened earlier. In fact, years later in an interview, John Carlos said "You know, a lot of people on the left thought 'Oh, George, he disrespected us' or 'he hurt us' or 'he didn't stand up for us.'Totally wrong! George was a tremendous individual during that time in '68, and he's even greater in life today."

In a 2003 interview with Dave Zirin, Foreman was asked if he had it to do over again would he still wave the flag? His response:"If I had to do it all over again I would wave three flags! I feel that I had been rescued from the gutter by America. One day I was under the gutter, chased by police, thinking dogs were going to get me ... The next day there I am standing on the Olympic platform and you hear the anthem. I was proud."

He went on to say, "... I didn't like being called or set apart as a "Black athlete" ... I got a chance from this country and when I go to Africa or Germany, or anywhere else in the world, people don't see me as black, but as an American."

The United States will never be perfect and it is important that people strive to continue to make it a better and better place. There is always room for protest and also for praise. The one thing that should always unite us is that we share in having been given the gift of being born here. We can have our disagreements, we can be critical of things and work for change, but we should never lose that gratitude for being Americans and still love our country. That is why staying united in respecting symbols such as the anthem and the flag are important. E Pluribus Unum (Out of many

Watching many of the protests taking place today, and listening too many on the Left as they criticize this country, I am struck by their tone. They don't appear to be fighting for change, but rather are trying to tear the country down all together.

Maybe they could learn from the athletes at the 1968 Olympics. Two men were protesting injustice one man was celebrating being an American. None of them feel they were in conflict with each other.

Whenever I see footage of George Foreman smiling and waving the flag I smile and feel good. It was a wonderful moment from a very turbulent era. Let's keep working to make positive change, but let's never forget what a great country we live in.

### HOOPS and HOCKEY in the HUB

In the overall constellation of the National Hockey League's regular season it was just another game on another night — one in which several other contests also took place.

But, of course, it really wasn't. That was because it was the Boston Bruins playing the Montreal Canadiens. And anytime that happens, well, you know, it is something special.

Special because it is the longest series between two franchises in the NHL. In its latest installment, the teams met for the 746th time, on this occasion at the Garden. And wouldn't you know, there just weren't enough ticks on the clock in a regulation 60-minute game to decide the affair. No, it went into overtime, with the Canadiens winning 3-2, on a spectacular rush down the ice to start the extra session, thus spoiling a comeback bid by the Bruins who had tied the contest on a power play goal in the late

It was the 62<sup>nd</sup> overtime game in the storied series with the Bruins now holding a 17-14-31 edge in those contests that go into OT.

Bruins Head Coach Bruce Cassidy admitted the final outcome was disappointing "especially when it happens that quickly. It was a pretty straightforward rush. We folded instead of challenging the puck carrier, so that started a domino effect and we lost coverage in front. We've been down this road earlier in the year. We lose the draw and never touch the puck and then all of a sudden ... So it's a little disappointing that we didn't defend the rush better and give ourselves a chance to win the game."

It was also an indication that the Canadiens are starting to even things off a bit — especially when one considers the more recent span of games in the series. Boston entered the game sporting an enviable 8-1-0 record in the last nine meetings between the two archrivals, the only blemish on that mark being a 3-0 loss in the Hub back on October 27<sup>th</sup>.

Now, with the overtime loss, the season series ended at 2-2, with each team getting both its wins on the road.

That's right. When the Canadiens left the Hub after the game, which was the last scheduled game between the two historic franchises this season. They could meet in the Stanley Cup Playoffs, of course. But if they don't, then we won't see the Canadiens again in Boston until October at the earliest.

And that's another reason why these games are now so special. As the league has expanded over the decades to 31 teams (with a 32<sup>nd</sup> coming in a couple of years to Seattle), it has come to mean that there are fewer and fewer games between traditional rivals.

Since the NHL leadership won't expand the schedule beyond its present 82-game limit, it means that to create a schedule for an expansion team they must take away games from the various series between

existing teams. Thus, there are fewer matchups between traditional rivals.

So, the Bruins-Canadiens series is now down to four games per year, a shame when you think of it. What the future expansion means for this series as the league expands to 32 franchises we do not know, but we hope that the Boston-Montreal season series is not truncated any further.

A major part of that is because of the excitement generated by these games. It's just a different atmosphere when these two rivals get together.

Take it from one who should know — Claude Julien. He's the man who coached the Bruins for nine plus seasons until he was fired two years ago (February 7, 2017), but was then promptly hired by the Canadiens.

Down the other end of the hall from where he once gave his postgame press conferences as the head coach of the B's, Julien, in his role as a visiting mentor, paused to consider the unique status of the well-remembered matchups between these two teams.

"I think there's always going to be a rivalry there," noted Julien, who has seen it play out from both perspectives. Citing how close both teams were in the standings, Julien said, "I think it was a big game for both teams. I think that helped the rivalry a little bit and probably added to the intensity of the game."

Montreal Goaltender Carey Price commented that he liked the rivalry. "It's just the atmosphere (in Boston). It's just a great place to play hockey. I've always enjoyed the rivalry between our two teams. There was a lot of intensity to the game for sure. It was back and forth with opportunities in both ends."

Price's teammate Paul Byron responded affirmatively when asked if it is "sweeter winning in Boston." Byron was definitely savoring the moment: "It definitely is. They're our number one rival. There's a lot of history here. Every time you come into this building (the Garden) and win, it's huge."

And, of course, Coach Cassidy aw it differently from the Bruins end. "Our execution was a bit off early on," noted the coach who is coming up on the second anniversary of his assuming the head job. "We misfired on a couple of onetimers. We were just a little off in that part of our game. But I thought our guys were here ready to play. They wanted to skate. Unfortunately, we just didn't execute some plays well enough — until the very end to tie the game. I thought we had enough action there to score more than one goal in the last minute. But like I said, we just didn't execute it."

So, it is another regular season in the books as far as Bruins-Canadiens games are concerned. But there's always a possible playoff pairing to look forward to — something that would brighten the landscape as sure as any sunny spring day.
