Lisa Marie Presley Dead at 54

Lisa Marie Presley, a singer in her own right, Elvis' only daughter, and keeper of the Presley legacy died last Thursday, January 12th four days after what would have been her father's 88th birthday after being rushed to the hospital for a medical emergency. Lisa Marie had her father's brooding charisma, eyes, smile, and the low sultry voice that made Elvis "the King of Rock n' Roll."

Lisa Marie even joined her voice with her father to such Elvis recordings as "In the Ghetto" and "Daddy Don't Cry," a mournful ballad which reminded Elvis of the early death of his own mother,

Just a few days before her death, Lisa Marie and her mother Priscilla Presley were at the Golden Globes celebrating Austin Butler's award for playing Elvis in a recent major musical feature Elvis.

"VOTES Act"

Requires Massachusetts Registry of Motor Vehicles to Remove Option for Customers to Opt Out of Automatic Voter Registration

The Massachusetts Registry of Motor Vehicles follow the RMV on Twitter @MassRMV. (RMV) announced that the RMV is no longer allowed to offer the option for customers to opt out of automatic voter registration.

The opportunity for driver's license and ID applicants to decline automatic voter registration is no longer possible in accordance with "The VOTES Act," a new election reform law which was passed by the Massachusetts State Legislature on June 22, 2022.

On each business day, the RMV will be required to transmit to the Secretary of the Commonwealth, specific applicant information on all eligible transactions with the RMV meeting the select criteria of persons attesting to U.S. citizenship and providing proof of lawful presence. Information that is sent to the Secretary of the Commonwealth will include the applicant's name, date of birth, address, attestation of citizenship, and an electronic signature.

RMV customers will be allowed to decline voter registration after receiving the acknowledgment notice from their respective municipal election officials.

The RMV has revised its driver's license and ID applications and the "Voter Registration Receipt" to reflect the new changes referenced above. To learn more, go online to www.mass. gov/service-details/automatic-voter-registration.

For the latest RMV updates and information,

The VOTES ACT requires the RMV to remove the "opt out" for voting from the driver licensing application. Applicants that wish to opt out may contact their town/municipality directly. Information on all eligible applicants will automatically be sent to the Secretary of the Commonwealth (SoC) for voter registration. The option to decline to register to vote will be removed from the application (paper and online). In addition, the deadline to register to vote will be reduced from 21 days to 10 days before an election.

Qualifications

To register to vote in Massachusetts you must be all of the following:

- A U.S. Citizen
- A Massachusetts resident
- · At least 18 years old on or before the next election
- You can pre-register to vote at 16 years of age. Voter registration deadlines
- To vote in a future election you must register: • 10 days before all primaries and elections;
- 10 days before a special town meeting More info

You should receive confirmation of your voter status within 2-3 weeks of registration. If you have not received confirmation, contact your local election office.

THE VORACIOUS AND VICIOUS VITELLIUS



Two of Vitellius' most prominent characteristics were his love for luxury and his cruelty. Every meal became a feast for himself and every night he indulged in a drinking orgy. Most of the time he forced or tricked someone else into picking up the tab for his feasts, which were known to have run as high as \$20,000 dollars for one sitting.

An emetic is a medicine or substance that causes vomiting. It is common knowledge that these ancient Romans often took emetics to avoid the acid indigestion associated with overeating. Vitellius usually resorted to this practice in order to sustain his heavy eating habits. An example of the kind of meal that was set before this voracious man is indicated by the spread offered at his own brother's home to celebrate the arrival of Vitellius into Rome. There were two thousand of the choicest fishes and seven thousand birds. Other platters contained delicacies like livers of pike, peacock's brains, flamingo's tongues, and milt (reproductive glands) of lamprey eels (yech). Even when traveling, if he came upon anyone who just happened to be making a sacrifice of food to some god he would snatch it up and devour it on the spot.

Inflicting torture or death upon anyone for any reason was his other personal delight. Those who were selected for execution were invited to his court through every kind of deception and then seized.

Two sons who attempted to intercede to save the life of their father were put to death with him. A Roman knight was ordered to be executed, and as he was being led away he called out to Vitellius saying, "You are my heir." After seeing his will, it was noted that a freedman was listed as a joint-heir along with the emperor; consequently, the freedman was also executed. Vitellius was even suspected of causing his ailing mother to starve to death because of an oracle that prophesied a long and secure rule if he survived his parent. Others say she was ailing and asked for poison, and that he quickly granted

During the eighth month of his reign, trouble started brewing in the provinces and some of the troops even swore allegiance to Vespasian. Offers to repent

those who were determined to take control of the empire. When Vitellius received news that the enemy was drawing near and his own forces had deserted him, he then gathered his most cherished possessions, his cook, his baker, and a girdle full of gold coins. He went first to his father's house, but after having second thoughts about remaining incognito, he then took refuge at the lodge of a friend. He tied a dog in front of the door and put a couch and mattress behind it. The invading forces quickly forced their way inside and dragged him from his hiding place. Vitellius attempted to escape capture by lying about his identity, but he was soon recognized. He then begged for his life to be spared and to be placed in confinement, alleging that he had important information that was vital to the safety of Vespasian. But the invaders, intent upon extracting their pound of flesh, bound his arms, tied a rope around his neck, and dragged him like a dog through the streets that were crowded with abusing and mocking citizens. They entered the Forum and this is where some people pelted him with dung while others hurled gross obscenities at him and still others taunted him about his bodily defects. He was tortured for a long time on the "Stairs of Mourning" and then killed by repeated blows. His head was paraded around Rome after his body was thrown into the Tiber River, and the spirit of the voracious and vicious Aulus Vitellius, the eighth emperor of the Roman Empire, was joined with those of his ancestors.

Saint Daniel of Padua

Daniel was an Italian of Jewish descent who converted to Christianity and eventually became a missionary. The exact date of his birth in the period of the second century is unknown. He was the deacon of Saint Prosdocimus, the first bishop of Padua, and is said to have converted many in the region of North-East Italy. Daniel was arrested and executed by a local governor on account of his refusal to make sacrifice to the Emperor Marcus Aurelius. Daniel was martyred by being nailed to a table to die of shock and blood loss in 168 at Padua, Italy.

The Counter Reformation in Italy saw an increase in the literal depiction of the martyrdom of saints. Saint Daniel is depicted in an appalling spectacle of being dragged by a horse and then crushed and nailed between a table of wood and one of stone

His body was discovered nearly 1,000 years later, and his relics were transferred to the church of Saint Sofia, in Padua, on January 3, 1064. Saint Sofia Church is believed to be the oldest Catholic Church in Padua having been built in the tenth



century. Saint Sophia's is the church where seventeen-yearold Andrea Mantegna painted his first independent work, an altarpiece depicting the Madonna with Child in conversation with saints.

St Daniel of Padua representation is a deacon holding a towel and laver (a bowl on stand) to indicate his service to his bishop. Saint Daniel is the patron saint of prisoners and women whose husbands are at war. The feast day of Saint Daniel of Padua is January 3rd.



Grow a Beautiful Indoor Succulent Garden

All you need is a lot of light and benign neglect to raise healthy and beautiful succulents. Place the plants near an unobstructed south -, west - or east - facing

Don't let a lack of light stop you from enjoying these beautiful plants in your home. You'll find many attractive options for displaying your plants while providing the light they need. A single desktop LED plant light, attractive plant light shelves and carts, and furniture-grade light gardens allow you to grow these sun-lovers anywhere in your home.

Grow these plants in cacti and succulent potting mix. These fast-draining mixes help reduce the risk of overwatering which can lead to root rot. Further reduce this risk by using containers with drainage holes that are only slightly larger than the succulents' root system. Growing them in too large of a container that retains moisture longer can result in root rot, decline, and even the death of your plants.

Water thoroughly whenever the top inch or two of soil is dry. Some gardeners check the soil moisture at the drain hole to ensure it is dry and the plants need to be watered. Always pour off any excess water that collects in the saucer.

Avoid water collecting in the rosette of leaves or the cluster of prickly stems that can lead to crown rot. Use a watering can like the Haws Indoor Watering Can which has a long narrow spout that allows you to reach under the plants to water just the soil.

Make slight adjustments in your watering regime and growing environment as the seasons change. Adapting to changing conditions will keep your plants healthy and looking their best year-round.

Find a cool, sunny, draftfree location for your cacti and succulents in the fall and winter. Maximize the amount of light the plants receive by moving them to the sunniest, usually south-facing, window in your home. Water thoroughly but only when the top few inches of soil are dry and just often enough to keep the plants from shriveling. These changes in the growing conditions often encourage a spring display of colorful and unique flowers.

L'Anno Bello: A Year in Italian Folklore

Magical Moonlight!

Every January, I look forward to a certain kind of dark and still night. During a night like this, a mystical hush infuses the air, as if the whole Earth stands holding its breath, interrupted only by quiet wafts of chilly wind. Gray clouds scuttle across the dusky sky, obscuring the stars. I hear the gurgling of melting snow as it rushes down the drainage system, a sound indicative of the frequent January thaws and the cyclical turning of the year. Indeed, the sensation of the coming spring permeates this night, as only short hours before the sky had been a jewel-like hue of deep blue. However, the sight which makes me shiver with the most awe on this night is the full moon suspended above me. She glows with a pearly white incandescence as she winks from behind the passing clouds, adding to the enigmatic mood of the evening. Seeing such a moon reminds me of all the reasons why this heavenly orb resonates so strongly with me: her mysterious beauty, her link to powerful femininity, the way her graceful silver light whispers promises of the changing seasons. The January moon has always been particularly meaningful for me, as she brims with the energy of the New Year and forms an elegant and radiant counterpoint to the dark winter skies. She carries the anticipation of the spring, much in the same way as women-centered January holidays like St. Agnes's Day. In all of her manifestations and stages, the moon has captured the attention of societies worldwide, boasting her own slew of folklore and superstitions.

In part, my love from the moon ppears woven into my DNA. a characteristic of my Italian magic and mystery I associate

heritage. When I was a child, my dad would frequently sing a catchy pop hit he remembered from his Italian boyhood, whose lyrics intoned: "La luna, la luna, ti portará fortuna" — meaning "the moon will bring you luck." Several Roman deities, the majority of them women, presided over the moon. Diana, the forest-dwelling huntress, was associated with the crescent moon, perhaps because it resembled the shape of her bow. The darker side of the moon belonged to the goddess Trivia, most commonly known by her Greek name Hecate, who ruled over witchcraft, crossroads, and all the spooky aspects of night. Finally, the goddess Luna served as the very personification of the moon, and her name lent itself to the Italian name for "moon." Contemporary Italians still include mentions of the moon in their folklore, especially in the realm of superstition. The most famous Italian moon-related superstition, also repeated frequently in the United States, declares that the full moon exerts an influence over human behavior, encouraging romance but also lunacy. In fact, the word "lunacy" shares the same root as "luna." Italians also whisper stories of the lupo mannaro, or werewolf, who changes into a frightening beast under the full moon. Sundry moon superstitions include cutting one's hair during a waxing moon, to ensure that it will grow back lusciously as the moon gets bigger, and that pointing at the moon is considered rude and unlucky. These pieces of lore speak to the moon's immense cultural significance.

One January holiday in particular hoasts the same sense of

St. Agnes's Day, or la Festa di Sant'Agnese in Italian, honoring a Roman virgin and martyr killed in the early fourth century. In Italy, this feast is linked to lambs, possibly because of the similarity between the name Agnese and the Italian word for lamb, agnello. Every year, the Pope blesses two lambs brought to Rome on January 21st specifically for the feast of St. Agnes. Significantly, sheep begin birthing lambs and commence the process of lactation around the middle of January. Therefore, la Festa di Sant'Agnese is one of those January holidays that looks ahead to the promise of spring, that honors rebirth and the new life blossoming under the winter snow. However, in addition to livestock, old St. Agnes's Day celebrations sparkled with enchantment and secrets. In the England of yore, the eve of St. Agnes's Day was set apart for romantic divination. Since St. Agnes is the patron of young women, girls would seize this opportunity to perform a plethora of charms in order to dream about their future spouse. These charms involved mysterious activities such ranging from silently walking backwards to bed, baking a cake at night without uttering a word, or repeating a magical rhyme while throwing grain into the soil. The romantic, supernatural nature of St. Agnes's Day perfectly accentuates the frigid, moonlit nights of January, when the moon illuminates the shadowy skies and hints at the spring to come. Though she is often eclipsed

by the warm and fiery sun, the moon provides us with a unique blend of mystical beauty and starry-eyed magic. She is a prominent figure in folklore and mythology, having long amazed people with her changing faces and powerful nocturnal presence. Wielding the mighty ability to affect tides but gentle enough to form lacy patterns of moonlight through the bare winter tree branches, the moon continues to enjoy her place in superstition, as people still repeat tales of her influence on human behavior. I encourage everyone to take time out of their busy lives to glance at the moon in all her splendor — whether she stands as a full white orb, or a glimmering sliver in the sky, or shyly peeks behind slate-colored clouds. One of my favorite moon moments was years ago, when I was driving back home with my mother after visiting my grandmother. As we passed a lake whose waters gleamed like polished glass in the nighttime, we immediately noticed an enormous full moon suspended in the sky, sending her spangles of light flitting across the tranquil waters. This moment reminded me that there is still so much beauty, magic and mystery in our world, which will only continue to be revealed as the winter melts into the renewed life of spring.

We Need to Work Together as We Face



In a recent letter to the editor in the East Boston Times, Carlos Munoz-Cadilla from the Gove Street Citizens Association wrote on the facts surrounding the McKay Project. As somebody who lives in Jeffries Point not that far away from this development site, I thought he explained pretty extensively the issues regarding this latest residential development project.

I have seen in my 13 years of calling East Boston my home, the growing pains associated with ongoing development and how it has been impacting folks trying to stay in this community. However, many have become victims of the unintended consequences of the building of more residential units in the neighborhood.

I know a number of people, long-time neighborhood families who simply could no longer afford all the "progress" being made, which has made housing costs skyrocket for ordinary working folks and small homeowners.

I have been living in Jeffries Point a little over two years, previously living up on Eagle Hill. Everywhere around me now is seeing ongoing development. Most of this new housing will affect parking, it has to.

I thank the letter writer for pointing out the need for more neighborhood input. We must continue to keep communicating with everyone involved in this ongoing housing boom. It is up to the Boston Planning & Development Agency to become the watchdogs of responsible housing development. City Hall, developers and community residents need to be in constant communication in working forward together if we want to be fully responsible for the future benefit of everyone.

The Gove Street folks just want to ensure that development will move forward with the best interests of all. That's what we all want. We can build this neighborhood up, we can build this city up, and we can push Boston into becoming even better than it is today, but only by listening to everyone about what is needed. We all have different visions, but it doesn't mean opposition, it just means treating each side of the housing issue equally. There are no good guys or bad guys.

I welcome communicating with those in the development sector. We need to find good solutions together because it doesn't work if we battle each other. Keep our eyes on the goal, which is sustaining our neighborhoods that we all can enjoy and afford. There has got to be room for everyone. Boston's greatness is found in its livability.

As we move into the New Year, stay involved in your neighborhood, keep up on the issues affecting your daily lives. Talk to each other and stop being strangers. Work together to improve life around you. It starts with one person and grows into our community open to all.

Boston to Pawtucket

January 23rd Opening Date for Pawtucket-Central Falls Transit Center



Governor Dan McKee, the Rhode Island Department of Transportation (RIDOT), Rhode Island Public Transit Authority (RIPTA), and the Massachusetts Bay Transit Authority (MBTA) today announced the January 23rd opening date for the new Pawtucket-Central Falls Transit Center, which will allow riders to switch modes of transportation easily between commuter rail operated by MBTA and RIPTA's statewide bus network.

"This new station will not only add to the quality of life in Pawtucket and the Blackstone Valley but it will also dramatically expand transit options for Rhode Islanders and those visiting Rhode Island," said Governor Dan McKee. "With easy connections to and from Boston — the opening of this station continues our momentum, breathing new life into Pawtucket and Central Falls."

The rail-bus transit center will provide a robust combination of commuter rail and bus service in an emerging area of transit-oriented economic development in Pawtucket and Central Falls. It will make it easier and more convenient for many Rhode Islanders traveling to and from Boston and other destinations in Massachusetts to use bus and train service, and it will help mitigate congestion on our highways and reduce greenhouse gas emissions in Rhode Island and Massachusetts.

This additional commuter rail station in Rhode Island will supplement three other stations (Providence, T.F. Green and Wickford Junction) serviced by the MBTA, with numerous stops in Massachusetts on the route to South Station in Boston. "Whether from Quonset Point to Quincy Market or from Boston back to Broad Street, Rhode Island transit riders are better connected starting January 23rd," said Lt. Governor Sabina Matos. "This rail station, in conjunction with RIPTA's outstanding service, will offer new economic and recreational opportunities for Pawtucket, Central Falls, and all of Rhode Island — plus new opportunities

for our visitors to discover the food, art, and culture that make our state unique."

"The opportunities this transit hub will create for Pawtucket and Central Falls are bountiful. It will truly show that our two cities are desirable places to live, work, and play," said Pawtucket Mayor Donald R. Grebien. "This project has been in the works for many years, with the help of Council members, our state and federal delegation, community partners, and RIDOT. I want to thank all of them for seeing it through to its full fruition."

"The Pawtucket Central Falls Transit Center is decades in the making and the amazing result of cooperation between municipal, state and federal partners," said Central Falls Mayor Maria Rivera. "We are committed to integrating Central Falls residents into our regional economy and continuing the transit-oriented growth in the Blackstone Valley with workforce and affordable housing."

"The new train station and bus hub are modern, safe and efficient rail and bus commuter facilities, that will provide more convenient access to and from Boston area destinations while providing momentum for Rhode Island's economic development," RIDOT Director Peter Alviti, Jr. said.

"RIPTA is excited about the opening of the new center because it will markedly increase the bus-to-rail connections we can help our passengers make," said RIPTA CEO Scott Avedisian. "These connections are vital as people are encouraged to leave their cars behind and use mass transit. Our service to this new transit center is robust and includes our R-Line, our highest frequency route. We encourage people to see how seamless bus-to-rail travel can be."

"The MBTA is excited to broaden the reach of our Commuter Rail network as we offer this additional transit option for our current Pawtucket-area passengers and welcome new riders to the system," said MBTA Interim General Manager Jeffrey Gonneville. "The Providence/ Stoughton Commuter Rail Line will begin making regular and convenient stops on weekdays and weekends at the new Pawtucket-Central Falls Transit Center later this month, offering efficient service to and from South Station in downtown Boston. We thank our partners at RIDOT and RIPTA, and encourage riders to check out the upcoming service schedule available on mbta.com."

The transit center is located at 300 Pine Street, near the intersections of Pine Street and Goff Avenue in Pawtucket, located close to I-95. It includes dedicated platforms for northbound and southbound service, connected by a glass-enclosed pedestrian bridge, elevators, ramps and stairs. Its elegant design utilizes state-of-the-art composite panels with covered waiting areas. The train station also has a separate drop off area and set of stairs and ramps to the platform on the Barton Street side of the rail corridor.

The bus hub includes five berths with covered shelters for passengers, with arrivals and departures every two to five minutes during peak hours. The hub connects to a transit emphasis corridor, which includes dedicated bus lanes and bike lanes along Exchange Street and Goff Avenue, linking the new transit facility to the heart of Downtown Pawtucket. Bicycle storage racks are present at the bus hub plaza area.

Adjacent to the center, RIDOT will operate a secure, well-lit 200-car parking lot, and RIPTA will operate restroom facilities. Radar-enhanced pedestrian detection crosswalks link the parking lot, bus hub and train station.

A Nostalgic Remembrance



It was late January in 62 and I was planning to head to Miami Beach for the February school vacation. In September, I started teaching in Boston and felt I needed a break. I was supposed to stay with a musician friend but my stay with him was cut short by the unannounced arrival of his sister with no place to stay. I found a place at a Miami Beach hotel and was ready for a vacation week of fun in the sun. I received a message at the hotel to call Larry, the musician I was supposed to stay with, and when I called back, he told me that his sister wanted to meet me and he was bringing her to the beach for an early Sunday dinner to which I was invited.

A heat wave hit southern Florida on the weekend, and that Sunday, I spent more time in the tropical waters of the Atlantic than on the towel I had purchased. When it was time to meet with Larry and his sister, I dressed. Back in the day, you dressed for almost every location on the beach. The problem was that, over the weekend, I had lost about ten pounds due to the climate and my suit was just hanging on me like a sack.

At the appointed time, I met Larry and his sister. There was a famous steak place on one of the side streets off Collins Ave. called the Embers. We met there for and early dinner. The food was great and I enjoyed the company of my friend Larry's sister. She was an older woman from a working class family in Boston and Larry was the star of the family having become a well known piano player in show business circles. When it was time for them to head back, Larry gave me a list of places where he thought I might enjoy the night life and meet some interesting people who also were

On my own, I walked along Collins Ave., Miami Beach's main street. I checked out the hotels, stores and the well dressed tourists. The first place I decided to stop at was a club called Murray Franklin's on a side street not too far from the Embers where we had eaten. Do you older folks remember a Boston comedian named Freddie Ross, yes? Well, he was the headliner there. I was ushered to a table near the stage, ordered a drink, and watched the opening act. A rather attractive young lady came out on the stage holding a dummy. She sat down with the dummy on her lap and began her act. The dummy had a Yiddish accent and the voice was a male voice. When the young lady spoke, she had a female voice and spoke with an accent, also. As I found out later, she was from Naples, Italy, not Naples, Florida. So, the dummy had a Yiddish accent, she had an Italian accent and you couldn't see her lips move when she did her routine.

After she had finished, Freddy Ross was announced and he spent an hour telling jokes. I gave the waiter a note to give to Freddy, and after he was done, he left the stage and came over

to my table. The note stated that Nick Conti was my Uncle. At that point in time, Uncle Nick was the vice president of the Musicians' Union and knew just about every entertainer in Boston. Ross and I spoke for several minutes about Boston's club scene which he was an integral part of. There were two people named Freddy that were Boston headliners back then, Freddy Ross and Freddy Hall, both good comedians. Just before he decided to leave the table, he spotted the ventriloquist with the dummy that had a Jewish accent. He called her over and as we were introduced, I stood up and said, "Multo piacere." She answered me in Italian and then asked in English how I knew she was Italian. I told her that I thought I heard a Neapolitan accent when she spoke. She said, "You're right, but how did you know?" I told her that my family was Avellinese and I was familiar with the accent. She smiled as I complimented her on the Yiddish accent she used through her dummy. Her answer explained the situation. She lived in a part of Brooklyn that, was a mix of Jews and Italians.

When I left the club after an hour of conversation with the entertainers, it was time for their next show. I wandered Collins Ave again and ran into a bunch of people from Revere. They were school teachers who, like me, were trying to obtain a Florida tan during the February school vacation. We all recognized one another other as three of the four people were taking graduate courses at Boston State a couple of evenings a week, and I had met them there. They invited me to join them and we headed for what would be a tour of the night clubs that were part of the better Miami Beach hotels.

As time went on, I discovered I was not a drinker. I would order a rum and Coke with the rum on the side and gave the rum to whichever of the others wanted it. I drank the Coke. As the evening continued, I told them the story of how a travel agent wanted to book me into a hotel where he said, "my kind" could be found. When I mentioned the hotel, the Johnina, one of the crowd said that there was a lounge in the hotel that they wanted to visit as the entertainment was supposed to be good. We headed to the hotel and the Dream Bar Lounge. The entertainment consisted of just a short man named Willie Rustum. He was dressed like a beach comer and sounded like Tony Bennett.

I was totally impressed with his voice. An hour later, one of the crowd said, "It's time for the Boom Boom Room. I asked what the Boom Boom Room was and was told that it was the most famous night club on Miami Beach. Located on the lower floor of the Fontainebleau Hotel, it featured two bands, one Latin American and the other American.

After being seated at a table, we ordered drinks and I danced the night away with one of the girls in the party. Due to time spent at the Cave, a Boston Latin American night club, I had become quite proficient at handling a mambo, meringue and a cha cha cha. My partner was a good Latin dancer and I held my own. This venture would be the first of many to the long gone Boom Boom Room. Over the next few years, every time I was in Miami Beach, one of the stops had to be that night club.

The Revere crowd and I parted company in the wee hours of the morning and I headed back to the small hotel I was staying at. The next day, I headed to South Beach to catch up with the same crowd. Back then, South Beach was not the South Beach of today. It was where the inexpensive Kosher hotels were located and the crowd was composed mostly of old folks from New York. From here on in, I would spend most of that vacation week with the same crowd. It was sunny and hot every day, and at the end of the week, I had developed a dark tan. Luckily, my Mediterranean skin tans without burning.

I flew home that Sunday night at the end of the week. Dad drove past me twice as I stood waiting for him outside the Logan terminal. When he finally spotted me, Mom apologized stating they didn't recognize me at first due to my deep tan. On the way home, I sat in the back seat with Babbononno and told him the story of the vacation. He insisted that, the next time I was heading to Florida, he would come with me. I said OK, but I knew it would never happen.

La Minestra (soup) or "Minest" as many Italian immigrants referred to when they came to this country was a soup made from prosciutto bones, ham hocks or pigs feet, meats, greens, beans and vegetables. Often referred to as "poor man's soup" because many families initially made it from greens (such as dandelion) that were picked from their yards, bones and even pig's feet from the butcher, that would have otherwise been discarded. Every family had their own rendition of this soup, and most were based on either the ingredients they had on hand or those their own family favored. Even with the numerous variations in recipes, the stock usually began by cooking crushed garlic and onions in olive oil, adding some type of pork bones, and meats such as sausage, prosciutto, salumi, and pepperoni. Greens included cabbage and escarole, and the beans used were either Cannellini or Borlotti. Many recipes, including my Nonna's, even called for the addition of potatoes.

When my Nonna made this soup, she used a prosciutto bone she would get from the butcher at the meat market. Today, prosciutto bones are almost impossible to find anywhere. When replicating her recipe, I now ask the butcher for the ends of the Parma prosciutto and use them in place of the bone, and if cooked long enough, it comes just as good. You can follow this recipe which is extremely tasty or feel free to add different pork bones, pigs' feet, and greens if you like. My Nonna's "Minesta" is by far one of the heartiest and delicious old time *minestras* (soups) you will ever eat!

NONNA'S "MINEST" Minestra Della Nonna



1 pound dry cannellini beans 8 to 10 cups water $\frac{1}{2}$ cup olive oil, more if needed

6 cloves garlic (pressed) 1 medium sweet onion, finely chopped

- 1 pound spicy Italian sausage or $\frac{1}{2}$ pound spicy and $\frac{1}{2}$ pound sweet, out of casing ½ pound Parma prosciutto end
- 1 8 ounce stick all natural pepperoni, cut in quarters
- 1 medium head savoy cabbage, cleaned and chopped 2 heads escarole, cleaned and
- chopped4 large russett potatoes, peeled
- and cut into chunks
- 3 32-ounce containers chicken broth 1 parmesan cheese rind
- (optional) grated parmesan cheese salt and pepper to taste

Place dry beans in a stockpot filled with 8 to 10 cups hot water, boil 2 minutes. Remove from heat and set aside for 1 hour.

In a large Dutch oven, over low to medium heat, add the oil, garlic, and onion. Sauté until softened. Add the sausage meat, cook until no longer pink. Add the beans, pepperoni, prosciutto end, and parmesan rind (if using). Fill with just enough water to cover the beans and meats, let this come to a boil. Boil for about 15 minutes. Lower the heat and add in the chicken broth, escarole, cabbage, and potatoes. Stir together and let simmer on low heat, stirring occasionally, for about 3 ½ to 4 hours.

When cooked and full of flavor, remove the whole pieces of pepperoni and prosciutto. Cut the meats into small bite-sized pieces and add them back to the soup. Salt and pepper can be added if desired. Ladle into serving bowls and serve with fresh crusty Italian bread!

Louis Braille

Louis Braille was a French Educator who invented a tactile system of reading and writing for the blind and visually impaired in 1824. The system is called Braille and it consists of raised dot codling. While playing in his father's shop, Louis injured his eye. His eye became infected, the infection spread to his other eye resulting in Louis becoming permanently blind.


Braille's parents wanted their son to be educated. He attended school in their village and learned by listening. An attentive student, when he was 10 years old, he received a scholarship to attend the National Institute for Blind Youth in Paris.

While at the school, he met Charles Barbier, who while serving in the French army, invented a code that used different combinations of 12 raised dots to represent different sounds. Barbier called the system Sonography. Those who could not see would decode the dots by touching them. Its purpose had been for soldiers to communicate silently at night, but since it did not succeed as a military tool, Barbier thought the system might be useful for blind individuals.

Braille was one of many people at the school who found Barbier's system promising; but he also discovered its shortcomings. It was quite complex and it was based on sounds rather than letters. Braille spent three years—from ages 12 to 15—developing a much simpler system. His system had only six dots — three dots lined up in each of two columns. He assigned different combinations of dots to different letters and punctuation marks, with a total of 64 symbols.

Louis brought his system to the new director of the Royal Institute to test his code. The director read a newspaper article aloud while Louis punched his stylus into the paper to write down what the director said. When the director finished, Louis ran his fingers over the raised dots and repeated back the exact words read by the director, needless to say, the director was very impressed.

In 1829, Braille published, "Method of Writing Words, Music, and Plain Songs by Means of Dots for Use by the Blind and Arranged for Them". He became an apprentice teacher at the National Institute for Blind Youth when he was 19, and then a teacher when he was 24. In 1837, the school published the first book in Braille. By 1850, when tuberculosis forced Louis Braille to retire from teaching, his six-dot method was well on its way to widespread acceptance. Louis Braille died of his illness on January 6, 1852, in Paris, France, at the age of 43.

Now it is all about protecting their property. Those Major League arms cost too much to overuse.

Workhorses nowadays on the mound think 200 innings is more than enough. Just like 300 strikeouts in a season is gone forever, so too are lifetime 300 game winners. No one starts enough games anymore. Now, it seems to be up to either a five or a sixman rotation. As for innings pitched per game, lucky if a starter gets out of the fifth inning now.

Remembering Jimmy O'Toole from the Cincinnati Reds

Back when I was a kid. I loved baseball and watched as much of it as I could. I bought all the baseball magazines, the Sporting News, and collected umpteen baseball cards.

One of my favorite pitchers back in the late '50s into the '60s was an 18-year-old, lefty from Chicago who had

a respectable record on the mound. He came up late in the 1958 season with the Cincinnati Reds appearing in his first game on September 26th. He spent all but his last season in 1967 with the Reds when he went to the Chicago White Sox. It was sort of a homecoming for him since he came from Chicago and was the son of a Chicago cop. His last appearance in baseball was on July 22, 1967.

When he was signed as a bonus baby with Cincinnati that was a big deal. His career record was 98-84. In 1960, he was named a Topps All-Star Rookie. In 1958, when he signed with Cincinnati, they were still called the Cincinnati Red Legs, which was the team name during the Red Scare and McCarthyism. In 1959, it was apparently okay to return to the name Reds again.

His best years were 1960-1964, when he had a good ERA for that era in baseball. During those five seasons, he went 81-55. He was only 30 years old when he retired. Never a Hall of Famer, but a really good pitcher in his day. I liked him for many reasons, but one was that like me he was left-handed.

The Cincinnati Reds had a good starting rotation back in those days with O'Toole, Bob Purkey, and Jim Maloney making up three-quarters of the rotation, and in their bullpen, they had Joey Jay, a great relief pitcher.



HOOPS and HOCKEY in the HUB

EXCEPTIONAL SUCCESS POSITIVELY NOTED — That is ESPN for short, in case you had not noticed. We start with our play on abbreviations because it was the more commonly recognized ESPN media network of television, radio, streaming content, and websites that recently assigned an A+ grade to the Bruins for the excellent manner in which they have proceeded to accumulate victories through the first half of the season.

Writer Kristen Shilton assigned the B's the highest possible grade, noting that "Boston is a top to bottom powerhouse with superb goaltending, a depth of offensive talent and an excellent defense. There are so few holes in the Bruins' game they will continue to be a top Stanley Cup favorite if they can stay healthy."

She was very impressed with the play of standout goalie Linus Ullmark and top offensive threat David Pastrnak. Through January 16th, the Bruins had played 38 games, amassing an NHL leading 34-5-4 record for a total of 68 points. Ullmark had won 23 of those contests (23-2-1), posting top league wide stats in save percentage (.936) and 1.92 goals against average. Plus, according to a list published in the New York Post, he is the top favorite to win the Vezina Trophy (best goalie during the regular season).

In addition, backup Jeremy Swayman was ranked seventh in the league with a .912 save percentage and a 2.35 GAA to go with a 10-3-3 record — including an impressive 6-0 shutout against Philadelphia at the Garden on Martin Luther King Day.

Pastrnak had 35 goals and 27 assists for 62 points as of that mid-January demarcation, placing him fourth in overall scoring in the 32-team league. Even defenseman Hampus Lindholm got a positive mark for his teamleading +29 rating when he is on the ice.

In the same New York Post stats section that mentioned Ullmark, Pastrnak was ranked second among favorites to win the Maurice Richard Trophy (top goal scorer in the regular season) while Lindholm and Charlie McAvoy were also on the list of favorites for the Norris Trophy (top defenseman during the regular season).

The game on January 16th, of course, belonged to David Krejci who was playing in his 1,000th NHL contest. He did himself proud, coming away with three points by assisting on a trio of goals.

The durable center first played with the Providence Bruins during the majority of the 2006-2007 season. He made his NHL debut with Boston on January 30, 2007, but it did not go well. Seeing action on only his third shift of the night, he would suffer a concussion, causing him to leave the game with just over two minutes of ice time played.

Although he would return to play in five additional games with the B's before the season ended, it would not be until nearly a year later when the David Krejci we know began to make his mark. He continued

to play in Providence (27 games) but got called up to the Hub as the season progressed.

He scored his first official NHL goal on February 26, 2008 during a 4-0 shutout of the Ottawa Senators. We say official because a few days earlier (February 19th) he scored during a shootout to help lead the Bruins to a victory over the Carolina Hurricanes. Goals scored during shootouts do not count in the official NHL statistics.

Krecji has experienced all the ups and downs of the B's during most of the 21st century. He won a Cup with the Bruins in 2011 and played in two additional Stanley Cup runs with the team that went to the final round. The first came in 2013 when the B's were beaten by Chicago and the most recent was in 2019 when the Black and Gold were denied the Cup by St. Louis.

He went back to Europe last year to play, but not before GM Don Sweeney told him, the door was always open for his return. And return he did for perhaps the best regular season run the Bruins have experienced in decades. ESPN has written that if the current pace were to continue, the Bruins would top out at 139 points after the final regular season game in April.

But in this season of winter wonderment on Causeway Street, it will be a challenge to maintain the current pace through the early April conclusion of the regular season. There may be a brief bump or two in the road, but with all those points already banked, a high playoff seeding is virtually assured.

The key element, as Kristen Shilton wrote, is maintaining the health of the players. Pastrnak, Brad Marchand, Patrice Bergeron, and Krejci are currently the top four point producers while Charlie McAvoy and Lindholm continue to be impressive in the back end. The B's would not be where they are this season without Ullmark or Swayman (the trusty backup) for that matter. All must be available to provide the best chance for a long run in the playoffs. Significant injuries to any of these could alter the potential playoff picture somewhat.

As the season gets closer to the NHL trade deadline, (March 3rd) look for the B's to perhaps make a deal — remember there is always room for improvement, even on the best teams. The current thinking is that a potential deal for a defenseman is a possibility. As always, there will be plenty of rumors with a number of names tossed about in the mixture.

Down the road look for Coach Jim Montgomery to perhaps rest players in the closing days of the regular season, especially if the B's have the Presidents' Trophy (most points in the regular season) all wrapped up — and the four rounds of home ice advantage in the playoffs that go with it. This would reduce the possibilities of injuries to key players as the playoffs loomed.

But right now, all is well on Causeway Street as the Big Bruins ship continues to sail onward during this season of exceptional success.
