Viva, Viva La Befana!

As the calendar turns its pages towards January, a blank and tantalizing promise of a month, it can be easy to settle into a spell of disappointed gloom. Christmas wreaths and holiday lights gradually disappear from rooftops and doorways, packed away until next year. The thermometer rests at frigid temperatures, heralding long stretches of cold, gray days. An aura from festivity seems to dissipate from the atmosphere as people head back to work and school, no longer looking forward to an imminent week-long break. These bleak images tend to characterize the common perception of January, but I believe that this month offers much more merriment and reward than people would normally think. The return to a routine after the holiday break can fill us with renewed discipline and purpose, harnessing the young energy of the New Year. Yes, the days are cold, but if we pay attention, we will notice that the sun shines longer in the sky now that the winter solstice has passed, sending pale golden streaks dancing across a snowy evening. Finally, the

early days of January love to

remind us that Christmas and all its quaint celebrations are not done yet! Traditionally, the Twelve Days of Christmas ended on the Epiphany, the feast honoring the Three Kings' visit to Baby Jesus, which falls on January 6th. In Italy, this important holiday is epitomized by an indelible, rustic character named La Befana.

Across Italy, the famed Christmas markets remain open until the feast of the Epiphany, sporting figurines of La Befana and bustling with costumed entertainers dressed like this customary gift-bringer. La Befana, whose name derives from a corruption of the Italian word for Epiphany, Epifania, is a

mystical fairy-witch figure who delivers presents to children on the night of January 5th. Decked out in a raggedy dress and kerchief and riding on a broom, covered in a layer of soot from entering people's houses through the chimney, La Befana's origins mysteriously linger in the mists of time. Nowadays, several scholars believe she may function as a remnant of the

> pre-Christian goddesses that symbolized the transition from winter to spring. According to

Italian lore, a legend explains La Befana's connection to the holiday of the Epiphany. The Three Kings stopped by La Befana's house while en route to visiting Baby Jesus, and asked her if she would like to accompany them on their journey. La Befana initially declined, remarking that she was too busy sweeping her house, but later changed her mind, hopped on her broom, and set out to find the Three Kings and the Holy Family. However, she was never able to locate them and continues her hunt to this day, dropping off presents as she circles the world in search of Baby Jesus. Italian



Stirpe Nostra

ANDRONICUS LIVIUS

Roman literati (scholars) into four general groups and then listed most of the celebrated literarians in each of those groups. The first category, as you may recall, was the Early Age or the Age of Greek Influence. The greats assigned to this era are 1. Andronicus Livius, 2. The Scipionic Circle and 3. Cato the Elder.

Andronicus Livius, the first of my candidates in this Early Age is considered to have been the founder of Roman epic poetry. We all know that epic poetry deals with important historical events and historical heroes. He was born of Greek parents in the ancient Greek colonies of Southern Italy which were called "Magna Graecia." He was brought to Rome as a slave after the conquest of Tarentum in the third century B.C., while still a young man. It is thought that he took the name Livius from his master after being given his freedom. As a free man he became an instructor in Latin and Greek languages. It was during this and possibly later times that he translated Homer's "Odyssey" into an ancient Latin poetry called "Saturnian" verse. This was a kind of poetry in which the meter was based on stress accents.

Last week we divided all of His work contained some imperfections but regardless of this, the translation was used as a school-book in Rome for centuries.

For those who are not too familiar with the work of Homer, I might add that he is considered to be the earliest man of fame in Greece and the personification of epic poetry. His most popular works are of course, the "Iliad" and the "Odyssey."

The Iliad tells of the war waged by a number of Greek City States to rescue the beautiful Helen who was captured and held in the walled City of Troy and the Odyssey tells of the wanderings of Ulysses after the destruction of Troy. It also tells of the return of the Lady Helen to her husband in Greece.

About 240 B.C. Andronicus was successful in establishing dramatic poetry in the theaters of Rome and even appeared as an actor in his own creations.

Meager or scanty remains of his works are all that have come down to us but, in retrospect, Andronicus Livius should be remembered as the founder of Roman dramatic and epic poetry and for his translation of Homer's Odyssey into Latin verse.

Blending in with the Background

Barack Obama signed the National Defense Authorization Act for Fiscal Year 2014 (H.R. 3304). The massive bill (500 pages in length) funds the U.S. military and makes several changes to personnel and procurement policies. Of interest to me is a policy change that mandates all branches of the services to use the same camouflage pattern.

The change had been pushed by William Enyart, Democrat from Illinois' 12th District, who says he started wondering about all those different patterns of camouflage in the service branches after reading a Washington Post story detailing how the military now has ten kinds of camouflage and spends millions on camouflage design.

Enyart's proposal had bipartisan appeal given the duplication in the military at a time of austerity in government. A Government Accountability Office September 2012 report revealed that the military had spent \$300 million in 2011 to purchase new camouflage and millions more for design. Over time, the study found, service branches have designed camouflage that distinguish one service from another. In a decade, the services introduced seven new camouflage uniforms with a variety of patterns and colors - two desert, two woodland and three universal patterns.

"Camo" is big business. Just in the year 2013 Depart of Defense contracts for camouflage clothing totaled \$89.1 million. Much of the production of the camouflage fabrics


On Thursday, December 26th, President that go into the uniforms is done in Fall River, Massachusetts, at Duro Textiles LLC. Hundreds of jobs have stayed in Fall River, rather than being "off-shored" to low wage and less regulated parts of the world due to a law, known as the Berry Amendment (U.S.C. Title 10, Section 2533a), which goes back to 1941 and was first enacted as part of America's preparation for World War Two which requires the Dept. of Defense to give preference American made products. In the case of clothing or textiles, every stage of production from fiber, to yarn, to fabric, to finished garment that will protect our men and women in uniform, must take place in America.

> Some have argued that we should scrap "Berry" and get our uniforms, tents, and parachutes from cheaper overseas sources such as China. Such thinking is very shortsighted. Think what would happen when after the U.S. manufacturers had been put out of business by cheap foreign competition — we found ourselves at war and unable to clothe and shelter our soldiers, sailors, airmen, Marines and Coast Guard because we could not get the supplies from a foreign source that was unable or unwilling to ship

> The new Defense bill, by preserving "Berry" but also requiring a consolidation of camouflage design across the services, assures that our uniformed personnel will have a reliable source of military clothing while saving money.

Saint Adrian of Canterbury

Saint Adrian was born in the seventh century. Not much is known of his early life, it is believed he was a Berber from North Africa. He was relatively young when he became abbot of Nerida, a Benedictine monastery near Monte Cassino Italy. Pope Saint Vitalian considered Adrian to be the best person to fill the vacant position of Archbishop of Canterbury succeeding Saint Deusdedit who passed away in 664 AD. Saint Adrian deemed himself unworthy and recommended Saint Theodore of Tarsus in his place. The Pope agreed but on condition that Adrian should accompany Theodore

Theodore and Adrian left Rome in 668 and traveled by way of France, there Saint Adrian was arrested by Ebroin, Mayor of Neustria who suspected he had a secret mission from the Eastern Emperor, Constans II to the English kings and Saint Theodore alone was allowed to go on. After two years, Ebroin found that his suspicion had been groundless and allowed Adrian to proceed to England. When Saint Adrian finally reached

to England as adviser of the

Archbishop.

England, he found Saint historian Saint Bede, also Theodore already confirmed in his See as Archbishop. Theodore immediately ap-Peter in Canterbury, a monastery which had been founded by Saint Augustine, the apostle of England. The school became known as Saint Austin's.

Through his prudent advice and co-operation, Adrian assisted Theodore in unifying the customs and practices of the Anglo-Saxon Church with those of the Church of Rome. Adrian was knowledgeable in all the branches of ecclesiastical learning, he was well versed in the Scriptures and the Fathers of the Church and a good Greek and Latin scholar. The monk and

known as the Venerable Bede in his Lives of the Abbots of Wearmouth, states pointed him Abbot of Saint that Saint Adrian was also versed in astronomy, science and mathematics. Under his direction the School of Canterbury became the center of English learning. He established numerous other schools in various parts of England, educating many of the saints, scholars, and missionaries, who during the next century rekindled the light of faith and learning in France and Germany. After spending 39 years in England, Saint Adrian passed away in the year 710 and was buried at Canterbury. His feast is celebrated on January 9th, the day of his death.

10 NEW YEAR'S RESOLUTIONS FOR MY POOCH FRIENDS

The New Year is a time to reflect on the past and to look forward to improving you and your dog's life over the next 365 days. Resolving to lose weight and to become healthier for you and your four-footed friend is always at the top of the list. The New Year is also a good opportunity to become more involved in pet activities. Here are some top 10 resolutions to add to your pooch New Year's list.

1. BANISH THE BULGE. If your pooch is overweight, resolve to begin a sensible eating program. A study by the Association of Pet Obesity Prevention shows that 45 percent of dogs are overweight, including 9 percent who are obese. Cut down on the amount of food you feed, especially the packaged snacks. Most commercial treats contain too much fat, sugar and unnecessary calories. If you must give your dog a goody, add some cut-up pieces of fruit or steamed veggies to the food bowl. (But make sure to stay away from grapes, raisins, avocados and onions, as they can be toxic to pets.)

2. FIT IN FITNESS. Give your dog more exercise. Being active offers many health benefits; studies show of some canine cancers, increases life span, maintains weight loss and even improves arthritis. A daily 45 minute walk is ideal, but start off with five minutes and build up slowly. Don't forget to take a clean-up bag with you and pick up any messes your dog leaves on the street.

trip to Grandma's or any overnight with you to a dogfriendly hotel changes your dog's routine and eliminates boredom or inappropriate household behavior. Short walks to new neighborhoods. a stroll around an outdoor shopping center, hiking or a ride to the country all can work wonders.

4. TAKE SAFE RIDES. Your dog should always wear a dog safety restraint while riding in the car and should never sit on your lap or ride loose. Unrestrained dogs can cause an accident and be thrown out of the automobile into traffic. With a small dog, use a doggy booster seat with a harness secured with the car seat belt. Medium and large dogs should always wear a safety harness seat belt in the car.

5. START TRAINING AGAIN. Work on any annoying behaviors your dog might that it reduces the risk have developed, such as

begging from the table, barking at other dogs on the street, jumping on strangers or destructive chewing. "It's never too late to train a dog to do anything." To locate obedience classes or trainers in your area, ask your veterinarian or friends for recommendations.

6. GROOM REGULARLY. 3. SEE NEW SIGHTS. A Resolve to groom your dog with regular bathing, weekly nail clipping and daily brushing. You can easily learn how to do it yourself or take your dog to a groomer. More than just a beauty treatment, bathing and brushing reduces shedding and maintains a healthy coat.

7. BRUSH UP ON DAILY **DENTAL CARE.** Start brushing your dog's teeth once a day. This helps reduce dental decay or oral infection. Use a dog toothbrush, it fits a dog's mouth more easily and apply dog toothpaste, which doesn't need rinsing. If your pet's teeth are neglected, your veterinarian may need to perform a professional cleaning to reach trapped debris.

8. SEE THE VETERINAR-IAN. Your dog may not need any vaccines, but should visit the vet every 6-12 months for a general check-up. And remember, the older your dog, the more frequently he or she needs to visit the vet.

9. BE A CANINE VOLUN-**TEER.** Consider donating time or money to a shelter or low-cost spay and neuter clinic in your area. Or, volunteer to walk dogs for elderly neighbors or animal

10. ADD TO THE FAM-ILY? Thinking about a second or third dog? Make sure you have enough time to care for another pet and contact your local shelter or buy a dog from a reputable breeder.

Ring in the New Year with your dog in mind. Together, you and your pooch can work toward a healthy and happy

children eagerly await La Befana's visit on Epiphany Eve, hoping to wake up to the sight of presents the next morning. Naughty children can expect to receive a lump of coal from La Befana, though this "coal" is really rock candy!

To this day, La Befana continues to remind me of my grandmother. Both are strong, wise women who keenly encapsulate feminine power and the magic of seasons and traditions. Furthermore, I cannot think of La Befana without remembering the haunting rhyme my grandmother often sings around the Epiphany: "La Befana vien di notte/Con le scarpetutterotte/Col vestito a la romana/Viva, viva La Befana! (La Befana comes at night/with her shoes all broken/with her Roman-style dress/Long live La Befana!)" In addition to this good witch, Epiphany in Italy also boasts other fascinating traditions. It marks the definitive end to the Christmas season, as evident in a proverb that states "L'Epifaniatutte le

that the Epiphany swipes away the festivities following Christmas. However, the Epiphany also commemorates the start of the Carnival season, that riotous time of fun and indulgence which culminates on Mardi Gras, the last Tuesday before the penitential period of Lent begins on Ash Wednesday. Many cultures mark the Epiphany and the commencement of Carnival by baking King Cakes, or ringshaped pastries that evoke both the crowns of the Three Kings and the growing sun. King Cake traditions vary around the world: in France, they are made of puff pastry and filled with creamy almond frangipane; in Spain and Latin America, they are studded with candied fruits. I bake a Louisiana-style King Cake, filled with cinnamon-sugar, on Epiphany Eve and adorn it with sugars in traditional Carnival colors: yellow, purple and green. These colors are cheerful enough to brighten the dreariest January day.

When I was younger, La feste le portavia" -- meaning Befana used to frighten me

- her earthy appearance stood in such sharp contrast to the rotund Santa Clauses and jolly elves of Christmas. However, I now love her for her traditional links to antiquity, nature and feminine strength. La Befana reminds me that, contrary to popular perceptions, January is a month of exciting celebrations and customs. It is the start of the Carnival season, signaling a lot more joviality to come, an aspect that is made by clear by the colorful King Cakes that line shop windows around the world. This New Year, I encourage everyone to approach January with a positive attitude and wholeheartedly embrace its good qualities. Celebrating with magical, gift-bringing witches and delicious pastries is a wonderful place to start enjoying this month!

So off we go with another New Year! Well, according to Barbra D'Amico, many Americans no longer celebrate the arrival of the New Year — they celebrate the survival of

Christina Quinlan, thinks a New Year's resolution is something that goes in one year and out the other.

For the record, Barbra and Christina are executives at Russo Imports located in East

Wow! 62% of Americans say they are worried about losing their jobs — a record high in surveys going back to the 1970s. Among Americans in households earning less than \$35,000 a year, 75% say they worry about losing their jobs and 54% have already had their work hours or salaries cut.

Interesting to note, only 6% of Americans approve of the job Congress is doing another new low.

But when the former attorney passed away in September at the age of 98, he left behind an astonishing \$187.6 million — and willed it all to charity. MacDonald's secret fortune, amassed over six decades on the stock market, will benefit the University of Washington School of Law, the Salvation Army and the Seattle Children's Research Institute. The latter gift, worth \$3.75 million a year, is the largest single donation to pediatric research in U.S. history.

A man badly injured in the Boston Marathon bombing has become engaged to a woman who helped nurse him back to health. James Costello, who was watching at the race's finishing line, was severely burned and cut by shrapnel in the April 15th attacks. He met Krista D'Agostino while recuperating in the rehabilitation hospital where she works as a nurse. The couple began dating and decided to marry. "I now realized why I was involved in the tragedy," Costello said. "It was to meet my best friend and the love of my life."

Moron! A man who sued Washington, D.C.'s subway system, claiming he slipped on a banana peel in an elevator, was charged with fraud when video footage showed him tossing the peel on the ground, stepping on it and theatrically falling down.

A Minnesota man was charged with disorderly conduct for "making it snow" dollar bills on Mall of America shoppers, causing a ruckus as people raced to grab the bills. Serge Vorobyov says he dropped his last \$1,000 in singles on shoppers as a statement of gratitude for being alive, despite his having a horrible year. "I wanted to do some sort of pay-it-forward kind of a thing," he said. "I don't see how holiday cheer is disorderly conduct."

Gee, a 6-year-old boy in Colorado was suspended from school for sexual harassment for kissing a female classmate on the hand. The girl did not complain, but officials say that under their rules, the kiss qualifies as harassment. "This is taking it to an extreme," said the boy's mother. "Now my son is asking, 'What is sex, Mommy?'"

The penalty for harboring the enemy was execution, but Elisabeth calmly told them there were Americans inside; the Germans were welcome to join them, she said, as long as they left their weapons outside. "It is the Holy Night and there will be no shooting here." The cabin atmosphere was tense, but after dinner and wine, relations warmed. One German, an ex-medical student, examined the wounded American; another gave them directions back to their lines. They parted ways — and the truce was over.

Perhaps, the most famous SOS was sent by the sinking liner Titanic to the S.S. Carpathia, saving 717 lives in 1912. Marconi, a frequent visitor to America, never became a United States citizen.

SPIZZATEDU (Spiz-za-thay-doo) Chicken in Bianco

- 1 three- or four-pound cut-up
- 1 medium onion chopped

2 tablespoons chopped fresh or dried parsley

1/4 cup cooking oil Grated Romano cheese Water


Heat oil in a six-quart pot. Brown chicken portions on both sides. Do not burn. The browning of chicken parts in the oil and the browning residue remaining at the bottom of the pot gives the flavor to this recipe. Add chopped onion and parsley to the chicken in the pot after all chicken has been browned. Stir until onion is opaque. Remove from stove. Add enough water slowly to cover chicken contents. Cover pot and return to heat. Bring to a boil and then lower heat. Continue to cook slowly until chicken is tender. A chicken bouillon cube can be added if desired. Salt to taste.

Cook pasta of your choice according to directions on package. Place cooked pasta in a large serving bowl. Pour chicken broth over pasta and stir before serving. Sprinkle grated Romano cheese over each serving. Chicken can be served with pasta or separately, with fresh garden salad and garlic bread.

Serves four to six people.

NOTE; This is a recipe taught to me in 1949 by my motherin-law, Mary Sinopoli. The family had migrated to this country in 1892. Her mother had taught her as a youngster how to prepare this "Spizzatedu" recipe that they had enjoyed in Messina, Sicily. It was a favorite of the family in the 1800s and continues to be so for the generations that have followed.

A Nostalgic Remembrance



Happy New Year everyone, Buon Anno Nuovo. I hope you all enjoyed New Year's Eve in your own way and are looking forward to a better year than 2013. Christmas was great for us. My sons came home with their ladies and Christmas Eve was celebrated at my house with the seven fish dishes my wife cooked. My son, John, and his future bride, Beth, bought a house and hosted Christmas morning breakfast for the first time. Later in the day, we all headed to the home of my cousin, Ralph Pepe and combined families for Christmas dinner. Later in the day, Ralph looked around at all the generations of the family as they ate, drank or just socialized. He nodded and said, "The only ones missing are the old-timers." I looked back at him and said, "Oh, they're here" and I pointed to him and then myself. Our parents and grandparents generations are gone and we are the old-timers.

New Year's Eve is usually spent with a small crowd of close friends. In the past, we have celebrated either at a private club on Commonwealth Avenue in Boston or the museum of the Order of the First Corps of Cadets a few doors away. This year, we were at the home of the leaders of the pack. Dr. Dean Saluti and his lovely wife, Margie Cahn hosted the festivities at their home and a great time was had by all. On the next morning, instead of just relaxing, Loretta and I headed off to Florida to enjoy the climate. Actually, I don't think I mentioned it to you, we bought a condo in Delray Beach.

Just before we returned home in October with me facing an operation, a condo came our way. It is in a complex I was familiar with and once we saw the place, I

said to Loretta, "See that lady, she owns the place and wants to sell it. This is what I want to spend ... go bargain with her." The units in the complex are basically one level two-bedroom two-bath homes. We got it for a bargain price, thanks to my wife's ability at bargaining. I tell people she's so good at bargaining, I once saw her make an Arab rug merchant cry. Anyway, we bought the place in October and began to furnish it with the things we like, but I had to return for the operation that turned out to be three operations and has left me recuperat-

ing ever since. By the way, I want to thank those of you who knew about my problem and supported me through my stays at Mass General and Mass Eye and Ear. I will explain the circumstances. A while back, I began losing hearing in my right ear. I thought the reason had to do with too many loud drummers behind me for a 50 year stretch. I tried all kinds of hearing aids from cheapies to the expensive electronic devices that work for most people losing their hearing. Nothing worked.

My wife made an appointment at Mass Eye and Ear, and after an exam, they sent me for an MRI. The results showed that I had a non cancerous brain tumor behind my right ear. It was too big to be zapped and had to be removed surgically. I did a bit of research as to who were the best surgeons and picked one of them to handle the operation. Everything went well, but a problem arose. Spinal fluid kept rising through my system coming out of my nose, a problem occurring with about 10% of the people who are operated on for cranial tumors. I had to go back in, this time, not to Mass General, but to Mass Eye and Ear

next door. Another surgical team had to take over and remedy the situation. Following a week's stay in the hospital attempting to put both operations behind me, I needed spinal taps to see if there was any chance of spinal meningitis.

I'm in Florida because the climate is more conducive to recuperating than the cold Northeast.

As many of you know, I am a professor at a couple of colleges. I started the fall semester but had to adhere to the schedule of the first surgical team. As a result, I turned my schedule over to Colonel John Silva, a close friend whose expertise in both world history and American history rivals my own. John finished the semester for me. Since the operation, I've told the powers that be that I am taking the spring semester off to completely recuperate. I'd rather not return until I am capable of working at the level I was at before my hospitalization. I don't want to be like the unnamed great baseball players who stayed on the field that one year too long and made damn fools of themselves. As the late spring brings an end to the semester, I will see if I'm capable of teaching at my old level of performance, and if so, I will teach an early summer course.

Up to this point in my life, I thought I was going to be like Babbononno. He was never sick and neither were his sons, Uncles Paul, Nick (my Godfather) and Uncle Gino. It seems that good health runs or ran on that side of the family. I was following in the foot-steps of my maternal grandfather. In 65, I had to get my nose operated on as I couldn't breathe. Under a local anesthetic, I conversed with the doctor who asked me, "Do you come from East Boston or the North End?" When I asked why, he responded, "You told me you broke your nose once. I can account for 12 separate breaks! Another time, I was bitten by something venomous and Loretta had me medivaced to Boston to save my life. But, that was it as far as hospitals are concerned, until now.

Hopefully things are getting back to normal with one exception. The hearing in my right ear will not return and no device will ever help. When I complain to my wife, she replies' "Think of the alternative if you didn't have the operations. You might not be here to complain."

But again, as I recoup, I want to thank my friends who were there checking on me every day and those of you readers who knew of my situation and sent cards, letters and such to cheer me up. I won't forget you and will try to respond as time goes on. I close with MILLE GRAZIE and may GOD BLESS AMERICA!

Boxing lends itself very well to the big screen. I have already mentioned Body and Soul, but there are so many others. Who can ever forget Marlon Brando as Terry Malloy in On The Waterfront. His lines, "I could have been a contender" are firmly embedded in the American culture. Robert Ryan was outstanding in the role of Bill Stoker Thompson, the washed up pug stepping into the ring in The Setup, a great film noir and one of the

best boxing movies ever made. Ryan had been a champion college boxer and it shows in the fight scenes. Other great boxing movies include Fat City with Stacy Keach, Champion starring Kirk Douglas and Raging Bull, the life of Jake LaMotta with Robert DeNiro in the lead role. Filmed in black and white and filled with raw intensity, it is considered one of the best American movies ever made.

Both Thomas Eakins and George Bellows did some great paintings of boxers. Bellows was from the Ashcan School of Art and portrayed the fighters in his work as almost blending into each other. Stag at Sharkey's was his most famous, but he also did a terrific piece with his subject being the Dempsey Firpo fight. Bellows always included himself in his paintings. It is a bit like how Alfred Hitchcock always made an appearance in his films.

Eakins' work was more traditional but very detailed and impressive. His two most well known boxing pieces are Between Rounds and Salutat. Both were painted in the 1890s and appear to be set in private clubs. They look quite sanitized when compared with Bellows' work, but are beautiful

Take some time to explore this connection between the arts and boxing. You will also find plenty of music, literature and poetry on the subject. It is a rich and fun topic. If Will Shakespeare had been around back in the glory days of boxing, I am sure you would have found him hanging out at Stillman's Gym.

Happy New Year to all of my readers. I do hope this is a safe year for all those brave boxers who enter the ring, and I hope they are respected and cared about by those who make so much money off of them.

HOOPS and HOCKEY in the HUB

THE FUTURE MEETS THE PAST — It was a battle of two young basketball minds, it was, one coming from a prior era in Boston Celtics history and another representing the future of the franchise.

It was a contest that featured two mentors who had honed their careers in the Hoosier State — one who had lived there all his life until last summer and another who had arrived as recently as 2007.

In fact, if both had remained in place, the state of Indiana would be rightly proud that both of these coaches would be well on the path toward leading their respective teams to possible championships this season.

But one left — to come to one of the most storied franchises in basketball — while the other remained at the helm of a team that has a very good chance of going deep into the NBA playoffs this spring.

The men need no personal introduction to each other since they used to be basketball neighbors. Celtics Coach Brad Stevens' former office on the Butler University campus was just a few miles from that of Frank Vogel, currently the coach of the Eastern Conference leading Indiana Pacers and formerly an assistant with the Celtics.

It was the potential future of the team meeting the Celtics past since Vogel got his start working as a student manager for Rick Pitino at the University of Kentucky. He later was hired as video coordinator of the Green and White when Pitino made the jump to the Celtics in 1997. Vogel remained in that position until 2001, when he became an assistant coach under Jim O'Brien after Pitino left. He would remain with the team until 2004, moving with O'Brien to the 76ers as the Doc Rivers era began in Boston.

He later worked as a scout for the Lakers and the Wizards before reuniting with O'Brien at Indiana. In 2011, after O'Brien was let go, Vogel became the interim head coach — leading the Pacers to the playoffs for the first time since 2006. He was officially named the head coach in July, 2011.

On that night a couple of weeks back, Indiana walloped the Celtics, 106-79, a lesson taken to heart by a first-year NBA coach and given by one who took a long and winding road to reach a similar position. Perhaps Stevens will return the favor some day in the future.

NELLIE NOW — There was a great back-of-the-book story in the December 23rd edition of Sports Illustrated on former Celtic Don Nelson who had a five-decade career

in the NBA as both a player and a coach.

It turns out that Nellie, who won five NBA titles as a member of the Celtics from 1965 to 1976, is now in retirement on the island of Maui in Hawaii - and enjoying every minute of it.

Nelson, who won an NBA title ring at the end of his first season with the C's (1966), went on to win four more — in 1968, 1969, 1974 and 1976 — before moving on to a head coaching career that included the Milwaukee Bucks, the New York Knicks, the Dallas Mavericks and the Golden State Warriors.

Many things changed in the NBA between the night that Nelson was drafted in the third round (17th overall) by the Chicago Zephyrs in 1962 and the time he coached his last game with the Warriors in 2010.

But the one aspect that did not change over the course of all those years was that on any given night in the regular season (and a good number of ones in the playoffs), Don Nelson was either playing in a game or coaching in one — or reading scouting reports and watching film in preparation for his next contest.

He averaged more than 10 points a game from 1968 to 1975 while with the Celtics, in an era when the threepoint shot was years from its introduction. He went on to be named one of the Top 10 Coaches in NBA History after he left the court as a player.

And some things were long overdue — such as his September, 2012 induction into the Basketball Hall of Fame in Springfield. That year he also received his degree from Iowa State University, the school he had left five decades earlier to enter the NBA draft.

Even his choice of a retirement location came about because of basketball. In the SI piece Nellie relates that he first came to Maui for a 1963 exhibition game as a member of the Los Angeles Lakers.

He vowed to return and he did — for his honeymoon with his wife Joy in 1991 and later in retirement. At 73, he says he has no interest in coaching opportunities or broadcasting positions, preferring to stay on Maui.

But the Nelson name is still prominent in a contemporary way in today's NBA. That's because one of Nellie's sons — Donn Nelson — is the general manager of the Mavericks.

They say there will always be an England. Maybe, given that Nellie has several grandchildren, there will always be a Nelson affiliated in some way with the NBA.
