Flight Cancel Culture

Southwest Airlines over the holiday period starting just before Christmas canceled thousands of flights as the carrier continued to struggle from both that recent severe weather and was also impacted by a reportedly outdated computer system and bad scheduling practices, say insiders and experts.

While other airlines managed to get most of their flights off the ground everything seemed to have collapsed at Southwest. Capt. Casey Murrary, President of the Airline's Pilots Union, told CNN, "its phones, its computers, its processing power, it's the programs used to connect us to airplanes — that's where the problem lies, and it's systemic throughout the whole airline."

Southwest relies on reportedly mandatory overtime to keep planes running and apparently showed itself to be vulnerable to unscheduled absences. Other airlines managed to avoid the worst of this most recent holiday chaos by offering employees incentives to work during major high volume periods.

According to airlines industry analyst Robert Mann, the industry as a whole still does not have enough people to serve the number of customers that are out there looking to fly.

Bloody Christmas Weekend Across U.S.

Gun violence cut through the country over the Christmas weekend leaving at least 16 people dead including a 3 year old and 25 others wounded. From Colorado to Florida, Minnesota to Pennsylvania, Missouri to West Virginia, and of course, New York City to Chicago. The Big Apple saw nine shootings, two fatal. Chicago saw two dead and 13 wounded.

Cardinal O'Malley to Kick-off the 150th Anniversary of Historic Italian Immigrant Church in Boston's North End

In a tribute that evokes the key role of immigrants in shaping Boston's history, Cardinal Seán O'Malley will be kicking off a year-long celebration at the first Catholic church built by Italian immigrants in New England. St. Leonard of Port Maurice Church, in the North End, dates back to 1873, making it 150 years old this year.

The Church is overseen by Franciscan Friars and at this weekend's ceremony, January 8th at noon, Cardinal O'Malley will be officially installing Franciscan Father Michael Della Penna OFM as the Church's pastor — an installation delayed by COVID.

"Built through the hard work, faith and sacrifice of Italian immigrants, St. Leonard's Church is representative of the contributions made by wave after wave of immigrants who helped build Boston," explained Father Michael Della Penna, who was born and raised in the North End.

At its peak, St. Leonard's Church was home to 20,000 parishioners. The North End retains its Italian roots and architecture, hosts religious processions through the Summer months, with the endof-summer St. Anthony Festival drawing more than 200,000 visitors to the North End. The Church is located at the corner of Hanover Street and Prince Street, at the heart of the North End restaurant district.

Throughout its long history in Boston, St. Leonard's and the Franciscans have been responsible for the original St. Anthony's Shrine; St. Mary's Chapel; St. Anthony's School; Christopher Columbus High School; Home for Italian Children in Jamaica Plain; St. Stephen's Church; Sacred Heart Italian Church; St. John's School; the Peace Garden at St. Leonard's' St. Joseph's Artisans and the Encounter Homeless Ministry.

The Church was named for Saint Leonard who was known as the "Missionary to the Italians" and famously popularized the Stations of the Cross. "The objective of our 150th Anniversary is two-fold both recognizing the legacy and accomplishments of the past and at the same time providing hope for the future," said Father Michael Della Penna OFM.

Additional Background

Saint Leonard was devoted to the Way of the Cross and instrumental in getting the Stations placed throughout Rome, and so the 150th celebration will have the Stations of the Cross as its centerpiece. Some of the ways this will be achieved, over the 14 months of the celebration, include:

• Focusing each month on one of the Stations with a meditation and journaling opportunity; • Offering the Stations on the 4th Sunday of each month at 3:00 p.m., resurrecting a tradition of the late 1890s. Various groups, affiliated with St. Leonard's will be hosting the Stations. The afternoon will include a social hour following the noon Mass and Adoration preceding the 3:00 p.m. Stations; and,

• Providing parishioners the opportunity to welcome the San Damiano Cross (the Cross that St. Francis received his calling from to form the Franciscan order) into their homes for a week of veneration and prayer.

The Anniversary seeks to "Honor the Past by Building the Future" and will include monthly faith and community building events.

The first program is "From Italy to the North End: Migrant Stories and Human Lives" on January 28th at 3:00 p.m. in the Church Hall. This will feature North End historians hosting an in-depth discussion about Anthony Riccio's recent publication of oral history accounts of neighborhood residents that sheds new light on Italian immigration to Boston and its enduring legacy to the North End.

Other upcoming highlights of the anniversary include a Gala Celebration on May 5th; a traditional Dinner-Dance in October; an outdoor Mass on the Prado on June 24th and many other educational and spiritual workshops and cultural events.

Stirpe Nostra

OTHO

Marcus Salvius Otho, the seventh emperor of Rome, was also the eighth Caesar. He was born on April 23, 32 A.D. During his early childhood, he was so wild and unruly that his father often had to discipline him by flogging. Later in his adult years, he pretended love for an older but influential woman in the court of Nero and used her to worm his way into the emperor's good graces. It is said that either because of similarities in character or immoral interests. Otho became a favorite of Nero and this contact helped him to keep informed on all of the imperial plans and secrets. Their closeness was such that Nero and Otho even shared the same mistress, who was named Poppaea Sabina. She had been separated from her husband and was living with the emperor. For some unexplained reason, she was turned over to Otho who seduced her, arranged a fake marriage, and shortly thereafter they fell deeply in love. Otho then refused to let Nero or his messengers near her, and even when the emperor stood at Otho's front door, demanding the return of his mistress, the door was slammed in his face. The crafty Nero then annulled the marriage, which he thought to be genuine, appointed Otho to the office of Governor of Lusitania (present Portugal), and recovered the mistress. Poppaea Sabina is the woman that was kicked to death by Nero at a later time because she complained about the emperor spending too much

Otho performed his appointed task with remarkable moderation and integrity for about ten years. During the final months of Nero's reign, Galba appeared to be the people's choice as a successor, and Otho chose the opportunity for revenge by supporting the cause of Galba. Otho gave gifts of money to many soldiers, missed no opportunity to flatter or shower his attention on dignitaries, and when Galba ascended the throne, considered himself to be the prime candidate for adoption by the new emperor. Galba, however, selected a man named Piso. There were at least seventeen men named Piso who had attained varying degrees of fame during ancient times. This unfortunate heir to the Roman Empire was named Piso Liciuianus and he enjoyed his heirdom for only four years while Otho induced the Praetorian

time at the chariot races.

Guard to rise against Galba and assassinate him.

Shortly after Galba's death, Otho entered the Senate and briefly explained what had happened, but declared that he had been carried off by the soldiers and forced to accept the rule. Strangely enough, once he had established himself on the throne, he repaired and reset many of Nero's damaged statues, reinstated many of that emperor's administrators, and appropriated about two and one half million dollars for repairs or renovations of Nero's Golden House.

About the time that all of this was happening, the Roman legions that were in Germany

swore their allegiance to Vitellius. As soon as this news reached Otho, he persuaded the Senate to send a delegation to inform Vitellius that an emperor had already been selected and to negotiate a peaceful settlement. It soon became clear that Vitellius would have no part of Otho, and marched his legions toward Rome. With characteristic rashness, Otho decided to engage the forces of Vitellius in a decisive battle as soon as possible and was victorious in three minor clashes. Finally, as peace talks were about to begin, Otho's defenders were treacherously attacked and defeated, and this is when he decided to take his own life in order to avoid further bloodshed.

After exchanging good-byes with relatives and burning personal papers, Otho put a dagger under his pillow and slept soundly that evening. At daybreak he stabbed himself under the left breast and was dead at the age of thirty-eight after only ninety-five days of reign. Otho was never considered to be a man of great courage. He was of average height, bowlegged, and slightly feminine in the care of his person. His body hairs had been plucked out and he wore a wig. Strangely enough, many soldiers wept because of his death, some kissed his hands and feet as he lay dead, while others slew themselves beside his coffin.

Nazzaro Center Holds School Vacation Week Activities









L'Anno Bello: A Year in Italian Folklore

Which Witch?: The Meaning of La Befana

If we were only to take a quick glance around us, the Christmas season appears to basically have finished. Scraggly trees stand forlornly next to dumpsters and dusty ornaments once again occupy shelf space in the closet. Dwindling leftovers and stale cookie crumbs speak of the great holiday feasts the previous week. However, according to both religious and folkloric calendars, we are still in the midst of the Christmas season! Christmas lasts for twelve days, up until January 6th, which is the feast of the Epiphany. In Italy, the Epiphany, or la Epifania, is a significant holiday with traditions that equal those of Christmas Eve. An ancient feast day, the Epiphany honors the visit of the Three Magi to Baby Jesus. On the eve of this holiday, Italian children excitedly head to sleep, knowing that in the morning they will find their stockings full of presents from La Befana, Italy's premiere gift-bringer. Along with the arrival of La Befana, the Epiphany also ushers in the Carnival season, a joyous time of mischief which paves the way for spring. With its appealing imagery of magical witches and playful silliness, the Italian Epiphany bursts with unique and fascinating customs.

Nowadays, Italian children receive presents on Christmas from *Babbo Natale*, or Santa Claus. However, *La Befana* has still retained her status as Italy's most famous folk figure and favorite gift-bringer. Who exactly, then, is this mysterious character? *La Befana*, whose name derives from a corruption of the word "Epifania," is a fairy-like witch who, like her male counterpart, drops presents in the stockings of good children

while leaving behind coal for the naughty. She is typically depicted as an old woman in ragged clothes mounted on a broomstick. A well-known legend explains La Befana's connection to the Biblical story of the Epiphany. According to this folktale, La Befana was sweeping her house when the Three Magi approached her, inviting her to accompany them on their way to find Baby Jesus. La Befana initially declined, saying she was too busy with her cleaning. However, she later changed her mind and hopped on her broomstick, flying through the sky in an effort to find the Magi. Unfortunately, she was never able to locate them, and still soars through the air with her broom to this day, depositing presents for children as she continues to search for Baby Jesus and the Magi. When I was a little girl, I was frightened of La Befana, whose stern and haggard countenance formed a sharp divide to the jolly and merry-faced Santa Claus. My apprehension was amplified by the haunting traditional melody my grandmother sang, which intoned: "La Befana vien di notte/Con le scarpe tutte rotte/ Col vestito a la Romana/Viva, viva La Befana!" (Translation: "La Befana comes at night/With her shoes all broken/Dressed in the Roman style/Long live La Befana!"). However, I now love La Befana for her powerful symbolism of feminine strength and her unique sense of magic. Many scholars believe that the figure of La Befana originated from old folk goddesses who oversaw the transition from winter to spring, which intensifies her cultural significance.

spring. The winter solstice has already passed, and the hours of sunlight slowly lengthen. The sapphire-blue skies and golden sunsets of these midwinter evenings instill in me an excitement over the turning of the yearly cycle. Though we can of course expect more months of snow and cold, the promise of spring now unfolds quietly before us. The Epiphany ends the Christmas season, as is evident in an Italian dictum which proclaims: "La Epifania tutte le feste le porta via" ("The Epiphany sweeps all the feasts away"). However, the Epiphany does introduce another season, that of Carnival. Carnival, the precursor to Lent and Easter, extends from the Epiphany to Mardi Gras, or the Tuesday before Ash Wednesday. As such, Carnival serves as a spring festival, a herald to the still far-off feast of Easter. All over the world, people bake King Cakes on Twelfth Night, or the eve of the Epiphany. King Cakes are breads made specifically for the Epiphany and Carnival season, with variations differing worldwide. In France, King Cakes contain a flaky crust and an almond frangipane filling. Spanish King Cakes are adorned with candied fruit. Louisiana-style King Cakes are ring-shaped, with a cinnamonsugar swirl inside and a colorful topping. I make this kind of King Cake every Twelfth Night, decorating it with the traditional Carnival colors of green, purple, and yellow. I follow the folk custom of hiding a chickpea inside the cake-whoever finds it will receive good luck in the coming year! With such a cheerful dessert promising good times ahead, the revelry of Carnival can officially begin! Though the Twelve Days of

Christmas are nearing their close, the celebrations do not have to end. The Epiphany provides us with ample ways to bring more festivity into our lives. We honor the arrival of La Befana, the magical witch who fills children's stockings with presents under the cover of night, who symbolizes the ancient strength and power of women while also ushering the change of the seasons. We can celebrate Carnival, that long welcome to spring that fills our days with color and laughter. As the Christmas season yields its way to the bright new days of January, we should always maintain our childlike wonder and our love for the magic and mysteries of Mother Earth inside us. So let us get ready for La Befana, for she lights our path to a joyful season of hope and promise!

MassDOT at it Again With Street "Makeovers"

The Mass Department of Transportation is at it again with bringing its plan to remake the Revere portion of Bennington Street between Beachmont and Suffolk Downs and Bennington Blue Line stations in its ongoing push crafting a statewide bicycle path network to protect and encourage more folks to bike it everywhere they can. MassDOT says it would reduce carbon emissions, TRAFFIC and promote public health. This state agency has been visiting cities and towns explaining how good these new project designs will enhance our quality of life.

I capitalize TRAFFIC because this is what Massport and the woke climate fanatics want to address. How to get more people out of their cars and onto bikes or public transportation. I stopped believing in the tooth fairy a very long time ago. Question everything they throw at us. Make them prove things to us. Who knows what disinformation looks like anymore?

Time for our elected officials to stand up for us. It is really getting harder for any of us to take anything at face value anymore, isn't it?

Saint Comgall of Bangor



Comgall was born sometime between 510 and 520 in Dál nAraidi in Ulster according to the Irish annals near the place now known as Magheramorne in present-day County Antrim. Comgall's father was Setna, a Pictish warrior; his mother's name was Briga.

He served as a soldier, and then studied with Saint Finnian of Moville. He was ordained to the priesthood by Bishop Lugaid before the age of forty.

Comgall and several companions lived for a time on an island in Lough Erne in county Ulster, where they observed a very strict ascetical life. He intended to go to Britain, but was dissuaded from this step by Lugald, bishop who ordained him, at whose advice he remained in Ireland and set himself to spread the monastic life throughout the country. Comgall established a monastery at Bangor (Bennchor) on the southern shore of Belfast Loch (in modern County Down). The monastery was founded sometime between 552-555.

It is believed that over four thousand monks were trained by Saint Comgall at Bangor, including Saint Columbanus of Luxeuil and Saint Moluag. Saint Comgall often prayed while standing in the water for several



hours. Sometimes at night his cell was ablaze with a heavenly radiance.

It is believed that there was a remarkably close connection between Comgall and Columba though there does not appear to be sufficient authority for stating that Comgall was the disciple of Columba. He is said to have been the friend of St. Brendan, St. Cormac, St. Cainnech, and Finbarr of Movilla. After intense suffering he received the Eucharist from St. Fiacra and passed away in the monastery at Bangor in the year 602. The feast of Saint Comgall is May 10th.

A Nostalgic Remembrance



I've mentioned a few times that I was a musician before becoming anything else in my young life. By the time I was in my late teens, I had been working at the Seville Theater for about six years but needed more money to continue with a college education. Work for free lance musicians was plentiful during the Christmas season, but after the first of the new year, it slowed dramatically. Just about the time it would start to pick up again, Lent would arrive, and then it really slowed down. Thankfully, Dad and my uncles had day jobs and didn't have to worry about putting food on the table, but full time musicians sometimes had problems. The exceptions were the players in the Boston Symphony and the Boston Pops, chamber groups, those on the road with what was left of the big bands and musicians who played the clubs in and around Boston.

My first steady job under my professional name began early in 1959. I had a trio consisting of piano, bass and drums. We played dance music from the Great American Songbook and jazz and were hired to play at a local bar (I won't mention the name) located near the Union Oyster House. The reason I didn't mention the name is that the place was so bad, the local rats were too proud to go in. They had sawdust on the floor and an out-of-tune upright piano in the corner. Beers were fifteen cents and the most provocative hard drink was a boiler maker. We played Friday and Saturday nights but it was blood money and I hated working there.

Toward the end of our booking, I got a call to audition for the lounge at the Charter House Hotel. The Charter House was located on the water's edge where Revere Beach and the Lynn Road come together. When we auditioned, the manager hated our music. A well-dressed-couple was sitting at a table in the lounge as the manager made comments on his dislikes. The couple interrupted him and asked if we knew a tune called Joey, Joey. I said yes and my pianist sang it as we played it. The manager got up to leave and was stopped by the couple who then said, you're hired. The manager turned purple until the male of the couple said, "He's the manager of the hotel, but I'm the owner ... you're hired. The woman then added, "We have a son named Joey. He's challenged but loves the song Joey, Joey. Thank you."

I told the couple that, as a courtesy, I would have to give a two week notice to the owner of the place we were now playing at. Coincidentally, when we got there that Friday night, we were given a two week notice. (Thank God)

As opening night approached, I let all of my friends know about the new job. Babbononno insisted on going but he didn't drive, nor did Mom. Dad was

working so Uncle Gino and Aunt Ninna picked up my mother and Grandfather and then headed to our opening night. Surprisingly, many of my friends also showed up that first night, and the place was packed. As time went on we attracted a new crowd that enjoyed our music and I was happy. I was also happy that I didn't have to deal with the manager who hated us. On my way home after that opening night, I began thinking about the musicians who had only music to rely on for a living. They were the free lance musicians who played the dances, private parties, weddings, Christenings, bar mitzvahs and other one nighters that were available before the DJs took over some of the business and made work even more scarce. As time went on, many of those musicians had to opt for day jobs to survive. When I spoke to Dad and Babbononno about my observations, they both said the same thing. I had my teaching profession during the day and music was a sideline which afforded me some of the luxuries in life. Later, it also allowed me to pay for several graduate degrees without having to borrow money.

That job lasted for about a year and a half. The couple that owned the hotel sold it and the new owners and management changed the entertainment format and brought in a top forty rock band to attract a younger crowd. As a result, we were out.

For the next year or so, the pianist took over getting us booked and we played many of the lounges and night clubs that dotted Route 1 in Revere, Saugus and Peabody. Part way through those club engagements, the drummer announced he was getting married and wanted to quit playing. A new drummer didn't work out and then another complication set in, the pianist began having marital problems and the trio fell apart. I next made some contacts in New York City and began working there on weekends but that too, was short lived. Many of the clubs I played in closed due to lack of business only to reopen as rock and roll clubs.

As luck would have it, once I decided on ruling out playing in New York any longer, I got a call from the manager of Piety Corner Gardens in Waltham. This facility had a function room, a men's bar, a dining room and a nightclub. From Wednesday through Saturday, they had entertainment in the nightclub and needed a band to play for dancing and cut the shows. I put together another trio and we got the job. We were well received by everyone. On opening night, Dad wasn't working and when I looked down from the stage during our second set, there was Dad. Mom and Babbononno sitting at a front table. Later, in came Uncle Nick and Aunt Dorothy. It was a family affair.

After a month on the job, my pianist showed up one Friday night with flu symptoms. An hour later he was too sick to play, and during a break, I began making phone calls trying to get a last minute replacement. I finally got someone who arrived fifteen minutes later than when we were supposed to return to the stage. Later that night, the manager chewed me out, screamed obscenities at my musicians and fired the band. Knowing that Uncle Nick was the president of the union at that time and was friends with the club owner, I figured I would let him handle things through union channels.

The following week, I received a call from the club owner who asked me to return. I told him I wasn't interested due to the fact that I would not work for the manager he had running the place. His comment was, "Sorry to say, that man is my nephew. I fired him yesterday, and if you decide to return, you will answer to me, only. We began again that Wednesday night and stayed there for two years.

What ended the engagement was tragic situation. The owner went home early one weekend night and left his son to lock up. On his way home, the son fell asleep at the wheel and was killed. The owner was never the same and the place soon closed its doors. One door closes, another opens. I had been knocking on doors in Hollywood and they were calling back ... a story for another day.

On New Year's Day, it is customary in Italy to eat *Cotechino* with Lentils. The Italians believe the lentils represent good fortune, and the pork signifies prosperity and wealth. Therefore, anyone indulging in this concoction should be destined to prosper in the New Year!

In the hopes of a better year ahead, my family honored this tradition and each New Year's Day, "Lentil Soup" and homemade Italian bread was served. To welcome the New Year with hopes for health and good cheer, I am sharing my favorite "Lentil Soup" recipe. In place of the spicy pork sausage or *Cotechino*, I use pancetta. However, feel free to add the sausage if you wish! *From my home to yours, Auguri di Buon Anno ...*

LENTIL SOUP Zuppa di Lenticchie



1/4 cup olive oil

4 ounces pancetta, chopped

1 medium onion, finely chopped

3 garlic cloves, finely chopped

3 carrots, peeled and chopped

3 celery stalks, chopped

1 (14 1/2-ounce) can crushed tomatoes

1-pound lentils, soaked and washed

12 cups chicken stock/broth

1 cup uncooked ditallini pasta1 cup shredded parmigiano reggiano cheese

salt and pepper

In a large stockpot, heat oil over medium heat, then add the pancetta, onions and garlic. Cook for 6 to 8 minutes. Add the carrots and celery and continue to cook, until tender. Lower the heat to a simmer, add the tomatoes and cook, stirring occasionally, for about 10 minutes. Add the lentils and broth, mix well. Raise the heat and allow the mixture to come to a boil. Immediately lower the heat to a simmer, cover and cook for about a half hour or until lentils are cooked. Add the uncooked pasta and simmer until al dente. Season with salt and pepper. Ladle the soup into bowls, sprinkle with grated cheese and serve!

A COLUMN OF PAST AND CURRENT EVENTS

ELLIS ISLAND - "Ieri"-The 27.5-acre island located in New York harbor now known as Ellis Island was once known as Kioshk to the Mohegans Native Americans, in reference to the population of seagulls that made it their home.

In 1630, the Dutch bought Kioshk as a gift for Michael Reyniersz Pauw, who had helped found New Netherland. When the Dutch settled the area as part of New Netherland, the three islands in Upper New York Bay — Liberty, Black Tom, and Ellis Islands — were given the name Oyster Islands, alluding to the large oyster population nearby. The present-day Ellis Island was thus called "Little Oyster Island" a name that persisted through at least the early 1700s. Little Oyster Island was then sold to Captain William Dyre in 1674, then to Thomas Lloyd on April 23, 1686. The island was then sold several more times.

By the 1760s, Little Oyster Island became a public execution site for pirates. Little Oyster Island was acquired by Samuel Ellis, a colonial New Yorker and merchant possibly from Wales.

Samuel Ryerson, one of Samuel Ellis's grandsons, deeded the island to John A. Berry in 1806. The remaining portion of the island was acquired by the federal government. Through the 1870s, the Navy built additional buildings for its artillery magazine on Ellis Island, eventually constructing eleven buildings in total.


The Individual states rather than the federal government regulated immigration into the United States at that time. Castle Garden, located in the Battery of Manhattan, served as the Net York State immigration station from 1855 to 1890, approximately eight million immigrants passed through its doors mostly from Northern Europe.

On April 11, 1890, the federal government ordered the artillery magazine at Ellis Island be torn down to make way for the U.S.'s first federal immigration station at the site. In 1890, a new immigration station was constructed on Ellis Island, which began receiving arriving immigrants on January 1, 1892. Annie Moore, a teenager from Ireland and her two brothers were the first immigrants to be processed.

With the passing of the Emergency Quota Act of 1921, the number of immigrants being allowed into the United States declined greatly, ending the era of mass immigration. Following the Immigration Act of 1924, strict immigration quotas were enacted, and Ellis Island was downgraded from a primary inspection center to an immigrant-detention center, hosting only those that were to be detained or deported. In November of 1954, the last remaining detainee on Ellis Island, a Norwegian named Arne Petersen, was released and Ellis Island was officially closed by the U.S. government.

In June 1964, the National Park Service published a report that proposed making Ellis Island part of a national monument. This idea was approved by Secretary of the Interior Stewart Udall in October 1964. Ellis Island was added to the Statue of Liberty National Monument on May 11, 1965, and in August, President Lyndon B. Johnson approved the redevelopment of the island as a museum and park.

Today, Ellis Island combined with Liberty Island, location of the Statue of Liberty, have formed one museum now known as the National Museum of Immigration.



Boost the Health and Beauty of Your Houseplants

Fight the post-holiday blues with a bit of indoor gardening. Keeping your houseplants healthy and looking their best with a bit of grooming this winter is sure to lift your spirits.

Clip off any dead leaves as they appear. Use a sharp snips or bypass pruner to make a clean cut that looks tidy and closes up quickly. An occasional brown leaf is not usually a problem but if browning continues, it might be time to take action. Evaluate the growing conditions and make needed adjustments.

Brown leaves are often caused by low humidity which is common in many homes during winter. Boost the humidity in your home by grouping plants together. As one plant loses moisture through its leaves through transpiration the neighboring plants benefit. Add pebbles or marbles to the saucer or trays beneath the plants. Allow excess water to collect in the pebbles below the pot. As the water evaporates it increases the humidity right around the plant. Move plants that require moist soil and high humidity into a terrarium. They are attractive living decorations and make caring for high-maintenance plants easier.

Over and under-watering can also result in brown leaves, leaf edges, and tips. Water thoroughly when needed. Base frequency on the plants you are growing, room temperature and humidity. Tropical plants need more consistently moist soil while cacti and succulents like it drier. With lower light conditions in many homes, plants grow slower and may need less frequent watering in winter. Pour off any excess water that collects in the saucer which can lead to root rot.

Stop fertilizing indoor plants in winter unless they are actively growing. Applying fertilizer that plants don't need can cause root damage, leading to leaf discoloration.

Trim off brown tips that are common on spider plants, dracaenas, Ti plants, and prayer plants sensitive to the chlorine and fluoride in water. Avoid the problem by using chemical-free water.

Wipe dust off the leaves with a damp cloth. Use a cosmetic brush to clean the fuzzy leaves of plants like African violets. Keeping your plants clean and well-groomed also helps reduce insect and disease problems.

Further protect plants from pests with Summit Sticky Traps (SummitResponsibleSolutions. com). Just place one or two in the pot with the sticky side exposed. The yellow attracts fungus gnats, aphids, thrips, leaf miners, and other harmful pests feeding on your plants. The sticky surface traps the insects causing them to die without the use of pesticides. Replace the trap once it is covered with insects or every three months.

Boost indoor plant resilience by providing the right amount of light. Move plants to a sunnier window or add artificial lights as needed. Then give plants a quarter turn every time you water. This promotes more balanced growth by exposing all parts of the plant to the light source.

Taking time to tend to your plants improves their health and beauty while elevating your mood and helping fight stress.



HOOPS and HOCKEY in the HUB

And then he was gone. For the second time in a little over a month.

A pair of surprises that no one would have believed unless they actually happened.

One was the biggest trade in the history of an NHL franchise.

The other involved one of the most highly anticipated games for the Bruins in the early years of the 21st century. And he had figured in both.

It was a saga unlike any other. The early years of a destiny to be continued at another location. The termination of a hope that did not come to fruition in the Hub.

It was the story of Joe Thornton and his time on Causeway Street, an era that unofficially ended some 17 years ago (January 10, 2006) in the opening minutes of a regular season game between the Bruins and the San Jose Sharks at the Garden.

The events marked a significant juxtaposition in his career—between all the possibilities of his selection in the 2006 NHL draft and what can be regarded as an unfulfilled finale before the Garden faithful.

June 21, 1997 was not only the first day of summer, it also marked the night that Joe Thornton became the number one overall selection in the 35th NHL Draft, held at the Civic Arena in Pittsburgh, the city of three rivers. Fast forward to the spring of 2022 and Thornton was the last active player from that draft still skating in the NHL.

Being chosen first brought with it a high dose of media attention. When the Bruins assembled for their training camp in the fall of 1997, the lenses of all television cameras were focused on Thornton, an 18-year-old from St. Thomas, Ontario.

Unfortunately, for Thornton, he was being billed as the savior of a franchise that had not won a Stanley Cup since 1972— even though at that point he had not played a single game in the NHL.

Joe Thornton was supposed to be the real deal right out of the box with no warm-up needed. Just let Joe take the ice and away we go to the promised land of the Stanley Cup Final. No one could have cleared a bar so high.

But make no mistake; Jumbo Joe was a very good player. He progressed gradually rather than immediately, indeed, he served as captain of the Bruins from the start of the 2001-2002 season until his departure on November 30, 2005.

Despite his rather prolific scoring, the Bruins remained essentially a middle of the road team. They were not bad, but they were not that good either — particularly when it counted — in the playoffs. The B's only advanced to the second round twice and did not even qualify for the playoffs several times during the Thornton era. General Manager Mike O'Connell came to be frustrated and Thornton also seemed to be unhappy - despite signing a three-year \$20 million contract extension in August 2005.

O'Connell decided to pull the trigger a little over three months later — on the last day of November. Thornton was thought to have taken the news hard with the *Boston Herald* reporting that he had been seen crying in his car.

Three players from the Sharks came east — Marco Strum, Wayne Primeau, and Brad Stuart. In return the Bruins leading scorer went west — only to return to the Garden six weeks later with the Sharks for their one game of the season in Boston on January 10th.

The buildup for the game grew in intensity as the date approached with everyone expecting the former Bruins star to play a full game.

Another surprise awaited the Garden faithful on game day. Thornton had departed the Bruins as their leading scorer with those 33 points. But as he took to the Garden ice some six weeks later as a member of the Sharks he was still the Bruins leading point producer — no one on the current roster that night had yet surpassed him. Thus you had the current leading scorer for the Bruins playing in the Garden as a member of the opposing team. A super surreal scene.

But the final surprise of the night was yet to come. Just a little more than five minutes after the game began Jumbo Joe was gone, having been assessed a game misconduct penalty during his second shift for hitting former Bruin teammate Hal Gill from behind.

The force of the blow drove Gill into the boards where he sustained a pinched nerve in his left shoulder. He immediately went to the B's locker room and did not return to the game which the Sharks won 6-2.

According to ESPN at the time, Gill bore no ill will toward Thornton — who had been his teammate for many years — and considered him a friend. For Thornton, the six-week interval enabled him to develop a perspective of understanding concerning the trade.

"The big thing is when [NHL] teams don't go the way they are supposed to go, people get traded or people get fired," Thornton told ESPN. "It is just the nature of the business."

Indeed, the trade did not remove GM Mike O'Connell from the hot seat. About four months after the deal was made, O'Connell found himself the recipient of a pink slip. On March 25, 2006 it would be his turn to walk the plank.

As some observers have pointed out, the Thornton trade began a major period of change for the Bruins. The money saved from Thornton's contract created enough financial space to sign free agent Zdeno Chara in July 2006. In addition, with Thornton's departure, Patrice Bergeron became the team's top center, a position he still holds today.

And Joe Thornton became one happy man. He went on to complete the 2005-2006 season with the Sharks in fine fashion, scoring 20 goals and adding 72
