## A PROCLAMATION ON COLUMBUS DAY, 2022

HOME BRIEFING ROOM PRESIDENTIAL ACTIONS

In 1492, Christopher Columbus sailed from the Spanish port of Palos de la Frontera on behalf of Queen Isabella I and King Ferdinand II, but his roots trace back to Genoa, Italy. The story of his journey remains a source of pride for many Italian Americans whose families also crossed the Atlantic. His voyage inspired many others to follow and ultimately contributed to the founding of America, which has been a beacon for immigrants across the world.

Many of these immigrants were Italian, and for generations, Italian immigrants have harnessed the courage to leave so much behind, driven by their faith in the American dream — to build a new life of hope and possibility in the United States. Today, Italian Americans are leaders in all fields, including government, health, business, innovation, and culture.

Things have not always been easy; prejudice and violence often stalled the promise of equal opportunity. In fact, Columbus Day was created by President Harrison in 1892 in response to the anti-Italian motivated lynching of 11 Italian Americans in New Orleans in 1891. During World War II, Italian Americans were even targeted as enemy aliens. But the hard work, dedication to community, and leadership of Italian Americans in every industry make our country stronger, more prosperous, and more vibrant. The Italian American community is also a cornerstone of our Nation's close and enduring relationship with Italy — a vital NATO Ally and European Union partner. Today, the partnership between Italy and the United States is at the heart of our efforts to tackle the most pressing global challenges of our time, including supporting Ukraine as it defends its freedom and democracy.

In commemoration of Christopher Columbus's historic voyage 530 years ago, the Congress, by joint resolution of April 30, 1934, and modified in 1968 (36 U.S.C. 107), as amended, has requested the President proclaim the second Monday of October of each year as "Columbus Day."

NOW, THEREFORE, I, JOSEPH R. BIDEN JR., President of the United States of America, do hereby proclaim October 10, 2022, as Columbus Day. I direct that the flag of the United States be displayed on all public buildings on the appointed day in honor of our diverse history and all who have contributed to shaping this Nation.

IN WITNESS WHEREOF, I have hereunto set my hand this seventh day of October, in the year of our Lord two thousand twenty-two, and of the Independence of the United States of America the two hundred and forty-seventh.

## Mayor Wu Announces Release of **BOSTON COMMON MASTER PLAN**

45-Day Public Comment Period Provides an Opportunity for the Public to Shape Implementation Phases

Mayor Michelle Wu today announced the official release of the new Boston Common Master Plan, a comprehensive vision for the future of the "People's Park." The planning process incorporated the input of Boston residents and park users to create a roadmap for preservation, maintenance, and public use. The recommendations include a comprehensive redesign of the Boston Common Frog Pond, including the Tadpole Playground; expanding the Visitor's Center; adding an accessible entrance at Shaw 54<sup>th</sup> Memorial; pedestrian improvements at the Charles Street entrance from the Public Garden; renovation of the heavily-used Mayor's Walk pathway;

piloting restrooms in several locations; and better activation of the Boylston Street plaza and entrance.

"Boston Common's gorgeous tree-lined paths and open spaces have hosted so many moments marked in history, from shaping our collective conscience to celebrating our communities," said Mayor Michelle Wu. "We're excited to be sharing a plan that honors the Common's history, reflects the community's vision, and creates a space that will be more accessible, more resilient, and more inclusive for generations to come."


The master planning process was guided by the goal of crafting an atmosphere of civic access and engagement. In June of 2019, public engagement kicked off with an online survey and "Mini-Common" pop-up exhibits. Mini Common pop-ups were deployed in the park and across the city at MBTA stations, community events, and farmer's markets. These pop-ups gave residents and visitors the opportunity to comment on specific areas of the Common, evaluate current programming, and recommend potential interventions and improvements. The team then held several open houses, both in person and virtually throughout 2019-2020 to gather suggestions from the community to inform potential changes. All

# Stirpe Nostra

#### **CLAUDIUS' OLD ROMAN MUSIC**

Not unlike his predecessors, and commonly a characteristic going handin-hand with imperial power, was Claudius' brutal attitude toward persons of lower rank. In time, he developed a very cruel and bloodthirsty disposition. Criminal witnesses were always examined by torture, and during gladiatorial shows he gave orders

that even those who accidentally fell should be slain. He liked to watch the faces of persons who were being tortured or were dying.

During the noon lunch break in the Colosseum, he would often remain in his seat and, if any of the service crew did not adequately perform their duties that morning, he would hastily match them up for combat in the arena. He even forced one of his pages to enter the arena for combat while wearing a toga.

He put his father-in-law and two granddaughters to death on unsupported charges, and gave them no opportunity for defense. He did likewise to his son-in-law Pompeius and also the fiancé of his youngest daughter. He is reported to have sentenced to death more than 35 senators and 300 Roman knights with easy indifference.

Claudius was also notorious



for his timidity and suspicion. He never attended a banquet without his guard and personal servants. The entourage included at least one official taster. He never visited a sick friend without first having the room inspected for hidden weapons and even the sick person's bedding was searched. Those who visited his palace for a morning call were subjected to the strictest search, and even women were grossly mishandled.

The dinner parties of Claudius were frequent and very luxurious. He often entertained 500 to 600 persons at one meal. Because of the enormous amount of food that was consumed, which of course was most eastern cultures as well

as with the Romans, the good old after dinner belch was considered polite and a compliment to the host. Even the most learned felt that the greatest wisdom was to follow these dictates of nature. Claudius supported this philosophy to the extent that he came very close to enacting a law permitting any emission of wind in public

places. Doctors suggested to their patients that they take full advantage of the attitudes and liberties favored by this well-meaning but effervescent emperor and just throw caution to the winds. As I sit here before my trusty Underwood upright, I can't help but wonder what the "sound of old Roman music" must have been like with 500 or 600 banqueting and contributing guests.

Claudius had an almost insatiable appetite for food and drink. He never left the dining room until he was fully stuffed and half "crocked." He went to sleep immediately after dinner, lying on his back and with his mouth open. It was standard operating procedure for his attendant to bring in a feather and a bucket to prove that

## L'Anno Bello: A Year in Italian Folklore

Italy's Spine-Tingling Side

Halloween season is officially upon us! An old-fashioned holiday wreath hangs upon my door, boasting Victorian images of smiling pumpkins, girls sporting pointy witch hats, and bats in mid-flight. Jack-o-lanterns and arched black cats grin mischievously from store shelves, with thin lights flickering inside them like little captured sunbeams. The cornstalks and scarecrows that adorn my neighbors' front steps speak of the concluding harvest season, while the colorful leaves that flutter to the ground against the backdrop of a slate-gray sky remind us that the year itself now winds down to its close. Halloween is the time to revel in all these examples of a world turned upside-down, of the pleasure of the unknown and the thrill of everything that is mysterious and spine-tingling. Though modern Halloween celebrations are largely an American phenomenon, the United States does not have a monopoly on spooky imagery or mythical creatures. Across the ocean in Italy, people also ready themselves for Halloween, and may draw upon their own unique mythology and folklore. So in the spirit of Halloween, let's dive into the eerier side of Italy, the side that you may not find in tour books but certainly plays an important part in the Italian character!

Italy has long had a fascination with the occult, stretching back to the days of Ancient Rome. The modern Italian prejudice against the number seventeen, similar to the American superstition of unlucky thirteen, stems from the burial customs of the Romans. The Roman numeral for seventeen, XVII, can be rearranged to spell VIXI, or the Latin word meaning "he lived" — a phrase frequently carved into ancient tombstones, and therefore linking the number with death. Ancient Rome's penchant for the macabre did not end with numbers, however. Romans shivered with fear over the *lemures*, or terrifying ghosts. These ethereal beings haunted certain houses or roads because, as many ghost stories stated, they could find no rest due to an improper burial or some sort of injustice committed against them during their lifetime. The Romans eve



holiday called *Lemuria* which sought to appease these spirits, and this creepy feast may form the origin of an olden superstition that advised against marrying in May. Ancient Romans also resorted to supernatural omens in order to predict the future. Priests known as augurs interpreted the flight of birds to divine looming events and outcomes. Haruspices had to report the future with a much yuckier method: they scoured the entrails of sacrificed animals for omens! While modern Italians are certainly less superstitious than their ancient counterparts, many remnants of Rome's mysterious folklore persist to this day, such as the ubiquitous charms against the evil eye and the popular red horn-shaped amulets said to bring good luck.

Though Ancient Rome's love for the mysterious is wellstudied, contemporary Italy nevertheless brims with a plethora of scary monsters and eerie folktales. Werewolf stories abound in Italy, where the hairy shape-shifting beast bears the name licantropo. The fear of the licantropo hearkens back to the time when the wolf stood as the most dreaded predator in the forests of Europe, especially during the nights of the full moon, when certain men could morph into this formidable animal. My father frequently spoke of hearing the plaintive howls of wolves in his secluded Italian village, and such a chilling memory is a testament to the strength of the werewolf myth. Similarly, the witch, or strega, constitutes a complex symbol in Italian society; sometimes functioning as an example of evil and other times signifying benign and astute female power. The gift-bringer of the Italian Christmas season La devoted the month of May to a Befana, is even depicted as a kindly fairy-witch figure. It can only be captured on the Epiphany, and this event forms a part of the region's folksy holiday celebrations to this day. Visitors to Naples may hear tales of the Monaciello, or "little monk," a gnome-like creature who resides in the city's old abbeys, monasteries, and canals, playing harmless tricks on people and offering help to wayward travelers. Meanwhile, the famous Lake Como boasts its own version of the Loch Ness Monster, a living dinosaur known as the Lariosauro! With all of these fascinating legends and beings, Italy is a prime destination for Halloween thrills and hair-raising adventures.

Halloween provides us with the wonderful opportunity to have fun with the mysterious. From witches to ghosts to vampires, all of the hidden, spookier aspects of society come out to play during this chilly autumnal night. This Halloween season, I will also be thinking about the mythical creatures and unnerving legends that form a part of my Italian heritage, old and new. After all, folktales and myths do a lot more than just give us a thrill. They connect with the universal fears, concerns, and desires of people across generations, emotions made manifest in guiding superstitions and metaphorical monsters. Let's celebrate the unknown on Halloween and reflect on how it impacts our lives as humans and our collective unconsciousness. Halloween teaches us that there is far more to the world than immediately meets our eye and the legends and beings of yore are prime examples of this lesson!

Boston, the Cradle of Liberty, has done just that where woke politicians now seem to be running things. What makes me really upset are the number of





## Saint Bruno of Cologne

Bruno was born in Cologne about the year 1030. According to tradition, he belonged to the family of Hartenfaust, one of the principal families of the city. He studied theology in the presentday French city of Reims before returning to his native land.

His education completed, Bruno returned to Cologne, where he was ordained a priest around 1055, and sent to St. Cunibert's Church. In 1056, Bishop Gervais recalled him to Reims, where the following year he was placed in charge of the schools and given oversight of all the educational establishments of the diocese.

Bruno led the school for nearly two decades, acquiring an excellent reputation as a philosopher and theologian. Among his students were Eudes of Châtillon, who would become Pope Urban II, Rangier, Cardinal and Bishop of Reggio, Robert, Bishop of Langres, and a large number of prelates and

The people of Rheims wanted to make Bruno archbishop; he



decided to pursue an eremitical life. He became a hermit under Abbot St. Robert of Molesmes (who later founded Citeaux) but then moved on to Grenoble with six companions in 1084. They were given a place for their hermitages in alpine area called La Grande Chartreuse, by Bishop St. Hugh of Grenoble, whose confessor Bruno became. They built an oratory and individual cells, followed the rule of St. Benedict, and thus began the Carthusian Order. They embraced a life of poverty, manual work, prayer, and transcribing manuscripts, though as yet they had no written rule.

The fame of the group and their founder spread, and in 1090, Bruno was brought to Rome, against his wishes, by Pope Urban II (whom he had taught at Rheims) as Papal Adviser in the reformation of the clergy. Bruno persuaded Urban to allow him to resume his eremitical state, founded St. Mary's at La Torre in Calabria, declined the Pope's offer of the archbishopric of Reggio, became a close friend of Count Robert of Sicily, and remained there until his death on October 6, 1101.

Bruno wrote several commentaries on the psalms and on St. Paul's epistles. He was never formally canonized because of the Carthusians' aversion to public honors but Pope Leo X granted the Carthusians permission to celebrate his feast in 1514, and his name was placed on the Roman calendar in 1623. His feast day is October 6th.





#### LAMB OF GOD -**OMEN**

(Vinyl) / Epic Records Lamb Of God personnel are: D. Randall Blythe (vocals); Mark Morton (guitar); Willie Adler (guitar); John Campbell (bass) and Art Cruz (drums). The band grew from basement shows and grimy DIY venues to arena headliners. Over the course of their career, the Richmond, Virginia-based band earned a reverence akin to musical forefathers (and road companions) Metallica, Slayer, and Megadeth. Timeless songs like "Laid to Rest," "Redneck," "Walk with Me in Hell," and "Now You've Got Something to Die For" became anthems in the heavy metal songbook. They shoved heavy metal into the new millennium with New American Gospel (2000). As the Palaces Burn (2003) joined Rolling Stone's Top 100 Greatest Metal Albums of All Time. Ashes of the Wake (2004) was the first Lamb Of God album certified gold by the RIAA, a feat once all but impossible for a contemporary extreme metal band. Sacrament (2006), Revolver's Album of the Year, went gold as well. The raw and organic malice of Wrath (2009) began the band's enduring relationship with Wilbur. Both the diverse Resolution (2012) and the explosive VII: Sturm und Drang (2015) debuted in the Top 5 of the Billboard 200. The 2020 self-titled set, their first new material in five years, added instant classics "Memento Mori" and "Resurrection Man" to the repertoire, alongside eight more monster tracks. Revolver, Metal Hammer, and Loudwire included Lamb Of God on their year-end Best Albums lists. The momentum continues with Omens, the band's ninth studio album, and most aggressive and ambitious album yet. Densely muscular, soaked in unnerving spite, with a pessimistic eye toward inner struggles and global affairs alike, Omens is a furious entry in the Lamb Of God catalog, perhaps their angriest album yet. "The world is crazy and keeps changing. Omens is a reaction to the state of the world," explains vocalist Blythe. "It's a very p---ed -off record." He pauses for emphasis. "It is extremely p---edoff." The tracks on Omens, were recorded live in the studio with longtime Producer Josh Wilbur and includes Blythe's vibrantly unhinged vocal attack plus Morton and Adler's threatening riffage to challenge and devastate headbangers alike and also features Cruz and Campbell's unstoppable rhythms. The album's first single, "Nevermore," was released in June, followed by the second single "Omens," and most recently "Grayscale." Tracks begin with the thumping beat of "Nevermore," followed by the head slam of "Vanishing," continuing the sound via "To The Grave," then the in-your-face "Ditch," filling the first side with the and the hook of the title track "Omens." Flip side opens by lowering the decibels and pace with "Gomorrah,"

trailed by the solo sound of "Ill Designs," their current single "Grayscale," the heart pumping "Denial Mechanism," and close out their solid effort with the piercing sound of "September Song."

#### **BOBBIE GENTRY** THE GIRL FROM CHICKASAW COUNTY: **HIGHLIGHTS FROM** THE CAPITOL MASTERS (2LP-Vinyl) **UMe**

Bobbie's seven studio albums revealed an extraordinary body of work that merged Americana, soul, country, chamber-pop, bayou funk, jazz, folk and psychedelia across recordings that possessed incredible musical ambition. Plus a quality of songwriting that lay within, where Gentry brings alive her evocative tales of life in the Deep South with all the characteristics of that region, its people and its customs illuminated to stunning effect. The result is the release of The Girl From Chickasaw County: Highlights From The Capitol Masters. Compiled and produced by Andrew Batt, Highlights From The Capitol Masters is the ultimate "all killer, no filler" Bobbie Gentry best of collection. The compilation draws from all of Gentry's studio albums supplemented by the cream of the previously unreleased recordings including tracks from her "lost" jazz album, The Windows Of The World, that was a standout vinyl release of 2021, the deluxe edition of her classic album The Delta Sweete, other outtakes, demos, rarities and live performances taken from her celebrated TV series for the BBC. Other picks include the classic original of "Ode To Billie Joe," alternative versions of "Mississippi Delta," "Touch Em' With Love" and the classy Glen Campbell duet "Let It Be Me," "Mornin' Glory" from The Delta Sweete, her definitive "Hushabye Mountain," pop soul triumph "Fancy," and the melancholy "Lookin In" from her final album. In addition, there are exceptional acoustic demos of originals like "Hurry Tuesday Child" and "Seasons Come, Seasons Go," new songs that never came out like "Smoke" and "Joanne," alongside essential covers of "Conspiracy of Homer Jones" and "God Bless The Child." For the hardcore collector, a number of the recordings have been remixed from the multitracks especially for this release including "Caskette Vignette" and "Recollection." Bobbie Gentry's career blazed brightly for a few short years, but only now is the full extent of her artistry coming into focus. The mystery of her disappearance detracts from her narrative as a self-made woman who strove for financial and creative independence. When we think of empowered female stars we think of Taylor Swift, Beyoncé, Madonna, or even Dolly Parton, but before all of them there came the girl from Chickasaw County. This impeccably curated new set reminds us once again just how special an artist she was. Enjoy

input was incorporated in the master plan's vision, guiding principles, goals and objectives, and recommendations.

This extensive stakeholder and public outreach captured a diverse range of voices across the city and beyond, allowing the project team to integrate the community feedback with considerations of the park's history, current conditions, and function. This holistic process allowed the team to identify the interventions most fundamental to the use, character, health, and management of the Common now and into the future. Top recommendations in the Master Plan include clarifying park entrances, connecting and upgrading core visitor amenities, enhancing and diversifying programming, establishing park management protocols, and improving support facilities.

#### The Plan Sets Forth Five Principles to Guide All Recommendations:

- · Support and sustain a multifunctional park for the full diversity of users from all backgrounds and neighborhoods;
- Strengthen the park's natural, historic, cultural, and visual landscape character;
- Expand amenities to support park visitors;
- Improve safety, maintenance, and management of the
- Improve the natural and physical infrastructure of the Common for quality and resilience.

With the release of the master plan, the City of Boston is asking the public to share priorities  $for \ implementation -- selecting$ high-priority projects related to accessibility, recreational opportunities, landscape improvements, historic interpretation, restrooms, and food options — during the 45-day public comment period that ends on November 30, 2022.

"The Boston Common is both a historic park and a central gathering space in our city," said Reverend Mariama White-Hammond, Chief of Environment, Energy and Open Space. "As the "People's Park", we knew this process required significant community engagement and we are excited to share the Boston Common Master Plan that brought together all the feedback we received into a cohesive plan."

"I am pleased to finally be able to share the Boston Common Master Plan, a document years in the making thanks to a partnership between the Boston Parks and Recreation Department and the Friends of the Public Garden," said Ryan Woods, Commissioner of the Boston Parks and Recreation Department. "This Plan is the result of a robust community outreach process and ties together all the elements that make the Common such a great public space. Future park users will find improvements throughout the Common with increased flexibility, better use of space, new features, and enhanced visitor orientation and interpretation."

"With this Boston Common Master Plan, America's first public park will have a unified vision for evolving and adapting to meet the needs of Boston's residents and visitors to our city as well as of the park itself," said Liz Vizza, President of the Friends of the Public Garden. "Parks need people and people need parks. A shared space like the Boston Common is a critical place for community, civic life, and respite in our city that deserves our continued investment and attention to bring the Plan to life."

A major tourist destination, cultural beacon, and neighborhood park, Boston Common is one of the most treasured green spaces in the world. This investment will ensure that the park's natural, historic, cultural, and visual character is strengthened and preserved for future generations.

#### **ABOUT** THE PARKS AND RECREATION DEPARTMENT

The Parks and Recreation Department creates and maintains clean, green, safe, and accessible public parks and open space throughout Boston. The department is responsible for 217 parks, playgrounds and athletic fields, two golf courses, 65 squares, 17 fountains, 75 game courts, 16 historic and three active cemeteries, urban

wilds, four High School athletic fields, and approximately 125,000 trees, all covering 2,346 acres, 1,000 of which comprise the historic Emerald Necklace. Parks and Recreation is also responsible for more than 35,000 street trees.

A Nostalgic Remembrance



Babbononno, once he settled down in Boston, became involved with all things Italian.

Back in his day, just before the turn of the 20th century, there was a lot of discrimination and prejudice leveled at the unwanted newcomers, the Eyetalians. As a result Italian organizations sprung up in every community the new comers settled in. The one dominant, now national, organization is the Sons of Italy. This year, the local lodges celebrated the 108th anniversary of the Grand Lodge of Massachusetts.

Babbononno was proud of his people and wanted to help, through this organization, the new comers who might have trouble adjusting to American life. What he later told me and I verified it with a bit of research was, 95% of the Italians who came here in that first wave, from 1880 to about 1900, were from southern Italy (south of Rome), and were illiterate in both Italian and English. Because of the isolation in southern Italy, they were distrustful of people from other provinces than their own. Napolitani didn't trust Siciliani, Siciliani didn't trust Calabrese, etc ... Once in America, they continued with this approach to people, and as a result. remained fragmented as an ethnic group. Not knowing the ins and outs of the culture, they let mercenaries, mostly Italians who preceded them, take advantage of them. So, 108 years ago, when the OSIA came into existence in Boston, Babbononno was right there, ready to help Italians less fortunate than himself.

It wasn't all business. When my mother and uncles were kids, there were family event that were sponsored by the Sons of Italy, dinner parties, dances, outings when the weather was good, and church activities. as most of the Italian population was Catholic.

Babbononno was lucky once he came here. He had two talents he could put to good use and make money. My great grandmother, Maria, sent her son Michael to the parish priest in Foggia to learn music and a trade. From that priest, my grandfather learned to make furniture and how to build things out of wood. He also learned how to play drums and guitar. Once in America, Babbononno would find immediate work utilizing his talents in furniture making and he would join with other Italians musicians and play music at night. As a result, he did rather well. My father's father,

on the other hand, was illiterate in Italian and English, did not have a trade, and once he got here, was handed a pick and shovel, and told that, if he wanted to work, he had to utilize those tools as a day laborer at construction sites. This is what he did until he retired at

Babbononno and Grandpa Christoforo brought up their families in 2 worlds, the world of the Italiani in America and the world of the Americani. Sometimes it was rather tough, but my parents, uncles and aunts survived and that second generation of the Contini and Christoforo families did rather well. The one thing the old timers didn't stress was education. In the old country, the elite that controlled, the clergy and the nobility (maybe all enemies) were educated. They were not to be trusted and whatever they did, you did the opposite. If they sent their sons to school, you sent your sons to learn a trade. No education for the girls. The way a man was judged was by his sore back and the calluses on his hands. With that same philosophy in play in America, most of the first born generation, went into family businesses or learned a trade. The girls from Italian families might work when they were single, but that was to help support the family or put money away for when they got married. My mother loved math and was a whiz at it all her life, but she was forced by Babbononno to quit school when she was in the 10th grade. She went to work as a salesgirl in retail and remained at her job until she married my father. Later in life, she told me that she had regretted not continuing her education.

Dad and my uncles were proponents of education and made sure their children went to school. As a result, all of my cousins and I finished high school and went off to college.

None of us left home, as that wasn't heard of in those days, so we attended local colleges ... a compromise that came from being part of Italian families.

Well, that was a long time ago, and my story started out about the 108th anniversary of the Sons of Italy. My dear friend, Dean Saluti, and I were sitting down at dinner one night and the subject of who and what we were came up. Considering our successes in life, we both agreed that it was time to give back something to the Italian or Italian American community and we both became involved with the Sons of Italy. We

became involved with a new lodge in the 1980s, The Greater Boston Renaissance Lodge. Dean eventually became the president and I the orator. Dean has staved in that position, but I moved-on to positions within the Grand Lodge of Massachusetts, calling it quits after two terms as the state treasurer. I was the one who signs the checks.

The Sons has dwindled down over the years. It really isn't needed for survival any more as we've taken our place alongside the rest of the Americans. Today, it's more social than protective, but there are issues still out there: discrimination, prejudices and ethnic biases. And let us not forget Hollywood's images of The Godfather and The Sopranos. These discriminatory images we constantly fight on local and national levels through the OSIA and several other organizations like the Italian American Alliance, the American Italian Anti Defamation League, Columbus Citizens Foundation, Italian American Civil Rights League, the Italian American National Union, Italy-USA Foundation and many more.

Union membership in the blue and white collar trades has helped since they opened their doors to the new comers (us) beginning around the first decade of the 20th century. As an example, I am third generation in my family to belong to the American Federation of Musicians. Dad and Uncle Nick (my Godfather) were executive officers in the Boston local for many years, and I was the CEO of the Professional Musicians Club for 13 years. As a teacher in Boston, I belonged to the Boston Teachers' Union and as an actor I had to belong to the Screen Actors Guild and American Federation of Radio and Television Artists.

When I've discussed Italian organizations with my sons, they've told me that they had no interest as there didn't seem to be any need. It seems that their social lives include people of all races and ethnic backgrounds. If that's the case, then we've come a long way since my grandparents stepped on American soil for the first time and were looked upon as the outsiders. I guess we've arrived.

Sicily's most cherished fall and winter fruit are their Sicilian Blood Oranges, and the only region in the world they can be found grown authentically is in Catania. Sicilians take such pride in their blood oranges that they honor their existence with a Sagra dell'arancia rossa (Blood Orange Festival) in Palagonia each year, towards the end of February. Sicilian Nonna's use these oranges to eat plain, or make all sorts of delicious treats, including candied orange peels, orange ricotta cookies, Sicilian orange and fennel salads, and of course, those renowned Sicilian whole orange cakes.

My Nonna always had oranges at her house. In fact, she kept them in a fruit bowl in the middle of her kitchen table and everyday she'd have one as an afternoon or evening snack. She told me when she was a young girl; oranges were considered a special treat. After eating them, her dad would take the peels and place them on top of their warm stove, and within seconds their home would be filled with a sweet citrusy aroma. Like most Sicilian women, my Nonna also used oranges to cook and bake with. Candied orange peels dipped in dark chocolate were a favorite of my mother and mine. There was a cake she made with a whole orange that many enjoyed, though I found it to be a bit too pungent for me. I favored her Torte Arnica Sicilian; a dense buttery ciambella with a moist and tender crumb. Nonna's Sicilian Orange Cake is perfect for breakfast or as a snack, and even more delicious when served as a dessert and topped with a dollop of homemade mascarpone whipped cream!

#### SICILIAN ORANGE CAKE Torta Arancia Siciliana



2 cups butter, softened 2 1/4 cups sugar 4 cups all-purpose flour ½ cup potato starch 1 package paneangeli lievito (or 2 1/2 teaspoons baking

½ teaspoon salt ½ cup whole milk

9 large eggs

1 ½ tablespoons pure vanilla extract

Zest of 3 organic oranges

#### **ICING**

powder)

1 ½ cups orange juice

1 ½ cups sugar

Preheat the oven to 350°. Grease and flour a ciambella or tube pan, set aside. In a large mixing bowl, cream the butter with 2 1/4 cups of sugar until light and fluffy. Sift in flour, potato starch paneangeli lievito, salt, and mix well. Add the milk, then the eggs, one at a time, beating after each addition. Stir in the vanilla and orange zest, mix well. Pour the batter into the prepared pan and bake for 1 hour 10 minutes, or until a toothpick inserted into the middle of the cake comes out clean. Remove from the oven and using a toothpick or bamboo skewer poke holes into the entire cake and then let it cool.

In a small saucepan, combine orange juice and 1 ½ cups of sugar over medium heat. Bring to a boil and remove from heat. With a pastry brush, coat the entire cake with the syrup, allowing it to seep inside. Cool slightly and enjoy!

snub U.S. outreach and reduce production, which would guarantee an increase in oil and gas prices.



## Plant in Fall for a Colorful Spring Display

It's time to think spring. Fall is the time to plant tulips, daffodils, crocus and other spring flowering bulbs. Use these early bloomers to welcome spring to your landscape. You'll appreciate the color and cheery blooms after another long winter passes.

Extend your enjoyment by including early blooming bulbs like snowdrops, squills, and winter aconites. Add early, mid, or late spring blooming tulips

and early and mid spring flowering daffodils for a continuous display of color. Check the package or catalog description for bloom times.

Create some winning combinations by planting white tulips with grape hyacinths or yellow daffodils with the equally assertive blue squills. Plant a fragrant garden bouquet by combining tulips, daffodils and hyacinths. Select varieties that bloom at the same time in complementary colors or blends.

Include summer flowering hardy lilies. Many are fragrant and these stately beauties provide vertical accents in the garden. Cut a few stems to display in a vase or mix with other flowers in summer bouquets.

Don't let hungry animals stop you from brightening your spring with these bulbs. Include animal resistant bulbs like hyacinths, grape hyacinths, daffodils, fritillarias, and alliums.

You can plant tulips, crocus, and lilies, just be sure to use physical barriers like chicken wire or animal repellents like rain resistant Plantskydd (plantskydd.com). It's an organic repellent that comes in both liquid and granular formulations to protect bulbs animals prefer to eat.

Lay the bulbs out on newspaper, apply the liquid repellent, and allow them to dry before

growing success.

Wait until the soil is cool to plant your bulbs. This is usually after the first hard frost or when night temperatures average between 40 and 50 degrees. Plant the bulbs two to three times their vertical height deep and at least two to three times their diameter apart. Try grouping at least six to nine larger bulbs, like tulips and daffodils, and 15 to 20 smaller bulbs, like squills and crocus, together for greater impact.

Mix a low nitrogen, slow release fertilizer into the soil surface and water thoroughly after planting. Continue watering thoroughly when the soil is dry throughout the fall, while the bulbs grow roots.

After you enjoy their blooms next spring, leave the leaves intact until they yellow. Leaves produce the energy needed for next year's floral display. Mask the fading foliage by planting winter hardy pansies with your bulbs in fall, adding color to both fall and spring gardens. Or plant bulbs amongst perennials. Early spring flowering perennials double your pleasure, later bloomers extend the flowering season, and both help hide fading bulb foliage.

Break out your trowel and gloves and get busy planting. You'll be glad you did when that first flower appears next spring.





# HOOPS and HOCKEY in the HUB by Richard Preiss

BRUINS MEDIA DAY — It was a rather crisp Columbus Day morning that greeted us as we made our way to Warrior Arena in Brighton for the annual Media Day of the Black and Gold, an event that serves as the commencement of the regular season that is to follow.

It was the first time since the coming of Covid-19 and all it protocols that there seemed to be a sense of near normality to the proceedings, an atmosphere that one hopes will firmly take hold during the upcoming season.

"I feel that as the restrictions were lifted (as last season went on), there was a bit of a feeling out period for a lot of our fan base about whether they were comfortable coming into TD Garden, regardless of what the restrictions were from city or state," observed Bruins Chief Executive Officer Charlie Jacobs during the event's feature press conference.

"We have begun to level set, in terms of whether those that were not comfortable have either moved on, sold their tickets or decided to come back and find some comfort in attending a game in person."

Jacobs noted that that unlike football, basketball and baseball, revenue from fans that attend games in the National Hockey League continues to play a significant role in the revenue streams of the various teams. "Hockey, unlike most other major sports, is really gate-driven, so it is important for us to get our fans in the building. He stated that while things may not quite be back to normal ("I won't say back to normal") it probably will be "the next normal that we will experience in 2022-2023."

The chief executive also indicated that he feels the team as constituted has the capacity to perhaps pleasantly surprise the fan base. "I try to leave the style of play and team performance to management but I feel we have a very competitive team that, I think, a lot of people don't expect. We have a more offensive team than maybe in years past and that is saying a lot considering we won 51 games last year."

For Bruins President Cam Neely, the results boil down to coming out and giving your all. "It is about not seeing any nights off. You may not play well on a certain night but you can certainly compete. I think we are pretty deep but for me it is just about competing every night. So that is what I expect."

Neely added that: "I am excited about this roster. I am excited about getting going. I think our players are really excited about this team. Talking with the guys that have been around here a long time, there is a really special feeling in the locker room right now. It is encouraging for me to see. I think these guys feel like something special can happen this year."

There has been quite a bit of speculation about the start of the season, given that several players will be out of action during the opening weeks. Thus, General Manager Don Sweeney feels that the health issue "is a two-fold issue for us. We have to get healthy and stay healthy. That is a challenge in the National Hockey League to begin with. But if fully healthy, I think our group is deep."

Sweeney feels that performance could be dictated by the health issue "but I like how our group has come together overall. I like the balance but the players have to go out and perform to what we think our expectations are. We are going to be a highly competitive team. We are going to be there at the end and challenge. A lot of things have to go right (once a team gets into the playoffs). But you have to get in and earn that right."

The GM added that because of the health issue, putting together a roster for the start of the season has been somewhat of a challenge. "The decisions we made (during training camp) give us more flexibility. It is the nature of some of the things we have to deal with — putting the roster together when you are teetering on guys that are going to come back as opposed to guys where that is unknown. Some guys are ready to come back within a shorter period of time. They are not out for the whole season. We are fortunate in that regard because they are good players."

A possible forecast of how this team will fare this season may come within a few weeks since Neely is a fan of the Thanksgiving Day indicator. This theory holds that how the various NHL teams stand on Thanksgiving Day is a pretty good indication of where they will finish in the regular season standings come April.

Concerning the critical position of goaltender, new head coach Jim Montgomery indicated that he will not designate a number one goalie to start the season but will let the play of Jeremy Swayman and linus Ullmark determine that as the season progresses.

He credited veteran B's goaltending coach Bob Essensa with doing "a great job with the goalies — making sure that the Bruins get excellent goaltending throughout the regular season so as to have the opportunity to get into the playoffs.

That is the objective of all 32 teams in the regular season — to make the playoffs. Even if a team just makes the postseason, it can pull off surprises in the playoffs — the second season. Columbus knocked off powerful Tampa Bay in a first round sweep during the 2019 playoffs. That same spring St. Louis, which was in last place in the (then) entire 31-team league on New Year's Day, won the Stanley Cup in June.

Continuing on, Coach Montgomery said that after the trade deadline (in late winter) and definitely by the time the team reaches the playoffs, one of the goalies will have played himself into the top position.

"That is up to one of those two goaltenders to emerge ahead of the other. In today's NHL, to have success in the regular season, you have to have two goalies that can do the job night in and night out."

And so it begins. Another important regular season to determine the teams that will compete in the Stanley Cup Playoffs next spring.
