Defiant Marine Freed

A Marine officer who was sent to military prison for weeks after demanding "accountability" for the botched U.S. pullout from Afghanistan was released on October $5^{\rm th}$.

Marine Training and Education spokesperson Capt. Sam Stephenson said in a statement that Lt. Col. Stuart Scheller would be allowed out "as a result of a mutual agreement between Lt. Col. Scheller, his Defense counsel and the Commanding General, Training Command."

Scheller went viral after he posted a video on Facebook in which he tore into military leadership following the August 26th ISIS-K suicide bombing at Kabul airport.

Speaking Truth to Power

"People are upset because their senior leaders let them down and none of them are raising their hands and accepting accountability or saying 'We messed up.'"

The day after the posting, Lt. Col. Stuart Scheller announced he was resigning his commission after 17 years. On a September 16th Facebook posting, Scheller accused General Kenneth McKenzie of 13 counts of dereliction of duty. Days later, the military and Scheller's family confirmed that he had been



THE CHARACTER OF ROMAN STRUCTURES


The shape, nature or characteristics of all structures that have been built at any time or place in history have been influenced by their geographic location, geology, climate, religious beliefs, and social attitudes. Understanding these influences is a prerequisite to an understanding of the architecture of any country.

Roman building was influenced by the availability of marble, materials for making brick, chalky deposit called tufa (which also made excavations

for the catacombs practical), excellent sand and gravel, a clean earth called pozzolana which helped in making a strong and durable concrete, and by exposure to the work of Phidias and the "golden age" of Athens.

The Greeks had developed a civilization of the highest order. When the Romans conquered the Greeks, they brought many Greeks back to Rome and used them as servants and tutors. These tutors and the high degree of Greek cultural development greatly influenced all of Roman life including their architecture.

An order of architecture is a column sitting on its base and the horizontal structure above it, which is called the entablature. The Greeks developed three orders of architecture. These are called Doric, Ionic and Corinthian and were used as structural elements as well as decorative features. Structure and ornament were blended



into one.

For example, the columns that held up the structure were also the predominant decorative feature. Removal of the columns would cause serious structural problems. The Classical Greeks spent about five hundred years working on and improving all features of their temples, such as the thickness, height, and spacing of the columns and the curvature of all horizontal and vertical lines to correct optical illusion. It is said that the typical Greek Temple was mans' most

nearly perfect creation.

When the Romans conquered the Greeks, they accepted and used the Doric, Ionic and Corinthian Orders but added two more of their own design. These two are called the Tuscan, which is not fluted, and the Composite, which is a combination of Ionic and Corinthian.

The Romans generally built their buildings first and then applied the orders as decoration later. Parts of structures are still standing even though the decorative features were removed centuries ago. The two very important structural contributions made by the Romans were the use of concrete and the employment of the arch to cover large areas, thus bringing the element of space into their architecture. They didn't invent the arch but were the first to use it to any great extent.

ELECTIONS OF THE COMITES

The elections for the renewal of *Com.lt.Es* (Comitato degli Italiani all'Estero) for the Consular jurisdiction of the Consulate General of Italy in Boston will be held on *December 3, 2021*.

The *Com.It.Es* are entities representing the Italian Community and assisting for its integration in the foreign Country in which they are located. The Committee to be elected will be composed of twelve (12) members, based on the number of residents in the community.

Italian citizens of legal age who are registered with AIRE (Registry of Italians Resident Abroad) and already resident in the consular jurisdiction *as of June 3, 2021* may participate in this important electoral event.

Elections are held by mail. **To vote, you must register in the voters' list**, utilizing the FAST-IT portal, or by filling out a form available on the website and by sending it to the Consulate by e-mail, by mail or by dropping it off in person during Consulate's opening hours *no later than November 3, 2021.*

All registered voters who requested to partecipate will receive a ballott during the month of November.

Voters must return to the Consulate the prepaid envelope with the ballot *no later than December 3, 2021.*

Christopher Columbus United a Divided Human Race, For that We Honor Him



Monday we celebrated Columbus day in the North End and throughout Boston, Massachusetts, and the nation. It is fitting that Columbus is one of three mortals to have a federal holiday in his honor.

Prehistoric global migration of mankind left the world with two populations, one in the Old World, the other in the New World, each wholly ignorant of the existence of the other. Monday we celebrated Columbus Day in honor of his historic voyages that opened communication, commerce, and migration between the Old World of Europe and the New World of the Americas. Richard Brian Polito, 58, passed awayunexpectedly on October 2, 2021, at his home in Revere.


He was born December 19, 1962, in Boston, MA. He was the son of Lois L. (Fawcett) Polito and the late Richard O. Polito.

Tony DeMarco

Beloved Boston icon Tony DeMarco, Boxing Hall of Famer, and former undisputed Welterweight Champion of the World, "The Flame and Fury of Fleet Street," passed away of natural causes on October 11, 2021 at the age of 89. DeMarco captured the hearts of Massachusetts boxing fans and proud Italians all over the country on April 1, 1955, by knocking out Welterweight Champ Johnny Saxon in front of a delirious crowd at the Boston Garden, just blocks from his home on Fleet Street in Boston's North End.

Born Leonardo Liotta, he "borrowed" the name Tony DeMarco from an older friend so he could box professionally,

because at 15 years old, Leonardo was not eligible. By showing his friend's baptismal certificate as proof of age, Leonardo was able to get his boxing license, and from that point on he was known as Tony DeMarco.

Following his championship win, DeMarco's historic matches with Boxing Hall of Famer, Carmen Basilio, are still considered two of the greatest fights of all time. Although DeMarco lost the title fight and rematch to Basilio, he went on to fight a total of eight world champions beating the likes of Kid Gavilan, Paddy DeMarco, Virgil Akins, and Chico Vejar.

After his retirement from boxing, Tony moved to Phoenix, Arizona, and opened a successful nightclub, Tony DeMarco's Living Room, which he operated for twenty years before returning to Boston where he resided for the rest of his life. Referred to as "The Champ" in the North End, Tony was always very accommodating to fans and tourists. The unofficial ambassador of the North End, Tony would often be seen chatting with fans and posing for pictures with them. Former Mayor

Thomas Menino renamed Fleet Street to Tony DeMarco Way, and several years later, in 2012, Tony was honored with a statue at the corner of Cross and Hanover streets, the entrance to Boston's North End. Tony's autobiography, Nardo: Memoirs of a Boxing Champion was released in 2011, and in 2019, Tony DeMarco was inducted into the International Boxing Hall of Fame to take his place alongside many of the champions he faced during his



L'Anno Bello: A Year in Italian Folklore

When Italy Turns Eerie

Halloween season is officially upon us! An old-fashioned holiday wreath hangs upon my door, boasting Victorian images of smiling pumpkins, girls sporting pointy witch hats, and bats in mid-flight. Jack-o-lanterns and arched black cats grin mischievously from store shelves, with thin lights flickering inside them like little captured sunbeams. The cornstalks and scarecrows that adorn my neighbors' front steps speak of the concluding harvest season, while the colorful leaves that flutter to the ground against the backdrop of a slate-gray sky remind us that the year itself now winds down to its close. Halloween is the time to revel in all these examples of a world turned upside-down, of the pleasure of the unknown and the thrill of everything that is mysterious and spine-tingling. Though modern Halloween celebrations are largely an American phenomenon, the United States does not have a monopoly on spooky imagery or mythical creatures. Across the ocean in Italy, people also ready themselves for Halloween, and may draw upon their own unique mythology and folklore. So in the spirit of Halloween, let's dive into the eerier side of Italy, the side that you may not find in tour books but certainly plays an important part in the Italian character!

Italy has long had a fascination with the occult, stretching back to the days of Ancient Rome. The modern Italian prejudice against the number seventeen, similar to the American superstition of unlucky thir-

Roman numeral for seventeen, XVII, can be rearranged to spell VIXI, or the Latin word meaning "he lived" — a phrase frequently carved into ancient tombstones, and therefore linking the number with death. Ancient Rome's penchant for the macabre did not end with numbers, however. Romans shivered with fear over the lemures, or terrifying ghosts. These ethereal beings haunted certain houses or roads because, as many ghost stories stated, they could find no rest due to an improper burial or some sort of injustice committed against them during their lifetime. The Romans even devoted the month of May to a holiday called Lemuria which sought to appease these spirits, and this creepy feast may form the origin of an olden superstition that advised against marrying in May. Ancient Romans also resorted to supernatural omens in order to predict the future. Priests known as augurs interpreted the flight of birds to divine looming events and outcomes. Haruspices had to report the future with a much yuckier method: they scoured the entrails of sacrificed animals for omens! While modern Italians are certainly less superstitious than their ancient counterparts, many remnants of Rome's mysterious folklore persist to this day, such as the ubiquitous charms against the evil eye and the popular red horn-shaped amulets said to bring good luck.

Though Ancient Rome's love for the mysterious is wellstudied, contemporary Italy nevertheless brims with a plethora of scary monsters and teen, stems from the burial eerie folktales. Werewolf stories customs of the Romans. The abound in Italy, where the hairy

name licantropo. The fear of the licantropo hearkens back to the time when the wolf stood as the most dreaded predator in the forests of Europe, especially during the nights of the full moon, when certain men could morph into this formidable animal. My father frequently spoke of hearing the plaintive howls of wolves in his secluded Italian village, and such a chilling memory is a testament to the strength of the werewolf myth. Similarly, the witch, or strega, constitutes a complex symbol in Italian society, sometimes functioning as an example of evil and other times signifying benign and astute female power. The gift-bringer of the Italian Christmas season, La Befana, is even depicted as a kindly fairy-witch figure. Unique mythological creatures also roam localized areas of Italy. The Badalisc is a large, hairy beast that inhabits the Alpine woods of Lombardy in northern Italy. It can only be captured on the Epiphany, and this event forms a part of the region's folksy holiday celebrations to this day. Visitors to Naples may hear tales of the Monaciello, or "little monk," a gnome-like creature who resides in the city's old abbeys, monasteries, and canals, playing harmless tricks on people and offering help to wayward travelers. Meanwhile, the famous Lake Como boasts its own version of the Loch Ness Monster, a living dinosaur known as the *Lariosauro!* With all of these fascinating legends and beings, Italy is a prime destination for Halloween thrills and hair-raising adventures.

Halloween provides us with the wonderful opportunity to have fun with the mysterious. From witches to ghosts to vampires, all of the hidden, spookier aspects of society come out to play during this chilly autumnal night. This Halloween season, I will also be thinking about the mythical creatures and unnerving legends that form a part of my Italian heritage, old and new. After all, folktales and myths do a lot more than just give us a thrill. They connect with the universal fears, concerns, and desires of people across generations, emotions made manifest in guiding superstitions and metaphorical monsters. Let's celebrate the unknown on Halloween and reflect on how it impacts our lives as humans and our collective unconsciousness. Halloween teaches us that there is far more to the world than immediately meets our eye, and the legends and beings of yore are prime examples of this lesson!

Some Friday nights during the late '90s and early '00s, after my mom got out of work, my family would head down to Uncle Pete's Hickory Ribs, a local sit-down/takeout BBQ joint. It was on Bennington Street in Day Square, at the site of an old Dairy Queen, and opened in 1995, when owner Pete Cucchiara turned his hobby of smoking pork and beef into a full-time business.

There was a hickory smoker on the premises behind the counter and glass, where the BBO dry rubbed meat would sit in there for six hours, tenderizing and delicioufying the St, Louis-style ribs and pulled pork. Great slices of meat are only part of the BBQ experience though, as Pete's also had a cornucopia of sweet sides.

The sweet potato biscuits with icing on top, the homemade baked beans, and the deliciously buttery mashed and sweet potatoes were worth giving up your first born child for. All of these could be enjoyed in the cozy dining room right next door to the smoker/takeout counter area, where you could watch the meats turning into mouthwateringly woody goodness. Pete would walk around the shop often, making sure everyone was satisfied with how the food and service was, putting a home-style spin to the place. The roll of paper towels on each table for when the finger-lickin' good fare got too messy certainly boosted that vibe.

Pete's wife Pha, who was from Thailand, even added a Thai twist to the menu, with her Thai peanut slaw and Thai fish cakes, for those customers who weren't in the BBQ spirit that day. There was also pulled jerk chicken, adding a Jamaican slant to the usual southern

spices. My mom would usually get the jerk and the Asian slaw when we went, as she was never a straight up BBQ fan, finding it to be too sweet and not hot enough. The accolades would start flying in about this unassuming establishment five minutes from Logan Airport, as Pete's won best in ribs and pork in a 2000 BBQ contest at the East Coast Grill.

They would eventually move to Squire Road in Revere in 2006, as the rent became too high at the Eastie location. Unfortunately, they only lasted in the new location for three years, as Pete would sadly pass away in March 2009, with the restaurant closing soon thereafter. For a 14-year period though, Uncle Pete's could lay claim as the best BBQ joint in the Boston area, at least from this writer's perspective. With reasonable prices and delicious Midwest BBQ, they kept the people coming back for more.

Many great restaurants have come and gone in East Boston over the years. Whenever we were hankering for slabs of hickory smoked ribs and an old country atmosphere brought to the city, Pete's Hickory Ribs was the place to be.



BUS NETWORK REDESIGN

Virtual Public Meeting

The MBTA and MassDOT will host a virtual public meeting on Wednesday, October 27th, at 6:00 P.M. to discuss the Bus Network Redesign Project. An initiative of the Better Bus Project, the MBTA and MassDOT's Bus Network Redesign Project is taking a look at the bus system as a whole in order to recommend a new network that better serves the needs of the region.

The project's second public meeting will present the approach and principles used by MassDOT and the MBTA to propose a transformed bus network through the Bus Network Redesign process. These design principles will shape the draft network map that the MBTA will share and discuss extensively with the public later this winter.

The meeting will be held virtually via Zoom. Members of the public can register for the meeting online. The meeting will be recorded and posted online for those who cannot attend.

MORE ABOUT BUS **NETWORK REDESIGN:**

The Bus Network Redesign Project completely re-imagines the MBTA's bus network to reflect these changes and to create a better experience for current and future bus riders. This redesign reflects rider feedback collected during one of the early phases of the Better Bus Project. It builds on work already done and guides recommendations for changes that address route design, frequency of service, hours of service, and coverage area.

This plan prioritizes riders in transit-critical communities like Roxbury, Everett, Chelsea, Mattapan, and Lynn. It is a once-in-a-generation attempt to make bold, foundational improvements to the bus network for the people who depend on it most.

ACCOMMODATIONS:

These meetings are accessible to people with disabilities and those with limited English proficiency. Accessibility accommodations and language services will be provided free of charge upon request, as available. 

NINE POUND HAMMER: WHEN THE SH*T GOES DOWN / (CD) Acetate Records

Nine Pound Hammer is known for their steamroller brand of buzz saw guitar country-punk and energetic live shows. These hellacious, garage rock stompers continue to deliver it loud and dirty. Blindly driving an old scrapheap with a stuck accelerator, fueled by potent trailer-park hooch and heading straight for hell, Nine Pound Hammer roared out of Lexington, Kentucky, belching mother-humping bourbon-soaked rock'n'roll and a sardonic swig of Southern culture that makes Jason and the Scorchers sound like a Sunday afternoon tea society and the Cramps like fussy stylists. Fueled by boredom and worry, Nine Pound Hammer fired it up during the dark winter of 2020 to record their new LP "When The Sh*t Goes Down" on Acetate Records. Ramones producer Daniel Rey braved the Kentucky elements to help the band conjure up 13 new Cowpunk Spirituals that are guaranteed to cure what ails you! NPH puts the pedal to the metal with non-stop rockers, including: "What Kind Of God," followed by the title track, "A Girl Like That," "Drunks, Babies & Fools," "Street Chicken," "2 Legged Dope," "Mama Lied," "Billy Lost His Feet," along with "One Last Midnight," "Get the Hell Off The Farm," "Possum Kickin FSESOB," "Daviess County Tractor Massacre," "Lizard Brain," and "Best Of All Possible Worlds." Buckle your seatbelt for

this wild, wild ride! **TAYLOR RAE:** MAD TWENTIES / (CD)

Americana Described as a largely chronological concept album, the disc treads a spiritual path in stunningly confessional detail. From the self-examination found in the opening track, "Window," to the closing ode: the raw, wake-up call of "Taking Space," the album examines the who, what, where and why of Taylor Rae's largely lived twenties. Her Blues/Jazz influenced youth can be heard on the B3-infused "Home on the Road," while she shares a sweet Folk feel with the dreamy "Fixer Upper." The energy explodes with the rhythmic hypnotics of "Never Gonna Do," and Taylor ably brings a Rock opera presence to "Forgiveness." Each track is an exploration — an adventure - and a deeply personal expression of self. Emotionally raw, lyrically polished and delivered with pure vocal mastery, Mad Twenties is the perfect introduction to Austin, Texas' Taylor Rae, as the 27-year-old's explanation sums up the content ... "This album is an accumulation of everything I've been through in my twenties so far. I've come to a place of external gratitude for each lesson and each moment during that time — the good and the bad."

WOODY GUTHRIE'S DUST BOWL BALLADS: HOME IN THIS WORLD / (CD) Elektra Records

Home In This World: Woodu Guthrie's Dust Bowl Ballads, a reimagined version of American folk icon Woody Guthrie's groundbreaking 1940 album, Dust Bowl Ballads, curated by Grammy Award-winning music supervisor and producer Randall Poster. Kiss The Ground, a nonprofit on a mission to awaken people to the possibilities of regenerative agriculture and inspire participation in this movement through media, communications, education, immersive programming, and advocacy, partnered with Woody Guthrie Estate for this release. The album was announced earlier this summer via Rolling Stone and heralded by The Secret Sisters' rendition of "Dust Cain't Kill Me," followed by Waxahatchee's take on "Talking Dust Bowl Blues" and Lee Ann Womack's "Dusty Old Dust." Rolling Stone praised Womack's interpretation, attesting, "there's an air of gallows humor in the swaying chorus ... with multi-part harmonies that convey both joy and sadness accompanying her," while Flood Magazine raved "Waxahatchee breathes new life into a timeless American tune, reminding of that sweet spot where songwriting and storytelling can be as powerful as the winds that cover this earth." Cited as one of the first concept albums ever, Dust Bowl Ballads' 14 tracks ring true nearly four generations later as America faces a different kind of depression and looming climate crisis. Poster has assembled an all-star cast of everyone from Grammy-Award winners Lee Ann Womack and John Paul White to grunge poet laureate Mark Lanegan.

LENA BLOCH & FEATHERY: ROSE OF LIFTA / (CD) Fresh Sound Records

Rose of Lifta digs deep into the yearning, soulful, complex sounds and the themes of exile, loss, and emerges with seven shimmering original tracks. Bloch's personal story is also closely related to yearning for home, as it traverses Russia, Israel, Holland, Germany, and finally immigration to the United States. Her experience informs the music and gives it a deeply personal angle. Bloch's second Feathery recording, demonstrates once again her three-tier excellence as a saxophonist, composer, and a bandleader whose approach nurtures listening, trust, and musical freedom. With a tone simultaneously delicate, nuanced, and emotionally powerful, Bloch leads her quartet in four Bloch originals and three Russ Lossing originals. "Promise of Return," the opening track by Bloch, begins with Cameron Brown's single bass line, joined by piano, drums, and saxophone melding into cascading, conversant, recurring motifs. A resonant, wistful saxophone solo starts the second track, "Mad Mirror," another Bloch's original. Lossing's searching emotional piano and compositional acumen are highlighted on "New Home" and "Old Home," as well as the final track, "Wintry Mix." Two more pieces by Bloch round out the recording, the title track "Rose of Lifta," and "Mahmoud Darwish," Bloch's sonic ode to the poet whose art and work inspired the album.

Nanna & Babbononno

A Nostalgic Remembrance



This is a special story. It doesn't involve Nanna, Babbononno or my parents, but corresponds to the values that they used in bringing me up. It all began in the fall of 2013 when I underwent surgery at Mass General Hospital. As I convalesced, a priest came into my room, introduced himself and asked me if I was comfortable. As the conversation began, I asked him where his accent was from as I didn't recognize it. It turned out that Fr. Joseph Owusu Boafo was one of 15 children born into a Catholic family in the West African country of Gambia. When it was time for Fr. Joseph to leave, he extended a blessing in my direction and placed his hand on my forehead. Immediately, I felt a surge of energy run through my body as if it was electricity. I mentioned him to my wife, Loretta, but dismissed the results of the physical contact.

Seven years ago today, one of my closest friends passed away, General Bill Hurley.

His wife, Sandy and the family gave him a military funeral Mass at their church, the Holy Rosary in Winthrop. As the casket was being brought into the church, I was standing at attention with several members of my military organization, the Veterans Association of the First Corps of Cadets. A side door of the church opened and a priest exited. We stared at each other, both knowing we had made contact somewhere in the past. Being at attention, I couldn't talk, but was determined to catch up to Fr. Joseph later. When communion was distributed, I got in his line, and after handing me the host, he placed his hand on my forehead and I felt that same surge of energy run through me that I had experienced when I met him in 2013. A year later, Sandy Hurley had a one-year memorial Mass said for her late husband, and I and several First Corps members attended. Fr Joseph officiated and when I accepted the communion from him, I asked for a blessing for my new granddaughter, Lina. He placed his hand on my forehead, and for the third time, I felt a surge of energy run through my body that I still can't explain.

Fr. Joseph is now a parochial vicar at St Joseph and Saint John the Baptist collaborative parishes in Quincy. As a result of Sandy Hurley's input and the fact that St. John the Baptist is my close friend, Dr. Dean Saluti's parish, Fr. Joseph is now the spiritual representative of the First Corps of Cadets and Dean's organization, the Greater Boston Renaissance Lodge of the Sons and Daughters of Italy.

When Sandy called and mentioned that on Sunday, September the 26th, there would be a 25th anniversary celebration of priestly ordination for Fr. Joseph, I immediately accepted her invitation. My wife and I followed Dean and Margie Saluti to St. John the Baptist and were joined by two other First Corp members, Generals Joseph Carter, and Michael Finer. The Mass reminded me of

the High Masses I used to experience as a child when I was a parishioner at the Sacred Heart in East Boston. Following the Mass, a lawn buffet was held for Fr. Joseph and the attendees of the celebration. Unfortunately, only one in our crowd, General Finer, was able to stay and greet Fr. Joseph. I was so impressed with everything I experienced, I decided to do a column on the good Father and share it with

Fr. Joseph came from a very religious family that, as I mentioned at the beginning, included 15 children. They were

Joseph and St. John the Baptist in Quincy, but due to his ministry at Mass General, he cares for sick and dying patients, also. His hospital work brings him to Belmont's McLean Hospital where he integrates his faith with skills that help patients who suffer from physical, emotional, and spiritual distress. One of his main concerns is what he calls "the addiction epidemic" that ravages the lives of people on a daily basis, and with his skills, he concentrates on helping this distinct population.

As I mentioned, Fr. Joseph is one of 15 children. Among his siblings are two Catholic priests, a nun of the St. Louis order and a Marist brother. One of his strongest influences was his mother, a devout woman who recited the rosary every morning and attended daily Mass. Unfortunately, his mother recently passed away. Due to COVID-19 restrictions, Fr. Joseph couldn't get home to attend her funeral. If I may, my column extends heart-filled condolences on the behalf of the Renaissance Lodge and the First Corp of Cadets. If any of my readers are interested in contacting Fr. Joseph, he is a parochial vicar at St. Joseph

a humble farming family, but his parents stressed the importance of education and religion to each child. As a result, all became actively involved in church activities. From the age of six, Fr. Joseph had desires to become a priest. He started out by serving as a Mission Boy for the Irish Missionary Priests that served in Gambia. Knowing Joseph wanted to become a priest, they entered him as a seminarian in the Holy Spirit Order. He was 17 at the time.

By 1987, Fr. Joseph began a three-year study of philosophy, one of pastoral experience and four years of theology. He was ordained in 1996, at the age of 33. For the next 10 years, he served at the Holy Family Church and the Star of the Sea parishes in Gambia. This was followed by more religious studies, this time in Ireland.

Coming to America, Fr. Joseph studied counseling psychology at Boston College and received two masters' degrees, later becoming a priest at the Holy Rosary Parish in Winthrop. Simultaneously, he served as a full-time Catholic Chaplain at Massachusetts General Hospital (where I met him back in 2013). He is now a parochial vicar at St.

and St. John the Baptist collaborative parishes in Quincy.

As I think back, I was raised with the dogma of Catholicism, but as I became more aware of the world I lived in, I began to question everything. Education didn't help, as it opened doors I didn't even know existed. So, being curious, I investigated what was out there. In terms of religion, As a result, I questioned everything I was ever taught. I looked into Orthodox Christianity, Judaism, Islam, Buddhism, and even the Hindu faith. What they collectively did was convince me that what I was brought up with was, for me, what I felt strongest in. I also discovered something else; as you get older, you start to question your own mortality and I wonder what's beyond this life, and that scares me. So to remain comfortable, I maintain my Catholic faith.

I can thank people like Nanna, Babbononno, my folks, my wife and spiritual leaders like Fr. Joseph for their influences that have kept me believing in who I am and what contributions I might leave behind that are beneficial to my family, friends, and the public at large.

GOD BLESS AMERICA



One of Italy's most famous sweets are biscotti. Plural for biscotto, translating to biscuit or cookie and named "bis" and "cotto" or twice baked, after their original method of baking. The second bake is intended to draw moisture out of the dough and increases their shelf life. Biscotti were perfect for traveler's years ago, and known to be a staple of sailors, soldiers, shepherds and fishermen. Legend has it that they were even enjoyed by Christopher Columbus on his long voyages at sea. Food historians have always given credit to Tuscany for creating the first biscotti, Cantuccini (made with almonds) and today, biscotti appear to be favored more than ever. I don't know of an Italian coffee bar that doesn't serve them! Ranging from soft and crunchy, to dry and hard, and plain to flavored, the varieties are endless. Italy's preferred method of eating the hard, dry biscotti has always been to "dunk" them in a glass of Vin Santo and now, even "dunking" in coffee is accepted. Those on the softer side go well with either a coffee or cappuccino.

Sifting through my Nonna's recipes, I found one I remember her making often. It is titled "Italian Biscotti," and in the upper corner, she wrote "Lovie's recipe," She was referring to her older sister, my Zia Nancy. This recipe must have been given to her well over 60 years ago. Flavored with the perfect balance of anise and vanilla, "Zia Nancy Delia's Italian Biscotti" are crisp on the outside, soft on the inside, and just amazingly delicious. These are definitely too soft to dunk, but nonetheless, make a perfect accompaniment, as my Nonna served them, to a fresh brewed cup of coffee or espresso!

ZIA NANCY DELIA'S ITALIAN BISCOTTI Biscotti Italiani di Zia Nancy Delia



3 eggs

1 ½ cups sugar

½ cup shortening, melted

½ pound butter (1 stick),

1 ½ teaspoons anise extract

1 tablespoon vanilla extract

½ cup milk

5 cups all-purpose flour 4 ½ teaspoons baking powder

Preheat the oven to 350°. Line two cookie sheets with parchment paper and put aside. In a large bowl, beat eggs and sugar until light and fluffy. Add cooled shortening and butter, mix well. Add milk, anise and vanilla extract, beat well. In a medium bowl, sift flour and baking powder together. Take 2 cups of the flour mixture and add to the wet mixture, beat until smooth. On a wooden board, pour remaining flour mixture and make a hole in the middle. Add liquid batter and mix well with your hands, until dough forms. Divide dough into 4 pieces. Roll each section into a log about 1 ½ inches in diameter, and the length of the cookie sheet. Place two logs, spread apart, on each of the prepared cookie sheets. Pat down so they are even in height, and bake at 350° for about 25-30 minutes, until light brown. Remove from the oven, slice each log into 3/4 inch pieces. Place slices face down on cookie sheets and second bake at 375° for 10 minutes (turning over at the 5-minute mark) or until golden brown. Cool on cookie sheets and store in a cookie tin to retain crispness.

New for the Holidays: Prices, Shipping Rates and Dates

Plan Ahead with Pricing and Shipping Deadlines for the 2021 Holiday Season

Mail Express

It looks to be another odd year for holiday celebrations. The biggest question likely on most minds is do we make merry in person or virtually? No matter your plans, the Postal Service is ready to do its part to handle your special holiday greetings and gifts. But we also need you to do your part, and that is to make sure you get those packages and good wishes to your Post Office location on time.

NEW PRICING

There are plenty of holiday — and winter themed stamps available to adorn your greeting cards this year. You can find them in our online Postal Store or at any one of our more than 34,000 Post Office locations. As a reminder, on Aug. 29th. the cost of a First-Class Forever stamp increased three cents, from 55 cents to 58 cents. There are also temporary price increases in place through Dec. 26th, 12:01 a.m., Central time for both retail and business customers for some of our more popular shipping products, which also includes military shipping — Priority Mail Express (PME), Priority Mail (PM), First - Class Package Service (FCPS), Parcel Select, USPS Retail Ground, and Parcel Return Service. International products are unaffected. These temporary rates will keep the Postal Service competitive while providing the agency with the revenue to cover extra costs in anticipation of peak-season volume surges similar to levels experienced in 2020.

Temporary pricing increases for Priority Mail, Priority Mail Express, Parcel Select Ground and USPS Retail Ground are as follows:

- PM and PME Flat Rate Boxes and Envelopes - \$0.75
- Zones 1-4, 0-10 lbs. \$0.25
- Zones 5-9, 0-10 lbs. \$0.75
- Zones 1-4, 11-20 lbs. \$1.50
- Zones 5-9, 11-20lbs. \$3.00 • Zones 1-4, 21-70 lbs. - \$2.50
- Zones 5-9, 21-70 lbs. \$5.00

All other **retail** shipping services:

The temporary adjustment is part of "Delivering for America," the Postal Service's 10-year plan for achieving financial sustainability and service excellence, which calls for appropriate pricing initiatives. We Will Miss You Champ



SAVARD STARTS SECOND CAREER AS HEAD COACH —

The bridge that crosses over the expanse of a river (or the tunnel that goes under it) are all that separate former Bruins player Marc Savard from the NHL and his new coaching duties just a short distance away in Canada.

That's because Savard, who played five years for the B's, is now a first-year head coach with the Windsor Spitfires, the Ontario Hockey League team that plays its games right across the river from Detroit, home of the Red Wings.

In that sense Detroit and Windsor are sister cities, across from each other in a fashion similar to Boston and Cambridge. Except, of course, they are in different nations.

Over the summer Savard, whose NHL career was curtailed following a pair of concussions about a decade ago, came aboard in Windsor after serving as an assistant coach with the St. Louis Blues during the 2019-2020 season.

According to the Toronto Star, a major factor in his hiring were his positive comments about coaching.

"If you are still talking about when you played and how things were when you were a player, I don't know if that will lead to any success as a hockey coach, Spitfires GM Bill Bowler told writer Dave Feschuk. "But all Marc talked about was coaching. If you care about coaching and are trying to learn a new craft as a coach, then I think you have a great chance to be a successful coach."

The year that Savard served in St. Louis was the one following the Blues' most memorable campaign. During that prior season they were literally in last place in the then 31-team NHL on New Year's Day and wound up winning the 2019 Stanley Cup by beating the Bruins 4-1 in a Game Seven victory in June at the TD Garden.

The following fall Savard came aboard and things continued smoothly for the Missouribased franchise. The Blues were leading the Western Conference with a 42-19-10 record across 71 games when action was halted in March due to the COVID outbreak.

When play resumed during the summer St. Louis went 0-2-1 in the round robin tournament and then was eliminated in the first round of the playoffs by Vancouver.

Marc Savard appeared to have the hockey world by the tail about a quarter of a century ago as a promising player in the Ontario Hockey League, the major junior circuit that he will now tour as a head coach.

During the 1994-1995 season Savard put up an eye-popping 139 points and two years later added another 130. That made him the top junior league point producer in Canada in two out of three years.

It also brought him to the New York Rangers' organization where he amassed 74 points with Hartford during the 1997-1998 season

As a center, Savard made his living passing the puck, often in a successful manner. In many years he normally had many more helpers on the ledger than actual tallies. His final season with the Atlanta Thrashers (2005-2006) proved to be his most productive with 97 points next to his name.

And talk about timing. The two words following that total were "free agent." Thus it was that Marc Savard joined the Bruins, signing a four-year, \$20 million contract.

For the B's it was money well spent. During the 2006-2007 campaign he had 96 points, 74 of them coming as assists. He played in the All-Star Game the following year and scored the winning goal with 21 seconds left in the contest. He also had 78 points that season.

In 2008-2009 he led the team with 88 regular season points and added 13 more in 11 Stanley Cup Playoff games.

The year 2009-2010 was a bittersweet one for Savard. On the one hand, he signed a seven-year, \$28 million contract extension, meaning he had now inked two pacts with Boston worth a total of \$48 million.

The bad news came when he sustained the first of two wellpublicized concussions. The initial one came on March 10, 2010 when he took a shoulder hit in a game against Pittsburgh. Although he recovered enough to compete in the playoffs, he continued to experience postconcussion symptoms over the summer.

As the 2010-2011 season got underway, the one that would lead to a Stanley Cup title for the B's, Savard was held out for the first 23 games, then returned for the next 25. A second concussion came on January 23, 2011 while playing Colorado. A month later Savard was officially ruled out for the remainder of the season.

His teammates saw to it that he got his name engraved on the Stanley Cup and that he rode in the victory parade through the streets of Boston.


But that January 23rd contest would be the last time Savard would ever play in an NHL game. Over the summer, it was announced that he would be held out for the entire 2011-2012 campaign.

"It is unlikely that Marc will ever play again," stated then Bruins' GM Peter Chiarelli.

Doctors would conclude that Savard had probably sustained at least four additional concussions dating back to his formative years in the game. He officially remained with Boston until the summer of 2015. Both Florida and New Jersey later picked up his contract when it was included as part of player trades. He officially retired on January 23, 2018, seven years after leaving the ice for the final time.

And about going forward? "Right now, I don't see myself as an NHL head coach," Savard told the Toronto Star. "But I don't see myself as an assistant either. We will see what opportunities arise. Who knows what the future holds."
