

Stirpe Nostra

A weekly column highlighting some of the more interesting aspects of our ancestry . . . our lineage . . . our roots.



Heliopolis

Last week we discussed Helios, the Sun god and his Roman counterpart named Sol. This week, attention is directed to an ancient Egyptian city near Cairo, named Heliopolis in honor of that Sun god. It was also well known as the "City of the Sun." Herodotus, the famous ancient Greek historian, claimed that its inhabitants were the wisest and most



ingenious of all Egyptians. Berosus, another Greek historian claimed that this was the city of Moses, while others tell us that it was a place of resort for all Greeks who visited Egypt for instruction and knowledge. Plato lived here for about three years. It is also listed as the residence of the Egyptian priest named Manetho, who wrote the first history of Egypt in the Greek language.

Strabo, a Roman geographer and historian spoke of this city being built on a long artificial mound of earth in order to keep it above the seasonal flooding of the Nile which occurred every year for thousands of years. The oracle of Apollo and a famous temple of the sun were located here, as well as a fountain which gave forth excellent drinking water. I am told that the fountain still remains and that it inspired the name "Fountain of the Sun."

Obelisk is the name given to the monumental pillars of Egypt. These are huge monoliths (monos meaning single, plus lithos meaning stone). They are square in shape but taper to the summit and look like a miniature Bunker Hill Monument or Washington Monument. They usually stood in pairs to dignify entrances to temples.

The usual height was ten times the thick-

ness at the base. Hieroglyphic inscriptions on the sides of these pillars tell the story of the persons or events for which they were erected. Heliopolis was noted for its obelisks, many of which were removed to other countries in later years. Two very famous obelisks are the one popularly known as "Cleopatra's Needles."

One of these was taken to London in 1878 and erected on the Thames embankment. The other was taken to New York City in 1881 and set in Central Park.

The largest obelisk in existence is the one in the piazza of Saint John Lateran in Rome. It came from the Temple of the Sun, in Heliopolis, where it was originally erected about 1500 B.C. by Thothmes III, one of the greatest of the Egyptian Pharaohs. The obelisk is of Egyptian granite, 105 feet high, nine feet square at the bottom, six feet square at the top, and weighs 450 tons. Another monument, the huge obelisk in front of St. Peter's in Rome should serve as a constant reminder of two of the most brutal men that this world has ever known. It was brought to Rome, also from Heliopolis, and was transported via a special boat that was constructed by the Roman emperor Caligula. The obelisk was erected on the "spine" (median strip) of Nero's Circus, and at the base of this monument is where St. Peter and countless numbers of Christians were martyred. It was moved from its original site to its present location by Pope Sixtus in 1586. I am told that the bronze cross now at the top contains a relic of the true cross.

Celebrating Italian-American Heritage Month in Massachusetts

According to tradition, the appropriate gift on a fifteenth anniversary is *crystal* and I say, Make it in the form of a wine flute and fill it with Prosecco, the dry, sparkling, white wine of Italy, for it is time to raise a toast.

This month marks the fifteenth official celebration of Italian-American Heritage Month in Massachusetts. Wow, that recent? Well, October, with the Columbus Day federal and state holiday falling on the second Monday, was long accorded an unofficial status as a month to celebrate all things Italian, at least in cities like Boston, with a large Italian-American population. But it was not until 1999, while Argeo Paul Cellucci, grandson of Italian immigrants, was governor that the legislature enacted Section 15EEEE of Chapter 6 of the Massachusetts General Laws.

"The governor shall annually issue a proclamation setting apart the month of October as Italian-American Heritage Month, in recognition of the significant contributions Italian-Americans have made to the Commonwealth and to the United States and recommending that said month be observed in an appropriate manner by the people. After consultation with Italian-American groups, the governor may include in the proclamation such contributions as he shall see fit."

Among the notable persons and events cited by Governor Deval Patrick in this year's Italian-American Heritage Month Proclamations are —

The 500th anniversary of the death of Donato Bramante, who introduced Renaissance architecture to Milan and the High Renaissance style to Rome.

The 300th anniversary of the first of Antonio Vivaldi's operas.

The 200th anniversary of the founding of the Carabinieri, Italy's military police who provide national defense and domestic security, and perform international peacekeeping and training missions in collaboration with the United States.

The 100th anniversary of the birth of Dr. Renato Dulbecco, the acclaimed virologist who in 1975 won the Nobel Prize in Medicine for his research explaining how genetic mutations may cause cancer.

The 100th anniversary of the birth of Ralph Fasanella, a laborer, union member, activist, and self-taught artist whose works include Massachusetts mill towns and scenes in the history of the labor movement, including paintings commemorating the 1912 "Bread and Roses" strike in Lawrence.

ANNOUNCEMENT COMITES ELECTIONS

A date has been set to elect new members of the **Committees of Italians Abroad (Comites)**, which represent the interests of Italian citizens residing abroad in dealing with their local consular offices. The *Comites* will be elected on the basis of candidate lists signed by Italian citizens resident in each Consular district.

Eligible voters must be Italian citizens and meet the following criteria: 18 years of age as of December 19th, 2014; registered with the Registry of Italians Residing Abroad (AIRE); resident in the local Consular district for at least six months; and entitled to vote. An information letter will be addressed to all members of the household who meet these requirements and reside in the Consular Jurisdiction.

THOSE WHO INTEND TO VOTE MUST BE ADDED TO THE ELECTORAL LIST BY TRANSMITTING A SIGNED REQUEST AND COPY OF IDENTIFICATION TO THE LOCAL CONSULATE. You may request an application form from the Consulate, Honorary Consulate or online, available to download from the Consular website at www.consboston.esteri.it You may also submit an application without using the form so long as the personal information is provided in a letter form (applicant's first and last names — please indicate maiden name for women, date of birth and current address) and you expressly declare the intent to vote in the elections of the *Comites*; said application letter must be duly signed and accompanied by a copy of a photo ID.

The application may be sent to the Consulate by mail (600 Atlantic Avenue, 17th floor, Boston, MA 02210), e-mail (elettoreale.boston@esteri.it), fax (617-722-9407), or it may be hand delivered. **IN ALL CASES, THE APPLICATION MUST REACH THE CONSULATE BY NO LATER THAN November 19th, 2014.**

By November 29th, 2014 the Consulate will mail ballots and a self-addressed stamped return envelope **ONLY TO THOSE VOTERS WHO SUBMITTED COMPLETE APPLICATIONS WITHIN THE REQUIRED TIME FRAME.**

Fanning Flames and Throwing Ice on Fears

The Ebola virus has hit America after President Obama thought it wouldn't. Over this past weekend, there were two local scares. First, in Braintree, a Liberian just back from West Africa presents himself at a Braintree health clinic with flu-like symptoms. He is immediately quarantined and shipped off to a Boston hospital. Two days later, a flight coming into Logan from Dubai has five passengers all suffering flu-like symptoms, the plane gets quarantined, workers covered in hazmat protective gear board the plane and remove those sick passengers

The Great Pumpkin

Whenever I think of autumn in New England, many beautiful images enter my mind: colorful leaves shining on wet pavement, mist hovering over fields laden with wheat, crisp and cool air mingling with bright sunshine. And then, of course, there is the pumpkin. Pumpkins are the quintessential fall staple, a harbinger of the season. Many autumnal decorations feature orange pumpkins standing proudly next to stalks of wheat or spilling out of cornucopias. The introduction of pumpkin lattes in coffee shops heralds the beginning of fall for many people, and these delectable drinks help us weather the chill days to come. Pumpkins are even associated with the two major holidays of autumn, whether they are being used as jack-o-lanterns during Halloween or made into a creamy pie for Thanksgiving. I love cooking with pumpkin during the autumn, and around October cans of Libby's 100% pumpkin puree become a regular item on my shopping lists. The pumpkin has long served as a cornerstone of American folklore and tradition, but this gourd is so associated with autumnal delight that it is well-known across the ocean in Italy as well.

Far before any Europeans set foot on North America, pumpkins were an important and respected crop among several Native American tribes. They used the pumpkin, including its seeds, for both culinary and medicinal purposes. When European merchants brought pump-



kins back to their homelands, the gourd quickly entered the dishes and the folklore of many cultures there. In the French fairy tale *Cinderella*, for example, the title characters magical godmother changes a pumpkin into a horse-drawn carriage to take Cinderella to the palace ball. Sometimes, European folklore made its way to America and became attached to pumpkins. When the Irish began immigrating to the United States in large numbers in the 1840s, they brought along with them a number of customs that shaped our modern Halloween. In Ireland, farmers would carve out turnips on Halloween and stick a candle in them to frighten off evil spirits believed to be wandering about on that night. As this custom spread in America, the larger and more easily carved pumpkin replaced turnips. Pumpkins even became associated with crazy superstitions, and it was once believed that pumpkins could eliminate freckles and cure snakebite! The rich folklore surrounding pumpkins contributed to the fruit's (and yes, pumpkins are fruit!) popularity in American holidays and cuisine.

The pumpkin is a beloved ingredient in Italy as well, where it is known as *zucca*. While pumpkins feature

prominently in American desserts, Italians prefer pumpkin in savory forms. Pumpkin ravioli and pumpkin tortellini are popular Italian dishes, especially when paired with a sage-cream sauce. Though I myself enjoy pumpkin more in desserts, I am particularly fond of a savory dish I make every St. Martin's Day (November 11) — pumpkin gnocchi with a browned butter sauce. Creamy and delectable, these gnocchi actually *taste* like fall, and they make the kitchen smell like the season as well with their aromatic blend of nutmeg and sage. I also make a cream cheese and pumpkin bread for Halloween that never lasts very long around my house, and a pumpkin cheesecake with a gingersnap crust for Thanksgiving. This year, I am excited to experiment with a pumpkin-chocolate chip cake, pumpkin cookies and pumpkin custard. To honor my Italian roots, I will also search for more recipes that incorporate pumpkin into pasta dishes. No matter how it is cooked, pumpkin reminds me of the warmth and coziness that autumn brings. Its association with festivities conjures memories of families sitting together around a bountiful table, sharing much laughter and love. For those reasons, along with its excellent versatility in the kitchen, pumpkin has become an indispensable part of my autumn traditions.

Nothing can fill me more with the excitement of fall

Closer to home, we fear the spread of Ebola while the U.S. continues to allow commercial flights from West Africa to America. We can't restrict a disease when our borders remain open to the disease flying into our airports.

America needs to be America again and become a world leader and not a follower. America needs to remember its revolutionary roots and set the agenda. We need a president who tells it like it is rather than as he wishes it to be. Radical Islam is a clear and present danger to America and the world. Even before I read one word of this book I want to congratulate everyone responsible for designing and developing such a stunning presentation. After reading thousands of books I cannot remember a previous book with such outstanding photographs that I believe will leave the reader gasping.

Back to the book. Immediately, Lionel Delevingne states authoritatively, the radioactive waste caused by the fission process remains for up to 250,000 years. Let that sink in.

He explains how he learned from a May Day demonstration held in the United States in 1971, "that the power of a peaceful but vocal citizenry could affect national policy." He continues, "this book is about power, not just nuclear power but also the power of a community to force action and make a change ... no construction of a nuclear power plant has been commissioned in the United States for 30 years."

Looking at the photos of, in particular, Three Mile Island, Chernobyl and Fukushima disasters one

cannot help but lead to the following conclusion, says Delevingne. "Evidence from these three nuclear catastrophes confirms and rein-

forces the belief that a safer energy alternative must be found." Photos of the people of Seabrook being assaulted by the police, express the negativism that prevailed. I found it impressive how Lionel captured the grim expressions on many senior citizens that were present who many considered a youthful outrage. A photo of middle-aged man with an unrelenting expression holding a sign that read simply, BAD will not be forgotten easily.

The victim's photos can never be described properly, literally. They can only be used to remember as an historic failure in time. The silent photographs are a reflection of an extraordinary photographer with a keen eye.

This book has left me with dire feelings that are dreadful and unforgiving. Lionel Delevingne photographs will fill you with over powering impressions that the mightiest words cannot. This book's photos capture the essence of man's sometimes fruitless efforts to improve the health of the world.

I plan to store this book safely in my library, but I cannot help feeling that it might just melt down.

Looney Beginnings



True enough, after *Snow White* and the demise of Max Fleischer Walt Disney was safe from competition. No one could dispute his title as the animation king as no one else dared to tackle a feature-length cartoon after the slumping of *Gulliver's Travels*. But cartoonmakers were appearing in all directions and the one that proved the most formidable rival to his cartoon shorts is the studio that would come to represent the Golden Age of Animation and all of its markers (the wackiness, the crushing sledge-hammers, the use of dynamite sticks to fight off an enemy, literal eye pops, and all the other crazy stunts of cartoon physics).

The ironic part is that Warner Bros.' animation could be argued to have originated at Disney's studio in 1927. There Herman and Rudolf Ising first created a happy-go-lucky character named Bosko, influenced heavily by Felix the Cat, Al Jolson's *Jazz Singer*, and, unfortunately, a lot of African-American stereotypes. The Isings had a hard time finding the right home for Bosko. After his riff with Disney, Charles Mintz took them under his studio where they made a revolutionary sound short titled *Bosko the Talk-Ink Kid*, which caught the attention of Leon Schlesinger, head of Warner Bros. rising animation stu-

dio. By the spring of 1929, the Isings were signed on to Warner and Bosko became the first character of the Looney Tunes series. Alas, it was a partnership that wouldn't last. A dispute with Schlesinger over salary could not be resolved and in 1933 the Isings took the




character for a short-lived stay at M-G-M.

But, looking back on what the Looney Tunes did for the history of animation and how it defined an era, the loss of Bosko was less than a drop in the bucket.

The greatest gift the Isings left Warner Bros with was a prodigy named Bob Clampett, a young, talented, genius with unusual creativity. Inspired by the antics of Charlie Chaplin and the Our Gang kids, he took off running at Warners and by 1937 created one of the most endearing characters of the Looney Tunes pantheon, Porky Pig.

It took a while for Porky to become the neurotic stammering sap he is best remembered as today. In his early incarnations he coasted from a much larger, sweater sporting, everyman of a pig (*Porky the Fireman*, *Porky's Railroad*, and *Get Rich Quick Porky*), to child (*Porky the Rainmaker* and *Wholly Smoke*), to antagonist (*Porky's Duck Hunt*), then in 1938 both Porky and Clampett had a *tour de force* with



Porky in Wackyland.

In 1935 there came another animator to Warner Brothers with an even zanier sense of physics than Clampett and though Tex Avery would be fired from Warner Bros., by 1941 he left probably the largest legacy of any of its animators. His first contribution was Daffy Duck, who made his debut in 1937's *Porky's Duck Hunt* and then faced off in a similar battle with a nitwit called Egghead who would evolve into Elmer Fudd.

Daffy's best days were yet to come and each of Warner's directors (Robert McKimson, Friz Freleng, and Chuck Jones) would have their try at the character. Consequently, Daffy's personality ranged from pure madcap antics in his early shorts, to a conniving hustler, until Chuck Jones finally unleashed Daffy's wackiest urges.

For Avery, too, the best years were still ahead. His departure from Warner brought him to M-G-M where he would create Droopy and find greater artistic freedom. But before his termination he left Warner, the studio that fired him, with the character that would become its logo and an American icon as well. Ironically, it was because of this very carrot chomping, long-eared, hare that Avery was fired. But more about that next time.

Saint Damien of Molokai

Father Damien, the Leper Priest, The Hero of Molokai, was born Josef de Veuster on January 3, 1840 in Tremelo, Belgium. His parents were farmers. His father sent him to a college at Braine-le-Comte. Because of a mission he attended given by the Redemptorists in 1858, Josef decided to become a religious. He entered the novitiate of the Congregation of the Sacred Hearts of Jesus and Mary in Leuven, taking the name of Brother Damien on October 7, 1860.

He would pray every day before a picture of St. Francis Xavier, patron of missionaries, to be sent on a mission. Three years later his prayer was answered when, because of illness, his brother, Auguste, could not travel to Hawaii as a missionary. So Damien was allowed to take



his place.

On March 19, 1864, Damien arrived in Honolulu in the Kingdom of Hawaii as a missionary still in minor orders. There, Damien was ordained to the priesthood on May 24, 1864 at the Cathedral of Our Lady of Peace. Fr. Damien served at several parishes on the island of Oahu when he became

aware of the public health crisis in Hawaii. Many of his parishioners were among the Hawaiians who became afflicted by diseases brought to the islands by foreign sailors. Thousands were dying from influenza, syphilis and other ailments that never before affected Hawaiians, especially leprosy, known today as Hansen's disease.

Hawaiian King Kamehameha IV, afraid leprosy would spread, segregated the lepers by creating a colony, moving them to the isolated settlement colonies of Kalaupapa and

Parla Come Mangi!

(Speak as You Eat!)

Benvenuti! Let's begin our culinary tour to Toscana (Tuscany) in central Italy with a traditional dish from the Tuscan Maremma whose territory includes the province of Pisa, Livorno and Grosseto and borders the Mar Tirreno (Tyrrhenian sea) and Mar Ligure (Ligurian Sea). The Maremma region is an extensive area that also includes parts of northern Lazio (Maremma laziale). Say Maremma and think "Butteri" - the local Tuscan cowboys that ride the Maremma horses and tend to the native Maremmana breed of cattle. The food image most evoked by thoughts of Butteri is "Acqua cotta" (cooked water) - a typical dish that makes use of the staples of the rural Tuscan kitchen: onion, extra virgin olive oil, tomato, garden herbs, eggs, stale bread and pecorino cheese. There are many version of this dish throughout Tuscany; very important for the outcome of any acqua cotta recipe is the quality of the olive oil. It must be "rustic" and savory, as better Tuscan oils are.

Acqua Cotta ("Cooked water") – Tuscan Vegetable Soup (serves 4)

2 large ripe skinless diced tomatoes or one small can of diced peeled tomatoes	4 Tbsp extra virgin olive oil
4 slices of country bread	2 large onions thinly sliced
4 Tbsp grated pecorino cheese	4 eggs
	fresh chopped garden herbs (marjoram, thyme, basil), salt and pepper to taste

Preparation: In terracotta or in a regular pot, slowly simmer the onions until very soft, almost "dissolved" in the olive oil. Add the diced tomatoes and the garden herbs - season with salt and pepper to taste and let simmer covered on low heat until they reach an almost creamy consistency. At this point add enough hot water to give your soup the consistency of a thick broth and let simmer. Toast the bread slices and keep them warm. Crack the four eggs directly into the pot with the acqua cotta (do not stir or break the eggs), ladle some of the soup over the eggs and let the pot simmer covered for a few minutes until cooked. Plate by pouring some acqua cotta into the bottom of a bowl, next place the slice of toasted bread and sprinkle on some pecorino cheese. Carefully, using a slotted spoon, lift one egg out of the soup and place it onto the bread slice. Add some more soup and serve right away. Buon appetito!

Acqua Cotta - Zuppa di Verdure Toscana (serves 4)

2 pomodori maturi grandi spellati e tagliati a cubetti o una lattina piccola di pomodori pelati a cubetti	4 cucchiaini di olio extra vergine d'oliva
4 fette di pane casereccio	2 grosse cipolle tagliate finemente
4 cucchiaini di pecorino grattugiato	4 uova
	trito di erbe aromatiche fresche (maggiorana, timo, basilico), sale e pepe q.b.

Preparazione: in un tegame (di terracotta o non) soffriggi lentamente le cipolle nell'olio senza caramellarle ma facendole quasi sciogliere piano piano. Aggiungi i pomodori a cubetti ed il trito di erbe aromatiche. Continua la cottura a fuoco lento, con il tegame coperto, fino ad ottenere una buona consistenza. Aggiungi acqua calda quanto basta per diluire la zuppa alla consistenza di un brodo e lascia cuocere ancora per un po'. Tosta le fette di pane e tienile in caldo. Rompi le 4 uova nel tegame con l'acqua cotta (non mescolare, le uova devono essere lasciate intere), ricopri con dell'acqua cotta e lasciale cuocere per qualche minuto a tegame coperto. Impiatta mettendo un fondo di acqua cotta in una ciotola e sopra, una fetta di pane tostato che cospargerai con del pecorino grattugiato. Facendo attenzione, trasferisci un uovo dal tegame direttamente sulla fetta di pane, aggiungi altra acqua cotta e servi subito. Buon appetito!

Nanna & Babbononno

A Nostalgic Remembrance



Babbononno, once he settled down in Boston, became involved with all things Italian.

Back in his day, just before the turn of the 20th century, there was a lot of discrimination and prejudice leveled at the unwanted newcomers, the "Eye-talians". As a result Italian organizations sprung up in every community the newcomers settled in. The one dominant, now national, organization is the Sons of Italy. On Saturday, October 4th the members celebrated the 100th anniversary of the Grand Lodge of Massachusetts.

Babbononno was proud of his people and wanted to help, through this organization, the newcomers who might have trouble adjusting to American life. What he later told me, and I verified it with a bit of research, was that 95% of the Italians who came here in that first wave, from 1880 to about 1900, were from southern Italy (south of Rome), and were illiterate in both Italian and English. Because of the isolation in southern Italy, they were distrustful of people from other provinces than their own. Napolitani didn't trust Siciliani, Siciliani didn't trust Calabrese, etc. Once in America, they continued with this approach to people, and as a result, remained fragmented as an ethnic group. Not knowing the ins and outs of the culture, they let mercenaries, Italians who preceded them, take advantage of them. So, 100 years ago, when the OSIA came into existence in Boston, Babbononno was right there, ready to join and help Italians less fortunate than himself.

It wasn't all business. When my mother and uncles were kids, there were family events that were sponsored by the Sons of Italy, dinner parties, dances, outings when the weather was good, and church activities, as most of the Italian population was Catholic.

Babbononno was lucky once he came here. He had two talents he could put to good use and make money. My great grandmother, Maria, sent her son Michael to the parish priest in Foggia to learn music and a trade. From that priest, my grandfather learn to make furniture and how to build things out of wood. He also learned

how to play drums and guitar. Once in America, Babbononno would find immediate work utilizing his talents in furniture making and he would join with other Italian musicians playing music at night. As a result, he did rather well. My father's father, on the other hand, did not have a trade, and once he got here, was handed a pick and shovel, and told that, if he wanted to work, he had to utilize those tools at construction sites. This is what he did until he retired at age 65.

Babbononno and Grandpa Christoforo brought up their families in 2 worlds, the world of the Italiani in America and the world of the Americani. Sometimes it was rather tough, but my parents and uncles survived and that second generation of the Contini and Christoforo families did rather well. The one thing the old timers didn't stress was education. In the old country, the elite (maybe the enemies) the clergy (maybe the enemies) the nobility (maybe the enemies) were all educated. They were not to be trusted and whatever they did, you did the opposite. If they sent their children to school, you learned a trade. The way a man was judged was by his sore back muscles and the calluses on his hands. With that same philosophy in play in America, most of the first born generation, went into family businesses or learned a trade. The girls from Italian families might work when they were single, but that was to help support the family or put money away for when they got married. My mother loved math and was a whiz at it all her life, but she was forced by Babbononno to quit school when she was in the 10th grade. She went to work as a salesgirl in retail and remained at her job until she married my father. Later in life, she told me that she had regretted not continuing her education.

Dad and my uncles were proponents of education and made sure their children went to school. As a result, all of my cousins and I finished high school and went off to college.

None of us left home, as that wasn't heard of in those days, so we attended local colleges...a compromise that came from being part of

Italian families.

Well, that was a long time ago, and my story started out about the Sons of Italy. My dear friend, Dean Saluti, and I were sitting down at dinner one night and the subject of who and what we were came up. Considering our successes in life, we both agreed that it was time to give back something back to the Italian American community and we both became involved with the Sons of Italy. We became involved with a new lodge in the 1980s, The Greater Boston Renaissance Lodge. Dean eventually became the president and I the orator. Dean has stayed in that position, but I have moved on to positions within the Grand Lodge of Massachusetts. Today, I am the state treasurer.

I guess I'm the one who signs the checks.

The Sons has dwindled down over the years. It really isn't needed for survival any more as we've taken our place alongside the rest of the Americans. Today, it's more social than protective, but there are issues still out there: discrimination, prejudices and ethnic biases. And let us not forget Hollywood's images of The Godfather and The Sopranos. These discriminatory images we constantly fight on local and national levels through the OSIA.

To conclude, I wish to congratulate my brother and sister members of the Massachusetts Grand Lodge for 100 years of existence in our Commonwealth. You were necessary for the survival of our forbearers and you are still needed today.

Kalawao on the eastern end of the Kalaupapa peninsula on the island of Molokai.

Bishop Louis Désiré Maigret, the Vicar Apostolic of the Honolulu diocese, believed that the lepers at least needed a Catholic priest to assist them, he realized that this assignment could become a death sentence, therefore, he did not want to send any one person "in the name of obedience". Four priests volunteered to go. The bishop's plan was for the volunteers to take turns assisting the inhabitants. Father Damien was the first priest to volunteer and, on May 10, 1873, he arrived at the secluded settlement at Kalaupapa, where Bishop Maigret presented him to the 816 lepers living there. Damien's first course of action was to build a church and established the Parish of Saint Philomena. His role was not limited to being a religious priest. He dressed ulcers, built a reservoir, built homes and furniture. Made coffins, dug graves, built chapels, roads and helped organize farms.

The King of Hawaii didn't plan the settlement to be in chaos but he neglected to provide desperately needed resources. Fr. Damien changed an impossible situation into a colony of life. He restored faith in his battered and neglected flock. He showed them that despite what the outside world told them, they were precious in the eyes of God. He taught them to believe in God and showed them that by his genuine acts of charity there was purpose in their lives. He restored personal

pride and dignity among so many who had given up hope.

In December 1884 while preparing to bathe, Damien inadvertently put his foot into scalding water, causing his skin to blister. He felt nothing. Damien had contracted leprosy. Despite this discovery, he worked vigorously to build as many homes as he could and planned for the continuation of the programs he created after he was gone. He hastened to complete his many building projects, enlarged his orphanages, and organized his work. Help came from four strangers who came to Kalaupapa to help the ailing missionary: a priest, a soldier, a male nurse, and a Religious Sister.

Father Damien died of leprosy at 8:00 AM on April 15, 1889, at the age of 49. The next day, after Mass by Father Moellers at St. Philomena's, the whole settlement followed the funeral cortège to the cemetery where Damien was laid to rest under the same pandanus tree where he first slept upon his arrival on Molokai.

In 1936, at the request of King Leopoldo III of Belgium and the Belgian government, Damien's body was returned to Belgium and now rests in Leuven. After his Beatification, the remains of his right hand were returned to Hawaii and re-interred in his original grave site.


He was canonized on October 1, 2009 by Pope Benedict XVI.

Saint Damien is the patron of those with leprosy and the State of Hawaii. His feast day is celebrated on October 11th.



Bills Prove Costly Following Another Patriots Win Over Buffalo

It was something that quarterback Tom Brady had done 22 out of 24 times in his career. The Patriots organization had achieved the feat on 65 previous occasions, their most versus any NFL opponent. So when the game ended 37-22 in Orchard Park, NY last Sunday afternoon, was it any real surprise which team had come out on top between the Patriots and Buffalo Bills? Make it 23 out of 25 and 66 head-to-head wins.



on Sunday, but Brandon LaFell stole the show hauling in two touchdown passes and looks primed to be a playmaker going forward. His 18-yard catch and run through the Bills defense with 8:42 to play in the game virtually sealed the win for New England.

"I'm not sure really, historically," said Brady who threw four touchdown passes in the game. "I have a lot of respect for this team. They play hard every time we play them. I think we just somehow come out on the winning end." Come on Tom, just say it, you own the Bills. Sure, Terry Pegula is the new legal owner of the Buffalo franchise, but on Sunday at a sold-out Ralph Wilson Stadium, the Patriots once again proved that they are Chairmen of this rivalry and the AFC East.

New England took control of the game in a span of four minutes at the close of the first half and start of the second. The game was tied at 7 apiece before two Stephen Gostkowski field goals gave the Patriots a 13-7 lead at the half. Then Brady and the offense literally ripped the game from Buffalo's grasp when he connected with wide receiver Brian Tyms on a 43-yard touchdown. Both Tyms and Buffalo cornerback Stephon Gilmore came down with the ball, but Tyms just wanted it more.

"It's frustrating," said Bills tight end Scott Chandler, who continued to burn the Patriots in a losing effort, finishing the game with 105 yards on six receptions. "They've been the top dog in our division since the division was formed."

The continued resurgence of the Patriots offense seems to coincide with tight end Rob Gronkowski's return to elite form and as Brady has looked more consistently to targets other than Julian Edelman. Sure Edelman led the team with nine receptions

Defensively, the Patriots collected five sacks of Bills quarterback Kyle Orton and forced three turnovers. Chandler Jones applied constant pressure while Rob Ninkovich led the unit with 3 sacks. Jamie Collins picked off an ill-advised Kyle Orton pass in the second quarter. It was the second year linebackers first in regular season action, having previously recorded his first pro interception in last January's divisional playoff win versus the Indianapolis Colts.

The game did come at a cost for the Patriots as linebacker-defensive signal caller Jerod Mayo and running back Stevan Ridley both were lost for the remainder of the 2014 season with leg injuries. The offensive line took a hit with injuries to rookie center Bryan Stork and left guard Dan Connolly. Neither player returned to the game with Connolly suffering what the team called a head injury. The offensive line had played well the past two games, but faltered once Connolly went down, allowing the Buffalo front to frequently pressure Brady.

"We're just going to have to get contributions from other guys — some at the linebacker position and some at other positions as well," said Bill Belichick when asked about the loss of Mayo. "We'll see how it all comes together."





Jerry Quarry He Was His Own Toughest Opponent Part 2

In part one of this piece I discussed how Jerry Quarry could be so great on some nights, and on others how he seemed to just lose it. I focused on four fights, three of which were for the Championship, and his bout against George Chuvalo. Jerry was so great in fights against some of the toughest customers in the heavyweight division in the Golden Age of Heavyweights and yet performed poorly when he had his chance at the title (the Chuvalo fight was not for the title, the exception). Did he choke or panic in those fights? Or was it something else? I think in at least one of these bouts it was a matter of choking. In the others it appears to be panic. Now, please don't confuse either of these problems with having anything to do with a lack of courage. Jerry Quarry proved his courage in the ring time and again, and I would argue that if he was in a state of panic going into any of these fights, that would be even further proof of his heart by still stepping in there.

I'll begin with the Jimmy Ellis bout that took place in 1968. Jerry was the slight favorite going into this final match of the tournament for the WBA Heavyweight Title. The winner of this match would be widely accepted as the Heavyweight Champion now that Muhammad Ali was no longer allowed to fight. The winner would certainly meet Joe Frazier to unify the title.

Ellis was one of the most underrated fighters of the era. He was an excellent boxer puncher who moved like a middleweight and had the power of a heavyweight. His best punch was a sneak right hand. I am sure that Quarry worked on defensive measures against that sneak right while training for this fight. I am certain of this for two reasons. It just made common sense that he would, and from the outset of the match, Jerry seemed to be almost completely focused on watching and avoiding getting hit by it. Jimmy was able to keep him off balance with feints, and Jerry was never able to really let his punches go. That single-mindedness on Quarry's behalf looks like a

symptom of choking, where an athlete's mind slows down to the point of only being able to think of one movement at a time, almost a slow motion effect. Think single punches versus combinations. Jerry lost a split decision, but he fought as if he were sleepwalking. He was nothing like the Quarry who had beaten Thad Spencer and Floyd Patterson.

Jerry's next major fight was for the other version of the title against Joe Frazier in 1969. While he was not the favorite in this fight, he did possess the tools to give Joe a good fight and possibly defeat him. Jerry was one of the best counter punchers ever and he had just the type of footwork to move around Frazier effectively. Jerry had the ability to take small steps very quickly, this would have allowed him to step to the side of Frazier, who was also very fast, and throw counter shots in close quarters from an angle, using Joe's forward momentum against him. It would not be easy, but it could work. So, what happened? The bell rang for round one and Jerry walked straight into Frazier. It was as if Quarry had been given instructions from someone in the Frazier camp on how to be the perfect opponent for Joe. I think what happened is that Jerry trained properly for the fight and had a solid game plan, but when the bell rang panic set in. In boxing it is sometimes emotionally harder to box than to slug. When boxing, you are making the other guy miss you while landing your own punches. This is the epitome of what boxing is all about, but the part that can be nerve wracking is that while those punches are whizzing past you, something in your mind can start sending off warnings (fears) of what could happen if you started getting hit by those blows. After his first but with Joe Frazier, George Foreman commented that when Joe's hook flew by his head

he could feel the breeze from it, and it was scary. In psychology, it is sometimes said that verbal abuse can be worse than physical abuse because with the physical abuse the victim knows the limits of the pain. With verbal abuse, the imagination takes over and leads the abused to have an even greater reaction to the threats than if the actual physical act were to happen.

That's why I believe when Jerry came out for that first round panic set in. Somewhere in his mind he knew that Joe would eventually connect, and rather than try to avoid the blows he figured he would just go in and get it over with, hoping he would be able to outslug the champion in the process, a form of going out in a blaze of glory. Jerry didn't quit in the conventional sense of the word. He certainly showed great courage, but he had given up on himself, on his great ability, and ended up in a state of panic.

Why didn't Jerry have the same reaction when he fought heavy punchers such as Ron Lyle, Ernie Shavers, and Mac Foster? Those fights were not title fights, and perhaps being under just that much less pressure made the difference.

Next week I will conclude by discussing Jerry's fights with George Chuvalo, a fight that wasn't for the title but where we still saw some odd behavior on Jerry's part, and Muhammad Ali, a fighter known for getting into his opponents' head. I will also explore what goes on in a fighter's mind during a bout.

The opening home stand of the season had come to its conclusion and judging from the comments of some people, one would have thought the world was ending.

The Bruins had been defeated in three consecutive games after their initial opening night victory, the first time they had experienced three straight setbacks since a similar stretch back in the middle of March, 2012.

And now, according to some, the floodgates had been opened, the ship was sinking and the possibilities for a successful season were going down the drain.

But, of course, things were far from over. In fact they were just beginning. As the Bruins took to the road for a relatively short three-game road trip, there was more than enough time to reverse the course, to right the somewhat sinking ship and have a fine season to remember.

But it does have to start soon. This is hockey, a pro sport that has only 82 regular season games compared to the 162 played in Major League Baseball.

"The bottom line is we've got to turn it around as soon as possible," said B's Head Coach Claude Julien before leading his club out the door for the start of a short three-game road trip. "Right now I think a lot of guys are forcing things and that could be because of the situation that we're in. The finish — whether it's around our net or on other opportunities — has to get better."

Julien also feels that the less-than-positive launch to the season could have a silver lining. "Those are the things that make your team a stronger team and a better team down the road," he noted. "When you have adversity, a lot of teams will tell you at the end of the year that it probably made them better hockey clubs. It can only do that for us if we start learning from it and we get ourselves going in the right direction. So I don't think those kind of things hurt you. If anything, they'll help you in the long run."

And it is the long run that really matters. The regular season does not end until mid-April so there's quite a bit of hockey to be played over

the course of the next six months. If a number of contests had been played before losing three straight games at home, chances are it would be seen as more of a blimp on the radar than a major negative occurrence.

For example, if the three-game home losing streak had happened in January, at a time when 40-45 games had been played, there would have been a substantial number of victories that would have cushioned the result. Early in the season, devoid of a pile of wins, it looks much worse than it really is.

That's not to say that early games are meaningless. They aren't. Those who read the tea leaves in the NHL tend to take a measure fairly early — around Thanksgiving Day. Both Julien and Bruins President Cam Neely are proponents of the idea that a good indication of how the teams will finish the regular season can be ascertained by looking at the NHL standings on Thanksgiving morning.

It's not a perfect picture. But seven weeks in tells those with experience that trends have started to form — many of which will continue throughout the season. Perhaps those in Bruins Nation who are so critical at the start should wait until Thanksgiving — when a much more clear picture of the 2014-2015 season is evident.

An early panic can compound the negative while a measured response can restore balance and confidence — the hallmarks of a successful season.

WHAT WOULD HE THINK OF KELLY OLYNYK? — It was during the preseason and Coach Julien was in a real good mood, smiling and interacting with members of the media. It was then he told one scribe sitting a couple of rows in front of us to "get a haircut." It was obvious that he meant it in a playful mood, but if one believes that there is a kernel of truth in every jest, then one has to wonder what Boston's hockey coach would think of 7-0 Celtics center Kelly Olynyk — a player who sports one of the longest manes in the NBA.

Not much we think. Olynyk, a native of Canada, would be in for a trim, we feel, if Julien had anything to say about it. He doesn't, of course, which means that Olynyk is free to display his distinctive hair style throughout the season.

GOING WITH GAGNE — Veteran forward Simon Gagne was signed to a one-year contract by the B's just before they departed on the road trip, a signal that there could be changes throughout the season.

Gagne, who has played 13 seasons in the NHL, had scored 288 goals and 309
