more commonly called Seneca the Philosopher. He was born in Spain about 3 B.C., brought to Rome at an early age, and educated by some of the most eminent philosophers of the time. His enthusiastic acceptance of their teachings and life-style caused him to emulate their way of life. He also became a brilliant lawyer. The Emperor Caligula soon became jealous,

ill health, and also because of rumors that he would soon die a natural death. Seneca surpris-Claudius, but he also made enemies of some powerful officials. After being accused of intimacies with a relative of the for-

and a severe critic of Seneca, and consequently marked him for destruction. Seneca was subsequently spared because of ingly rose to great prominence under the succeeding Emperor

mer Emperor Tiberius, Seneca was banished to Corsica for about eight years. Through the intervention of Agrippina (wife of Claudius), he was returned to Rome to tutor her son Nero.

Nero became emperor after the death of Claudius, and it is reported that during his early years, the only decent part of his reign was brought about as a result of Seneca's guidance. This period was known as the "gold quinquennlum" (golden five years). It soon became evident that Nero could not be controlled. He turned against Seneca, and in time caused him to commit suicide.

We are told that Seneca was one of the most brilliant figures of his time, and equal to the greatest intellectuals of the Silver Age.

His prose works were numerous and important. These included many speeches which were written for Nero, several treatises, a biography of his father, a panegyric (praise) of the famous Messalina, and a number of books of letters.

The greatness of Seneca probably stems from his narratives on morality. Many of his letters were written as sermons, while others attacked the vices of that time. He was one of the foremost Stoic philosophers of Rome. Much of his literary work greatly influenced Italian and French classical drama during the Renaissance period of many countries.

America's Italian Heritage

"Tutti gli uomini sono per natura egualmente liberi e indipendenti."

— Filippo Mazzei (1730 - 1816)

In 1776, writing our American Declaration of Independence, Mazzei's colleague and friend, Thomas Jefferson, drew on the line above by Mazzei, and gave us the now-familiar phrase 'All men are created equal." Mazzei, a son of Italy, was a man of many accomplishments, he was trained and practiced as a physician, he engaged in international trade, and promoted liberty in Europe and America. During the American Revolutionary War, he acted as an agent to purchase arms for Virginia.

The contribution of Philip Mazzei to the Declaration of Independence was acknowledged by John F. Kennedy in his book A Nation of Immigrants, in which he states that:

"The great doctrine 'All men are created equal' and incorporated into the Declaration of Independence by Thomas Jefferson, was paraphrased from the writing of Philip Mazzei, an Italian-born patriot and pamphleteer, who was a close friend of Jefferson. A few alleged scholars try to discredit Mazzei as the creator of this statement. and idea, saying that 'there is no mention of it anywhere until after the Declaration was published.' This phrase appears in Italian in Mazzei's own hand, written in Italian, several years prior to the writing of the Declaration

of Independence. Mazzei and Jefferson often exchanged ideas about true liberty and freedom. No one man can take complete credit for the ideals of American

Many of the heroes of the American Revolution were foreign-born and raised. Historians have long recorded with interest the contributions of German, French, Polish, Italian, and other nationals who fought and died on behalf of the cause of America's liberty.

The U.S. Commission for the Preservation of America's Heritage Abroad is an agency of the Government of the United States of America. The establishment of the Commission recognized that the population of the United States is mostly comprised of immigrants and their descendants. The United States has an interest in the preservation of sites in other countries related to the heritage of these Americans.

In 2008, the Commission funded a memorial to Philip Mazzei in his birthplace of Poggio-a-Caiano, Italy. The funds for this memorial were generated by Commission Member Tyrone Fahner and the American Society of the Italian Legions of Merit. The project was an initiative of New York State Supreme Court Justice Dominic R. Massaro.



He is Senior Director of Government and External Affairs at the Massachusetts Association of Health Plans, an organization of 17 of the Commonwealth's health insurers which cover over 3 million Massachusetts residents. He previously served as Deputy Chief of Staff and Legislative Director to former House Speaker, Sal DiMasi, and

prior to that, served as former Speaker DiMasi's Director of Constituent Services.

Mr. Aluia attended Suffolk University, and is very active in the neighborhood, serving on numerous boards and committees, including the St. Anthony Feast Society; the Christopher Columbus Day Celebration Committee; and is the chairman of the Ward Three Democratic Committee of Boston.

NEW Health operates three community health centers in the North End, Charlestown, and at the Charlestown High School. With a yearly budget approaching \$25 million and over 170 employees, the center cares for over 15,000 patients annually. 

bestsellers and have received national recognition. He wrote Dark Tide, The Boston Italians, A City So Grand, and more!



Author David Kruh

Revives Old Days of Scollay Square

NEW DATE: On Monday, October 21 from 7:00 to 9:00 p.m. at The West End Museum, sneak backstage and settle into the cushioned seats of Scollay Square's famous — and infamous — theater, The Old Howard. Author and historian David Kruh will regale attendees with tales of Boston's legendary Square and reveal largely unknown stories of famous inventors, Civil Rights activists and future presidents who had a role in the Old Howard's history. Admission is free for Museum members and \$10 for non-mem-






bers. Pre-registration is required at the Museum's website.

A former New Yorker born just a few years before Scollay Square fell in 1962; Kruh first became interested in the area through his uncle. A WWII sailor and doctor who'd spent "liberty time" in Boston, Kruh's uncle told many stories about the notorious "playground." Kruh's first book, Always Something Doing: Boston's Famous Scollay Square, came out in 1990. In 2004, Arcadia Publishing released Kruh's Scollay Square as part of its *Images of America* series. The book featured nearly 200 never-before-seen photos of the Old Howard Theatre, Howard Casino, and more.

Kruh has also written works for the stage, including The Curse of the Bambino, about the fateful 1920 sale of Babe Ruth to the New York Yankees by the Boston Red Sox, and the team's subsequent decades chasing the World Series championship. The musical premiered in 2001 at Boston's Lyric Stage and broke all box office and attendance records.

Magic — the word rolls off your tongue like a charm, filled with wonder and possibility. It conjures images of puffs of colorful smoke and cards that disappear into the air. I particularly think of magic during the month of October, when signs of the mystical side of life surround me. Leaves shining on the pavement after a chilly rainfall, candles flickering inside toothy jack-o-lanterns,

the foreboding sky of an early evening, the cackle of witches — all these elements make October a month in which to revel in the supernatural and in the spooky sense of the unknown. This longing for the mysterious taps into our primordial collective unconsciousness, as some of our earliest introduction to magic tropes and beings came from our childhood. The wonderful

eves to a plethora of bizarre, subversive, and enchanting elements. These were tales where powerful women could shape a person's destiny with wishes and spells, where animals and trees talked, where the assurance of a happy ending always came as a result of an arduous and mutable journey. Fairy tales have proved so instrumental in shaping our psyche that modern scholars debate, dissect, and study them in the halls of academia. My introduction the fairy tales came as a result of my grandmother, Nonna, whose bedtime stories evoked an Italian countryside full of tricky gnomes, prowling wolves, and wise, grizzled crones. The spooky, magical month of October is perfect for diving into the folktales of Italy and the motifs that make them still so popular today.

Any mention of fairy tales instantly brings to mind the specific names of these stories' protagonists, from Snow White to Little Red Riding Hood. Repeated through oral tradition and echoing across generations, these characters have mutated and morphed to fit the values, mores, and customs of each time period or locale, while still keeping the core of their stories intact. Italy boasts variations of several of our beloved fairy tale protagonists. An early version of Cinderella, called Cenerentola, is present in the collection of seventeenth-century poet Giambattista Basile. In Basile's tale, a girl named Zezolla is forced to work in the kitchen by her stepmother until a fairy living in a date tree magically prepares her for a royal ball. Basile also recorded a story similar to Rapunzel, in which the main character was named Petrosinella, or parsley, and was held captive by an ogress rather than a witch. Another fairy tale named Maria, the Wicked Stepmother, and the Seven Robbers blends elements of Snow White with those of Hansel and Gretel, as a young girl named Maria is abandoned in the woods at the behest of her stepmother, only to stumble across a home belonging to seven robbers and eventually marry a prince. However, my absolute favorite fairy tale, the one most laden with foreboding and symbolism, is Little Red Riding Hood. The Italian version of this tale, La Finta Nonna ("the false grandmother") incorporates all the familiar elements a girl visiting her grandmother and realizing that something is wrong-but also adds other unique components. For example, the creature who eats the grandmother is an ogress rather than a wolf. Furthermore, Little Red Riding Hood herself manages to defeat the ogress and release her grandmother, rather than depending on a huntsman. Talk about girl power!

Fairy tales, whether originating in Italy or not, endure because of their highly symbolic and extremely universal archetypes. In fact, I find that the most common fairy tale motifs frequently remind me of my time in Italy over ten years ago, particularly the days spent

Saint Rose Venerini

Rose was born i n Viterbo, Italy, in 1656. Her father, Goffredo, after having completed his medical studies at Rome, m o v e d t o Viterbo where he practiced at the major hospital of the city. He

became noted for his work. Rose's mother was Marcia Zampichetti, of an ancient family of Viterbo; she had four children: Domenico, Maria Maddalena, Rosa, and Orazio.

Rose made a vow to consecrate her life to God at the age of seven. At age twenty, though, ahem chose to accept an offer of marriage; her fiancé, however, died shortly after their engagement.

Following the death of her fiancé, she entered a convent, but soon returned home to care for her newly widowed mother. Meanwhile, Rose invited the women of the neighborhood to recite the rosary in her home.

As she looked to her future under the spiritual guidance of a Jesuit priest, Rose became convinced that she was called to become a teacher in the world rather than a contemplative nun in a convent. She was a born teacher, and the free school for girls she opened in Viterboi in 1685 was well received.

Rose had a real ability to teach and to train teachers. Her reputation spread, and in 1692, she was invited by Cardinal Barbarigo to advise and help in the training of teachers and organizing of schools in his diocese of Montefiascone.

The first objective of Rose was to give poor girls a complete Christian formation and to pre-

pare them for life in society. Rose opened the first public school for girls in Italy.

From 1692 to 1694, she opened ten schools in Montefiascone and the villages surrounding Lake Bolsena. The cardinal pro-

vided the material means and Rose made the families aware of the value of education for their daughters, trained the teachers, and organized the schools


On December 8, 1713, with the help of Abbot Degli Atti, a friend of the Venerini family, Rosa was able to open a school in the center of Rome, at the foot of the Campidoglio.

On October 24, 1716, the Sisters received a visit by Pope Clement XI, accompanied by eight cardinals, who wanted to observe the lessons. At the end of the morning, he addressed these words to Rose: "Signora Rosa, you are doing that which we cannot do. We thank you very much, because with these schools you will sanctify Rome.

Rose Venerini passed away in Rome on the evening of May 7, 1728. By then, she had opened more than 40 schools.

The Sisters went to the United States in 1909, primarily to help the Italian immigrants, establishing the first day care centers in many cities of the Northeastern United States. They served in Switzerland from 1971 to 1985 and the congregation has since extended its apostolic activity to India, Brazil, Cameroon, Romania, Albania, Chile, Venezuela, and Nigeria. Rose Venerini was canonized by Pope Benedict XVI on October 15, 2006. Her feast day is May 7th.


Four Women "Quattro Donne" subtitle, A North End Love Story

In the next few weeks this column will feature excerpts from this book.

Excertp from Four Women:

After Grandpa passed away, Grandma and Auntie Stella took a flat on the second floor of a bow front building, over a barbershop, on Garden Court Street, the same street Rose Kennedy once lived on when the neighborhood was Irish. Their building had a black, spiral, iron staircase, which everyone feared was too difficult for Grandma to climb, but she managed just fine.

Grandma had this black, French Bulldog, Blackie, that always sat at the entrance of her flat. She never closed the door, so the dog spent all his time sprawled across the threshold, peering down the spiral staircase. Blackie snored and passed gas all day long, making the entrance to Grandma's flat smell of whatever Blackie ate the night before and had trouble digesting. One steamy hot summer day, Grandma was trying to take a nap. Blackie's snoring, gassing and occasional snort, prevented her from sleeping. Grandma was swearing at the dog in Italian, yelling out: "Smetti di russare e scorggiare!" (Stop snoring and gassing!) When she couldn't stand it any longer, she threw her slipper at him, hitting Blackie on the head, bending his ear. Grandma



spent the rest of the day massaging Blackie's ear, trying to make up with the dog, and get the ear to stand straight. She feared what Auntie Stella would say after seeing the ear bent, because this happened before, only it involved Blackie's other ear. The ear never straightened out, and Blackie continued to snore and gas, seemingly, to take revenge on Grandma for her burst of temper.

Grandma and Auntie Stella had these little skirmishes that didn't amount to much, but certainly enlivened each day. Although Grandma could speak English, her arguments with Auntie Stella were always punctuated with Italian, while Auntie Stella argued in both English and Italian. Grandma was at a disadvantage, she could not understand everything Auntie was saying, aggravating her. When arguing, every inch of her body was animated, she made hand gestures that didn't need translating. The arguments always ended with Grandma tossing one arm in the air and walking away, leaving Auntie Stella alone with Blackie, while Grandma proceeded down the stairs, muttering things in Italian. There were times when Grandma would decide to go to church in the middle of an argument. She put on her little black, straw hat, fastened to her head by a long hatpin with a pearl at the end, make her way down the stairs muttering in Italian, with only the black veil and brim visible from the landing above. It all ended with Auntie Stella looking out the window, making certain Grandma made it safely across North Square to the church.

Almost all Italian grandmothers have their own special recipe for Italian Torta di Mele (Apple Cake). When you think of the abundance of apple orchards there are in Northern Italy, producing some of the world's finest apples, it certainly comes as no surprise! Unlike American Apple Cakes that are mainly batter and spices, Italian Apple Cakes are all about the apples and contain very little batter. The main ingredients are few and basic: apples, flour, sugar, eggs, oil or butter, milk, baking powder, and flavoring, which is most often lemon zest.

My Nonna had a Golden Delicious apple tree in her back yard, which just happens to be the perfect apple to bake with. She and I made many delicious desserts with these apples. Nonna always seemed to favor her Sicilian Apple Cake, made with raisins and walnuts. While I preferred this version, which is plain, simple and so easy to make. This Italian Torta di Mele is absolutely perfect to serve for breakfast, on a crisp fall morning, or in the afternoon with a cup of coffee or shot of espresso. It is best when served warm, and simply heavenly when paired with a scoop of vanilla gelato!

ITALIAN APPLE CAKE Torta di Mele

2 extra large eggs 1 cup sugar

5-6 large Golden Delicious (or 1/4 teaspoon salt Cortland) apples, peeled, cored, and cut into 1/4-inch slices

Juice of 1/2 large lemon 2-3 tablespoons or into 1/4-inch cut

2est of 1/2 targe temon 1/3 cup whole milk 7 tablespoons butter, melted 1 3/4 cup All Purpose Flour 2 teaspoons baking powder 1/4 teaspoon salt

2-3 tablespoons sugar 2-3 tablespoons cold butter, cut into 1/4-inch cubes Confectionary sugar (for dusting

top of cake)

Preheat oven to 350°. Grease and flour a 9-inch Springform pan. Peel, core and cut apples into 1/4-inch slices and place in bowl. Immediately add the lemon juice in with the apples, toss well (will prevent browning) and put aside. In a separate mixing bowl, beat the eggs and sugar until a pale yellow, add lemon zest. Sift the flour, baking powder and salt into the wet mixture. Add the cooled melted butter and milk gently. Take just a little over half of the apples and add them to this batter. Using a spatula, fold gently and then pour into prepared Springform pan, distributing evenly. Layer the remaining apples on top of this mixture in a decorative spiral form. Sprinkle 2-3 tablespoons of sugar on top of apples, then evenly scatter the 1/4 inch cold butter cubes on top of the sugar (this will caramelize the apples). Bake at 350° for about 1 hour and 10 minutes. When done, as ovens vary, cake will be golden brown on top and sides may slightly pull away from the pan. Let sit for about 10 minutes before removing the sides of the pan. Sift confectionary sugar over top, slice, and serve.

Put Fall Leaves to Work in Your Landscape

like a chore and a never-ending one, at that. Reduce time and effort spent managing fall leaves leaves and other landscape trimby putting this valuable resource to work in your landscape.

Use your mower to recycle leaves right where they fall. As you mow the grass, you'll shred the leaves into smaller pieces. If they are the size of a quarter or smaller, your lawn will be fine. As these leaf pieces decompose, they add organic matter and nutrients to the soil.

bagger to shred and collect the leaves with every pass of the mower. Only use grass clippings collected from lawns that have not been treated with a weed killer this fall. Or burn a few extra calories and rake the leaves into a pile. Shred with a leaf shredder or mower and spread them over the soil surface helps insulate plant roots, conserve moisture, suppress weeds and improve the soil as it breaks down.

Bag shredded leaves you want to save for next season. Tuck them out of sight for winter under trees or around the foundation of your house for added insulation.

Dig extra shredded leaves into vacant annual flower and vegetable gardens or incorporate them into the soil as you prepare new planting beds. They will break down over winter, improving the drainage in heavy clay soils and

Raking fall leaves can seem the water-holding ability in fastdraining soils.

Create compost with shredded mings. Do not use meat, bones or dairy that can attract rodents. Avoid diseased, insect-infested trimmings and weeds that can survive in compost piles that don't produce enough heat to kill these unwanted pests.

Start with a compost pile that's at least three feet high and wide for efficient decomposition. Place a mixture of shredded fall Another option is to attach a leaves, grass clippings free of herbicides, vegetable scraps and other landscape trimmings in an 8- to 10-inch layer. Cover with compost and sprinkle with a low nitrogen, slow release fertilizer.

Repeat the layers until the pile is the desired height. Then moisten until it's the consistency of a damp sponge. Turn the pile occasionally, moving the matearound perennials. Leaf mulch rial in the center to the outer edge and the less decomposed trimmings to the hotter center. It's a great workout and speeds decomposition. Or pile the materials in a heap and let nature do the work; it just takes longer.

> Oak and large maple leaves both make great mulches and additions to the compost pile but are slow to break down. Shred them with your mower or leaf shredder first for better results. Avoid black walnut leaves that contain juglone, a compound which is toxic to many plants.



Nanna & Babbononno

Back in his day, just before the turn of the 20th century, there was a lot of discrimination and prejudice leveled at the unwanted newcomers, the Eyetalians. As a result, Italian organizations sprung up in every community the new comers settled in. The one dominant, now national, organization is the Sons of Italy. This year, the members celebrate the 105th anniversary of the Grand Lodge of Massachusetts.

Babbononno was proud of his people and wanted to help them through this organization, those new comers who might have trouble adjusting to American life. What he later told me and I verified it with a bit of research was, 95% of the Italians who came here in that first wave, from 1880 to about 1900, were from southern Italy (south of Rome), and were illiterate in both Italian and English. Because of the isolation in southern Italy, they were distrustful of people from other provinces than their own. Napolitani didn't trust Siciliani, Siciliani didn't trust Calabrese, etc. ... Once in America, they continued with this approach to people, and as a result, remained fragmented as an ethnic group. Not knowing the ins and outs of the culture, they let mercenaries, Italians who preceded them, take advantage of them. So, 105 years ago, when the OSIA came into existence in Boston, Babbononno was right there, ready to join and help Italians less fortunate than himself.

It wasn't all business. When my mother and uncles were kids, there were family event that were sponsored by the Sons of Italy, dinner parties, dances, outings when the weather was good, and church activities, as most of the Italian population was Catholic.

Babbononno was lucky once he came here. He had two talents he could put to good use and make money. My great grandmother, Maria, sent her son Michael to the parish priest in Foggia to learn music and a trade. From that priest, my grandfather learned to make furniture and how to build things out of wood. He also learned how to play drums and guitar. Once in America, Babbononno would find immediate work utilizing his talents in furniture making and he would join with other Italians musicians and play music at night. As a result, he did rather well. My father's father, on the

other hand, did not have a trade, and once he got here, was handed a pick and shovel, and told that, if he wanted to work, he had to utilize those tools at construction sites. This is what he did until he retired at age 65.

Babbononno and Grandpa Christoforo brought up their families in two worlds, the world of the Italiani in America and the world of the Americani. Sometimes it was rather tough, but my parents and uncles survived and that second generation of the Contini and Christoforo families did rather well. The one thing the old timers didn't stress was education. In the old country, the elite (maybe the enemies) the clergy (maybe the enemies) the nobility (maybe the enemies) were all educated. They were not to be trusted and whatever they did, you did the opposite. If they sent their children to school, your children learned a trade. The way a man was judged was by his sore back muscles and the calluses on his hands. With that same philosophy in play in America, most of the first-born generation, went into family businesses or learned a trade. The girls from Italian families might work when they were single, but that was to help support the family or put money away for when they got married. My mother loved math and was a whiz at it all her life, but she was forced by Babbononno to quit school when she was in the 10th grade. She went to work as a sales clerk in retail and remained at her job until she married my father. Later in life, she told me that she had regretted not continuing her education.

Dad and my uncles were proponents of education and made sure their children went to school. As a result, all of my cousins and I finished high school and went to college.

None of us left home, as that wasn't heard of in those days, so we attended local colleges ... a compromise that came from being part of Italian families.

Well, that was a long time ago, and my story started out about the Sons of Italy. Quite a while ago, Dean Saluti, and I were having dinner at a restaurant one night and the subject of whom and what we were came up. Considering our successes in life, we both agreed that it was time to give back something to the Italian or Italian American community and we both became involved with the Sons of Italy, he first and I a bit later. We became involved with a new lodge in the late 1980s, The Greater Boston

Renaissance Lodge. Dean eventually became the president and I the orator. Dean has stayed in that position, but I moved on to various positions within the Grand Lodge of Massachusetts. I made it up to the level of state treasurer and after two terms, decided to call it quits, and let the younger people have a chance as state offices. Today, I am a member of the Culture Commission, something I can participate in from where ever

I am, Boston or Florida. The Sons has dwindled down over the years. It really isn't needed for survival any more as we've taken our place alongside the rest of the Americans. Today, it's more social than protective, but there are issues still out there: discrimination, prejudices and ethnic biases. And, let's not forget Hollywood's images of The Godfather and The Sopranos. These discriminatory images we constantly fight on local and national levels through the OSIA. As of late, several communities have tried to disgrace Columbus and have cancelled Columbus Day as a holiday. The Italian American Alliance, October is Italian Heritage Month, the Pirandello Lvceum, the Dante Alighieri Society, many Italian clubs, as well as the Sons of Italy are all attempting to combat the people who are trying to re-write history and discredit the Italian navigator.

Columbus Day is at hand and there are celebrations that are taking place all over the state, thanks to the Heritage Month Committee. One of the oldest celebrations is the parade in Boston. Each year it is in either East Boston or the North End. I used to run the Sons of Italy part of the parade, but retired from that a few years ago also, but I've been dragged out of retirement by Dean Saluti and was on the reviewing stand for Revere's parade on Monday the 14th. My job was to introduce Dean's addition to the parade, the twenty something antique cars and their drivers who led off the parade. I was delighted that some of you stopped by and say hello, I was on the reviewing stand on Broadway in Revere all afternoon on the 14th, and was so happy to see you and say hello back and wish you all a "Happy Columbus Day."

in my father's quaint hometown of Sulmona in the mountainous Abruzzi region. One such archetype is the enchanted forest, or woods filled with magic, mystery and the tingling possibility of both danger and opportunity. In Sulmona, where the forest stretched endlessly in a sea of lush emerald green and trees whispered secrets in the wind up the mountainside, it was easy to imagine elves and gnomes hiding among the foliage. The concept of the crone appears in many fairy tales as well. These immensely powerful, wizened old women wielded their abilities for good, as in the case of fairy godmothers, or for bad, as in the case of sinister witches. These examples of female agency always impressed me, especially in a genre which often took a more traditional approach to gender roles, and in their positive iterations, the crones remind me of my own wise and resourceful Nonnas. Finally, there is the image of the wolf. The wolf was once the most feared animal in Europe, and as such figured in many folktales as a symbol of menace and the unknown. In fact, though Italy has its own rendering of Little Red Riding Hood, most Italians are also familiar with the famous version in which a wolf swallows the grandmother. My father frequently spoke of having to ride his bicycle home late at night during his childhood, snaking through darkened mountain roads as wolves howled in the distance. Fairy tales tap into our subconscious fears and desires, and therefore their symbolism will always be repeated and reinterpreted with each passing year.

As Halloween approaches, my thoughts turn to everything that is spooky and, well, magical. Fairy tales perfectly encompass the mood of the wondrous month of October, a month that sees the mystical dance of the harvest and ends with a festival honoring the unknown. From enchanted forests to women who can grant wishes with the wave of a wand, from





It's Been 60 Years Since Tiger Ted Lowry and Rocky Marciano First Fought

Controversy Still Hangs Over the Fight

Rocky Marciano

On October 10, 1949, at the Rhode Island Auditorium in Providence, the up and coming heavyweight prospect Rocky Marciano stepped into the ring with veteran Tiger Ted Lowry. Marciano had won his first 20 fights, 19 by knockout, and was stepping up in class against the cagey and hard hitting Lowry. Ted's record going into the fight was 63 wins, 49 losses, and 9 draws, but these numbers don't tell the real story behind what a formidable opponent he was.



Rocky Marciano

Lowry had been fighting since 1942 and had faced many of the best fighters of the time. He had also squared off against champion Joe Louis in an exhibition bout where he more than held his own. He had been stopped only one time in those 121 bouts. He showed no scars on his face, a tribute to his fine defensive skills. His record lists such names as Archie Moore, Lee Oma, Omelio Agramonte, Aaron Wade, and Lee Savold.

This fight would be Marciano's first big test against a highly skilled fighter who would be able to extend him. The fight was scheduled for ten rounds, and went the full distance.

Three thousand, six hundred ninety six fans showed up, the vast majority were there to cheer on Marciano. As the bell rang for the first round it quickly became apparent this was not going to be an easy night for the kid from Brockton. Lowry stung Marciano in the first round with two right hands, and in the second hurt him with a pair of left uppercuts. Lowry held the upper hand in the 4th round as well when it appeared Marciano was close to being stopped.

Things changed in the 5th round when Lowry went into a more defensive posture. Some of the fans started booing as they felt Lowry was purposely backing off. Had he been told to

At the end of the ten rounds the decision was awarded to Marciano. This did not go over well with the crowd that felt Lowry deserved the win. Of course, when a prospect has

well with the crowd that felt Lowry deserved the win. Of course, when a prospect has been on a roll and has been mowing down every opponent put in front of him, his fans will feel let down when he has a night where he looks less than

Out of his 49 fights Marciano only had two that could be called at all controversial decisions. This fight with Lowry and his first bout against Roland LaStarza. In the LaStarza fight Marciano decked Roland at the end of the 4th round. Marciano had the 8th taken away from him because of a penalty for hitting low. One judge had LaStarza winning 5 rounds to 4, while the other judge had it for Marciano by the same margin. The referee had the bout even at 5-5 but gave Marciano the nod on points. The press reported the win as paper thin. This wasn't so much controversial as it was a very close fight that could have gone either way.

In the Lowry fight it is very possible Marciano got the benefit of the doubt in getting the decision, but the controversy was not so much over the scorecards but rather Lowry's change of tactics in the fight. Even today it is said either the fix was in or Lowry was told to back

off when he came to his corner after the 4th round.

To the first accusation, that the fight was fixed. This doesn't hold up at all. If Lowry had agreed to throw the fight why would he have gone after Marciano so hard in those early rounds, almost stopping him in the 4th? He was obviously going for the win; there can be no doubt about that.

The other theory is that after the 4th round his corner men told him to back off. The reason being that certain people had spoken to them during the round and told them it would be bad for their health if Lowry kept up the his assault. Could this have happened? Well, it is boxing so anything is possible.

Ted Lowry never ever said this happened. He felt he deserved the decision, and denied he had been told to back off. He told reporters that after the 4th round Marciano had changed his strategy and he only adapted to that change. He still felt that he won two of the last 5 rounds which, coupled with his strong start entitled him to the win. It must also be noted that Marciano came on strong in those later rounds, a trait he would display throughout his career.

Unfortunately, no film of the fight exists. What really happened? If you look at the rest of

Marciano's career, you will see a number of fights where he did not do well in the early rounds. His matches against Jersey Joe Walcott and Archie Moore are two examples. The Moore bout might be the best one to use when trying to figure out what happened in the Lowry fight.

Against Moore, Marciano was decked in the second round by a thunderous right hand. Moore landed heavily on him and appeared to have the upper hand. However, Marciano got stronger as the fight progressed, and by the 9th round had worn Moore down and stopped him.

It is very likely a similar thing happened in the Lowry fight. While Tiger Ted was landing heavily on Marciano early on, the Brockton Blockbuster never stopped coming. When Lowry says Marciano changed tactics after the 4th round, that is also quite possible. With the brilliant Charley Goldman in his corner it is likely given solid instructions, probably along the lines of being told to get into a lower crouch so he would not be an easy target.

I believe this fight was on the up and up. It is possible that Lowry deserved the decision, but it was not the Brink's robbery. What was seen that night was the drive that would lead Marciano to go on to win the heavyweight title.

The two would meet again a year later with Marciano winning a decision. Ted Lowry did not dispute the outcome of this fight.

It is interesting to note that out of Marciano's 49 victories; only two could be considered at all close. The wins over LaStarza and the first fight with Lowry were close, but in both fights Marciano had a solid claim to victory.

It should also be noted that Ted Lowry was the only man go the distance twice with Marciano, and other than Ezzard Charles, he fought the most rounds against the Rock.

HOOPS and HOCKEY in the HUB

SPANNING THE DECADES TOGETHER — They may have never encountered each other but they have coexisted in America for

They both have been in their share of the limelight over the decades, one on a more regular basis in more recent times while the other somewhat more sporadically. To the best of our knowledge, they have never met — though both are obviously aware of each other's presence.

some 95 years — and counting. They are both known throughout

America and indeed the world.

One is an individual and the other is an organization which employs individuals, a number of whom have earned fame and fortune based upon their performance.

Yes, that is one of the many ways to view the life of former U.S. President Jimmy Carter and the fortunes of the Boston Bruins, both of whom are 95 years young in 2019, separated by only two months with regard to their entrance into the world.

Carter, the former governor of Georgia who served one term as President from 1977 to 1981, was born on October 1, 1924, in the small town of Plains in the Peachtree State, the community where he continues to reside.

He continues to be in the news because of his association with the Habitat for Humanity a charitable organization that builds homes for lower income people throughout America. In addition, he has survived a serious challenge from cancer in recent years. Just a few weeks ago, he drew some media attention for needing 14 stitches just above his left eyebrow following a fall in his home.

But just like so many of the players that perform for that team in Boston, he emerged once again ready to engage in life none the worse for wear.

Just two months after Carter was born the Bruins took to the ice for the first time on December 1, 1924 — defeating the Montreal Maroons 2-1 at Boston Arena, the venue now known as Matthews Arena and the home of Northeastern University athletics.

And just as the two continued to be active down through the decades, so too did they continue to celebrate in their own distinctive ways as the bulk of the 20^{th} century and the first portion of the 21^{st} century rolled on by.

In fact, both have celebrated milestones in the same week more often than not. Carter, of course, observes his birthday every year on the first day of October. And just a few days after that the Bruins also have an annual celebration. It is their opening night game of the season in the National Hockey League.

This year, the candles were just barely out on Carter's cake when the B's left for the airport and traveled to Dallas where they opened the 2019-2020 campaign against the Dallas Stars.

It was the 95th opening night for the Bruins and they didn't disappoint, downing the Stars to increase their overall record to 41-38-16 in first games of the season for the team that hails from Causeway Street.

Carter is the first U.S. President in history to reach the age of 95.The Bruins, however, are not first in season openers in the National Hockey League. They are third, exceeded by only the Montreal Canadiens and the Toronto Maple Leafs. Both of those teams have celebrated the opening of a new NHL season on 102 occasions.

Jimmy Carter — the President whose lifetime has literally encompassed the entire history of the Boston Bruins. Those beloved B's — who existence as a franchise has run parallel to all but two months of Carter's life. Linked by a common span of time, they move forward, soon to greet the third decade of the $21^{\rm st}$ century, where — in a wonderful way — all that exists are possibilities.

RAY BOURQUE TO BE HONORED — The former Bruins all-star defenseman will be presented with the Keith Magnuson Man of the Year Award at the NHL Alumni Awards Celebration that will be held in Toronto on October 26th.

The award is given "to a former player who has applied the intangibles of perseverance, commitment and teamwork developed through the game into a successful post-career transition. He is an ambassador for the game at all levels through his continued commitment to the community and charitable causes."

Bourque, who played more than two decades in the NHL, won the Norris Trophy five times and was inducted into the Hockey Hall of Fame in 2004. He retired as the top scoring defenseman in NHL history with 410 goals and 1,169 assists for a total of 1,579 points. He won a Stanley Cup in his final year in the NHL (2000-2001) with the Colorado Avalanche.

Many may remember when he brought the Cup back to the Hub on June 12, 2001, hoisting the trophy above his head at Boston's City Hall Plaza before a crowd of several thousand fans that had gathered on a warm late spring day. "Every loves Raymond," said Bourque into a microphone as he used a play on words that referenced the title of a popular TV show of the time. "And Raymond loves you." The crowd went wild with its appreciation and applause.

Since his retirement, he has been involved in a number of charitable causes in the Boston area. He started the Bourque Family Foundation in 2017 to serve as a conduit for the distribution of funds to various charities.

A native of the Montreal area, Bourque played 21 seasons for the Bruins, from 1979-1980 to 1999-2000, before being traded to Colorado for his final 16 months in the league.

The only other member of the Bruins organization to be awarded the Magnuson Trophy has been Brad Park. He was presented with the award in 2012.

In addition to receiving many other awards, Bourque was selected as one of the 100 Greatest NHL Players by the NHL during the commemoration of the league's $100^{\rm th}$ anniversary in 2017. He is co-owner of the popular Italian restaurant Tresca in the North End.
