

Americans will exercise their fundamental right to vote as the spirited No matter what side you're on, this election season has reinvigorated American politics like no other in recent memory. As Bostonians head out to the polls, I want to take a moment to go over what voters can expect come Election Day. With thousands of newly registered voters in the City and a host of issues to consider, from the presidential race to local ballot questions, we're bracing for record turnout and doing everything possible to ensure smooth and efficient voting.

On Tuesday, November 4th, millions of Additional translators will staff a hotline from City Hall.

• The Election Department will open a presidential campaign draws to a close. new, dedicated 25-line phone bank for voter information requests on Election Day.

> • Polling locations will have enough ballots to accommodate 115% of eligible voters.

> Polling places in Boston are open from 7:00 a.m. to 8:00 p.m., and in some places, long lines will be unavoidable, especially in the morning and evening hours. If possible, the Election Department encourages people to vote mid-day, between 11:00 a.m. and 3:00 p.m., to avoid extended waits. Please remember that voting in Massachusetts is addressbased, and registered voters need to know their correct polling location and correct ward and precinct. If you're unsure about your polling location, use the voter registration search tool at www.cityofboston.gov/elections.



Election Day preparations include:

• Increased the number of poll workers, greeters, and volunteers, especially in high-traffic areas such as the Second Suffolk Senatorial district. This year, there will be nearly 1,800 poll workers and volunteers across the City. • Many polling locations will have translators on-hand for languages such as Spanish, Chinese, Vietnamese, Portuguese, Cape Verdean, and Haitian.

NEPTUNE

a god of the sea and the Roman counterpart to Poseidon. Salacia, his wife, was worshiped as a goddess of salt water. The worship of Neptune appears to have been influenced through the Sibylline Books that have often been mentioned in Roman history. These books started as a collection of oral expressions dating back to 600 B.C. According to legend there were originally nine books that were offered to the Roman king Tarquinius Superbus at an exorbitant price by the Cumaean Sibyl. When the king refused to pay the price, she burned six of the books. The king then purchased the remaining three at the original price.

For those persons who are not familiar with the name "sibyl", I might add that it identified the female counterpart to a prophet. The ancient city of Cumae, Sicily, was named in honor of the Cumaean sibyl, one of the ten or twelve most famous of these prophetesses. Roman mythology placed her abode in a cavern below the acropolis in that city. In her

Neptunus or Neptune was youth, Cumaea was loved by Apollo, who later granted her as many years of life as the grains of sand that she held in her hand. She accepted, but forgot to request the youth to go along with her years. She was also thought of as the Sibyl of the Roman Catholic Church whose strength, age, wisdom, and resistance to false gods she so grandly embodies. The famous ceiling of the Sistine Chapel at the Vatican in Rome shows Cumaea, in addition to four other sibyls; Libica, Delphica, Erythraea, and Persica. Here, Cumaea is shown hoary with age in a manner that only the great master Michelangelo could portray. Also, he shows her holding two books which are thought to be the Old and the New Testaments.

The identification of Neptune goes back to the "Lectisternium" festival, which started about 400 B.C. The root of this name is in the Latin "lectus" for bed or couch. Lectisternium is identified as a ritual or feast where the image of a particular god was set on a couch and this couch was

placed near the dining table. Remembering that formal dining in ancient Roman times was in the reclining position, we can now understand that this was a festival wherein a selected god was invited to dine with his mortal worshippers.

Like Poseidon, Neptune was also worshiped as a god of the equestrians, and as such, a temple in his honor was erected in the Circus Flaminius sometimes around 200 B.C. Marcus Agrippa, a Roman general, son-in-law to Augustus, and builder of the Pantheon, also built a temple to Neptune in honor of his naval victory over Marc Antony and Cleopatra at Actium. This was one of the most decisive battles in the history of the ancient world, since its outcome determined the lordship of the Roman Empire.

The ancient Romans also worshiped "Portunus", a god of the harbors. A special priest in Rome sacrificed to him during the "Portunalia", a festival to this god, which was held annually in the month of August.

Senator Dianne Wilkerson Convicted of Fraud

An embattled Massachusetts State Senator appeared in a federal courtroom charged with taking \$23,500 in bribes, including cash that she stuffed into her bra during a meeting at a tiny Boston restaurant that was secretly videotaped by an undercover FBI agent, federal prosecutors said.

Democratic Senator Dianne Wilkerson is facing forty years in prison after federal prosecutors outlined accusations today that she accepted the bribes over an 18-month period in a money-for-legislative influence sting operation, prosecutors said. She had \$6000 in cash in her purse when she was arrested at her Roxbury home by nearly two dozen law enforcement officials.

Photographs released by United States Attorney Michael Sullivan showed Wilkerson stuffing ten \$100 bills into her bra at No. 9 Park restaurant last June. During another meeting with an undercover FBI agent two months later, Wilkerson took her granddaughter to accept a \$1,000 kickback at the Fill-A-Buster restaurant, a famed political hotspot directly across the street from the Massachusetts State House, according a 32-page affidavit filed in the case. A federal complaint charges that Wilkerson accepted

eight bribes totaling \$23,500 over an 18-month period in exchange for her influence on Beacon Hill. Undercover agents posed as a property developer who wanted to build on state land and another worked Wilkerson as a potential barroom owner willing to pay for a liquor license.

"She has a long history of acting as if she was above the law," said Assistant United States Attorney John S. McNeil during Wilkerson's initial appearance in court. Wilkerson - the state's only black Senator - is a convicted tax cheat and a campaign finance scofflaw who has a long litany of legal problems that has marred her 15-year record as a lawmaker. Earlier this month, the Massachusetts Bar began proceedings to disbar Wilkerson, an attorney, after an investigation determined that she lied and perjured herself while testifying in a superior courtroom on behalf of her nephew, a convicted murderer who was seeking a new trial. In August, Wilkerson agreed to pay a \$10,000 fine and forgo about \$30,000 in debts she said her political committee owed her after acknowledging she failed to keep proper campaign records from 2000 to 2004. Wilkerson has also spent time in a halfway house for federal income-tax evasion and narrowly escaped home foreclosure. "Public service is a privilege. Voters and taxpayers expect that elected officials will do what is right for their constituents, not what is financially best for themselves," US Attorney Michael J. Sullivan said at a news conference. "Citizens place extraordinary trust in those it gives the greatest authority. And with that authority comes the obligation to act with fairness and honesty."

Wilkerson's attorney Max Stern insisted that his client was innocent. He also accused McNeil of trying to "character assassinate" Wilkerson by bringing up her unrelenting problems with the Massachusetts Attorney General and campaign finance officials.

Wilkerson was released on \$50,000 bond and left the courthouse through a side exit without speaking to reporters. She was flanked by supporters, including a Boston minister, the Rev. William Dickerson, and her son, a one-time investigator for the Suffolk County District Attorney's office.

"Everything is not how it looks," Dickerson said.

She is under court order not to destroy any personal or campaign documents relating to her finances, including phone and gas bills. Prosecutors said she could face additional charges.

"We are going to look at her finances carefully to see if she reported her taxes correctly," McNeil said.

Other Boston City officials were named in the affidavit, including Mayor Thomas M. Menino - who received a phone call from Wilkerson lobbying for new liquor licenses - along with State Senate President Therese Murray and City Council President Maureen Feeney. The complaint alleges that Wilkerson pressured the Boston Licensing Board, the mayor and the City Council to create new liquor licenses in her district. She is also accused of stalling pending legislation in the Senate, including legislation increasing the salaries of the Boston Licensing Board. Wilkerson has represented Roxbury since first winning election in 1992, but lost the Democratic primary to Sonia Chang-Diaz last month. Wilkerson has been mounting a sticker campaign to regain her seat in the November election. That campaign has been divisive as Wilkerson's surrogates have made flagrantly racist comments about Chang-Diaz with one state employee working for the incumbent saying that Chang-Diaz, who is Hispanic, was "not a person of color." Another Wilkerson supporter, Massachusetts Governor Deval Patrick, called the charges against the senator "troubling." Mayor Menino said her arrest marked a "very sad day." City Council President Feeney said "this is a very disappointing day for all who are involved in public service. The people have a right to a higher standard."

NO SAFE HAVENS — WE ARE IN A RECESSION

The market didn't fare as bad as predicted last week and investors had a sense of relief that the market did not do as bad as expected. The Dow lost about 5% for the week, and has plunged 25% since the end of September alone. The NASDAQ lost 9% for the week. The S&P lost nearly 7%. Most analysts are predicting the declines to continue over the near future. Fear is driving the market and investors are acting on bad news as corporations are reporting earnings and they are glum. The U.S. is in a recession, with earnings contracting, unemployment rising, and employers cutting jobs according to government data. Other countries are also hurting as England reported that its economy shrunk in the 3rd quarter ending September 30th and sparked a sell-off in Europe. The U.S. Commerce Department reports next week. Analysts said market psychology will eventually change as investors see signs of the economy are nearing bottom and start bargain hunting. The stock market starts to turn about six months before the economy does and they are looking at next summer. Some positive news has occurred, oil prices have dropped more than 50% since peaking @ \$1.45/bll in July 08. Oil closed @ \$65/bll Monday, which is putting more money in people's pockets and reducing business costs. Interest rates are falling also. The Fed should drop its benchmark rate by

would make it back to 1%. Also Barney Frank, the Newton Democrat, said he expects Congress to pass another economic stimulus package which should help to mitigate the recession.

Gold prices have fallen along with equities and many investors are wondering why they are not a safe haven in times of turmoil. Gold is down 7.1% for the week to \$729.10/oz. The firming dollar, and India, a big consumer in gold, has not been buying gold, as the rupee depreciated against the dollar, making gold more expensive for Indian jewelry makers. The market is much divided about the outlook for gold. Gold ranges from \$977.70 to \$741.30/oz. in the third quarter and is very volatile. Analysts profit forecasts are falling sharply as third quarter profits come in and companies own forecasts have become more pessimistic. At the start of this month earnings were projected to be up 25.7%. Now profits are expected to rise 13.2%! Stocks reflecting the global slowdown, is now projecting a 9% increase in the 4th quarter earnings down from the 22% expected on October 1st. Earnings from consumer discretion companies that include automakers and luxury goods are now forecasting to rise 2% instead of 12%. Materials companies hit hard by the drop in commodities prices are expected to fall 4% instead of rising 29%. PNC was chosen to take-

1/2 point this week. That over National City Bank by the government. PNC will sell \$7.7 billion worth of preferred shares and warrants valued at less than National City's book value. National City suffered \$266 billion in losses during the past 9 months. They agreed to a price of \$2.25/share. Other banks in this predicament are Capital One Financial and Sun Trusts Bank along with many other regional banks that were badly wounded when the housing bubble burst. The takeover banks have no leverage and must take what is offered as the government will not lend them any money, unless they cooperate.

The government is in the banking business. The exact strategy is to have the banks buy out the government within 4 years. The government has taken preferred stock and warrants paying 5% for 5 years and then rises to 9%. The government will then sell the stocks back to the banks as the financial system comes back to normal. The government helped to broker the sales of Bear Stearns to JP Morgan Chase, and Merrill Lynch to Bank of America and, AIG with an \$85 billion loan, and Freddie Mac and Fannie Mae which had government backing to help them survive. TONY MARCHIONE The Last American to Die in WWII

The telegram from the Army read "Killed in Action August 18, 1945". How could this be? The War was over, the Japanese were going to sign the terms of surrender on the USS Missouri. Where was the action? How did he die? These and other questions must have run through the minds of Ralph and Amelia Marchione of Pottstown, Pennsylvania, a small town about 30 miles north west of Philadelphia, concerning their 20-year-old son Anthony "Tony" Marchione, the oldest of the three children in the family and the only boy. Tony was five foot six, good-looking, black hair and brown eyes and weighed 120 pounds. He was a typical young man like all the other young men who signed up to defend their country in World War II.

In 1943, although still in high school, he wanted to sign up to be a pilot in the Army Air Force; instead he was sent for training to be an aerial gunner. In November of 1944 he was transferred to Will Rogers Army Air Force Base in Oklahoma to be trained in photo reconnaissance. Marchione along with fellow gunners Rudolph Nudo, Frank Pallone and Raymond Zech received training to become photographer's assistants and were assigned to a reconnaissance B-32 Dominator when their squadron moved to Okinawa.

The squadron's duties changed when the Japanese surrendered. The crew was now to fly photo-reconnaissance missions during the daytime to insure that the Japanese complied with the cease-fire that was in effect. The terms of the cease-fire allowed Mission 230 A-8 was to cover the same targets as the previous flight. First Lieutenant James Klein in the **Hobo Gueen 11** would lead to be followed by First Lieutenant John R. Anderson in the second B-32. Flying with Anderson would be Marchione, Rupke and Joseph Lacharite, from Massachusetts. As they flew over Tokyo, down below at the Japanese airbases the fighter pilots on the ground ran to their planes to intercept the two B-32 Dominators, including two of Japans Aces, Saburo Sakai and Sadamu Komachi, between them they had shot down 100 Allied aircraft.


One of the gunners on Klein's plane saw a plane on the ground taking off and Klein turned the plane to see them coming up at them. He knew it would take a while for them to reach him since he was flying at 20,000 feet but his concern was for Anderson who was at 10,000 feet. He radioed a warning to Anderson but received no answer. Anderson's tail gunner had spotted the fighter now flying at the same altitude and he was able to shoot him down. Lacharite and Marchione were tying their camera gear when they heard the cry of incoming aircraft. Lacharite went to the starboard observation window to try to see the attacking planes and was hit in both legs. Having the presence of mind to reach for the cord from a barrack bag that carried the camera gear he tied a tourniquet around one of his legs and an intercom cord around the other while Marchione was helping him to a cot on the floor. Marchione got on the intercom and told Anderson what had happened and Anderson said he was sending Rupke. As Marchione turned to Lacharite a $20\ensuremath{\mathsf{mm}}$ round came through the starboard side and hit him and threw him to the other side of the plane. When Rupke arrived Tony was bleeding with a large hole in his chest. After thirty minutes of giving him plasma and applying compressions bandages to his wound Tony Marchione was dead in Rupke's arms. The Dominators returned to base with minor damages. Anderson had lost an engine and had lost partial rudder control. That battle was the last air battle of the war. Included in the cease-fire was a passage that required propellers be removed from all Japanese fighters. US planes were now free to fly over Japan without fear of an attack. The last air battle was overshadowed by the attention to the signing of the surrender on board the USS Missouri. The body of Anthony "Tony" Marchione was brought back to Pottstown, Pennsylvania accompanied by his Italian-American buddies Frank Pallone and Rudy Nudo on March 18, 1949. He was buried with full military honors and was laid to rest in St. Aloysius Old Cemetery.

for the US planes to fly freely over Tokyo. This was also to insure that the Japanese would not use anti-aircraft fire or send fighters against the planes.

It became a possibility that there was within the Japanese government, including the military, that due to the recent bombings of Hiroshima and Nagasaki they were ready to go along with an unconditional surrender. On August 15, 1945 Emperor Hirohito went before his nation on radio and announced his intention to surrender to the Allies. This, the military felt, was a dishonor to the country. Many of the Japanese navy fighter pilots at the nearby bases around Tokyo were capable of carrying on the fight to defend the honor of Japan. On August 17, as four B-32 reconnaissance planes made their way up the northeast coast they were attacked. The B-32s were able to fend off the attack without any injuries to the airmen but the planes sustained some minor damage. After filing their reports it was decided by US Commanders that the missions should continue in order to find out if indeed the Japanese were going to abide by the cease-fire or continue the war.

Given the magnitude of our problems, it is difficult to







In November, we begin to think more of food! Well, here are some interesting facts about the origin of names of Italian foods. For example, "wearable" foods include ditali and its miniature version, ditalini, the small pieces of pasta whose names come from the Italian for "thimble" or "finger of a glove." The pasta called annelli, meanwhile, has a name that translates from the Italian as "little rings" and is a linguistic relative of annular; which describes an eclipse in which the sun forms a complete ring of light around the heavenly body blocking it. Songwriter and performer David Seville chose the names for the "stars" of his 1958 hit record. Simon and Alvin were named for two executives at Liberty Records - Simon Waronker and Al Bennett. Theodore was named for Ted Keep, the recording engineer. So we asked Albert Natale, who wrote "Mary Had a Little Lamb?" His answer! One of the earliest and most influential American magazine editors, Sarah Josepha Hale — in 1830. In addition to founding the first national women's magazine, Godey's Ladies' Magazine, and successfully campaigning to make Thanksgiving a national holiday, she was inspired to write the rhyme by an actual case of a child's being followed to school by a pet lamb.

A salty question! Why is spilling salt considered bad luck? One reason is because salt was once valuable and difficult to obtain. According to an old Norwegian superstition, a person is doomed to shed as many tears as it takes to dissolve the spilled salt. Another reason is the belief that spilled salt refers to the devil. In the German superstition, whoever spills salt engenders enmity: It is thought to be a direct act of the devil. And both the French and the Americans toss salt over the left shoulder to hit the devil in the eye.

Italian Americans in Sports: At age 15, Linda Fratianne won the U.S. Ladies Figure Skating Championships in 1970 and 1980. Winner of the 1977 and 1980 World Figure Skating Championships, she capped her career with a silver medal from the 1980 Olympics. One of the few women skaters who routinely performed triple jumps, she won over 140 championships. Boxing manager Angelo Dundee, born Angelo Merena, Jr., in 1921, trained and managed fifteen world champions, including Muhammad Ali, Sugar Ray Leonard and Jimmy Ellis. In 1978, Chicago business man George Randazzo established the National Italian American Sports Hall of Fame in Arlington Heights, Illinois. The NIASHF recognizes and promotes the achievements of Italian American athletes and their contributions to sports. Advance notice! Recipes from the Homeland

COPYRIGHT, ALL RIGHTS RESERVED MAMA'S RICOTTA CHEESE GNOCCHI (Pasta)

3 cups unbleached flour (preferably King Arthur or Gold Medal) 1 beaten egg

- 1 teaspoon salt
- 1 pound ricotta whole milk cheese
- 4 quarts boiling salted water.

In a bowl mix ricotta cheese, beaten eggs and salt. Add flour gradually to the mixture, mixing by hand, until dough is soft. Remove dough from bowl and place dough on a floured pastry board to knead. If dough sticks to your fingers or hands, add a little flour and continue kneading until the dough is soft, smooth and pliable.

Cut and roll portions into long 8- or 10-inch rolls of about one-inch thickness. Place in bowl and cover. Taking one roll at the time, flatten roll *slightly* with your hand or a rolling pin. Cut into one-inch portions. With index and middle fingertips, press into each piece of dough and roll fingers forward in the dough. This will curl the dough into gnocchi. Continue until all dough is used.

For cooking gnocchi, boil about 4 quarts of salted water. After dropping gnocchi into the boiling water, stir and cover. Watch carefully because water boils over quickly. Gnocchi will float to the top as they cook. They cook rapidly. Check for consistency desired. Drain and place in a bowl. Add your tomato sauce and serve.

Serves four.

Note: I love the memories of watching my parents make homemade macaroni in our home. They didn't seem to have a written recipe. It was all stored in their minds. Through the years, I decided their recipes should be written out. I watched Mama measure out the flour, add the water or beaten eggs and all the necessary ingredients for gnocchi. Papa kneaded the dough. Mama always took out her extra-long wooden rolling pin when the dough had to be rolled into thin round portions before Papa could fold it and then cut it into linguine. For gnocchi, Papa cut up the dough after kneading it. Mama, with her fingers, patiently formed the small portions of cut-up dough into gnocchi. Before my brother Peter and I knew it, the homemade macaroni was ready to serve at noontime for Sunday dinner. They always made it seem that it was such a pleasure serving homemade macaroni, and it was!


US Senator John McCain he born in Indonesia? Or in refused to disclose his medical history, the media would question out loud why or what was he hiding.

A Nostalgic Remembrance

Everyone in my family loved parties. Today is Halloween. The way kids celebrate is American but Nanna and Babbononno learned this early-on and were ready for trick-or-treaters when they arrived at their front door. Nanna always had a couple of rolls of nickels for this annual holiday. She once told me that she didn't know what kind of candy the costumed children liked and didn't want to disappoint anyone, so she gave out money. Babbononno assured me that there were never any complaints, because back in the day, you could buy a candy bar for a nickel. If you had penny candy in mind, you could leave a candy store with a bag full of sweets for the same nickel.

Mom inherited the love of parties from her parents and Dad went along with her tastes. Every time Uncle Nick or Uncle Gino came home on leave, my folks had a party. There was always food on the kitchen table, usually Italian cold cuts, cheese, bread and all the condiments that make a sandwich taste good. Wine, beer and hard stuff flowed like water and the floor model Philco radio/record player sounded out with dance music from the batons of Benny Goodman, Artie Shaw, The Dorseys, Duke Ellington, Count Basie and an assortment of society band leaders. Friends and relatives came to celebrate the safe return of my uncles and partake of a good party. I even remember my parents dancing together. The only problem I ever saw was my Dad attempting to dance. In spite of him spending his life as a musician, he had two left feet. When he danced, both of them landed on my mother's bunions. It was cruel and abusive punishment in the first degree.

I inherited the love of parties from my mother's side of the family. My memory is such that I remember every birthday party they threw for me as a child, beginning restaurant, the place was with number three, when I received a purple and white tricycle, a brown leather toy horse and an assortments of games of the day. When I became an adult, I decided to reciprocate beginning with my folks 25th anniversary. Through Uncle Nick, who at the time was the vice president of the musicians'

union, I threw a surprise dinner party for them at Blinstrub's Supper Club in South Boston. Sammy Davis was the entertainer and made a big deal about my folks being married for 25 years. I repeated the process for their 40^{th} , and ten years later, for their 50th. Interspersed were numerous surprise birthday parties

that I set up for my folks. My dear wife, Loretta, is not much into parties. She likes quiet intimate gatherings where a few close relatives and friends sit and enjoy a quiet dinner. Respecting her wishes, I have minimized the size and scope of parties I have thrown for her to celebrate her birthdays. The only time she relented was when I was very active as a musician. Right after the New Year, I would throw a party at our house and invite all of the musicians who had worked for me through the year and their families, along with selected relatives and neighbors. I could tell that Loretta was not the most comfortable person in these situations but I assured her that they only happened once a year.

I can't believe it, but on the 21st of this month I turned, ouch, 70!!! Loretta asked me what I would like to do for my birthday and I, knowing how she dislikes big celebrations, replied that I would like her to call Barbara Summa and go to La Summa's for dinner with our closest friends, Dean Saluti and Margie Cahn.

Knowing that my son, Michael, having a small part in the new Mel Gibson film, would be shooting in Rhode Island, and be out of the loop. John, our oldest, lives and works in Zurich, Switzerland, and was not scheduled to come home until Christmas. Combined with this is the fact that Dean and Margie would be out of town on the date of my birthday, so it was planned that we would have dinner at La Summa on the Sunday before the 21st.

When we walked into the packed with people who all jumped up and yelled, "Surprise!" I couldn't believe it. The entire restaurant was filled with family and friends. I should have guessed something was up when Dean insisted on wearing a suit and tie, but I just passed it off as Dean being Dean. While I stood there

speechless, someone tapped me on the back. As I turned, the person said, "Felice Compleanno, papa, cent' anni." It was my son, John. He had taken a week off to come home for my 70th.

It seems that, Loretta, knowing my love of parties, had been planning this one for months. I don't know how it was kept secret, but it was, and over 50 people applauded as I stood there with my mouth open in surprise. For one of the few times in my life, I was truly speechless, I'm not kidding. My one remaining uncle, Lou Contini, whom I refer to as, Uncle Gino, and my aunt, Ninna, his wife, represented the last of my parents' generation. What I found surprising was a table made up of young people in their 20s, friends of both of my sons, kids who grew up in my house, and for whatever reason, relate to me in their own ways.

Loretta had taken the picture in August with her digital camera, but I paid no attention to it as she also shot pictures of other antiques that surrounded my car at an old car get together. I did ask her why she insisted of taking the picture, and when she commented that she had a picture of me with my antique 1962 Lincoln, but that she didn't have one with me and the Thunderbird, I dismissed the possibility of an ulterior motive.

I would publicly like to thank Loretta, for throwing me a party of this magnitude. The people who were there represent my dearest relatives and my closest friends and business associates. If I had the room in this column, I would acknowledge everyone of them, but seeing I'm out of space, I can only say, "Mille, mille grazie." I will never forget the tribute you paid me, and to my wife of over 30 years, "I luv ya." And by the way, GOD BLESS AMERICA.

MUSSOLINI'S DEMISE: WHO ACTUALLY KILLED HIM? Mussolini grandchild Guido - son of Vittorio Mussolini, is involved in a unique research. From present history we know that Benito Mussolini and his girlfriend, Clara Petacci, were executed at Giulino di Messegra (in the province of Cuneo). Guido is assisted by Attorney Luciano Randazzo. They have discovered documents that make the principals (the attorney and Guido) question most of the notions they, and most of us, have known so far about Mussoini's end. Two particular documents are significantly telling. Attorney Randazzo has petitioned the Court, in Como, to acquire these two documents. One is part of the records kept in London, England. This document issued on April 5, 1944 by the High Commissioner of the occupying forces in North Italy, proclaims that there was a proposition to Winston Churchill to kill Mussolini. The other document was a secret report that Togliatti, the Head of the Italian Communist Party, sent to Stalin a few days after Mussolini's death, detailing the real truth, heretofore unknown. Togliatti describes what he claimed at the time to be the true events which tell that in the middle of the night of April 5, 1944 Mussolini and Clara Petacci were victims of a premeditated murder, not outside the gates of the residence where "Il Duce" and Clara Petacci were. Furthermore, Togliatti claims that the killing of Mussolini was actually ordered by the British SOE, with the coordination of the extreme Communist Left under the leadership of Luigi Longo. The District investigating Judge has contended that if the murder was a conventional crime the Statute of Limitations nullifies any further legal action (not so in the US). On the other hand, if the killing was politically motivated it is also nullified by the amnesty (for political crimes) issued by the very same Togliatti who was a member of one of the early coalition governments (1947-48). Guido Mussolini's attorneys (there are two now), strongly contended that if the murder was premeditated and committed by the British it would be configured as the killing of a Head of State (as Mussolini was, at the time, of the Social Republic of Salo'). It would be subject to prosecution.

Guido Mussolini's defense is still engaged in finding the truth, and nothing else. They claim they have no vindictive plans, only to find the real truth.

This is what they are seeking.



It ascended from the floor which, when you really think about it was an appropriate starting place. After all, the team whose name the banner bore had done the same thing — had climbed out of the depths of the nether world of professional basketball and had reached the peak of perfection — the NBA Championship.

Yes, that is what the 2007-2008 Boston Celtics had done. There had been the dark days — the weeks that encompassed the 18-game losing streak during the 2006-2007 season. They had picked themselves up from that, brought in new talent and rose steadily and surely to league supremacy — just as the banner rose higher with each mighty pull, gathering more light, more attention, until it finally came to rest in the rafters.

The individuals hoisting Banner 17 at the TD Banknorth Garden on October 28 were the players that had reached that pinnacle. It was their final act of remembrance towards last season's memorable run and it came just after they had received the emblems of their dramatic success.

Just moments earlier, before a sellout crowd, the Princes of the Parquet had become the Lords with the Rings — bestowed with the gleaming \$30,000 symbols of triumph that they will possess throughout their lives.

From the Line of Legends that escorted the championship trophy to the center of the floor to the last basket in the 90-85 victory over Cleveland, it was a night to remember in Boston. Just maybe, there will be an encore performance next year. ARE THEY PRACTICING FOR A TRIP TO JAPAN TOO? — Everyone remembers the Red Sox super long trip to Japan in March. It turns out

that the Bruins also had a lengthy road trip of their own during the first month of the season. When the B's went on their recent three-game road trip to Western Canada, they really added mileage to their frequent flier accounts. Boston? The win came on the first home start of the season for B's goalie Manny Fernandez. It also evened the B's lifetime series against the Thrashers at 14-14-5.

JUST OVER A YEAR -That's how long the interval was between hat tricks for the Bruins. When Milan Lucic found the range for his three tallies against the Thrashers at the Garden on the last Saturday in October it marked the first hat trick by a Bruins player since Phil Kessel, against the Kings in Los Angeles back on October 12, 2007.

AND EVEN LONGER STILL - Was the time between season opening victories. When the Bruins defeated Colorado, 5-4 in Denver back on October 9 to start the season, it marked the first time they had recorded a season starting triumph since October 4, 2001 when they beat Anaheim 4-2 at the Garden. And you have to go way back to October 5, 1993 to find the last time the B's won on the road before this year a 4-3 win over the Ranger at Madison Square Garden.

MEASURE FOR MEASURE - From the youngest (Blake Wheeler at 21) to the oldest (Tim Thomas and Manny Fernandez, both 34), from the heaviest (Milan Lucic at 228) to the lightest (David Krejci at 178), from the shortest (Marc Savard at 5-10) to the tallest (Zedno Chara at 6-9), these are some of the standout performers for the B's. For the 23 players on the active roster the last week of October, the average age was 28, the average weight was 201 and the average height was 6-1.

THE COACH ON KREJCI -When asked what he likes about center David Krejci B's head coach Claude Julien said thought a lot of "his hockey sense, his vision and everything else. When he's got his confidence he's unbelievable. What I like about him, especially this year, is that he's gotten over the intimidation factor as far as being in awe of this league. He's going after guys. He's playing hard and throwing his weight around. He's really been a good player for us and just keeps impressing everybody. I think as we move on, if he keeps going like that, he's going to start pushing some guys out of their spots. You're probably going to see him more and more." GARDEN GAB — The Bruins scored the first goal of the game in five of their first seven contest this season. They went 2-2-1 in that span of games ...
