



SIBYLS AND THE SIBYLLINE BOOKS





Michelangelo's Libyan Sibyl, Sistine Chapel

We are reminded that the female counterpart to a prophet is called a sibyl. Delving a bit further into the word Sibyl, there appears to be a root expression, "the will of God" attached to it. Sibyl is also the name used during ancient times to identify those prophetesses who were inspired by some god, usually Apollo, and some were even described as Apollo's daughters or favorite wives. More often than not, they were considered to be maidens who lived near

springs that inspired a divine influence. This caused the sibyl to utter prophetic expressions while in a trance, daze, or frenzy.

Most confusion about sibyls seems to be in their exact numbers. Plato, for instance, identified only one, while others named any number up to ten or twelve. The important sibyls that I recall at this time were the Erythraean, Cumaean, Delphian, Libyan, Persian, Samian, Egyptian, Babylonian, Cimmerian, Hellespontine,

Phrygian and the Tiburtine.

Michelangelo's Sistine Chapel ceiling frescoes is said to be the world's most powerful piece of painting. In addition to scenes that illustrate events from the Old Testament, he also enthroned seven prophets and five sibyls. The prophets are Jonah, Daniel, Isaiah, Zechariah, Joel, Ezekiel, and Jeremiah. The sibyls are Erythraea, who foretold the details of the passion of Christ and the Resurrection, Cumaea, who is credited with "God shall be born of a pure virgin and hold converse with sinners," Delphica, or the Delphic Oracle, who, in addition to being consulted on national and personal matters, wrote many poems about the Incarnation, the virgin birth, the passion, the crucifixion and the Resurrection, the Libyian sibyl who said, "The day shall come when all men will see the King of all living things. A virgin, the mistress of the nations shall hold him in her lap, and shall reign in mercy," and lastly, the Persian sibyl who said, "Satan shall be overcome by a true prophet. The



Blessed Elisha of Saint Clement, O.C.D.

Teodora Fracasso was born on January 17, 1901, in Bari as the third of nine children (four died as infants) to Giuseppe Fracasso and Pasqua Cianci. Her family then lived in Saint Mark's Square and supported by what the father earned as a master painter and decorator.

In 1905, the family moved to Via Piccinni, to a house with a garden, in which, the little Theodora



Towards the end of 1917, Theodora decided to seek advice from a Jesuit Priest, Fr. Sergio Di Gioia. He became her new Confessor. About a year later he decided to direct her, together with her friend Clare Bellomo, the future Sister Diomira of Divine Love, to the Carmel of St. Joseph, Via De Rossi, in Bari. They went there together for the first time in December 1918. Theodora entered the community on April 8, 1920, and took the Habit on November 24th, the same year, taking the name Sister Elisha of Saint Clement. She made her first simple vows on December 4, 1921: "Alone at the feet of my Crucified Lord, I looked at him for a long time, and as I looked I saw that He was my whole life". She made her solemn profession on February 11, 1925

In the spring of 1923, the prioress Angelica Lamberti put her in charge of the embroider machine at the girl's boarding school but the authoritarian and strict head mistress of the school removed her from that position in 1925. But Lamberti held her in high esteem and in 1927 named her as the sacristan. From 1922, she became close with Father Elia di San Ambrogio and the two often corresponded.

On December 21st, she suffered from a high fever. On December 24th, a doctor was summoned and diagnosed her with possible meningitis or encephalitis not deemed to be serious. But on Christmas morning two doctors were summoned and declared she had an irreversible brain tumor far too advanced to heal. Elisha died at noon on Christmas Day, December 25, 1927 — from a brain tumor; she had predicted that she would die on an important feast. Archbishop Augusto Curi presided over her funeral on December 26th.

She was proclaimed Blessed on March 18, 2006, by Pope Benedict XVI. The Feast of Blessed Elisha of Saint Clement, O.C.D., is May 29th. Blessed Elisha knew and experienced the love of God within her soul. She lived her whole life in service of God and those around her.



Loretta R. "Laura" Caira

Loretta R. "Laura" Caira, 95, the much loved and widely admired matriarch of a large Wilmington family, died at her home in Wilmington on October 3, 2020 enveloped in the loving arms of her family. She was the beloved wife of the late Aldo A. Caira, former National President of the Order Sons of Italy in America and a long time Wilmington public official.

Mrs. Caira was born in Newton, MA, the youngest of 12 children to Felice and Lucrezia Bianchi. She graduated from Newton High School in 1943. She met her future husband, Aldo, who was also from Newton, upon his return from military service in 1946. Despite knowing he was a Yankees fan, she agreed to a first date at Fenway Park. They married in 1947 and soon thereafter she converted him to the Red Sox! One bright spot to the Red Sox 2020 season was a video scoreboard and broadcast tribute by Jerry Remy, her favorite player, honoring her lifetime support for the team.

Laura and Aldo moved from Newton to Wilmington with their growing family in 1958. Laura was actively involved in the activities of her five children and willingly opened her home and her heart to their friends. She delighted in the births of her twelve grandchildren and seven great grandchildren, rarely missing an opportunity to attend their games, recitals, concerts, plays, award and graduation ceremonies, and a myriad of other activities. Her most enjoyment, however, came from cooking homemade meals and feeding her family and their friends. Everyone eagerly awaited her all too familiar inquiry, "Seconds?"

Her contribution to her community was most exemplified by her active membership in the charitable, cultural and social programs of the Order Sons of Italy in America. She was a member for 67 years, initially in Newton and later in both Winchester and Wilmington. She was instrumental in her husband's success as he rose through the ranks of the Order. She quickly captivated members throughout the country in her role as both State and National First Lady with her gracious demeanor and her countless acts of kindness. She was equally at ease whether helping out at a local lodge supper or attending a White House State Dinner, as she did with her husband when President and Mrs. Reagan honored the Prime Minister of Italy.

Laura's greatest achievements as a member were with her home lodge in Wilmington, which she founded in 1967. She has been the guiding force of the Wilmington Sons of Italy, spearheading countless projects and programs which have helped raise and distribute nearly \$2 million for community, scholarship and charitable endeavors. Her dedication and unflagging commitment to the service of others was formally recognized in 2004 by the Grand Lodge of Massachusetts. Laura was presented with the Golden Lion Award, the most prestigious award given to a member.

Laura was a welcome and familiar presence in the Wilmington community. She served nearly 50 years as an election official, greeting countless voters at the Wildwood School. She volunteered at the Wilmington schools into her 80's, was an active member of the Wilmington Senior Center and a faithful parishioner of St. Thomas of Villanova Church. This past July, the community celebrated her 95th birthday with a 60 vehicle caravan led by the Police and Fire Departments. She

was recognized by the Governor, both branches of the Massachusetts Legislature and the Wilmington Board of Selectmen.

Laura will be remembered for her boundless energy, her engaging personality and for her generosity and kindness. Laura was much loved and will be dearly missed by all who knew her.

She is survived by her devoted children, Michele Caira Nortonen, Michael and Jane Caira, Aldo Jr. and Sharon Caira, Kevin and Cheryl Caira, all of Wilmington and Kenneth and Marianne Caira of Pelham NH. Adored grandmother of Jennifer and Christian Bolanos, Angela Caira, Michael Jr. and Kristen Caira, Brian and Amanda Caira, Sara-Jean and James Phillips, Brianne Caira, Jeffrey Caira, Joseph and Katherine Caira, Aldo Caira III and Gabrielle D'Entremont, Mark Caira, Amy Caira and David Caira. Special GiGi to Christian Jr., Allison and Samantha Bolanos, Caroline and Anna Caira, Jude Phillips and Lucy Caira. Laura was especially excited to welcome her 8th great grandchild, Jacoby, at the end of this month. L'Anno Bello: A Year in Italian Folklore

Honoring Autumn's Harvest

Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



It is no secret that I love to bake. The bookshelf adjacent to my kitchen brims with dogeared cookbooks whose chocolate-stained, worn pages tell the stories of delicious treats past. I especially enjoy baking when the calendar turns to the months of autumn, when chilly dark nights propel me into the warmth of a cozy kitchen. Fall is also an optimal time for baking because of the abundance of fruits and vegetables harvested around this time of year. As surely as the colorful leaves swirl gracefully in the October wind, I know that crisp apples, juicy pears and creamy pumpkins will form an essential part of my fall baking repertoire. However, baking is not the only way to enjoy the generosity of Earth's harvest. Autumnal produce makes a wonderful addition to salads, pastas and drinks, and of course nothing can quite compare to a fresh, seasonal fruit eaten in its plain natural state. One can develop an even deeper appreciation of fall's bounty when one examines the manner in which these fruits have shaped not only culinary creations but the very culture and traditions of societies around the world. So as

the autumn unravels around us in all its rustic and comforting glory, let us take a look at the folklore, superstitions, and recipes of four of our favorite seasonal treats.

• Apples: Apples are synonymous with the fall for me. They conjure memories of collecting bags of bright jewel-toned fruit at a sunny apple orchard, of the tingle of tart apple cider dancing on my tongue, and of fresh-baked breads and streusel-topped crisps cooling on the kitchen counter. I have a difficult time thinking of an apple recipe I did not enjoy, and apples eaten straight from the trees are equally delicious with their burst of juicy, bittersweet pulp. As one of the quintessential fruits of the season, with a fairly long harvesting period, apples also figure heavily in European myths and legends. The Greek demigod Heracles (or Hercules to the Romans) had to obtain golden apples as one of his arduous twelve labors, and the Celtic King Arthur recovered from his wounds in a mythical land called Avalon, or "isle of apples." Apples symbolized wisdom and immortality to the ancient Norse, while in the Germanic fairy tale Snow ing German-inspired apple

• Pumpkins: Ah, the pumpto cure snakebites and banish

White, an apple causes the titular princess to fall into an enchanted slumber from which only a true love's kiss could save her. Popular tradition equates the apple with the fruit of the Tree of Knowledge in the Garden of Eden, though it was never actually identified as such in the Bible. Apples also formed the crux of many Halloween divination rituals, as unmarried girls would interpret the shape of an apple peel or eat an apple in front of a candlelit mirror to reveal her future spouse on this spooky night. In Italy, apples are known as mele and are often baked into tarts or dumplings. Northern Italians are particularly fond of mak-

kin! This rotund, sunny fruit — and yes, pumpkin is a fruit! carries the connotation of cozy, communal festivities. After all, pumpkins are one of the most recognizable symbols of Halloween worldwide, and pumpkin pie has become a mainstay at autumnal harvest celebrations like Thanksgiving. The autumn means pumpkin to me, and whether I am making pumpkin-chocolate chip bread, pumpkin butter cake, or pumpkin scones, the aroma of this fall favorite wafts through my kitchen on the darkened evenings of the season. Like apples, pumpkins also hold an important cultural history. Native Americans used pumpkins, including pumpkin seeds, for culinary and medicinal purposes long before the Europeans arrived on the continent. After pumpkins were introduced to Europe, the orange fruit found its way into several familiar fairy tales and tidbits of lore. In the French folktale Cinderella, a fairy godmother turns a pumpkin into a horse-drawn carriage, which then takes Cinderella to a much-anticipated royal ball. Strange superstitions became attached to pumpkins, including the fruit's alleged ability

We surely cannot fix the past because, well, it's the past, and its over and done with.



All this being said, Newton is the latest city that wants to replace the Columbus Day holiday with Indigenous Peoples Day. Kudos to Newton City Councilor Leonard Gentile for telling his fellow councilors that as an Italian American renaming the holiday is an insult to him and to members of the city's Italian-American community. As he stated, "The holiday itself has come to represent a celebration of Italian Heritage" and to eliminate it "is insulting to Italians."

Newton isn't the first municipality seeking to take out Columbus, and it sadly will not be the last. We are better today than we were yesterday, and will be even better tomorrow.

Isn't that why my grandparents fell in love with America along with millions and millions of other immigrants in our nation's life?



Lord shall be brought forth in the orb (center) of the lands," and "The womb of a virgin shall be the salvation of the people."

The Sibyline Books are quite often mentioned in Roman history. They are a collection of oracular sayings or prophesies (nine books) in Greek hexameter verse. The books are attributed to the Hellespontic Sibyl, put together at the time of Solon (bout 638 B.C.) and buried in the Temple of Apollo at Gergis, on Mount Ida. The collection found its way to Cumaea who brought it to Rome during the reign of Tarquinius Superbus, the last king of regal Rome (about 500 B.C.). It is said that Cumaea offered the nine books to the king at an exorbitant price. He refused to pay the amount so she burned six of the books. The king finally bought the remaining three books at the original price. These three books were preserved in a vault beneath the temple of Jupiter, but were destroyed when the capitol was burned in 83 B.C. The Roman Senate then sent out agents to acquire a new collection of similar oracular sayings, and this new collection was deposited in a restored temple. Sometime around 405 A.D. this second collection was also destroyed.

Columbus Statue to be Replaced By Italian Immigrant Statue in North End Park; K of C Will Display Old Statue

Mayor Marty Walsh announced on Monday evening October 5th to the North End/Waterfront Neighborhood Council (NEWNC) that the fragile condition of the Columbus statue after its recent beheading by vandals means that it will not be returning to its pedestal in Christopher Columbus Park.

Instead, the Boston Arts Commission will begin a process to design and construct a new statue recognizing Italian immigrants to be placed on the pedestal. The existing statue will be repaired and placed at the North End chapter of the Knights of Columbus where it will be publicly displayed as part of their in-progress affordable housing development on N. Margin Street in the North End. The controversial decision comes just days before Columbus Day.

"The Columbus statue, I know it means an awful lot to residents of the North End and obviously it's a very passionate, emotional issue," stated Mayor Walsh.

Following the statue's vandalism in June, the sculpture was removed from the North End park to assess the damage and the statue's 'historical meaning' according to city officials. Curators found the statue could be repaired but not without visible marks upon repair.

North End's Knights of Columbus offered to display the statue in their new affordable housing development at 41 N. Margin Street. The City will be repairing the statue as best as possible so that it can be publicly displayed by the Knights of Columbus in their


new facility.

Over the years at the water-front park, the statue has experienced its fair share of vandalism from being doused in red paint with the words "Black Lives Matter" written on it in 2015 to its most recent (but not first) beheading. Officials expressed concerns that the statue would continue to be vulnerable to vandalism, prompting the decision to remove and replace it.

As for the empty pedestal in Christopher Columbus Park, Mayor Walsh stated that there will be a 'robust community process' in deciding what will replace the statue with a focus on 'highlighting the Italian immigrants of the North End.' The Boston Art Commission (BAC) will create a North End community advisory group to advise future decisions.

At this time, there are no discussions about changing the name of Christopher Columbus Park although it was questioned whether the name still makes sense without the statue.

At the meeting, residents expressed mixed reactions. NEWNC council member Damien DiPaola thanked the mayor for acknowledging the contributions of North End Italian immigrants and suggested the new statue's design include a family with a suitcase. North End resident Bernie Sapienza expressed frustration over allowing vandalism to dictate the statue's future as erasing history." Mayor Walsh responded that "vandalism and destruction in our neighborhood is never okay" and noted

the difficulty of making a decision that would appease every perspective.

"I think this is a good solution, although not perfect for everyone. I don't think we'll ever get to unanimous 100% support of what should happen there," responded Mayor Walsh.

There will be a BAC meeting on Tuesday, October 13th at 4:00 p.m. to further discuss the future of the statue and its replacement.

1. Get a Kit of pet emergency supplies: Just as you do with your family's emergency supply kit, think first about the basics for survival, particularly food and water.

Food: Keep at least three days of food in an airtight, waterproof container.

Water: Store at least three days of water specifically for your pets, in addition to water you need for yourself and your family.

Medicines and medical records: Keep an extra supply of medicines your pet takes on a regular basis in a waterproof container.

First Aid kit: Talk to your veterinarian about what is most appropriate for your pet's emergency medical needs. Most kits should include cotton bandage rolls, bandage tape and scissors; antibiotic ointment; flea and tick prevention; latex gloves; isopropyl alcohol and saline solution. Include a pet first aid reference book.

Collar with ID tag, harness, or leash: Your pet should wear a collar with its rabies tag and identification at all times. Include a backup leash, collar and ID tag in your pet's emergency supply kid.

Important documents: Place copies of your pet's registration information, adoption papers, vaccination documents and

medical records in a clean plastic bag or waterproof container and also add them to your kit.

Crate or other pet carrier: If you need to evacuate in an emergency situation take your pets and animals with you, provided that it is practical to do so.

Sanitation: Include pet litter and litter box if appropriate, newspapers, paper towels, plastic trash bags, and household chlorine bleach to provide for your pet's sanitation needs. You can use bleach as a disinfectant (dilute nine parts water to one part bleach), or in an emergency you can also use it to purify water. Use 8 drops of regular household liquid bleach per gallon of water, stir well and let it stand for 30 minutes before use. Do not use scented or color safe bleaches or those with added cleaners.

A picture of you and your pet together: If you become separated from your pet during an emergency, a picture of you and your pet together will help you document ownership and allow others to assist you in identifying your pet. Include detailed information about species, breed, age, sex, color and distinguishing characteristics.

Familiar items: Put favorite toys, treats or bedding in your kit. Familiar items can help reduce stress for your pet.

Consider two kits in one, put

everything your pets will need to stay where you are and make it on your own. The other should be lightweight, smaller version you can take with you if you and your pets have to get away.

2. Make a Plan for what you will do in an emergency: Plan in advance what you will do in an emergency. Be prepared to assess the situation. Use common sense and whatever you have on hand to take care of yourself and ensure your pet's safety during an emergency.

Evacuate: Plan now you will assemble your pets and anticipate where you will go. If you must evacuate, take your pets with you, if practical. If you go to a public shelter, keep in mind your pets may not be allowed inside. Secure appropriate lodging in advance depending on the number and type of animals in your care. Consider family or friends outside vou immediate area who would be willing to take in you and your pets in an emergency. Other options may include: a hotel or motel that takes pets or some sort of boarding facility, such as a kennel or veterinary hospital that is near an evacuation facility or your family's meeting place. Find out before an emergency happens if any of these facilities in your area might be viable options for you and your pets.

Develop a buddy system: Plan with neighbors, friends or relatives to make sure that someone is available to care for or evacuate your pets if you are unable to do so. Talk with your pet care buddy about your evacuation plans and show them where you keep your pet's emergency supply kid. Also designate specific locations, one in your immediate neighborhood and another farther away, where you will meet in an emergency.

Talk to your pet's veterinarian about emergency planning: Discuss the type of things you should include in your pet's emergency first aid kit. Get the names of vets or veterinary hospitals in other cities where you might need to seek temporary shelter. Also talk with your veterinarian about micro chipping. If you and your pet are separated, this permanent implant for your pet and corresponding enrollment in a recovery database can help a veterinarian or shelter identify your animal. If your pet is micro chipped, keeping your emergency contact information up to date and listed with a reliable recovery database is essential to you and your pet being reunited.

Gather contact information for emergency animal treatment: Make a list of contact information addresses of area animal control agencies including the Humane Society or ASPCA and emergency veterinary hospitals. Keep one copy of these phone numbers with you, and one in your pet's emergency supply kid. Obtain



"Pets inside" stickers and place them on your doors or windows, including information on the number and types of pets in your home to alert firefighters and rescue workers. Consider putting a phone number on the sticker where you could be reached in an emergency. And, if time permits, remember to write the words "Evacuated with Pets" across the stickers, should you evacuate your home with your pets.

3. Be prepared for what might happen: Some of the things you can do to prepare for the unexpected, such as assembling an emergency supply id for yourself, your family and your pets, is the same regardless of the type of emergency. However, it's important to say informed

about what might happen and know what types of emergencies are likely to affect your region. Be prepared to adapt this information to your personal circumstances and make every effort of follow instructions received from authorities on the scene. With these simple preparations, you can be ready for the unexpected. Those who take the time to prepare themselves and their pets will likely encounter less difficulty, stress and worry. Take the time now to get yourself and your pet ready.





Early Saturday morning, the family gathered at Grandma's flat for the departure to Kingston. Grandma had been cooking for two days in preparation for the trip. She had prepared enough food to fill two large hampers. We were to travel to Kingston, as usual, in two cars, Uncle Jimmy's Plymouth and Uncle Tino's Buick. Uncle Tino was Grandma's younger brother. He was a guy who liked to play the field, had many girlfriends but never settled down. He enjoyed gambling and fast living. They signaled their arrival on Garden Court Street with a blast of their horns, setting in motion the family's departure. Gradually, the cars filled with food, suitcases and shopping bags stuffed with clothing and enough first aid material to stock a small clinic. Uncle Tino, noticing the car was gradually filling, stood in the middle of the street with a cigar firmly planted in the corner of his mouth, shouted up to Grandma, "Lucia, there's going to be no room for the family. Stop sending things down!" When Auntie Stella appeared in the doorway carrying Grandma's canary and cage, Uncle Tino shouted, "What the hell is this? Do you have to take the canary?" Grandma popped her head out the window, shouting, "If we leave the canary, morira' (it will die)." Uncle Tino shouted back, "Lascialo morire (Let it die)! All it does is eat and crap!" "The canary sings and makes me happy", Grandma responded. She then directed Mom, "Put the canary in the car. I will carry the cage on my lap." Uncle Tino then shouted, "If you take the canary, you're

going to have to leave one of



your grandchildren behind!" Grandma responded by slamming her window closed, a signal the argument was over, the canary was coming, and none of us would be left behind

While all this was going on, the street gradually filled with neighbors, drawn by the commotion taking place under their windows. Mom, never missing an opportunity, enlisted the DeStefano brothers, who were watching our street scene, while sitting on their stoop. She asked them to lift the larger trunks and place them on top of both cars, tie them down, and secure them with rope for the 40-mile journey ahead of us. Finally, the family made its way to the cars. Dad was to remain behind for a week, because of work, and would be joining us the following week. The rest of us piled into Uncle Jimmy's Plymouth. 



Little Boy and Fat Man

Among the controversies and retellings of the dropping of the first two atomic bombs on Hiroshima and Nagasaki, a fact has gone astray. Even before its entry into WWII, the United States was in a secret race against Germany in the development of nuclear weapons. Germany was leading the race and, out of fear, the United States watched closely trying to learn how to build its own.

After almost two years of research, the United States found itself drawn into the war upon the attack on Pearl Harbor, so the government handed over its research to the Office of Scientific Research and Development and the War Department. The U.S. Army Corps of Engineers were responsible for building the infrastructure where the work that would come to be known as the Manhattan Project would be conducted.

By 1945, the materials (uranium-235 and plutonium-239) were ready to be shipped to New Mexico where J. Robert Oppenheimer was waiting with his team to turn them into the first atomic bomb at their site in Los Alamos. On July 16th of that year the first test was conducted at Alamogordo, becoming the first successful test of an atomic bomb.

Japan was the last holdover of the Axis powers and shortly after the July 16th test, the United States offered Japan one last chance to surrender via the Potsdam Declaration, threatening Japan with "utter destruction" if it refused. Undeterred, Japan vowed to fight till the end with the number of American casualties already on the rise.

There was some reluctance on the United States side to drop an atomic device, most notably from General MacArthur who favored a traditional land invasion, named "Operation Downfall." However, the calculated body count (upwards of 1 million U.S. soldiers) was a price that President Truman refused to pay and opted for the dropping of the bomb.

The first bomb, nicknamed "Little Boy" was shipped to the U.S. base in the Pacific Island of Tinian where it was loaded into bomb carrier Enola Gay, which pilot Colonel Paul Tibbets was to fly and drop over the selected target, the industrial city of Hiroshima (population

estimated at 350,000).

At 8:15 on August 6th, "Little Boy" was dropped on Hiroshima via parachute, exploding some 2,000 feet above the city, destroying five square miles and killing over 80,000 people.

Still, Japan refused to surrender and so, on August 9th, Major Charles Sweeney flew a second bomber (Bockscar) to the next

targeted city Kokura. However, low visibility due to foggy conditions caused Sweeney to move on to the secondary choice, Nagasaki. Although this next bomb. "Fat Man" was more powerful than the first, the impact was smaller by about a half. Only 2.6 square miles of the city were destroyed and only 40,000 casualties were estimated.

On the afternoon of August 15th, Empero Hirohito announced via radio that Japan surrendered, ending WWII. On September 2nd, the surrender was formalized on the U.S. Battleship *Missouri* at Tokyo Bay. Per accordance with the surrender, the U.S. allowed Hirohito to remain emperor and "Victory in Japan" brought celebrations and hopes of peace. Japan could not have known it then, but it too had something to look ahead to. From the ashes of Hiroshima and Nagasaki, the rebuilding and recovery efforts would push Japan into one of the world's leading technological and auto manufacturers of the later half of the 20th century and beyond. The world was ready to be transformed.







A Nostalgic Remembrance



It was the beginning of October, and one Saturday morning at about 5:00 a.m., there was a knock at the kitchen door. Dad woke up first and answered it. It was Grandpa Christoforo, and he was standing there holding a sprig of three grapes. They were not grapes to be eaten. They were wine grapes and the gesture indicated that it was time to make the wine. Dad shook the cobwebs from his head, invited Grandpa in and then woke me up. Even though I was just a kid, I knew from experience that we were to help my paternal grandfather carry on an annual Italian tradition, even in America.

Before attempting a new batch of wine, Grandpa emptied his barrels by filling dozens of gallon jugs and an assortment of whiskey bottles he had stored in his cellar for just this purpose. Now that his barrels were empty, cleaned and ready to go, it was time. He had purchased a shipment of imported grapes. I don't remember if they were from France or Italy, but remembering his attitudes, I believe he would only use Italian grapes. They would have come in on a had purchased. When I asked freighter from Europe, he would him why the white grapes, he have gone to whichever Boston pier the ship docked at, and he would have bought enough crates of grapes to make fifty or more gallons of wine, both red and a few white.

Dad made breakfast for me, but Grandpa only had a cup of coffee while periodically looking at his pocket watch (which I still have in a domed glass display container). When we were done, we headed to my grandfather's Chelsea Street home and Grandpa's wine cellar.

Dad and I uncrated Grandpa's grapes with tools that my grandfather had made just for this type of operation. When enough of the boxes were open, we filled the cylindrical wine presses to crush them into juice and pulp. The wheel shaped lids were lowered onto the contents of the vats, the screw mechanisms were turned to lower the disc shaped covers downward, and the grapes began to be crushed. Neither Dad nor I said anything. We just followed Grandpa's instructions. He was the master vintner and that was that.

Just then, I heard footsteps on the cellar stairs. It was my uncle Jim. Romeo James Dello Russo was Dad's sister Mary's husband. He and my aunt had married after Jim was discharged from the Navy at the end of World War II. He showed up to claim the crushed grapes due to the fact he wanted to make grappa with them. Grappa is an after dinner liqueur that, if made right, would grow hair on your tearing eyes, and Uncle Jim knew how to make it that strong. I think he added in pure grain alcohol to boost the octane, but I'm not sure.

We would repeat the wine making process with the boxes of white grapes that Grandpa responded with, "Durante il verano, bebiamo solomente vino bianco, capisce?" (During the summer, we only drink white wine, understand?) I shrugged my young shoulders and then watched as Dad, Uncle Jim and Grandpa repeated the siphoning process with the white liquid heading for the few empty barrels that my grandfather saved for white wine. Once they had finished, Uncle Jim asked Dad to help him make anisette, one of his specialties. They mixed anise flavoring with food coloring and alcohol and poured the liquid into five-gallon containers that were lined up in a corner of Grandpa's cellar. I didn't know what they were doing, but I liked the colors, and clear. Years later, traveling around the world, I would discover that many cultures. not just the Italian, enjoyed a similar drink. 

'Mbriulata is a Sicilian spiral shaped stuffed bread that originated in the small village of Milena that is located between Agrigento and Caltanissetta in Sicily. The 'mbriulata is a bread dough stuffed with black olives, potatoes, caramelized onions, minced pork and aged pecorino cheese. Years ago, Sicilian housewives prepared these stuffed breads as a wholesome meal for their family members that worked long hard days in the fields. The people of Milena are very proud of their culinary creation. So much so, that every year on the second Friday of August, the Sagra della 'mbriulata is celebrated. Today, in Milena you'll find the 'mbriulata served with a glass of the finest Italian wine, as it continues to be an indulgence enjoyed by many.

In this country, many Italian-Americans have created their own rendition of 'mbriulata. Some use the traditional recipe that calls for minced pork, others prefer sausage. Many make their breads portion sized, and others make them larger so they can be sliced. 'Mbriulata is found in many homes on Christmas Eve, where it is traditionally served as a midnight treat. My own family made this "Stuffed Sicilian Bread" regularly during the fall and winter months. We followed a traditional recipe yet used hot and sweet Italian sausage in place of minced pork. Today, I am sharing my family's recipe for 'mbriulata and if you try it, I guarantee you will fall in love with this scrumptious "Stuffed Sicilian Bread"!

STUFFED SICILIAN BREAD 'Mbriulata

In a small bowl, dissolve yeast and sugar in water, set aside until ready.

In a large mixing bowl mix flour, oil, and yeast mixture. Gradually add water until a soft dough forms. Knead by hand or with a dough hook attached to a mixer for about 8-10 minutes.

Place dough in a large oiled bowl, cover and let rise until doubled in size.

Filling

1/4 to 1/2 cup olive oil

1-pound sweet Italian sausage, remove casings

1-pound hot Italian sausage, remove casings

4-5 potatoes, peeled and cut into small cubes

2 medium sweet onions ½ cup sliced black olives 1 cup softened butter Olive oil

Fresh ground black pepper Freshly grated Pecorino cheese

In a medium frying pan, add 1/4 cup oil and fry onions until caramelized, and sauté potatoes until cooked, set aside. In a large frying pan, add remaining oil and sauté sausage until cooked, add olives, mix together, and cook for a few minutes. Add potatoes and onions mix well and cook the entire mixture over low heat for about 3-5 minutes. Remove from heat and allow to cool.

Preheat the oven to 350. Line 1-2 baking sheets with parchment

Take risen dough and split into 4 or 8 pieces, depending on the size you want your 'Mbriulata's to be.

Piece by piece, roll dough into rectangle shapes. Brush each piece of dough with softened butter. Divide filling evenly and place each portion going down in a line, lengthwise in the middle of each rectangle. Drizzle filling with a little bit of olive oil, black pepper and a generous grating of cheese. Roll the rectangle into a cigar/cylinder shape and then roll the cigar/cylinder into a spiral shape, making sure to tuck the seams in so the filling will not spill out when baking. Place each spiral on prepared baking sheet/s and rub olive oil over the dough. Bake for approximately 35-45 minutes or until light golden brown.

freckles! Nowadays, pumpkins are instantly recognizable as carved and illuminated jack-olanterns at Halloween, a holdover from an old Irish custom of hollowing out turnips and placing a candle in them in order to frighten the evil spirits perambulating the world on this night. Italians love to cook with pumpkin — known as zucca in Italy — in savory dishes, such as pumpkin ravioli and pumpkin gnocchi, often accompanied by buttery sauces with sage.

• **Pears:** My mother loves pearls, and eagerly awaits the arrival of these green-yellow fruits at the supermarket every autumn. Pears drizzled with caramel sauce or yogurt are simply sublime, as the sweetness of the topping brings out the subtle, slightly nutty taste of the fruit. I like to bake pears in cakes or breads, and they taste especially good when mixed with tart apples in a pie or crisp. Pears do not occupy as big of a space in folklore as some other fruits, but nevertheless several

fascinating bits of folklore abound. In China, it is bad luck to split and share a pear with a close friend or loved one. That is because the Chinese term for "sharing a pear" sounds like the word for "separate," and thus holds an ominous connotation. In Europe, it was bad luck for a pear tree to bloom out of season, and such an unusual event portended calamitous consequences. Italians know pears as pere and use them in many inventive dishes. Pears can form the main component of tarts or cakes, or can be enjoyed in savory dishes like salads. Italians like to serve pears poached in wine or drizzled with balsamic syrup for a simple yet decadent finale to an autumnal meal.

• Chestnuts: Finally, I am compelled to add chestnuts to this list because of nostalgic purposes. Every fall, my father would bring home a bag filled with chestnuts, gleaming like polished wood, straight from the supermarket or, even better, a small Italian grocery store. He would then cut an opening at the top of each chestnut to release the stream and roast them in the oven. The warmth of the oven and the creamy aroma of the roasting chestnuts enveloped the whole house like a bear hug, and to this day chestnuts remind me of cloudy, drizzly fall days spent in the joyful company of friends and family. Superstition dictates that carrying a chestnut protects a person

Roenicke Gone And I Saw it Coming

Ron Roenicke, who managed the dismal Red Sox this shortened season was canned before the final game of the season was played. Is anyone really surprised? I believe, whether the Red Sox deleted this season or were the best team in baseball, that Roenicke was gonzo from the get-go. He was a fill-in because they needed someone quickly after Alex Cora was suspended for one-year from baseball. I can only hope the Red Sox don't bring back Cora. I don't want him anywhere near the Boston Red Sox in the 2021 season. He's nothing but burned toast to me. There's no credibility left in that guy, if you ask me.

Ron Perranoski, RIP

Just found out that following relief pitcher Ron Perranoski from back in the '60s and '70s has passed away at 84 years of age. As a high school student and baseball fan back in the '60s, I remember him well. He was one of the two top relief pitchers in baseball when he was with the Los Angeles Dodgers and Dick Radatz pitched for our own Boston Red Sox.

Relievers back in those days were just getting developed. It used to be that bullpens were mostly filled up with aging starters who couldn't pitch that long anymore, so they went to the pen. Relief pitching is most of the game now. We don't have batter guys, one inning guys, and every once in a while, a reliever who can actually pitch two innings, but these guys would be the new workhorses.

Back in the '60s, relievers came in at different periods of the game. Most of them pitched as long as the manager wanted them to pitch. However, big guys like Perranoski and Radatz were large in size, about a half foot taller, and weighing in around 240-250 pounds.

Perranoski played from

1961-73 for the Dodgers, Twins, Tigers, and Angels. He was 79-74 with 178 saves and a 2.79 ERA over his career. He signed with the Cubs in 1958, and was traded to the Dodgers in 1960 for Don Zimmer. Yes, that Don Zimmer; and became the ace of the bullpen from 1963-66. When I think of him, it is always as a Dodgers player.

His best year was 1963, when he moved to the pen full time going 16-3, and earned a save in relief of Johnny Podres in Game 2 of the World Series against the dreaded Yankees. That season, he also had 21 saves and a 1.67 ERA.

In the 1965 World Series against the Twins, he made two relief appearances and the Dodgers beat the Twins in seven games. He led the NL in appearances in 1962 with 70, 1963 with 69, and 1967 with 70. With the Twins in the AL, he led the league in saves with 31 in 1969 and 34 in 1970.

He went on in his retirement working with both the Dodgers organization and also with the Giants organization, too.

Did you know that in 1941, at age 22, Ted Williams only had 185 hits when he won the batting crown with that .406 average? He walked 147 times that season. Williams led the league in walks eight times in his career.

How Great is JBJ?

Many Red Sox fans think Jackie Bradley Jr., is a great asset to the team as was Mookie Betts, but I am not one of those guys. Yes, he might be one of the all-time Red Sox defensive center fielders, but his lifetime average is .239, and he hit far worse than that on the road.

Let him try free agency, good luck to him. He might even come back to Fenway with the Sox. He's a likable guy and plays hard, but his batting remains suspect, especially when it is needed and fails at the plate.





Lack of fear can work against a fighter. It's very possible Clay was channeling his fear into his confident persona. He may have had a surge of adrenaline when he saw Liston and that was his way of dealing with it while at the same time hoping to get under the champ's skin. It should also be remembered his blood pressure returned to normal a short time later. I really don't think it did much to bother Liston.

The other tactic that has been cited by Angelo Dundee to intimidate Liston was having Cassius stand up straight when facing Sonny while being given the preflight instructions before the opening bell. Since Clay was taller than Liston, Dundee said this would bother him. I doubt it had any effect as he had fought men who were taller than him before, most notably Cleveland Williams.

Clay was very likely scared to death when getting into the ring with Sonny Liston that night in Miami. He certainly should have been. But like all great athletes, and in particular, great boxers, he was able to channel his anxiety into focused energy. The adrenaline flowing through his system made his reflexes sharper and his mind more focused. While many people fall apart in a situation like that, those who can work with it are able to do amazing things.

Now, Liston on the other hand may have been dealing with a different problem when it came to fear; his lack of it. It had been reported he was not training hard for the fight. While he was only three pounds over his weight for the Patterson fight a year earlier, he did not work with the same intensity while getting ready to face Clay. He looked at this fight as easy pickings. And why not? In Clay's last two fights he had not looked particularity threatening. He won a somewhat controversial decision over Doug Jones, and defeated Henry Cooper after Cooper had flattened him with a left hook. Jones weighed 188 pounds and Cooper came in at

HOOPS and HOCKEY in the HUB

They say positioning is everything and Frank Vogel came to that realization early on.

Vogel, once with the Celtics and now in his first season as head coach of the Los Angeles Lakers, grew up in Wildwood Crest, New Jersey, a coastal community on the New Jersey shore. It is one of those places that draws thousands to the beach in the summer and then assumes a much more sedate status during the offseason.

But there would be two experiences that would make an impression on Vogel as he grew up. The first was that media attention was important. As an eighth grader, he managed to get on the Late Night with David Letterman show where he displayed his talents by spinning a basketball while brushing his teeth. At a young age, he had already made a mark, however briefly, by appearing on national television.

The next time would be a matter that was much more serious. In December of 1990, the family home caught fire. He and his mother the only two at home at the time — escaped through a window and were uninjured. Just about all items in the home were destroyed.

And thus it was that Vogel, who possessed an intense interest in basketball above all else, graduated from high school the following June and enrolled in Juaniata College, a Division 3 school in Pennsylvania, where he made the starting five.

But Vogel had his sights set on something higher in the basketball world — even if it meant he would have to halt his career on

Maybe it took a lot of fortitude, but Vogel sat down and wrote a letter to the University of Kentucky's Head Coach Rick Pitino, telling him that all he wanted was to be a student manager for his team.

"He wrote me a long letter about following me from Five Star Camp (a summer gathering of elite high school players) and saying he'd like to learn everything we do," Pitino told the New York Post recently.

Noting that Vogel was from New Jersey, Pitino suggested a school closer to his home, perhaps one between Philadelphia and New York.

"But he wrote back and said that really didn't matter — that he was just interested in basketball."

Actually, he may have stated that in his follow-up letter, but time would prove that wasn't quite true. When Vogel did graduate from Kentucky, he earned a degree in Biology — meaning he was also able to pass the demanding laboratory courses in that discipline.

And even after he graduated, Vogel was able to stay on with the basketball program at Kentucky as a staffer.

Pitino compared Vogel with Jeff Van Gundy, another assistant he had when he coached at Providence College in the middle of the 1980s. "With Vogel and Van Gundy their work ethic was something to marvel," said Pitino, who will start the 2020-2021 collegiate season as the head coach at Iona College. "I was getting in at 6:30 a.m. and they always were ahead of me, always there when I left. You don't see that much anymore. Frank never came in and said he had been there for 12 hours. He just got the job done."

And thus, it was that Frank Paul Vogel's life changed the day the phone rang in 1997, telling Pitino he was being hired as the new head coach of the Celtics. Northward he went with his mentor, though now in the capacity of team video coordinator.

He served in that position until the start of the 2001-2002 season when he was promoted to assistant coach. He would remain in the Hub after Pitino's resignation in January 2001, when Jim O'Brien, who had been Pitino's top assistant at both Kentucky and the Celtics, took over as the bench boss.

He later moved on to become an assistant with Philadelphia for the 2004-2005 season under O'Brien, then worked as an advance scout with the Lakers (2005-2006), and with Washington (2006-2007).

He was reunited with O'Brien in 2007, when the former Boston mentor was named the head coach of the Indiana Pacers, replacing Rick Carlisle, who had played for the Celtics in the 1980s.

The Pacers missed the playoffs the three full seasons that O'Brien led the team and were on the way to a fourth playoff miss when he was fired in January, 2011, when Indiana's record stood at 17-27 through 44 games.

Vogel was installed as interim head coach and was able to go 20-18 over the final 38 games and claim a playoff berth. That was good enough for him to be named permanent head coach that summer.

If there was ever a reason for a coach to get even with Miami and Coach Erik Spoelstra, Vogel has it in capital letters. For the first three complete seasons that he coached the Pacers, they were beaten in the playoffs by the Heat and Coach Spoelstra. There was the loss to the Heat in the 2012 Eastern Conference Semifinals, as well as being eliminated by Miami in both the 2013 and 2014 Eastern Conference Finals.

Vogel would remain as the head coach of the Pacers for two more years — missing the playoffs in 2015, and losing in the first round to the Toronto Raptors in 2016. In the end, he wasn't fired. His contract simply expired and wasn't renewed.

From there, he went to Orlando for two years. The Magic were attempting a makeover, both on the court and off. The GM who hired him was later replaced, not a good sign for those in the coaching ranks.

The latest may be the greatest. As head coach of L.A., he led the Lakers to a 52-19 record over 71 games (.732), good enough for first place in the Western Conference.

As this was being written, the Lakers were leading the Heat and Coach Spoelstra in the 2020 NBA Finals. If they win the championship, it will be Banner 17 for the Lakers, bringing them into a tie with the Celtics for most NBA titles won.

Regardless, it has been a remarkable journey for Frank Vogel, who long ago had the fortitude to write the letter that set him on a successful path. It eventually led him to the highest echelons of his chosen profession — all because he realized early on that positioning is everything.
