#### Now Who's Talking About an Obamacare Delay?

### **ABCD Calls on HHS to Release Fuel Assistance Funds Thousands in Boston Literally Waiting in the Cold for Relief**

Government Shutdown May Slow Release of Funds

of low-income seniors and families are worried about how they will heat their homes.

Normally the ABCD Fuel Assistance program opens on November 1, with oil trucks rolling to low-income households as the weather turns cold and payments to utilities preventing shutoff of gas and electric service in homes where families, struggling to survive, have fallen behind on their bills.

But this year, citing the disruption of the government shutdown, the federal Department of Health and Human Services has not yet allocated funds to the states to provide fuel assistance to low-income elders and working families eligible for the Lowincome Home Energy Assistance Program.

The program cannot open until officials at the Commonwealth receive notification from HHS of the availability of LIHEAP dollars and authorize ABCD and other fuel assistance providers to begin the heating assistance program.

ABCD and other providers of fuel assistance in the cold northern states are very concerned about the delay. Already ABCD has received more than 12,000 applications for heating assistance. Last year over 21,000 applications came in over the length of the program. Across the state, more than 200,000 households receive fuel assistance.

"It's truly a matter of life and death for many people who have no extra money to pay for heat. With oil prices at near-record highs, it's a tough situation," said ABCD President/CEO John J. Drew.

He noted that the government shutdown is over and a Continuing Resolution is in force, requiring fuel allocations at last year's levels. "I don't understand why the funding for this desperately needed program is delayed," he said. "Poverty data released by the Census this fall shows increased poverty, with 15 percent of Americans or 46.5 million people living below the poverty level of \$23,550 for a family of four. In those homes there is just not enough household income to pay for the bare necessities."

Drew said that these families regularly

Cold weather has arrived and thousands are forced to choose between heat, food, medicine and paying their rent.

> Based on last year's allocation, families with incomes below the federal poverty level are eligible to receive the maximum fuel assistance benefit. Last year that was \$1,125. With current oil prices near \$4 a gallon, which will not even fill an oil tank

#### Forward funding from Massachusetts

The Commonwealth is considering "forward funding" fuel assistance legislation that would provide funds to get the program started while waiting for federal funds to arrive. The state would then be reimbursed.

Drew urges quick passage of that bill. "We need to get help to those who cannot turn up their thermostats," he said. "I urge the legislature and Governor Patrick to make that money available. A direct state supplement of \$20 million, that didn't have to be paid back, would be even better."

He noted that the program is costeffective. "Without adequate heat, people get sick and end up in emergency rooms. Children can't do their schoolwork in a freezing apartment and get poor grades. Space heaters cause fires and take lives. Providing these funds, this program immediately is the right, moral thing to do and, in the end, it saves money."

Families who qualify for heating assistance also can benefit from ABCD's weatherization programs and qualify for repair or replacement of faulty heating systems. ABCD also helps clients improve energy



#### Call Me a Taxi

The story goes that humorist Robert Benchley, upon asking a man outside of the '21' Club to call him a taxicab, was informed that he was an admiral for the U.S. Navy. Benchley responded, "Well, then call me a battleship." Taxis, being more directly relevant to the average Post-Gazette reader than are battleship, let's talk about taxis

Mayor Thomas M. Menino this past week released a Taxi Consultant Report, commissioned by the City of Boston and prepared by independent consultant. Issues identified in the report -

Poor performance in response to trip requests. When a customer requests a trip only 78% of the requests are completed and only 87% of the served trips are picked up within 20 minutes of the call.

There is unmet demand during peak hours. Regardless of what neighborhood needs service, many report that during rush hour, late

during inclement weather, it is difficult to get a cab.

Rates are either difficult to access or are confusing. While base rates but not all charges are displayed on the passenger information monitor, some customers have difficulty finding the rates and those that are able to find the rates may not realize they are displayed over multiple pages. Additionally, there is specific confusion over (1) large vehicle charge of \$6:00; (2) distinctions between Logan Airport and East Boston that affect an additional \$2.75 charge; and (3) the \$2.25 Massport pool entry fee to customers.

Massport staff indicated a desire to have a flat rate structure to/from airport, as they have received complaints from out-oftowners.

Insufficient, undersized, and unknown taxi stands. Taxi customers and taxi drivers alike could benefit

nights on weekends and from additional and strategically located taxi stands that are better marked and better advertised.

> Little assistance and public education/information. Visitors and local customers alike have little guidance as to the approximate fares.

> Wheelchair accessible vehicles are not compliant with City of Boston standards, are not regularly inspected and are not readily available.

> I don't know why the city had to spend money on a study. Any resident could have told them that Boston does not have enough taxis and that the ones we have are in poor repair and smell. The fares are the highest I know of in any American city and are impossible to understand. And, in my experience, wheelchair accessible vehicle are not "not compliant," they are "nonexistent." And, yes, during rush hour in the rain you are about as likely to hail a battleship as a taxi.

## All Saints Day

Christians have been honoring saints and martyrs since at least the second century AD. Initially the calendars of saints and martyrs varied by location, with churches honoring local saints, gradually feast days became more universal. The first reference to a general feast celebrating all saints occurs with Saint Ephrem the Syrian (373AD). Saint John Chrysostom (347-407) assigned the first Sunday after Pentecost to the feast where in the Eastern Churches the feast is celebrated to this day. In the West, this date was probably originally used, and then the feast was moved to May 13th. The current observance (November 1) probably originates from the time of Pope Gregory III (741AD).

It was on May 13, 609 or 610, when Pope Boniface IV consecrated the Pantheon at Rome into a Christian church dedicated to the Blessed Virgin and all the martyrs establishing an anniversary to celebrate the event. The Pantheon was a famous pagan temple generally considered to have been built by the Emperor Marcus Agrippa about the year 27 BC. The Roman historian Pliny tells us that Agrippa dedicated the Pantheon to Jupiter the Avenger, later the temple was repaired by Septimus Sererus and his son Caracalla.

The feast of All Saints, on its current date, November 1, is traced to the foun-



dation by Pope Gregory III fied and reached heaven, (731-741) of a chapel in St. Peter's for the relics of the holy apostles and of all saints, martyrs and confessors, at which time the celebration of the feast was moved from May 13th to November 1.

The Church established All Saints Day to commemorate all those who have attained the beatific vision in Heaven. The following day the Church celebrates All Souls' Day commemorating the departed faithful ber 1, is a Holy Day of Obligawho have not yet been puri-

### The North Bennet Street School

Opens a New Facility in the North End

The availability of two adjacent buildings, with a total of 65,000 square feet of industrial space in Boston's North End, provided a oncein-a-lifetime opportunity to build the expanded facility North Bennet Street School ( NBSS ) has long needed while retaining its historic ties to the North End neighborhood. The new facility provides code-compliant and energy-efficient spaces for the school's training programs and the ability to expand public programs and increased visibility in the city. For the first time in decades, the school has space for the entire school to gather, enhancing the educational experience for students and strengthening the sense of community.

In January 2012, the City of Boston advertised for developers for two surplus buildings on North Street. In May, 2012 the school's offer to the city was approved. The purchase included a property swap with the city. North Bennet Street School's historic home on North Bennet Street will become part of an expanded campus of the successful Boston public K-8 John Eliot School.

Renovation and new construction at the site, designed by Kennedy Violich Architecture and built by BOND, began in late 2012 and the school opened at the new facility on September 9, 2013. The schedule was tight and the obstacles many but a committed team of designers and contractors met weekly to ensure the project's success.

Not only did the school meet its construction goals, they launched and completed a capital campaign, raising more than \$17 million to purchase and renovate the building. Opening the new facility nine months after construction started, with fundraising goals not only met but exceeded, is a tremendous accomplishment that would not have been possible without the dedicated and forward thinking campaign donors who shared the vision of a reunited school.

The building dedication is Friday, November 8th at 11:00 am at 150 North Street followed by a public Open House, November 8-9.

Event speakers include: Charles Kline, Chair of the Board of Directors, North Bennet Street School: The Honorable Thomas Menino, Mayor, City of Boston and Miguel Gómez-Ibáñez, President, North Bennet Street School.

Located in Boston, North Bennet Street School offers intensive, hands-on training in traditional trades and fine craftsmanship, helping students to achieve meaningful lives and livelihoods. North Bennet Street School was incorporated in 1885 in Boston's North End as North Bennet Street Industrial School. North Bennet Street School offers full-time programs and workshops in bookbinding, cabinet and furniture making, carpentry, jewelry making and repair, locksmithing and security technology, piano technology, preservation carpentry and violin making and repair. In their ongoing efforts to educate youth about the devastating effects of drug and alcohol abuse and to stress alternative adolescent activities, North End Against Drugs and the Nazzaro Center recently hosted a workshop at the center conducted by Kevin Sheehan a substance abuse clinician who works in the Criminal Justice Services department of the AdCare Hospital. Kevin is no stranger to the Nazzaro Center. He has two daughters in the youth program and regularly brings his message to the youth there. And again, as he has in the past, Kevin brought a former client with him, **Jimmy**

McSorley, late of the mean streets in Charlestown. After a brief introduction by Kevin, it didn't take Jimmy long to connect with the 25 teens through his stories and anecdotes about a life on drugs. The portion of Jim's narrative that seemed to have the most powerful effect on the teens was how his choices had such a devastating effect on the people he loved most...yet he still couldn't stop his destructive behavior! The audience was visibly moved by Jimmy's accounts of his criminal activities, his betrayal of family and friends and his ultimate salvation. And although Jim's been clean for a year now, he very adamantly stressed that he considers himself a recovering addict for life who must guard at all times against falling back into the trap of addiction and that the best way to conquer addiction is to never become addicted at all.

Statistically speaking, it is almost certain that a percentage of the 24 youth who attended this workshop will dabble with substance abuse at some point in their lives on some level. Yet, the mandate of NEAD and the Nazzaro Center is to knock that percentage down, hopefully to zero, by whatever means possible. To that end, North End Against Drugs and the Nazzaro Center will continue to sponsor events such as this on a fairly regular basis.

### L'Anno Bello: A Year in Italian Folklore

From Graveyards to Cookies: Italy's Day of the Dead

A baker is walking home on the night between All Saints' Day and All Souls' Day when she passes by a church, lit up like a beacon in the dark. Entering inside for Mass, she quickly realizes something feels off. A neighbor warns her to get out — a neighbor, that is, who has been dead for several years. As the baker hurries to leave this Mass of the dead, she frightens herself so much that she loses her voice. So goes one of the many stories pertaining to All Souls' Day from my father's region of the Abruzzi, collected on the Italian website www.sehaisetediluce.it. In Italy, the twin holidays of All Saints' Day and All Souls' Day, falling on the first two days of November, brim with superstitions and creepy tales of the supernatural. Since ancient times, these have been feasts honoring the dead, and the Italians

embrace these celebrations with gusto, food, and shivers excitement. Halloween continues to grow in popularity among Italians, but the following days devoted to saints and the deceased still maintain their traditional, spooky customs. These feasts comprise some of the most important winter celebrations in Italy and their spine-tingling lore reverberates among Italian society.

I first became acquainted with All Souls' Day through Spanish class. In Mexico and other Latin American countries, November 2nd is Día de los Muertos, or Day of the Dead. We celebrated in class with decorations of flowered skulls and fancilydressed skeletons, altars and cinnamon-spiced pan de muertos, or bread of the dead. Later, my father introduced me to the Italian customs pertaining to il Giorno dei Morti, which also means

Day of the Dead in Italian. All across Italy, people visit cemeteries on this day, cleaning and repairing graves and bringing offerings to deceased relatives. In my father's region of Abruzzi, neighborhood children may trek from door to door, offering prayers for the dead in exchange for treats of autumnal fruit, nuts and candy. The people of Puglia, from where my mother's family hails, set dinner tables for the souls who are returning to their former homes on the eve of this feast, replete with place settings, food and wine. As everyone falls asleep, they know that the dead are enjoying the banquet. Sicilian children can expect to find tiny presents and candy from the souls of the departed when they wake up in the morning of November 2<sup>nd</sup>. of these traditions stem

I changed my habits and lifestyle, eat smarter and exercise as much as I can. My sugar issue disappeared. My blood pressure went way down and I dropped 30 pounds

I feel great, alive and enjoy my life at 65. Recently, I covered a Golden Age Club meeting as a reporter, not as an old guy. I guess I take after either my mother or my Uncle Nealy. My ma always said being old is five years from now. My uncle belonged to a senior club called Forever Young which he was until the day he died.

Hey, we all want two things. We want to go to heaven but not today and we never really want to feel old. I am planning, God willing, to play first base again for the West End Softball League in 2014 and I will still be using the first base mitt I bought at Raymonds Department Store in Downtown Boston back in 1965 when I played first base for the St. Philip Phillies in Roxbury. I don't run as well and my hitting now has become more a matter of timing and luck but I can still field the ball and play the

# An Open Letter to Suffolk Downs, Our Elected Officials and the People of East Boston

#### Dear Friends

In all honesty, it's hard for ministers to agree on

But when it comes to the potential of a casino in East Boston, we're in complete agreement:

God has something better for this town than a casino.

Multiple independent studies have demonstrated that casinos increase crime, addiction, traffic, pollution, bankruptcy, insurance rates and numerous other harms. That's why this casino proposal is accompanied by a "mitigation package" - which is an attempt to reduce the severity of the problems that a casino will create.


And, yes, we know that Suffolk Downs has promised 4,000 casino jobs: they've plastered that promise - along with the logo of Caesar's Entertainment - all over our

Of course, our community needs jobs. But the problem with Suffolk Downs' job plan is that their casino proposal includes at least 4,000 slot machines, and research has shown that every new slot machine in a community kills 1-2 jobs per year.\* That's because people spend their "pocket change" and "fun money" on slot machines instead of spending that money on local businesses.

What that practically means is this: A casino at Suffolk Downs will most likely take more jobs from East Boston than it will ever provide, and that's just not a gamble this town needs to take.

When you're days away from voting on whether or not to allow a proposed casino to forever reshape your community and its identity, and it is suddenly revealed that the chosen and highly-touted operating partner, Caesars Entertainment, is being investigated for alleged business ties to organized crime, that's a very, very big deal.




Ah, Italy! A narrow peninsular of 110,675 square miles crowded with more than thirty-five million human beings. That was the last count many years ago.

# Recipes from the **Homeland**

### VEAL CACCIATORE

#### Veal Stew Meat or Veal Shoulder Arm Chops

- 1 pound veal meat 1/2 cup chopped celery
- 2 cloves garlic (optional)
- 1 medium onion chopped
- 2 large carrots
- 2 large potatoes1 sprig of bay leaf (optional)
- 1 chicken bouillon cube
- l cup water
- 1 full tablespoon capers (in vinegar and water)
- 1/4 cup canola or vegetable oil3 medium-size ripened
- tomatoes chopped
  1/2 pound fresh string
- 1/2 pound fresh string beans, or 8 oz. can of cut beans, or frozen cut beans.

Line a twelve-inch skillet with canola oil and heat over medium flame. Leave bone in if using shoulder chop but remove extra fat from veal shoulder chop. Place veal in heated skillet to sear and brown. Remove meat from skillet and set aside. Add celery, onions and capers to the skillet. Stir until onion is opaque. Do not brown onion. Add a little of the vinegar and water from the capers' bottle. Add bay leaf (optional) and simmer about two or three minutes before adding chopped tomato pieces. Stir occasionally and cover. Simmer slowly for about three minutes. Meanwhile, dissolve bouillon cube in warm water. Slowly stir in bouillon mixture into skillet. Add garlic and veal into skillet. Cover and cook about ten minutes over medium heat.

Peel and slice carrots into wedge about two inches long. Cut tips of string beans if using fresh beans and wash thoroughly. Peel potatoes and cut into two-inch wedges. Add carrots first to skillet. Cover and cook them about five minutes before adding string beans and potato pieces.

Add additional water if needed. Cook until potatoes and vegetables are tender. Season to taste. If bay leaf is used, remove before serving meal.

NOTE: I learned from my mother to vary the recipe by occasionally adding a can of mushrooms to the skillet. Another option is to add sliced green peppers or some green peas. In place of potatoes, I sometimes prepare some of my favorite rice and serve it plain or topped with a few tablespoons of sauce from the skillet.

from the prevalent belief that spirits roam the Earth during these nights, which originated from the ancient Celtic holiday of Samhain, the precursor to our Halloween. All Souls' Day in Italy also means snacking on ossi dei morti, or spice cookies whose name translates to "bones of the dead." Often, these cookies are shaped like beans, which have been a symbol of death since the time of the ancient Romans.

I believe that it is hardly a coincidence that these celebrations of the dead occur during the month of November. This month reminds us of the mortality of the earth and its seasons, a symbolism which carries over to its holidays. During November, dark, bare branches frame cloudy skies. The last brittle leaves of autumn float off the trees, swirling around in the crisp and chilly air. The melancholy sound of migratory geese, flying in v-formations across the heavens, sets the appropriate tone of the month. At a time when vegetation withers and the harvest have already been collected, people naturally turn to the memories of the dead, of all things past. The cold weather and dark days of November also encourage people to gather together as a community, taking comfort in the love of family and food. Holidays

such as St. Martin's Day

and Thanksgiving provide a honeyed glow of abundance, gratitude and companionship as the Earth begins her winter nap. The celebrations of the dead that begin November, therefore, anticipate the overall sense of family and community that characterize this month, whether they include the community of the living or of another world.

Italy's Day of the Dead overflows with spooky traditions that emphasize the transitory nature of November. These are not festivities of fear, but rather feast of honoring the past and attuning to seasonal changes. Italians embrace the unknown, inviting the spirits of the deceased to eat dinner at home or leave small presents for children. We should follow their lead by commemorating the spirits of the past and reveling in seasonal changes instead of fearing them. Just as the ossi dei morti spice up All Souls' Day in Italy, so too do holidays that bring people together in festivals of harvest and community spice up the cold winter days as well.

# Nanna & Babbononno

A Nostalgic Remembrance



When I was a child, there was an event that happened every fall. As an example, let me relate one episode that I remember. There was a knock on the kitchen door early one Saturday morning. I'd say it was around 6:00 am. Dad had come home around 2:00 am with a couple of the guys in his band and a dozen hot bagels they had picked up at Katz bakery in Chelsea. The musicians didn't leave until around 4:00 am, so I'm assuming Dad didn't get more that two hours of sleep.

When we heard the wrap on the kitchen door, Dad, grumbling under his breath, got up, threw on his robe and headed into the kitchen. I was right behind him curious as to who was looking for us at that early hour. When my father opened the door, there was Grandpa Christoforo standing there holding up a twig with three large red grapes hanging from it. When Grandpa spoke it sounded like he said, "Fa tempo per fare vino nuovo, tu, me e mi genero, Jim." ("It's time to make the new wine, you, me and my son-in-law, Jim.") Son-inlaw, Jim, was Uncle Jim Dello Russo, Dad's sister's husband.

As Dad was grumbling under his breath about only two hours sleep, I jumped up and down asking, "Me too, me too, me too!" By this time, Mom was up making coffee and within minutes, we heard footsteps climbing the stairs that led to our top floor apartment at 74 Eutaw Street in East Boston. It was Uncle Jim Dello Russo. He had picked up Grandpa Christoforo and was waiting in the car. Grandpa was in a hurry but neither Dad nor Uncle Jim had had their morning coffee as a result of the early hour and no one was going anywhere until that first cup had been consumed.

Grandpa kept looking at his pocket watch, but it was almost a half hour before my father and uncle we did leave and were in few weeks or months. Uncle Jim's car, Grandpa said to Dad, "Io promesso tu suocero, andiamo a suo cassa." ("I promised your father-in-law, let's go to his house.") So, we headed to Nanna and Babbononno's place and picked up Babbononno who was already waiting on the front steps.

Babbononno had long since again, one man on each end stopped making his own wine, but this year, he and Grandpa Christoforo split the cost for grapes and they were joining forces to make a new batch of both red and

of Grandpa's house on Chelsea Street and headed down to the cellar. En route, I could smell the sweet aroma of grapes filling the air. When we were finally in the wine making part of the cellar, there were cases of grapes piled up from floor to ceiling. There was Italian writing on each case indicating the point of origin of the grapes. Normally, when Grandpa Christoforo made wine on his own, he would buy California grapes, but this time around, with both he and Babbononno splitting little kid, asked why the the cost, they decided on the imported grapes.

Grandpa was always a laid back type of person, but he now took command and gave his son and son-in-law and Babbononno instructions on what he wanted them to do. I just watched and sampled the grapes (as fruit, not wine). Dad, Uncle Jim and Babbononno opened the cases of grapes and emptied them into the big round grape press until it was filled. This large round vat with vertical wooden slats had a cover that was lowered by a spiral thread on a screw shaped spindle. There was a hole going through the threads and a long metal rod was fed through the hole, parallel to the floor. When it was turned clockwise, the cover was lowered, crushing the grapes as it descended toward the bottom of the round press. A spigot at the I explained that if I nailed a bottom of the press was large empty grape container opened and the squeezed liquid poured out into containers held below it by Grandpa and Babbononno. When the containers were filled, the spigot was shut off and the grape juice poured into oval and round shaped casks for the fermentation process that would convert the liquid were ready to travel. of the iron bar pushing as hard as they could, while Grandpa instructed them to squeeze out every drop of liquid that was possible.

When all of the red grapes had been crushed, Grandpa Uncle Jim parked in front and Babbononno cleaned out the press by scooping out the crushed grapes and putting them in an old fashion oval shaped copper wash tub. In the mean time, Dad and Uncle Jim opened the boxes of white grapes and when the press was empty and cleaned out, they poured in the new batch. They repeated the squeezing process and the white liquid was later poured into another barrel which was exclusively reserved for white wine.

> Me being the observing writing on the boxes of white grapes was in English. As it turned out, the only Italian grapes Grandpa and Babbononno could get their hands on were the red. The white grapes were from California, hence English writing on the boxes. When all was said and done, Grandpa and Babbononno added something to the barrels that contained the new grapes. I think it was sugar, but I'm not sure. When I asked, Grandpa told me that he wanted to speed up the fermentation process and Babbononno just nodded in the affirmative as he spoke.

> Just before we headed upstairs to the kitchen, I spotted pieces of wood that were just lying around and asked Grandpa if I could have them. One was a 2" by 6" by 4' piece. Another was 1" by 2" about 3 feet long. on top of the large board and cut the smaller one in half and nailed them on top for handles, I could then nail the two halves of a roller skate to the bottom and have myself a scooter. Grandpa said, "Va come se piace," (Whatever you like.)

#### THE MUCH-DISCUSSED "I.M.U. TAX IN ITALY:"

WHAT IS IT! The I.M.U. tax is plainly a municipal tax applied on a residence passed in late 2011. It became a law on January 1, 2012. It is applied to any Italian citizen who owns real estate in Italy. The law, however, says nothing concerning Italian citizens residing abroad who own real estate in Italy. Those who are required to pay this tax, excessive for many, are those who own not only the main residential building but also any other real estate, such as: storage buildings, stables, garages for any kind of vehicles as well as any, building lot or other buildings owned or acquired out of a divorce or from a will and testament. The question often asked by Italians residing abroad is, "how much I.M.U. he or she must pay." Presently the law provides no hints about the law's true implications. To make matters even more confusing, we learn that not all Italian municipalities have agreed to apply the I.M.U. defined by many as an experimental form of taxation. Therefore in order to avoid any alarmist concern, a foreign Italian resident should contact the municipality, he or she came from and try to get the right information. Now we learn something more interesting: in late August (2013) the Council of Ministers approved a decree to abolish the I.M.U. all together. If it is approved by the Parliament it will be a relief to at least those good citizens who have paid the tax early in 2013. Now the remaining quarterly payments are cancelled.


CAN A MICROCAMERA HELP A BLIND PERSON? Up until a few years ago such possibility was a visionary fantasy. Today it is in the process of becoming a reality. First in the entire world, the blind has re-acquired, all but partially, their eyesight. It happened at Pisa not long ago, at the local University Hospital where a medical team inserted in the eye of a 60-year-old patient a micro camera, connected to electrodes which make it possible to distinguish, at least, some shadows. The experiments, in Pisa, have continued over the last nine years on patients who had progressively lost their eyesight due to "Retinitis Pigmentosa." Most patients have been able to see moving shadows, after two weeks of rehabilitation, and recognize them! The device has been called "Argus 11," and it was developed in California and it is capable of bringing back partial vision capability in patients afflicted with degenerative illnesses of the retina which cause virtual blindness in both eyes. The surgery in Pisa was the first implantation of the prosthesis of the retina under the supervision of Stanislao Rizzo, Director of the Ophthalmic Surgical Department of the hospital. The procedure was also used throughout the European community. The Pisa experiment has been welcomed with great satisfaction by Daniela Scaramuccia, the head of the Regional Department (Toscana Region) "Right to Health" Program, which will continue to support the research and the investments with adequate policies.

In 1972, his first year with the Phillies, he finished with 27 victories, 30 complete games, 310 strikeouts and a 1.97 ERA. The lowly Phillies that season won only 59 games making Carlton's 27 wins 46 percent of the team's total victories. A Major League mark that could stand forever. He was called the best athlete of 1972.

#### No One Forgets Stan "the Man"

Stan "the Man" Musial was one of the greatest hitters of all time. He retired from started off his great baseball baseball when I was 16 years

old. In his long career, he won the batting title seven times and finished runnerup four timers. When it came to the MVP Award, he won it three times and finished second, four times. He had 3,630 career hits. He split them evenly, 1,815 hits at home and 1,815 hits on the road.

In 1948, the year I was born, he had 230 hits, 46 doubles, 18 triples, batted .376 and won an MVP for it.

#### Boys of Summer

The 1955 Brooklyn Dodgers won their first and only World Series in Brooklyn after they finally beat their cross-town arch-rivals the NY Yankees when Brooklyn won Game 7, 2-0.

#### Sandy Koufax **Back in 1965**

Sandy Koufax threw his fourth no-hitter on September 9, 1965 in Los Angeles in what many consider the greatest pitching duel of all time. The Dodgers great pitched a perfect game that night against Bob Henley of the Chicago Cubs who pitched a one hitter in this game. The Dodgers scored their only run in the fifth inning when outfielder Lou Johnson walked, took second on a sacrifice fly, stole third and scored on a wild throw. In the seventh inning when Johnson returned for his next at bat, he got the game's only hit a mere single.

THE ONE THEY SENT AWAY — Of all the players that we felt should have been kept by the Bruins over the years, Jaromir Jagr ranks near the top on our personal list.

Acquired from Dallas at the trading deadline last season, the big man (6-3, 230) was a presence to be reckoned with, picking up 10 assists in 22 playoff games as the B's made their march all the way to the Stanley Cup Final.

However, soon after the Cup run ended, Bruins GM Peter Chiarelli announced that the team would not offer a contract renewal to the 41-year-old veteran winger, effectively putting J-J on the free agent market. He was signed by New Jersey on July 23.

During the Bruins Stanley Cup run, Jagr stated in one locker room post-game interview that he definitely wanted to continue to play, mainly because playing hockey was something he loved to do. He made that statement with a wonderful smile on his face. You knew right then that playing hockey for him wasn't simply a means of employment, it is something that he truly has enjoyed doing throughout his life.

In short, he is fortunate enough to be an example of the statement "Do what you love and you'll never work a day in your life."

That's why it was so good to see him take the ice as the Bruins hosted the New Jersey Devils at the Garden on October 26th. And true to his persona, Jagr was a major factor in New Jersey's come-from-behind 4-3 victory over the Bruins.

Early on, in the first period, he assisted on New Jersey's first goal, a power play tally by Adam Henrique. But he saved the best for last, also assisting on the game-winning marker with 45 seconds remaining in the third — another power play score, this time by Andy Greene. It was his seventh assist of the young season, leaving him just two shy of the 1,700 threshold in career assists.

A few days later, when New Jersey played a home game against Philadelphia, Jagr bagged the gamewinning goal as the Devils downed the Flyers 2-1. It was the 119th game-winning goal of his NHL career, one that spans 20 seasons.

His latest game winner brought him to within two of the all-time mark — held by NHL legend Gordie Howe who found the range for 121 game-winning scores over the course of his storied career. It also pushed him past former Bruins great Phil Esposito who is now third on the list with 118. And last, but certainly not least, he earned the game's number one star.

Thus, as the Devils closed the book on the October por-

tion of their schedule, he was the team's leading point producer with 3-7-10 totals.

This was a player that the Bruins didn't want to keep. My, oh my, oh my.

CAMPUS STROLLS — The big story continued to be Northeastern which opened at 5-0-0 for the first time since the 1988-1989 season. It was only the fourth time in school history that the team had gone that far into the season undefeated.

Even after a 6-4 loss at St. Lawrence that left NU at 5-1-0, the Huskies still managed to advance a notch upward in the U.S. College Hockey Online poll, moving up to 19th in the nation after being ranked in the 20th position the prior week.

Coach Jim Madigan's skaters are the ones to credit for the great start. It sounds simple but all they've done is put the puck in the net, having scored 30 goals in the first six contests, a hefty average of 5.00 goals per game.


Meanwhile, Hockey East newcomer Notre Dame continues to be ranked second in the nation in both national polls, having also achieved a 5-1-0 mark. The Irish had a start similar to Northeastern, posting a 5-0-0 mark before bowing 4-1 at Minnesota-Duluth. The Irish lead the nation in power play opportunities with 53. They've taken good advantage, currently being ranked second in the nation with 10 power play goals.

That's two behind UMass-Amherst which leads the nation in power play goals with 12, a big factor in that statistic being the Minutemen scoring on the man advantage four times in a pair of games against Maine up in Orono. However, those tallies didn't bring UMass success as they lost twice to the Black Bears (3-2 and 8-4).

In that second game, Maine scored six times in the second period, the first time the Black Bears have scored six goals in a single period since November 15, 2002 in a 8-2 victory over Northeastern. Maine also had two shorthanded goals and two power play goals on the weekend. The double setbacks left UMass with an overall record of 2-4, the worst start of any Hockey East team this season.

Turning to Boston University: when the Terriers lost 2-1 at the University of Michigan, it may have looked like a normal setback. But, in fact, there was a historic aspect to it. You see, in games where BU had allowed exactly two goals, they had been undefeated in 44 consecutive games at 39-0-5. That's right. The Terriers were unbeaten in the last 44 games where their opponents scored only two goals. The BU skaters scored three or more goals on 39 of those occasions. Guess they just needed a little incentive to find the scoring groove.
