Rand Paul Wants Dr. Fauci to Quit Fauci Basically Says Hell No

U.S. Senator Rand Paul (R-KY), blasted Dr. Anthony Fauci at a Senate hearing last week over gain-of-function research in Wuhan calling for his resignation. Paul grilled him on why he has repeatedly denied that the virus research was funded by the National Institute of Health (NIH) prior to the pandemic. Paul then said, "I think it is time you resign."

In response, Fauci said Rand was "egregiously incorrect in what he says." He also doubled down on the origins of the virus by saying, "It's much more likely that COVID-19 was a natural occurrence."

U.S. Issues 1st Passport with "X" Gender Marker

The United States has issued its first passport with an X gender designation, a milestone in the recognition of the rights of people who do not identify as male or female, stated the U.S. State Department.

The department did not identify the passport recipient but Dana Zzyym, 63, from Colorado said "they" received it. Zzyym who prefers a gender-neutral pronoun believes he shouldn't have to lie about gender by picking either male or female.

Zzyym stated, "I am not a problem. I am a human being. That's the point." According to a LGBTQ media advocacy organization, intersex, nonbinary, and trans reflect who they say they are.

Philly Pulls Cops Off Stops

Philadelphia will soon stop its cops from pulling over drivers for minor infractions on the road. Thus, making the City of Brotherly Love the first major U.S. city to enact so-called "driving while black" legislation.

The Driving Equality Bill passed a city council vote and could be signed, if not already, by Mayor Jim Kenney. This law would classify vehicular registration lapses, broken brake lights, and non-registration as a secondary violation, meaning police would be prohibited from pulling motorists over if these infractions are spotted.

This city move is aimed at easing tensions between police and the black community "while removing negative interactions that widen the divide and perpetuate mistrust," says a City Council statement.

However in Minnesota

Minneapolis voters overwhelmingly rejected a measure on November 2nd to have the city's police department removed and replaced by a Department of Public Safety. The measure was sparked by the death of George Floyd. However, most voters recognized that replacing the police with the Department of Public Safety would mean fewer police on the streets of the city. Most seemed to agree that ballot question would result in a failure to address rising crime across the city.

Mayor-Elect Michelle Wu Swearing-In

Set for Boston City Hall Council Chamber

Mayor-elect Michelle Wu's swearing-in ceremony will be held at noon on Tuesday, November 16th in the Boston City Hall Council Chamber.

"Given the shortened transition and the urgent challenges facing Boston, we're getting right to work on November 16th, said Mayor-elect Wu. "While we plan for a full inauguration with public events in January, alongside the Boston City Council, I'm thrilled to mark the quick start of our Administration with a moment in the City Council Chamber next week. Boston City Hall was designed to reflect transparency and a commitment to public service, and the work of building a Boston for everyone means empowering all of city government to move with urgency and build community."

After a brief oath of office ceremony, Wu will head to the Mayor's office on the other side of the 5th floor to get to work. The transition marks a full circle moment: she first started in city government as an aide to the late Mayor Thomas M.



Menino, working in the very same offices on the 5th floor that she will work in day to day starting November 16th.

As a City Councilor for nearly eight years, the Council Chamber holds special meaning for Mayor-elect Wu. During her tenure as Council President, Mayor-elect Wu led efforts to make the City Hall Council Chamber more accessible, including a comprehensive redesign that involved adjusting aisle widths, floor heights, and public lecterns to make them more functional for individuals facing barriers to mobility, as

well as making the Chamber more energy efficient. She also introduced video-conference testimony and advocated for closed captioned transcripts of meetings, to make it possible for people across Boston to learn about and participate in City Council meetings.

In the long-running debate about the seat of Boston's city government, the Mayor-elect has been a consistent champion of City Hall and its brutalist architecture, even inviting detractors on architectural tours of the building.

Mayor-elect Wu's swearingin will come two weeks after her history-making election on November 2nd, when she became the first woman and first person of color to be elected Mayor of Boston. More information about the swearing-in ceremony, including how people can watch live, will be announced in the coming days.




Stirpe Nostra

THE ROMAN BASILICA



The Basilica was a commercial exchange and a hall of justice. Much of it served as inspiration for the design of courtrooms up to the present day. The building was usually rectangular in plan, and twice as long as it was wide, with a semicircular section at each end which were called apses. The floor of the apse was raised and called the dais. This served to elevate the tribunal for the judges and assessors (archons and praetors).

A balustrade or rail separated the dais from the main part of the building. This main section contained two or sometimes four rows of columns that ran the entire length of the building. The center section was called the nave and the side sections between the columns were called the aisles. The Basilica usually faced the Forum with the main entrance doors at the front, or long side, and not on the

The Roman Basilica was destined to become one of the most important of all of the structures that they built and a direct link between Pagan Rome and Christian Rome. We know that Christianity was born in Judea and carried to Rome by St. Peter, St. Paul, and others. We also know that during the height of Roman power, little Christian bands started to form. These early Christians worshiped their own God and would not pay homage to the Emperors and they would not serve in the Roman Army.

The Christians were also charged with starting the fire that burned two thirds of Rome in 64 A.D. Because of these events, Nero banned Christianity and started the persecutions, which lasted for 250 years.

History claims that in the Year 312, the Emperor Constantine was engaged in battle at the Milvian Bridge in Rome, when he had a vision of the cross, which appeared in the bright midday sky. Along with this vision, there appeared a legend written in Greek, "By this sign, thou shall conquer." His subsequent victory moved Constantine to eventually stop the persecutions and adopt Christianity as the religion of the empire. The Christians were then permitted to occupy some of the temples, baths, and basilicas for the practice of their religion.

In time, they settled on the Basilica as the structure having the interior design, which most suited their needs. It follows then, if we seek the origin of our Roman Catholic Church structure, we should compare all of the interior features of our parish church with those of the Basilica. Examine the apse, the dais, the rail or balustrade, the altar, the columns, the nave and the aisles. Truly, here lies many of the roots of our church structure not the spiritual portion, just the structure.

JERRY FORTE ANSWERS HIS FINAL BELL

On November 2nd, All Saint's Day, one the greatest boxer's from the New England area, Jerry Forte, answered his Final Bell. His sudden passing took the wind out of all who knew the classy well-dressed gentleman who would go to the end of the earth for any friend or foe. He was an original North Ender and never forgot his Italian roots. He attended Don Bosco High School and ended up working for the State of MA as an auditor.

thought so, too.

From the first day that he walked up the steep set of stairs at the original New Garden Boxing Gym on Friend Street his mind set was to be the best and that he was. He was taken under the tutelage of the great Al Clementi who once told him (in my presence at an Italian American Sports Hall of Fame Dinner) that he always thought he would be the Bantamweight Champ of the World — I

At a Golden Gloves reunion back in 1991 Joe DeNucci told Jerry that he was the greatest, he defeated Ray Jutris, who was the greatest Lowell had to offer and later went onto box in the Pro Ranks and fight for the World Title. I remember saying Jerry was the greatest but I was only a ham and egger. Joe hit the ceiling and said "Mickey you were no ham and egger anyone who puts on the gloves and goes up those three steps is a boxer and don't forget that you were a boxer." I took his advice and never forgot — I lived with pride knowing what I did.

Forte's career in the Ring was what every boxer dreamt of. In 1962, he defeated the aforementioned Ray Jutris by a decision to capture the New England Golden Gloves Title and did that in Lowell, which was unique in its own way — not many Boston boxers got the decision in Lowell even if they won. By the way, he was an 8 to 1 underdog so that tells the story of Jutris. Jerry also took the NEAU and Diamond belt Titles along with the New England Traffic Club and the Mass State Championship Titles by going against some of the best around at the time. His sparring partners were all heavier weights than he was and in the professional ranks.

He summed up his career with a record of 33 bouts winning 30 and losing 3 fights that were

of a questionable decision. In 1995, he was inducted into the Ring 4 Hall of Fame for his contribution to the Sport of Boxing. Jerry served as a Deputy Boxing Commissioner and judged many fights in the State of Mass. I always said the only time he ever missed a fight was when there were two cards on the same night. He wasn't omnipresent.

A few years after his retirement I watched him go a couple of rounds against two guys who never boxed

but pushed him into letting them get in the Ring with him - a mistake on their part. Jerry did a number on both of them; in fact, Al Clementi stopped both encounters. I asked him afterward why he did what he did, his reply was typical Jerry, and I quote "Mickey, Boxing is my life, I worked hard to achieve what I did and no wannabe is going to say he went the distance against me." How sincere could one man be?

Buddy Ford, a boxer from yesteryear watched him spa one day at the Gym and was amazed at the talent Jerry had. He spoke often about how he controlled the Ring.

His Final reward came on September 12th of this year when he was awarded the Ring 4 All Time Amateur Boxer Silver Cup. At that time, he paid tribute to his idle Tony DeMarco for being a great influence on his life. Ironically, that moment would be the last either would be honored. Within a month, they both answered their Final Bell. God Bless and rest in peace brother — you were the man.

He was born in Boston, March 9, 1943, a son of the late Rosato and Inez (Tarquini) Forte and was raised in Boston and moved to Billerica 40 years ago.

Jerry was employed as an Auditor for the State of Massachusetts for over 20 years prior to his retirement.

Beloved husband of Betsy (Delgado) Forte. Besides his wife, he is survived by his daughter, Christina Forte-Maragioglio of Billerica; his grandchildren, Giana and Lorenzo Maragioglio and his brother, Robert Forte of FL.

Visitation was held Tuesday, November 9th, at the Sweeney Memorial Funeral Home, Billerica, MA. A graveside service was held Wednesday, November 10th at St. Michael Cemetery, Boston, MA.

A Special Day in the Heart of November

November, probably far more than any other month, embodies a multifaceted range of characteristics and qualities. One side of November encompasses the frenzied threshold to the holiday season. Advertisements set to the tune of tinny jingle bells or featuring a jolly, smiling Santa Claus overtake our television sets and billboards. Shopping centers are already wrapped in evergreen boughs and twinkling electrical lights. However, the other side of November remains its most immediately recognizable. This side involves the gray skies of early winter, the cranberrycolored leaves strewn across the ground as tree branches stand bare, the plaintive cries of geese streaking across the heavens as they migrate south. We are often in too much of a hurry to jump into the gaiety of the festive aspect of November that we forget to appreciate the month's unique beauty. November, in all its chilly and hushed glory, offers us a chance to reflect on the past, to ponder on our memories, to express gratitude for our loved ones and the blessings in life. November even contains a date that seems tailor-made for honoring the simultaneous somber and communal nature of the month. It is November 11th, a day which demonstrates to us all that is meaningful and powerful about this time of the year.

As a history teacher, I always try to bestow upon my students an appreciation for the sacrifice and dedication of the men and women in our armed forces, living and dead, past and present. I tell them that it is important to honor Veterans Day, the most well-known commemoration occurring on November 11th. Across Europe, Martinmas Originally called Armistice Day, blended religious significance

mark the anniversary of the end of the First World War, when peace was declared on the eleventh hour of the eleventh day of the eleventh month. Nowadays, this holiday functions as a reminder of the sacrifices our veterans, of all wars, have made on behalf of our country. Often, my veteran co-workers organize a school assembly that includes speeches by those who have witnessed the horrors of war firsthand, patriotic music by the school's band and chorus, and poignant recollections from veterans of all ages. This event endeavors to foster gratitude towards our brave veterans, and it is my hope that, hearing about warfare through the words of those who have experienced it, my students will be more likely to strive for peace. Veterans Day is also a solemn occasion, honoring the men and women who died in the line of duty. This fits into the very history of November, a month that ancient Europeans distinguished as a time to commemorate the dead. When vegetation withers and the air turns gray and cold, our minds wander to thoughts of mortality and memory. This Veterans Day let us keep the sacrifices of all our veterans forever in our minds and let us offer thanks for the freedoms they protected and enabled. Moreover, let us always ensure that this sense of honor and gratefulness for our military does not end on Veterans Day, but continues all year long.

November 11th also holds a European festival celebrated since the Middle Ages. St. Martin's Day, commonly known as Martinmas, honors the fourth-century French bishop St. Martin of Tours. Veterans Day began as a way to with agricultural importance,

vest season and the beginning of winter. Martinmas celebrations boasted feasts of seasonal foods and boisterous family reunions. In Central Europe and Scandinavia, people dine on goose, often stuffed with the autumnal chestnuts. This meal commemorates a well-known legend about the humble St. Martin, who supposedly hid in a goose pen when he was reluctant to receive the position of bishop. In Germany and the Netherlands, costumed children collect sweets and coins in lantern-bearing processions, while people in Poland enjoy croissants filled with poppy seeds and almond paste. Italians celebrate Martinmas, or il Giorno di San Martino, by sampling the year's new wine. One of my father's favorite proverbs was "San Martino, si fa il vino", meaning that wine is made on St. Martin's Day. Another proverb, "San Martino, castagne e vino," states that chestnuts and wine can be expected at Italian Martinmas celebrations. These proverbs reveal the Italian affinity for seasonal delicacies and traditions hearkening back to olden agricultural days of society. I always make pumpkin gnocchi, from the inimitable book Festa by Helen Barolini, and bake a cinnamon-swirl bread for Martinmas. As the scent of warm spices like nutmeg permeate my cozy kitchen, I cannot help but feel a special connection with my Italian ancestors who battled the darkness of the encroaching winter with communal meals and the love of family. Martinmas is a special November feast precisely because it embodies all the varied aspects of the month: it reflects on the harvest and the start of winter, but it also presages the joyous goodwill of the holiday season. November brims with many

delights and much symbolism, even though many people view it as nothing more than a stepping-stone to December. However, November can be the most rewarding of months if we recognize its wondrous details. The wintry sights of red and brown leaves dancing across a cloudy sky and the yellow burst of an early sunset encourage us to reflect on the cycle of the year as the current one draws to a close. Cold, dark evenings beckon us home to the loving embrace of friends and family. November 11th is a date which allows us to ponder the meaning and the pleasures of this month. 



Eligius developed a close friendship with the King and his reputation as an outstanding metal smith became widespread. With his fame came fortune. Eligius was very generous to the poor, ransomed many slaves, and built several churches and a monastery at Solignac. He also erected a major convent in Paris with property he received from Clotaire's son, King Dagobert I.

After the death of Clotaire (Continued on Page 10) (629), Dagobert appointed



Eligius his chief councilor. The fame of Eligius spread rapidly, and ambassadors first paid their respects to him before going to the king. His success in inducing the Breton King, Judicail, to submit to Frankish authority (636-37) increased his influence. Eligius took advantage of this to obtain alms for the poor and to ransom Roman, Gallic, Breton, Saxon,

and Moorish captives, who were arriving daily at Marseilles. He founded several monasteries, and with the king's consent sent his servants through towns and villages to take down the bodies of malefactors who had been executed, and give them decent burial.

On the death of Dagobert (639), Queen Nanthilde took the reins of government, and Eligius and his friend Dado left the court.

Eligius later fulfilled his desire to serve God as a priest, and was ordained in 640. The death of Acarius, Bishop of Noyon-Tournai, May, 13, 640, Eligius was made his successor with the unanimous approbation of clergy and people. The inhabitants of his diocese were pagans for the most part. He undertook the conversion of the Flemings, Antwerpians, Frisians, Suevi, and the barbarian tribes along the coast.


Eligius passed away on December 1, around 660, at Novon. He is the patron of metalworkers, Coin Collectors and horses. His feast day is December 1st.

Nanna & Babbononno

A Nostalgic Remembrance



MUSIC-MUSIC-MUSIC

Babbononno came to America with the Royal Italian Marine band. From the time of Thomas Jefferson's presidency through the years of Harry Truman, an Italian Marine band serenaded the leaders in Washington once per year. My grandfather was part of that band that came here in 1896 to serenade President Grover Cleveland and his administration.

While in Washington, Babbononno received a cable from the Reuters Service that his wife had died in childbirth. He was devastated and resigned from the service and remained in Washington after the band went back to Italy. There was nothing in our nation's capital for an Italian who couldn't speak English and him, hearing that there was an Italian population in New Orleans, headed south. He had no luck there and headed north again, this time stopping in New York. He was overwhelmed with the Big Apple and headed north to Portland, Maine, then an outpost of civilization. Hearing that there was a friendly Italian community in Boston, he headed to the city's North End.

After establishing himself and making a few connections, he utilized both of his skills to earn a living. He became a furniture maker by day and a musician by night. Babbononno played drums and guitar. He played the snare drum in marching bands and for concert bands that catered to Boston's Italian community. As a guitarist, he hooked up with a dance band that played for Italian functions: weddings, baptisms, engagement parties, first communion parties, family reunions and neighborhood dances.

Around the turn of the 20th century, he met the woman who would become his new wife (Nanna), and together, they would produce four children. Unfortunately, one would pass away before he was three. He and Nanna next sent for his two children that were left motherless but living with Babbononno's mother, my great-grandmother, Maria Contini.

From early on, my grandfather taught his sons to read and understand music. His oldest, Paul, and middle son, Nick, both studied clarinet. He wanted them to become concert musicians. When they were of age, they secretly bought saxophones and learned the pop music of the day, which Babbononno hated. When his youngest son, Louis (Uncle

Gino) was of age, he taught him to play drums. Paul would specialize in Dixieland music, Nick became one of the top society band saxophonists in Boston and Uncle Gino gave playing drums just lip service.

Their sister began dating a bass player in the early 1930s and married him in 1936. She would become my mother and the bass player, my father. Angelina Contini and John De Cristoforo would produce only one son (me) and with a father who was a musician, three uncles who were musicians and a grandfather who was a musician, I didn't stand a chance of escaping from anything connected with music.

I tried just about every instrument and rejected them all. As a young child, I had been taught by Babbononno to read music and tried to learn accordion. Drums came next, then clarinet, saxophone, trombone and piano, but I rejected them all. I did learn how to play the bugle and became part of the drum and bugle corps of my junior high school, the Barnes in East Boston. The bugle led to the trumpet, which I tried playing in high school. This instrument I liked, but I hated practicing, and with little time on my hands, the trumped began to collect dust. Sports, hanging out on a street corner and working at the Seville Theater seemed to occupy all of my time, but there was a light at the end of the tunnel. When I turned 17, I asked Dad to teach me his instrument, bass violin.

I loved studying bass and found the time to practice a few hours every day. When I hit 18, I turned professional added in bass guitar. I learned to play everything from symphony to soul, and have been doing it now for 65 years.

My dear wife, Loretta, gave birth to two sons who became jocks in their formative and teen years. First, there was baseball and then basketball. John rejected anything related to music, but Michael studied piano. I brought home a friend, Julio Gianotti, who was a professional pianist as well as a teacher, and he gave my youngest son lessons on the instrument. After about a year, Michael was sitting at the piano with his baseball cap on sideways and his infielder's glove sitting atop the piano. In frustration, he said to me, "Dad, you've heard me play piano and seen me play baseball. I can't do both ... which should I do?" I handed my son his glove and

dismissed him from the piano. He would make it all the way to the minor leagues, but that's a story for another day.

On their own, both boys learned guitar. Son John has a feel for jazz and a knack for it. This is something you can't be taught. I think the feel for music is a gift you are born with, but I don't want to get philosophical. I had an extra bass guitar and recently brought it over to John's house. It is a clone of a Fender Jazz Bass but it just wasn't being used any longer. We were at John's for dinner the other night and I used an electronics cleaner to clean up the pickups and wires and then tried out the instrument to make sure it was working correctly.

While I was walking my fingers over the strings to see if the sound was there, I suddenly heard a guitar playing along with me. I looked up in surprise to see John joining in to become half of a father and son duo. This was the first time either of my sons and I did anything musical together.

I never worked with Babbononno. He had retired from music when I was a child. I did a few jobs with Dad, but only band concerts where I played bass and he played tuba, and a couple of times when he was on bass and I was the band leader. I did a few jobs with Uncle Paul over the years, but did work quite a bit with Uncle Nick for some of Boston's dance bands.

So, with son John representing the 4^{th} generation of the Contini/Christoforo family, we played music together. Babbononno, Dad and my uncles are all long gone. But, I bet if they were still around, they would be proud of my boys. We will all be together for Thanksgiving and I will make sure that my sons bring their guitars with them to play with me either before or after the turkey is served. (Michael, in his spare time, has taught himself how to play guitar.) If this happens, maybe from somewhere beyond, Babbononno, Dad and my uncles will listen in to their 4th generation of family musicians ... who knows.

Though it is highly unlikely you will ever find "meatloaf" on the menu of a restaurant in Italy, here in the United States it has earned its place as being one of the ultimate comfort foods. For this reason, you'll find that many Italian immigrants over the years have created their own Italian version of this so-called meatloaf. Some Nonna's use a combination of meats such as pork, veal, and beef, while others simply use just beef and many make theirs the same way they make their *polpettes* or meatballs. Could be because in Italy, *polpettte* are not served with pasta as they are here in the states, they are instead found on the menu as a separate main course.

My Nonna told me that she never made meatloaf when she was in "the old country." However, when living in this country, she made her own version, and it is no surprise that it turned out to be a delicious cold weather meal that the entire family loved. Nonna made her meatloaf almost identical to how she made meatballs for her Sunday sauce. She used ground beef and mixed it with homemade breadcrumbs that were seasoned with parsley and freshly grated parmesan cheese. She then stuffed it with whatever she had on hand, from prosciutto and cheese to sometimes, even just hardboiled eggs. I am sharing my favorite version of "Polpettone di Nonna" or "Nonna's Italian Meatloaf" and not only is it quick and easy to make, but it's also the perfect heartwarming cold weather meal to enjoy alongside of baked carrots and potatoes, with family or friends!

NONNA' S ITALIAN MEATLOAF Polpettone di Nonna



2 pounds ground sirloin
2 ½ to 3 ½ cups homemade
breadcrumbs seasoned
with parsley and grated
parmesan (can use store
bought Italian seasoned)
2 to 3 large eggs, beaten well

Salt and pepper to taste
½ to 1 cup freshly grated
parmesan cheese (optional)
½ pound prosciutto
½ pound fontina or mozzarella
cheese

Preheat oven to 350 degrees. Line a deep 18×13 -inch baking pan with parchment paper. Brush generously with olive oil, set aside.

½ cup olive oil

In a large bowl, combine ground sirloin with $2\frac{1}{2}$ cups bread-crumbs, add eggs and mix together with your hands. Add additional breadcrumbs as needed to make a mixture the same consistency as you would for meatballs. Add salt and pepper to taste and some additional grated parmesan if you would like. Take this mixture and make it into a large rectangle shape. Layer the prosciutto then the cheese on top of the meat, and fold it into a long oblong shape, tucking in and sealing the meat together well, so the prosciutto and cheese will stay inside while cooking. Carefully place this meatloaf into the prepared baking dish. Cover well with aluminum foil (must cover) and bake for about 1 to 1 $\frac{1}{2}$ hours, or until a meat thermometer inserted in the center reads 165 degrees.

Note: You can also (as my Nonna and I do) cut up carrots and potatoes, toss them with olive oil and salt and pepper, and place them around the meatloaf. They will cook beautifully alongside of the meat.

When You Remember Ray Fosse, You Always Remember Pete Rose, Too

I didn't want to forget to mention the recent passing of a former two-time All-Star baseball catcher who passed away back on October 14th. Fosse was a strong-armed catcher whose career was upended when he was bowled over by Pete Rose at the 1970 All-Star Game. He was 74, and been battling cancer for 16 years.

Fosse was a budding talent for the Indians when he made his first All-Star Game at age 23 in 1970, the year he hit .307, 18 homers and won the first of two Gold Gloves, throwing out 55 percent of those who tried to steal a base from him.

A bad case of fate hit him in the 12th inning of that All-Star Game at Cincinnati's Riverfront Stadium. Rose barreled over Fosse scoring the winning run, but he fractured and separated his left shoulder. In 2015, he



HOOPS and HOCKEY in the HUB

They are at every practice; they can be seen at every game. But most are not known to the

They are the silent ones. The ones who never give press conference. They are the assistant coaches of the Boston Bruins.

As the season leaves its early October beginnings and starts to take on a more mature status, we thought it might be a good idea to present the backgrounds of various assistant mentors that are often seen but rarely heard. We will start with Joe Sacco and go forward with additional ones in the coming weeks.

Joe Sacco, who is now in his seventh season with the B's, came home to join the Bruins staff. Growing up in Medford -only a few transit stops away from the Garden -- he played for Medford High School. During his junior and senior years he put up 114 points across 51 games.

That got him a lot of attention. But he didn't have far to travel to play for one of the best college coaches in America. Jack Parker was just a few miles away at Boston University. Unlike a number of talented players today, Joe played all four years (1986-1990).

That means that as a collegian he played against the man who is now his boss, Bruins general manager (and Harvard alum) Don Sweeney, not only in the Beanpot but a number of times during his pro career as well.

Sacco was drafted by Toronto in 1987 (71st overall) and began playing for the Maple Leafs during the 1990-1991 season. Over his career, he was an NHL journeyman, moving from Toronto to Anaheim to the New York Islanders, then on to Washington and finally Philadelphia. He finished with 94 goals and 119 assists across 738 games.

But when one door closes, another often opens. Thus it was that Joseph William Sacco joined the Colorado Avalanche organization as the head coach of the American Hockey league affiliate in Lowell and later Albany before being named the bench boss in Erie (PA).

All that experience meant that he was an NHL coach in waiting. And it looked like he would wait a while longer after the Avs dismissed Tony Granato (now the head coach at the University of Wisconsin) during the summer

That's because Patrick Roy, the retired all-star goaltender for the Montreal Canadiens, was first in line for the position. But he turned the Avs down.

Thus Sacco was back in the NHL as a head coach. Over the course of four seasons under his direction, the Avs certainly had their difficulties.

But not at first. In Sacco's initial campaign Colorado finished the regular season with a highly respectable 95 points (43-30-9, second in the Northwest Division). He was a finalist for the NHL's Jack Adams Coach of the Year award.

It was mostly downhill after that with Colorado not advancing to the postseason during the final three years of his tenure in Denver.

And maybe, Colorado was a good team in the wrong conference. Over a three-year stretch, Sacco led Colorado, a Western Conference team, to a 33-14-7 record against Eastern Conference opponents.

The high point in Sacco's career as a coach thus far has to be the 2019 playoffs that saw the B's advance to the Stanley Cup Final before losing to St. Louis. So close to having one's name etched on hockey's holiest hardware.

A new NHL team — the Seattle Kraken -- meant additional jobs. Sacco reportedly interviewed for the Kraken head coaching position that eventually went to Dave Hakstol, the former University of North Dakota and Philadelphia Flyers mentor. Others in the mix included former Tampa Bay and Arizona coach Rick Tocchet and David Quinn, who lost his job with the New York Rangers last spring and was formerly the head coach at BU.

BEFORE THE CURRENT BRAD THERE WAS ANOTHER **BRAD** — Brad Marchand, just move over for a bit while we discuss another player from a different era — Brad Park.

Brad Park came to the Hub just as the storybook era of the early 1970s Boston Bruins was ending. But in doing so he was able to redefine another era that continued into the early 1980s.

In this region, those of a certain age immediately identify him as a Bruin, one who came to the B's via a November trade with the New York Rangers back in 1975. A player sent along with Park was also an accomplished performer — Jean Ratelle, the leading scorer for the Rangers during the 1971-1972 season. Their arrival also meant some departures from Boston to NYC, in this case Phil Esposito and Carol Vadnais.


Park, a defenseman, had played seven seasons for New York prior to the trade and had faced the B's numerous times. If there was a showdown match between the two rivals it took place at the 1972 Stanley Cup Final, which was won by the Bruins.

In a New York Post article on November 7th, Park admitted that he cried when he first learned that he would be dealt to Boston. In that regard, he foreshadowed another player, Joe Thornton, who cried in his car in 2005 after being told that he would be moving from Boston to San Jose.

Park settled into his new Hub surroundings and was a major factor in leading the Bruins to the Stanley Cup Final in both 1977 and 1978. Esposito did the same for the Rangers in 1979. The common opponent was Montreal — and all three times Montreal captured the Cup. As for Thornton, now with Florida, he did just fine with San Jose.

Park continued to play for Boston until 1983, forming a formidable tandem in the B's back end with newcomer Ray Bourque. He later played one year for Detroit before retiring in 1984. He was inducted into the Hockey Hall of Fame in 1988.

Park is held in high regard in both New York and Boston. As a Bruins player, Park moved to the North Shore of Massachusetts. Now 73, he continues to live there while also owning a vacation home in Maine. He and his family never moved back to the New York metropolitan area.
