#### CHARLESTOWN ANNUAL VETERANS' DINNER

Once again, all Charlestown veterans and those presently on active duty, family and friends packed the Knights of Columbus on Medford Street last Friday, November 7 at the 2nd Annual Veterans" Dinner sponsored by the Abraham Lincoln Post 11, GAR. This annual pre-Veterans Day appreciation dinner is held to honor all who served in the Armed Forces. It was 96 years ago on the 11th hour of the 11th day of the 11th month, that World War I came to an end and hundreds of thousands of American soldiers began the long voyage home. This year, in the months to come many of our troops will be coming home and sadly many others will be going off to harm's way leaving their loving families behind to defend American principles.

As a Vietnam era U.S. Air Force veteran, I remain especially cognitive of the lack of appreciation and honor due to them when they returned from the war which had grown quite unpopular at home in the U.S.

This feeling of being unrecognized was aptly portrayed in the poem "Coming Home" by Bill Ehrhart who served as a Marine sergeant in Vietnam back in 1967-68. In this poem he wrote a very sad and descript scene of his invisible arrival in San Francisco at the end of his tour of duty in 1968:

#### "COMING HOME"

"No more corpsmen stuff, Ruptured chests with cotton balls and not enough heat tabs to eat a decent meal. I asked some girl to sit and have a Coke with me. She thought I was crazy; I thought she was going to call a cop. I bought a ticket to Philadelphia, at the loading gate they told me, "Thank you for flying TWA. We hope you will enjoy your flight. No brass bands; no flags, no girls, no cameramen.

Only a small boy who asked me what the ribbons on my jacket meant."

Today, in America, coming home means something again. What happened back then should never be repeated again.

# **BOSTON EVENT COUNCIL ESTABLISHED** AMIDST CONTEST FOR OLYMPICS

The International Special Events Society (ISES) recently hosted a presidential meeting of the minds to establish an event council for Boston. This call to action was necessary with the city vying for a bid at the 2024 Olympics. This meeting of event organization leaders included representation from the six major associations in Boston: ISES, Boston Wedding Group (BWG), Meeting Planners International (MPI), National Association of Catering Executives (NACE), Greater Boston Convention and Visitors Bureau (GBCVB) and Hospitality Sales and Marketing Association International (HSMAI).

As a group, it was decided that in order to positively effect change in Boston, they will meet frequently to discuss the economical standings in the city, representing the 2,000 + collective members of hospitality providers. General topics that were discussed included the Olympic 2024 Bid for Convention Center Authority (MCCA.)

Boston, Boston Venue and Hotel Expansion, Cal 133 and Boston Fire Codes. Lisa Santoro, ISES New England President, explained, "with the planned expansion of the Boston Convention and Exhibition Center in the next few years, we must add more hotels and large venues to accommodate the larger conventions and tradeshows coming into our city. If the Olympics come to Boston, the city must create and build temporary and permanent building structures. With our need for more hotels and large event venues, the Boston Event Council will have the opportunity to have a voice in what structures stay and become places for events to take place permanently."

A tentative meeting has been set for December, adding in representatives from the Professional Convention Management Association (PCMA) and the Massachusetts

# Stirpe Nostra

#### **BIRTH OF THE GODS**

One essential difference between Greek and Roman mythology is the extent to which their family trees were developed. Greek mythology lists at least eight Primeval Beings as the forerunners of the Titans, and at least twenty-one Titans who were the forerunners of the gods. Generally, Roman mythology identifies only one Primeval Being and six Titans. The balance of the mythological families appear to be about even in both cultures, with close likenesses in many of the gods and demigods.

During past issues we have discussed the legends surrounding the development of the Primeval Beings. We also discussed the Titans; who in some instances were the fathers of the Gods. This week we are ready to discuss the mythological Gods themselves. They are divided into two distinct groups; (a) Primary Gods, and (b) Secondary Gods. The six Primary Gods are the offspring from the union of the Titans Cronus and Rhea, while the Secondary Gods are the offspring from the union of Zeus (Jupiter) with other Goddesses.

The story surrounding the birth of the Primary Gods is quite interesting. It tells of Cronus, the Titan, being warned that someday he would be dethroned by his offspring; consequently, he swallowed his first five children at birth. When Zeus was born, a great stone was

wrapped in swaddling clothes and presented to Cronus in place of the sixth child. This bundle was quickly swallowed by Cronus, thinking that all was proceeding according to plan, and that he was avoiding all possibility of his downfall.

The infant Zeus was taken to the Dictaen cave in Crete where he was nursed on honey and goat's milk. When fully grown, Zeus gave one of the goat's horns to his former nurse, along with a promise that she would always find in it whatever she wished. This is now called the "cornucopia" or the horn of plenty. Later, after the nurse died, Zeus placed both the horn and the goat among the stars.

Zeus eventually succeeded in getting Cronus to drink a potion which contained a powerful emetic. This caused the great stone to become disgorged and it was followed by the five brothers and sisters of Zeus, who had previously been swallowed. These other deities are known today as Hestia, Demeter, Hera, Hades, and Poseidon. Zeus was known to the Roman as Jupiter, and those brothers and sisters were known as Vesta, goddess of the hearth; Ceres, goddess of agriculture; Juno, wife of Jupiter; Dis, God of the underworld and Neptune, God of the sea. In time all of these Primary gods banded together in support of Zeus, to wage war against the Titans. After the Titans were defeated, the world was divided into three parts; Hades took the lower world; Poseidon (Neptune) took the sea, and Zeus (Jupiter) took the heavens. The earth was reserved as the common possession of all three. Regardless of the division, Zeus remained as king of the Gods, greater and more powerful than all of the other Gods combined.

#### North End and East Boston Delivered for Charlie Baker

In the election for governor earlier this month, Republican Charlie Baker won, narrowly, statewide and in the City of Boston outperformed most Republican candidates of recent years, getting 30% of the vote in a Democratic stronghold.

Baker won three Boston neighborhoods, including the North End and nearly won in a few others, including the historically Italian-American neighborhood of Orient Heights in East Boston.

Here's a breakdown of the neighborhoods in which Baker did better than his 30% city-wide average.



On Wednesday, November 5<sup>th</sup>, the ABCD North End/ West End Neighborhood Service Center (NE/WE NSC), part of Action for Boston Community Development, Boston's largest anti-poverty agency, celebrated Family Literacy Month and held an event to honor Helen Bender, Librarian, West End Branch of the Boston Public Library, and Susan Voloshin, Librarian, North End Branch of the Boston Public Library. A festive brunch, including pastries, sandwiches and coffee was held to mark the day. Students from their advanced English for Speakers of Other Languages (ESOL) class attended, along with their staff, volunteers, seniors and other community members were in attendance.

Their neighborhood service center provides educational and social services to the elderly, families, immi-

grants and anyone in need. They run an ESOL program that serves students from 13 countries and spans three levels — beginning, intermediate and advanced. As parents are the first teachers of their children, they wanted to continue with Governor Deval Patrick's commemoration of November as Family Literacy Month, and to introduce the students and community members in attendance to all that the library has to offer.

Susan Voloshin of the North End Branch of the Boston Public library has helped many ESOL students at the NE/WE NSC to obtain library cards and museum passes, and other resources for assistance. In addition, she has donated many books to their ESOL program. Many of their seniors use the library to peruse the Italian language collection. Susan is an active member of their

#### IS THERE REALLY ANY GREAT NEED FOR A **MATTAPAN HIGH SCHOOL IN 2014?**

For almost 20 years now, City Councilor Charles Yancey seems to have been on a crusade pushing the need for a Mattapan High School. Recently, the City Council at a hearing tabled this motion reportedly to work on other city councilors and the mayor's office on the merits of his new school idea for Mattapan. Yancey stated, "There is no question we need it, but I'd like it to be a unanimous vote."

Many, me included, do have questions about Yancey's proposed new high school, which is probably why the idea was tabled recently at the City Council. The idea for a Mattapan high school has been hanging around since 1995 and over the years the BPS student population has been decreasing and recently the iconic South Boston High School was shuttered by the School Department due in part to a dip in school population. This Mattapan school project is projected at \$120 million and would be built on the grounds of the old Boston State Hospital, but over the years with a shrinking student population this project may no longer be relevent.

I believe at the moment the city is currently creating a ten-year plan for school buildings and while interim Supt. John McDonough says he isn't closed to the idea but sees it as a part of a broader plan that includes school closings as well.

The news that the Henderson Inclusion School in Dorchester (the former Patrick O'Hearn School) has begun its own 5-year plan to expand to a full pre-K to 12 school. The Henderson along with the former Woodrow Wilson School (which will house upper classes) may mean the death for another high school in Boston at this time or in the foreseeable future.

Yancey will have to justify the actual need for the spending of \$120 million that could be used to improve conditions in other schools, such as the new pre-K-12 high school in Dorchester.

It may have made sense back in 1995 when first proposed, but sometimes a good proposal simply runs out of time. The clock may simply run out on Mattapan High School.

#### The History of Animation: Cartoons Go to War



WWII affected Hollywood even before the United States became involved. Chaplin's *The Great Dictator*, the Three Stooges' You Nazty Spy! and I'll Never Heil Again hit theaters before Pearl Harbor. Walt Disney was wary of Hitler's rise but it's telling of Hollywood's oblivion in the '30s that Disney didn't publicly condemn the Chancellor until Hitler insulted his Mouse.

It could be argued that the first point of impact the War had on the American animation industry was when the Day of Infamy took the cover of TIME Magazine, pushing out a planned feature on Dumbo. From that point on, war themes took over the animation units all the major studios. Dumbo itself was one of

the first cartoons to reference the war (before the U.S. got involved). In the finale, when the little elephant's big ears become a sensation, the United States Air Force takes notice and designs a war plane based on them.

The United States government saw the Walt Disney Studio as the most influential of the cartoon factories and pressured Disney stronger than the rest for propaganda shorts. Disney and his animators (still calming down after the bitter strike of 1941) set quickly to work producing shorts for various branches of the U.S. military, putting on hold other projects then in production ("Peter and the Wolf," which would later be an episode of the compilation film Make Mine Music, Peter Pan, and an elaborate version of Alice in Wonderland combining liveactors and cartoons that never came to be). Given the abruptness of this interruption from the geopolitical world, the rush put on the production of these films, and the lack of commercial interest Disney undoubtedly saw in them, it's truly surprising how well produced they are and their wide appeal. Artistically they are as good as any short Disney produced during the Golden Age of Animation, adding an another layer to some of his biggest stars. Most of the cartoon cast got to do their part for the war effort including Goofy (Victory Vehicles and How to Be a Sailor) and Pluto (Private Pluto and The Army Mascot) but, without a doubt, Donald Duck was Disney's biggest weapon in helping the Allied cause. The Army shorts are some of the Duck's funniest. Start-


ing with 1942's Donald Gets Drafted, The Vanishing Private and Sky Trooper, Fall Out Fall In and The Old Army Game the following year, and finally 1944's Commando Duck which sent our feathered friend to Japan on a secret mission where he becomes a hero by accidentally washing out an airfield. Donald proved so powerful an icon for the war effort that Disney used him as spokesperson for his Treasury Department shorts The New Spirit and its sequel The Spirit of '43. But the Duck's ultimate statement was the Academy Award winning cartoon of 1943, Der Fuehrer's Face, a surreal, funny, but also biting satire of the Third Reich in which Donald has



a starved and abused citizen of a menacing Totalitarian state.

Some of Disney's war shorts were far darker in spirit, however, starting with the somber Education for Death: The Making of the Nazi (a harrowing attack on the Hitler Youth) and Reason and Emotion. His ultimate accomplishment, however, was a most unusual feature film titled Victory Through Air Power a light but fascinating semi-documentary about the history of aviation and the role it played in WWI and in the present war. After the war Disney saw no commercial value for the film and kept it off circulation for decades (save a few scenes spliced into his television show in the '50s) until it was finally released on DVD in 2004.

Even outside of the propaganda films, Disney used the war for background themes in such shorts as Donald's Tire Trouble and Home Defense (also starring the Duck and his three nephews). The best thing Disney got out of participating in the war effort was a tour of Latin America as part of the Roosevelt Administration's Good Neighbor Policy. From this south of the border journey came two innovative feature films, the episodic Saludos Amigos (1943) and The Three Caballeros a dazzling and inventive travelogue of Latin America with Donald Duck as a tourist, enhanced by an unforgettable soundtrack with a Latin beat. The Three Caballeros proved something of a milestone for Disney even after the war as its combination of live actors with cartoon charac-



ters proved revolutionary for 1945 and led to many other attempts beginning with the following year's Song of the South. Aside from these two features, the trip inspired several shorts including Pluto and the Armadillo, Clown of the Jungle, The Pelican and the Snipe as well as two new popular characters, Jose Carioco, a Brazilian parrot and Panchito the Mexican charro rooster.

Elsewhere animation studios were also doing their part for our fighting men. Warner Bros. probably produced the most of them, many with all new characters or caricatures of political figures including Russian Rhapsody in which gremlins sabotage Hitler's aircraft and

The Ducktators where the despots of the war were caricatured as ducks. Of course, Warner's main stars did plenty. Bugs Bunny, curiously did only two direct mockeries of our enemies abroad. One is the very funny Herr Meets Hare and the other is the now rarely seen Bugs Bunny Nips the Nips. But Bugs

a nightmare where he is did appear in a musical morale booster (Any Bonds Today?) and references to the war appeared in many of his cartoons such as The Unruly Hare and his own match with a gremlin in Falling Hare. As in Disney, however, it was the duck star that appeared in most of the war shorts. Like Donald Duck's, Daffy Duck's war cartoons are some of his best, especially Scrap Happy Daffy and Daffy the Commando. The most original of them was Plane Daffy where he takes the role of a messenger pigeon and outwits a seductive Nazi spy.

Disney and Warner were, of course, the biggest players but every studio did their part. Paramount sent Popeye on The Mighty Navy and then in Fleets of Stren'th. The most successful was Tex Avery, now finding a new beginning at M-G-M cartoon studio after his bitter departure from Warner Bros. His 1942 effort for his new home, The Blitz Wolf (a parody of The Three Little Pigs and a gag on Hitler) was nominated for an Academy Award.

WWII changed the course of animation along with history and the world. But, animation, like all art, triumphs even during our darkest hours and when we needed them most these geniuses of animated drawing gave us laughter and hope.

# Simple TIMES...

Their names you never read until today. Their faces not seen since 1918. Why? Because the boys of St. Mary's Parish in Brookline went to fight and die in The Great

November honors the Armistice (Veterans Day) that ended The Great War in 1918. And this year commemorates the 100-year start to that awful conflict that caused 14 million deaths of soldiers and civilians. A dread, prior to 1914, never imaginable in any war in history.

Known today as St. Mary of the Assumption Church, I first read the bronze tablet upon a noon Mass two months after September 11, 2001. The young American soldiers' names took on heartfelt meaning to me as their worthiness remains a powerful reminder of a war still recalled 100 years later. I have honored them by reading their names before or after every Mass I attended the past 13 years.

After the noon Mass on Election Day last week, I knew I must share their story in my writings and jotted down their names. They are: Timothy B. Sullivan, Patrick J. Dunn, Martin Crowe, Norbert J. Rigby, James F. Cromie, George P. McGillan, Hugh C. Blanchard, John P. Duggan, Charles W. McCarthy, Joseph J. Waters, Matthew J. Rey, John J. Campbell, Robert J. Palmer, John C. Malloy, Henry J. Devaney and Stephen Rutledge.

At the bottom of the weathered bronze tablet resting on the wall to the left of the large oak doors to St. Mary's entrance, an inscription brings a touchstone to suffering: "Gift of the Catholic Women Altar Society. The Boys' of St. Mary's Parish Who Made the Supreme Sacrifice in The World War. The Rev. P. Sheehan who died Feb. 13, 1918."

The wonderful women of the Catholic Women Altar Society are everybody's mother, sister, aunt, wife, friend, grandmother, and neighbor who have lost a dear soldier to the horrors of war.

For the millions of Europeans who lived through the hell that visited their soil the name they gave it forever remained The Great War. Named World War One after the end of World War Two in 1945, "the war to end all wars" became a common slogan. Yet one author, who

published a book in January to commemorate the centennial of The Great War, entitled his tome *The War That Ended Peace*.

Now Americans and foreign folks alike are united anew in a seemingly endless war to eradicate evils known as ISIS, Taliban, and Al Qaeda. We live in a peculiar time. Wars rage in 40 nations. Our sisters and brothers — young and old alike — are senselessly slaughtered. They are indeed our sisters and brothers as we all inhabit the same planet.

I feel a connectedness to the "boys" of St. Mary's who left the loving security of their families, parish, neighborhoods and hometown to fight and die so that people they never met may live free from tyranny. My paternal great-uncles — George A. Plante and Louis J. Plante — fought in The Great War. They were fortunate to return whole and alive to their loved ones in Waterville, New York. They died in their '70s a few years prior to my birth in 1959.

I also devoted my May column to a deceased neighbor, Joseph Mazza, an Italian immigrant who fought with New York's Fighting 69<sup>th</sup> Infantry. His stories of The Great War still resonate with me and my six siblings

As we reflect decades after the start of The Great War, a poem written by Canadian Major John McRae, "In Flanders Fields," vividly reminds us of the sad tribute to his friend who died in battle in May 1915. McRae saw striking red field poppies amidst mass destruction. The poppy flower grew to a worldwide significance of Remembrance:

"In Flanders Fields the poppies blow Between the crosses, row on row, That mark our place; and in the sky The larks, still bravely singing, fly Scarce heard amid the guns below. We are the Dead. Short days ago We lived, felt dawn, saw sunset glow, Loved and were loved,

and now we lie in Flanders Fields."
Hail, Boys of St. Mary's! Hail to their fellow comrades of that century-old conflict, as well as to all the soldiers and civilians of the wars that followed! Their sudden end to life is worthy remembrance today and forevermore in hope that war ceases as a tool to peace.

# Saint Hugh of Lincoln

Hugh was born about the year 1135 at Avalon Castle, near Pontcharra, in Burgundy. His father, William, Lord of Avalon, descended from a noble Burgundian family, very little is known about his mother, Anna. After his wife's death, William retired from the world to the Augustinian Monastery of Villard-Benoît, near Grenoble, and took his son, Hugh, with him. Hugh became religious and was ordained deacon at the age

While visiting the Grande Chartreuse monastery with his prior in 1160, Hugh decided to become a Carthusian and was ordained. After ten years, he was named procurator and in 1175 became Abbot of the first Carthusian monastery in England. It was situated in Somerset and had been founded by Henry II in compensation for his having failed to go on the crusade imposed as a penance for the murder of St. Thomas Becket of Canterbury.

There were difficulties in building the new monastery, the first prior was retired and a second soon died. It was by special request of the of vacant bishoprics, including that of Lincoln. On May 25, 1186 the cathedral chapter of Lincoln was ordered to elect a new bishop and Hugh



English king that St. Hugh, whose fame had reached him through one of the nobles, was made prior.

In May 1186, Henry summoned a council of bishops and barons at Eynsham Abbey to deliberate on the state of the Church and the filling of vacant bishoprics, including that of Lincoln. On May 25, 1186 the cathedral chapter of Lincoln was ordered to elect a new bishop and Hugh

was elected. Hugh refused the bishopric because the election had not been free. A second election was held with due observance of canon law — this time at Lincoln, and not in the king's private chapel — and Hugh, though chosen unanimously, still refused the bishopric till the prior of the Grande Chartreuse, his superior, had given his consent. This being obtained, he established his independence from the King, and was consecrated in St. Catherine's chapel, Westminster Abbey, on September 21, 1186,

As bishop, Hugh was, generous with his charity and scrupulous in the appointments he made. He raised the quality of education at the cathedral school. He also defended the Jews living in London from persecution under Richard I with the passing of Henry II.

In Richard I, Hugh found a more formidable person to deal with than his predecessor. He was unjust in his demands, which Hugh remained resolute in opposing. "Truly", said Richard to his

Thanksgiving Safety Tips for My Pooch Friends

Tis the season for friends, family and holiday feasts, but also for possible distress for our animal companions. Pet's won't be so thankful if they munch on undercooked turkey or a pet-unfriendly floral arrangement, or if they stumble upon an unattended alcoholic drink.

Talking Turkey: If you decide to feed your pet a little nibble of turkey, make sure it's boneless and well cooked. Don't offer her or him raw or undercooked turkey, which may contain salmonella bacteria.

Sage Advice: Sage can make your Thanksgiving stuffing taste delish, but it and many other herbs contain essential oils and resins that can cause gastrointestinal issues and central nervous system depression to pets if eaten in large quantities. Cats are especially sensitive to the effects of certain essential oils.

No Bread Dough: Don't spoil your pet's holiday by giving him raw bread dough. When raw bread dough is ingested, an animal's body heat causes the dough to rise in his or her stomach. As it expands, the pet may experience vomiting, severe abdominal pain and bloating, which could become a life threatening emergency, requiring surgery.

Don't Let Them Eat Cake: If you're baking up Thanksgiving cakes, be sure your pets keep their noses out of the batter, especially if it includes raw eggs, they could contain salmonella bacteria that may lead to food poison-

Too Much of a Good Thing: A few small boneless pieces of cooked turkey, a taste of mashed potato or even a lick of pumpkin pie shouldn't pose a problem. However, don't allow your pets to overindulge, as they can wind up with a case of upset stomach, diarrhea or even worse

an inflammatory condition of the pancreas known as pancreatitis. In fact, it is best to keep pets on their regular diets during the holi-

A Feast Fit for a King: While humans are chowing down, give your cat and dog their own little feast. Stuff their usual dinner perhaps with a few added tidbits of turkey, vegetables (try sweet potato or green beans) and dribbles of gravy inside a Kong toy. They'll be happy and occupied for a while, working hard to extract their dinner from the toy.



On any given day, you will find all five family members working side by side, each handling a different aspect of the business. Elizabeth, perched on her chair in the kitchen, prepares all the delectable dishes you will find in the prepared foods area including: kibbeh, various types of hummus, mujadara, lahmajun, potato salads, vegetables, falafel, muhammara, garlic sauce, grape leaves, kofta, tabbouleh, etc. These perfectly packaged homemade items like your mother or grandmother would make are excellent choices for young professionals and families, not only because of the convenience, but also the food quality is unsurpassable. Hagop, who cooks alongside his wife, is known for his homemade jam ... yes, I said jam: apricot, raspberry, one more delicious than the next.

Their eldest son Hrach, who begins his day at 4:30 am, delivers the freshest produce each morning to the market and his keen sense for quality is evident in their selection, which is top-notch. Everything from vibrant red heirloom tomatoes to fresh figs to seasonal exotic fruits and vegetables,

there is always something new. Shant, who is the youngest sibling, can be found at the register conversing with clients and assisting them, most of whom he knows by first name. Over the past few years, Arax has become the number one purveyor of hookah related products



including all the latest enticing tobacco flavors, hoses, tips, portable cases, vapes, eliquids, etc. in our area due to his hard work and knowledge of these products.

Betty, who is the resident baker and catering manager, is known for creating mouthwatering treats that are worth every calorie. Middle Eastern nirvana for sure! Where do I begin? The baklava is Heaven on Earth, especially if you are lucky enough to be there when she makes her famous melt in your mouth nutella baklava or chocolate macaroons with the perfect combination of chewy center and crisp shell. Each pastry case is gleaming with homemade sweets, one better than the next.

A quick walk through this market is not possible, as your eyes dart from shelf to shelf: assorted teas, nuts, hard to find spices, fine china, imported oils, cured meats, breads, yogurts and the best selection of Kinder products on this side of the Atlantic. and is definitely THE place to dine for wood fired Italian Neapolitan-style pizzas, homemade pastas and appetizers. The combination of casual chic meets rustic style atmosphere is inviting with warm accents, oversized candles, a comfortable bar and of course their woodburning oven. Nestled on Elm Street in Davis Square, Somerville, Posto is a great date night spot or meeting place for friends. Chef/Owner Joseph Cassinelli, who opened this gem in 2009, hails from Boston's famed Mistral, Teatro and L'Andana restaurants; however, his talents here at Posto surpass all expectations.

Posto, translates to "place,"

On Saturday night, we arrived at Posto around 6:30 pm with no reservation (daring I know) and hoped to find a few seats around the bar. To our surprise and delight, the manager offered us a table in the bustling dining room, which is a great people watching location. Since this was our fifth or sixth time to Posto, we had a good idea about our dining choices for the evening, but their seasonal selection is constantly evolving and worth trying. As I peruse the menu sipping a Vespa, which is one of their signature cocktails made with cucumber vodka, lime and prosecco, taking in the wonderful scents of delectable dishes as they pass by I can't help but want everything on the menu.

We begin with bruschetta,

topped with roasted grape tomatoes, goat cheese, purple onion, basil and drizzled with balsamic vinegar. The bread is toasted to perfection and combined with roasted tomatoes bursting with flavor. We realize that one order may not be enough. Next arrives a dish of wood oven roasted head on shrimp in a garlic chili butter sauce served atop grilled ciabatta (perfect for scooping up all that delicious sauce) followed by crispy calamari in a light batter with a pine nut romesco and fresh lemon. The burrata appetizer, served alongside poached d'anjou pears with candied walnuts, is a perfect balance of creamy and sweet. Our favorite two salads are the arugula with endive, gorgonzola picante, drizzled with honey thyme vinaigrette and their Greek with finely chopped tomatoes, cucumbers, red onions, olives and sheep's milk feta.

What would any Italian ristorante be without ... homemade (think of your Sunday's rolling out the dough and cutting each individual piece) and cooked to perfection. The gnocchi, at www.postoboston.com.

served in a braised beef short rib red wine sauce is filled with robust flavors, while the spaghetti with parmesan crema, house cured pancetta and egg yolk is a little more subtle. Both are guaranteed to satisfy your comfort food craving. Their grilled rib eye served with rosemary gold potatoes is tender and flavorful.

And now ... the pizza! Posto's classic margherita, cooked to perfection is topped with San Marzano tomatoes, homemade fiore di latte mozzarella and fresh basil. Their pizza embodies the true meaning of Neapolitanstyle from start to finish and is the closest I have found to traditional dining in Naples. Their fiorentina white pizza combines various types of mushrooms including crimini, white trumpet and shiitake topped with spinach and fontina cheese, creating an earthy yet delicate taste.

Posto's use of simple highquality ingredients, locallygrown products and attention to detail have earned its place among some of the best restaurants. Their prices are reasonable, especially for the quality. The only drawback: food arrives quickly, so if you are a slow eater, order a couple dishes at a time.

# Parla Come Mangi!

(Speak as You Eat!)

Our next Tuscan recipe comes from the city of Prato. Biscotti di prato or cantuccini also called cantucci o giottini, are a beloved Tuscan sweet specialty. They are baked twice (biscotti) to be very firm and dry. These crisp cookies are traditionally dipped in Vin Santo for dessert. Vin Santo ("Holy wine"), is a dessert wine made from Trebbiano and Malvasia grapes, and is always paired with cantuccini cookies. Although the origin of the name Vin Santo is debated, we can say with certainty that it dates back to the Middle Ages and some say it was the wine used in religious Mass.

#### Biscotti di Prato or Cantuccini (Prato biscotti)

2 cups almonds, skinned and roasted
4 ½ cups flour
1 ½ cup sugar
4 eggs
Salt

Cantel Zest of 2 lemons
½ tsp anise oil or anise
extract
Butter (to grease the baking sheet)
1 egg

**Preparation:** chop the almond coarsely and mix with the flour, sugar, eggs, and a pinch of salt in a mixing bowl. Add the lemon zest and anise to taste. Form the dough into long rolls about 1 inch diameter and place on a greased baking sheet. Whisk the egg with a little sugar and brush the rolls with it. Place into a preheated oven and bake, or rather dry, at 250°F for no more than 30 minutes. Cut the rolls into ½ inch thick diagonal slices, and bake these for about another 15 minutes until completely dry. Serve with a small glass of *Vin Santo* for dipping. Buon appetito!

#### Biscotti di Prato o Cantuccini

300 g di mandorle pelate e tostate limoni
500 g di farina ½ cucchiaino di estratto di anice
4 uova Burro (per ungere la teglia)
Sale 1 uovo

**Preparazione:** trita grossolanamente le mandorle e versale in una terrina con la farina, lo zucchero, le uova e un pizzico di sale. Amalgama bene il tutto e aggiungi la buccia di limone grattugiata e l'estratto di anice. Forma la pasta in cordoli di circa 2.5 cm di diametro e trasferisci su una teglia imburrata. Sbatti l'uovo con poco zucchero e spennella la superficie dei cordoli. Fai cuocere in forno preriscaldato a 120°, per 30 minuti. Taglia i cordoli in fette diagonali di 1 cm di spessore e fai asciugare in forno per altri 15 minuti circa fino a completa cottura. Servi con del *Vin Santo*.Buon appetito!

A Nostalgic Remembrance

A friend, Dick DeVito, recently sent me an article called, "Capeesh." I will repeat some of it for you, but after I read it, it started me thinking about the local neighborhoods that it was pointing to. I read it to a few friends and to some, it sounded funny. To my Italian friends, it sounded demeaning and stereotypical. Let's see what you think:

"Come stai? Molto bene Bongiorno Ciao Arrivederci." Every Italian knows these expressions and we Italian Americans have used them from time to time. But, the article has a hidden language that the writer called the Goomba Italiano. It's not gangster slang that we hear in today's films that try to depict our ethnic group as the originators, organizers and sole directors of organized crime. The article uses a contraction of Italian. English, and made-up street corner words and calls it "Guido" talk. It starts by saving that when an Italian arrives or leaves from a location he says, "Ciao." When he expresses emotion, he says "Mama Mia," regardless of the situation. If our speaker wants to be a bit more crass, you might hear "mannaggia," or "Oofah," The emotional sentence might end with "Capeesh?"

Our star of this debacle might use a muppeen to wipe his hands in the cuchina, or get agita from gravy that was too spicy and will skeeve the meatballs he's been served unless they were made by his mother or grandmother. To continue, when he sticks a piece of bread in the gravy, if he gets his fingers wet, he might be considered a 'strunzo," "googootz" or a "mezzo finookio." Some of the guys from that old neighbor-hood are called "Mamalukes," and when referring to the girls, they might have been referred to as "faccia bruta," or "schifosa."

The next set of references include. "cattivo," "cabbadosto," "sfatcheem," meant you were a pain in settings of the grandparents the rear or worse. It said that we all carried a corna or horn, which would give the evil eye. Actually, according to superstition, the horn was to ward off the evil eye given by the "malokya or evil eye" expressed by pointing your index and pinkie fingers at a person you wish to curse.

that when this guy was responding to his parents, grandparents or elders from the neighborhood, he always said, "Per piacere, prego or mille grazie."

If he was feeling tired or out of sorts he used words to describe the sensation such as mooshadda, stunada or mezzo-morto. His grandmother would always get him out of this funk by giving him something to eat, maybe a sangweech of cabacol, or some proshoot or mozzarella and a piece of cheese. If she was pushing sweets, they might include zeppolis, cannolis, torrone, struffoli, shfoolyadell or cookies with pignoli on top. Once out on the street, our friend might use terms like "disgraziato," dispiachay" or just "faghedda boudit." ARE YOU GETTING DISGUSTED YET?

The story then goes on to describe a typical Italian house with a \$40,000 kitchen on the first floor and a 50-year-old Sears stove in the cellar which is constantly used. The living room is filled with old wedding favors and little packets of coated almonds that are too pretty to eat. All lamp shades, stuffed chairs and couches are covered in clear plastic. Portraits of Frank Sinatra and the Pope hang in the dining room. And, God forbid anyone ever attempted to eat Chef Boyardee or Franco American pastas or use any sauce called Ragu or Prego or anything else in cans or jars labeled as Italian. Meatballs are made with pork, veal and beef all mixed together. On Thanksgiving, the turkey might as well be made of plastic because no one eats it because it doesn't come up to the level of escarole soup, ravioli, sausages, meatballs, stuffed artichokes, stuffed mushrooms all followed by a salad covered by olive oil and red wine vinegar. The wine is always homemade and all the table utensils were placed on the right side of the plate and the napkin on the left. Cloth 'stupido" or "strunzo." These napkins were at the place as they wouldn't use paper napkins. After dinner, the kids would go out and play, the men would head for the living room and all fall asleep and the ladies would clean the dining room and wash the dishes.

When social events would take place, especially for the Aunt Carmela, the seamstress, would make a formal dress for the cost of the material and the kid's hair would be done by cousin Maria the hairdresser. If the girl had a date for this special occasion, standing in the back of the location would be her parents, grandparents and her Godparents.

By the time I reached this point, I had had enough of the stereotyping. I will admit that some of the comments hit home and I loved them, but much of it was nothing more than demeaning to Italians and Italian Americans. I remember conversations with Dean Saluti when we were young men working on doctoral degrees at Boston University. Some of the descriptions in the forgoing paragraphs were in our conversations as well as the attitudes toward our ethnic origins and their descendents in America. We decided that we, somehow, were going to make a difference in society and help dispel these depictions of who and what we were and are.

Hollywood hasn't helped, but I can't blame them. The producers of the movie industry are out to make money and much of the general public only knows us by what Holly-wood portrays in the films they have distributed. When Dean and I concluded our conversation(s), we decided to begin making that difference for ourselves and our people.

The gods of success must have been smiling at us because we both, as well as an inner-circle of friends, have been working at improving the image of Italian Americans. Not because of us, but due to education, whatever levels they may be or whatever disciplines they might involve, things are a lot different than in the days of our parents or the Nannas and Babbononnos of America.

Someone recently asked me why people like Dean and I have been so successful. My whimsical comment was, "We dress British, think Yiddish, but let them know that we are first and foremost, Italian. By the way, growing up in East Boston and the North End, I had never heard the term, "Badda Bing."

Well, it's time to close and I hope this week's column didn't offend anyone. Beginning next week, I will detail how my family prepared for Thanksgiving, a genuine and traditional American holiday, how we prepared for it, Italian style.


#### Obama Sending Troops Back To Iraq

courtiers, "if all the prelates in the summer of 1200. of the Church were like him, there is not a king in Christendom who would dare to raise his head in the presence of a bishop."

Crossing again Normandy, Hugh arrived just before the king's death, and was present at the funeral at Fontevrault. He then attended John's coronation at Westminster in May, 1199, but was soon back in France aiding the king in the affairs of state. He visited the Grande Chartreuse

While returning to England, he was attacked by a fever, and died on November 16, 1200 at the Old Temple, the London residence of the bishops of Lincoln. The primate performed his funeral rites in Lincoln cathedral, and King John assisted in carrying the coffin to its resting-place in the north-east transept. In 1220, he was canonized by



#### The Real Rockys

A History of the Golden Age of Italian Americans in Boxing 1900-1955



The Real Rockys

"The Real Rockys" by Rolando Vitale (RV Publishing, 430 pages) is not only an encyclopedic history of Italian American boxers during the golden age of the sport, it is also a fascinating social history focused on immigration and the progress of immigrants as they made their way navi-

gating the promises and hopes that the United States held for them. While a huge wave of Italian immigrants made their way to these shores in the early part of the 20th Century, most people don't know that half of them returned home, a fact that Mr. Vitale points out early in his book. That fact does not mean these folks failed here, though while it is true many returned home because of disillusionment and lack of success, many also had made the trip with the intentions of going home after making enough money to enable them to enter a higher social status back home. Many members of this group were men who had made the voyage alone, leaving their families at home to await their triumphant return.


Those who stayed faced many challenges. Life was not easy and there was much anti Italian sentiment they had to deal with. While life was hard. Mr. Vitale points out that the Italians who chose this country as their new home should not be looked back on as an underclass. They worked hard, many started businesses, and they provided, sometimes sparsely, but usually consistently for their families. A better term for them would be a struggling working class.

During the early years of the last century and then again when the Great Depression hit, it was difficult to make a decent living. Well paying jobs were scarce, especially for newcomers. There was one way for a young man to go out and make some good money, and that was by climbing into the ring. Just by having a couple of pro fights a week a man could bring home more than a week's pay. Not bad, and as Mr. Vitale points out, a

young fellow also would gain in his participation in the Italian cultural philosophy of "fare la bella figura" (making a good impression), a mindset of keeping one's image intact. Boxing, being the second most popular sport in the country, and the most individualistic, was the perfect way for a young man to gain respect among his peers.

While this book covers much of the immigrant experience, it is also is a treasure trove for boxing fans. The author has done exhaustive research into many aspects of boxing history, and the second half of the book is like an encyclopedia filled with facts such as the occupations of the fathers of Italian boxers as well as the fighters' own occupations before and after being in the sport. The life span of the fighters, and what I found very interesting, the uncovering of Italian names behind many Irish and Anglo named prizefighters. A couple that struck me was such great Italian American boxers as Fireman Jim Flynn (Andrew Chiariglione) and Lou Ambers (Luigi Giuseppe D'Ambrosio). There are many more and I am sure readers will be surprised by a number of them.

Mr. Vitale points out that while many of these men changed their names because of anti Italian sentiment, some did it for the simple reason that their names were being misspelled and mispronounced so often that it just made it easier to go with a name such as Flynn.

There are interviews with such boxing notables as historian Hank Kaplan, Angelo Dundee, and Tony DeMarco who all offer great insight into the game. Unfortunately, Messrs Kaplan and Dundee have now passed on, so it is special to have them speak to us from this book.

Another interesting subject covered is the role the Catholic Church played in encouraging boxing among young men growing up in the city. While at first frowned upon, the clergy found boxing to be an excellent way to encourage good behavior and clean living habits among this rather rough and tumble crowd. Soon they developed programs for participation in other sports through organizations such as the Catholic Youth Organization (CYO). A side benefit was increased attendance at Sunday Mass, seeing that if you said you were too ill to go to church you were also stuck with being too ill to play your sport that afternoon.

In the second half of the book, Mr. Vitale treats us to a number of short biog-



Oh yes, the author also spends some time discussing a heavyweight from Brockton, MA by the name of Rocky Mack. Well, that's what the

boxing promoters wanted the young Rocky Marchegiano to change his name to because it would be much easier to pronounce. Rocky wanted nothing to do with distancing himself from his Italian heritage, so he compromised and settled on Marciano, "It's Italian all right."

Rocky was the bookend on the final chapter of the Golden Age of Italian boxers. Upward social mobility, better educational opportunities, and, the success of pizza (Paulie Malignaggi's observation on this phenomenon is very insightful), led to the decline in the appeal of making a living while getting punched in the nose.

The one problem I have with the book is its lack of an index. While it is an interesting read, there is an incredible amount of information in it (I have only touched on a bit), and it would be nice to be able to use an index as a quick reference source. I would recommend marking passages as you read through it as you will want to return to much of what you have read.

Finally, the author makes an observation that echoes my own belief. He states, "Television exposure influenced boxing styles, with performers pressurized into substituting boxing science with a slam bang approach, and youngsters were thrust in at the deep end having not fully polished off their ring craft." That same influence is what has contributed to the downfall of today's boxing.


