



Women of Color Big News in November 7th Election

The news spread across the country. In Boston's recent city council elections, six women of color got themselves elected as either city councilors at large or as district councilors. Just a few years ago, the number was zero. City Councilor Ayanna Presley was the first, but in just the last three elections, five more women of color have joined the 13-member Boston City Council.



Boston's political history just passed the 50th anniversary of one of the most divisive mayoral elections in the city's history as Kevin H. White faced off against Louise Day Hicks. Two powerful politicians representing two parts of Boston's electorate. Liberals pulled out all the stops to get White elected mayor, while the more conservative neighborhoods of the city backed Hicks. She even made the cover of *Newsweek* as Boston's version of George C. Wallace. The race was close, but White did win and went on to three more terms before retiring from office in January 1984.

DOMITIAN: THE KILLER-DILLER



A complete list of Domitian's condemnations and the manner of his tortures certainly matches those of Caligula and Nero. He even devised a special truth extracting technique for use during inquisitions. This consisted of inserting fire into the privates of the witnesses. Financial problems brought about as a result of his shows and building programs resulted in economic measures — tax assessments, and confiscations — that were also equal to those of Caligula and Nero. The property of the living and the dead were seized anywhere, at any time, and on any charge that had been brought by any accuser. A mere word or action that could be construed as derogatory to the majesty of the emperor was all that was needed for condemnation. Domitian even confiscated estates of persons who were in no way connected with the emperor. All that was needed was for one man to come forward to say that he had at one time heard the deceased say that the emperor was his heir. He levied harsh taxes

them with the utmost rigor to force payment. One man who attempted to conceal his identity was examined publicly in a crowded courtroom and forced to reveal the fact of his circumcision.

Domitian was not to be outdone in his sex life, either. He was excessively lustful and was constantly engaged in sexual intercourse, which he called "bed-wrestling," and referred to this kind of activity as exercise. He even depilated his concubines with his own hand. It was said that he was such a downto-earth guy that he even swam in the baths with common prostitutes. He refused a niece who was offered to him in marriage when she was a maiden, but later he seduced her after she became the wife of another. Still later, when she suffered the loss of her husband, he loved her ardently and openly, eventually causing her death by ordering an abortion.

Domitian was quite tall, with large eyes, handsome and graceful. In his later years, he suffered baldness, a protruding belly, and was spindle-legged. on the Jews and pursued He exercised very little and

was incapable of exertion, but instead was carried in a litter. His only interest in arms was archery. He was an excellent marksman and often killed wild beasts with two successive shots in such a manner that the



arrows gave the effect of horns. Domitian was killed by a

conspiracy of close friends that also included his wife Domitia. The murder took place in his bedroom after a lengthy struggle. Stephanus, the steward of Domitia, concealed a dagger in a fake arm bandage. He stabbed the emperor in the groin while he was reading a paper. The emperor fought with Stephanus and both fell to the floor where they struggled for a long time. Domitian tried to get the dagger away from his assailant and even tried to gouge out his eyes with his own lacerated fingers, but eventually he was slain when Parthenius, a second assassin, stabbed the emperor seven times. The day of his death is listed as September 18, 96 A.D., in the fifteenth year of his reign. His corpse was carried out on a common bier by persons who normally buried the poor. He was cremated on his suburban estate, which was located on the Via Latina, and his ashes were placed in the Flavian family temple. The people received the news with indifference, but the senators were so overjoyed, that they immediately removed his shields and images from the walls of the Senate House and dashed them to the floor. They also decreed that all of his inscriptions be erased, and all record of him obliterated. Probably the one most significant feature of his reign was the manner in which he had advanced toward absolute

I do recommend and assign Thursday, the 26th day of November next, to be devoted by the People of these States to the service of that great and glorious Being, who is the beneficent Author of all the good that was, that is, or that will be ...

National Thanksgiving Day Presidential Proclamation)

The Pilgrims, Puritans, Huguenots, Quakers, Anabaptists, Lutherans, Jews, Catholics, deists, and even atheists who came to America in the colonial period found here freedom not

> possible in the lands of the Old World, where an established church was the norm. Their descendants founded the United States on a radical and untried principle no religious establishment and no government interference with religion. What a surprise

then to find that the very first Presidential Proclamation issued was Washington's Thanksgiving Day call to prayer to an Almighty God.

Indeed, the only distinctly American holiday is the fourth Thursday in November, which we set aside to thank God for our blessings. Think about it. Christmas is celebrated worldwide, even in lands where Christians are a small minority. Every nation celebrates New Year's Day and the various national holidays commemorating great leaders, important battles, and the date of national founding.

Our distinctly American national holiday is a re-enactment and re-interpretation for contemporary multi-ethnic and multi-religious American culture — of that first Thanksgiving in Plymouth, Massachusetts, celebrated by survivors of the Mayflower passage. And, yet, the story is not narrowly the tale of the Pilgrims. Few Americans are literally Mayflower descendants. Most of us do not trace our roots to East Anglia. Most of us do no follow their reformed Calvinist religion. Nevertheless, their story is the American story. It is the story of families that left their homeland for a better life in America.

Did your people come here on sailing ships in the 17th, 18th, or 19th century? Or were they part of the big steamship migration of the late 19th and early 20th century that filled Boston with Irish and Italians? Or perhaps you are a more recent immigrant. Whenever your people came here and by whatever means, they, and you, are part of the narrative we re-tell every Thanksgiving Day.

our own pace, following maps to regular meeting points, the road bikers always lead the way. Except maybe for the first 30 seconds or so, when I and a couple from NH I befriended (due in equal part to our lack of speed and appreciation for the food) would eagerly start first out of the gate while guessing how many seconds it would be before the road bikers blasted by us. (Typically, about 30 we discovered.)

Despite our wildly different modes of experiencing a bike trip, the road bikers and hybrid riders got along famously when out of the saddle. It was a very congenial group for the most part. (Of course, there are usually notable exceptions in these traveling groups and we had ours; but that's another story.) One morning, during our afterbreakfast meeting to review the day's route and activities with guides Christian and Marco, Marco excitedly told us we would be riding through wild boar, or cinghiale (chin-gee-AH-lay), country and we should keep an eye out for them. He also mentioned that our lunch stop restaurant served *cinghiale* as their specialty. (This was a bit more exciting to me.)

And then we were off, with the road bikers, as usual, blasting past me, Gloria, Paul, and pretty much everybody else. We leisurely pedaled along some country roads and eventually wound up on more of a main road — not exactly city, but more suburb than country. Surprisingly, this was the stretch of road we were expecting the cinghiale sighting. We had not spied anything beyond the usual restaurants, shops, factories, office buildings, etc., that typically dot suburban main roads — in Italian, of course — when suddenly the road bikers went flying past us ... in the opposite direction! Normal speed to them, but to us, the combination of speed and direction was a little alarming. But then, suddenly, they went flying by in our direction, waving their hands, pointing ahead to the left, and shouting "CINGHIALE!!!" like some kind of wild bike cavalry battle cry. Aha! We now kept our eyes peeled to the left as we passed a short expanse of field and forest. Sure enough, there were three dark brown blobs nosing around in the underbrush. Not close enough to stop for a photo, but we could at least say we saw them, thanks to the road bikers. (And later, ate them, thanks to lunch!)

After that episode, I referred to the road bikers as "the Cinghiale" for the rest of the trip. The name seemed apt, and Gloria and Paul joined me in the reference. We'd yell "Cinghiale!!!" every time they blew past us, which was at least twice a day on the road. (We returned the favor at meals.)

A few years later, I took another bike trip, this time to the Provence region of France. My friend Pat accompanied me this time and I explained to her about the Cinghiale when we arrived. Sure enough, there were five or six in our group of 18 choosing the road bikes (not including us!) And, as expected, we did not see much of them during the biking portion of the days' activities. Meanwhile, we befriended a couple, Marilynn and Bob (aka "Yes, Dear!") from Boise, again with similar lack of speed and great appreciation for the food and wine. We frequently rode in their company — at least until there were hills. Often, I would lose Pat, too, on the uphill roads, but she would generally catch up to me on the downhills. One afternoon, when it was just the two of us, I got ahead of her on a hill. We had been tooling along some backcountry roads, but the turn at the top of the hill took me into a beautiful and serene wooded area. The trees towered over me as I cruised down a gentle slope, feeling like I was disappearing into an old fairy tale. I remember wondering at the absolute stillness; not even a bird chirping.

At the bottom of the hill, there was an opening into a meadow of some kind to my right. But I couldn't make out what the cottony vegetation was until some of it moved. Then I realized I was looking at a large flock of sheep, standing quietly shoulder to shoulder and giving the appearance of a fluffy blanket spread out for a giants' picnic. I sucked in my breath and pulled out my camera, hoping to get a shot before they realized I was there. But at this exact moment, Pat came barreling down the hill, arms and legs extended wide as she balanced on her seat, yelling, "CINGHIALE!!!!" (Think Carol Burnett's Tarzan yell without all the reverberation.)

Well. Needless to say (but I will), the sheep suddenly noticed us. I could tell, because the cottony blanket rose and rippled seemingly three feet above the ground as if one of the giants was just laying it out. If that wasn't enough, a dog that was apparently napping on the job behind a shrub, had jumped straight up about ten feet and was now running around and barking hysterically. I just looked at Pat and whined, "You ruined it!" "Ruined what?" she asked, perplexed. But she figured it out as she turned to look where the barking was coming from. "Are those SHEEP?!"

Just the other day, Pat and I went biking on the Minuteman Trail in Bedford. On our leisurely ride (on hybrid bikes!), she told me about going to join a Meetup Group for a morning of biking in the area a week or two before. But when she got to the meeting place, apparently the last one to arrive, she found a group of spandexclad, thirty-somethings on road bikes. When they anxiously asked, "Are you Pat?", she said, "NO!" and took off! When I stopped laughing, I said, "Oh! Cinghiale!!"

Postscript: As I started writing this story, I had to check on the spelling of cinghiale. When I googled what I thought was the spelling (wrong!), the correct spelling came right up, as well as links to a number of businesses using cinghiale. in their name. and friends, forming a barrier against the encroaching dark, cold winter. This symbolic connotation compels me to believe that Thanksgiving should never be celebrated alone but rather with others in a celebratory atmosphere, sharing in communal feasting and unending love of family. The more the merrier on this most ritual of holidays!

Indeed, communal food-based

festivals similar to Thanksgiving dot the Italian calendar during the autumn and winter. The most famous of these, St. Martin's Day, occurred this past week on November 11th, when Italian villages gathered for banquets featuring chestnuts, goose, and the year's new wine. Now that the Christmas season quickly approaches, Italians are busy in the kitchens or markets preparing delectable meals for the holiday gatherings and various saints' days that pepper the months of November and December. These ritualistic celebrations and meals tap into the powerful desire to not only share strength and sustenance with the community, but also to maintain an irrevocable connection to the traditions of the past. According to Italian-American author Helen Barolini in her book *Festa*, the most significant part of sharing food is the ritual behind it, the repeated customs and motifs that link it to larger, universal themes. Whenever I gather for a Thanksgiving feast, I sense a special kinship with my Italian ancestors of yore, who also congregated around a family table on cool, blustery days to pay homage to the last bounty the Earth bestowed on them before settling for its long winter nap. A tradition does not have to be intricate and fancy to remind us of our subconscious desires for love, gratitude and hope. For example, my husband and I sometimes go out for sushi the day after Thanksgiving, a way of eating a light meal to counterbalance the excesses of the day before and to eschew the rampant commercialism of Black Friday. Honoring our traditions, no matter how small, simultaneously joins us to our past while imbuing our present with renewed meaning.

There are many ways we can commemorate the importance of feasting and tradition this Thanksgiving — ways that last beyond the date of the holiday on November 23rd. We should donate food to local charities and food banks, giving families in need the chance to partake in this festival of gratitude, togetherness, and love. We should relish the time we spend in the company of family and friends, ensuring that we fill the air with laughter and constantly remind each other of our mutual love. And finally, we should all share food together, reveling in that highly symbolic act of community and familiarity, an act which formed the backbone of our ancestors' lives and drives us forward with hope for the future.

A Special Veterans Day Celebration This Year

As a military veteran, I always look forward to the annual Veterans Day Parade back home. However, this year I found myself 1,700 miles from Boston and chose to march in the City of Austin's Veteran's Day Parade, starting at the Ann Richards Bridge down Congress Avenue to the grounds of the State Capitol.

I am a proud veteran who still remembers being only 18 years old just out of high school in 1966 when I made my first trip to Texas, an involuntary one as my enlistment into the U.S. Air Force down in San Antonio at Lackland AFB began.

No way would I miss marching in this parade. I was disturbed during the previous week to news that the mayor of Austin was planning on boycotting the parade due to the news that a Confederate flag might be flown by one group. I thought, how silly can one get?

The Civil War was the bloodiest American War with nearly one million from both sides perishing. I have seen the Civil War Monument on the grounds of the state capitol. I don't find this monument offensive to 21st century values. There is no gloating present, just sadness at the many who died fighting for their cause.

However, my greatest peeve with the Austin Statesman newspaper's coverage was that it printed so little on how so many came together on Saturday, November 11th, to honor America's military veterans. The streets were lined with young and old, black, brown and white, rich and poor, standing up for America and saluting all who served their nation in both war and peace.

I marched with the Lone Star chapter of the D.A.V. I was invited to march along with them as a member of the John F. Kennedy chapter of the D.A.V. in Dorchester, MA. I enjoyed seeing cheering crowds and one little girl handed me a plastic bag containing two Hersey Kisses and a toy soldier and said "Thank You.'

However, looking in the Sunday newspaper, I found one photo of J.C. Ernst, 98, who served in World War II, Korea and Vietnam. It was on page B-1 of the Metro & State section. The other photo that showed up was in the Insight section on E-2; it was of East Austin's Richard Overton who, at 111 years old, is America's oldest living veteran. It accompanied a commentary on veteran's services in Texas by Governor Greg Abbott.

Nothing at all about how great the parade was and how much fun parade-goers had watching marchers and veterans pass by them. Lots of kids, lots of balloons, and lots of fun. A great family friendly holiday on a great day honoring all who served their country to make such parades possible as holiday treats.

I am sure all the veterans who participated in the parade had a great time and none of them seemed to have any plans to fade away just yet. 
Saint Gaetano Catanoso

Gaetano Catanoso was born in 1879 in Calabria, the third of eight children to prosperous land owners Antonio Catanoso and Antonia Tripodi. He had a deep desire to enter religious life and made several attempts to enter a seminary but had to return home each time because of ill health. Eventually, he succeeded and was ordained on September 20, 1902. His first parish was in the remote hill village of Pentedattilo, where he served from 1904 until 1921.

Father Gaetano was fervent about imitating the life of Jesus in his service to the poor and would hike or ride on a mule to the remote surrounding mountain villages to bring the message of the Gospel and hope to the isolated people.

To help him in this cause, he founded an order of nuns known as the Suore Veroniche del Santo Volto in December 1934. The order established elderly in small and often quite and to that end formed the



remote places. The goal was to combat ignorance through education and the word of God. Father Catanoso also founded the Poor Clerics to encourage priestly vocations.

Father Catanoso had a deep schools and also homes for the devotion to the Face of Christ

"Confraternita del Santo Volto" in 1919. He also revived Marian and Eucharistic devotions and improved catechesis while also working for the observance of liturgical feasts. In 1943, he opened a makeshift orphanage for those children who were orphaned due to World War II casualties.

Father Catanoso died on April 4, 1963. He had become ill and blind before his death, though he still welcomed those who came to visit him and seek his counsel. He was canonized on October 23, 2005, by Pope Benedict VXI. The Feast of Saint Gaetano Catanoso is celebrated on September 20th.

Christopher Columbus Park's Art Installation Chosen for 2018 Boston Greenfest

Environmental Project Raises Awareness of Ocean Pollution; Turns Trash into Art

Christopher Columbus Park's *Changing Course* art installation has been selected to be part the 10th Annual Boston Greenfest, to be held August 11-13, 2018. The installation was designed and created by Friends of Christopher Columbus Park (FOCCP) Board Member and Art Curator Robyn Reed.

Changing Course is comprised of almost 2,000 plastic bottle "fish" to raise awareness of the large amount of plastic trash in the world's ocean and waterways. The installation was suspended from the Columbus Park trellis this summer.

"There's an uninhabited island in the Pacific that in recent years has become "home" to some 35 million pieces of plastic trash," says Reed. "Henderson Island dramatically illustrates how powerfully and negatively plastic impacts our environment and marine life. The idea for this project came to me when I learned that fish are ingesting the materials and are practically becoming plastic."

In addition to drawing attention to an important environmental issue, the project also brought together the community for its creation. The bottles were collected and painted by North End and Waterfront neighbors, as well as children from the after-school program at the Nazzaro Center, residents and staff of the Spaulding Nursing and Therapy Center, a local Brownie Troop, and visitors to Columbus Park.



My grandfather joined the Italian Marines in the late 1800s, auditioned for their Rome-based traveling band, and toured as a member playing drums and tympani. There was a tradition in this country that started with Thomas Jefferson when he became president, and ended after Harry Truman left office. Each year, that Italian Marine Band came to America and serenaded the brass in Washington, D.C. That's how Babbononno came to the United States. While he was here, he was notified that his wife had died in childbirth, and he never went back. A generation or two later, WWII came along and two of his sons, Uncles Nick and Gino, wound up in the military — Uncle Nick in the Navy and Uncle Gino in the Army Air

When they asked Uncle Nick what he did in civilian life, he answered, "I'm a musician." When they asked him what else he did, he replied, "I'm a musician, and that's it." As a result, he was told to audition for a Navy band led by the famed

conductor Andre Kostelanetz. He made the band and became one of their reed players, playing tenor saxophone, clarinet, and flute. As luck would have it, the band was stationed at the Newport Naval Station, in Newport, Rhode Island, for the duration of the war. They would play every time a war ship came into port to be repaired or to give the men shore leave. As I said, Uncle Nick lucked out in that he never saw combat. The fatality he experienced as a result of the war was the breakup of his marriage to his childhood sweetheart and their subsequent divorce, which, back then, with the Massachusetts Blue Laws, was messy and took almost five years before it was finalized.

Uncle Gino, on the other hand, saw combat as a member of the Army Air Corps. He flew with the 5th Air Force and hit island after island in the Pacific as our military headed toward Japan. He was part of the bombing raids that leveled Tokyo just before the two atom bombs were dropped. He was in the thick of it and was lucky he was never wounded, but he never liked to talk about his experiences. I had older second cousins who fought in Korea and were in the infantry. They, too, saw a lot of action, but when they came home, they just wanted to forget their experiences and get on with their lives.

My generation headed for Vietnam. Some friends, and later, many of my students, headed there and never came home. This bothers me still. I was a flag waver back then, but looking at things in retrospect, I now know that we didn't belong there. The U.S. was asked to send military advisors to help the South Vietnamese, but we wound up fighting their war with the Communists of the North. The situation became a political chess game with our fighting men and women as the pawns. Rather than being told where and when to kick butt, the politics of the day dictated what to do, and the South Vietnamese lost. We finally quit in the early 1970s. We didn't lose; we just quit.

Regardless of the circumstances, those Vietnam veterans deserve recognition for putting themselves in harm's way for their country. The same applies to the men and women who joined the military and have fought in other parts of the world since then.

Last Sunday, the military organization I belong to, the Veterans Association of the First Corps of Cadets, honored several people who served in WWII and Korea. Each fall, we

have a recognition ceremony, saluting veterans whose names have been suggested to us and we present them to the Corps of Cadets and honor them with a dinner at the Smith and Wollensky Steak House in Boston. I am just a small part of this celebration, but feel compelled to honor the service personnel who served.

My wife, Loretta, comes from a Navy family. Her father served on a few aircraft carriers during WWII. He wasn't as lucky as some of his shipmates, but luckier than those who didn't make it back. Twice, he went down with the carriers he was assigned to. The last one, I think it was the Battle of the Coral Sea, saw him being fished out of the South Pacific while unconscious. He woke up at the San Juan Naval Hospital in Puerto Rico, half way around the world. He recuperated there for several months and, when better, was assigned to yet another carrier. Luckily, the war was just ending and he never saw combat again.

You couldn't get him to talk about the battles and what he experienced unless you were able to get a couple of drinks in him. As I mentioned earlier, the combat-hardened veterans never really wanted to relive those days; they just wanted to forget them and get on with their lives.

Two of my closest friends, Dean Saluti and John Silva, also First Corps members, hold the retired rank of colonel. A third member of my inner circle, General Bill Hurley, passed away two and a half years ago. We often had discussions about some of the older members of the First Corps, some gone and some still with us, who served and never wanted to talk about their exploits. That's the way it was and that's the way it is.

My wish is that, someday, we will never have to talk about wars or combat ever again.

Until then, may GOD BLESS AMERICA.

Roast Leg of Lamb

1 leg of lamb (5 to 6 pounds) 4 cloves of garlic ½ cup chopped mint (optional)

4 cloves of garlic ¹/₄ cup lemon juice 1 tablespoon thyme or oregano Salt and pepper

Rub the leg of lamb with half of a garlic clove. Then make several gashes with point of knife into the lamb leg and insert small cut portions of garlic clove into the narrow openings. Rub meat with mint, thyme, or oregano, whichever you plan to use, or some of each. Rub leg of lamb with salt and pepper. Add a little water to the lemon juice and pour gently over lamb. Place lamb fat side up in roasting pan. Place in preheated 325°F oven uncovered. After 30 minutes, baste lamb with juices from the roasting pan and repeat frequently. Lamb should be baked until meat

OPTIONAL: Small white potatoes, carrots and some mushrooms can be added around the leg of lamb after the lamb has baked about an hour. Continue basting vegetables as well as the lamb.

He captures everything that is joyful and fun about rhyming verse across languages, never becoming rigid or stuffy."



HOOPS and HOCKEY in the HUB

Walking into the TD Garden on the night of a Celtics game these days, it is like all has been forgotten.

Has it really been just a scant six months since the 2017 playoffs when all the local hoops world was ecstatic about Isaiah Thomas? About how the 5'-9" dynamo was the center of attention as he deftly scored night after night against men a foot or more taller than him, running circles around the goliaths before depositing the ball in the hoop?

About the sadness that he experienced with the untimely passing of his sister in an auto accident in the Seattle area just as the playoffs were about to commence?

Or how about Kelly Olynyk, his long hair on display as he moved up and down the court? Remember Jae Crowder, a determined performer if there ever was one?

And it was in those playoffs that the Celtics stood tall, making it all the way to the Eastern Conference Finals before finally falling to King James and the Cavaliers. The Celtics had indeed made the NBA's Final Four and one had to believe that achieving a berth in the NBA Finals was a distinct possibility the next time around.

But then came summer and Olynyk signed with Miami for \$50 million, while Thomas and Crowder were traded to Cleveland for Kyrie Irving. Thomas expressed hard feelings concerning the transaction, while head coach Brad Stevens was portrayed as having a left-at-aloss for-words reaction.

"I've been staring at the wall for five hours, wondering what I could say to you," was the quote printed in Sports Illustrated that referenced Stevens' text to Thomas in the immediate wake of the move that disturbed many during the lazy days of summer.

Yes, it's all in the past because you know what — the Celtics are winning. There's new excitement on the floor. Through November 15th, the Green have won 13 in a row. The win streak may be over by the time you read this or it may still be continuing. Whatever, just think, out in Cleveland the Cavs continue to sag around King James, dropping to 7-7 through mid-November with an unbelievable 4-6 losing record in their last 10 games through November 15th. The nearest Eastern Conference challenger to the Cs was Detroit at 10-3.

The Celtics are the talk of the basketball world, with Stevens and his staff masterminding it all from the bench while GM Danny Ainge is considered a magician when it comes to the draft and negotiating deals.

How long it will last is anyone's guess, but it sure is fun watching it unfold.

IT NEVER GETS OLD FOR THE BLACK AND GOLD — They are older, now, the members of this select group, but wiser and still willing to find a way to make their mark in the game they love.

Welcome to the Hockey Hall of Fame class of 2017, a group that includes several who put in significant stints with the Bruins and another who performed several times a year on Garden ice.

The Bruins group includes former players Mark Recchi, Dave Andreychuk, and Bs owner Jeremy Jacobs.

Recchi spent 22 years in the NHL but is best remembered here for his final three with the Bs — including his swan song season in 2010-2011 that culminated with the Bruins winning their first Stanley Cup since 1972.

Andreychuk played 63 games of the 1999-2000 season with Boston and is best known within Bruins Nation as part of a trivia note. He was the "other player" included in the deal that sent B's legend Ray Bourque to the Colorado Avalanche on March 6, 2000.

Bourque would win a Stanley Cup with Colorado in 2001, but Andreychuk would have to wait a bit — until he signed on as a free agent with Tampa Bay during the summer of 2001. That was a move that saw him provide veteran leadership to the Lightning — a move that would culminate in Tampa's winning the Stanley Cup in 2004. Bourque and Andreychuk share a similar record — they both played 22 seasons before winning a Stanley Cup.

Jeremy Jacobs has owned the Bruins and NESN since 1975, ownerships separate from the Jacobs family-controlled Delaware North Company, which owns the TD Garden and the concession services provided within the building. Delaware North is headquartered in Buffalo, while Jacobs lives just south in East Aurora, N.Y.

As Chairman of the NHL's Board of Governors for the past 10 years, he is one of the most powerful individuals in the world of hockey — although if you were speaking with him, he would probably say that was an overstatement. He has said many times that he loves owning the Bruins.

Paul Kariya was seen on a regular basis in Boston during his college days when he was a standout performer for the University of Maine Hockey team. As a member of Hockey East, Maine played BC, Northeastern, and BU in Boston and also played in the Hockey East Tournament at the Garden. He was a member of Maine's 1993 NCAA Frozen Four National Championship team.

A footnote involving Kariya, who played 15 seasons in the NHL, goes back to the 1996 NHL All-Star Game at the Garden. Through an unwritten "understanding," the annual contest is traditionally played as a nonchecking game to limit the possibilities of injuries. However, during the game Ray Bourque did check Kariya into the boards, the resulting sound being heard throughout the arena.

When asked about the check in the postgame press conference, Bourque put his head down for a moment then, with a sheepish look, said simply, "I forgot."

But all were remembered on the night this group was inducted into the Hockey Hall of Fame in Toronto. Congratulations to all.
