19th Annual Trellis Lighting Ceremony

On Monday, November 22nd, The City of Boston, the Friends of Christopher Columbus Park, and the Boston Parks and Recreation Department hosted the 19th annual holiday lighting of the signature trellis at Christopher Columbus Park in the North End.

The park transformed into a beautiful holiday wonderland when the park's 260 feet of trellis were set aglow with 50,000 glowing blue lights along with 14 beautifully decorated trees near the Marriott Long Wharf Hotel, and throughout the park.

On hand to kick-off the festivities of the upcoming holiday season were Boston Parks Commissioner Ryan

Woods, Joanne Hayes-Rines, President of the Friends of Christopher Columbus Park, Postmaster of Boston David C. Guiney, who revealed a newest stamp, students from the North End Music & Performing Arts Center (NEMPAC), vocalists Ackeem Hill and Sharon Zeffiro, also in attendance were Mayor Michelle Wu, State Representative Aaron Michlewitz, Councilor at-Large Erin Murphy and other local politicians.

Guests were treated to cookies and hot chocolate from the Boston Marriott Long Wharf, clam chowder from Joe's Waterfront, and a visit from Santa Claus and other holiday guests.

The official holiday season kick-off in Boston includes the lighting of the City of Boston's official Christmas tree and trees throughout Boston Common and the Public Garden. Boston's official 2021 Christmas tree is a 60-year-old, 48-foot white spruce tree from Orangedale. Municipality of the County of Inverness, Cape Breton. The tree has been donated by the landowner L'Arche Cape Breton Community, a nonprofit organization that creates safe, supportive homes and meaningful work for people with disabilities.

The holiday lights throughout both parks will light up in sequence shortly before 8:00 p.m. when Mayor Wu is joined onstage by members of the Royal Canadian Mounted Police, Santa Claus, Rudolph, and Frosty. The show will close with a pyrotechnic display by Atlas PyroVision.





THE ROMAN AQUEDUCTS



An aqueduct is a pipe, conduit, canal, or trough used to convey water from one place to another. At one time, approximately 350 million gallons of water poured into Rome each day from as many as 14 great aqueducts in order to serve their needs for thermae, public fountains, and for domestic use.

One of the first of these aqueducts was the Aqua

Appia, which brought water from springs seven miles east of Rome and was completed about 312 B.C. The reservoir for the Aqua Appia was located near the Tiber and consequently only supplied a part of the city.

Forty years later in 272 B.C. they completed the second aqueduct by drawing from the Anio River on high ground near Tivoli about 20 miles from Rome.

The Aqua Marcia was third and came from springs in the upper valley of the Anio a distance of 38 miles but, in order to avoid some low lands and to maintain the proper pitch, a circuitous route increased its length to 61 miles. The last seven miles entering Rome were supported on arches. It was completed in 144 B.C. and was built at a cost of approximately 8 million dollars.

The fourth, named the Aqua Tepula, was only 13 miles long, the last half of which was supported on the arches of the Marcia.

The Aqua Virgo served the Baths of Agrippa, so named because of the young maiden that pointed out the location of the originating springs. Water from these springs is still being brought to Rome in a newer aqueduct, which is called the Trevi ..., need I sav more.

Next came the Aqua Claudia, built by Caligula and Claudius, and completed about 50 A.D. It brought water from the Subiaco a distance of 45 miles and in some places was carried on stone arches over 100 feet high.

One of the longest aqueducts seems to have been the Anio Novus, which was completed about 50 A.D. and ran about 62 miles. The first 49 miles were subterranean.

Some of the others had names like Aqua Felice, Aqua Paolo, and Aqua Alexandrina.

Most importantly, they all started in the surrounding hills and were brought into Rome on a gradual pitch, sometimes going miles off course in order to avoid steep grades. The portion on the ground ran in concrete channels or pipes and above ground on beautiful stone arches. Some of these conduits supplied a stream of water entering the city 40 feet deep and two feet wide running at about five to six miles per hour in a continuous current. They coped with this by making sharp changes in direction about every mile and by providing reservoirs at strategic locations. Settling tanks had to be provided to remove much of the chalky matter with which the water was loaded.

A study of Roman antiquities made about 100 years ago stated that if all of the water from all of the aqueducts could be brought together at one point, it would create a stream 25 feet wide and 6 feet deep constantly running at a speed four or five times faster than most rivers. These aqueducts also furnished the water required to sustain the beautiful villas and the farms that covered the countryside during imperial times. Most of the water furnished to the inhabitants was free. There were about 600 open reservoirs in the city for use by anyone. The only requirement was that you bring your own "secchia" or bucket. (MWRA Please note.

Today, about 2,000 years later, one cannot speed through the Campania in an air-conditioned train, bus or car and view the standing remains of these majestic structures without some passing thought to the vision, daring and wisdom of those Roman engineers.

Catherine (Bono) Geany

May 11, 1922 – November 18, 2021

Catherine (Bono) Geany of Medford, formally of the North End of Boston, passed away peacefully on November 18th, surrounded by her loving family as the recited the Holy Rosary for her soul.

"Katie" as she was known to her North End childhood friends, grew up on North and Fleet Streets at a time when the descendants from the town of Sciacca, Sicily, inhabited that area, close to the North End waterfront. During those decades (1920s to 1970s), that section of the North End was a neighborhood on to itself (North, Fleet, Clark, and Lewis Streets). It was a little Sicilian fishing village.

Katie's parents (Filomena Graffeo and Raimondo Bono) were both from the town of Sciacca in Sicily. Her father was a fisherman in Sicily and continued his work as a fisherman in Boston. The name of his boat was The Saint Calogero (Patron Saint of Sicily).

Raimondo was founding member of the Madonna del Soccorso Society di Sciacca of Boston (1910), which sponsors the annual Fisherman's Feast held each August.

Katie never missed a feast in all of her 99 years. She made sure she was always there to see the Madonna come out of her chapel at the start of the feast for the Blessing of the Fleet on Thursday, and the Grand Procession on the Sunday.

Katie had the honor of making two of the Madonna's capes and the vest, which carries the Madonna's jewelry during the feast. She was very devoted to Madonna del Soccorso di Sciacca (The Blessed Mother of Help) and Saint Anthony.

She brought up her family to be devoted to the Madonna as well. Her Catholic faith was paramount. Faith and family was most important to her. She, along with her loving husband (of 50 years) the late James Geany raised five children (John, Mary, Raymond, twins Filomena (Phyllis) and Jimmy. She was adored by four loving grandchildren (Michael, Michelle, Kristi, and Johnny), and four great-grandchildren (James, Ryan, Tyler, and Andrew). She is survived by her younger sister Virginia (Jenny) Cobuccio. She was also loved by many nieces and nephews who referred to her as "Auntie Rina" (from Caterina).

L'Anno Bello: A Year in Italian Folklore

The Return of the Light at Advent

Every year, I unfailingly hear the same refrain uttered from the lips of exasperated coworkers and family members: "The Christmas season starts earlier and earlier each year!" This nebulous phenomenon is actually known as Christmas creep, and it can be a real pain for those of us who wish to enjoy each season slowly, watching it unfurl naturally. I remember staring in shock at a commercial featuring Santa Claus which aired a few weeks before Halloween, and marveling at the boxes of Christmas lights that stocked store shelves before the last jack-o-lanterns or witches' hats made their way to the storage room. Then, of course, comes Black Friday, the day of long lines snaking out of department stores at the wee hours of the morning and crowds jostling to find the perfect deal. I try to avoid the rampant commercialization of Christmas. My Black Friday tradition involves a refusal to set foot in any store; instead, I spend a quiet day watching television, grading papers or eating sushi with my husband. I prefer to settle into the Christmas season calmly and organically, savoring it with the same appreciation as a cup of velvety eggnog. For this reason, I am especially thankful that the calendar sets aside a special time devoted to waiting, a value which too often seems lost in our fast-paced world. This period of reflective spirituality is known as Advent, and it brims with its own fascinating customs and traditions as it patiently ushers in the joyful Christmas holiday.

Advent, which begins on November 28th this year, stretches across the four weeks prior to Christmas. The meaning of this deeply significant time period has changed con-

spiritual cleansing in preparation for Christmas. It was time set aside for fasting, and vestiges of this practice can be seen in the many European cultures, including the Italian, which serve seafood rather than meat during the traditional Christmas Eve dinner. However, modern Advent celebrations focus more on the delightful anticipation for Christmas. This forms the symbolic crux of the Advent wreath. Every Sunday during Advent, someone lights one of the four candles — three purples, one pink — on the wreath until they all burn radiantly on the last Sunday of the season. These luminous candles cut through the dark nights of winter and reference the reemergence of light at Christmas, religiously through the birth of Jesus, and metaphorically through the slowly lengthening days after the winter solstice. I honor Advent with several quaint family traditions. My husband and I light a candle on our Advent wreath every Sunday, accompanied by the reading of an appropriate Bible verse and the singing of an Advent carol like "O Come Emmanuel." When we visit his parents, we attach a special ornament to an old cloth Advent calendar that they have held for years. On the first Sunday of Advent, I set out my Christmas decorations and begin baking my holiday cookies as well. These customs instill in me a keen eagerness for the Christmas festivities while still allowing me to revel in the unique delights of Advent.

During Advent, I also pause to remember my father's childhood memories of a Christmas season in Italy. Advent had a rustic and simple charm in his hometown of Sulmona, nestled in the mountains of the Abruzzi siderably from its medieval region, and every tradition roots. In the early days of was imbued with a profound Christianity, Advent meant sense of holiness. Bagpipe decked out in folkloric garb, still descend from the frosty mountain pasture to the haunting tune of their ancient Christmas melodies. They make their way to Rome and stay there until the Italian Christmas season ends on the holiday of the Epiphany. Throughout Advent, presepi, the quintessential Italian Christmas decoration, begin to appear throughout the whole country. Presepi, or Nativity scenes, adorn private homes, city plazas, and village squares, sometimes with live actors portraying the members of the Holy Family. These Nativities form such an indispensable part of Italian Christmas celebrations in part because they were created by the country's beloved patron saint, St. Francis of Assisi. My father always remembered with great love and nostalgia the enormous presepio he helped construct in his town church, replete with moss and running water. Finally, Advent signals the arrival of the ubiquitous Christmas markets in Italy. These enchanting bazaars grace nearly every Italian city, with the most famous located in Piazza Navona in Rome. Stalls burst with Christmas ornaments, toys and edible treats, all to the soundtrack of performers and musicians entertaining the shoppers. Tourists line up to try famous fruitstudded Christmas breads like panettone and panforte. These markets are just one of many customs which add to the magical charm of an Italian Advent, a season which excitedly awaits the arrival of Christmas while also commemorating the spirituality of the holiday.

I realize that it can be all too easy — and frustrating — to get caught up in the frenzied rush which frequently characterizes the holiday season. The incessant drone of commercials and the overwhelming surge of people in a crowded mall can either propel us to buy more and more material goods, or rather hide away home. However, by honoring Advent, we give ourselves a reprieve from the holiday turmoil. This period shines with the themes of anticipation, light and the humble pleasures of a Christmas season spent with loved ones. 


CHAPTER 64



Saint Sylvia

Little is known about Saint Sylvia's early life. She is believed to have been born in the year 515 AD in either Sicily or Rome. Apparently she was of a distinguished family as her husband; Gordianus was a high Roman official. She had two sons, Gregory and a second son,

whose name did not survive through the ages.

Sylvia's son Gregory would become Saint Gregory the Great, Pope and Doctor of the Church. Sylvia was noted for her great piety, she gave her sons an excellent education. After the death of her husband, Gordianus around 573, she devoted herself entirely to religion. Sylvia was renowned for her beauty throughout Rome. Saint Gregory's sanctity and intellectual brilliance are in no small way due to his mother.

Gregory converted his paternal home into a monastery. Sylvia thereafter retired to a solitary and quasi-monastic life in a little home near the Church of Saint Saba on the Aventine Hill. It became her custom frequently to send fresh vegetables to her son on a silver platter. She passed away in 592 A.D. The vénération of St. Sylvia is of early origin. In the ninth century an oratory was erected over the site of her former home, near the Basilica of San Saba.

Pope Clement VIII (1592-1605) inserted her name under November 3rd in the Roman Martyrology. She is invoked by pregnant women for a safe delivery. The Feast Day of Saint Sylvia is November 3rd.



One of my favorite eating places is Mike's City Diner

over in Boston's South End. As a kid, I lived for a time on East Springfield Street and in those days this diner at the corner of East Springfield and Washington Streets was a popular fish & chips joint designed in art deco style.

Whenever I sit at the counter today at Mike's, I still see a lot of art deco occupying the walls of this place. The food has always been great and the crowds always long, but things got worse during the pandemic as distance protocols kicked in and with the long lines came seemingly even longer wait times. Restaurants do what they can and many like Mike's City Diner survived the worst of these recent times and is still open while many other eateries didn't fare so well and shuttered their doors forever.

Kudos to Jay Hajj, who has owned this eatery since 1995, and the place like many others became short-staffed, but this place still serves roughly 500 folks per weekend day because it is a go-to place for the quality of its menu.

Things in the restaurant world have not yet returned to normal and all we can hope is that it returns as soon as possible but meanwhile Jay and his wait staff keep plugging away doing what this place always does, which is to serve great meals to hungry customers.

Nanna & Babbononno

A Nostalgic Remembrance



Back in the day, the week after Thanksgiving brought the musicians in my family into the Christmas season, and that was our busiest time of the year. Up until the '70s, most music was live. DJs were just coming into vogue and there was a reason why. Many of the older musicians refused or couldn't play the music the younger people liked to listen and dance to. They came up with every reason in the book as to the negatives attached to, especially, rock and roll, but whether they couldn't feel the music or understand it, they didn't want to play it. Most of the rock groups couldn't play the traditional dance music and the compromise was to hire a DJ.

Dad, Uncles Nick and Paul played mainly society music, working with the dance bands of Boston. If I was not playing steady somewhere, I would let it be known that I was available and the work rolled in. Back then, there were Christmas parties beginning the weekend after Thanksgiving Day and continued until December 25th.

For many years, Dad played at Santa's Enchanted Village at Jordan Marsh. New York had Macys and Gimbals, but Boston had Filenes and Jordan Marsh. Jordan's, as most Bostonians called the long gone department store, would have Santa Claus stationed in their Enchanted Village, and during the afternoons of the Christmas season, had a trio dressed in Tyrolean costumes playing for the kids and their parents. Dad was the bass player with the trio. Danny Cavicchio played accordion and Charlie Opper was on violin. They were quite a site dressed with lederhosen (Swiss leather short pants with suspenders), knee length stockings and Tyrolean Alpine

Most businesses had Christmas parties for their employees and they all had live entertainment. The bands that serviced the parties were hired during the day for a two or three hour time interval, and there might be two or three parties to play on any given day. Dad and Uncle Nick would hire chauffeurs to take them from a multi-generational family in one job to another. Parking in downtown Boston has never been easy, and with jobs being spaced close together, being let off in front of a designated building was a lot easier (and cheaper) than hunting for a parking space.

I began teaching school in Boston in the early '60s, but was able to book in the late afternoon Christmas parties in I was working the nightclub

downtown. I really never worked with Dad as we played the same instrument, bass violin, but many times, I worked with Uncle Nick who played tenor sax and often led the small groups that played throughout the city. The nights were just as busy during the Christmas season. There were many parties held in the function rooms of Boston hotels and private clubs. Organizations like the Masons, the Elks, the Moose, the K of C, the VFW, the Sons of Italy and dozens more, all held parties in their buildings usually located in the suburbs, which made it easier on the parking situation, as most had their own parking

If all of us were playing and finished early, we would head to our house where Mom and Babbononno would be waiting with a pot of coffee and something to eat in case we hadn't eaten on the jobs. Babbononno was long retired from the music business, but lived again through the stories the men in his family told about playing with the different bands we had worked with. He knew that we played what might be called music from the American songbook. All of the musicians who played these single engagements never used any written music. Whatever tune it was ... was memorized. Most of the top men in Boston had at least 1,000 or more songs they could play from memory. If we played a set of, let's say six songs, all we had to know was the key for each, and as the leader would segue from one to the other, he would hold up a series of fingers to indicate what the new key was ... one finger for the key of F, two for B flat, three for E flat, four for A flat, an arched thumb and index finger for the key of C and an index finger pointing down for the key of G. These were the most common keys and most of the dance tunes, the fox trots, waltzes, polkas, etc. ... were written in these keys.

Quite often, Dad and Uncle Nick would talk about the men in the bands they were working with that day or/and night. Babbononno could often identify with the names. If it was music, he most likely knew their fathers or uncles especially if they were Italian. Italians, Jews and African Americans dominated the music business back in the day. There were, of course, people from every other ethnic group, but the main body of commercial musicians were from those three backgrounds.

During some of those years,

scene, which meant that I couldn't play the Christmas parties that my Dad and Uncles played. More often than not, those nighttime parties were held at nightclubs and private halls in the suburbs making it a lot easier for the musicians.

As we headed into the early '70s, I met Dean Saluti and we became fast friends. He was in graduate school at the time, and to earn tuition and living expenses, was working as a bartender at Lucifer's, one of three nightclubs located in the same building called the Kenmore Club in Kenmore Square. Uncle Nick knew the owner and I often would meet my uncle at Lucifer's for a last call drink. Chances were that we finished at either midnight or 1:00 a.m., and Lucifers closed at 2:00 a.m.. Once the club closed, Dean, Uncle Nick and I would head to Chinatown for a bite to eat before going home. Dean would tell stories about what happened in the club that night and who some of the people were that frequented the place, and Uncle Nick and I would talk about the jobs we had played and how the people were into the spirit of the season.

Dad wasn't interested in "hanging out" after a late job, and would head home, so he wasn't part of the late night scene. Aunt Dorothy (Uncle Nick's wife) had retired and was living in Florida. As soon as the holidays were over, Uncle Nick would head south for a couple of weeks and then, maybe a weekend a month, until he retired. When he did retire in the late '70s, he headed to Florida and Aunt Dorothy, permanently.

Today, it's a toss-up as to whether a Christmas party has live entertainment or a DJ. When I speak to full-time musicians (and there are only a few of them), they tell me how difficult it is to make a living at their craft. Most of the luckier ones learned other trades and work days and have made music an avocation. The COVID epidemic has worsened the situation, so I guess I was one of these luckier ones. I taught public school during the day and played music at night. Now in my old age, until last year and the COVID-19, I attended the type of functions I used to play. Most of them are quite fun, but those days gone by ... they were quite an adventure and I was on top of my game and earning pretty good money. Oh yeah, another thing, I was young and that made part of the difference.

As the holidays are upon us, you are bound to find beautifully decorated trays of ricotta cookies on tables throughout Italian homes everywhere! These soft, sweet pillowy delights are melt in your mouth delicious, and have always been a favorite of adults and children alike. Recipes for them vary and some are made with butter, others use margarine or shortening. Flavors typically include vanilla, lemon, orange and almond and some are left plain, while others are iced and sprinkled with decorative nonpareils.

My Nonna had so many different recipes for ricotta cookies. Honestly, I remember one being more delicious than the other. Among them, there was one called Ricotta Cookie Slices or Fette di Biscotti alla Ricotta. She would make these into the shape of a log, using a small scoop to drop the sticky batter onto the baking sheet. The logs would be baked, cooled, then iced and sprinkled with small colored dots. They resulted in what you might consider a soft ricotta biscotti, and they were absolutely scrumptious. Nonna always made these using vanilla, but Ricotta Cookie Slices are equally as delicious when flavored with lemon, orange or almond. They are the perfect soft biscotti to have on your table during the holidays, or at just about any other time of the year!

RICOTTA COOKIE SLICES Fette di Biscotti alla Ricotta



1 cup margarine or butter, *softened (I use butter)*

2 cups sugar

1 container (15-ounce size) ricotta cheese

2 teaspoons vanilla extract 2 large eggs

1 teaspoon salt

4 ½ cups all-purpose flour 2 teaspoons baking powder

Icing

1/4 cup butter, softened 3 or more cups confectioners'


2 teaspoons vanilla extract Whole milk, added 1 tablespoon at a time Nonpareils


Preheat oven to 350°. Line a baking sheet with parchment paper, set aside. In a large mixing bowl, cream together margarine and sugar, increase speed and beat until light and fluffy for about 5 minutes. Lower speed and add ricotta, vanilla and eggs, one at a time, until blended. Sift in flour, baking powder and salt, mix together until dough forms.

Using a small scoop, drop dough onto baking sheet into a log shape the length of the baking pan and about 2 $\frac{1}{2}$ to 3 inches wide and 1 ½ inches tall. Repeat and place the logs apart, as this dough spreads when baking. Bake for about 25 to 30 minutes or until logs are a light golden color underneath and the insides are cooked lightly golden (they will be soft). Gently remove cookies with a spatula and cook on a wire rack.

To make icing, in a medium bowl, beat butter and vanilla on low speed, and then gradually add confectioners' sugar and milk, a tablespoon at a time, until desired consistency is reached. Ice cooled logs, sprinkle with nonpareils, and allow icing to harden. Slice, place on a tray and serve.

Gift Spring Blooms for the Holiday

Give the gift of spring this winter to gardeners and nongardeners alike. A pot of tulips, daffodils or other spring flowering bulbs is sure to brighten a dreary winter day and elevate the recipient's mood.

Spring flowering bulbs need 12 to 15 weeks of temperatures between 35 and 45 degrees to initiate flowering. This happens naturally in areas with cold winters. Bulbs are planted in the fall, receive the chill they need, and add welcome color to the spring garden.

Those in warmer climates, typically zones 8, 9 and 10, need a different approach. In those areas, low chill bulbs that don't need as long a cold period or pre-cooled bulbs are grown. The pre-cooled bulbs also sold as pre-chilled, have received the needed cold period and can be grown like annuals.

No matter where you garden, spring flowering bulbs can be chilled in a spare refrigerator. Keep bulbs away from apples and pears. These fruits give off ethylene gas, a natural hormone that does not harm people, but can hasten ripening and interfere with flowering when bulbs are stored in the same refrigerator compartment. Check the pots occasionally and water when needed to keep the soil slightly moist, but not soggy wet.

Some friends and family may appreciate a DIY bulb forcing kit as their gift. Spring flowering bulbs, potting mix, and a container with drainage holes are all that is needed. Provide directions

for assembly, suggestions for providing the cold treatment if needed and proper care.

Others may prefer a gift that requires minimal care like Gardener's Supply Company's Months of Bloom. location to extend their bloom time. Once the plants are done blooming, you can add them to the compost pile.

For those that prefer to enjoy them a second season and beyond, provide some post-flowering care. Remove the faded flowers and move the container to a sunny window. Keep watering thoroughly whenever the top few inches of soil begin to dry.

Pour off any excess water that collects in the saucer to prevent root rot and apply a dilute solution of any flowering houseplant

Once the leaves turn yellow and die or the soil in the garden warms and the danger of frost has passed, you can move them into the garden. Tulips and hyacinths perform best in sunny areas with well-drained soils. These two bulbs tend to flourish for a year or two and then produce few or no flowers. Keep that in mind as you plan for the future.

Daffodils and grape hyacinths will grow in sun or shade and a variety of soil types. These tend to be long lived as they grow and spread over time.

It may be two years before you have flowers but it's a great way to extend the enjoyment of a holiday gift.

On a cool Thanksgiving night in 2012, the New England Patriots and the New York Jets squared off in front of a crowd of over 79,000 fans at MetLife Stadium. There was nothing particularly noteworthy to be gained by either team with a victory, as the Pats had a 3 game lead over Gang Green in the division standings. The game started uneventfully, with a scoreless 1st quarter. HOOPS and HOCKEY in the HUB

A PREVIEW OF THE PLAYOFF POSITIONS — That's how current Bruins President Cam Neely and former B's coach Claude Julien view the NHL standings on Thanksgiving Weekend even though it will be a number of months until the conclusion of the regular season.

Both are of the opinion that how the teams stand at this time of year is a pretty good indication of how things will work out by the end of the regular season. Right now that seems a bit distant since the final day of action in the regular season is April 29th.

So download the standings from one of the days on Thanksgiving Weekend (or clip them out if you are a fan of print edition newspapers) and consult them again on April 30th.

The Bruins, for example, will have played only 18 games of the 82 scheduled contests by November $28^{\rm th}$, the Sunday of Thanksgiving Weekend. That leaves some 64 games remaining.

Thus, with so much of the schedule still to be played, these potential previews can turn out to be quite inaccurate. Consider, for example, the 2018-2019 season when the St. Louis Blues got off to a poor start. They began the 2019 portion of the schedule literally occupying last place in the entire league, yet went on to not only make the playoffs but to win the Stanley Cup, defeating the Bruins in six games.

So, with all due respect to Cam Neely and Claude Julien, consider these previews with a wayward eye. As has come to pass in prior seasons, there could well be several teams battling for the final playoff spots right down to last day.

BRIEFLY A BRUIN BUT A KEEPER IN COLUMBUS — Once he played for the B's on Causeway Street, but if you were not paying close attention, you might have missed him.

He was number 61 — Rick Nash — in the twilight of his career. Traded to the Bruins by the New York Rangers just before the trade deadline in 2018, the regular season was so close to a conclusion that he actually saw action in more games during the Stanley Cup Playoffs.

But now Nash, the current director of player development for Columbus, will be honored this coming March 5th when his number will be retired in a pre-game ceremony. It was the Jackets that originally selected him first overall in the 2002 NHL Draft after he amassed 138 points across 112 games during a two-year stint in the Ontario Hockey League.

And on hand for the ceremony will be Nash's final team — the Bruins. They will be playing Columbus that day as the former Blue Jacket has his number raised to the rafters, the first player to be so honored in the history of the Columbus franchise.

Nash requested a trade after nine years in Columbus yielded just one brief playoff appearance (2009). He went to the Rangers for most of six seasons, save for those final weeks in 2018 when he was sent to the Hub.

A forward, he still holds the Columbus franchise records for most games played (674), most goals (289); most assists (258) and most points (547). He earned two gold medals at the Winter Olympics (2010 and 2014) as a member of Team Canada.

While with the B's he played in 11 regular season games scoring three goals to go with three assists. In the 2018 playoffs that followed he saw action in 12 contests, finishing with three goals and two assists.

His last NHL game as an active player came on May 6, 2018 as Tampa Bay scored a 3-1 victory to eliminate the Bruins 4-1 in the second round of the Stanley Cup Playoffs.

IGINLA INDUCTED INTO HALL OF FAME — Former Bruin Jarome Iginla received the notification of his election to the Hockey Hall of Fame when he was otherwise busy, as he tells it.

While standing in line at a rental car counter in British Columbia, Iginla received not one, but two calls from Toronto that attempted to inform him of his selection. Not realizing the nature of the calls, he hung up twice.

As a report on NHL.com noted, only when he received a text message from Lanny McDonald, the chairman of the Hall of Fame, telling him to call back, did he finally receive the news that every NHL player would love to hear as a career capstone.

Iginla's story was one of many that came out of this year's Hall of Fame celebration that saw him join the ranks of those already enshrined. A prolific scorer as a forward, he played the first 16 years of his career in Calgary before being traded to Pittsburgh for the final 13 games of the 2012-2013 season. That was the year that Boston lost to Chicago in the Stanley Cup Final.

As a free agent (and perhaps encouraged by the B's performance), he signed a one-year contract with the Bruins over that summer. The veteran proceeded to play in 78 games during the 2013-2014 campaign, scoring 30 goals and adding 31 assists for a total of 61 points across 78 games as the B's won the Presidents' Trophy by compiling the most points (117) during the season.

He also scored five goals and had two assists in 12 postseason contests. The Montreal Canadiens eliminated the Bruins in a second round Eastern Conference Playoff series that went the full seven games.

Not re-signed by the B's due to salary cap constraints, he later played with Colorado followed by a partial year with Los Angeles before hip surgery in 2017 curtailed his career.

His final statistics include 625 goals and 675 assists for an even 1,300 points across 1,554 games. He added 37 goals and 31 assists in 81 career playoff games. He also won two gold medals in the Winter Olympics (2002 and 2010) as a member of Team Canada.

And although he left the Bruins, he never really departed from the Boston area. According to internet sources, he and his family have lived in Chestnut Hill since 2017.
