## St. Joseph's Society Gifts \$1 Million to Restoration of St. Leonard Church in Boston's North End

How do you say, "Thank you" to people who have stood by you, in good times and bad, for more than 100 years?

That's the question pondered by the Society of St. Joseph when they became aware that St. Leonard Port Maurice Church was in the midst of a multi-million dollar restoration project. In fact, the St. Joseph Society could think of a million reasons — both spiritual and practical — to support the good Franciscans who administer St. Leonard. It was to say "thank you" for the past as well as to preserve the future, that the Society of St. Joseph voted to give \$1 million dollars the — largest gift ever received by the parish — to cover the remaining costs of St. Leonard's Restoration Project.

The St. Joseph Society reflected on the record. When the deadly flu pandemic struck the North End in 1918, leaving hundreds of orphans, it was the Franciscans of St. Leonard's that established the Italian Home for Children in Jamaica Plain to care for them.

When thousands of poor and illiterate Italian immigrants



crowded the North End at the turn of the 20th century, it was the Franciscans of St. Leonard's that established St. Anthony's Elementary School as the first step in insuring a brighter tomorrow for young Italian Americans.

As the need for education became clearer, it was the Franciscans of St. Leonard's that established Christopher Columbus High School for boys and Julia Billiard High School for girls.

Beyond all of that, the St. Joseph Society reflected on so many calls in the middle of dark nights when the Friars responded to the sick. They also remembered how many times the Friars administered the sacraments, from baptism to the Sacrament of the Sick.

So it was decided. In the

End for the next hundred years.

## Pearl Harbor Remembered on 76<sup>th</sup> Anniversary

When I was growing up in the '50s' and '60s, I was lucky enough to have actually known and talked with several retired U.S. Navy veterans who had survived December 7, 1941, at Pearl Harbor, that day of infamy that was still very much in the minds of those who lived through the horror.

The Japanese Imperial Navy launched a surprise attack when they bombed Pearl Harbor for over two hours, killing more than 2,400 American sailors and civilians, damaging 20 ships, and destroying 164 planes. The destruction of the *USS Arizona* killed 1,077 men, nearly 50 percent of the total dead that Sunday morning.

Last Friday morning, I was over at the Charlestown Navy Yard by the *USS Cassin Young* for the 76<sup>th</sup> Remembrance Day for the victims of Pearl Harbor.



### Updated Massachusetts K-12 Standards are Worse in English, Still Mediocre in Math

The 2017 update of Massachusetts' English and Math K-12 academic standards represents further deterioration in English, while the math standards are essentially unchanged from the 2010 version according to the first independent evaluation of the newly revised standards, published this past Tuesday by the Pioneer Institute. The 2010 standards, which were based on Common Core, led to declining scores on national tests in both English and math.

**The new English standards** will result in students leaving high school with little knowledge in areas such as literature, language, and literary criticism.

"These standards rely on process- and skills-based ideas, which brush aside knowledge of Western and English literary traditions," said Emory University English Professor Mark Bauerlein, co-author of **Mediocrity 2.0: Massachusetts Rebrands Common Core ELA and Math**. "The result is a set of standards light on content but heavy on fuzzy subjective terms such as 'high quality' and 'challenging.' Great works of literary art and the history of the English language, not to mention the American patrimony, disappear."

Rather than identifying some works as superior to others, the appendices to the standards simply include long lists of suggested authors and works, which are largely derived from Common Core. Moreover, they touch briefly on a number of cultures, informing a curriculum that is without context or a coherent sequence. This makes students less likely to retain the material.

**The new mathematics standards** are not an improvement over the Common Core-aligned standards adopted by Massachusetts in 2010. Under the new standards, Massachusetts students will remain three or more years behind their peers in high-achieving countries like China, Japan, South Korea, and Singapore.

"These standards are based on the idea that the math students used to learn is obsolete," said Stanford University Professor Emeritus of Mathematics James Milgram, who co-authored the study. "But mathematics is entirely hierarchical. Areas that have become more prominent in the 21<sup>st</sup> century require the same basic math foundation."

In high-achieving countries, multiplication and division are taught simultaneously. When a student learns that  $8 \times 4 = 32$ , she also learns that  $32 \div 8 = 4$  and  $32 \div 4 = 8$ . Separating the two topics results in Massachusetts students being at least two years behind their peers in high-achieving countries by the time they finally complete division in sixth grade.

Ratios, rates, percents, and properties are not introduced until sixth grade in Massachusetts. In high-achieving countries, they are richly represented in the third- or fourth-grade curriculum.

The Massachusetts high school standards focus on general properties rather than properties of important, explicit functions, like linear functions or square roots. The intent appears to be to give students a superficial familiarity with the easier aspects of these topics rather than to teach them to use core math skills.

After the Commonwealth adopted Common Core in 2010, the amount of classic literature students read was cut by 60 percent and students now don't reach algebra until ninth grade. The delayed math progression makes it much more difficult for students to succeed in math or science studies in college.

Between 2011 and 2015, Massachusetts was one of 16 states whose NAEP scores fell and its scores are no longer the nation's best in eighth-grade reading.

SAT scores have also fallen, with a particular drop in student writing that is likely attributable to the reduction in literature.

### HADRIAN THE CRITIC

Hadrian was always ready to criticize the learned men of his day, but he also bestowed upon them great wealth and honors. Teachers who were not fit for their positions were presented with token honors — and then dismissed from their positions.

Some of his friends were refused nothing while, for some unexplained reason, others that had helped him in obtaining the imperial power, he reduced to poverty. Some persons he drove to suicide while others he attacked through certain publications. A well-known philosopher of the day yielded to Hadrian's criticism of a word that was used and this brought ridicule from the philosopher's friends, whereupon the philosopher replied to those friends: "You are urging me to take a wrong course when you do not expect me to regard as the most learned of men the one who has command of thirty legions."

Hadrian possessed a remarkable memory along with great powers of concentration. He personally dictated his speeches and was extremely witty. A story is told of his refusing a request of a gray-haired man. Later, the

man returned with dyed hair and made the same request, whereupon Hadrian replied, "I have already refused this to your father." He was able to call a great many people by name even though he had heard it only one time. He was also able to read a considerable amount of written matter very quickly and then repeat it from memory. Incredible as it might seem, he was able to write, dictate, lis-

ten, and converse with friends, all at the same time. He had a complete knowledge of his state budget and all of its details and kept abreast of all actions taken by his magistrates. He never allowed his freedmen (former slaves) to play a prominent role in public affairs or to have any influence over himself and he punished any who lied or boasted of such influence.

Although he was accomplished in poetry, prose and the arts, he ridiculed those persons who were obviously more learned than him; some were even subjected to scorn and humiliation. Hadrian's passion for literacy fame grew to such proportions that he even wrote his own biography and then gave it to his educated subordinates with orders to release the material as their own creation. Lastly, he was so proficient in astrology that during the early part of January, he made his personal written predictions for the coming year. And it is said that he also recorded with uncanny accuracy all that he was going to accomplish, almost to the very moment of his death.

## Saint Elzear of Sabran and Blessed Delphina

Baron of Ansouis, Count of Ariano, Elzear was born in the castle of Saint-Jean-de-Robians near Cabrières-d'Aigues in Provence, southern France, in 1285. He was son of the Count of Ariano from the Kingdom of Naples, Italy. His mother consecrated him to God as soon as he was born. He was well educated in the sciences as well as in the exercise of weapons, becoming an outstanding knight and a champion in the tournaments. He married Delphine of Glandèves and, by mutual agreement, they took a vow of perpetual virginity. Both joined the Secular Franciscans, the Third Order of Saint Francis. Their piety extended to the running of their household — everyone in it was expected to attend Mass daily, go to confession weekly, and be ready to



forgive injuries. As part of the corporal works of mercy they personally practiced, twelve poor people dined with them every day.

For a time, Elzear was a counselor to Duke Charles of Calabria in southern Italy. When his father died in 1309, he inherited the County of Ariano and went to Italy to assume the governance of his territories, which were located within the kingdom of Naples and in southern France.

Elzear joined John, brother of the King of Naples, in commanding an army against Emperor Henry VII, who led the anti-papist Ghibelline party in Italy. They defeated the German sovereign, who died soon after in 1313. In 1317, Elzear returned to Naples to become the tutor of Duke Charles and, later, his prime minister when Charles became regent. In 1323, he was sent as ambassador to France to arrange a marriage with Marie of Valois for Charles.

After four years of separation, Delphina joined Elzear in France and found him among the brilliant courtiers wearing magnificent clothes. She feared that during this period of separation, Elzear had forgotten his religious duties and became worldly. He sensed her thoughts and assured her that despite appearances, he always remained faithful to the Franciscan spirit, revealing a hair shirt that he wore constantly under his garments.

Elzear was sent to the court of Paris on matters of state and there he became seriously ill. He prepared himself for death, making a general confession of his whole life and receiving the last sacraments, and passed away on September 27, 1323. Delphina continued her works of charity for 35 years after Elzear's passing. Elzear and Delphina are buried in Apt, France. He was canonized in 1369 and she was beatified in 1694. The feast day of Saint Elzear of Sabran is celebrated on September 27<sup>th</sup>.

Few of the survivors of that attack are with us today. But at the Charlestown Navy Yard, Emery Arsenault and Freeman K. Johnson, both 96, joined the *USS Constitution's* commanding officer Nathaniel Shick on the *USS Cassin Young*. Arsenault served on the *USS St. Louis* and was among those survivors who were present at Pearl Harbor last year for the 75<sup>th</sup> anniversary remembrance.

Both WWII veterans joined Shick and threw wreaths of red, white and blue flowers over the side of the *USS Cassin Young*.

In a tribute to the heroes who perished that day and to the two aging survivors still with us, National Parks of Boston Superintendent Michael Creasey stated, "The spirit of what our veterans did to keep our country safe is remembered in ceremonies like this and we

are honored by the presence of all veterans who have served with such distinction."

The attack on Pearl Harbor became a wake-up call for America and, in all our struggles since, we will remember the sacrifice made that December morn in 1941 and all the sacrifices still being made today by our brave military in a quest to keep American strong and free.





## L'Anno Bello: A Year in Italian Folklore

### A Very Merry History of Christmas Traditions

Lately, it seems as if the world around me can be defined in terms of light — or, sometimes, lack thereof. When I wake up in the morning, a sky as black as a stormy sea greets me, sending me scuttling towards the comfort of a warm breakfast. During the day, the sun is low in the sky, gracefully sending golden spangles of light through the bare trees. The upcoming winter solstice, after all, serves as the darkest day of the year, when night wraps its cloak around the feeble sunlight of a short day. However, the winter solstice also marks the return of the sun, as after this date the sun will stay for a longer time in the sky. No wonder that so many mid-winter festivities, from Christmas to Hanukkah to Kwanzaa, emphasize the theme of light! In preparation for the winter solstice on December 21<sup>st</sup>, I decided to pay attention to origins of the Christmas symbols and customs that surround us. I found a fascinating tale of history and metaphor, of the yearning for light and eternal life. Below are a number of Christmas customs and their beginnings, in the context of both our Italian heritage and universal human nature:

**Pre-Christmas Holidays:** Historians have identified several ancient feasts that served as symbolic precursors to the secular celebrations of Christmas. Our ancestors in Italy gathered for a wild weeklong festival known as Saturnalia starting on December 17<sup>th</sup>. This holiday honored Saturn, the god of agriculture and time. During Saturnalia, slaves and masters exchanged places, a harbinger of the misrule that characterizes Christmas, New Year and Epiphany traditions to this day. Ancient Romans also exchanged gifts on Saturnalia, a custom which has survived in the modern Christmas. Meanwhile, the people of Northern Europe celebrated a holiday known as Yule. They adorned their homes with greenery as an example of eternal life in the midst of the

dark winter and lit candles not only for warmth but to symbolize the return of the sun after the solstice. We still see greenery and candles in our contemporary Christmas decorations and we still use the word Yule to describe the Christmas season!

**December 25<sup>th</sup>:** In her comprehensive book *Encyclopedia of Christmas and New Year's Celebrations*, author Tanya Gulevich outlines the fascinating story of how Christmas became associated with the date of December 25<sup>th</sup>. The earliest Christians did not celebrate Christmas. In fact, though Christmas gets more attention, Easter, which honors the Resurrection of Christ, remains the most important holiday in the Church calendar. Christians were observing Epiphany, the day that the Three Kings visited Baby Jesus, before they observed Christmas. The first mention of Christmas falling on December 25<sup>th</sup> occurs in a calendar from 336 A.D. In the year 350, the Pope officially declared December 25<sup>th</sup> as the date of the Nativity. Some scholars theorize that this date was chosen to bring a Christian perspective to winter solstice celebrations, as the birth of Jesus symbolically offered a return of light in the world.

**Christmas Trees:** Mention the word "Christmas," and the first image that may pop into your mind is that of an illuminated, beautifully decorated evergreen. Pagan's long venerated trees in the winter. Evergreens were considered symbols for eternal life, as they persisted through the cold, barren winter. Romans even adorned their homes with greenery for the solstice celebration of Saturnalia. The Christmas ornaments hanging from the trees, meanwhile, may derive from the medieval practice of paradise plays. Performed around Christmas, these folk dramas recreated the Biblical tale of Adam and Eve. A tree festooned with apples, symbolizing the Tree of Knowledge in the Garden of Eden, formed the centerpiece of these plays.

Christmas trees didn't catch on in America until people caught wind of the fact that the fashionable Queen Victoria celebrated the holiday with a tree, a remnant of her German heritage. The Christmas tree has spread to Italy as well, where it stands as a well-known holiday decoration and is known as *l'albero di Natale*.

**Holly and Mistletoe:** Like the Christmas tree, holly speaks to the potent allegory of eternal life around the winter solstice. An evergreen plant, holly was worshipped during the winter by European pagans. It acquired a Christian perspective in the Middle Ages, when its leaves came to symbolize Jesus's thorny crown and the red berries His blood. Meanwhile, mistletoe, a plant sacred to the Celts, also became equated with rebirth due to its status as an evergreen. The custom of kissing under the mistletoe may derive from ancient Scandinavia, where mistletoe served as an emblem of peace. According to tradition, enemies who passed each other under a mistletoe branch had to lay down their arms and call a truce. In Italy, holly is known as *agrifoglio* and decorates homes for Christmas and New Year's. Mistletoe, or *vischio* in Italian, holds a special place in the country's culture because it was the fabled "Golden Bough" the mythological figure Aeneas needed in order to placate the gods during his journey into the underworld.

**Yule Log:** There is nothing like a warm, crackling log on the fire to conjure images of a cozy, joyous holiday. However, the yule log's origins are enshrouded in mystery. Ostensibly it derives from the Germanic Yule celebrations, the feast celebrating the winter solstice in which greenery and fire were brought indoors to form a literal and symbolic barrier against the cold air. Yule log traditions vary across the world. The English hold a plethora of superstitions around the Yule log, such as one which states that bad luck will follow if the Yule log is extinguished before the night is over or that the log contains healing properties. The French eat *buche de Noel*, or a sponge cake shaped like a log, during their Christmas Eve dinner. In Italy, the Yule log is called *il ceppo di Natale* and is blessed with prayers and songs.

The Christmas traditions which surround us burst with rich symbolism and complex spiritual significance. They remind us of the comfort and joy which characterize the holidays and link us to the universal hopes and desires of our ancestors. These customs tell us that though the nights around the solstice appear dark and gray, the love of family and of our shared humanity ignites the most brilliant light of all. This season, be sure to view the ubiquitous symbols of Christmas with new eyes and spread the love of the holidays to all you encounter!

# THINKING OUT LOUD

### What is the Next Step After They Walk Out of Prison?

As a retired police officer with the state Mental Health department and as a former mental health counselor on a state acute mental health unit, I understand the concerns expressed by Revere City Councilor George Rotondo over his knowledge that three individuals are now living together in the City of Revere and are apparently registered as Level 3 sex offenders, those deemed most likely to re-offend.

Legally, these individuals have broken no laws in living at one residence. One community resident in the news story added, there wasn't a place on Earth for these guys. This is understandable because of the fear of re-offending. However, once someone completes their prison sentence, they get released. In Massachusetts, upon release they must register as sex offenders and report their addresses to local police. If they don't, they could go back behind bars.

There is no requirement that sex offenders must live alone, therefore nothing illegal about sharing a place with other sex offenders. Criminal law simply has not caught up with sexual predators. What to do when they finish their sentence for a criminal act? Some states like Kansas and Minnesota, just to name two, have the abil-

ity to seek a judge's order to place them in a mental health facility for up to a lifetime if they are deemed still dangerous to society. However, many civil libertarians see this as a double punishment, i.e., getting punished twice for the same crime. Civil confinement isn't a new prison sentence but, like a duck, if it walks, quacks, and looks like a duck, it will be viewed as a double dose of jail time for these sex predators.

I am not an advocate for the civil rights of sexual predators, but everyone in criminal justice knows that eventually all of these predators usually finish their prison time, then what? Can someone be sane enough for prison and then eventual release then be deemed unready to re-enter society?

The law must catch up to this reality. Should Level 3 sex predators ever get released from behind the wall? If they do, then what? We don't punish folks for what they might do in the future.

No wonder most of society is outraged when a sex offender becomes their neighbor next door. The best advice until the laws get tweaked — be wary of everyone and protect your children. Keep your eyes open and pray to God your kids remain safe.

### SHE LOVES ME

is a Romantic Delight in Stoneham

If you are feeling a bit overwhelmed by holiday shopping, I would suggest you take a couple of hours away from the madness and stop by to see the Greater Boston Stage Company's production of *She Loves Me*. This very warm musical, which had its first run in 1963, will be familiar to many of you who have seen the movie *The Shop Around the Corner*. The story about a romance that began through letters and involves mistaken identity is funny, touching, and warm. It is also quite enjoyable.

Of course, with Jennifer Ellis in one of the lead roles, you could never be disappointed. Ms. Ellis is a positively outstanding talent with a superb singing voice and amazing acting ability. I would pay just to see her read the phone book. Yes, she is that good.

Ellis as Amalia Balash plays opposite Sam Simahk, who takes on the role of Georg Nowack. They have an onstage chemistry that is magical. Having such a wonderful score to showcase their voices doesn't hurt.

The play is set in Hungary as Christmas approaches and revolves around the romances both Amalia and Georg are having via mail (not email, but the letters you have to put a stamp on and deposit in a mailbox, remember those?) with people they have not yet met. It turns out the two have been writing to each other without realizing it, which becomes more complicated when Amalia gets a job at Maraczak's, a perfumery where Georg is already employed. The two do not hit it off well. The confusion draws in the other

employees of the store, as well as Mr. Maraczak (Tom Gleadow), who is also dealing with a case of mistaken identity.

Local favorite Jared Trolio plays the obnoxious Steven Kodaly, who is pursuing fellow employee Ilona Ritter played by Aimee Doherty. Trolio is just wonderful in the number "Ilona," which has a bit of a Mambo bit. Ms. Doherty will have you smiling with "A Trip to the Library."

"A Romantic Atmosphere" with Nick Sulfaro as the maitre d' of a local restaurant is one of many standout numbers that include "Tonight at Eight" (Georg), "Vanilla Ice Cream" (Amalia), and "Where's My Shoe?" (Amalia and Georg). "Perspective," sung by employee Ladislav Sipos (Robert Saoud), is filled with advice on how to keep your job. The delivery boy and aspiring clerk Arpad (Brendan Callahan) appeals for a promotion in "Try Me." It would be very hard to refuse him after hearing his musical argument.

The story is not a complicated one, but it is so enjoyable to watch. The musical numbers are just wonderful and, with Musical Director Matthew Stern at the helm, the orchestration is tight. The choreography by director Ilyse Robbins is smooth and light.

While the entire cast and production are wonderful, Ms. Ellis and Mr. Simahk are positively great. This is a play worth seeing. It will leave you with a big smile on your face.

### This Man of La Mancha

is Not Quite the Impossible Dream

The New Rep Theatre's current production of *The Man of La Mancha*, directed by Antonio Ocampo-Guzman, looked promising as the cast took the stage. It appeared it would be earthy and salty but, unfortunately, it did not turn out that way. I found this version to be disjointed and confusing. At times, I wasn't sure if it was reminiscent of a production done in Berlin in the 1920s or a Harvard Square

coffeehouse in the 1960s. The transitions were choppy and it did not convey the edginess that it meant to.

Having the musicians playing instruments while acting their parts on a set that resembled backstage at a theater was a nice touch, but the music was at many times tinny. Lead actor Maurice Emmanuel Parent, who was superb in the Speakeasy's production of *Scottsboro Boys*, doesn't seem able to quite settle into his role. I don't think it is as much him as it is the material he is working with.

This is a production had a lot of potential, but it could be possible the director got too caught up in trying to send a message about the current state of politics today instead of letting the work be subtler and allowing the audience to read into it their own interpretation.

### MANY PARENTS NOT LIKING NEW START TIMES FOR SCHOOLS

Many parents are calling on the Boston Public Schools not to start new times next September and are arguing that they will be too disruptive with after-school activities and day care. An online petition has been started and already has 2,500 signatures. The city responded that it is currently talking with after-school program partners to work along with the city's public schools.

### IS IT TIME FOR AN ELECTED SCHOOL BOARD AGAIN?

Recently, Action for Boston Community Development (ABCD) sponsored a discussion on the Boston School Committee in which a panel of elected and community leaders talked about whether or not Boston should, among other things, return to an elected school board.

ABCD CEO John Drew says the legislation creating the appointed board 25 years ago "disenfranchised parents from saying what could happen to their children when they go to public schools" (see related story above). John Tyler, a member of the panel who runs the Municipal Research Bureau, supports the appointed board saying being appointed means the board can focus on policy rather than politics.

Personally, I support the return of an elected body, which I believe would better serve the interests of parents than an appointed board serving the wishes of City Hall. In all transparency, I was a short-time candidate for the District 1 school committee seat in 1983 when the reform went into effect. Politics and public policy can work hand in hand. Even with an appointed board, does

anyone think there's no politics involved?

Bring back an elected Boston School Committee.

A Nostalgic Remembrance

For those of you who can't make it to a book signing and would like an autographed copy of my latest book, **TRUE SHORT STORIES**, send a check for \$20.00 made out to me, **JOHN CHRISTOFORO**, and mail it to **Beagsley Publishing Co., Box 342, Arlington, MA 02476**. The book is a compilation of 18 short stories about growing up in East Boston in the mid-1950s and attending English High School. It details almost everything I did and got away with as a teenager.

The year was 1948, and Christmas was coming. Mom and Grace Manfredonia had made plans to take me and the, then, three Manfredonia children to see Santa Claus.

Grace and her husband, Ralph, were the owners of 74 Eutaw Street where Mom, Dad and I lived. Plus, they all knew each other from when they were young. John Manfredonia, their oldest, and I were born a week apart and were inseparable until we hit our teen years. The plan was to take us to Jordan Marsh to see Santa. Jordan's had the largest toy exhibit in New England and that's where the REAL Santa Claus was located. We knew that many stores had Santa imitations, but the real Santa was operating at Jordan Marsh. Mom and Grace Manfredonia had an ulterior motive. Jordan Marsh had a café where they sold the best blueberry muffins made in the City of Boston and, after the visit to the toy department and a sit-down with Santa, we would all be hungry enough to sample those famous muffins.

We would head down the Eutaw Street hill, take a trolley to Maverick Station, head downstairs to the trains and somehow wind up at the station under Filenes Department Store, come back up to the street level, and wind up on the corner of Washington and Summer Streets. Filenes had great Christmas displays in their windows, mannequins dressed in period clothing and, of course, electric train and toy displays that intrigued all of us. Their toy department couldn't compare with Jordan Marsh, which meant that their Santa wasn't the real one.

After looking at the displays in Filene's windows, we would head to the 5<sup>th</sup> floor toy department at Jordan Marsh. This was the real thing and we kids knew it. Grace would accompany her daughter, Adelaide, to look at the dolls and Mom would follow John and Fred Manfredonia and me as we headed toward the grandest electric train display found anywhere. They would have a setup consisting of Lionel trains, many of them, traveling from model cities to towns and rural areas with all of the whistle stops, buildings, lakes and hills

one might expect to see in the 1940s. I had Lionel trains at home and would make a mental note of what I saw and wanted to let Santa know when it was my turn to talk to him.

After a lengthy visit to the train display, we boys would head to look at the erector sets and see what ingenious creations we could make if we only had one of them at home.

From there, we would head to an area where they had microscopes and chemistry sets, which interested me, but not my friends. The compromise was the model plane display. I was an avid model maker and had a copy of just about every World War II bomber and fighter used by the Army Air Corps, the Navy, and the Marine Corps. Most of my model planes were made by the Guillow Company of Wakefield and were made of balsam wood. The Jordan Marsh display was of Strombecker planes made from hard wood with more detail than the Guillow planes and I was hooked. The second last thing we would look at was the display of sleds — small ones, large ones big enough to carry two or more kids, and the giant toboggans that we never saw on the streets of Boston. The last thing we had to see was the air rifle and cap gun display. I loved both and wanted pistols and an air rifle, a Daisy pump action Red Rider BB rifle that I could use for target practice in the cellar.

Once the window shopping was over, we headed to wait in line to visit Santa. We would line up and ascend the steps to where he was seated and give him our wish lists for Christmas. I remember asking for additions to my electric train set, additions to my erector set, a chemistry set with the accompanying microscope, air plane models, a set of Roy Rodgers cap pistols, and the air rifle I described. Santa would promise to try to bring me the things I asked for and I was satisfied because I knew that when Dad would ask me what I said to Santa, he would secretly speak to him and be assured that I would get everything I wanted.

When the two families were all back together, our mothers would insist we head for the famous Jordan Marsh blueberry

muffins. We would then go to the café, find a table, and dig into to their creations. Mom and Grace with their cups of coffee and we kids with glasses of cold milk enjoyed those delicious muffins and discussed what we asked Santa to bring us for Christmas. Just before we left the café, our mothers would each buy a dozen muffins to bring home and then we would retrace our steps to get back to East Boston. From that point on, it was anticipation as we awaited the arrival of Santa.

on that Christmas Eve. I left out a dish of cookies for Santa with a glass of Zi'Antonio's best home-made red wine and a note of thanks for my presents. On Christmas morning, I found many of the things I had asked for, with the exception of the air rifle and chemistry set. A note from Santa assured me that when I was older, I could ask for them again. What were conspicuously missing were the additions to my electric trains. I was unhappy until the phone rang and Babbonnonno on the other end explained that Santa Claus had made a mistake and delivered my trains to him and Nanna. Dad and my uncles played music day and night during Christmas season and Uncle Nick, who picked up the trains, couldn't get them to our house in time for Christmas Day and left them with Babbonnonno. It didn't matter, I bought the story told me by Babbonnonno and, after breakfast, ran from Eutaw Street to their apartment on Princeton Street and picked up the additions to my train set.

There was one problem, though. When I returned with the trains, Uncle Gino and Aunt Ninna were already at our flat, and they and Dad helped me add in the train parts to my setup. The problem was that I couldn't get at the trains for quite a while as they all played with them without me for about an hour. GOD BLESS AMERICA

**CASSATTEDI**  
"ka-sa-ted-dee"

A Sicilian Christmas Ricotta Cheese Turnover

- |                                  |                              |
|----------------------------------|------------------------------|
| 1 pound container ricotta cheese | 1/2 teaspoon sugar           |
| 2 cups flour                     | Pinch of salt                |
| 1 tablespoon orange rind         | Pinch of cinnamon (optional) |
| 3/4 cups water                   | 2 cups cooking oil           |
| 1 tablespoon red wine            | Additional granulated sugar  |
| 1/4 cup shortening or margarine  | 10-inch Teflon skillet       |

Place ricotta cheese in a colander to drain. Put flour in ten-inch bowl. Cut in shortening with knife and fork. Add sugar and salt. Mix while adding water slowly. Before using all water, work red wine into mixture. (Wine causes dough to bubble when fried.) Continue mixing dough until it holds together and all flour is used. Knead dough to a smooth consistency. Separate into three portions. Roll each into a long piece. Cut roll into smaller portions approximately one-inch thick. Place in bowl and cover.

Transfer drained ricotta into bowl. Add orange rind and cinnamon and mix thoroughly by hand. With rolling pin, roll each piece of dough into paper-thin rounds. Place a tablespoon of ricotta in center of dough. Fold over (like turnovers). Press lightly around filling to allow inside air to escape. Then seal edges with crinkled pastry cutter or press edge with fork. Set aside on pastry cloth or a flour-dusted tablecloth. Makes about twenty-four Cassattedi.

Pour enough oil in a ten-inch Teflon skillet to cover bottom. Prick top of six Cassattedi at a time (with a pin) before placing in hot oil, *top down*. When frying, turn each one with spatula until golden brown on both sides.


When any ricotta or fluid escapes into the hot oil, the liquid will splatter and burn. Remove Cassattedi from oil. Clean skillet. Add and heat new oil and continue frying remaining Cassattedi.

Place fried Cassattedi in a serving platter layered with granulated sugar. Sprinkle additional sugar on each one. Serve hot or cooled. Leftover Cassattedi must be refrigerated.





For a while, they were in somewhat of an unaccustomed position. After all, they play a sport where their executive leader proudly proclaims, "There is no out of bounds."

Yet, in some ways, for the past few weeks, it did seem to appear as if they had been nudged, perhaps not out of bounds, but definitely to the side, by their winter sports neighbor on Causeway Street.

We speak, of course, of the Boston Bruins, who have proudly represented our town in the National Hockey League since 1924, a community that has, via the talented word-smithing of esteemed *Boston Globe* hockey writer Kevin Paul DuPont, come to be called "the Hub of Hockey."

And yes, it was during a media day interview session a few years ago that one Cameron Michael Neely, formerly a standout player for the Black and Gold and presently the President of the Bruins, made his comment about the continuous flow of the game of hockey, how the boards confine the action to the area of play, in contrast to many other sports where the action ceases due to out of bounds areas.

But it seemed for a while, at least until the Bruins righted their own ship with a recent burst of victories, that the seasonal sports spotlight had swung somewhat away from the Bruins and more pronouncedly in the direction of the Celtics.

Think back a bit. When the Celtics were in the process of putting together a significant winning streak that eventually stretched to a span of 16 games, didn't nearly everyone have an opinion on the 2017-2018 edition of the team that plays on the parquet?

Of course they did. Their somewhat unexpected resurgence given the Gordon Hayward injury seemed to be the talk of the region. Even at a Thanksgiving dinner hosted by relatives who are diehard Bruins fans (they've been known to fly the Bruins flag on game days outside their house and their mailbox on a rural road is adorned with the Bruins logo), it became apparent that their allegiance had been somewhat adjusted to accommodate the Celtics.

"How about those Celtics?" said one of the relatives who loves the Bruins. "I didn't think they were all that keen on basketball," I said to another relative. "They are now," came the response.

And thus, the bandwagon ballooned as the number of victories ventured ever higher in number.

It was during this time that the Bruins toiled away. Although the live gate attendance never wavered (it was continuously announced as a sellout of 17,565), it was plain that the Bruins were falling behind in the parlance of public conversation.

In addition, while the Celtics were leading, the Bruins were bleeding — if not literally, at least figuratively. Injuries seemed to pile upon injuries and the calls to Providence for

replacements from the AHL franchise seemed to multiply as numerous players were away from the ice for various medical reasons.

And yet the Bruins, to their everlasting credit, never really sank. They managed to tread water. Like swimmers at the beach who might temporarily go under as the surf sweeps over them only to reappear bobbing in the water after the waves have passed, so too the Bruins never really sank but did enough to sustain themselves.

And eventually the hard work paid off as the Bruins recently came away with eight victories in a ten-game span.

"We've had a lot of different faces on the team this year," noted Marchand from the perspective of a veteran. "A lot of our older guys have been out early with injuries. It's given guys opportunities and guys have taken advantage of that. The fact that we've been able to kind of stay above water shows the character of this group. It's going to help us again moving forward, the fact that guys have had an opportunity to play early on. You see guys stepping up huge."

Patrice Bergeron, who, like Marchand, has seen it all in his career on Causeway Street, feels that the key to the winning stretch was "playing good defensively. Plus getting some guys back has helped us."

But there's also been a silver lining. As Marchand noted, all those injuries gave younger players opportunities, which resulted in learning experiences.

Now, with injured players returning, Bergeron's keen eye picked up on this factor. "We have more depth now than we thought we had at the beginning of the year. It's definitely nice to have."

Rask, the veteran netminder back in the lineup and doing quite well, has noticed the difference. "Guys are doing a good job of eliminating the second chances and, obviously, if the other team doesn't get rebounds all the time it helps."

Another important aspect is forcing opponents to take shots from less than ideal areas on the ice. "We're also skating back so hard, we're forcing people to take shots in bad spots where they don't have all the time in the world," Rask observed. "We're shutting them down and also blocking a lot of shots. I think all of those things together have made it."

Yet, despite all the recent positives, one aspect of the game that has consistently hurt the Bruins this season has been the team's lack of scoring. As of December 13<sup>th</sup>, the Bruins were next to last in goals scored by Eastern Conference teams (ahead of only Buffalo) and were 27<sup>th</sup> out of the entire 31-team NHL in goals scored.

That was through 27 games played by Bruins, so literally about two-thirds of the schedule lies ahead. Goal scoring wins games. Unless the Bruins can increase the number of goals they put in the net, the chances for a playoff berth in the spring will remain up in the air at best.
