Edwards Wins Special State Primary for State Senate

Lydia Edwards is now bound for an historic victory next month after claiming victory in Tuesday's special state senate election and said, "I'm proud of who I am, of hope I got here. We did this. We did this."

Edwards garnered 77.49 percent of the vote to fill the seat in the Massachusetts State Senate in the First Suffolk & Middlesex District, according to the Boston Election Commission. Revere School Committee member Anthony D'Ambrosio, 25, wound up with a 22.17 percent share of the Boston vote.

Lydia Edwards is currently Boston City Councilor representing District 1, which includes East Boston. "I am just overwhelmed by this moment. Boston put me on the map ... and it took a lot to get here." At another point during her victory speech, she said, "We won Winthrop 60-40."

Edwards is now a lock-in guaranteed to win the general special election to be held on Tuesday, January 11th.

No Republican ran in the GOP state primary so Edwards

is on track to become the first woman and first person of color to represent the Senate district.

The seat was vacated earlier this year by Joe Boncore, who left for a position as CEO for MassBio, which triggered the special election.

During the campaign, many across the district were impressed with Anthony D'Ambrosio out on the campaign trail. He definitely has a future in politics if he wants it. We have not heard the last of him.

Baker-Polito Administration Announces 2.1 Million At-Home COVID Tests

State Announces Initiative to Make Purchasing Tests Easier for Municipalities

for 102 High-Need Communities

The Baker-Polito Administration announced plans to increase access to at home COVID-19 test kits for residents across the Commonwealth. The Administration has secured 2.1 million iHealth Labs over-thecounter (OTC) at-home rapid antigen tests that will be delivered to 102 towns with the highest percentage of families below the poverty level. These free tests will be available for distribution to the public by each municipality, with an emphasis on increasing access for individuals and families who are facing financial hardship.

"With the holidays approaching, we encourage residents to utilize rapid tests as a convenient way to keep family members and friends safe at gatherings," said Governor Charlie Baker. "While these tests are widely available at many pharmacies and retail locations across the Commonwealth, we are making it even easier for residents to get free rapid testing through these initiatives."

"Massachusetts has developed a nation-leading testing infrastructure, with free testing available across the Commonwealth," said Lt. Governor Karyn Polito. "Increasing access to these free OTC rapid antigen test kits will serve as another tool to combat COVID-19."

While the initial 2.1 million OTC rapid antigen tests will be distributed to 102 highneed communities across the Commonwealth, the Administration is finalizing plans to allow municipalities and other public entities to directly purchase tests from test manufacturers at fixed, state-negotiated prices. The Administration posted a procurement opportunity on Friday,

December 10th for manufacturers, and municipalities will be able to order in January 2022. The Administration will provide more details on how municipalities can procure these tests later in the coming weeks. Municipalities are able to utilize American Rescue Plan Act funding, as well as Federal COVID-19 Relief funding to purchase the rapid antigen test kits.

At-home COVID-19 rapid antigen test kits are a fast, easy and convenient way to test for COVID-19. In addition to the Administration providing iHealth Labs OTC at-home rapid antigen test kits and allowing municipalities to directly purchase tests, residents can visit local pharmacies or order online to purchase rapid test kits on their own, as needed.

Massachusetts performs more COVID tests than almost any other state in the country thanks to the hundreds of existing testing locations across the Commonwealth; including 38 free state sponsored Stop the Spread testing sites. Residents can continue to access these COVID testing sites during the holidays. All testing sites are listed here: mass.gov/gettested.

HOW THESE COMMUNITIES WERE SELECTED:

The 102 municipalities in the Commonwealth with the highest proportion of families at or below the poverty level are receiving iHealth Labs OTC at-home rapid antigen test kits in this initial distribution. All twenty of the Commonwealth's most disproportionately impacted equity communities were included by these criteria. In total, the 102 municipalities

iHealth Labs OTC at-home rapid antigen test kits will start to be delivered to the eligible communities this week by the Massachusetts Emergency Management Agency, in partnership with the Massachusetts National Guard. Tests will be distributed proportionally across the 102 communities based on the proportion of families living at or below the poverty level within their respective communities.

While each city or town will be able to determine how best to distribute tests within their community municipalities are asked to prioritize those most in need, allocating equitably and at locations accessible to individuals and families who are determined to be in high need and as quickly as possible during the holiday season.

The Commonwealth is paying \$5 per test. All tests come in packs of two. The tests can be completed in 15 minutes without the need to send a sample to a laboratory; a mobile phone or computer is not needed for any part of the test. Individuals 2 years of age and up can use the tests regardless of vaccination status or whether or not they have symptoms.

CDC last week issued guidance on self-tests like the iHealth tests, with information on when to consider self-testing, how to complete the tests, and how to react to a positive or negative result

COVID-19 rapid tests are one of many risk-reduction measures, along with vaccination, that can protect individuals by reducing the chances of spreading COVID-19.

Efforts to Save Peace Park Going Strong

Stirpe Nostra

THE ROMAN COLOSSEUM

For centuries, the Roman Colosseum was considered to be the most extravagant expenditure for public amusement ever made in the world. It was intentionally built as a place for the wholesale destruction of human and animal life for the amusement of spectators, and for witnessing these scenes of murder and butchery, which were repeated hour after hour, day after day, and month after month.

We know that this amphitheater was the scene of fearful barbarities during the persecutions of the Christians. We also know from earlier columns that the reason for these persecutions was because the Christians worshiped their own God and would not pay homage to the Emperor nor would they serve in the Roman Army. They were also falsely charged with starting the fire that burned two-thirds of Rome in 64 A.D. Because of these events, Nero banned Christianity and started the persecutions, which lasted for 250 years.

The structure was also used for Gladiatorial combats for 300 years. For the provision of this fatal service to the Emperor, the empire, and the glory of the Colosseum, they always kept ready in Rome about 10,000 gladiators, held as prisoners. They were strong, athletic, well fed, well lodged, skilled in the use of combat weapons, and had at one time been soldiers themselves who had fought against the Roman Legions and in some instances even defeated them. One thing was for sure; they were absolutely certain of an early death.

The sheer stupidity of it all seems to be the manner in which these herds of human beings accepted their fate, yielded to the ceremonial atmosphere

of the arena, considered this mortal combat as a duty, made the grand procession around the combat area, yelled the famous Ave! And then flung themselves against man or beast in a fight to the death.

The last Gladiator fights took place in 404 A.D. and the last wild beast fight in 503 A.D. Bull fights were held there from 1312 to 1362. No chariot races were held in the Colosseum, these were reserved for the Roman Circus.

There are those who have said that while the building was imposing, because of the nature of its activity, it was never considered beautiful. The exterior was faced with travertine, and had the Tuscan, Ionic and Corinthian Orders superimposed on the first, second, and third stories respectively. The interior had marble facing on the emperor's ringside platform. There was a marble throne, marble seats for the dignitaries and row upon row of stone seats for the spectators. Huge masts projecting from the upper story were equipped to hold brightly colored awnings, which protected the spectators from the summer sun.

During the 15th and 16th centuries, it was used as a quarry to furnish building stones for a number of churches and palaces. The destruction was stopped after two-thirds of the original material was removed. The structure was later consecrated to the memory of the Christian martyrs.

The building got the name Colosseum from the colossal statue of Nero, which stood near it in Ancient Times.

It has been said many times: While stands the Colosseum, Rome shall stand. When falls the Colosseum, Rome shall fall.

What's Your Favorite Christmas Movie?

Democrats' favorite Christmas movie is Miracle on 34th Street. Republicans' favorite Christmas movie is It's a Wonderful Life."

> I first heard that aphorism at a holiday party over two decades ago. It's been around longer than that and I haven't been able to determine who first said it and when. On the face the saying makes sense. After all, what better movie for adults who still believe in Santa Claus than Miracle

on 34th Street? Besides (watch out for plot spoiler) the picture's crisis is resolved when a huge federal government agency the Post Office — comes to the rescue. And with a divorced mother rearing a child alone, Miracle features a nontraditional family, surely a plus in the eyes of liberals.

It's a Wonderful Life, on the other hand, celebrates the infinite worth of an individual human being, a worth that far exceeds even the biggest financial fortune. In Wonderful Life the hero's crisis is resolved (another plot spoiler) by the spontaneous voluntary action of family, friends, and local community; emphatically *not* by the government. The film also shows people in fervent prayer, not to some generic higher power but to the God of the Bible as worshipped by Protestant and Catholic believers. That alone must drive some liberal's nuts when the film is broadcast over the public airwaves.

But the game can be played the other way. Wonderful Life presents negative stereotypes of bankers, so much so that when it was released some Hollywood observers (but not, as is erroneously asserted on some liberal websites, the Federal Bureau of Investigations itself) charged that it was a vehicle for communist propaganda. The charge is easy to ridicule today, but in the 1940s communist infiltration of the motion picture industry was a real and serious threat to American values. Now look at the favorable treatment — not to mention free advertising — that *Miracle* gives to two large department stores! Main Street Republicans surely must find that refreshing compared to the negative views of business that Hollywood gives us today.

The lesson? It's just a movie! Enjoy them both, or whichever ones you choose to watch this holiday season. Santa's list does not include your political affiliation, but he does have a lump of coal for those who would strip our public life of all sense of Wonder at the Love of God and thankfulness for all Miracles big and small.

L'Anno Bello: A Year in Italian Folklore

Solstice, Symbols and Holiday History

Lately, it seems as if the world around me can be defined in terms of light — or, sometimes, lack thereof. When I wake up in the morning, a sky as black as a stormy sea greets me, sending me scuttling towards the comfort of a warm breakfast. During the day, the sun is low in the sky, gracefully sending golden spangles of light through the bare trees. The upcoming winter solstice, after all, serves as the darkest day of the year, when night wraps its cloak around the feeble sunlight of a short day. However, the winter solstice also marks the return of the sun, as after this date the sun will stay for a longer time in the sky. No wonder that so many midwinter festivities, from Christmas to Hanukkah to Kwanzaa, emphasize the theme of light! In preparation for the winter solstice on December 21st, I decided to pay attention to the origins of the Christmas symbols and customs that surround us. I found a fascinating tale of history and metaphor, of the yearning for light and eternal life. Below are a number of Christmas customs and their beginnings, in the context of both our Italian heritage and

universal human nature: • Pre-Christmas Holidays: Historians have identified several ancient feasts that served as symbolic precursors to the secular celebrations of Christmas. Our ancestors in Italy gathered for a wild weeklong festival known as Saturnalia starting on December 17th. This holiday honored Saturn, the god of agriculture and time. During Saturnalia, slaves and masters exchanged places, a harbinger of the misrule that characterizes that Christmas, New Year and Epiphany traditions to this day. Ancient Romans also exchanged gifts on Saturnalia, a custom which has survived in the modern Christmas. Meanwhile, the people of Northern Europe celebrated a holiday known as Yule. They adorned their homes with greenery as an example of eternal life in the midst of the

dark winter, and lit candles not only for warmth but to symbolize the return of the sun after the solstice. We still see greenery and candles in our contemporary Christmas decorations, and we still use the word Yule to describe the Christmas season!

• December 25th: In her comprehensive book Encyclopedia of Christmas and New Year's Celebrations, author Tanya Gulevich outlines the fascinating story of how Christmas became associated with the date of December 25th. The earliest Christians did not celebrate Christmas. In fact, though Christmas gets more attention, Easter, which honors the Resurrection of Christ, remains the most important holiday in the Church calendar. Christians were observing Epiphany, the day that the Three Kings visited Baby Jesus, before they observed Christmas. The first mention of Christmas falling on December 25th occurs in a calendar from 336 A.D. In the year 350, the Pope officially declared December 25th as the date of the Nativity. Some scholars theorize that this date was chosen to bring a Christian perspective to winter solstice celebrations, as the birth of Jesus symbolically offered a return of light in the world.

• Christmas Trees: Mention the word "Christmas," and the first image that may pop into your mind is that of an illuminated, beautifully decorated evergreen. Pagan's long venerated trees in the winter. Evergreens were considered symbols for eternal life, as they persisted through the cold, barren winter. Romans even adorned their homes with greenery for the solstice celebration of Saturnalia. The Christmas ornaments hanging from the trees, meanwhile, may derive from the medieval practice of paradise plays. Performed around Christmas, these folk dramas recreated the Biblical tale of Adam and Eve. A tree festooned with apples, sym-

tree festooned with apples, symbolizing the Tree of Knowledge in the Garden of Eden, formed

the centerpiece of these plays. Christmas trees didn't catch on in America until people caught wind of the fact that the fashionable Queen Victoria celebrated the holiday with a tree, a remnant of her German heritage. The Christmas tree has spread to Italy as well, where it stands as a well-known holiday decoration and is known as *l'albero di Natale*.

• Holly and Mistletoe: Like the Christmas tree, holly speaks to the potent allegory of eternal life around the winter solstice. An evergreen plant, holly was worshipped during the winter by European pagans. It acquired a Christian perspective in the Middle Ages, when its leaves came to symbolize Jesus's thorny crown and the red berries His blood. Meanwhile, mistletoe, a plant sacred to the Celts, also became equated with rebirth due to its status as an evergreen. The custom of kissing under the mistletoe may derive from ancient Scandinavia, where mistletoe served as emblems of peace. According to tradition, enemies who passed each other under a mistletoe branch had to lay down their arms and call a truce. In Italy, holly is known as agrifoglio and decorates homes for Christmas and New Year's. Mistletoe, or vischio in Italian, holds a special place in the country's culture because it was the fabled "Golden Bough" the mythological figure Aeneas needed in order to placate the gods during his journey into the underworld.

• Yule Log: There is nothing like a warm, crackling log on the fire to conjure images of a cozy, joyous holiday. However, the yule log's origins are shrouded in mystery. Ostensibly it derives from the Germanic Yule celebrations, the feast celebrating the winter solstice in which greenery and fire were brought indoors to form a literal and symbolic barrier against the cold air. Yule log traditions vary across the world. The English hold a plethora of superstitions around the Yule log, such as one which states that bad luck will follow if the Yule log is extinguished before the night, or that log contains healing properties. The French eat buche de Noel or a sponge cake shaped like a log, during their Christmas Eve dinner. In Italy, the Yule log is called il ceppo di Natale and is blessed with prayers and songs.

The Christmas traditions which surround us burst with rich symbolism and complex spiritual significance. They remind us of the comfort and joy which characterizes the holidays and link us to the universal hopes and desires of our ancestors. These customs tell us that though the nights around the solstice appear dark and gray, the love of family and of our shared humanity ignites the most brilliant light of all. This season, be sure to view the ubiquitous symbols of Christmas with new eyes, and spread the love of the holidays to all you encounter!

CHAPTER 66 The Meeting



Saint Egwin

Born in the seventh century of royal blood, Egwin was a descendant of Mercian kings. He may possibly have been a nephew of King Ethelred. Egwin entered a monastery, and was eventually enthusiastically received by royalty, clergy, and the people as the Bishop of Worcester, England. As bishop, he was known as a protector of orphans and the widowed and a fair judge. Some clergy complained that he was too strict with them. A group of them, with the support of the king, made an official complaint against him.

Egwin travelled to Rome to present his case to Pope Constantine. According to legend, he put a pair of shackles on his legs and threw the key into a river before he began his journey to Rome. On the sea crossing a fish was caught and when it was cut open, it was found to be carrying the key to his shackles. He accepted this as an expression of the Will of heaven and removed the shackles. According to another version of the legend, the fish was caught in the Tiber, after Egwin had appeared before the Pope in Rome. The Pope dismissed the charges against Egwin and he was soon restored to his diocese.

Upon Egwin's return to England, he founded Evesham Abbey, which was dedicated to Our Lady. The site for the abbey was chosen at a place where a shepherd had experienced a vision of Mary. The Abbey became one of the great Benedictine houses of medieval England.

Egwin undertook a second journey to Rome, in company with both Coenred and King Offa of Essex. St. Egwin died on December 30, 717 AD and was buried in his Abbey at Evesham, to which his shrine brought many medieval pilgrims. His relics were so popular that, when the abbey church required a major rebuilding in 1077, they were taken on a highly successful fundraising tour of southern England, initiating miraculous cures at Dover, Oxford, Winchester and elsewhere. The Feast of Saint Egwin is December 30th.

A Nostalgic Remembrance



When I was a kid, I belonged to the Trinity Neighborhood House, a settlement house located at 406 Meridian Street in the Eagle Hill Section of East Boston. The house was built in 1847 for a local businessman named Noah Sturtevant. In 1917, it became the Trinity House, a recreation facility and day nursery for locals established by the Trinity Church in Copley Square, a member of the Episcopal Diocese of Massachusetts. In 1966, it merged with the East Boston Social Center and has been rehabbed to provide elderly housing for neighborhood folks, but is registered as a landmark, which means that changes to the outside of the building are prohibited.

The Trinity House was within walking distance of Eutaw Street where we lived and I joined the settlement house to learn model making (model planes, that is) and how to play basketball. At one point, I even learned how to box and ballroom dance, but this was years later. They even had a Cub Scout troop in operation at the center, and I joined for a short time, but I had to quit when they told us that we would have to attend a particular Protestant Church that was an affiliate. I wound up joining the Cub Scouts at the Sacred Heart Catholic Church, our parish. Things were that restrictive in those days.

Well, it was 1949, and I was making model planes one evening a week and playing basketball on another and learning to box on another. When I first started, a man named Mr. Dudley was the director. He was replaced by a local, J.J. Dana, and after a basketball game one night, he informed the teams that the Trinity House was having a children's

I told my mother and grandparents about the party when I got home, but the date and time conflicted. Nanna and my mother would be preparing for the Christmas Eve and Christmas day dinners, and Dad would be playing with the band he was with, back then. The only one left was Babbononno.

I asked my grandfather to bring me to the party and he accepted. When I gave him the date and time, he cancelled out a trip to whatever social club he frequented on that night and we were set to go. On the night of the party, Babbononno was dressed in a suit, shirt and tie. He always had to look the part which included a spit-shine on his shoes. He supervised my dressing capabilities and helped me tie a necktie, fearing that I couldn't make a four-in-hand knot. Once he was satisfied with the way I looked, we headed to Meridian Street and the Trinity

When we arrived, we were greeted by Ms. Orr, one of the directors and Edith DeAngelis, her assistant. (Years later, the late Dr. Edith DeAngelis would become an advocate for all things East Boston, but that's a story for another day.) Once inside, there was entertainment and music for us kids, and later, soda and cake. After the treats were consumed, we all sat down and the Gospel According to St. Luke was recited by Ms. Orr as she held a Bible in front of the guests describing the birth of Jesus. After, we might hear The Night Before Christmas, written by Clement Clarke Moore, or Yes, Virginia, There is a Santa Claus, written by Francis P. Church When the evening would come to an end, there was a little gift for each of us that was handed out by Ms. Orr as we exited the building. Babbononno had a sweet tooth and the cake and soda was always to his liking. With him satisfied, I knew that there would be no complaints once we got home.

Around the same time, the Scout Master at the Sacred Heart Church would hold a Christmas party for the kids in the Cub Scouts. His name was Bill McGonagle, and his wife, Mary Jane, was our den mother. I would attend the general party at the church and on another afternoon, a party at the McGonagle house which was on Saratoga Street, a few blocks away from the Sacred Heart.

Back then, Christmas time was a busy period for the men in my family. Dad was playing at Santa's Village in the Jordan Marsh Department Store during the afternoons and several parties in the evenings up to December the 24th. Neither he nor my uncles worked on Christmas Eve. They all had morning jobs on Christmas morning. Uncle Nick played a Christmas party for the kids at the Fernald School in

Waltham. They were all special needs, and to him, this was give back. I don't remember where Uncle Paul played but he had something every Christmas morning, as well. For years, Dad played a Christmas morning party aboard the U.S.S. Vulcan, an aircraft repair ship that was based in Boston. Much of the crew was composed of Bostonians and they and their families attended a Christmas morning party aboard the ship with good food, good entertainment and a visit from Santa for the children of the men who manned the ship.

I often attended the morning party with my father and loved the idea of being on a war ship with the kids of the sailors who manned the vessel.

Later in life, beginning when I was about 18 or 19, I followed suit. I was in college at the time and often attended class in a tuxedo, carrying my bass violin under one arm and books under the other. I wasn't afraid of the bass being stolen if I left it in my car all morning, but was always worried about the wood cracking in the cold and the strings going out of tune due to the temperature outside the car.

When I began playing for the Ken Reeves Orchestra, we often had several afternoon parties to play, one after another. Most businesses would have parties in their offices for a couple of hours. This was at a time before DJs were invented. Everything was live music. On a given afternoon, I might play a party from 3:00 to 5:00 and rush to another location and play a second party from 5:30 to 7:30. I would then have a half hour to rush to where ever I was playing that night and entertain at another party or maybe two, if they could be squeezed in together without overlapping.

If we had jobs to play on the 24th, Dad, my uncles and I would make sure that they ended before it was time to head home and the Christmas Eve fishes that my mother and Nanna would prepare. If there were jobs that were booked for Christmas Eve, everyone in the family would have a backup musician who was Jewish to cover them. They had agreements with Jewish musicians and Dad and my uncles would cover for them on Jewish holidays when work interfered with their religious practices.

Things worked out well. Back then, a good part of Boston's Musicians' Union was a combination of Italian and Jewish musicians. More often than naught, during the rest of the year, they worked together and helped each other out at holiday time.

Those days are long gone. The money I made paid for my college tuition, and then some. Beyond this, I had fun. Looking back at the first part of the story, I guess I've had fun all of my life ... no complaints, and its now two generations later.

In many Italian-American homes, the celebration that takes place the night before Christmas is called "The Feast of the Seven Fishes." While abstinence from meat was observed, in my Sicilian family, that name was always frowned upon. Christmas Eve or La Vigilia (the vigil), as my mother called it, was the most sacred and celebrated of all of our holidays. The preparations preceding this evening, took place for days on end, and the foods, desserts and drinks, were more than plentiful. Served buffet style, we'd have breads, cheeses, antipasto and snail salad. Seafood dishes of clams, shrimp, calamari and smelts and of course, desserts, cookies, and pastries, and even a side table for wine and drinks. Our family gathered on this magical evening to eat, drink, exchange gifts, and then off to midnight mass we went. This was a night where lifelong memories were made!

When I think of La Vigilia, I picture my Nonna in her Christmas apron cleaning the squid for the pasta sauce she made only for this special night. Or my mom, who'd be frying shrimp; I honestly can't think of anyone that loved this holiday more than she did. The air was filled with love and the food was incredible. When it came time for dessert, everyone was usually so full that they didn't touch any of it. The only exception to this was, my "Zia Paulette's Pineapple Lime Jell-O Mold". I waited every year for this; it was the perfect ending to this amazing feast! Many Christmas Eve's ago, I asked my Zia Paulette for her recipe. When she gave it to me, I wrote it down on one of her red cocktail napkins. Ironically, I still have the napkin with the recipe written on it. This light and fluffy dessert is flavored with hints of lime, pineapple, and nuts. It's easy to make, delicious to eat, and it looks absolutely beautiful on a holiday dessert table. La Vigilia symbolizes what has always meant the most to my family, as well as myself; family, our Sicilian heritage; religious values, food, and of course, love. I hope you and your loved ones enjoy my "Zia Paulette's Pineapple Lime Jell-O Mold" as much as our family always did. Buon Natale Con Amore!

ZIA PAULETTE'S PINEAPPLE LIME JELL-O MOLD




- 1 3-ounce package lime jell-o 1 cup boiling water 1-pint good quality vanilla ice

 anilla ice ¾ cup chopped walnuts (the
 recipe calls for 1 cup, I use less)


Lightly grease or spray a jell-o mold, set aside.

The Rosie Ruiz Marathon Flim-Flam

On April 21, 1980 Rosie Ruiz was crowned female winner of the 84th Boston Marathon with a record breaking time of just under two hours and thirty-two minutes, cutting her own finishing time for the New York City Marathon the previous year by twenty-five minutes. And that time qualified her for the Boston Marathon.

However, almost from the start, things weren't looking right. For one thing she demonstrated an ignorance of jargon familiar to most runners, nor of the Wellesley College students who were out cheering the women runners on and she arrived at the finish line without the sweat or heart palpitations expected from a marathon participant, especially one completing the race in such a record time.

Ruiz accounted for the latter observations simply by stating, "I got up with a lot of energy this morning." But what she could not explain was why no other runner could recall seeing her at the race, not even the ultimate first-place or second place winners Jacqueline Gareau and

Pati Lyons respectively. Neither could she be seen in any video footage of the event.

Two witnesses who did see her were two Harvard students who later recalled her emerging from a crowd of spectators on Commonwealth Ave about half a mile from the finish line.

Meanwhile, New York was conducting its own investigation and, after interviewing witnesses and accounting for her timing, Ruiz was disqualified retroactively from the New York City Marathon. Because that event qualified her for the Boston Marathon she was by extension retroactively disqualified. However, Boston Athletic Association conducted its own investigation into the matter and also concluded to disqualify Rosie Ruiz from the Boston Marathon, Gareau was then recognized as the first place

Ruiz left New York soon after and ran into legal problems involving embezzlement and drug dealing but she always maintained that she ran the entire course of the Boston Marathon.

Do-it-Yourself Holiday Centerpiece

Dress up your holiday meals with a centerpiece crafted from greens, colorful stems and seed heads collected from your garden. Or purchase fresh materials you need from your favorite garden center or florist.

Most gardeners spend some time gathering a few blossoms and creating a bouquet or arrangement for their summer gatherings. Don't let winter stop you from crafting a festive centerpiece from materials collected from your gardens this time of year.

Start by gathering some greens. The fan-like sprays of arborvitae, blue-green sprigs of juniper as well as branches of yews, boxwood, pines and spruces can provide all the greenery you need.

Now look for items with interesting color or shape. Red and yellow twig dogwoods and paper bark birch add festive color to any arrangement. The interesting shapes of curly willow, contorted filbert and fantail willow provide intriguing form.

Next gather cones, berries, and fruits. Look for orange and red rose hips, blue berry-like cones of junipers, sweet gum seedpods, and alder's cone-like fruit. Gather a few evergreen cones to include in or around your arrangement.

Look for potential adornments that are lingering in the perennial garden. Coneflower, rudbeckia, and allium seed heads can add a bit of structure to your arrangement. Gather a few milkweed, balloon plant and lotus pods. And don't worry, your milkweed plants will return for next year's visiting monarchs. Honor their natural color or add a bit of bling with some gold, silver, or red paint.

Include a few shiny ornaments as needed. Glittered stems, ribbons and candles can add festive color to nature's beauty in your centerpiece.

Visit your favorite florist or craft store for needed supplies. Pick up some floral foam to secure the stems. Cut it to shape to fit the size and shape of the container.

Moisten the foam before inserting fresh greens and cut flowers. Set the block of foam on top of a basin of water and let it sink. This allows all the air spaces to fill with water, ensuring your flowers and greens



have the water they need. Use high density foam when working with evergreen boughs and branches.

No need to moisten the foam when using dried and artificial material. This material makes it easier to create your arrangement.

Consider purchasing a few seasonal flowers for added color for your special event. These can be placed directly in the floral foam or water filled florist tubes set in the arrangement. Simply remove faded flowers and replace as needed.

Or use miniature poinsettias, kalanchoes and cyclamen for longer lasting living color. Tuck them in the bed of greens or use them to decorate each place setting. Check the soil moisture frequently as the small pots dry out quickly.

The possibilities are endless, and the results are sure to brighten your spirits no matter how you are safely celebrating this holiday season.



elections, and he was one of the best players in baseball's storied history.

Minnie Miñoso came to America from Cuba in 1945 inspired by the Brooklyn Dodgers signing Jackie Robinson to a minor league contract and spent three seasons in the Negro League playing for the New York Cubans and helped that team win a championship. When he was signed by Cleveland in 1949, he wasnit the first Cuban to play in MLB. Several Cuban ballplayers preceded him, but they were light-skin Cubans. He couldnot pass and felt the sting that many black players felt. The minor leagues in the late '40s and early '50s treated black players terribly. Racism was rampant. Robinson became a symbol of hope. For Miñoso like other black players, playing professional baseball meant no walk in the park or picnic.

His first season in baseball was 1951. During the period 1951-1961, Miñoso ranked third in the majors in hits behind Nellie Fox and Richie Ashburn. During those 11 seasons, he batted .300, and was up there with Mickey Mantle, Willie Mays, and Stan Musial.

Miñoso was a mentor to many younger Latin players and his attitude towards life was very positive. There a quote I recently saw from him, "Be in love with the game. Do everything beautiful for the game and the people and country you represent. That what I want everyone to do."

Long before I read that quote, I remember his attitude first hand. I can remember back in my youth going to many games at Fenway Park. I either sat in the bleachers for 90 cents or in the right field grandstands for \$1.75. One game, I had a great low seat in the right field grandstands. Boston was playing Cleveland and out came Minnie Miñoso with a large bag of baseballs. He went up to all the kids I was with and he started talking to us and passing out free baseballs. It was like Christmas in July. Then all of a sudden, a Red Sox official comes out, without saying a word, scoops the bag of balls in Minnie's hands, and walks off with them. Miñoso stares at him without saying a word, and then turns to us with a smile saying, «No more free balls today I guess.»


To Miñoso, baseball wasnit a business, it was fun and he surely enjoyed every moment of the fun he had on and off the field for his 20 seasons of living his dream. He was one of us. There was no wall that separated him from the fans and we all enjoyed that feeling. Younger fans today missed my youthful experiences when baseball was played the way it was supposed to be played, the way it was intended to be played. There are sadly no more Minnie Miñosos in Americas former pastime. We are now crying in our crackerjacks remembering the old days and players like Minnie Miñoso.



HOOPS and HOCKEY in the HUB

GOING ... GOING ... GONE? Will the NHL be going to the Winter Olympics in China? That's the big question that looms larger every day.

And that's because we now know the deadline date concerning when an absolutely final decision must be rendered.

According to published reports, it is January 10th less than a month from now. A decision could come earlier but that January date is Olympic hockey's decisive day - when the speculation halts and a move forward either encompasses the NHL or it does not.

Just a couple of days after that became widely known, former Boston College and Boston Bruins player Bill Guerin was appointed the GM of USA Hockey, the organization that is responsible for selecting the nation's Olympic team.

Born in Worcester and raised in the Springfield suburb of Wilbraham, Guerin was on three Olympic teams. He is currently the General Manager of the Minnesota Wild.

As we stated in a previous column, NHL executives and the NHLPA agreed back in early September that the league's players would participate. But there was a caveat: Both entities reserved the right to back away because of evolving COVID-19 conditions that could impact player safety.

It is not a small decision since approximately 150 NHL players are tentatively set to compete in the 12-team tournament in Beijing. At the very least, Team USA and Team Canada are expected (as of now) to have rosters comprised entirely of NHL players while other nations will feature varying numbers of the league's performers. Guerin's first big task - and right on deadline — is to preside over the selection of NHL players for the Team USA roster.

But things are far from improving in the NHL. Hours before the Bruins game against Vegas on December 14th, for example, both Brad Marchand and Craig Smith were placed in COVID-19 protocols. The start of their absence coincided with the return of head coach Bruce Cassidy, who had just completed a COVID-19 sidelining. He is slated to be an assistant coach with Team Canada at the Olympics. In addition, B's assistant Chris Kelly also has returned from protocol.

The absence of Marchand and Smith came a day after the NHL postponed three games involving the Calgary Flames, including contests at Chicago and Nashville and a home matchup with Toronto. In addition, the Flames practice facility was closed until further notice.

Calgary thus became the third team to have games postponed due to COVID-19 conditions. Back in November, Ottawa had three games postponed while the New York Islanders had two.

Scenarios in the NHL are not looking good as a decision deadline looms. So what could happen on (or before) January

The NHL and NHLPA could

reaffirm their decision to participate. In that case, it would be left up to individual players to decide whether to compete in China or not. In a recent piece, New York Post columnist Larry Brooks, citing one of his sources, indicated that some players might decline offers to join Team USA. Could other NHL players take their places? Yes, but would they? That's another question that would have to be answered. Which players would want to go and which might decline is part of uncertainties that Guerin will have to deal with.

If the NHL pulls out, the Olympic tournament would still be held. Teams would fill roster spots with players from outside the NHL. Team USA, for example, could assemble a roster consisting of recently retired NHL players plus Americans playing in Europe, the minor leagues or for college teams. This is the Plan B team that Guerin must also put together.

In fact, such a squad has already competed under the Team USA banner. It happened in 2018 when the NHL decided not to compete in the Olympics held in South Korea. That meant that Team USA featured players from a variety of backgrounds, including Harvard star (and Scituate native) Ryan Donato - now with the Seattle Kraken.

But that team was put together with plenty of advance notice. A complicating factor is that the AHL, for example, is scheduled to play through the three-week Olympic window in February, meaning players, if selected, would miss numerous league games. College players, by comparison, could miss the stretch run as teams jockey for playoff berths in the various conferences and the NCAA regionals. College coaches might not be pleased, especially on short notice, to lose star players at such an important iuncture.

Then there is the matter of scheduling. The Olympic Break encompasses most of February, meaning that arenas may well have contracted for events such as concerts to fill in those empty

If the NHL decides not to participate, what happens to the Olympic Break? Is the threeweek shutdown still observed or is an alternative schedule — one without the Olympic Break that was sent to executives at all franchises over the summer but was never published activated for the remainder of the regular season?

With the Break, the regular season is set to conclude at the end of April with the latest possible date for a potential Game 7 in the Stanley Cup Final penciled in for June 30th. Without the Break, does the NHL simply continue to play in February and March with the regular season ending in early April? Is that even possible, now that some buildings may have scheduled other events.

All matters that are now on the table for hockey's powers that be as the days dwindle down to a defining decisive moment.
