THE APPLES OF THE HESPERIDES



Prometheus Bound by Peter Paul Rubens, Circa 1611 to 1612, Philadelphia Museum of Art

The legend concerning the apples of the Hesperides starts with the marriage of Jupiter, chief of all Roman gods, to the goddess named Juno. The wedding was attended by all other deities, who brought beautiful gifts. The grandmother of the bride brought a wedding gift of golden apples growing on live branches. As soon as the ceremonies had ended, the branches were planted in the sacred garden of Juno. The Hesperides, three daughters of Atlas, and a goddess named Hesperis, were directed to cultivate and watch over the growing trees. The golden fruit soon became known as the apples of the Hesperides. The girls were negligent in their duties and frequently plucked off apples for themselves. Consequently, Juno sent a large serpent to guard the fruit. This monster had a hundred heads that slept at different intervals, so that it was ever watchful. The eleventh task required of Hercules was to bring back to the king, at the city of Tiryns, the apples of the

The journey to the sacred garden of Juno took Hercules into the Caucasus Mountains where he came upon Prometheus, still bound to the rock. We remember Prometheus as the Secondary Titan who stole fire from the gods and gave it to mankind. Later, he displeased Jupiter, so he was chained to this rock. Each day a giant eagle tore at his liver, which grew whole again each night. The best artistic representation of this legend has been portrayed on an eight-foot-high oil-on-canvas masterpiece by Peter Paul Rubens. It is entitled Prometheus Bound, and is owned by the Philadelphia Museum of Art. Prometheus

is also represented in a sculptured wall plaque that is now in the National Museum at Naples, Italy. Hercules shot and killed the eagle; then he freed Prometheus from his bonds. In gratitude, Prometheus advised Hercules not to enter the sacred garden of Juno, but to send Atlas, the father of the Hesperides, to fetch the apples for him.

Continuing his outward journey, Hercules finally came to the sacred garden of Juno. It was located near the spot where Atlas was holding the sky on his shoulders. Remembering the advice of Prometheus, Hercules offered to relieve Atlas of the weight temporarily if he would gather the golden apples from the garden. Atlas agreed, fetched the apples, and returned shortly thereafter. Hercules soon discovered that Atlas did not intend to resume his great burden, but instead offered to deliver the apples himself. Having this great weight upon his back prevented Hercules from resorting to any kind of force against Atlas. Using caution and wit, Hercules pretended to agree to the proposal of Atlas, but begged him to hold the sky just long enough to permit a pad to be placed on his head. The gullible Atlas laid the apples on the ground and took back the sky. As soon as the weight was transferred, Hercules picked up the golden fruit and started his journey back home.

After receiving the apples, the king immediately returned them to the Hesperides because it was not considered proper that such sacred fruit remain in anyone else's keeping.

Christopher Columbus:

PARTS II & III Fact vs. Fiction

This week in a continuing effort to present more balanced information about Christopher Columbus, the Commission for Social Justice of the Massachusetts Order of the Sons and Daughters of Italy in America looks at Columbus: **Fact vs. Fiction**, a document prepared by the National Order Sons and Daughters of Italy. This is Parts II and III of that document.

PART II: What Columbus Accomplished

HISTORICAL

- Columbus proved that it was possible to safely cross the Atlantic Ocean.
- Columbus founded the first permanent European settlement in the Western Hemisphere, Hispaniola (now Haiti and the Dominican Republic).
- Columbus was the first to open relations between Europe and the Western Hemisphere. His voyages mark the beginning of more than 500 years of cultural, economic, and political relations between Europe and the Americas.
- The recorded history of the Western Hemisphere begins

with Columbus. There was no written history about these vast continents before his arrival in 1492.

NAVIGATIONAL

- Columbus was the first European to realize the full importance of the Atlantic wind pattern called the prevailing Westerlies, which blew steadily west to east. This convinced him it was possible to sail west with the Trade Winds to the New World and return to Europe with the Westerlies.
- During his four transatlantic voyages, Columbus chartered the route for what today are the islands of Cuba, Haiti, the Dominican Republic, Puerto Rico, Jamaica, the Lesser Antilles and the coasts

of Panama, Honduras and Venezuela.

- Columbus' trans-Atlantic route laid the foundation for future navigation in the region. His maps were used by Amerigo Vespucci (after whom the American continent takes its name), whose maps were used by later explorers of South
- America.
 The route across the Atlantic Ocean that Columbus charted in the 15th century is still used by sailors today.
- Columbus introduced the principle of compass variation (the variation at any point on the Earth's surface between the direction to magnetic and geographic north) and observed the rotation of the Pole star.

PART III: Why We Should Celebrate Columbus Day

- Columbus Day recognizes the achievements of a great Renaissance explorer who founded the first permanent European settlement in the New World. The arrival of Columbus in 1492 marks the beginning of recorded history in America and opened relations between the Americas and the rest of the world. Columbus Day celebrates the beginning of cultural exchange between America and Europe
- After Columbus, millions of European immigrants brought their art, music, science, medicine, philosophy and religious principles to America. These contributions have helped shape the United States and include Greek democracy, Roman law, Judeo-Christian ethics and the belief that all men are created equal.
- Columbus Day is one of America's oldest holidays. The tradition of observing Columbus Day dates back to the 18th century in this country. It was first celebrated on October 12, 1792, when the New York Society of Tammany honored Columbus on the 300th anniversary of his first yovage
- Columbus Day is a patriotic holiday. In fact, the Pledge of Allegiance was written in 1892 in honor of the 400th anniversary of his first voyage. That year, President Benjamin Harrison declared Columbus Day a legal holiday.
- The United States has long admired Columbus. America has more monuments to Columbus than any nation in the world, according to the Christopher Columbus Encyclopedia.
- The United States has a significant collection of

Columbus memorabilia, including his desk, papers, and the cross he used to claim the New World for Spain. These are in the Columbus Chapel in Boalsburg, Pennsylvania.

- In 1905, Colorado became the first state to declare Columbus Day a holiday.
- In 1971, Columbus Day became a federal holiday in all 50 states after Congress passed a

law declaring the second Monday in October Columbus Day.

• Columbus Day also commemorates the arrival on these shores of more than 5 million Italians beginning in 1880. Today, the children and grandchildren of these early Italian Americans constitute the nation's fifth largest ethnic group, according to the U.S. Census Bureau.

Police Reform Bill a Step Backwards

As a retired police officer with 28 years of service, I believe the Police Reform Bill that came out of the conference committee up on Beacon Hill is a big step BACKWARDS on the issues that law enforcement work so hard on and now looks most assuredly to hurt law enforcement and public safety. A vote was scheduled for December 2nd (Wednesday)

Kevin Plunkett, president, of the Emerald Society of Boston says of this legislation, "While we fully support positive changes for all moving forward, this bill has missed its mark. I agree this bill shouldn't even be under consideration. It is time for a reset creating an open process to develop common sense reform in the next session."

This Police Reform Bill does not protect or serve anyone. It would make police officers second class citizens by denying them the due process given to all other Massachusetts Public Employees. As written, the newly formed Massachusetts Peace Officer Standards and Training Commission would be able to revoke an officer's certification before that officer has a right to challenge discipline, in many cases even before internal investigations are completed! This is absurd! There is no fairness if officers can be stripped of their livelihood based on unsubstantiated claims. Other public employees such as teachers have certification — but their due process rights are protected by the law. Police officers deserve no less than all other public employees.

On Tuesday, (November 1^{st}) apparently both branches of the state legislature passed the police reform bill and sent it on to the governor's office where it awaits the governor's action on it. I urge folks to contact the governor's office and urge Governor Charlie Baker to veto this bill which was rushed through the legislature and I also urge all citizens to also contact their State Representatives and Senators urging them not to override the veto but to get back to work on re-writing this rushed bill.

NEW Health COVID-19 Testing Sites in North End and Charlestown:

Hours and Locations for Winter 2020

NEW Health, a federally qualified health center and an affiliate of Massachusetts General Hospital and Boston Medical Center, will continue to offer COVID-19 testing in Charlestown and the North End this season. The testing sites opened this past summer to all NEW Health patients and all residents of both neighborhoods, regardless of symptoms or insurance.

Both sites will remain open as long as needed, and locations and hours are as follows for the winter months.

The Charlestown site is open Monday through Friday, 1:00 p.m. to 4:00 p.m., and has been moved indoors to the Crossroads Resource Center at 15 Tufts Street; both drive-up and walkup options remain available.

The North End site is open Tuesday and Thursday, from 8:30 a.m. to 12:00 p.m., and has been moved into the alleyway directly behind NEW Health at 332 Hanover Street in order to provide more cover from the elements; the entrance is on North Bennet Street. Walk-up patients only.

Appointments are required and can be made by calling 617-643-8000 for the North End location and 857-238-1100 for the Charlestown location.

L'Anno Bello: A Year in Italian Folklore

Excitement on Santa Claus Lane

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



The Christmas season that most wonderful time of the year, is fully upon us! I feel its merriment whenever I take a sip of spicy eggnog, its velvety texture warming me inside with the taste of the holidays. On the day before Advent, my husband and I decorated our home for Christmas, setting up our small tree and placing an evertwinkling lights of these adornments shine through even the darkest midwinter night, while the greenery reminds me that the cycle of life rolls on despite the blustery cold of the season. Christmas carols, ubiquitous on the radio now, compose to soundtrack of my days now, filling them with the sounds of jingle bells. However, the most Christmas celebrations remains the jolly man in the North Pole himself — Santa Claus! Santa Claus appears everywhere nowadays, from thrones in shopping malls to television ads, from cookie faces to household decorations. Sometimes, Santa Claus manifests as the elegant Father Christmas — a serious-faced man clad in long, intricate robes, holding a staff. More often, however, he is a rotund, merry-faced man with a bushy white beard and a red suit, a bag bursting with gifts slung around his shoulder. Though Santa Claus has become a prominent figure in Christmas commercialism, at his purest form he is a comforting symbol of the mirth, goodwill and kindness which characterize this season. This complex charing with Christmas history!

The idea of Santa Claus may seem rather strange, even bizarre. Here is a man who lives in the North Pole, wears red, owns a toyshop run by elves, and hops aboard a sleigh to deliver presents to children on Christmas Eve. Why is this figure so attached to the holiday season? Like most Christmas symbols, Santa Claus derives green wreath on our door. The from both Christian and pagan roots. Some of his characteristics hearken back to the Norse god Odin, who led a wild hunt across the midwinter night sky on an eight-legged stallion. Children would leave carrots out overnight for Odin's horse, similar to the tradition of offering cookies and milk to Santa Claus. Elves also form a major part of Scandinavian folklore, inescapable symbol of secular where tales abounded of magical creatures who were especially active during the Twelve Days of Christmas. Nevertheless, Santa Claus's most immediate ancestor is St. Nicholas of Myra, a fourthcentury bishop hailing from Asia Minor, now modern-day Turkey. St. Nicholas became famous for his generosity, eventually serving as the patron saint of children. His association with gift-giving stems from a famous legend in which he secretly made gifts of gold to three sisters too poor to afford a dowry. The very name "Santa Claus" is a corruption of "St. Nicholas," hailing from Dutch settlers who brought the figure of Sinterklaas to America. In other countries, such as England, Santa Claus's name is "Father Christmas." This corresponds to his Italian moniker as acter even has his own holiday well, as the jolly man is known as on December 6th, a day abound- Babbo Natale—literally, "Father erosity that characterizes the Christmas." Though the premiere

gift-bringer in Italy remains La Befana, the kindly witch who circles the world on Epiphany Eve, Babbo Natale yields enormous presence there as well, and Italian children write letters to the merry, red-suited man.

St. Nicholas, Santa Claus's predecessor, even boasts his own feast day on the 6th of December. My grandmother hails from the southern Italian city of Bari, which holds the relics of the saint, and as such la Festa di San Nicola, or St. Nicholas's Day, endures as one of her most cherished holidays. She still speaks fondly of citywide celebrations on this day, replete with parades and processions, most centered around the Basilica di San Nicola. In other areas of Europe, St. Nicholas's Day functions as a quaint and charming precursor to Christmas, a day devoted to the happiness of children. Children in Germany, Hungary and the Czech Republic leave their shoes or boots on the windowsills during the eve of St. Nicholas's feast, only to find them filled with candy and trinkets in the morning. Polish children find small bags of candy tucked under their pillows, while their counterparts in France bake gingerbread and brioche to mark the holiday. My family honors St. Nicholas's Day with customs that awaken my inner child. My husband's parents bless and distribute candy canes on this day, sharing the joy of this nostalgic treat. I bake an eggnog cake for this feast. Silky and warm, studded with golden raisins and topped with a brown sugar streusel, this cake tastes like the Christmas festivities. As its scent fills the air, I become thankful for the pleasures of home and hearth that form the crux of holidays like St. Nicholas's Day.

Though the modern age seems bent on commercializing Santa Claus, we should pay attention to the true significance of this enigmatic and jovial figure. A combination of Christian and pagan roots, Santa Claus celebrates the values of compassion and kindness. The feast day of his predecessor St. Nicholas honors children and is imbued with the optimism and gen-Christmas season. While it may seem far too easy to impatiently wait for Christmas's arrival, St. Nicholas's Day serves as a welcome reminder that the whole Advent period brims with unique and special holidays that reveal the various facets of Christmas. During the holidays this year, let us make a pact to face life with the same sense of magic and wonder that typifies Santa Claus, or Father Christmas, or Babbo Natale. When we look at Christmas with joyous, childlike eyes, we can finally enjoy the true magnanimous spirit of the holidays, making our souls as bright as Santa Claus's smile!

Mental Health Issues Hit Third Rail?

As a retired police sergeant for the Massachusetts Department of Mental Health for 28 years, I believe what transit commuters are seeing in the New York subways is truly madness gone off the rails. If it can happen there, it can happen anywhere.

What has been happening most recently in New York City shows positive proof that there is an ongoing mental health pandemic in the Big Apple and it appears it's going from bad to worse with seemingly New York City Hall barely acknowledging the problem staring them clearly in the face!

During my DMH career, I also worked as a mental health assistant on an acute in-patient unit for six years in the '70s and early '80s. What I see on the streets of American cities today is a systemic failure to address what should be crystal clear. Cities like New York and Boston have many untreated folks out on the streets and politicians everywhere don't know how to deal with it effectively. This issue is now some 40 years old and started when states started closing inpatient facilities and sending them from the back wards to the back streets and the subways where they can cause havoc.

Is anyone really surprised that for over 45 years now with the unlocking of those bad old back wards, we as a society have created something even worse for those suffering with chronic and quite severe psychiatric issues? The socalled cure of the '70s was to unlock the doors and free folks from physical bondage while doing next to nothing about the constant pain these folks must feel during their every waking

When people suffer from a horrible form of disease that separates them from reality playing havoc and altering their

minds, anything is possible. These sad souls who end up untreated on our streets and in our communities are always five minutes from midnight. Lately, it seems midnight has been repeatedly reached down in the N.Y. subways. When folks go untreated out in the streets, sometimes they lash out at others, too. Pushing commuters in front of incoming subway trains is about as bad as things could be. These perpetrators are a danger to themselves and everyone around them.

When is it going to be time for state and local public officials across America to see that they have a serious public health crisis both for the untreated who roam around and the innocent people sometimes caught in their crosshairs? Who is addressing the increasing shortage of psych beds in the city's hospitals? All folks hear is silence from those in power. Their inactions tell me they don't know what to do and they are caught up in a sea of benign neglect. Is the problem too big for them? Is it too costly to fix? Should they just pretend they see nothing? Or will they step up to the plate and do something? It's always easy to place the blame elsewhere. Doing nothing does nothing!

The bottom line can't be to let these troubled souls roam around us because not only is it unfair to them but it is causing a public health and safety issue for those who are innocent and end up paying the price. We have elected politicians who seem to shut their eyes and hope that when they open them again, everything will be fixed. I thought we lived in a sane society but the status quo on the issue of mental illness seems insane to me.

This has to change. It's up to all of us. Doing nothing only gets you more of the same and the same is failing everyone.



Several days passed rather uneventfully. We were all having a good time. On the surface, all seemed to be going well, but it was obvious that Pietro was thinking of Carla. We all did our best to distract him, but something about his demeanor betrayed his yearning for Carla, which was obvious to Mom and Grandma.

On Friday evening of our first week in Kingston, Dad arrived by train, as he always did, to spend the following week with us. On Saturday morning, Dad suggested we should go quahogging on the flats in the bay. We all knew this would be followed by a dinner of spaghetti with crab sauce, made up of Alaskan King Crab legs, Dad always bought in Plymouth. Just before heading to the flats, Dad pulled Mom aside to tell her he heard the Ricci brothers were coming to Kingston to visit their Uncle Seymour, who was renting a cottage just down the road from us. Mom anxiously asked Dad if Carla would be coming along with them. When Dad responded he didn't know, Mom began to worry, for if Carla came, it could mean trouble. We waded out to the flats in our bathing suits, and began the process of searching for quahogs by plodding through the mud in our bare feet. Quickly, we were all knee-high in mud, hoping with each step, to feel the subject of our search beneath



our feet. Every time one of us hit a quahog, he would yell, "quahog!" Everyone cheered. Pietro, seemed to be frozen in place, finding the whole process amusing and foreign to him. Dad kept urging Pietro to wade through the mud. Finally, he got moving, and before long he found his first quahog. About an hour into the hunt, Charlie reached into the mud and pulled a horseshoe crab out by its tail. He threw it into his bucket with the quahogs, planning to take it back to shore to terrify the women. Dad spotted him, knew what he was up to, and told him to get the crab and throw it in the water, which of course Charlie didn't obey. Instead, he put it at the bottom of his bucket and covered it over with quahogs, figuring one of the women while preparing supper, would uncover it and begin screaming. With our buckets filled with quahogs, and the one special bucket containing the stowaway horseshoe crab, we headed back to the beach. 
As you can imagine, due to COVID-19, we are unable to hold our annual luncheon, however the need is anticipated to be greater than ever!

Cold Weather Tips for Dog Owners

Even if your dog has a thick, heavy coat, he or she might still feel chilly in the winter. Pets are just as likely to get frostbite (frozen skin and tissue) and hypothermia (low body temperature) as their owners. But it's easy to protect your pooch from the cold. Many of the same safety measures you take for yourself will keep your best friend safe and warm.

Limit time outdoors: No dog not even the toughest Arctic sled dog is meant to spend huge amounts of time outside in the winter. A thick coat doesn't protect all body parts. Their ears are exposed, their paws are in direct contact with cold cement, and their nose is sticking out there in the wind. Never leave dogs outside unattended for any length

of time. Only take them outside if they're going to be active and exercise. Even then, you may need to shorten a walk if it's really cold.

Dress him or her warmly: Small dogs and those with short hair need extra help when there's a chill in the air. Puppies and old canines also may find it hard to control their body heat. A sweater or coat can be a really nice addition that makes the pet more comfortable. But leave his or her head bare. If it's so cold that you think you should cover their head, you probably shouldn't go outdoors. To keep your pal's coat healthy during the winter, bump up the protein and fat in his or her diet.

Wipe down his or her paws: Ice, snow, rock salt, and toxic chemicals like antifreeze and deicers can build up on your dog's feet. If he or she licks them, he or she could swallow the poisons. Antifreeze, in particular tastes sweet but can be deadly. Make sure you wipe his or her paws down with a towel every time he or she comes inside. Check his or her pads regularly for injuries. Ice and snow can cause painful cracks and bleeding. Trim the hair between their toes to prevent ice buildup.

Don't leave him or her in the car: You know not to leave your dog in a vehicle when it's hot.



The same goes for cold weather. It really is a bad idea, often people don't think about how fast cars can cool down in the winter. Even if it's not a direct health risk for pets, they're likely to be uncomfortable.

Pet-proof your house: Keep an eye out for winter dangers inside your home, like space heaters. Dogs can burn them-

selves or even tip them over and start a fire. Heated pet mats could burn your pal's skin. A dog bed or blankets should keep him or her plenty warm. Know the warning signs. Be on the lookout for symptoms of frostbite and hypothermia, and know when to call your vet.

Get your pet inside right away if him or her: Whines or act anxious; can't stop shivering or seems weak; has ice on his or her body; stop moving or slows down and looks for warm places to burrow. These can be signs of hypothermia. Once he or she is out of the cold, wrap him or her in blankets and call the vet for more instructions. Frostbite symptoms can take longer to show up. Check your dog every day for any unusual changes like painful or pale areas.

Protect against the elements: If you have no choice, but to leave your dog outside for a time, make sure he has a dry, roomy shelter out of the wind. The floor should be raised several inches off the ground and sprinkled with cedar shavings or straw. Keep the doorway covered with waterproof plastic or canvas. Give him or her plenty of food, and check as often as you can to make sure his or her water doesn't freeze over.

Saint Amato Ronconi

Amato Ronconi was born in the village of Saludecio near Rimini in 1225 to a noble and wealthy household. He was orphaned in childhood and cared for by his older brother Giacomo spending his childhood and adolescence growing up in his brother's home. He had at least one sister named Chiara.

As he grew older, he was urged to get married, but felt that God called him to a life of prayer and penance. After joining the Third Order of at Saludecio. He was can on November 23, 2014 b Francis. His remains are Church of San Biagio home town of Saludecio.

St. Francis, he fled to a solitary place and began to live as a hermit following the life of Saint Francis. Ronconi followed his call to serve God and devoted his life to catering to the needs of the poor and assisting pilgrims, in doing so gave up all his possessions which he passed on to the poor. He later emerged from his hermitage and constructed various chapels and shelters for pilgrims; some of those places still exist at present including a hospital in Rimini, the Hospital of St. Mary of Mount Orciale, where he spent the last years of his life as a nurse.

He underwent four pilgrimages to Santiago de Compostela to visit the tomb of James the Apostle wanting to grow in personal holiness. He attempted a fifth pilgrimage to Santiago but never made it for he had a vision in which he was told he would soon die and had to return to his home; he did so and stopped at the Benedictine convent of San Giuliano in Rimini where he gave them the remainder of his possessions. Ronconi passed away on May 8, 1292 at Saludecio. He was canonized on November 23, 2014 by Pope Francis. His remains are in the Church of San Biagio in his

"St. Bernard's was going up against teams from the top schools in New England, with thousands of students, multimillion-dollar endowments, and players who were much larger physically - and winning," said All In producer Jeff Bowler. The St. Bernard's team went on to win the state Super Bowl played in Gillette Stadium. The 26 boys on the team, fighting for every inch of the field that

their hero, New England Patriot

Quarterback **Tom Brady**, called home on Sundays, won the State Championship, generating enough national publicity to raise the money needed to save the school, including a huge donation from a still anonymous donor.

Shortly thereafter, with funds in hand, the school officially became independent, with the full support of the Diocese. In the first year following the miraculous football season, admissions are soaring, and an entire town's spirits have been raised in celebration of saving their historic high school.

"As a St. Bernard's alum and filmmaker, I was tapped by the school to help tell this truly remarkable story to the world," said Bowler. "This feel-good, underdog tale is about so much more than football. The story is about a community that rallied together to create their own miracle. Faced with the closing of their beloved high school, students and faculty members stepped up to the plate to save their school, with unwavering perseverance."

Nanna & Babbononno

A Nostalgic Remembrance



Well, December is here and it's time to prepare for Christmas. Christmas season was a lot different in the Christoforo and Contini households back in the day. My father and two of my mother's brothers, Uncle Nick and Uncle Paul were professional musicians, and Christmas time was their busy season. When I was in my late teens, I joined the family business and made it three generations in a row. You see, Babbononno, my grandfather, (Mike Contini), started the tradition, but by the time I became a professional he had long retired from playing.

The way it started out for me was with an assumption. When I was a child, everyone assumed that I would become a musician like Babbononno, my uncles and Dad. This assumption began to take root when I was just a kid. Babbononno would sit me down in front of a music stand and teach me something called Solfeggio, the Italian method of rhythmic articulation in reading and understanding what written music was all about. When he felt I was ready, Dad tried interesting me in accordion. His presumption was that keyboard players always worked and even made more money than the other sidemen. I hated accordion. The next instrument was piano. I took a couple of lessons and hated that, too. Both Uncles Nick and Paul then stepped in and tried to teach me their instruments, soprano, alto, and tenor saxes, along with clarinet and flute. I hated them, too. Babbononno had played drums and guitar and gave me lessons on both. Again, I didn't bite.

These ill fated attempts went on for years, and Dad reconciled himself to the fact that his son was going to play baseball until the first snowfall and then read Captain Marvel comic books and make model airplanes out of wood until the snow melted and it was baseball time again. When I started the 7th grade at the Joseph H. Barnes Junior High School, I decided to join the drum and bugle corps and take lessons on how to play the bugle. The teacher turned out to be a man named Ralph Fucillo, a trumpet player that Dad and my uncles had worked with over the years and knew well. Dad was happy and brought me to a music store, Harris and Fandel. I believe they had a branch store on Meridian Street near Central Square in East

Boston. He bought me a Rexcraft bugle, the best that was available at the time. With a musician's discount, the price was a whopping \$17.00. I still have that bugle and have recently begun to restore it to its original condition.

Mr. Fucillo taught me how to play the instrument and I learned the required marches that we would play when marching with the school band. Next, I went to Sabo's, a men's store also located on Meridian Street near Central Square. There, I bought the required military uniform and shoulder patches that indicated I marched for the Barnes Junior High School. The uniforms were the same as the U.S. Army wore back then, tan shirts, pants, with matching overseas cap, necktie and web belt. Nanna sowed on the patches and with my creased shirt, pants, and the rest of my uniform, I was ready to play my bugle.

The band marched in the Columbus Day Parade (East Boston or the North End), Feast Day parades, the School Boy Parade, and several others that we were asked to march in. At times, we even joined with the East Boston High School Drum and Bugle Corps to celebrate Veteran's Day, (Armistice Day back then) President's Day, Memorial Day and even the Fourth of July. If the Catholic churches in East Boston had parades where they needed music, we played for them, too. I loved every minute of it. When I started high school, I joined the English High School Drum and Bugle Corps, but lasted only one year. At age 13, I lied about my age and began working at the Seville Theater. This job, combined with homework and baseball prevented me from continuing with music. Dad didn't want me to give it up and asked Mr. Fucillo to teach me how to play the trumpet. He borrowed a silver trumpet from a Mr. Joseph Trongone, the head of the music department for the Boston Public Schools, and I took the weekly lessons, but could never find the time to practice. The trumpet sat in my bedroom and began to collect dust from lack of use and Dad's hopes of his only son becoming a musician began to fade.

When I was in my last year of high school, I asked Dad to teach me how to play the bass violin, his main instrument. He started giving me lessons, but I got to the point where I lost interest. Reconciled to the fact that I preferred working at the Seville, hanging on a corner in my spare time, or playing baseball, the lessons ended. The interest returned when I started college, and the lessons resumed. One warm spring day during my junior year of college, I was sitting on the front steps of our house at 74 Eutaw Street, and a friend, Johnny Magnasco, happened to walk by on the other side of the street with his bass violin over his shoulder. I asked him where he was going and he stopped to talk for a few minutes. He told me that he was selling his bass as he had joined the army. He added that he had been playing with another neighbor, guitarist, Bob Avola who had a small band that was popular around East Boston. He then suggested that I contact Bob and take his place seeing that I studied bass and Bob's band would need a new base player.

I took his advice and began rehearsing with the band which included Bob on guitar, Ronny Hughes on alto sax, Jimmy Pastore on trumpet and Bill Welch on drums. I knew them all as we lived within blocks of each other, and this time I didn't quit. My first job with them was in 1958, and I played successfully, either bass or bass guitar for the next 50 something years. During this time, I tried everything from symphony to soul. Babbononno loved it when I played classical music as that and opera were his first loves. From that beginning, I worked my way up and worked with some of the greats in Boston, New York, and Los Angeles, playing both dance music for private functions and jazz at many of the long-gone clubs that dotted all three of those cities and several others around the country. At the tail end of my career, I was working as part a piano and bass duo with the late Marty Goldman. We specialized in private cocktail parties playing the great American songbook that featured the music of Gershwin, Cole Porter, Duke Ellington and many other talented American composers of good music.

When Marty passed away unexpectedly, I tried a couple of other pianists but it wasn't the same. I decided that maybe 50 odd years was enough and I went into semi-retirement as a musician. By this point in time, Babbononno, Dad, Uncle Paul and Uncle Nick were all gone and I became a senior citizen. As some of you know, I combined this profession with teaching school and when I retired from the Boston Public Schools, I became a professor at three colleges, positions I recently retired from. The COVID virus has caused most of my former classes to become virtual, as most college classrooms are now off limits. I don't like teaching via the computer or cell phone, so it's up to the next generation of college professors to take over. What makes me proud, though, is this column. Next May it will be 30 years running!!!

GOD BLESS AMERICA



In Italy, few desserts symbolize Christmas as much as Pandoro except of course for its equally favored counterpart, the Panettoni. During the holiday season, Pandoro can be found beautifully wrapped and packaged throughout most of the shops in the country. Pandora (pan d'oro or "golden bread") is traditionally a tall, golden colored star-shaped cake dusted with powdered sugar. It resembles a Christmas



tree covered in newly fallen snow. Pandoro originated in the northern Italian town of Verona and this legendary Christmas cake is the brilliant creation of Verona pastry chef Domenico Melegatti. While attempting to improve Verona's traditional Christmas dessert, the Nadalin, (a yeast-based cake in the shape of a star, with raisins, pine nuts and granulated sugar), Melegatti adjusted some of the ingredients. He eliminated the raisins, nuts and sugar; because he believed they inhibited the leavening. He added more butter and eggs to increase the softness and flavor, and hence the iconic "golden bread" or Pandoro was born. Melegatti patented his recipe and Pandoro on October 14, 1894.

Pandoro is delicious yet simple. It is equally as good when served plain and sprinkled with icing sugar as it is when toasted and dressed with butter or jam. It goes beautifully with a cup of Espresso and even better with a glass of *Prosecco*. *Pandoro* can be decorated and filled with cream, chocolate, custard or Mascarpone (Tiramisu). The decorated Stuffed Pandoro Christmas Tree or Albero di Natale Pandoro Farcito is a Christmastime favorite in Italy. It is made with a variety of fillings, a few of which I have shared below. Once you place a deliciously decorated Stuffed Pandoro Christmas Tree on your holiday table, it's going to look just as beautiful as those in Italy do!

STUFFED PANDORO CHRISTMAS TREE

Albero di Natale Pandoro Farcito

1 large homemade (I make my own) or store bought Pandoro, cut into 4-5 slices (see directions below)

FILLING CHOICES

Italian Custard: In a medium saucepan, sift together 3/4 cups flour and 2 cups sugar add 8 egg yolks and 4 cups whole milk, beat well. Add whole rind from 1/2 organic lemon and 2 teaspoons vanilla bean, cook over medium heat, stirring constantly for about 15-20 minutes or until a thick custard forms. Remove from heat remove lemon rind, strain, and place in a glass bowl. Cover custard with plastic wrap, cool and refrigerate. Will be ready in about 4-6 hours.

Diplomat Cream: Fold 1 recipe of Italian Custard into 1-2 cups whipped cream sweetened with 2-3 tablespoons icing sugar (added to the cream when whipping for sweetness).

Nutella and Whipped Cream: Place 3 cups whipping cream, 3-4 tablespoons icing sugar, and 2 teaspoons vanilla in a mixing bowl, beat until whipped. Layer Pandoro as directed below layering Nutella first then whipped cream on top. Decorate with shaved chocolate curls, if desired.

Tiramisu: Place 2 cups whipping cream, 1/2 cup icing sugar and 2 teaspoons vanilla in a mixing bowl, beat until whipped. Add 2 cups softened mascarpone cheese and mix until combined and smooth, set aside. In a medium bowl pour 2 cups espresso sweetened with sugar and mix in 2 tablespoons amaretto, rum, or coffee flavored liqueur. Layer Pandoro as directed below taking pastry brush and painting coffee mixture on Pandoro first then layering cream mixture, and dusting cream with pure cocoa powder, repeat until finished. Decorate with shaved chocolate curls, if desired.

TO STUFF/DECORATE PANDORO

Place the Pandoro on its side and using a sharp knife, cut it into 4-5 slices. Make sure the bottom slice is slightly thicker than

Place the bottom layer on a chopping/serving board and spread a thick layer of filling on top, in the centre, using a spatula.

Then, place the next slice of Pandoro on top, making sure it is off centre so that you start forming the shape of a Christmas tree. Layer filling (before layering filling, you can brush rum or ama-

retto syrup lightly on each layer) on top of this layer and place the next slice on top. Repeat this until you top off the Christmas cake with the final slice.

Put a few generous spoonfuls of filling into a piping bag and squeeze small amounts onto each star peak of your Christmas tree. Starting with the bottom layer, place small cherries, currants, strawberries, raspberries, blueberries, etc on each star point.

Add more filling to the top of your Italian Christmas cake and then decorate the way you like with fruit on top.

When finished, use a sieve sift icing sugar on top of the dessert so it looks like a touch of snow!

The Cuban Revolution



Perhaps no other 20th century event best demonstrates the dangerous faith in revolts than does the Cuban Revolution of 1959. The effect it had on Cuba is best described thus: Fidel Castro, Che Guevara and their cohorts displaced the often brutal government of Fulgencio Batista in which the divide between the wealthy Americanbacked industry executives and the starving populace was stark and replaced it with another brutal dictatorship where everyone was poor...except for the Castros and their minions.

Throughout his first presidency, lasting from 1933 to 1944, Batista maintained a good relationship with the United States and other foreign governments that saw Cuba as the tropical paradise for investments. For some on both sides of the equation this partnership proved highly profitable and Cuba became a new land of opportunity. As long as the money was rolling in, Batista had little desire to regulate and such an environment ultimately led to corruption. Havana became the playing field for American mobsters, casino magnets, and hustlers who found the island just over the clouds from Florida provided a good shied from the eyes of the feds.

Hostility was rising among the peasants, especially as those who protested the government were often violently done away with. By the early '50s a band of violent revolutionaries led by Fidel Castro and Che Guevara were making themselves known, rising both the wrath of Batista and the United States feared that its interest sites in the island would be lost.

To the Cuban poor, however, Castro was a hero and a liberator. Who could blame them, really? Whatever prosperity was

brought to their homeland had shut them out. Batista often showed them no mercy when they spoke up and some didn't live to tell about it afterward.

Both Castro and Guevara knew how to talk the poor and could easily paint themselves as the heroes they sought and make the folks believe whatever they needed them to believe.

In December of 1956 an attempted coup failed to unseat Batista who had returned to power in 1952. What the coup did accomplish, however, was convincing the United States that it was impractical to continue to support Batista. The solution was to find another president that would either snuff out the radicals or at least quell their bloodlust.

It would prove too late. On January 1, 1959, Castro and his cohorts launched their second coup, far more violent and organized than their attempt just over two years earlier. Batista and his cabinet fled Cuba for the Dominican Republic. Back home, Castro took over Havana six days later and became the island's dictator for almost six decades. His lackeys took no prisoners, taking many representatives of the former regime or of the establishment and executed many without a trail. Businesses (mostly American owned) were looted and burned and Cuba was changed forever. It became a Communist autocracy.

What was once a fenced dream for a few, became a wasteland for almost all but the Castros and their immediate connections. Castro wasted no time in cozying up to the Soviets as a final statement to where he was heading. In 1961, the United States, hoping to regain its foothold and re-establish business on the island launched the Bay of Pigs



Invasion in the hopes of unseating Castro but the mission failed. As a last resort, President Kennedy severed all ties with the island nation and imposed a trade and travel embargo.

The politics and logistics of such a move, especially its continuance to this day (though restrictions have been loosened), are beyond the scope of this article. It does, however, make one wonder what could have been with, perhaps, a less myopic view of the suffering that was happening all around those glitzy casinos and nightclubs.

Winter Care

for Trees, Shrubs and Perennials in Containers

Moving containers to a sheltered location and placing them close together for added insulation is one strategy to help them survive cold winter temperatures.

As you prepare your landscape for winter don't overlook the trees, shrubs, and perennials you have growing in containers. These need a bit of extra protection to help them survive cold winter temperatures.

The small amount of soil in container gardens does not always provide sufficient insulation. The roots are more exposed to temperature extremes than those of their counterparts growing in the ground. Extremely cold temperatures can damage or kill the roots and even the plant.

Plants rated at least one zone hardier than your zone can usually survive when left outside for winter. Just make sure your containers will also tolerate the challenging winter weather.

Here are a couple strategies for helping your other containers through the winter. Select the one that best fits your landscape space and gardening style. Those in apartments or with limited space may need to enlist the help of their gardening friends.

Move containers to a sheltered location. Place them close together for added insulation. Then surround this with annual pots of flowers and vegetables to further insulate the roots. Wait until spring to empty and compost the annual plants. Or cover the pots with woodchips or surround them with bags of leaves, potting mix or bales of straw. Add another layer of insulation by piling snow that is free of deicing salt over the pots throughout the winter.


Any plants growing in nursery pots or plastic containers can be overwintered in a vacant section of the garden. Sink the pots in the ground and make sure the pot is covered with and surrounded by soil. Water if needed. Then lift the plants in spring and set them in a decorative container to enjoy throughout the growing season.

An unheated garage also provides a suitable location for overwintering container gardens. Heated garages are usually too warm and plants will begin to grow. With a lack of sufficient sunlight, they usually struggle through the winter and often die.

Place the plants away from the overhead garage door. Add a bit of insulation such as packing materials, bagged soil, or other potential insulation you probably have in your home or garage. This protects the roots when the temperatures plummet. Water your stored containers whenever the soil is thawed and dry. A scoop of snow that is free of deicing salt works well. Just toss a scoop on each pot. When the temperatures rise the snow melts and waters the pots. Dry soil during a winter thaw is the usual cause of death when pots are stored this way.

If space allows, you may decide to plant those trees, shrubs, and perennials growing in containers into the garden each fall. You will eliminate this overwintering task and have a great excuse for buying new plants next spring.

Had the Tools to Beat Ali


When thinking of dream matchups in boxing people usually think of pairings where the boxers have opposite styles. It is usually boxer vs slugger. And that makes sense, as these are the bouts that quite often provide the most fireworks. There is that attraction that is similar to the bull vs the matador.

But an interesting and intriguing fight isn't necessarily that between two polar opposites. Matching two smart boxers against one another can make for a very interesting fight. It can also show that one of the boxers who were considered highly skilled may not prove to be as talented in the scientific aspect of boxing when faced with a better ring technician.

The dream fights involving Muhammad Ali usually have him facing the great sluggers of the past such as Rock Marciano or Joe Frazier. Joe Louis, though more than a slugger, is often mentioned as well, and this is because of his tremendous punching power. Seeing that Ali was never kayoed (his bout against Holmes certainly doesn't count), I believe the interest in these hypothetical matches lies not just in whether or not these greats of the past could beat him, but rather in whether they could knock him

I think it is more interesting to look back and try to find boxers from years past who could outbox him. In the past, I have discussed the possibility of Jersey Joe Walcott and Gene Tunney doing so. There is another who would give Ali fits. That is Billy Conn.

Many will say Conn was too small and didn't punch hard enough to beat Ali. Two things should be remembered; Ali had some of his toughest fights

more difficulty with fighters who were light and fast as compared to powerful but slower. Joe Frazier would fit into the category of small and fast though he was a slugger, though he deserves more credit than he gets for his boxing ability.

Ali is overrated when it comes to his technical ability in the ring. This does not take away from the fact that he was a great fighter. The thing with Ali was he was not a greatly schooled fighter. Joe Frazier was actually a better ring technician. Ali was an ad-libber in the ring. He had

power when he stepped up and took on heavyweights.

Ali had difficulty in his fights with Doug Jones, Henry Cooper, Billy Daniels, and was floored hard by Sonny Banks. Later in his career, he was given fits by the light punching Jimmy Young. None of these men were large heavyweights, though they all would have a few pounds on


Ali did better against the big heavyweights; men like Sonny phenomenal instincts, amazing reflexes, blinding speed for a man his size, and an iron chin, not to mention endless stamina. He did have a problem adapting when faced with a fighter who gave him problems. In three fights against Ken Norton, certainly nowhere near an all-time great and a one-dimensional fighter, Ali was never able to improve over his previous performance. Contrast that with someone like Joe Louis who always did much better in rematches against fighters who gave him a tough fight.

Jimmy Young was another puzzle for Ali, and one I very much doubt he would have been able to solve if they fought a second time. Young, like Norton, was far from an all-time great, but he was a cunning boxer, what used to be called a 'cutie" in the ring.

If Ali were to face Billy Conn, he would be facing a pro with far more tools than Norton and Young. Not only was Billy fast, he was brilliant boxer. Unlike the slow moving targets like Foreman and Liston, Conn would have been all over the place while matching, and I believe out performing Ali when it came to both hand speed and

Ali would have had fits with Billy, and I think it is very likely that the Conn of the first Louis fight would have out pointed Muhammad. This is another case of styles making fights, and Conn had all the tolls to beat Ali.

I know this is a fight that is never mentioned when thinking about who from the past could have beaten "The Greatest", I think it is a very intriguing matchup. My money would be on "The Pittsburgh Kid."



When the Boston Celtics face the Brooklyn Nets on December 18th at the TD Garden in a preseason game, it will be a welcome homecoming for a team that has literally been away for over nine months.

When we last saw the Celtics in the Garden, it was early March and the stretch drive that led into the playoffs was under way. But as we all know there was an unprecedented "intervention" that caused the NBA to shut down for several months before action resumed.

And while the Celtics played in Florida, it didn't quite feel the same. It was essentially the squad that had played in early March — but in a way, things were different. We knew they were not coming back to the Garden until the NBA powers that be declared that preparations could commence for the new 2020-2021 season.

And so here we are. At the start of preparations for that very season — with some teams having played into the fall and eight others not having taken the floor since that March night when all games were halted around the league.

The Celtics will be back on the court by the time you read this — holding preseason practices prior to playing their first exhibition game on December 15th against the 76ers in Philadelphia.

That will be a reunion of sorts since former Celtics head coach Doc Rivers will be at the helm in Philly, a good coach who immediately found another position after being let go by the Los Angeles Clippers when they lost in the second round of the 2020 playoffs.

The Celtics will also be seeing a bit more of another member of the Rivers family during the regular season since Austin Rivers, the son of Doc Rivers, recently signed a contract with the New York Knicks.

The Knicks and the Celtics have a long rivalry since they are the only two original NBA franchises still playing in their original cities. It is also interesting that when Austin Rivers takes the floor in New York this season, he will be following in the footsteps of his father. Doc Rivers played for the Knicks from 1992 to 1994.

In addition, Austin played for his father from 2015-2018, when his dad coached the Clippers. While Austin played in California, Mike Woodson was one of his father's assistant coaches. Woodson is now an assistant coach with the Knicks.

Plus, the Knicks head coach will be Tom Thibodeau, who served as the Celtics associate head coach under Doc Rivers from 2007 to 2010. That includes the span when they won the NBA championship (2008) by defeating the Lakers and then later lost to the Lakers in the NBA Finals (2010).

And, by the way, if you can locate the Knicks game day notes on the internet they are a pleasure to read. The section

called "Knicks Notations" is like going on a historical tour of the NBA. Every day something different is cited — whether it be an interesting statistic, a key game from the past, a memorable trade, or an accomplishment by a player or coach.

That second preseason contest with Brooklyn could also prove interesting since the Nets have a first-year coach in Steve Nash — the former NBA All-Star. The New York media have focused quite a bit on the reaction to his hiring - especially follow comments by Kyrie Irving that he, teammate Kevin Durant and Nash might well act as some sort of collaborative.

The way Irving envisioned was that the Nets might not really have a head coach — though Nash would have the title.

"I don't really see us having a head coach," remarked the former Celtics player when he appeared on Durant's podcast. "You know what I mean. KD could be the head coach. I could be the head coach."

Irving even threw Knicks assistant head coach Jacque Vaughn into the mix, adding "It's a collaborative."

Those are certainly interesting comments to consider, especially coming from Irving, who signed a four-year, \$141 million deal with the Nets in the summer of 2019. In case you are wondering, that works out to an average of \$35.2 million per year over the 48-month span — or the impressive sum of \$96,575 every day for the duration of the contract.

Durant, for his part, saw the hiring of Nash as a positive step. "His insight for the game, his communication — how he communicates the game of basketball — is definitely going to help me as a player develop and it is going to help the rest of the team."

But Irving's comments are certainly a less-than-positive way to go into the new season. We assume that over the past couple of months there have been some attempts to iron out this whole thing.

Of course, whether there will be any fans on hand to witness the 2020-2021 NBA season remains the big question. Although more than half of the NFL teams currently allow some fans to attend, the vast majority of those games are outdoors.

Most states currently have different rules for outdoor and indoor activities, with the requirements on indoor events being more stringent. Since all NBA games are indoors, the number of fans on hand may range from none to only a few as the season gets under way.

There won't be a bubble but does that spell trouble? We hope not. It will be a long season — right through the NBA Finals in July. By then something called normal may have returned — as in how the league was able to conduct its games up through February, 2019. May we witness those days again sometime in 2021.
