
# The Boston Conservatory of Music Christmas Concert



## THE END OF THE LINE


I wrote that Julius Caesar was a dictator but not an emperor. As a ruler with absolute power, he made such a favorable impression on the Roman people that the Senate bestowed upon him the honor of dictator for life, the forename of imperator, and the surname of father of his country. Through Octavius (Augustus), he was offered a crown of olive leaves and the position of king of the Roman world, which he modestly refused. But it set the people up to accept an emperor in the near future.

Julius Caesar designated his grandnephew Octavian as heir to his fortune and to his name. After the death of Julius, Octavian accepted his inheritance, was elected emperor, and changed his name from Octavian to Augustus. During his 41 years of reign, Augustus received the admiration, respect, and affection of the Roman people, while history praises him for his restraint, patience, and true concern for the Roman tradition.

Both Julius Caesar and Augustus Caesar left such an indelible mark on the history of the world up to that time that the Senate conferred the title of Caesar on many succeeding emperors. This is the part of imperial history that is confusing to so many of us today. Some emperors were voted the title of Caesar by the Senate and some were not, while still others did not remain in office long enough to be evaluated. Some of them were gentle, kind, and very considerate, while many others were nothing more than brutal bastards.

Nero's death ended what is commonly referred to as the Julio-Claudian line of Roman emperors and there were five that followed after the death of Julius Caesar. All five were in some way related to Julius through the female members of their families.

We know that Tiberius, who followed Augustus, made such a bad impression on the people that, at the first news of his death, many people ran about the city shouting, "Tiberius to the Tiber," while others prayed to their gods to provide him no everlasting home except among the damned. Caligula, the next



The second part of the story tells of lightning striking a temple of the Julio-Claudians after Nero's death. This one lightning strike is said to have caused the heads to fall from all of the statues at the same time, while the scepter (symbol of power) fell from the hand of Augustus. Additionally, this one story is said to have caused more flatulence (stomach gas) in more people than any other story to come out of Roman Antiquity. But don't be discouraged folks, better times are coming. The Flavian and Antonine emperors produced some of the best rulers in Roman history. But first we'll have to sweat out Galba, Otho, and Vitellius, "i tre pagliacci" (the three clowns).

## New City-Operated **SENIOR CENTER OPENS** in East Boston

The East Boston Senior Center, based on community input, will offer programs and services for older adults (Boston residents age 60+) which started December  $1^{st}$ .

Mayor Michelle Wu, in partnership with Massport, announced the opening of a new city-owned senior center in East Boston, located at 7 Bayswater Street. Mayor Wu joined Massport CEO Lisa Wieland, elected officials and community members involved with advocating for the new center at a ribbon cutting Wednesday, on the one year anniversary of her taking office as Mayor. The center will be operated by the Age Strong Commission and managed by the Property Management Department.

"This new, accessible senior center in East Boston will expand opportunities for our older adults to connect and build community," said Mayor Michelle Wu at the opening on December 1, 2022. "I'm grateful to all our City departments, local partners, and community members that have advocated for years to make today's opening a reality."

The center will provide lunch on weekdays, as well as classes for wellness, entertainment, and more. "This new senior center in East Boston will raise the bar for senior programming in Boston and is a great example of what can happen when the City partners with residents and entities like MASSPORT to serve a critical neighborhood need," said Chief of Human Services, José F. Massó. "We're excited to be able to offer programming that will resonate with all the diverse groups of older adults that make up East Boston."

"Socialization, connection, and community are vital to human wellbeing," said Emily K. Shea, Age Strong Commissioner. "Research shows that people who have friends and participate in activities are more healthy and live longer. The new center will provide a place for our older residents to connect with each other and engage in a richer, healthier life."

"This was a great collaborative effort between PFD, Age Strong, and Property Management," said Chief of Operations Dion Irish. "The renovation allows for additional programming and services while the new addition enhances accessibility with respect to its existing urban setting."

Formerly serving as the East Boston Barnes Branch of the Boston Public Library, the construction of the new center site officially started in September 2020 and was led by the City's Public Facilities Department. New additions and renovation of the site were initially delayed due to COVID-19 pandemic and supply chain issues. This project, with a focus on accessibility for older adults, consisted of over 20 external partners, including the architect, Fennick McCredie Architecture (FMA), and general contractor, GVW Construction (GVW). Additionally, Lifespan Design was brought on as a consultant for their expertise in senior center features, which was noted in the RFP.

The new center consists of two levels, with modern, accessibility features for older adults including an elevator (upgraded from a lift), wave/sensor door openings instead of push buttons, tables that wheelchairs can easily roll up to, bright lighting, a hearing loop system (hearing aids can connect to), and stairs with stepgrippers. The center's restrooms are large enough to include a care partner, wheelchair, or walker and include dual grab bars and toilet seats of different heights to accommodate older adults of varied heights. Light switches are installed at a lower height and electrical outlets higher to accommodate older adults as they bend. Outside of the center, there is a walking path in the backyard to cue folks with memory loss as well as raised garden beds, so older adults can participate in gardening either from a wheelchair or without steep bending.

"The opening of this vital civic space for our seniors comes after decades of advocacy from many individuals," said City Councilor Gabriela Coletta. "I am so grateful to the community members, former and current elected officials, and Massport for making this dream a reality. The center will be a hub of activity and bring people together for years to come."

Supporting our seniors is one of the most important things we can do as a community and a city, thank you, Mayor Michelle Wu, the Age Strong Commission, Public Facilities, members of the East Boston Community, and MASSPORT for your work in bringing a new Senior Center to East Boston," said State Senator Lvdia Edwards. "I'm excited to see the long-awaited dream of the East Boston Senior Center finally realized," said Representative Adrian Madaro. "This is something that I have advocated for throughout my time in office. Our seniors are the bedrock of our community, and this new state of the art center will provide East Boston's elders with a dedicated space to gather, participate in enriching activities, and access supports and resources. Thank you to the city's Age Strong team and Mayor Wu for helping us get the Senior Center across the finish line!" The City committed \$6.5 million in the capital budget for the design and construction of the new center. In partnership with the City of Boston to improve the quality of life for residents, Massport contributed significant funding for the creation and operation of this center. "Massport is pleased to partner with the City of Boston and support the new East Boston senior center, which will deliver important services and programming," said Massport CEO Lisa Wieland. "We are glad to see the community's hard work and dedication over the years coming together in this terrific new asset for East Boston."

emperor, became an insane tyrant who did more harm than good, and is regarded as the most grotesque figure ever to serve as emperor of the Roman Empire.

Although I avoided commenting on the negative side of the reign of Claudius during previous columns, there are credible historians who claim that he was treated as a buffoon in his younger days, that his selection as emperor of Rome was made by the fickle finger of fate, and that his campaign (which supposedly gained great victories in Britain) was the greatest sham ever to be perpetrated upon the Roman populace.

Nero, the last of the Julio-Claudians, became one of the cruelest, most depraved and despotic emperors that ever ruled Rome. His own father said, "Only that which is abominable and harmful to the public could be born of Agrippina and myself" and Nero certainly didn't disappoint his dear old daddy.

An interesting comment by one ancient historian tells of an eagle that flew to Livia, the wife of Augustus, who was sunbathing at her villa. The bird dropped a white hen in her lap and it in turn was holding a sprig of laurel in its beak. Livia raised the hen and it hatched a great brood of chickens. She also planted the laurel, which grew into such a large grove that all of the Caesars gathered their branches from this place before going to celebrate their triumphs. We are told that after celebrating, each of the Caesars returned to the grove to plant their laurel branches in the same spot, and these also flourished. The story goes on to


Realty, ran with her partner and daughter Alessandra and son Michael. Always going the

Vincent Capodanno was born in 1929 of an Italian immigrant father and an Italian American mother. After high school, he joined the Seminary and was ordained a priest in 1957, and later served as a foreign missionary. In the mid-1960s, he volunteered to serve his country and became a commissioned officer in the Navy. In April 1966, Capodanno was sent to Vietnam to serve with the 1<sup>st</sup> Marine Division. He was respected by all those around him earning the nickname the "Grunt Padre." Lt. Fr. Capodanno requested a sixmonth extension after his tour was up. On September 4 1967, the 38-year-old Capodanno learned that a platoon was in danger of

At the time, he was in Company command post, yet he left that safe haven to run through an area riddled with gunfire to get to the platoon under attack. He was eventually hit by an exploding mortar, which caused multiple arm and leg wounds and severed part of his right hand.

Despite these wounds, he refused medical help and instead moved around the battlefield offering encouragement and assisting the wounded. When he noticed a wounded Marine, he rushed to help. He was within inches of the Marine when he was hit by machine gun fire twenty-five times and died at the scene.

His loss was interminable. He went on to posthumously earn the Purple Heart, the Bronze Star, and the Silver Star. On January 7, 1969, his family received the Medal of Honor on his behalf.

## L'Anno Bello: A Year in Italian Folklore Lighting Up the Seasons

Is there a Christmas symbol more powerful and life-affirming than the light? Everywhere I turn this season, different lights glow in the air around me, each providing a distinctive sensation of the holiday season. When I see the multicolored lights strung around the bushes surrounding the confection shop near my home, playfully blinking at

me with their bright hues of red and green and blue, I am filled with a childlike zest for Christmas. These lights remind me of old-fashioned toys and candy canes, chocolate treats and wrapping paper. The golden lights that drip off ceilings are more elegant, reminiscent of a candle's warm heart and the generosity that accompanies the holidays. After all, a candle glowing in the window has long been a sign of hospitality and welcome. Meanwhile, the icy blue lights that adorn trees in some town squares remind me of quiet and snowy winter evenings, as sparkling as Elsa's palace in Frozen. Indeed, lights do form a significant aspect of the Christmas season, serving both a religious and symbolic purpose. Religiously, these candles signify the light Jesus brought upon the world at His birth on Christmas. Symbolically, the lights brighten the darkest nights of the year and celebrate the return of the sun after the winter solstice. Two holidays which occur during this time, St. Lucy's Day and Hanukkah, incorporate lights as central features of their celebrations, spreading warmth and cheer into the chilly winter air.

St. Lucy's Day, one of my favorite feasts, occurs on December 13th. Known as la Festa di Santa Lucia in Italian, this holiday honors a fourthcentury martyr from Syracuse, Sicily. Italians celebrate St. Lucy in varying ways depending on the region. According to a Sicilian legend, St. Lucy once alleviated a famine by sending in ships bearing wheat into the port of Syracuse. To commemorate this event, some Sicilians prepare cuccía, or a porridge of boiled wheat berries that can be served with honey and ricotta, on the feast day. In the northern areas of Italy, such as Veneto and Friuli, St. Lucy serves as a gift-bringer. She distributes small gifts to children on the eve of her festival, accompanied by her donkey and by her assistant Castaldo. The name Lucia stems from the same Latin root as the word light, making her the perfect saint for festivities which take place on one of the darkest nights of the year. Before the calendar reform, December 13th was the winter solstice, a vestige which remains in the Italian proverb Santa Lucia, il giorno piú corto che ci sia ("St. Lucy's Day is the shortest day there is"). Her association with light also explains why St. Lucy is such a popular saint in the Scandinavian countries, where winter darkness can last for the better part of the day. Candlelit St. Lucy's Day processions occur along the streets of major Scandinavian cities, featuring lots of girls dressed like St. Lucy and boys wearing gingerbread men costumes, or conical hats decorated with stars. On the feast of St. Lucy, a daughter in the family wakes up early and dresses in a white robe and a red sash. Sporting a wreath of electric candles on her head, she greets the family at breakfast by serving them hot chocolate and *lussekatter* or raisin buns spiced with saf-



St. Lucy's Day, I honor the light breaking through the darkness by baking sweet potato biscuits, which emerge warm from the oven with a beautiful sunny glow.

Hanukkah, a Jewish holiday which begins on December 18<sup>th</sup> this year and ends on December 26<sup>th</sup>, also incorporates light into its festivities. Hanukkah celebrates the over

two thousand-year-old victory of a Jewish patriotic group known as the Maccabees over the Seleucid Army, which wanted to impose Greek culture and religion on the Jews. When the Holy Temple in Jerusalem was rededicated during the revolt, there was only a small supply of oil to light the sacred menorah, or candelabra, in the Temple. Miraculously, however, the oil lasted for eight days, which forms the basis of Hanukkah as an eight-day celebration. Families honor the miracle of the oil by lighting one candle on their own menorahs every night of Hanukkah. Fried food is traditional for Hanukkah because it also commemorates the oil that illuminated the Temple's menorah. These foods can include latkes, which are potato pancakes, and sufganiyot, a jelly-filled donut. Italy is home to a number of old Jewish communities in cities like Rome and Venice, and there Hanukkah is celebrated with beloved traditions and specialty foods. One such food is precipizi, or deep-fried dough balls coated with honey. Golden and warm, the precipizi looks like miniature suns, reaffirming the motif of light breaking through the darkness. Italian Jews also popularized frying vegetables, and as such fried artichoke remains a popular Italian Hanukkah dish. I grew up in a town with a large Jewish population, and holiday parties in my elementary school always featured a blend of Christmas and Hanukkah festivities. I remember playing dreidel, a game involving a spinning top and a pile of prizes, with my classmates and accumulating delicious gelt (chocolate coins) wrapped in golden foil, and topping latkes with sour cream and applesauce. It was wonderful to have two great holidays bring my town close together during the dark of winter.

As the winter solstice approaches, the nights get progressively darker, casting a gray gloom earlier and earlier into the afternoon. For this reason, holiday lights play a powerful and heartfelt role in many winter celebrations. Candles illuminate the nights across the world, whether they spring from the crown of a girl dressed as St. Lucy or from a Hanukkah menorah being lit by a family. It is easy to get bogged in a metaphorical darkness this time of year — not just because of the early sunsets, but because of the stress and depression that sometimes accompany the holiday season. During moments like this, it is important to pay attention to the symbolic lights in our life: family and friends, nourishing food, personal strength, acts of kindness. When we dwell on these aspects, rather than let the darkness get the best of us, we will see that our inner light can outshine anything.

At the moment East Boston has zoning by variance. It seems everywhere whatever the zoning board denies, the zoning board of appeals approves. Right now all over our neighborhoods, the developers rule and City Hall seems to serve them. Too often the powers-that-be can't seem to be bothered by standing up for East Boston residents. It's always about the power of money, not the power of us. Back when I joined up with Standing Up For Eastie, I knew it was more than a slogan. Now I hear one of its founders was actually forced out of Eastie because she was unable to afford to stay here any longer.

I want to thank all who helped make this meeting possible and thank our City Councilor Gabriela Coletta for attending, listening to all of the neighborhood's concerns about the future for Orient Heights and all of East Boston. She offered some sage advice and reminded all that City Hall isn't her boss, we are. I feel she heard us and will carry our hopes, fears; concerns, etc back to City Hall as our collective voice.

I used to live in Eagle Hill and now live in Jeffries Point. I see overdevelopment everywhere. Just look at what is happening along the Greenway on Bremen Street. That doesn't have to be the future for us. We hear about "affordable" housing but every time a single two-family gets sold; it gets replaced by multiple high-end units in buildings, not homes.

I left the meeting up at Don Orione feeling much more positive. We need to stand together and speak out together. They win when we throw our hands up to the so-called inevitable. We are not victims, nor should we think like victims. We can control our own inevitability.



## Saint Maria Maravillas de Jesus


María de las Maravillas was born in Madrid, Spain, on November 4, 1891. Maria was born into a noble family, her father, Luis Pidal y Mon, the Marquis of Pidal, was the Spanish Ambassador to the Holy See. Her mother, Cristina Chico de Guzmán y Muńoz, was both pious and devoted to her family.

Reading the works of St. Teresa of Ávila and St. John of the Cross surely fueled Maria's interest in becoming a Carmelite. María entered the Discalced Carmelites of El Escorial in Madrid on October 12, 1919. She made her simple vows on May 7, 1921. Before her final profession on May 30, 1924, María had already received a special call from God to found the Carmel of Cerro de los Ángeles, the foundation was established on October 31, 1926 with three other Carmelites. This was the first of the series of Teresian Carmelite Monasteries that she would establish, according to the Rule and Constitutions of the Discalced Carmelites.

On June 28, 1926, the Bishop of the Diocese of Madrid-Alcalá appointed her prioress of the new monastery. In 1933, she established another foundation in Kottayam, India, from this other monasteries were founded in India. In the following years, foundations were established in other parts of Spain. Mother Maravillas (as Maria was known) also restored and sent nuns to her original Carmel of El Escorial and to the venerable monastery of the Incarnation in Avila. In order to unite the monasteries, she founded the Association of St Teresa, which received official approval from the Holy See in 1972.

With Vatican II, some religious communities sought to change the way they lived their vocations. Mother Maravillas strongly advocated for Discalced Carmelites who desired to live under the practices St. Teresa of Ávila had instituted, including almost complete enclosure, extremely simple habits and sandals, and nearly total silence. It wasn't that Mother Maravillas objected to others embracing more relaxed conventions; she simply wanted women like her who desired to live as St. Teresa of Avila had directed to be able to do so.

On December 8, 1974, the Solemnity of the Immaculate Conception, Mother Maravillas was anointed and received Holy Communion. On December 11<sup>th</sup>, surrounded by her community in the Carmel of La Aldehuela, Madrid, she passed away. At the time of her death, her sisters report that Mother Maravillas kept repeating the phrase: "What happiness to die a Carmelite!" She was beatified by Pope John Paul II on May 10, 1998. At her 2003 canonization, St. John Paul II said she was "motivated by a heroic faith that shaped her response to an austere vocation, in which she made God the center of her life." The Feast Day of Saint Maria Maravillas de Jesu is December 11<sup>th</sup>.


#### **EPILOGUE**





I was only three when this story unfolded, but everything was explained to me in words that I could understand in English and Italian. It was a December Sunday and we were sitting down at the dinner table at 2:00 p.m., as we always did on Sundays, Nanna, Babbononno, Mom, Dad, my uncles, and their families. The living room radio was on and suddenly, the music was interrupted by a news flash. It was 9:00 a.m. in Hawaii and Pearl Harbor had just been bombed by Japanese airplanes, a war-like act that had begun at 8:00 a.m., their time. The normally happy Christoforo/ Contini family became very solemn. I didn't understand until Mom explained things to me so a three year old could understand. In my young mind, I knew that something bad had happened.

The next day, none on the men in the family went to work. Babbononno worked for a company that made furniture. Uncle Paul, who lived on the top floor of our house, was a printer by day, young Uncle Gino worked at the Chelsea navy yard and Dad and Uncle Nick, both full time musicians, didn't opt for their usual Monday ritual and head for the musician's union. Along with Nanna, Mom and my aunts, the family surrounded the kitchen radio waiting for a broadcast from President Franklin D. Roosevelt. When it began, the president started out with, "Yesterday, December 7, 1941, a date that will live in infamy, the United States was suddenly and deliberately attacked by naval and air units from the Empire of Japan ... <sup>3</sup> and concluded by saying that a state of war existed between our two countries. When I asked what it all meant, I was told in two languages that we were in a war. Babbononno said, "Siamo in Guerra."

I had heard Babbononno pontificating at the dinner table about Italy and Mussolini tying up with Hitler and the Nazis. He hated both the Fascist and Nazi parties and thought they would eventually ruin the countries they were born in. I really didn't understand what was going on and I was told on that Monday morning that bad people were running those countries, and the Japanese, who had bombed Hawaii were their friends. When the broadcast was over, Nanna poured a second cup of coffee for everyone and the men discussed what was going to happen now that we were at war with Japan. Everyone decided to wait a few days to see what was in the news and headed out just before lunch time. They didn't have to wait too long. On December 11<sup>th</sup>, Germany and Italy declared war on the United States. Everyone knew that war was raging in Europe but American wasn't directly involved. The Germans and Italians had taken over North Africa, France had a puppet government faithful to the Nazis (Vichy France), and after the Battle of Dunkirk, the Brits were pushed back to England with London suffering bombing raids on a daily

basis. We were still isolationists, a position we took after World War I and maintained through the Roaring 20s and the depression of the 1930s. The decision was made by the men in my family to register for the draft. Babbononno was denied draft status because he was too old to serve (age 66) and Uncle Paul was on the borderline as far as age requirements were concerned. Dad, Uncle Nick and Uncle Gino were at the right ages and were give lottery numbers and told that when their numbers were called, they would be given more information on what to do. Actually, Dad and Uncle Nick had spoken to a marine recruiter who came to the union a month before Pearl Harbor. He signed several musicians to play in the marine reserve band that was located in Boston. They were told that they wouldn't go through the same training as "mud marines." The unit needed musicians and that's all they would do ... play music. The day of the swearing in, both Dad and Uncle Nick were involved in a recording session, and never made it to the Fargo Building in South Boston where the swearing in was to take place. They were lucky, because after Pearl Harbor, the musicians who had joined to play in the marine band were told to put their instruments away. They were sent to Parris Island, South Carolina, for a 13 week training program (boot camp) to become fighting men.

As the war intensified, Uncle Nick joined the navy and Uncle Gino, the army air corps. Dad accepted a teaching job in the Boston Schools. Although he hadn't gone to college, he had graduated from East Boston High School after majoring in machine shop as a trade. As a tradesman, he could return and teach the same skills without a bachelor's degree. He occasionally worked in the trade but became a professional musician right after graduating EBHS in 1929.

After military training, Uncle Gino was assigned to the 5<sup>th</sup> Air Force and sent to serve in the Pacific fighting his way from New Guinea to Japan, itself. Uncle Nick auditioned for the navy band and made it. He would spend the rest of the war playing for Andre Kostelanetz, serenading the brass at the Newport Naval Base. Not long after Dad started teaching, he was approached by two members of the OSS, the forerunner to today's CIA. The government was housing Italian war prisoners at facilities on the islands just outside Boston Harbor. When they ran out of space, they began housing the rest at the long-closed immigration station located on Marginal Street in East Boston. The OSS needed someone to interrogate the prisoners on a part-time basis and Dad's name came up for some reason. He accepted the job which wouldn't begin until the school day ended. He received permission to have a recording secretary accompany him and was given the OK after the person he chose was run through FBI files. The person was Michael Contini

(Babbononno). Dad's spoken Italian was marginal at best and Babbononno was of course, fluent. He also could read and write in both Italian and English.

Dad was able to get many of the POWs jobs working on the pushcarts that dotted the area from Central Square to the Sumner Tunnel. They could work as long as they reported back to their quarters by sundown. By 1943, when Italy surrendered and changed sides, many of the freed prisoners, especially the single ones, chose to stay in Boston and would settle into new lives and become American citizens.

Fortunately, Uncle Gino would come home in one piece, surviving the first of the bombing raids on Tokyo and the Japanese mainland. Uncle Nick and his wife, Aunt Ada, would part company and divorce by1950 (It took that long in Boston back then). Soon after, he and Aunt Dorothy would marry and spend the rest of their lives together.

In spite of my age, my memory serves me well and I remember all of the above as if it happened this year. My grandparents, parents, uncles and aunts have all passed on, but survived the war and prospered. Me? I guess I'm the one that has to keep the lamp lit with stories of my family and the way it was growing up as an American in an Italian family. **GOD BLESS AMERICA**

As our holiday baking continues, I am taking you to the Palermo region of Sicily, where Cuccidati or Sicilian Fig Cookies are their signature Christmas cookie. Cuccidati are a combination of a tender, sweet buttery dough wrapped around a scrumptious fruit and nut filling, then egg washed or white glazed and sprinkled with nonpareils. Some claim their history dates to the Muslim rule of Sicily, mentioning a strong Arabian influence as seen with the dried fruit, oranges, almonds and spices included in most recipes. Cuccidati are made in many different shapes from bite sized rolls to half-moons and curved with slits. The recipes also have slight variations in dough and filling according to region, family and personal taste.

Most Sicilian immigrants came to this country with their family's Cuccidati recipe in hand. Some still speak of the days in villages in Sicily where the women would bring their nuts, dried fruits and spices to the butcher shops so they could mince their fillings for the Cuccidati. Many Sicilian families continue the annual tradition of making Cuccidati for the Christmas holiday. Most have their own family recipe that they follow, and today I am going to share mine with you. I hope you enjoy them as much as we do!

## **CUCCIDATI** Sicilian Fig Cookies



Filling 2 cups dried figs 2 cups dried dates 1 tablespoon orange zest  $\frac{1}{2}$  cup honey

1/2 orange juice

- ½ raisins
- $\frac{1}{2}$  cup almonds, chopped
- 1/2 cup walnuts, chopped

2 teaspoons pure vanilla

4 eggs beaten, room

temperature

2 teaspoons pure vanilla extract

Add the figs, dates, honey, orange juice and orange zest to a medium saucepan. Cook over low to medium heat for about 20 minutes, until softened. Remove from heat and let cool. Add the cooked cooled fruit mixture, nuts and raisins to a food processor and process until smooth, set aside.



Add confectioners' sugar to a medium bowl, gradually add milk and vanilla and mix until a smooth consistently results. Dip tops of each cookie in icing, sprinkle with nonpareils and let dry. Store between waxed paper in an airtight container, in a cool dry place

#### Real ID Deadline Pushed to 2025

Five months before the latest Real ID deadline, Homeland Security has again extended when travelers need a federallymandated ID card for domestic flights. The new deadline is May 5, 2025, after the most recent deadline May 3, 2023.

The 24-month extension will address "the lingering impacts of the COVID-19 pandemic on the ability to obtain a Real ID driver's license hindered by licensing backlogs."

#### **Clothes** Recalled **Over Lead**

Nearly 90,000 pieces of children's clothing featuring "Disney" and "Star Wars" characters are being recalled over a risk of lead poisoning. The recall includes 87,000 clothing sets that were sold at TJ Maxx, DD's/Ross, Burlington, Army & Navy Exchange Service, Amazon.com and other retailers between November 2021 and August 2022.

#### **Record Number** at the Border

At least 73,000 illegal immigrant migrants were spotted crossing over the border into the United States but evaded Border Patrol officers, the highest number recorded evading border agents at the U.S.-Mexico line. U.S. Border Agents use the term "getaways" to describe immigrants who are spotted by cameras or by border agents themselves but avoided capture.

Since the start of the 2023 fiscal year that began October 1, there have already been 137,000 getaways. In the just ended fiscal year 2022, there were nearly 600,000 getaways. The year before that 389,155 getaways.

## Growing Easy-Care Aloe Vera, Nature's Burn Ointment

Aloe Vera plants grow best in sunny windows away from cold (Photo courtesy of MelindaMyers.com) drafts.

Grow your own burn ointment by adding Aloe Vera to your indoor plant collection. This succulent has been used for centuries to treat superficial burns, cuts, sunburns, and more.

The gel inside the leaves is the medicinal part of the plant. Just cut away the outer part of the leaf and use just the gel on the problem areas. Make sure to remove the latex plant sap located between the outer layer (skin) of the leaf and the gel that can cause skin irritation. It is always best to test a small area of your skin first.

You may have read about Aloe Vera being used in beverages and desserts. Properly prepare the aloe before consuming. Make sure to remove the latex and use only the gel to avoid cramps, diarrhea, and stomach upset. Keep Aloe Vera plants out of the reach of children, cats, and dogs.

Plant Aloe Vera in a container with drainage holes. Consider using a clay pot that allows the soil to thoroughly dry between watering and prevent larger often top-heavy plants from tipping over. Use a pot as wide as it is deep whenever possible to accommodate the spreading nature of this plant.

Cover the drainage hole with a coffee filter or piece of paper towel. This prevents the potting mix from leaking out the drainage holes after planting. Use a well-drained cacti and succulent potting mix.

Grow this plant in a sunny window along with your other cacti and succulents. South and unobstructed east or westfacing windows are usually the best. Set it under artificial lights if a brightly lit location is not available. Water thoroughly whenever the top third of the soil is dry. Avoid applying water over the center of the plant where it can collect between the leaves and lead to rot. Pour off excess water that collects in the saucer. Prevent early death of your plant by avoiding waterlogged soil. Watering too often or allowing the pot to sit in excess water can lead to root rot and the death of the plant. You will need to water less often in winter when days are shorter, light intensity is lower and plant growth is limited. Keep plants away from cold drafts and temperatures below 50 degrees Fahrenheit that can damage the plants. Northern gardeners may need to move the plants back a bit from the window in winter as outside temperatures drop.

Clean leaves occasionally with a damp rag. This removes any dust that may collect on the leaves and helps reduce the risk of insect pests such as mealy bugs and aphids. These plants are sensitive to many chemicals so check the label and test a leaf before treating the whole plant if additional treatment is needed.

Watch for small plants to form at the base of the original plant. You can use these offsets, often called plantlets or pups, to start new plants to grow or share with others. Use a sharp knife to separate the small plants, roots and all, from the parent plant. Repot the offsets in small containers just an inch or two larger than the remaining root system.

Boxing was once taught as an art form and not turning young men into Rock'Em Sock'Em Robots. There were trainers who knew how to take a promising young fighter and teach him the intricacies of the game. These trainers did not have a one size fits all approach. Rather they would assess a prospect's physical and mental strengths and weaknesses and work to develop a style that would work best for them. Some teachers, such as Cus D'Amato, had a more set method and would look for fighters that would best be able to fit into the style they taught. In the case of D'Amato, he wanted fighters with fast hands and a hard punch. They would best adapt to his peek-a-boo style. Mike Tyson and Floyd Patterson fit the mold.

Teachers such as Charley Goldman would approach a young fighter much in the way a sculptor would work on a piece of raw marble. He would study the prospect and then find the style that worked best to make him into a good fighter. Sometimes he had to come up with innovative methods to bring out the best in an awkward fighter, but one in whom he saw a spark of promise. This was best shown in how he develbest of his era. He fought Joe Gans, Harry Greb, and Sam Langford. Blackburn would go on to mold Joe Louis into a very great champion.

Yank Durham took a young Joe Frazier while not overly impressed with his skills saw the determination and work ethic he had along with that natural left hook and guided him to the title. When Yank passed away Eddie Futch took over and handled Joe for the rest of his career.

While a fighter has to have natural ability, having someone to bring that ability out and add to it is important. What these

trainers knew and taught has really become a lost art. There are still many young athletes with the potential to be great fighters, but there is no one left to teach them the intricacies of the sport. That knowledge has been lost and it's a shame. ## HOOPS and HOCKEY in the HUB

CASSIDY COMES BACK TO CAUSEWAY STREET — There is a bit of a tradition in hockey. Those that go elsewhere often return to the home of their former employer to make a statement.

And that really was what was the underlying theme of the Vegas Golden Knights' visit to Boston was — an opportunity for former coach Bruce Cassidy to make a statement to the franchise for forcing his departure last spring. The game took place one day short of six months since his dismissal back on June 6.

On paper, it carried as much weight as any regular season game — worth two points to the winners and a point to the losers of the overtime contest that saw the Knights emerge victorious 4-3 in the game that was decided by a shootout.

In the overall picture it did not really impact in a major way the potential playoff picture. Both teams are rolling along quite well. Barring total collapses both will make the playoffs come April.

But the photo on the first sports page of the Boston Globe's print edition the next morning told a different story, picturing a beaming Cassidy shaking hands with one of his assistants in the immediate aftermath of the triumph. Adding to the atmosphere, there was a fan in the background wearing a shirt with what seemed to be the somewhat less than happy countenance of a bear emblazoned on it, capturing rather well the defining final moment of the evening.

Cassidy said he had a lot of respect for the Bruins organization — a first class statement. After all, the franchise did run a tribute to him on the Jumbotron midway through the first period. But the sweetness of success that came with the victory definitely meant something to him. And the fact that his team halted the Bruins home game winning streak at 14 was surely icing on the cake. After it was over Cassidy did admit "it was not an ordinary game."

Earlier in his visit to the Garden Cassidv had looked upward towards the rafters where the banners of the B's various Stanley Cup championship teams are displayed. Although he had been with the franchise since 2008 (counting his years in Providence) he fell a bit short in his one appearance in the Stanley Cup Final — in 2019 when the B's lost to St. Louis in seven games. During their two other trips to the SCF in the 21<sup>st</sup> century — winning against Vancouver in 2011 and losing to Chicago in 2013 - he had been in Providence. He knows there is one possibility that will never appear on a tote board in Las Vegas the odds that he would return to the Bruins. If he wins a Cup it will be someplace other than Boston. Cassidy guided the B's to the playoffs each and every year he was behind the bench. He led the 2019-2020 Bruins to the Presidents' Trophy (most points accumulated during the regular season) and also won the Jack Adams Award (NHL Coach of the Year).

The contest on Causeway Street was really a two-sided event with Vegas jumping out to a 3-0 lead, leaving members of Bruins Nation to contemplate that their hopes of a 15th consecutive home victory had melted away.

But the B's managed to climb back into contention with Brad Marchand and David Pastrnak scoring second period goals, the latter's coming with just 25 seconds left in the period. Taylor Hall knotted it at three all in the third. Reilly Smith, who played two years for the B's during the Claude Julien era, provided the winning tally for Vegas in the shootout.

Bruce James Cassidy first served as an assistant coach with the P-B's for three years. Then he was promoted to the lead position behind the bench. He became a Big B's assistant in 2016 and took over the team after Julien was let go in February 2017.

In a way both Boston and Vegas have been living out a dream so far this season. The Bruins had amassed some 41 points following the Vegas game while the Golden Knights were not far behind with 39. They were first in the Western Conference and looking to eclipse the success of their inaugural season (2017-2018). In a city where taking chances are ever present, Vegas reportedly went off at 1,000 to one odds back in the fall of 2017 to win the Stanley Cup the following spring. The Golden Knights almost pulled it off - losing to Washington in the SCF.

But by getting that far, Vegas still won big that year. A team that existed only on paper 12 months earlier actually posed a realistic threat to win the biggest prize of all in hockey.

And now comes Cassidy, after 14 years with the Bruins franchise (Providence and Boston combined). It took four people to dismiss him in the Hub. In the official transcript of Don Sweeney's press conference last spring, the GM stated that he forwarded his "recommendations" to B's President Cam Neely, plus franchise CEO Charlie Jacobs and team owner Jeremy Jacobs.


When they collectively decided to pull the trigger, it took only eight days for Vegas to swoop in and sign him to a contract What was that old saying about the house always winning? Sounds like it did when Vegas got Cassidy. And the B's also got their right guy. But in a slower way. It was about a month after Cassidy was dismissed that Jim Montgomery signed on in the Hub. Now he is the man of the moment on Causeway Street and has the Bruins sailing smartly toward the playoffs. Out West, the Knights bet the favorite right out of the gate and things are working out well in a similar fashion. With a nod to Clement Clarke Moore, the author of the immortal poem The Night Before Christmas, we present a somewhat altered wording: "The members of Bruins Nation were nestled all snug in their beds, while visions of a Boston-Vegas Stanley Cup Final danced in their heads.'

Some, such as Jack Blackburn, were great fighters themselves. Blackburn learned by doing and was in with the
