MORE STAINED GLASS

The most beautiful stained glass windows ever to be produced are said to be in the Cathedral at Chartres. The edifice stands on a low hill, 55 miles south of Paris, and it dominates all of the other buildings in the vicinity. The church spires can be seen 20 miles away. Fire destroyed two previous churches which stood on the same site. While the church was being built for the third time, preachers solicited gifts from all over France. People gave money, food, or labor. Other churches were larger, higher, and more richly decorated, but Chartres is known for being a people church, and also a pilgrim church. Students from the Sorbonne, part of the University of Paris, make an annual weekend pilgrimage to this church by walking the 55 miles, inspecting the stained glass, camping overnight in the church and then hiking back the next day. We must be mindful of the



fact that during this time in history, it was the clerks and scribes who were literate, but almost all others could not read or write and had to be told about their religion in picture form. Early Christian art started on the walls of the catacombs, and gradually grew into a vast language of symbolism which told stories of the Bible and of the Lives of the Saints. The Creation, Flood, Annunciation, Nativity, Miracles of Christ, The

Crucifixion and The Resurrection were retold many times in this manner. The dove became the symbol of Peace and the Resurrection of Christ, the anchor symbolized faith, and a fish was the symbol for Christ.

Even the saints had their distinctions: St. Peter always held the keys to the gates of Heaven and St. Paul held a scroll, while St. Matthew held a purse. St. Catherine was always shown with her wheel of martyrdom and St. Mark was shown with his lion, to name just a few.

During medieval times, people asked "What should one do upon entering a church?" and the answer usually was: 1. take Holy Water; 2. pray to the Almighty; and 3. read the stained glass windows. The windows in the medieval cathedral became a spiritual encyclopedia to show the people what they were to believe.



Attorney Joseph Boncore

Announces Candidacy for State Senate

Winthrop native and attorney Joseph Boncore has announced that he will run for State Senate to represent the First Suffolk and Middlesex District, which includes Cambridge,



to take place on May 10, 2016. Born and raised in Winthrop, Boncore, 33, is the current chair of the Winthrop Housing Authority, a seat he was elected to in 2009. Boncore also serves as the chair of the Town of Winthrop Ordinance Review Committee, a position that two Town Council Presidents appointed him to. As a bar advocate with Suffolk Lawyers for Justice, where he often provides legal representation to indigent clients, Boncore has practiced law with the Boncore Law Office since being admitted to the Massachusetts Bar in 2007 Boncore also serves as the National Vice President of the Sons of Italy in America and is member of the Justinian Law Society.

Boncore looks to fill the seat vacated by Anthony Petruccelli, who resigned on January 21, 2016, to take a position in the private sector. "I will have some big shoes to fill if I am fortunate to earn the support of the district's voters. Senator Petruccelli served as an effective leader for this district for eight years. I hope I can continue his work with a similar passion," said Boncore while campaigning in Revere.

The district's makeup means that the next State Senator will need to address a number of critical issues, including housing, Logan Airport expansion, substance abuse and addiction, public safety and transportation. "As a result of my experience as a public defender and my work with the Housing Authority, I find myself often helping the members of our society who are most in need," said Boncore.

One issue that stands out for Boncore is substance abuse and addiction. "Society needs to come to the realization that addiction is a disease and should not be conceived as a stigma. We can't just label those suffering from addiction as criminals. Many of the people I interact with would not be involved in the criminal justice system if they had access to the resources needed to deal

with their addiction or the underlying mental health issues for which they may be selfmedicating," said Boncore. Pointing to the disparity in funding, Boncore wondered why "the Commonwealth spends four dollars

on putting an addict through the criminal justice system and only one dollar on treatment, when the opposite should be true." Boncore believes that we can make significant progress in combating these issues by targeting the youngest citizens and investing in the means to identify and diagnose mental health issues in our children while making resources available for treatment and education on the negative effects of opiates.

Denise LoConte of Winthrop says she is in Boncore's corner. "I have known Joe and his family for many years. He has always stood out amongst the best and brightest in this community and is a person that truly knows how to help others. I look forward to having him as our next State Senator."

Boncore has already assembled a talented campaign infrastructure and finance committee ... many whom helped elect former Senator Anthony Petruccelli in his victory over Dan Rizzo in 2007. In addition, Boncore is reaching out to younger voters and encouraging their involvement.

Juan Jaramillo of Revere is excited to be working with Boncore on his campaign. "I am thrilled to work for Joe because the issues at stake in this election, issues that Joe proudly stands behind, like the need for criminal justice reform and affordable housing, are vital to preserving the fabric of the communities of the district." Juan is the former Program Director for the civic organization Revere Youth in Action, which has worked on social justice issues throughout the community.

A formal campaign kickoff is scheduled for Friday, February 19, 2016, at the Beachmont VFW Post at 7:00 pm, where Joe will outline his priorities for the Senate district. The public is welcome to attend.

To date, the campaign has already received endorsements from the International Union of Painters and Allied Trades District Council 35 and International Association of Heat and Frost, Insulators and Asbestos Workers (Local 6).

Mayor Walsh Announces Launch of

Boston Paytix, a New Parking Ticket Payment App

Mayor Martin J. Walsh announced that the City of Boston is launching Boston PayTix, a new app that allows for quick, convenient and secure parking ticket payments by smartphone. The app also provides parking ticket payment reminders and alerts to help motor vehicle owners avoid late fees; a feature for users to maintain an online list of their personal parking ticket history; and an option to look up their unpaid parking tickets. The free Boston PayTix app is being introduced as a joint collaboration between the Mayor's Office of New Urban Mechanics, the Department of Innovation and Technology and the Boston Transportation Department in partnership with Xerox.

"The new PayTix app is another example of how we're using technology to make city government more efficient and effective for the people of Boston," said Mayor Walsh. "We've seen through other city initiatives, such as ParkBoston and 311, that mobile apps are a great tool and we look forward to continue finding new ways to utilize technology to improve basic city services."

"Like the new smart meters being installed on local streets to replace our inventory of outdated parking meters, PayTix is a good example of how current technology is being used to improve customer service and enhance our parking management system in Boston," said Gina Fiandaca, commissioner of the Boston Transportation Department. Over the past year, through another partnership with TicketZen, the City saw a steady increase of parking violations being paid with the mobile app. The proofof-concept project for mobile parking ticket payment with TicketZen showed the demand from users to continue this service, with over 2,100 ticket payment transactions a month through the app. TicketZen made a business decision to focus on other products at the conclusion of the pilot with the City in November.

"While it's never fun to pay a parking ticket, we want to make sure that every digital interaction with the City of Boston is friendly, convenient, and fast," said Chief Information Officer Jascha Franklin-Hodge. "PayTix joins BOS:311, Trash Day, and

apps for people who live or work in Boston." "We were thankful to work with a local start-up in TicketZen over the past year, and learned a great deal about the demand for these types of services available on mobile devices," said Kris Carter of the Mayor's Office of New Urban Mechanics. "We are excited to launch the next generation of this service in the Boston PayTix app, just one of the digital tools making life easier for both visitors and residents. "Boston PayTix is available to smartphone users at the App Store and Google Play. When a City of Boston parking ticket is received, users should use their phone to scan the barcode, enter their payment information and press the submit button. Parking ticket numbers may also be entered manually. If your ticket has not yet been

This holiday is named after a Saint Valentine or San Valentino, about whom many legends arose — one says that he performed forbidden marriages for Roman soldiers, another says he fell in love with the blind daughter of his jailer and cured her, then addressed himself as "her Valentine" prior to his execution. Meanwhile, some scholars believe that the pagan origins of this feast hearken back to an ancient Roman festival known as Lupercalia, dedicated to purification and fertility. While there is no direct link between Lupercalia and Valentine's Day, these mysterious origins of the holiday, both in religious and folkloric terms, point to its importance as a springtime celebration of love and renewal.

Indeed, love blooms all around us on St. Valentine's Day. One medieval superstition, popularized by Geoffrey Chaucer, claimed that birds chose their mates on Valentine's Day, a tidbit of lore which speaks not only to the romantic connotations of the holiday, but to its links to fertility and nature's rebirth. Other ancient bird superstitions pertaining to Valentine's Day stated that the first feathered friend a girl saw on this holiday presaged the career of the person she would one day marry – a robin meant a sailor, a goldfinch meant a wealthy person, a bat meant a baseball player, etc. (I am not sure which bird signified "an insurance specialist in a travel company," because that is the one I must have seen.) Over in Italy, people celebrate St. Valentine's Day, or il Giorno di San Valentino, much in the same way as it is celebrated in the United States, with romantic dinners, flowers, and cards. The really romantic Italians may trek to the beautiful city of Verona, where they will gather

under Juliet's balcony and contemplate the star-crossed lovers of William Shakespeare's tale. Modern lovers scribble their initials on the tunnel walls near the balcony, creating a veritable mural to the history of passion. Meanwhile, the lovelorn write their own letters to Juliet, or Giulietta as she is known in Italy, asking for her wisdom in romantic matters. These superstitions and folk traditions pay homage to the intense and, at times, crazy power love wields in our lives. It is wonderful to have a quaint holiday, poised on the precipice between winter and spring, which honors love in all its multifaceted shades.

This Sunday, February 14th, I know that I will be eating chocolate in some shape or manner, most likely in the form of the red velvet chocolate chip cookies I will make for my husband. However, I will also express my gratitude for all those in my life whom I love — my family, my friends, even my pets. After all, nothing melts the proverbial winter more than the laughter and care of our loved ones. We should honor this love not only on St. Valentine's Day, but every day of the year. As spring approaches, let us notice the truly loveable signs of the renewal of nature that surround us: the first flower buds peeking out from the dirt, a robin hopping around in the shadows of a bare bush, the pale glow of the evening sunshine. Just as St. Valentine's Day reminds us to recognize love in all its glory, we can also recognize this love in the natural world around us, bright as the spring sun.



Saint Magnus Erlendsson, Earl of Orkney

In order to understand the story of Saint Magnus, we need to know something of his immediate family. Magnus's grandparents on one side were Earl Thorfinn and Ingiborg Finnsdottir (whose father was related to Kings Olav II and Harald II of Norway) who gave birth to twin sons, Erlend and Paul.

Magnus, born in 1075, was the son of Erlend Thorfinnsson, a Viking and Earl of Orkney. He was expected to rule over part of the islands after his father's death. His father, Erlend, ruled Orkney with his brother Paul, and the two men were great friends and shared the islands between them. Paul's son, Hakon, was a greedy and violent man who quarreled with his cousin Magnus, and even brought about strife between their fathers, and so the Orkney Islands were divided between them so that they held their own territory separate from each other. Hakon was subsequently sent to Norway, where he was appointed to act as regent on behalf of Sigurd, a Prince of Norway, and was made an earl in 1105.

Magnus Erlendsson, meanwhile, was struggling to strike the right balance between the political and military expectations for him and his Christian beliefs. On one occasion (in 1098) Magnus sailed with Hakon and King Magnus Barelegs to pillage the islands off the west coast of Scotland. The party then decided to sail down the west coast of Britain and raid Wales, but Magnus seems to have had friends in Wales. He proclaimed "I have no quarrel with any man here," and refused to participate in the Welsh raid and remained on board praying. His fellow Vikings perceived his refusal as both cowardly and treacherous.

Magnus was obliged to take refuge in Scotland, but returned to Orkney in 1105 and fought with Hakon over the succession. Having failed to reach an agreement, he sought help from King Eystein I of Norway, who granted him the earldom of Orkney, which he ruled together with Hakon until 1114.

Their followers fell out, and the two sides met on the Orkney mainland, ready to do battle. Peace was negotiated and the Earls arranged to meet



each other on the island of Egilsay at Easter, each bringing only two ships. Magnus arrived with his two ships, but Hakon turned up with eight ships. Magnus, aware of his cousin's treachery, escaped and made his way to shore and went into hiding, eventually taking refuge in the court of King Malcolm and Queen Margaret of Scotland.

Magnus later took refuge in a church overnight, but the following day he was captured and offered to go into exile or prison. Hakon, seizing his opportunity, had Magnus killed by a blow to the head with an axe. This occurred on the island of Egilsay in 1115.

It is reported that the last words of Magnus were a prayer asking forgiveness for his killer.

Saint Magnus is buried in the cathedral of Saint Magnus in Kirkwall, Orkney, Scotland.

St Magnus was canonized in 1135. He is the patron saint of the Orkney and Shetland Islands. His feast day is April 16th.

GERRY ADAMS

(October 6, 1948, Belfast, Northern Ireland):

From Revolutionary to Peacemaker



More than anyone, Gerry Adams is the central figure of all political issues concerning Northern Ireland. Following in the footsteps of his father and grandfather before him, both Irish Republican fighters, he began as a rioter in his youth and grew to be Northern Ireland's most powerful political leader today as well as the president of the Irish Republican Party, Sinn Fein, since 1983.

Adams, however, has not been devoid of controversy. Some of it added to his reputation as a fierce leader against British forces. He was first arrested in March of 1972, but released thanks to the IRA, who were able to negotiate a truce (albeit a short-one) with the British government. Ironically, his second arrest, in July of 1973, did more to enhance his reputation. After a failed escape attempt, Adams spent the next three years of imprisonment writing and publishing articles for the cause of Irish liberation. It's a testament to the support he garnered that when he was arrested a third time in 1978, for allegations of involvement with the IRA, the charges failed to stick and he was released.

By this time, Sinn Fein was growing into a powerful political party (with tactics that could no longer be ignored, such as the hunger strike of 1981) and, in parallel, Adams's status was growing. In 1983 he was elected president of his party and, in a perverse way, an assassination attempt by the Ulster Defense Association the following year indicated how much of a concern he had become to Britons.

For his part, Adams has always denied involvement with the IRA, though some biographers disagree. Adams himself may have fueled the confusion by attending meetings during the organization's formative years and supporting the movement while avoiding official membership. Former IRA members like Anthony McIntyre and Richard O'Rawe have also added to the confusion, crediting Adams as an instrumental part in the growth of the IRA. While Adams fought off allegations of involvement with the 1978 La Mon restaurant bombing and organizing the transport of explosives that killed Officer Seamus Quaid in 1980, the allegation that caught the most attention and proved the most devastating for him was the accusation of assisting in the murder of British informant Jean McConville, and the subsequent cover-up, back in

1972. McConville was one of the sixteen who "disappeared" during the troubles that spanned thirty years of turbulence between the United Kingdom, the Ulster Loyalists, and the Irish Republican Army.

In this instance, Adams' greatest foe proved to be Provisional Irish Republican Army volunteer and activist Dolours Price, who had become increasingly hostile to Adams's plea for reduced violence. Price claimed that the murder (committed in 1972) was ordered by Adams and that he even assisted with the burial of her body (which was discovered in 2003). It's likely that Price contributed to Adams' arrest for the murder in 2014, though the degree is questionable. Be that as it may, Adams was released without charge after no evidence was found connecting him to the murder.

Despite the emotional toll these trials and allegations took, Adams was charging full steam ahead as President of Sinn Fein. He became regarded as such a powerful opponent



strongly opposed the inclusion of Sinn Fein in talks, at least until the IRA disbanded. To keep their votes, Major excluded Sinn Fein and the IRA revoked its ceasefire.

Fortunately, this turned out to be but a mere stumbling block. With the election of 1997

the Ulster Unionist Party, which

to be but a mere stumbling block. With the election of 1997 came a shift in party (the Labor Party took over) and a change in ideology. This solidified the Belfast Agreement, uniting the British government, Sinn Fein, and the Unionists. With the IRA agreeing to a ceasefire, once more violence dropped drastically, save for the Omagh bombing in August of 1998 which resulted in the death of 31 people. Adams condemned this action despite his tendency to not speak out against the IRA.

Some friction continued to exist, even amongst more unbending members of the Irish Republican Party, who saw Adams as growing soft for the ease with which he compromised, but his popularity largely stayed strong winning him re-election in 2007.



of British rule that Margaret Thatcher, in one of her most ridiculed moves, banned all broadcasts of his voice (along with those of others, though Adams' was the most prominent) for fear of rallying up the opposition.

By the mid-80s, Sinn Fein began moving toward a more mainstream approach to politics under Adams' leadership. This would culminate into the Belfast Agreement between the British Northern Ireland Office, the Secretary for State for Northern Ireland, and the Government of the Republic. The most valuable product of this agreement was an IRA ceasefire in 1994. At first, this seemed like the promise to a new peaceful beginning, but developments were slow and British Prime Minister John Major was becoming increasingly reliant on support from

From here, Adams' prestige continued to grow with a 2010 re-election as MP for West Belfast and he made history in May of 2015 by shaking hands with Prince Charles on his visit to Galway. It was a meeting of reconciliation between the British Royal Family — who had suffered a loss at the hands of the IRA in 1979 when a bomb the group set-up killed the prince's great-uncle Lord Louis Mountbatten, his grandson Nicholas Knatchbull, Lady Doreen Barbourne, and a local teenager — and Gerry Adams, who was considered part of the IRA think-tank then, justified the bombing.

And so, Gerry Adams, Sinn Fein President and revolutionary, has completed his circle as peacemaker, becoming not only Northern Ireland's most influential figure, but her most enigmatic.

Practice Safe Skin with Free Public Sunscreen

Melanoma Foundation of New England (MFNE), a non-profit aimed at reducing the incidence of melanoma, the deadliest form of skin cancer, is now offering cities, non-profits and private businesses the opportunity to obtain weather resistant, low maintenance sunscreen dispensing units for the benefit of their communities. A limited number are available for free to municipalities and non-profits that apply via an online RFP process, and any public or private organization can purchase dispensers for their use or as a donation. This sunscreen distribution program, called Practice Safe Skin, offers an effective preventive measure to help visitors avoid sun over-exposure year round in public and private recreation areas including playgrounds, ski areas, beaches, civic buildings and amusement parks.

The RFP process to apply for a free unit runs through March 30, 2016, with priority given to New England-based organizations in the first round. Businesses and organizations seeking to purchase units can apply online throughout the spring.

Melanoma is rising faster than any other cancer, with one person dying from the disease every 50 minutes. Studies show that with daily sunscreen protection, the risk of melanoma is reduced. In response to the Surgeon General's 2014 Call to Action to address skin cancer as a major public concern, MFNE and partner Make Big Change (MBC) launched a pilot program during the summer of 2015 to donate free sunscreen throughout Boston parks and Massachusetts beaches at no cost to taxpayers.

According to Deb Girard, Executive Director of MFNE, "Our pilot program this past summer to install sunscreen dispensers within the City of Boston and on Massachusetts state beaches was a huge success. We are thrilled to be able to expand on that program and offer these sunscreen units for public and private distribution throughout New England and beyond." She added, "We hope these sunscreen dispensers will become as ubiquitous as hand sanitizer over the next few years in businesses and outdoor recreation areas across the country."

Following the success of the pilot program, the

Abraham Lincoln, 16th U.S. President, was born on this day, February 12, 1809. The first president to be assassinated, Lincoln died the day after he was shot by John Wilkes Booth, on April 15, 1865. President Lincoln is buried at Oak Ridge Cemetery, Springfield, Illinois. In 1876, a gang of thieves broke into Lincoln's tomb, planning to hold the body for ransom. They were apprehended and punished with a year in jail for lock breaking, because there was no law against body snatching. The Illinois legislature quickly passed one, and Lincoln has lain undisturbed ever since.

She said the initiative was aimed at reducing HIV transmission and unplanned teenage pregnancies, which are both rampant in South Africa and frequently cause women to drop their studies. But Mfanozelwe Shozi, the chairwoman of South Africa's Commission of Gender Equality, said she would investigate the policy because, "there is an issue around discrimination on the basis of pregnancy, virginity, and even against boys."

Celine Dion saw her older brother Daniel, 59, quietly laid to rest in Charlemagne, Quebec, just a day after the lavish state funeral for her husband and manager, Rene Angelil. Both men had long battled cancer. Angelil, 73, was remembered in an emotional, live-streamed service at Notre Dame Basilica in Montreal, where he and Dion were married 21 years ago. The singer sat shrouded in a black veil as her oldest son Rene Charles, 14, delivered the eulogy and her hit songs



played over the loudspeakers. "He will be remembered as a gentle man, generous and kind, an unprecedented visionary, a modern Pygmalion, a Renaissance man," she said in a Facebook

Great move! A Norwegian man wearing only his underpants stopped a thief from stealing his car by clinging to the roof in near zero-degree temperatures. Police said the 25-year-old woke in the night to hear his car being stolen, and without stopping to dress, raced outside, grabbed the vehicle's roof bars, and clung on as the thief sped off at nearly 60 mph. The man broke a window and grappled with the thief, causing him to crash. "Bruce Willis wouldn't have managed that," said Police Chief Jan Nesland.

Criminals in Australia who attempted to siphon gasoline from a tour bus got a nasty surprise when they accidentally tapped the vehicle's sewage tank. Police said thieves targeted the bus as it was parked overnight, but removed the wrong cap; when they started siphoning, by sucking on a hose, they got a mouthful of human waste. "We can infer they beat a very hasty retreat, with a somewhat bitter taste in their mouth,' said police.

An Illinois man is earning \$1,500 a day by demonstrating a mystifying ability to stick beer cans, liquor bottles, cell phones, and other objects to his head. Jamie Keeton, 47, discovered his adhesive ability as a child, when toys would stick to him, and is now paid by companies to attend parties, concerts, and sporting events with branded products stuck all over his shaved head. Doctors are baffled by his condition, but Keeton says he has unusually deep skin pores that act like tiny suction cups. "It's exciting for me and my friends and family," he said. The Transportation Security Administration seized 2,653 guns from airline passengers' carryon bags last year — a 20 percent increase from 2014, and a new record. More than 80 percent of those guns were loaded!

A boom in gun sales, — a record 3.3 million weapons in December 2015 alone — has left the federal government "overwhelmed" by the number of background checks it must perform, Attorney General Loretta Lynch told Congress. The Obama administration says it needs to hire 430 people to keep up.

Of the 45 million people who visited the U.S. last year, more than a million overstayed their allowed welcome, according to a new Department of Homeland Security report. Canada was the top source of illegal overstays, with 93,035. Mexico was second with 42,114.

PASTA CON BROCCOLI (Great Lenten Dish)

10 ounces cut-up broccoli frozen or fresh

6 cups water

- 2 tablespoons olive, canola, or vegetable oil
- 2 tablespoons butter or margarine (optional) 1 cup cut up *spaghetti
- or short pasta of choice 2 small minced garlic cloves

(optional) Salt to taste

*Break up spaghetti or thin spaghetti into two-inch portions.

Bring six cups of water to a boil in a saucepan. Add cut-up broccoli to saucepan, cover and cook at a slow boil for about five minutes. Add cut up spaghetti or pasta of choice to broccoli. Stir and cook until pasta is to your liking. *Add oil, butter or margarine, and salt to taste. Stir and continue to cook for a few seconds before removing from burner.

*Variation: Place oil in a small bowl. Add two small minced garlic cloves to oil. Stir and add to broccoli/pasta mixture. Place saucepan on burner, bring to a boil and then remove from burner. Salt to taste. Serves two.

NOTE: When Mama was needed in the bakery, she prepared this simple meal on a two-burner gas unit that Papa had installed in a back room of the bakery. Those evenings, we ate on a makeshift table created by turning over one of the 3' x 6' wooden bread boxes that my brother Peter or Papa rested on a few milk crates or wooden horses. We had family discussions during the meal just as we did in our apartment. Papa insisted on the family having our meals together.

Meat did not have to be served for supper when Mama prepared pasta with broccoli because our family preferred having a second helping of pasta in place of meat.



Nanna & Babbononno

A Nostalgic Remembrance



I guess I've never been much for winter sports. As a matter of fact, as a young single man, I only vacationed north of Boston once during a winter break. My preference was to head to warmer climates where I could see palm trees, coconut trees and skis ... water skis. The one exception happened when I was in my early twenties. I was in graduate school at the time and living back with my folks, which helped me pay my own way through. Babbononno was living with my folks and would often ask me questions about what I was studying. I know down deep, he regretted not having gone beyond the 6th grade. He was quite inquisitive and intuitive, especially when it came to the history courses I was taking. We had many in depth conversations about how the world would be if history had led us in other directions.

I was home studying one night when Babbononno answered the phone and yelled, "Jenny, dissa cawla foh you. Penso che e una ragazza giovena e possiblemente bella?" (Johnny this call is for you. I think it is a young girl and possibly a pretty one.) It turned out to be one of the teachers on the faculty of Hyde Park High School, a young single teacher who was attractive, just like Babbononno imagined. We talked for a bit, and in the conversation she mentioned that she belonged to a ski club in New Hampshire. They were having an open house that coming weekend to interest new prospective members. The weekend was the one just before the February school vacation and my band wasn't booked anywhere, nor was I working with any other group. On a whim, I agreed to take her up on her invitation. She then informed me that I could invite a friend along to the open house weekend.

Just as soon as I hung up, I called Sal Meli, one of my closest friends and a person who was ready, willing, and able to take off at a moment's notice. He didn't have any plans either, and that Friday, as soon as school let out, I headed from Hyde Park to Polaroid on Route 128 and picked him up. Both of us had suitcases filled with warm clothing, because it was winter and we were heading to a ski lodge at the foot of Cannon Mountain in central New Hampshire. The only thing I knew about the area was that during February, it was damn cold. A few hours later, we arrived in ski country. Boston had a bit of residual snow on the ground from a snowstorm earlier that week. Cannon Mountain and its environs had several feet of hard-packed snow on the ground, and I thought I was in another world when we arrived.

I found the young teacher who invited us sitting in the lobby of the lodge, just waiting for us. She helped us check in, then we headed to the dining room for a late dinner. After dinner, we were given a ski lesson by a tall blond German ski instructor. The lesson was basically how to put our skis on, how to push off and how to stop. After that, it was cocktail time, and the instruction area became a pub.

The next morning Sal and I sat at a breakfast table next to a window that faced the novice slope of the mountain. I could see beginner skiers falling all over the place and became nervous about my own future on skis. When we headed out of the lodge, I knew that we were north, way north of Boston. It was a clear day with the sun shining on Cannon Mountain and the temperature was about five degrees below zero ... ouch.

Sal headed off on his own, as he was a journeyman skier. I headed for the novice slope, but couldn't get on due to the number of people falling all over the place as they tried to ski, possibly for the first time, just like me.

I got on a "T bar" and headed for the middle of the mountain. I figured it wouldn't be as crowded and I would have a better chance with my first attempt if I had a little room to maneuver. Well, the middle of the mountain was just as crowded as the novice slope with the exception of the falling skiers. I then climbed into a gondola and headed for the top of the mountain. There were less people up there, and when I arrived, I understood why. The angle of the slope was about 75 degrees (that's a steep angle) and the temperature was 10° to 20° below zero. I watched the expert skiers for several minutes and then did what they did: checked the laces on my boots. snapped on my skis, got myself into a position where I could push off and headed down the mountain. The only difference between me and the other skiers was that I was praying in Italian and English at the same time as I picked up speed heading down Cannon Mountain.

Well, I made it to the middle of the mountain without falling and continued toward the novice slope. When I got there, I zigzagged around all of the beginners who were still falling down. I somehow made it past them all without any collisions. The outside wall of the lodge kept coming closer, and I

snow plowed (pointed my skis toward each other) to help me stop. I then twisted my body so that my skis were parallel to the wall and dug my poles into the hardened snow. I stopped without falling even once. The next step was to not temp fate. I immediately removed my skis, stood at attention and saluted Cannon Mountain. The young teacher who had invited me, happened to witness my events of the morning, walked over and whispered in my ear, "Beginner's luck.'

At that point, I promised the good Lord that I would never attempt to ski again. I didn't want to tempt fate. I returned the skis and other rented or borrowed accessories to the rental office of the club and headed to the lounge and a large hot chocolate. At that point I discovered several parts of my body were numb from the cold and realized immediately that my ancestors were from the southern part of the Italian peninsula where palm trees grow even in winter. I made a pledge never to try to defy my ancestry or insult my ancestors ever again, and swore that if ever I was to don another pair of skis, they would be the type that could be used on a lake, pond, or body of water that was near or in the tropics. I have kept my word on this subject throughout my life.

I did return to ski areas many times after this point. Each time, I enjoyed the friendship of others who I came in contact with (inside the resort buildings). Loretta and I have taken our sons on ski trips and they are quite good at it. When my son John was living in Zurich, Switzerland, we brought the boys skiing in St. Moritz every time we visited him. He and Michael skied, I stayed indoors. Mayor Walsh Launches "Neat Streets"

to Target Cigarette Butts on Boston Streets and Sidewalks

Mayor Martin J. Walsh launched "Neat Streets," an interactive public space installation, which aims to deter littering behaviors among residents and visitors who smoke cigarettes.

"Boston is a beautiful city, but to keep it that way we must all do our part to keep our streets clean," said Mayor Walsh. "This smart and innovative effort incorporates a public polling process to engage our residents and visitors in protecting our environment."

Modeled after a similar initiative in London, the Neat Streets initiative is aimed at decreasing litter on the streets in an interactive manner. One facet of the initiative is the cigarette butt receptacle, which prompts smokers to dispose their cigarette in a slot on a board by voting for the question being posed at the top of the board. For example, "More essential Boston winter gear? Hats or boots?" Residents and visitors are encouraged to submit questions to @ CityofBoston on Twitter, using hashtags #NeatStreets or #Neat-StreetsBos, through March.

Cigarette butt receptacles will be located throughout the city at locations chosen based on maximum foot traffic. Neat Streets will be installed by the end of February. Danger! Awesome, a



makerspace, helped in tailoring the boxes for Boston streets.

According to the Centers for Disease Control and Prevention, smoking remains the leading cause of preventable death and disease in the United States, killing more than 480,000 Americans each year. Smoking causes immediate damage, which can lead to long-term health problems.



In the end, Peyton Manning the game manager was good enough for the Denver Broncos after all. Following an NFL career spent continually carrying teammates, it was his team that carried him in his 17th and possibly last season. All the way to a second Super Bowl title.

"I feel very, very grateful," said a reflective Manning post-game. "It's very special to cap it off with a Super Bowl championship."

Setting the record for the fewest offensive yards by a winning team in the Super Bowl, the Broncos paltry 194-yard assault will be out-weighed in the history books by the seven-sack output by their defensive unit. The sack total tied the sum tallied by the 1985 Chicago Bears in Super Bowl XX.

In citing that great Bears' team, it's fitting that Denver's Von Miller became the first pass-rusher to earn the Most Valuable Player (MVP) award since Chicago's Richard Dent garnered the honor just over 30 years ago. "If I could cut this award, I would give it to Demarcus Ware and Derek Wolfe and all the other guys [Defense]," said Miller. "The MVP is great, but I'll just take the ring.'

Miller was once again an unstoppable force for Denver, tallying 2.5 sacks of Panthers quarterback and 2015 NFL MVP Cam Newton, while also forcing two fumbles, both of which led to Bronco scores. His first stripsack was recovered by lineman Malik Jackson in the end zone for a 10-0 first quarter lead. The second came in the fourth and was recovered by safety T.J. Ward. With the opportunity to scoop up the recovery, Newton simply shied away. He would repeat the gesture in his post-game press conference. More on this later.

On a day where he didn't have to be Manning of old, Peyton should be credited for jumpstarting his team, leading the Broncos on a 10-play, 64-yard

drive, capped off by a 34-yard field goal by Brandon McManus. Manning completed only 13 of 23 passes for 141 yards, and for the most part looked like he was throwing a wet loaf of bread instead of a football. But while the arm may be gone, his pre-snap reads and field smarts remain.

Similar to their AFC Championship game versus the Patriots, the Broncos special teams unit outshined their counterparts on the opposite sideline. A miscue by the Panthers coverage team in the second quarter led to three for the Broncos. When Jordan Norwood decided against signaling for a fair catch, the Panthers were bewildered, appearing to not know what to do. Despite bumping him as he made the catch, they never tackled him, allowing Norwood to maneuver through 61-vards of playing field before being wrestled down. Later in the third quarter, a field goal attempt by Carolina kicker Graham Gano struck the crossbar.

The lone bright moment for the Panthers came when defensive end Kony Ealy intercepted Manning on a third-down play at the Carolina 24-yard line. Manning forced the ball to wide receiver Emmanuel Sanders despite the 6'4", 275-pound Ealy being directly in front of Sanders. Ealy also registered three of the five Panther sacks in Super Bowl 50.

And what of Cam Newton? The boisterous NFL MVP was at a loss for words following a humbling 18-of-41, 265-yard, one interception performance on pro football's biggest stage. In post-game interviews, Newton offered only dejected, mostly one-word answers. "I don't know what you want me to say. I'm sorry." Fitting, I suppose, as his output on this day was also not on par with a stellar 2015 season. At 26, Newton's skills are unques-

Walt "No Neck" Williams, R.I.P.

Walt Williams, a high-energy outfielder who played for four Major League teams in his career, was probably best known for his physique that got him the nickname of "No Neck." He recently passed away in Texas on January 23rd at 72 years of age. Williams played most of his career with the Chicago White Sox. He began in Houston and finished with the NY Yankees, spending one season with the Indians. Fans loved him wherever he played baseball. He was often compared to Pete Rose

for his over-caffeinated play. He was so eager to hit the ball, he rarely walked, and never had more than 26 walks in a single season of play. He only struck out 211 times in a 10year career.

He had a quick bat and was very good at bunting, but had little power. He only hit 33 home runs in his career. His best year was 1969 when he hit .304, making him one of only six American Leaguers to top .300 that season. Williams was short and broad, and thus got his nickname.

Before the 1963 season, he signed with the second year Houston Colt 45s, playing with their minor league team, then playing in the big league briefly before being picked up on waivers by the St. Louis Cardinals. Williams was quickly traded to the White Sox where he made his debut in 1967.

After his Major League career ended, he ended up playing baseball in both Mexico and Japan

In 1897 Ruby Robert Taught Gentleman Jim About Solar Power

James J. Corbett, also known as Gentleman Jim, won the Heavyweight Championship of the World from John L. Sullivan in 1892. It was only Corbett's thirteenth professional fight, and in it he not only overcame the odds in defeating the great John L., he also ushered in the era of modern boxing. The Corbett/Sullivan bout was the first title fight held under the Marquis of Queensbury rules. It was very similar to the rules we have today, requiring rounds be of three-minute duration and with each participant wearing padded gloves. It was an effort to add a layer of sophistication to a sport that was considered by many at the time to be barbaric. The fight was held at the prestigious Olympic Club in San Francisco.

After winning the title, Corbett was not an active champion. He waited a year and a half before having his first defense, a third-round stoppage of Charlie Mitchell. After that, another two and a half years elapsed before he fought Tom Sharkey to a four-round draw.

Corbett found he could make more money cashing in on his fame as champion by taking to the theatrical stage, his first love. He also participated in exhibition matches.

Meanwhile, Bob Fitzsimmons, the former World Middleweight Champion now campaigning as a heavyweight, was compiling an impressive record while fighting on an almost weekly basis. From 1892 through 1896, "Ruby Robert" had 36 fights, winning 34 with one draw with his only loss being by disqualification to Tom Sharkey. Twentynine of those victories were by knock out, with twenty-eight occurring before the end of the 5th round. The lanky Fitzsimmons, a former blacksmith, was certainly among the hardest hitting fighters of all time.

By this time, Bob Fitzsimmons was eager for a shot at the champion. Corbett was enjoying the life of a thespian and his life was more that of a former titleholder. After much negotiating, Gentleman Jim agreed to defend his title against Bob in a fight scheduled for St. Patrick's Day 1897. The match was to take place outdoors in Carson City. NV. The state of Nevada had passed a special law allowing for the fight to take place, as boxing was illegal in the state at that time. I have not been able to find out how many rounds the fight was scheduled for. I think it may be a safe assumption that it was going to be a battle to the finish.

Corbett, despite his inactivity, came into the ring looking fit at 184 pounds. Fitzsimmons was wiry at 167 pounds. Jim certainly looked bigger and stronger.

In the early rounds, the champion showed the fleetness of foot he was famous for. He was very effective with the left jab and straight right hands as he busted up the face of the challenger. In the sixth round, Fitzsimmons was dropped for a nine count. There has been some controversy over this as Fitzsimmons went down to a knee and held onto Corbett's leg. While Corbett was trying to

step back and free himself from Fitzsimmons' grip, the referee did not begin the count. Bob, cut and looking like a beaten man, survived the round.

As the fight moved on, Corbett began to slow down. The years of inactivity, combined with Ruby Robert's relentless pressure, were now taking their toll. The champion continued using his superb boxing skills, but Fitzsimmons was starting to get closer and was effective with body punches.

In the thirteenth round, Corbett was continuing to jab. Fitzsimmons, now bleeding quite profusely, was timing Corbett's jab, which had slowed down just enough for Fitzsimmons to become more effective in countering it. Midway through the round, the challenger slipped inside the champion's left and landed a solid left to the midsection. Corbett went down as if he had been stabbed. His body appeared paralyzed while his head seemed clear. He struggled to regain his feet, attempting to crawl near the ropes in order to pull himself up. His efforts were in vain, as he was counted out and Bob Fitzsimmons was declared the new champion.

In the days that followed, the punch that ended the fight was training camp where he would not only practice his art in the ring, but also discuss it with his trainers and sparring partners. Old school boxers became well versed in anatomy, and it is possible that he knew the term solar plexus before the bout.

I believe this was the only time in heavyweight championship history that the title has changed hands as the result of a single blow to the body. Body punches have played a major role in the defeat of champions, but I cannot recall another time when one punch to the stomach put a champion down for the

History was made that spring day in Carson City, NV. Bob Fitzsimmons would eventually lose the title to James J. Jeffries, but then go on to win the light heavyweight championship. His career record would stand at an amazing 63 wins against just 8 losses and 4 draws. An astounding 59 of his 63 wins came via knockout. Ruby Robert's name rarely comes up today in discussions about great fighters of the past, but he certainly deserves recognition as one of the greats. He certainly ranks near the top in punching power, and his photo should be next to the term solar plexus in the anatomy books.

HOOPS and HOCKEY in the HUB

It was great. It was memorable. It was fantastic. And yes, probably most especially, in one of America's most historic cities, there it was before your the making of history in the Hub.

We refer, of course, to the extraordinary game played between Boston University and Boston College for the 2016 Beanpot Championship at the Garden. It was so good you wanted more — and they gave you more. Yes, it took overtime to decide the title as BC won the championship 1-0 with just under two minutes having been played in overtime.

And when it was over, all over, BU goaltender Sean Maguire lay on the ice in defeat while BC sophomore forward Alex Tuch experienced a moment of athletic glory by having scored the game-winning tally and then embracing his teammates in joy. At that moment, one felt both happiness and sadness. Happiness because there was a victor, sadness because that joy could not be shared. There could only be one winner but you knew there shouldn't be a loser. It was that grand a game.

For those who feel that the Beanpot has dropped a bit in prestige and popularity, this was a major indicator that nothing could be further from the truth. The skill, spirit and emotions displayed in the contest were worthy of a national championship game.

In fact, given that BU played Providence College in the National Championship game at the Garden back in April, we'd say that the Beanpot contest was the better one by far, even for BU which lost both games.

It was probably the best college hockey game at the Garden since Maine beat UMass-Amherst in the 2004 Hockey East Championship game in triple overtime.

In the 256th game in Beanpot history and the 64th year of the storied tournament, it was the first time that a game had ended with a 1-0 score. In addition, it was the first time in Beanpot history that a game was scoreless at the end of regulation. It was the 20th shutout all-time

in Beanpot history. It was also the 22nd time that the two archrivals faced each other in the championship game. If you can't remember the other 21, that's OK. The one that was played on February 8th will go done in history as the most memorable of all of them.

The one-goal margin of victory also was the latest chapter in an interesting facet of Beanpot history. Ten of the last 11 Beanpot games between BU and BC have been decided by a single goal. Six of those contests went into overtime.

It was the 20th time that Boston College has won the tournament and its 55th time in the championship game. The Eagles have now won six of the last seven Beanpot crowns.

It was the ninth Beanpot crown for veteran BC coach Jerry York, who has now eclipsed the eight amassed by legendary BC mentor John "Snooks" Kelley.

The victory enabled BC to extend its unbeaten streak to 7-0-3. The Eagles entered the contest tied with St. Cloud State for the longest active unbeaten streak in the country.

The game was a matchup of top 10 teams. BC was ranked third in America while BU was seventh.

It was the second time in five years that BC beat BU in overtime to win the title. Back in 2012, the last time the two teams met in the Beanpot Championship game, BC prevailed 4-3 in the extra session.

While BC outshot BU 23-12 in the first period — a session interrupted by a 29-minute power outage, both teams were held to single digits in shots in both the second and third periods. BU was held to a single shot on net in the abbreviated overtime.

Alex Tuch, who scored the game-winning goal for Boston College, actually grew up in an area dominated by basketball. He's from Baldwinsville, N.Y., a community about 15 miles from Syracuse, a city well known for coverage of the Syracuse University basketball program.

The game may not have been the last meeting of the two teams this season. They could meet in the Hockey East Tournament while other possibilities include the NCAA regionals or the Frozen Four itself.

BU goalie Sean Maguire made 41 saves in the championship game and was presented with the Eberly Award for having the best saves percentage (.970) over the two games of the event. He was also named the tournament's Most Valuable Player.

His counterpart, Thatcher Demko of Boston College, made 30 saves to record his ninth shutout of the season, a school record at The Heights.

Given the fact that the Bruins were whacked by the Los Angeles Kings by a 9-2 count at the Garden on the very next night, one just might be able to make the case that the best two Boston-based goalies on the singular evening of Tuesday, February 9th were not employed by the Boston Bruins but instead were still performing for their respective colleges—Thatcher Demko for Boston College and Sean Maguire for BC. Maguire was drafted by Pittsburgh in 2012 while Demko was drafted by Vancouver in 2014.

Finally, remembering veteran Boston College sports information staffer Dick Kelley on the second anniversary of his passing (February 13, 2014) from complications of ALS. As always, he was there in spirit.
