# \$6.4 Million for North End Knights of Columbus HQ

MassDevelopment Issues Tax-Exempt Bond to Repurpose Knights of Columbus Building for Senior Affordable Housing

MassDevelopment has issued a \$6.4 million tax-exempt bond on behalf of 41 N. Margin Senior Apartments, LLC, an affiliate of East Boston Community Development Corporation (EBCDC) and Affirmative Investments, Inc., which is using bond proceeds to receive a 99-year lease from Ausonia Home Association for a portion of its property at 41 N. Margin Street in Boston's North End. EBCDC and Affirmative Investments are also using bond proceeds to convert the property, which has been vacant for two years and was previously the headquarters for the Ausonia Council 1513, Knights of Columbus, into the Knights of Columbus Apartments that will feature 23 one-bedroom units of affordable senior housing

to be rented to households earning no more than 60% of the area median income. The project includes renovating the building, adding two floors where the housing units will be located, and constructing a 1,600-square-foot addition that will serve as the new quarters for Ausonia Council 1513, Knights of Columbus. Eastern Bank purchased the bond.

"MassDevelopment is proud to help bring affordable senior housing to one of the most historic neighborhoods in Boston, through East Boston CDC and Affirmative Investments, Inc.," said MassDevelopment President and CEO Dan Rivera. "The Knights of Columbus headquarters played such an important role in the life of the neighborhood so we are

# Principal Says Education Based on Racism

Sherwood High School Principal Melissa Baran was slammed as a "BLM Marxist" for saying education has its roots in "white supremacy." Baran addressing the Sherwood School District on the outskirts of Portland, Oregon said, "Historically, our under-represented students, our most vulnerable students that are experiencing a variety of difficult circumstances ... the system hasn't been working for them."

Baran, added that, "Education as a whole was built on the system of oppression and white supremacy, and we are trying to talk about that more."

### How Many Masks are Too Many?

The CDC is now recommending that everyone wear two face coverings after a new study found that doubling up can improve mask performance against COVID-19 by about 50 percent.

Wearing a cloth covering over a disposable mask significantly helps reduce exposure to the deadly virus, the CDC study found. Users should make sure no air is escaping from the area under their eyes or from the sides of the mask, the agency said.

#### NBA Tells Cuban to Play The National Anthem

The NBA has told Dallas Mavericks owner Mark Cuban to restart the playing of the National Anthem before the team's home games after Cuban apparently stopped doing so because of his concerns about unifying the nation in these turbulent times.

The NBA says the National Anthem will be played before the start of each game. Prior to Cuban's reversal after told to do so by the NBA, Anthony White, the Vice President of the Fort Worth Police Officers Association

# Stirpe Nostra

#### **VIRGINES VESTALES**

(The Best Little Virgins in Old Rome)

Nothing in Rome is said to be more ancient than the institution of a maiden priesthood. As was mentioned in a previous issue, the worship of Vesta goes back to the time when it was difficult but necessary to obtain fire. The sacred fire, the source of all Roman life and power, was kept alive in an edifice known as the Temple of Vesta. It was constantly tended by a group of virgin priestesses that were known as the Vestals.

At Rome, their number started at four, but was increased to six about the time of the early Republic. During primitive times, the possession of fire was the greatest gain that man had yet made, and to lose it was the greatest misfortune for the community. The chief, or the so-called king, fulfilled a most important duty towards his people by keeping a fire always burning, from which they could at any moment kindle their own. Nothing could be more natural than for the chief's unmarried daughters to be placed in charge of this precious hearth, under the protection of Vesta, the goddess of fire.

The number of Vestals corresponds to the idea that they were originally the daughters of one family, and that they were

the king's daughters is traceable to their position of honor in the Roman State. They have been compared to the nuns of the Roman Catholic Church, and the Atrium Vestae has been called their convent. There was a close resemblance in their vow of chastity and the cutting of their hair.

They were dressed entirely in white, with a coronet shaped headband (infula), ornamented with ribbons (vittae) suspended from it, and also a white veil or hood (suffibulum) made from a piece of white woolen cloth with a purple border.

It is here that the resemblance ended, for instead of poverty and obedience, the Vestals enjoyed great independence and luxury. They were exempt from the common law, and not even subject to the censor's authority. They enjoyed a most conspicuous freedom, having the right to "hold property and to make a will. These rights alone exceeded those of the average females of the times. The Vestals also enjoyed great political importance, often interposing to save a life, to restore harmony at critical moments, or even to carry out the provisions of important wills. Death was the penalty for injuring them, and any-

one whom they escorted was also protected from assault. Meeting them by chance in the street also saved a criminal who was being led away to punishment.

## Democrats Intent on Using Pandemic to Permanently Change Elections

Massachusetts Republican Party Chairman Jim Lyons on Wednesday, February 10th blasted legislation filed by Democrats that seeks to make universal mail-in voting a permanent fixture in Massachusetts, a system he pointed out that "half the country doesn't trust."

"The Democrats are trying to use the COVID-19 pandemic as an excuse to permanently change how we vote," Lyons said, referencing the so-called VOTES (Act fostering voting opportunities, trust, equity, and security) Act, a proposal that calls for same-day voter registration, two weeks' worth of early voting, and no-fault vote-by-mail.

Proposals outline in the legislation are backed by Secretary of the Commonwealth William Galvin, among other Democrats.

"Just this past year, we saw thousands of ballots mailed to residents who had long since changed addresses, and meanwhile Secretary Galvin has so far refused to even acknowledge a request made by Republicans to hold a review of the last election's strengths and weaknesses, and instead he and the rest of the Democrats want to make mail-in voting permanent," Lyons added.

Lyons pointed to concerns voiced by several town clerks regarding the lack of signature verification systems and references photos that surfaced ahead of the 2020 election of reams of ballots sitting unattended outside several Massachusetts town halls.

"Voters deserve a free, fair, and secure election process," Lyons said. "When half the country doesn't trust that process, Democrats should find out why before trying to make it permanent."

He also singled out language in the VOTES Act stipulating ballot signature comparison inspections "except if a family member signed the application ... or if the voter received assistance in signing the application or the envelope."

"That line about 'voter assistance' is classic Democrat Partyspeak for ballot harvesting," Lyons said, referencing the controversial practice of allowing third parties to collect and deliver ballots. "Voters need to feel assured that their vote counts, and proposals like these only serve to sow more doubt and division."

The proposal for permanent mail-in voting may not even be constitutional. Shira Schoenberg, a reporter for CommonWealth magazine notes, "The Massachusetts Constitution explicitly says the Legislature can authorize absentee voting for just three reasons: if someone is out of town, physically disabled, or cannot vote on Election Day due to a religious belief."

## Opposition to 25 Atlantic Avenue Development Proposal



Dear Editor,

We want to explain why we adamantly oppose the current plans to develop the property for luxury condominiums. The following are some of the reasons why at a recent meeting of the North End Waterfront Residents'

Association (NEWRA) members voted 41 to 0 to OPPOSE this project (with 1 abstaining). We shall try to make this letter brief out of respect for your time.

- 1. The developer owns a neighboring building where he operates a construction company. He has proposed to develop a 5-story luxury residential building with an elevator exiting onto a roof deck recreational area that stands 8'2" above the roof.
- 2. Before the developer purchased the property, neighbors from 63 Atlantic Avenue met with him to see if we might try to develop the property in a manner that would benefit the neighborhood. A two-story parking garage that would be attractively landscaped and serve the adjoining residents was proposed. The developer did not like the potential economic return for the project.
- 3. At a later meeting with the developer, we were told that he had purchased the 25 Atlantic Avenue property without contingencies for permitting. He showed us plans for a 4-story building. We gave him comments on how his building might be improved, and we were grateful that he did not seem intent on maximizing every square foot of FAR. We said we would work with him.
- 4. However, at our next meeting with the developer he showed the Trustees of The Prince Building new plans. He had added another story, so now it was a 5-story building, using up every square foot of FAR possible. He smiled and said "My bank made me do it." We asked if he had consulted residents of the neighboring Howe & Bainbridge building, as they would surely be most affected by the loss of light, air and views. He had not.
- 5. The developer is now pushing forward with a building that would stand out as a mediocre monolith of granite and limestone that would cut off views of the classic brick buildings in the North End for the considerable pedestrian traffic walking on Atlantic Avenue. It will also obliterate the views of Boston Harbor enjoyed by residents of Howe & Bainbridge on Commercial Street. Its façade would be a cold, dull, uninviting wall that would sap vitality, light and views from neighbors and visitors.
- 6. The developer has been denied a building permit for his proposed building because he needs the approval of the Board of Appeal under Section 54-18 of the Boston Zoning Code. This provision prevents a developer who has torn down a building in existence on June 24, 1985 from constructing a new building with height in excess of that which existed on the site on that date. This provision of the Zoning Code was intended to avoid the sins that happened in the West End when developers destroyed a neighborhood by tearing down historic structures and replacing them with higher (and more profitable) buildings in the name of "neighborhood improvements." The building previously on the property was designed by a nationally recognized architect and was sensitive to the light, air and views of its neighbors. The buildings were approximately 16 feet high.
- 7. The developer tore down the old buildings, then paved over the property and used it as a parking lot. The city shut it down because he did not have a permit for parking.
- 8. Currently there are 6-7 parking spots on Commercial Street adjacent to the lot. The proposal shows that there will

## L'Anno Bello: A Year in Italian Folklore

Hope and Renewal on Our Lenten Journey

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



Deep inside, we know that spring is coming. Not even layers of snow can disguise the rosy light of a late evening sky or the increasing chatter of birds singing from the bare bushes. However, for many of us, the winter season still reigns supreme. The thermometer dips to the low twenties, causing nights when the air stands so chill that I want nothing more than to rush home and gulp down a mug of hot chocolate. Winter's thick blankets of snow will likely remain on the ground for a long time — but even when there is no snow, the ground below us still reveals unsightly patches of dirt and dry grass left over from summer. Seasonal produce also varies unpredictably, as the oranges and lemons of winter peter out before the tender herbs and peas of spring can line the supermarket shelves. Rather than a herald of gloom, however, this liminal period simply represents nature's renewal and regeneration for the rapidly approaching spring. Once we understand that nature proceeds to awaken from her slumber underneath all this snow, seasonal periods like Lent will make even more sense. The vernal equinox and the joyous celebration of Easter loom closer every day, and just like the natural world around us, we too must purify our beings and examine our consciousness before embarking on a springtime adventure. With its restorative qualities and voyage of discovery, the Lenten season safely carries us over into spring.

This year, Lent began on February 17<sup>th</sup>, Ash Wednesday. It covers a 40-day period prior to Easter, the most important feast in the Christian calendar. These days serve to prepare the faithful for Easter through

purification rituals such as prayer, fasting, charity and selfreflection. The timing of Lent is highly symbolic, as it occurs during a seemingly barren season in which nature also purifies herself after a long winter, emerging ready for the rebirth of spring. In order to appreciate the glory of Easter and spring, however, we need to embrace the seasonal transition with contemplation and introspection, an opportunity which Lent generously affords us. When my father was a child in Italy, Lent. or la Querisma, functioned as a somber and austere period, matching the chill sterility of nature. Though the rules have relaxed since then, the rite of purification remains the crux of Lenten customs in Italy and beyond. This explains the popular practice of giving up a bad habit or an indulgence for Lent, a tradition which is not mentioned in the Bible but nevertheless fits seamlessly with the folkloric cleansing rituals of the season. The purpose of this Lenten abstinence should not be deprivation, but rather a chance to examine our values or priorities and improve ourselves. This Lent, for example, I gave up my browsing some of my favorite websites, in order that I may break my smartphone habit and spend more mindful time with my family. The promise of Lent, however, stands in the fact that all of our hard work will be rewarded with a beautiful springtime. After all, the English term for Lent shares the same root with the word lengthen, referring to the growth of daylight in the spring sky!

Lent means more than saying goodbye to your favorite treat, though. In Italy, this meditative time inspired the creation of unique folk traditions and customs that would come define

the tapestry of pre-Easter celebrations. The most famous Lenten rule involves the forbidding of meat on Fridays; as such, ingenious Italian cooks devised many fish and vegetable dishes for these days. A visitor to Italy during Lent will notice farmers' markets bursting with fresh fish and baccalá (dried cod), along with the first spring vegetables, from which can be crafted a nourishing minestrone. Italians also snack on quaresimali, or almond biscuits, which, as the name suggests, are made especially for Lent. According to the author Helen Barolini in her book Festa, a simple and customary Italian Lenten dessert is pizza frita, fried dough sprinkled with sugar. My mother and grandmother would frequently whip up this dessert when I was younger, much to my pleasure, though I only recently learned of its Lenten connotations. The people in Italy also celebrate the fourth Sunday of Lent as Mezza Quaresima, or mid-Lent. These festivities mark the halfway point of Lent and honor the imminent arrival of Easter, and many Italian towns and cities hold parties and processions reminiscent of Carnival. Of course, due to the self-reflection and sacrifice that accompanies Lent, it is important to remember that giving is just as powerful as abstaining. People in Italy and around the world commemorate Lent with charity and community service, and truly there is no better way to spread the light of spring than by helping others.

When the glitter of Carnival and the crumbs of St. Valentine's Day candies are swept away, the erratic and unfruitful period between winter and spring can seem even more barren and cold. However, the journey of Lent reminds us that the promise of Easter and spring, is never far away. Just as sprouts begin to stir beneath the frost and robins fly back from their winter homes, just as buds nuzzle out of tree branches and melting snow drips down the street drains, we too can enter a meditative period of self-examination and inner cleansing. We can ready ourselves for the joy that is spring. Lent permits us to challenge ourselves, perform charitable acts, and observe new and exciting traditions of the world. With Lent, we honor change and rebirth, darkness and light, and emerge as better people into the spring sunshine.

Philip's Salon celebrated its 60th anniversary and I started chatting with Maria Russo and discovered she has been chatting up customers while styling their hair since 1968, first at 34 Charter Street and for the past 14 years at 437 Hanover Street. Alongside her for many, many vears has been Doreen Merola, her ace co-worker. These two women have built a great clientele list. Many of their "regular" customers have been customers for decades. Maria said her business has become a generational one, too. She's been styling hair so long. 

# Massachusetts Registry of Motor Vehicles **Encouraging Customers to**

# **Renew Expired Inspection Stickers**

Over 584,000 Active MA Vehicle Registrations Currently In Need of Annual Emissions and Safety Inspections

Law enforcement currently encouraged to use their discretion and help remind and not cite expired drivers whenever possible

The Massachusetts Registry of Motor Vehicles (RMV) is ramping up customer communication efforts to encourage anyone driving one of over 584,000 registered vehicles with an expired Massachusetts' inspection sticker on their vehicle's front windshield to make a plan to get their annual inspection and update their sticker as soon as possible. All vehicles registered in Massachusetts must pass a yearly vehicle emissions and safety inspection, also known as the Massachusetts Vehicle Check Program, which is essential to the safety of the Commonwealth's environment and roadways.

At the outset of the COVID-19 pandemic, some extensions were granted to annual inspection stickers expiring between March and May of 2020, however those extensions have since expired and no further extensions are planned. There are 1,800 local inspection stations, many of whom are small businesses, across Massachusetts that are open for business and conducting inspections in accordance with state public health guidelines and safety protocols. Customers are encouraged to visit the Inspection Station Locator to find a location near them and plan their trip to update their sticker.

"Annual motor vehicle inspections are an integral part of helping ensure that vehicles travelling on roadways across the Commonwealth are deemed safe and not releasing dangerous emissions that can be harmful to individuals and the environment," said Acting Secretary of Transportation and CEO Jamey Tesler. "We are thankful for all of the work and collaborative efforts that are currently underway with the Massachusetts Department of Environmental Protection, Massachusetts State Police, local law enforcement, and key businesses partners and stakeholders to remind customers with expired inspection stickers to have their vehicles inspected as soon as possible."

"The RMV encourages any customer with an expired inspection sticker to make a plan to get their inspection and sticker updated," said Acting Registrar of Motor Vehicles Colleen Ogilvie. "Resources are readily available to help customers locate a convenient inspection station and guide them through the inspection process, following all safety and social distancing protocols to keep customers and inspection station staff safe."

The RMV is teaming up with the Massachusetts Department of Environmental Protection (MassDEP), Massachusetts State Police (MSP), local law enforcement, and other

business partners to remind customers of this time-sensitive requirement. While driving any motor vehicle without a valid inspection sticker is a traffic violation that may result in a fine and impact individual insurance rates, the RMV is asking law enforcement to use their discretion at this time and help remind and not cite those with expired stickers it's time to renew.

"The emissions and safety inspection ensures motor vehicles operating in Massachusetts are safe, properly maintained, and not emitting excess air pollutants in our communities, which will improve air quality for us all," said MassDEP Commissioner Martin Suuberg. "MassDEP, along with our program partners, encourages Massachusetts residents to renew their stickers to ensure that their vehicle emission systems are inspected yearly."

"The Massachusetts State Police and local law enforcement are aware of the difficulties of prompt vehicle inspection renewal caused by the pandemic and agree that a reminder may be an effective temporary alternative to a citation during this current period," said Massachusetts State Police (MSP) Colonel Chris Mason.

"We encourage individuals to proactively check the current status of their motor vehicle inspection stickers, and not wait to schedule a safety inspection, if warranted," said Chelsea Chief of Police and President of the Massachusetts Major City Chiefs of Police Association Brian Kyes.

# Blessed Alexandrina Maria da Costa

Alexandrina was born on March 30, 1904, in Balazar, a rural parish of Póvoa de Varzim, Portugal. Her father abandoned the family when she was very young leaving the family impoverished. Alexandrina never had more than eighteen months schooling before being sent to work on a farm at the age of nine. In her teens she started to work in Balazar as a seamstress along with her sister.

In March 1918, when she was fourteen an incident changed her life. Her former employer along with two other men tried to break into her room. To escape them, Alexandrina jumped 13 feet down from a window, barely surviving. Her spine was broken from the fall. Until age 19, Alexandrina was still able to "drag herself" to church where, she would remain in prayer, to the great amazement of the parishioners. During the early years,



Alexandrina asked the Blessed Mother for the grace of a cure.

At the age of twenty-one, she became totally paralyzed and permanently bedridden. Alexandrina accepted this affliction as God's will for her and an opportunity to offer herself totally as a "victim soul" for the conversion of sinners. For a period of three and a half years, she received the mystical gift of

experiencing each Friday the pains of Christ on the Cross. She remained bed-ridden for about 30 years.

According to her Vatican biography, from March 1942, for about 13 years until her death, she received no food except for the Holy Eucharist, and her weight dropped to about 73 pounds. She was examined by medical doctors, with no conclusion.

Alexandrina requested for her tombstone these words: "Sinners, how much I want to tell you ... Do not risk losing Jesus for all eternity, for he is so good. Enough with sin. Love Jesus, love Him!" 
CHAPTER 41

# Nanna & Babbononno

A Nostalgic Remembrance



Babbononno didn't know his birth date. He knew he was born in February of 1875, on a cold winter's day back in Foggia, an east coast city in the province of Puglia. As a result, Nanna and the family gave him February 22<sup>nd</sup>, George Washington's birthday, as his birthday. He didn't mind as he loved American history and was a fan of George Washington. He often said, if he was born in this country back in Washington's time, he would have ridden with him to fight the British for American independence. So, we celebrated February 22<sup>nd</sup> as Babbononno's Day.

It was the winter of 1955, and my mother and her brothers all met to plan an 80th birthday party for their father. Nanna wasn't part of the meeting because they wanted the main present to surprise her, also, a new big screen television set. Dad and my uncles knew someone who owned an appliance store on Washington Street in Boston who would sell them a state-of-the-art TV for a wholesale price. The store owner was a weekend musician whom the men in my family knew well, seeing they were all musicians.

Around the second week in February, Dad and Uncle Nick made the purchase and put the carton containing the TV in the trunk of Dad's '54 Chevy, tied the trunk lid down tight to hold the oversized container in place, as it was really too big to fit in the trunk with the lid closed, and then headed to our house in East Boston to store the gift until Babbononno's birthday.

Dad wanted to store the crate at Uncle Nick's 1st floor apartment on St. Paul Street in Brookline, but the apartment was so small and the box so big, it wasn't a practical idea. The only problem was that we lived on the 3<sup>rd</sup> floor of 74 Eutaw Street. There were two sets of steps to get the TV through the entry of the house and two winding flights of steps to get the carton up to our apartment on the 3<sup>rd</sup> floor, a location we affectionately called the penthouse.

I was in high school at the time and arrived home just as Dad and Uncle Nick pulled up in front of our house. For the next half hour, with Mom supervising from the 3<sup>rd</sup> floor, my father, Uncle Nick, and I maneuvered the crate up the steps to the 3<sup>rd</sup> floor.

Dad was swearing under his breath in Italian and Spanish. When Uncle Nick asked him what was wrong, Dad reminded him that they were going to have to maneuver the box down the steps, deliver it to Nanna and Babbononno's apartment, which was on the second floor of a three-decker on Lexington Street, near the corner of Putnam and Lexington. We left the crate at the top of the stairwell at our place so no one would trip over it or bump into it.

February  $22^{\rm nd}$  was on a Tuesday and all the men in the family planned to come home early for a dinner party at my grandparents' apartment on that date. They all made sure that they weren't playing with their bands on that night. Well, the  $22^{\rm nd}$  rolled around and Uncle Nick, Dad and I, somehow, got the large carton carefully down the flights of steps to the street and relocated it, once again, in the trunk of Dad's '54 Chevy.

Mom was already at her parents' apartment with both she and Nanna cooking Babbononno's favorite foods. By about 5:30 the rest of my uncles showed up with their families and it sort of felt like a Sunday afternoon. Babbononno never knew what the commotion was all about when my father and three uncles headed downstairs. This time, Dad and Uncle Gino walked the large carton up the narrow flight of stairs to the second floor. They left it out of sight when they reached the landing and told Babbononno that they had forgotten to lock their cars ... that's why they all had to head down to the street. My grandfather bought it, and concentrated on who wanted what to drink before dinner.

Mom and Nanna actually cooked two separate meals, one for the family and one for Babbononno who liked pasta with oil, garlic and black pepper, and baked fish with lemon. We had ravioli, meatballs, sweet sausages, gravy meats, stuffed artichokes, stuffed mushrooms, green beans, and garden salad. It looked like a combination of Friday night and Sunday afternoon dinners, but, what the heck.

After dinner, Uncle Paul, who was the designated birthday cake presenter, brought a large rum cake to the table with eight candles lit, each one representing ten years. Babbononno was told to make a wish and blow out the candles, which he did as quickly as he could as he had a sweet tooth and could hardly wait for the first bite.

After dinner, Babbononno opened his presents ... a new white dress shirt and tie from my cousins Paula and Ellie, underwear from Mom and my aunts, and a bottle of Italian

brandy (Mouquin) from me. Then, Uncle Nick told his father that the big surprise was out in the hallway, and Babbononno had to take his radio off the table in the living room.

When the crate was placed next to that table, my grand-father was told to open it carefully. He followed the instructions he was given, and when he saw the big screen TV, his eyes filled with tears. He had no idea that the family knew what he wanted.

Dad knew more about electronics than my uncles did and his job was to plug in the TV, attach the antenna, a set of rabbit ears, (remember those???) and make all of the adjustments for a clear picture. Within a few minutes the black and white TV came to life and Babbononno was thrilled.

Uncle Nick knew that my grandfather would never understand the instruction booklet that came with the set, so he and Dad spent the next half hour showing Babbononno and Nanna how to operate the knobs that controlled the off and on, the changing of the channels, the horizontal hold, the vertical hold, the brightness, the contrast, and the sound volume. Eventually they got it, but I know it took several tries and many future phone calls to one or more of my uncles for help. That set lasted many years and made old age just a little easier for Nanna and Babbononno. With the rabbit ears, they could watch channels 2, 4, 5, 7, 38, and 56. That TV was "state-ofthe-art" with a large seventeen inch black and white screen that took four minutes to boot up once the set was turned on. So, to you, Babbononno, "Happy Birthday" ... "Felice Compleano" and may: GOD **BLESS AMERICA**

The season of *Quaresima* (Lent) that begins on Ash Wednesday and ends on Easter Sunday, has significant meaning in Italy. For Italian Catholics, these forty days are a time of abstinence, prayer, and almsgiving. Attending mass, giving up something or doing good deeds, and refraining from meats, sweets, and chocolate, was once customary. The rules of the church have become less stringent, and culinary practices have changed. Today, refraining from meat is only required on Ash Wednesday and every Friday up until Easter. As a result, Meatless Fridays have become one of the most well-known Lenten traditions in Italy, as well as here in the states.

Nevertheless, many of the older Italian Catholics, including those in my own family, continue to abide by the conventional practices. Some even refrain from eating meat on Fridays year-round. Growing up, my Nonna made a variety of "Meatless Friday" dishes. One in particular that she favored, "Linguine with Cabbage and Beans," came from the farmers in Sicily. This easy to make *cucina povera* dish consists of savoy cabbage, butter beans, garlic, and spices. When topped with freshly grated cheese, this dish is hearty, nutritious, and makes an absolutely delicious Meatless Friday meal!

### LINGUINE with CABBAGE and BEANS Linguine con Cavolo Cappuccio e Fagioli



1½ to 2 heads savoy cabbage, cleaned and chopped 6 cloves garlic, finely chopped ½ cup (more if needed) olive oil 2 to 3 cups water

1 to 2 teaspoons hot pepper flakes

2 cups cooked butter beans 4 to 6 quarts salted water

1 pound fresh or dry linguini Freshly grated parmesan

Place olive oil and garlic in a large skillet and cook over medium heat until the garlic is softened, not brown. Add the cabbage and about 2 cups water to this pan, stir together well. Cover and cook over medium heat for about 10 minutes. Add the rest of the water only if needed, salt and hot pepper flakes to taste, and cook an additional 15 minutes, or until cabbage is tender. Add the cooked butter beans, stir, cover and remove from heat.

Simultaneously, in a large stockpot, bring 4 to 6 quarts of salted water to a rolling boil. Add linguine to the pot and cook until al dente. Using a slotted spoon, remove linguine from water and add to the cooked cabbage and bean mixture, toss together. Add some pasta water and additional salt and hot pepper, if needed. Place in serving bowls and top with a generous sprinkling of freshly grated parmesan cheese. *Enjoy!*



be one sidewalk cut out to allow access to their two-car garage door, so the neighborhood will lose one or two parking spots. However, the developer is adamant that they will be adding two parking spots! Please review the attached photo.

9. The developer's original plans for development were turned down by ISD because they did not show a loading zone, as well as other violations. An off-street loading zone is required under the Code for a building of this size. The more current plans show a proposed 10' x 20' loading zone dropped into the driveway easement that services 38 automobiles entering and exiting the garage at 63 Atlantic Avenue. The developer did not disclose to ISD that the proposed loading zone is squarely within a driveway easement that explicitly states "[s]aid easement area is not to be used for the parking of vehicles, and is to be kept free and unobstructed at all times." Had the developer revealed this restriction to ISD, they certainly would also have cited the lack of a legitimate loading zone as another reason for denying a building permit.

10. During three separate public meetings with neighbors, the developer did not reveal light, air and view studies that would show the effects of his proposed building on his neighbors, each time saying the studies were "not quite finished." At the fourth meeting, he revealed his "preliminary shadow studies", but has presented nothing to

show how the project will affect his neighbors' views, which is a key consideration under Boston Building Code Section 54-18.

11. The project proposes 6 luxury condominium units that will be selling for well over \$1.5 million each. There has been no offer by the developer of any critically needed support for low income housing for the neighborhood. There is no benefit to the neighborhood from this project, other than tax revenue for the City and profit for the developer, while sacrificing property values and quality of life for neighbors.

12. The footprint of the proposed building takes up almost every square foot of the developer's land. The land is within 250 feet of Boston Harbor, and Chapter 91 requires that 50% of the development project be open space. The developer has proposed that he be allowed to use the existing City sidewalks that surround his property to satisfy DEP's 50% open space requirement, in exchange for an obligation to improve and maintain the sidewalk for the City in perpetuity. If DEP were to allow such use, it would require the City to join in the developer's petition and would set an awful precedent for waterfront property throughout the City and the Commonwealth. It would clearly violate the spirit and intent of Chapter 91.




#### Ozuna Back with Braves Four-Year Deal

## Johnny Bratton vs. Kid Gavilan II

No Rope a Dope in this Fight

Recently, I received an email from my friend boxing historian Mike Silver, the author of The Arc Of Boxing. Mike included a link to a YouTube video of

the second Kid Gavilan vs Johnny Bratton fight. Mike described the bout as one of the best he has seen and commented that "This is BOXING." After that ringing endorsement I had to take a look for myself. Mike certainly was right. The fight was indeed entertaining as well as a textbook example of how much boxing has devolved over the years.

Kid Gavilan and Johnny Bratton fought three times during the period from 1951 to 1953. In their first fight Gavilan won the NBA World Welterweight Championship from Bratton. In their third

fight the Kid defended the title against Johnny. Their second fight was a ten round non-title affair.

Rare today, non-title fights were not unusual years ago. They would take place when the fighters would come in over the weight limit of the division the title holder was in. This was prearranged and the fans knew they were not going to see the champion risk his belt. It was a way for a title holder to stay busy without the hoopla of the

match being for the title. It was also an opportunity for someone not rated high enough to get a chance at fighting a champ and even in losing good enhance his reputation by showing he could stay in there with the best.

The second Gavilan/ Bratton fight was a bit unusual as the two had fought for the title just six months earlier. In that fight, held on May 18, 1951, Bratton fought with a broken jaw from the fifth round on but lasted

the full distance while losing a decision. Just six months later on November 11, 1951 the two would meet again, this time in a non-title fight. And what a fight it was.

You might think Bratton would have been a bit gun shy after having taken a licking in their first encounter, but at the opening bell he came out with guns blazing. Of course, Gavilan was their to meet fire with fire, and this led to a very "entertaining" fight. It also was a display of two ring wise boxing

veterans plying their craft.

For the first three rounds Johnny tried matching Gavilan's speedy combinations. This led to some great exchanges but The Kid was getting the best of them. In the 4<sup>th</sup> round Bratton changed tactics and started looking to counterpunch. He had more success with this strategy. Gavilan was a very rhythmic fighter and Johnny was trying to break that rhythm by making moves to throw the Champ off his game. Bratton even mimicked Gavilan's trademarked bolo bunch in an effort to rattle him. In the seventh round the two tried to outdo one another while digging into their bags of tricks. Gavilan used head feints and a shuffle



times and neither of these was a hug fest. They also only went

form, took place almost entirely away from the ropes.

In the eighth round Bratton was stepping back from Gavilan and went back to the ropes. He immediately responded by neutralizing the champ's left hook by placing his right hand on the inside of Gavilan's elbow while stepping away from the ropes. This was one of two times that the referee stepped in, and even that action by the third man

was not needed as the two were breaking on their own.

It is also a pleasure to watch how these two artists used their

left jabs. Today, most fighters hold their hands up against their faces in what makes them look like they are wearing ear muffs. It is impossible to throw a decent jab from that position, not that any of them seem interested in throwing jabs anyway. Both Johnny and the Kid used a classic stance where the left hand is held low and out in front of them while the right hand is kept open and held high in order to parry the opponent's punches. Having the left in this position allows for the punch to travel a shorter distance while also leaving the option of turning

it into a hook or an uppercut, and for the real masters, a hook off the jab. It is also a great defensive position as Bratton showed in the 8th round when he was able to disarm Gavilan by grabbing the inside of his elbow and walking him away from the ropes. The left can also be raised in a stiff arm fashion to deflect a punch. They both employed feints in an effort to get the other to lead, knowing that a fighter is most vulnerable

when he is throwing a punch. It's funny, but at one point the referee took a round away from Gavilan for holding and hitting. This was weird as other than with their fists the two hardly held at all. I think the ref was feeling unneeded and wanted to justify being paid.

At the end of the ten rounds the decision was announced as a draw. If not for the referee taking away the round from Gavilan, the champ would have won the fight.

The two would meet one more time in November of 1953, this time for the title. Gavilan won a one-sided decision over fifteen rounds. The press reported that Bratton was thoroughly beaten by the 12th round but he held on until the final bell.

I highly recommend viewing the second fight between these two excellent fighters. You can watch it a number of times, as with any great work of art you will notice new things each time you see it. And Mike was right; it is a very entertaining fight.

## HOOPS and HOCKEY in the HUB

He was the man who ended an era, brought celebration by way of a joyous conclusion and thereby closed the record books on two of the most referenced words in professional hockey.

For it was George Armstrong, Toronto's veteran right wing, who scored the final goal in the "Original Six" era back in the spring of

Armstrong, a former team captain of the Leafs who died at age 90 in late January, brought down the curtain on the era when he scored an empty net goal with 47 seconds left in game six of the Stanley Cup Final, providing the insurance tally in a 3-1 victory over Montreal and the ticket for Toronto's victory parade.

Montreal and the Maple Leafs had made it to the championship round that spring, the last time that only a half dozen teams would constitute the league. Come the fall of 1967 six additional franchises would take to the ice as the first teams in what we now call the

And the additions would keep on coming--right through this year. Starting in the fall of 2021, Seattle will join the league, increasing the number of teams in the National Hockey League to 32. It seems light years away from the Original Six era that existed from 1942 through 1967.

Boston, Detroit, Chicago, Toronto, the New York Rangers and the Montreal Canadiens came to be called that after three teams that had competed in the NHL during the 1930s dropped out--the New York Americans, the Montreal Maroons and the St. Louis Eagles (formerly the Ottawa Senators). That left the Original Six.

It was an era unlike any other. For a quarter of a century each NHL team had only five opponents, creating a scenario where rivalries deepened and fan followings of teams and individual players became fantastically fervent.

It was an era when all players competed without helmets and visors and all goalies guarded the crease without wearing masks. In short, it was an era that would be considered frightening today by some and probably at least highly questionable by even the most ardent followers of the game in contemporary times.

For the vast majority of the Original Six era, hockey ended around the time Major League Baseball season began—often by mid-April.

But as more games came to be added to the regular season schedule, the end date of the Stanley Cup playoffs gradually crept into late April and finally crossed over into the early days of May.

And thus, it was that game six of the 1967 Stanley Cup Final was played on May 2<sup>nd</sup>

The Canadiens and Maple Leafs had finished second and third in the 1966-1967 regular season standings behind the Black Hawks.

And just as an aside, where were the Bruins? At the bottom, way down there with a 17-43-10 regular season mark. The two telling stats for the B's that year: they scored the fewest goals of any team (182) while allowing the most tallies of any franchise (253).

Perhaps the most stunning result of that year's playoffs came in the opening round when Toronto upended Chicago by winning the series in six games. During the regular season the Black Hawks (who became the Blackhawks in 1986) had amassed a total of 94 points while the Maple Leafs had just 75.

The teams split the first two games in Chicago. But then the action shifted to Maple Leaf Gardens where Toronto came alive and won both games, evening the series at 2-2.

Back in Chicago, Toronto came away with a 4-3 victory in game five and then closed out the series in game six with a victory at home.

The surprising win propelled the Maple Leafs into the SCF. Both teams split the first two games in Montreal and did the same with the next two in Toronto, with the Maple Leafs winning game three in double overtime.

But Toronto really got hot late in the series, winning both game five and game six while allowing Montreal only one goal in each of those contests.

And so it was that when George Armstrong scored his empty net goal with less than a minute remaining in game six to provide the Leafs with their 3-1 victory it would be the final time the puck had crossed the crease in the Original Six era.

The championship really would prove to be the Stanley Cup Final for Toronto in more ways than one. The triumph would be the fourth Stanley Cup title for the Leafs during the 1960s—the franchise also having captured the Cup in 1962, 1963, and 1964. It was the perfect conclusion to mark the end of an era as well putting the capstone on an outstanding span of achievement—four Cup titles

But as the decades have rolled on the 1967 victory has, in reality, proved to be the Stanley Cup Final for Toronto since It would also be the last time that the franchise would take possession of the trophy. That's right. After George Armstrong and his teammates skated off the ice with Lord Stanley's Cup on that early spring night back in 1967, Toronto has never stood on hockey's summit since. The last time the Leafs got close was back in 2002 when they lost to the Carolina Hurricanes in the Eastern Conference Finals.

Fast forward to 2021 and the picture has brightened—at least during the early phases of the shortened 56-game schedule. As of February 16th, the Maple Leafs were leading the North Division (comprised entirely of teams based in Canada) with an 11-3-2 mark, good for 24 points, four more than second place Montreal.

There are plenty of games to go but one can't find fault with a successful start. It is more than enough to warm the hearts of those residing in the city that sits along the icy shores of Lake Ontario during these cold midwinter days.

And somewhere, George Armstrong, whose career in hockey as a player, coach, executive and ambassador to the game spanned 70 years, is smiling.
