"A NEW AMERICAN MOMENT"

President Donald Trump declared "a new American moment" in his State of the Union address, touting the recently passed tax reform legislation that he signed into law and the booming U.S. economy. But, more than that, he gave us his friendship and companionship.

Freeway arrived at the Post-Gazette one day as he was taking his daily walk with his human, Marie Simboli. Our good friend Coach Dom Campochiaro was sitting on the stoop as he usually did in the afternoon and introduced us to Freeway. This was the beginning of a long relationship, including Freeway becoming one of the Gazette's most popular columnists with "Freeway Says."

Freeway enjoyed long walks, fine dining, and the community he loved his entire life. He was the best dressed dog in the North End and he loved sitting in the middle of the sidewalk in front of the Post-Gazette office in the summertime, showing off his outfit of the day while all the tourists walked around him and took his photo.

Freeway has touched many people over the years, whether the Mayor of Boston (Tom Menino), someone recuperating in the North End Nursing Home, or a stranger on the street. Of course, no one was a stranger for long. Freeway made many, many friends in his lifetime.

In addition to his human friends, Freeway always looked out for his fellow furry friends,



not only by educating us humans with his pet care column, but also with his annual Pet Food Drive at Thanksgiving. He had a huge heart and appreciated what a great life he had. He wanted to make sure less fortunate pooches and kitties were taken care of.

The lives of his fellow Gazette workers will never be quite the same. When you came into the office, you didn't always know

that he was here. But you always felt warmer when you spotted him sleeping on his chair. Other times, he made his presence felt even before you came through the door, barking his commentary on his lunch, his need to "step outside," or just for help getting up or down from his chair in later years. He was famous for being able to smell chicken, no matter how carefully wrapped – he particularly like the chicken wings from the Chinese place on the corner -- and hearing his "mom," Marie, arrive after her shift at the Union Oyster House to pick him up. Frances remembers how he used to sit right in the middle of her desk, preventing her from doing any work. Joanne always liked to have him sit up front with her. Jeanne knew she had been accepted when he allowed her to give him a scratch under the chin. Joan was always in charge of "stepping outside" with him, no one else would ever do (except his "mom"). Pam's nurturing side was brought out most when trying to get him to eat anything besides chicken and meatballs.

He was the life of all our parties (and gave really nice gifts!) He will be sorely missed.

AURELIUS THE EMPEROR

After he was adopted into the imperial household, Marcus' respect for his relatives, friends, and finances remained unchanged. Hadrian died about six years later, leaving Antoninus Pius as heir to the throne. This is the time when Marcus worked very closely with the new emperor, doing a tremendous amount of work for him, but still found time for his studies. Marcus soon married Faustina, the daughter of Antoninus Pius, instead of Hadrian's granddaughter. In spite of Faustina's extravagance and recklessness, he highly praised her obedience, simplicity and affection.

Pius ruled for twenty-three years and, when he saw that his end was drawing near, called his chief magistrates and friends around him and formally named Marcus Aurelius as his successor in the empire. He ordered that the golden statue of Fortune, which he normally kept in his own chamber, be transferred to that of Marcus, uttered the famous "Aequanimitas" to the Tribune of the night watch, and then expired.

Marcus Aurelius was now forced by the Senate to assume the office of emperor. One of his first acts was to name an adopted brother as his colleague in the empire. He gave his colleague the name of Lucius Aurelius Verus Commodus, but also bestowed upon him the titles of Caesar and Augustus; however, history records him as just plain Lucius Verus. This was the first

time in history that two adopted brothers sat in joint rule of the Roman Empire.

Having taken care of all preliminary matters with the Senate, the two rulers set out for the Praetorian Camp, where they promised 20,000 sesterces apiece (about \$1,000) to the common soldiers and a proportionately larger amount to the officers. The joint rulers acted in such democratic fashion that even the lenient manner of Pius was not missed. Marcus pursued his philosophical interests while at the same time cultivating the goodwill of the people.

Mother Nature always has been able to find some way to disrupt any form of national tranquility; the time of Marcus and Verus was no exception. A flood of the Tiber River, probably the most severe of their time, ruined houses, drowned animals, and caused widespread famine. The joint emperors helped to alleviate the pain and suffering with their own personal financial aid. A volatile situation in Parthia now erupted into a full-scale war, hostilities threatened to break out in Britain, and forces of the Catti tribes invaded Germany. Agricola, an excellent general, was sent to Britain and General Victorinus repelled the Catti, but the Parthian war became the personal concern of brother Verus. Marcus kept watch over the administration of the empire while Verus was successful in the prosecution of the war. At the end of hostilities, each emperor was voted the name "Parthicus" and later "Father of His Country."

Saint Joseph Confasso

Joseph Confasso was born in Castelnuova d'Asti in the province of Piedmont, Italy, in 1811. A devout and docile child, he was born with a deformed spine, which contributed to his short stature and frail constitution.

At the age of fifteen, Joseph decided to become a priest. He studied at the seminary in Turin and was ordained in 1833. He continued his theological studies at the seminary, then at the Institute of St. Francis, and became a brilliant lecturer on moral theology. Ten years later he was appointed superior of the college and he remained so until his death. He made a profound impression on all his students, often helping those in poor circumstances to finish their studies by providing them with the necessary books and money.

He worked against the spirit of Jansenism with its strong focus on sin and damnation; he substituted the teachings of Saint Alphonsus Liguori and Saint Francis de Sales to moderate the rigorism of the education of students while striving to offer them simple



values and morals. He likewise fought against state intrusion in the affairs of the Church.

Fr. Confasso was known for his practice of mortifications in the aim of becoming as frugal as possible. He never smoked, nor did he drink anything other than water. He never indulged in coffee nor food between his meals. He never complained about pain or hard work. When once asked whether or not his constant work ever wore him out, he replied, "Our rest will be in Heaven." He celebrated Mass each day at 4:30 am and was known for spending long hours in the confessional and chapel.

Fr. Confasso was a popular preacher and confessor, seeming to have a special gift for discerning exactly what each

penitent needed. In addition, he had a special charism towards prisoners and spent a great deal of his time hearing their confessions and helping them in any way he could, staying with them the entire night before their executions, even accompanying them in the cart to the place of execution. He offered up penances and mortifications for the salvation of their souls and spent time before the Blessed Sacrament praying for each one of them, that none might be lost. Fr. Confasso also urged one of his former pupils, Saint John Bosco, to establish the Salesians congregation to work with the youth of Turin.

Fr. Confasso died from multiple ailments, including a stomach hemorrhage, on June 23, 1860, at the age of 49. He was greatly mourned, and his funeral, at which Don Bosco preached, drew great crowds. He was canonized in 1947. The Feast day of Saint Joseph Confasso is celebrated on June 23rd. Saint Joseph Confasso is the Patron Saint of Italian prisoners.






Actors' Shakespeare Project Presents

Continuing its season of "The Downfall of the Despots," Actors' Shakespeare Project (ASP) kicks off 2018 with Richard III, William Shakespeare's stunning portrait of Machiavellian genius and the murderous quest for absolute power. Under the direction of Resident Acting Company member Robert Walsh, the original "game of thrones" comes alive in an intimate staging at the Swedenborg Chapel (50 Quincy Street, Harvard Square, Cambridge) February 7th thru March 11th.

"I am thrilled to circle back to Richard III, ASP's inaugural production in 2004," says Walsh. "The timeliness of the play couldn't be stronger abuses of power today are as pronounced as Shakespeare imagined them in 15th century England. I look forward to telling a story with more than 65 characters — and just six actors —

in the setting of an English Gothic-style chapel, and how Shakespeare's language will resonate in that space."

In Richard III, the titular character spares no time revealing himself as a cunning, charismatic, and heartless tyrant who will stop at nothing to secure England's crown. The end of the civil "Wars of the Roses" promises a period of peace for the nation, until the death of Richard's newly crowned brother, Edward IV. Seizing the opportunity, Richard, Duke of Gloucester, schemes to become king by seduction, betrayal, and any means necessary. Twisted inside and out by discontent, and ruthless in removing anyone he deems obstacles to the throne, Richard hurls the court and the country farther into moral decline and military destruction. Ultimately, his abuse of power sets the stage for a new hero to rescue England, and a new house to reign.

L'Anno Bello: A Year in Italian Folklore

Feeling the Forces of Nature in February

All around me, nature shifts and pulsates with a renewed energy. I see this energy reflected in the increased number of birds hopping and singing around the bare branches of my backyard trees. I see it in the pinkishorange sunset hue peeking through the clouds on a windy evening. The rushing sound of melting snow seems to sing the newness of the season, while the scent of damp soil brims with the promise of new life. The calendar has now turned to February, a month of transition, a month filled with the crackling air and delicate reminders of early spring. Above all, February functions as a month devoted to purification, to dusting out the metaphorical cobwebs of a stagnant past, and ushering in a hopeful future. The Italian roots of the word "February" reveal the month's cleansing power, as it derives from Februa, an ancient Roman purification festival. Indeed, I love February precisely because it offers a new beginning, a chance to springclean the literal and figurative clutter in my life. This desire arises from seasonal cues and has been felt since ancient s, as evident by a plethora of February traditions held dear by our ancestors in Italy. Italian holidays and customs fully embrace the restorative nature of February, paving the way to an exciting spring.

As a child growing up in the mountainous Abruzzi region of central Italy, my father participated in a quaint ritual that

introduced the changeable days of February. On the evening of February 3rd, he would walk through the crisp, windswept air to his local church, beautifully aglow with candlelight. There, the parish priest would hold two crossed candles against the throat of each worshipper and say a blessing. This was la Festa di San Biagio, or the feast day of St. Blaise, the patron saint of illnesses of the throat and neck. St. Blaise, a fourth-century Armenian bishop, reportedly saved a choking boy's life by dislodging the fish bone that was stuck in his throat. The ritual that my father fondly remembered from his boyhood sought to prevent congregants from acquiring any sort of malady or injury to the throat in the future. In her inimitable book Festa, author Helen Barolini mentions that Italians eat special hard biscuits on la Festa di San Biagio, as yet another means to protect the throat. These curative customs practiced on St. Blaise's Day strongly remind me of the purification rites so prevalent in February. La Festa di San Biagio, therefore, reminds us that the time is ripe for reevaluating the small improvements we can make in

The people of Catania, Sicily, get another chance at a purification festival with la festa di Sant'Agata, or St. Agatha's Day. Bright lights and raucous revelries mark these celebrations, which culminate on February 5th, the saint's feast day. Huge candles and intricate light displays illuminate the city as people march in processions bearing relics of St. Agatha, a third-century Sicilian martyr. These luminous lights mimic the sun, which is now appearing for a longer time in the sky, scattering the darkness of winter and welcoming the restorative days of spring. Like St. Blaise, St. Agatha also presides over the protection against certain illnesses — in her case, diseases of the breast. However, St. Agatha further serves as the patron saint of bakers and, as such, Sicilian bakers bring their breads and pastries to church for a blessing on her feast day. Now imbued with healing powers, these blessed treats will bring luck and renewal to those who eat them. I recently discovered the celebrations in honor of St. Agatha, and this holiday fascinates me with its themes of light and darkness, feminine power, and symbolic foods. It seamlessly captures the purifying mood of February with its desire to rid people of both literal and figurative maladies, as well as greeting spring in a blaze of warmth. In fact, even after St. Agatha's Day ends, Italians look forward to a whole season of festivities that metaphorically dispel the dark winter days and hail the spring, from the flowers of St. Valentine's Day to the mischief of Carnival.

This February, I am eager to jump into a fresh start. The pastel hues adorning the latest spring fashions, the birds chirping in the bushes, and the delectable Valentine's Day chocolates fill me with an irresistible energy and enthusiasm. I realize that I am certainly not alone in looking forward to the spring, while still enjoying the unpredictable nature of a season in transition. February is a liminal month, where folk customs around the world gleefully greet a new cycle in the year with traditions that emphasize cleansing and healing. In order to fully delight in the spring, after all, we must make good on our promises of the New Year and purge ourselves of the negativity left over from our metaphorical winters. It is our time to let bad habits, self-doubt, and worries melt away like the snow during a thaw. Taking an example from the celebrations of St. Blaise and St. Agatha, we can realize that the power for change comes from within and that with love and hope, our hearts will forever blossom like a spring garden.



Five Must-Know Tips for Taking Care of Your Dog's Paws

Dog paws are as vulnerable as human feet and, like ours, they need to be taken care of and pampered. An owner wouldn't walk across a hot parking lot or a snow-covered field without the proper protection on their feet. A paw pad needs to be checked for a myriad of issues that should be addressed, including nail length, cracked pads, and foreign objects wedged in between paw pads.

- 1. **Trimming**: If a dog's nails are click, click, clicking when they walk or get snagged easily, then they are in need of having them clipped. The nails should barely skim the ground. Most vets offer this service if the owner is too anxious to do it themselves or the dog is unwilling to have it done. The hair in between the pads does cause painful matting if not trimmed regularly. Comb hair out and trim so they're even with the pads. Check for pebbles or other debris while trimming.
- 2. Cracked Pads: Pads do crack and bleed if they get too dry. Don't use human lotion on the dog's pads, it may soften pads too much and lead to more issues. Instead, look into pad moisturizers specifically designed for a dog's dried-out paws. While rubbing in the lotion, give the dog a paw mes-

sage by rubbing between the pads and up in between each toe.

- 3. Summertime Care: Dog's paws feel heat as much as humans do on the bottom of their feet. Keep this in mind while out walking during the heat of the summer. To avoid blistering and burning, avoid walking on hot surfaces (such as parking lots or sand). If blistering or burning occurs, wash with an antibacterial soap and loosely wrap with gauze.
- 4. Wintertime Care: Excessive exposure to cold weather could cause paws to dry out. This will lead to pads becoming chapped and cracked. Another thing to keep in mind during the long, cold winter months is that lots of people use salt, de-icers, and other products to melt ice off of sidewalks. This

could be toxic to dogs who like to lick their paws or could even cause burns on their feet. When coming home from a daily walk, either wipe down or rinse the paws with warm water to wash away any chemicals they may have picked up. Another alternative is to slather the dog's paws with Vaseline before a walk, which will keep salt from getting on the pads, or get canine snow boots for your pup.

5. Cuts and Scrapes: Occasionally, dogs will cut the pad of their paw and require some first aid. Clean the cut out with antibacterial wash, put some antibacterial cream on the cut, and bandage the paw. Of course, that is easier said than done. If the dog is unwilling to have their paw tended to, the owner should do the best they can under the circumstances. As always, seek veterinary care for any symptoms or injuries that concern you or become worse.


The Bridge on the River Kwai

The Bridge on the River Kwai, one of the greatest war movies ever, is about two commanders, one English and one Japanese, that butt heads in a concentration camp in the sweltering jungles of Burma. By the end, the prisoner becomes crazier than the captor.

In a shocking twist for a film produced in Great Britain and the United States and released just twelve years after the end of WWII, David Lean gives the audience less a clear understanding of British Lt. Nicholson (played by Alec Guinness in, arguably, his greatest role) than the sadistic Col. Saito (Sessue Hayakawa). More likely, however, Lean is asking us to pity the Lieutenant for the madness he is driven to as a prisoner of war.

Suggesting that a British officer could dissolve into a level of insanity worse than his oppressor was a brave stance for a British director to take so soon after the war, but then David Lean was always fascinated by geopolitics from various angles. If anything, the real villain here is war. As Roger Ebert wrote of the film, "The last words in David Lean's The Bridge on the River Kwai are "Madness! Madness ... madness!" Although the film's two most important characters are both mad, the hero more than the villain, we're not quite certain what is intended by that final dialogue. Part of the puzzle is caused by the film's shifting points of view."

The film is set during the construction of the Burma Railway between 1942 and '43. When a group of British prisoners arrives at a Japanese camp in the Burmese jungle, the commanding Col. Saita informs them that their mission is to complete a railway over the



river Kwai connecting Bangkok to Rangoon.

Here the power struggle begins as does Lean's clever narrative tactic. Nicholson is resilient at first and commands his men to be as well. Despite the brutality of Saito's punishments, he stands firm. However, Nicholson eventually realizes the substandard construction job his men did on the bridge while he was in confinement and decides to lead them in creating a sound bridge that will impress Japan. Perhaps Nicholson's change of heart comes from a sense of national pride. Even if the bridge will benefit the enemy during war times, it will stand as a testament to English ingenuity and design for generations after. What isn't as easy to understand is why building the bridge by Saito's deadline becomes his obsession.

For Saito, the importance is clear; if the bridge is not completed by the time appointed he must, as per Japanese custom, commit suicide. But what really is driving Nicholson? Is it the effect of war mixed with pride? Could it be that, as a prisoner, this is his one sense of purpose?

It's hard to tell and the movie is too intelligent for easy answers. But if the bridge became the center of Nicholson's life as a prisoner, the ending is a psychological tragedy, as the last vision of the dying Nicholson is the collapse of the bridge that defined his last days. The Bridge on the River Kwai is one of the greatest war movies ever made, and yet the horrors are almost entirely of the mind. In the end, it's not enemy fire that brings down Nicholson or his bridge, but his own insanity.

The Bridge on the River Kwai was based on Le Pont de la Riviére Kwai by French novelist Pierr Boulle, a satirical account of the building of the bridge aimed at mocking the English obsessions with rank and order. Lean saw this, but in his movie, the social satire turned into a tragedy.

The book caught the attention of screenwriter Carl Foreman who, shortly after his success writing the Western hit *High Noon*, was working in London after being blacklisted in Hollywood. However, he wrote an adaptation and passed it off to producer Sam Spiegel who struggled to find a director. The screenplay was rejected by Fred Zinnemann, John Ford, and Howard Hawks before David Lean took control.

The end result was the Best Picture winner of 1957 and, for Lean, his award as Best Director marked a turning point in his career. For the next twenty-five or so years, he was the crown prince of cinematic epics. Roger Ebert said it best, "Although David Lean won his reputation and perhaps even his knighthood on the basis of the epic films he directed, starting with *The Bridge on the* River Kwai in 1957, there's a contrarian argument that his best work was done before the Oscars started to pile up. After Kwai came Lawrence of Arabia, Doctor Zhivago, Ryan's Daughter, and A Passage to India; all but Ryan were nominated for best picture, and the first two won. Before Kwai he made smaller, more tightly wound films, including Brief Encounter, Oliver Twist, and Great Expectations. There is a majesty in the later films (except for Ryan's Daughter) that compensates for the loss of human detail, but in Kwai, he still has an eye for the personal touch, as in Saito's private moments and Nicholson's smug inspection of the finished bridge. There is something almost Lear-like in his final flash of sanity: 'What have I done?!"

Così Fan Tutte

at the **Boston Conservatory Theater**and at the **Shalin Liu Performance Center** in Rockport, MA



Boston Conservatory at Berklee presents the opera Cosi fan tutte, written by Mozart and Lorenzo Da Ponte in 1790 — the artists' third collaboration and arguably their strongest. The sparkling comedy begins with a wager between a cynical old bachelor and two young men, who swear that their fiancées will always be faithful. The boys pretend to go off to war and then return - disguised as Albanians — to woo each other's betrothed, aided by the wily chambermaid of the ladies. Lessons in love are learned, unrealistic expectations are shattered, and everyone comes out a little wiser in the process. Although well received when it was written, Così fan tutte lost favor in the mid-19th century, since Victorian audiences found the subject scandalous. The opera gained a new audience in the mid-20th century and has remained popular ever since. The Conservatory's production will be sung in Italian with English supertitles.

"It is important to take a fresh look at how to make *Così* fan tutte relevant for today's audience," said Cosi director Johnathon Pape, professor of opera. "The title itself has a built-in double standard — it means 'all women are like that'. The subtitle, ossia la scuola degli amanti, or 'the school for lovers,' is perhaps less overtly sexist, but doesn't address the imbalance inherent in the plot. The male characters are equally guilty of deception, inconstancy, and unrealistic romantic expectations, but only the women are condemned. Worse, the cynical old bachelor Don Alfonso excuses the women, saying, 'It is just their nature to be fickle!' Sadly, Mozart and DaPonte never considered calling their work Così fan tutti ('everyone is like that.').'

Despite the mixed messages in the show, Pape sees merit in presenting it from an educational standpoint. "The opera is a valid experience for singers and orchestra alike. Learning to perform Mozart well is a critical part of our students' training. The arias in Così are as beautiful as they are technically challenging, and the score contains some of Mozart's best ensemble writing. These are characters that young singers can relate to and successfully portray and, since the opera is frequently performed, it is valuable for them to have the roles in their repertoire."

Così fan tutte will be performed at the Boston Conservatory Theater, 31 Hemenway Street, Floor 2, Boston, on February 8th-10th; and at Shalin Liu Performance Center, 37 Main Street, Rockport, MA, on Sunday, February 11th.



A Nostalgic Remembrance



Recently, I was speaking to a group of people at one of my book signings and a question was asked by someone around my age, "To what do you attribute your successes in life?" I thought for a minute and then replied, "One important fact above most, strong male influences." As I formulated my answer beyond that point, the names of the people who influenced my young life came to the forefront: Babbononno, Dad, Uncle Nick, and James F. Ray, the man who managed the Seville Theater for the ten years I worked there (1952-1962).

Mom and Nanna were always there nurturing me along the way, keeping me out of harm's way when I was young, caring for me when I was sick, making sure I was well fed and supplying me with clean clothes every day. I'm not going to get into a discussion about roles in life. The women in my family were Italian, the center points of their families, not the heads, but expert at their adopted roles in life. Once women's roles began to change in the 1960s. Mom admitted that she had wished things were different when she was young. She had always loved math, and could take a column of numbers ten high and six across, look at it and immediately give you what they added up to. Babbononno made her quit school in the 10th grade to go to work and help support the family. According to my grandfather, she was a girl and education wasn't important and there was a depression going on in America. After she married Dad, she never worked again. Her job was to take care of her family. As a result of her not working, Dad worked day and night, by day as a teacher in the Boston Public Schools and by night, as a musician. Whether we agree or disagree, that's the way it was.

As I mentioned earlier, the major influences in my life were the men who guided me by their own actions and achievements and by showing me the way. I continued to explain about success and began with Babbononno as one of the first influences in my young life. He taught me how to work with wood, how to build things ... even make furniture. This was his trade and he wanted to pass it on. He also taught me I made sure I didn't disappoint the foundations of music, how to read the notes, how they interconnected and how they were combined with each other to form a melody and harmony

and mathematically resolve each time. Beyond this, when I accompanied him to his storefront social clubs, I saw how he interacted with his friends, how, because of reading newspapers and listening to the radio, he was informed about what was going on in the world and how to express the events of the day in conversation. From him, I also learned to dress properly. Whenever we went out, he wore a suit, starched white shirt, a tie, a fedora with the brim turned down in front, and a spit-shine on his shoes.

Dad was my major influence throughout the years of my youth. He talked about the right and wrong ways to do things, using the premise that he wanted to show me the easy way in life. I accompanied him just about everywhere he went and was never told to be seen and not heard. Observing his interactions with others helped set the foundation for my future interactions with peers, older people and, later in life, younger people. One of the major things I learned was respect. When I saw how people respected him, his comment was always, "Respect, you give it, you get it." Like many Italian fathers, he passed on his trade. He was a musician before anything else in life and made sure I was a part of it. I saw him interact with people who weren't Italian and discovered that they weren't that much different. Back then, Boston's music business was composed of men who were mainly Italian, Jewish, and African-American. He interacted with all of them without a problem. The people he worked with in the school department were mostly Irish and he interacted with them just as easily ... and I observed it all.

Uncle Nick was my mother's middle brother, my uncle, and my Godfather. He never had kids and I was the surrogate son he never had. I learned some of the same lessons from him that I learned from Babbononno and Dad. Put it this way, the lessons were reinforced. Later. when I became a young adult and turned professional as a musician, he put me to work, saying, "I can open a few doors for you, but once inside, you're going to have to prove yourself to others, or you won't make it." him all along the way.

Beginning at age thirteen, there was Mr. Ray. I lied about my age and went to work as an usher at East Boston's Seville

Theater, and stayed there for ten years. Mr. Ray was a Boston Yankee, and the first influence in my life that wasn't Italian. He was sophisticated, educated, and always well-dressed. Without me knowing it then, whatever semblance of class I came up with, I learned from him. He was a bachelor and often had very attractive young ladies visit him at the theater, all of whom interacting in a way I only dreamed of as a pimple-faced teenager. When the pimples began to disappear, I adopted his ways of interacting with others, especially the opposite sex. He possessed what today we call "class."

As young adulthood approached, the influences of the men in my life began to show through and I was able to face the world. When I did, I found many levels of success.

I flopped at a few things, but most everything I tried I succeeded at because of the foundation I received from the male elders I've mentioned. When I observed acquaintances that were not as successful, I also observed that most of them had never had male figures in their young lives to guide them along the way. I saw the same thing a generation later when my sons succeeded in school and in sports and other boys did not. Most of those who did not have the male leadership fell by the wayside or never realized their

As I continued to express myself to the crowd in front of me, I could see heads nodding up and down due to the listeners silently agreeing with me about success and failure. When I mentioned failure, I called it a learning experience that helps to direct a young man along with the successes in life.

Dad, Uncle Nick, Mr. Ray, and Babbononno have all passed on, but their teachings linger as long as I'm still around. I hope the apple doesn't fall far from the tree and my boys continue to succeed due to the foundation being passed along to them, with enough influence to allow them to pass it along to their children.

Times have changed, but how to succeed and how to fail in life haven't. I know some of you will disagree with me, but I also know that most of you won't. So, I say thank you to the men in my life and growing up in East Boston and the North End of Boston.

Recipes from the Homeland

AGLIA, OLIO, POMODORO, E BASILICO CON LINGUINE

(Aglia e Olio alla Salemitana)

5 large vine-ripened tomatoes (well ripened) 10 cloves of garlic 1/2 cup olive oil

1/3 cup fresh basil leaves Grated cheese of choice l pound linguine Salt and pepper

Cut up tomatoes into a thick medium-sized bowl. Add peeled and cut-up garlic gloves.

Wash fresh basil leaves. Cut up and add to tomato and garlic. With a wooden mallet, crush contents of bowl into a pesto sauce (thoroughly mashed). Add oil, salt, and pepper to taste. Mix contents thoroughly. Cover and set aside.

Following directions on the package, cook one pound of linguine to your liking. (Reserve about one cup of water when draining the pasta.) After draining, place pasta in a serving bowl. If desired, add a small amount of the hot reserved water to the uncooked tomato mixture. Then spread mixture over the linguine. Stir and serve in bowls topped with grated cheese of choice.

Hoyt Wilhelm Best Relief Pitcher Ever

When I was growing up as a baseball fan in the late '50s through the Miracle Mets of 1969, I thought the best relief pitcher ever was a knuckleballer named Hoyt Wilhelm. He didn't make it to the big leagues until the old NY Giants brought him up in 1952. He had been languishing in the minors for a full ten seasons up to then and looking like a nowhere man in baseball. However, once he made the trip up to the biggies, he hung around for twenty seasons, playing for nine different teams. Talk about never giving up. He knew he was good and just waited for his time to prove it.

Lifetime with nine teams, he finished 143-122 with 228 saves and a career 2.52 ERA. He was an 8-time All-Star and pitched in a World Series. In 1958, he no-hit the Yankees in only his ninth career start and got himself elected to the Hall of Fame in 1985, becoming the first relief pitcher ever elected to the Hall of Fame.

Wilhelm went into the Hall of Fame wearing the cap of the NY Giants. However, for me, I still remember him as a great relief pitcher for both the Orioles and

Neeno! Neeno!

Fifty Years Ago, Nino Benvenuti Arrived in America

On April 17, 1967, Nino Benvenuti stepped into the ring at Madison Square Garden to challenge Emile Griffith for the Middleweight Championship of the World. This would only be the third time Nino had fought outside of his native Italy and his first appearance in the United States. He brought a record of 71 wins in 72 fights with him. Twenty-nine of his victories were via knockout.

While it was not unusual for European fighters to arrive in the States with outstanding records on paper, many of the opponents they had would be viewed as being of questionable talent and lacking in motivation. With Benvenuti, it was a bit different.

In the 1960 Olympics, Nino had won a Gold Medal in the welterweight division. He was voted Outstanding Boxer in the games, beating out a young American boxer by the name of Cassius Clay for that honor. Of course, the Olympic Games that year were held in Rome, but by all accounts, Nino was deserving Remember, all but one of his of the recognition.

It has been reported he had an amateur record of 120 wins and no losses. It is hard to verify that, but anything close is still quite impressive. He won numerous amateur titles.

Nino would turn pro in 1961 and begin amassing a very impressive record that led to his winning the Italian Middleweight Title in 1963. In 1965, he won the World Light Middleweight Title by defeating Sandro Mazzinghi. He would beat Mazzinghi again in a rematch. In Sandro's career, he suffered only three losses in being to Benvenuti.

Nino would stay busy in the ring defending the title and fighting non-title bouts. He defeated American Don first round and showed that Fullmer and, in his first fight outside Italy, he defended his title against Jupp Elze in Germany. His next stop would be a title defense in South Korea against Kim Ki Soo. Fighting Soo in the Korean's hometown. Nino tasted defeat for the first time, losing the title. Benvenuti claimed he was robbed and that is very likely. However, instead of looking for a rematch and a the champion wasn't hurt. In chance to regain the title, he the fourth round, the champion decided to campaign for a shot at the World Middleweight Title.

Emile Griffith was the champion and promoters were looking for someone exciting to match against him. Things were a bit slow in the division at that moment and Nino had wins over top contenders Mazzinghi and Fullmer. Nino also had something else going for him: personality. He was handsome and could light up a room with his smile. Tex Maule, writing in Sports Illustrated, would call Benvenuti "[t]he best Italian import since olive oil." Combined with his not so bad boxing abilities, there was the perfect combination for a very attractive bout.

As Nino entered the ring for the fight, he looked fit and relaxed. At 5'10", he was tall for a mid-

One thing that was in question was how he would adapt to fighting under American boxing rules, which allowed for a lot more infighting and roughhousing than he was used to. previous fights took place in Europe, where the rules were similar to those in Olympic boxing and a fighter could be disqualified for crouching too

He fought hard in the clinches, so much so that he had Emile complaining about the tactics he was using. It was clear Benvenuti was there to win and was not going to give any ground.

Nino floored Griffith in the second round for a two-count, but connected with a solid right that put the Italian down and had him hurt. Griffith was unable to take advantage of the moment, though, and Nino survived the round using his defensive skills. The rest of the fight was hardfought, with Benvenuti bleeding from a cut on the bridge of his nose that he sustained in the second round.

Griffith worked the body hard in hopes of slowing Nino down in the later rounds, but the tactic did not work. To the chants of "Neeno! Neeno!" from the crowd, Benvenuti finished strong and won a unanimous decision, bringing the Middleweight Crown to Italy for the first time.

After the fight, the new champion had to be secluded in his dleweight and he had broad dressing room for about an hour

before meeting with the press, as he was ill. No, not from the effects of the punches, but rather from the emotions of having accomplished his dream.

Nino Benvenuti not only won the title that night, but he also gave boxing a much-needed shot in the arm. He brought an excitement to the sport. He proved so popular that it was decided to hold his rematch with Griffith five months later at Shea Stadium. Nino would lose the title on a close majority decision that night and then regain it the following year.

Nino was in his thirties now and his fine boxing skills were slowly starting to diminish, though he still could dig down and show what made him champion. He did just that in his defense against former Welterweight Champ Luis Rodriguez, where he was taking a pretty good lacing and then flattened Luis for the count in the eleventh round with a perfectly timed uppercut. He defended the title four times before losing it to the great Carlos Monzon. After losing to Monzon in a rematch, he retired. Benvenuti always said he would get out of the game when he no longer had it and he made

good on that promise. He was one of the few who knew when it was time to pack it in.

He invested wisely, acted in movies, hosted a television show, and opened a restaurant. He also became a city counselor in his home town of Trieste. He maintained a friendship with Emile Griffith and helped him out financially. Griffith was godfather to one of his sons. Nino

also became friends with Carlos Monzon and had him as a guest on his television program a number of times.

Nino Benvenuti is living la dolce vita in Italy. On April 26th, he will celebrate his eightieth birthday, making him the oldest living middleweight champion, though he looks years younger. He still flashes his infectious smile and looks more like a movie star than a former boxer.

Nino's name is rarely mentioned when the topic of all-time greats comes up, but he certainly was a very impressive boxer/ puncher. He was a master at throwing a hook off the jab. He could move very fast, had great defense, a lethal right hand, and a devastating uppercut. Nino was always very courageous in the ring and had no quit in him. He was a proud and popular champion and is still well-loved in Italy.

His professional record was 90 total fights with 82 wins, 35 by knockout, 7 losses and 1 draw. He was stopped on only three occasions; two of those were in his final two bouts, which were against Monzon.

Nino Benvenuti was a classy champion. He made the sport interesting and fun. He deserves to be remembered with the respect and dignity he earned. On April 26th, raise a glass of wine to him and say, "buon compleanno Nino Benvenuti campione!"

The contest will mark the 46th time the Terriers and the Crimson have met in the Beanpot, with BU holding a 28-17 record in those matches. Statistics can be deceptive, though, since Harvard has won three of the last four matchups with BU in the Beanpot.

A number of players who have participated in the Beanpot have gone on to play in the Winter Olympics, but not perhaps in an interval spanning just a few days. That will be the case, however, for Harvard star Ryan Donato, who will play in the opening round game against BU and then board a plane for South Korea, where he will suit up for Team USA in the international competition.

Donato, the son of current Harvard head coach (and former Bruins player) Ted Donato, has been a standout for the Crimson this season. As of January 30th, he led the team in points (23), goals (20), power play goals (4), game-winning goals (3), and shots (183). And, in case you're wondering, he's indicated that he will remain in Cambridge, saying he'll stay in school and graduate rather than leaving early for the pros.

The Terriers, of course, come in with history on their side, having won thirty of the previous sixty-five Beanpot championships. In fact, a win over the Crimson would send the Terriers into the championship game for the 31st time in the last 35 years. Once again, though, stats can be a bit deceiving, since BU has struggled a bit in the Beanpot in recent times, not advancing to the championship game in 2011, 2013 and 2014.

The team that did win in those years was Boston College. The Eagles will take on Northeastern on Opening Night, hoping to avenge last year's disappointing fourthplace finish. Nevertheless, it has been BC, under veteran coach Jerry York, that has

had the most success in recent Beanpots.

The Eagles won a school record five straight Beanpots between 2010 and 2014 and added another in 2016. Indeed, York has won nine Beanpot titles since 2001 and owns a very enviable 31-15 coaching record in tournament games.

And perhaps, just perhaps, the times could be changing again. When Harvard won the title last year, it ended a streak that spanned from 1993 to 2016 in which either Boston University or Boston College had won the tournament. BU had captured the crown twelve times while BU had taken home the trophy ten times.

In fact, York refers to the Beanpot as the annual start of "trophy season" in college hockey. Up to that point, there are individual games to win. But starting with the Beanpot, something tangible can also be claimed.

Following the Beanpot, there's the Hockey East Championship at the Garden, with its award of not only a trophy but an automatic berth in the NCAA regionals for the victor. The same goes for the ECAC, where Harvard will be on the hunt for the hardware and the automatic berth to Lake Placid.

If you want to root for an underdog, then you want to go with Northeastern. The school on Huntington Avenue has won only four Beanpot titles over the decades, while advancing to the championship game only thirteen times. The Huskies have won the consolation game eighteen times and have finished fourth on thirty occasions.

You may not want to count NU out this year, though, since the Huskies boast the only three players on the same team to combine for 100 points so far this season. The threesome includes NCAA point producing leader Adam Gaudette (39 points) plus teammates Dylan Sikura (tied for 7th nationally with 35 points) and Nolan Stevens (26 points).

NU starts scoring early. The Huskies were outscoring opponents 30-12 in the first period through games of January 30. In addition, Cayden Primeau has been a pleasant surprise in the nets. He's one of only three rookie goaltenders in the nation with 11 victories.

Those achievements have been noticed. The Huskies held down 11th place in the national rankings the week leading into the tournament.

Whoever wins, it's a certainty that the trophy will stay local and not be carried off to some far-flung place. After all, it's the Beanpot, an event once put on a so-called bucket list by Sports Illustrated magazine as one that all sports fans should see in person at least once in their lives.

But it's right here. Just a T ride away. Time to get over to the Garden for those traditional first two Mondays in February.
