Stirpe Nostra

ARTEMIS AND DIANA

The union of Zeus with the goddess Leto produced the twins Apollo and Artemis. Both twins were worshiped in many areas of the ancient world, but their principal places of worship were in Greece and Rome. Apollo, became identified as the god of light, health, prophesy, music, poetry and protector of the flocks, while Artemis (Diana in Rome) became the virgin goddess of the hunt and wild life. During ancient times this goddess was usually depicted wearing a kneelength tunic, braided hair, leather sandals, and armed with bow and arrows. While Apollo became known as the luminous god of day, Diana in turn, with her torch, became the goddess of light by night, and in time she also became identified with other goddesses of the moon and of the night.

The natural environment of Diana was the hills, valleys, woods, meadows, and rivers. She became a mighty huntress, chasing wild animals, dancing, playing, or bathing, with her companions, the nymphs, in the forests. This is also an appropriate time to mention that the Galleria Borghese in Rome contains a painting entitled "The Chase of Diana." It is one of the famous works of the master named Domenichino, and it portrays Diana with her nymphs of Marathon, when Miltiades

shooting arrows and bathing in a forest retreat. All animals were sacred to this goddess, but the hind, of course, was her favorite. This was the sacred animal which inspired the offerings of deershaped cakes during ancient ceremonies. Diana was also worshipped by Roman women who sacrificed to her for happiness in marriage and for normal childbirth.

Although her image was one of peace and tranquility, we are told that in Greece even the Spartans sought her favor by the sacrifice of a she-goat before a battle. It was prior to the battle

vowed to her as many goats as there were enemies who had fallen in the fields. The numbers were so great that the vow could not be kept, but instead, five hundred goats were sacrificed at each anniversary of the battle.

In addition to her position as goddess of the hunt and wildlife, she was also worshipped as the goddess of the moon. Special holidays honored her with parades and sporting events. During the full moon, large round cakes with candles were carried in procession and presented as a symbol of her light. Girls between five and ten years old, clad in orange-vellow colored garments were conducted in procession to the image of the goddess and commended to her care. As protectress of youth, young girls worshipped this virgin goddess as the guardian of their maiden years and prior to their marriage, they offered up a lock of their hair, their girdle, and their maiden garments.

Another interesting aspect of the Artemis-Diana worship, was the construction of several temples, one after the other, on the same site in Ephesus, Syria, and dedicated alternately to Diana Artemis. The latest structure was built about 350 B.C., so large, that it became one of the seven wonders of the ancient world. It was the center of the Pan-Ionic festival of the Asiatic colonies, and assumed to itself almost every public function. It was serviced by special priests, priestesses, image makers, poets, and soothsayers, while at the same time offering asylum to fugitives, acquired vast wealth, became a treasury, and later even a bank. The roof of the temple was supported by 127 columns which were between 54 and 60 feet high. Thirty-six of the columns were beautifully sculptured on their lower sections, while the gable end of the temple showed the goddess flanked with her devotees bringing offerings.

The most celebrated ancient statue of this goddess is the "Diana of Versailles," which once stood in Emperor Hadrian's Villa at Tivoli, his favorite residence. During this emperor's reign, the villa contained miniature reproductions of many famous structures of antiquity. The next time you visit the Villa d'Este at Tivoli, look off in the distance (about half a mile) and you'll see the ruins of one of the most splendid villas that the world has ever known. I'm sorry to say that time and the elements have taken their toll and most tours don't even visit the area now. How do you think you'll look when you're 1,900 years old?

QUALITY DIET vs. CALORIES COUNT. Those who ingest food with the same calorie count can become skinny, normal or even obese! Why? Because it is not the calorie count that is relevant, it actually is the quality of the ingested food that makes the difference. As by the research conducted by the national University "La Sapienza" in Rome, Italy, by the department of medical and endocrinologyphysiopathology, the outcome was presented at the 7th Regional Congress of the Italian Society of Obesity held in Rome. Researchers analyzed food intake of 120 people who followed different dietary methods as follows: 30 of them were strictly vegetarians, 30 were milk-egg vegetarians, 30 were skinny omnivorous and 30 were omnivorous obese. Each group ingested quantities of calories, but with very different body weight. Vegetarians ingested 1,920 calories a day, but with a body-mass index of 23.6; the milk-egg vegetarians 2,174 calories with a body-mass index of 22.9; the skinny omnivorous ingested 2,020 calories with a BMI of 23.69; the obese omnivorous 2,140 calories and a BMI of 37.9. When the quantity of calories were similar every day the four groups showed very different weights. Which showed that the ingestion of calories is not the only way to determine the increased obesity or the overweight condition, but instead what the menu consists of, as Andrea Lenzi, professor of endocrinology and director of the center of Medical Physiology and Endocrinology, in the department of experimental medicine at "La Sapienza" University. Researchers have come up with a new indicator called "Index of Quality Diet" (IQD), which makes possible to identify the "perfect menu" that prevents putting on weight, but provides good health, irrespective of the calories. Actually the damages caused by certain foods can be overcome by foods rich in fiber, such as cereals, vegetables and fruit, which create a balance between foods that contain saturated fats. Thus dishes deprived of fiber and grains, namely red meats, make possible a fattening outcome causing the development of illnesses related to obesity. Overweight and obesity occur mainly among the omnivorous who indulge eating fatty meats and certain types of cheese, totally ignoring greens. Although the "quality index" is still on the experimental stage, researchers plan to further extend the "sample," hoping to

LETTER TO THE EDITOR

President Failed to Provide Leadership

Dear Editor

The President has once again failed to provide the necessary leadership for this nation.

His request of Authorization for the Use of Military Force (AUMF) against the Islamic State shows that he has failed to carefully evaluate the threat, develop a workable strategy to overcome it, and propose to use all means necessary to achieve success.

His justification for the use of force is a grab-bag of statements, with only a vague reference to the "national security interests of the United States" and no attempt to clearly define those interests, nor to consider whether the use of military force is the best approach. Other reasons given to justify intervention describe conditions which exist outside the Middle East (e.g. the depredations of Boko Haran), yet he does not believe they require US intervention elsewhere. Congress, during its hearings on the AUMF, must take the responsibility for debating and deciding what our national interests are and whether the threat requires military force.

The President's "strategy" relies on US air power and ground forces provided by other nations. However, it remains to be seen whether those nations, primarily Iraq, will be able to field effective armies. At best, it will take time for them to be equipped and trained, which raises questions about the three year limitation proposed by the President. Military experts, and even highranking officers of the armed forces, have declared that US ground forces may be needed, and should be available for use. A good strategy should not assume that all will go well. Rather, it should assume that the difficulties will be greater than expected and be prepared to deal with them, not placing limits of time or force

If the Islamic State is a true threat to our "national security interests" (and I believe a strong case can be made), then our strategy must include possible use of as much military force as necessary to guarantee victory. Victory in the Gulf War of 1991 and the Iraq War of 2003-11 came because American presidents

The Pirandello Lyceum Celebrates

The Founding in 1800 of the **American Conservatorio of Boston**

The following is a follow-up article to one that was published in the Post-Gazette of December 5, 2014 pertaining to the founding in 1800 of the "first conservatory of music in Boston and in the United States" — the American Conservatorio of Boston.

The Pirandello Lyceum, Rosario Cascio, president, on Sunday October 26, 2014, sponsored the unveiling of the plaque marking the location of the American Conservatorio of Boston founded in 1800, the first conservatory of music in Boston and the first in the United States. The commemorative plaque is located at the Bedford Street facade of the historic Church Green Building. The Pirandello program cited the three immigrant musicians, Filippo Trajetta of Italy, Francis Mallet of France and Gottlieb Graupner of Germany who founded the American Conservatorio of Boston. The Privitera Family Charitable Foundation, represented by Philip Privitera, president, and Frank Privitera chairman, generously donated the funding of the beautiful bronze plaque at the site of the Conservatorio. The Privitera Family Charitable Foundation also provided the major funding for the Pirandello celebration at the West End Museum which immediately followed the unveiling. The program included the life and times of Filippo Trajetta, an Italian musician from Venice and one of the founders of the American Conservatorio of Boston. Sal Bramante was Master of Ceremonies for the program.

The discovery of the founding of the American Conservatorio of Boston in 1800 unfolded because of the research of Teresa F. Mazzulli, (a Pirandello "I Migliori" award recipient in 2014 in recognition of her interests in historic research). The Boston Musical Intelligencer.com website (August 29. 2014) reported that Teresa discovered this little-known Boston music history after reading a passage back in 1999 in a book titled "The Italian Americans of Greater Boston" by William P. Marchione, which stated in essence that the conductor-com-

poser from Venice, Filippo Trajetta "... established the first American conservatory of music in Boston." Motivated by this passage in Marchione's book, Teresa Mazzulli began her meticulous research establishing that the American Conservatorio of Boston founded in 1800 is the first conservatory of music established in Boston and in the United States, and her "shedding light" on the important music legacy to this country by each of the three European immigrant musicians, beyond the founding of this first conservatory of music in America.

A special program arranged by Teresa Mazzulli was conducted and supported by the Hyatt Regency Boston Hotel on August 27, 2014, including a musical interlude by the Rowe's Lane Quartet, named in honor of the "street" where the American Conservatorio of Boston and the Conservatory Hall were located in 1800 (today's Bedford Street was then known as Rowe's Lane). A "virtual plaque" unveiling ceremony by Privitera Family members complemented the Hyatt's joyful celebration in recognition of this remarkable music history of our City of Boston and of our United States.

A Night at the Movies

NOTE: This is my traditional Oscar column! I change the details every year, but keep much of it the same as it is the piece I am most proud to have written about my love for film. Just as you bring something different to the table every time you see a presumably familiar movie, I hope that this column instills in you a renewed love for cinema each year you read it.

It is that wonderful time of the year again. The time of watching movie stars glide across the red carpet, as graceful as paper swans, wrapped in jewel-hued gowns. It is the time when television channels replay Oscarwinning movies of the past, with iconic images of sultry femme fatales and tightjawed heroes and conniving villains flashing across the screen. During the past few



weeks, people have devoted many moments to recognizing the artistic achievement, a medium which often goes unappreciated, being synonymous with lightweight popcorn fare. Now, however, people are in full recognition of the powerful force that movies play in our lives. Which film of the past year, they ask, best crafted a story that transported us to another time or place? Which director imbued his or her project with the most love and passion? Which actress or actor best delved into the complexities of their role? Yes, it is the time of the year when the Academy Awards are announced. As a long-time lover of film, I will spend the evening of Sunday, February 22nd, glued to my television, shivering with anticipation as the little gold statuettes are distributed. While I am watching, I will also pay tribute to the significance of movies in my life and heritage. Movies have always comprised an integral part of my soul. Indeed, film has contributed to the collective subconscious of people around the world. Much of our notions of good and evil, achievement, love and longing derive from the celluloid world. When I think of selfless romance, for example, I think of cynical café owner Rick Blaine from Casablanca letting his true love Ilsa depart on a plane on a foggy Moroccan night, all for the higher cause of stopping Nazism. Han Solo from Star Wars, on the other hand, forever stays in my mind as the epitome of the rascal with a heart of gold, the guy everybody knows, who tries to be tough but cannot conceal his soft side for long. When he reappeared at the end of the film to save Luke Skywalker from the clutches of the evil empire, I felt a cheer swelling up inside me. That is why I appreciate film so much, because they are little stories that encompass the spectrum of emotions that give meaning to our existence as humans. During Oscar season, I try to catch as many of the Best Picture nominees as I can, though busy work and school schedules make it hard. This year, embarrassingly, I have yet to see any of the Best Picture nominees, as an unfortunate clash of illness, snow days, and busy work schedules made it difficult for me to get to theater. However, I hope to watch many of the nominees as soon as I am able, perhaps on a cozy movie night, snuggling with my husband and a big bowl of buttered popcorn. From dramatic biographies to quirky indie

flicks, the year's Oscar-nominated films encapsulate a rich tapestry of the human story, and I hope to soon add them to my repertoire.

The Oscar season also reminds me of the tremendous achievement that Italians and Italian-Americans have made in the field of cinema. Stateside, directors like Francis Ford Coppola and Martin Scorsese have become icons of American

filmmaking. My father is always quick to remind me that Italian-born moviemakers have supplied the world with many indelible masterpieces. World cinema stands all the richer because of directors like Federico Fellini, who brought whimsy and absurd satire back to the silver screen or Vittorio De Sica, who gave a voice to Italy's working-class citizens or Sergio Leone, whose revisionist Westerns reshaped the myth of the American frontier. Italian film even forms the backbone of an interesting story repeated among my family. When my grandmother was a young and sophisticated student in Rome, she was courted by the studio bigwigs of Cinecittá, the Italian version of Hollywood, to become an actress. Though one of her old-fashioned relatives put an end to this, the story speaks to the splendor of Italian cinema and its ability to inspire dreams in young people just like the fictionalized Hollywood of legend. In honor of Italian contributions to movies, I often serve star-worthy Italian dishes for my Oscar-watching events. Last year, I made a mascarpone cheesecake drizzled with chocolate sauce. WINTER PET CARE

Five good habits to teach your pet. It's never too late for your cat or dog to be on their best behavior. When a pet knows and follows the rules, it makes living together more pleasant for everyone. Even though owners love their pets, the animals behavior sometimes needs improvement. It's never our objective to annoy; it's just that we haven't yet learned (or have forgotten) the proper way to act. If you believe your pet could benefit from etiquette lessons, know that it's not difficult to teach a dog or cat to behave better. To make the most of your relationship with your pet, teach good habits using:

PRACTICE: Once you decide on a behavior to focus on, give your pet plenty of opportunities to practice it. Try it at different times of day, in different situations, even in different locations around the house.

PRAISE: Animals love to be adored and told how good we are. When your pet masters a new habit, praise him or her in an enthusiastic voice. Use the pet's name and say how wonderful they are. Pat them on the head or scratch them behind the ears as vou praise.

REWARDS: Who doesn't like a cookie (even if it's in the form of a dried fish morsel for a cat?) Accompany your praise with a treat. Even a small piece communicates how proud you are.

IMPORTANT HABITS TO LEARN

1. **COME:** The best time to teach a cat is before mealtime. Call her name right before you reach for the kibble or can opener. With repetition, she'll start to believe that hearing her name means to make a beeline for you. Away from the kitchen, call her name and have a reward like a silver tuna or chicken. Repeat. Similarly, with a

dog you can use food and practice, praise and reward.

- 2. **GO:** When placed in a lean litter box, most cats figure out what to do. With a kitten, gently take her paw and use it to scrape the litter. If instinct doesn't take over, keep her in a confined space with the box until she uses it. Clean and repeat. With dogs, it's all about timing (crate training helps too!) And remember to praise and reward good behavior with enthusiasm.
- 3. **BE A GOOD TRAVELER**: Whether you need to take your pet to the veterinarian down the street, or on a trip around the world, good behavior can make travel less stressful for everyone. To keep your pet and others safe, make sure that you have an appropriate restraint or carrier for them. Make test runs to get your pet accustomed to leaving the house. On a trip, allow time to stop and provide water and a bathroom
- 4. **LEAVE IT**: Pets are naturally curious, and dogs in particular are scavengers. To convince yours to give up something he finds that's toxic or potentially dangerous, teach him that the "Leave it" command is always followed by a tastier reward.
- 5. **DON'T PULL:** Walking even a small dog can pull you off balance, so it's important to control your pet rather than the other way around. With the dog on your left, walk quickly, talking to the dog as you go. Stop, treat, and go and make every walk a training session until your dog consistently keeps pace with you.

THE HISTORY OF ANIMATION:

That's All Folks!



Nowhere was the ending of classic animation bumpier than the Warner Bros. lot. Animators and studio heads were moving around and, strangely, the studio's cartoons were finally being recognized by the Academy, which had been dominated by Disney and the Tom & Jerry shorts. It's as if the studio wanted one last burst of energy before its closure.

Chuck Jones's Road Runner continued to dominate the Warner cartoons during their sunset years as well as the cast of new characters including Pepe Le Pew, Marvin the Martian, and the Tasmanian Devil.

Warner was struggling with the changing of times as well, going so far as shutting down the studio for 5 months in 1953 in a complete refusal to invest in the new 3D technology of animation that Disney had taken to. The studio, however, took much more kindly to TV, repackaging some of their classic shorts in anthology kids shows like The Bugs Bunny Show and later The Road Runner Show.

Still, the real prize was in the theatrical shorts and some of the very best cartoons that Warner did came out within its last few years. Birds Anonymous, a clever spoof of Alcoholics Anonymous with Sylvester struggling to give up birds, won the award for Best Animated Short Subject. The following year, the award went to a very funny Bugs Bunny and Yosemite Sam pairing set in Arthurian times. In Knighty Knight Bugs, Bugs is a jester in King Arthur's court tasked with retrieving the legendary Singing Sword from Captain of the Guard Sam and his troublesome dragon with a habit of sneezing at the worst possible time.

The reality of TV's domination, however, could not be ignored for long and when David DePatie took charge of the animation division in 1961, he knew the studio would not live to the end of his reign. Indeed, the following year he announced the closure of the studio, letting go of several of its most tal-



ented artists including Chuck Jones. By December of 1963 the studio that in its heyday had been one of the pillars of the Golden Age of Animation, closed its doors for good. Before his departure, Jones and others rushed out some last minute cartoons that were released in 1964, including False Hare, Bugs Bunny's last theatrical cartoon until 1990's Box-Office Bunny.

After that, most of the animation team dispersed, Chuck Jones had a varied career of his own, at first reviving Tom and Jerry for M-G-M before moving onto animated feature films. Friz Freleng turned his focus to a series of Pink Panther cartoons inspired by the success of the Peter Sellers movie. He joined forces with his old boss DePatie to form DePaite-Freleng Enterprises in an attempt to revive some of the classic characters they worked with in their glory days. For their headquarters, they leased their old studio and even brought an old protégée Robert McKimson, onboard.

Most of these shorts involved Daffy Duck's battles with Speedy Gonzalez and Road Runner-Wile E. Coyote skits, but none of them matched the ingenuity of the classic cartoons in any department, not animation, not gags, not character development. Even the creation of new characters, like Cool Cat, failed to renew spark.

If there was any good to come out of this bleak period it's that Warners realized the value of their old cartoons, moved the animation unit back within the studio, and began airing them as a regular fixture on TV, where they found a new generation of fans and have continued to delight young and old ever since. Broadcasted in various networks (from ABC, home of the original Bugs Bunny Show, to Nickelodeon) before Ted Turner, who had bought the Warner Bros. package, confined their airing to Cartoon Network and its off-shoot Boomerang!. No matter the channel, however, the Warner Bros. cartoons have stood the test of time and are the strongest living monument to the days when animation was king.



Autumn has never had any formal art training. Early on she began a process of self-education through studying works by other artists in books, online and at museums. The first book she remembers picking out for herself was a huge volume on Georgia O'Keeffe. Attracted initially to O'Keeffe's pretty pictures of voluptuous flowers, Autumn poured over the book and tried to figure out the techniques O'Keeffe used to make her images. Works by Autumn over the years of ram skulls - sometimes primitively outlined against bold shapes of color, other times illusionistically painted against diaphanous backgrounds — clearly reference one of O'Keeffe's trademark motifs.

Ray Barron's 11 O'CLOCK NEWS

A proposal to add a Latin phrase to Vermont's state motto caused an uproar when some residents mistook the ancient Roman language for Spanish. A state senator proposed adding "Stella quarta decima fulgear" (The 14th star shines bright") to the state seal. But protestors took to the internet to declare "Vermont ain't no Latino area" and "This is America, not Mexico."

Product placement, after Danielle Lei, an enterprising San Francisco Girl Scout, opened up a stand outside a local marijuana dispensary and set a national record by selling 208 boxes of cookies in just two hours.

Heartful performances, after a Colorado woman pleading to be excused from jury duty was told to come back to court the next day. She fell to her knees and began pulling out clumps of her own hair, and was immediately excused.

Tough love, after a Missouri couple was arrested for allegedly arranging to have their 6-year-old kidnapped because he was "too nice" to people. The boy was lured into a pickup truck, threatened with a gun and tied up, and then lectured about "stranger danger."

First impressions, after a Texas woman lost her prospective pizza delivery job because she tweeted, "Ew, I start this (expletive) job tomorrow." Her boss tweeted back, "No you don't start that job. I just fired you!"

Waste management, after a \$110,000-ayear water manager in San Francisco was suspended for urinating in a city reservoir, suspended without pay for five days, and warned that if he "pees in the wrong place again, you are toast."

Boston Record snowfall: Harsh winter weather continues to pound New England as residents brace themselves for their fourth powerful snowstorm in less than a month. The winter storms have been so extreme that Massachusetts Governor Charles Baker was forced to deploy 500 National Guardsmen to help shift the nearly 6-feet of snow that fell in just 17 days — much of which has been thrown into Boston Harbor in violation of normal practice.

News from Grosseto, Italy. Cruise captain found guilty: An Italian court has sentenced the former captain of the Costa Concordia cruise ship, which capsized in 2012, killing 32 people, to 16 years in prison. Francesco Schettino allowed the ship to be steered too close to shore, where it struck a reef, and then he hopped on a lifeboat to save himself while the vessel keeled over. He was convicted of multiple manslaughters, causing a shipwreck, and abandoning passengers. He won't serve time soon though, since the court said he could remain free during Italy's complicated appeals process, which is expected to take years. Before the verdict, Schettino wept on the stand. "All the responsibility has been loaded on to me," he said, "with no respect for the truth or for the memory of the victims."

Rosie O'Donnell has quit The View just five months after her dramatic return to the show so she can deal with her split from second wife, Michelle Rounds. The couple had been living apart for months, says the New York Post, and O'Donnell is concerned about the well-being of her five kids-including her adopted baby daughter with Rounds. "This has been a very stressful situation," said a spokesman for O'Donnell.

Hey, guys, pay attention. Men who average three drinks a day and women who average two face a significantly higher risk for stroke in middle age, a new study has found. The study by Swedish scientists examined drinking habits of more than 11,000 twins over four decades, and found that those they defined as "heavy" drinkers in their

50s and 60s have a 34 percent higher risk for stroke than more



moderate drinkers. That makes excessive alcohol consumption a greater risk factor in strokes than high blood pressure and diabetes. Heavy drinkers also were more likely to have strokes five years earlier than light drinkers, regardless of their genetics or other health habits. The findings are consistent with the American Heart Association's recommendations that men not exceed two drinks a day, and women, one. Previous studies have found that moderate drinking can have a protective effect on heart disease and overall mortality, and the Swedish study found that abstaining from alcohol altogether did not lower the risk of stroke. Drinking is "like Jekyll and Hyde," Tara. Narula, a cardiologist at New York City's Lenox Hill Hospital, tells CBSNews.com. "It can be medicinal and beneficial or poisonous and detrimental, depending on how much you

Over the past decade, thanks in part to widespread restrictions on when and where people can light up, the number of Americans who smoke has rapidly declined. But despite that reduction, some 58 million Americans are still regularly exposed to secondhand smoke, according to the U.S. Centers for Disease control and Prevention. Although this is a 50 percent drop from 10 years ago, one in four nonsmokers remains vulnerable, and the risks are most pronounced among African-American children and the poor. Exposure among black children from ages 3 to 11, is still 68 percentabout twice the level for white or Hispanic kids. The percentage of impoverished people exposed to secondhand smoke stands at about 43 percent, compared with roughly 21 percent for those living above the poverty line, Health officials warn that when it comes to secondhand smoke-which is linked with several health risks, including asthma, respiratory infections, and heart and lung disease-there is no safe level of exposure.

Parla Come Mangi! (Speak as You Eat!)

Benvenuti! This week's recipe, Castagnole fritte, is in honor of my recent visit to Venezia where I took some of my students to see Carnevale last week. After learning about "Le maschere della Commedia dell'Arte" we were able to see Arlecchino, Dottor Balanzone, Pulcinella, Colombina and other maschere performing live in Venice's piazzas! "Commedia dell'Arte," the 16th century Italian colorful and tragicomic teatro di piazza consisting of improvised sketches and scenes representing human characteristics through the maschere of the Italian comedy performance, was born as a reaction to the cold and rigid plays of the time. "Pazzi Lazzi," a delightful professional troupe of accomplished Italian actors, brings the excellence of the Commedia dell'Arte right here in Boston with the delightful "Aria di Commedia" shows where actors interact on stage with the "Renaissonics," professional Renaissance musicians bringing the audience right back to the 1500's. I bet Arlecchino would love to try some Castagnole, a sweet fried dough dessert that gets its name from the Italian word castagne (chestnuts) due to its shape and size.

Castagnole

1/3 cup + 2 Tbsp of milk 1/3 cup + 2 Tbsp water 3 Tbsp vanilla sugar ½ stick butter Grated zest of ½ lemon 1 tsp baking powder 1 ¼ cups of flour 4 whole large eggs + 1 large egg yolks Powdered sugar to garnish Frying oil

Preparation: In a medium pot bring the milk, water, sugar, butter, salt, lemon zest, vanilla and baking powder to a boil, remove from the heat and all at once throw in the flour mixing well with a spatula or wooden spoon, put the pot back on the stove on low heat and stir until the dough forms into a ball that detaches from the sides of the pot. Transfer the dough into an electric mixer and let cool slightly. Using the paddle attachment, incorporate one egg at the time into the dough. Make sure that each egg is well incorporated before adding the next. This process will take several minutes. Cover with plastic wrap and let rest at room temperature for one hour. In a large pot, pour enough frying oil for deep frying and heat it up at medium high temperature. Using a tablespoon, scoop some dough into the oil (a little spoon will help you get the dough off the tablespoon and into the hot oil), lower the heat to medium and fry until golden brown. The Castagnole will puff right away but make sure to fry only a handful of them at a time to avoid further lowering of temperature of the oil. Transfer onto a paper towel to drain. Let cool completely, sprinkle with powdered sugar and serve. Buon Carnevale!

Castagnole

100 ml latte 1 cucchiaino di lievito per dolci
50 g di zucchero vanigliato 50 g di burro 4 uova intere + 1 tuorlo
La buccia grattugiata di mezzo limone 1 cucchiaino di lievito per dolci
140 g di farina 4 uova intere + 1 tuorlo
Zucchero a velo per guarnire
Olio per friggere

Preparazione: Versa in una casseruola i primi 8 ingredienti e fai bollire il tutto su fuoco moderato. Leva dal fuoco e versa la farina, tutta in una volta, mescolandola bene con una spatola o con un cucchiaio di legno. Rimetti sul fuoco e mescola continuamente a fiamma bassa fino a quando si sarà formato un composto omogeneo e liscio e che si stacca dai bordi della pentola. Togli dal fuoco, fai intiepidire e aggiungi, una alla volta, mescolando bene le uova ed i tuorli avendo l'accortezza di non aggiungere un altro uovo se il precedente non sarà stato ben amalgamato. Copri la pasta con la pellicola trasparente e fai riposare per 1 ora. Riscalda l'olio, circa 1 litro, in una padella. Quando è ben caldo ma non bollente prendi con un cucchiaino un po' di pasta e, aiutandoti con un altro cucchiaino, fai cadere la pasta nell'olio a fiamma moderata e le castagnole si gonfieranno immediatamente. Toglile dal fuoco quando sono ben dorate e colorite. Trasferiscile su della carta assorbente e falle raffreddare completamente. Guarniscile con dello zucchero a velo e servi. Buon Carnevale!

A Nostalgic Remembrance



February school vacation was a couple of weeks away and I had made plans to go on vacation. I was teaching drafting and industrial design at Hyde Park High School and was playing with several bands, performing each night of the week except on Mondays. That was unofficially the night off for most musicians back in the day. I had learned my lesson a month earlier, between Christmas and New Year's Eve. I had accepted an invitation at a ski lodge near Cannon Mountain in New Hampshire.

Let me start by saying, "I hate the cold." As I've gotten older, I hate it even more, but even back then, I hated the cold. This time around, I wanted to vacation in the tropics. More about the plans in a minute, but first let me tell you about a trip to Cannon Mountain: A pretty young teacher on our faculty was an avid skier and invited me and another young male teacher from the Hyde Park faculty to the ski lodge she belonged to. We would pay our own way, but as her guests, it was a lot cheaper than if we made reservations at a hotel.

I had never been on skis before and didn't have the right clothing nor the equipment necessary. When I mentioned my plans to the guys in the bands I was working with, a couple of them offered to lend me the necessary clothing and boots. Sal Meli, an old friend from East Boston, could take time off from his job at Polaroid and decided to join in with us, and on December 26th, Sal, the girl that invited us and the other male teacher, Tom Aylward, and I jumped into my Thunderbird fourseater and headed north.

It was Wednesday morning, the day after Christmas. I picked everyone up, but told my friends that we would have to come home on Sunday, as I was playing on New Year's Eve, but didn't want to take any chances. All agreed and off we went.

The resort had all of the amenities, and by late afternoon we were checked in and raring to go. After dinner, Sal, Tom and I were introduced to the club members and we partied until it was time to call it quits. Early the next morning, I was fitted for skis and headed to the novice slope of Cannon Mountain to take a skiing lesson. The instructor took about a half hour, showing us the ins-and-outs of the sport. To me, the most important aspect of everything was how to stop. Once I thought I was ready, I

headed to the top of the novice slope, but didn't think I could maneuver around all of the beginners who were falling down. As a result, I decided to head farther up the mountain. When I got to the intermediate level, it was too crowded, so I continued until I found myself at the top of Cannon Mountain with the expert skiers. I snapped on my skis, pointed them down the mountain, said a quick Hail Mary, and pushed off.

Dragging my ski poles, I slowly descended the mountain, swerving to avoid the pros that were flying down the mountain. The swerving also allowed me to miss the trees and boulders that dotted the slopes of Cannon Mountain. I was nervous and wished I were back home having a glass of winter wine with Babbononno.

Well, I somehow made it down the mountain without falling or hitting anything. When I arrived at the novice slope, I zigzagged my way around all of the falling beginners and saw the side wall of the public ski lodge coming closer, I pointed my skis at each other (called snow plowing) and jumped sideways. I stopped within a couple of feet of the outside wall of the lodge, snapped off my rented skis, looked back at the slopes of the mountain, saluted and headed inside with no broken bones, no scrapes or bruises, only a body full of cold New Hampshire mountain air. I had beginner's luck and didn't want to tempt fate. That was the first and last time I ever put on a pair of skis in my life. Once inside, I ordered a hot chocolate and waited for Sal and the rest of my friends to come back and join me. I don't know if I was dressed well enough for the northern New England climate, but it took me a day or two to warm up. I made a promise to myself, if the good Lord would allow me to thaw out, I would never go skiing or try outdoor winter sports ever again. I warmed up and have kept my

A couple of months later, and as I said, the February school vacation was approaching. Both Sal and my faculty friend, Tom, decided to go to Puerto Rico. I knew two things about this island, it was an American commonwealth, and it would be warm during February vacation. I called a friend of Uncle Nick and Aunt Dorothy to arrange things. Well, I'm not much of a drinker and neither was Sal. Tom had a couple, but the friend that drove him to the airport put a good dent in a bottle of Jack Daniels and was feeling no pain.

After a couple of hours, they rescheduled our flight in spite of the snow and by late that evening we were ready to fly out.

Just before boarding the plane, I called home to let everyone know what was going on. Babbononno answered and told me that I should have taken him with me to translate. I asked my grandfather if he could speak Spanish and he said, "Noh, ma Italiano, sheeza peedy close to Spanisha." I thanked him anyway and told him to tell Mom and Dad we were on our way. WE'RE MOVING ON TO THE OFF-SEASON ...

With two weeks separating us from Malcolm Butler's Super Bowl clinching interception, it's time to start shifting focus onto the 2015 season. The Patriots long playoff run and subsequent championship celebrations have the team behind in terms of preparation for next season. The team has decisions to make with key players who are headed for free agency, names that include safety Devin McCourty, kicker more doable. Release him. Stephen Gostkowski, running back Shane Vereen and center Dan Connolly, to name the essentials. The contract situation of Cornerback Darrelle Revis, who will hold a \$25 million cap charge, is another issue that needs to be resolved.

Of the above listed free agents, McCourty is a top priority and definitely needs to be retained by the team. This is not intended to diminish the contributions of the others, but this upcoming free agent period will be one of the weakest in recent history when it comes to safeties. With a defensive secondary that played incredibly down the stretch of last season, the Patriots would be foolish to tinker with the group. With the franchise tag at their disposal, if a long term deal cannot be reached with McCourty prior to March 10th, the tag must be applied.

Bottom line: Devin loves playing for the Patriots and the team should do everything it can to bring him back.

Next, the Patriots need to ensure that another key piece of the secondary, Darrelle Revis, remains in Foxboro next season and beyond. The two sides will need to be willing to renegotiate the one-year left on his contract, and bring his mammoth cap number way down. Team President Jonathan Kraft all but guaranteed a Revis return, calling the current deal a "place-holder," and I believe the two sides will come together and that Revis will sign a lucrative long-term deal. The team hasn't performed well and has at times down right insulted players with their contract offers. Revis is not the player to do this with. We all saw how much he meant to the Patriots last season, giving head coach Bill Belichick the flexibility to run more exotic defenses. This was only possible because of Revis ability to shut down his side of the

Bottom line: Pay the man! Another player in a contract that requires adjustment is linebacker Jerod Mayo. Mayo is coming off a second consecutive injury shortened year and will carry a cap charge of \$10.4 million. Further complicating things for Mayo was the play of Dont'a Hightower and Jamie Collins. Those two never missed a beat in the middle of the de-

The two will also come at a of .516. fraction of the cost, approximately \$3.5 million combined. The organization and Mayo share a mutual affinity, however, unless he agrees to take a significant pay cut, the team should walk away. I've never been a fan of Mayo's game and quite frankly think he is overrated. Bottom line: Cutting Mayo will mean \$4.3 million in cap relief and will make resigning McCourty and the others

Annual Banquet to Honor Tony DeMarco on 60th Anniversary of Winning World Title


Ring 4 President Mickey Finn has announced this year's Ring 4 Hall of Fame inductees at a meeting of the Board of Directors held on February 14th. Kevin McBride, Ken Flora and Brian Powers were selected as this year's honorees.

Kevin McBride, The Clones Colossus, represented Ireland in the 1992 Olympics in Barcelona, Spain. Kevin

turned pro after that and compiled outstanding record of 24 wins, 3 losses, and 1 draw when he signed up to fight Mike Tyson. Most experts didn't give McBride a chance against Iron Mike, but Kevin trained to win and was not intimidated by the hardhitting former champ. Kevin

made history when he stopped Tyson in the 6^{th} round, sending Mike into permanent retirement. Kevin finished his career with a record of 35-10-1 and an amazing 29 wins by knock out. In addition to Tyson, he faced top contenders Axel Schulz, Louis Monaco, Andrew Golata and Tomasz Adamek. He was trained by Goody Petronelli.

The New Garden Gym (there were actually three over the years all within yards of each other) was the Mecca of Boxing in Boston. Anyone who was anyone in boxing stepped into the ring there. There were saints and sinners, cops and robbers, and some of the best people you would ever want to meet there. Ring 4 inductee Ken Flora's story is a great example of what a great influence that old gym had on so many young men looking for a place in which they could find the path to manhood and the road to self confidence. Ken described himself as a very shy kid with a speech defect who got hooked on boxing once he saw the Friday Night Fights on TV. He did some boxing with his friends around his home town of Watertown and eventually climbed the stairs up Mark DiAmicus and Art

to the New Garden Gym. It was there that he met middleweight contender Blair Richardson, one of the New Garden's saints, who gave the young Ken great encouragement and was a posi-

tive influence on him. Ken trained alongside fighters such as Gabe LaMarca, Johnny Coiley, Jerry Graci, Dick Hall and Marion Conner. His first amateur bout was at Norfolk Prison where he was part of a team put together by Vinny Marino, Johnny Gagliardi,

Johnny Dunn and George Holden. Former World Middleweight Champion Paul Pender was athletic director at the prison. Ken fought from 1966 to 1970 and complied an outstanding record of 30-8. He holds wins over Golden Gloves Champion Bobby Jones,

Montminy. He dropped a decision to fellow Ring 4 Hall of Fame member Mike Mullen whom he considers the best he ever fought.

Brian Powers retired from boxing as an undefeated professional. Everyone I have spoken to tells me he had everything it took to go all the way to the top. Tony Petronelli says Brian had it all, punch, guts, stamina and desire. Ring 4 President Mickey Finn told me that Brian was one of the best prospects he has ever seen. Brian, who calls Holbrook his

hometown, fought from 1986 until 1992 with one more fight happening in 1998. He fought some rough guys and always came out on top. He beat three opponents who went into the ring against him with undefeated records. Brian has stayed active working with young boxers and

is highly respected among his peers.

President Mickey Finn told me he is extremely proud of this year's class of inductees and that he is looking forward to the banquet and award ceremony.

In addition to the Hall of Fame inductions, former World Welterweight Champion, Tony DeMarco, will be honored at this year's banquet. April 1, 2015 marks the 60th anniversary of Tony's winning challenge against Johnny Saxton for the World Championship. Tony won the title in magnificent fashion when he kayoed the very tough Saxton in the 14th round at the Boston Garden. I don't think any fighter could have beaten Tony that night. The 83-year-old former champ is still going strong and has written his autobiography, Nardo, which is a great read. Tony also still throws a mean left hook, so keep your distance.

HOOPS and HOCKEY in the HUB

Breaks in the action are funny. Sometimes they can come just when a team needs them, providing a time to prepare for the games to come, a time to put together a strategy for the stretch drive.

At other times, they can appear on the schedule at a most inopportune time. Their pause can break momentum, stifle enthusiasm, postpone or perhaps derail entirely an excitement that had been building over the course of several contests.

As we considered it over the course of another snowy weekend as the road outside our dwelling grew ever narrower while the piles of snow grew ever higher, we realized that when the Celtics resumed action after the All-Star break, they would be at such a juncture — one that could well determine whether they will play beyond the end of the regular season on April 15th.

When the Celtics broke for All-Star Weekend, they did so with the sound of euphoria resounding throughout the TD Garden. Their one point victory (89-88) over the Eastern Conference leading Atlanta Hawks brought echoes in the hallways of the Garden that have been almost foreign for some time. They were the shrieks, the whoops, the stride, the pride of victory, the most significant one for the C's thus far this season and a perfect experience to relive through nine days away from the action.

Most media outlets concentrated on Evan Turner's seven-foot jumper with just two-tenths of second remaining that delivered the victory to the Green. But you can't overlook another stat — the 19 for 20 foul shooting that truly was the decisive hidden factor. If the C's had missed just a couple of more of those, the Hawks would have left with their 44th victory of the season.

And yes, Turner had a significant hand in that. He was 4-4 from the line on a night when that stat meant so

"It feels good in that locker room for these guys to experience a win where you didn't play perfect but you ground out a victory against a really good team," said Celts Head Coach Brad Stevens minutes after the C's captured their 20th win of the season. "We needed that experience and hopefully we can build off it."

A good many people have already taken notice. The Celtics have seemed to play with a new spirit, a new expression, a new enthusiasm since yes, Rajon Rondo was traded to Dallas back on December 18.

Remember earlier in the season when the Celtics would keep up with teams in south in the second (especially the fourth quarter) on things turn out in April.

the way to another depressing defeat. That rarely happens anymore. The Celtics can lose games, of course, but there is a different feeling about those setbacks — a fought-them-to-the-end attitude rather than a wave-the-white-flag in-defeat resignation.

"We had a bunch of games early that didn't go our way," noted Stevens. "We had a bunch of things that we could control and that we could do better. One of those things was making gamechanging plays in gamechanging moments. The other was executing a little bit better. We've also tried to put an emphasis on our play at the end of quarters."

In short, the young Celtics are learning how to win and the good feeling that can flow from that. During most of February Stevens stated things have been different from the time of the early season losses, noting in recent games "we've had to come back and I feel like it's been a positive in the last eight minutes of games. So that's encouraging from where we started the year."

And wouldn't you know, as the Celtics resume after the All-Star break with 31 games remaining on their schedule, there is finally talk in the daily media (we've been saying it all along) that this current group of Celtics could possibly qualify for a playoff berth.

Indeed, at the break the Celts were only one and a half games out of the eighth and final playoff spot in the Eastern Conference. There are a number of other contenders for the same berth. Things will continue to be very fluid as play resumes. The Celtics will have to continue to win and yes, several other teams will have to lose, but the Celts seem to now have a much better attitude toward it all.

As we write this, the NBA trade deadline was looming and rumors were rampant that the C's would pick up one or more players for the final couple of months of the season. The various names mentioned would fill a good portion of a team roster.

But, in some ways, Stevens is still a college coach, one who appears to like a settled team, especially the one that he has now. The team has started to gel and one has to be careful about introducing individuals into that mix that might upset that chemistry. The Celtics already have numerous draft picks (through 2021) acquired through previous transactions. Whether a player with an expiring contract would really make a difference now is questionable. If it was earlier in the season, yes. But now, as the current players forge a cohesive unit, it would not be productive to disturb that the first half and then go process. Our suggestion is to let it be and see how
