# There's No Such Thing as Honor in Defeat

Mary Z. Connaughton, Karyn Polito, Jeff Perry, Sean Bielat and the other major Republican contenders for statewide and Congressional offices in Massachusetts may have all put up a great fight last fall, but they ultimately could not go the distance; they were prevented from scoring a political touchdown by powerful unions, negative mainstream media coverage, incessant derogatory advertising and, most importantly, a state Republican Party that mistakenly placed excessive financial focus on the gubernatorial election.

Scripture says that without a vision, the people perish. The center-right people of Massachusetts certainly perished politically last November. How do conservatives, centrists, libertarians and right-leaning moderates avoiding taking another trip down the road to perdition?

One pathway to victory lies in a proposal by David D'Arcangelo, an aide to former Governor Paul Cellucci and former Senate Majority Leader Richard Tisei and the current chair of the Malden Republican City Committee. Known as the New Mass Playbook, this proposal promises to restore two-party balance to a state that desperately needs it.

D'Arcangelo recognizes that one of the major problems facing Republicans in this state is their chronic poor showing in urban areas. The conventional wisdom is that the urban voting be trained to confront. coalition represents an impregnable Democratic fortress, a no man's land for anyone right of center. However, D'Arcangelo rejects this pessimistic philosophy. "[W]e simply cannot expect to win a statewide election and lose the City of Boston by over 76,000 votes, as was the case with nearly all of our statewide candidates this past election," notes D'Arcangelo on newmassplay book.com. "We should ... promote the planks from our platform that appeal directly to urban voters. Take for example our position on the environment. The whole world is 'going green' and we should be tapping into that

sentiment. After all, we have allowed liberals to take advantage on environmental issues." Education reform is another issue that might resonate with urban voters, whose children have been waiting for Superman for far too long; of course, GOP reform proposals will likely arouse the fury of the teachers' unions, something Republican candidates must

Speaking of training candidates, D'Arcangelo also emphasizes the need to have candidates fully prepared to win, noting, "Too many of our candidates did not have the skill necessary to perform rudimentary campaign functions such as how to: fundraise, voter ID. setup and prepare for debate, establish a direct mail account, develop direct mail pieces, etc. This can be addressed with a few low cost and low-tech solutions."

The GOP's acquisition of sixteen seats in the state legislature proves that not all is lost for the Common-

### Yancy Wants to Mandate **Vests for Cops**

City Councilor Charlie Yancy has decided mandating Boston cops to wear bulletproof vests. As it stands right now, Boston police officers are not required to wear them. However, Yancy has decided recently to propose a change in current policy to require uniformed officers to wear them. Yancy stated, "I'm more concerned about the fact that once you put a uniform on there's a target to people who potentially might confront the police department." However, the Boston Police Department countered, "Although Councilor Yancy is well-intentioned, Commissioner Davis believes that this issue belongs between the police administration and the police union."

# **CALIGULA**

A study of all the stories, events, and the characters associated with the rise and fall of the Roman Empire would be like reading an entire library, and would probably take a 100 years to fully understand and record its beauties. A capsule explanation divides the history of Classical Rome into three distinct periods: 1. The Regal Period (the legendary kings like Romulus) 753 to 510 B.C.; 2. The Republic (the time of the great Roman Senate and ending with the death of Julius Caesar) 510 to 27 B.C.; 3. The Empire (the period of Roman emperors starting with the great Augustus and ending with the pitiful Romulus Augustulus) 27 B.C. to 365 A.D.

During the period called the "Empire," there were many good emperors like Nerva, Trajan, Hadrian, Antoninous Pius, and Marcus Aurelius. Unfortunately, along with the good, they also had to contend with the bad. There were rulers like Caracalla who, not only built one of the world's largest bath tubs, but was also noted for his brutality, Heliogabalas, who was noted for his debauchery, and Commodus, the son of Marcus Aurelius who was reported to have been the most blood thirsty and unruly emperor that has ever been recorded in all of history. Those of us who are in good health pay a daily tribute to the memory of this character.

Then there was Nero, the archenemy of all Christians, who was one of the most cruel, depraved, and despotic emperors that ever ruled Rome.

nutcake named Caligula, who was just plain off his "Roman rocker". His reign got off to a pretty good start, but the finish just defies de-

scription.

Caesar was the family name of Gaius Julius Caesar, and after his death the title of Caesar was given to all of the Roman emperors from Augustus to Hadrian. References are still being made to these 12 Caesars whose popular names, in chronological order are: Julius Caesar, Augustus, Tiberius, Caligula, Claudius, Nero, Vespasian, Titus, Domitian, Nerva, Trajan, and Hadrian.

Caligula was born of Germanicus and Agrippina, in an army camp, in the year 12 A.D., and was brought up among the legions. The name Caligula as given to him by the soldiers because of the "caligae" or army boot that he was required to wear. His proper name was Gaius Caesar Augustus Germanicus and it was the name he preferred. As a young man, while in the court of his grandfather Tiberius, he displayed a naturally mean and vicious temper, a wanton love of cruelty towards persons of lesser rank, and a most abandoned and unprincipled debauchery. He became a most eager witness to tortures and executions of prisoners, and he reveled at night in adultery and glut-

Greek and Roman mythology tells of Phaethon, the son of Helios the sun god who borrowed his father's sun chariot and through reckless driving was about to set the world on fire when Zeus

Finally there was a destroyed him with a thunderbolt.

> Tiberius often said that to allow Caligula to live would prove to be the ruin of all men and that he (Tiberius) was breeding a viper for the Roman people and a second Phaethon for the destruction of the world.

> The will of Tiberius made his two grandsons, Druses and Caligula, joint heirs to his private property. (What a mistake that was!) There are some conflicting reports about the death of Tiberius. One sure bet was that he did not die of natural causes. It was known that his death was not too far off and one day he fainted, consequently he was thought to be dead. Caligula was being saluted as the new emperor when he was informed that Tiberius was still conscious. One report claims that Caligula immediately smothered his grandfather with a pillow and a second report tells of Tiberius being poisoned.

> Caligula succeeded in having himself proclaimed emperor and this appointment was received with great joy throughout the empire. The early days were marked with moderation, liberality and justice. He freed all state prisoners, recalled all of those persons who were previously banished from the empire, forbade all prosecutions for treason, conferred free and independent power on the magistrates and distinguished the first eight months of his reign with generosity and nobility in the eyes of the world. # FEDS LOOKING TO BAIL OUT OF FREDDIE AND FANNIE

Fannie Mae's and Freddie Mac's days appear numbered. Reportedly both the White House and GOP are one on this plan. But what will replace them is causing a major controversy. The administration plans to phase out these government-sponsored enterprises but is reportedly still looking for a government role. Congress may get three options: Get the government out of the loaning business, offer limited guarantees or full guarantees. Even liberals seem to want to limit the fed's role in it all. Everyone across the political spectrum seems to agree that the current levels of 90 percent government-backed mortgage finance need to be reduced.

We the people are on the hook for \$142 billion to \$259 billion in bad loans but the housing market is more reliant than ever on Fannie and Freddie and they both back or own 95 percent of new home loans as private outfits have fled that scene. Unless there is a phase out, Fannie and Freddie will just keep getting bigger and send private firms running away from it. House Financial Services Committee Chairman Scott Garrett, (R-NJ) argues the focus should be on protecting taxpayers, ending the bailouts and getting private firms back in the housing market again. However, US Rep. Maxine Waters, D-CA insists that any reform needs to ensure "access to sustainable homeownership, at affordable rates, for the American middle class." She wants those 30-year, fixed rate mortgages maintained.

Lots of liberals warn of so-called "Radical Privatization," if government's role in the process were reduced. Sarah Wartell from the liberal Center for American Progress Action Fund thinks that would shut out more middle class families from homeownership.

According to a report in the Investors' Business Daily newspaper, "If Congress and the White House fail to agree on reform. The status quo, which nearly everyone says can't go on, could well continue."

Its snowballing throughout the Mideast and the army is getting involved. Gas prices are higher at \$3.17/gallon and the death toll is rising. Violence in Mexico is at an all-time high, as it enters the tourist areas like Acapulco. The death toll is rising here also with over 50 people killed.



# Just Say No, Period

As the debate continues over whether to raise the federal debt ceiling to \$14.3 trillion, most of us according to poll numbers have made up our minds. Don't even think about it. Since 1917, Congress has set a legal limit on the amount of money that the government can borrow. That limit is now \$1.4 trillion but our national debt is already almost \$14.4 trillion and the US Treasury says the ceiling has to go higher. Many Republicans are resisting the call, especially those Tea Party Republicans. If you listen to US Treasury Secretary Timmy Geithner, the whole world will collapse unless we do it.

Congress needs to address its spending urge which is a major cause of our economic

This year's budget contains an incredible \$3.8 million in discretionary spending and entitlements now represent 60 percent of spending. We are now about \$300 billion short of the ceiling and next year's debt should be \$1.5 trillion so here comes the limit. Geithner is pushing Congress to raise the ceiling or face disaster as the only alternative but the very opposite could be equally true if we just keep spending more and more money like it grows on trees.

The whole purpose for placing a debt ceiling on the nation back in 1917 was to control spending. Think of it this way, back 94 years ago, the U.S. government was a single-story ranch house. As we kept spending, it turned into a triple-decker and eventually has become a high rise apartment building. With no end in sight as how far up we can go. If we can keep building up, the whole purpose of the debt ceiling is history.





# Saint Peter Damian

Saint Peter was born about the year 988 in Ravenna. He was the youngest child of a large family; though his parents were of noble station they were poor. Peter was orphaned at an early age; he was cared for by his brother Damian, who was archpriest at Ravenna. Peter added the name Damian to his own in grateful recognition of his brother's kindness.

The child showed signs of great piety and of remarkable intellectual gifts. He made rapid progress in his studies, first at Ravenna, then at Faenza, finally at the University of Parma, where at the early age of twentyfive, he had already become a well-known teacher, both at Parma and Ravenna.

It was about the year 1035 when Peter decided to pursue an ascetic life, detached from the world. He encountered two hermits from the Camaldolese Abbey of Fonte-Avellana, which was located at the foot hills of the Apennines in Umbria. Encouraged by them, Peter, after a retreat of forty days, decided to enter the "silent life" as it is often referred to; he was accepted at the abbey where he received the monastic habit. Both as a novice and professed religious his fervor was remarkable, he was given to performing acts of penance, so much so that for a time his health was affected. He spent his convalescence studying Holy Scripture, on his recovery, he was asked to lecture to his fellow monks in neighboring monasteries. Saint Peter spent the next three years lecturing and writing; soon after his return to Fonte-Avellana he was appointed successor to the prior, becoming prior in 1043, a position he retained till his death.

Peter governed his monastery with wisdom and sanctity. He also founded five other hermitages; in which he placed priors under his care instilling in them the spirit of solitude, charity, and humility. Among them many became great lights of the church. He was for 12 years actively employed in the service of the church by many bishops, and by four popes successively, namely, Gregory VI, Clement II, Leo IX, and Victor II. Pope Stephen IX, in 1057, made him Cardinal-bishop of Ostia, a post Peter reluctantly accepted, as his heart remained always close to the "silent life" of the monastery.

In 1059 Peter was sent as emissary to Milan by Pope Nicholas II, where with Saint Anselm, Bishop of Lucca they strove to correct mishandlings that had crept into the local church. Peter confronted the problem and successfully re-asserted the authority of Rome. Unfortunately, on the death of Nicholas II, the same disputes broke out; and were not settled until 1066.

St. Peter was sent as legate by Pope Alexander II, to adjust the affairs of the church in Ravenna. Once again he settled a local crisis; this was his last undertaking for the church. On his return he was seized with fever near Faenza. He lay ill for a week at the monastery of Santa Maria degl'Angeli, now Santa Maria Vecchia. He passed on February 21, 1072. He is honored as patron of Faenza and Font-Avellano.

In 1823 Leo XII extended his feast February 23, to the whole Church and pronounced him a Doctor of the Church.





Oudinot began his siege with deception. He wrote General Roselli on June 1 that, though the armistice was over, he was deferring the attack on 'the place' ('piazza') until Monday, June 4. The gullible Roselli believed him, and, countering Garibaldi's plans to fortify the outer defenses to high alert, toured the outposts of the Villa Pamfili assuring the troops that they could relax until Monday morning. With Garibaldi too ill on the night of June 2-3 (he had been wounded in the side on April 30 but swore his doctor to secret treatment) to urge vigilance, the defenders manning the Pamfili/ Corsini outposts slept that night, the main point Oudinot targeted. At 3 AM, therefore, French troops penetrated the walls of the two villas with hardly a fight, and by the time Italian sentries fired their muskets, were pouring, wave after wave, into the Pamfili grounds. Half the 400 Italians there were captured quickly, while the other half tried to set a defense at Villa Corsini, closer to Rome's walls. Reinforcements from the city helped them hold on, but French artillery and superior numbers soon drove the defenders down the hill to the Vascello, a villa shaped like the prow of a ship. By morning light, the critical Villa Corsini, without which Rome could barely

When he heard that Rome was under attack, Garibaldi rushed from his sick bed with his several officers many in their twenties, most to lose their lives that day — to join his troops. Gathering his forces in the Piazza of St. Peter's, he led them to the Porta Cavalleggieri, contemplating where, with Corsini now swarming with the French, he could make a stand. All the bells of Rome were clanging the alarm, soldiers and their equipment flying everywhere, most headed for the Janiculum. Garibaldi with his Legion made it to the Porta San Pancrazio about five in the morning. Inside the walls, the Italian regiments were gathering to



PART THREE: The Seige Begins, June 3

prepare for the attack; outside the walls, and opposite San Pancrazio stood the key to the entire battle — the Villa Corsini, four stories high, perched like a fortress commanding the entrance to the city — now held by the French. Garibaldi judged that it had to be retaken, no matter what the cost. The cost would be great that day, June 3, when so many martyrs of the siege of Rome would die. This was due in part to the way in which the Corsini had to be attacked through a narrow gate and uphill 300 yards to a long staircase that allowed only a few soldiers at a time to run, and during which they were open targets for French sharpshooters. Even if the French had to yield the Corsini Villa, as they did several times that day, they could retire to the Pamfili grounds where a hollow provided cover for a new attack. With a force approaching 30,000 troops, they had ample reserves to do so. The Italian defenders under Colonel Galletti, meantime, had possession of the Vascello, at the bottom of the hill. They also had a battery at the Casa Merluzzo, left of the San Pancrazio gate, from which they could shell the Villa Corsini.

This became the crux of  $\,$  killed early. Angelo Masina

the pivotal battle on June 3, 1849. The Corsini windows, balconies and walls sprouted French soldiers firing at detachment after detachment of Garibaldi's legionnaires dashing for the narrow, deadly entrance gate, pouring through, and rushing up the narrow way to the villa. Then, the survivors of that murderous fire, if any

that murderous fire, if any, would storm up the double staircase, gain the balcony, bayonet the French in the drawing-room, and stand for a few minutes masters of the villa. Often the charge failed half-way up, from sheer want of numbers. But several times the Corsini was carried, and held for awhile, against the concentrated fire of a whole army in the woods of the Pamfili beyond. On one of these occasions the Garibaldians piled up their dead comrades in the open loggias on the west side of the villa, and repulsed the French attacks from behind that barricade. (Trevelyan, 175)

At 7:30 that morning, Garibaldi made his first announcement of several that day that the Corsini had been retaken. But it was soon lost again, and a new attack would begin. The losses on the Italian side were terrible: Garibaldi's chief of staff, Daverio, was killed early. Angelo Masina

was wounded and refused to go to the hospital until Garibaldi ordered him to; he was back in an hour with his arm in bandages. When the 900 Lombard Bersaglieri finally arrived (they had been held, against Garibaldi's plea for assistance, inside Rome by an order from the feckless General Roselli), Garibaldi sent one company to occupy the nearby Casa Giacometti, from which they could fire into the Corsini villa. Then he ordered most of the rest to capture the Corsini. Led by Luciano Manara and Enrico Dandolo, the Bersaglieri stormed the villa, only to be mowed down by the French firing from inside windows and behind protective walls. Rather than retreat, they took up positions and sought to trade fire in what was becoming a massacre. Enrico Dandolo was among the first to be killed. When Manara saw how hopeless his situation was, he ordered the retreat, but that turned out to be more fatal than the attack. As the Swiss volunteer Gustav Hoffstetter later recorded it:

And now as these de-fenceless men poured out of the garden, the deadly harvest began in earnest. At first I imagined that the numbers of men falling on their faces had merely stumbled in their haste over the roots of the vines. But their motionless bodies soon showed me the truth ... (Trevelyan, 179)

Having lost some of his best soldiers, Garibaldi probably should have fallen back for an artillery bombardment (indeed, many criticized him for not having softened the French position before ordering the Bersaglieri to attack). In part he did. But then he indulged in what has been called a 'piece of madness.' Finding a reserve of Bersaglieri inside the walls, he asked for a small party to engage in a "difficult undertaking." Though Emilio Dandolo, in charge, had just heard a rumor that his brother had been slain, he volunteered to lead. He later wrote:

"Go," said Garibaldi to me, "with twenty of your bravest men, and take Villa Corsini at the point of the bayonet." Involuntarily I remained transfixed with astonishment — with twenty men to hurry forward to attack a position which two of our companies and the whole of Garibaldi's Legion, after unheard-of exertions, had failed to carry ...

But the 19-year-old Dandolo obeyed the order and charged towards the Corsini Villa. By the time his little band reached the entrance, only twelve men remained. His account continues:

would twelve men do against a place occupied by several hundreds of the enemy? I had nothing left but to stoop to that which more numerous forces had already done — give the signal to fire, and then retreat. When we had got half-way down the road, S and I were both struck in the thigh by the same ball. We returned to the Vascello, six in number, in a deplorable condition, and with the conviction that the really extraordinary courage which had just been so conspicuously and recklessly displayed would have no effect, beyond that of showing the French that Italians were still capable of fighting with temerity, whatever the fortune of war might

Dandolo, severely wounded and out of action, dragged himself from post to post that afternoon, seeking his older brother. No one had the courage to tell him the truth until he entered the Casa Giacometti and found Luciano Manara and Hoffstetter beside the dead body of his brother, Enrico. Hoffstetter stepped away, while the Colonel grasped Emilio's hand:

"Do not seek your brother any more—it is now too late; I will be a brother to you." The young man, sick with wounds and grief, fell fainting against Manara, who carried him out of the room in his arms. (Trevelyan, 181-82)

The afternoon then proceeded with a fierce cannonade by the Italians from the Casa Merluzzo and the walls. The effect was to make an uninhabitable ruin of the Villa Corsini, its floors collapsing, the French trying to hold on. When fire from the French side slowed, Garibaldi ordered his last attack, with Masina's lancers in the vanguard, followed by now-General Galletti and Masina himself with bandaged arm. The horsemen made it up the slope and followed Masina galloping up the steps of the Corsini. Behind them, Manara and Garibaldi led the infantry in clearing the last of the French from the Villa, and occupied it. Cheers erupted at the gate below, and a mad rush by citizens, artists, gunners, and stray infantrymen charged the villa in a race to glory. A defense was hastily prepared in expectation of the inevitable French counterattack, which was not long in coming. And though the mob defended the Villa doggedly, before long the overwhelming numbers of French broke through the defenses, and the retreat was called. The Villa Corsini could be taken by the Italians, but it could not be held.

Can the police, without any information, randomly stop trucks on the road for safety checks.

COMMONWEALTH vs. WAYNE D. LEBOEUF, JR. APPEALS COURT OF MASSACHUSETTS No. 09-P-1529 2010 Mass App.

June 15, 2010, Argued • October 8, 2010, Decided

On March 10, 2009, Officer Strange was in the parking lot of a vacant restaurant performing administrative safety inspections. He observed a large, two-axle dump truck, operated by the defendant, traveling on Concord Street, a public way in Framingham. Believing it to weigh over 10,000 pounds, therefore qualifying it as a commercial vehicle under Federal and State regulations, he signaled the defendant, and requested that he hand over his license, medical certificate and the registration of the truck. The defendant was unable to provide a valid commercial driver's license and informed the officer it had been revoked. He was charged with operating a motor vehicle on a suspended license.

Here, the defendant claims that police use of random stops, not based on any reasonable suspicion of a violation of an administrative

regulation, to effect warrantless administrative safety inspections of commercial vehicles, violates the law. That precise question has not been addressed in our decision.

The Commonwealth's interest in the regulatory scheme is substantial, seeking to enforce the State and Federal regulations that will ensure safe operation of intrastate commercial vehicles on the public ways of the Commonwealth, by inspection of documents that reflect that the operator is properly licensed and able to operate the vehicle safely, by inspection of documents pertaining to the vehicle, and the vehicle itself, to determine that the vehicle is properly maintained and its cargo is safely carried. The statute furthers the Commonwealth's substantial interest in protecting from harm those who travel on or near its ways. ("the

interstate trucking industry is regulated extensively by both [F]ederal and [S]tate agencies. Federal regulations alone cover such things as drivers' qualifications, drivers' hours of service, inspection, repair and maintenance of trucks, vehicle parts and accessories, reporting of accidents, of itineraries, safe handling of cargo, transportation of hazardous materials, and a myriad of other issues").

This case says the police without and suspicion are authorized to stop any truck and investigate the truck, the driver and the cargo.

The police may not randomly without suspicious behavior or information stop passenger vehicles and interrogate the driver.

Judge Stanziani made that decision years ago when he was the Judge at the Chelsea Court.

that attack was Angelo Masina himself, abandoned in the confused retreat. His body, left lying a few yards from the steps he had charged on horseback, would remain there, his bleaching bones able to be recovered only well after Rome fell. Another renowned Italian

would fall late that day. Goffredo Mameli, the 21year-old poet of Genoa and author of the most famous hymn of the Risorgimento, Fratelli d'Italia (music by Michele Novaro), was wounded in one last desperate charge against the Corsini ordered by Garibaldi, one which Mameli, who had served till then as adjutant, begged to join. He did, and was wounded in the knee, lay for a month trying to recover, and died from the gangrene that had set in. That last attack also ground outside the walls, and Garibaldi's men in possesand the Vascello below. With-

The most bitter casualty of out the high ground, everyone knew, Rome's fate was

their lives in that fierce opening battle, 30 officers and 200 soldiers from Garibaldi's legion alone. Manara's Lombard Bersaglieri, often called the flower of northern Italy, also estimated their losses at 200. And though many conceded that Garibaldi himself had made several mistakes (he should have prepared his attacks with more cannonfire), he emerged from the June  $3^{rd}$  battle more revered than ever. He had given Italians a lesson in heroism, had inspired them to a day of martyrdom that would bear fruit, if not in 1849, then in the next decade. As Alfonso Scirocco notes, that heroic defense astonished Europe, turning "June 3 into the first of several events that made it increasingly failed, leaving the French in difficult to reverse the possession of the high momentum toward national unification" (Garibaldi, 165). It was this that Mazzini sion of the Casa Giacometti understood, and in the month of fighting that fol-

lowed, as more Italians lost their lives in what all knew was a noble but About 1,000 Italians lost futile defense of the indefensible, the inspiration they gave to the rest of Italy would prove to be enduring, invaluable. As Trevelyan puts it:

Some patriots, indeed, regretted that the defence of Rome was ever made since it was so spendthrift of Italy's treasure; yet the treasure was profitably spent. Because men remembered and told with pride and anguish the story of the uncalculating devotion of those young lives in this hopeless struggle, there grew up, as the years went by, an unconquer- able purpose in the whole nation to have their capital: there rose that wild cry of the heart — Roma, o Morte!

# Recipes from the Homeland

### CABBAGE AND PORK CHOPS

- 4 pork chops
- 1 medium onion chopped
- 3 ripe plum tomatoes or 8 oz. canned crushed tomatoes
- 2 dry bay leaf sprigs
- 2 small garlic cloves chopped (optional)
- 1 small head of cabbage
- 3 carrots
- 3 potatoes
- 1 cup of water
- 1/3 cup olive, canola or vegetable oil
- salt and pepper


In a twelve-inch saucepan, heat oil and carefully add pork chops. Brown chops lightly on both sides. Remove them from saucepan and set aside on a platter. Add chopped onion to the saucepan and simmer until onion is about to brown. Add bay leaves, garlic and cut-up or crushed tomatoes. Stir and cover. Simmer over low heat for about fifteen minutes.

Meanwhile, clean and wash carrots. Cut carrots into fourinch lengths and set aside. Peel potatoes and wash. Cut into wedges of one-inch thickness and set aside. Remove soiled or spoiled outer leaves of cabbage. Wash and cut into four or five portions. Set aside.

After tomato mixture has simmered for fifteen minutes, add one cup of water and stir. Add the chops and carrots. Cover and bring mixture to a slow boil. After ten minutes, add the cabbage. Ten minutes later add the potatoes. Additional water may be added if needed. Salt and pepper to taste. Cover and cook over medium/low heat until vegetables are tender.

NOTE: I remember that as soon as the cold weather replaced the warm days of summer, Mama changed her supper menu. The above is one of her winter meals. Spring is early this year and a few more cold days may be coming our way. You might enjoy this warm meal. At times, Mama substituted frankfurters or Italian-style sausages for pork chops. She boiled rice for those who liked it and served it topped with the vegetables and/or meat cooked in this meal.

# Nanna & Babbononno

A Nostalgic Remembrance

Well, it's Presidents' Week and I'm half way through a story about vacationing in the islands with friends back in the day. As a young man teaching school in Boston, I had the school vacations off including the 3<sup>rd</sup> week in February. Back a few years ago, it was called Washington's Birthday Week and many of my fellow teachers would head for ski country to vacation and maybe break an ankle trying to navigate the slopes of northern New England's snow covered mountains. I tried it once and hated everything except the social activities that took place at the ski lodges. Once I had discovered the tropics, that was the end of heading north to vacation. Last week's story involved my old friend, Sal Meli, whom I had grown up with in East Boston and a pal that I taught with. The three of us headed to Puerto Rico for the February vacation, basically to bask in the sun and swim in 80 degree Caribbean waters.

Before I ran out of space, I mentioned that we headed for a hotel casino and I tried my hand at gambling for the first time. The only other casino I had ever been in was at the Havana Hilton. Uncle Nick and Aunt Dorothy often took cruises during vacation time and in 1958, they headed for Havana during Easter week. As was often the case, I was invited seeing Uncle Nick was my Godfather. In '58, I accepted their offer and joined them and one of the side ventures was a stop at the Hilton's casino. I didn't gamble. Uncle Nick wouldn't let me. Well, it was the early '60s, Cuba was off limits and San Juan had taken over as the number one Caribbean stop for American tourists and Sal suggested the casino at the Caribe Hilton, one of San Juan's best hotels. I had beginner's luck, a phenomenon that only happens to a person the first time they try something.

We dressed back then. You couldn't get into most of the better places unless you wore a suit and tie. Once we were properly attired, we headed from the Hotel Normandie to the Caribe Hilton. After we entered the casino, I sat down at a blackjack table and tried my luck. As I said, I had beginners luck. No matter what I did, I won. If I had 18 showing, and foolishly drew a card, with the way my luck was going, I would have

drawn a 3 hit 21. I stayed at the table for quite a while and kept winning. At one point, I wanted to leave but drew 2 aces. I split the cards, bet everything I had and drew 2 kings, making double blackjack. When I finally quit, I had enough money to go on a Caribbean shopping spree and not think twice. The next day, we headed for St. Thomas. We actually had reservations at a long-gone resort called the Gramboco Inn.

Once we arrived and were settled in, the owner a woman who looked like a hippie, told us about the beaches we should visit. She saw the beginnings of our Puerto Rican tans and assumed we were sun worshipers. She was right and we rented motorcycles and were on our way to the local beaches. During the afternoon, we headed to the main street in Charlotte Amalie, St. Thomas' capital. For about a mile on both sides, there were stores of every type and description. I bought cartons of cigarettes for \$2.10 per carton. Handmade cigars for 50 cents each, assorted summer clothes, jewelry and perfumes for gifts and several quarts of liquor not on the market back home. The quota was 4 quarts packaged and an open bottle for medicinal purposes. I even bought a bottle of 100 year old cognac and French absinthe, which not long after, became illegal to distill or sell. At that point, Sal told me that he wasn't buying more than one bottle of liquor and I bought more to fill his quota. The one mistake was to purchase a bottle of Japanese scotch. I learned from that purchase, that if I was to buy scotch, it had to come from Scotland.

I only had one problem. When we flew to St. Thomas, we left some of our clothes at the Hotel Normandie and packed enough for a couple of days in St Thomas. We three then flew to St. Thomas. My suitcase didn't. I had just the clothes on my back. I basically needed a bathing suit. Neither Tom nor Sal were anywhere near my size, but I met some tourists from Belmont, MA, and one of the guvs lent me a pair of swim trunks. On the last day there, my suitcase arrived having been diverted to Rio de Janeiro by mistake. All was well.

We had an honor system bar at the Gramboco Inn. You made your own drinks and then paid what you owed at

the end of your stay. Each after noon we would discuss where we were going to go for dinner over a tropical drink. In the process, we became friendly with several naval officers who often utilized the hotel as their watering hole. There were a few of the sailors who were part of the compliment of men on the U.S.S. Thresher, a submarine stationed in St. Thomas. A few months later, the Thresher went down in the Atlantic with the entire crew losing their lives. I was very saddened when this happened.

Well, the trip to St. Thomas came to a close and we headed back to Puerto Rico a bit more tanned than when we left. Fortunately, my suitcase didn't head to South America this time around. Once back at the Normandie, our rooms were waiting for us along with passes to a private beach club, El Escambron. At the club, we met an American icon. This gentleman was in Puerto Rico promoting professional boxing among local athletes. Once we spotted him, we introduced ourselves. The big man smiled, shook our hands and said. "Hello, my name is Joe Louis." We were thrilled, and in conversation just referred to him as, "Champ." I would run into him again several years later in Las Vegas, but this was the first time and I was thrilled. Later that day, I called Dad and Babbononno to tell them about the chance meeting as they were both fight fans and Joe Louis had been their favorite heavyweight before he

That night, we headed out on the town, eventually ending the evening at an all-night deli called the Red Rooster. We met some people sitting at the next table and one of them turned out to be Dick Shawn, a Hollywood actor comedian, who would star in it's a Mad Mad Mad World the following year.

It was during this vacation that I developed a taste for Puerto Rican and Cuban food

Much of it was centered around marinated roast pork with sweet plantains, beans and rice with carmel custard and local coffee for dessert. I can still taste the garlic.

That Sunday, we flew back to Boston, deeply tanned and fully un-rested needing a day or so to recuperate. Once back at Logan, Tom's father picked him up, and as arranged, Dad was to pick up Sal and me. Actually, he and Mom drove past us twice. We were so tanned, they didn't recognize us. The third time, I flagged them down and they stopped. The February vacation was over, but I still remember it after all these years.

EXAMPLES OF FRINGE BENEFITS ENJOYED BY ITAL-IAN PARLIAMENTARIANS! We have, on occasions, described some of the unique benefits that members of the Italian Parliament enjoy. Each member is entitled to receive medical assistance to the tune of 11/2 million euro. There is also a budget that covers photo-op to all members at the cost of 302,000 euro. Then there is parking for the parliamentarians' vehicles at the cost of only 1 million euro. To park motorcycles, inside a garage, it costs another 33,000 euro. Among the suppliers of the Chamber's members there is an entrepreneur by the name of Angelo Jacorossi the former "king of the Roman Oil," who was once kidnapped by the "Kidnapping Anonymous," in the 1970's, and also being investigated in the 1990's. To update the TV satellite channel of the Chamber, two consultants were hired: Rosaria Marchese (paid 40,000 euro), appointed by Minister Bondi, the chairman of the "Cinema Commission," and Gustavo Pacifico (paid 50,000 euro) in charge of editing of the Stream Channel 2, in which appears "Big Brother." All the care for the artistic activities at Montecotorio and organization of exhibits are under the care of architect Cristina Mazzantini (paid 100,000 euro), who is the wife of Pier Ferdinando Casini!

THERE ARE TOO MANY PROVINCES IN ITALY! Some of the new organized provinces in Italy, as well as some of the old ones, may be dissolved and for a good reason: low population in each provincial territory. All the provinces with a total population under 220,000 inhabitants may soon disappear, merging with adjacent provinces. Here is an example of "doomed" provinces: Biella in Piemonte Region, Fermo in the Marche Region, Ascoli Piceno also in the Marche Region, Matera in Basilicata, Crotone in Calabria, Isernia in Molise, Rieti in Lazio, Massa Carrara in Toscana, and Vibo Valentia in Calabria.

TOO MANY PARLIAMENTARIANS IN ITALY. For quite some time there has been in Italy a long running argument to reform the Constitution. Many of you may know that the Parliament is quite "crowded." The lower Chamber, the "Camera dei Deputati" (the Chamber of Deputies) has 630 members (in the US we have 435 members). "Il Senato" (senate) has 315 elected members (half the chamber) and another "seven" members appointed by the President and the Parliament. They are outstanding people who have distinguished themselves in their fields, literary or scientific, or former Presidents, and are appointed for life. If you now compare Italy with our much larger country, you realize that there is a dire need to "shrink" Italy's Parliament. So far, however, hypocrisy has won the day, for the simple reason that the top political leaders don't want to see their friends lose the "post" and want to stick with it. In short, Italians love political profession!

### Ray's Number Hanging High

Former Mayor Ray Flynn, a former star guard at Providence College in his pre-political life, had his Friars jersey retired during a game against Cincinnati at the Dunkin Donuts Center in Providence. Flynn's number 14 was hoisted to the rafters along with number 10, which was worn by his backThe 1963 grads will join the likes of former Celtics and Lakers guard Ernie DiGregorio and 9-time NBA All-Star Lenny Wilkens already hanging in those rafters.

Back in the day, Ray scored 1,000 plus points, averaged 128.9 points and helped lead the Friars to two NIT titles in 1961 and 1963 and was called by those who watched him play as one of the greatest outside shooters in the history of Friar basketball.

### The "Minute Man" of Negro Leagues Cecil Kaiser Dead at 94



Cecil Kaiser, a little lefthander who made \$700 a month at the height of his Negro Leagues career in the 1940s, died on Valentine's Day at age 94. Kaiser grew up a Yankees fan in New York but with his path to the majors blocked by segregation, the 5-foot-6, 165 pounder played outfield with a number of sandlot teams and eventually ended up with the Pittsburgh Crawfords and the Homestead Grays in the Negro Leagues. According to the Negro Leagues Baseball Museum, Kaiser first played for the Crawfords as an outfielder but after a number of pitchers were injured, he was sent to the mound. Despite his size, he became known as a strikeout artist whose fastball was mixed

yard partner Vinnie Ernst. with good off-speed pitches. He was nick-named "Minute Man" because it He took him only a minute to strike out a batter. This past January, he attended the opening of a Negro Leagues exhibition at an art museum in Muskegon, Michigan. At the event, he informed folks that he played baseball with legendary players such as Satchel Paige and Josh Gibson. He relayed to the Muskegon Chronicle just a month before dying that, "They're pretty much all gone now; not too many are left.'

> In 1947, he was making \$4,700 a month for the Grays with whom he played through the 1949 season. Perhaps his best year of winter ball came in 1949-50 when he pitched with Caguas, in the Puerto Rican League, where he posted a league-leading 1.68 ERA. After losing his power at the plant due mostly to his size, he left pro-baseball and ended up with the Ford Motor Company team in the Detroit Industrial League. According, once again, to the Negro Leagues museum, "Certainly, we will remember him fondly, remember the contributions he made, not only in baseball."


