# Fare Increase for the Disabled Unfair

If you depend on the MBTA's **The RIDE** service and I know many of my readers in the North End, East Boston, and surrounding communities do - you are probably worried about the proposals to cut MBTA services and raise fares. The potential for a 500% increase, to \$12 per ride, is, and ought to be, frightening to Americans with disabilities living on a fixed, and often very limited, income. The detailed proposals from the MBTA are extremely complex and are written in a technical jargon that is nearly impenetrable by the average citizen.

Here are the facts, simply stated.

The MBTA is required, by a federal law, to provide the RIDE service. When President George Bush signed the Americans with Disabilities Act into law on July 26, 1990, he said: "It signals the end to the unjustified segregation and exclusion of persons with disabilities from the mainstream of American life." He went on to compare it to the Declaration of Independence. So in spite of any rumors you hear, the "T" is not proposing to end the RIDE. Nor are they going to limit the RIDE to only doctor's visits. The law requires that the RIDE provide service "comparable to ... public transportation services provided to individuals without disabilities." It would hardly be comparable service to tell the disabled that you cannot use the RIDE to visit your grandkids, go marketing, attend church or synagogue, or go to the theatre or sporting event, when persons without disabilities can do all those things on a bus, sub-

way, or trolley. The T, however, does have two specific proposals to increase the fare for using the RIDE. Currently the fare is two dollars, which it has been since 2007. To understand the proposals, first you must understand that there are two components to the RIDE. First there is the standard service that the Americans with Disabilities Act requires. Secondly, there are additional services (what the MBTA calls "Premium Service") that go beyond the requirements of the law. Tens of thousands of disabled persons in the greater Boston area depend on both the standard and "premium" services.

The T is required to provide the RIDE service for any trip that is within 3/4 of a mile of a bus, subway, or trolley line and for the same hours operation as the bus, subway, or trolley line. The fee is limited to not more than two times the cost of a subway ride. Finally, to get this basic service you must book the trip at least the day before.

Currently the RIDE goes to many more places than just those within 3/4 mile

of a regular T route. In some places you may take the RIDE earlier or later in the day than when the buses run. Finally, the T does its best to accommodate "same day" requests. These are the so-called "premium services" that will have large fee increases under the MBTA plans. The standard service will also go up in price.

Under MBTA Plan #1 the standard service will have a 125% fare increase, to \$4.50. The "premium" services will have a huge 500% increase to \$12.

Under MBTA Plan #2 the standard service will increase to \$3 and "premium" services will increase to \$5.

Neither plan, as far as I can tell, calls for eliminating any RIDE services, but the proposed fare increases could put the RIDE out of the price range of many current users.

Fare increases for the RIDE under Plan #2 are not as high as under Plan #1, however, Plan #2 also calls for eliminating over 100 bus routes, including the #120 and #121 buses (East Boston), which could result in more RIDE trips falling into the more expensive "premium" category (due to no longer being within 3/4 of a mile of a bus route). 

## COMMODUS ... THE BASTARD RULETH

Commodus had not only developed the habit of drinking all night long but often wandered through taverns and brothels, squandering the resources of the Roman Empire. Even the selection of provincial rulers was made from among his criminal companions, or was recommended by them. He so detested the Senate that he vowed to destroy all of them, consequently, some senators formed a conspiracy against him. The fool who was sent to perform the assassination betrayed the plot by forecasting his intention before performing the deed, and was quickly overpowered. Needless to say, this set off a round of executions.

Meanwhile Saoterus, the lover of Commodus, became more powerful than the officers could endure. He was escorted from the palace through a ruse and assassinated. Commodus, who was now angered more than he had been concerning the attempt on his own life, started a wholesale purge of the Praetorian Guard, exterminated one entire family named Quintilii, and a number of high ranking officials. After this incident, Commodus appeared in public infrequently, performed few, if any, of the duties required of an emperor, and

even processed written messages through his secretary Perennis. The emperor was now easily persuaded to devote himself to pleasure while the secretary assumed all of the burdens of the government, and of course the power that went along with those burdens.



Boston Police Investigating Phone Scam Targeting Elderly Residents: Company Called GE Security Systems Going Door-to-door Using Mayor's Name to Promote Free Installation of Home Security System

The Boston Police Department is investigating two consumer scams targeting Boston residents. Several victims have reported to police receiving a phone call from number 702-330-9199 and other similar numbers. Victims are then told by the caller (suspect) that they have won a prize which includes a large amount of money, a new car or property. Victims are then instructed by the caller to go to a local convenience store and purchase a Green Dot Money Pack (reloadable credit card). After the reloadable credit card is purchased, victims are instructed to contact the caller (suspect) and provide the serial number to the prepaid card. Once that access to the account and the money. Officers would like to take this opportunity to alert potential victims that there is no prize. This is a scam.

The Boston Police Department encourages individuals who receive phone calls of this nature to call 911 immediately. Victims should never send money or give personal information to an unknown individual and should instead immediately contact police.

# Saint Brigid of Ireland

Saint Brigid, (also called Saint Brigit) known as the second Patron of Ireland, was born in County Louth near Dundalk about the year 451. She was born of a noble family and is said to have been baptized by Saint Patrick. Brigid, from her youth, showed signs of sanctity; she received many offers of marriage but refused them all to become a nun. Saint Brigid is celebrated for her

generosity to the poor. Brigid received the veil from Saint Macaille and was professed by Saint Mel of Ardagh who is believed to have conferred on her abbatial powers, that is, the powers reserved for an abbot or abbess.

Brigid, with a small group of nuns, went to Druin Criadh where she founded the first convent in Ireland, her famous Convent of



Cill Dara, (the church of the oak) now Kildare, over which she presided for many years. St. Brigid's small oratory at Cill-Dara became a center of religion and learning, and eventually developed into a cathedral city. It is reported that she chose St. Conleth "to govern the church along with herself"; thus for centuries, Kildare was headed by a double line of abbot-bishops and abbesses, the Abbess of Kildare

being regarded as superior general of the convents in Ireland. It was from the Scriptorium at Kildare that the illuminated Book of Kildare was created, a magnificently illuminated Book of Gospels that disappeared during the Reformation.

Saint Brigid founded two monastic insti-






















# The Wally Bowe/Salesian In-house **Basketball Tournament Begins**





# A Slice of North End History

## After 105 Years, Parziale's Bakery Still Going Strong Thanks to Family and Tradition

100 years ago, one can head down to Prince Street and walk into Parziale's Bakery. The Parziales have been baking bread in Boston since 1907, when Giuseppe "Joe" Parziale came from Italy with his wife Anna and opened a small bakery on Charter Street. Many things in the neighborhood have changed since then, including the bakery's address — which is now 80 Prince Street — but the Parziale family still churns out crunchy loaves of Bastone just like it did back in the day. "The bread is made the same way my grandfather used to make it," says Augustine "Augie" Parziale, the third generation of the family currently running the bakery. "We don't use any preservatives and we let the dough rise twice before placing it in the oven."

The recipe is the same one grandfather Joe brought with him from the province of Naples, but Augustine learned to knead and bake bread from his father Arcangelo, better known as Angelo. "I didn't get to know my grandfather that well," says Augie. My father was given the bakery that year as a wedding gift when he married my mother Brigitte. I was a teenager when he passed away, and my parents had been working in the bakery since 1933." Between then and 1950, Angelo and Brigitte had five children: Sandra and Augustine. "You drizzled in fine extra virgin

To taste what bread was can say we grew up in the like in the North End over bakery," says Augie. "As a boy, I'd be in here every chance I had, throwing dough around or helping out with whatever needed to be done. It was my life. Then I got married and took one of the apartments over the bakery, so it was really easy to go from home to work."

Augie took over the family business in 1986, when his mother fell sick. Now that he is older, though, he has left many of the bakery's daily operations to other members of the family, stopping by around 4:30 in the morning to check how things are going. "It's all about family," he says. "Family is the most important thing in a business like this. It's a hard life, so you need family to keep going. I used to work with my brother Ferdinand until he passed away in 2002. Now it's up to my children, my nieces and my nephews to carry on." Augie's eldest son, 37-yearold Augustine, recalls the days he'd sneak in as a kid to take in the smell of fresh bread in the morning. "I loved it in here. People come in at all hours for our bread," he says. "We're closed only between 6:00 p.m. and 10:00 p.m., then we re-open to start working on the next day's bread. You'd be surprised to see how many people, like cab drivers, stop by during the night just to get a loaf of bread." Augie's other son Aldo, 30, prepares the renowned Parziale to-Ferdinand, Anne, Loretta, mato and cheese pizza,

olive oil and works at the bakery's two ovens alongside his cousin Matthew. At the front, Augie's niece Maria takes care of sales.

Although Parziale's is known for its bread, it also serves pastries, cookies and muffins, as well as a few specialty breads. "The shop actually used to sell all sorts of groceries when I was a child," says Sandra, one of Augie's sisters. "It was a long time ago, but we sold cold cuts, coffee, tomatoes... you name it. Then the bread business picked up and we focused just on that." Sandra, who still lives in the North End and often goes to Italy to visit the land her grandparents came from, was not as involved as her brother Augie in the family

business growing up, but she never managed to let go of the family's passion for bread. "I still go to the bakery every Saturday to lend a hand," she says, "and I make my own bread at home. When I was younger we'd have a stand selling our bread during St. Anthony's Feast. I used to do that all the time. Then we stopped doing it, but now the boys have picked up that tradition again, and I think it's been three years we have had a stand at the

feast." Sandra is now working with her niece Patty on a new and revamped website.

In 2007, Parziale's Bakery



celebrated its 100th anniversary with Mayor Tom Menino, who distributed free bread alongside Parziale family members to hungry passersby. On that occasion, the mayor placed a commemorative plaque right in front of the shop's entrance, and had a sign attached to the street light just outside. Pictures of the event, as well as old family photos, are hanging today at the store windows, narrating the long and ongoing family history. The best testimony to the Parziale's long history, though, remains their bread, a 105-year-old North End tradition that lives on.

city was slowly edging forward but at times it looked like two steps forward and one step back. Racial tensions growing in several city neighborhoods slipped over into politics as Hicks became the voice of discontent for many and White attempted to be that voice of reason. He finished runner-up to Hicks that September but beat her in November to win the job of mayor.

He would go on to get elected three more times and evolved over the years into whom some consider the first modern mayor of Boston. You know that old song about being part country and part rock and roll? White was part oldschool Boston politics. Both his father, grandfather and father-inlaw all served as City Council President. He obviously had politics in his DNA. He loved it. However, he also had a leadership vision of trying to make Boston the best it could be. One of the slogans used to describe him stated that he was "A Loner in Love with his Angelo Picardi and Mayor White singwas in love with his city.

Boston in the Seventies went through much racial turmoil as outside forces demonized the ethnic neighborhoods of South Boston and Charlestown. Court-ordered busing divided the city and the mayor was called upon time and time again to hold the city together. He succeeded for the most part. Many called him a polarizing figure but he really wasn't. I always say Boston elects the mayor it needs at various times in city history.

Boston Herald columnist Peter Lucas poked fun at him calling him "Mayor of America" and "Kevin DeLuxe: Anti-Busers would call him Kevin from Heaven. With all transparency, I was a Joe Timilty guy through White's first three terms as mayor. However, by 1979, I actually supported his re-election bid. I remember writing a newspaper column explaining my change of heart over him. A short time later I received a note from the mayor saying it was about time I supported him. He appreciated that I was always fair to him in my criticisms.

Looking back now, I think he would have made a good governor and I am sure he would have been good at any office he sought because he put 110 percent into everything he did. I also remember my mother met him one year after he left the Mayor's Office. He was glad to see my mother remembered him and told him she always voted for him. She also told him I was her son. My mother told me he laughed at getting that news and told her I was a great newspaper writer especially when I said good things about him.

watch the Columbus Day parade march by him. We talked for a while about the old days when he and I were younger. We talked about Charlestown politics. We talked about how great Boston grew under his helm and that of Ray Flynn and Tommy Menino who followed him into office. We hugged each other and made our goodbyes. Too many people saw him as stand-offish but he really wasn't that guy at all. He had great wit and a great smile that he often used as a political tool when necessary.

Many people in my generation learned so much from him. You need to be serious when you have to be but you need to be able to laugh during your struggles too. Was he bigger than life and my answer would be in the negative. He wasn't bigger than life but he used his time well and for a purpose.

There was a quote in the newspaper recently by former City Councilor Larry DiCara, "It's a sad day for Boston ... he deserves a (10-foot statue across from City Hall) statue that is bigger than life." I disagree with my friend Larry, the statue is too big and out of reach. This mayor was never distant from the city; he had an intimate relationship with all parts of it. He was approachable, funny and proud to call himself a Bostonian.

Recently, as US Senator John F. Kerry stood gazing at the Kevin White bronze statue, an 8-year-old boy stood next to him doing likewise. Kerry asked the boy, "Do you know who this is?" The little boy answered, "A famous man." I would like to add, The last time I spoke with him and a man with a vision for tomorrow. his wife Kathryn was under the His eyes always fixed on the future. 

PINO DANIELE LIVE IN BOSTON - Saturday, June 9, 2012. Pino Daniele is an influential Italian jazzfusion guitarist. From the beginning of his career, it was evident that his passion lay in rock and blues. Greatly influenced by his own cultural background, his music was a successful fusion of tradition and modernity. His solo debut, Terra Mia, sung in Neapolitan, was the first example of what Daniele called "taramblù," a combination of tarantella, rhumba, and blues. In 1979 his self titled record was released, followed by Nero a Metà in 1980, and that same year Daniele was invited to open for reggae superstar Bob Marley for his show in Milan. In 2005 Daniele released Iguana Café. Between 2005 and 2010. Daniele released three more studio albums: Il Mio Nome e Pino Daniele e Vivo Qui, Ricomincio da 30 and Electric Jam. In 2010, Daniele released his 13th studio album, Boogie Boogie Man.

Thanks to the lovely, brilliant Lisa Cappuccio of East Boston we learned how many saints the Catholic Church recognizes. In brief, there are about 2,500 saints with feast days, 200 fewer than in the earlier years of the twentieth century. In 1969, the Vatican removed the feast days of over 200 saints from the liturgical calendar because they were of only regional interest or because they were no records of whether the saints had lived. Among the saints affected were Saint Valentine, patrons of lovers, and Saint Christopher, patron of travelers.

Reminder! This year Valentine's Day, February 14 falls on a Tuesday. So remember, to send me a Valentine.

Millions of Americans may have an alcohol problem without realizing it. A new report by the Centers for Disease Control and Prevention shows that one in six people binge drink about once a week. For women, binging is downing at least four drinks in a sitting, and for men, at least five. But the survey of 458,000 people found that bingers actually consume much more — an average of nine drinks in one night for men and six drinks for women. The results are "alarming," the CDC's Robert Brewer tells WebMD.com. Excessive drinking causes roughly 80,000 deaths per year — often through car wrecks, violence and suicides. Young people between the ages of 18 and 34 are the most likely to binge drink, but people 65 and older who overindulge do so more frequently — as often as six times a month. And most binge drinkers don't consider themselves alcoholics, since they get fall-down drunk "only" once or twice a week, instead of every day. "If it is acceptable that this many adults are binge drinking," says study co-author Dafna Kanny, "we have a problem in this society."

Heavy drinkers have what is known as saloon arthritis — every night they get stiff in a different joint.

Our distinguished and stately musicologist Albert Natale reports violins crafted by the Italian masters Antonio Stradivari and Giuseppe Guarneri some 300 years ago are legendary for their exquisite sound, but they may not be worth their high price tags. When researchers brought two Stradivariuses, a Guarneri and three new instruments to an international violin competition and asked blindfolded violinists to play them and rate their quality, one of the new models emerged as the clear favorite. The oldest Strad consistently ranked worse than the others in terms of tone, projection, and general playability. "There was no evidence that people had any idea what they were playing," Michigan violin-maker Joseph Curtinb tells NPR.org. And yet the combined value of the old violins was roughly \$10 million; the new ones together were worth about \$100,000. Like wine-which people often think tastes better if they know it's expensive or from a vaunted vineyard-we may perceive added beauty in music that comes from a prestigious violin. "I don't think there are any secret" to the sound of a Strad or a Guarneri, says acoustic physicist Claudia Fritz, "except in people's minds."

## MOLIGNANA PIENA

#### Baked/Stuffed Eggplant in Tomato Sauce

- 6 small eggplants 1 cup unflavored bread
- crumbs
- 2 tablespoons grated Romano cheese
- 6 minced Sicilian green olives
- 1 can anchovies chopped

#### \*TOMATO SAUCE

- 1 28 oz crushed tomatoes 1 onion chopped
- 1 stalk celery chopped 1small onion chopped
- 1 large garlic clove chopped or minced
- 2 tablespoons capers
- 3 tablespoons olive oil
- 1 baking dish
- 1 garlic clove shopped (optional)
- 3 tablespoons olive oil

In a sauce pan, heat olive oil and add onion to simmer. Stir in garlic (optional) and stir to keep from burning Add crushed tomatoes stir and bring to a slow boil. Add some water and stir. Cover and simmer at least thirty minutes. Stir occasionally to prevent from sticking.

Remove stems from top. Wash outer skin of eggplants. Cut each in half. With a sharp paring knife, in a circular motion cut out part of the center portion of eggplant. Cut up each removed portion into small pieces and place in a bowl with the bread crumbs. To bowl add cheese, capers chopped garlic, celery, onion, green olives and anchovies. Sprinkle a little olive oil over contents in bowl and mix thoroughly. (Keep in mind that Capers and anchovies are salted.)

In a skillet, heat olive oil. Place breadcrumb mixture into skillet and stir for a minute or two as it blends and softens. Remove skillet from heat. Cool. Using all the mixture, with a tablespoon fill each eggplant cavity.

Heat olive oil in skillet and place the six eggplant halves skin down in skillet. Simmer skin portions of eggplant for a few minutes, being careful not to burn. Remove from heat and cool.

Spoon some tomato sauce into bottom of baking dish. Place stuffed eggplant portions in baking dish over sauce. Sprinkle grated cheese over each eggplant half. Add more tomato sauce over stuffing. Cover and bake in a preheated 275°F oven for about thirty minutes. If drying too much, add additional sauce or a little water to baking dish. Uncover and return to oven for about two or three minutes to brown on


\*Remaining sauce can be served with pasta of choice or save in a container in your refrigerator or freezer.

A Nostalgic Remembrance

Last week, I left off leaving Florence to head to Venice. As we drove northeast, the scenery changed a bit and the temperature was a little cooler. Northern Italy seemed more like Switzerland or Austria than the Italy we had experienced in the south. If you want to know the truth, I felt more comfortable in the south. The people were more friendly and outgoing, and we physically blended in much better. Once we finally arrived in Venice, we had to leave the car in a lot on the mainland as there are no drivable streets in Venice, only waterways.

A travel service near the car lot booked us into a pensione, a small bed and breakfast and we headed to the dock to take the bus. Oh, by the way, the busses in Venice are called vaporette. They are boats that stop at various locations (bus stops) to take local people to their neighborhoods. We had just missed the bus going our way and decided to hail a taxi. Taxis in Venice are speed boats. We piled our belongings in the rear of the six passenger craft, and off we went.

When we arrived, I found the resort interesting. Although we were on the coast, the building looked more like a mountain chalet and the owners spoke a dialect of Italian that seemed punctuated with words we didn't understand. I said to Franny in English, "Dorothy, this doesn't look like Kansas." Sal and Jose understood what I meant, all having seen the Wizard of Oz.

It was late afternoon and time for dinner. We were tired and decided to eat in the dining room of the pensione, study the map of the city and then head out later to explore and have a cup of coffee. What surprised me was that there were only one or two pasta dishes on the menu. I ordered a lamb shank and it came with a salad, vegetables and rice. When the bread basket was placed on the table, a slab of butter accompanied it. We hadn't seen butter since we ate in an American restaurant in Naples. The wine was a lot lighter in flavor that the southern wines we had become accustomed to in our travels, and I noticed that there was as much beer being served at other tables as there was wine.

After relaxing a bit, we decided to take the nearby vaporette to St. Mark's Square, the center of Venice. The square was filled with tourists and pidgeons. Gondolas were docked at the edge of the water along with taxis and couples and families were waiting in line to take romantic cruises through the canals. We found an interesting trattoria, sat outside and ordered coffee and drinks. For the next hour or so, we watched the tourists parade by. I heard people speaking French, German, Dutch, Flemish. Spanish, English, Portuguese, Arabic and Japanese. I was fascinated.

Before going to bed, I decided to call home. With a six hour time difference, bed time for us was late afternoon in Boston. Babbononno answered the phone. "Allowe." I responded with, "Buon giorno, Babbononno." He replied, "Jonny, you cumin-a homma?" I told my grandfather where we were and it would be a couple of weeks before we were heading back to the states. I then described our travels north to him and he listened eagerly, not having seen his homeland since 1896, 76 years earlier. We talked for a bit and then Mom and Dad got on the extension phones when they discovered I was on the phone. Everything was OK at home and that weekend, they were all taking off for Maine. That meant that if I had to get in touch in an emergency, I would have to call one of the neighbors in Maine as we didn't have a phone at the cottage. (What did we ever do before the invention of cell phones???)

The next day, we headed back to St. Mark's Square and visited the mansions, estates and museums that were built during the Renaissance and later. Most were beautiful, ornate and reflected Venice being one of the financial and business centers of Europe back in the day. Our next stop was St. Mark's Cathedral with its golden altar and famous bell tower. Atop the tower are bronze statues of people that move on the hour. They revolve around the top of the tower, turn and hit bells with giant hammers signaling the time of day. We decided to climb to the top. Unfortunately for me, it was at noon time. Just as we reached the

top, the statues began signaling via the bells. My head didn't stop vibrating for a few hours and my ears rang all

We had a snack at a café in St. Mark's Square and then headed for a vaporette that would take us to the Island of Morano. This was the location of several factories that made crystal objects for the world, glasses, goblets, dishes, decorative pieces and chandeliers. Once on the dock of Morano, we stopped in a tourist office to book ourselves a tour of one of the factories. Luckily, one had an opening within minutes. The owner greeted us at the entrance and apologized stating he would have to conduct the tour himself. All but one of his employees were on vacation. One glass blower was still there and would show us how to make glass objects.

The owner spoke perfect English. I thought he might have been an American who moved to Italy or an Italian American who returned home. That's how perfect his English was. When he used words with "ed" at the end, I discovered that he wasn't American, only someone with a good ear for the language. He pronounced the ed at the end of words like cooked or worked: cook-ed or work—ed. The man gave us the grand tour and his glass blower made a cowboy on a bucking bronco out of molten glass as we watched. He presented it to Franny as a gift. When it was time to leave, I tried to tip the owner, who refused saying, "Please, if you want to tip someone, take care of my glass blower. I did.

As we were leaving, a group of English tourists were the next in line to see the factory. The owner greeted them with a perfect British accent. Overhearing this. I marveled at his capacity with our language.

Venice was fascinating, but it was time to head back to Cassino and Franny's family at the farm. When we returned, I discovered that there were other family members who had dropped in for a few days, and Sal and I decided to check in at a local hotel, the only one in Cassino with a swimming pool. The owner turned out to be someone who had been deported from the U.S. He used his ill gotten gains to open a hotel and go on the straight and narrow, but that's a story for next week.

arrow. Anyone who ridiculed him was thrown to the wild beasts. One fat person was cut right down the middle of his stomach so that his intestines gushed forth, while some men were given a new name of "one-eved" after he plucked out one of their eyes, and still others he named "one-foot" after he cut off one of their feet. In addition to this, he murdered many other persons, some because he didn't like their garments or manner of dress, others were slain because they appeared noble or handsome. At one time he even bled men to death with scalpels as he played at being a surgeon.

During his reign, many men were able to secure punishment for their enemies by bribery, or even to buy immunity for themselves, a change of punishment, or a substitution of another person for one who was condemned to death. He sold provincial governorships, administrative posts in the city, and he even sold results in lawsuits. Finally, to show his impartiality, even his top city officials were either poisoned or introduced to the point of his sword after a few months in office.



THE NATIONAL MUSEUM OF EMIGRATION INAUGURATED BY THE ITALIAN PRESIDENT, GIORGIO NAPOLITANO.

Twenty nine million Italians left Italy from the year 1800 in search of a job and a better life. The Italian President recently inaugurated the Museum in Rome, at the Vittoriano (the monument complex to King Victor Emmanuel the Second). 
