Consalvo Aims for More Affordable Housing

Boston City Councilor Rob Consalvo has just been re-appointed to the city's Neighborhood Housing Trust. The trust is responsible for allocating the city's linkage monies to organizations and groups seeking assistance in building affordable housing. The trust works to increase the supply of such housing. Consalvo has been a trust member since 2002. Said Consalvo, "In this role, I will be able to continue the working partnership with many worthy organizations as we attempt to provide more affordable housing opportunities in our City."

Since its inception, the trust fund has helped create or preserve over 6,000 affordable housing units. Housing is a priority issue for Consalvo who also was just reappointed as the chair of the City Council's Housing Committee. As Consalvo concludes, providing safe, quality, affordable housing is one of the key issues to making our city a great city. To be able to work on that is one thing I love.

The Real State of the Union ... By the Numbers

Now that the mainstream are, but most of us are not. media is hopefully done swooning over President Obama's State of the Union Speech, some of us are more concerned about the real State of the Union, by the numbers. It's not what he said or did not say, nor is it how he said it. It should be about our national security and our national economic health.

after the The day president's State of the Union speech, an appliance installation and repair man was installing some new appliances in our home. Unsolicited, he said he had a hard time sleeping last night after hearing the president's speech. When I asked why, he said he did not hear anything in the speech that made him feel that America is safer as a nation, nor did he hear anything that would really help grow economy.

No wonder the man doesn't sleep.

I told him I agreed with him, and that he expressed the feelings of probably most of us who are not intoxicated by the president's words and his delivery. Many people

Maybe there are some provisions in the START Treaty that regular folk like the repair man and I don't know about. But it appears as if the Russians got a better deal by limiting our ability to deploy missile defense systems in other parts of the world, where a lot of our enemies are located. For example, cancellation of the missile defense system being built in Turkey does not seem like a good idea. The world is not safer! And we

have reduced our ability to

help keep it safe.

Gross Domestic Product did grow year over year in 2010 by 2.6 percent. But China's economy grew by around 10 percent, which means, at those comparable rates, China's economy will surpass us 15 to 20 years from now. Since China holds the largest percentage of our foreign-held debt, I consider that a national security threat as well as a threat to our financial stability.

In fact, the total amount of U.S. Treasury Securities held by foreign countries increased 18.5 percent in 2010 (Treasury.gov). That's not a comforting sign.

Total bankruptcy filings were nearly 14 percent higher in 2010, on top of the 1.4 million fillings in 2009. It should be no surprise that the unemployment rate remained between 9.4 and 9.8 percent throughout 2010, and that the weekly new jobless claims were around 400,000 per week nearly every week. The small number of "new" private sector jobs has simply not been enough to offset that pace of joblessness.

A year ago, in the president's State of the Union speech, he said that creating jobs would be a top priority. In early 2009, he said that the nearly \$1 trillion in stimulus spending would keep unemployment under 8 percent and grow the economy.

The unemployment rate has not been below 9 percent since the stimulus bill was passed, and I guess it de-

Stirpe Nostra

PIUS TIBERIUS

Tiberius Claudius Nero Ceasar, second emperor of Rome, was the third of the twelve Caesars and was also the third member of the Julio-Claudian line. He was born on the Palentine Hill on November 16, 42 B.C., the son of Tiberius Claudius Nero and Livia. His mother Livia later married Augustus. His father died when Tiberius was only nine years old and at that young age he eulogized his dead parent from the rostrum in the Forum. While in his early teens he and Marcellus accompanied the chariot of Augustus in the triumph at Actium (the defeat of Marc Antony and Cleopatra).

At a later age Tiberius married Agrippina, the daughter of Marcus Agrippa the army general, statesman and builder of the Pantheon. They lived happily for a few years but he was forced to divorce her and to contract a hurried marriage to Julia, the daughter of Augustus, an act he regretted for the rest of his life. His marriage to Julia soon cooled to the point where he ceased to live with her.

His first military service was as a tribune of the soldiers (commander) wherein he led a campaign against Armenia and Parthia, and was responsible for resettling forty thousand prisoners of war into new homes along the Rhine. He returned to Rome riding in a chariot, honored with the Triumphal Regalia, a new kind of distinction never before conferred upon anyone. His popularity mounted and in time he held the offices of quaestor (public prosecutor), praetor (chief magistrate), and consul (one of the two highest magistrates).

During the height of his success Tiberius withdrew from political life, asking for leave of absence because of weariness of office and a desire to rest. He made a hasty departure from Rome and settled in Rhodes for about seven years. He returned to Rome and took up residence on the Esqualine Hill where he attended mostly to his personal affairs and exercised no public functions. Claudius was adopted by Augustus along with Marcus Agrippa a great military

commander and also the builder of the Pantheon. The practice of adopting adults was not uncommon in Rome during imperial times.

During a revolt and ensuing three year war with Illyricum, Claudius was given command of fifteen legions plus an equal number of reserve forces. His perseverance was amply rewarded by a complete victory over this territory which now makes up a part of Yugoslavia. The victory took on more importance because of a simultaneous defeat of three Roman legions in Germany, thus, through Claudius the day was saved for Rome in this area. Because of this success a "Triumph" or great victory parade was held in honor of Tiberius. He was offered the surname of Pannonicus, Invictus, or Pius. It is interesting to note that this all took place in the year 9 A.D. and the name Pius in Latin means conscientious, godly, holy, motherly, brotherly, sisterly, good, sacred or patriotic. I'm not complaining, just explaining.

From Person to People: Presidents Reagan and Obama Compared

Thirty years ago tomorrow President Ronald Reagan opened his first major Presidential address to the nation on the economy with these

"I'm speaking to you tonight to give you a report on the state of our Nation's economy. I regret to say that we're in the worst economic mess since the Great Depression.'

week President Last Barack Obama turned to the economic condition and outlook in his 2011 State of the Union Address, stating:

"We are poised for progress. Two years after the worst recession most of us have ever known, the stock market has come roaring back. Corporate profits are up. The economy is growing again."

By some measures Mr. Obama is correct. By some measures the economy is improving. But for the millions of American who are unemployed, underemployed or who have taken pay-cuts just to keep a job, there is little evidence of economic growth. There is a telling difference in how these two presidents — thirty years apart and of quite different political persuasion - respond to unemployment.

In 1981 conservative Republican Ronald Reagan spoke of:

"Seven million Americans caught up in the personal indignity and human tragedy of unemployment. If they stood in a line, allowing three feet for each person, the line would reach from the coast of Maine to California.'

Mr. Reagan — a man who had risen from poverty him-

self and who, as a conservative, instinctively thought in terms of the individual soul conceived unemployment as a personal blow to the outof-work man or woman. Even when he speaks of the unemployed collectively he does so with a graphic image of persons queuing up, much as at a 1930 Depression-era soup kitchen. It is an image that directs the listener to the magnitude of individual suffering and away from the abstract idea of "unemployment."

Now consider how President Obama addressed the same suffering:

"We measure progress by the success of our people. By the jobs they can find and the quality of life those jobs offer."

Mr. Reagan's imagery conveys that he has looked into the faces of these sufferers. He feels — and moves us to feel — sympathy. Mr. Obama, on the other hand, can merely summon up a clichéd phrase about "quality of life." I've no doubt President Obama cares about "our people," but he shows little, if any, understanding of how it is for the individual person who is unable to care for his or her family. In that he is like the Charles Schulz character Linus who said, "I love mankind, it's people I can't stand."

THE NORTH END, RESTAURANTS AND CLOSING TIMES

Another battle over a proposal from two North End restaurants to stay open for an extra hour have drawn opposition from several of the neighborhood's residents. Many are fearful that if these two eateries get the extra hour, there will be an avalanche of restaurants asking for the same action.

Mary McGee who is a member of the North End Waterfront Residents Association is quoted in the Boston Herald, "I've lived in the North End 37 years and I love city living ... But even city dwellers have to sleep at some point."

Both Tresca on Hanover Street and Vinoteca di Monica on Richmond Street are seeking to remain open until 1 a.m. Massimo Tiberi, co-owner and general manager for Tresca said 73 percent of North End restaurants with full liquor licenses close at one in the morning and believes his place is "not asking anything out of the ordinary."

I understand what Ms. McGee is saying and also that of North Ender Anne Pistorio who told the Herald reporter, "If these restaurants win approval for later closing hours, it will open up the flood gates for all the others." She asked why don't they open up earlier for, say, breakfast or lunch? However, folks don't eat ham and eggs or a burger and fries at fine Italian

In recent decades with the growth of restaurants inside the confines of the North End, there has been an ongoing uneasy truce between restaurants and residents. This latest battle has been played out before and surely will again in the future. Each side really does need the other. Perhaps, with Tresca and Vinoteca di Monica, a compromise time of 12:30 a.m. could be reached. The real problem is that over the years as the neighborhood restaurant base has grown, the needs of neighborhood folks often can get lost. Restaurants also have to be good neighbors and work with the community to address issues of commonality.

When it comes to communication, there is much work to be done by both sides.

A Tribute to Ronald Wilson Reagan

Thirty years ago, Ronald Reagan was sworn in as the 40th President of the United States. The nation in 1980 was very downbeat after suffering through four very long years of Jimmy Carter who, in my book, is hands down the worst president ever elected. Reagan was elected despite being 69 years old when folks voted for him on that Election Day back in 1980. On January 20,1981, he officially became the oldest elected first term president and just 17 days until birthday number 70.

This upcoming Super Bowl Sunday (February 6) will mark the centennial of Reagan's birth back on February 6, 1911 in Tampico, IIIinois. He grew up to become a success in life before going into politics as a B-movie actor which he often joked about in later years. He didn't enter retail politics until he was 55 years old, when he was elected to his first of two terms as California governor. In fact, the governor of California today, Jerry Brown, was the governor who followed him in office back in 1975. However, even as an actor, he was politically motivated and in the late '40s and early '50s, as Screen Actors Guild president, he fought to cleanse Hollywood from those accused of communist ties. In 1962, he switched to the Republican Party saying he didn't leave the Democrats, the Democratic Party left him.

The birth of Reagan's political career began in 1964 when he became a spokesman for U.S. Sen. Barry Goldwater's presidential campaign against President Lyndon B. Johnson. He first came to my attention as a possible national leader during the Goldwater campaign. In 1968, he took on Richard Nixon at the Miami convention, Nixon won but Reagan was apparently on the move to a goal. In 1976, he took on President Gerald Ford in the GOP primary and narrowly lost to him. Ford lost to Carter which set the stage for 1980. In 1980, Reagan was the underdog thanks to President Nixon, 1974 and Watergate. After Nixon got on the helicopter back on August 9, 1974, the Republican Party looked like death warmed over. However, Ronald Reagan pulled the party from the depths of hell back into power with his optimistic leadership after four long years of pain under Carter.

In 1984, Reagan ran for reelection and easily defeated Walter Mondale at age 73. He left office in 1989 and was followed into office by his vice president George H.W. Bush. He slowly disappeared from view. In 1994 he wrote a letter to the American people, his long goodbye, revealing his diagnosis of Alzheimer's disease. The last years of his life seemed unknown to him. He forgot he was a president, a great president.

He forgot his role in ending the Cold War. He forgot how he pulled Americans back up on their feet after the horrible '70s. He made people forget about Watergate. He made us proud to be Americans again. He forgot it all. However, we didn't forget and still haven't forgotten his role in American history. I was saddened to hear that Reagan's memory had died long before his body did at age 93 on June 5, 2004. There's a story about former attorney general Edwin Meese, who recalled going to the christening of the USS Ronald Reagan back in 2001. He brought Reagan the ship's baseball cap which read "USS Reagan CV-76" and wondered "why would anyone name a ship after me?"

Twelve years after leaving office, the most important president since Franklin Delano Roosevelt had no memory of having been president for eight years or even having been a B-movie actor. So sad. As for me, I will remember him for inspiring me to public activism. I was inspired by Jack Kennedy back when I was 12 years old. I was inspired again by Ronald Reagan 20 years later in 1980. I have not been inspired since. Sarah Palin called Ronald Reagan "America's Lifeguard" in a commentary run in the Wall Street Journal in January. She's right. We needed a lifeguard in 1980. Someone who made us feel safe. He was someone who led us and the entire world out of darkness. I will always remember Ronald Reagan for who he was and what he gave us when we most needed it. He was our lifeguard, rescuing us, as Sarah Palin stated, "with his optimism and common sense. We need more lifeguards like him."

FRIGID TEMPERATURES INCREASE THE RISK FOR FROZEN WATER PIPES

... Simple Steps Can Help Protect Homes and Businesses ...

gusty winds can cause one of winter's worst woes - frozen water pipes. With winter's cold, more and more home and business owners may encounter frozen water pipes.

take some simple precautions to prevent the inconvenience and expense of frozen water pipes," said Raymond Raposa, executive director of the New England Water Works Association, the region's largest organization of water works professionals. These include:

Turning off outside faucets. Disconnect the hose. Turn off the water from inside your home or business, then drain the pipe. Leave the outside valve open slightly, so any water left in the pipe can flow out and not freeze in the line.

Patching any cracks and holes in doors, windows, and walls near pipes. When temperatures drop to near zero, a high wind blowing through a small opening can freeze a nearby pipe. When patching these openings, do

Frigid temperatures and not block the air vents that your water bill. Check with your furnace needs for proper combustion.

Making sure that heat can circulate around pipes. Pipes inside or outside walls, or in an enclosed area can freeze, especially when the "But property owners can wind-chill factor is well below zero and heat is not circulating through these ar-

> Insulating pipes and faucets in unheated areas. Wrap pipes with pipe-insulating material, which is available at hardware and plumbing supply stores, or use insulation. Be sure to protect all pipes in unheated areas, such as crawl spaces and garages.

> NOTE: Follow-up interviews can be arranged with Raymond Raposa, executive director of the New England Water Works Association, to discuss the information in this release.

Not allowing your water to run overnight — this should not be your first option. This practice will not necessarily prevent pipes from freezing. Instead, it wastes water and increases

your local utility about the necessity of running water overnight under special circumstances.

Checking insulation around pipes regularly. Older-model furnaces generated sufficient heat to warm basements in cold weather. However, today's energy-efficient heaters limit wasted heat. Homeowners with wood stoves or other heat sources often turn down the furnace, which could lower temperatures in the basement

Never shutting off your heat completely. If you are planning to leave your home or business for an extended period and you don't drain your pipes, you should lower the thermostat but never shut it off. The lack of heat can freeze the pipes in walls and the basement. If freezing occurs, the pipes will burst. When the area warms up, the thawing water will cause flooding and possible property damage.

ECONOMY HITS NEW HIGH

US economy tops 2007 peak, rising 3.2% in the fourth quarter. The economy ran up for the second straight quarter as consumer spending increased for the fastest pace in four years according to the Commerce Department. Wall Street had expected a strong rate of expansion, but consumers were supporting the Federal Reserve's aggressive efforts to boost growth and bring down unemployment. There is increasing evidence that the economy is self-sustaining said analysts at Wells Fargo Investments and bring down unemployment. Massachusetts Small Business Cheers Ruling in Federal Health Care Challenge

Independent Business (NFIB) applauded a ruling in federal court today overturning the controversial Patient Protection and Affordable Care Act. Bill Vernon, the organization's state Director, said the decision is a major victory for small businesses in Massachusetts.

"The mandates, penalties and regulatory burdens imposed by this law are costly and confusing to Massachusetts small business owners, who already face the financial burden of Massachusetts' health care law," said Vernon. "We are very pleased by the judge's ruling today and we are confident that the law is an unprecfederal government."

Since NFIB filed its case, six more states have joined, meaning that a majority of states now reject the federal law as an intrusion into their constitutional rights. "Just as Massachusetts employers can testify to stagnating job growth from health care changes here, the staggering increased costs for small businesses from the federal changes will likely cost the nation hundreds of thousands of jobs, and further frustrate local business owners as alignment of the two laws gets underway," said Vernon.

"If the federal government can order people to

Karen Harned, Director of NFIB's Small Business Legal Center, said the law violates the Constitution because it concentrates too much power into the hands of politicians and bureaucrats in Washington.

"NFIB is extremely pleased with Judge Vinson's decision," said Harned. "NFIB joined this case to protect the rights of small-business owners to own, operate and grow their businesses free ment intervention. The individual mandate, which forces citizens to purchase government approved health insurance, undermines this core principle and gives the federal government entirely too much power. We are delighted Judge Vinson agreed with NFIB and the states on this critical issue."

In his decision, Judge Vinson ruled that Congress lacks the constitutional authority to force citizens to purchase health insurance:

"Because the plaintiffs maintain that an individual's failure to purchase health insurance is, almost by definition, "inactivity," the individual mandate goes beyond the Commerce Clause and is unconstitutional." Page 13



break will be a very special one for twelve lucky and hardworking students of East Boston High School. As part of an ongoing exchange program with a school in Italy, the students will be part of a two-week experience abroad that will strengthen a relationship started in 2010 with a Sicilian school.

Students will fly from Boston to Rome on an overnight flight on March 16. Before heading down to Palermo with another flight, the students will spend two days exploring the cultural and historical sites of modern and ancient Rome. "The plan in Rome is to see the main sights," says Jessica Gorham Cronin, a level 2 Italian teacher at East Boston High School who has been helping with the trip's organization. "It's hard to see Rome in six months, let alone two days!"

Students will fly to Palermo on Saturday morning where they will be met by their

This upcoming spring host families. The group will stay in Alcamo, about 25 miles southwest of Palermo, for seven nights. The Sicilian host school has compiled an itinerary of our week's stay, which will include travel to various cities of historical/ cultural importance within the region. The group will return to Boston on Saturday, March 26th.

To help the students pay for their airline tickets, the school is organizing a special "Serata Italiana" Italian evening fundraiser. On Saturday, February 12, participants in the fundraiser held at Savio High School (145 Byron Street, East Boston) will enjoy home cooked pasta, meatballs and Italian cookies. There will also be a raffle with many prizes and children will be involved in games such as "pin Sicily on the map of Italy" after getting their faces painted with the green, white and red tri-colore. Once again, the fundraiser will take place on February 12, from 5 p.m. to

8 p.m., at Savio High School. Tickets are \$10 each, or \$5 for children 12 and under.

The trip is the second act of a broader exchange that saw eleven Italian students from Sicily come to Boston last year, so the students going to Italy already know who they will meet across the ocean. "The students are Facebooking each other already, making arrangements with the families they will be staying with and planning their schedules while there," says Cronin, who herself spent her junior year of college in Florence. Cronin recalls the great time the Italian students had in Boston, as they experienced some U.S. traditions such as the school's homecoming dance and watching the Thanksgiving football game all together.

"The students are very excited and motivated for the trip," says Cronin. Students will keep their teachers, friends and families up to date on their Sicilian adventures through blogs they will set up before the trip. A major theme is easy to predict: cannoli, a Palermo specialty!

Once again this year, members of Donne 2000 celebrated the arrival of "La Befana" on January 9th with their children commemorating Christmas Italian style. La Befana entered sweeping, dressed in worn garb, greeting the little children. They all marveled at her and anxiously awaited their gifts. She also passed out little treats to the grownups consisting of a tangerine, torrone and chocolates with the traditional Befana poem

La Befana is one of Italy's oldest and most celebrated legends. Each year on January 6th, day of the Epiphany, the children of Italy awaken in hopes that la Befana has made a visit to their house. This is a significant day for Italians because it marks the end of the Christmas season and it is the day that the three Wise Men arrive at the manger of the Christ Child bringing Him presents of Gold, Frankincense and Myrrh.

As legend has it, the three Wise Men were in search of the Christ Child when they decided to stop at a small house to ask for directions. Upon knocking, an old woman holding a broom opened the door slightly to see who was there. Standing

at her doorstep were three colorfully dressed men in need of directions to find the Christ Child. The old woman was unaware of who these men were looking for and could not point them in the right direction. Prior to leaving, the three men asked the old woman to join them on their journey but she declined saying that she had too much housework to do. After they left, she felt as though she had made a mistake and decided to catch up with the kind men. After many hours of searching she could not find them. Thinking of the opportunity she had missed, the old woman stopped every child to give them a small treat in hopes that one of them was the Christ Child.

Each year on the eve of the Epiphany, she sets out looking for the Baby Jesus. 

tions, your pipes do freeze, it is best to call a licensed plumber, added Raposa. "Make sure you keep the name and telephone number of your plumber handy throughout the winter.'

If you locate the frozen section of pipe and try to thaw it yourself, be sure to take the following precautions to protect yourself and your property:

Do not use a torch with an open flame. You risk setting your property on fire. In addition, overheating one area can cause the pipe to burst.

Place a warm towel or rag around the pipe.

Make sure you know the location of your master shut-off valve. The frozen pipe may already be broken and, when the water is

thawed, it will leak. In this case, you will need to shut off the water in your home or business until the leaky pipe is

Wow! The world's four richest citizens — Carlos Slim, Bill Gates, Warren Buffet and Mukesh Ambani — control more wealth than the world's 57 poorest countries.

Lucky guy! John Davis, a mechanic from Pawlewys Island, South Carolina, was down to \$6 in his checking account and was only days away from foreclosure when his luck turned: Davis won a \$200,000 lottery jackpot. Winning "took my breath away," said Davis, a single father of two daughters, ages 3 and 15. A few of the people at work came over, and I said, "Am I seeing things?" They said, "No, you won the lottery." Davis said he will use the money to pay off his mortgage and save for his daughters' college tuition.

Huh? A Houston couple was told to stop feeding the homeless because they don't have a permit. Bobby and Amanda Herring had been feeding up to 120 people nightly, using donated food prepared by volunteers. But city officials shut down the program because the kitchen isn't inspected and certified. "Poor people are the most vulnerable to food borne illness," an official explained.

Eat your broccoli! British researchers found that eating five more portions of fruit and vegetables a day raises carotenoid levels and gives skin a golden tone, making people look healthier and more attractive. So remember, eat more veggies and fruits!

BAKED SCALLOPS

 pound scallops
 Ritz or Hi-Ho type crackers crushed
 tablespoons butter or

margarine

1 tablespoon chopped parsley 2 tablespoons white wine paprika salt

Spread some butter or margarine at bottom of baking dish (10" x 12" x 2"). Wash scallops and drain excess water. Place scallops in baking dish. Blend melted butter into cracker crumbs. *Spread crumbs over scallops. Pour two tablespoons of white wine in a glass with two tablespoons of clam juice or water. Sprinkle gently over cracker crumbs and scallops. Sprinkle paprika over the cracker crumbs. Cover and bake at 400° F for fifteen or twenty minutes or until scallops are the right consistency to serve.

NOTE: *When preparing the above recipe for my husband and me, I sprinkle garlic powder over the scallops before adding the cracker crumbs and remaining ingredient. We enjoy the garlic flavoring.

I often bake this meal in my heated toaster oven set on broil. I cover scallops with aluminum foil before placing in toaster oven. Broil for about eight to ten minutes. Then set the toaster oven to bake for the remaining time needed.

I serve mashed potatoes or rice pilaf along with French-cut beans and/or carrot strips topped with butter or margarine.



Nanna & Babbononno

snow since the blizzard of "78." When that storm hit in February of 1978, we got a winter's worth of snow all at once. This winter, we've been getting hit quite frequently, a few inches at a time. The problem I have at this point in time is that everyone prevents me from shoveling or plowing out the snow that we get. To keep everyone quiet, I have hired a company headed by Mike Ruggeri, a young man who grew up with my son, Michael. My problem is that we live on a street that is a bus route. The minute one snow flake hits the ground; the plows are out clearing the way for public transportation. This means that if we get a sizable amount of snow, I could have a plowed mountain across my driveway. Loretta tells me that I'm too old to shovel my way out and maybe she's right. So, I leave the snow removal to the professionals.

Snow was the main reason we left East Boston back in the 1960s ... no place to park. When I was a kid, Dad had one of the few cars that was parked on Eutaw Street. He, Al Luis, Marie Alexander, Bert Marotta and a couple of other neighbors owned cars; most did not. As a result, there was never any trouble parking. As a matter of fact, Dad never had to secure his shoveled parking spot by placing barriers like old chairs, barrels or saw horses in them. Everyone knew that the spot in front of #74 was my father's and they left it alone. At night, Dad would return home from wherever he was playing, park in his dug-out spot, take his bass violin out of the car and head into the house. But, beginning around 1950, things began to change.

The neighborhood began to change by mid century. Many of the old timers began to die off, houses were sold and new people began to move to the Eagle Hill section of East Boston. This was combined with the fact that began to move to the suburbs. When this began to happen, most of the new comers owned cars, and as time went on, parking sometimes became a problem. At one point in the 50s, the city passed an ordinance regarding parking restrictions. You could only park on the even numbered side of the street on certain days and the odd

I have not seen this much numbered side on the alternate days. If you violated this, you might get a parking ticket. This made it more difficult for Dad who came home sometime after midnight most nights of the

By the mid to late 1950s, most of my generation that grew up on Eutaw Street owned cars which added to the parking problem. This meant that Dad might have to drop off his bass violin while double parked and then go hunting for a parking space somewhere in the neighborhood. When I became a professional musician, I had the same problem, but I was a kid and things like hunting for a parking space didn't bother me like they did my father. Disgruntled during the winter months, Dad began talking about moving to the suburbs.

Actually, he had wanted to buy a house in the burbs before this point in time, but my mother wouldn't hear of it. She wanted to be close to Nanna and Babbononno. By the mid 1950s, they were living in an apartment at 199 Lexington Street, near the corner of Putnam. Babbononno had sold 70 Eutaw Street to the Pina family. Uncle Paul had moved his family to St. Edwards Road in Orient Heights, Uncle Nick was living in Brookline going through a divorce and Uncle Gino and his new wife, Ninna, had an apartment on Saratoga Street. We were living at 74 Eutaw and the big house at #70 became too much for Nanna to handle. Once the house was sold, my grandparents moved to Princeton Street, then later, Lexington Street, both locations within walking distance from where we lived which meant that Mom could take care of her parents whenever it was necessary.

In 1957, Nanna developed breast cancer and passed away just before Christmas in 1958. Cancer cures were primitive back then, and she many of my folks generation really suffered. After her passing, Babbononno moved in with us which allowed my mother to take care of her father every day. The five room third floor walk-up became a bit crowded, but we managed. Every time Dad mentioned moving to the suburbs, Mom and Babbononno would gang up on him and the subject went nowhere.

I graduated college in June of 1960 and began teaching drafting in the Boston Schools. Like Dad and my uncles, I was now a professional musician playing several nights of the week. With so many cars now on Eutaw Street, parking was getting more difficult especially during the winter months when there was snow on the ground. One night, Dad was playing with his band and went an hour overtime. When he left the function hall, there were several inches of snow on the ground and he carefully drove home. He stopped in front of the house, brought his bass inside and then drove around the neighborhood for a half hour before finding a place to

park. He walked home with

just his shoes on, swearing

all the way. When he got in,

he poured himself a drink (he was a tea totaler) and

complained about the park-

ing situation, waking every-

one up in the process.

The next day, he began to look at houses in the suburbs. Uncle Gino and Aunt Ninna had moved to Belmont and Dad liked the town. When he mentioned it to my mother, she would have none of it. She was an East Bostonian and would not move. Babbononno sided in with her. By the winter of 1961, Dad found a house in Belmont. When he discussed it with friends and relatives, they told him he was crazy because of the price, "You can buy the same house in Medford for \$10,000 less or Saugus for \$8,000 less. His reply was always, "But, I want Belmont." When he intensified his desire verbally, Mom refused to go. He then told her that he would pay for the apartment and she and Babbononno could stay there, but he was moving to Belmont. I agreed with him. Mom panicked and told

Babbononno that her place was with her husband and if he wanted to buy a house in the suburbs, then her place was with her husband. Babbononno grumbled, but had no say in the matter. So, in the spring of 1961, we moved to Belmont. That first night, I couldn't sleep. There were no planes flying overhead. There were no sirens blasting away. There was no traffic noise. The quiet kept me awake. Dad was happy and Mom made new friends in the neighborhood. Although they weren't Italian, my mother fit in and became a Belmontonian. Babbononno was never happy there, and in his old age, moved back to East Boston. My folks remained in that same Belmont house for the rest of their lives and loved it...no parking problems. If this weather continues, I may consider moving, too. Del Ray Beach or Boca Raton, Florida sounds good to me. What do you think???

pends on his definition of "grow". I call a 2.6 percent increase in GDP anemic, especially when most of it was generated by a productivity blitz by U.S. businesses and not by economic policies.

A year ago, Congress raised the statutory debt ceiling, and now they are talking about the need to raise it again. The current national debt, which amounts to \$45,000 for every man woman and child in national debt (\$14 trillion total) is not enough for this administration. If it is left

unchecked, there appears to be no end in sight. And we are supposed to feel good about the state of the union.

Like the appliance repair man, we will continue to have some restless nights because of broken promises and failed policies by the administration. The House is starting to see the light, but this president isn't even aware of the heat.

Maybe he will become aware in 2012 when he joins the ranks of the unemployed.

LO SAPEVATE CHE ...

Lo stress fa male non solo alla psiche ma lascia anche dei segni fisici profondi, soprattutto nei bambini. Alcuni scienziati dello Stanford University Medical Center hanno scoperto che alti livelli di stress, come per esempio in chi soffre di disturbo post traumatico da stress, lasciano delle vere e proprie 'cicatrici' nel cervello, danneggiando e restringendo l'area dell'ippocampo coinvolto nella memoria e nelle emozioni e rendendo così i piccoli meno capaci di gestire ansia e difficoltà. A renderlo noto è uno studio pubblicato sulla rivista "Pediatrics". Nei bambini esaminati durante la ricerca sono stati riscontrate quantità più alte nel sangue dell'ormone dello stress, il 'cortisolo'. Secondo i ricercatori gli alti livelli di cortisolo danneggiano l'ippocampo che, a sua volta, aumenta l'ansia. Il danno che ne deriva può prolungare i sintomi dello stress e interferire con la terapia dpts (disturbo post traumatico da stress). Un gruppo di ragazzi studiati per avere manifestato stress vari non riuscivano a gestire informazioni e nel metterle insieme, specialmente se il danno alla memoria, a causa dello stress, è stato molto serio.

Naturalmente non tutti i soggetti studiati erano in grado di rispondere all'effetto dello stress in maniera simile. Il loro responso era flessibile. Ulteriori studi cercheranno di spiegare se l'ippocampo più piccolo sia un segnale che predispone al disturbo post traumatico da stress, o se invece ne è la conseguenza. Uno studio condotto sui veterani di guerra sembrerebbe suggerire che sia l'ippocampo danneggiato a predisporre all'insorgere di questo disturbo, o viceversa.

DID YOU KNOW THAT ...

Stress is bad to the psyche but also leaves its mark, physical and deep, on the little children mainly. Some scientists of Stanford University Medical Center have discovered that high levels of stress, as on those who are affected by traumatic stress disorder, leave real 'scars' on the brains by damaging and shrinking the section of the hippocampus involved in emotions and memory, and causing to the least able the inability to manage anxiety and difficulties. The study became public after its publication on the magazine "Pediatrics". On the children examined during the research study they found very high quantities of 'Cortisol' in the blood of this stress hormone. The researchers believe that high levels of Cortisol cause damage to the hippocampus, which at same time, increases anxiety. The result is the damage that may prolong the stress symptoms and interfere with the PTSD (post traumatic stress disorder). A group of children studied after manifesting diverse kinds of stress were unable to make sense of the 'information' and put them together, particularly if the damage to the memory, because of the stress, was very serious. Of course, not all those studied responded in a uniform manner to the effect of the stress. Their response was flexible. Further studies will try to explain if the smallest hippocampus is a sign that predisposes to the post-traumatic stress disorder, or the consequence. A study conducted on war veterans would seem to suggest that it may be a damaged hippocampus to make possible the insurgence of such symptoms, and not vice-versa.

They made the ultimate sacrifice for their "Loved One!" A feat that others should look at, learn from, and strive for. Real fighters have courage; They stand up to adversity. They have the will to face obstacles, battling for them, uncertain of victory. You fight, and still lose? Oh well. So be it. The reward? A supreme goal. Warrior Joe DeNucci expressed it so well in the column written by Joe Fitzgerald in the Boston Herald titled: "Joe's leaving but the fighter remains." That's an excellent
