

The closures are scheduled to take place over the next four weeks during the overnight hours of 11:59 p.m., through 5:00 a.m. on the evenings of Sunday, Monday, Tuesday, Wednesday, and

The closures are necessary to allow crews to remove existing overhead guide sign structures and install new sign structures along Route 1A at several locations. The work will require the closure of both northbound and southbound directions intermittently for 15 minutes at a time.

Traffic will be released after the 15 minutes, then once traffic clears, another 15 minute roadway closure will begin. This work will continue until all overhead guide sign structures have been installed.



Stirpe Nostra

A weekly column highlighting some of the more interesting aspects of our ancestry . . . our lineage . . . our roots.



Last week, we discussed Helios, the Sun god and his Roman counterpart named Sol. This week, attention is directed to an ancient Egyptian city near Cairo, named Heliopolis in honor of that Sun god. It was also well known as the "City of the Sun." Herodotus, the famous ancient Greek historian, claimed that its inhabitants were the wisest and most ingenious of all Egyptians. Berosus, another Greek historian claimed that this was the city of Moses, while others tell us that it was a place of resort for all Greeks who visited Egypt for instruction and knowledge. Plato lived here for about three years. It is also listed as the residence of the Egyptian priest named Manetho, who wrote the first history of Egypt in the Greek language.

Strabo, a Roman geographer and historian spoke of this city being built on a long artificial mound of earth in order to keep it above the seasonal flooding of the Nile which occurred every year for thousands of years. The oracle of Apollo and a famous temple of the sun were located here, as well as a fountain which gave forth-excellent drinking water. I am told that the fountain still remains and that it inspired the name "Fountain of the Sun."

The Cleopatra's Needle of New York was erected in Central Park on February 22, 1881.

Egypt. These are huge monoliths (monos meaning single, plus lithos meaning stone). They are square in shape but taper to the summit and look like a miniature Bunker Hill Monument or Washington Monument. They usually stood in pairs to dignify entrances to temples.

The usual height was ten times the thickness at the base. Hieroglyphic inscriptions on the sides of these pillars tell the story of the persons or events for which they were erected. Heliopolis was noted for its obelisks, many of which

One of these was taken to London in 1878, and erected on the Thames embankment. The other was taken to New York City in 1881, and set in Central Park.

The largest obelisk in existence is the one in the piazza of Saint John Lateran in Rome. It came from the Temple of the Sun, in Heliopolis, where it was originally erected about 1500 B.C. by Thothmes III, one of the greatest of the Egyptian Pharaohs. The obelisk is of Egyptian granite, 105 feet high, nine feet square at the bottom, and six feet square at the top, and weighs 450 tons. Another monument, the huge obelisk in front of St. Peter's in Rome should serve as a constant reminder of two of the most brutal men that this world has ever known. It was brought to Rome, also from Heliopolis, and was transported via a special boat that was constructed by the Roman emperor Caligula. The obelisk was erected on the "spine" (median strip) of Nero's Circus, and at the base of this monument is where St. Peter and countless numbers of Christians were martyred. It was moved from its original site to its present location by Pope Sixtus in 1586. I am told that the bronze cross now at the top contains a relic of the true cross.

Saint Charbel


Youssef Antoun Makhlouf was born on May 8, 1828, one of five children born to Antoun Zaarour Makhlouf and Brigitta Chidiac. They lived in the village of Bekaa Kafra. His father, a mule driver died when Youssef was only three returning from his service to the Turkish army, leaving his wife a widow to care for their children.

At the age of 23, Joseph joined the Monastery of St. Maron at Annaya, Lebanon, and took the name Charbel in honor of a second-century martyr. He professed his final vows in 1853, and was ordained six years later.

Among his professors at the seminary was Father Nimatullah Kassab, who was himself later also declared a saint. He was ordained six years later, on July 23, 1859, in Bkerke. He was sent back to St. Maron Monastery, where he lived a life of severe asceticism.

In 1875, Charbel was granted by the abbot of the monastery the privilege of living as a hermit at the Hermitage of Saints Peter and Paul, a chapel under the care of the monastery. He spent the next 23 years living as a solitary hermit, until he passed away. Charbel passed away in the late afternoon on Christmas Eve. Christians and non-Christians soon made his tomb a place of pilgrimage and of cures.

A few months after his death, bright lights were seen around his grave. From there, his corpse, which had been secreting sweat and blood, was



transferred into a special coffin. Hordes of pilgrims started swarming the place to receive his intercession and through this intercession, God blessed many people with recovery and spiritual graces.

In 1925, his beatification and canonization were proposed for declaration by Pope Pious XI. In 1950, the grave was opened in the presence of an official committee which included doctors who verified the soundness of the body. After the grave had been opened and inspected, the variety of healing incidents amazingly multiplied.

Miracles happened beyond the Lebanese borders. This unique phenomenon caused a moral revolution, and return to faith.

Pope Paul VI beatified Charbel in 1965, and canonized him on October 9, 1977.

The Feast Day of Saint Charbel is July 24th.

Since ride-hail services started, sexual assaults have been an ongoing issue. State regulators have been working on reducing this with better background checks while companies have been adding other safety features. The system is open to imposter drivers, sexual predators and other violent criminals who have shown they can exploit the system

Suffolk County D.A. Rachael Rollins says, "We are not going to victim blame. We are going to be teaching very vocally our overwhelming young men about consent. We're going to be talking to people about being safe when you are out drinking and when you are out."

That makes good sense but for those sexual predators out there roaming for victims, her statement is useless. The Commonwealth can pass all the legislation in the world over these ride hail drivers and public safety but in the end, the bottom line remains with those folks calling for a ride

As former Boston Police Commissioner Bill Evans observed, "If you've had a couple, and you're not about your right wits, you're not going to read the plates as well. You'd be very susceptible to jumping in the wrong car with the wrong driver."

Evans is so right. The latenight bar scene is chaotic with all kinds of people waiting for their rides to show up and many of these folks are stinking drunk, too. As someone who operated a sausage cart late into the early morning hours down at Faneuil Hall Marketplace, I speak from first hand knowledge of this situation. Many of those coming out of a bar about to go home would buy food off the cart and weren't even able to handle putting mustard on their hot dogs without help from me. Do we think any of them would know if they were getting into their called for Uber or Lyft?

Whatever happened to personal responsibility on those out late bar hopping? Gina Scaramella, executive director of the Boston Area Rape Crisis Center says, if I understood her correctly, "that this whole problem most reflects a societal failure to stem sexual assaults. I am sure that is a big part of the problem but her suggestion that bars should have staff making sure that customers get into the right cars."

Stay together with your group, don't walk around alone, and keep you eyes open.

The Real Christopher Columbus Story

by Carol Delaney, Ph.D.

The following excerpt is taken from Anthropologist Carol Delaney, Ph.D., book Columbus Quest for Jerusalem. Part four of a six part series.

PART 4
REPORTING BACK
TO THE SPANISH
SOVEREIGNS AND THE
SECOND VOYAGE OF
COLUMBUS TO THE
NEW WORLD

It was a stormy dangerous crossing but they arrived back at Palos on the Ides of March, 1493 and spent several days at La Rabida to recuperate.

News of their return spread rapidly and they were summoned to Barcelona where the sovereigns were holding court.

Columbus prepared the natives for the journey taking every care they would be comfortable. When they arrived, the sovereigns held a reception in public view. Then, it is said that Columbus, "quietly and modestly, related the highlights of his voyage and discoveries, and presented the six natives to them."

A few days later the natives were baptized with the king, queen, and Columbus standing as godparents. Baptized people could not be enslaved. One became Columbus's godson who accompanied him on many of his later explorations and was a loyal interpreter. At least one of the natives remained at court for the rest of his life. The others chose to return.

Despite all the fanfare, Columbus was anxious about the men back in Hispaniola. He had no trouble convincing Isabella to launch a second voyage. She quickly alerted the pope, Alexander 6.

As God's emissary in the world, he, as Pope, felt he had the right to bestow on Christians territories that were in the hands of non-Christians. He had already given regions in Africa to the Portuguese; he now bestowed the newly discovered part of the world to the Spanish. This he acknowledged May 3, 1493 in the Papa Bull called Inter caetera.

The very next day, realizing that was not clear enough, the Pope issued another Bull in which he drew a line from north to south down the middle of the Atlantic Ocean!! The side close to Africa was given to the Portuguese and the side of the new world to Spain. But even that was not enough. A few months later he issued Didim siquidem which said that by sailing west one could reach the east and the land of the "Indies" and granted the Spanish sovereign the right to "freely take corporal possession of the said islands and countries and hold them forever." The Portuguese were outraged and some adjustments were made.

Soon Isabella approved another, much bigger voyage –17 ships! There were sailors and settlers, some hidalgos, also Ponce De Leon [future discoverer of Florida] and Michele de Cuneo whose descriptions of the voyage and settlement survive. Also 3 Franciscans and a Benedictine friar whose job it was to convert the natives- though he did very little. Columbus's brother Diego and the father of Bartholome de las Casas were also aboard.

Along the way they discovered Guadalupe on which lived



some of the fierce Caribs. They learned that they had captured people from the group Columbus knew. He rescued as many as he could and took them back to their homes. They also discovered Puerto Rico and the Virgin Islands where they encountered more fierce Caribs and their enslaved people. In other words some of the natives were already enslaving people.

As they approached Guacanagari's village they saw a shocking sight several lifeless bodies floating in the water. When they landed, they learned that all of the men who had been left behind were dead. The Friar immediately wanted revenge and told Columbus to go kill Guacanagari and all his people. But Columbus did not believe it was Guacanagari's doing.

With his native godson, Columbus went to see Guacanagari and learned as he had imagined, that the men had begun to fight among themselves, formed groups that went on raiding parties against another chief, had raped the women, and stolen things. That chief then came and killed them all.

The relationship between Guacanagari remained stead-fast and friendly but that between Columbus and the settlers deteriorated. He decided that it would be better to move on so they sailed to a place called La Isabella.

There was much work to do: build houses, storeroom, gardens etc. but immediately there were problems with the hidalgos. They refused to work and also refused to let Columbus use their horses to haul timber and stone which put a huge burden on other settlers In addition, these men expected that the natives would be their servants.

Shortly, some of the hidalgos returned to Spain taking spices and 26 of the supposed man-eating Caribs who could be enslaved according to papal policy. Nevertheless, Columbus requested that they be treated better than other slaves and given instruction in the faith so that at the least "they would secure the welfare of their souls."

But he also said that if any natives at La Isabella worked for the Spaniards they should be paid as employees of the Crown! He was clearly disappointed with his own men but eager to go exploring to find the Grand Khan. He put a man named Margarit in charge and left specific instructions about what to do and how to treat the natives. But Margarit and the men were cruel and without Columbus's knowledge, rounded up a large group and sent them back to Spain with a number of the disaffected hidalgos who then complained to the sovereigns that Columbus was too strict with them.

Meanwhile Columbus was exploring farther to the West and when he came to Cuba he thought it must be the beginning of the mainland, "adjacent to the noble region of Cathay" i.e.: not too far from the grand Khan. But they had been gone a long time and were running out of food so

they headed back to La Isabella. On the way a fleet of elaborately decorated canoes came out to meet them. The chief of that group greeted Columbus:

"Friend, I have decided to leave my homeland and come with you to Castile and see the King and Queen of the world." Columbus wrote: He said this so reasonably I was wonderstruck," but due to a storm approaching persuaded them to wait for his next visit.

When he got back to La Isabella, he found that his brother Bartholomew had arrived and also learned what Margarit had done. Isabella was concerned so in the next shipment of supplies for the settlement she requested that Columbus return to discuss the situation.

At that time he felt he could not leave because many of the men were sick but asked her to send good friars who would learn the language and instruct, not just baptize, the natives in the religion.

Finally, in March 1496, he returned to Spain with more than 200 of the Christians and 30 natives who had been rounded up by Margarit.

Perhaps due to his remorse or as a penance for how the natives had been treated in his absence, and the death of a few of his friends, Columbus donned the course brown habit, knotted with the cord of a Franciscan friar. He became a lay monk of the Obervatine Order! It is said that he wore this outfit the rest of his life and, at the end, it became his burial shroud.




Sea Lions: Life by a Whisker

Premieres at Aquarium's Newly Renovated Simons Theatre As Part of Sea Lion, Seal Campaign

In time for February School Vacation Week, the New England Aquarium's freshly renovated Simons Theatre will re-open with plush seating for its 80-foot giant screen and state-of-the-art technology to feature the 3D film, Sea Lions: Life by a Whisker. The film details the challenges encountered by a population of endangered Australian sea lions, and the plight provides lessons in marine conservation success as the Aquarium's "Protecting the Blue Planet" campaign spotlights seals and sea lions in the coming months.

The New England Aquarium is one of only three aquariums in the U.S. where visitors can see northern fur seals, a vulnerable species, as they dart through the water in the New Balance Foundation Marine Mammal Center. California sea lions also live in the center, and Atlantic harbor seals delight visitors at the Aquarium's front entrance. In the past few decades, populations of California sea lions and Atlantic harbor seals have rebounded due to conservation efforts, and the Aquarium studies whiskers, fur, tears, and even feces to understand the species. The new film in the Simons Theatre addresses how California's experience with restoring the sea lion population is influencing Australia's efforts.

Three other films are also playing at the theatre, including



Australia's Great Wild North: The Wildest Place You've **Never Seen**, an epic adventure about Australia's wildlife, indigenous peoples, wetlands, and the oldest rainforest spanning 50,000 years. As reported in the *NY Post*, "I was kind of horrified," the father of a preschooler told me. "They say they're trying to reduce racism and discrimination. To me, they're perpetuating it, fomenting a sense of victimhood that 4-year-olds would never consider on their own."

In an e-mail to parents and caregivers on January 16th, teacher Rosy Clark laid out lessons based on the Black Lives Matter Week of Action for a pre-kindergarten class at PS 58, located in well-regarded District 15 in Carroll Gardens.

"This year, the week is February 3-7, 2020. We are starting to talk about these ideas now, as we approach Martin Luther King Jr. Day [which was January 20th], and as we prepare to go into February, Black History Month.

At the end, the teacher reveals her extracurricular work as an activist, work that evidently seeps into the classroom.

I haven't heard of anything like this happening within Boston Public Schools, but parents should always stay clued in to what their kids are learning when they go off to school in the morning, right?

GOD BLESS AMERICA



Italy is known for its delicious foods and desserts, and of course street foods are of no exception. Each region from North to South has its own local street food delicacies. Arancini di riso (Rice balls) or Arancini as they



are most often referred originated in Sicily and happen to be one of the island's most sought after finger foods. Their name came from arancina, or "little orange" as a result of their round shape and color. These crispy, creamy, rich savory rice (risotto) balls are traditionally stuffed with meat ragu, peas, and mozzarella. Then breaded and deep fried to absolute perfection. Arancini have become increasingly popular and are no longer exclusive to Sicily. They can now be found throughout most of Italy, as well as right here in the states.

As with any fried foods, Arancini are best when eaten immediately after frying. Therefore, their only drawback is that they are often difficult to make and keep for any given period of time. For this reason, the "Arancini Casserole" is a perfect alternative. Using the same ingredients traditional Arancini are made from, it is put together in a mold coated with toasted breadcrumbs and baked, not fried. It can be prepared ahead, keeps longer, and is equally as delicious as its counterpart. When made in a Bundt pan, the Arancini Casserole unmolds into a beautifully presented savory and scrumptious dish!

ARANCINI (RICE BALL) CASSEROLE Casseruola Arancini

MEAT RAGU SAUCE

- ½ cup olive oil
- 1 medium sweet onion, sliced thin
- 3 garlic cloves, chopped finely
- 1 (6 ounce) can tomato paste
- 1 (28 ounce) can san marzano whole tomatoes, crushed by hand
- 1 pound ground sirloin Salt and pepper, to taste

RICE MIXTURE

6 ½ -7 cups cooked arborio rice (that has been made with

- chicken broth) or leftover
- 2 ½ -3 cups grated pecorinoromano cheese
- 4 eggs, at room temperature, beaten well
- 1 ½ cups fresh breadcrumbs, toasted lightly
- 4 tablespoons butter, at room temperature
- 1 cup thawed frozen peas
- 1 8-ounce ball fresh mozzarella, diced Bundt Pan (10-12 cup)

MEAT RAGU SAUCE

In a large saucepan, warm olive oil over medium heat, add onions and cook until soft. Add tomato paste and garlic, cook 10 minutes. Add sirloin and salt and pepper, to taste. Mix all ingredients together well; cook until meat is almost done. Add crushed tomatoes, cook for several hours, stirring often. Sauce should be thick, meaty, and sweet to taste, when done. Cool and place aside (can be made a day in advance)

RICE MIXTURE

In a large bowl, combine the cooked rice or risotto, pecorinoromano cheese and beaten eggs, mix well, set aside.

ASSEMBLE THE ARANCINI CASSEROLE

Preheat oven to 350°. Take 2 tablespoons of the butter, grease the inside of a Bundt pan, making sure to coat every spot. Taking a ¼ cup of the breadcrumbs at a time, evenly sprinkle the buttered pan to coat. Be sure there are no spots left uncovered with breadcrumbs.

Using damp hands take 2/3 of the rice mixture and press it against the breadcrumbs, coating the entire pan with an even layer.


Take 3 cups of the meat sauce and mix it with the thawed peas and diced mozzarella. Spread this filling mixture evenly over the rice up to almost the top of the pan

Take remaining 1/3 rice mixture and spread evenly over filling while gently pushing down to seal.

Sprinkle remaining 1/4 cup breadcrumbs over top and dot with the remaining 2 tablespoons butter. Bake until lightly browned on top, about 45 minutes.

Cool for 15 minutes. Invert the Arancini Casserole onto a plate. Carefully lift the pan off of the rice, shaking gently, if needed. Take some of the remaining sauce, fill the opening in the middle of the mold, and serve.



Jack Sharkey and Ernie Schaaf Good Friends



Heavyweight Champion Jack Sharkey and top contender Ernie Schaaf were good friends. Schaaf was a protégé of Sharkey's but the men formed a strong bound beyond their boxing relationship.

Ernie, who was from Wrentham, MA, had an apartment in Brighton on Strathmore Road while Jack lived not far away but in the much tonier suburb of Chestnut Hill. In fact, after buying a \$100,000.00 home on Beacon Street in 1929, Sharkey became known as "The Squire of Chestnut Hill."

Sharkey won the title by defeating Max Schmeling in 1932 and later lost it to Primo Carnera in 1933. At that time he was the only heavyweight champ to both win and lose the championship to a European fighter.



It is apparent from the price he paid for the house that Sharkey was already making big money before he won the title. I don't know when he sold it. It is now owned by Boston College and looks much the same when the King of the World occupied it.

Ernie Schaaf lived in more a modest dwelling in Brighton. A staunch Catholic, the quiet Schaaf was known to be a true gentleman. Ernie looked to be a future challenger for the heavyweight crown holding wins over Jimmy Braddock, Tony Galento, Young Stribling, and another upcoming prospect, Max Baer whom he beat by decision in 1930.

In 1932, Baer and Schaaf fought again with Baer taking a majority decision this time in a hard fought battle. Moments before the final bell Max hit Ernie with such force that Schaaf was knocked unconscious and remained in that





state for several minutes. The bell rang before the count reached ten so the official verdict was a loss by decision.

After the fight, Schaaf complained of having headaches but continued to fight. He had four more bouts with his last being against Primo Carnera. In 13th round, Primo hit Ernie with what appeared to be a not terribly hard jab and Schaaf went down for the count. The fans began shouting cries of fake, but it turned out Ernie had suffered an inter-cranial hemorrhage. He died four days later.

It has been often believed that the punishment he took in the Baer fight was really the cause of death, but it turns out Ernie had a case of the flu going in to the Carnera fight. Perhaps it was a combination of the two things that led to the tragedy. Ernie Schaaf was only 24 years old.

It's sad to think that the smiling and gentle looking man in the photos would be dead in less than two years.

HOOPS and HOCKEY in the HUB

The ever-popular Tacko Fall continues to bring calls from Boston Celtics fans at the TD Garden for him to play more during home games. One can feel the energy in the building increase every time Head Coach Brad Stevens makes the decision to bring the Tall One off the bench and onto the court.

And we do mean TALL. When measured at the 2019 NBA Combine, Fall stood at 7-7 in shoes (but now lists at his barefoot height of 7-5 for roster purposes). His wingspan is eight feet, 2.25 inches and he has a standing reach of 10 feet, 2.25 inches — meaning a portion of his hands can go over the rim while he is standing. He is currently the tallest player in the NBA.

This season, during Fall's rookie year, he is more than likely to see action in the fourth quarter, when the outcome of any particular game has been virtually decided.

But there is a location where he does play more. It's just not on the parquet. If one drives north into Maine during our mostly snowless winter, one can witness the former University of Central Florida athlete in quite a bit of action.

Fall is on a two-way contract with the parent Celtics, meaning he can be on the roster of the Green and White for only 45 days during the regular season. The rest of the time, he plays for the Maine Red Claws, Boston's affiliate in the NBA's G League. This means, of course, that he can be brought up to the Boston roster at any time, even for just a specific game. Or he could also spend extended periods up in the Pine Tree State.

The trip to southern Maine has been a familiar drive for generations of Boston area residents at another time of year as they follow the coastline north to enjoy sunny, summer days at the beaches and the quaint seaside towns that dot the road-sides along the way.

Making that trip in the winter would normally provide a very different experience, but so far this season most of the region has caught a breather with much less snow on the highways.

Once in Portland, you would have the opportunity to see Fall play in more lengthy stretches than he does in the Garden. That extended time generates more meaningful statistics, of course. Through the end of January, for example, the big man had recorded 10 doubledoubles (double-digit points plus double-digit rebounds) for the Red Claws, who play in the Portland Exposition Building. In order to accomplish that, one must get a whole lot more playing time. And Fall does.

As we went to press, he was averaging 13.4 points a game to go with 9.9 rebounds per contest while seeing action in just under 23 minutes per matchup in 18 league games. The Red Claws were in second place in the Eastern Division of the G League, sporting a 21-8 record as of February 4th, a mere one and a half games behind

division leader Wisconsin.

Contrast that with his appearances at the Garden. There he had played in only five contests through early February, getting on the floor for an average of just under five minutes in that handful of matchups while scoring at just a 3.8 clip. Things could change at any moment, of course, but with the Celtics having played over 50 games on the year, who will play a significant amount of minutes and who will not has pretty much been determined.

Of course, there was a time that Fall, like all players, first caught the eyes of the powers that be in the Celtics front office. Not selected during the two-round NBA draft this past June, he was one of the last two players signed as free agents by Boston over the summer on July 25th (Javonte Green was the other).

The signing came on the strength of his performance two weeks earlier in the Las Vegas Summer League where he saw action in five games, scoring an average of 7.2 points per game to go with 4.0 rebounds and 1.4 blocked shots while playing just under 13 minutes per contest.

He made it onto the C's training camp roster, giving him another opportunity to audition before Head Coach Brad Stevens and the entire Boston coaching staff. In his first preseason game against the Charlotte Hornets, with the Garden fans chanting his name, Fall entered the contest in the fourth quarter and proceeded to score five points, grab three rebounds, and block two shots.

He finished the four-game preseason by averaging 3.5 points and 2.6 rebounds in just under 10 minutes per game. He was assigned to Maine, but that two-way contract meant that he would have a presence in the Garden on selected occasions as well.

Elhadji Tacko Sereigne Diop Fall was born on December 10, 1995, in Dakar, Senegal, and lived in that West African nation until his family moved to the United States when he was 16. He first played high school basketball in Houston where his team won a state championship and later transferred to Liberty Christian Prep in Florida. At the time he was the tallest high school player in America and a superior student. He earned a 4.0 grade point average in high school and scored in the 95th percentile on the Scholastic Aptitude Test.

He chose to attend Central Florida where he majored in computer science. Over four seasons, the team improved dramatically, securing its first NCAA Tournament berth in his senior year.

After four years of college ball, a rarity for most current NBA players, he's now with the Celtics organization. All ardent fans of Fall, who really want to see him play, should consider a trip to Portland. It's there that the real Tacko will stand out, offering a glimpse of a possible future in Boston on the famed parquet floor.
