

Many Italian-Americans from all regions of Italy, and Americans in general, have a St. Joseph's table or serve St. Joseph's Day food. This is due to great publicity the Feast Day has received in a number of American newspapers, magazines, and other media. The custom of St. Joseph's Table began in private homes. Individuals who received favors through St. Joseph's intercession would promise altars to honor him. At first it was a private affair, a simple table with a statue of St. Joseph with the Christ Child and traditional foods. In some areas of Sicily, there was a community altar as well as family altars. The poor would be invited to attend the Community Altars. This part of the tradition is based on Scripture, "But when you make a feast, call the poor and you will be blessed because they don't have the means to make recompense."

There is also a beautiful religious tableau connected with the St. Joseph's Table, which is

reminiscent of Biblical Times. The Holy Family and the Saints parade around the exterior of the house where the St. Joseph Table is held. Mary and Joseph knock and ask for shelter, but the door is slammed in their faces. The third time around, Jesus knocks on the door, "Who is there?" asks a voice from within the house. Jesus replies, "Jesus, Mary and Joseph." The door is then opened and all enter. The person playing the Child Jesus blesses the altar with a sprig of parsley dipped in Holy Water, making the sign of the cross. In actuality, the priest blesses the altar the night before. There are many other beautiful rituals such as washing the feet and special prayers, including a pause for special intentions and lighting candles. After prayers, the Holy Family proceeds to eat from the altar. There are toasts and may cries of "Viva San Giuseppe!"

Saint Joseph was a holy man and a great man. He was, and is, very special to God. His day is a cherished celebration. The traditional St. Joseph's Day feast varies across the nation with special St. Joseph liturgies, parades, dances, altars, dinners, etc. There is a bright side to the dreariness of March; it is March 19th, St. Joseph's Day. THE INSATIABLE AUGUSTUS

During the past six weeks, we have been examining the early career of the grandnephew of Julius Caesar named Octavian, who became the first emperor of the Roman Empire. He ascended the throne after the death of Caesar, took the name of Augustus, and reigned for about 41 years. Continuing with this ten-part series, we find that not unlike all public figures, Augustus received his share of criticism. It was Marc Antony who claimed that as a seducer and adulterer, Augustus walked in the footsteps of his granduncle Julius, a fact that even his friends did not deny. They excused it by claiming that these acts were committed as a matter of policy and not out of passion. Marc Antony made numerous other accusations about the moral conduct of Augustus. References were often made to his hasty marriage to the pregnant Livia, and to the fact that his second wife Scribonia was divorced because she voiced strong resentment to the excessive introduction of a rival. Others implied that the rival was Livia.

Antony also claimed that friends of Augustus acted as panderers, stripping and in-

specting matrons and wellgrown girls as one would the slaves on the block before presenting them to the emperor. The charges of unnatural voice by Marc Antony were denied by offering evidence as to the purity of Augustus' character, but the charge of lustfulness could not be disputed as it became common knowledge among his inner circle of friends that he was fond of deflowering maidens. These were selected by friends from throughout the Empire. It is said that some of the maidens were even selected by his wife Livia.

Another charge of Marc Antony's that could not be refuted was that Augustus took the wife of an ex-consul from her husband's dining room right before his eyes and brought her into a bed chamber. It is said that when they eventually returned, her hair was in disorder "tutto sciatto" and her ears were glowing.

Wealth, power, and adultery seem to be "kissing cousins" with all emperors, and with Augustus it appears to have been his way of keeping track of his adversaries. The Wicket mart Investor

Employ the Wisdom of Cover Bands

It's normal to feel vulnerable when hiring an investment advisor. You may get a nagging feeling you're not getting good advice. This pain is easy to avoid; hire someone who acts like a cover band and borrows heavily from the masters.

To explore this suggestion I trudged out to see my buddy Clarkey's band, The Section 8s. Frankly, I'm surprised that Clarkey has a band at all, since he was one of the principal disruptors of Mr. Binney's seventh grade music class. But I give Clarkey credit since the last time I sang karaoke, the audience was actually throwing wet cocktail napkins at me.

When I enter Clarkey's venue du jour, I get a much better reception. "Christopher sit over here," he calls from the stage and I dutifully study his showmanship with affection. My buddy's act is an amalgamation of rock legends; he's got some of Aerosmith's Steven Tyler's goofy moves, a harmonica sound like J. Geil's Magic Dick, and the musical breadth of The Car's Ben Orr. I don't know what explains the Engelbert Humperdinck haircut, but to each their own. When he finishes the set with Tom Jones' "She's a Lady," I chuckle. Clarkey thinks he's just as smooth with the ladies as Tom ain't that a joke. What isn't a joke is that the skilled musicians are well-rehearsed and their deep song repertoire doesn't disappoint. Seeing a Section 8 show is a great night out.

Clarkey's show is entertaining because he doesn't try to reinvent the rock-and-roll wheel. He imitates legends that have sold millions of records and scored huge hits. The crowd loves it. If your advisor adopts the same approach and mimics the maestros of investing, you'll likely improve your results.


So, who are these financial whiz kids and why are they so wonderful? They are researchers that you probably never heard of because they work for think tanks and universities, not some out-of-tune brokerage firm with a huge advertising budget. Please bear with me as I have to use some highfalutin' language as I detail some of their works. There is Harry Markowitz, who developed the Modern Portfolio Theory, a framework for building a portfolio. His colleague William Sharpe developed a tool for risk adjusted investment performance analysis, the Sharpe Ratio. Also adhering to the evidence-based investing school of thought is Eugene Fama. He is credited with the Efficient-Market Hypothesis. What makes this research so valuable is that it has no inherent bias, just proven results and a long track record. All of these eggheads have won Nobel Prizes for their work.

If you have the patience to read this peer-reviewed research, it is real good stuff. But I must warn you, it's very dry to most people. But the essence of the research is giving it to you straight like Clarke would. He just delivers the facts in a far less polished, far more hot-headed manner. (Sorry Bro!)

If your advisor adheres to the philosophy of evidence-based investing, it should be music to your ears. Your investment choices aren't based on a hunch or an opinion, but on actual science. There is no room for last year's star money manager as he is probably a One-Hit Wonder. Sticking with this approach will likely give you more good years than bad.

I could go on about Clarkey, but I am bound by a somewhat sacred agreement among us local celebrities. Besides, The Wicked Smart Investor isn't giving it up for free. I'll wait until VH1's Behind the Music comes knocking with checkbook in hand.

Saint Louis Bertrand

Louis Bertrand was one of nine children born in Valencia on January 1, 1526, to Juan Bertrand and Juana Angela Exarch. Through his father, he was related to Saint Vincent Ferrer. He conceived the idea of becoming a Dominican friar while still very young and was clothed with the Dominican habit in the Monastery of Saint Dominic, Valencia, on August 26, 1539. After the usual period of probation, he pronounced the evangelical vows and was ordained to the priesthood in

He was appointed to the office of Master of Novices in the Dominican Monastery at Valencia. He taught the novices to give themselves completely to God. When the plague broke out in Valencia in 1557, he devoted himself to the sick and dying; he prepared the stricken for burial and interred them himself. When he first began



to preach, it did not seem as though he would be very successful, but his deep love for souls brought great results. When the plague had subsided, he turned his attention to preaching, which he did

fervently. He filled the cathedral

to capacity and eventually it became necessary for him to resort to preaching in the public squares of the city. It was probably the fame of his preaching that brought him to the attention of Saint Teresa of Avila, who sought his counsel in the matter of reforming her Bertrand had long desired

and the most spacious churches

to perform missionary work in the New World. Upon receiving permission, he sailed for the Americas in 1562, at the age of 36, landing at Cartagena, Colombia. He immediately began his missionary work. Saint Louis was then sent to Panama, where in a comparatively short time he converted some 6,000 natives. He next turned to Tubara, where he converted 10.000.

After seven years as a missionary in South America, Bertrand returned to Spain in 1569 to plead the cause of the oppressed natives, but he was not permitted to return to his missionary work. He used his own growing reputation for sanctity, as well as family and other contacts, to lobby on behalf of the native peoples he had encountered as he served in his native diocese of Valencia where he also became a spiritual counselor to many.

In 1580, Bertrand fell ill and passed away on October 9, 1581. He was canonized by Pope Clement X in 1671. His feast day is observed on October 9th. Saint Louis Bertrand is sometimes called the "Apostle of South America."



L'Anno Bello: A Year in Italian Folklore

Reflections of Lent

We find ourselves in the midst of the changeable month of March, and spring seems palpably in our grasp. Sparkling shamrocks and mischievous leprechauns adorn doorways and windows across my town, reminding me of the upcoming St. Patrick's Day festivities. Robins herald the arrival of a new season with their blazing red breasts as they hop about on the slowly-budding tree branches. However, though the signs of spring prove plentiful, other aspects of nature tell us that we are still in a period of transition, when the weather remains as unpredictable as the March winds. Clumps of old snow, stubborn to melt, cling to the ground under trees or on the edges of parking lots, while an occasional slate-gray sky threatens additional wintry weather. Bursts of frigid air still send us scrambling for heavy coats, scarves and gloves. In supermarkets, agricultural produce comes to a virtual standstill, as the lemons and oranges of winter dwindle before they can be replaced by the tender greens and herbs of spring. During this time of the year, when winter reluctantly yields its hold on spring, folk customs around the world honor the changing of the seasons. For example, we are now in the period of Lent, an interval which boasts profound religious significance but also cultural and seasonal importance. Lent mirrors the changes occurring in the natural world and guides us towards spring with a sense of promise, hope and renewal.

This year, Lent began on March 1st, Ash Wednesday. It covers a 40-day period prior to Easter, the most important feast in the Christian calendar. These days serve to prepare the faithful for Easter through purification rituals such as prayer, fasting, charity and

self-reflection. The timing of Lent is highly symbolic, as it occurs during a seemingly barren season in which nature also purifies herself after a long winter, emerging ready for the rebirth of spring. In order to appreciate the glory of Easter and spring, we need to embrace the seasonal transition with contemplation and introspection, an opportunity which Lent generously affords us. When my father was a child in Italy, Lent, or la Querisma, functioned as a somber and austere period, matching the chill sterility of nature. Though the rules have relaxed since then, the rite of purification remains the crux of Lenten customs in Italy and beyond. This explains the popular practice of giving up a bad habit or an indulgence for Lent, a tradition which is not mentioned in the Bible, but nevertheless fits seamlessly with the folkloric cleansing rituals of the season. The purpose of this Lenten abstinence should not be deprivation, but rather a chance to examine our values or priorities and improve ourselves. This Lent, for example, I gave up my beloved iced chai lattes in order that I may stretch out of my comfort zone and discover new flavors. The promise of Lent, however, stands in the fact that all of our hard work will be rewarded with a beautiful springtime. After all, the English term for Lent shares the same root with the word lengthen, referring to the growth of daylight in the spring sky!

Lent means more than saying goodbye to your favorite treat, though. In Italy, this meditative time inspired the creation of unique folk traditions and customs that would come to define the tapestry of pre-Easter celebrations. The most famous Lenten rule involves the forbidding of meat on Fridays; so Italian cooks devised many fish and

vegetable dishes for these days. A visitor to Italy during Lent will notice farmers' markets bursting with fresh fish and baccalá (dried cod), along with the first spring vegetables from which can be crafted a nourishing minestrone. Italians also snack on quaresimali, or almond biscuits, which, as the name suggests, are made especially for Lent. According to the author Helen Barolini in her book Festa, a simple and customary Italian Lenten dessert is pizza frita — fried dough sprinkled with sugar. My mother and grandmother would frequently whip up this dessert when I was younger, much to my pleasure, though I only recently learned of its Lenten connotations. The people in Italy also celebrate the fourth Sunday of Lent as Mezza Quaresima, or mid-Lent. These festivities mark the halfway point of Lent and honor the imminent arrival of Easter, and many Italian towns and cities hold parties and processions reminiscent of Carnival. Of course, due to the self-reflection and sacrifice that accompanies Lent, it is important to remember that giving is just as powerful as abstaining. People in Italy and around the world commemorate Lent with charity and community service, and truly there is no better way to spread the light of spring than by helping others.

Though the checkered March weather makes it appear as if winter will never quite lose its grasp on spring, holidays like Lent skillfully guide us in managing this transition and welcoming a new season. Now that the luxurious chocolates of St. Valentine's Day and the raucous Mardi Gras decorations are swept away, the time proves right for purification and introspection. The rites of Lent, replete with their emphasis on self-improvement and reflection, echo the regeneration of nature as the vernal equinox, and later Easter, approach. Lent is a time to do good deeds, to ruminate on the successes and challenges of the past year, and to cleanse yourself of negative emotions and distractions prior to the triumph and rejuvenation of spring. Significantly, Lent is a season of hope — hope for the promise of Easter and hope for the return of the spring sun. Nature will reawaken, the sun will resplendently shine, and the wheel of the year will roll on, carrying with us through life's treasures.

A Moving Look at the Challenges of Being Kind

Grand Concourse

SpeakEasy Stage

The SpeakEasy production of Grand Concourse by Heidi Schreck now playing at the Calderwood Pavilion in Boston's South End is one of those truly wonderful theatre experiences that touches on so many emotions.

There are four characters in this play that takes place in the food preparation area of a soup kitchen in the Bronx. As the play progresses, the depth and struggles of each of these individuals becomes more apparent. It is impossible to watch this work and not become emotionally invested in each one of them.

Shelly, played by Melinda Lopez, is the Catholic nun who runs the kitchen. She is committed to her work but is having doubts about her faith and purpose. She practices praying while using a microwave timer. Shelly is a kind and compassionate human being, but is that enough and what does it mean to be compassionate? Melinda Lopez brings depth and warmth to Shelly. I felt I had known her for years.

One day Emma, a college dropout, stops by and offers to volunteer. At first, she seems like a young person who wants to do something good, but as the play progresses we see there is much more going on with her. Played by the very talented Ally Dawson, Emma is very manipulative and makes things quite difficult for the others. She also accomplishes much good while pushing the others to the limits of their compassion. Ms. Dawson handles this very complex character perfectly. It is an emotional roller coaster watching her, and I have to say I felt drained by her actions. However, it was in a way that made me feel good in the sense that I was forced to look more deeply into someone whom it would have been very easy to write off as superficial and self-absorbed.

Thomas Derrah plays Frog, a homeless man who has been a regular at the soup kitchen for some time. In between telling and selling jokes to the others, he also spins his philosophy on life and insights into people and society. I have seen Mr. Derrah perform for more years than I would like to admit, and I have to say it would be a challenge to find an actor who can match him for how consistently good he is. He certainly does not disappoint here. He makes many entrances and exits in the course of this production and each one is fresh and outstanding.

Oscar, played by Alejandro Simoes, is the maintenance man. He is funny and kind. Oscar was a dental student in his native Dominican Republic and is now struggling to put a life together in the United States and marry his girlfriend Rosa. At first he appears to be a fairly light character, but Mr. Simoes treats us to a man who has weaknesses and conflict but is filled with decency. He truly touches us with his goodness.

Grand Concourse easily could have been a very predictable and formulaic work about people helping people and getting caught up with the conflicts in their own lives. At first I thought that's where it was going. What author Heidi Schreck has given us is a play that goes much deeper than that. I was very moved by this play. It compelled me to ask just what it means to have compassion and what its limits. The Catholic social activist Dorothy Day once said her purpose was to comfort the afflicted and afflict the comfortable. Well, it's not always easy to tell who is afflicted and who is comfortable.

I have to admit I left the theatre emotionally spent. It was an amazing afternoon watching terrific actors working with a fine script that was well-directed and staged beautifully. I highly recommend Grand Concourse. The SpeakEasy Stage has done it again and this is a play not to be missed. You will be deeply moved by what you see.





A Nostalgic Remembrance



Easter will be here before we know it and I thought I would begin my Easter stories with one that I've briefly mentioned a couple of times in the past. Of course, seeing that these events took place when my mother and uncles were kids, I can only relay excerpts from stories my mother and grandparents told

It was the early 1920s when Babbononno purchased the house at 70 Eutaw Street in the Eagle Hill section of East Boston. Like many Italians, he and Nanna grew vegetables in the backyard. My grandfather even planted a peach tree in one of the corners of the yard that was separated from the yards of the houses to the left and right of us, and the yard jutting out from the house opposite us, which was located on Monmouth Street. Oh by the way, the separation of yards was indicated by wooden picket fences, which my mother and uncles learned to climb over at early ages.

It was 1924, I think, and Babbononno had built a shed in the backvard to house anvthing that should be covered during the winter or that he didn't want to store in the cellar of the house. Easter was on April 20th that year, so I guess the year was 1924. Anyway, Babbononno came up with an idea that winter. He decided to buy a live lamb and raise it for a few months and then slaughter it for Easter dinner. He insulated the inside walls of the shed and this is where the lamb slept at night. During the day, it was fed foods that would make it grow and fatten up. Everyone in the family knew the fate of the lamb and could almost experience the taste that could be expected on Easter. Everyone, with the exception of Uncle Gino. My youngest of uncles was going on seven and assumed that the new member of the family was just another pet, not unlike Babbononno's dog or Nanna's cat.

I have a hunch that my uncle brought the lamb into the cellar of the house and played with it after school each day. If he did, I would assume that my uncle fed the animal a portion of the lunches that Nanna made him. By the time Babbononno would arrive home from work, the lamb would be back in the shed and his kids would be washed and ready to eat dinner. After dinner, my grandfather would take the scraps left over from the meal and bring some of them out to the shed. During the mornings, after Babbononno had left for work and her kids were at school, Nanna would feed the lamb. As a result of all of the food, the lamb grew tall and fat rapidly. Oh, just to set your minds at ease, the meat scraps weren't given to the lamb. The cat and dog enjoyed these 1eftovers

I don't know how old the lamb was when Babbononno bought him, but by the time April rolled around, it was large enough for slaughter and the Contini Easter dinner table. All of the Continis knew the facts and observed the readying process; that is, except Uncle Gino. The lamb had become his personal

March the 5th was Ash Wednesday that year, and Babbononno began paying more attention to the lamb. Everyone knew why except my youngest of uncles, who probably assumed that his father loved the animal as much as he did. Babbononno did, but for different reasons. I don't know what things were like during the following few weeks, but after Palm Sunday, which was on April 13th that year, the Contini family began to prepare for Easter. New clothes, family attendance at Easter Mass, and Sunday dinner with the extended family invited to join in. Everything was happening smoothly until the Contini family returned from Mass and Uncle Gino headed out to the shed to play with his pet--but it was nowhere to be found. He was beside himself with worry until Nanna told him that the animal probably went for a walk and would be home later.

Once the extended family arrived, the children of Zi' Antonio and Zia Mariuccia (Nanna's brother and his wife) began to play with the Contini kids. The two families were always very close and several cousins would socialize long after they had families of their own. The interaction of the two families made my uncle temporarily forget the disposition of his pet lamb. About an hour after the arrival of all of the people who were invited to Easter dinner, they were informed that it was time to sit at the dining room table.

Nanna and my mother, who would turn 15 that May 17th, began to serve Easter dinner. First was the soup course, escarole soup with pasta and tiny meatballs (the type that the Americans call Italian Wedding Soup). Next, the home-made ravioli, the meatballs, and the sausages, the chunks of gravy meat (especially the pork), the dishes of sautéed vegetables, the stuffed artichokes, stuffed mushrooms, the eggplant, and finally, the large roasted animal which was placed in the center of the table.

Uncle Gino, being a rather intelligent young lad, put two and two together, and it added up to five. He looked at the roast that was placed in the center of the table, began to scream and ran from the table. No one could console him, and after a while, they left him to his own devices as he locked himself in his room and cried the rest of the day.

That was Easter of 1924, 93 years ago. Uncle Gino will turn 100 this June, a survivor of many Pacific battles during WWII. He is the father of two and the grandfather of four, a man who was successful in business all his life. But according to Aunt Ninna, his wife, my uncle hasn't eaten lamb since she has known him, and has stated that the story she got from my mother (may she rest in peace) indicated that Uncle Gino hasn't eaten lamb since that day in 1924.

This was a fond memory from when my mother's generation was alive. Uncle Gino is the last one left of all his cousins. He is the last one of the first generation of my family born in America.

Between Christmas and New Year's this past December, my son, John made arrangements to bring his new daughter, Lina, to visit her great-great uncle and aunt. He cooked a dinner for them and, along with my youngest son, Michael, and me in tow, headed to Uncle Gino's place. On the way home, I told my sons about the Easter dinner of 1924, when my mother and her brothers were kids and the lamb that was sacrificed for a holiday dinner.

I've never mentioned Easter of 1924 to my uncle. I wonder if I ever should???

PIZZA GHENA "Peeza Gay na" Easter Ricotta Cheese Pie with Meats

CRUST:

1 cup lukewarm water 2 to 3 packages dry yeast 6 tablespoons vegetable oil

1 teaspoon salt

1 1/2 teaspoons sugar

Preheat oven to 400°F.

6 to 7 cups flour — preferably King Arthur or Gold Medal 1 beaten egg for egg wash 1 9" x 12" x 3" baking pan

1/8 teaspoon black ground

Pour water into a bowl. Sprinkle yeast over water. Stir until yeast dissolves. Add oil, sugar, salt, pepper and stir. Add flour gradually until all water is absorbed. Add additional flour if dough is too soft. Work dough into a soft ball. Knead dough for a minute and then separate into two portions. Spray vegetable oil lightly into a bowl before placing the two portions in it. Cover and let dough rise to twice its size.

Spray oil lightly over entire inside of baking pan. Moisten hands with oil for ease of spreading risen dough in baking pan. Then take one portion of crust dough out of bowl. Begin spreading and flattening it out by hand or with a rolling pin. Place it gently in the baking pan. Continue spreading by hand until the dough covers the entire inside of pan (including the four sides) all in one piece. Crust should be about 1/8 inch in thickness. Set aside. 1/2 pound sliced Prosciutto*

FILLING:

8 beaten eggs 1 pound ricotta cheese 1 pound fresh formaggio cheese 1/2 cup freshly grated Romano cheese

1/2 pound sliced ham of

pepper * Other dried cured meats such as sopressata, pepperoni, and various salami slices can be added if desired.

1/2 teaspoon black ground

1 teaspoon salt

choice*

FILLING MIXTURE:

In a large bowl, place ricotta cheese, fresh cut-up formaggio cheese, grated Romano cheese, salt and pepper. Mix gently with a fork. Cut up ham and prosciutto* slices into smaller portions and add to bowl. Add eight beaten eggs. Using a fork or spoon, mix thoroughly. Gently pour filling over bottom crust in the baking pan. Fill only about two-thirds of the baking pan, leaving about one inch or more from top edge of pan.

Spread top crust to about 1/8 of an inch in thickness and large enough to cover mixture as one piece in baking pan. Then place over mixture. With your fingers, gently crimp edges of the two crusts together and roll inward to seal mixture in baking pan. If desired, crimp edge portions with fork. This is necessary to prevent mixture from seeping through any openings while baking.

With pastry brush, spread egg wash over entire top crust. Prick three or four small openings in top crust to help moisture escape

Place baking pan in middle shelf of preheated 400°F oven for one-half hour. Then lower to 350°F and continue baking for about three-quarters of an hour. Then lower oven to 300°F and continue baking until the crust is golden brown. Check mixture after two hours of baking by inserting a thin small knife into center. If knife blade comes out dry, mixture is cooked.

Cool this special Easter Pie for at least eight or nine hours for best results. Pie is served in square portions. Makes 16 to 18 portions.

The Twilight Zone Movie Accident:

A Hollywood Tragedy

Despite the hot talent involved (Steven Spielberg, John Landis, and William Shatner), Twilight Zone: The Movie was going to be something of a boxoffice challenge almost from conception. Sure, fans of the classic TV series of the late '50s and '60s were likely to go, even if accompanied by skepticism. The charm of the TV series was its stark, haunting look and simplistic settings, and usually no more than a handful of characters appeared. A big-budget color production with a topselling talent from the early '80s seemed hardly an appropriate way to salute a favorite. And yet, Warner Bros. went on in what was, in hindsight, the smartest way possible. It took four of the classic episodes and retold them with modern technology. If nothing else, this would prevent criticism of taking liberties with familiar and fondly remembered

And yet, the misfortune that befell the movie during production was something unprecedented in Hollywood; it not only set new standards, but no amount of publicity could shake it off. In a dark spot in movie history, three people were killed on set — actor Vic Morrow and two child actors.

The incident happened on July 23, 1982, during the shoot of the John Landis segment, which was based on the episode "A Quality of Mercy." The story followed a loud-mouth racist, played by Morrow, who is transported to the old South where he is persecuted by a lynch mob; a concentration camp in Germany; and, finally, to Vietnam.

Landis must have known he was heading for trouble when he violated a number of safety laws involving child actors, among them, shooting at night. Landis refused to apply for a waiver, believing it would be denied when it was revealed the children would be working near pyrotechnic effects. To

circumvent the need for a permit, the two child actors were paid under the table. The parents of seven-year old Myca Dinh Le and six-year-old Renee Shin-Yi Chen were wary of allowing their children to work in a film, but ultimately agreed, believing it would be a good experience.

Many things went unsaid. The firefighters supervising the effects on stage were never told children would be involved, and the fire inspector had a strong fear that the pyrotechnics would cause the UH-1B helicopter used in the scene to crash, but he never shared his concerns with Landis.

The helicopter and the explosion effects were to be used in a scene where Morrow walked with the two children through a river (made up to be in the jungles of Vietnam, but actually filmed in the popular filming location of Indian Dunes) while the chopper flew above. Darcey Wingo, a Vietnam veteran with much experience, was piloting the helicopter. When filming began, Wingo turned the chopper to the left of the camera while the pyrotechnics were released to simulate a bomb going off in the war zone. What remains clear is that the effect went off too soon, while the helicopter's rotor was still above it, sending

the aircraft spinning out of control and into the water, killing Morrow and the two children.

Much would be said later. Many on the set, including the children's parents and camera operator Stephen Lydecker, would testify that Landis, despite becoming aware of the risks, kept demanding the helicopter fly lower.

The trial that came from this would be a sensational one that brought many changes to safety in filming, shaking the film industry. It was also the first time a director was charged with manslaughter for a death during production. As Mark Locher, spokesman for the Screen Actors Guild, said, "The entire ordeal has shaken the industry from top to bottom, with every actor concerned about their own safety and studio managements saying 'let's not take a risk."

Between civil and criminal charges, the trials lasted nearly a decade. In the end, all those charged with manslaughter (Landis, Wingo, associate producer George Folsey, Jr., and production manager Dan Allingham) were acquitted in what many consider to be a case of power overstepping justice, and civil suits with the families of Morrow and the two children were settled. However, that is not to say that Landis' career had a smooth ride from then on. He did continue directing immediately after the tragedy, including hits Trading Places and Three Amigos, but his legacy would always be marked. His friendship with Steven Spielberg also came to an end. Spielberg openly stated to being sickened by what happened and added, "No movie is worth dying for. I think people are standing up much more now than ever before to producers and directors who ask too much. If something isn't safe, it's the right and responsibility of every actor or crew member to yell, 'Cut!'"

In Spielberg's comment there is a hint of the positive things that came from this. Warner Bros set up a safety committee that would strictly supervise every aspect of production. The Directors Guild of America started penalizing members that violated safety regulations and the Screen Actors Guild began encouraging actors to refuse shots that endangered them. For the next few years, helicopters were not used in the same shot as actors, the effect of proximity to the flying machines achieved by crosscutting.

But in this landmark case that has become a mark in Hollywood history, there were no winners. As even John Landis explained, "There was absolutely no good aspect about this whole story. The tragedy, which I think about every day, had an enormous impact on my career, from which it may possibly never recover." In the end, that was the most sensible thing he said during and immediately after the whole mess.



games, achieving that feat in 1951 with the St. Louis Browns, who moved to Baltimore and became the Orioles in 1954. He went 20-12 in 1951 while the Browns finished in last place going 52-102. He batted .305, and hit a home run on the final day of that season when he recorded his 20th win. Ned Garver recently passed away in Bryan, Ohio, at age 91.

He was runner-up for the AL MVP, losing to Yogi Berra from the pennant-winning NY Yankees, who finished 46 games in front of the lowly Browns. Garver also led the league with 24 complete games and started the 1951 All-Star game.

He was only 5' 10" and 180 pounds, but his sinkers, sliders, and change-ups took advantage of hitters' weaknesses. He pitched 14 seasons, going 129-157. Satchel Paige, who was a teammate of Garver on the Browns, once said, "Next to me, Ned knew more about baseball than just about any pitcher in the American League." By the way, other than Garver, no pitcher on that horrible 1951 team won more than six games.

After leaving the Browns, he spent four seasons pitching in Detroit, and then four seasons in Kansas City, then retired during the 1961 season with the LA Angels.

He may not be known by many baseball fans, but his achievement in 1951 was one of the best seasons a pitcher could have in a lifetime of baseball.



HOOPS and HOCKEY in the HUB

It isn't often in the NBA that the defense can be publicly proclaimed for winning a game. After all, at a level of the game where contests are often high scoring affairs, does real tight defense really matter?

Yes it does. And it can be the reason games are won or lost.

A case in point was the Celtics memorable 103-99 victory over the reigning NBA Champion Cleveland Cavaliers at the Garden back on March 1st. It was a game to circle on the calendar and it didn't disappoint.

The contest was probably the best home game of the regular season between two teams who may very well meet in the Eastern Conference Finals in the spring. Just how good was it? Well, the game featured 24 lead changes and was tied 19 times as each side briefly held the upper hand on numerous occasions.

As it does in a fair number of NBA games, this one came down to the final minute — or rather to the final 38 seconds, during which the Cs effectively shut down the Cleveland scoring spigot, blanking the Cavs during those final 38 ticks on the clock.

On a night where LeBron James would record his seventh triple double of the season and the 49th of his career with 28 points, 13 rebounds and 10 assists, it was all about shutting down King James and teammate Kyrie Irving (also 28 tallies) as those precious last seconds went by.

And indeed it happened. After Irving scored on a driving reverse layup with those 38 seconds left, the Cavs would not score again in the most crucial moments of the game.

Some 10 seconds later, Isaiah Thomas, an excellent 91 percent from the line this year, would sink two free throws to give the Cs 101-99 lead with 28 seconds remaining.

And then came the biggest stop of the year. For the next 23 seconds, the Cs threw up an iron curtain. No one could penetrate the defensive wall of the Celtics. King James tried but could not; several other also made attempts but to no avail. Finally, with one second remaining on the 24 second clock, Deron Williams let fly a three-point attempt from 25 feet out.

Boston's Jae Crowder gathered in the rebound, was fouled by James, and then calmly sank two free throws to give the Cs a four-point, 103-99 lead with just four seconds left, effectively putting the game out of reach and sealing the deal on a sensational triumph by the Celtics.

Postgame, the corridors seemed like a receiving line as coach Brad Stevens made the long walk from the Celtics locker room to the media room for his press conference. It seemed as though everyone stationed in the corridors wanted to shake his hand.

Stevens indicated that as the team prepared for the game,

he was more concerned about quality of play. "I told them I wasn't as concerned about the result," explained Stevens from the podium. "I just wanted to play with a real purpose from possession to possession and maximize as many of those as possible. We did a better job of that than we have in a lot of games this year. We just played with the right poise and purpose. Hopefully we can keep doing it."

The coach singled out Avery Bradley for his job defending Irving. "Irving is a tremendous scorer," observed Stevens. "He's a hard guy to stop. But having a guy like Avery out there means something. He makes it as tough as humanly possible when he's guarding somebody."

And Isaiah Thomas, a pacesetter for the Celts, felt that the strong defensive effort "was very important. If we want to win, we have to play that way. We tried to slow down their transition points and keep them off the glass. I think we did a good job with that and we got the win."

Fast forward to March 7th and the Celtics were atop the Atlantic Division, having finally overtaken the Toronto Raptors. They were also the second best team in the Eastern Conference, trailing the Cavaliers by just 2½ games to play with 19 games remaining in the regular season. Of course, anything can happen, but right now it looks like the Celtics stand a pretty good chance to play the Cavs in the Eastern Conference finals in May.

While that scenario may not come to pass, it shows the vast improvement that the Celtics have made that we can even consider the possibility. The teams will meet once more in the regular season — on April 5th at the Garden — as the countdown to the end of the regular season on April 12th looms

This should be a big game, offering a possible playoff preview and possibly impacting the conference standings in a significant way.

Regardless of how the Celtics fare against the Cavs, the feeling of several members of the media along press row is that while the Celtics can beat the Cavaliers on any given night, they would probably not be able to win four games in a best-of-seven series with Cleveland. The feeling is that the Celtics are a key player or two away from being able to do that

Right now, the Cavaliers represent a big bump in the playoff road for the Celtics. One gets the feeling that Cs, as presently constituted, would have a very good chance of advancing through the first two rounds of the playoffs.

It's in the Conference Finals where they would probably be stopped, a situation that may not be remedied for this spring, but will definitely be addressed by GM Danny Ainge as he heads into the NBA June Draft and the summer free agency period.
