## L'Anno Bello: A Year in Italian Folklore Lucky Spring!

Ah, spring! I can feel the blossoming of Mother Earth all around me whenever I step out the door. The arrival of the new season is present in the gurgling sound of melting snow dripping down the drain. It is in the flash of red feathers I saw as a robin danced among the bare branches of my backyard tree. It is in the sparkling green shamrocks and pastel-hued Easter eggs adorning doors and shops. Yes, as the weather skyrocketed up to a balmy 50 degrees this past week, I find myself bouncing with an undeniable case of spring fever. After such a difficult winter, the call of spring resounds so much more profoundly, awakening not just the vegetation of the Earth but also the energy and good humor of all living beings. A time of such joy calls for a celebration. Fortunately, this upcoming week sports two separate spring holidays that instill us with the beauty of the season. March 17th is St. Patrick's Day, a feast of green. Two days later comes St. Joseph's Day, a traditional Italian celebration honoring one of the country's most beloved saints. Collectively, these holidays usher us into spring with

cherishing the treasures of the Earth as they become available. However, St. Patrick's Day is more than just a chance to indulgence in delicious food. This feast honors St. Patrick, or San Patrizio in Italian, a Roman-British man who was brought to Ireland as a slave. A popular legend about St. Patrick says that he used a shamrock to teach people about the Holy Trinity, thus marking this little spring plant as one of the most unforgettable symbols of the holiday. St. Patrick's Day reminds me of spring days when the trees look especially lush and green after a sudden shower, and an ephemeral rainbow graces the sky. It is a holiday of spring, and that is why it will forever be celebrated with much love.

On March 19th, another spring holiday approaches, one that is very dear to my family. It is St. Joseph's Day, or il Giorno di San Giuseppe in Italian. # Stirpe Nostra

#### **APHRODITE**

Aphrodite is most popularly known as the Greek goddess of Love. According to ancient tales she was the daughter of Zeus and the goddess Dione. Legends tell us that Aphrodite first appeared to the mortal world as a goddess who was born out of the ocean foam and first stepped ashore on the island of Cyprus during Phoenician times. Initially, she was worshipped as the goddess of love but in later years her influence was extended to maritime traffic, tranquil seas, and prosperous voyages. Those mortals who were not seafaring people knew her as the goddess of spring, gardens, and groves.

Notwithstanding all of the above, in the world of mythology Aphrodite showed her full power as the goddess of love and beauty. She was above all other goddesses in loveliness, grace, magic charms, and captivating beauty; irresistible to the wisest mortal and able to subdue any god. Even the legends surrounding the Trojan War place Aphrodite in the events that lead to the hostilities. Eris, the goddess of discord threw a golden apple among the assembled goddesses. The apple was inscribed "For the fairest". An ensuing quarrel between Aphrodite and the other goddesses was finally

referred to Paris, a shepherd on Mt. Ida, whose judgment was to be final. Each of the contestants offered gifts which were intended to influence Paris' decision. One goddess offered a kingdom, while another offered intel-

lectual superiority, etc. The prize was finally assigned to Aphrodite who promised Paris the fairest woman in the land for his wife. Due to Aphrodite's delay in paying her debt, plus the coincidence of Paris' voyage to Greece, advantage was taken of an opportunity to abduct the fair Helen, wife of Menelaus, a Spartan king. The Trojan War, as you know, was fought in order to secure the release of Helen and to return her to Menelaus.

Mythology places Aphrodite as the wife of Hephaestus, smith of the gods, but there are also stories of notorious escapades with other gods. One such escapade with a member of Trojan royalty produced Aeneas, who later became known as the ancestor of the Roman race.

Aphrodite became a favorite subject with the ancient artists, but was represented in whatever mode suited their individual interest at that particular time. Early works showed this goddess clothed or draped, while in later years, she was generally shown undraped, rising from the sea, or leaving her bath. Speaking of baths, excuse me while I try to find some soap.

#### You Cannot Build Up by Tearing Down

A friend recently sent me a Huffington Post essay written by Cambridge's Robert Reich. I read things from Professor Reich from time to time and always end up at the same conclusion: Reich is smart and perceptive; he has a knack for finding a neglected truth that, once put into writing, seems so self-evident that you can't believe you missed it; but at the end he falters and falls into old left clichés, debunked Keynesian economics, and 1930s Socialist cant.

Reich in this piece "The Republican Shakedown" accuses Republicans of being tools for the rich, hoodwinking middleclass Americans (in the largely non-unionized private sector) into thinking that government and unions in the public sector are the cause of our economic stagnation under President Obama. Implied is a "divide and conquer" theory of domination of the system by the rich and powerful.

Certainly, I agree that setting one part of the middle class (private sector) against another (public sector) is not good for either. In the past we Americans had leaders, such as Ronald Reagan, who (quoting William John Henry Boetcker (1873–1962) proclaimed: "You cannot lift the wage earner by pulling down the wage payer." To which I add: you cannot rise up private-sector workers by tearing down publicsector workers. And, from the article, it appears that Professor Reich agrees, so far.

However, this is exactly where Reich, who is so perceptive up to this point, goes on autopilot and lapses into socialist canards. His solution is not to stop trying to better vourself by tearing down someone better off, rather his answer is to tear down someone even better off. Aside from the question of whether "soaking the rich" is sound policy economically or ethically, Reich's flawed conclusion — we need substantial tax increases on the rich — is absolutely refuted by his argument. On the one hand he says the problem is that the rich have distorted and broken the system. On the other hand he says the answer is higher taxes on the rich. But if the rich have the inordinate influence he says, then won't they simply use it to corrupt the tax code in their favor?

The answer is not to tear down the rich but to build up the middle class. To do that we need to rebuild our manufacturing economy, and to do that we need to press the "reset" button on our trade policy and reject the free trade agreement with Communist Vietnam that President Obama is pursuing. We also need to embrace a trade policy which includes provisions to offset the value added taxes of our trading partners and a tariff that compensates for some trading partners' illegal currency manipulation. Rather than Professor Reich's "shakedown" what we need is a SHAKE-UP in Washington, and the Republicans may be the only ones who can do it.

## Saint Matilda of Saxony

Matilda, also known as Mechtildis and Maud, was the daughter of Count Dietrich of Westphalia and Reinhild of Denmark. She was raised by her grandmother, the Abbess of Eufurt convent.

Matilda married Henry the Fowler, son of Duke Otto of Saxony, in the year 909. Henry succeeded his father as Duke in the year 912 and in 919 he succeeded King Conrad I to the German throne.

Matilda was noted for her piety and charitable works. She was widowed in the son Henry's claim to his



year 936, and supported her elected, she persuaded him to name Henry Duke of father's throne. When her Bavaria after he had led an son Otto (the Great) was unsuccessful revolt. She

was severely criticized by both Otto and Henry for what they considered her extravagant charities.

After her husband died in 936 at Memleben, Matilda and her son, now King Otto of East Francia, established Quedlinburg Abbey in his memory, in what is today Quedlinburg, Saxony-Anhalt, Germany. In 966 her granddaughter, also named Matilda, became Quidlinburg's first abbess.

At first the Queen Mother remained at the court of her son; however, in the quarrels between the young king and his rivaling brother Henry, a group of royal advisors is reported to have accused Matilda of decreasing the royal treasury in order to pay for her charitable activities. She resigned her inheritance to her sons, and retired to her country home in Westphalia where she established a college of canons. In 947, Matilda was brought back to court at the urging of King Otto's first wife, the Anglo-Saxon princess Edith of Wessex.

In 941, Henry again revolted, this time Otto put down the insurrection with great cruelty. Matilda reprimanded Henry when he began another revolt against Otto in the year 953 and for

Italy, as its focus on the role of San Giuseppe as the spouse of the Virgin Mary and the stepfather of Jesus. In Sicily and other areas of Italy, including some Italian-American communities, people build altars dedicated to St. Joseph brimming with bread, candles and fava beans — a spring crop that, during the Middle Ages, saved the inhabitants of Sicily from a famine after they prayed to St. Joseph for help. Another lovely Italian customs involves doing charitable actions on St. Joseph's Day, a sentiment that should carry over throughout the year. For my father, St. Joseph's Day meant scouring the forest with his friends, looking for firewood to build il faló di San Giuseppe, a big bonfire held on the eve of the feast.

With its bright and warm light, these bonfires symbolize the sun and the transition from winter to spring. Sometimes, an effigy representing winter is thrown into the bonfire to symbolically make a fresh start for the new season. Of course, St. Joseph's Day in Italy would be incomplete without zeppole, or fried puffy donuts strongly associated with the holiday. My father loves his zeppole sweet and filled with cream, like the ones he used to buy from quaint pastry shops in the North End. My grandmother, on the other hand, makes savory zeppole with potato. In either case, these delectable treats remind me of a holiday that makes me proud of my heritage and excited for



I always know the difference between Irish and Italian music and wakes. Italian music is romantic while Irish music is such a downer. The Irish mourn the dead, remember lost loves and fight in endless wars. When it comes to the dead, the Irish most of the time see all life nothing but fate to which they are often so helpless. However, when it comes to wakes, the Irish wakes are far more fun as mourners remember the life of the dead while Italians often turn wakes into weeping rooms. Too depressing at times for me. Go to an Irish wake and you catch up with friends, talk about great times and say how good so and so

I actually think Irish-Italian folks get the benefits of both ethnicities. We laugh a lot, have plenty of fun, get serious when we have to and stay out of trouble by blaming your other side if you run into trouble.

It was only a cheap transistor pocket radio we had picked up in San Juan for \$4.00. Just then, an old man approached us holding our radio. He said that he was the caretaker of the beach and didn't want any thieves to steal our possessions and handed us back the radio. With that he added that he had acquired quite a thirst guarding the radio and they sold beer at a small kiosk near the parking area. We took the hint and bought him a beer. It was only fifty cents and he was a nice little old man. He made me think of Babbononno. Twice more we headed for the water and twice more the radio was gone. Each time the old man had it and each time he had a thirst that only another beer could quench. It was quite a day.

That night, we headed for El Convento, a hotel in Old San Juan that had been a convent from the time Puerto Rico had been a Spanish possession until the mid 20th century. We had heard that the food was great and they had a Flamenco show second only to those in Spain. We were escorted to a table in front of the stage and ordered drinks. The waiter brought us menus and verbally gave us the specials of the evening. Among them was paella valenciana, the national dish of Spain. I ordered for the table and began with a dish that looked like fried minnows on garlic bread. We all decided on the paella (pronounced pie-aye-yah) and awaited the dish. When it came, it arrived in what looked like a giant wok filled with yellow rice covered with pieces of lobster, chicken, and fish. It also contained clams, quahogs, muscles, and sliced up peppers. The yellow color of the rice was due to saffron, the herb used to flavor the dish. Before eating, we squeezed green lemon on the concoction for added flavor and then began to indulge. As side dishes, we ordered ripe plantains fried in olive oil and garlic, and salad. When it was time for dessert, we topped of the meal with flan, an egg custard soaked with burned caramel. The accompanying beverage was Puerto Rican coffee, similar to espresso. This was accompanied by snifters of

aged rum, their version of coffee and cognac. What helped us to digest were the Flamenco dancers. They rivaled any similar show found in Spain. This was an evening to remember.

Later that evening, we headed back to the hotel section of the city and stopped in at Hernando's Hideaway, a night club where many of the local musicians could be found. We listened to salsa music until the wee hours of the morning, and before calling it quits for the night, we stopped in at a deli called The Red Rooster, a local hang out that was open all night. While sipping coffee, once again, we got into a conversation with the people at the next table. One of the people at that table was actor Dick Shawn, who was on the island playing a role in a film being shot there. We wound up heading to bed when the sun was coming up. We slept for a couple of hours, and after a breakfast of nothing more than black coffee, headed for the pool and Caribbean sunshine.

Well, the end of the week finally rolled around and it was time to head home. I knew that I had to work the night we were to get in and slept on the plane. When we arrived at the airport, Sal and Tom, my partners in crime, had people waiting for them and I waited for Dad to pick me up. As I stood there waiting for my father, he drove by and kept on going. He came around again and I could see Mom in the co-pilot's seat and Babbononno in the back of Dad's car. Again, they drove by me without stopping. The third time, I walked in front of the car and Dad slammed on his brakes and stopped. I was so tanned they didn't recognize me. I guess I didn't realize how much sun I had gotten. I don't burn even in the tropics. I just get darker and darker.

Once we got home, I opened my suitcases and brought out the gifts I had picked up for the family, Spanish perfume and soaps for Mom, and cigars and exotic liquors for Dad and Babbononno. They all were pleased. After relaxing for a couple of hours, I dressed in my tuxedo and headed out to play with the band that I had promised to work with that Sunday evening.

One of the messages that had come in while I was away was from the management at the Charter House, a long gone hotel that was just after China Sails at the beginning of the Lynnway, where Revere and Lynn come together. They wanted me to audition for their cocktail lounge. The next day, I called a Mr. Newmark, the hotel's manager. He told me they were looking for a quiet jazz group, maybe just piano and bass to play on weekend nights. Later that week, I headed for the audition with Tony Poto, a parttime pianist who was part of my trio all through college.

Once at the hotel, I met the manager, Mr. Newmark and was told to set up in the hotel's lounge. Within a few minutes we were ready to show him what we could do and he arrived accompanied by another man and a woman. We played several songs from our repertoire, and when we finished, were told by the manager that we weren't what he was looking for. Just then, the other man asked if we knew a tune called, Joey. We knew it and Tony even sang the lyrics. Tears came to the woman's eyes and the man whispered in the ear of Mr. Newmark who then walked out of the audition. This man then introduced himself saying, "My name is Dante Mazzeri and I own the hotel." Pointing to the woman, he added, "My wife and I have a son named, Joev. You're hired.

We talked over the terms and the salary and both aspects were to my liking. I signed the contract and discussed my still evident tan with both him and his wife.

I had to re-arrange a few things, but at the end of the following week, we opened at the Charter House Hotel, and actually stayed there for a year. I let everybody in East Boston and the North End that I was friendly with, know where we were playing, and as a result, brought in my own crowd which helped business and made us look good. I think the proudest person who came to see us was Babbononno.

ter Jackie Robinson broke the color barrier back in 1947 with the Brooklyn Dodgers. He was part of a wave of black players who changed baseball ever. When he finished his career 35 years ago, he was a beloved legend with the Chicago White Sox. Minoso passed away of natural causes. His innings simply ran out. Born in Havana, he played 12 of his 17 seasons with the White Sox batting .304 with 135 homers and 808 RBIs. He became the third player to get a hit after the age of 50 and the second player to appear in the major leagues in five decades.

When he came up with the Indians in 1949, he said he was prepared for racial insults. Sometimes he said he would insult them back in Spanish and warned them, "I can tell you worse things than you said to me without you knowing what I said."

In 1951, he finished second to NY Yankees' Gil McDougald for American League Rookie of the Year in his first full season. On May 1, 1951 he was traded to the White Sox and became the first black player on the team, hitting a homer in his first game with his new team. He returned to the Indians before the 1958 season and also played for the Cardinals and the Senators and had 1,963 hits, 186 homers, knocked in 1,023 RBIs and had a career .298 average. He was an All-Star nine times, but failed to make it to the Hall of Fame, which to me seems a disgrace. Besides his hitting ability and superb fielding, he also was a speedster on base and led the league in steals his


On September 22, 1955 Rocky Marciano stepped into the ring to defend his title in Yankee Stadium against the great Archie Moore. It was a bruising fight with Moore dropping the Champion in the second round, but Rocky eventually wore down his cagey opponent and stopped him in the 9th round. While the fight was one sided in scoring up until the stoppage, it was by no means an easy fight for the Rock. Moore was a great boxer and a powerful puncher, and he landed punches on Marciano that would have flattened other mortals. But Marciano was no mortal when he was in the heat of battle. He seemed to get stronger when he got hit, and his drive and determination were too much for the 49 men he met and defeated in the ring.



These are the Bruins that will move forward, defend their playoff berth and hopefully move on to the Stanley Cup Playoffs.

The trade deadline has passed and the team is now set for the final stretch drive. The B's possess the eighth and final playoff berth in the Eastern Conference and are in the process of defending it against all challengers.

"That's important," noted B's defenseman Torey Krug just after the B's put away Detroit to add two points to their season's total. "Guys are starting to pay a little more attention to the standings and when other teams are playing. But at the same time we just have to focus on ourselves. We're in a spot right now where, if we keep playing the way that we're playing, we're going to find ourselves in the postseason. Guys are working towards that. We're not just sitting back and playing games. We're here to win games and get our game going so we're confident going into the playoffs."

But perhaps just as important is that a big concern has been removed from the locker room — the trade deadline has passed and everyone can calm down. The players know that they are members of the team going forward.

"Guys talked about it time and time again," recalled Krug. "It's a tough thing. We always say we don't worry about it. It's out of our control and you try your best not to think about it. But I'm sure when guys read the names it can be tough. Stress is a big part of this game. Mentally, you've got to be sharp. If you're coming to the rink stressed every day you're not going to be able to put your best foot forward. I think it definitely can weigh on guys no matter what they say. But now we finally have a group in here and we know that's it. Nobody's moving, nobody's leaving. We're excited about the opportunity and the challenge to move forward into the postseason and go from there."

And yes, there is something in the locker room that perhaps was not there earlier in the season. That is excitement.

"This is the best time of year other than the playoffs," noted B's forward Brad Marchand, who delivered a big win for the B's over Philadelphia at the Garden just when Boston needed it. Trailing by a goal with 15 seconds remaining in regulation, Marchand scored on a 6 on 4 power play to tie the count and then found the range for the game-winner in OT. It did more than win a game. It seemed to ignite the B's going forward — as the Bruins posted back-to-back home victories over the Flyers and Detroit and followed that up with an impressive 3-1 victory over Ottawa on the road.

"Guys are so much more

excited to play every game and put our best effort on the ice right now," explained Marchand. "I think it's bringing character out on our team and that's what we need. I think right now everyone is bearing down and making sure we don't get too far ahead of ourselves. We know the situation we are in and we can't take any game for granted. When you do that every game is important. We just seem to be prepared and focused on what we have to do to win every game."

If there's an area of concern down the stretch it's with goaltending. Over the summer of 2014 the B's let substitute goalie Chad Johnson sign with the New York Islanders. Johnson had been a superb backup to Vezina Trophy winner Tuukka Rask last year, playing in one third of the regular season games while putting up stats that were sixth best in the

This season backup duties have been assigned to Niklas Svedberg, a goalie who had only one NHL game under his belt when the season started. There's no question that Rask is the top netminder. The questions come when one discusses the backup situation.

It's the position where the B's are most vulnerable. If Rask couldn't go because of an injury or family emergency, there's a feeling among many that there would be a drop-off in quality in the crease. Svedberg went the distance in the win over Detroit, but still there were moments that gave one pause.

Coach Claude Julien noted that there was "a lot of pressure on a guy who hasn't played much. He won us a game in New Jersey and a game here against Detroit and that's all we can ask from a guy like that who hasn't played too much."

Yet Julien also admitted that there was a point in the Detroit game where pulling Svedberg in favor of Rask entered his thoughts. "I'm going to be honest with you," said the coach. "I'm not going to say it didn't cross my mind. At one point there, you look at the score and say well, if something happens, maybe I have to make a tough decision."

The B's are in the middle of a significant stretch of games — 11 contests in 18 days — that will go a long way in determining their fate. So far it's been successful. As the middle of March approached, it looked as if the B's could even make a run at Washington, the team just above them in the wild card standings.

The three games with perhaps the most meaning loom ahead — matchups against wild card challenger Florida. One is at the Garden (March 31st) while the other two are on the road (March 21st and April 9th). Right down to the wire this race may go.
